POLITICAL CRISIS

Slogans

The four political slogans launched in November 1988 appeared in most issues of The Working People's Daily throughout the month, as did the "Noble Desire" slogan begun in January 1990. We reprinted them in the January 1991 issue.

Since Jan. 3, 1991, most issues have also run the following slogan:

The interests of the State cannot be served and promoted by disturbances and instability. Join hands with the Tatmadaw in preventing disturbances and acts of instability.

From April 1989 the The Working People's Daily ran a political slogan across the bottom of each front page. This was changed to a religious slogan in August 1991, and later moved to the top of the page:

Oct. 1-2: Dananca, generosity; this is the way to auspiciousness. $\ \ \,$

- Oct. 3-16: Dhammacariya ca, lawful conduct; this is the way to auspiciousness.
- Oct. 17-23: Natakananca sangaho, to support the relatives; this is the way to auspiciousness.
- Oct. 24-30: Annavajjani kammani, to perform faultless actions; this is the way to auspiciousness.
- Oct. 31: Arati papa, to abstain from evil; this is the way to auspiciousness.

On Oct. 7, 1991, the political slogan returned, in addition to the religious slogan, in its old bottom of the page slot:

Oct. 7--31 : Emergence of the State Constitution is the duty of all citizens of Myanmar Naing-Ngan

Cartoons

There continued to be several political cartoons in each issue. $E.\,\sigma.:$

Oct. 1: "Those who know about themselves better feel ashamed." Myanmar to Foreigner: "We hate neither your race nor your nation." Foreigner: "So, you have nothing to hate about me?" Myanmar: No, we have. The acts of interfering the internal affairs of another nation is very loathsome."

Oct. 3: 1st Myanmar: "Oh, our country is peculiar, Aba... One who came back from underground...says he does not have a high opinion of the Thirty Comrades...he dubbed the Thirty Comrades Fascists...he also picked up a young girl to marry...He is said to have been awarded the Naing-Ngant Gon Yi Title..." 2nd Myanmar: "Oh, You! What a lot of unbelievable nonsense." 1st Myanmar: "Believe it or not but don't think it's a fable. There are said to be evidence...Well, I suppose historians will deal with that matter, Aba." [Reference is to U Nu--HCMacD]

Oct. 3: 1st Myanmar [thinking "Beware of saboteurs"]: "Every person has the duty to give information to expose destructionists." 2nd Myanmar: "Of course, otherwise our families and relatives may also meet trouble."

Oct. 3: Myanmar girl to parents: "It is my own right to marry whoever I like." Parents: "But we will in no way give our consent if you choose a foreigner as a husband."

Oct. 4: "Colonialists" with moneybag to Myanmar soldier and civilian: "Hehehe... I cannot provide assistance if there is no interest for me."

Oct. 4: "Taking training zealously." Myanmar athlete climbing stairs towards sign reading "Myanmar sports shall overwhelm the world": "To compete with the love for the nation and the race."

Oct. 7: KNU to wind-up "parallel government" and "ABSDF": "Yes, my followers. Commit demolition, robbery and murder. Then drop dead."

Oct. 7: Myanmar to girl (hot pants, T shirt) and boy (long hair, trousers, skull on T shirt): "Are you true Myamars?" Response: "Yes" Myanmar: "Do you love Myanmarpyi?" Response: "Very much." Myanmar: "You want to see Myanmar traditional culture become extinct?" Response: "No." Myanmar: "So, be decent, don't be decadent, observe culture."

Oct. 7: 1st Myanmar: "Video known as `The Edge of Burma' was telecast once on TV Myanmar. It was shot by KNU terrorists. Where did they come? They claimed that they came from Mesopotamia. They said they were Caucasians." 2nd Myanmar: "If so, they better return to the place they come from. They should be received there since they are the same race. To say in commercial terms, I would like to even include Sein Win parallel government, NDF, CRDB, ABSDF... and BBC listeners." 1st Myanmar: "Yes, they will not become Caucasians but they are sure to be Kaw-Kan-Kar."

Oct. 9: 1st Myanmar: "What is the meaning of duty-conscious citizen, Aba?" 2nd Myanmar: "It means the person who provides information to authorities to expose and hinder the dangers of the State and the people; who peforms duties conscientiously and who

stays within the framework of law."

Oct. 12: Civilian: "It is said that the Kayin terrorists infiltrated the Delta." Solder: "Don't worry, Aba. The Tatmadaw in every era crushes all the terrorists brilliantly." Civilian: So, we the people will also join hands with the Tatmadaw to crush the terrorist."

Oct. 14: 1st Myanmar: "Aba, why did our people have to address the colonialists `Phaya' or `Thakin'?" 2nd Myanmar: "Because of the causes which Saya Pe depicts as...`we lost sovereignty due to the lack of discipline...'"

Oct. 14: 1st Myanmar: "Here's the good news. In our country the earth will bear fruits of gold; something to be happy and proud about it." 2nd Myanmar: "The news states that well No. 45 of Shwepyitha oil and gas field in Manaung is producing crude oil on commercial basis daily."

Oct. 14: One Myanmar to another: "You will not survive long if you are concerned only with getting power by using the cover of democracy without any interest in national objectives."

Oct. 18: Myanmar to Old Man: "Oh, Uncle Byauk-O, why are you so quiet? Now there are many voices floating around...." Old Man: "Don't worry about that Ko Shwe Mbegyo. We've already cited pattha parita to keep out all dangers, and, as I've signed, I am afraid that it will be my responsibility, if there is any disturbance. That's why I am quiet. Let it be. They are correlated to one another... Due to being British subject perhaps...Hehehehe..."

Oct. 18: 1st Myanmar: "It is very confusing, Uncle Byauk. When Myanmar Naing-Ngan regained independence, the President was Sao Shwe Thaik. Later, the President was Sir Ba Oo. He was the one who handed down death sentence to anti-imperialist leader Saya San according to the wish of colonialists. Such person could become a President smartly during the AFPFL parliamentary era." 2nd Myanmar: "Oh, is that so. Those law experts may be very scarce in that AFPFL era. Tut...tut..."

Oct. 19: "They will be punished for their sins and misdeeds." Myanmar [thinking "ABSDF"] reading newspaper: "The group which went underground screaming to bring about democracy in Myanmarpyi is now sending saboteurs to explode bombs and killing innocent people. What's their act? That's their way of showing how much they love for the nation and the people. Heck!"

Oct. 21: Son: "Papa, it is very heartening to learn that a big amount of arms and ammunition were seized in Delta and Tanintharyi Thayetchaung region from enemies due to the operations jointly waged by Tatmadawmen and people. Many enemies were captured dead." Father: "Yes, son. These stupid guys are still committing misdeeds though they know the dynamic combatting capability of the Tatmadaw... Their destiny is at a dead-end. They will soon be annihilated." Mother: "Why don't BBC and VOA broadcast such news?"

Oct. 22: 1st Myanmar: "Shouldn't Perez de Cuellar and Mandela have won the Nobel Prize? That is our view... That is Myanmar view." 2nd Myanmar: "That's right... That's right. But it is surprising that they haven't won this prize, just like howling up the wrong tree. Haa!Haa!"

Oct. 23: 1st Myanmar: "It's all right that U Nu and Sein Win parallel governments are not supported. It is also necessary not to support terrorist KNU Nga Mya, KIA Brang Seng, BCP UGs Kyin Maung and Kyaw Mya, and Tanintharyi BCP-terrorists who have been causing disturbances since the attainment of independence." 2nd Myanmar: "Yes, it's true. Yes, there are still those who are more experienced and far-sighted. They should also say something."

Oct. 26: 1st Myanmar woman: "Just think of it! Under the name of democracy, a man is tied up, his shin rolled with wooden roller, given shocks with 30 volts, flesh chopped off from his thighs, legs and cheeks and finally bludgeoned to death. How cruel!" 2nd Myanmar woman: "Yes, the armed terrorists has no scruple, no law. Their democracy is lawless democracy...a kind of democracy in which they kill anyone they like to kill...it is kill-as-like democracy."

Oct. 28: Underground Parallel Government: "We are supported by neither the people nor the parties." Myanmar: "Hahaha. Hence, there is only one thing left for you to do... Drop dead!"

Oct. 28: Father to trousered son: "You are sent abroad for

Oct. 28: Father to trousered son: "You are sent abroad for further study neither to become conceited nor to get a high opinion of all that's foreign but to strive hard for the development of our people. Don't forget that, my son."

Oct. 30: Soldier simultaneously offering flowers to a civilian and pointing a gun at a fleeing insurgent: "Our today's Tatmadaw is... Just like cool water or pleasant moon when dealing with the people... And like intense fire or scorching sun when dealing with enemies."

Oct. 31: 1st Myanmar: "If one were to make a study of an epoch..." 2nd Myanmar: "...for that one must make a study of the pronouncements and speeches of the leaders...during the period of struggle for independence, there are the speeches of Bogyoke Aung San; during the period of AFPFL parliamentary era, there are speeches of the then Prime Minister; for the period of the Caretaker Government there are the addresses delivered by the Prime Minister of that period...and then of course for the period of the Revolutionary Council, there are the speeches given by the Revolutionary Council Chairman... then for the period of the Lanzin Party...there are the speeches of the Lanzin Party Chairman...after that, for the period of the People's Government which emerged on the basis of the 1974 Constitution, there are the speeches given by President of that Government..." 1st Myanmar: "Then, what about for the period of the State Law and Order Restoration Council Government..." 2nd Myanmar: "Oh, you dunce..! there are of course the speeches given by the State Law and Order Restoration Council Chairman...these are historical and revolutionary speeches... these are policies...these must be carefully read, studied, remembered, adhered to, propagated and practically utilized in practise...'

Political Articles

Following the pattern begun in October 1988, each issue contains lengthy feature articles, translated from Burmese, designed to bolster government views and policies. Editorials sometimes touched on similar themes. We note them briefly, with excerpts of typical or particularly significant portions:

Oct. 1-9: China-Myanmar goodwill visits of great historic significance, by Bo Thamani. [Cont. (13-21) Review of visits in both directions since 1949. "Pauk-phaw" {relative} relationship between the two countries recalled. Myanmar gave 1,500 tons of rice to China for flood victims after the May-June 1991 Chinese floods, and China will give interest-free loans of Yuan 50 million to Myanmar and construct a Television Station (CH-5 project).]

Oct. 1-3,5: First-person accounts of the 17-9-88 incident at the Ministry of Trade, by A Tatmadaw Officer. [Cont. (8-11) Military account of incident.]

Oct. 2,7-9,14-16,18-20,22-31: Post independence press in retrospect (1948-1958), by Shwe Kalaung. [Cont. (59-78) Political divisiveness in the Myanmar press.]

Oct. 3: Fitness--A Positive Force, by Ivan King. [Cont. Remembering old stars so as to renvigorate sports; e.g., Suzanne Lenglen, the Barotras, and Fred Perry in tennis; Stanley Matthews and Tom Finney in golf; Jack Hobbs and Don Bradman in cricket. "It is the past that has made this Todays; and will make the Tomorrows."]

Oct. 7-10, 12-15: From the Ministry of Trade to the Battle of Methawaw, by A Tatmadaw Soldier. [(1-8) Tatmadaw reminiscences of attack on KNU stronghold.

Oct. 12: I feel ashamed for the `chickens without bones', by Yadanabon Maung Hmat. [Heroic Gen. Maha Bandoola contrasted with his cowardly son, who surrendered to the British, and political parties denouncing Sein Win.]

Oct. 16-17: Those who are not ashamed of themselves (Thitsa-Myitta Discussions), by Byammahso. [BBC allied to KNU terrorists. Shameful acts of Sein Win and U Nu; of US in blaming foreigners for its crime and drugs, etc. The VOA and BBC "are nothing but people who do not feel ashamed of themselves."]

Oct. 20-22: A Concise History of Myanmar and the Tatmadaw's Role (1948-1988), by A Tatmadaw Reporter. [Cont. $\{from Sept. 21\}$ (147-149) War against insurgency.]

Oct. 21: No encroaching on Myanmar's essential jurisdiction, by Kyaw Thura. [As Minister for Foreign Affairs U Ohn Gyaw said at the UNGA, UN Secretary General Perez de Cuellar was right in warning against using human rights as an excuse for encroaching on the domestic jurisdiction of States.]

Oct. 21-24: Who's Who Hereabouts, by Po Toke. [I: The Backers and the Doomsayers. BBC and VOA backing terrorists. "Rumour-mongers and evil broadcasts are a great help...toward further price-rises, instability and insecurity." II: Plain as plain can be. "The Tatmadaw has been, is, and will always be going after armed terrorists under whatever name in the interests of internal stability" The KNU Delta offensive crushed. III: What we write with our hands.... "Just as the terrorists are flushed out, those working hand in glove with the terrorists, overtly or covertly, must be made to understand that they cannot do...[it] with impunity." IV: Public Indignation at KNU misdeeds.]

Oct. 23: For good conduct of persons in service, by An Observer. [Review of rules of conduct for government employees. "In sum, what is required of all persons in service is to be loyal to the State, to abide by laws and services rules and work to the best of their ability for the good of the country and the people, avoiding any association with party politics or committing `anti' speech, behaviour and activities, always mindful that they have been given the final warning."]

Oct. 24-26: The story of Myanmar conscripted labourers forced to work in the construction of Thai-Myanmar Railway Road, by Soe Nyunt. [(1-3) Review of Thai-Burma Mee Yahgta Lan Ko Twe Chway Tat Hmat Tan (The Record of Own Experiences on Thai-Myanmar Conscripted Labour Force) by Linyone Thit Lwin. Neo-colonialists "still striving to enslave us."]

Oct. 27-31: The task of ensuring constant development of Myanmar language and literature, by Soe Nyunt. [(1-5) Promote Myanmar culture; British efforts to wipe it out during colonial period; Myanmar culture has flourished "for thousands of years"; re-birth of Myanmar literature in 1916.]

Oct. 27: KIA involvement in narcotic drugs, by An Observer. [Revelations of Lazum Gamli {see Oct. 11 Press Conference} revisted.]

Press Conference

Oct. 11: : At the 112th State LORC Press Conference, spokesman Lt-Col. Ye Htut discussed KIA involvement with narcotics, adding that "The governments of foreign countries know of this fact" and that one country had refused Brang Seng a visa on narcotics grounds. He said stories, such as those in the October 11 Asiaweek, about KIA opposition to drugs, were lies.

-- Speaking of KNU activity in the Delta, he said that the

number of KNU terrorists who had entered the Delta region was not more than 100, and they were being crushed. He noted a DAB statement, quoted in Thailand, that Bo Mya had ordered a general offensive in the Delta and everywhere else in Myanmar.

- -- Three recent defectors told their stories about the KIA.
 Lazum Gamli of the ABSDF 701 Regiment turned himself in at Momauk on Oct. 1, Soe Kyaing at Bhamo on Oct. 2, and Thet Tin at Bhamo on Oct. 6. They told of rape, torture, and narcotics activities.
- -- Lazum Gamli, a student from Bhamo, said inter alia: "There is no KIA leader who does not grow opium poppies. All leaders, followers and their families grow opium poppy and have to turn all opium produced over to the KIA. They collect, at ten ticals per viss.... In April 1989, I saw heroin in about 20 buckets and knapsacks, and when I asked one KIA terrorist of the weight, he replied that there were a total of 20 kilos.... I later learned that some of the KIA leaders were addicted to heroin. The KIA is the most notorious in drug abuse.... Just as their leaders, almost all KIA followers abuse heroin, stealthily as it might be insulting to their leaders if the abuse is in the presence of their leaders...."
- -- He told how one Sai Maung Maung from Myitkyina, suspected of being a Tatmadaw spy, was tortured at length with electricity, and when he confessed, was beaten to death.
- -- During training, Lazum Gamli said their camp was visited by a reporter, a naval captain from Taiwan and party. He learned that Bertil Lintner visited in Jan. 1991. At Mupon camp, "another reporter, a colonel of the US Marine, and his wife visited there. James Linbawm, the personal assistant to KIA Chairman Brnag Seng, was a Kachin national living in Sweden, and he came together with the foreigners.... The foreigners were told that these villages no longer grow opium poppy, and they were taken back...." (WPD 10/12)
- -- After looking at films showing the killing of people at Uru Chaung, and asking about jails and treatment for addicts (Brang Seng said there weren't any), "the Marine colonel then said that they were abusing human rights, that what they said they were doing was for the cause of human rights and they desired democracy was not true. He said that they could not accept this. The KIAs were very embarrassed to hear that We heard later that, the foreigners told KIA terrorists they would build airstrips for emergency landing once opium had been wiped out and that they inspected the site for construction of the airstrip. We also learned that they visited the area to equip the KIA terrorists with arms suitable to their geographical locations.... We, NBs, also had the chance to talk with them.... Than Gyaung and Myo Win told them that...the NBs were fighting the [SLORC] Government, that they wanted aid for the training programmes, that they wanted some food and medical aid. The Marine colonel said he would submit this matter to the higher authorities. About two days after the return of the Marine colonel, two Japanese reporters came to the area on 18 August 1991...to study opium plantations.... '
- -- Thet Tin told at length and in detail how KIA interrogators tortured and killed students suspected of being from military intelligence. He finally escaped after being mistreated. He described how KIA leaders used girl students (yemays) for sex, and produced opium, "most of which is sent to the western bank of the Ayeyarwady." He was told that "on TV and at [KIA] press conferences, the persons had to say according to what they were told to say and they were told to say things which were not true and that they were told to say these at gun-point. These are all lies...."
- -- Thet Tin said that "the foreign contacts were that in January 1989, before our training started, Bertil Lintner of FEER magazine came. He took documentary photographs and asked students what kind of assistance they wanted.... Later in February, reporters, said to be from Switzerland and Australia, arrived. They took documentary video films while we were undergoing training Japanese reporters came to liaison camp. I do not definitely know when that was.... I learnt that a colonel from the US Marines came. I

only heard about it but I did not see him... What I do know definitely was the arrival of two reporters from Australia during the second week of August 1991...."

 $\mbox{--}$ Soe Kyaing said he was a farmer drafted by student guerrillas as a porter, who escaped after a month.

 $\mbox{\ \ --}$ In response to questions, the following information was given:

There were 500 people in ABSDF Northern Burma, of whom only remain. The KIA has 50 students under arrest, of whom 6 have been killed.

The KIA story that the Myanmar Government supported narcotics "was concocted by a foreign country to cause doubt," and the stories of torture were true and not invented to gain leniency.

ABSDF headquarters is in Manerplaw, Kayin State. The Northern Central "subsisted on the support of the KIA."

The strength of the regiments of NB (Northern Burma) is 300, with four regiments: 401, 501, 701, and 702. Mupon camp is on the south, four days trekking from the Liaison camp in the north.

The BCP has been demolished, and there "were no remnants of the BCP in the Bhamo area."

They personally saw Bertil Lintner when he came to the camp. The ABSDF was originally led by Tun Aung Kyaw, but is now led by Moe Thee Zun. (WPD 10/13)

Maj-Gen. Khin Nyunt's Warning

Oct. 4: In a lengthy speech (full text printed) to Government department heads at the Ministry of Defence, State LORC Secretary (1) Maj-Gen. Khin Nyunt warned that civil servants and military must abide by all laws relating to them, stay away from politics, and be loyal to the State, or face "effective action." Relevant statutes and rules were displayed. (WPD 10/5-6)

Warning Editorial

Oct. 14: "Stop the deception; be correct [Editorial]. The Ministry of Home and Religious Affairs...issued Declaration of Warning No. 1 on... 4th September 1991.... The Declaration added, political parties and some service personnel who have been carrying out deceptive activities against the Government (The Tatmadaw) are hereby warned to stop doing so forthwith.... Those committed to leading the country must avoid deceptive means of wresting leadership, and also avoid putting their self-interest and the interest of their parties in the forefront.

"Moreover, State employees...must honestly prove they are worthy of the faith and trust the State places in them. Instead of deception, instead of giving self-interest priority, they must think, speak and act responsibly, and discharge their duties exerting their all for the benefit of the citizen and the State, showing highest regard for faithfulness and allegiance.

"More recently...Yangon...Commander Maj-Gen Myo Nyunt reminded...the nation, of the significance of the aforesaid Declaration of Warning No. 1, even going into military Staff Duty interpretation of the term 'on behalf of', or acting on deputed authority for someone. The gravity of the term, or its implication, specially its misuse, rather than use, must be taken into full cognizance by politicians, State employees and all citizens lest they run afoul of the law and get into trouble." (WPD 10/14)

Gen. Saw Maung's Speech

Oct. 28: Addressing Chairmen of State/Division LORCs, State LORC Chairman Senior General Saw Maung said [full text]:

I will speak only a little in my meeting with the Command Commanders, Division Commanders and the Chairmen of State and Division Law and Order Restoration Councils.

On my part I have said, to a considerable extent, what ought to be said. I tell only the truth. We have held the election we promised. That's why I'll speak briefly and go straight to the point.

What is important is:

- (1) don't let your own integrity be lost no matter whoever loses his;
- (2) don't violate the laws although others may be violating the laws;
- (3) don't let yourself be deceived whoever deceives to whatever extent;
 - (4) although one is wise one seldom has presence of mind;
 - (5) do your work with presence of mind, diligence and wisdom;
 - (6) rely on yourselves;
- (7) do your work with determination, diligence, perseverence, zeal and courage.
- (8) it is cause that produces effect; believe that effect in turn becomes cause; this is the Pathana preached by the Enlightened One

In this regard I will take this opportunity to elaborate a little. There are preachings by the Sayadaws. One Sayadaw said, "Do things with presence of mind, diligence and wisdom." Another Sayadaw said that there is "Vijja, Carana, Sampanna" at the Pavarana ceremony held on the Fullmoon of Thadinkyut. Another Sayadaw said that there were diplomatic relations between one country and another on the basis of the teachings of Lord Buddha.

I have once told you. To tell the truth is Truth. I only tell the truth. I have shown to those who ought to be shown the evidence on which I based the truth. If you, the Command Commanders, the Division Commanders and the Chairmen of State and Division Law and Order Restoration Councils, have not seen them, take a look at them. I have all the evidence in connection with what I have said.

What is happening today is that some people, in spite of their being Buddhists, are not free from the 10 Duccarita (Evil Conduct)—three committed through deeds, four committed through words and three committed through thoughts.

To put it in a nutshell, even the difference between "Anicca" (impermanence) and "Marana" (death) is not known.

The difference between some nations and ours is that they say that they eat food with their eyes and we eat food with our mouths. This, one and all know.

They do not clearly know the difference between Mind and Matter. A people live according to their own mentality. They do not understand the Myanmar mentality. Everybody has his own mentality. It is natural that there will be things which one and others have the same attitude and there will still be others towards which one and others have different attitudes. We have formed the commissions concerned in connection with parties, law and history.

Every service personnel must do his or her own work. As for the members of the Tatmadaw, we have to perform the duties of the State on the one hand; what is important (for the members of the Tatmadaw) in performing their original duty, is to work in co-operation with members of the Sangha and the people for ensuring the prevalence of peace and tranquillity, peace of mind of the people and the rule of law. Firmly bear in mind that Constitution is the concern of all the citizens of the nation.

In order to be able to adopt plans to crush the terrorists, present at this meeting correct reports of the prevailing situations as well as facts. If you have other things to present, speak frankly and openly and present facts. We will do as far and as much as we can. Don't present things which cannot be undertaken or which cannot be put into practise. I would like to tell you not to entertain such an attitude as "he has outdone me" or vice versa in presenting matters.

As regards Samvega, take cognizance of the impermanence of things in accorance with Minister Ananda Thuriya's poem which begins with "Thu-di ta-yauk kaung-bo yauk mu" If and when a person is to do well... "In doing your work hold form to the teachings "Su, Ci, Pu, Bha, Vi, Li, Si, Dha" of Shin Maha Ratthasara.

I will tell you a little the meaning of the teachings "Su, Ci,

Pu, Bha, Vi, Li, Si, Dha." The passage is "Bear these eight initials of the words of Su, Ci, Pu, Bha, Vi, Li, Si, Dha as one wears a garland of flowers everyday" and I will explain this passage. The definition of these is as follows:

Su - Suneya - One should listen and learn

Ci - Cinteya - One should think

Pu - Puccheya - One should ask Bha - Bhaseya - One should speak out

Vi - Visareya - One should analyze and assess

Li - Likheya - One should note down

Si - Sikkheya - One should practise

Dha - Dhareya - One should learn by heart

There is one thing I would like to tell the organizations and persons concerned. Stop saying things according to your whims and fancies; stop spreading rumours; stop spreading fabricated and false news; stop putting blame on others while you yourselves pretend to be good and stop making false accusations. Don't deceive the nation; don't deceive the people.

I urge you...make up your mind to do, to the best of your ability, what ought to be done, in the interests of the State as well as in the interests of the people. That's all. (WPD 10/29)

UNGA Address

Oct. 5: Minister for Foreign Affairs U Ohn Gyaw was named a Vice-President of the current 46th United Nations General Assembly. Speaking to UNGA on Oct. 4, he made the following principal points:

-- Myanmar welcomes the new members of the UN, especially the Republic of Korea "with which Myanmar has established long and fruitful relationship of friendship, understanding and cooperation..." and the Baltic States which "represents the righting of a historical wrong perpetrated in violation of international law..."

-- Takes satisfaction "at the liberation of Kuwait from Iraqi occupation" under the UN Security Council, while expressing doubt at at "The Council's decision authorizing the use of force on a national and coalition basis which clearly does not conform with...Chapter VII; the apparent lack of proportionality in the employment of armed force; the want of full compliance with the rules of humanitarian law...; the over-extension of...Chapter VII measures; [and] the continued enforcement of some of these measures long after the end of hostilities which has caused grievous suffering to innocent civilian populations"

-- Joins the concern of "small" and "weak" nations at "moralistic stances which in truth conceal attempts to modify the time-honoured concept of sovereignty and to erode certain cardinal principles of the Charter, such as...non-interference in the internal affairs of other States,...respect for the territorial integrity and political independence of States and the principle of sovereign equality of States." One such area is human rights. Myanmar promotes human rights "to the fullest extent permitted by our own national circumstances--not least of which is the continued existence of armed

insurrection in the remote parts of the country and the destructive activities of underground elements in urban and rural areas"
But, in the words of the Secretary General, the defence of human rights should not become a "platform for encroaching on the essential domestic jurisdiction of States and eroding their sovereignty...."

- -- Is gratified by the end to fighting in Cambodia and the formation of a Supreme National Council under Norodom Sihanouk, and hopes for the finalization of a comprehensive peace agreement.
- -- Believes that a Middle East settlement requires application on Security Council Resolutions 242 (1967) and 338 (1973) in their entirety, including recognition of the rights of the Palestinian people to self-determination and an independent and sovereign state, and recognition of the sovereignty and territorial integrity of all States in the region including Israel.
- -- Welcomes developments in South Africa, while believing that international pressure must continue until "the evil system is totally eradicated."
- -- Welcomes President Bush's disarmament initiatives, and hopes that a positive Soviet response will start a process leading to the total elimination of nuclear weapons in the world.
- -- Calls for international debt and debt-servicing reduction as essential to international economic development, as well as bolder approaches, because "That over a billion people now live in absolute poverty is not only immoral, it also poses a real threat to international security and stability."
- -- Supports environmental measures to halt degradation that puts "the very survival of the human race at stake." Among issues to be faced are "the unsustainable pattern of production and consumption." Myanmar accords high priority to the environment. "Myanmar's abundant forests, a resource of considerable economic value, have been managed on a rational and sustainable basis."
- -- Myanmar has made enormous efforts against narcotic drugs, including the destruction of drugs and equipment worth US\$4.33 billion since 1990 and of 200,000 acres of poppy fields (with an annual yield capacity of 940 tons of opium) since 1975.
- -- Myanmar is at the threshold of a new era, as its Government seeks "to usher in a process leading to peace and prosperity and the fulfilment of the aspirations of the people for a democratic state." Progress has been made in restoring law and order; all schools, colleges, and Universities have been reopened; complete freedom of religion reigns; eight insurgent groups have returned to the legal fold. "For the first time in decades guns have fallen silent and peace and tranquility now prevails in remote areas of the country where terror and lawlessness previously reigned."
- -- "Questions have been raised in some quarters about the perceived delay in the transfer of power. Some ...assert that the Myanmar Government has shown no sign of respecting the wishes of the people." Though this a purely domestic matter:
- All political parties have agreed to the Government's program for implementing the free and fair elections of May 1990;

The Election Committee is completing its final report, hampered by the inadequate accounts kept by many candidates;

Contested elections are being investigated by the Tribunals and "this due process of law must be allowed to complete its course";

Once the Election Commission submits its report, the [SLORC] "will meet with the elected representatives to discuss the holding of a national convention...entrusted with the task of working out a broad national consensus which will form the basis for framing a new constitution." The Convention will include elected representatives, political party leaders, representatives of all national races, and respected veteran politicians.

On the basis of the national consensus, the elected representatives will draw up a new Constitutions. The [SLORC] will make suggestions and render all necessary assistance "in the best traditions of the Myanmar Defence Services," but is above party politics and "is neither a political organization nor does it have

any intention of forming one." It will lead the nation "until...a strong government can be formed on the basis of the new constitution."

-- "In conclusion I should like to state categorically that once the political process I have outlined is completed the State Law and Order Restoration Council will transfer the reins of the State to a strong and stable government formed in accordance with the new constitution." (WPD 10/6)

KNU Attacks Ayeyarwady Division

Oct. 9: "KNU terrorists...have entered Bogale Township of Ayeyarwady Division with malicious intent. They, with the help of their hardcores, in the area, were scheming to give trouble to the people from the Delta, which is a consolidated area and which has become peaceful for 19 years, and to cause unrest, it is learnt."

Bogale police on Oct. 2 captured five KNU "hardcores" at Titunt village, along with 8 AK-47 rifles and 2,081 rounds of ammunition and 8 magazines. The police then went to Katthamhmyin village. 17 police

were killed and 17 weapons lost in the attack of about 40 "KNU terrorists and their hardcores."

The Tatmadaw under South-West Commander Maj-Gen. Myint Aung went into action, and in 9 clashes with KNU, 9 KNU terrorists were "captured dead" and 5 alive, along with 18 weapons, 9,986 rounds of ammunition, 19 magazines, 6 grenades, and 32 detonators. 22 Tatmadawmen, including police, were killed and 18 weapons lost. Mopping up is under way.

"The area that the KNU terrorists have entered now is the Tawpaing area previously entered by terrorists led by expatriate Nyo Hmaing in 1972. They were then annihilated by the Tatmadaw...and the area has become peaceful then up to the time this group of terrorists entered the area, it is learnt." [Map showing sites of 9 clashes, all south of Bogale and Pyapon] (WPD 10/10)

Oct. 11: One KNU leader was killed Oct. 10, and three KNU privates surrendered, as "mopping-up" operations continued. On the 11th, Army units clashed with 60 "KNU terrorists" near Sarphyuzu village [map]. Deputy Commander-in-Chief of the Defence Services and SLORC Vice-Chairman Gen. Than Shwe visited Bogale. (WPD 10/12)

Oct. 13: "Fighting continued between the Tatmadaw columns and the KNU terrorists in Tawpaing area in Bogale Township." On Oct. 11 there was a clash with 60 KNU at Sarphyuzu village; 5 KNU were killed, and 3,750 rounds of ammunition and other equipment was seized. Mopping-up operations continue in Katthahmyin and Tawpaing areas; a powered boat, 2 rifles, and 191 rounds of ammunition were seized.

On Oct. 12 there were two armed clashes; 1 KNU were killed and a rifle were captured. Saw Lu Galay, 49, of the KNU terrorist group, surrendered at Katthabaung Sethsan police station, with a rifle. (WPD 10/14)

Oct. 14: State LORC Secretary (1) Maj-Gen. Khin Nyunt visited Ohnbinzu village, Myaungmya Township "where fighting had taken place between Tatmadaw columns and KNU terrorists," and inspected captured enemy equipment.

On the military front, "fleeing KNU terrorists fled Sarphyusu and took the path in a north-west direction along Maungdee, Kanasogon, Madok creek, and Kyondeik... Skirmishes took place at Madok Creek in Myaungmya Township...on 12 October, and at Kwinbauk...and at Kyondeik... on 13 October. It is reported that the fleeing terrorists were in the environs of Onbinsu [sic] Village in Myaungmya Township on 13 October afternoon. Vessels of Tatmadaw (Navy) and the columns of the Tatmadaw (Army) took up positions along Sagamyar Creek...and the...(Army) columns beseiged the enemy's stronghold on the west and south. About 5,000 people...provided assistance and support... Helicopters...airlifted the military columns to the areas close to the enemy.... The Airforce provided air support.

A battle was fought near Ohnbinzu village. 59 KNU terrorists were killed. Captured were 2 grenade launchers, 1 40-mm launcher, 56 rifles, 7 mines, 27 rocket grenades, 20 40-mm shells, 10,000 bullets, 2 communications sets, 15 navigation charts, etc. 3 Tatmadawmen were killed and 5 wounded.

"The KNU terrorists left Theikpangongyi region in Labutta Township on 8 October towards the north along Kakayan River and arrived Sarphyusu Village after taking the path along Kyunpyatthat River," where they were attacked on Oct. 11.

The Army also dislodged fleeing KNU elements in the Tawbaing area of Bogale Township and on Oct. 12 seized 9 rifles and 1513 rounds of ammunition hidden near Oo Nisu Village. In the Kathahmyin and Tawbaing areas, as of Oct. 14, 36 weapons and 15,781 bullets, 8 rockets, and 2 walkie talkies were seized.

Overall, betwen Oct. 4-13, the Tatmadaw killed 75 enemies and captured 8. Four surrendered. 95 weapons, 25,000 rounds of ammunition, 33 shells, 4 communications sets, mines, and other equipment were captured. [2 maps] (WPD 10/15)

Oct. 16: On Oct. 14, 13 KNU terrorists surrendered at

Myaungmya. A rifle was found on Oct. 15 in Dauntgyi village, Bogale Township, and 40 shells and 4,603 bullets at Theikpangongyi village, Labutta Township. On Oct. 16, in a clash with KNU terrorists at the mouth of Hlinebon Chaung in Ngaputaw Township, 7 KNU were killed. Captured were a rifle, a mine, 3 RPGs and 3 motorized vessels. Through the month, there were frequent extensive articles about "mass rallies denouncing the KNU terrorists" in Ayeyarwady Division towns.

BCP Defeated in Tanintharyi

They are also prohibited from exporting "goods which the State organizations and local authorities prohibit them from doing so."

However, with export licences from the Border Trade Offices of the Trade Department of Myanma Export Import Services, private entrepreneurs may export six kinds of beans and pulses, corn seed, and salt water prawns. (WPD 10/30)

Landlords Must Report Rents

Oct. 30: All landlords in the Yangon City Development Committee area who "rent land, houses (wholly or partially), flats, and boarding houses" must report to the Township Development Committee Offices by Dec. 31, 1991, bringing relevant documents. Oct. 14: Authorities searched the motorized vessel Sein Hnint Mya as it was about to leave Pazundaung Market Jetty [Yangon] on Sept. 21, and seized 96 tons of teak, 16 pieces of jade, 26 sapphires, 20 rubies, 9 gold rings, and 20 jade bangles, which were to be smuggled to Singapore. \\ Yangon police seized 10 over kilos of marijuana from a bus entering Yangon at the Minlwingon check-point and from houses searched as a result of subsequent investiga-tions. Anti-Narcotics Activities

Oct. 22: During August 1991, the Tatmadaw seized 31.6 kilos of opium, 0.4 kilo of heroin, 54.6 kilos of marijuana, and 244 gallons of acid. During the same period, the police seized 45.8 kilos of opium (65 cases), 35 kilos of heroin (113 cases), 27.8 kilos of marijuana (64 cases), 923.9 litres of phensedyl (19 cases), 1,376 Chinese cough tablets (1 case), and 17.1 kilos of opium powder (3 cases). There were 214 cases of failure to register and 22 other drug-related cases. In all, the police took legal action against 656 people (501 cases). (WPD 10/23)
