POLITICAL CRISIS

Slogans

The four political slogans launched in November 1988 appeared in most issues of The Working People's Daily throughout the month, as did the "Noble Desire" slogan begun in January 1990. We reprinted them in the January 1991 issue.

Since Jan. 3, 1991, most issues have also run the following slogan:

The interests of the State cannot be served and promoted by disturbances and instability. Join hands with the Tatmadaw in preventing disturbances and acts of instability.

From April 1989 the The Working People's Daily ran a political slogan across the bottom of each front page. This was changed to a religious slogan in August 1991, and later moved to the top of the page:

Nov. 1-5: Arati papa, to abstain from evil; this is the way to auspiciousness.

Nov. 6-9: Virati papa, to refrain from \sin ; this is the way to auspiciousness.

Nov. 10-12: Majjapana ca samyamo, to refrain from intoxicating drinks; this is the way to auspiciousness.

Nov. 13-17: Appamado ca dhammesu, to be diligent in laws; this is the way to auspiciousness. Nov. 18-24: Garavo ca, reverence; this is the way to

Nov. 18-24: Garavo ca, reverence; this is the way to auspiciousness.

On Oct. 7, 1991, the following political slogan was added to the bottom of each front page:

 $\,$ Emergence of the State Constitution is the duty of all citizens of Myanmar Naing-Ngan

Cartoons

There continued to be several political cartoons in each issue. E.g.:

Nov. 2: 1st Myanmar: "Ahemmm!... There are many things left for you to read and study. To know the true facts, you'd better read the books on the Special Press Conferences of Secretary-1." 2nd Myanmar: "Right. The facts are quite true. It can challenge, `Who can deny these facts?'"

Nov. 3: "We count on our Myanmar athletes... Myanmar Sports shall overwhelm the world." 1st Myanmar: "I rejoice at the victory of Myanmar youth football team, Aba. I take pride of them." 2nd Myanmar: "Of course, that is how all patriots would feel."

Nov. 3: Myanmar civilian: "KIA's atrocities are so cruel that they should be put on record in history." Myanmar soldier: "Yes, today's youths should know this and beware of that danger. And those youths who went underground should also understand that and return to legal fold."

Nov. 3: Father to son headed abroad: "My son, before you go for further study, I'll tell you: You are a Myanmar citizen, born in Myanmar. Don't become a traitor nor betray Myanmarpyi. Don't become one who sows discord among Myanmar people. Don't let yourself become one who destroy and disgrace Myanmar Language."

Nov. 3: "The desire of the national people." Myanmar to an embarrassed Myanmar holding a folder labeled "Party": Myanmar is a race which has strong will. Never fall into servitude. Don't think any ideas to assume a foreigner as master. We will in no way let our Union disintegrate."

Nov. 4: "[May all them be mushrooms free from toxins.]" Myanmar looking at three mushrooms labeled "new video star," "new stereo songster, "new author.": "It is good as the emerge in abundance but what is important is they should not be contrary to Myanmar traditional culture."

Nov. 6: 1st Myanmar: "Uncle Byauk, you are so quiet." 2nd Myanmar: "Because I'm afraid of martial law." 1st Myanmar: "By the way, what is the destination of who betrays the state by deceiving it?" 2nd Myanmar: "For those traitors...it is none other than the destination of traitors. Hmmmm!" 1st Myanmar: "Oh, yes. There can be nothing else than that! Hehehehe!"

Nov. 7: 1st Myanmar: "Uncle Byauk, tell me about the 1935 Government of Burma Act and the 1947 Constitution." 2nd Myanmar: "You are too naive. They are very similar...not different. That's the answer...there can be nothing else than that answer. Hehehe!" 1st Myanmar: "Oh, yes. Nothing else than that answer. Hehehehe!"

Nov. 8: Myanmar to long-haired youth: "To escape from the life of servitude, our national people had to fight for a long time. We cannot lose the independence which we regained after so many the national people had sacrificed their lives... No...No...No...Never shall we allow this to happen despite a handful of the likes of you who stink of slavishness...!"

Nov. 9: Myanmar looking at four steps marked "Submission of the Final Report by the Commission", "Holding the National Convention," "Drawing up a firm Constitution," and "State Power": "Stairs are to be climbed step by step. If you take overstep you may tumble down and get into trouble."

Nov. 9: 1st Myanmar: "Opposite of democracy is anarchy." 2nd Myanmar: "It can also be said that opposite of democracy is ABSDF." 3rd Myanmar (thinking): "Cruel and brutal tortures and killings."

Nov. 10: "Respect Myanmar Language" Official at "Immigration Office": "Are your parents Buddhists?" Mini-skirted woman: "Yes."

Nov. 10: 1st Myanmar (thinking of a politician): "That man...?" 2nd Myanmar (also thinking of him): "What about him? I know him well... He..He. He was in No 2 position during the time of the Revolutionary Council and No 20 as member. Now I don't know whether he is No 1 or not. He..he..he."

Nov. 11: "Not respected by anyone, not even by dogs." 1st Myanmar: "Aba Byauk, what usually happens if the Tatmadaw is inferior?" 2nd Myanmar: "It is very difficult to make you understand. If the Tatmadaw is inferior, it will not be respected by anybody. Moreover, we may be flung back into servitude."

Nov. 11: 1st Myanmar: "Aba, I cannot sleep or eat well if I don't hear BBC and VOA broadcasts." 2nd Myanmar: "Well, that disease is incurable. It is called the disease of stinking slavishness."

Nov. 12: 1st Myanmar: "The editorial of the 10-11-91 issue of Loktha newspaper is `Ehipathikaw'. It said `Lord Buddha is not an ordinary man absolutely.' I'm astonished that anyone would dare to say our Lord Buddha is an ordinary man... Wonder who said it?" 2nd Myanmar: "Oh, there is someone who dares... That one will surely go to Aviti (deepest hell)... Sup! Sup! Blup! Blup!"

Nov. 12: 1st Myanmar: "Lawyer should be the one who stands in front of the people and brings about the truth within the framework of law." 2nd Myanmar: "He shouldn't be the one who stays behind the people and asks for the exorbitant fees."

Nov. 13: 1st Myanmar: "As you said about falling into Aviji (deepest hell), what will happen to the followers and associates?"
2nd Myanmar: "Hey Acari! If one commits a sin against our Lord Buddha verbally, mentally and physically, one will surely falll into one of the remaining SEVEN LAYERS of hell even though he may not fall into Aviji. This may be based on grading. Sup! Sup! Blup! Blup!" Snail: Ah-he! My abode is higher than that. Hey! Hey!"

Nov. 16: 1st Myanmar: "Hey, in the past the cases were tried by a group of judges." 2nd Myanmar: "Yes, cases were tried by groups in the past and now they are tried by a judge. Anyhow, what is important is to ensure that `money in no way influences the judgement'. It is according to the Penal Code that has been in operation since 1 May 1861."

Nov. 18: "Businessmen" wielding "Money" lures "Writer" away from "Literature Contributing Towards the Interest of the People" and towards "Literature for Pleasure-reading."

Nov. 18: Baby: "National Day... 10th Waning of Tazaungmon, 1282 ME" Father to long-haired, trousered, guitar-carrying son: "Where to? You are not even as patriotic as a child."

Nov. 18: "Collectively defend (our culture) against the rats." Rat "Western Culture" gnawing at book "Myanmar Traditional Culture."

Nov. 21: Father to son: "My son, as you are a serviceman, you must... abide by laws and rules; don't be a dude worker; do avoid mercenary spirit; be loyal to the Union; repay the gratitude of Motherland; be dutiful and not shirk; be always vigilant against destructive elements."

Nov. 21: 1st Myanmar: "Silence reigns these days." 2nd Myanmar (with "Questionnaires", "Biography", and "Historical trend."): "There is a saying that silence is worth a `htaung' (thousand). Shhh..!" 1st Myanmar: "OK. It is worth a `htaung' Ha...Ha... But I don't think that `htaung' is a sack of a thousand bucks."

Nov. 22: 1st Myanmar: "National Day is getting closer. I'd like

Nov. 22: 1st Myanmar: "National Day is getting closer. I'd like to say what I remember, that is...on a memorable occasion, someone said omniscient Lord Buddha is just an ordinary person." 2nd Myanmar: "Oh, don't talk about it. That creature is topsy-turvy...that's for sure."

Nov. 23: 1st Myanmar: "Yesterday there was something about the `topsy-turvy'. What will one be if one thinks highly of and reveres it?" 2nd Myanmar: "He He He.... Then, one will be ever more `topsy-turvy'"]

Nov. 24: 1st Myanmar: "Let's continue about those who'd go to

hell which I mentioned yesterday. Then... there were some persons who dubbed Lord Buddha as Muddha." 2nd Myanmar: "Oh, they are those who'd go deep into hell." 1st Myanmar: "They may be atheists. They are not afraid..."

Nov. 25: 1st Myanmar: "Let's continue what we were talking about yesterday." 2nd Myanmar: "Oh, oh! That one which awarded prize to the person who said that Lord Buddha was an ordinary person..." 1st Myanmar: "Yes, that one will to to hell in a great way."

Nov. 26: 1st Myanmar: "Let's continue our talk about those

Nov. 26: 1st Myanmar: "Let's continue our talk about those who'd go to hell (which I mentioned yesterday)... How many years did our Buddha endeavour to attain enlightenment?" 2nd Myanmar: "Oh! What a different [sic] creature you are!... It took four aeons and 100,000 kapas for the embryonic Buddha to attain enlightenment. Bear it in mind for the rest of your life. 1st Myanmar: "What about Aggasavaka?" 2nd Myanmar: "Again! It took two aeons and 100,000 kapas." 1st Myanmar: "And, what about Mahasavaka?" 2nd Myanmar: "You dull and dumb fellow [hitting him]. It took one aeon and 100,000 kapas."

Nov. 28: 1st Myanmar: "Maha Wizaya Zedi..." 2nd Myanmar: "It was built in commemoration of the successful conclusion of the First Congregation of the Sangha for Purification, Perpetuation and Propagation of the Sasana. Isn't it?" 1st Myanmar: "However, some said it is `Kalaphaya'. 2nd Myanmar: "For this sin, they will surely go to hell topsy-turvy." 1st Myanmar: "Yes, exactly."

Nov. 28: Myanmar to friends: "Oh, our nation is very poor. People attire multi-coloured dresses elegantly and smartly...and eat well and contribute donations abundantly, happily and generously."

Nov. 30: Myanmar to friend: "Hey! Maung Moegyo, you said yesterday [sic] that some dubbed the Maha Wizaya Zedi as `Kalaphaya'. Isn't that so?" May be...they would like to worship the Kalas and may be that's why they're saying such things."

Official Books

Officially published books and periodicals are advertised or publicised regularly. These were featured this month:

Series of books on classical literature (in Burmese).

Book on World War II Thai-Myanmar Railway (in Burmese); previously published in Japan.

Handbook for service personnel.

Book (in Burmese) on Gen. Saw Maung's visit to China.

Book (in Burmese) on the 1988 catastrophe caused by the lies of the BBC, VOA and AIR.

Political Articles

Following the pattern begun in October 1988, each issue contains lengthy feature articles, translated from Burmese, designed to bolster government views and policies. Editorials sometimes touched on similar themes. We note them briefly, with excerpts of typical or particularly significant portions:

Nov. 1-8,23-24,26: Post independence press in retrospect (1948-1958), by Shwe Kalaung. [Cont. (79-89) Political divisiveness in the Myanmar press.]

Nov. 1: The task of ensuring constant development of Myanmar language and literature, by Soe Nyunt. [Cont. (6) Origins of Myanmar literature.]

Nov. 2-7,12-13 If I speak out, it may amount to Aung Min's taking too much for granted, by Aung Min. [(1 2 pts.) KNU terrorists' intrusion into the delta. "Only a handful of terrorists led by notorious Nga Mya the Brute who have been swayed by their masters in the West whom they rely on say that they are not of Asian origin and that they are descendents of long-nosed people living in the vicinity of the Caucasus Mountains where the rivers Euphrates and Tigris flow.... Well, that group that say they are of Caucasian origin seemed to have lost their way on their way to the Caucasus and entered the Kandonkani chaung (stream) or perhaps their `traditional god'... might have thought `these foolish people...who are ungrateful (to the country and people) must be punished' and thus must have sent

them to the Ayeyarwady Delta, a white ["pacified"--HCMacD.] area, where the people are in the habit of hitting hard at their enemies."

[(2-2 pts.) The way of all the traitors. Three things people condemn are: "(i) undertaking armed insurrection; (ii) relying on the imperialists and dancing according to the tunes of the imperialists, and (iii) trafficking narcotic drugs."

[(3-2 pts.) Don't get flattered. Imperialists plotted Aung San's assassination; KNU uprising; 1988 disturbances. We must choose between "the Tatmadaw that is striving...to prevent disintegration...." and "those who are out to grab power... who think foreign nations will be giving them a lot of assistance, who desperately crave for power relying on foreign aid...such as Sein Win... and some who make slanderous attacks (on the Tatmadaw) while waiting for the news of how a foreign nation would exert pressure on the army."

[(4-2 pts.) What is wrong with the world today?. Atrocious crimes in America, natural disasters, violence in India, corruption in "a country on the east of ours." Gen. Saw Maung's Oct. 29 call to wisdom recalled. If Bush and Gorbachev "go on inciting here and there, instigating here and there, kindling fires here and there and thus kick off a nuclear or thermo-nuclear war" that would be what the Buddhist scriptures call the "appearance of seven suns."]

Nov. 6-7: Bribery and corruption to be opposed, by Pyi Chit Maung. [(1-2) "Cases of economic wrong-doings are found to be on the rise." Fable on the need for honesty in government.]

Nov. 8: Never again to be given as a present as a colony, by Maung Pyone Cho. [On Jan. 1, 1886 Lord Randolph Churchill gave Myanmar to Queen Victoria as a present. British imperialism reviewed.]

Nov. 10-11,14-15,19,21,27-29: A Concise History of Myanmar and the Tatmadaw's Role (1948-1988), by A Tatmadaw Reporter. [Cont. {from Oct. 22} (150-158) War against insurgency.]

Nov. 11-13: Like brothers and kin, by Shwe Baw Phyo (Sindewa). [(1-3) Gen. Saw Maung and Aung San on unity with border area brethren.]

Nov. 14-15,18,20,22-23,25,27-28: An anti-imperialist book published 56 years ago, by Aung Kyi Htun. [(1-4) U Po Kyar's Thibaw Min Pardawmu Ahyedawbon ("The Movement Connected with the Seizure and Taking Away of King Thibaw"), "written with the aim of keeping patriotism and a sense of nationalism alive and dynamic" discussed, along with the author's other works. (5) Killing of a King's relatives to remove competition can be found in the Bible, in Africa, and throughout British history. (6) King Thibaw "fell prey to others' manipulations" and "therefore, the king and queen ought not to be blamed for the killing of the princes and relatives, for poor administration and finally for the country's loss of independence." (7) Inappropriate "vulgar terms and usages" have been spoken against King Thibaw---"abusive words which originated in evil minds." (8) Myanmar lost its independence because of "our lack of strength, our lack of power, our lack of sting..." (9) U Po Kyar's courage in telling the truth though "under the iron heels of the British imperialists and colonialists at that time."]

Nov. 15: Five ways of questioning, by Aung Min. ["I am also hearing my political friends say: `Ha, 'tis no easy life being politicians nowadays; can't take it easy; must keep reading, noting and researching to be able to answer questions authorities may ask. Reading, noting and studying we have now gained clearer conceptions and more comprehensive understandings of certain subjects.'" Five ways of asking questions are: to learn, to compare, to confirm, to solicit a desired answer, to verify depth of information.]

Nov. 16-17: If I speak out, it may amount to Aung Min's taking too much for granted: A government that has always been a very good friend, by Aung Min. [(1) Myanmar "has all along been sincere and upright" in international relations. (2) The Government "always tells the truth and always does what is right, it never insults and assaults others"]

Nov. 19-21: The Myanmar's endeavour to be able to stand on own feet, by Bo Thanmani. [(1) The Revolutionary Council's coming to power in 1962 "is also a historical landmark of liberating the people of Myanmar Naing-Ngan from the imperialist-capitalist economic system." (2) Withdrawal from Sterling area in 1966 was in fact "aimed at promoting stronger friendly ties and relations with them." (3) "Long live the Myanmars' being able to stand on their own feet!"] Nov. 22: Editorial: For all citizens of Myanmar Naing-Ngan to be conscious. ["Although there is no need to mention with what law the State is being administered as it is over three years ago, even those who are wise sometimes lose presence of mind and lest they do so it is to be reminded that the State is being administered with `Martial Law'. According to Westerners, Martial Law means the wishes of `the General'. It is worthy to be aware that the person who is responsible in Myanmar Naing-Ngan is a Senior General and is higher in rank than a General.... It is the same as the Five-Star General...[or] Field Marshal. This we should be aware of. Thus, Government servants must be fully conscious that they must stay clear of party politics. There is another point which the service personnel must be conscious of. That point is the phrase `Let bygones be bygones' mentioned by the Senior General on 25 June, 1991. It is to be pointed out that this phrase not only meant forgiving but is also a warning."]

Nov. 24-30: The matter of Myanmar Naing Ngan's paying debts

Nov. 24-30: The matter of Myanmar Naing Ngan's paying debts arising out of its separation from India, by Bo Thanmani. [(1-7) History of of the separation of Burma from India in 1937, and its financial arrangements.]

Nov. 30: If I speak out, it may amount to Aung Min's taking too much for granted: The Stone from Hiroshima, by Aung Min. [US development and use of nuclear weapons recalled. Myanmars should support total destruction of mass weapons "as well as to watch out with vigilance and defend and protect Myanmar Naing-Ngan from the danger posed by the forces that bully, influence and dominate others by force of arms."]

Press Conference

Nov. 1: At the 113th State LORC Press Conference, spokesmen reviewed the October KNU incursion into the Delta area:

- -- Hearing of KNU arms infiltration, the Bogale Twp. authorities on Oct. 3 raided Teetant village and seized 3 KNU terrorists and 8 weapons. The same day police raided Katthamyin village and clashes began. The Tatmadaw launched "Operation Mondaing" Oct. 3, under the leadership of South-West Command.
- -- The infiltration was ordered by KNU Central with the participation of the KNU No 4 and No 7 brigades, under the direction of KNU "brigade commander" Oliver of No. 4 brigade and "lieutenants" Paw Htoo, Ainkhant, Tin Oo, and Saw William Jack (a) Saw Jack. Duties were also assigned to "former surrendered KNDO members and hardcore villagers whom they had organized in each township and secretly sent arms and ammunition from KNU No 4 brigade to them." The arms came from the KNU "Minthamee" camp in Dawei Twp. [Tanintharyi] and were secretly carried to Pulaw twp. [Tanintharyi] and then sent to the Delta on three schooner trips.
- -- Following the clash at Katthahmyin village on Oct. 3, the KNU formed three columns. One, led by KNU Lts. Ka Paw Htoo and Saw Jack who had entered the Htawpaing area of Bogale Twp., formed the Bogale Column of persons organized and trained from Katthahmyin, Chaungbya and Byubinzu villages.
- -- KNU Lts. Ainkhant and Tin Oo, who arrived at Ohngyikon village, Labutta Twp., gathered and trained villagers, and sent them to KNU hardcore member Saw Lardo at Padaukkon village. There and at Theikpangongyi village they were armed (Oct. 4-7) and ordered to march to Pantanaw Twp. via Mawlmyinekyun Twp. and to penetrate Hinthada Twp. Meanwhile, Organizing Committee Chairman Mahn Kyaw Hla of the Labutta Twp. League of Union Kayin Nationals, a surrendered Myaungmya District KNUP member from Shwegon village, went to Padaukkon village to join Lt. Tin Oo.

- -- On Oct. 7, KNU terrorists Ainkhant, Tin Oo, and Reinnay, and KNU hardcores Saw Lardo, Saw Mahn Chit, Saw That Nyaw, and Mahn Kyaw Hla formed two more columns. The Mawkyun Column led by Ainkhant and Saw Lardo penetrated into the Hinthada area via Pantanaw Twp. The Theinlar Column led by Tin Oo, Mahn Kyaw Hla, and Reinnay, was to march to the Theinlar area of Myaungmya Twp.
- -- The 100-man Bogale Column led by Kaw Paw Htoo and Saw William Jack (a) Saw Jack clashed 14 times with the Tatmadaw between Oct. 6-10. 63 KNU including the two leaders were killed, and the Tatmadaw captured weapons and ammunitions [details]. The column is reduced to 40 hardcores with 10 firearms, hiding in the Htawpaing
- -- The 100-man Mawkhun Column led by Ainkhant, Saw Lardo, Saw Jupitar (a) That Nyaw, Aung Shwe, Saw Mahn Chit, and Saw Lu Thar went up the Padaukkon chaung (stream) in 5 powerboats on Oct. 7, and reached Tharluphar village and then went to Beegon and Payagon villages and entered Mawlamyinekyun Twp. The Tatmadaw No. 11 LID attacked them near Sarphyusu village in five battles in Myaungmya Twp. between Oct. 11-13. 79 KNU were killed including Ainkhant. The others surrendered. Arms and ammunition were captured [details].
- -- The 120-man Thainlar Column led by Tin Oo, Mahn Kyaw Hla, Reinnay, Takiko, Kawlar, Aung Chit Tin, and Robinson, left Padaukkon village, Labutta Twp., in schooners on Oct. 7 and arrived at the Theinlar area of Myaungmya Twp., where they spent a week training and reorganizing. National League for Democracy Myaungmya Twp. Organizer Mahn Aung Maung joined them and served as "section commander" as well as in charge of transport and provisions. From Oct. 15 they moved to Teteku village, and in seized schooners moved along the Ngawun River and entered Hlaingbon chaung (stream) in Ngaputaw Twp. on Oct. 16, where they were met by the Tatmadaw. There were 10 skirmishes up to Oct. 29. On Oct. 22, soldiers in ambush in Tawgyi shot and captured the National League for Democracy Ngaputaw Twp. organizer Saw Michael of Ayodah village; action will be taken against him. During the skirmishes 105 KNU were killed, including KNU "section commanders" Reinnay and Taki[ko]. Weapons and ammunition were captured [details]. The remaining 20 column members led by Tin oo and Mahn Kyaw Hla fled with 20 firearms, and are being sought.
- -- Altogether the Tatmadaw killed 247 KNU terrorists and captured 6. They seized 5 M-16 rifles, 1 M-20 pistol, 2 BA-52 stenguns, 1 BA-63 automatic rifle, 1 US-made M-60 machine-gun, 1 .38 revolver, 8 .303 rifles, 1 .303 LMG, 7 M-23 machine-guns, 1 M-79 launcher, 2 RPG launchers, 1 BA-103, 1 L.A.W. launcher, 1 launcher, 1 60 mm. mortar, 84,113 rounds of ammunition, 220 rounds high-calibre ammunition, 42 propellant cartridges, 24 claymore mines, 43 TNT sticks, 250 magazines, fuses, 22 hand grenades, and 6 communication sets. 44 hidden arms caches were found in all. The Tatmadaw lost 17 killed and 23 wounded; the police 18 killed. One Tatmadaw and 17 police firearms were lost.
- -- Meanwhile, the Tatmadaw South-East Command on Oct. 23 launched an attack in Palaw Twp. [Tanintharyi] north of Myeik [Mergui], which was used by the KNU as a base for transporting arms and ammunition. There was one engagement. 1 KNU was killed and 2 captured. 11 M-16 rifles, 65 AK-47 automatic rifles, 18 M-22 automatic rifles, 2 M-23 machine-guns, 2 carbines, 60 RPGs, 168 rounds of ammunition, 3 motorized vessels and 1 Hino engine were seized.
- -- "Those who collaborated with and gave support to terrorists are also terrorists. It is heartening to learn that the people in delta area are holding mass rallies to denounce the KNU terrorists almost every day Persons and mentors who instigate, support and help them from behind and certain broadcasting stations which meddle in through their fabricated broadcasts the internal affairs of Myanmar Naing-Ngan with intent to cause unrest are strongly condemned."
- -- "We also know that there are certain politicians and some political parties in the country that spread rumours and fabricated

news which might undermine peace and tranquillity.... I would like to warn them that they are to stop such things forthwith.... We will take effective action.... The clarifications have been given...because there are false news being spread in connection with the infiltration of KNU terrorists into the Ayeyarwady Division."

- -- Asked how the KNU was funded, now that smuggling taxation was down, the spokesman said "the KNUs seek financial and arms support through certain means and that the journalists might know how they could receive them and that it is estimated the latest strength of KNU terrorist group is 4,000 men."
- $-{\rm -}$ Asked whether ABSDF youths were involved, the spokesman said that the KNU had "mobilized youths from the delta only" and the "ABSDF was not included.
- -- Asked whether the KNU actions, plus the floods in Ayeyarwady Division, would decrease rice output, the spokesman said "there need not be any anxiety about rice owing to the above factors."
- -- Asked about civilian casualties and student involvement, the spokesman said "there were no casualties of residents" and "there was no involvement of students with the KNU terrorists."
- -- Asked whether the BCPs crushed in Tanintharyi were "remnants of the former BCPs," the spokesman said they were "of the former Tanintharyi Division BCP group." (WPD 11/2)

Maj-Gen. Myo Nyunt

Nov. 3: Speaking to the National Defence College, Yangon Commander Maj-Gen. Myo Nyunt said that "certain ex-officers of the Tatmadaw were no longer loyal to the Tatmadaw; instead they were attempting to cause disintegration of the Tatmadaw." He quoted the October 1991 news bulletin of the Union Nationals Democracy Party and "said that they were trying to cause disintegration of the Tatmadaw though they seemed to be in support of the Tatmadaw." Finally, he "said that certain political parties had signed pledges stating that they had no contact with terrorist organizations and sent them to the government but they maintained contacts with terrorist organizations clandestinely." He called on everyone to heed State LORC Chairman Senior General Saw Maung's advice in his October 28 speech. (WPD 11/4)

Nov. 9: Yangon Commander Maj-Gen. Myo Nyunt "inspected exercises involving the people's strength in encirclement and annihilation of the enemy in Tanyin [Syriam], Khayann, Thongwa, and Kyauktan Twps. [Yangon]. "He said that as the eastern sector of Hanthawady is bordering with the Gulf of Mottama [Martaban], east of the mouth of the Sittoung River, there is the danger of insurgents terrorists intruding into the area. The local people therefore were responsible for preventing their white area from becoming a bloody one, he added." (WPD 11/10)

Maj-Gen. Khin Nyunt

- Nov. 5: Speaking at the inauguration of the Institute of Nursing, State LORC Secretary (1) Maj-Gen. Khin Nyunt said, with regard to human rights:
- -- Prof. Yozo Yokoza from the UN Human Rights Commission and her colleague "had met with the Election Commission members and representatives from three political parties and arrangements had been made for them to freely meet them and ask questions, that they were taken where they wished to go such as the Shwedagon Pagoda, the new towns, the Yangon Circular Road, the Insein Jail, etc., that frank clarifications were given to whatever they wished to know...."
- -- He said Myanmar human rights "were aimed at bringing about development of all the national brethren and an enabling the people from all strata and classes to enjoy them." He contrasted this with "Western" so-called human rights that "are meant ultimately for the elite, the privileged and the ruling class." Myanmar rights are "in accordance with the Myanmar traditional values, customs and religion" which are "totally different" from those of the West. "East is East and West is West."

-- He said "certain big countries are making attempts to dictate the country in its political, administrative, economic and social affairs. There are those who count on them, who want to become their lackeys and national traitors." [For remarks on Myanmar medical facilities, see below under Health.] (WPD 11/6)

Nov. 23: State LORC Secretary (1) Maj-Gen. Khin Nyunt spoke at the consecration of Buddha images for the Wa and Kokang regions: "The BCP terrorists who have no religion oppressed and persecuted the people in the regions for over 20 years and committed sacrilegious acts such as banishing Buddhist monks, destroying monasteries and pagodas and causing the Sasana to diminish, he explained.

"He said peace and tranquillity has been restored to these regions as a result of the efforts made by the [SLORC] (Tatmadaw Government) that has been striving to promote and propagate the Sasana. Hence, the Government has decided (1) to carry out development measures for Wa and Kokang regions; (2) to renovate ruined monasteries and pagodas; (3) to convey Buddha images to these regions that are lacking sacred images; and (4) to send missionary monks to the regions..."

"He added that the Department for Promotion and Propagation of the Sasana has conducted a first refresher course for Buddhist missionaries, and the missionary Sayadaws would be sent to these regions and would be provided with the four kinds of requisites by the Government. In conclusion, he called on the members of the Sangha and the laity to strive for flourishing of the Sasana with a view to ensuring perpetuation of the Sasana for more than 5,000 years." (WPD 11/24)

Gen. Than Shwe

Nov. 19: Speaking in in Wetthay village, Pathein-West Twp. [Ayeyarwady], [SLORC] Vice-Chairman Gen. Than Shwe:

"Pointed out that the Tatmadaw was able to crush within a few days the KNU terrorists who had penetrated the delta area which had been peaceful for 19 years.... He stressed the need for the people in the area to be aware of fact that the Tatmadawmen were risking their lives to see to the security of the people. The people in the region must also take measures in bringing security to the area.... He called on the people to co-operate with the government and not to believe the rumours and fabricated news spread by outsiders.

"The government is like a father to the people. If we fight among ourselves believing what outsiders say, we will surely get into trouble.... He then stressed the importance of giving information about the enemy. He said that one is liable to face life imprisonment or even death sentence because one's failure to report about the entering of the enemy into one's area amounts to committing high treason..." (WPD 11/20)

Maj-Gen. Tin Oo

Nov. 28: Speaking at a paddy coordination meeting at the Trade Ministry, State LORC Secretary (2) Maj-Gen. Tin Oo "gave an enumeration of annual paddy yield. He said there will be an annual yield of 644 million baskets from 11.5 million acres of successful fields out of a cultivated acreage of 12 million, if calculated at 56-basket yield per acre.

"Out of the 644 million baskets, if public consumption including seeds, wastage and storage for farmers is 500 million baskets, there will be a surplus of over 100 million baskets, he said. He pointed out that under these favourable conditions of paddy yield, the present instability of prices of rice should be reviewed.

"He blamed the price instability on avaricious traders and some

"He blamed the price instability on avaricious traders and some weaknesses in means of distribution, saying the majority of traders and businessmen are taking advantage of the situations in which the State is in the process of changing from one system to another.

"He added that these traders, taking advantage of rights given to them under the new economic system, are smuggling products from agricultural and forestry sectors out of the country and are evading

taxes in collaboration with some unscrupulous personnel, who are engaged in such malpractises as bribery and corruption..." (WPD 11/29)

Nov. 28: Speaking to transport officials, State LORC Secretary (2) Maj-Gen. Tin Oo said that 2,360 miles of new roads had been built, 10,501 miles repaired, and 572 miles expanded, at a cost of over K11,630,000,000. The Shwenyaung-Bahtoo and Aungban-Loikaw railroads were built, and the number of rail coaches, motor vehicles, and vessels increased. The number or rail trips and air flights has grown, and new ticket sales systems were introduced. He stressed the need for security. (WPD 11/29)

Nov. 14: Minister for Livestock Breeding & Fisheries and for Agriculture & Forests Lt-Gen. Chit Swe addressed the FAO session on Nov. 13, saying [excerpts]:

- -- "Myanmar has been subject to both sporadic drought and floods; the floods, being the severest in the past decades. The floods affected over 400,000 acres of crops, mostly paddy, rendered more than 280,000 people homeless, and led to considerable loss in public and private property and infrastructure. Measures have been taken to recultivate damaged areas, with crops appropriate to postflood growing conditions, and we are glad to report that national food requirements and our normal potential surpluses will not be unduly affected. The measures of assistance rendered by UN Agencies, international organizations and numerous donor countries, towards the relief efforts, are highly contributive, and we remain deeply appreciative...."
- -- "The pace of economic growth and development [in Myanmar], however, had not been comparatively satisfactory [despite abundant natural resources]. The Government of Myanmar, in recognition of the negative environments, instituted drastic changes to its economic structure in recent years. Significant steps were taken for the shift towards a market economy and with a view to maximize private domestic participation, attract foreign investment and accelerate growth and development. Emphasis have been given on creating profit incentives for farmers as well as small entrepreneurs and on infrastructure development.

"The measures were followed by the promulgation of a new Foreign Investment Law. The Law, containing favourable returns on investment has provided equitable conditions for foreign ventures in production, trade and service sectors. The responses have been encouraging and currently a considerable number of enterprises in forestry, fisheries, oil and mineral exploration, industries and for hotel and tourism are in operation.

"Measures were also taken for relaxing controls in international trade and with mechanisms for exporters to retain the full amount of their foreign exchange earnings, for purchase of appropriate imports. The incentives have generated favourable private sector response, and has led to an increase in the volume of agricultural exports. Similarly, the legislation of the inland border trades with the neighbouring countries have further given a surge to Myanmar's exports in numerous agricultural produces.... Early indications signal that the agriculture sector has responded well to the increasing demand and higher prices of agricultural products....

- -- "The conservation of genetic resources remains extremely essential for the ensurance of an assured supply of basic material for plant and animal breeding; and importantly also for future biotechnology advances. The collection and exchange of plant germplasm continued to be built up in Myanmar and we hope that our efforts in these spheres will be further strengthened through the enlarging scopes of the Special Action Programme on Biological Diversity"
- -- "The 2800 kilometre coast line of Myanmar supports a vast reservoir of varied fish resources.... The marine resources, however, still remain under-exploited. The total harvest in 1990 amounted to only about half a million metric tons against an estimated sustainable yield of one million metric tons. Our national fishing fleet still lacks the capacity to accommodate the potential; and as an interim bridging measure and in conformity with United Nations Convention of the Law of the Seas, for sharing surpluses, a number of fishing rights, associated with development programmes, have been granted. The rights are for one year with options for extension and are meant to serve as prelude to more economically viable Joint Ventures under our Foreign Investment Law. I wish to take the opportunity of assuring the Conference that the operations will be controlled under strict legal and administrative mechanisms, so as to prevent over-exploitation or damage to the environment...."
- -- "In spite of our financial resource constraints, we have taken firm measures to integrate environmental consideration into the various facets of national development The government has also set up a National Commission for Environmental Affairs...to coordinate efforts.... Fortunately, Myanmar's environment has not been unduly impaired...due to the relatively limited population pressures, the still low level of industrialization and the limited use of polluting agricultural chemicals.... The forest resources continue to be managed under sound silvicultural systems. The extraction of timber is strictly on a selection felling basis.... The rate of reafforestation of teak, hardwood and fuelwood species progress at 25,000 hectares yearly.
- -- "The private sector, as of recent, was permitted to participate in the extraction of hardwoods under our new economic restructuring. Similarly steps were taken to harvest the backloads of standing teak and hardwoods along the inaccessible border areas, under extraction rights {and joint-ventures} * with neighbouring countries. Although the operations are being undertaken under strict forests and customs regulations, regrettably there have surfaced insinuations of over exploitation and clear felling. We appreciated the well-intentioned concern of certain quarters in these respects, but wish to inform the Conference that the disinformation remains unfounded. The total area of all the border concessions covers only over three thousand square miles amounting to 2.6 percent of the total forest area of the country. Moreover, under the terms of contract, only trees of the exploitable girth classes are permitted for extraction in accordance with our selective felling system. There are also restrictions in area as well as limitations in quantity to be harvested in all the concession areas. {* Please ignore "and joint-ventures"... (WPD 11/16) }

"As an agricultural country we attach extreme importance to the

protection of the tropical forest ecosystems. We continue to subscribe to the activities of the Tropical Forestry Action Plan, and the tenets of the declaration adopted at the Ministerial Conference on Environment and Development in Asia and the Pacific held in 1990. We also fully endorse `The Paris Declaration' of the Tenth World Forestry Congress and will effectively co-operate with the international community in this vital area."

-- "Our campaign to combat and eradicate opium poppy cultivation and illicit trafficking in narcotic drugs, is also being waged relentlessly. The government, at the same time, has been according high priority to the development of the border areas, with a view to improve the rural infrastructure, agricultural development and socio-economic condition of the region... The support rendered in the efforts, by FAO, UNDP and UNDCP, among others, have been invaluable and we remain indebted to them... Myanmar has, at the same time, entered into bilateral cooperation with...China, Thailand and Laos...with a view to strengthen the war against drugs.... (WPD 11/15)

Mandalay & Yangon Land Fraud

Nov. 12: Between Oct. 11-29 the National Intelligence Bureau

exposed another 151 people who deceived authorities by understating sales contracts of land, buildings, and houses in Mandalay. The sales were recorded at K39.6 million but were really for K250.7 million, or K226.9 million more than the claimed amount. "If the amount exposed for the second time was added, it totalled K 437.943 million involving a total of 292 cases up to 29 October." The taxes due will be collected from both buyers and sellers, as provided by law. From 1989 to 1991 there were 2,529 real estate transactions in Mandalay, but the Internal Revenue Department "has taken care of only 100 cases." The NIB has now exposed 292 cases, and the IRD has another 2,127 to assess. "The sellers and buyers of land, buildings and houses in Mandalay, in collaboration with some personnel of the Mandalay Division Settlements and Land Records Department and lawyers, signed contracts which failed to mention the actual amounts.... Moreover, some employees of the Internal Revenue Department in order to get bribes applied delaying tactics by giving advice to the tax payers how to evade taxes. Severe action will be taken by the NIB if such acts continue." (WPD 11/13)

AIDS Seminar

Oct. 30: A 2-day seminar to draw up curriculum for prevention and control of AIDS for State/Division instructors opened at the Health Museum, with Health Department, WHO, and UNDP representation. Present were Health Department officials and doctors, and 28 state/division health personnel. (WPD 11/1)

Institute of Nursing Opened

Nov. 5: The new Institute of Nursing was opened in Yangon by State LORC Secretary (1) Maj-Gen. Khin Nyunt. It is the first such institution in Myanmar; a training course in Mandalay will be opened simultaneously. After reviewing the history of medicine in Myanmar, he said the Institute of Nursing was an outgrowth of the new Midwifery and Nursing Law of Oct. 17, 1990; it will confer B.Sc. (Nursing) degrees. At first, the degree will be given after two years' study to people with a three-year nursing diploma, with priority to nursing instructors and those in charge of wards. Classes will be held in Yangon (53 trainees) and Mandalay (15 trainees), including 28 Tatmadaw trainees. Later, those who pass the BEHS exams will be allowed to attend and receive the B.Sc. (Nursing) degree after four years.

The Secretary-1 said that in 2 1/2 years 27 hospitals and 56 dispensaries have been opened in 13 border development areas in five states and one division, at a cost of K39.1 million. 185 people have been assigned to them at an additional salary cost of K4.2 million, for a total of K43.4 million, not including medicines and equipment.

Altogether, there are now in Myanmar 684 hospitals and dispensaries (including 16 special and 21 general hospitals), 4,692 nurses, 3,747 outside nurses, 7,926 midwives, 9,939 outside midwives, and 1,387 women health employees, with 380 more to be appointed. Oct. 31: The Lashio anti-drug squad on Oct. 22 seized 5.6 kilos of heroin aboard a motor vessel arriving from Hsenwi. \\ The National Intelligence Bureau uncovered a teak smuggling scheme involving bribery of officials of the Hseikkan Twp. General Administration Department (K5,000-10,000 per consignment), the Central Movement Control Committee (Sinmalaik) of the Transport and Communications Planning and Operations Department (K1,000-10,000 per vessel), the Yangon, Thingangyunn, Toungoo, and Alon Twps. Forest Departments (K4,000-40,000 per trip), and Customs Department (K5,000-70,000 per vessel). The scheme was exposed when authorities on Sept. 21 seized export quality teak on board the motor vessel Sein Hnint Mya as it was leaving for Singapore. Action will be taken. (WPD 11/1) // Nov.4: Further details of the scheme exposed, including extensive forgery of documents and involvement of various private companies and individuals. "Than Lwin, Myint Than, Khin Aung, Tin Maung Latt and U Shwe who are mainly responsible for smuggling teak out of the country are absconding. Han Khin...was arrested on 14 September 1991. Severe action will be taken against companies and merchants who are committing economic malpractices taking advantage of the market economy being practised in the country...." (WPD 11/5)
