Slogans

Regular Slogans: See January 1992 issue.

Variable Slogans: Since August 1991, The Working People's Daily has run a changing religious slogan at the top of each front page:

Sept. 1-13: Panditanan ca sevana, to associate with the wise; ; this is the way to auspiciousness.

Sept. 14-27 Puja ca pujaneyyanam, to honour those worthy of honour; this is the way to auspiciousness.

Sept. 28-30: Patirupadesavaso ca, to dwell in suitable locality; this is the way to auspiciousness.

Cartoons

Examples of political/economic cartoons:

Sept. 1: Big umbrella over tea-house patrons; man waving tiny umbrella: "Big umbrella is for use at roadside stall...small one is for use on board the bus."

Sept. 2: Man surrounded by angry creditors labeled "Rice creditor," "Cooking Oil creditor", and "Tea shop owner": "It's Pay-Day! Creditors are waiting to be paid!"

Sept. 4: Husband to wife (looking at picture of hippy on the wall): "You better have a talk with your son and daughter.... They are dressing rather out-landishly these days!"

Sept. 5: Patient to "Specialist treatment" doctor: "How much would it cost if I had only ordinary treatment and not specialist treatment?"

Sept. 6: First Myanmar: "Why did that rich man's son with 800 million become a pauper? [Thinking: "Lack of Education".] Second Myanmar: "Because he went on a pilgrimage and had to pay gate fees and to contribute cash donations all along the way."

Sept. 7: Myamar woman to husband: "Come on! Show some courage! You're only going to the market...don't be so hesitant and timid!"

Sept. 8: Women watching woman with chicken-filled basket: "Her husband is a gate-guard at the hospital."

Sept. 9: Man with tiffin-carrier knocking on a door: "Yoo hoo! I'm here for a visit... I've brought my own food!" [Note: Given the Burmese hospitality tradition of feeding anyone who appears at mealtime, this suggests a food shortage--HCMacD.]

Sept. 10: Visiting officials: "You put on quality goods...not bad at all!" Salesclerk: "Yes, we always do so." Customer: "Can't I have one at the same quality and price as the one shown just now? Clerk: But that one is only for display when authorities come for inspection. Customer (thinks): "Oh that's the way it is...."

Sept. 11: Father: "Son...haven't you got the teachership appointment for which you applied?" Son: "It is not that easy, father. Getting a degree in Education does not automatically lead to landing a job as a teacher...it requires money...K 8,000 even for the post of a school watchman. K 20,000 for the post of a PAT. K 30,000 for the post of a JAT. K 50,000 for the post of a SAT."

Sept. 12: Daughter: "Who would you want me to marry, mother, a Drug Shop Sales Clerk or a Grog Shop Server?" Mother: "Why not both, daughter?"

Sept. 13: One Myanmar to another: "I went in because a fashion

show was going on.... It was only a society wedding."

Sept. 14: Sign: "Specialist Mr. Greedy (ABCDEFGH)." Doctor (hears through stethoscope): "Please charge little for diagnosis! Please charge little for diagnosis!"

Sept. 15: Sign: "Sales Department." Clerk: "A cartoonist wants to buy some of the goods." Manager: "Is that so? Well, sell it to him! Sell it to him quickly...otherwise he might put us in one of his cartoons....!

Sept. 16: Sign: Grog Shop. First Myanmar: "They say that drinking it neat is asking for an early death.!" Second Myanmar: "Not to worry! There's absolutely no need to add water... They've already done it for us."

Sept. 17: First Myanmar (looking at sparkling building): "That's strange... everything's spick and span!" Second Myanmar: "Don't you know. A VIP's coming!"

Sept. 18: Cartoonist to friend: "A cartoonist should study logic, philosphy, etc: Wife (through door): "Here, Mr Cartoonist. You'd better study 'kitchenology' first.'

Sept. 20: Inspector to official of "Myanmar Durian Jam Co Ltd": "Ah...the work programme of your company, please." Official: "We advertised 'vacancy' thrice. Then, we sold directives of five kyats each and application forms at ten kyats each. In this way, we have no gained over K 3 million profit. Hehehe!:"

Sept. 21: "Private tutor" to colleagues: "Who will deny that we are providing invaluable contribution towards education?"

Sept. 22: Man to couple: "How come you've become so poor?"

Couple: "Well, there was a continuous stream of live-in guests at our house for months at a time."

Sept. 23: Mother to teacher: "Teacher, my son tells me that you teach him at home better than at school."

Sept. 24: Doctor pointing out "Doctor Bourgeois" clinic to friend, in smog-filled area containing signs saying "Iron smelting works", "Lead smelting", "Plastic works", "Aluminium Works", Lead smelting works", Rubber industry", "Battery Charging", Plastic works", and "Rubber compound": "Having heard this ward to be very famous, I tried my luck by opening a clinic and found it to be very....very good."

Sept. 25: One frazzled Myanmar to another: "Our Bus plies the full roster of trips \dots that is, except during the rush hour periods \dots !"

Sept. 26: Clerk (with sign reading "Avoid bribery and corruption" behind him) to client: "If you want to give something come and give it at my home, not here at office."

Sept. 27: Husband: "Hey! You bought eggs again." Wife: "You said buy something not adulterated or short-weighted."

Sept. 28: Trousered Myanmar to another: "We work in that country... Those in that country work in another...!"

Sept. 29: Superior to bureaucrat: "Make field trips. Make field trips." Bureaucrat (arrived in paddyfield): "You were asked to grow paddy. Haven't you grown paddy?" Peasant: "But they are paddy plants." Bureaucrat: "Hey! Is that so?"

Sept. 30: Client: "Amazing! Everyone's present at the office today!" Bureaucrat: "Of course! It's pay day you know!"

Sept. 18: Four years of goodwill, by Kyaw Thura. [Virtues of SLORC administration.]

Doctors Refresher Course

Sept. 5: Doctors attending the Special Refresher Course No. 2 at the Central Institute of Public Services (CIPS) at Phaunggyi gave voluntary treatment to 1,104 patients from CIPS families, Prison Department personnel, Information and Public Relations Department personnel, Tatmadawmen, and villagers. They also donated K15,105 of medicines. (WPD 9/6)

Sept. 12: Addressing the closing session of the Course, SLORC Secretary-1 Maj-Gen. Khin Nyunt reviewed Government health activities and presented prizes. "Health, he said, is interrelated with the economic, defence and social development of the country and especially, drug addiction and AIDS must be viewed not as ordinary disease but spawned by foreign cultures and combated with a national outlook. He reminded the doctors to abide by the laws, rules, orders and directives to be followed by government personnel or a citizen, saying being loyal to the State is an international code of conduct."

Prisoners Released

Sept. 8: 23 men "against whom action was taken according to the existing laws and serving sentences" were released from Pathein jail under SLORC Declaration No. 11/92 on reduction of jail terms. (WPD 9/8)

Sept. 10: 30 men were released from Insein and Pathein jails after their sentences were reduced under SLORC Declaration 11/92. (WPD 9/11)

Sept. 12: 23 men were released from Pathein jail. (WPD 9/13) Sept. 15: 18 men and one woman were released from Maubin Jail. (WPD 9/16)

Sept. 18: 32 men and one woman were released from Maubin jail. (WPD 9/19)

Sept. 19: 27 men were released from Myaungmya Jail. (WPD 9/20)
Sept. 22: 46 men were released from Hinthada and Insein Jails.
(WPD 9/23)

Sept. 28: Altogether, 529 persons have been released from

prison, and 5 from restrictions, under SLORC Declaration No. 11/ 92 of April 23, 1992 [details]. (WPD 9/29)

Curfew Ended

Sept. 10: SLORC Order No. 10/92 of Sept. 10, Deletion of Curfew

Order, provides:
 "In view of the fact that the security, prevalence of Law and Order and regional peace and tranquillity of the State have improved, the State Law and Order Restoration Council hereby deletes the prohibition 'No one shall go into the streets from 23:00 hours (11 pm) to 04:00 hours (4 am) without specific permission to do so' of Order No. 4/90 of 10th October, 1990, which was the latest amendment of paragraph 1, sub-paragraph (a) of Order No. 2/88 of 18th September, 1988, with effect from this day.

The State Law and Order Restoration Council (WPD 9/11)

SLORC Anniversary

Sept. 17: Speaking on the "Fourth Anniversary of the Advent of the State Law and Order Restoration Council", SLORC Chairman General Than Shwe told a coordinating meeting with State/Division and LORC members that "undertakings that would be beneficial only in the short term but disadvantageous in the long term are to be avoided." He urged them "to strive their utmost to make use of the materials available in the country and to avoid dependence on foreign materials." Turning to administration, he "said that proper and thorough instructions are to be given to those who would take charge of duties when the Townships are reconstituted" [see below]. Finally, he "cautioned against the danger of foreign interferences," and told officials "to beware of possible combined military and political movement of underground terrorist organizations." (WPD 9/18)

From Sept. 18-26 there were several pages of photographs in each issue depicting activities of SLORC Ministers, Deputy Ministers and other members since 1988.

Absconders Return

Sept. 21: Two people, Maung Zaw Myo Thura and his wife Ma Tin Tin Win, who absconded to India after the 1988 disturbances, returned home. They met in India and were married in 1991 [details and photo]. (WPD 9/22)

Bangladesh Border Returnees

Sept. 22: 46 persons (25 men and 21 women) were handed over to Myanmar authorities by Bangladesh Khaungton Camp official Mr. Ziauddin Ahmed, and were returned to the Kanyinchaung Reception Camp in Maungdaw Township. "The group is the first to return to Myanmar Naing-Ngan after fleeing the country.... Leaders of Myanmar Naing-Ngan and Bangladesh agreed to repatriate, after due scrutiny, those who fled Myanmar Naing-Ngan tino Bangladesh. The agreement was reached during the discussions between 23 and 28 April 1992.... Departments concerned are making arrangements to send them back to their respective areas of residence." (WPD 9/23)

Martial Law Revoked

Sept. 26: SLORC Order No. 12/92 of Sept. 26, Revocation of Martial Law Orders, reads [text]:

In consideration of the improvement and stability of the general situation in the State and in view of the interest of the people, the State Law and Order Restoration Council hereby revokes the following Martial Law Orders with effect from this day:ÄÄ

(1) Martial Law Order No 1/89 dated 17th July, 1989, of the State Law and Order Restoration Council issued in respect of the

conferring of executive and judicial Martial Law powers to be exercised by certain Military Commanders within their respective Military regions;

(2) Martial Law Order No 2/89, dated 18th July, 1989, of the State Law and Order Restoration Council issued in respect to the procedure to be followed in administering justice by the Military Tribunals.

Township LORCs Reorganized

Sept. 28: SLORC Declaration No. 14/92 of Sept. 28, Reorganization of Township Law and Order Restoration Councils, reads [text]:

It is now over four years that the State Law and Order Restoration Council formed the Township Law and Order Restoration Councils and assigned responsibilities thereto under sub-paragraph (b), paragraph 1 of Declaration No. 5/88 dated 20th September, 1988. At present the Multi-party Democratic System is being implemented within the State. In anticipation of the future administrative machinery and in order that the administrative organizations may acquire practice and experience the State Law and Order Restoration Council hereby re-organizes the Township Law and Order Restoration Councils as follows and assigns responsibilities thereto:ÄÄ

Township Law and Order Restoration Council

- (1) Staff Officer, Township General Administration Department \dots Chairman
 - (2) Township People's Police Force Commander ... Member
- (3) Staff Officer, Township Immigration and Man-power Department \dots Member
- (4) Staff Officer, Township Planning Department, or, An office of the Township level assigned responsibility by the Chairman ... Secretary (WPD 9/29)

ELECTIONS

Hluttaw Member Resigns

Sept. 23: Election Commission Announcement 1030 states that U Hkun Hsaing, elected in 1990 as National League for Democracy Pyithu Hluttaw member for Kutkai 1, has been permitted to resign "for health reasons." (WPD 9/24)

Two Hluttaw Members Die

Sept. 28: Election Commission Announcement 1031 states that U Khin Maung Aye, elected in 1990 as National League for Democracy Pyithu Hluttaw member for Budalin-2, died on Sept. 5 and has therefore been cancelled from the list of representatives. (WPD 9/29)

Sept. 29: Election Commission Announcement 1032 states that U Tun Tin, elected in 1990 as Shan Nationalities League for Democracy Pyithu Hluttaw member for Kehsi, died on Sept. 7 and has therefore been cancelled from the list of representatives. (WPD 9/30)

NATIONAL CONVENTION

Gen. Than Shwe on Convention

Sept. 15: At a coordination meeting with State/Division LORCs, SLORC Chairman General Than Shwe noted that it was almost four years since the SLORC took over State responsibilities, and that this is a term for a normal government. The Tatmadaw would not hold on to power for long and would return it to the people at an appropriate time. The coordination meeting for convening a National Convention has been held, and preparatory measures for the Convention are being taken. In the meantime, internal and external organizations as well as aboveground and under-ground groups were creating difficulties, trying to exert pressure militarily and economically while instigating the national races. He called for precautionary measures and warned

against being swayed by such attempts. (WPD 9/16)

Diplomatic Calls

Sept. 17: Indian Ambassador Shri Preet Mohan Singh Malik, who has completed his tour of duty in Myanmar, called on SLORC Chairman General Than Shwe. (WPD 9/18)

Sept. 22: Vietnam Ambassador Nguyen Van Tiep called on Minister for Forestry Lt-Gen. Chit Swe. (WPD 9/23)

Sept. 24: Korean Ambassador Hang Kyung Kim called on Minister for Planning & Finance Brig-Gen. Abel. Indian Ambassador Shri Preet Mohan Singh Malik called on Minister for Planning & Finance and for Trade Brig-Gen. Abel. (WPD 9/25)

Sept. 25: Singapore Ambassador Brig-Gen. Chin Siat Yoon, accompanied by Charge d'Affaires Lam Peck Heng, called on SLORC Chairman General Than Shwe, and on Minister for Planning & Finance Brig-Gen. Abel, and on Deputy Prime Minister Lt-Gen. Tin Tun. (WPD 9/25)

Sept. 29: Belgian Ambassador Xavier Van Migem called on Minister for Rail Transportation U Win Sein. Korean Ambassador Hang Kyung Kim called on Deputy Minister for Health Col. Than Zin. (WPD 9/30)

New Myanmar Ambassadors

Sept. 5: Myanmar Ambassador to Italy U Aung Phone left for Italy. (WPD 9/6) // Sept. 27: On Sept. 22 he presented credentials in Rome to Italian President Oscar Luigi Scalfaro. (WPD 9/28)

New Ambassadors to Myanmar

Sept. 2: The Government has approved the nomination of Mr. Valeri Vartanovitch Nazarov as new Russian Ambassador to Myanmar. He was born in 1941 and graduated from the Moscow State Institute of Foreign Relations. He entered the Foreign Affairs Ministry in 1965 and served in Myanmar from 1965-73 and 1982-88. Since February 1992 he has been Director of the Department of West and South Asia in the Russian Foreign Ministry. He speaks Myanmar and English, is married, and has two daughters. (WPD 9/3)

Sept. 25: The Government has approved the nomination of Mr. G. Parthasarathy as new Indian Ambassador to Myanmar. Ambassador Parthasarathy was born May 13, 1940. He joined the Indian Foreign Service in 1968 and has served in Moscow, Dar-es-Salaam [where your compiler knew him well], Washington and Karachi. He is currently Indian High Commissioner in Cyprus. (WPD 9/25)

Sept. 30: The Government has approved the nomination of General (Police) Mochamad Sanoesi as new Indonesian Ambassador to Myanmar. The General was born Feb. 21, 1936. He joined the Indonesian Police in 1962 and has served in various capacities; since 1991 he has been "the highest official at the police headquarters." He is married, with three daughters. (WPD 9/30)

Myanmar Rejoins Non-Aligned Movement

Sept. 1: Following a Consensus Decision at the Minsterial Meeting "for Myanmar Naing-Ngan to rejoin the Non-Aligned Movement," a delegation led by Minister for Foreign Affairs U Ohn Gyaw left for Jakarta to participate in the 10th Non-Aligned Movement Summit Meeting. The Myanmar delegation will include Ambassador to Thailand U Nyunt Swe, Ambassador to Indonesia U Nyunt Tin, Director-General of the Political Department at the Ministry of Foreign Affairs U Aye, Myanmar Charge d'Affaires to Singapore U Kyaw Myint, Counsellor of the Embassy in Jakarta Daw Than Than Htay, and Personal Staff Officer

Daw Moe Thuzar. Myanmar was a founding member of the Non-Aligned Movement in 1961. "But from 1979, due to prevailing circumstances and varied reasons, Myanmar temporarily suspended its participation in the Non-Aligned Movement for a period of time.... Due to the evolving changes taking place at present within and without the country, Myanmar believes that the Non-Aligned Movement can play an increasingly significant role in international affairs. Moreover, Myanmar is convinced that the reactivation of its membership can greatly contribute towards the long-term interests of the Movement. Henceforth, Myanmar will be taking an active part in the Non-Aligned Movement." (WPD 9/2)

Sept. 5: Speaking at the 10th Non-Aligned Summit in Jakarta, Minister for Foreign Affairs U Ohn Gyaw said Myanmar had been a founder of the Non-Aligned Movement and had "faithfully implemented its fundamental principles even during the period when we were not able to have active participation in its formal gatherings for a number of years in the past." Today, he said, the Movement "has a new relevance and more crucial role to play, and assist, to effectively bring about a new world order of peace, security and justice" While an end to East-West confrontation has been achieved, "there remain other major and unresolved issues...such as the protection and preservation of our hard-won independence and sovereignty, attainment of disarmament objectives, elimination of racism and racial discrimination, pacific settlement of disputes among states, preservation of the environment through sustainable development, the promotion of human rights free of extraneous and ulterior motives, and the pursuit of equitable economic relations."

He noted widespread concern "as to the unwelcome tendency by a few major states to take advantage of the institution of the United Nations towards adoption of policies and activities against the interest of the vast majority of states that consitute the international community." He endorsed the Summit's promotion of human rights, but noted that human rights must include all areas, "including cultural, economic, social, educational, political, civil and not the least for developing countries such as Myanmar, the right to a decent and honourable livelihood with adequate food, clothing and shelter." Human rights must take account of each countries circumstances, and "cannot and should not be promoted through pressure and confrontation."

He endorsed the Rio environmental summit, noting the "our joint objective to achieve sustainable development giving due regard to environmental concerns." Finally, noting the adverse international economic situation, he said that Myanmar perceived "the necessity to reverse trends towards unilateralism and protectionism." (WPD 9/6)

Sept. 9: Minister for Foreign Affairs U Ohn Gyaw returned. (WPD 9/10)

Sept. 10: Following his return, Minister for Foreign Affairs U Ohn Gyaw was interviewed by the Myanma News Agency (Internal). He summarized the Jakarta Message of Sept. 6 issued by the Summit, and discussed Myanma's bilateral talks in Jakarta.

He had had a warm meeting with Indonesian Foreign Minister Mr. Ali Alatas. He had met with the Brunei Foreign Minister and agreed on "speedy establishment of diplomatic relations between the two countries." He had had a cordial meeting with Philippine Foreign Minister Mr. Roberto Romulo. He and Bangladesh Foreign Minister Mr. Mustafizur Rahman had cordial discussions "on immigration matters between the two countries based on the points of agreement reached between the two countries." He had briefed, and asked for support at the UN from, New Zealand Foreign Minister Mr. Don MacKindon and Spanish Deputy Foreign Minister Mr. Inocencio Arias, who were observers at the Jakarta meeting.

Following an invitation from Thai Foreign Minister Mr. Arsa Sarasin he had stopped over in Thailand from Sept. 6-8, on his way home, and had discussions during which the Thai side proposed the creation of a Joint Myanmar-Thai Commission co-chaired by the two foreign ministers. (WPD 9/11)

Sept. 23-24: A Letter from Jakarta, by Moe Moe. ["Dear Mee Mee, Cowabunga! I still can't believe that I'm actually here in Jakarta for the NAM Summit!" Journalistic account of NAM meeting.]

Diplomatic Housing

Sept. 14: One of four Ambassadorial residences, and 3 of 12 secretarial residences for diplomats have been completed in Bahann Twp. [Yangon] and are ready to rent. They were built by the Engineering Department (Buildings) of the Yangon City Development Committee starting in Sept. 1991. A second Ambassadorial residence and three for secretaries are under construction. The project area covers 8.9 acres. Each Ambassadorial residence is 78' x 58' with telephones, hot and cold taps, air-conditioners, bathrooms and toilets for every bedroom, and separate garages. Each will have a swimming pool and small garden. Residences for secretaries have similar facilities. "The residences for diplomats will be rented in US dollars." (WPD 9/15)

INTERNATIONAL COOPERATION

Workshops

Sept. 3: A 6-day Regional Workshop on Pesticide Residue Trials opened at the Medical Research Centre, jointly sponsored by the Ministry of Agriculture and the FAO (Pacific and Asia Region). A similar workshop, on safe and efficient use of pesticides, was held in Yangon in Feb. 1991. It is being attended by 17 representatives from Bangladesh, China, India, Indonesia, Republic of Korea, Malaysia, Nepal, the Philippines, Sri Lanka, Thailand, Vietnam, Japan, and Myanmar. Licensees may produce, sell, and export salt and chemical salts/by products freely, use foreign exchange from exports to buy chemicals, materials, and apparatus, and apply for long-term and expansion approval. The Managing Director of the Myanma Salt and Marine Chemical Enterprise, under the Ministry of Mines, will enforce the law and provide inspectors. Use of "woodfire or charcoal" to produce salt is prohibited. (WPD 9/19, correction 9/23)

They also said that a fish breeding pond stretching 5.76 acres could earn about K 60,000 equivalent to the sum invested for the business." (WPD 9/8)

Sept. 13: The Ministry of Agriculture issued Reminder No. 3/92:

"As there was enough rain in the middle of the rainy season,
cultivation of paddy was successful and paddy plants grow well, and
so farmers must attend to the paddy plants for successful yield.
Farmers have to take measures such as weeding, stirring, irrigation,
fertilizing, and so on for successful yield. The most important thing
is irrigation. Water must be stored as much as possible in the late
monsoon not only for successful yield in this season but also for
double cropping and winter crops. Systematically using stored water
and insecticides also play an important role. The farmers are also to

The reasons are: people have much less time to attend performances; they are poorer because of inflation (from which Myanmar once believed itself exempt), and

younger audiences are not familiar with the 'jatakas' on which most 'zat' plays were based. (4) "National resilience." Like the Pyittaing-htaung, "the Standup Guy who bounces back every time you give a shove or a nudge", Myanmar has always bounced back from challenges.]

35 Gays Arrested

Sept. 22: [full text]

"35 men caught having sex at public toilets and guest houses

"After receiving information that some persons of the same sex
were having sex at underground toilets and guest houses in Yangon
City Development Committee area, authorities concerned arrested 35
such persons between 10 and 13 September. The men who are in the age
limit of 20 and 56 were arrested with photography supporting their
unnatural act. It was revealed, after investigations, that most of
them are homosexuals who lured men into fulfilling their desires with
the promise of money or free of charge. Effective action will be

taken against the 35 men." (WPD 9/23)

Sept. 26: Editorial: Avoid temptations. ["More, one of the news carried by papers on 23 September give an alarming report about arresting altogether 35 gays. They were actually unearthed at underground water-closets and at some guest houses. In reality they are or may be repositories of HIV. They developed it without testing positive for the virus. The satisfaction gained by means of homo-sex may be free of charge or of little charity which can be counted by minutes of single digits or a little bit more. However, retaliation of this is frightening. Causes of HIV infection are mostly of drug addiction, homo-sex, prosecution, promiscuition and receiving HIV positive blood [sic]."

Building Collapses

Sept. 24: A three-storey building in Bahann Twp. [Yangon], nearly completed, collapsed. 12 of 14 workmen rescued were taken, badly injured, to hospital; at least 4 workers are still missing. [photo] (WPD 9/25) // Sept. 17: The body of Maung Tun Tun Win was pulled from the wreckage after a long search. Five persons died in the collapse, and 13 were hospitalized, with two of them seriously wounded. The contractors have been arrested. (WPD 9/28)

Corrupt Yangon Officials Fired

Sept. 24: Four members of the Yangon City Development Committee were dismissed on Sept. 23, "for misusing rights and engaging in unscrupulous activities in implementation of the Bayintnaung Brokerage Construction Project in Mayangonn, in breach of rules and regulations of the committee." U Thein Htoo, U Hla Pe, U Kyaw Han, and U Aung Myint "obtained sales rooms at the Bayintnaung Brokerage. In addition, Head of Engineering Department (Buildings) U That Sin, Deputy Head of Department U Khin Maung Yi, and Assistant Engineer U Myint Swe of the YCDC were "also dismissed from their poses for breaching rules and regulations, misusing rights and engaging in unscrupulous activities." (WPD 9/25)

Castaways Return

Sept. 26: 77 out of 100 Myanmar fishermen who were cast away in "a neighbouring country" because of a storm returned by Myanma Airways from Port Blair, India. Arrangements are under way to repatriate the others. (WPD 9/27)
