Mothers, children in Sittway receive cash assistance for nutrition

Thursday, 15 February 2018

Under a programme to help pregnant women and children under 2 years of age, expecting mothers, toddlers and babies in Sittway and at the Thakkepyin IDP camp received cash assistance yesterday.

The programme is aimed at providing nutrition to children within 1,000 days after birth.

The cash was presented to mothers and their children yesterday by Union Minister for Social Welfare, Relief and Resettlement Dr. Win Myat Aye and local authorities. More than 8,000 mothers and children are eligible to receive the cash assistance under the programme, which is being carried out in Chin State, Rakhine State and the Naga Self-administered Zone.—MNA

Myanmar Permanent Representative to the United Nations delivers a Statement at Security Council on Government's efforts in Rakhine State

NEW YORK, 13 Feb — The United Nations Security Council held a briefing session regarding the situation in Myanmar at its Chamber in New York on 13 February 2018. At the session, U Hau Do Suan, Permanent Representative/Ambassador of Myanmar delivered a statement at the Council on the Government's efforts on restoration of rule of law, peace and stability, preparation for repatriation of displaced persons from Rakhine State, and implementation of the Rakhine Advisory Commission recommendations. Some salient points of his statement are as follows:

- Myanmar has been cooperating with the United Nations in its efforts to alleviate the current humanitarian problems and to achieve its objective of sustainable solution to the issue of Rakhine State.

- Myanmar and Bangladesh have made significant progress in their bilateral efforts for repatriation of displaced persons. Myanmar will draw on the services of the UNHCR as needed and at the appropriate time. - Myanmar has already provided Bangladesh with information relating to the resettlement plan, provision of livelihood assistance, access to basic services, and safety arrangements for verified returnees.

Yangon-Mandalay Road to be upgraded to international standard with ADB assistance

THE first 40-mile section of the Yangon-Mandalay Expressway, on which hundreds of traffic accidents occur every year, will be upgraded to international standards with the assistance from the Asian Development Bank (ADB), said Deputy Minister for Construction U Kyaw Lin.

He made the comment at the Pyithu Hluttaw yesterday in his answer to the question of whether the government has a plan to upgrade the road to a modern four-lane road in order to decrease road accidents, to install modern monitoring and safety equipment and to enforce traffic rules along the road.

"The cabinet has allowed us to get a loan from ADB to upgrade the section from 0 mile to 40 miles starting from Yangon, and we will submit our plan to Pyidaungsu Hluttaw soon," said Deputy Minister U Kyaw Lin.

The condition of the road does not meet international standards in three ways -- speed, comfort and safety, he said.

Though the road was targeted to be constructed meeting the expressway standard, use of the road was allowed before the road met the international standard, said U Kyaw Lin.

In attempts to reduce traffic accidents, road signs, rumble strips, road lines, road lane and solar lamp posts are installed at 22 places where road accidents mostly happened.

The major cause of traffic accidents is speeding, and it has been discovered that the number of traffic accidents has decreased dramatically as speed limits have been imposed and pointed out that it is necessary to set up sign boards for road safety along the expressway.

Actions have been taken against more than 22,600 vehicles from 2016 to 2018 for breaking traffic rules.— Kyaw Thu Htet, Mi Mi Phyo/Myanmar News Agency

The meeting was attended by the Pyidaungsu Hluttaw Deputy speaker; Joint Bill Committee and Public Account Joint Committee Chairman U Aye Tha Aung; the joint bill committee and public account joint committee deputy chairmen; secretaries, joint secretaries and committee members; Legal Affairs and Special Cases Assessment Commission members: and officials from the Ministry of Planning and Finance, Union Attorney General's office and the Pyidaungsu Hluttaw office. -Myanmar News Agency

Motion to conserve natural resources as national duty passed

THE MPs of Amyotha Hluttaw debated the depleting environmental resources in Myanmar at the Amyotha Hluttaw yesterday, and urged the union government to provide protection to the country's natural resources.

The debate focused on the preservation of the country's natural resources as a national duty, submitted by MP U Pe Chit of the Yangon region constituency (9) to the Hluttaw. In his discussion, U Khin Myo Win of the Taninthayi Region constituency (12) pointed out that five factories in Myeik, Taninthayi Region, are using some 300 tonnes of fingerlings a day to produce chicken and duck feed, and they were also using some 20,000 tonnes of firewood every year to run the factories.

"Short-term and long-term plans are required to save millions of fingerlings that are being used to produce feed," said U Khin Myo Win. Six MPs also participated in the discussion. Union Minister for Natural Resources

and Environmental Conservation U Ohn Win explained the measures adopted by the ministry, pledging that the extraction of natural resources would be conducted with accountability and responsibility towards sustainable development.

In response to the motion,

the union minister also acknowledged that the natural resources of the country need to be conserved. To implement the tasks prescribed in the Environmental Conservation Law, the union government formed a national-level body for environmental conservation, headed by Vice President U Myint Swe, as well as work committees and region/state supervisory committees for environmental conservation that were formed on 2 June 2016, he said. The union minister also called for cooperation from all sectors, including government, non-government organisations, region/state governments and local people, to ensure environmental conservation is a success, and urged the Hluttaw to put the motion on record. The motion was passed by 92 votes to 82, with four abstentions.—Aye Aye Thant (Myanmar News Agency)

Myanmar Permanent Representative to the United Nations delivers a Statement at Security Council on Government's efforts in Rakhine State

- Myanmar is ready to receive the first group of returnees and will continue to work in close consultation and cooperation with Bangladesh for the voluntary, safe and dignified repatriation of the displaced persons in accordance with the bilateral agreement.

- In recent days, members of the Diplomatic Corps and representatives of the UN Agencies including UNHCR, WFP, FAO and World Bank, have been given access to Maungtaw area to observe preparation for repatriation and the situation on the ground. The Government has also arranged day-trips to Rakhine State for the Diplomatic Corps and UN agencies residing in Myanmar in three groups in February.

- The Minister for Home Affairs of Myanmar will visit Bangladesh on 15 February to discuss with his counterpart on matters relating to cooperation in repatriation as well as to find solution to the problem of people stranded on Zero line of the border.

- The Government has the primary responsibility to protect its own people. As lives in the affected areas return to normalcy, the police forces have largely taken over security responsibility in most part of Maungtaw District. Although no major clashes with the terrorists have been reported in the past six months, there is always a threat of ARSA terrorists who are taking refuge among innocent peoples. They will take every opportunity to undermine law and order and public security. They will not hesitate to use their brutal tactics of intimidation and killing innocent people who want peaceful life and living in harmony with other communities in Rakhine. The recent media reports on the killing of two camp leaders from refugee camps in Bangladesh sent a warning to those who want to return to their villages.

- On humanitarian assistance, the Government and the Union Enterprise have been providing food and household needs to all communities in Rakhine States in addition to building infrastructures and business activities for economic development of the region. The Red Cross Movement and the ASEAN Coordinating Centre for Humanitarian Assistance on Disaster Management (AHA Centre) are actively participating in the Government-led mechanism to deliver humanitarian assistance in affected areas.

- An Advisory Board headed by Dr. Surakiart Sathirathai, former Deputy Prime Minister and Minister for Foreign Affairs of Thailand was formed to provide external perspective and advice to the Committee for the Implementation of recommendations on Rakhine State.

- Concerning allegations of human rights violations, the Government of Myanmar has always made its position clear that it will not condone any action of abuse. If there is concrete evidence, action will be taken against the transgressor in accordance with the law no matter whom or what he is.

With regard to the Reuters report in December last year on the finding of 10 bodies in a cemetery in Inn Din, Maungtaw, the Tatmadaw has already formed a high level enquiry team and conducted investigation on the incident. It was found out that 10 ARSA members were arrested by the security forces on 1 September 2017 soon after the terrorist attacks on 25 August. The next day, on 2 September they were executed and buried in the village cemetery without handing over to the Police. Therefore, actions are being taken against 16 individuals including army and police officers and some villagers who had acted in violation of standard operating procedures and rules of engagement. This action of the Tatmadaw is a positive step forward in taking responsibility and deserves encouragement.

- Achieving durable peace, harmony and development in Rakhine State is contingent upon the nation-wide peace and the success of democratic transition of Myanmar. The greatest national endeavour for Myanmar today is to forge a lasting peace.

- Without peace and stability and

rule of law, the country will not be able to realize its ultimate goal of building a genuine democratic federal union which will guarantee security, freedom and progress for all the people.

- On 13 of February, 2 ethnic armed groups, namely New Mon State Party (NMSP) and Lahu Democratic Union (LDU) have signed the Nationwide Ceasefire Agreement (NCA) in Nay Pyi Taw, bringing the total NCA signatories to 10.

- The current humanitarian crisis is the consequence of terrorist attacks against security posts. It was a clear present threat to the security, sovereignty and territorial integrity of Myanmar. It is not a religious issue as some people are trying to portray. The majority of Muslims living in other parts across Myanmar have been living peacefully and in harmony with other people of different faiths throughout history.

- The challenges facing Rakhine State has no easy quick fix. Ultimately, it is up to the people of Myanmar to determine how to achieve a peaceful and prosperous Rakhine State.

- Myanmar welcomes constructive cooperation from the international community. Myanmar should not become hostage of the one-sided media and activists in policy making process. Important judgment and policy decision should be based on careful examination of the information.—Myanmar News Agency

Ministry granted 1,605 hotel licenses in January

MORE than 1,600 hotels and guest houses, renting out over 64,500 rooms, were operational across the country as of the end of January 2018, according to the Ministry of Hotels and Tourism.

The Ministry of Hotels and Tourism has approved licenses for these hotels, after carefully reviewing the hotels' applications, to ensure tourist can travel conveniently throughout Myanmar.

There are some 390 hotels and guest houses with 20,245 rooms in Yangon, 208 hotels with 8,676 rooms in Mandalay, 141 hotels with 4,401 rooms in Taunggyi and Inle and 85 hotels with 2,919 rooms in Bagan and Nyaung U.

The number of hotels and guests houses which were granted licenses by the Ministry Hotels and Tourism has increased every month.

Also, the ministry has granted some 2,638 travel and tour agency licenses, including to 2,596 companies owned by local residents. In addition, the ministry has granted 2,548 transport licenses, 4,380 guide licenses and 3,449 regional tour guide licenses, as of January 2018.

Among the 14 states and regions, tourists primarily visited Mandalay and Yangon regions and Shan State. Some 3.44 million tourists visited Myanmar in 2017, 2.91 million in 2016 and 4.6 million in 2015.

The number of hotels and guests increased from May 2015 to January 2018 by 457 hotels with 19,247 rooms.— Zwe

Some 95 domestic investment enterprises permitted

DOMESTIC investment, including increased investments, reached Ks3.37 trillion (over US\$900 million) as of the first week of February in the current fiscal year (FY) 2017-2018.

This FY, the Myanmar Investment Commission approved 95 local enterprises. Those domestic investments are engaged in electric power, real estate development, transportation and telecommunications, livestock and fisheries, hotel and tourism, industrial estate development, agriculture and other service sectors.

The Real Estate Development sector absorbed most of the domestic investments, as detailed by the Myanmar Citizens Investment Sector.

According to the new Myanmar Investment Law, region and state DICA offices are authorized to approve investment proposals with capital of not more than \$5 million. Land leases are also to be authorized from regional offices. In addition, tax relief for investments will be available, depending on the set investment zone. – Ko Htet ■

Thailand-Myanmar border trade reaches US\$1.2 billion

THE value of border trade between Thailand and Myanmar between 1st April and 2nd February was more than US\$1.2 billion in the current fiscal year (FY), which is an increase of \$97 million over the same period in the last FY. Thai-Myanmar border trade is carried out through the Tachilek, Myawady, Kawthoung, Myeik, Hteekhee, Mawtaung and Maese gates.

Of these seven gates, Myawady gate is the main access point for Thai-Myanmar trade, though trade value was \$6 million less than last FY. Similarly, Hteekhee also shows a slight decline in trade. The remainders show increases in trade. Exports through the Kawthoung and Myeik checkpoints significantly surpassed imports.

Export values were \$71 million at Tachilek gate, \$751 million at Myawady, \$159 million at Kawthoung, \$211 million at Myeik, \$10 million at Hteekhee, \$5.8 million at Mawtaung and \$0.75 million at Maese. Thailand exports cosmetics, machinery, food products, agricultural equipment and trucks into Myanmar, while marine products (various fish, dried shrimp and fish, fresh crabs) and agro products (onions, sesame seeds, turmeric, corns, etc) were exported to Thailand.—Ko Khant

Five containers of Taro leaf-stems to be exported to S Korea

FIVE containers of dry Taro leafstems (petioles) will be exported to South Korea this fiscal year, according to U Aung Ye Myat, a merchant from Pantanaw Township, Ayeyawady Region.

"Currently, we are planning to annually export more dry Taro-leaf-stems to Korea. The price of dry Taro leaf-stems has increased. On the other hand, South Korea has also offered to buy double the amount of dry Taro leaf-stems. Recently, Korea began buying dry Taro leaf-stems, which are grown in Ayeyawady Region and Shan State, he added.

Dry Taro leaf-stems grow naturally in the Ayeyawady Region. Foreign demand has increased because Taro leafstems are healthy and are not grown using chemical fertilizers.

Taro leaf-stems grow during the rainy season in rural areas. Taro leaf-stems are grown in Nyaungdon, Maubin and Pantanaw Townships.

There are six types of Taro leaf-stems. The price of dry Taro leaf-stems is Ks 2,200 per viss. In Shan State, the price of dry Taro leaf-stems is Ks 2,500 per viss, depending on the distances in which they are transported to market.

Dry Taro leaf-stems are also exported abroad. Recently, local farmers began buying land to cultivate Taro in order to prevent a scarcity of Taro leaf-stems. — Zar Lin Thu (AMIA)

All-round cooperation needed to practice OSH system

More than 100 workers are subject to occupational accidents each year, based upon a survey conducted at factories, workshops and stores, in accordance with the Factories Act 1951. This figure excludes accidents in other workplace locations.

According to a report based upon the Myanmar Labour Force Survey 2015, the country has a labour force of 44.8 million people, more than 51.7 per cent of which is working in the agriculture industry. The industrial sector accounts for 16.8 per cent of all workers, while 31.5 per cent are engaged in the service sector. If those sectors are included in the survey, the rate of occupational accidents and deaths rises higher.

Global estimates of occupational accidents and work related diseases, issued by the International Labour Organization (ILO), claims that a worker dies from a work-related accident or disease every 15 seconds, at a rate of an estimated 2.3 million lives per year. It also claims that some 317 million workers suffer from accidents. This announcement also points out that a lack of occupational safety leads to a nation's 4 per cent loss in GDP. In Myanmar, there were overall 156 cases of work-related accidents from 1st January 2017 to 3rd December 2017, with 49 minor cases, 82 serious accidents and 25 fatal cases, according to a table of work-related accidents.

The Factories Act 1951 was amended in 2016, however, the new law fails to cover occupational safety in every workplace. The Occupational Safety and Health Law (draft) submitted to the Pyidaungsu Hlutttaw in February 2017 is now in the hands of the Bill Committee of Pyithu Hluttaw. After this law is instituted, OSH activities will be obligatory for all employers. U Nyunt Win, director-general of the Factories and General Laws Inspection Department, said that prior to enactment of the OSH bill, educational campaigns regarding occupational safety were conducted at factories and workplaces, in cooperation with ILO.

"The OSH law, which is soon to be developed, is regarded as an umbrella law. The formation of the OSH committee and assignments are embodied in this bill. It highlights the joint agree-

ment between employers and employees. Procedures for formation of safety committees and inspections to identify safety and health hazards and training in the workplace are incorporated into this bill", he noted.

At present, employers and workers usually agree to mutual understandings about compensation following occupational accidents. Cases requiring action under the underlying laws are seldom seen.

Employers are reluctant to execute OSH activities due to weaknesses in the law and regulations, along with the high cost of OSH activities, U Nyunt Win said.

"Employers have little interest in the Occupational Safety and Health process. Most of them are concerned over high costs, and those activities are virtually meaningless to them. We can even count on the fingers of hands number of businesses which practice OSH system", said Director-general U Nyunt Win.

Weak OSH processes, a lack of leadership, a minimum budget to carry out the OSH process, workers who have little knowledge about OSH, and workplaces in far-flung areas in which labour inspectors cannot easily reach, are contributing factors to the high rate of work-related diseases and accidents, said U Kyaw Kyaw Tun, deputy director of the Factory and General Labour Law Inspection Department.

OSH requirements include having a proper working environment with specific lighting, protective measures to guard against chemical and toxic hazards, electrical safety and workstation ergonomic designs. Additionally, purchasing safe machines, using safe feeding and ejection devices, placing guards around dangerous parts and regular maintenance, are a must to ensure safety around machines.

Occupational safety does not count solely on the leaders and employers. U Naw Aung, deputy chairman of Myanmar Industries Craft and Services Trade Unions Federation (MICF), stressed flaws found in both the government and employees.

Regarding occupational safety and healthy activities, the government's law enforcement is also weak. Employers need to create a happy work environment for workers by providing necessary facilities to assure occupational safety, he noted. Workers also need to avoid careless actions, such as working without wearing gloves, masks, safety boots, and more. Workers need to recognize the risks of possible work-related accidents and diseases.

"The government's supervision and law enforcement is the most critical thing. All those stakeholders who are links in the chain of events show weaknesses", he continued.

SMEs and garment industries, which form the basis of Cutting, Making and Packaging systems, have a strong labour force which must adopt OSH processes, said U Aye Thaung, chairman of the Shwe Lin Pan Industrial Zone. OSH related certificates are required for CMP based garment factories linked with Europe, the USA and Japan, and so they hire doctors and nurses in the workplace. The government requires creating educational campaigns about OSH, and providing subsidies for carrying out the OSH processes.

"Prevention measures are needed to prevent accidents. If the government cannot provide financial assistance to small enterprises which cannot afford to carry out OSH activities, they should link with organizations for funds", said U Aye Thaung.

Dr Khin Maung Lwin, Managing director of Fame Pharmaceuticals, who has been recognized by ASEAN for carrying out OSH activities in the workplace, points out that quality management systems, environmental management systems and occupational safety and health systems must work in harmony to have a successful business.

"Those employers that put in place OSH systems gain considerable prestige", he noted.

Carrying out OSH activities is likely to reduce medical leaves, prevent risks of fires, create a proper workplace and build good relation between employers and employees. Therefore, businesses following OSH system can save more money in the long term and promote businesses' reputation, said Dr. Khin Maung Lwin.

In 1972, the Occupational Safety and Health Review Commission (Central) adjudicated the working functions at factories, forming sub-committees. After 1988, this committee was dissolved. There are now stacks of occupational accident records at the Social Security Board and the Factory and General Labour Law Inspection Department under the Ministry of Labour, Immigration and Population, as well as related departments under the Ministry of Health and Sports, said Dr Than Htut, retired deputy director (Occupational Health) of the Ministry of Health and Sports.

"The lack of occupational safety causes disabilities and even fatalities. The workplace must have occupational safety measures and related educational events for their workers. It also needs to support training, when it is required", he added.

Occupational safety is compulsory for the workplace, due to changing working conditions, and in line with introduction of new technologies, said OSH trainers.

"OSH is a right of workers, and its use creates prestige for employers. OSH activities might seem like a burden on employers, but they will reap benefits to the state, employers and workers, in the long term. Thus, all-around cooperation is required by the state, employers, employees and social welfare organizations, said U Ohn Myint, patron and advisor of the Wisdom World Company, which provides OSH training.

Poor human resources and financial conditions in Myanmar results in a rising toll of work-related accidents and diseases in SMEs, which remain the driving force of Myanmar's economy. As a consequence of this, accidents can harm productivity rates and it can also affect the country's economic growth, somehow.

NCA signatories: We are ready to work together to create the Federal Republic

THE news team interviewed participants at the signing of the Nationwide Ceasefire Agreement (NCA) by the New Mon State Party (NMSP) and Lahu Democratic Union (LDU).

Colonel Wunna Aung, Secretary (1) of Joint Monitoring Committee

We will be monitoring if organisations are following the military rules and regulations, as well as the NCA rules. We might send inspection teams for that, but our main goal is to reduce difficulties for everyone.

U Yar Htep, Shan State Minister for Lahu Ethnic Affairs

Our region still lacks good healthcare, education and basic infrastructure, but by cooperating with the union government, we hope to provide better opportunities to the ethnic people. Peace is crucial for the country's development and to achieve that, firstly, all ethnic groups must be united, and secondly, all ethnic groups must have mutual respect. If we can achieve that, then we can develop each region, state and the nation.

U Khin Zaw Oo, Secretary of Peace Commission

On 15 October 2015, the union government and eight ethnic armed organisations (EAOs) signed the Nationwide Ceasefire Agreement, and now, after numerous meetings, we have two additional signatories to the NCA. In southern Myanmar, there is Kayin State, Mon State and Taninthayi Region, and of the three, only Mon State had not signed the NCA and was not involved in the peace effort and development processes. However, now that the New Mon State Party has signed the NCA, we can assume that all of lower Myanmar is on the right path towards lasting peace. We have not closed our doors to anyone for peace talks. There have been unofficial meetings with EAOs, but we cannot officially announce anything yet.

The NMSP alone cannot bring about change, so we are ready to work together with everyone to create the Federal Republic.

Dr. Tu Jar, Kachin State Democracy Party

Civil war is a political problem that needs a political solution, and everyone knows this. Especially in 2010, during President U Thein Sein's administration, people have come to accept this and have engaged in talks, as opposed to using force. Eventually, this led to the forming of the NCA and holding of discussions based on it. Not all EAOs have signed the NCA, because there are some points in it that they want to amend. During the meetings leading up to the NCA, we can at least achieve a temporary ceasefire scenario, which may help us build trust in each other. The delegation for political nego-

Environmental impacts are the biggest problems, and they will impact people's lives.

The matter of environmental conservation and climate change needs to be coordinated and conducted up to international norms and standards.

It is important for the Union government and states and regional governments to work in coordination. The environmental conservation projects need to be approached with thoughts on the duties and responsibilities of states and regions in a Democratic Federal Republic system.

Citizen's Budgets – Democracy in Action

As Myanmar moves towards greater decentralization of political power and fiscal responsibilities, how is the current conversation between governments and citizens shaping up?

MYANMAR is currently in the midst of a historic shift towards more democratic and responsive government, spurred by the creation of elected state and region governments. Local politicians at subnational level must now win elections, conceptualize policies and manage their own budgets to best to respond to their citizens' needs. In theory, such decentralization of political power and fiscal responsibilities, away from the center and closer to the people, is perceived to be a good thing.

If a productive dialogue between governments and citizens is central to a functioning democracy, then decentralization brings the two parties closer, facilitating a smoother conversation and allowing the government to hear and respond to voices it would have missed from further away.

However, closer proximity alone does not directly result in more fruitful conversations and a more responsive government. Equally important is the quality of these conversations as they ultimately contribute to a stronger social contract between governments and people. The quality of the conversations between government and citizens depends on various elements: fair and open elections, the dissemination of accurate information, mechanisms of accountability, the free exchange of ideas, and strong rule of law, for instance. Many of these elements will take time to strengthen during this critical period of transition in Myanmar's history, begging the immediate and fundamental question - how is the current conversation between governments and citizens shaping up?

Initial decentralization efforts created a strong demand from citizens for information about how their government works and their own role in emerging democratic structures. After decades of centralized dictatorial rule, the citizens' enthusiasm to engage and participate in the decisionmaking process that affect their lives carries is hopeful and encouraging. International and local NGOs have attempted to meet these demands by producing public documents on a range of topics including new government structures, the responsibilities of Hluttaws, and public finances. More recently, however, state and region governments have begun responding to these demands and have themselves started reaching out to citizens.

This year, six state and region governments (Ayeyarwady, Bago, Kayin, Mon, Kayah, and Tanintharyi) have followed the central government's lead and published their own Citizen's Budgets, a document presenting key public finance information to a general audience. As the name suggests, it is meant to provide government budget information to citizens. By presenting budget information in a more accessible format, Citizen's Budgets foster a greater understanding of how public money is being used. The release of these documents demonstrates a significant government



effort toward fiscal transparency and stronger democracy for multiple reasons.

First, at the most fundamental level, Citizen's Budgets are a crucial step governments at different levels made towards meaningful interactions with citizens as they share information that would have been arduous for anyone to acquire just a few years ago. These documents not only increase transparency, but also give citizens ownership of information that is geared toward serving their

Second, behind the push for transparency lies the governments' increasing willingness to conduct a conversation with its constituency, an early sign of strengthening channels of communication between the government and its citizens. It encourages civic engagement with the government process, and their participation can lead to more informed budget and policy decisions, and ultimately, better development outcomes.

Third, subnational Citizen's Budgets reflect a rare exercise of local authority. Although releasing Citizen's Budgets mirrors the initial step taken by the Union government, a closer look reveals differences across states and regions in how the subnational governments have approached their constituencies in this regard. These diverse approaches demonstrate increasing state/region government ownership over its responsibilities, and should encourage cross-state and region learning opportunities.

Building a responsive and democratic government necessitates time and effort. A productive conversation between governments and their citizens will require building trust, and must be founded on a capable and engaged citizenry and a transparent government. In this regard, the conversation between governments and citizens in Myanmar has a long road ahead; however, Citizen's Budgets are a strong step in the right direction.

MR to build ten diesel locomotives this year

MYANMA Railways (MR) will build ten diesel locomotives this year, according to a report in 13 February's Myawady Daily.

The MR will build ten locomotive workshops in Nay Pyi Taw and Myintnge at the end of February. Locomotives will run on 2000- HP diesel engines and operate at speeds of up to 100 km (70 miles) per hour. According to the upgrade project, launched in 2015, the MR will build 22 locomotives and 60 train coaches.

Currently, the MR is operating the Yangon-Mandalay-Pyay rail service with the use of 12 locomotive and 39 coaches.

"The building of locomotives included in this project will be completed this year. The MR will continue producing locomotives, if its receives necessary monetary assistance," said U Aung Win, the General Manager of MR.

Nay Pyi Taw locomotive workshop has received equipment for five locomotives, with the remainder still to be delivered. The assembling of the locomotives can begin at the end of February.—GNLM

Over 2,500 dengue cases, 27 deaths, recorded in Rakhine State last year

RAKHINE State recorded more than 2,500 confirmed cases of dengue fever in 17 townships last year, said Dr San Kywet Khine, Assistant Director of the state Public Health Department.

According to the Myawady Daily's Tuesday report, the cases of dengue haemorrhagic fever (DHF) in Rakhine State significantly increased, when compared with the previous year.

As reported in hospital-based data, the number of DHF cases increased in Sittway, Minbya and Taungup townships in 2017. The disease killed 27 people, mostly in Sittway, Kyauktaw and MraukU townships. The most affected age group was children between 5 and 10 years of age, according to physicians.

Dr San Kywet Khine said the health department continues to carry out preventive measures against dengue fever in every ward and township since the beginning of this year.

In Myanmar, the disease used to be more common in the rainy season, but now DHF transmission occurs throughout the year, said physicians.

The virus has been particularly prevalent in flood-affected areas that provide ideal breeding grounds for mosquitoes. Lack of sanitation, unhygienic water storage and overcrowding are mainly blamed for causing the deadly infectious disease.

There were more than 42,900 confirmed cases of dengue fever, with 140 deaths, in the country in 2015. However, these figures dropped to 10,770 cases with 58 deaths the following year.—GNLM

Middle-aged man hurt in mine blast in Myitkyina Township, Kachin State

A local resident sustained serious injuries in a mine explosion near Nangkwechaungpya in Myitkyina Township in Kachin State on Monday in the early morning.

The 42-year-old man, identified as U Ngwa Lay, a resident of Area-14, Shwesettaw Ward, was searching for his cattle in a field near Nangkwechaungpya when the explosion occurred, injuring his left arm and leg. He underwent surgery at a 300-bed military hospital.

Four other people were also hurt in mine explosions near Tanai Township, Myitkyina District, Kachin State, on 19 January and 20 January. —Win Naing (Kachinmyay) ■

Two high school students killed in traffic accident

TWO high school students were killed in a collision between a farm tractor and a motorbike in Bago Town on Union Day, which fell on 12 February, according to the police.

The motorbike, which had no number plate, was driven by Maung Maung, an 18-yearold student, traveling with two others onboard. Officials said the bike collided with the tractor, driven by Ko Thu, 22, who resides in Mazin Ward in Bago Town. The accident happened near Power Restaurant at the edge of Socialist Street-23 in Shinsawpu Ward in Bago at around noon.

The motorcyclist, Maung Maung, was pronounced dead at the scene, while Zin Bo, a 16-year-old student, one of the bike's passengers, was rushed to a nearby hospital where he died during treatment.

The drivers of the tractor and motorbike have been charged under Section 304 (a), 337 and 338 of the Penal Code, with careless driving.—Tin Soe (Bago) ■

Taxi driver escapes from vehicle fire

An taxi caught fire in Kamayut Township, Yangon, in the early morning of Tuesday, 13 February, according to the township Fire Services Department.

The fire occurred in front of the Yangon Institute of Marine Technology on Bayintnaung Road at about 5.54 am. The taxi, driven by U Zeya Tun, 38, caught fire while enroute to Kyimyindaing Township. The cause of the fire was believed to be an overheated engine.

It is not clear whether the taxi was in service at the time,

but it is known that there were no passengers on board.

Authorities say the vehicle was engulfed in flames when firefighters arrived. There were no reported injuries.

The flame was extinguished by firefighters within 10 minutes of their arrival.

Police are still investigating the incident, in an effort to arrest the driver who fled from the scene of the fire. The driver could face legal charges under Section 285 of the Penal Code.—Pwint Thitsa

About 62,000 SMEs have registered member cards

About 62,000 small and medium sized enterprises (SMEs) have registered SME member cards with the Directorate of Industrial Supervision and Inspection, according to a report on Monday in the City News Daily.

"Most of the SMEs are registered in the hope of getting loans from us, as we provide loans to SMEs which have operated for at least two years.

"By registering SME member cards, they can access technology and training from us. In our country, most SMEs are not registered. And, some registered not to receive loans, but for government recognition. If they do not register their SME,

it is not safe for their business, said Daw Aye Aye Win, the Director General of the Directorate of Industrial Supervision and Inspection.

With SMEs registering, the government can assess the conditions of related industries and identify policy priorities.

If all SMEs are registered, the government will know the exact number of SMEs in different industries, such as agriculture and livestock.

The registration fee for small enterprises is Ks 5,000 and Ks 10,000 for medium enterprises. All SMEs need to extend their SME member cards every two years.—GNLM

Plum growers report losses due to decline of plum prices in Mandalay Plum growers in Mandalay retownship.

gion have reported losses, as plum prices declined to nearly half of last year's prices, according to plum growers from Kyaukse township.

"Last year, the price of plums was between Ks 9,000 and Ks13,000 per basket. But this year, the price of plums is only Ks 6,500 to Ks7,000 per basket. Therefore, local plum growers do not even break even on their planting costs", said U Khin Lin, a plum growers from Kyaukse

being sold in paper boxes, the cost is higher than their being sold in baskets. Last year, plums sold well in the local market. That is why local plum growers increased the amount of their cultivation this year. We have also produced more fruit, and plum traders have bought plums at lower prices. When we do not sell fruit at the lower price, the fruit will spoil on the tree", he added.

Recently, plum traders "Though plums are also bought plums directly from farms. Then, they sent them to be sold in Muse, Tamu, Kalay and the upper regions of the Chindwin River through Yangon, Mandalay, Bago and Monywa, annually from December to March. Plums are mainly grown in Mandalay, Magway, the Sagaing regions and Nay Pyi Taw. Brazil apples, also called Loquat and Taiwan plums, have to be picked between January and March.-Myat Thu (AMIA)

from the Ministry.

"Previously, Myanmar exported between 70,000 and 80,000 tons per year. Since last year, Myanmar has exported over 100,000 tons per year. We expected that we can export 150,000 tons of rubber this year," he added.

Last year at this time, the price of rubber was Ks 1,300 per pound. But this year, rubber prices declined to Ks 750 per pound. To charge a high price for rubber, officials need to keep track of rubber prices in October and November, he added. Myanmar harvests nearly

200,000 tons of rubber annually. China usually buys some 80 per cent of Myanmar's rubber. The other 20 per cent is shipped to Singapore, Indonesia and Malaysia. Myanmar rubber is produced mainly in Mon State, Taninthayi Region, Kayin State, the Yangon Region and Bago Region. Currently, Myanmar has more than 1.6 million acres of rubber plantations, as more than 700,000 acres produce latex rubber.—GNLM ■

Prosecution witness in Reuters reporters' hearing testifies

THE latest prosecution witness in the hearing to determine whether two detained Reuters reporters should be charged under the Official Secrets Act appeared in court yesterday.

Sub-inspector Myo Ko Ko was the fourth prosecution witness to testify in the proceedings to decide whether reporters Wa Lone, 31, and Kyaw Soe Oo, 27, should be charged under the colonial-era Official Secrets Act.

All the witnesses for the prosecution have so far been police officers. "Two more prosecution witnesses will appear at the court at next hearing," said Deputy District Judge Daw Sandar Win. The next hearing is scheduled for 21 February, according to the court.

Wa Lone, also known as Thet Oo Maung, and Kyaw Soe Oo, also known as Moe Aung, with the Yangon bureau of the Reuters news agency, were arrested on 12 December for illegally obtaining and possessing important and secret government documents.

The journalists told relatives they were arrested almost immediately after being handed some papers at a restaurant by two officers they had not met before.—Zaw Gyi ■

Heart valve procedure successfully performed at Mandalay General Hospital

Five cardiac patients who were in need of heart valve replacement underwent successful procedures this week using Transcutaneous Aortic Valve Implantation (TAVI) at the cardiac unit of Mandalay General Hospital.

Mandalay General Hospital has been performing operations for patients who are in need of heart valve replacement but cannot tolerate open-heart surgery. The TAVI treatment uses a catheter to insert a new heart valve through an artery.

This recent treatment was made with the help of two cardiologists from Mandalay General Hospital and National University of Singapore (NUS) from February 12-13.

The 12 heart valves used in the procedure were donated by Edward Life Science Co. Ltd. All the procedures were deemed successful, medical officials said.

The following are excerpts from interviews with doctors, cardiologists and patients from Mandalay General Hospital.

Prof. Dr. Than Than Kyaing, Head of the Department of Cardiology, University of Medicine, Mandalay

This is the first time this type of cardiac treatment using Transcutaneous Aortic Valve Implantation (TAVI) has been done in Mandalay. With the help

of Dr. Edgar Tay and Dr. Jimmy Hun from NUS, we could perform the TAVI procedure successfully.

Formerly, this kind of treatment used to take six hours and most of the patients were elderly. Nowadays, in Asia alone, there are 10,000 patients who have received this kind of treatment, and the majority are from Japan, then Singapore. Thanks to this new treatment, the patients will recover within a couple of days.

Dr. Edgar Tay, a cardiologist from Singapore

The reasons why I come here is to treat the patients who are suffering from cardiology. As far as I know, the doctors from this hospital are well experienced and helpful. I see that all my patients are getting better and pleased it after the operation.

UBo Maung, cardiac patient

I suffer from heart disease and went to Mandalay General Hospital. Due to my old age, I couldn't undergo the operation. Now, a new valve has been transplanted without any surgery and I am feeling better now. So I want to say that I am very grateful to those who helped me.—Min Htet Aung (Mandalay)

Suzuki bets on remodeled eco car to rev up sales in Thailand

BANGKOK — Japan's Suzuki Motor Corp has launched a remodeled environmentally-friendly Swift hatchback in Thailand, aiming to increase its eco car sales to grab around a 20 per cent share of the segment in Southeast Asia's second largest auto market.

Suzuki Motor (Thailand) Co, a wholly owned subsidiary of the Japanese carmaker, said it expects to almost double sales of cars in the Swift series from 8,080 units last year to 15,700 this year with the first release of the third-generation All New Suzuki Swift model in the region. Senior officials of the local unit foresee new car sales in Thailand this year growing 3.4 per cent from 2017 to over 900,000 units while predicting the eco car segment will surge 15.2 per cent to 180,000 ve-

Russian Navy to get large amphibious assault ship by late spring

MOSCOW — The large amphibious assault ship Ivan Gren is scheduled for delivery to the Russian Navy by the end of spring, Head of the United Ship-Building Corporation Alexei Rakhmanov told reporters on 9 Friday. "We are expecting any minute, so to speak. The task is to complete all the measures. I won't give any specific timeframe but I believe that we are to complete everything by the end of spring," he said.

Sergei Mikhailov, spokesman for the Yantar Shipyard on the Baltic

coast, which is building the Ivan Gren, earlier told TASS that the warship's state trials were expected to be completed in late February. The Project 11711 large amphibious assault lead ship Ivan Gren was developed by the Nevskoye Design Bureau in St Petersburg in northwest Russia. It was laid down by the Yantar Shipyard in Kaliningrad in west Russia in December 2004 and launched in May 2012. Its sea trials began in June 2016.

On 30 November, 2017, the large amphibious assault ship Ivan Gren started undergoing state trials in the Baltic Sea.

The warship can carry 13 main battle tanks or 36 armoured personnel carriers (infantry fighting vehicles), or up to 300 marines. The amphibious assault ship can also transport a reinforced marine infantry company with organic military hardware and land it with the use of pontoons.

The amphibious assault ship Ivan Gren is armed with 30mm six-barrel artillery systems and two Kamov Ka-29 transport/attack helicopters in its deck hangars.—Tass

Cuba prepares to end dual currency system

HAVANA—For more than two decades, Cubans have used a unique dual currency system to protect a fragile economy, but with just weeks of his mandate remaining, President Raul Castro has signaled much-delayed change is finally coming.

Plans to scrap the divisive system were first mooted in 2003 as part of a series of market-oriented reforms introduced by Castro, who is due to step down in April. Now, after years of delays, authorities on the Caribbean island are finally expected to bite the bullet and begin consolidating the two currencies, despite fears of a shock to the economy. "This issue has taken us too long and it cannot be delayed any longer," Castro said in a speech in December. The government has resisted any commitment to a timetable, but many observers believe a meeting of the Central Committee of the Cuban Communist Party (PCC) next month will finally set the process in motion.

The country has had two currencies since 1994 when it introduced the Cuban Convertible Peso, or $\ensuremath{\mathrm{CUC}}$ — alongside the

Cuban Peso, the CUP — as part of measures to protect the economy in the wake of the collapse of its biggest sponsor, the Soviet Union.

The CUC, originally used exclusively for foreign trade and in the tourism industry before gradually seeping into the normal economy, is worth about 25 times the CUP and pegged to the dollar.

The dual currencies created a two-tier class system in Cuba, which favored those with access to the lucrative tourist sector through hotels, restaurants and foreign trade.—AFP

Dutch FM resigns triggering vote of no-confidence

THE HAGUE — Dutch Foreign Minister Halbe Zijlstra resigned on Tuesday after admitting lying, triggering a political bombshell and a vote of no-confidence in the country's prime minister.

Prime Minister Mark Rutte overwhelmingly survived the vote brought by his arch-foe far-right politician Geert Wilders, with 101 MPs against and only 43 in favour.

But the scandal has erupted in just a few days in the Netherlands, and threatens to undermine Rutte's fledgling and fragile four-party coalition.

The drama came after Zijlstra admitted he had falsely claimed to have attended a 2006 meeting with Russian President Vladimir Putin.

"This is by far the biggest mistake I have made in my career," he told the lower house of parliament, adding tearfully that he had no option but to resign.

Rutte then found himself in the firing line, when MPs grilled him about why he had not informed parliament sooner after being told about Zijlstra's deception on 29 January.

"It was an error of judgement on my part," Rutte said. "I didn't think this affair would have such a political fallout. I under-

this lie." Lack of experience

Zijlstra, a member of Rutte's Liberal VVD party, had only been in the post

for four months, and his appointment in October had already raised eyebrows due his lack of experience. His resignation came

just hours before he was set to leave for Moscow to meet with Russian Foreign Minister Sergei Lavrov.

They had been due to discuss among other things the 2014 downing of Malaysian Airlines flight MH17 shot down by a missile fired from territory held by pro-Russian rebels in eastern Ukraine.

The tragedy in which all 298 people on board died, most of them Dutch, has soured ties and led to accusations that Moscow is not being truthful about the events.

A Dutch foreign min-

estimated the impact of istry official told AFP that the Moscow "meeting will not go ahead, for obvious reasons" and they would try to look "at a later date".

> Stepping down, Zijlstra told MPs on Tuesday that the credibility of the country's foreign minister must be "beyond doubt, both inside and outside of the country".

> He resigned after finally admitting that his longheld claim to have attended a 2006 meeting in Putin's dacha, which included Jeroen van der Veer, Shell's former chief executive, was false. "I have spoken about an incident of great importance, saying I was there in person, while that was not the case," Zijlstra told MPs on Tuesday. "I wanted to tell this story convincingly without revealing my source, it was obviously the wrong choice. I should not have done it. I am sorry."-AFP

Largest human image of Myanmar breaks Guinness World Records title

THE largest human image of Myanmar, organized by Telenor Myanmar at the sports grounds in Magway on 12 February 2018 was recorded in the 2018 Guinness World Records.

The image of Myanmar measuring 234ft in length and 106 ft in width in the space of 24,804 sq ft was shaped by 3,466 people including students. It became the first ever mass gathering to create an image of a country or a continent to break the Guinness World Records title in Myanmar.

"The reason why we chose Magway to shape the image of Myanmar is that Natmauk Town, is the birthplace of Myanmar's independence hero General Aung San. The event was held to mark the 71st anniversary of Union Day," said an official from Telenor Myanmar Co, Ltd. In September 2016, 811 people teamed up to create image of the Africa continent, setting a Guinness World Records title.

There are other recipients of Guinness World Record titles in Myanmar such as Mingun Sayadaw U Vicittasarabivamsa, a record holder in the human memory category, the largest sapphire in the world, the heaviest bell in the world called Mingun Bell and the people with the longest necks.—Myanmar Digital News

Nishikori through to 2nd round at New York Open

NEW YORK — Japan's Kei Nishikori safely advanced to the second round of the inaugural New York Open on Tuesday, beating American wildcard Noah Rubin 7-5, 6-3 in his opening game.

Nishikori is competing in his first ATP World Tour event since sustaining a right wrist injury last August. The 1.75-metre Noah, ranked 232nd in the world, forced Nishikori to come back after seizing a 3-0, firstset lead.

With a crucial break in the 11th game, Nishikori turned the tide and took advantage of Rubin's mistakes in the second set.

"It was the best game I've played since I returned," Nishikori said.

"There are still areas I need work on such as my feel for the game and how I enter the match, but it's gradually getting better. This is where it starts getting harder," he said.

The 12-18 Februaru tournament at Nassau Coliseum in Long Island is the first ATP World Tour event to use black-colored hard courts. Since his return to competition in late January, the 28-year-old Nishikori has competed in Challenge Tour events while aiming to regain his position in the top tier. He won the Challenger event in Dallas earlier this month.

Nishikori reached fourth in the men's singles world rankings less than a year ago but now finds himself 27th. He will face 72nd-ranked Evgeny Donskoy of Russia in his next match on Wednesday.— Kyodo News ■

Allegri irritated by criticism as Juve fail to kill off Spurs

TURIN — Juventus coach Massimiliano Allegri insisted he would not be getting depressed despite criticism at failing to land the killer blow against Tottenham in their Champions League last 16, first leg clash in Turin.

"If anyone thought that Juventus would win 4-0 this evening he was way off track," blasted Allegri, after his more experienced side threw away a dream start with two Gonzalo Higuain goals inside ten minutes to end with a 2-2 draw in front of their frustrated fans at the Allianz Stadium.

"The Champions League is a dream and an objective, but winning it is not easy. I think people have lost some objectivity here. Juve play to win, but they are not the favourites. You can't reach the final every year," said Allegri.

Higuain got the first goal after 73 seconds, and minutes later added a second from the spot after Ben Davies' foul on Federico Bernardeschi.

But Harry Kane revived Spurs hopes after half an hour, with his seventh goal in the competition this season, rounding flattened goalkeeper Gianluigi Buffon.

Higuain missed a second penalty before the break following Serge Aurier's reckless challenge on Douglas Costa to keep the English side in the game.

Christian Eriksen scored Tottenham's second goal from a free-kick after centre-back Giorgio Chiellini fouled Dele Alli, sending it low past a wrong-footed Buffon, leaving all to play for in Wembley on 7 March.

"It's like we lost 8-0 — good doctors are needed, not one, but many very, very good," Allegri berated journalists at the postmatch press conference.

"Football is like this, we went from 3-0 to 2-1, we had a 3-1 penalty and instead Tottenham equalised 2-2," explained Allegri of the game. "I believe the lads are putting in a fantastic season, but that's a long way off thinking they can win a last 16 match by a 3-0 scoreline."

Three-pronged attack Juventus are bidding for a seventh straight Serie A title this season, and are just one point off leaders Napoli. They are also in the running for a fourth straight Italian Cup, and to reach the final of the Champions League for the third time in four years.

"People must realise that winning is not normality, it is extraordinary," continued the former AC Milan boss.

"I will not accept that tonight's 2-2 draw could depress the Juve fans. There are some scary ups and downs in the mood here. "This really irritates me, because people have no idea of how teams function. The primary objective is the Scudetto: it's not easy. Then we'll try to go forward in the Champions League.

"It was always 50:50 with Tottenham and it still is."

Spurs boss Mauricio Pochettino said his side "showed character" in a competition where their best finish was the semi-finals in 1962.

"We've shown great personality against a team that has played two finals in the last three years, my players have been fantastic.

"Now it'll be like a final in London."—AFP
