Since then we have been celebrating this day annually and this year marks the 45th Anniversary.

Mon State is a place where Mons and Burmans constitute the majority and Kachins, Chins, Rakhines, Shans and Pa-O ethnic races all live in close friendship. In various parts of the Republic of the Union of Myanmar, all types of ethnic national races have been living since centuries ago together in close friendship in weal or woe. All our ethnic brothers and sisters have struggled together, hand in hand in unity to free ourselves from the colonialist yoke.

However, since the day we gained independence, our ethnic brothers have been unable to settle their political ideologies through negotiations and compromise. However they have tried to settle these differences through armed conflicts. As a result of this we have moved further away from internal peace and our country had to suffer the bitter experience of armed conflicts for many years. Although successive governments have tried to solve the problem of internal armed conflicts in many ways among our ethnic brothers and sisters, because we have been unable to solve the root political problems through political means, even to this very day we are witnessing the continuation of these armed conflicts.

Our Union Government has been successfully conducting the Union Peace Conference - 21st Century Panlong Meetings up to the Third meeting. We have also reached agreement on some fundamental federal principles. We have done these things to fulfill the ardent desires of our citizens who have been yearning for many years for durable peace. They know that to achieve this, armed conflicts which are the roots cause of political problems need to be solved through political means; and that a democratic federal union which is acceptable to all ethnic brothers and sisters need to be established.

I have been very happy to note that the New Mon State Party signed the NCA – Nationwide Ceasefire Agreement on 13th February 2018 and that it has participated in the political dialogues at different levels. Our ethnic brothers and sisters need to maintain the agreements reached thus far; I believe that they will continue to participate enthusiastically in our endeavors for the emergence of a democratic federal union as soon as possible.

Mon State which is full of splendor and steeped in culture, history and traditions, has the potential to develop with momentum within a few decades because of its location and geographic situation. I have been pleased to notice this. As we strive ardently for a constitution that would allow us to build a democratic federal union which can guarantee us rights such as democracy, national reconciliation and the right of self-determination, I firmly believe that both men and women of Mon State would join in, strive hard and work hand in hand with other Union citizens.

The opportunity to practically create the dream of a federal union which has yet to be fulfilled, though we have yearned for it for so many years is now within the reach of every Union citizen. This dream of a federal union is the dream of Bogyoke Aung San our national leader, architect of independence and father of the Tatmadaw and other Union leaders to be passed on to the new generation of youths. I send this Message of Greetings with good wishes for our Mon ethnic brothers and sisters urging them to continue walking on the path of National Reconciliation and Union Peace with courage and wisdom. I also pray that they would be able to firmly grasp the stability and peace of Mon State to strive in unity for the emergence of a socially harmonious, equitable, modern, and developed state within the coming decade.

From there the State Counsellor went to Hpa An town Thita Hta Man Aung Pagoda and paid homage to the pagoda offering flowers and water. She then made a cash donation for all round maintenance work of the pagoda to the pagoda trustees.

After wards the State Counsellor met with the local people at Hpa An town Zwekabin hall.

At the meeting the State Counsellor said the reason for holding a meeting with the people was to learn from the people. It was for the government, the public servants and the people to learn. It was to find a way of working together in cooperation in a democracy system. That was why when I hold such a meeting I don't want personnel from the government administration in the meeting hall while people were on the outside. In such a setup both sides would not have the opportunity to learn from the other side. When I came the first time to Mt. Zwekabin in 1995, it was to pay homage to Thamanya Sayadaw and since then many changes could be seen.

At that time Hpa An town was not as big as now. Hpa An had developed to a certain level but the development was not adequate enough. There remained many requirements. These would be included when people made their submissions later. These were requirements in the entire country. It would be difficult to fulfill all the requirements of the country. Time would be needed. It had been for decades that the country had not developed and it would be impractical to develop such a country in three years. Yet there were developments even though the development had not reached a satisfactory stage. In fact we must never be at a stage where we were satisfied. If so we would not be striving hard and lose the will for it. We must strive towards developing year by year.

When I came by car back in 1995, I was able to learn about the situation in the small villages. Now that I came by air, I was not able to see the situation at village level. I lost some opportunities to know the situation of farmers and people at the grass roots level. On the other hand, as I came in by air, I was able to see clearly how developed Hpa An had become. This was a lesson for me. A view from a place is not the same as a view from an-

other. Only when the views and thoughts are combined can we make our country develop fully. From Kayin State we were able to understand well the miseries of not having peace. We also saw clearly the changes when there was ceasefire and were on a road toward peace.

About two years ago a dis-

He admitted that as he lived in a place where there was peace he did not know of the effect on daily lives when there was no peace.

He understood the importance of peace after hearing what the youngsters from Kayin State said. Locals in Kayin State had learnt from their practical life of the importance of peace. There-

cussion was held with youths about peace. Youths from all around the country attended that discussion. A youth from Mandalay was there. Two youths from Kayin State were there. When they discussed the two youths from Kayin State knew the importance of peace and its value. They told of what they had seen clearly after achieving ceasefire and how the lives of the people had changed. The youth from Mandalay spoke honestly of learning there and then about it. As he was born in a peaceful region, he never had firsthand experience about the miseries and tragedy of internal conflict. It was not that he did not know as he was quite a well learned youngster who had much interest in the affairs of the country. fore I strongly believed that the people here would work enthusiastically toward the success of the peace process. Only then can our country become a true democratic federal union. Our country has not become a full democracy yet. We are yet to be a country that practices a firm federal system. This was thought to be the goal of all. Some did not understand this. Some support it. Some were not interested. I would be repeating the same thing repeatedly if I were to speak to those who were not interested.

We should not be dis-interested in politics. Politics directly relate to us. Politic was about the affairs of the country. It was not about party politics or solely about winning an election. Democracy nowadays was about a government elected by the majority of the people. In other words it was a representative democracy. It was not a direct democracy. Our country had a population of more than 50 million. All were not at the voting age. Looking at those who were of voting age, not all could participate in the administrative machinery. A representative democracy system was a system that was practically appropriate to the will of the people. However it was not without faults too. People themselves were not faultless. As people who were not faultless created something it would not be faultless too. A renowned person said a democratic system was not good but other systems were worse. From whatever angle it was looked at, a system that represented the people cared for the people.

A system that represented the people would be a system that placed emphasis on the will of the people. This need to be noted and emphasis must be placed on the will of the people. The government members and public servants were also the people. But they were people who were given the rights to do things. Whether these rights were used for the country and the people or for themselves were to be decided by them. It would be a grave mistake if people in the government and the administrative machinery used these rights for their benefit. Personally it would be a great opportunity to gain much merits. Politically, it would be a great opportunity to benefit the country. Thus, use this opportunity well. Only through correct use can there be development for self, as well as for all. I spoke about this throughout our entire movement for democracy. Once there was an eastern saying that categorizes four types of government. The first was a government despised by the people. A little worse one would be a government feared by the people. A better one was a government that was praised by the people. But the best was a government whose existence the people did not know. If we reviewed our government's performance through the past three years, we had not reached the best stage yet.

Because the people did not know about all that we had done, I concluded that we were not too bad. They thought this was their right. I like that. For example, the two youths from Kayin State first spoke about road transport at the peace discussion. After achieving peace road transport became better. Roads can be built with peace. Prior to that, as there were battles raging, roads could not be built. Due to improvements in roads, their lives developed. Within the three years more than 60 miles of road were built. Most would not have realized this and they need not too. The main thing was the changes in people's lives. They were not looking at how many miles of roads constructed. But they knew the changes to their lives. It was the same when I was representing Kawhmu Township. **SEE PAGE-4**

I had a sad experience on how successful the road communication was. After a child was killed in a road accident, I went to the child's parent and the mother in tears told me of the death of her child. She said her child was not able to enjoy the good road that was built and that hit me very hard.

Those who did not look into it deeply wouldn't realize how important it was but the roads were becoming better for sure. Whether they realize this or not a good government do such things. Our country was still going down the path of democracy. Cooperation of the people was required to achieve success. People need to notice this. For all to develop, all need to participate. It would not be possible to share the benefit of development if you do not want to part take in the development works. All need to do it hand in hand. Our country was not facing challenges only from the development side but from all sides. I have said this repeatedly. It was our choice whether these challenges were an opportunity or a problem for us. The important thing was to make it as an opportunity for us. Due to the challenges, we got to know the importance of collective strength. If we faced the challenges with unity, we would overcome it and reach our goal. People from Kayin State would be especially capable to teach the people in the whole country about union spirit. Teach all about it. The best way to teach was to practice it yourself. Do not teach by word but teach by action. People from Kayin State were to walk down a path that would enable their offspring not to experience what they had experienced from internal conflicts. If all aimed towards peace, we would achieve peace. Destabilizing the country more by taking opportunity of facing challenges would be akin to being disloyal to the country. It would be akin to not having metta towards the people. Such people and organizations would not benefit anything or anyone. They may look successful for a short while but in the long run they would never benefit the world they lived in. Kayin people were known for being loyal not only in this country but in other countries as well. Be an example on being loyal. Spread metta. There were many beliefs and

religions in Kayin State. There were many ethnic nationals. People from Kayin State were to show how through this collective situation they achieved their goal successfully. Relevant departmental officials will now answer to submitted questions.

We will permit people to raise questions and to do this we would have to select who would ask the question. As we do not have time for all to raise questions, people should be disciplined. Do not compete towards raising a question. The main point was to get an answer to your question. If you were not permitted to ask a question, you can do so in writing. We have opened a complaint section. Questions should be mainly about our country and related to the benefit of the country.

Pre-submitted questions covering cross border travel and permission for foreigners, railroad connection, upgrade of bridges, traffic congestion, construction of roads and bridges, questions raised by five locals outside the meeting covering returning confiscated land, reviewing expansion of the school land and theft of motorcycle in Hpa An university and questions raised by 3 locals in the meeting covering construction of a new airfield for Hpa An, reopening village connecting road, existence of buildings that should not be on Strand Road in Hpa An, having adequate medicines in Kamamaung People's Hospital, upgrading Kamamaung town into a township etc. were answered by State Chief Minister and departmental officials.

The State Counsellor added onto the replies made by saying that government need to assess and measure a feasibility of a work program. Decision on conducting a huge work could not be made without detailed were made and instructions issued. Trespassing or illegal settling was not acceptable. It was violation of laws and rules. If people do not have a place to live, they should approach their respective state/region governments. Governments were to setup projects to provide for this, said the State Counsellor.

In conclusion, the State Counsellor spoke of receiving questions on land matters whenever meetings with people were held. Therefore, a priority pro-

study. Utilization of government could not be decided by looking narrowly. Demands and requests made from all over the country were reviewed and our aim was to fulfill all but priority had to be made and was implemented only after a practical study was conducted.

Arrangements were made to return land confiscated after 1988. In a country practicing democracy nothing could be done by verbal order alone. It would not be legal. Official decisions gram was being drawn up to return such lands to true owners. As people rely on agriculture the importance of land ownership was understood and the government was making it a priority to resolve these matters. Decisions were made after careful assessment according to the law without taking the administration's side or the side of the people.

For some a country's modernity and progress meant having modern buildings or having high technology. In her view a truly modern country provided both physical and mental security. The most important for a country to be modern was to have rule of law. People were bored with this word and were not interested in this. They were not interested in laws, rules and regulations. But a law was made by the people and it need to be fair and just.

A word of caution as made in my visits to state and region governments would be made here again. Engagement with the people was required. Both the administrative and government portions need to engage with people.

The state government was elected by the people. Even though public servants were not elected by the people, they become public servants because they wanted to. If they served for money alone or just to have a living it would not make them an honorable dignified public servant. As they became a public servant, they might just as well become a good public servant that were loved and respected by the people. If they were loved and respected by the people, they would never go hungry or face difficulties. If the people did not love and respect them, they would not feel good even if they were rich or live in peace.

Afterwards the State Counsellor went to the Computer University (Hpa An) where the headmaster of the school explained about construction of staff house and students' hostel while migrant workers working at the site

discussed about their job opportunities and education and health of their offspring.

The State Counsellor commented that parents need to arrange for the education of their children and employers also need to help their employees' children to attend school. The government was providing assistance to expecting mothers and children up to two years old and General Administration Department would help towards providing financial assistance.

Later in the afternoon, the State Counsellor went to Naungkamyaing village at the invitation of a villager present at the meeting with the people in Zwekabin hall and paid homage to Naungkamyaing Ywagyi monastery Sayadaw U Thumana and donated offertories.

Union Minister U Min Thu meets GAD staff of Kayin State

U MIN THU, the Union Minister for the Office of the Union Government, met with staff of the Kayin State General Administration Department at the State GAD office in Hpa-an, Kayin State, yesterday.

Firstly, the head of the Bago Region GAD, U Kyaw Soe, introduced the Union Minister to everyone in attendance and explained about the State GAD's processes and performances. The Union Minister then delivered a speech.

GAD's roles and plans

The Union Minister said the GAD has been strengthening the administrative mechanism of successive political systems for the nation and the people. He said now is the time for the GAD to make visible changes for the public to see to be in line with the changing political system and government policies.

It was with this mindset that the workshop on reform was held in Nay Pyi Taw for GAD staff from 26 to 28 February. There, GAD staff and officials engaged in meaningful discussions on taking further steps for the future of the GAD, said the

Union Minister.

Vision, mission of the GAD

The Union Minister said the workshop produced vision and mission statements, workplace standards and reform procedures for the GAD. The vision statement was chosen as 'Building good administration and mechanism based on the people'. This is the long-term objective chosen by the GAD staff.

The mission statements made at the workshop include proliferating the rule of law and community peace, implementing State Policy, establishing a good administrative system, and carrving out people-centred regional development. These mission statements were designated by the GAD staff and thus they must undertake them with deep consideration, said the Union Minister.

Three main reform tasks

The Union Minister said the workshop also facilitated the emergence of 3 tasks for reform: (1) reforming policies, (2) reforming regulations and managerial components, and (3) establishing regional development and good practices.

The first reform task includes reviewing amending laws, bylaws, written orders and directives as necessary. The Union Minister said this task requires some preparation as the GAD has been transferred to his ministry and includes the need for some flexibility and lessening of restrictions. He said this task will be undertaken on a step-by-step priority basis.

The second reform task includes handling the GAD's manual, organization, administrative management, e-Government and the digital platform, capacity development, and public interaction. These will also be ordered on a priority basis.

The third reform task will also sort out and prioritize steps to be taken towards establishing good practices that are in line with the current political system, and to produce noticeable regional development. The Union Minister said the reform tasks need to be carried out at the same time in uniformity with each other and with the One

State-One Township project.

Ideals to maintain on the path to reform

The Union Minister urged GAD staff to systematically implement the vision, mission and reform tasks in a uniform manner. He said the GAD is working towards becoming an administrative sector that initiates reforms as an example to others will being people-centred. He said there are three points to remember in this regard.

Tatmadaw conducts Combined Fleet Exercise-Sea Shield 2019

TATMADAW (Navy) conducted a Combined Fleet Exercise-Sea Shield 2019 yesterday in the Bay of Bengal and Commander-in-Chief of Defence Services Senior General Min Aung Hlaing inspected the exercise.

Accompanied by Union Minister for Defence Lt-Gen Sein Win, Commander-in-Chief

(Navy) Admiral Tin Aung San and Commander-in-Chief (Air) Lt-Gen Maung Maung Kyaw, senior military officers from the Office of the Commander-in-Chief of Defence Services viewed the combined fleet exercise from the Aung Zeya Vessel.

First, the Senior General and party heard a report on the exercise presented by the naval division commander on duty of naval division who was the leader of the exercise, and gave the verbal offensive order on war vessel-Aung Zeya. Afterwards, the commander and Cos returned to their respective warships and conducted the exercise in accord with the program.

Navy seals gave a demonstration of raiding an enemy-seized passenger and trading ship and rescuing hostages by using four fast patrol crafts and three helicopters.

On completion of the exercise, the participating war vessels saluted the Senior General aboard war vessel-Aung Zeya under fleet review.

Next, officers and other ranks aboard the high-speed watercrafts who participated in the exercise saluted the Commander-in-Chief of Defence Services.

They then continued conducting their exercise by firing aerial defence weapons at enemy aircrafts and fired artilleries at enemy reconnaissance watercrafts. In order to crush the enemy's main fleet, the naval troops changed into Formation-10 and conducted firing missiles and main artilleries. After the fighting exercise, the naval water crafts carried out underway replenishment at sea exercise.

End armed conflicts without losing sight of people's aspirations

EVERY meeting with locals during her visits to the regions and states, the State Counsellor has listened to the concerns of the people and tried to fulfil their needs as far as possible

The issues raised by the people mostly involve education, health, economy, transportation, safe drinking water, land confiscation, and electrification.

The Union Government is working to upgrade towns to uplift the socio-economic condition of the people, and providing help to ensure the same for people in rural areas.

The development of border regions and far-flung hilly areas is especially being given a priority by the government.

While the Union Government is working hard to find sustainable solutions to bring about peace, stability, and development in Rakhine State, the recent fighting ignited by attacks on police outposts by the AA group has further complicated the situation in the state.

The attacks have highlighted the urgent need for a nationwide ceasefire agreement, under the ongoing national peace process.

The attacks on police outposts have disrupted not only the rule of law, but also the daily lives and security of the local people.

What is worse, the AA deliberately chose to attack civilian targets, setting fire to a vessel carrying construction materials worth about K1.072 billion on 16 March. The shipment was meant for the Paletwa Bridge project across the Kaladan river.

There has been widespread condemnation among the public of AA's terrorist act of burning and destroying a civilian vessel transporting

materials meant for the development of Rakhine State.

The attack on the civilian target has highlighted the need for communal peace and rule of law to carry out regional development aspired to by the people. It has also highlighted the fact that armed conflicts only hinder regional development projects and pose obstacles to the aspirations of the local people.

The Union Government is committed to overcoming the grave challenges it has faced in Rakhine. From the very beginning of its term, the government has made rule of law and sustainable development in Rakhine, for which there is a vital need in the state, a national priority.

To ensure long-term peace and harmony in the State, the incumbent government has been doing its utmost to meet the security and humanitarian needs of the people, in line with the recommendations of the commission led by the late Dr. Kofi Annan.

To end ongoing armed conflicts, we would like to urge the Government, the Tatmadaw, and the ethnic armed organizations to resolve issues through negotiation, without losing sight of the goal of total peace for the country.

MONG the kitchen ingredients people use in the kitchen, none are as basic or widely used as the noble salt. Salt is an essential nutrient for humans and animals as it contains the chemical sodium that helps nerves and muscles, including the heart, to function correctly.

Myanmar's history with salt

Salt production in Myanmar can be divided into two groups; coast and inland productions. Inland production is where salt is harvested from saltwater springs and wells. Shwebo District once housed a prominent inland salt production industry during the reign of Myanmar's kings. Takwataw, Hanlin, Sartaung regions and Kyauktaw Village in Sagaing all produce salt for Myanmar. People in Chin State were known to harvest salt from the saltwater springs in Hukaung Valley and more were found in Kamine Township. Another prominent salt producer is found in Shan State at Bawkyo Village in Hsipaw Township.

Coastal salt production is where sea salt is harvested from seawater. In Myanmar, you can find sea salt harvesters in Taninthayi Region, Mon State, Bago Region, Ayeyawady Region, and Rakhine's coastal region.

When Myanmar fell under British colonial rule, the governing body took direct control of the national salt industry. Up till just before World War II, salt had to be imported for domestic use. In 1908, salt manufacturing was limited to Kyaukpyu, Hanthawaddy, Myaungmya, Pathein, Dawei, Kyaikkhami, Thaton, Myeik, Katha, Sagaing and Shwebo districts to control the production of salt.

The British government systematically levied taxes on salt production in Myanmar and sold back to foreign countries at quadruple the purchasing price.

Early Rakhine salt era

It was in the initial years of the British occupation where Rakhine's salt business was at its peak. This is evident from the records at Kolkata and Chittagong ports that shows salt from



Rakhine producers need to implement clean high-quality salt in order to normalize the salt market.

Kyaukpyu District was imported from Kyaukpyu port.

Salt production rose rapidly after the end of WWII. This was intentionally boosted to make Myanmar self-sufficient on domestically manufactured salt with no foreign imports necessary.

After independence, few people get involved in salt production in Rakhine State; boiled salt was produced to meet local demands in Myanmar during 1955-1956. Mass production was carried out in Kyaukpyu District and Maungtaw township and supervisory offices were opened in their respective townships to oversee management.

Salt production was enough only for the State. After 1962, the salt industry survived unsteadily under the Socialist Economic System. But in Rakhine State, production changed from boiled salt to sun-dried salt by means of techniques, helping much development of production in the State

der trading officially opened in 1995. Sun-dried salt was exported to Bangladesh via border trade especially from Sittway's borders from 2002 to 2008.

Demand from Bangladesh became so strong that additional salt had to be ordered from the Ayeyawady Region. Salt warehouses proliferated along the banks of Shwemingan brook during these times.

Bangladesh was suspended in 2009, leading to a decrease in Rakhine's salt production and ultimately a loss of salt market to Bangladesh. In addition, in 2010, smooth salt from Thailand began entering Myanmar with cheaper prices thus sending Rakhine salt production to its lowest level.

State government reopened trade opportunities with Bangladesh in 2012-2013, but the quality had dropped below Bangladesh's standards. Their sun-dried salt was now produced with modern techniques and was a cut above the methods used in Rakhine's producers.

Bangladesh now produces a clean and quality salt by channeling salt water to plastic-spread salt land. Rakhine producers need to implement clean high-quality salt in order to normalize the salt market.

However, salt export to Industrial Raw materials

As Rakhine State is on the edge of the Bay of Bengal, eleven coastal townships are expected to carry out sun-dried salt production successfully. As it is used as common salt as well as industrial raw material; raw salt is used for ice packs and for paper production machines.

By-products from sun-dried salt are marketable items. Magnesium sulphate, calcium sul-

phate and magnesium hydroxide are produced from --- water. Magnesium sulphate can be used in the manufacturing of medicines and calcium sulphate are used in the cement and porcelain factories. Magnesium chloride can be used in rice mills and greatly in need for the production of fertilizers.

Therefore, the development for the market of sun-dried salt can be improved. The State for feasibility for a parcel of land for construction The Rakhine State has a long and beautiful coast and wide areas of paddy land. Thanks to geographic backing for social advancement, it has an abundant supply of rice, fish, meat and natural resources accompanied by invaluable heritage.

Thus, the people of the state will have to try to succeed what they possess in hands to become a modernized region. It is true that Rakhine State is in a good geographic location and possesses plentiful natural resources; its coastal areas are strategically located with the Bay of Bengal.

These conditions create a golden opportunity for the people of the State. Geographically there are a lot of streams and rivers and much plain; forests and mountains and a wide land area will attract a good investment by locals and foreigners. Climate is favorable with natural resources both in land and the sea. As the State is strategically near the Bay of Bengal, it serves as a commercial gate to China, India and other ASEAN countries.

Assistance needed

To produce salt of high quality, the latest techniques are required and about K9 million is needed per acre, said salt producers. That is why financial support is required, they said. Ethnic businessmen want assistance from local government for the development of small and middle businesses. At the same time, by-products from salt production should be fully emphasized. Presently, Rakhine salt producers are found to be helpless. To improve Rakhine salt market, to produce salt of higher quality and to penetrate new markets are the harsh realities of the producers' life.

NRPC, KNPP hold meeting in Nay Pyi Taw

NATIONAL Reconciliation and Peace Center (NRPC) and Karenni National Progressive Party (KNPP) held a meeting at NRPC in Nay Pyi Taw yesterday morning.

At the meeting, NRPC member Union Attorney General U Tun Tun Oo said KNPP had signed a state level and union level agreements since 2012 and was an organisation that had maintained an almost perfect zero conflict status in the region. KNPP Vice Chair Khu Oo Reh had participated as a leader of UNFC's Delegation for Political Negotiation (DPN) and thoroughly discussed UN-FC's 9 point-proposal in order to continue the peace process. Although a good situation of having an agreement on almost all of the proposals were reached, there remains some that still need to be discusses and thus KNPP was unable to sign the NCA yet and had been continuing discussion with the government.

The Peace Commission and KNPP had met in Loikaw, Kayah State on 27 April 2018. Negotiations were conducted on signing the NCA and progress was achieved on the matters of troop movement and communication, holding regular state level meeting, mutually agreeable communication channel for the short time period prior to signing of the NCA as well as agreement on troop matters.

On 10 March this year a working meeting was held in Chiang Mai, Thailand where difficulties faced by both sides were openly discussed and outcome of this was today's meeting. Therefore, discussion in today's meeting should also be conducted openly and discussions are requested on matters in which

the government side should do said the Union Attorney General.

Next KNPP Peace Implementation Committee group leader Khu Oo Reh said in order to resolve the 70 years long problem between KNPP and government discussions had been held for seven years from 2012 March to 2019 March. There were progress during these seven years of discussions but there still remain some problems out of which some were still being under negotiation. This meeting is finding a solution to the problems and the problems need to be recognized by both sides. Problems recognized by both sides also need to be resolved in a way that is acceptable to both sides. Only when there are the same understandings on the problems can an answer acceptable to both sides could be identified.

It is an honest assessment that mutual recognition during the seven years of discussion had become firmer but mutual understanding had been waxing and waning. But this doesn't mean there is a lack of trust between the two. Official and unofficial meetings were between the two groups for several times. All meetings were conducted not only to find a solution or submit a matter but to discuss what were the understandings of both sides on the matters and to find solutions that were the best for the country.

Therefore in the day's meeting too KNPP will discuss agreements reach at bilateral level and difficulties faced on the ground. It'll discuss matters to be discussed in the next levels and agreement related to NCA (Nationwide Ceasefire Agreement). In today's meeting military matter will be left out to be discussed with the Tatmadaw next day. Some ongoing works conducted in the region will also be discussed by representatives. While expecting for the best, it is strongly believed that there'll be some progress said Khu Oo Reh.

Next regional development matters, holding monthly state level coordination meetings, signing of NCA, future peace process works and general matters were discussed.

Afterwards Khu Oo Reh said the day's meeting was beneficial and was thankful to see both side eager to openly discuss requirements in the seven years of meetings. It is expected that an agreement stage with better guarantee and solution will soon be reached and felt that both sides were satisfied with the outcome of the day's meeting. Therefore it is hoped that next meeting will achieve better results said Khu Oo Reh.

In return NRPC member Union Attorney General U Tun Tun Oo said NRPC and KNPP had spent a lot of time to thoroughly discuss matters. Discussion today was on education, health, regional development and training and is believed that the matters can be implemented soon. The matter of conducting regular monthly meeting will be implemented with the State government and it'll enable achieving better results in the peace process.

Agreement was reached to hold another meeting before end of April and signing of NCA discussed in today's meeting will be continued. As KNPP is also joining the forthcoming meeting with other non-signatories of NCA on 21 March all are urged to strive toward signing of NCA, said the Union Attorney General.

After the meeting Peace Commission Support Group member U Kyaw Lin Oo and KNPP spokesperson Nei Neh Plo met with the media and responded to questions raised by the media.

The meeting was attended by NRPC members Union Attorney General U Tun Tun Oo, Lt-Gen Yar Pyae and Lt-Gen Min Naung, secretary Deputy Minister U Khin Maung Tin, Peace Commission secretary Lt-Gen (retired) Khin Zaw Oo and member U Aung Soe and Kayah State minister for planning and finance U Maw Maw. MCEA asks gov't to enact Apartment Law

THE Myanmar Construction Entrepreneurs Association (MCEA) said it has asked the government to enact the Apartment Law.

Although there are about 300,000 apartments in the Yangon Region, there is no guarantee when it comes to purchase of apartments because there is no binding law, according to the association.

If the Apartment Law is enacted to develop the housing sector, apartment owners will be able to get their titles registered, enter into legal deeds of sale, and the government will earn a good revenue from sales tax. Additionally, apartment owners will be able to sell, transfer, and mortgage their apartments legally.

"The enactment of the Apartment Law will turn around 300,000 apartments into strong assets. In the absence of the Apartment Law, most sales contracts are being drawn up in an informal way. This being so, if owners try to mortgage their apartments with banks, they are not granted loans. Apartment owners cannot exercise their consumer rights. There are also unwanted problems such as cases of construction contractors absconding, brokers cheating, and apartments owners being at risk of losing their apartments.

As for the government, it cannot impose taxes. If the Apartment Law is enacted, registration will be required when purchasing apartments," said U Myo Myint, the General Secretary of the MCEA.

Yangon Region has higher apartment occupation compared to other states and regions. Therefore, the MCEA is planning to draw the Apartment Law for Yangon Region along with the regional government.

The Myanmar Licensed Contractors Association has submitted a bill to the Pyithu Hluttaw after drawing up the National Apartment Law. The law is to be implemented by the Urban and Housing Development Department, under the Ministry of Construction.

Currently, the National Apartment Law is being discussed at the Pyidaungsu Hluttaw construction committee meeting.

According to the constitution, the Apartment Law can also be enacted at the state and region levels. Before work begins on a building, the construction plan needs to be submitted six months in advance to the Yangon City Development Committee (YCDC) for approval as designing buildings, copying municipal maps, etc., take time. So, if the YCDC makes changes once work begins, construction cannot be completed on time, creating differences between home-owners and contractors, according to the MCEA.

The MCEA has requested that contractors be granted at least 6 months' grace period at the 25th regular meeting between Vice President U Myint Swe and entrepreneurs, held on 15 March at the Office of the Republic of the Union of Myanmar Federation of Chambers of Commerce and Industry.

Five passengers killed, 12 seriously injured in car plunge on Alaungdaw Kathapa road

FIVE passengers were killed and 12 others injured when an express car plunged into a 200-footdeep ravine at 16 mile 1 furlong on Alaungdaw Kathapa road, Sagaing Region on 18 March.

The vehicle carrying on board the pilgrims plunged into a deep ravine, according to U Thike Soe Tun, the administrator of Kani Township.

"Five passengers-one male and four females--died on the spot with 12 others on board the express car seriously injured in the fatal accident. There were altogether 36 passengers onboard on the express car, it is learnt. The injured were rushed to Monywa People's Hospital in the vehicles from the social organizations," said U Thike Soe Tun. According to the witnesses, the express passenger bus, which was arranged by Yangon Shwe Chanthar vehicle line, dived down into the ravine when the driver lost control of the car.

"We saw the express passenger bus diving down at around 6 am. When we checked the bus, we found 12 passengers seriously injured, and we thus took them in a hurry to the hospital by my friend's car. We are not sure that they are still alive or not. But five passengers lost their lives on the spot," said U Tun Tun Win, Kani Township Hluttaw representative.

The police from Kani Myoma police station arrived at he scene of the accident, and they interrogated the driver and the witnesses to take legal action


against him if found guilty.

The cases of accident are annually reported on Alaungdaw Kathapa hill road, which was built with tortuous bends involving many twists and turns. To reduce such fatal accidents, the Sagaing regional government and the related ministries are discussing upgrading of the road by the private construction companies under the B.O.T system. — Myo Win Tun (Monywa)

Security forces conduct operation against AA, arrest suspected member

SECURITY forces clashed with an AA group in MyaukU on 14 March, after 10 AA members, in civilian outfits, attacked a convoy carrying military personnel with remote-controlled mines.

The fighting took place near mile post No. 118/2 on the MraukU-Kyauktaw Road.

The security forces continued their operations along the route AA members had retreated.

During the operations, U Sein Hla, the son of U Hla Tun Aung of Phayargyi Village, MraukU Township, was found carrying an improvised explosive device (IED) in the toolbox of his motorcycle, and was arrested.

On 15 March, security forces clashed with AA members between MraukU and Teinnyo Village. Following the clash, the security forces seized a Honda Wave motorcycle used by the AA group.

In a separate incident, a military convoy sent from Sittway to conduct security operations in Kyauktaw and MraukU townships was ambushed by about 30 AA members. Following the fight, security forces found the body of an AA member and one IED.

On 17 March, security forces attacked an AA base at Point-802 hill near border post BP-67. Some AA members were killed in the clash and some arms and ammunition were seized. The AA group had set up base at the hill to hinder border fencing work.

The security forces are continuing to conduct operations in Rakhine State to ensure security and stability of the people, according to the Office of the Commander-in-Chief of Defence Services.— MNA

WITH gold prices registering a downward trend in the global market, the price of gold in the domestic market is expected to remain low, said U Ohn Myaing, the General Secretary of the Myanmar Gold Entrepreneurs Association.

Rice export earns \$615 mln over 11 months

THE volume of rice export from 1 April, 2018 to 1 March, 2019 is estimated at 1.82 million metric tons, earning over US\$615.74 million., according to an announcement of Myanmar Rice Federation (MRF).

Over the past 11 months, Myanmar's rice was shipped to 50 countries whereas over 393,790 metric tons of broken rice were exported to 25 countries, earning \$114.69 million.

Normally, border trade volume was relatively high compared to sea trade in rice export. Yet, tight confiscation by China results in trade drop at border gates. Maritime trade outperformed border trade.

Additionally, the values of rice and broken rice export dropped compared to the corresponding period of the 2017-2018 fiscal year.

In the last 2017-2018 fiscal year, 3.6 million tons of rice and broken rice worth \$1.13 billion were exported to foreign countries.

MRF did not reach its target of 2 million tons during the past mini-budget period (April to September). -GNLM

Export to Japan exceeds \$460 mln in current fiscal

THE value of export to Japan in the first four months (October-January) of the current fiscal year hit over US\$461.6 million while import was valued only \$166.8 million, according to the data of the Ministry of Commerce.

The value of trade between Myanmar and its development partner Japan touched over \$628.46 million during Oct-Jan period.

Myanmar's export items to Japan are garments, marine products, rice, black sesame, green grams, rubber and other products. In return, it imported machines and machine equipment, electronic equipment, fertilizers, chemical products, medicines, automobiles, and other products.

Bilateral trade values were registered at \$1 billion in the past mini-budget period, \$1.92 billion in the 2017-2018 FY, \$2 billion in the 2016-2017 FY and \$1.84 billion in the 2015-16 FY respectively.

This FY, five enterprises from Japan were approved to make initial investments of \$15.96 million into the country, according to the data of the Directorate of Investment and Company Administration (DICA).

Japan has made up nearly 28.9 per cent of total FDI in Thilawa Special Economic Zone, with estimated value of \$464 million since its establishment in 2014-2015 fiscal year.

The Japan International Cooperation Agency (JICA) offers loans such as ODA loan and twostep loan with a view to bringing about socioeconomic development in Myanmar. -GNLM

About 150 tons of cabbage exported daily to Thailand via Myawady

ABOUT 150 tons of cabbage are being sent to Thailand every day through the Myawady border gate, according to traders in the Bayintnaung vegetable market in Myawady Town.

"Myanmar did not send cabbages to the Thailand market earlier. Exports began this year. Cabbage farms in Thailand have been destroyed due to excessive use of pesticides. Therefore, Thai traders have begun purchasing Myanmar cabbages. Cabbages, an important ingredient in Thai dishes, are fetching 6-7Baht per kilo in the border market. They are also being delivered to Bangkok, Phuket, and Pattaya," said a merchant.

The cabbages being supplied to the Thailand market are from Pyay, DaikU, Kalaw, and Aungban towns.

During the period between 1 October and 8 March in the

current financial year, imports outperformed exports at the Myawady border gate, with imports registered at \$318 million and exports valued at \$58 million.

Myanmar primarily exports fishery products such as crab, fish, and shrimp and agro products such as onion, sesame, dry tea leaves, coconut, and turmeric to Thailand. 
Suarez suffers badly sprained ankle — Valverde

SEVILLE (Spain) — Luis Suarez suffered a "bad sprain" to his right ankle during Barcelona's win over Real Betis on Sunday, coach Ernesto Valverde confirmed.

Suarez was taken off for Philippe Coutinho in the 89th minute of the 4-1 victory, in which he scored one goal and set up the second of a Lionel Messi hattrick.

"He has a bad sprain," Valverde said afterwards. "We'll see what the doctors say but this is the feeling we have."

Suarez looks unlikely now to feature over the international break, with Uruguay playing Uzbekistan in the China Cup on Friday. He will hope to recover in time for Barca's La Liga clash against Atletico Madrid on 6 April and has just under four weeks to be ready for the first leg of their Champions League quarter-final against Manchester United.—AFP ■

Philippines will be "overwhelming underdogs" in FIBA World Cup: coach

MANILA — Yeng Guiao, the head coach of the Philippine men's national team, said his nationals will be "overwhelming underdogs" in the 2019 FIBA World Cup.

Guiao said it will take a "miracle" for the Philippines to clinch a victory in the World Cup, after the national team was slotted with powerhouse squads in Serbia, Italy, and Angola in Group D at the end of the draw

on last Saturday night.

"I'm not going to say this is the group of death. But like I said, we're overwhelming underdogs. Maybe this is the group of near death," the national team mentor said on Sunday, adding that Serbia is really a worldclass team and it's the same with Italy.

However, Guiao does not want to say miracles can't happen.

"The good thing about me is I believe in miracles. But you need to prepare hard for miracles to happen," Guiao said.

If there is a chance for the Philippines to pull off an upset in the quadrennial competition, it will be against Angola.

"They (Angola) are a strong team. Angola is the team that we can say we can realistically upset. But it's going to be a hard win. We will fight tooth and nail to win. That's how hard it's going to be," Guiao said.

The Philippines still has nearly six months to plan and prepare before the World Cup kicks off on August 31 in China.

According to the head coach, he is eyeing to have the national team train for two to three months and to have former NBA veteran Andray Blatche back from the US as early as possible. — Xinhua 🔳

United's Martial pulls out of **France Euro** qualifiers


PARIS (France) — Manchester United forward Anthony Martial will miss France's Euro 2020 qualifiers against Moldova and Iceland with a knee injury, the French Football Federation (FFF) announced on Sunday.

Martial who wasn't selected as part of the World Cup winning squad in Russia is replaced by Atletico Madrid's Thomas Lemar.

The United attacker, 23, aggravated the problem in his club's FA Cup defeat to Wolves on Saturday. His last international appearance came in a friendly against Russia in March 2018 and has scored nine goals in 21 Premier League games for the Red Devils this season.

World champion Lemar has found it difficult since arriving the Spanish capital in July scoring only once in La Liga.

France face Moldova on Friday before hosting Iceland on 25 March in a qualifying group which also includes Turkey, Albania and Andorra.—AFP

Ronaldo rested as Genoa inflict Juve's first Serie A defeat

MILAN (Italy) — Juventus suf- off the bench in the second half fered their first Serie A defeat of the season on Sunday losing 2-0 to Genoa with late goals from former player Stefano Sturaro and Goran Pandev.

Ronaldo missed the trip to Genoa after firing the Serie A side to the Champions League quarter-finals with a hat-trick over Atletico Madrid during the week.

Sturaro and Pandev came

scoring on 72 minutes and 81 minutes respectively to inflict the first league defeat on Massimiliano Allegri's side since April 2018 against Napoli.

The Champions had already been beaten this season by Atalanta in the Coppa Italia and lost in the Champions League to Young Boys in the group stage and Atletico Madrid the last 16 first leg.

Juventus had won 24 of their 27 previous matches in Serie A with three draws including 1-1 to Genoa in the reverse fixture.

Allegri's side remain on track for an eighth consecutive title as they sit 18 points clear of second-placed Napoli who host Udinese later on Sunday.

Genoa move up to 12th after this eighth win of the season. —AFP ■
