



Extremely Severe Cyclonic Storm approaches India

ACCORDING to the observations at 10:30 pm yesterday, the Very Severe Cyclonic Storm "FANI" over the Southwest Bay of Bengal and adjoining Westcentral Bay of Bengal has moved North-Northwestwards and intensified into an Extremely Severe Cyclonic Storm "FANI".

It is centered at about 260 miles East-Northeast of Chennai (India), 270 miles Southeast of Machilipatnam and 275 miles South-Southeast of Vishakhapatnam. It is forecast to move Northwestwards. It is not moving towards Myanmar coasts, the present stage of the Extremely Severe Cyclonic Storm is coded yellow stage. SEE PAGE-12



- 1. State Counsellor Daw Aung San Suu Kyi paid an official visit to the Kingdom of Cambodia from 29 April to 1 May 2019 at the invitation of Cambodian Prime Minister Samdech Akka Moha Sena Padei Techo HUN SEN, and arrived back Nay Pyi Taw on 1 May 2019.
- 2. The Myanmar delegation led by the State Counsellor arrived Phnom Penh International Airport via Kunming, People's Republic of China in the afternoon of 29 April 2019 and welcomed at the airport by Dr. Kantha Phavi, Minister for Women Affairs of Cambodia.
- 3. In the evening, the State Counsellor visited Myanmar Embassy in Phnom Penh and met with U Myint Soe, Myanmar Ambassador to Cambodia, staffs and family members of Myanmar Embassy and Defence Attache' Office at the Embassy and attended a dinner hosted by Myanmar Ambassador.
- 4. In the morning of 30 April 2019, the State Counsellor and party attended the Wreath Laying Ceremony at the Independence Monument. Then, the State Counsellor laid a wreath at the Monument of Preah Borom Ratanak Kaudh, the Late King-Father of Cambodia.
- 5. The State Counsellor and party proceeded to the Prime Minister's Office (Peace Palace) and attended the official welcoming ceremony by Prime Minister Samdech Akka Moha Sena

Padei Techo HUN SEN, and held the bilateral meeting with Prime Minister Hun Sen. During the meeting, the two leaders discussed matters on a wide range of issues pertaining to promoting bilateral relations and cooperation, especially enhancing cooperation in the areas of trade and investment, education, culture and tourism, and expanding cooperation in the regional groupings including ASEAN and Ayeyawady-Chao Phraya-Mekong Economic Cooperation Strategy (AC-MECS). Suspect behind Taunggyi homicide apprehended

THE suspected killer behind the murder of four people at the Myin Phyu Nha Kaung (Two White Horses) traditional medicine house in Taunggyi, Shan State, on 28 April was apprehended the next morning, according to Myanmar Police Force.

The man is identified as Tin Ohn (a) Aik Ohn and was arrested together with almost a viss (3.6 lbs) of gold jewellery and over K700,000 in his possession. **Crime scene**

On the day of the incident, Daw Aye Shwe, the owner of the traditional medicine house, was returning from a donation ceremony held at Kamma Htan monastery in Pinlone.

Upon reaching her house, Daw Aye Shwe discovered the deceased bodies of her son-inlaw Sai Say Mon, daughter Ma Nan Kham Hlaing, grandson Sai Pha Pha, and housemaid Ma Aye Moe in their home.

She also discovered that 15 gold jewellery and K4 million (about K155 million combined) were missing and opened a case at Taunggyi police station. **Police pursuit**

Police received information from a law-abiding citizen that led to a search for the suspect. Coupled with evidence from the crime scene and successive investigations, police arrested suspect Tin Ohn at his home in Ahtet Myin Kwin village, Kyaukme Township, at 7am on 29 April.

Police from the Special Criminal Investigation department discovered a viss of gold jewellery and K720,000 in the suspect's home yesterday that may be evidence of his involvement in the crime. **Motive for murder**

Initial investigation reveals that Tin Ohn is a drug addict and cousin of Daw Aye Shwe, the owner of the traditional medicine house. Daw Shwe Aye's husband has passed away and they had no children of their own and so adopted one of Tin Ohn's sons from his first marriage.

That son is now married and living separately from Daw Aye Shwe. She is said to have adopted Ma Nam Kham Hlaing 20 years ago as well. Ma Nam Kham Hlaing lives with Daw Aye Shwe and leads the daily operations of the medicine store.

U Tin Ohn is said to have worried that his son would

receive less inheritance and also about his own financial difficulties. This is said to have motivated him to team up with other unnamed suspects and mastermind the homicide.

The Myanmar Police Force is continuing investigations to apprehend the remaining suspects and recover the stolen items. —MNA

Soft loan agreement signed for national electrification plan

SOFT loan agreement for National Electrification Plan in collaboration with the Italian government was signed at the Department of Rural Development on 30 April.

At the event, Union Minister Dr. Aung Thu said efforts were made to distribute electricity to the areas outside the realm of main power lines by long and short term implementations.

The department under the Ministry of Agriculture, Livestock and Irrigation launched its first five year project in the 2016-2017 fiscal year and electricity have been supplied to about 9,874 villages.

About 229,000 households and 32,000 public institutions have gotten access to electricity through the solar power system in 2017- 2018 FY.

He went on to say that for the 24 hour electrification in 26 villages, solar power system, mini hydro power plant and biofuel-fired power plant are being implemented.

The ministry targeted to supply electricity to 237,000 households and 22,000 public institutions in this fiscal year. So far, loan of US\$68.22 million from the World Bank, contribution of US\$25.26 million from the State and US\$ 6.9 million from the public have been spent for the benefits of rural population.

He added that according to the survey by the World Bank and (ESMAP), solar power system will benefit the rural areas enormously and that about 25.6% of rural households outside the realm of national grid system are targeted to get access to electricity at the end of this fiscal year. He expressed his gratitude to the Italian government for the Euro 30 million loan.

Afterward, Italian Ambassador Ms. Alessandra Schiavo and Country Director of the World Bank Ms. Eilen Goldstein delivered key-note addresses.

The Director-General of the

Rural Area Development Department U Khant Zaw signed the soft loan agreement with the Italian ambassador and with the World Bank's country director for technical assistance. This soft loan agreement will benefit rural population of 0.48 million in Chin state and surrounding area.—MNA

Nine US firms explore partnership in areas of trade, investment in Myanmar

THE representatives of nine American companies, led by the US Ambassador to Myanmar, Mr. Scot Marciel, met with Myanmar entrepreneurs to discuss cooperation in trade and investment in the country at the Republic of the Union of Myanmar Federation of Chambers of Commerce (UMFCCI) and Industry office on 30 April.

The nine companies whose representatives took part in the meeting were Chevron, Earth Networks, ITW Welding Singapore, Xylerm Water Solutions, Astrophysics, Visa Myanmar, Fedex, GIS, and Arizona Tools Company.

At the meeting, UMFCCI chairman U Zaw Min Win said Chubb Life (USA) has been granted permission to operate an insurance company in Myanmar.

The US Ambassador to Myanmar said the business meeting held at the UMFCCI would provide good opportunities to entrepreneurs from both countries. The representatives from the nine American companies came to Myanmar for the first time for the meeting, and they visited the Thilawa Special Economic Zone to explore opportunities for investment.

A total of 40 Myanmar entrepreneurs from the energy, oil and natural gas industry, water purification industry, information and communication technology industry, telecommunications, media, hotels and tourism, printing services, agriculture, livestock and fisheries, construction industry, banking industry, automotive industry, footwear industry, and transportation industry attended the business meeting.

UMFCCI vice chairman Dr. Maung Maung Lay said that US companies are interested in exploring investment opportunities in Myanmar. "The potential investment in trade may amount to US\$1,000 million. Myanmar has been undertaking reforms to turn itself into a developed country.

In this regard, it is of paramount importance to get foreign companies to invest in Myanmar," he said. ■

Special coffee zone set up in Thandaunggyi Township

COFFEE will be cultivated on 5,000 acres of land in Thandaunggyi Township, Kayin State, as part of a special coffee zone project, according to the state's Agriculture Department.

Officials said there are also plan to cultivate lychee, pomelo, avocado, rambutan, orange, durian, mangosteen, star anise, green tea leaf, and cardamom at the Shwenyaungpin orchard owned by the Thandaunggyi Township's Agriculture Department.

"We have inspected land preparation work for 5,000 acres of coffee farms and provided the necessary assistance,"said U Than Htike, the head of the regional Agriculture Department.

"Five thousand acres of coffee farms have been registered under a special coffee zone project. The project aims

to fulfil the market demand in Thandaunggyi Township, produce value-added coffee, and create jobs for residents," he said.

"Coffee researchers and technicians are also required to cultivate quality coffee plants in Kayin State. At present, local farmer groups and coffee associations are working together on the project. Coffee farms will be extended by using pedigree coffee seeds based on Thandaunggyi's weather, geography, and the requirements of growers," he added.

"Two types of coffee beans are being cultivated in Thandaunggyi region, depending on the land. For instance, the Bawkali region is located 3,000 feet above sea level so, highland coffee beans are cultivated in the region, and lowland coffee varieties are being cultivated in Laketho and Thandaunglay regions as they are situated at an altitude below 3,000 feet. Good quality coffee can be exported if this project is successful," said U San Lwin, a coffee grower from Thandaunggyi township.

Expansion of cultivation is also a means of import-substitution, according to the Ministry of Agriculture, Livestock and Irrigation.

Coffee grower groups need to be established for exchange of technical knowledge, and necessary support from concerned departments is required to produce value-added coffee products.—MYANTRADE

Bonded Warehouse system set to provide boost to industries

THE Customs Department, Ministry of Planning and Finance, and the DaNa Facility, a UK aid funded programme, today launched the Developing Customs Bonded Warehouse system to introduce Customs officers and relevant stakeholders to the potential of a bonded warehouse system in supporting local industry, and to highlight the key components of a bonded warehouse programme in Myanmar.

Bonded warehouses are specifically designed to support industry, particularly those which import high value and/or high import duty goods. Through bonded warehouses, these industry sectors will have the ability to defer their import duties and taxes until they themselves find customers willing to buy the goods or identify export markets, meaning that they can improve productivity and better manage their cash flows.

This system allows for exported finished goods to be more competitively priced in regional and global markets as this export pricing does not include embedded duty and tax charges. This system also enable to export through such an enhanced competitive process brings in important income for the country. The significant cases are found in the garment exporting countries, where shorter leadtime is a competitive factor. Therefore, it will be a case for Myanmar.

"The Customs warehousing business has improved accompanied with increased job opportunities. Especially, opportunities for CMP manufacturing could increase in areas such as delivering goods to customers in real time, saving costs of transportation and manufacturing, allowing higher competitive capacities to enter international markets. Additionally, trade with neighbouring countries would be more developed if customs and bonded warehouses are situated at border points," said U Aung San Tun, Deputy Director General of the Customs Department.

Bonded warehouse systems not only streamlines international trading process and contributes to the transformation of key industries such as garments and other manufacturing, but also creates an environment conducive to linkages between SMEs and large multinational and local firms.—GNLM

Clamping down on spurious inputs can keep farmers away from poverty

YANMAR is an agro-based country. More than 70 per cent of the country's population is residing in rural areas, and most rural people are relying on agriculture for their livelihood.

To develop the country, we need to work to improve the socio-economic life of the rural people in every possible way.

To help farmers, the incumbent government has increased the amount of agricultural loans and is providing assistance to farmers in land preparation. The government has also been lending agricultural machinery and allowing farmers to buy machinery on instalment

The government has also set the basic price of rice, the staple food of Myanmar, at K5,000 per basket so that growers do not suffer losses.

Farmers can send a product they are suspicious of to the local agriculture department, in accordance with the rules and regulations.

Meanwhile, the standard of inputs, such as pesticides, fertilizers, and seeds, has become an important factor in the production of quality crops.

Pesticides, fungicides, herbicides, crop seeds, and topsoil are available in the market when the growing season draws near.

We would like to urge the authorities to step up efforts to investigate spurious inputs in the market before they reach the farmland, at the request of farmers.

At the same time, businesses and organizations interested in trading agricultural inputs must follow the set procedures. For instance, those engaged in seed trading need to apply for a seed recognition certificate and then apply for a business license. A business license permits traders to only deal in crop seeds they

have obtained a certificate for. Only if they meet these requirements can businesses produce and distribute crop seeds, in accordance with the Seed Law.

Businesses seeking to import pesticides have to submit a sample product to the license verification board, which sends it to a laboratory for testing whether the sample meets the set standards. If all requirements are met, then a license is issued along with a permit from the Department of Agriculture.

The department also inspects every import shipment to see if it matches the specifications of the sample product submitted during the examination.

Shipments are only allowed to leave ports and enter the market after passing these inspections.

Farmers can send a product they are suspicious of to the local agriculture department, in accordance with the rules and regulations.

If the product does not match prior standards, then the matter can be relayed to a relevant committee for further action.

Ministry of Defence and **United Nations Country Task** Force on Monitoring and Reporting (UN CTFMR) signed an

agreement on a plan of action for prevention of military recruitment of underage children on 27 June 2012 and a 13-member committee was formed. During the third one year term of the government, the government of Myanmar and UN CTFMR met twice in the Ministry of Defence and once in Yangon. Monitoring visits were made to two infantry regiments and two non-combatant units. Multiplier courses on preventing recruitment of children were conducted by Military Commands and were attended by 1,520 officers and 6,163 other ranks. The courses were conducted Military Command wise once every two months. Tatmad aw personnel found to have been recruited before reaching the age of 18 years were also being released from military duty according to Tatmadaw rules and regulations. 75 were released back to their parents or guardians on 31 August 2018 and a further 32 were released back to their parents or guardians on 31 March 2019. To prevent enlistment of under 18 years old bone X-ray method was used to determine their ages. Using this method prevents recruitment of 1,636 under age recruits during the third one year period. And it had prevented unusual recruitment of under aged recruits during the third one year period.

Myanmar Tatmadaw in cooperation with UN CTFMR was following to the letter the Plan

Magway Region

THERE have been many noticeable changes and improvements in the third year of administration by the people's elected government. The governing body of Magway Region has been striving for the uniform development of the people's livelihoods and regional stability since over the course of three years.

Historical milestones

The regional government's efforts to improve the lives of its citizens and speed up regional development and stability has solid undeniable historical milestones.

The Department of Roads handled 2,187.544 miles of road in the region and 454.460 miles were implemented by six private companies under the B.O.T system.

There are five districts and three special road and bridge groups under the regional road department. They carry out tasks such as constructing new roads and bridges, maintaining and upgrading existing ones in line with the available funds from the Union and regional budgets.

From the 2016-2017 FY to 2018-2019 FY, they received K15,070.544 million from the Union budget and K169,677.52 million from the regional budget. The department performed such tasks as paving bitumen roads, asphalt concrete roads, expanding roads, laying new layers on existing roads, paving reinforced roads, building bridges and concrete culverts. Additionally, the roads department acquired funds from the department for developmental affairs and used them on paving 120/5.62 miles of roads, building 682 bridges, conducting 367 water-related projects and other 76 miscellaneous tasks.

They also used a tender system to pave 2/4.25 miles of roads, funds from the regional government for 17/2.27 miles of roads, 181 bridges and canals, 19 water-related projects, and 36 other tasks. Using the tender system, they also built 66 bridges and canals.

Natural disasters

The regional department for water resources and development of bodies of water used K450 million from the 2018-2019 FY's Union budget to dig shoals. They carried tasks to ensure smooth flow of bodies of water and preventive measures for bank erosion using K1,552.91 million from the regional funds, K340.938 million from the general excess funds, and K380.42 million from the tax dividend funds. They also used K90 million from the natural disaster fund and K3,136.75 million from the regional funds to conduct preventive measures for bank erosion.

Positive results

The regional cabinet has collaborated with the Ministry of Construction to build roads and bridges that will support the region's development. The transportation infrastructure was upgraded over the course of three years and has resulted in lesser

traffic accidents, cost-effective and time-saving travel, increase trade and other benefits.

The Agricultural Machinization Department contributed to the agricultural development of Magway Region. In the 2016-2017 FY, they formed 100 acres of irrigated cultivation for Ko Yan Taung-tract in Myothit Township and 200 acres of irrigated cultivation for Kalar Par village-tract in Minbu Township using K175.75 million from the regional budget. To help farmers own more agricultural machinery, the regional government has arranged for purchasing schemes from government departments and private-cooperation sales. In 2018-2019, government departments sold 26 large tractors, 566 mechanized tillers and 2 combine harvesters.

The Department of Irrigation and Water Management began repairing the Yesakyo-Tamartan embankment in 2018-2019 FY using K100 million. They have currently finished 35 per cent of the work.

They have conducted 45 maintenance tasks in the first six months of 2018 using K1,058.976 million from the Union funds. In 2018-2019 FY they used K2,120 million to begin work on 116 tasks and have completed 76 of

them so far.

Ongoing tasks

The Agricultural Machinization Department also used K569 million from the Union budget in the six-month budget period of 2018 to build approach portions, crest portion walling to RL-560' and approach portion walling up to RL-540'.


In the 2018-2019 FY, they will use K750 million from the Union budget to repair spillway No. 2, approach portion walling. They began work on the spillway on 15 December 2018 and are carrying out coffer dams, basins and drainages.

Concerning the construction and maintenance of dams and rural reservoirs, they used K4,217.489 million in the first six months of 2018 to undertake 184 tasks. They used K5,572.921 million in 2018-2019 FY for 187 tasks. They also used K593.0204 million from the tax dividend fund for 24 tasks and K30 million from the disaster fund for 1 task. Out of the 212 tasks they are handling, 57 tasks have been completed so far.

The regional government delegated the task of increasing spillways in the Kyee-ohn-kyeewa dam in 2018-2019 FY to an external company. They used K250 million from the Union budget to expand 200 feet of the 450 feet of spillways by lowering RL-340' by 4 feet to RL-336'.

Implementations

The Department of Rural Development's responsibilities involve developing the education, healthcare, society and businesses of the people and regulating better trade flow. In the first six months of 2018, they implemented 7 miles and 5.18 furlongs of rural trade routes and built 3 rural trade bridges using K204 million.

In 2018-2019 FY, they used K770.876 million to implement 21 miles and 5.9 furlongs of rural trade routes and build 12 rural trade bridges.

Furthermore, they used K4,587.8189 million for rural water supply tasks from 2016-2017 FY to the six-month budget period of 2018. Using that fund, they implemented 443 tasks in 431 villages, benefitting 319,210 people from 66,388 households. They performed 123 rural water supply tasks for 123 villages in 2018-2019 FY using K2,360.604 million from the allotted budget.

In the electric power distribution sector, the regional government used K10 billion from their budget in the first

six months of 2018 to implement 103.83 miles of 11KV transmission lines, 100 11/0.4 KV transformers, and 47.871 miles of 400V transmission lines benefitting 104 villages. They constructed the 66/11 KV 5 ampere Thayet substation to convert from a 6.6 KV system to a 11 KV system. **Upgrading and expanding**

The regional government upgrades classrooms regularly to develop the education sector. In 2018-2019, they opened 47 basic education high schools, 143 basic education high branch schools, 417 basic education middle schools, 187 basic education middle branch schools, 148 post primary schools, 85 primary schools and 27 primary branch schools. They also carried out numerous developments for the healthcare sector in 2018 FY by constructing three-room residential buildings for the Department of Traditional Medicine in Myaing Township which was completed on 16 August of the same year. They also constructed an embankment for the traditional medicine department of Yenangyoung Township and provided fencing for a similar department in Htilin Township.

Support provided

For the township rural

health departments and sub departments in Magway Region, the regional government sued K1,711.761 million in 2018-2019 FY to purchase pharmaceuticals. And with the programme provided by the Public Health Department, the regional government was able to supply 2,745 mobile tablets to various doctors and medical personnel across the townships of Magway Region so that they can be up-to-date with the latest medical news and discoveries.

The regional government elevated two rural health sub-departments to department status in 2018 and opened 14 new sub-departments as well.

In the 2018-2019 FY, the regional General Administration Department used K15 million from its allotted budget for rural development projects by submitting to the regional government so as to approve the proposals from districts for development. The regional government expanded and rearranged 29 villages in 2018.

There are couple of noteworthy cases concerning illegal drugs in the third year of the Magway Region government administration. From 23 to 27 January 2018, the regional government collaborated with the Tatmadaw, Myanmar Police Force, relevant departments and NGOs to uncover and destroy 55.8 acres of poppy plantations in Ngaphe Township of Minbu **District and Thayet Township** of Minhla District. From 3 to 9 December 2018, they eradicated 18 acres of poppy plantations of the same two townships. And from 21 to 27 January 2019, they eradicated 28.14 acres of poppy plantations from the same two townships.

Visible change

The efforts of the Magway Region Government to make the region more developed and safer for its residents is visible and their accomplishments are plain for all to see. The regional government has made strides in agriculture, electric power, transportation, water supply, healthcare, education, rule of law, communal safety, and the rights and protections granted by existing laws on the people.

The reforms, improvements and achievements made by the people's government are the fresh new steps towards establishing a peaceful and prosperous nation with sustainable peace. It won't be long till we all reach our shared objective in the future.

16 Indian commandos killed in fresh election violence

MUMBAI(India) — A suspected bomb attack by Maoist rebels killed 16 Indian elite commandos on Wednesday, police said, the latest incident of election-time violence in a decades-long insurgency.

"Maoists attacked a team of commandos travelling in a private vehicle to inspect an earlier attack. So far 16 men have died," an official at police headquarters in the western state of Maharashtra told AFP.

"More teams have been sent to site for rescue and combat operations," said the officer, who did not want to give his name.

India is holding elections and attacks by Maoist rebels, who are active in several states, often spike as the country goes to the polls. A second police official put the death toll in the latest incident in the Gadchiroli region of Maharashtra at 15.

"Maoists torched over 30 vehicles in Gadchiroli today at 12.30pm (0700 GMT). In another blast, 15 security officers were killed and rescue operations are ongoing to ascertain the damage," Gadchiroli police official PrashantDute told AFP.

Indian forces have been fighting Maoists rebels for decades in several areas, in an insurgency that has killed tens of thousands. The Maoists are believed to be present in at least 20 Indian states but are most active in Chhattisgarh, Odisha, Bihar, Jharkhand - and Maharashtra. India's nationwide election began on 11 April and runs until 19 May. Last weekend rebels opened fire on Indian police, killing two constables and wounding a villager in the central state of Chhattisgarh, the Press Trust of India (PTI) news agency reported. One constable and an assistant constable died at the scene and the villager, shot in the chest, was taken by local residents for treatment, PTI reported.—AFP

Emperor Naruhito declares succession to throne in ceremony

TOKYO-Emperor Naruhito declared his succession to the Chrysanthemum Throne in a ceremony Wednesday and pledged to fulfill the symbolic, nonpolitical role in accordance with the postwar Constitution.

His enthronement after Tuesday's abdication by his 85-year-old father former Emperor Akihito-the first by a Japanese monarch in 202 years — marked the start of Japan's new imperial era, named Reiwa.

The 59-year-old is the first emperor to be born

The ceremony at the "Matsu no Ma" stateroom in the Imperial Palace was attended by some 260 people, including the heads of the government, legislature and judiciary as well as other imperial family members.

Following the emperor's speech, as a representative of the people, Prime Minister Shinzo Abe congratulated Emperor Naruhito on his enthronement and pledged to create a "bright future" that is peaceful and full of hope by respecting him as a symbol of the state.--Kyodo News

Local gold price likely to continue declining trend, say traders

WITH gold prices witnessing a downward trend in the global market, the price of gold is likely to continue its slide in the domestic market, said U Myo Myint, the chair of the Yangon Region Gold Entrepreneurs Association.

Gold is currently priced at K1,037,000 per tical (0.578 ounce) in the domestic market, he said.

"Gold is sliding in the global market. As the domestic gold price is related to global prices, it is also declining,"said U Myo Myint.

If the downward trend in global gold prices continues, the domestic gold price is likely to remain on the low side as well, he added.

"Global gold prices have dropped by US\$1 per day. So, the domestic gold price will also fall a bit," said U Myo Myint.

In the second week of April, global gold prices reached above US\$1,300 per ounce. At present, they have declined to \$1,279, said traders. In addition, the gold market is cooling off, they said,

With global gold prices increasing, the local gold price hit new peaks in 2019. It reached K1,050,000 per tical between 17 and 29 January, above K1,060,000 in the period from 30 January to 7 February, above K1,070,000 from 8-18 February, and above K1,080,000 from 19 to 21 February. Then, the price gradually declined to reach the current level of K1,037,000.

Local gold price touched a low of K1,043,4000 on 1 January and a high of K1,061,000 on 31 January. It hit a low of K1,058,400 on 2 February and a high of K1,087,300 on 20 February. In March, the lowest level of K1,048,600 was recorded on 30 March, and the highest level of K1,069,000 was seen on 21 March. In the past month, the gold price reached a low of K1,037,200 on 24 April and a high of K1,054,700 on 11 April, according to gold traders.

How to operate companies after establishment

By Maung Ti Kar Myanmar Companies Law

The Myanmar Companies Law signed by the President which was released on 6 December 2017 came into force starting from 1 August 2018. The new company law comprising modern procedures and improvements in legal affairs being exercised in the international community set up the harmonized framework which is clear and transparent for companies. Companies at home have opportunities for easily abiding by the company law because of easing procedures. Hence, the new law is more effective not only for companies but for relevant governmental departments which take responsibilities for controlling the companies. Significantly, as the new law consists of full text of provisions on corporate management affairs which were not included in the old law, the law

contributes a great deal towards creation of connections between businesses of Myanmar and international business firms. Moreover, the law reduces burdens of rules and regulations for small- and medium-scale enterprises as well as cuts the cost in practising the law. A new online registration system namely Myanmar Companies Online (MyCO) was established together with the new company law in order to ease the processes of setting up the company for businesspersons in Myanmar. As such, all the businesspersons who have experienced in applying the MyCO show their satisfaction. Foreign businesspersons praised that MyCO was much better than online registration system of some regional countries. Thanks to MyCO, a total of 11,658 new companies could be registered from 1 August 2018 when the MyCO was launched to the end of February 2019. Moreover, a total of 46,377 companied

aged by the government in uplifting the position of Myanmar in the Doing Business Report yearly issued by the World Bank.

Registrar and Regulator

Some people ask that if companies have registered in easy processes, how the company registration office will regulate them to correctly operate their businesses and how to tackle increasing number of compa-

which took registration under the old law were re-registered through the online system. That is why 58,035 companies in total have been registered through the online facility so far. With regard to the statistics on yearly registration, new record of registering the companies was remarkably set within seven months by breaking the old record with 9,286 companies registered in 2017-2018 fiscal year. Active registration of companies through the online was based on modernity of new company law and clearness and ease of MyCO which remarkably cut work procedures, duration of procedure and cost for registration of companies. Such a plan will contribute much towards the tasks being vigorously encournies doing misdeeds. Actually, it was found that the majority of questioners do not really understand the duty and authority of the Directorate of Investment and Company Administration (Registrar) which handles the company law and the role of relevant governmental departments (Registrar) which controls businesses of registered companies under respective laws.

The company means a business group which is formed with share-holders with or without limitation of liability under the relevant company law. In fact, a company is a separate group which is set up under the law. Legal vocabularies related to economy define the company as "Legal or Judicial Person" SEE PAGE- 15

and human being as "Natural Person". It means a company has the rights of possession, the rights of living and the rights of arguing the cases in a court of law similar to that of a human. The DICA scrutinizes and controls things whether the companies abide by provisions of the company law or not. That is why the DICA is taking responsibilities for registering the companies as well as controlling the company law. On the other hand, the DICA can be dubbed as immigration for companies because immigration department scrutinizes the citizens to be able to issue the citizenship scrutiny cards.

If a registered company starts a business, it needs to seek permission order, licence and permit from relevant governmental organizations under the provisions of the respective law as well as operate tasks of business under the supervision of relevant governmental organizations in line with the law. For example, one wish to operate hotel services, one must seek licence for hotel at the Ministry of Hotels and Tourism. Likewise, one wants to carry out export and import businesses, one need to apply for hospital licence from the Ministry of Health and Sports. So also, one wishing to operate security services must seek permission order from the Ministry of Home Affairs. Only when they get such permission orders and licences, will they have to initiate their businesses. Registration at the DICA is not to allow operation of a business but it helps emerge a company under the law. The majority of people seem the business can be operated after taking registration at the DICA but it is untrue. With regard to the issue of a company related to security services spreading in the social media, it is necessary to apply for

the permission order from the Ministry of Home Affairs at first, and only when it receives the permission, can it launch the business. However, the Ministry of Home Affairs has not received the application for the business yet. And, the ministry has not given permission to it yet.

Who will take action against companies doing misdeeds? Somebody ask that at a time when the events emerge that some companies doing misdeeds in the economic arena break the laws, how will the DICA take action against them? Actually, the relevant governmental organizations which handle relevant laws will take action against the companies which broke the laws. Only when the companies break the company law, will the DICA take action against them under the provisions of the company law. On the other hand, relevant government organizations will take action against a citizen who violates the law. "The immigration" cannot take action against such citizen although the Immigration issued the citizenship scrutiny card to him. So also, relevant governmental organizations must take action against the company which breaks the law. However, if members of the Board of Directors from the company fail to duty and qualification of BOD members prescribed in the company law, the DICA will take necessary action against them under the company law. Moreover, if those BOD members commit dishonest activities, they can be prosecuted to face separate penalties sentenced by the court.

means that the government lays a sound foundation for development of private sector. In fact, the company law brings development to all companies which are systematically operating the businesses under the law. However, companies in operating relevant businesses need to take registration through MyCO with ease, quick and clear facilities. And then, as it is important that these companies must exactly and correctly carry out their tasks under relevant laws in respective business fields, I would like to urge these companies to contact relevant departments for seeking permit if necessary.

Financial services reforms to take centre stage in 2020 report on Myanmar

NEW report by the global research and consultancy firm Oxford Business Group (OBG) will map out Myanmar's ongoing efforts to open up its economy to the outside world, and the legislative and regulatory reforms that are being implemented to accommodate the nation's plans.

PARIS (France) — Fernando Alonso will quit endurance racing after June's '24 Hours of Le Mans', which he won last year, the Toyota team said on Wednesday.

The Japanese team said Alonso, who twice won the F1

world championships with Renault in 2005 and 2006, had set himself fresh motor sports targets.

The 2020 Dakar Rally in Saudi Arabia is thought to be high on his agenda after he tested the Toyota Hilux in South Africa alongside 2009 Dakar champion Giniel de Villiers. The 37-year-old Alonso who raced F1 until last season is widely viewed as one of the top talents of his generation, and enjoys global star status after

racing 312 Grand Prix, winning 32 of them.

"I have enjoyed being part of Toyota Gazoo Racing, but this chapter is ending," Alonso said in a press release on Wednesday.

"Winning the Le Mans 24

Hours is one of the highlights of my career as part of my triple crown challenge," said Alonso, who races the Indy 500 later this month in his triple crown (Monaco GP, Le Mans and the Indy) bid.—AFP
