Govt, private sector must cooperate on formation of Coffee Board: U Henry Van Thio

YANMAR Coffee Forum 2019 was held in Mandalay yesterday by the Ministry of Agriculture, Livestock and Irrigation. This forum moved to form a Coffee Board to push for production of quality coffee and expanding the export market.

Vice President U Henry Van Thio said in his opening address that the aim of the forum was to - "To keep our coffee sector on its development trajectory, to deal with the current situation, and to fulfill the needs for the development of coffee".

The second coffee forum has come two years after the first one, which was held in Nay Pyi Taw on 23 May, 2017.

In his capacity as the Chairman of the Body for Protecting Farmers' Rights and Promoting their Interest, Vice President U Henry Van Thio appreciated the successful implementation of the decisions taken at the 2017 forum, and pointed out some more requirements.

"After working for the development of the coffee sector for two years, between the two forums, we have witnessed an increase in production and access to markets, with farmers applying good technology. These have come as visible achievements," said the Vice President.

He called for cooperation between the government departments and the private sec-

tor for the formation of a Coffee Board, quality control of coffee, getting a suitable price in the market, and granting of loans to coffee growers.

He said that coffee came after crude oil in the world trade market, and it was considered an industrial crop that could generate foreign exchange, like other agricultural products coffee coff

such as rice and peas.

He added that Myanmar Arabica coffee produced in Pyin Oo Lwin and Ywangan in Shan State was ranked a specialty coffee globally, and Myanmar coffee fetched a reasonable price in the international markets

He also asked all stakeholders in the sector to develop not only Arabica coffee, but also Robusta coffee in areas with favorable climate, as a substitute for imported instant coffee.

He said it has been found that the Myanmar coffee sector still lagged in terms of development due to weaknesses in processing technology compared with Thailand, Indonesia, and Viet Nam, shortcomings in information sharing, and a small market share.

To put Myanmar coffee on the track to sustainable development, collaboration between the government and private players must be undertaken, in conformity with the government's policies and private sector development.



Appointing local ethnic teachers, developing industrial sector

THE sixth-day meeting of the Second Pyithu Hluttaw's 12th regular session was held yesterday. Making Mawtaung trade camp permanent

Daw Tin Tin Yi, MP for Kyunsu constituency raised a question on whether the temporary Myanmar-Thai border gate trading camp in Mawtaung Sub-town, Taninthayi Township, will be made into a permanent trade camp. She reasoned that the trade through the camp only takes 8 hours for Myeik's fishery products, thus considerably reducing transportation fees and allowing effective inspection for quality.

Deputy Commerce Minister U Aung Htoo replied that both countries need to agree on and add in a clause in the border demarcation agreement for Mawtaung trade camp to be established as a permanent camp. Moving network boxes off pavements

U Tun Myint, MP for Bahan constituency raised a question on whether the network boxes placed inconveniently on pavements in Bahan Township will be moved to more suitable locations and whether the entangled communication lines and utility poles leaning from their weight will be fixed. Deputy Minister

for Transport and Communications, U Kyaw Myo replied that Myanma Post and Telecommunications, the Myanmar Post and Telecommunications and the Yangon Region government are working together to install new multi-service access nodes (MSAN) to replace the old devices and will work with external professionals and communications-licensed companies to handle the utility poles and reduce overhead cable clusters. He said this will reduce the inconvenience in public spaces throughout all of Yangon.

Bill Committee's amendments to Basic Education Bill approved

Next, Bill Committee member Daw Mar Mar Khine submit-

ted the proposal for amending the Ministry of Education's Basic Education Bill to the Hluttaw. Pyithu Hluttaw Speaker U T Khun Myat called for the assembly's deliberation on the Bill Committee's 67 amendments outlined in their proposal. With no opposition raised to the proposal, the Speaker announced the bill has been approved and will continue its due process.

Urging government to appoint local ethnic teachers first

U Nyan Hein, MP for Thanbyuzayat constituency tabled a motion urging the Union Government to enact a policy that prioritizes graduate ethnic people in the primary teacher selection process in their hometowns. The MP said he has read the full report on the basic education schools in Mandalay and Yangon submitted by the Union Education Policy Commission at the 11th regular session of the Pyidaungsu Hluttaw but stated that the challenges and solutions outlined in the report are different from the ones rural areas are facing. He said the first challenge there is the language barrier.

U Nyan Hein said the Union Government's success in making the transportation network better has resulted in more ethnic people from rural areas graduating university. He said assigning them to teaching roles will solve the language barrier issue, resolve the tendency for teachers to file for leave when they are assigned to remote locations, reduce the cost for accommodation for hiring outof-town teachers, and increase the promotion of local customs and traditions through the local ethnic teachers in education and administration tasks.

U Myint Oo, MP for Gwa constituency seconded the motion. The Speaker called for the Hluttaw's deliberation, received approval and announced the motion has been forwarded for discussion. He called for MPs interested in discussing the motion

to enroll their names.

Motion urging for industrial sector development

Hluttaw representatives then discussed a motion tabled by Daw Cho Cho, MP for Ottwin constituency. The motion urged the Union Government to review the investment policies surrounding the domestic industrial sector, plans for including domestic products in the global supply chain, and acquiring the necessary finance and technology for pursuing them.

Dr. Daw Thet Khine, MP for Dagon constituency, Tatmadaw Pyithu Hluttaw representative Major Zay Phyo and Dr. U Win Aung, MP for KhinU constituency discussed the motion.

Following the Hluttaw representatives' discussion, Union Industry Minister U Khin Maung Cho responded to the motion on behalf of three ministries concerned. He said the Ministry of Industry regularly conducts a variety of training courses and awareness campaigns across Myanmar to further the development of its MSMEs, including capacity building initiatives, handing over of production technology, financial management, designing business plans, among others.

Second Amyotha Hluttaw's 12th Regular Session holds its sixth-day meeting

The sixth-day meeting of the Second Amyotha Hluttaw's 12th Regular Session was convened, yesterday morning, in the Amyotha Hluttaw's meeting hall, where asterisk-marked questions were raised and answered, a bill and two motions were tabled, and a report was read.

Asterisk-marked ques-

tions and answers

In the first question of the Hluttaw Session, U Kyaw Ni Naing of Shan State constituency 11 raised a question concerning the conservation works of depressed median on Yangon-Mandalay road. Regarding this query, Deputy Minister for Construction U Kyaw Lin replied that depressed median, flexible barrier and guardrail had been constructed in order to alleviate the traffic congestion, an effort to facilitate smooth transportation on the roads in accordance with the standard of highway capacity although there were four-lane roads and the present height of

the median were raised.

U Htein Win of Ayeyawady Region constituency 2 asked if there was a plan to implement Pegyi Kyun-Pauk Tabin-Seiktha-Kywet Kyun route in Hinthada Township, Ayeyawady Region, and the project had not been carried out until now although field survey had been conducted with the help of the World Bank two years ago.

U Min Swe Naing of Kachin State constituency 6 asked if there was a plan to upgrade the earthen roads to gravel ones linking to Nan Khan village and Kyunpinthar village situated in Nanma village-tract, Mohnyin Tsp, Kachin State.

U Myo Htap (a) Salai Myo Htike of Chin State constituency 12 asked if there was a plan to construct a road between Kayat-Sardi-Wadinegone-Walonggone-Shwepyigone-Sinli-Parsin villages in the 2019-2020 FY.

U Man Law Maung of Meiktila constituency 8 asked if there was a plan to issue the account settlement process of money collected from Mini Toll Gate 2 running from Meiktila to Nay Pvi Taw.

Next, Deputy Minister for Construction U Kyaw Lin replied the queries posed by U Min Swe Naing of Kachin State constituency 6, U Myo Htap (a) Salai Myo Htike of Chin State constituency 12 and U Man Law Maung of Chin State 8 respectively.

U Aye Min Han of Mon State Constituency 1 asked if there was a plan for the State Government to provide effective technical and financial assistance for international standard of salt production that aimed to prevent the salt exports from other countries while setting up manufacturing industries with the use of raw materials.

In addition to this, Deputy Minister for Natural Resources and Environmental Conservations Dr. Ye Myint Swe replied that the revenue of the salt productions was being contributed to the regional and state funds. There were a total of 76 salt mills in the 2018-2019 FY. It would be costly to produce iodized refined salts due to the technology. China National Complete Plant Import and Export Yunnan Co, Ltd have offered a proposal to produce iodized refined salt in 2010, but the investment proposal had been postponed due to the consent of the local populace. Moreover efforts were being made to curb the illegal trading in cooperation with the Ministry of Planning and Finance and Department of Customs while setting up inspection gates in the regions. Deputy Minister Dr. Ye Myint Swe replied the queries raised by U Maung Maung Lat of Sagaing Region constituency 9 and Dr. Khun Win Thaung of Kachin State constituency 11.

The Vice President added that if the quality of coffee could be controlled, it could become an import substitute product, and get a larger share of the foreign market.

He further went on to say that to achieve this, it was necessary to rely on those who lead in terms of integrating the internal affairs and the external affairs related with coffee communities, directly and indirectly.

He called on the Agriculture Department, the Myanmar

Coffee Association, and other related departments, including the Department of Trade and Cooperatives Department to form a Coffee Board, which was considered a priority at the forum.

He also called for seeking loans from local and foreign sources and exchange views and ideas for tackling current challenges at the forum as part of efforts to get good strategies for developing the coffee sector as soon as possible.

He further added that discussions at the forum should also focus on requirements to be fulfilled by the government, tasks to be carried out for the development of coffee in the future, market situation, necessary assistance for coffee growers and producing value added coffee products.

Following the Vice President's opening address, Chief Minister of Mandalay Region Dr. Zaw Myint Maung and Deputy Minister for Agriculture, Livestock and Irrigation U Hla Kyaw discussed future tasks for developing the coffee sector.

At the ceremony, Vice President U Henry Van Thio, Mandalay Region Chief Minister Dr. Zaw Myint Maung and Deputy Minister U Hla Kyaw presented prizes to award winners in different categories related with coffee production sector.

After the ceremony the Vice President visited the Yeywa Hydro Power Plant in Kyaukse District, Mandalay Region, where officials concerned reported on generating electricity at the plant.

At the briefing hall, Managing Director of the Electric Power Generation Enterprise

Yeywa Hydro Power Plant can produce 3550 million Kilowatt hours per year.

U Khin Maung Win reported on linkage between the plant and the national grid, electricity production, actual design and production of power in reality and security of the plant.

Afterwards, Deputy Minister Dr. Tun Naing reported on completion of power plants in 2019, maximum production of electricity yearly including from hydro power plants while Director-General of the Hydro Power Implementation Department U Chit Toe provided a briefing on completion of dams for production of hydro power.

After hearing reports, the Vice President stressed the need to take necessary measures for producing hydro power as the monsoon seasons was expected to end early this year.

He also called for maintenance of the remaining two turbines as the other two were on operation.

The Vice President also visited the plant and dam and presented gifts to the employees of the plant.

Yeywa Hydro Power Plant was established in the 2001-2002 fiscal year and the dam is 2264 ft long and 433 ft high.

Over 12 million acre feet of water flows into the dam every year and the dam can store 2.1 million acre feet.

The spillway of the dam is Ogee Type Ungated type and it is 448 ft wide.

The plant has 790 MW capacity and it can produce 3550 million Kilowatt hours.—MNA (*Translated by Tun Tun Naing*)

Ministries of Ethnic Affairs, Education, Nay Pyi Taw Council explain third-year performances

THE Ministry of Ethnic Affairs, Ministry of Education, and Nay Pyi Taw Council held a press conference on the third year in office serving the public at the meeting hall of the Ministry of Information in Nay Pyi Taw yesterday.

Dr. Myo Thein Gyi (Union Minister for Education)

The Union Minister said his ministry has been working tirelessly to fulfil the 12 priority objectives for reforms they had promised to the public. He said they have worked for synchronizing middle and upper classes of basic education schools to improve the lives of people with low education and opened vocational training classes for them as well.

He said they have permitted universities to design and teach their own curricula and conduct self-administration and research programmes. In addition, they have strived for educational services that will ensure students do not become a burden to their society, and for a transparent handling of educational budgets from the Union Government, private sector and other domestic and foreign sectors.

The Union Minister said national expenditure on education has increased with K2.17 trillion spent in the 2018-2019 for implementing education reforms and transitioning from a primarily rote-learning system to one that encourages critical thinking.

He said they have made necessary amendments to the textbooks for Grades 1, 2, 3 and 6 and have given training to teachers on the Grades 3 and 6 textbooks for 1 June of the 2019-2020 academic year. He said they are aiming to complete redesigning the textbooks for Grades 4, 7 and 10 for the 2020-2021 academic year, Grades 5, 8 and 11 for 2021-2022, and complete textbooks for all 12 Grades and the teachers' manual by 2022-2023.

The Union Minister said there are 404,444 teachers and 9,144,169 students in the 47,005 government schools across the nation and combined with private schools, the number of students in Myanmar totals out at 9,707,080. He said the number of students in Shan State and Ayeyawady Region increased with the expansion of schools in the 2018-2019 academic year.

The Union Minister said they are constructing new school hos-

tels with the allotted budget and handing out textbooks on social and moral development and teachers' manual free of charge. He said the matriculation exam pass rate has increased from previous years.

The Union Minister said there has been an increase in students living with disabilities, from migrant families, and in penitentiaries taking the matriculation exam in the 2018-2019 academic year. He said the Rector Committee has been formed and has held two seminars followed by the formation of nine working committees and eight special task groups.

The Union Minister said they are upgrading the 2-year education college courses to 4-year education college degrees. He said they have opened courses to meet the specific requirements of various regions such as opening a postgraduate course on tourism management at the National Management Degree College and Mandalay Degree College, a postgraduate course on fisheries and aquaculture in Yangon University, and a postgraduate course on marine science in Sittway University.

He added that 1,890 students have been sent on scholarships to 49 countries between 2016 to 2018.

U Min Aye (Director-General, Ministry of Ethnic Affairs)

The Director-General first highlighted the ministry's role in organizing the Ethnic Sustainable Development Forum on 18-19 January 2018 in Nay Pyi Taw. He said a noticeable result of the forum was the establishment of the Myanmar Ethnic Entrepreneurs Association (MEEA) on 17 March of the same year.

He said the MEEA facilitated the Myanmar Ethnics Culture Fest in Yangon's Kyaikkasan grounds from 25 to 30 January this year, which was successfully thronging with visitors amid free admission. The festival showcased a plethora of traditions, cuisine and other aspects of the multitude of ethnic races across Myanmar in addition to holding the Miss Ethnic Myanmar 2019 pageant, with ambassadors and foreign visitors attending, said the Union Minister.

He added that a forum titled 'Change-Challenges to Opportunities' was held on 24 January 2019 to honour the Myanmar Ethnics Culture Fest.

U Min Aye said his ministry helps with organizing celebrations for auspicious days of ethnic races in Nay Pyi Taw Council Area and coordinates with the relevant government for celebrations held across the states and regions. He said the Union Minister for Ethnic Affairs and the Deputy Minister either attended the various ethnic auspicious commemorations and presented cash donations or sent messages of greetings.

U Min Aye said his ministry collaborated with the Ministry of Education to appoint teaching assistants for ethnic literature in basic education schools during the 2017-2018 academic year and has currently appointed 5,161 teaching assistants across the states and regions and Nay Pyi Taw. He added they are planning

with MoE to send 719 graduates of the appointed teaching assistants to the education college and appoint them as primary class guides.

The Director-General said they have published 3,412,230 story books containing the Burmese language and one of 66 ethnic languages for KG classes. He said they held a workshop on 6 March 2018 to translate the healthcare standards guidebook into ethnic languages. He said they are discussing with all concerned ethnic literature and culture groups.

U Min Aye said they have translated posters educating the public on vaccines for children, Japanese encephalitis and influenza into ethnic languages and the results have seen a better understanding on these topics by ethnic people.

He said they are continually working on documenting endangered ethnic cultures and customs for preservation and have completed a documentary on the Tanaw ethnic race.

U Min Aye said they are providing rice and fishing boats to the Salone people in Taninthayi Region using K61.6 million of the regional budget, with the ministry's regional department acting as the focal point.

He said they have held a coordination meeting to evaluate the draft bylaw on protecting the rights of ethnic races on 20-21 September 2018. He said they have sent the bill to the Union Attorney-General's office and will send it to the Union Government if the UAG gives approval.

U Tun Tun Win (Acting

Secretary, Nay Pyi Taw Council)

U Tun Tun Win said the Nay Pyi Taw Council has used K174,885.511 million from the Union budget, Pyidaungsu Hluttaw development budget, Nay Pyi Taw Council budget and donors to implement tasks and projects for the development of the education, healthcare, transportation infrastructure, irrigation, electrification and other developmental sectors of Nay Pyi Taw during the three-year period of the incumbent government.

U Tun Tun Win said the Union Government gave permits to 23 farmers to use 58.55 acres of land for farming and other uses in the incumbent government's first year of administration, to 5 farmers for 10.86 acres in the second year, and to 31 farmers for 72.55 acres in the third year.

He said there were 83 criminal cases under the ten major offences in Nay Pyi Taw and the most widespread was homicide and sexual assault. He said there were 2,092 criminal cases for the other ten offences, an increase of 116 cases from last year. However, there were 1,924 criminal cases under ten preventive offences, a decrease of 2,742 cases from last year. U Tun Tun Win said Nay Pyi Taw Council has regularly fulfilled their annual objectives for each sector and has seen development rise by 2.4 per cent. He said the average production and service value each individual was K1,540,706 during in 2017-2018 FY according to a temporary census. He said they are aiming to increase that value to K1,626,639 in the 2018-2019 FY.

The Acting Secretary said the One Stop Shops in all eight townships of the Nay Pyi Taw Council Area provided 32,721 services in the first year of the incumbent government's administration, 31,160 services in the second year, and 31,758 in the third year. He added that there were 172 natural disasters and K144.04 million was spent on rescue and rehabilitation efforts.

U Tun Tun Win said they have confiscated a total of 701.2128 tons of illegal timber. He said they have planted 516.8 acres of teak and 1,500.50 acres of hardwood plantations. He said they have formed 144 regional reforestation groups and planted 4,854.92 acres of trees.

Loom weaving at risk of dying out in Amarapura

MACHINERY loom weaving in Amarapura Township, Mandalay Region is in danger of being lost as production costs are rising year by year, said local weavers.

Loom weaving was traditionally practiced in the township in the past, but now the industry is on the brink of collapse as the price of raw materials is increasing and traders are controlling the price, said U Aung Min Than, a loom weaver.

Scania buses to run on Yangon circular route from Aungmingala Highway Terminal

A FLEET of 39 Scania buses will operate on the Yangon circular route from the Aungmingala Highway Bus Terminal this month, with a round trip costing K1,000, according to the Yangon Region Transport Authority.

The circular service will run from the Aungmingala Highway Bus Terminal to Kaba Aye-Botahtaung-Strand Road-Thamine Junction-8 mile-Nawaday-North Okkalapa and end at the Aungmingala Bus Terminal, according to the YRTA.

The new service was announced by U Hla Aung, joint

secretary, YRTA at a press conference at the YRTA headquarters, located at No.65, Manhaung Ward, Laydaukkan Road, Tamway Township.

"The City Transit Company has obtained the transport authority's approval for running the Scania buses on the Yangon circular service. The route has been divided into parts. A single trip will cost the passenger K500 each destination on the route and the fare for a round trip has been fixed at K1,000," said U Hla Aung.

"The project took long as the company had to construct a terminal. They will start services this month," he said.

The YRTA is supervising the Yangon Bus Service in the region. As commuters in the commercial hub of Yangon depend on bus services, the YRTA is endeavouring to offer better services to the public than the All Private Bus Lines Control

The YBS was launched on 16 January, 2017, during the incumbent government's term. At present, over 100 of bus lines are operating 4,300 buses on about 123 routes along with the Airport Shuttle. The number of daily commuters has been estimated at 1.8 million.

The YRTA was formed to improve the transport facilities in Yangon for the convenience of the public. Yangon Region Chief Minister U Phyo Min Thein was appointed as the patron of the transport authority, while Daw Nilar Kyaw, the Yangon Region Minister for Electricity, Industry, and Transportation, was made the Chairperson.

In April, 2019, the number of members was increased to 22 from 16, with the YRTA appointing the Security and Border Affairs Minister as Vice Chair 1 and Yangon Mayor as Vice Chair 2, besides officials from related departments and organizations.

AMR control measures gain momentum in 12 towns bordering Mekong region

TWELVE border townships of AMR control activities, with Mekong region health project, are carrying out surveillance for antimicrobial resistance (AMR) control in full swing, said an official from the National Health Laboratory under the Ministry of Health and

"Myanmar's 12 townships border with four countries -Cambodia, Laos, Viet Nam, and Thailand—in the Mekong region. We are undertaking

Myanmar, which are part of a a loan from the Asian Development Bank, in order to curb the spread of antimicrobial resistance among migrant workers and the ethnic minorities," said Professor Htay Htay Tin, Deputy Director-General, National Health Laboratory.

The 12 Myanmar townships are Loikaw in Kayah State; Tachilek, Kengtung, and Lashio in Shan State; Hpa-an and Myawady in Kayin State; Mawlamyine in Mon State;

and, Kawthoung in Taninthayi Region.

The AMR project is being funded by a US\$12 million loan from the ADB. It was initiated in December, 2017, with the approval of the Pyithu Hluttaw and the Amyotha Hluttaw. The implementation of AMR control activities began in early

The Health Department is working to ensure there is no gap in provision of health services to migrant workers and ethnic minorities. Furthermore, they are endeavouring to reduce the outbreak of communicable diseases, conducting surveillance activities to monitor communicable diseases, raising awareness on prevention methods, upgrading the laboratory to combat those diseases, providing medical care to suspected patients at the nearest hospitals, and providing laboratory equipment. —Myint Maung ■

Thailand extends visas, work permits of Myanmar workers by 9 months

THE visas and work permits of Myanmar migrant workers which were scheduled to expire on 31 March, 2020 have been extended by nine more months to 31 December, 2020, according to an announcement from the Labour Office in Bangkok, Thailand.

The two countries had discussed issues concerning Myanmar migrant workers prior to the Thailand and Myanmar Migrant Labour Affairs Experts meeting in Phuket, Thailand, on 13 May. During the negotiations, the Thai authorities agreed to relax some rules.

"We had a good response from the Thailand authorities before the Thailand and Myanmar Migrant Labour Affairs Experts meeting was held. As a result of the negotiations, the Thai authorities have extended the visas and work permits of Myanmar migrant workers, which

were to expire on 31 March, 2020. Because of the nine-month extension, the visas and the work permits will now be valid until 31 December, 2020. Moreover, Certificates of Identity, which will expire on 1 November, green book holders, ME Bangkok, issued by the Data Collection Center are all covered under the new arrangement. There are around 600,000 migrant workers in Thailand. So, both countries still need to discuss many things," said U Moe Gyo, the Chairman of the Joint Action Committee for Burma Affairs (JACBA).

The Thai authorities will announce the details of the new agreement before the visas and work permits expire. About 600,000 migrant workers in Thailand will be covered by the new agreement. Both countries will conduct further discussions at the working group level to find out which process will be smoother.

The Bangkok Labour Office said individual Myanmar migrant workers or social organizations can submit their suggestions on matters pertaining to labour issues by mail or phone.—Pwint Thitsa

Seintalone mangoes command high prices in Seikpyu Township

GROWERS of Seintalone (Diamond solitaire) mangoes in Seikpyu Township, Magway Region said they are getting a better price for the fruit this year.

Earlier, growers in Magway Region were using traditional methods to cultivate mangoes, but now, they have begun to apply more scientific techniques of production.

"At present, the mangoes are fetching between K300 and K600, which is higher than the previous year's price of K250-K500. The mango growers purchased the farms outright last year. They cultivated

Hteekhee gate sees significant rise in trade in Oct-May

BILATERAL trade between Thailand and Myanmar through the Nabule-Hteekhee border gate has picked up dramatically from just over US\$1 million in October-May in the 2017-2018FY to an estimated \$1.36 billion in the current fiscal, according to the Commerce Ministry.

Normally, the Myawady gate sees the largest trade among the Myanmar-Thailand checkpoints. Between 1 October, 2018 and 5 May, 2019, trade surged at the Hteekhee gate, with exports reaching \$1.34 billion and imports valued at \$21 million.

The rise in exports at the Hteekhee border gate has helped boost the value of Myanmar-Thailand border trade to \$2.28 billion, more than double the value registered in the previous financial year.

Of the seven border trade points between Myanmar and Thailand, Tachilek, Myawady, and Myeik gates have witnessed a small decrease in trade in the current financial year, while the remaining gates have registered an increase in trade.

Myanmar primarily exports fishery products, coal, tin concentrate (SN 71.58 %), coconut (fresh and dry), beans, and bamboo shoots to Thailand. It imports capital goods such as machinery, raw industrial goods such as cement and fertilizers, consumer goods such as cosmetics, and food products. —Ko Htet

200 pairs of eels to be imported from Viet Nam for experimental farming

ABOUT 200 pairs of eels will be imported from Viet Nam for conducting experimental eel farming in Yangon Region, said Daw Toe Nanda Tin, Vice Chairperson, Myanmar Fisheries Federation at the 8/2019 Regular Meeting with fishery entrepreneurs, which was held at the MFF on 10 May.

"We will sign a contract to import 200 pairs of eels from Viet Nam this week and conduct experimental eel farming. Currently, we plan to install transformers in Twantay. A five-acre plot of land has been readied for eel farming. We have been granted permission to use the land. We plan to produce live feed for the eels," she added.

"The eels will be imported in May or June. We will conduct experimental eel farming in Yangon Region with the cooperation of Yangon University's Zoology Department and the Fisheries Department," she said.

In 2017, officials from the MFF went on a study tour to Viet Nam, which has successfully carried out eel cultivation. From October, 2017 to May, 2018, experimental eel farming was carried out with 100 pairs of eels at the MFF head office.

"We won't stop experimenting with farming of local eel species. We will give injections to local eel species in May. We will keep the local eels separate from imported eels. Then, we will conduct research as to which species can be produced more," said Daw Toe Nanda Tin.

The first experimental eel cultivation was not successful because the eels' reproductive organs were damaged, she said.

A single eel can yield 200 to 1,000 eggs. If the experimental eel cultivation process improves further, many more fish farmers will be engaged in eel farming, she added.

Myanmar's eels are mainly sent to China and Thailand.

It's all about oil fields

REQUENTLY, we me across articles the oil industry in dailies and weeklies. This article, however,is merely written as an educational piece for those who are interested in the oil industry.

Oil and gas are two types of natural resources that lie thousands of feet under the ground. When studying reservoirs where oil and gas deposits are trapped, reservoir pressure and reservoir temperature are two important components to be aware of. This is because oil that is trapped in the reservoir is, when in the original reservoir condition, under high pressure and experiencing high temperatures. Underground forces resulting from these types of pressure work to move the trapped water, oil and gas from the reservoir to the wells. and reservoir pressure is what enables the trapped oil to flow from the reservoir to the wells or to our oil collection tanks.

The pressures decline when oil and gas are produced or as long as they are being produced and this is a naturally occurring process, and as more oil is produced, the pressure decline increases and oil production decreases, depending on the nature of wells, reservoirs, and oil fields. This occurrence is actually called a natural decline. Every oil field in the world faces a natural decline as oil is produced and thus, the decline in the daily production of ma-



ture oil fields in Myanmar such as Yenanchaung, Chauk, Mann and Htaukshabin are expected.

Myanmar's oil fields have their own fascinating facts. Yenanchaung field is well-known as being one of the oldest oil fields in the world and has been producing oil since the year 1970. In addition, Yenanchaung and Chauk fields also put Myanmar on the list of pre-war oil-producing countries. Mann and Htaukshabin fields also played a major role in producing a record breaking daily

production rate of more than 30,000 barrels of oil at one point and shortly after discovery of the field in 1970. Among these fields, Mann Field specifically, has made an all-out effort to fulfill the country's oil demands.

Mann Field, which has produced oil for the country since 1970, is now entering its golden anniversary in 2020. As a long-serving oil field in the country, the field now produces just more than 1,100 barrels a day. However, there has been

there are now no more wells to be drilled and enhanced oil recovery efforts are difficult to carry out. In this regard, in my opinion, if the field was alive and could speak, it would cry and say"humans asked it to produce more than it could over the years and are now blaming it for being old and unproductive". When the country was listed as a Least-Developing Country (LDC) and was facing difficulties to import oil to fulfill do-

mestic fuel demand, Mann Field

oil production, which sustained the country for more than ten vears while fulfilling domestic demand and removing import

Mann Field used to be a major oil producing field that fulfill domestic fuel demands over a certain period of time. I travelled to Mann Field multiple times in order to carry out production boost-up operations when the country's remaining fuel stocks were dwindling. Therefore, I would say the current situation of Mann Field is

evident in itself of the production burden it had to endure inappropriately based on its area, size and field life

A foreign expert once commented that the oil field development operations in Mann Field were not in line with normal oil industry norm. However, in the view of national experts, these operations were actually commanded to reach a production target according to the needs of the country at the time. At the end of the day, it was successful and we are proud of it

Now Mann Field has made it—it has received, as the first ever producing field in the upstream sector of Myanmar, an Environmental Compliance Certificate (ECC) which supports its Redevelopment and Enhanced Oil Recovery Program from the Environmental Conservation Department of the Ministry of Natural Resources and Environmental Conservation in March 2019 in line with the Environmental Conservation Law, By-laws, Environmental Impact Assessment (EIA) Procedures and Regulations. In light of this, it will continue implementation of the environmental management plans approved in the ECC. Thus, I would like to admiringly pay homage to it as follows:

"You, Mann field..,

Although old and in decline of production,

Now endowed with an ECC as an exemplary field,

Makes me proud of you. Congratulations!"



Governments agree landmark decisions to protect people and planet from hazardous chemicals and waste, including plastic waste

ECISIONS on plastic waste have been reached on 11 May in Geneva, as approximately 180 governments adopted a raft of decisions aimed at protecting human health and the environment from the harmful effects of hazardous chemicals and waste.

Pollution from plastic waste, acknowledged as a major environmental problem of global concern, has an estimated 100 million tonnes of plastic now found in the oceans, 80-90% of which comes from land-based

Governments amended the Basel Convention to include plastic waste in a legally-binding framework which will make global trade in plastic waste more transparent and better regulated, whilst also ensuring that its management is safer for human health

time, a new Partnership on Plastic Waste was established to mobilise business, government, academic and civil society resources, interests and expertise to assist in implementing the new measures, to provide a set of practical supports - including tools, best practices, technical and financial assistance - for this ground-breaking agreement.

He said the Ministry of Planning and Finance has lessened restrictions placed on MSMEs by allowing them to now take out K20 million-CGI loans with an MSME Member Card instead of requiring approval from the Directorate of Industrial Supervision & Inspection, as was the case before. Furthermore, MSMEs applying for a K100 million loan only need to show a document of approval from the aforementioned directorate and no longer need to show documents of approval from the MSME Agency.

The Ministry of Investment and Foreign Economic Relations has followed the Union Government's designated Investment Policy (7-8) and supported the legislation of The Myanmar Investment Law and The Myanmar Companies Law, and authorizing the Myanmar Investment Development Project, said the U Khin Maung Cho. He added that these are contributing to development of the industrial sector.

The Union Minister said the three ministries mentioned are working together to carry out the objectives outlined in the motion tabled by the MP for Ottwin and will collaborate with other ministries and international organizations for further support. He said the motion is suitable for approval. Next, the Pyithu Hluttaw Speaker asked for the motioner's opinion who replied for their motion to be approved. The Speaker then gathered the deliberation of the assembly and announced that the motion has been approved.

The seventh-day meeting of the Second Pyithu Hluttaw's 12th regular session will be held tomorrow.—MNA ■

Other far-reaching decisions from the two weeks included the elimination of two toxic chemical groups, which together total about 4,000 chemicals, listed into Annex A of the Stockholm Convention, namely Dicofol and Perfluorooctanoic Acid, and its salts and related compounds. The latter has till now been used in a wide variety of industrial and domestic applications including non-stick cookware and food processing equipment, as well as a surfactant in textiles, carpets, paper, paints and fire-fighting oams.

Important progress was also made under the Rotterdam Convention, which provides a legally-binding framework for information exchange and informed decision-making in the trade of certain hazardous pesticides and industrial chemicals. Two chemicals, the pesticide phorate and the industrial chemical hexabromocyclododecane were added to Annex III of the convention, making them subject to the Prior Informed Consent Procedure, through which countries can decide on future imports of these chemicals. A further decision, to approve procedures and mechanisms on compliance with the Rotterdam Convention – seen as a crucial step for further improving implementation of this key convention - was adopted with great appreciation by Parties.

Working for two weeks in Geneva under the theme of "Clean Planet, Healthy People: Sound Management of Chemicals and Waste", approximately 1,400 delegates from around 180 countries converged for the meetings of the Conferences of Parties to the Basel, Rotterdam and Stockholm conventions. Participants benefited from the nu-

merous opportunities and events to exchange information on alternatives to these chemicals, as well as best practices.

Speaking at the closing session of the COPs, Rolph Payet, UN Environment's Executive Secretary of the three conventions for, said that "I'm proud that this week in Geneva, Parties to the Basel Convention have reached agreement on a legally-binding, globally-reaching mechanism for managing plastic waste. Plastic waste is acknowledged as one of the world's most pressing environmental issues, and the fact that this week close

to 1 million people around the world signed a petition urging Basel Convention Parties to take action here in Geneva at the COPs is a sign that public awareness and desire for action is high."

"We were able to list two out of 7 candidate chemicals and will continue working closely with parties to identify feasible alternative solutions to hazardous pesticides, taking due account of food security and market access aspects" added Hans Dreyer, UN Food and Agriculture Organization's Executive Secretary of the Rotterdam Convention. ■

Tabling a motion

U Maung Maung Ohn of Ayeyawady Region Constituency 5 tabled a motion on urging the Union Government to draw up laws, rules and directives to take the precautionary measures, in an attempt to protect the natural resources and interests of the coastal states and regions from possible heavy oil pollution from giant crude oil tankers transporting the crude oil to China through the pipe lines from the Madee island deep-port of Rakhine State to China.

U Aye Min Han of Mon State constituency 1 seconded the motion, saying that oil spill could havoc on contamination of the soil, natural habitats, surrounding wildlife, ecosystem and other environmental damage.

He urged the government to enact the law and rules proposed MP U Maung Maung Ohn to provide safety to livelihood of the local fisherment relying on the sea and to conserve the coatal areas.

Daw Nwe Aung of Mon State constituency 2 seconded the motion saying hat Myanmar has not prescribed the laws on marine pollution although Myanmar has become a member of IMO since 1951. With a view to ensuring to get compensation and natural environment, necessary measures should be taken to draw up laws and rules for protecing marine ecosystems. Then the motion

Japan health insurance to cover new leukemia therapy worth 33 mil. yen

TOKYO — A government panel on Wednesday approved coverage of a new therapy to treat leukemia and other hematologic cancers, which currently costs 33.49 million yen (\$305,000), by national health insurance, a move that would significantly ease the burden on patients.

The drug Kymriah, to be produced and sold by Novartis Pharma K.K., a Tokyo-based unit of Swiss pharmaceutical giant Novartis AG, will carry the highest price tag of any single drug in Japan. Coverage is set to take effect 22 May.

But the decision by the health ministry panel may raise concerns about the impact on the country's ballooning medical care costs amid the rapidly ageing population.

The one-time therapy,



which works by genetically modifying a patient's immune cells to launch an allout attack on the disease, is considered effective on patients for whom existing treatments do not work.

Under Japan's public health insurance system, a policyholder usually shoulders around 10 per cent to 30 percent of the cost incurred at medical institutions, with the remaining amount covered by the policy in exchange for paying monthly premiums.

There is also a cap on monthly medical payments depending on a policyholder's income. For example, a patient with annual income between 3.7 million yen and 7.7 million ven, would have to shoulder costs of roughly 410,000 yen a month to be treated with Kymriah.

The Ministry of Health, Labor and Welfare estimates the number of patients that will be eligible to use the drug will total 216 a year at most and will generate annual revenue of 7.2 billion yen.

Clinical tests of Kymriah, including those in which Japanese patients took part, have shown that around 80 percent of those suffering from leukemia and some 50 per cent of those with lymphoma saw significant improvements in symptoms.

Those eligible to use the drug include children and those 25 or younger with B-cell precursor acute lymphoblastic leukemia and patients with diffuse large B-cell lymphoma, who are not able to be cured using other anticancer drugs.—Kyodo News

Scientists unearth 'most bird-like' dinosaur ever found

PARIS — Researchers in Germany have unearthed a new species of flying dinosaur that flapped its wings like a raven and could hold vital clues as to how modern-day birds evolved from their reptilian ancestors.

For more than a century and a half since its discovery in 1861, Ar $chae opteryx-a\ small$ feathered dinosaur around the size of a crow that lived in marshland around 150 million years ago - was widely considered to be the oldest flying bird.

Palaeontologists from Ludwig-Maximilians University (LMU) in Munich and the University of Fribourg examined rock formations in the German region of Bavaria, home to nearly all known Archaeopteryx specimens.

They came across a petrified wing, which the team initially assumed to be the same species. They soon found several differences, however.

"There are similarities, but after detailed comparisons with Archaeopteryx and other, geologically younger birds, its fossil remains suggested that we were dealing with a somewhat more derived bird," said lead study author Oliver Rauhut from LMU's Department of Earth and Environmental Sciences.

They called the new bird-likedinosaurAlcmonavispoeschli - from the old Celtic word for a nearby river and the scientist who discovered the fossil, excavation leader Roland Poeschl.—AFP■

Reforms in the Banking Sector

Significant developments in the banking sector

OMENTOUS transformation has been taking place in the Myanmar Banking Sector with series of significant reforms. The latest ones are five directives, issued in March 2019, covering eligibility, responsibilities and accountability of board of directorsand external auditors, fit and proper criteria for bank directors and top management, and restrictions on acquisition of substantial interest and related party transactions. In July 2017 also, the monetary authority issued four prudential regulations covering capital adequacy requirements, management of problem assets and maintenance of adequate provisions and reserves, concentration of risks and large exposure limits, and appropriate liquidity requirements in banks.

These regulations and directives are not invented locally but adapted from the Basel standardssetby the Basel Committee on Bank Supervision (BCBS) to suit the needs and requirements of local banks.

BCBS is an international body of central bankers and supervisors formed to strengthen the regulation, supervision and practices of banks worldwide with the purpose of financial stability.

The other essential directives issued for the smooth transformation are Directive No.7/2017, 1/2019 and 2/2019.Issuing these directives, the monetary authority has allowed local banks (a) to make medium-term loans of up to three years based on the business cycle and cash flow patterns,(b) to extend loans without collateral at a maximum lending rate of 16 per cent, and (c) to make long term housing loans of up to 5 per cent of total loan portfolio.

The above regulations and directives can be viewed as significant restructuring measures towards modernization of banking sectorto be able to effectively promote optimum allocation of financial resources for a long-term economic development. Local banks are trying to comply with these regulations and directives in the face of large outstanding amount of overdraft loans with potential loan defaults and lack of proper risk management, largely associated

with the collateral-based lending system that prevailed in the banking sector for a long time.

Collateral-based vs. risk-based lending

Under the collateral-based lending system, banks usually accept land and landed property as collateral. After assessing the market value of the collateral. the bank estimates the forcedsale value of the collateral. To keep themselves on the safe side, banks usually grant credit of up to 50 per cent of the forced-sale value of the collateral without making any comprehensive appraisals on the loan proposals. Under the system, banks are risk-averse and credit risk assessment does not play an essential role there. Routine rolling over of loans mostly in the forms of overdrafthad becomea normal banking practice for a long time leaving the legacy issue of large volume of outstanding overdraft loanswith potential loan defaults in banks.

Directive 7/2017 dated 24 November 2017 is a significant departure from the old and outdated banking practice of collateral-based to cashflow-based system of lending. Issuing the directive, the monetary authority allows local banks to make threeyear term loans based on the cashflow pattern of the borrower. It is a risk-based lending. It promotesrisk-appetite in banks. In promoting the culture of risk-appetite, liberalization of product innovation and price setting is crucial. It is encouraging to learn that in the DirectiveNo. 7/2017, the Central Bank of Myanmar encourages local banks to develop new lending products with repayment terms that consider the business cycle and cash flow pattern of the borrower.

Pricing of products

Pricing is still mandated in the

banking sector.Based on the central bank rate of 10 per cent, the monetary authority sets a nominal interest rate of 8 per cent on deposit and 13 per cent on commercial loansleaving a profit margin of 5 per cent for the lender. However, the current situation does not allow banks to enjoy a full net interest margin of 5 per cent. Low net interest margin (NIM), resulting from the low loan to deposit ratios together with insufficient non-interest income and low actually received interest payments mainly due to the large amount of overdraft loans, is putting pressure on bank profitability.

In fact, Myanmar is among a few countries in the world left with regulated interest rates. The mandatory interest rates usually do not reflect the actual market condition and tend to create distortions in investment. The fixed interest rate environment does not allow banks

to price their risks and hence reduces their ability to choose viable businesses for effective financing. Offering the same price to every customer would weaken the bank's quality of risk assessment and henceheighten the risk ofdefault on loans.

Interest rate liberalization for risk-based pricing


In contrast, under the risk-based or cash-flow based system of lending, banks can take a more holistic approach when judging the weaknesses, strengths, viability, credit amount and particularly the repayment capacity of each business. Under the risk-based system of lending, banks have

"Gundam" robots to greet athletes with messages from space

TOKYO—Organizers of the 2020 Tokyo Olympic and Paralympic Games announced plans Wednesday to launch model robots from the anime "Mobile Suit Gundam" into space aboard a satellite that will broadcast messages of support to athletes. In the project conducted in collaboration with the Japan Aerospace Exploration Agency and the University of Tokyo, two 10-centimeter models depicting Gundam and Char's Zaku robots from the animation series will be sent into orbit on a 30-cm long, 10cm wide micro satellite.

The "G Satellite," with an electronic bulletin board for displaying messages, will be sent to the International Space Station aboard a supply ship next March and later launched from the ISS. After the satellite enters Earth orbit, it will deploy the bulletin board and model robots, capturing images of them with its onboard camera.—Kyodo News

MFF seeking coach for national youth football teams

THE Myanmar Football Federation is currently seeking a qualified Youth Coach for its U-15 and U-17 National Youth Teams, the federation announced yesterday.

The football federation is looking for a head coach who can mentor the local assistant-coaches of the U-15 and U-17 national teams. In its announcement, the MFF has listed the duties of the coach, as well as the qualifications it requires from candidates.

The coach must possess AFC A License, UEFA License, and preferably, have a UEFA Elite Youth License. The coach must have international experience as an Elite Youth Coach, with a minimum 3-year knowledge of and experience in Asian Elite Youth Player Football. Knowledge of English language (verbal and written) is compulsory. Digital skills are required. The candidates must also have presentation skills, and technical and tactical analysis skills at the Elite Youth Player level.

The coach must understand and apply a methodological and

pedagogical approach, according to the highest football elite player development standards, the MFF stated. He will have to work closely with the head coach and coaching staff of the U-14 National Youth Team. He must possess a good knowledge of elite youth player development, especially in the U15-17 age bracket.

He must have experience working with potentially talented elite youth players at the highest level (National Youth Teams and Top Youth Academies).

The salary will be negotiable, in line with the qualifications of the candidate, said a source with the football federation.

Interested candidate can submit their resumes, detailing their knowledge and experience, to the Myanmar Football Federation by e-mail by 25 May. Tiger, Koepka hunt more major glory in PGA at Bethpage

BETHPAGE (United States) — Masters winner Tiger Woods, chasing a 16th major title, and defending champion Brooks Koepka lead a powerhouse field into Thursday's opening round of the PGA Championship at raindrenched Bethpage Black.

Woods, who ended an 11-year major title drought last month at Augusta National, and Koepka, who held off Woods to win last year's PGA crown, join reigning British Open champion Francesco Molinari of Italy in the feature group of the first two days.

"I'm just looking forward to playing with him," Koepka said of Woods. "I don't think we've really been paired together too much, especially over the last couple years. It'll definitely be interesting."

It's the same layout where Woods won the 2002 US Open and shared sixth behind winner Lucas Glover at a rain-hit 2009 US Open, both times with the vocal support of New York crowds

who made the Long Island trek.

"This week is going to be a lot of fun with the crowds, the excitement that we've had here," Woods said. "The pairing I'm involved in, it's going to be just a boatload of fun for all of us."

Woods would match Sam Snead's career US PGA Tour win record of 82 with a triumph and move within two of the all-time major win mark of 18 by Jack Nicklaus with a victory. The 43-year-old American would become the 10th oldest major winner, two days older than Ted Ray when he won the 1920 US Open, and match record co-holders Nicklaus and Walter Hagen with a fifth Wanamaker Trophy.

He would also be halfway to a calendar year Grand Slam, the PGA shifting to May for the first time since 1949 in a revamped world golf calendar.—AFP
