# State Counsellor, Japanese FM hold joint press conference

STATE COUNSELLOR Daw Aung San Suu Kyi and Japanese Foreign Minister Mr Taro Kono met at the Ministry of Foreign Affairs in Nay Pyi Taw on Wednesday morning.

During the joint press conference after the meeting, Mr Taro Kono said that he was pleased to visit Myanmar for the third time as foreign minister, and reaffirmed that Japan would continue providing assistance to support the State Counsellor and the Myanmar government in the economic, social and other sectors

He also added that as a historic and partner country, Japan would provide assistance to Myanmar as she was encountering tough challenges, and said that peace and stability were essential for building a democratic state.

Mr Taro Kono also said that Japan would also support peace-making efforts in Myanmar with very firm determination. He added that in today's meeting very productive discussion and exchange of views had been held with respect to the situation in Rakhine State.

He said he valued the efforts made by the Myanmar government to bring back the displaced persons from Bangladesh. He hoped that the Myanmar government would accelerate its implementation efforts including the work of the ICOE – Independent Commission of Enquiry.

Daw Aung San Suu Kyi also said that it was the goal of the Myanmar government to work for the safety, stability, progress and development of all citizens; to this end the Myanmar government has been striving for improvement in all fields such as social, economic and political. She expressed her deep appreciation for the assistance being provided by friends in Japan to help her in

her efforts.

The State Counsellor said that she was eagerly waiting to watch the Myanmar-Japan football match that was about to take place in the near future as it could help strengthen the friendly relations between the two countries. No matter what the outcome of the football match might be, she believed that it would further strengthen the friendly and close relations between the two countries.

### Pyithu Hluttaw's sixth day meeting discusses proposals, bill

THE Second Pyithu Hluttaw organized the sixth day meeting of thirteenth regular session on Wednesday.

Before the queries of MPs, the Speaker announced the Pyithu Hluttaw accepted the request of MP Daw Cho Cho from Ottwin constituency to quit Banking and Financial Development Committee. The Speaker also updated the numbers, the names, the leading person and tasks in the formation of the Advisory Group on Parliamentary Capacity-building.

#### **Movie Theatres**

U Oo Hla Saw, MP from MraukU constituency, asked about the possible construction of movie theatres in Sittway Township, Rakhine State.

U Aung Hla Tun, Deputy Minister for Information, said that a total of four movie theatres were nationalized on 1 July 1969 by the order of Information Ministry under the Revolutionary Council;

these were later privatized with agreements and without agreements to operate these facilities for other commercial purposes instead of movie industry; among these five facilities, 'Myoma' theatre was under the management of Ministry of Information, and the new owner U Tun Maung used it as a movie theatre till 2013. And that the ministry notified him to rerun the movie theatre. Moreover, the ministry issued notifications on 18 February 2015 to all the owners of movie theatres across the country to adhere to agreements included in the purchasing contract to use the facilities for movie shows. The lower floor of 'Myoma' theatre is being used for a restaurant, and the upper floor is being prepared for movie shows, but the date has not been specified until now.

The deputy minister also said some movie theatres in Ra-

khine State were privatized with the agreements to continue this business. As the new owners failed to meet the agreements, they have been remined to stick to the promises.

According to the order on 10 April 2018, a total of 121 movie theaters under the management of ministry and are liable for showing movies were transferred to Nay Pyi Taw Council, the governments of states and regions, while the documents of five movie theatres in Rakhine State were also handed over to its government for close and effective management.

The deputy minister concluded that the government has no plan yet to construct more movie theatres in Rakhine State, but the any proposal to do this business will be decided by the State government.

U Myint Lwin, MP of Twantay constituency, asked to show educative short films and slogans before starting a movie at the theatres across the country.

The deputy minster replied that as the Motion Picture En-

terprise has no digital version for the educative short films and slogans yet, these cannot be screened at the movie theatres until now. Instead, captions and logs are being used for some educative programmes, for example, No Smoking and No Alcohol campaigns.

He also said the educative short films and campaigns could be shown before saluting the National Flag, and posters can be displayed for easy visibility in line with the policies and instructions of relevant departments.

### Plan for storage of reserved electricity

U Nay Myo Htet, MP of Kyauktada constituency, asked to adopt plan for generating more electricity for reservation.

Dr Tun Naing, Deputy Minister for Electricity and Energy, explained that the generation of electricity must be increased by 10 to 20 per cent for reserved power that can be classified as spinning reserve and cold reserve.

THE sixth-day meeting of the 13<sup>th</sup> regular session of the Second Amyotha Hluttaw was held at the Hluttaw building yesterday.

MPs raise question on education matters

First, Daw Nwe Nwe Aung, MP for Mon State constituency 2, raised a question on whether there were plans to upgrade B.E.M.S. branch school in Phar Auk village, Mawlamyine Township, from its branch status during the 2019-2020 academic year.

Union Education Minister Dr Myo Thein Gyi replied that the school did not meet the criteria for an upgrade as it had only 199 students when the required number is 240 and is only 1 mile away from the nearest middle school when an upgrade requires it to be over 2 miles away.

Next, U Aung Myo, MP for Sagaing Region constituency 2, raised a question on whether emergency repairs for the basic primary school in May Gon village, Padauk Gaung village-tract, Shwebo Township, will be approved soon.

Dr Myo Thein Gyi replied that K23.868 million for the

school's repairs were already allocated on 18 June, 2019.

After that, U Myo Win, MP for Mon State constituency 8, raised a question on whether the Ministry of Education has plans to enact a nationwide policy for calculating the construction costs for school dormitories.

The Union Education Minister replied that they already distribute detailed drawings for basic education schools, offices, staff residences, libraries, laboratories, fencing and restrooms free of charge. He said they carry out these tasks under an all-encompassing standard guideline.

Following that, U Khin Maung Latt, MP for Rakhine State constituency 3, raised a question on how many AGTI/ GTC schools operating on foreign funding were open in Myanmar and whether there were plans to open one in Rakhine State.

Dr Myo Thein Gyi replied that they have opened course on motorcycle maintenance, one-horsepower engine maintenance, electrical wiring, sewing and basic computer skills in collaboration between Sittway's Government Technical High School and GIZ.

He said they have cooperated with ILO to conduct shortterm mobile training courses in Maungtaw and Buthidaung townships. He said the Union Government will consider proposals from international organizations to open a school in the region.

#### MPs debate Import Control Bill

The Hluttaw then debated the Import Control Bill. U Maung Maung Ohn, MP for Ayeyawady Region constituency 5, said there must be tax reduction and contract leniency to support domestic production, national social security and domestic export. He said raising tax on certain products and reducing tax on exports can effectively decrease reliance on imports.

U Kyaw Toke, MP for Mandalay Region constituency 7, suggested that a representative from the Union Attorney-General Office should be included in the Import Control Committee as it is important to have a legal expert to ensure coherence with international laws. He also suggested including a representative of domestic commodity producers and international merchants each.

The bill was further debated by Tatmadaw representative Major Ye Tint Aung, MP Dr Pyae Phyo of Ayeyawady Region constituency 7, and MP U Soe Thein of Taninthayi Region constituency 10.

The Speaker announced that the Amyotha Hluttaw Bill Committee will review the bill further.

MPs debate motion urging women empowerment in rural areas

The assembly next discussed a motion tabled by Dr Tin Tin Win, MP for Bago Region constituency 5, urging the Union Government to create a positive and supportive environment that raises the living standards and business feasibility of women in rural areas, and to reduce their likelihood to find work abroad through adverse conditions.

At this time when Myanmar was passing through a difficult period, she believed that the Japanese people who have passed through similar difficult times would have compassion and understanding for the Myanmar people. She concluded by saying that she sent warm greetings and good wishes to the Japanese people from this press conference.

In answering queries from the media, the State Counsellor clarified the fruitful results of the Thilawa Special Economic Zone in Yangon as well as other special economic zone being implemented in other states/regions; she also answered questions regarding the situation in the Rakhine state.

She said the Myanmar-Japan mega joint project was a very successful project. Since the majority of the companies in this project were Japanese companies, she said it was possible to forecast what kind of fruitful results could be obtained from such kind of bilateral cooperation. It had stimulated other states and regions to set up such special zones.

Meanwhile, the country was implementing only the Kyaukpyu and Dawei economic zones. She said work was initiated with these



two economic zones and that not much progress had been made.

She also said the transportation infrastructure would be developed in Dawei first with Japanese assistance, and she was hopeful that similar success could be achieved in other states and regions also. She wanted them to implement such projects.

The State Counsellor remarked that the most tangible result of the Thilawa SEZ was the increase in job opportunities. The Myanmar people wanted job opportunities. She believed that Myanmar people were capable of creating their own destinies and working for their own development once they have jobs.

She said she was very encouraged by the success and progress of the Thilawa SEZ. She said it was important for the Myanmar people to have jobs opportunities as well as jobs with dignity. She concluded her answers to the media, with saying thanks to the Japanese companies in Thilawa SEZ.

Finally, Japanese Foreign Minister Mr Taro Kono said that in his discussions with the State Counsellor, he had commented on the extremely dire conditions of refugee camps on Bangladeshi side, and that he had urged the Myanmar government to take more strenuous efforts to bring back the displaced persons from Bangladesh. He added that the Japanese government would encourage and urge as much as possible.

He said he has also urged and stressed to the Myanmar government that it was important to conduct the Independent Commission of Enquiry in a transparent and credible manner.

Furthermore, he and informed the State Counsellor that yesterday it had been learnt that the Bangladesh government had already given approval for the ICOE to conduct investigations on the Bangladesh side.

The Japanese Foreign Minister concluded his answers with the promise to continue solving these problems by joining hands with the Myanmar government.— MNA

In his opening remarks at the ceremony, Union Minister

for Agriculture, Livestock and Irrigation Dr Aung Thu said that the Mekong-Lancang Cooperation projects would be conducted with the aim of reducing the development gap, assisting the establishment of the ASEAN community, achieving the 2030 Sustainable Development Goals adopted by the UN, boosting the cooperation among the developing countries in addition to enhancing socio-economic development of the people in the rural area and prosperity of the farmers.

Then Ambassador of the People's Rof China Mr Chen Hai explained about work plans for Mekong-Lancang Cooperation projects between the governments' of Myanmar and China. Deputy Director-General of the Ministry of Foreign Affairs Daw Marlar Than Htike explained about the diplomatic relationship with PRC.

Then Director-General of the Agriculture Department Dr. Ye Tint Tun explained about the implementation of five projects under the Mekong-Lancang Cooperation Special Fund (the first phase.

Next, Director-General of the Department of Planning U Kyaw Swe Lin explained about twelve projects under second phase of the Mekong-Lancang Cooperation Special Fund.

Afterwards, Union Projects Minister Dr Aung Thu presented commemorative gifts to the Ambassador of the People's Republic of China at the event. Following the ceremony, the union minister and invited guests observed the displays for schemes arranged by the departments.

The Mekong-Lancang Cooperation is a type of cooperation mechanism among five Mekong-Lancang countries comprised of Cambodia, Laos, Myanmar, Thailand and Viet Nam together with China and which aimed at promoting cooperation in the areas of political, security, economic and social development. The Mekong-Lancang Cooperation Special Fund of 300 million US dollars was established by the China with a view to carrying out the development schemes, and the Ministry of Agriculture, Livestock and Irrigation is conducting the agriculture and poverty reduction schemes as a focal ministry.

As the Mekong-Lancang Cooperation fund (the second batch), a total of 23 proposals had been made to implement in the sectors of agriculture, livestock and rural development projects, and 12 proposed schemes had been selected to be carried out. The departments under the Ministry of Agriculture, Livestock and Irrigation will be implemented five priority areas, namely; connectivity, production capacity cooperation, cross-border economic cooperation, water resources, and agriculture and poverty reduction. —MNA

### Myanmar Investment Commission approves investment proposal which will create over 3,000 job opportunities

THE Myanmar Investment Commission (MIC) meeting (12/2019) was convened at the meeting room of the MIC on the morning of 30 July 2019 in Yangon. U Thaung Tun, Chairman of the MIC, Dr Than Myint, Vice Chairman and (8) members attended the meeting.

The meeting approved nine projects in the livestock and fisheries, manufacturing, hotel and realestate sectors. The amount of USD 101.172 million and Kyat 110,703.800 million have been approved for those projects, which will create 3,029 job opportunities for Myanmar citizens.

A total of 1,752 foreign enterprises in 12 sectors from 49 countries were permitted, with the total pledge amount of US\$ 80,892.061 million from 1988 to the end of June 2019. Among them, the three leading countries who invested were Singapore, People's Republic

#### of China, and Thailand.

The largest sector of investment has been Oil & Gas sector. It accounted for 27.72%, follow by the Power sector, which accounted for 26.18%. The third largest sector was manufacturing, which accounted for 13.82% of the total permitted amount of foreign investment. —MNA ■

expressed his dismay and objected to the comments recently made by Malaysian Prime Minister that displaced persons should be treated as nationals or be given a chance to form their own state and that genocide is happening in

d the country.

Permanent Secretary further stated that such allegations are not supportive to the ongoing efforts of Myanmar Government and ASEAN in finding a sustainable solution for peace, development and social harmony in Rakhine State. It was also against the ASEAN's cardinal principles of non-interference in the internal affairs and respect for the sovereignty and territorial integrity of ASEAN Member States. The Malaysian Ambassador was also informed that Myanmar categorically rejects allegation on genocide in Myanmar, which is not constructive and in breach of the principles enshrined in the ASEAN Charter.—MNA

## Permanent Secretary of Ministry of Foreign Affairs, High level Myanmar Delegation meet with representatives of displaced persons at Cox's Bazar, Bangladesh

A HIGH level Myanmar delegation led by U Myint Thu, Permanent Secretary of the Ministry of Foreign Affairs of the Republic of the Union of Myanmar and ASE-AN ERAT Team comprised of officials from the ASEAN Secretariat and the AHA Centre, paid an official visit to Bangladesh from 27 to 29 July 2019.

Myanmar delegation and ASEAN ERAT Team left Dhaka for Cox's Bazar by air on 27 July 2019 and met with some 50 displaced persons from various camps at the Office of Camp No 4, Cox's Bazar.

Those present at the meeting were U Lwin Oo, Myanmar Ambassador to the Republic of Bangladesh, Mr Md Delwar Hossain, Director-General, South Asia Division, Ministry of Foreign Affairs of Bangladesh, Mr Manjural Karim Khan Chowdhury, Ambassador of Bangladesh to the Republic of the Union of Myanmar, Mr Md Abul Kalam, Refugee Relief and Repatriation Commissioner and responsible officials.

Permanent Secretary briefed the displaced persons on the preparations for the repatriation, including the construction of buildings, repatriation process at the Reception Centres and Transit Centre, prevalence of law and order, access to education and health, citizenship in line with the 1982 Citizenship Law, benefits of NVC Card, creation of job opportunities, and social cohesion among various communities, among others. ASEAN ERAT Team members also explained on the outcomes of the **Preliminary Needs Assessment** (PNA) conducted in Northern Rakhine State and possible areas of cooperation between Myanmar and ASEAN to support the repatriation process.

Permanent Secretary also handed over Factsheets on repatriation process, prepared in Myanmar and English languages, to Mr Md Abul Kalam, Refugee

Relief and Repatriation Commissioner for distribution among the prospective returnees in the camps. Furthermore, he circulated among the displaced persons who were present at the meeting.

In the evening, Myanmar Repatriation Task Force held a meeting with Bangladesh counterparts in order to address the difficulties and challenges in the verification process of displaced persons, particularly the need to comply with the agreed verification form.

On 28 July 2019, Myanmar delegation and ASEAN ERAT Team revisited the Office of Camp No 4 and met again with the displaced persons from various camps in Cox's Bazar. They discussed issues focusing on the continued dialogue and engagement between the Myanmar delegation and ASEAN ERAT Team with the prospective returnees, citizenship, and the prevalence of peace and stability upon their return.

Permanent Secretary explicitly explained that 1982 Citizenship Law also contains the eligibility of naturalized citizenship, and the decision to return should be made by their own volition without fear or favour.

Myanmar delegation and ASEAN ERAT Team then visited the Front Office of Camp No. 4, where they met with the representatives of the United Nations Agencies, including UNHCR, WHO, WFP, IOM, UNDP and ICRC. They briefed the United Nations representatives on the outcome of the visit to Cox's Bazar, cooperation between Myanmar and ASEAN in the repatriation process, and Myanmar's continued cooperation with UNDP and UNHCR in line with the Memorandum of Understanding, including the implementation of Quick Impact Projects in Northern Rakhine State.

Permanent Secretary and ASEAN ERAT Team explained on the queries raised by the United Nations representatives, specifically on the citizenship in line with the Citizenship Law, the National Camp Closure Strategy, access to education and health and activities to promote social cohesion among various communities.

Subsequently, Myanmar Delegation and ASEAN ERAT Team received the representatives from Hindu and Christian communities, who were currently residing in Cox's Bazar. Permanent Secretary explained on the cooperation with Bangladesh authorities for the return of Hindu communities. District Commissioner of Maungtaw District, Rakhine State Government, U Soe Aung and Executive Member of the Interfaith Dialogue Group, U Ragu Ne Myint also explained on the preparations for the Hindu communities in Northern Rakhine State.

On 29 July 2019, Myanmar delegation and ASEAN ERAT Team met with Mr Kamrul Ahsan, Acting Foreign Secretary and Bangladesh delegation at the Meghna Guest House, Ministry of Foreign Affairs in Dhaka. Bangladesh delegation comprised of Mr Mahbub Uz Zaman, Secretary for Asia and Pacific, Mr Md Delwar Hossain, **Director-General of South Asia** region, and Mr Manjurul Karim Khan Chowdhury, Ambassador of Bangladesh to the Republic of the Union of Myanmar and officials from the Ministry of Foreign Affairs.

Permanent Secretary

briefed the meeting on the discussion with the representatives of the displaced persons at the Camp No 4, Cox's Bazar on 27 and 28 July 2019 as well as meetings with the representatives from the United Nations Agencies based in Cox's Bazar and representatives from Hindu and Christian communities. Furthermore, Permanent Secretary reminded the need to follow the bilateral arrangement on repatriation between the two countries, and highlighted on the preparations made by Myanmar Government and the readiness to receive the verified displaced persons.

Mr Arnel Capili, Deputy Executive Director, AHA Centre and Mr Ky-Anh Nguyen, Director, Socio-Cultural Community Department, ASEAN Secretariat also explained on the mandate given by the ASEAN Leaders and the terms of reference of the ASEAN ERAT Team to conduct the Preliminary Needs Assessment in Northern Rakhine State in March 2019, and the Comprehensive Needs Assessment to be conducted by ASEAN ERAT Team, and the ASEAN's continued support to the repatriation process.

At the end of the meeting, Acting Foreign Secretary of Bangladesh handed over the verification forms of 25,047 people to Myanmar delegation. Myanmar delegation requested the immediate delivery of colour photographs that is necessary for the systematic and effective verification.

To fulfill the bilateral agreement signed on 23 November 2017, the Myanmar side had put in place the necessary logistic and other facilities to be able to receive the verified returnees since 23 January 2018.

High-level Myanmar delegation led by Permanent Secretary, Ministry of Foreign Affairs arrived back to Myanmar on 30 July 2019.—MNA ■

Myanmar can produce about 3,600 MW annually. The country's power demand is increasing at a rate of 13 per cent every year. The ministry has targeted to generate annual production of 5,646 MW in 2021-20122 fiscal year, and expected to store reserved power up to 14 per cent between 2019-2020 and 2025-2026.

Construction of sports facilities

U Tin Aye, MP from Matman constituency, asked about constructions of facilities for sports activities in Matman Township, Shan State.

Dr Myint Htwe, Union Min-

ister for Health and Sports, replied to the quries.

Construction of national grids

U Thaung Aye, MP of Pyawbwe Township, asked about construction of one 33/11 KVA 3 MVA power distribution station and 12-mile long 11KV power line to supply electricity for people in 30 villages in northern part of Pyawbwe Township.

Daw Cho Cho, MP of Ottwin constituency, asked about electricity supply from national grids through affordable rate to the villages with self-reliant basis.

U Thet Naing Oo, MP from Yebyu constituency, asked about the development of LNG power supply project (Kanpauk) for power distribution in southern Myanmar.

The queries were replied by Dr Tun Naing, the Deputy Minister for Electricity and Energy.

The Pyithu Hluttaw then submitted proposals and passed the Bill for the Fourth Amendment to Union Judiciary Law unanimously.

Measures against tobacco consumption

U Khin Cho, Mp from Hlaingbwe constituency, urged the government to make effective measures against tobacco consumption.

U Saw Tun Mya Aung, Pa-

pun constituency, suggested tobacco consumption should be prohibited by law as it is a tradition of ancestors, and it must be banned at schools and university campus, as well as in public areas of railway and bus stations. As a whole, he supported the proposal.

U Thein Tan, MP of Hlegu constituncy, said that tobacco consumption in Southeast Asia amounted to 89 per cent of global consumption, while Myanmar, India, Nepal, Pakistan, Thailand and Sri Lanka stand atop in the list of tobacco consumption rate. Among them, over 12 billion of cheroot and cigarettes are being consumed in Myanmar annually. He also advised to make no-smoking campaigns, and to raise overall taxes on tobacco products.

Moreover, Sedoktara constituency MP U Kyaw Aung Lwin, Loikaw Constituency MP Dr Khin Sithu, Kawhmu constituency MP U Kyaw Swe Win, Chauk constituency MP U Bo Gyi, Dala constituency MP U Dr Sein Mya Aye, Htigyaing Constituency MP U Maung Maung and PyinOoLwin constituency MP Dr U Aung Khin made discussions.

Dr Myint Htwe, Union Minister for Health and Sports agreed the proposal along with the discussions, and the Hluttaw approved it.—MNA

The Speaker called for the deliberation of the assembly,

Myanmar has been party to the UN Convention on the Rights of the Child since 1991 and has enacted The Child's Rights Law accordingly.

The amended Child's Rights Law, enacted recently, encourages the authorities concerned to ensure that philanthropic shelters and temporary shelters meet certain set standards.

Children require security in addition to progress in their overall development. The states and regions have the legal authority to carry out child development and security tasks. There is a significantly large population of children who cannot attend preschool, and this is a priority area on which we can work together.

The Ministry of Social Welfare, Relief and Resettlement has expanded the number of preschools from 99 in 2016 to 128 this year. To ensure the security of children, licenses have been made mandatory for private

day-care centres.

On our part, we need to find ways to ensure that children lodged in prisons retain their rights, increase efforts to prevent and raise awareness on the rising incidence of child sexual abuse, and disseminate the new law across the nation, right up to the level of subnational Hluttaws.

As our country struggles for political stability and economic improvement, it is facing challenges in improving the remaining sectors. There are also hindrances which are delaying the country's advancement, and the Union Government is putting all its energy into securing the basic needs of the people, including livelihood and the rule of law.

Hence, the whole society has an obligation to enforce the Child's Rights Law and other laws which guarantee rights to children.

# **Coffee Growers in Myanmar Receive a Fair Deal**

**UNIC Yangon and UNODC** 

OE Ohn cannot stop grinning as she picks the ruby-red coffee beans of the bushes in Shan State. The future after all, seems much brighter. Moe Ohn, who is from Htant Hpa Yar village in Hopong township, belongs to a cooperative: Green Gold. Thanks to the hard work of farmers like Moe Ohn, yesterday, Green Gold learned that they had been awarded Fairtrade Certification – the first coffee cooperative in Myanmar to do so.

Green Gold was founded in 2015 with the support of the United Nations Office on Drugs and Crime (UNODC) and the governments of Finland, Germany and Switzerland. Green Gold is located in Southern Shan state, a region known for conflict and being one of the highest producers of opium in the world. Green Gold is made of almost 1000 small-scale farmers who used to grow opium. They come from both the Shan and Pao ethnic groups, who have historically been in conflict with one another. Today though, these farmers, including Moe Ohn, are working together to grow high quality arabica coffee beans.

This coffee is going places, literally. The coffee Moe Ohn and her fellow farmers have picked, was served at the Parliament in France this March. Green Gold has partnered with Malongo, a French coffee company to sell the coffee in Europe

For Moe Ohn and her family, Fairtrade certification guarantees they receive a fair price for their coffee. The farmers also receive an additional premium which can be used as direct investment for social benefits (schools, roads, health centers, etc.) in their communities. This premium can also be invested for the strengthening of the cooperative itself or to improve the productive conditions.

All the farmers have the same responsibilities, same decision power and the same number of votes. All members must know what the aim of the cooperative is and know basic principles of Fairtrade standards. They are involved in all steps of the production, since cooperatives must provide services to its members, including processing facilities, technical assistance and help to sell the final product. The empowerment of members and reaching financial autonomy of the cooperative is key.

Moe Ohn, and other women in the cooperative like Moe Du, Nang Htwe and Nang Lon, directly benefit from Fairtrade certification. Under Fairtrade conditions, women are empowered and there is progress towards gender equity in all the levels of the organization and on the farms. Their children will not be subject to work in the fields; after all, Fairtrade encourages the protection of the children and prohibits child labour. Fairtrade promotes the teamwork with human values



and recognize the importance of working with farmers to develop sustainable livelihood alternatives to opium poppy cultivation", says Troels Vester, Country Manager of UNODC Myanmar.

In addition to supporting the cooperative to achieve the Fairtrade conditions required for certification,

### Magway hospital to provide free treatment to Hepatitis C patients

THE Magway general hospital will open a Hepatitis C virus (HCV) treatment center in August, the 10<sup>th</sup> such center in Myanmar, to provide free treatment to patients suffering from HCV, said Dr Khin Sandar Aung, the manager of the National Hepatitis Control Programme.

HCV treatment centers have been opened at Yangon, Mandalay, and Nay Pyi Taw general hospitals since 2017, while similar centers were set up in Myitkyina and Mawlamyine hospitals in 2018.

"The Magway general hospital is planning to set up a new treatment center. We are going to provide training to staff. Some of the medicines and laboratory equipment have already been sent to the Magway general hospital. We expect to provide free treatment to 200 to 250 patients initially," said Dr Khin Sandar Aung at a ceremony to mark World Hepatitis Day,

#### held on 30 July at the Nan Htike Thu hotel in Magway.

The World Health Organization (WHO) has designated hepatitis as a public health issue and is aiming to eliminate it by 2030. Myanmar is cooperating with WHO in combating hepatitis. The Ministry of Health and Sports is planning to conduct a survey on HCV incidence in Myanmar in 2019-2020.

"Magway has got a chance to provide free HCV treatment under a WHO project. Therefore, patients with HCV will receive free medical care at the Magway general hospital," said Prof Dr Thin Thin Nwe, Medical Department, Magway University of Medicine.

According to a 2015 survey,

6.7 per cent of Myanmar's population had contracted Hepatitis B and 2.7 per cent had Hepatitis C. Although there is no preventive medicine for Hepatitis B, we can provide treatment to eliminate hepatitis, said an official at the World Hepatitis Day ceremony.—Zayyatu (Magway)

# Myanmar to open arbitration centre for resolving commercial disputes

THE Myanmar Arbitration Centre (MAC) will be opened on 3 August at the Republic of the Union of Myanmar Federation of Chambers of Commerce and Industry to resolve commercial disputes among Myanmar entrepreneurs, according to the UMFCCI.

The Commercial Disputes Coordination and Mediation Work Committee of the UMFCCI has been trying to set up an arbitration centre since 2017. The MAC has been registered as a company with the Directorate of Investment and Company Administration, and the permission to form the centre was granted on 11 March, 2019.

"Our company is not a normal one like other companies. Ordinary companies need capital investment. When we established the MAC, we didn't have to put up any capital investment. We only have to implement the MAC with the company's guarantee," said Dr Maung Maung Thein, a consultant with the UMFCCI, at a media

conference held on 31 July at the MAC at UMFCCI, Yangon.

Although it has been set up to look into commercial disputes, the arbitration centre will have the authority to issue punishments, he said. Once the MAC is opened, disputes need not be taken to the court of law, thus helping people save money and time, he added. Currently, a training course is being conducted for 42 experts, who will be responsible for hearing commercial disputes brought to the MAC. The arbitrators will have to remain free from corruption, said Dr Maung Maung Thein.

"The MAC will be opened on 3 August. Clients will be able to hire any arbitrator from MAC, for a fee. But, arbitrators from MAC will work for profit. The centre can launch operations next month. We haven't decided on the charges yet," he added.

The center will allow clients involved in disputes to negotiate under their preferred law and procedures, he added.

"We will not negotiate labor issues because there are already judges for hearing disputes between employers and employees. The MAC will also not negotiate in government investment matters," said U Hnin Oo, the Managing Director of the MAC.

The Commercial Disputes Coordination and Mediation Work Committee was formed in 2016. There were over 80 commercial disputes between 2016 and 2018.

The Arbitration Law, enacted on the basis of the India Law of 1944, was revoked, and the Determination of Arbitration Law was enacted with 58 sections on 5 January, 2016.

In 2018, the Supreme Court announced an order related to the Determination of Arbitration Law.

### **Exports soar** to \$13.37 bln

MYANMAR'S exports touched a high of US\$13.37 billion between 1 October, 2018 and 19 July, 2019 in the current fiscal, according to data provided by the Ministry of Commerce.

The figure showed an increase of \$992 million compared with the corresponding period of the previous FY, when income from exports stood at \$12.37 billion. Of the seven export groups, shipments of agriculture, livestock, fishery, and finished industrial goods showed an increase, while those of minerals, forest, and other products declined.

Export values were registered at \$2.7 billion for agro products, \$320 million for livestock. \$627 million for fisherv products, \$1.26 billion for minerals, \$138 million for forest products, \$7.6 billion for manufactured goods, and \$673.9 million for other goods.

Myanmar's export sector relies more on the agriculture and manufacturing sectors. While export earnings from the CMP (cutting, making, and packaging) garment businesses are rising, the country's reliance on natural resources, such as natural gas and jade, is lessening.

The Ministry of Commerce is focusing on export promotion in order to reduce the trade deficit, and it has adhered to its reforms policy since 2011.

In addition, a series of reforms aimed at liberalization and transparency have been introduced, through policy development, to improve the trade environment, the Permanent Secretary had said at the Myanmar Global Investment Forum 2018, held on 12 September, 2018 at MICCII in Nay Pyi Taw. — GNLM (Translated by EMM)

### Demand for coconut handicrafts high, but production low

ALTHOUGH handicrafts produced from coconut shells enjoy a strong demand in the market, the number of artisans engaged in the craft is too low to cater to the demand, said U Htay Aung, who owns a 'Shwelatyar' coconut shell handicraft business.

"Coconut handicraft businesses can create job opportunities, but artisans can seldom be found even in Ayeyawady and Taninthayi regions, where coconut trees are found and yields are high. Handicrafts from dried coconut are first created by artisans from Magway Region. They are then sent to markets in Myathalun and Shwesettaw pagodas," he said.

"Both locals and foreigners like to buy the products. We would like to invite young people interested in observing this art because there are few artisans involved in coconut handicraft production, in spite of the high demand in the market." he added.

"Since 2011, we have been producing monkey, elephant, and bird toys from dried coconut shells. Later, we added 30 products, including handbags, combs, buttons, stationery products, cups, flower pots, and others to the list.

The prices range from K3,000 to K10,000, depending on the products," said Daw Kvu Kyu Khine from a 'Shwelatyar' dried coconut handicraft business

"To produce coconut toys, fresh coconuts need to be dried for a month and half, and artisans can produce two toys per day. We need more machines to improve productivity," according to artisans engaged in the sector. —Zayyatu (Magway)

### Annual inflation reaches highest in June at 8.08%

THE annual rate of inflation in Myanmar, based on the Consumer Price Index, was the highest in June at 8.08 per cent, according to a report released recently by the Central Statistical Organization, under the Ministry of Planning and Finance.

The inflation rate was up 0.26 per cent compared to May, when it was registered at 7.82 per cent.

Compared with May, the Myanmar Kyat gained against the US dollar in June, leading to a drop in fuel oil prices.

Barring the telecommunications, non-food, tobacco, and beverages groups, there was a remarkable increase in CPI in the food, household goods and maintenance, transportation, other commodities, clothing, health, education services, recreation, and culture groups.

The average inflation rate rose gradually from 5.02 per cent in July, 2018, to touch its highest level in June this year.

In the past 12 months, the year-on-year inflation rate was the highest in May at 9.57 per cent, while core inflation, which strips out volatile food and energy prices, was 6.34 per cent.

In June, Magway Region recorded the highest inflation rate of 12.31 per cent, followed by Mon State at 10.14 per cent, and Mandalay City at 9.99 per cent. The year-on-year inflation rate fluctuated with a maximum rate of 14.33 per cent in Magway Region and a minimum rate of 3.76 per cent in Kachin State.

### Airbus A220-300 passenger aircraft makes its debut in Myanmar

THE Airbus A220-300 passenger airliner has arrived in Yangon, Myanmar, as part of its twoweek demonstration tour of the Asia-Pacific region.

The aircraft on display at Yangon International Airport is an Airbus flight test aircraft, featuring a brand new and comfortable cabin layout of 143 seats in a single class passenger cabin.

Yesterday, airline executives and members of the media witnessed its leading-edge capabilities and high levels of passenger comfort during a special one-hour demonstration flight. Airbus representatives also highlighted the aircraft's capabilities during dedicated presentations.

The A220-300 is operated successfully yesterday in the Asia-Pacific region by Korean Air on both domestic and international services. Air Vanuatu ordered four A220s, comprising two A220-100s and two A220-300s, in February 2019.

The A220 is part of Airbus' modern and comprehensive aircraft family, which covers the market ranging from 100 to more than 400 seats. In the single-aisle category, this comprises the A220 and the A320 Family (which includes the A320neo, the best-selling aircraft in aviation history). In the widebody family, Airbus manufactures the A330 Family (including the latest A330neo) and the long range leader A350 XWB Family.

In the region's single-aisle market Airbus has over 60% market share, with more than 3,000 aircraft in service with 80 airlines, and over 1,500 on order for future delivery.

In Myanmar, Airbus has a presence in the airline market with Myanmar Airways International which operates a fleet of A319 aircraft on its services out of Yangon. —GNLM

### ASEAN foreign ministers begin talks, with S China Sea on agenda

BANGKOK — Foreign ministers of 10 Southeast Asian countries began their annual meeting in Bangkok on Wednesday, with the Korean Peninsula and disputed South China Sea at the top of the agenda.

Tensions remain high in the South China Sea, where some members of the Association of Southeast Asian Nations have overlapping claims with China, with a Chinese anti-ship ballistic missile test in the sea coming to light recently.

In his speech at the opening ceremony of the foreign ministers' meeting, Thai Prime Minister Prayut Chan-o-cha called on ASEAN members to deepen internal collaboration and be open to cooperation with non-ASEAN countries.

Foreign Minister Don Pramudwinai, who chaired the meeting, stressed the importance of unity and co-

operation among ASEAN members. More cooperation is needed "in time of great challenges" because "we all are stakeholders," he said.

The United States and North Korea have yet to resume stalled talks on the latter's denuclearization even though their leaders have agreed to resume them. In a joint communique to be issued after the meeting, the ministers will urge the parties concerned to resume dialogue and continue the denuclearization process on the peninsula, according to a draft of the statement seen earlier.

According to the draft, the ministers will underscore the importance of ASEAN-led platforms, such as the ASEAN Regional Forum — 27-member regional security talks that include North Korea — to promote the dialogue. The forum will be held in Bangkok on Friday.

Regarding the South China Sea, the ministers will take note of concerns from some members over land reclamation and activities in the areas that could stability, according to the draft. China, which claims sovereignty over almost the entire South China Sea, has reclaimed a number of disputed reefs and built airstrips and other military facilities there over the past few years. ASEAN and China have been negotiating a code of conduct for the disputed sea to manage tensions in the waters.

The ministers are expected to welcome an effort to complete the first reading of a "single draft negotiation text" of the code within this year.

ASEAN foreign ministers are scheduled to hold talks with their dialogue partners, including Japan and the United States, on Thursday.

ASEAN groups Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand and Vietnam. —Kyodo News

ASEAN factfinding mission to visit E Timor 4-6 September over membership

BANGKOK – The 10-member Association of Southeast Asian Nations will send a fact-finding mission to East Timor from 4 to 6 September to assess whether the young nation is ready to take on full-fledged membership, ASEAN diplomats said.

Indonesian Permanent Representative to ASEAN Ade Padmo Sarwono told Kyodo News late Tuesday the mission will be "a high-level one consisting of senior officials from all ASEAN member countries, as well as permanent representatives to ASEAN."

He spoke on the sidelines of the annual five-day ASEAN Ministerial Meeting that runs until Saturday.

Such a high-level fact-finding mission will be the first of its kind since East Timor's application for membership in 2011 when Indonesia was chairing ASEAN.

"We will really now begin assessing, analyzing, fact-finding," another ASEAN diplomat, who refused to be named, said in an interview with a small group of reporters recently. —Kyodo News

### Japan, US, S Korea to hold foreign ministerial talks on Friday

BANGKOK — Japan, the United States and South Korea plan to hold a foreign ministerial meeting Friday in Bangkok, with Washington likely to play a mediating role in an effort to defuse tensions between the two key US allies, sources familiar with Tokyo-Seoul ties said Wednesday.

US Secretary of State Mike Pompeo may urge Japanese Foreign Minister Taro Kono and South Korean Foreign Minister Kang Kyung Wha to exercise self-restraint in taking actions that would further deteriorate ties between the Asian countries, which have fallen to their lowest point in decades over wartime history and trade policy issues, the sources said.

It remains unclear whether US mediation efforts will affect Japan's planned Cabinet decision on Friday to remove South Korea from its list of countries allowed under preferential arrangements to

buy products that could be diverted for military use.

There are no indications that Japan will change its position. On Wednesday, trade minister Hiroshige Seko told reporters that Japan will carry out necessary procedures as planned. Separately, Kono and Kang will hold a bilateral meeting Thursday on the sidelines of Association of Southeast Asian Nations-related foreign ministerial meetings in the Thai capital, according to South Korean Foreign Ministry officials.—Kyodo News

# Philippines approves plan to build new Manila airport

MANILA — The Philippines on Wednesday approved a plan to build a new airport near Manila, in a bid to ease congestion with the capital's existing airport operating at full capacity.

Philippine conglomerate San Miguel will build the airport in Bulakan town, north of Manila Bay, that will feature four parallel runways and serve 100200 million passengers a year, a government statement said. "This new interna-

tional airport is important in helping ease the congestion of the Ninoy Aquino International Airport (in Manila)," Transportation Secretary Arthur Tugade said in the statement. San Miguel, which was the only company to bid for the project, will have to

break ground on the \$14 billion project before the end of the year and open for business no later than 2025, the statement said.

The company has said it plans to run the airport, which would be the biggest infrastructure project under President Rodrigo Duterte's government, after obtaining a government concession. —AFP ■

### Maduro honors Americans evicted from Venezuelan embassy in US

CARACAS — President Nicolas Maduro on Tuesday honored American protesters who had occupied the country's embassy in Washington for weeks in support of the beleaguered leader before being evicted by US authorities.

Venezuela broke off relations with Washington after President Donald Trump said he recognized opposition politician Juan Guaido as acting president — one of around 50 countries to acknowledge the 36-year-old as leader of the crisis-hit nation.

A number of left-wing and pacifist activists protesting Guaido's bid to remove Maduro from power occupied the Venezuelan embassy in Washington in April, aiming to block the entry of his

delegation to the embassy, before US police evicted them the following month. On Tuesday, Maduro awarded the American squatters a replica of the sword used by Venezuela's founding father Simon Bolivar.

"I want to give it to you as a show of deep gratitude," he said.

The Venezuelan government had condemned the eviction of the activists and accused the US government of violating international law.

For more than a month, an unclear number of Americans belonging to a group calling itself the Embassy Protection Collective lived in the diplomatic mission, with the consent of the Maduro government. A group of Venezuelan residents of Washington meanwhile camped outside the building to protest against the squatters and prevent any supplies from being delivered to them inside.—AFP

#### Greece releases policeman convicted of teen killing

ATHENS — A Greek policeman, convicted of killing a teenager in Athens 11 years ago, has been released from prison after his life-sentence was reduced, a judicial source said Wednesday.

In 2010, Epaminondas Korkoneas was found guilty of killing 15-year-old Alexis Grigoropoulos two years earlier in the Athens neighbourhood of Exarchia, known for its repeated clashes between authorities and anarchists.

The teenager's death triggered riots in the capital and across Greece. Since then, students mark the event every year in rallies that often take a violent turn. On Monday, the Lamia Appeal Court reduced the policeman's life sentence to 13 years, as he had no previous criminal record.

Having already spent 10 years in detention and working in prison, he was also entitled to remission on his sentence and was accordingly released from prison late Tuesday.—AFP

#### Libya denies UN envoy's reports about military use of Tripoli airport

TRIPOLI — Ministry of Transport of the UN-backed Libyan government on Tuesday denied the remarks of UN Envoy to Libya Ghassan Salame about the military use of M'etiga international airport in the capital Tripoli.

"Ministry of Transport is surprised about the remarks of the UN Envoy to Libya Ghassan Salame during a UN Security Council session regarding the use of the Government of National Accord to M'etiga international airport for military purposes," the ministry said in a statement.

The ministry confirmed that the airport is only used for civil aviation as an international port.

"The repeated targeting of the airport has affected civilian facilities and aircraft. It endangers the safety of travelers and workers, obstructs the transportation movement, and causes great losses to the civil aviation and transportation," the statement explained.—Xinhua

Pakistan evacuates Chinese nationals as firing in Kashmir kills three

MUZAFFARABAD (Pakistan) — Pakistani officials evacuated more than 50 Chinese nationals working near the Kashmir frontier, authorities said Wednesday, after skirmishes with India killed at least three people and injured dozens.

The Chinese were working on a dam being constructed in Pakistani Kashmir along the confluence of the Neelum and Jhelum rivers when firing pushed authorities to move the workers late Tuesday, according to a senior local administration official Badar Munir. Another local official Raja Shahid Mahmood said the decision was made after Indian security forces fired a volley of "indiscriminate fire that killed three people including a woman and a child and wounded 31 others during the last 24 hours".

Mahmood said local mosques have also called on

residents to refrain from unnecessary movements which would expose them to potential firing.

Pakistan's military spokesman went on to say via Twitter that ceasefire violations "shall always be effectively responded" to, adding that security forces will "take all measures to protect innocent civilians" along the de-facto border. Tensions remain high with arch-rival India after the nuclear armed neighbours launched tit-for-tat air strikes in February following a suicide bombing in Indian Kashmir which was claimed by Pakistan-based militants.

Since then they have stepped back from the brink, but firing between the two sides across the de-facto border dividing Kashmir has continued. Kashmir is ruled in part but claimed in full by both countries, who have fought two of their three wars since independ-

ence in 1947 over it. The latest incident comes after US President Donald Trump Trump triggered a political fiasco in India last week by claiming during a meeting with Pakistani Prime Minister Imran Khan that Indian leader Narendra Modi had asked him to mediate in the Kashmir dispute. India vehemently denied that Modi had made any such request, saying the Kashmir issue must be resolved bilaterally between the two countries. —AFP

### **Tensions high as Hong Kong** pro-democracy protesters face court

Hong Kong pro-democracy protesters appeared in court Wednesday after being charged with rioting, setting the stage for further unrest in a weeks-long crisis that has rocked the global financial hub.

The announcement on Tuesday night that 44 people had been charged with rioting -- an offence that carries a jail term of up to 10 years -- immediately triggered another round of clashes between police and protesters.

Supporters continued to voice their outrage as they stood for hours on Wednesday outside court, braving heavy winds and rain, as the accused rioters appeared before a judge.

"Release the righteous... no rioters, only tyranny... reclaim Hong Kong, the revolution of our times," the supporters chanted.

The protesters were generally calm as they took turns to

#### **Protest evolution**

Semi-autonomous Hong Kong has endured more than seven weeks of unrest that began with a government bid to introduce a law that would have allowed extraditions to mainland China. The protests evolved into a movement for deeper democratic reforms and an end to eroding freedoms, in the most significant challenge to Beijing's rule since the city's handover from Britain in 1997.

In the latest confrontation, police used pepper spray and batons against hundreds of protesters who had gathered outside a police station in solidarity with those who had just been charged.

Footage broadcast live on television showed an officer aiming a shotgun at protesters who were throwing objects at him.

The previous two weekends had seen a surge in the level of violence used by both protesters and police, who repeatedly fired rubber bullets and tear gas to disperse projectile-throwing crowds.

A mob of pro-government thugs also attacked protesters, putting 45 people in hospital.

The 44 protesters were charged for their alleged role in running battles between police and protesters in a well-heeled residential neighbourhood on the main island on Sunday.—AFP

### China halts individual travel to Taiwan

BEIJING — China stepped up pressure on Taiwan on Wednesday as it announced the suspension of individual travel permits to the self-ruled democratic island "due to current cross-strait relations".

Relations between Communist-ruled Beijing and Taipei have plummeted since President Tsai Ing-wen came to power in 2016 because her party refuses to recognise the idea that Taiwan is part of "one China".

cut official communications, cities to apply for permits to visit ramped up military exercises, poached diplomatic allies and ratcheted up economic pressure on the island.

The latest move comes as Taiwan prepares to hold a presidential election in January, with Beijing-friendly candidate Han Kuo-yu of the opposition Kuomintang (KMT) party hoping to defeat Tsai.

### N Korea fires two ballistic missiles: South

SEOUL — Pyongyang fired two ballistic missiles on Wednesday, Seoul said, days after a similar launch that the nuclear-armed North described as a warning to the South over planned joint military drills with the United States.

The two devices were fired from the Wonsan area on the east coast at dawn and flew around 250 kilometres (155 miles) into the sea, said South Korea's Joint Chiefs of Staff.

'We stress a series of missile launches do not help ease tensions in the Korean Peninsula and urge the North to refrain from such acts," they said in a statement, while the presidential Blue House expressed "strong concern".

The North is banned from ballistic missile launches under UN Security Council resolutions but it was the second such firing in less than a week, despite a meeting between leader Kim Jong Un and US President Donald Trump last month.

Pyongyang and Washington are engaged in a long-running diplomatic process over the North's nuclear and missile programmes that has seen three high-profile encounters between their leaders in the space of a year. They agreed to resume talks during their impromptu June encounter in the Demilitarised Zone that divides the peninsula, but that working-level dialogue has yet to begin.

Pyongyang has warned the negotiations could be derailed by Washington and Seoul's refusal to scrap the annual manoeuvres between their forces. The North has defied years of isolation and sanctions to develop its arsenal and has not given up any of its weapons, while proving itself adept at dragging out discussions.

On his way to an Asian regional forum where the North will be high on the agenda — even though its foreign minister will apparently not attend - US Secretary of State Mike Pompeo told reporters that the talks had been expected "within weeks" but were taking "a little bit longer" to start. There was no immediate comment from Pyongyang on the latest launch, but Harry Kazianis of the Center for the National Interest in Washington said it was a warning to the two security allies to stop the exercises or the North will "raise tensions to a slow boil over time".—AFP

### Rooney says his future is in MLS ahead of All-Star clash

ORLANDO — Wayne Rooney stressed Tuesday that his future remains in Major League Soccer amid new suggestions his family are unsettled in Washington and want him to return to England before his current contract expires. The former England and

Manchester United forward bristled when asked about stories circulating in England that wife Coleen has demanded he quits North America when his current DC United contract expires at the end of 2021.

Rooney, in Orlando ahead of Wednesday's MLS All-Star match against Atletico Madrid, says he has started work on his coaching badges and admits he wants to follow the likes of new Chelsea coach Frank Lampard and make the transition from player to manager.

The striker signed a threeand-a-half year deal last summer following his move from Everton.

But when asked by AFP if his wife has put down demands for him to quit football for the sake of his family, Rooney snapped: "Is that what was in the media? That my wife has got her own way?

"Those reports are a bit far fetched. I'm concentrating on playing for DC United and trying to get them into the playoffs.

"I haven't thought about anything beyond that.

"I am a bit tired as I left on Tuesday morning at 4am to come to Orlando but I feel in good shape."

Rooney has enjoyed his spell in MLS, scoring 23 goals in 42 appearances.

At the age of 33, however, the Liverpool-born star knows his playing career won't last forever.

"Coaching is something which I have thought about for a long time," Rooney said. "Tm in the process now of going through my badges. It would be a shame for me to finish playing and just walk away from the game.

"I have a desire to go into management and hopefully the right opportunity will come up."

Rooney will team with fellow European star Zlatan Ibrahimovich and Carlos Vela, the Mexcian forward and current MLS goals leader, against an Atletico side boasting the likes of Spanish international Diego Costa and Portuguese wonderkid Joao Felix.

LA Galaxy forward Ibrahimovich, 37, gave the impression of someone who would rather be resting than taking part in an exhibition game in the searing Florida heat and humidity.—AFP
