Dy Construction Minister replies to road infrastructure questions

Next, MP U Sai Thiha Kyaw of Mongyai constituency raised a question asking what plans have the relevant state/regional governments and ministries drawn up for the road and bridge projects handled by the Mongyai Township Department of Rural Road Development.

Deputy Minister U Kyaw Lin replied that six-mile Monyai-Narkho-Helut earthen road will be upgraded to bitumen in the later part of the 2020-2021 FY, and the bridges and ducts along it will

be maintained as well.

The 12-mile Mongyai-Narwa earthen road had two miles upgraded to gravel in the 2018-2019 FY and a budget petition to upgrade another 3.4 miles, with three box culverts, has been submitted for the 2019-2020 FY, said the Deputy Minister.

Motion urging greater collaboration on noncommunicable disease prevention

After this, MP Dr San Shwe Win of Yekyi constituency tabled a motion urging the Union government to arrange for active cooperation among the different ministries to effectively control noncommunicable diseases. MP

U Aye Win of Ingapu constituency seconded the motion.

The motion states that ministry reports show there were 3 million inpatients, 12 million outpatients and 760,000 surgeries performed for kidney and liver transplants and heart surgeries during all three years the incumbent government has been in office

The motion also states there has been annual increase in noncommunicable diseases such as diabetes, hypertension, cardiac-related complications and cancer, while communicable diseases have been spreading less and less. The motion states the number of deaths from noncommunicable diseases has risen from 48 per cent in 2014 to 52 per cent in 2017. It states aortic stenosis causes the most deaths while cancer comes in second.

Amyotha Hluttaw convenes ninth-day meeting of 13th regular session

A ninth-day meeting of Second Amyotha Hluttaw's 13th regular session was held at the Amyotha Hluttaw meeting hall yesterday morning. At the meeting five questions raised were answered, three bills tabled and a motion discussed.

Question and answer

In the question and answer session Union Minister for Education Dr Myo Thein Gyi responded to a question raised by U Shar Aww of Chin State constituency 2 on whether teachers required for basic education high schools in Chin State can be appointed. The Union Minister said that headmasters for middle schools upgraded in academic year 2019-2020 were appointed and vacant high school teacher positions will be filled through transfers, promotions and volunteers based on the applicants' work experiences. The transfers, promotions and proposals as high school teachers will also be according to guidelines set by the states and regions explained the Union Minister.

In responding to a question raised by U Whey Tin of Chin State constituency 11 on whether there was a plan to relax the requirement for students who matriculated in the 2019 matriculation examination to attend education colleges in order to fill

up staff requirements of basic education schools in Chin State, Paletwa Township as a special region Union Minister for Education Dr Myo Thein Gyi said there is no such plan yet. However starting from 2018, applications for education colleges were to be made township wise only while 2019 university entrance guide book had stated that 5 per cent of the students accepted in each education colleges were reserved for applicants who are willing to serve in remote areas said the Union Minister.

In the same way a question raised by U Kyaw Toke of Mandalay Region constituency 7 on when a system of determining university entrance will be made through criteria and requirement set by the university rather than by marks obtained in the matricu-

lation examination was answered by Union Minister for Education Dr Myo Thein Gyi. The Union Minister said that once the universities manage themselves after drawing up and approving a university charter according to the enacted National Education Law and university councils were formed, university entrance will be determined by the university council. By that time students who want to study at a university would be required to sit for an entry examination conducted by that university said the Union Minister.

Questions raised by U Kin Shein of Taninthayi Region constituency 9 on when the government will sign contract and tax income on breeding of Swiftlet bird in seven townships of Taninthayi Region and U Saw Moe Myint @

taw Bill Committee member U Lal Min Htan read and explained a committee report for each bill. After each reading and explanation of the report Amyotha Hluttaw Speaker announced for Hluttaw representatives who want to discuss the bills to register their names.

Next a motion urging the government to review the quality of private schools opened in connection with a foreign university of education entity or with their own curriculum and to review and announce about the certificates issued by those schools tabled by U Kyaw Htway of Yangon Region constituency 8 was discussed by U Kyaw Thaung of Sagaing Region constituency 1, Daw Than Than Aye of Magway constituency 7, Daw Naw Chris Tun @ Dr Arrkar Moe of Kayin State constituency 7, U Aye Bo of Yangon Region constituency 11 and U Than Soe @ Than Soe (Economic) of Yangon Region constituency 4.

In conclusion, Amyotha Hluttaw Speaker Mahn Win Khaing Than announced to convene the tenth-day meeting of Second Amyotha Hluttaw's 13th regular session on 14 August.—MNA ■

The motion states that even though the Control of Tobacco law was enacted in 2016, there has been weak enforcement of it. It says that while production, sale and import of alcohol and opening of liquor stores are beyond the jurisdiction of the Ministry of Health and Sports, the ministry has to deal with the related diseases that occur because of alcohol. In addition, the taxation of tobacco and alcohol is also separate from MoHS.

The motion suggests ensuring all relevant ministries follow existing laws and ensure proper taxation of tobacco and alcohol products and other related measures, especially properly educating the public, to combat the rise of noncommunicable diseases.

The Speaker called for the deliberation of the Hluttaw on the motion, received no opposition, put the motion forward for further debate, and called on

MPs interested in discussing to enrol their names.

Medical degree, diploma bill

Similarly, the Speaker called for the deliberation of the Hluttaw on the Bill Committee's report on the Myanmar Medical Degree & Diploma Bill put forward by the Health and

Union Supreme Court holds 17th coord meeting with lower courts

THE Union Supreme Court and State/Regional High Courts held their 17th coordination meeting in Nay Pyi Taw yesterday.

First, Chief Justice U Htun Htun Oo delivered the opening address. He said that during the judicial reform process, the courts of law must ensure quality justice on every person.

He said there must be objectives to generate greater public

trust on the courts, deliver effective rule of law, pass free and fair judgement, be punctual and other standards the courts must uphold.

The Chief Justice told the judges that they must be extremely careful of their conduct as they are the pinnacles the people look to for level-headed judgement and proper exercise of justice. He added that they are

working hard to open a judicial college in Nay Pyi Taw.

Next, the Chief Justice gave an account of the status of criminal and civil cases and writ petitions from the Supreme Court down to the township courts and other special courts.

From 1 January to 30 June this year, the Supreme Court has accepted 1,152 criminal and 1,421 civil cases and 214 writ petitions

of which 1,094 criminal, 1,712 (including 291 cases from the past year), and 167 writ petitions were fully examined.

Similarly, the State/Regional courts have accepted 4,232 criminal and 3,236 civil cases of which 3,782 criminal and 2,525 civil cases were fully examined.

District courts have accepted 11,294 criminal and 7,822 civil cases of which 10,906 criminal and 5,547 civil cases were fully examined.

Township courts have accepted 228,442 criminal and 17,058 civil cases of which 222,418 criminal and 12,517 civil cases were fully examined.

Juvenile courts of Yangon and Mandalay have accepted 121 cases and fully examined 117. Municipal courts of Nay Pyi Taw, Yangon and Mandalay have accepted 4,739 cases and fully decided on 4,746 (including 7 from previous year). Traffic courts of Nay Pyi Taw, Yangon and Mandalay have accepted and fully examined 54,746 cases.

The Chief Justice said they

began implementing the case management system in 74 state/regional courts. He said statistics in June this year showed that while these courts had good rates of completing course examinations, other courts still had high rates of court delays.

The Chief Justice said they began the trial programme of letting courts take the lead of civil cases in two district courts and two township courts over a period of five months, starting from 1 March 2019. He said they had successfully resolved 76 civil cases during that time.

The Chief Justice said they have outfitted four district courts with special witness interrogation rooms and other necessary equipment to question juveniles and adults in need of protection.

Attending the coordination meeting were the judges of the Supreme Court, chief justices of region/state high courts and other officials related to the legal field. The meeting continues today.—MNA

Forest Department holds High-Level Policy Dialogue on HKH Call to Action

FOREST Department held High -Level Policy Dialogue on HKH Call to Action in coordination with International Center for Integrated Mountain Development(ICIMOD) yesterday morning.

At the event, Union Minister U Ohn Win said that

mountain region makes up 42 per cent of Myanmar and that bio-diversity in those regions, culture, the existence of the diverse tribes and the fresh water sources have economic significance for the country.

The regions are natural habitats of both local and global

plant species. For this reason, policy on eco-tourism, deforestation and carbon REDD plus mechanism are included in national-level strategy.

ICIMOD's help in drawing up policy on eco-tourism, management strategy and guidance concerning natural habitats has been of great assistance, not only in mountainous regions, but in maintaining and prolonging environment of other regions as well.

The HKH evaluation report was written by 350 researchers of 185 organizations from 22 countries and individuals doing field works in HKH, and experts on policy.

The report is important for achieving steady development goals, reducing climate change and making plans to bring about steady development. To reduce the global warming below 1.5 C, the countries in the region should make collective efforts to hold international forums concerning climate change and counter its effects.

The event was attended by permanent secretaries, directors-general, managing directors, professors, staff members of Ministry Natural Resources and Environmental Conservation, the Director-General of ICIMOD, Dr David Molden representatives and officers from related departments.

Then, the dialogue was chaired by Director-General of Forest Department, Dr Nyi Nyi Kyaw, and Deputy Director-General of ICIMOD, Dr Eklabiya Shama, and other officials presented six call to action plans for HKH. Representatives of the ministry and other departments then discussed them in detail. —MNA (Translated by Alphonsus)

Over 300 modified motor vehicles seized in Yangon

OVER 300 motor cars have been seized by the Road Transportation Administration Department (RTAD) so far on account of modifications such as installation of new parts and changes in the body coach, according to YRTA member U Lian Cin Mang (aka Ngam Khai Pa Pa), who is also the director of the RTAD.

Some unscrupulous people are modifying the body coach before seeking registration from the RTAD, and the department will not issue certificates to those modified vehicles, he

said. So far, over 300 vehicles have been seized due to modifications in the body coach and their registration has been cancelled, according to the RTAD

Earlier, the RTAD collected fines for modifications detected on a vehicle's body coach during examination. Under Section 4 (18) (e) of the 2015 Motor Vehicles Law, the registration of a motor vehicle can be canceled if the type, year, structure, or body of the vehicle has been changed without permission. The RTAD has been confiscating modified vehicles since June, 2018. ■ (Translated by Ei Myat Mon)

Smart card security features upgraded to prevent fraud

IN a bid to curb counterfeiting of driving licenses, the Road Transporation Administration Department has upgraded its smart card technology, said U Lian Cin Mang (also known as Ngam Khai Pa Pa), YRTA member and Director of the Road Transportation Administration Department (RTAD).

"Earlier, we revealed the data embedded in smart cards to the public through official announcements in order to identify fake cards. Yet, it encouraged counterfeit producers to easily scam them. This being so, smart card specifications and security data will stay safe and will not be revealed to unauthorized persons in any way," he said.

The upgraded smart cards have been issued from 1 July. The card fee has not been changed, according to the (RTAD).

Last year, some people producing counterfeit smart driving licenses were captured, and lawsuits were filed in 17 counterfeit card fraud cases.

At present, the RTAD is

issuing smart card licenses to drivers after screening their applications. It is also checking drivers' compliance with traffic laws and vehicle specifications, and instituting traffic law, rules, and regulations to ensure road safety.

In addition, traffic officers are also going on patrols every four months in their respective townships to ensure traffic safety. However, the department's workforce was remained unchanged in the past decade, while the number of vehicles has increased remarkably, put-

ting burden on the staff, said U Lian Cin Mang.

Additionally, over 1,000 vehicles are processed at the RTAD everyday, leading to long queues and worsening traffic congestion on the road near the department. Therefore, an online vehicle registration service was launched on 1 January, 2018.

Over 1,090,000 motor vehicles are registered at the RTAD across Myanmar, and half of them, or over 540,000 vehicles, are registered in the Yangon Region.

Over 500,000 fingerlings released to meet local demands in Pathein District

THE Pathein District Fisheries Department released over 500,000 fingerlings into Thayetchaung lake in Kangyidaung Township, Pathein District, Ayeyawady Region on 7 August.

The Head of District Fisheries Department, Township administrator and officials added a total of 503,500 fishes including 250,000 carps, 250,000 barbs, 1,500 catfishes, and 2,000 stinging catfishes with the aims to meet the local demand and enhance the aquatic resources.

UNDER the supervision of Pyinmana Township Development Affairs Department and the arrangement of Township Fisheries Department, about 50,000 fish were relocated from Mingalar Shan lake in Pyinmana Township to Zabuthiri Mingalar lake on 5 August.

After a massive death of fishes including around 300-400 fish in Mingalar Shan lake from 13 to 14 May, 2018, the Township Fisheries Department carried out laboratory analysis. It found that the water quality degradation and insufficient oxygen in the lake caused the fishes to die. Therefore, the Township

Fisheries Department and the locals relocated 50,000 fish, each weighing over 5 viss (1 viss=1.6 kg) to the 40 acres of lake in Zabuthiri Township.

It was over 30 years that the fish in the lake were not removed from it. Fish are added into the lake and the locals usually release the fishes as a good deed during festival and Sabbath days.

Therefore, some fish were moved to another lake to reduce the fish population in the lake according to the Head of Township Development Affairs Department.—Soe Moe (IPRD)

24 houses, religious buildings damaged after tornado hits Paung

A tornado struck four villages in Paung Township of Mon State on the afternoon of 7 August, tearing the roofs of 24 houses and religious buildings, including a parasol atop a pagoda.

In Kyarbo village, the tornado destroyed the roofs of six

houses, and left one person injured. In Kywalchan Village, five houses were damaged, and no injuries could be confirmed.

The roofs of houses in Ahauk Village, and nine houses and one religious building in Motetama Village were destroyed by strong winds. Currently, victims are being provided temporary shelters in their villages. Meanwhile, the parasol of the Dhammayarza Theikdhi pagoda in the monastery compound has fallen to the ground.

The recent tornado is the second one to strike in the first week of August. Earlier, a tornado in Thabyu village on 4 August had damaged 15 homes.—Zin Myo Thu (Paung) ■

Peanut oil fetching high price in central regions due to low crop yield

Peanut oil is being sold at a high price in the central regions — Kyaukpadaung and Yenangyoung townships — due to low production of peanut, according to some oil shops and peanut brokers.

Currently, only old peanuts are being sold in the market because the new crop has not been harvested yet. Additionally, peanut oil is also being exported to China, therefore, the price is not likely to fall, said Ko Kyi Khine,

The prevailing market price of peanuts is K3,000 per viss (1 viss is equivalent to 1.6 kg), while peanut oil is being sold for K6,600 per viss. The price has remained

on the high side, while the supply has been low in the market.

Peanuts are mainly cultivated in the central regions of Myanmar. Last year, the price of peanuts had reached K14,000 per basket, while the wholesale price of peanut oil was in the range of K6,000 per viss. Last year's high price encouraged growers to cultivate peanuts this year, said U Tin Yun, a farmer from Yenangyoung Township. A total of 36,093 acres of monsoon peanut is planned to be cultivated during the rainy season in Yenangyoung Township, according to the Township Agriculture Department.—San Nyunt ■ (Translated by La Wonn)

Gold price soars to K1.2 mln; high demand pushes market to close

THE price of gold in the domestic market has touched a high of K1.2 million per tical (0.578 ounce or, 0.016 kilogram), with a surge in demand and shortage in supply leading to closure of the market, said U Myo Myint, the Chair of the Yangon Gold **Entrepreneurs Association** (YGEA), during a discussion on ways to stabilize the gold price, which was held at the YGEA

"Gold price has been on the upward trend in recent days, and high demand has even pushed for market closure in the last two days, along with a shortage of gold bars. The price is likely to remain on the high side. Those holding gold stocks must not sell them off. Domestic gold is expected to continue rising depending on the global gold price," said U Myo Myint.

To stabilize the gold price

and control the price level, fair trade is required, according to the YGEA. On 22 June, the price of pure gold crossed K1.1 million per tical, and it reached the newest peak of over K1.2 million on 8 August.

The domestic gold price is positively linked to global gold prices. Gold is likely to continue its strong gains in the global market on the back of an escalating trade war between China and the US. Gold price is currently pegged at US\$1,489 per ounce in the global market.

The Kyat exchange rate against the dollar is K1,506-1,510, according to the local forex mar-

The YGEA has already warned its members of legal action in any fraudulent case detected during the price hike. Furthermore, traders have been asked to make payments at once, according to the YGEA.

With global gold prices on

the uptick, the domestic price has hit fresh highs this year.

According to gold traders, in the month of January, the domestic gold price reached its lowest level of K1,043,4000 on 1 January, and the highest level of K1,061,000 on 31 January. It touched a low of K1,058,400 on 2 February and a high of K1,087,300 on 20 February. In March, the lowest price recorded was K1,048,600 (30 March) and the highest was K1,069,000 (21 March). In April, gold prices registered a low of K1,037,200 on 24 April and a high of K1,054,700 on 11 April. The lowest price for gold in May was K1,035,200 (2 May) and the highest was K1,059,200 (14 May). Gold prices touched the lowest of K1,055,000 on 1 June and the highest of K1,125,500 on 25 June. Last month, the prices moved in the range of K1,099,000 (1 July) and 1,149,400 (31 July). ■ (Translated by Ei Myat Mon)

Currently, the people and children of Bago Region, Kayin State, Mon State, Taninthayi Region, and Ayeyawady Region are sheltering at the temporary camps set up in their respective areas.

Floods have a direct impact on people's lives, as they often involve injury and drowning. Beyond these immediate risks, floods pose a hindrance to safe drinking water supply and damage sanitation facilities, increasing the risk of diarrhea and other disease outbreaks, besides impacting children's access to education.

The monsoons bring not only floods, but also landslides in the hilly areas of Myanmar. When torrential rain falls, people must remain on the alert for flash floods and landslides near hilly areas and also small rivers, according to the weath-

er bureau.

To reduce losses, disaster preparedness must begin at the grassroots level, but ministries and regional authorities must take a leading role in the drive.

The monsoon floods in August have affected over 14,000 people in Bago Region, over 11,000 people in Kayin State, over 7,500 people in Mon State, over 200 people in Taninthayi Region, and 700 people in Ayeyawady Region, which brings the total to over 34,000.

The authorities and local social organizations are working together in flood-hit areas to provide assistance to flood victims. So far, the Ministry of Social Welfare, Relief and Resettlement has provided over K290 million to flood victims in July and August.

Meanwhile, the authorities are urged to share information as quickly as possible, and use social media effectively.

I would like to know what is being done about that. **A:** we were informed that there was mass death of pigs in in Mongla. We have a sub office there. It was informed to us that the official in Mongla were given instruction to examine whether it is African swine flu. It has also been instructed not to import pig and pork products. The instruction has been given to dispose of the carcasses in case of death.

A special team from our department has been sent to that area to examine that. The team is working towards obtaining samples from pig sties in Mongla. We have not yet received the samples. On the arrival of the samples we will examine if it is African swine flu. It will be announced to the public if it

happen to be ASF. A team of experts was sent to the area this morning. They will conduct field observation on the condition of pig sties of the region and collect samples.



And it's not contagious to people. If it does spread, there's a higher chance of death for pigs and that can negatively affect the pork livestock market.

Q: What preparations have been implemented to combat this virus?

A: We've arranged preparations

since the virus first surfaced in our close neighbor, China, in 2018. We conducted awareness programs at all respective border gates and immigration checkpoints. We also handed out pamphlets stuck up posters. In addition, we conducted awareness programs in the native language of the region receiving them

We have trained all our staff in the 330 township sub-departments on what procedures to follow when this virus appears. We have even practiced roleplays with them for practical

We have conducted monitoring tasks in areas with high susceptibility to outbreaks. We have legally designated the virus from level B to level A. We

have explained our procedures to local authorities and CSOs to ensure smooth operations. We have provided adequate training to laboratory staff in Yangon, Mandalay and Nay Pyi Taw to run tests on the virus.

We have banned pork and related products at the airports, especially in Mandalay and Nay Pyi Taw. We confiscate and destroy any that are found. We had issued these warnings in advance. We will publish our findings for Tachilek and Mongla publicly as well.

Just last week, we held a short course on emergency response in case of a African swine flu outbreak. There have been times when we receive news of an outbreak but it has gone by the time we get there. We will establish a news network to relay this information faster. We were a little late for Tachilek. We came as soon as we heard the news but we couldn't get a sample.

Q: Do you have anything else to tell the public?

A: African swine fever has been around for about 30 years now but it never spread very over there. Now it has spread to Asia which has a large livestock market so the chances of it spreading are higher. This virus doesn't have a vaccine yet so we need to be careful. We must also administer vaccines for other viruses. Although it can't spread to humans, we have restricted consumption of pork. It is important to establish a clean livestock rearing system to protect ourselves from this



Security forces seize storehouse of drugs, weapons in AA supporter's house

SECURITY forces conducting security operactions in Yathedaung Township, Rakhine State, yesterday performed a surprise inspection into the house of Thakontaing Village administrator U San Thar Kyaw.

Acting on a tipoff, authorities confiscated 2.5 million WY tablets (worth K5 billion at street value), 36 hand grenades, 52 handheld transceivers, 23 steel pipes used for making landmines, 2 gunpowder sacks and other related items in his house. U San Thar Kyaw and his five family members reportedly fled on 3 August at the same time Tatmadaw columns began taking over an AA training camp

in the compound of Chay Ya Taw Pagoda in Yathedaung.

Myanmar Police Force reports that AA members habitually hide in civilian clothes in Thakontaing village and the administrator is a staunch AA supporter who conducts mine attacks on Tatmadaw columns. MPF says psychotropic tablets at his house were given by AA group to sell and procure funds while the other objects were stored in his house for easy retrieval when necessary.

Tatmadaw columns are searching the area for more hidden caches of weapons and other related items.—MNA ■ (Translated by Zaw Htet Oo)

UNHCR that needs impartiality

BEFORE 2015, all the areas, except from Buthidaung and Maungtaw regions where ARSA terrorist insurgents were active, of Rakhine State were peaceful and stable areas. Beginning 2015, AA group entered Rakhine State, and peace and stability in the northern parts of the state started to deteriorate. Since then the AA group has been continuously attacking police outposts stationed in the regions for enforcing the rule of law and community security, intimidating or murdering village administrators or forcing them into leaving their job, and blowing up mines to cut off communication lines, mainly targeting the administrative and security machinery and the rule of law of the Government.

On 26 July 2019 at 4.15 am, AA group using a strong force attacked the Nyaungchaung area police station with heavy weapons and small arms. A police company led by a police major of the police border guards was posted at the police station to shoulder the duty of ensuring community peace, the rule of law and area security at Nyaungchaung Village in Buthidaung Township. The police station did not fall thanks to the police members who valiantly defended their station. However, the AA group indiscriminately fired shots at Muslim villages along their retreating route. Three Muslim women were wounded and one house caught fire due to the indiscriminate attack. The three wounded Muslim women were admitted at Buthidaung People's Hospital at 11.45 am the same day, and the Tatmadaw provided necessary assistance to repair the house that caught fire.

The abovementioned event is one of the most obvious instances of AA attacks. Although there are many instances of AA group's destructive acts against the rule of law and community peace, it is found that the UN, NGOs and the media never give faithful accounts of the events. As regards the current situation of Rakhine State, Ms. Ravina Shamdasani, the spokesperson of the United Nations High Commissioner on Human Rights (UNHCR), released a Press Briefing Note "Myanmar Military Target Civilians in Deadly

Helicopter Attack, UN Rights Office issues War Crimes Warning" on the news website of the UN on 5 April 2019. What the Note stated was that again the Myanmar Tatmadaw was committing an offense that might amount to war crimes against the civilians at the time when the international community was pressing forward with demands for accountability of the Myanmar Tatmadaw for its past crimes; and that the consequences of impunity would continue to be deadly.

The Note also condemned the armed clashes between the Myanmar Tatmadaw and the AA group in Rakhine State; that civilians including native Rakhine, Chin, Mro and Daingnet people of Rakhine and Chin states and issued on 4 April. The Tatmadaw received information which said that about 150 AA members arrived at the surrounding areas of Saidin Creek in the east of Wakhotechaung Village on 3 April afternoon; and that they were going to attack, threaten and control Buthidaung Town and the surrounding villages including the Wakhotechaung Village. The Tatmadaw acted fast and struck first in crushing them. Thanks to the quick response of the Tatmadaw, the AA members could not disturb the town and villages. They could only fire heavy weapons rounds at a local battalion headquarters near Phonnyoleik Village in Buthidaung Township from afar in the evening.

In one of the obvious instances, woman known as writer Nwe Thaki posed a fabricated live broadcast on the social media about the gun attack against police superintendent of Teinnyo Police post in Mrauk-U Township at about 7.30 pm on 23 March 2019 to give people a wrong impression of the Tatmadaw. When an investigation was made, it was found that she was a Rakhine woman who lived in Lashio and not in Rakhine State; and that she had already fled.

A lawsuit has been filed to take legal action against her. Moreover, when a battle broke out at Teinnyo-Aukthakan Village on 29 March 2019, there were fabrications saying that many residents including two women were died or wounded when the Tatmadaw schemed a plot and indiscriminately opened fire at them. The administrator of Aukthakan Village disclosed the truth about the situation and the Tatmadaw released news about it in time on 29 and 30 March 2019. Lawsuit was filed against her. She is still at large.

The Note does not mention any of the terrorist acts and cruelties of AA group as if the UN has never heard of them. Instead, it acknowledged only the projected rumors spread by the AA members under the guise of natives or by the residents who were forced to do so by the insurgents. NEW YORK — Samsung Electronics Co. unveiled its new Galaxy Note 10 and Note 10 Plus smartphones on Wednesday at an event in New York.

The Note 10 will feature a 6.3-inch (16 centimeters) display while the Note 10 Plus will have a 6.8-inch screen. Both will be equipped with an up-

graded S Pen stylus and the capability to convert handwriting to digital text.

The new models will also feature improved camera technology including "Live Focus Video," allowing the user to blur out the background while filming, and a "Zoom-In Mic" that can amplify specific audio during vid-

eo capture. Both smartphones will also have 5G capabilities.

"For everyone who demands the best, I am proud to introduce the newest version of the world's most powerful mobile device," DJ Koh, the president and CEO of Samsung's IT & mobile communications division,

said at the launch.

Samsung, the world's largest smartphone maker, suffered a decline in operating profit in the April-June period compared to a year earlier as the US-China trade war has slowed global economic growth.

The trade policy dispute between Japan and South Korea is also threatening the company's semiconductor business.

Consumer trends such as keeping devices longer before upgrading and choosing less expensive options have put a dent in sales for Samsung's flagship devices as well. Nevertheless, Samsung remained at the top for smartphone shipments with a market share of 22.7 per cent in the second quarter of 2019, according to US market research firm IDC. The same firm noted a 2.3 per cent drop in smartphone shipments worldwide.

The new Galaxy phones will be available for sale on August 23 in the United States and South Korea.—Kyodo News

S Korea confirms 1st export permit under Japan's tougher rules

SEOUL — South Korean Prime Minister Lee Nak Yeon confirmed Thursday that Japan has issued its first permit for exporting to South Korea one of three chemicals that have come under tougher export controls since last month.

Lee told a government meeting that the chemical is photoresist, a light-sensitive material used to coat semiconductor circuit boards. Yonhap News Agency reported that the chemical's export had

been requested by South Korea's biggest chipmaker Samsung Electronics Co.

The Japanese government announced the first issuance of the export permit earlier in the day, a little over a month after it began requiring exporters to obtain a license prior to each shipment to South Korea of photoresist, fluorinated polyimide and hydrogen fluoride.

Exporters had previously been granted bulk licenses for shipping the three chemicals, which are used by South Korean companies to make semiconductors and display panels.

Thursday's Yonhap report said both Samsung and SK Hynix Inc., South Korea's second-biggest chip manufacturer, applied for shipments of the materials early last month.

Once the photoresist arrives, Samsung intends to use it at its extreme ultraviolet technology line in Hwaseong, a city south of Seoul, Yonhap said, citing an industry source familiar with the matter.

Citing observers, the report also said that by approving the export, Japan may be trying to "give an impression that it's not banning trade with South Korea itself."

South Korean President Moon Jae In on Thursday held a separate meeting with top economic officials to discuss measures to minimize the effects of Japan's export controls.—Kyodo News

US crude oil production continues to increase: EIA

HOUSTON — US crude oil production increased slightly during the week ending 2 August, US Energy Information Administration (EIA) said Wednesday.

According to the EIA, US crude oil production averaged 12.3 million barrels per day (b/d) last week, up by 100,000 b/d from the previous week and up by about 1.5 million b/d year on year. This was the second week that the US crude oil production increased after decreasing for two consecutive weeks.

US crude oil production will reach record level in 2019 and 2020, according to the EIA on Tuesday.

In its latest Short-Term
Energy Outlook (STEO),
EIA forecast US crude oil
production will average
12.3 million barrels b/d in
2019 and 13.3 million b/d in
2020, both of which would
be record levels. EIA also
estimated that US crude
oil production will average
11.7 million b/d in July 2019,
down by 0.3 million b/d from
the June level. Enditem.

New ASEAN Secretariat building inaugurated by Jokowi in Jakarta

JAKARTA — Indonesian President Joko "Jokowi" Widodo on Thursday inaugurated the new ASEAN Secretariat building in his nation's capital.

The new building, located adjacent to the old Secretariat building in South Jakarta, features two 16-story towers connected by a skybridge.

In remarks he made before the opening ceremony, the president said the much-larger building, which can host more ASEAN activities than before, will allow the Association of Southeast Asian Nations to work more effectively and efficiently.

"This will drastically reduce travel cost that must be spent...

and the travel cost currently spent can be used for more beneficial activities," Jokowi said.

ASEAN Secretary General Lim Jok Hoi said the new building will provide "a sound foundation" to deepen the body's community-building efforts "by creating more opportunities of physical meetings, face-to-face interactions."

The sixth round of talks of the Regional Comprehensive Economic Partnership, the world's largest free-trade agreement being negotiated by 16 mostly Asian countries including ASEAN, will be the first meeting in the new building, taking place from 19 to 25 August. The ASEAN Secretariat was set up in 1976 by ASEAN foreign ministers, being initially housed at the Indonesian Ministry of Foreign Affairs before being moved to the current location in 1981.

The construction of the new building started in early 2018. Three years earlier, Jokowi, then the governor of Jakarta, handed over the former office of the South Jakarta mayor to the ASEAN Secretariat for its expansion.

ASEAN comprises Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand and Viet Nam.—Kyodo News ■

40-odd countries including China sign Singapore Convention on Mediation

SINGAPORE — Some 46 countries including China and the United States signed here Wednesday a United Nations' convention on mediation, which is named after Singapore and designed to boost mediation as another means of solving the international commercial disputes.

The United Nations Convention on International Settlement Agreements Resulting from Mediation, also known as the Singapore Convention on Mediation, was adopted by the United Nations General Assembly in December 2018 and open for signature on Wednesday.

Li Chenggang, assistant minister of Commerce of China, signed the convention together with representatives from other 45 countries at the Singapore Convention Signing Ceremony and Conference. Over 1,500 delegates from around the world attended the historic event, co-organized by the Singapore

Ministry of Law and the United Nations Commission on International Trade Law (UNCITRAL), including Stephen Mathias, assistant secretary-general for Legal Affairs of the United Nations.

Singapore Prime Minister Lee Hsien Loong said in his opening address that the Singapore convention is a powerful statement in support of multilateralism.

Multilateralism is under pressure but the solution is not to abandon it but to improve it, Lee said, adding that the alternative of a world without multilateral institutions and widely accepted international rules disadvantages all countries, big and small.

Mathias said in his speech that the convention has brought what was missing in the international framework on dispute settlement — "an effective mechanism to enforce international settlement agreements." —Xinhua

Olympics: Games organizers open 2nd-chance lottery for Japan residents

TOKYO — Those who were not among the lucky 960,000 who were allocated tickets to the 2020 Tokyo Olympics in the first domestic lottery in May will get another shot in the second-chance draw which opened early Thursday.

The registration period runs until 11:59 a.m. on Aug. 19, and winners will be announced on Sept. 11, the organizers said. The second-chance lottery is only open to the approximately 4.16 million residents of Japan who were unsuccessful in the initial draw.

Applicants can sign in using the same ID, but those who did not enter the first draw or who won at least one ticket will be automatically disqualified.

About 7.5 million residents of

Japan registered online for the official IDs required to make a ticket application and 5.12 mil-

lion took part in the first-round lottery, but millions were left disappointed when results were

announced 20 June. There will be about 680,000 tickets made available for the supplementary lottery, and these include 170 sessions in 20 of the 33 sports such as soccer, baseball, basketball and hockey.

Lottery participants can only apply for one session, with a maximum four tickets for a medal session and up to six tickets for other sessions. The second phase lottery, for those who did not enter the first or second-chance rounds, will be held this fall. People outside of Japan will be able to buy tickets through Authorized Ticket Resellers, the official sales channels appointed by the respective National Olympic Committees.—Kyodo News

Acting Spanish PM still looking for way to form gov't

MADRID — Acting Spanish Prime Minister Pedro Sanchez assured on Wednesday that he will continue working to form a viable government despite his defeat in two investiture votes on 23 and 25 July.

Sanchez has now been acting prime minister for 100 days since his Socialist (PSOE) Party won the April 28 general election with 123 of the 350 seats in the Spanish Congress of Deputies.

Talks with the left wing party Unidos Podemos to form a coalition government broke down between mutual recriminations and on Wednesday

Sanchez said the lack of trust between the two parties was "reciprocal," although he added he would "not throw in the towel" in his efforts to return to power.

In declaration broadcast on Spanish state TV network RTVE, Sanchez again asked for the support of Unidos Podemos and for the right wing parties Ciudadanos and the People's Party (PP) to abstain to allow his investiture.

"The Spanish people don't deserve to have to go back to the polls," he said, adding that the King was "correct" in stating that it was desirable to form a government.—Xinhua

Madagascar says remains of UK student who fell from plane now found

ANTANANARIVO — Police in Madagascar on Wednesday said villagers had found the remains of a British student who apparently jumped from a plane after opening the aircraft door in mid-air.

Nineteen-year-old Cambridge University student Alana Cutland, who was on a research trip, fell from a light aircraft shortly after it took off from an airport in remote northwestern Madagascar. Her body was found on Tuesday in the Mahadrodroka forest, police said. "Villagers have finally found Alana Cutland's body after a fortnight of searching," chief investigator Spinola Edvin Nomenjanahary said. Police said she apparently jumped from the plane just a few minutes after it took off from a small airport at Anjajavy on a flight to the capital Antananarivo on 25 July. The pilot and another passenger, named as Ruth Johnson, say they tried in vain to stop her, investigators report. –AFP■

Two bodies found in Canada, believed to be teen murder suspects: police

MANITOBA — Canadian police said Wednesday they had discovered the bodies of two men believed to be a pair of fugitive teens who had been on the run after allegedly murdering three people last month.

The Royal Canadian Mounted Police in the central province of Manitoba said they had found the bodies near the shores of the Nelson River, not far from where they had found items linked to the suspects. Kam McLeod, 19, and Bryer Schmegelsky, 18, were wanted over the murders of an Australian man and his American girlfriend in their 20s, as well as of a Canadian biology professor. "At this time, we believe these are the bodies of the two suspects wanted in connection with the homicides in British Columbia," RCMP spokeswoman Jane MacLatchy said.—AFP

Body of stabbed Israel soldier found in West Bank

JERUSALEM — The body of an Israeli soldier was found with multiple stab wounds near a Jewish settlement in the occupied West Bank on Thursday, the army said.

"Today in the early morning hours, a soldier's body was found with stabbing marks on it adjacent to a (Jewish) community north of Hebron," an English-language army statement said.

It did not elaborate on the circumstances but said that troops, police and members of the Shin Bet intelligence agency were searching the area.

The newly drafted 18-yearold soldier was a student at a Yeshiva — or Jewish seminary — in the settlement of Migdal Oz, near where the body was found.

He was in a programme that combined military service with religious study, the seminary head told Israeli public radio.

"The soldier left for Jerusalem during the afternoon to

buy a gift for his teachers," rabbi Shlomo Wilk said.

Missing British scientist found dead in Greece: TV

THEN — The body of a missing British scientist has been found in a ravine on the Greek island of Ikaria two days after she disappeared, Greek public television reported on Wednesday.

The cause of death of Nicosia-based astrophysicist Natalie Christopher, who had been on holiday with her partner, was not yet determined, the ERT channel said. Greek police had been searching for the 35-year-old after she reportedly failed to return from a run on Monday.

A Greek police spokeswom-

an earlier told AFP that police had late Tuesday joined Ikaria port patrols, firefighters and volunteers already looking for the scientist.

According to Greek and Cypriot media, Christopher and her 38-year-old Cypriot partner had arrived on the Aegean island on Saturday and stayed near the port of Agios Kirykos. She left their hotel for a jog on Monday morning but never returned, her partner told media. "The couple talked by phone around 10am and she said she had gone for a run

in the neighbourhood," a police spokesman told Cypriot television. The Cyprus Mail website said Christopher's companion notified the police that she had not returned at around 12.40pm, while other press reports said her phone has been traced to the island of Fournoi, about 10 kilometres away, without saying how it might have got there.

Greek media reports also said traces of blood had been found in the couple's hotel room and were being examined.

Christopher, well known in

Cyprus as an active sportswoman, was involved in several social media projects, including one - "Cyprus Girls Can" - which aims to break down barriers between Greek and Turkish youngsters on the divided island.

The incident comes three weeks after the murder of US molecular biologist Suzanne Eaton on the Greek island of Crete.

The 59-year-old had been attending a conference near the city of Chania and gone out on July 2 without taking her mobile phone, the police said.—AFP■



Lukaku in Milan ahead of probable Inter move

ROME — Manchester United's Belgian forward Romelu Lukaku arrived in Milan early Thursday to undergo medical tests ahead of his likely transfer to Inter, Italian media reported.

"Lukaku is ours" chanted Inter Milan ecstatic fans who turned out at the airport to welcome him on his arrival during the night. The 26-year-old has not played a single minute of United's pre-season campaign as talk of a transfer to the Serie A intensified, with Inter Milan the hot favourites.

Italian newspapers have said the fee could be 65 million

euros (\$73 million), plus bonuses of around 10 to 13 million euros.

Sports newspaper Gazzetta Dello Sport said Lukaku travelled to Milan with his agent and friend Federico Pastorello and was to undergo stringent medical tests on Thursday.

Inter coach Antonio Conte said on Sunday he was "very hopeful" of finalising a deal to bring the former Everton star to the San Siro. "Lukaku is a good player, a striker who I had tried to buy when I was coach at Chelsea" from 2016 to 2018, Conte said.

According to Gazzetta Dello Sport, Manchester United initial-

ly refused a deal and frenzied contacts between the two sides have taken place in recent days.

The player was in Brussels on Monday and Tuesday training with his boyhood club Anderlecht. Local papers showed pictures of him in the Belgian club's colours.

Inter have been in the market for a centre forward since the start of the transfer window.

But the club has been competing for his services with fellow Serie A side Juventus, who Italian media said had offered Manchester United an exchange with Paulo Dybala.—AFP

Liverpool bank on stability over signings to end title wait

LIVERPOOL — Missing out on the Premier League title despite a record-breaking campaign was eased by winning a sixth European Cup for Liverpool last season, but ending a 30-year wait to be crowned English champions is now more important than ever on Merseyside.

Jurgen Klopp's men are expected to strike first blood in the title race when they kick off the Premier League season against newly-promoted Norwich under the Friday night lights of Anfield.

However, unlike most of their competitors who have delved into the arms race for talent in another transfer window where Premier League clubs have spent over £1 billion (\$1.2 billion), the European champions have been conspicuously quiet in the transfer market.

Teenage talents Sepp van den Berg and Harvey Elliott have been snapped up with an eye to the future, while Spanish goalkeeper Adrian will replace Simon Mignolet as back-up to Alisson Becker in three low-key arrivals. Klopp, though, believes the foundations are already in place for another tilt at the title after spending over £230 million in the past two years on the likes of Alisson, Virgil van Dijk and Mohamed Salah.

"You should never do transfers because other clubs are doing transfers," Klopp told Sky Sports. "That makes no sense, it's not about that. And if you sit back for a second and have a look at the squad, do we need more players?"

On the evidence of last season, there is precious little for Liverpool to improve on.

Man City set the bar

A Premier League points tally of 97 would have won the title in any season bar the last two as Manchester City have set a new bar under Pep Guardiola.

City have further strengthened the squad that won a first ever domestic treble of trophies in England last season with the club record signing of Spanish midfielder Rodri and will be the benchmark for Liverpool to beat.—AFP
