Gote Twin Bridge likely to open today

TEMPORARY Bailey Abridge to replace the Gote Twin Bridge, which was blown up by armed groups on 15 August, is expected to be commissioned into service today.

Construction work on the temporary bridge was completed yesterday evening. Officials completed installing the steel frames for the bridge yesterday, and aim to finish paving the Bailey bridge's road and open it to the public today.

After a load test, trucks and vans weighing less than 36 tons will be allowed on the bridge from 20 August, according to the Ministry of Construction.

Deputy Minister U Kyaw Linn inspected the construction of the triple truss, single story, two-laned, 210-feet Bailey bridge on 18 August.

The Ministry of Construction and Shan State government decided to construct the Bailey bridge after the Gote Twin Bridge was damaged in a recent explosion.

Twenty-eight engineers from the Department of Bridges and 105 skilled workers from **Bridge Construction Special** Teams 2, 4, 6, 9, and 12, and Construction Team 3 worked nonstop to finish the major bridge on the Mandalay-Muse-Lashio Road which is the main trade route to China.

Director-General of International Organizations and Economic Department, Ministry of Foreign Affairs receives Deputy Representative of UNHCR

TChan Aye, Director-General of the International Organizations and Economic Department, the Ministry of Foreign Affairs of the Republic of the Union of Myanmar received Ms Cecile Fradot, Deputy Representative of UNHCR in Myanmar at 2 pm on 19 August 2019 at the Ministry of Foreign Affairs in Nay Pyi Taw. During the meeting, the Director-General explained the position of the Ministry of Foreign Affairs regarding the UNHCR's request to access the resettlement sites of 3,450 verified displaced persons who will be expected to repatriate to Myanmar on 22 August 2019 in accordance with the bilateral agreements between Myanmar and Bangladesh, and areas of cooperation between Myanmar and UNHCR.

The Director-General informed the UNHCR's Deputy Representative that the repatriation of 3,450 verified displaced persons will be conducted in accordance with the bilateral agreements between Myanmar and Bangladesh and the MoU signed between Myanmar and UNDP/UNHCR. The UNHCR could propose related assistance to provide for the resettlement

of the returnees on their return to Myanmar. Myanmar will also inform the UNHCR should it have any need for assistance in its efforts to resettlement. The Government of Myanmar has provided relevant information of the resettlement and sites to the Bangladesh Government, in accordance with the bilateral agreements. If Bangladesh needs any further information, Myanmar stands ready to cooperate with Bangladesh constructively. Recently, a delegation of Myanmar led by the Permanent Secretary of Ministry of Foreign Affairs, together with the members of an Association of Southeast Asian Nations' (ASEAN) emergency response team, visited displaced persons' camps in Bangladesh's Cox's Bazar to explain the way forward for their repatriation. The Director-General also reiterated that Myanmar would continue to cooperate with UNHCR in accordance with the MoU signed between Myanmar and the UNDP/ UNHCR and the UNHCR can render its assistance for the returnees at the Hla Phoe Khaung transit center in Maungtaw Township, the

Rakhine State and at subse-

quent resettlement sites.

According to the bilateral agreement between Myanmar and Bangladesh, a Memorandum of Understanding (MoU) was signed between the Government of Myanmar and UNDP/UNHCR on 6 June 2018 to provide the Government of Myanmar with the necessary assistance in repatriation process in consultation with the Government. The MoU was extended for the next 12 months with exchange of letters between the Government, the UNDP and the UNHCR on 28 May 2019.

In line with the provisions of the MoU, the Government of Myanmar has allowed UNDP and UNHCR to conduct independent field assessments in over 80 villages as of 13 July 2019 and to implement 34 Quick Impact Projects (QIPs) as of 5 September 2019 in order to benefit all communities and the potential returnees. It is learnt that the Government will grant UNDP and UNHCR necessary authorization for the remaining QIPs and assessments as and when security situation of Rakhine State allows. —MNA

UNION Minister for Social Welfare, Relief and Resettlement Dr Win Myat Aye, together with his Deputy Minister U Soe Aung, met with the members of Natural Disaster Management Committee at the office of Shan State's Deputy Head Office of General Administration Department in Lashio yesterday morning.

The attendees then elaborated the tasks undertaken on the consequences of conflicts broke out from 15 to 18 August and the works of district disaster management committee. They also requested for the readiness of more rescue items, construction of multi-purpose resistant buildings and the formation of a specific disaster management committee for the northern Shan State. Union Minister Dr Win Myat Aye and party then visited Lashio People's Hospital and comforted the injured persons in the armed conflicts.

MoI kicks off third media and information literacy course

The Ministry of Information conducted the third media and information literacy course for the officials of Information and Public Relations Department yesterday morning.

The opening ceremony of the course was held at the training school of IPRD headquarters in Nay Pyi Taw. Deputy Minister for Information U Aung Hla Tun officiated at the event, with the remarks on the increasing trend of online and social media platforms in searching information.

He also said the data has

shown that there are over 20 million social media users and 60 million mobile sim card users in the country with more than 51 million of population.

The deputy minister also concluded the trend of mainstream media seems to decline as the popularity of social media is increasing. He added that although many people are using social media, all the news stories on these platforms are not trustworthy in the view of common sense as rumours, false news, fake news, fabricated news with bad intention and hate speech have gone viral on social media.

He also remarked the information literacy can scrutinize and analyze sorts of information, their sources and related media groups on their reliability. He finally concluded that all the social media users need to learn media and information literacy, and the trainees were urged to disseminate the knowledge gained from this course which will be conducted from 19 to 24 August for 37 officers of district IPRD offices.—MNA

Yangon-Bagan train service back to normal after repairs

THE train service between Yangon and Bagan returned to normal on Sunday after eight days of repairs on the BR-135 bridge, located between Bagan and Taungzin railway stations, according to the Myanma Railways (upper Myanmar).

Transport services on the 120-feet-long BR-135 bridge were halted in the afternoon of 10 August, after two (PR-3 and 4) of its five pillars were damaged by rainfall-related erosion. On account of the damage to the bridge, a Yangon-Bagan train was terminated at the Kyaukpadaung station that day.

After eight days of repairs on the bridge, the Nay Pyi Taw-Pakkokku trains resumed normal trips.

"The train service to Bagan was suspended and the train was terminated at the Kyaukpadaung station after damage was detected on the



bridge. Now, the train will run the normal trip after the fixing of the Bailey bridge," said U Myo Win, the General Manager of Myanma Railways.

Meanwhile, the Mandalay-Bagan train service was forced to a halt due to soil erosion between Palin and Bagan along the Mandalay-Bagan railway on 10 August, and services were resumed from 3 pm on 11 August.

"The Bagan station was submerged and the roads were destroyed due to heavy rain. Work to mend and repair the road started after the report at 5:30 pm," said U Nyi Nyi Lwin, the Manager of the Division 3 of MR.

The Myanma Railways re-

Bears in Shwetaung Oo to be freed in Htamanthi Wildlife Reserve

THE Shwetaung Oo Board of trustee is planning to hand over bears to the Forest Department so they can be released into the Htamanthi Wildlife Reserve, according to U Than Soe, the Director of the Sagaing Region Forest Department.

"We have not received an official request for the release of the Shwetaung Oo bears yet. Normally, we work with the Wildlife Conserve Sanctuary for the release of wild animals into the Htamanthi Wildlife Reserve. But, it is not easy to release bears into the wildlife reserve, and they are set free in the sanctuary only after they

are trained to find food and protect themselves," he said.

"When old captive bears, that have become reliant on humans for food, are released into the sanctuary, they find it difficult to find food. Therefore, we are only training young bears and setting them free in the wildlife sanctuary. We will seek more information about the plans for the release of Shwetaung Oo bears," he said.

"We are creating lakes for conserving wild animals at the bat cave conservation area, under the supervision of the Sagaing Region Government. Moreover, there are plans to



showcase bears in enclosures to draw visitors," he added.

Study tour for CBT pilot project under way in Yangon

A study tour is being conducted in some townships of Yangon Region to explore their potential for community-based tourism (CBT), according to U Naing Win, the director of the Yangon Region Directorate of Hotels and Tourism.

The study tour is under way in some villages in Kawhmu, Hlegu, and Taikkyi townships, under the guidance of the Yangon Region Chief Minister, who is also the chair of the regional tourism committee.

"We are currently looking

for potential places. We are exploring potential destinations on the basis of culture, handicraft business, and other attractions. The Yangon Region government is also assisting in technical work. Cooperation from local residents plays a major role in creating CBT sites. We are just doing a study tour, and it cannot be considered a feasibility study yet," said U Naing Win.

"Hlegu and Taikkyi have the potential for CBT as well as eco-tourism. However, there are drinking water lakes in those townships. We will decide to continue with our plan for these sites only after discussions with the Forest Department, municipal officials, and experts concerned," he said.

"Yangon's main attractions are its pagodas. Additionally, the concerned departments will also assist in the upgrade of the Hlawga National Park in Shwepyitha Township and the National Races Village in Thakayta Township in order to attract more visitors," U Naing Win added.

"Myanmar is rich in tourism sites which can be developed for CBT. There is one CBT site in Twantay Township. If we can create CBT sites in Hlegu. Taikkvi. and Hmawbi townships, Yangon Region will become a sought-after destination among tourists," said U Phyo Zaw Wai, the vice chair of the Union of Myanmar Travel Association.

The CBT site at Kyaikthale Village in Twantay Township of Yangon Region was set up in February, 2017.

Eco-tourism, cultural tourism, and community-based tourism sites are being implemented in Yangon, Sagaing, Taninthayi, Mandalay, Ayeyawady, Bago, and Magway regions and Kachin, Mon, Shan, and Chin states.

Border rice exports continue to plunge

MYANMAR'S RICE shipments through the border trade channel have shown a drastic decline in the current fiscal year, accounting for just over 29 per cent of the total rice exports, according to figures released by the Myanmar Rice Federation (MRF).

Myanmar primarily exports rice to China through the border gates. However, trade in agricultural products has been halted on account of China clamping down on illegal trade in border gates.

At present, rice is being exported to China through government-to-government (G2G) agreements and under a barter system, in exchange for Chinese goods.

Earlier, border trade of rice was relatively high compared to maritime trade. However, in the current financial year, border trade has accounted for only 29.89 per cent of the total rice exports, while 70.11 per cent of rice has been shipped via maritime trade.

Between 1 October, 2018 and 2 August, 2019, rice exports through the border gates earned an estimated US\$177.29 million, whereas sea trade generated an income of \$420 million, as per data from the Commerce Ministry.

The total volume of rice and broken rice exports, as of 2 August, was estimated at 1.97 million metric tons, worth over \$597.6 million, according to an announcement issued by the MRF.

China, which accounts for 33 per cent of the total rice *Mon*))

exports, is the main buyer of Myanmar rice, followed by the Philippines and Côte d'Ivoire. Meanwhile, Cameroon is the fourth-largest and Madagascar the fifth-largest buyer of Myanmar rice. The European Union countries account for over 20.88 per cent of the export, while 25.4 per cent of Myanmar's rice is shipped to African countries.

Myanmar's broken rice is mostly exported to Belgium, followed by Indonesia, China, the Netherlands, and the UK. It is sent to 36 foreign markets.

Myanmar shipped 3.6 million tons of rice to foreign countries in the 2017-2018 financial year, which is its highest record in rice exports. —GNLM

Manufacturing exports up \$1.48 bln in current financial year

EXPORTS of finished industrial goods touched a high of US\$8.36 billion between 1 October and 9 August in the current financial year, registering an increase of \$1.48 billion compared with the corresponding period of the previous fiscal, according to the Ministry of Commerce.

As per figures provided by the Ministry, the exports of finished industrial goods totalled \$6.87 billion during the same period in the 2017-2018FY.

Myanmar's manufacturing sector is largely concentrated in garment and textiles produced on the Cutting, Making, and Packaging basis, and it contributes to the country's GDP to a certain extent.

The CMP industry has emerged as a very promising one in the export sector. The value of CMP exports was just \$850 million in the 2015-2016 fiscal year, but it tripled within two years to reach \$2.5 billion in the 2017-2018FY, as per figures provided during the Myanmar Global Investment Forum 2018, held on 12 September.

In the last mini-budget (April-September, 2018), exports of clothes made under

the CMP system were valued at \$2.27 billion.

Japan is the largest market for Myanmar apparel, followed by the European Union.

There are currently over 400 garment factories in Myanmar, which employ more than 300,000 workers. Investors prefer to invest in cheap-labour countries like Myanmar.

In the current FY, the manufacturing sector has ranked second in terms of FDI inflows, after the transport and communications sector. — GNLM

Myanmar's bilateral trade with Germany exceeds \$550 mln in Oct-June

TRADE value between Myanmar and Germany between 1 October, 2018 and end-June 2019 of current fiscal year reached US\$551.74 million, according to data of the Ministry of Commerce.

Myanmar's export to Germany in first nine months of the current FY surpassed its import, with \$407 million worth of export and \$144 million valued import, according to the statistics released by the Ministry of Commerce.

Beyond regional trade regime, Myanmar has established trade links with EU members. Germany is the biggest trade partner in European Union, followed by the UK and France.

The main export items are rice, pulses, tea leaf, coffee, garments on Cut-Make-Pack basis and fisheries. Meanwhile, machinery, data-processing equipment, electrical and optical goods, chemical products, motor vehicles and parts and pharmaceutical products, cosmetic, food and beverages and

consumer goods are imported into Myanmar.

Myanmar reinstated EU's Generalized Scheme of Preference starting from 19 July 2013. Myanmar can enjoy GSP for export of fisheries, rice, pulses, agro products, bamboo and rattan finished products, forestry products, apparels and finished industrial goods. Nevertheless, EU imposed three-year tariff on indica rice (long-grain rice) imported from Myanmar and Cambodia starting from 18 January.

Trade value with Germany was registered at \$373 million in the past mini-budget period (April-September 2018), \$584 million in 2017-2018 FY, \$342 million in 2016-2017 FY and \$153 million in FY 2015-16 respec-

it Trade Environment Index produced by The Economist Intelligence Unit. The index evaluates countries on their structural capability to protect against illicit trade, highlighting their specific strengths and weaknesses across 25 policy, legal, regulatory, economic, trade, institutional, and cultural indicators. The 2018 index evaluated 84 countries on the extent they enable or prevent illicit trade. Myanmar ranks 82nd, with an overall score of 23, out of 100, above Iraq and Libya.

Myanmar's annual trade totalled US\$29.209 billion in the 2016-2017 fiscal year, \$33.537 billion in the 2017-2018 fiscal year, and \$26.223 billion in the 2018-2019 fiscal year (October to June).

The annual figures show that maritime trade rose, while border trade declined. The fall in border trade was found to be connected to an increase in illegal trade.

A look at the border trade figures of Myanmar and Thailand in June, 2019 reveals a

gap of more than \$150 million, which indicates the magnitude of illegal border trade. Furthermore, illegal timber exports are affecting the economy as well as damaging the environment. Fake products, especially medicines and liquor, are hurting the economy as well as endangering consumers.

Besides, illegal imports through the border are threatening the existence of small and medium enterprises (SMEs).

To overcome the challenges in fighting illegal trade, illegal trade control and prevention groups have been formed in the regions and states sharing a border with neighbouring countries.

The authorities in the concerned regions are urged to step up efforts for stamping out illegal trade as it hinders economic growth.

For this, the cooperation of the people and neighbouring countries is very important.

The situation demands that we work more closely with our neighbouring trade partners to resolve immediate cross-border illicit trade issues, while raising people's knowledge and awareness of the dangers of illegal trade.

ITH a view to facil-Myanmar economy in conjunction with the growth of the private sector expansion, the Myanmar Companies Law was enacted in line with the international norm and standard.

In the backdrop of perfect setting and situation embedded in the Myanmar Companies Law being combined with the stylish and smart new electronic registration system of MyCO (Myanmar Companies Online), which brings prompt and accuracy, has earned good reputation in easing business inside the country as well as abroad. The new system with electronic registration platform reduces red tape, saves time and cuts expenditures in a remarkable way.

Myanmar Companies Law

Company incorporation is carried out by Directorate of Investment and Company Administration (DICA) in accordance with the provisions of Myanmar Companies Law (2017) and investment proposal applications are subjected to Myanmar Investment Commission.

DICA has the responsibility of shouldering the task as registrar and also act as legal and juridical person. Moreover, the DICA has to oversee the irregularities of the companies and act as regulator.

The registrar will establish and maintain the electronic registry platform. Any registry transaction will be carried out using the electronic registry system.

Taking under its charge, the DICA is to entrust the MyCO for maintaining and up keeping of digital registration system when all the detailed information and statistics being provided by the companies.

Relevant information starting from the first registration of the company and all the subsequent updates of the company are to be informed to DICA.

An application for the re-registration of an existing company must include: (i) the full name, date of birth, gender, nationality and address of every director

and secretary of the company, (ii) the address of the registered office and (iii) the address of the principal place of business of the

In the case of an existing company, the application must include the full name and ad-

with the intent to function properly and effectively.

For many years, the reforms over the smooth registration have been long awaited in great expectation to be realized as the previous system was very much messy and bonded with

At this juncture, a question may arise on the responsibility of person over the authenticity and accuracy of the information and data of the company, and the legitimacy and legality of the figures being provided.

As some of the persons from the companies are not familiar with the scope and span of the MyCO system, which is being formed with international norms, there exists incorrect interpretation and misunderstanding. Therefore, clarification of the responsibility of the registrar is needed to be unveiled.

Taking on the shoulder, the Director-General of DICA acts as the registrar holding the task for the legal registration of the companies and upkeep the data and information of the companies company constitution might re-

utes, the share holder certificates, the official documents, the evident papers, the necessary register books must be maintained in proper and legitimate manner in the hands of the com-

With regards to the legality of the information and data, the person that have signed and submitted the relevant entries must stand as witness over the facts

In other words, it means that digital registration platform of the company and the person who submitted the information and data to MyCO have to take the responsibility of its accuracy, legitimacy and comprehensiveness.






around 3,600 labourers per year who are expected to attend training courses and seminars conducted by the center.

Ban on sending wild elephants to zoos a step closer

GENEVA (Switzerland) —The regulator of global wildlife trade will likely ban sending African elephants captured from the wild to zoos after countries supported the move Sunday, in what conservationists hailed as a "historic win".

A large majority of countries voted in Geneva to prohibit the transfer of elephants caught in the wild to so-called captive facilities — a practice animal protection groups have long described as "cruel".

The vote was the first rendered during a 12-day meeting of the parties to the Convention on International Trade in Endangered Species, which kicked off on Saturday with thousands of conservationists and policymakers from more than 180 countries in attendance.

With 46 in favour, 18 against and 19 abstaining, the vote cast in one of two committees secured the two-thirds majority needed to pass, but will still needs to be approved by the full conference before the meeting concludes on 28 August.

"This decision will save countless elephants from being

ripped away from their families in the wild and forced to spend their lifetimes imprisoned in substandard conditions at zoos," Iris Ho, a senior wildlife specialist with Humane Society International (HSI), said in a statement.

Specifically, the countries voted to limit trade in live wild African elephants only to conservation in their natural habitats, effectively ending the practice of capturing elephants and sending them to zoos and entertainment venus around

the world.

While elephants in western, central and eastern Africa have long been listed among the species in need of most protection under CITES, and thus banned from all trade, some trade has been permitted in southern Africa, where elephant populations are healthier.

Zimbabwe has for instance captured and exported more than 100 baby elephants to Chinese zoos since 2012, according to HSI.—AFP

Indonesians hit the beach in mass trash pick-up

JAKARTA (Indonesia) — Thousands of Indonesians combed trash-strewn beaches at the weekend in a nationwide bid to tackle the Southeast Asian nation's mammoth marine waste problem.

As the country celebrated its 74th independence day anniversary, volunteers and civil servants scoured for plastic rubbish and other debris, collecting truckloads of trash across the 17,000 island archipelago.

Numbers were still being tabulated, but it was estimated that tens of thousands of people took part in the initiative — with hundreds of tonnes of rubbish collected, according to Pandu Laut Nasional, the event's coordinator.

Indonesia is the world's second biggest contributor to marine debris after China, and pledged to reduce marine plastic waste by 70 per cent by 2025.

A string of initiatives have been rolled out to fight the scourge of plastic waste.

Bus passengers in Indonesia's second-biggest city Surabaya can now swap recyclable plastics for free local travel, while holiday hotspot Bali is rolling out a single-use plastics ban.—AFP



US gives Huawei 90 day reprieve on ban: Ross

WASHINGTON (United States)
— The United States gave Huawei a 90-day reprieve Monday on
a ban against buying US technology, but added nearly four dozen
subsidiaries of the Chinese telecoms giant to the prohibition.

"As we continue to urge consumers to transition away from Huawei's products, we recognize that more time is necessary to prevent any disruption," Commerce Secretary Wilbur Ross said in a statement.

The ban is part of a sweeping effort by President Donald Trump's administration to restrict Huawei, which officials claim has links to Chinese intelligence that makes it a security threat.

Ross announced that another 46 Huawei affiliates are being added to the list of banned companies, meaning over 100 are now subject to the restrictions.

But the Commerce Department has extended a temporary

license for US companies to work with the Chinese firm and its subsidiaries for another 90 days.

"We are giving them more time to wean themselves off," Ross said on Fox Business Network, noting that the new deadline for implementing the ban is 19 November: "Technically Huawei says they're privately-owned company, but under Chinese law, even private companies are required to cooperate with the military and with the Chinese intelligence agencies and they're also required not to disclose that they are doing so," Ross said.

Huawei is the number two global smartphone vendor and is considered the world leader in fast fifth-generation or 5G equipment, but is hampered by lack of access to key hardware and software, including smartphone chips. Trump on Sunday repeated that "we don't want to do business with Huawei for national security reasons. —AFP

Three killed in east DR Congo protest after militia attack

BENI (DR Congo) — Three people were killed in a town in eastern DR Congo on Monday when police opened fire at a protest over poor security, a local official told AFP.

"There was a demonstration in which three people have just died -- a young man of about 25 who was shot in the abdomen and died in the hospital, a Pygmy who was shot and died immediately, and another child who was shot and also died," said Donat Kibwana, chief administrator for the Beni region.

The incident happened in Oicha, a town about 30 kilometres (18 miles) north of the city of Beni.

Beni is the capital of North Kivu province, where murder, extortion and other crimes are rampant.

The region, which is also struggling with an epidemic of Ebola, is in the grip of militias who have killed hundreds of people over the last five years.

The Oicha protest came a day after an attack attributed to a Ugandan Muslim militia called the Allied Democratic Forces (ADF) in which two people were killed

Noella Katongerwaki, a representative of grassroots groups in the Beni region, said: "The police dispersed the protesters with live rounds and teargas.

"Right now, the toll is three dead, including a Pygmy woman." Another activist, Janvier Kasairio, said ordinary life in Oicha on Monday had "stopped".—AFP ■

19 killed in Uganda fuel truck blast: police

KAMPALA (Uganda)— Nineteen people died when a fuel truck barrelled into other vehicles in a busy town in western Uganda and exploded, police said Monday.

The blast occurred Sunday evening in the Kyambura trading centre, a mountainous area near the Queen Elizabeth National Park.

"Ten people died instantly when the fuel truck lost control

and hit three other vehicles, leading to multiple explosions that also burned 25 small shops," said regional police spokesman Martial Tumusiime.

"Of the people that were rushed to the hospital, nine of them have also died as a result of wounds," he added.

In 2002, 70 people were killed when an oil truck rammed into a bus in Rutoto, less than 50 kilometres (30 miles) from Kyambura.

And in 2013, 33 people died in an explosion after a fuel truck overturned — many having rushed to the scene to siphon fuel.

The accident in Uganda came eight days after a fuel truck exploded in Tanzania. The fireball engulfed a crowd thronging to collect petrol from the wrecked vehicle, leaving 95 dead.—AFP ■

Zimbabwe deploys security forces over banned march

BULAWAYO (Zimbabwe) — Troops and police were out in force in Zimbabwe's second city of Bulawayo on Monday in a bid to block a planned opposition march, three days after brutally dispersing a banned protest in the capital Harare.

Soldiers and armed police on horseback and in trucks patrolled the central business district and most of the high density suburbs.

Using loudhailers, police warned people against joining the demonstration, which was called to protest at deteriorating economic conditions.

One of the city's usually busy areas, the precincts of Tredgold Magistrate Courts, where illegal forex changers ply their trade, was cordoned off.

Police also set up checkpoints on most roads leading to the city centre.

The authorities banned the protests, organised by the opposition Movement for Democrat-

ic Change (MDC), after police routed protesters who had defied a similar order in Harare on Friday.

"The move by the government to ban the demonstration shows they are running scared," Mbuso Fuzwayo, of the rights pressure group Ibhetshu Likazulu, told AFP as military helicopters hovered over the city, an opposition stronghold.

"They don't have confidence in themselves. This is like Rhodesia. This is primitive," he said referring to the British colonial rule era.

The MDC is challenging the ban in court, which is expected to issue a ruling at 1400 GMT.

The protesters are angry over the country's floundering economy and the jailing of a wellknown government critic, tribal chief Felix Ndiweni.

The chief, who is revered in the western region of Matabeleland, was last week jailed for 18 months for allegedly destroying a villager's property.

Police fired teargas and beat up several demonstrators in Harare on Friday after they gathered in a square.

Those protests were the first since President Emmerson Mnangagwa's decision to double fuel prices sparked nationwide demonstrations in January that were crushed by police with the loss of at least 17 lives.

UN concern

Mnangagwa took over from long-time ruler Robert Mugabe in November 2017.

He won disputed elections in July last year on a platform of change.

But many Zimbabweans say the economy has gone from bad to worse with rocketing inflation, shortages of bread, fuel, medicines and other basics.

According to the UN, about five million Zimbabweans, or a third of the population, are in need of food aid.—AFP ■

US economists expect recession in 2020 or 2021: survey

WASHINGTON (United States) — A majority of economists expect a US recession in the next two years, but have pushed back the onset amid Federal Reserve actions, according to a survey released Monday.

The survey came out after President Donald Trump pushed back against talk of a looming recession as a raft of US data reports last week showed a mixed picture on the economy.

"I'm prepared for everything. I don't think we're having a recession. We're doing tremendously well. Our consumers are rich," Trump told reporters Sunday.

"I gave a tremendous tax cut, and they're loaded up with money. They're buying. I saw the WalMart numbers, they were through the roof," he said.

"And most economists actually say that we're not going to have a recession. But the rest of the world is not doing well like we're doing."

His chief economic advisor Larry Kudlow also downplayed talk of a recession.

"I sure don't see a recession," he told NBC's Meet the Press.

"Consumers are working at higher wages. They are spending at a rapid pace. They're actually saving also while they're spending... So I think actually the second half, the economy's going to be very good in 2019," he said.

"We're doing pretty darn well in my judgment. Let's not be afraid of optimism."

The National Association for Business Economists (NABE) found far fewer experts now think the next recession will start this year compared to a survey in February.

NABE conducted its policy poll as Trump put the Fed under constant attack, demanding more stimulus, but before the central bank cut the benchmark lending rate on 31 July.

However, the Fed was already sending strong signals that it intended to pull back on the rate increases made in 2018 due to concerns starting to dog the economic outlook, including the trade war with China.—AFP

Tokyo stocks rise on hopes for overseas stimulus measures

TOKYO — Tokyo stocks rose Monday as hopes for stimulus measures signaled by China and Germany eased fears of a global economic slowdown.

The 225-issue Nikkei Stock Average ended up 144.35 points, or 0.71 per cent, from Friday at 20,563.16. The broader Topix index of all First Section issues on the Tokyo Stock Exchange finished 9.04 points, or 0.61 percent, higher at 1,494.33.

Major gainers included oil and coal product, securities house and bank issues. Shares were firm from the outset, with the Nikkei briefly gaining more than 200 points after hitting a six-month low late last week

Along with other Asian stocks, the Tokyo market was driven by optimism for new stimulus measures announced Friday by China, which it is hoped will restore growth that has been hurt by the U.S.-China trade dispute, dealers said.

China said it would introduce programs aimed at increasing disposable income for 2019-2020 as part of efforts to strengthen consumption.—Kyodo News

Sudan's Bashir got \$90 in from Saudi, investigator tells court

KHARTOUM (Sudan) — Sudan's deposed military ruler Omar al-Bashir has admitted to receiving \$90 million in cash from Saudi royals, an investigator told a Khartoum court on Monday.

Police Brigadier Ahmed Ali said at the opening of Bashir's corruption trial, which an AFP correspondent attended, that the former president told him that the latest payment was "delivered by some of Mohammed bin Salman's envoys".

Bashir, whose military Islamist regime ruled Sudan for 30 years, arrived at the Judicial and Legal Science Institute where the trial is taking place in a huge military convoy.

Inside the courtroom, he was sitting in a metal cage, unshaven and wearing a white traditional gown. His relatives in the courtroom chanted "Allahu Akbar" (God is greatest), to which he responded with the same words.

The former strongman was forced from power on 11 April after months of protests. A transitional constitution meant to guide Sudan towards civilian rule was officially signed on Saturday.

Bashir faces a raft of charg-

es of war crimes, crimes against humanity and genocide from the International Criminal Court over his role in the war in Sudan's western Darfur region.

However, the jailed leader appeared in court Monday on charges of receiving and possessing foreign funds illegally.

The police investigator told the court that nearly seven million euros (\$7.8 million) were found at Bashir's residence, as well as smaller amounts in US dollars and Sudanese pounds.

"The accused told us that

the money was part of a sum of \$25 million sent to him by Prince Mohammed bin Salman to be used outside of the state budget," Ahmed Ali said.

The investigator said Bashir had said he also received two previous payments of \$35 million and \$30 million from Saudi's King Abdullah, who died in 2015.

The investigator said Bashir had said the Saudi money was exchanged and spent and that he could not remember how nor did he have documents providing further details.—AFP

Britain's Prince Andrew 'appalled' by Epstein abuse claims

LONDON (United Kingdom) — Britain's Prince Andrew has said he was "appalled" by allegations of sexual abuse surrounding Jeffrey Epstein after a video was released purporting to show him at the home of the convicted paedophile in 2010.

"The Duke of York has been appalled by the recent reports of Jeffrey Epstein's alleged crimes," Buckingham Palace said in a statement on Monday.

"His Royal Highness deplores the exploitation of any human being and the suggestion he would condone, participate in or encourage any such behaviour is abhorrent," the statement said.

The grainy video published by the Mail on Sunday claims to show the prince waving goodbye to a woman as she leaves Epstein's New York mansion in 2010.

Epstein had pleaded guilty in 2008 to procuring for prostitution a girl under the age of 18 and served 13 months in prison before being released on probation.

The video was the latest in a string of revelations about Prince Andrew's friendship with Epstein in British tabloids.

The Mail on Monday said the prince had hosted Epstein at Balmoral, Queen Elizabeth II's home in Scotland, in 1999 at a time when the monarch may have been in residence. He also reportedly hosted Epstein at Sandringham, another royal residence in eastern England, a year later.

'Lurid details'

Epstein was found dead on August 10 in a federal jail in Manhattan as he awaited trial charged with one count of sex trafficking of minors and one count of conspiracy to commit sex trafficking of minors. A coroner ruled that he committed suicide by hanging.

Over the years, the financier hobnobbed with politicians, socialites and celebrities, including Donald Trump before he was president, and Bill Clinton. Virginia Giuffre — previously Virginia Roberts — one of Epstein's alleged victims, has testified that she was forced to have sex with Prince Andrew in London when she was 17. She said she had sex with him again in New York and on Epstein's private island in the Caribbean.—AFP

Iran warns US against seizing tanker

TEHRAN (Iran) — Tehran said Monday it has warned its arch-foe Washington against attempting to seize an Iranian tanker that has set sail from waters off Gibraltar after being impounded for six weeks.

Iran had been locked in a standoff with US ally Britain since Royal Marines seized the tanker off the coast of the British overseas territory Gibraltar on July 4 on suspicion it was shipping oil to Syria in breach of EU sanctions.

Little more than two weeks later, Iran's Islamic Revolutionary Guard Corps impounded the British-flagged Stena Impero tanker in strategic Gulf waters in what Britain called a tit-fortat move. A court in Gibraltar on Thursday ordered the release of the Grace 1, since renamed the Adrian Darya.

That was in spite of a last-minute US bid to detain the ship on allegations of involvement in supporting illicit shipments to Syria by the Guards, listed as a terrorist group by Washington.

Gibraltar's government re-

jected the request, saying it could not seek a court order to detain the supertanker because US sanctions against Iran were not applicable in the European Union. The tanker, flying the Iranian flag, departed on Sunday evening for the Greek port of Kalamata, according to shipping data.

But the final destination of the supertanker and its 2.1 million barrels of oil remains unclear, with authorities in Greece yet to confirm that it is expected to dock there.

'Bullying and unilateralism'

As it finally sailed east-ward on Monday, Iran said it had warned the United States through the Swiss embassy in Tehran, which represents US interests, against trying to seize it again. "Iran has given necessary warnings to American officials through its official channels... not to make such a mistake because it would have grave consequences," said foreign ministry spokesman Abbas Mousavi.

Speaking to reporters at a

news conference, he dismissed the notion that there was a link between the seizure of the Iranian tanker off Gibraltar and the British-flagged tanker in the Gulf.

"There is no connection whatsoever between these two vessels," said Mousavi.

"There have been two or three maritime violations made by that ship," he said, referring to the British-flagged Stena Impero held off the Iranian port of Bandar Abbas. "The court is looking into it. We hope the (investigation) is completed as soon as possible and the verdict is issued."

The Iranian spokesman said the Gibraltar court order for the release of the tanker was a blow to US "unilateralism".

"The Americans have not been very successful with their unilateral sanctions that have no legal basis. "They should come to their senses that bullying and unilateralism cannot get anywhere in the world today."

Mousavi urged other countries not to accept sanctions the United States has imposed on

Iran "because they're not legitimate and have no legal basis".

Iran to seek damages?

Iran's judiciary chief Ebrahim Raisi called for legal action to be taken against Britain over the ship's detention.

"Now following the release of the ship, the Islamic Republic of Iran should seek damages," he told state television. But despite the tanker's release, Iran still faced a dilemma over its ultimate destination and that of its oil, said Commerzbank analyst Carsten Fritsch. "The tanker was renamed... but the problem with US sanctions remains," he told AFP. "I don't see any buyer in the Mediterranean apart from the sanctioned regime in Syria.

"Returning to Iran will be difficult since it would need to make the whole trip around Africa."

In its decision ordering the release of the tanker, Gibraltar said it had received written assurances from Iran that the ship would not be headed for countries "subject to European Union sanctions".—AFP

Thousands riot in Papua, parliament building torched

MANOKWARI (Indonesia) Riots broke out and a local parliament building was torched in Indonesia's restive Papua region on Monday, as thousands protested against the weekend detention of dozens of Papuan students.

Demonstrators took to the streets of Manokwari, the capital of West Papua province, bringing the city of some 130,000 to a standstill as its civic building was nearly reduced to ashes.

Some protesters set fire to

shops and vehicles, knocked down street signs, and threw rocks at government buildings, according to an AFP reporter at the scene, who estimated several thousand demonstrators were present.

Indonesia's security minister Wiranto, who goes by one name, appealed for calm and said there would be an investigation of the incident that triggered the unrest in Manokwari as well as protests in several other Papuan cities on Monday. "This has clearly disrupted our unity as a nation," he said. The riots marked the latest flashpoint in a region hit by a decades-old insurgency against Indonesian rule and allegations that its security forces committed widespread rights abuses against its ethnic Melanesian population.

Papua shares a border with

independent Papua New Guinea (PNG), just north of Australia.

A former Dutch colony, it declared itself independent in the early Sixties, but neighbouring Indonesia took control of the resource-rich region following a UN-sponsored independence referendum that was widely viewed as a sham. In Manokwari, three police officers were injured by rock-throwing protesters, authorities said. It was not immediately clear if any demonstrators were injured. Local schools were shut for the day.

Anger boiled over at reports that authorities tear-gassed and detained some 43 Papuan university students in the Southeast Asian nation's second-biggest city Surabaya on Saturday — Indonesia's independence day.—AFP■

Empty classrooms as some schools re-open in Indian Kashmir

NEW DELHI (India) – Some Kashmir schools re-opened on Monday but were largely empty following weekend clashes in Srinagar, two-weeks after India removed the restive region's autonomy and imposed a lockdown.

The authorities said that they were re-opening 190 primary schools in the city yet few children could be seen at half a dozen places visited by AFP. –AFP ■

Bangladesh cabinet approves policy to feed 15 mln school children

DHAKA – Bangladesh's cabinet approved a proposal on Monday to feed 15 million children under a countrywide primary school meal program.

After the cabinet meeting with Prime Minister Sheikh Hasina in the chair, spokesman Mohammad Shafiul Alam told reporters that the cabinet gave its approval to the "National School Meal Policy 2019."

Under the program, students will get balanced meal five days a week and fortified biscuits every day.He said the meal program was aimed at boosting the nutritional needs of the children to improve attendance rates in rural areas.—Xinhua 🗏

17 injured as series of blasts rock Afghan eastern Jalalabad city

JALALABAD – At least 17 people have been injured as six explosive devices placed by militants went off in parts of Jalalabad city, the capital of eastern Nangarhar province, on Monday, provincial governor's spokesman Attaullah Khogiani said.

All the victims, some in critical conditions, are civilians, the official added. The blasts took place as the people of Afghanistan were celebrating 100th anniversary of their country's Independence Day amid tight security. –Xinhua

Singapore to bolster coastal defences against rising sea levels: PM

SINGAPORE — Singapore needs at least \$72 billion to build defences against rising sea levels, its leader said Sunday as the low-lying city-state gears up against the impact of climate change.

Prime Minister Lee Hsien Loong described climate change as "one of the gravest challenges facing humankind" and said the Southeast Asian country is already feeling the impact through a hotter weather and heavier rainstorms.

He devoted a large portion of a major policy speech late Sunday — which included initiatives on the economy and social issues — on how the city-state will tackle global warming.

"Because we are a low-lying island, Singapore is especially vulnerable to one grave threat, and that is rising sea levels," he warned.

City planners previously required buildings to be constructed at least three metres

(9.9 feet) above the mean sea level, leaving a one-meter buffer against flooding after high tide.

But if sea levels rise by one metre due to global warming, the buffer could be breached when heavy rains coincide with high tide, prompting the government to require new developments to be built four metres above sea level. Critical infrastructure like the Changi Airport's new Terminal 5 must be built five metres above sea level.

Lee cited findings by Singapore's Centre for Climate Research that the city-state, "is more vulnerable to climate change than the global model suggests" because it is near the equator. A key measure will be to build the island's coastal defences, he said.

One option is to learn from the experience of the Netherlands which reclaimed from the sea by building a seawall and then draining the water within

it to create dry land called "polders", he said.

"Polders are a serious option for us," the prime minister said, adding that Singapore will trial the process on a small

Another option is to reclaim "a series of islands offshore" and connect them with barrages to create a freshwater reservoir that can serve as a drainage for rainwater, he said.

The coastal defence infrastructure could cost the country at least Sg\$100 billion (\$72 billion) over the next 100 years, he said. "Because this is a 50 to 100-year problem, we can implement a 50 to 100-year solution,"

"We should treat climate change defence like we treat the Singapore Armed Forces — with utmost seriousness... These are life and death matters."—AFP■

Shan United wins MPT U-19 Myanmar National League 2019

THE Shan United F.C. have claimed their third MPT U-19 Myanmar National League championship title with 53 points from 16 wins, five draws, and one loss, according to the Myanmar National League website.

The team suffered their sole loss this season in the closing match against the Ayeyawady F.C. yesterday, when they were defeated by 1-0.

While the Yadanarbon F.C. and Yangon United F.C. tied with 49 points from 15 wins, 4 draws, and 3 losses, Yadanarbon was adjudged the first runner-up with 41 goal differences, and Yangon United was the second runner-up with 28 goal differences.

A ceremony to present the awards was held in conjunction with the season-closing match of the league yesterday at the Padonmar Stadium in

Former world cycling champion Dumoulin joins Jumbo-Visma

PARIS (France) — Former world champion Tom Dumoulin, second to Geraint Thomas in the 2018 Tour de France, joined Team Jumbo Visma on Monday, quitting Sunweb after eight years.

The 28-year-old Dutchman, who was forced to sit out this year's Tour de France with a knee injury, had two years to run on his Sunweb contract.

Jumbo-Visma said its goal was to win a Grand Tour with Dumoulin, a former Giro winner, in its ranks for the next three years.

"I'm looking forward to contributing to that goal, winning a Grand Tour", Dumoulin said on his new team's website.

Earlier, Sunweb announced the 2017 world champion was quitting the team "after an incredible eight-year journey filled with countless successes..."

Dumoulin was forced to sit out this year's Tour de France due to an injury that cut short his Giro challenge. While away from the action he began to think about his future and the "great" offers coming his way.

"After the disappointment of missing the Tour and finding myself sitting at home, I started to consider that a new environment could be refreshing," he said.

"There were great offers and this phase of my career felt like the right time to take it."— AFP
