Constitution amendment bill sent to Pyidaungsu Hluttaw for second time

ATTHE 24th meeting of the Second Pyidaungsu Hluttaw's 13th regular session yesterday, the Speaker informed the Hluttaw about the receipt of the bill to amend the Constitution for the second time and the formation of a joint committee to study the bill. Copies of the letter and the bill were then distributed to the Hluttaw representatives.

Bill Amending the Constitution for the second time

Pyidaungsu Hluttaw Speaker first informed the Hluttaw of the receipt of a bill amending the Constitution for the second time signed and submitted by 144 Tatmadaw Hluttaw representatives including Pyithu Hluttaw Tatmadaw representative Brig-Gen Maung Maung on 10 September 2019. As per Pyidaungsu Hluttaw Rule section 135, a Joint Committee to Study the Bill to amend the Constitution for the second time was formed consisting of all committee members of Pyithu Hluttaw and Amyotha Hluttaw Bill Committees with Pyidaungsu Hluttaw Office Notification 69/2019 on 17 September 2019. A copy of the draft bill and the letter sent were being distributed to the Hluttaw representatives, said the Pyidaungsu Hluttaw Speaker.

The aim was for all students in basic education schools to have access to quality education, create learning opportunity for out-of-school school-age youngsters and to strengthen financial and management abilities.

The program duration was for four years and the program value total US\$ 180 million of which \$ 100 million was World Bank loan, \$ 70 million was a grant from Global Partner for Education and \$ 10 million was a grant from European Union, said the Union Minister.

By conducting the program the capacity of the teaching staff and personnel will be strengthened in addition to enabling transparent management of human resources and public finances. Basic Education Department had prepared school quality assurance norm index in cooperation with World Bank and development partner organizations and will draw up school development program according to the index and raise the quality of the schools.

School maintenance program for the most required schools will also be conducted as part of the program. By conducting on job training courses for teachers, access to quali-

ty education program will be strengthened and increased for all children. While efforts were made to reduce drop-outs from schools, quality out-of-school education will be provided to about 77,000 out-of-school school-age youngsters by the program.

The loan is a 30 years development loan with a grace period of 5 years. Loan repayment period is 25 years with 3.3 per cent of the total loan being paid back annually. SDR service fee and interests were 0.75 per cent and 1.25 percent respectively

explained the Union Minister in order for the Hluttaw to approve the \$ 100 million loan from World Bank IDA.

Deputy Minister for Planning and Finance U Maung Maung Win explained that the program was in accordance to Fiscal Year 2018-2019 Union Budget Law, Public Debt Management Law, 2018 Mid-term debt management strategy and policy on development aid. Furthermore it was also found to be in line with Myanmar Sustainable Development Plan (2018-

2030) strategy 4.1. The Deputy Minister concluded by requesting the Hluttaw to discuss and approve the loan.

Following the explanation by the Union Minister and the Deputy Minister, the Pyidaungsu Hluttaw Speaker announced for Hluttaw representatives who want to discuss the matter to register their names.

New Tree Species Protection Bill approved

Joint Bill Committee Secretary Dr Myat Nyana Soe then tabled a motion to approve by clauses the New Tree Species Protection Bill in which the two Hluttaws were in disagreement. After discussion by Hluttaw representatives and obtaining the opinion of the relevant ministry and the Hluttaw representatives, Pyidaungsu Hluttaw Speaker announced the approval of the bill.

UNION Minister for Labour, Immigration and Population U Thein Swe attended the 3rd Labour Ministerial Conference on labour cooperation among the five CLMTV countries, which was held in Siem Reap, Cambodia, yesterday.

The event was organized under the theme of 'Toward the Protection of Migrant Workers in the CLMTV Countries: Cooperation in Social Security'.

With the opening speech delivered by Cambodian Prime Minister Samdech Akka Moha Sena Padei Techo Hun Sen, the event was attended by the labour ministries from Cambodia, Laos, Myanmar, Thailand and Viet Nam, as well as the representative from ASEAN Secretariat.

Cambodian Minister of Labour and Vocational Training Ith Sam Heng presided over the meeting where Union Minister U Thein Swe and labour ministers from Laos, Thailand and Viet Nam delivered speeches.

The conference agreed on the endorsement of the Siem Reap Declaration on Roadmap toward the Labour Ministerial Declaration on the Portability of Social Security Schemes in the CLMTV countries, and the joint statement of Labour Ministers on the outcomes of the 3rd Labour Ministerial Conference.

On 16 September, the 5th Senior Labour Officials meeting was attended by Myanmar delegation led by the Director-General of Labour Department. The delegates from CLMTV countries discussed the portability of social security schemes.

The 2nd CLMTV Ministerial Conference on Labour Cooperation was held on 1 and 2 August in 2017, under the theme of "Promoting human resource development and decent work for migrant workers." At the conclusion of the meeting, the CLMTV ministers endorsed a joint declaration on migrant labour safety.

With this declaration, the ministers affirmed the nine commitments to further promote regional cooperation in order to better manage migration labour through a number of priority areas for the 2018-2020 period, including social security mobility; pre-departure training and mobility of skills recognition; fair recruitment and guidance from the International Labour Organisation; standard labour contracts; and the welfare fund.

During the visit in Cambodia, Union Minister U Thein Swe held discussions with Cambodian Minister of Labour and Vocational Training Ith Sam Heng about closer collaboration in labour affairs. — MNA

NRPC holds peace dialogue with ethnic armed groups in Kengtung

HE government's National Reconciliation and Peace Centre (NRPC) and representatives of the four groups KIO (Kachin Independence Organization), MNTJP (Myanmar National Truth and Justice Party), PSLF (Palaung State Liberation Front) and ULA (United League of Arakan) met at the Amazing Kengtung Resort in Kengtung (Shan State) yesterday morning to discuss signing of the Bilateral Cease-fire Agreement.

Union Attorney-General U Tun Tun Oo, in his capacity as the vice chairman of the NRPC, extended his greetings saying that the meeting was a significant event for the peace making process, and that discussions had been made during the previous occasions in Kengtung for the future ceasefire plan.

During that meeting, both sides thoroughly discussed to stop recent armed conflicts. As a result, the attacks had significantly become fewer along the Union Road despite small remaining clashes in some areas. The three northern ethnic armed groups made a ceasefire announcement as proposed by the government. This situation was recognized as a progress in the ongoing ceasefire attempts. Both sides need to maintain this momentum.

The government discussed the draft proposal of the northern four ethnic armed groups to sign the bilateral ceasefire agreement. Although there were no notable controversies, there were still pending issues on monitoring processes. He was hopeful that this agreement would be signed after both sides had reached agreement.

The unilateral ceasefire announcement by the Tatmadaw would expire on 21 September.

The NRPC vice chairman also urged the representatives of armed groups to bring about a ceasefire agreement as the people across the country were worrying about the results of this meeting.

He also remarked that the peace process would include signing the preliminary bilateral ceasefire agreement with the four northern armed groups in this first stage, and to proceed for making detailed agreements with each individual group. The next step would be the discussions for Nationwide Ceasefire Agreement. After these stages, the political dialogues will be

held with the participations of all four northern armed groups in accordance with the roadmap based on the results of the peace talks.

The peace process for northern Myanmar was very important at the moment. Dialogues need to be held very frequently to build mutual trust.

The government was also preparing for holding the fourth session of the Union Peace Conference-21st Century Panglong with the NCA signatories before the 2020 General Election. This session was expected to finalize political agreements in building the Democratic Federal Republic, agreements on lasting ceasefire, agreements on basic principles on democracy and federal system, ongoing plans beyond 2020, and implementation procedures.

In adopting the peace process beyond 2020, the ideas of the four northern armed groups were seriously taken into account as the government has recognized that the northern armed groups played crucial role in adopting the future peace process.

Recognizing the seriousness of the meeting, the government side was represented by NRPC members, Lieutenant Generals from the Tatmadaw, Vice Chairman of the Peace Commission, its secretary and members.

KIO General Secretary Kumhtat Hting Nan said that he recognized the development of the fourth meeting due to participation of senior Tatmadaw officers to be able to make wider discussions.

He also said the four northern armed groups welcomed the agreements of NRPC on their draft proposal in the previous meeting, and that it had been a driving force for the progress of meeting. The four armed groups were willing to continue the peace talks without prior conditions. The remaining issues were to be discussed in accordance with the dialogue plan for stronger ceasefire agreement. He added that the four armed groups have reviewed the draft proposal.

Hopefully the participation of senior Tatmadaw personnel would reduce conflicts between the Tatmadaw and the armed groups on the ground, and it was hoped that harsh condemnations of each other would not be made. It was hoped that constructive talks would be made to solve problems.

Then, the representatives discussed the draft Bilateral Ceasefire Agreement in detail.

The meeting was attended by Vice Chairman of NRPC and Union Attorney-General U Tun Tun Oo, Lt- Gen Yar Pyae, Lt-Gen Min Naung, Lt-Gen Tin Maung Win from the Office of the Commander in Chief (Army), Vice Chairman of the Peace Commission U Thein Zaw, its Secretary retired Lt-Gen Khin Zaw Oo, member of Advisory Board for Peace Commission U Moe Zaw Oo, Shan State government's Security and Border

Affairs Minister Colonel Hla Oo, Director-General U Zaw Htay from Ministry of the Office of the State Counsellor, Secretary of Stan State government U Soe Soe Zaw and peace negotiator U Thet Naing.

From the EAOs side KIO representative head KIO general secretary, MNTJP representative group head, ULA representative head ULA secretary general and PSLF representative group head PSLF General-Secretary attended the meeting. Peacetalk Creation Group (PCG) representatives also attended the meeting as observers.

NRPC representatives and representatives of four EAOs had met in Muse on 30 April, Mongla on 30 June and Kengtung on 31 August for the Bilateral Cease-fire Agreement and this was the fourth meeting.

After the day's meeting between NRPC and KIO, PSLF, MNTJP, ULA representatives, the heads of the two sides signed a 7 points meeting minutes.

In his concluding remark at the end of the meeting PSLF representative head General Secretary Tar Bone Kyaw said the day's meeting held for the second time in Kengtung brought many expectations for peace. Many tea breaks were taken and discussions were intense. Even though some expectations for peace that were hoped for were not achieved, some good results had been achieved. In their opinion agreeing to discuss again another time, agreeing on

a work process to achieve a true ceasefire and sign an agreement could be regarded as good results. However, thinking back, leaders from both side need to work towards freeing the people from the damage caused by conflict. Tatmadaw leaders attended the meeting together with NRPC. He added that even though there were conflicts at lower levels, they were able to hear the leaders speaking their minds and thought this was a good basis to stop the war.

Afterwards, Vice Chairman of NRPC and Union Attorney-General U Tun Tun Oo said the last Kengtung meeting discussed the proposal of the four groups and that the day's meeting continued with further discussions and coordination efforts were made. Agreements reached were issued as meeting minutes. Discussions were made point by point based on the meeting minutes and agreement was reached to meet again in October to discuss signing of the bilateral agreement, ending the ongoing fighting, IDP matters, troop deployment, ending the seizing of personnel and finding conflict resolution methods. Efforts would be made towards signing an agreement, said the NRPC vice chairman.

After the meeting, Director General U Zaw Htay from the Ministry of the State Counsellor's Office held a press conference with local and foreign news media. — Ye Khaung Nyunt

Helping farmers produce safe products, reaching markets is sine qua non

HE setting up of trading centres in townships, on the lines of farmers markets, is a step towards establishing a farmers' market system, which can boost the economic and environmental sustainability of local agriculture.

The Ministry of Commerce has established trading centres in regions and states where local farmers can trade their produce. The centres are similar to farmers markets, and so far, 65 centres have been set up in Yangon, Ayeyawady, Bago, Sagaing, and Magway regions, and Shan, Mon, Kachin, Kayah, and Rakhine states.

The trading centres can be considered as links between producers and consumers in a direct market, and through such direct engagement between farmers and consumers, farmers can become more willing to reduce chemical inputs to meet customer demand.

To ensure that both consumers and farmers benefit from the system, arrangements must be made to fix basic prices for agricultural and livestock products, and to improve production chains to ensure food safety.

In the current situation, there may be barriers to the establishment of a farmers' market system, such as lack of adequate funding, staffing, information, energy and waste diversion infrastructure, and sustainable packaging and collaboration...

The ministry, on its part, is making arrangements to provide farmers with quality seeds, good breeds of livestock animals, technology, and to help them be competitive in the market. It is also conducting government-to-government negotiations to expand the export market.

To establish a farmers' market system, farmers' organizations need to be formed, which can control the market. Farmers' groups play a key role in operating a farmers' market system.

At the moment, the Union Government is supporting farmers to make sure that they have the capability for cooperative work and corporate investment. Only then can they form such farmers' groups.

Post-harvest infrastructure, such as storage and distribution facilities, is vital to a farmers' market, according to the current market-oriented economic system. To implement the farmers' market system, we need time and space to improve such facilities and to encourage practices which can enable a sustainable market situation.

For local development and to solidify community pride in the quality of locally grown products and livestock products, we need to encourage a farmers' market system.

We welcome the motion tabled before the Pyithu Hluttaw for setting up a farmers' market system.

In the current situation, there may be barriers to the establishment of a farmers' market system, such as lack of adequate funding, staffing, information, energy and waste diversion infrastructure, and sustainable packaging and collaboration, all of which make it difficult to understand and implement circular economy practices at a citywide level.

However, we must not lose sight of our ambition of establishing a farmers' market system, and we must work towards this goal step by step.

Can we turn suspended factories into engines of national economic growth?

TEEL is an essential material in the industrial products and in building infrastructures. If Myanmar can produce steel on commercial scale, we will be able to save our foreign exchange used in importing steel products and build an industrialized country. In fact, the country has large deposits of iron ore.

Myanmar set up steel mills for the said purpose in the past but they were not successful as they cannot compete with their foreign counterparts in quality, price and designs. They also faced high production costs, dwindling production capacity and financial losses. Hence, the country had to stop them all.

The suspended No. 1 Steel Mill was set up with a total capital of K 1795505 million and Euros 1054 million in Myingyan in the central part of Myanmar. The annual expense for monthly salaries of 828 in-service employees and six retired persons is over K 1805 million. So the suspended mill showed a loss of over K 25090 million in fiscal year 2017-2018.

So the fourth regular session of the second Pyidaungsu Hluttaw approved the suspension of 2 steel mills and other 22 factories that are showing losses annually for five success years. The Ministry of Industry owned 112 factories and workshops and of them, 57 are private-government joint-ven-

tures, 31 are operating under the ministry and 24 are suspended factories.

"These factories are showing annual loses as their production cost are high and their products are not competitive in the market. Besides, they have the expenditure for employee salaries, maintenance cost, and interest for foreign loans. So, they are facing losses annually," said MP U Aung Kyaw Kyaw Oo.

The Ministry of Industry showed a loss of K 89741 million in fiscal 2015-2016, K 94850 million in 2016-2017, and K 66266 million in 2017-2018. The 24 suspended factories of the ministry have 6698 employees and the Union is spending Ks 1243 million annually from its coffers to pay their

salaries

Because of the long-term termination of operations, factories are facing wear and tear while the Union is facing financial losses. Moreover, morale of employees is falling and the industrial sector is facing s sharp drop in production. At the 13th regular session of the second Pyithu Hluttaw, MP U Bo Gyi of Chauk Township Constituency submitted a motion, suggesting joint-venture and privatization programs for the suspended factories of the government as a means to reduce the unnecessary expenditure of the Union and if possible to gain profits.

"Although the cost of loan interest payments, salary payments, production and maintenance expense are high, the fac-

tories are operating at a loss. As a transparent means to turn them into profitable businesses has not yet seen, I have presented this proposal," he explained.

Other MPs held discussions in support of the motion. As regards the motion, Deputy Minister for Industry Dr. Min Ye Paing Hein promised the adoption of definite and clear policies and procedures in finding the best privatizing and joint-venturing means for the suspended industries.

After studying the factories operating under joint-venture programs, the ministry would try to seek ways to serve the interest of the country best, the deputy

Public-Private Partnership (PPP) Center to assess the possible areas where privatization process can yield profitable results. It will sell the factories that are not economically viable," he said.

The Lower House than passed the motion.

"We should seek new and innovative ideas, instead of out-of-date or conventional means for this privatization project. We should make assessment of the situation from the technological, financial and economic points of view in adopting feasible means to lessen losses by cutting unnecessary expenses and turn unprofitable factories into profitable

minister assured, and added that the Industry Ministry would cooperate with the relevant organizations including the Ministry of Planning and Finance in effectively managing and settling the issue of domestic and foreign loans.

"The Industry Ministry will join hands with Project Bank and

We must take into account economically viable means, market-friendly ways as the flourishing of industries will generate jobs and income of the people, and finally towards the national economic growth. What's more, we can create a pleasant environment for our people alongside the rise in exports and per capita income, said MP U Kan Myint.

Seven points agreed during ceasefire talks in Kengtung

SEVEN points were agreed between the government's National Reconciliation and Peace Centre (NRPC) and four ethnic armed groups — KIO (Kachin Independence Organisation), MNT-JP (Myanmar National Truth and Justice Party), PSLF (Palaung State Liberation Front), and ULA (United League of Arakan) during ceasefire negotiations yesterday in Kengtung, Shan State.

Following the meeting, the Director General of the Office of the State Counsellor, U Zaw Htay, who participated in the talks, held a press conference.

"Seven points were agreed during today's talks. Roughly, both sides have agreed to sign the bilateral ceasefire agreement, and discuss ways for ending the current armed conflicts and tackling the internally displaced persons (IDP) issue. Besides, they have agreed to hold talks again with the Tatmadaw over designating ceasefire rules to be followed by both sides," he said. He continued to say the two sides have also agreed establishing communication offices to avoid further clashes, no arrests from both sides for building mutual trust and a common plan for NCA, making acceptable dialogues from both sides for stronger ceasefire agreement, and another meeting in October

The government has planned to hold the NCA anniversary, and making discussion about resuming 21st Century Panglong. The UPDJC Secretarait will have an oversea trip. And that we will choose an appropriate timing for the next meeting amidst the above-mentioned schedules. In brief, we could made the seven agreements in this fourth peace dialogue.

We issued a joint statement after the previous meeting. As we could make some agreements through serious discussions, this dialogue has positive results. Through frequent meetings, it is hopeful that we have obtained mutual understanding, and the discussions were very friendly and frankly.

As both sides are genuinely trying for a halt of armed clashes in northern Shan State and the emergence of a lasting ceasefire agreement, it is very optimistic about getting better results in upcoming dialogue in near future.

When Director-General U Zaw Htay replied to the answers of media persons, he said that the government was ready to sign a bilateral agreement. If a representative of respective armed group did not have a mandate to do it when they came to the dialogue, they could go back to Mongla for getting approval from their headquarters while we would be waiting for them in Kengtung. However, the four northern armed group just agreed on the meeting minutes as their headquarters did not give them a mandate to sign bilateral agreement. These points are also some parts of bilateral agreement. If they received a clear mandate, it is hopeful to sign the agreement. Therefore, these representatives will report back to their headquarters, and agreed the developing points in the meeting minutes. A wide range of discussions resulted in broader agreements.

In replying to a question about discussion on reducing armed conflicts included in the Bilateral Ceasefire Agreement he told of requiring an agreement on ending armed conflict. Arrangements were made to cease firing on a certain date but the four northern groups were not ready to sign it so it was kept as an agreement reached at the meeting.

On the matter of monitoring committee included in the Bilateral Ceasefire Agreement U Zaw Htay said the latest agreement was on conflict resolution, how to resolve dispute between the two groups. It was not about monitoring. It was conflict resolution during the interim period like how to resolve dispute on deployment of forces said U Zaw Htay. On the question of whether there'll be an extension of Tatmadaw's ceasefire that will end on 21st September, he responded in a positive manner saying Tatmadaw representative group led by Lt-Gen Yar Pyae will be reporting to Commander-in-Chief of Defence Service.

With regards to preparation made by the government to prevent harms to the people if discussions didn't go well he replied that peace could not

be achieved by one side only. A will from all side was required, and said Tatmadaw representative group offered to discuss with the four northern groups individually and discuss what was needed by each group. But the other side didn't have the mandate to do that. This side made efforts to avoid conflicts. Agreement to prevent conflict was required and this side made an effort toward that end. While having Tatmadaw representative group was present an approach was made for AA and TNLA to have a separate meeting with the Tatmadaw as the discussion would be effective and an offer was made, said U Zaw Htay.-

Myanmar's FDI inflows touch \$4.3 bln

DURING the eleven-and-a-half months from October to mid-September in the current fiscal year, foreign direct investment of US\$4.3 billion flowed into the country, including capital expansion by existing enterprises, according to the Directorate of Investment and Company Administration.

The total figure includes investment of \$362 million in the Thilawa Special Economic Zone.

The Myanmar Investment Commission has set an FDI target of \$5.8 billion for the current FY. However, only \$4.3 billion has flowed into the country in the past eleven-and-a-half months, according to the DICA.

In a press statement, the DICA has stated that 262 foreign enterprises obtained MIC permits and endorsements from regional and state investment committees between 1 October and 14 September in the current fiscal, bringing in a capital of \$2.59 billion. Singapore-listed enterprises were the largest investors during the October-September period, followed by China and Hong Kong.

Transport and communications absorbed over \$1.5 billion in FDI, topping in the investment sector line-up, followed by the manufacturing sector.

In the 2018-2019 fiscal year, foreign investments have flowed into agriculture, livestock, manufacturing, power, transport and communications, hotels and tourism, real estate, industrial estate, and other services sectors.

Under the Myanmar Investment Law, the Region and State Investment Committees are allowed to endorse local and foreign proposals, where

the initial investment does not exceed K6 billion, or \$5 million.

This is aimed at simplifying the verification process of invest-

ment projects.

Manufacturing exports up \$1.67 bln

EXPORTS of finished industrial goods touched a high of US\$9.3 billion between 1 October, 2018 and 6 September, 2019 in the current financial year, an increase of \$1.67 billion compared with the corresponding period of the previous fiscal, according to the Ministry of Commerce.

As per figures provided by the Ministry, the exports of finished industrial goods totaled \$7.6 billion during the same period in the 2017-2018FY.

Myanmar's manufacturing sector is largely concentrated in garment and textiles produced on the Cutting, Making, and Packaging basis, and it contributes to the country's GDP to a certain extent.

The CMP industry has emerged as a very promising one in the export sector. The value of CMP exports was just \$850 million in the 2015-2016 fiscal year, but it tripled within two years to reach \$2.5 billion in the 2017-2018FY, as per figures provided during the Myanmar Global Investment Forum 2018, held on 12 September.

In the last mini-budget (April-September, 2018), exports of clothes produced under the CMP system were valued at \$2.27 billion.

Japan is the largest market for Myanmar apparel, followed by the European Union.

There are currently over 400 garment factories in Myanmar, which employ more than 300,000 workers. Investors prefer to invest in cheap-labor countries like Myanmar.— GNLM

Natural gas exports reach \$3.5 bln in Oct-Aug

MYANMAR'S exports of natural gas as of August-end in the current financial year amounted to US\$3.5 billion, an increase of \$430 million compared with the corresponding period of the previous fiscal, according to the Commerce Ministry.

The increase in the value of exports is linked to the rise in the price of natural gas in the global markets, according to an expert.

Natural gas is included in the list of major export items of Myanmar. Over 20 per cent of the country's total export earnings come from the sale of natural gas.

The Shwe natural gas field, located offshore from Rakhine State, was discovered in 2014. Natural gas extracted from the field is exported to China.

The Yadana natural gas project is being carried out by the TOTAL Company, with its pipeline supplying natural gas to Thailand. Natural gas is also extracted in Yedagon, located offshore from Taninthayi and discovered in 1992. The Zawtika Project in the Gulf of Moattama mainly

supplies natural gas to neighboring Thailand.

Production at Yadana and Yedagon is declining, and those projects will be halted in the coming years.

According to the second five-year National Development Plan (from 2016-2017 to 2020-2021), the Yadana, Yedagon, Zawtika, and Shwe gas projects are expected to collectively produce over 630 billion cubic feet of natural gas in the 2019-2020 fiscal year. — Ko Htet

Logistics hub planned on Yangon outer circular road: Minister

A TRUCK terminal yard or logistics hub is likely to be developed on the Yangon outer circular road once the traffic congestion caused by trucks in the city is eased, said U Myint Thaung, the Yangon Region Minister for Planning and Finance.

The minister made the remarks in response to a question raised by U Kyaw Min Han, a Region Hluttaw representative from Latha Township Constituency 2, at the first day meeting of the second Yangon Region Hluttaw's 10th regular session. U Kyaw Min Han had asked whether there are any plans to implement a logistics hub to ensure smooth freight transport and create jobs for Yangon residents.

"Highway freight forwarders

transport goods using 12-, 10-, and 6-wheeled vehicles. Goods imported by the private and public sectors through the sea channel are kept in warehouses in Sule jetties and private port terminals, and then, they are delivered to Yangon and other regions and states. Players in the road transportation sector use 22-wheeled trucks, 12-wheeled trucks, and six-wheeled trucks to carry the goods to factories or Bayintnaung terminals. At present, factories in Hlinethaya, Shwepyitha, Mingaladon, South Dagon, and East Dagon industrial zones are distributing the goods. In addition, the Bayintnaung terminal cannot accommodate all the trucks and the concerned trade body is discussing this with the Myanmar Highway Freight Transportation Services Association. After we

reduce the numbers of trucks entering and exiting the city, we will implement a trucks terminal yard on the Yangon outer circular road. The implementation of a logistics hub will help create job opportunities and improve the SME sector as well," said U Myint Thaung.

U Kyaw Min Han from Latha Township Constituency 2 suggested inviting local and foreign investors for developing international standard warehousing facilities.

"The development of a logistics industry can help control commodity prices, ensure smooth trading, reduce production costs, and support SMEs,"

"While sending goods into Yangon city, placing central warehouses on the outside of Yangon

city, forwarding goods to warehouses of respective townships using small express vehicles, and then delivering the goods door-to-door to customers will facilitate shipping and handling of goods. Hopefully, it will also help reduce traffic congestion caused by heavy trucks," said U Kyaw Min Han.

The country's freight transport is moved by air, water, road, and rail. In the 2017-2018 fiscal year, rail freight volume was estimated at 526,100 tons, while over 533,400 trucks, trailers, and threewheeled vehicles were used for road freight services. Inland water transport carried 422,135 tons using 12 state-owned ferries and 336 private vessels, while domestic airlines transported 1,372 tons

Apple embarks on EU court battle over €13b tax bill

LUXEMBOURG — Apple embarks on an epic court battle with the EU on Tuesday fighting the commission's landmark order that the iPhone-maker reimburse Ireland 13 billion euros (US\$14 billion) in back taxes.

Lawyers for the world's biggest company

will face EU officials in a Luxembourg court, challenging a decision that CEO Tim Cook slammed at the time as "total political crap". The European Commission's conclusion was delivered in August 2016 by Competition Commissioner Margrethe Vestager, a shock decision that put

Europe at the forefront of an emerging effort to rein in the power of US big tech. The two days of hearings on Tuesday and Wednesday will take place at the EU's lower General Court, where judges will give their judgement no earlier than 2020.

Any appeal would then go the EU's highest court,

the European Court of Justice, for a final decision that could land as late as 2021.

The EU accuses Apple of parking untaxed revenue earned in Europe, Africa, the Middle East and India, in Ireland, which has emerged as a European hub for big tech and global pharma giants.—AFP



German payment provider Wirecard enters global partnership with China's UnionPay

BERLIN — German payments company Wirecard has signed a memorandum of understanding (MoU) with UnionPay, the world's largest credit and debit card scheme, to "form a global strategic partnership," Wirecard announced on Monday.

The cooperation of the two financial service companies is set to "expand the global acceptance of UnionPay as a digital payment method across all channels," according to Wirecard. "As the world's largest card scheme in terms of card issuance, UnionPay will be one of our key alliances in Asia," said Georg von Waldenfels, executive vice president of Wirecard's business development division. According to the Nilson Report, a US publication that tracks the global credit card industry, UnionPay has issued a to-

tal of 7.59 billion payment cards, accounting for 57.6 per cent of all cards in circulation worldwide.

Wirecard announced that the partnership was envisaging a number of projects, such as payout products, fast digital payment services for businesses as well as consumer-oriented products like digital wallets for tourists in China.

In a first step, Wirecard and UnionPay are plan-

ning to launch additional projects in markets where the two companies already work together, such as in the Asia-Pacific region, Europe as well as the United States, according to Wirecard. "Through our global strategic partnership with Wirecard, we plan to continue driving our international expansion forward," noted Larry Wang, vice president at UnionPay International.—Xinhua

Myanmar attracts FDI worth US\$ 4.1 bln in 11 months

HE foreign direct investment in Myanmar during this fiscal year totaled more than US\$ 4.1 billion in the current fiscal year, according to a source from the Myanmar Investment Commission (MIC). The MIC greenlighted 252 foreigner-invested projects that are valued at over US\$ 2.55 billion and can create 135,000 job opportunities for Myanmar citizens from 1 October 2018 to 5 September 2019.

"The foreign investment permitted by the MIC in the financial year 2018-2019 under the Special Economic Zone Law reached US\$ 223.680 million. So the MIC approved foreign investment projects worth US\$ 4.1 billion during the period from 1 October 2018 to 5 September this year", said UThant Sin Lwin, Acting Director-General of the Directorate of Investment and Company Administration under the Ministry of Investment and Foreign Economic Relations. Similarly, the MIC gave the green light to 152 Myanmar citizen-invested projects valued at more than Ks. 1,116,619 million and US\$ 335.834 million, creating more than 17,000 job

opportunities for Myanmar people. Hence the investment volume by Myanmar citizens saw Ks. 1,373,619 million and US\$ 425.501 million.

The majority of the foreign investment flowed to manufacturing, transport, communications, tourism, agriculture, electricity generation, and industrial sectors.

The government believes that the foreign direct investment is a key drive for economic growth and is committed to an open, fair and clean investment policy.

The DICA has been cooperating with NGOs and INGOs so as to lure foreign direct investments to the country by organizing seminars, investment and business forums under the Myanmar Investment Promotion Plan (MIPP) which aims

to attract FDI worth US\$ 200 billion over the next 20 years. Arrangements are being made to attract more foreign direct investments in the industrial sector that can create more job opportunities for Myanmar citizens under the MIPP.

The MIC expects that the country will receive more foreign direct investment in the years to come. Under the Myanmar Investment Law, foreign investors can lease land from the government for 50 years.

FDI inflows to the country contribute to the creation of job opportunities for local people, help their income increase and promote their socioeconomic status.

The MIC OK'd the investment projects worth more than US\$ 200 million and Ks. 25 billion during its monthly meeting held in Yangon on 31 August. The meeting was attended by the Chairman of the MIC and Union Minister for Investment and Foreign Economic Relations U Thaung Tun and nine commission members. The MIC approved six projects in the real estate sector, livestock and fisheries sector and agricultural sector during in the meeting.

The investment projects permitted by the MIC during the meeting including the amount of increased investment were valued at US\$ 214.223 million and Ks. 25,733 million, creating 374 job opportunities for Myanmar citizens.

The Yangon Region Investment Committee also gave the green light to 10 foreign investment projects from China, Hong Kong and British Virgin Islands on 28 August. These investment projects are worth US\$ 10.655 million and come to the industrial sector, creating 4268 job opportunities for Myanmar people.

A total of 1,779 foreign enterprises from 50 countries around the world were allowed to invest in 12 sectors, with the total amount of US\$ 81,249.193 million during the period from 1988 to the end of July 2019.

Singapore and China were the largest foreign investors in Myanmar, with both countries channeling more than US\$ 1.3 billion and around US\$ 350 million into the projects in the Southeast Asia country.

The largest sector was oil and gas sector, accounting for 27.5 per cent of the total foreign investments, followed by the power sector with 26.07 per cent and the manufacturing sector with 13.94 per cent.
