The meeting focused on promotion of bilateral relations and friendship between Myanmar and Japan, promotion of cooperation between the two parliaments, to assist in promoting bilateral economic cooperation including the Thilawa industrial zone, the status of plantation of cherry trees in Myanmar with the management of JMPFA to mark the friendly relations between Myanmar and Japan and future plans of the association in Myanmar. The meeting was also attended by Union Minister U Kyaw Tint Swe, Deputy Minister U Set Aung, Myanmar Ambassador to Japan U Myint Thu and officials.

Then, the State Counsellor met with King Jigme Khesar Namgyel Wangchuck, of Bhutan at the same venue. During the meeting, they discussed promotion of friendly relations and cooperation, development and conservation of culture and traditions and exchange of visits between the two countries.

The meeting was also attended by Union Minister U Kyaw Tint Swe, Deputy Minister U Set Aung, and Permanent Secretary of the Ministry of Foreign Affairs U Soe Han. In the afternoon, the

THE government will hold the anniversary of the Nationwide Ceasefire Agreement next week in Nay Pyi Taw.

Eight ethnic armed groups signed the NCA on 15 October 2015, followed by the two groups on 13 February 2018. The government has organized the anniversaries of the NCA every year to honour the historic achievements in the peace-making process of the country.

Union Minister Dr Myint Htwe presided over the meeting and said to make appropriate plans for the development of health in Rakhine State by reviewing the needs and situations in skills, social, administration and management in cooperating with relevant departments and ministries. He also called for a coordination between the local government and the Department of Public Health of the Rakhine State.

The Union Minister also suggested social conflicts, instability, security and volatile situations need to be considered in carrying out healthcare services in Rakhine State; deficiencies and challenges could be identified by holding discussions at the camps to be able to adopt proper plans as he quoted the concept of 'Health as a Bridge for Peace' for stability of Rakhine State.

The Union Minister pointed out the important role of mobile clinics for temporary rescue camps and remote areas in Rakhine State.

According to the Myanmar Micronutrient and Food Consumption Survey (MMFCS) (2017-2018), malnutrition is mostly found at women and the under-five children in Rakhine State.

Dr Myint Htwe also appraised health workers and physicians for their efforts to overcome various challenges in the State. He also pledged to fulfill the function of health sector development in Rakhine State.

Then, Rakhine State Social Minister Dr Chan Thar presented the works of local government for health sector, their challenges and difficulties.

Dr Nyan Win Myint, the Deputy Director of Central Epidemiology Unit of Department of Public Health, discussed preparations in repatriation programmes in Maungtaw and healthcare services for the returnees to the area. — MNA

Myanmar to grow Chinese strain of paddy on trial basis to boost exports

TO ship about one million tons of rice to China annually, the Myanmar Rice Miller Association is planning to get paddy seeds from China and cultivate them in Myanmar on a trial basis.

"Our market in China is just for raw rice. China really needs fine rice for cooking and baking. We still can't export fine rice because we don't have a brand. We are teaming up with millers, farmers, and merchants to produce a brand that they desire by getting paddy seeds from them," said U Kyaw Win, the chairman of the Myanmar Rice Millers Association.

Under a similar arrangement, China purchases about 1 million tons of rice from Vietnam every year, according to reports.


"We can ship one million tons of rice per year if we can grow these seeds all over the country," said U Kyaw Win.

According to reports, the seeds can only be grown in cold weather, and only for two years, if cloned. Rice grown from the seeds is of fine quality and does not go soft within 24 hours of cooking, according to the association.

"The new strain of rice will be grown in Myanmar under the name 'Nathame' and will be tested on 2,000 acres, starting this year," said U Kyaw Win.

Myanmar exported 3.5-4 millions tons of rice in 2016, 2017, and 2018 and over 2 million tons this year.— Aye Min Thu (Translated by Ba Htoo Kyaw)

Understanding causes, approaches key for ending malnutrition in Rakhine

IN KEEPING with the idea of 'health as a bridge for peace', we must make efforts to provide quality healthcare for people, paying special attention to conflict-ridden areas.

According to the Myanmar Micronutrient and Food Consumption Survey: 2017-2018, women and children aged under five in Rakhine State are suffering from malnutrition. The survey has called for immediate action, and the Ministry of Health and Sports and local authorities have made joint efforts for tackling poor nutrition in the state. Malnutrition is responsible for more illnesses than any other single factor.

To tackle malnutrition as well as address some of the underlying issues related to it in households, as part of healthcare

To lay down future tasks for ending malnutrition and promoting health in Rakhine, different approaches from the technical, social, administrative, and management sectors should be adopted to ensure that the authorities concerned lay down pragmatic tasks.

activities, we must take into consideration social conflicts, instability, security, and the changing situation in Rakhine.

Collecting necessary information on the requirements, challenges, and opinions of households suffering from malnutrition at the grassroots level, especially at the IDP camps, through discussions, is a must to ensure that the right decisions are made and the right tasks are drawn up.

Mobile clinics can be very effective in helping people at IDP camps and villages, which are not easily accessible due to social problems, get access to healthcare. We need to find ways to provide regular healthcare services to such areas.

In spite of the obstacles and challenges, the Ministry of Health and Sports is implementing the five-year Multi-Sectoral National Plan of Action on Nutrition (MS-NPAN) 2018-2023. Myanmar is also expanding its vaccination programme and actively

participating as a member country in the Scaling Up Nutrition (SUN) movement for reducing malnutrition in accordance with the slogan — "1,000 Days: Change a Life, Change the Future".

The movement covers dissemination of nutrition-related knowledge in states and regions, and nutrition campaigns for pregnant women and children under 2 years of age were started in 2013 through the establishment of five networks involving experts and organizations from the relevant sectors.

To lay down future tasks for ending malnutrition and promoting health in Rakhine, different approaches from the technical, social, administrative, and management sectors should be adopted to ensure that the authorities concerned lay down pragmatic tasks.

Understanding the causes of, and approaches and solutions to, nutrition-related public health achievements, situations, and problems in Rakhine State are key to fixing the problem of malnutrition in the state.


The Meaning of the Name 'Mrauk U'

RAUK U, called 'Mrohaung(Old city) by ▼ **⊥**locals, is the last of the ancient Rakhine capitals. It was founded by King Min Saw Mon in 1430 A.D and came to an end in 1785 A.D. A long line of 48 kings reigned in it for about 355 years. It witnessed its heyday during this long spell. It is situated on the bank of the Dat creek, which lies in the upper reach of Hin-kha-raw creek, a tributary of the Kalandan River. This article is not dealt with the history of Mrauk U but with the etymological explanations about the term 'MraukU'.

It is found that the term 'MraukU' conveys 'different meanings' and has different sources. The first source of the meaning of the term ' Mrauk U' goes back to Late the Vesali period thus: By the end of Vesali period, King Culacandra drowned to death some miles


of the much coveted throne. At long last, they came upon two Mro brothers and a son of the younger brother fishing in a river. Much to their surprise, the ring fitted all three of them. So they were brought into the court and the elder brother A-mra-tu was placed on the throne of Vesali, the younger brother Amraku installed as Crown-prince and his son Pei Phru given a village called Mrauk U. But, soon, as the Chief Consort had a loving affair with Crown-prince, the king, devising a means, shot him dead with a poisoned arrow in a remote place. Shrewd Prince Pei Phru perceived his uncle's cruelty towards his father, but he repressed his anger and awaited the suitable time to retaliate the latter. When the Pyu king to the east of the Rakhine Yoma heard of the death of King Culacandra and ruling of three Moros over Vesali, he crossed the Yoma in

Mrauk U is located between the Kaladan and Lay Myo rivers in Rakhine State in the Western part of Myanmar. Over a period of more than 350 years

thus: When the Taung-nyo Hill and the Kukkar Hill were bulldozed and the ground levelled for the site of the Mrauk U palace, the excavators saw a female monkey guarding over an egg of a pea-hen. After this phenomenal event, King Min Saw Mon named his new town ' Myauk U', meaning, 'the egg of the monkey'. In course of time, the term ' Myauk U' was corrupted to ' Mrauk U'.

The third source is also found in the same book thus:While King Min Saw Mon was searching for a suitable place along a creek, a tributary of the Laymyo river to construct Mrauk U city, he, at a certain spot, saw two women catching fish with a bamboo fishing-trap each on either bank of a stream, calling out each other's name ' Hey, May Mrauk U'. ' Hey, May Wa-thay'. When the king heard their names, he knew the side on which the women called 'May Mrauk U' stood was ' Mrauk U' and the side on which the woman called 'May Wa-thay' 'Wa-thay'. As he built his new town on the side where May Mrauk U stood fishing, he named it 'Mrauk U'.

The fourth source is found in a palm-leaf manuscript on the Rakhine chronicle thus: Once, there lived in a forest a king of peacocks who had 1,000—strong retinue and a king of monkeys who had 500-strong retinue. Soon afterwards, king of pea-

cocks and consort of king of monkevs died almost at the same time. So King of monkeys and the consort of King of pea-cocks continued to live as a couple. When some time went by, the pea-hen laid three eggs. The King of monkeys brought and submitted them to King Hmwe-soka by saying that they were laid by a pea-hen, his wife. Out of surprise, the king asked Ven. Moggaliputta about this phenomenal event. The monk then replied that what king of monkeys told was true and that the Sasana (The teachings of Buddha) would flourish and a big city would appear in the place inhabited by the monkey and that the city would be known by the name of Myauk U, for it was the place where the monkey submitted eggs to the king. The name ' Myauk U' was changed to ' Mrauk U' with the passage of time.

The Than-paing chronicle (palm-leaf manuscript) mentions thus: During the lifetime of the Kassapa Buddha, the Buddha during his itinerary reached the place where Mrauk U city would emerge. It was then inhabited by ogres. Later, a female monkey and a peacock lived there as husband and wife. In due course, the female monkey laid two eggs. The couple, much surprised, submitted the eggs to the Buddha.

About 8,000 buyers apply for Yangon government-owned land in 2 weeks

THE Yangon Region government recently announced the sale of land plots for setting up industrial businesses and public housing, and within two weeks, it received about 8,000 applications for the plots, said U Than, the Joint Secretary of the Yangon City Development Committee (YCDC).

He made the remarks at a press conference on YCDC's performance on 21 October, which was held at the Yangon

City Hall.

The plots of land owned by the Yangon Region government will be sold in three phases.

"In Phase 1, land-use applications for 500 land plots in Hlinethaya, Shwepyitha, and four Dagon Myothit townships were sold on 7 October at the office complex of the General Administration Department (Eastern District), and the number of applicants has reached 7,786 within two weeks," said U Than.

Over 180 plots from the

Myaungtagar Industrial Zone will be sold in Phase 2, and, over 9,000 acres, previously marked as agricultural land, in East Dagon and Dagon Seikkan townships will go under the hammer in Phase 3, said U Than.

The Land Management Committee will screen the applications and sell the plots to selected individuals and organizations for setting up businesses and housing projects.

"As the land is being sold by the regional government, it will have full guarantee," said Yangon Mayor U Maung Maung Soe. The plots that are slated to be sold were previously seized by the government, and compensation had not been awarded to their original owners. Therefore, to compensate the original farmland owners, the undeveloped lands are being sold again, according to officials.

The applications for the plots have to be submitted by 8 November.

TCP targets Myanmar with plant

TOA-Chugoku Paints (TCP) has earmarked 500 million baht to construct its first overseas paint factory in Myanmar, expecting to capture demand from megaprojects the Bangkok post reported.

The new factory will produce two paint products — heavy-duty coating and marine paint — with a monthly capacity of 300 tonnes.

The project will be located in Thilawa Special Economic Zone. It is scheduled to begin operations in April 2020.

TCP set up a new local unit in Myanmar, Chugoku-TOA Paints Myanmar, to operate the factory.

Chugoku Marine Paints (CMP) from Japan holds a 51% stake in the Thilawa company, while TOA Venture Holding (TOAVH) from Thailand owns the remainder.

Pisit Boonchanya, TCP's managing director, said the Thai company started exporting two paint products from Mae Sot district to Yangon and Thilawa in 2012. The Thai and Japanese

arms decided early this year to invest in a plant in Myanmar.

"Myanmar opened for new business and investment flows five years ago. There are many megaprojects awaiting development and expansion," he said.

"We will capture many busi-

ness sectors there — fishery crafts, shipment vessels and construction — as well as distribute our paint products to Myanmar's navy agencies."

Myanmar's heavy-duty coating and marine paints have a market value of roughly 300 million baht, of which TCP captured a 70% market share with exports from Thailand, said Mr Pisit.

He said the Myanmar business plan is part of TCP's expansion abroad, with plans to enter Cambodia, Laos and Bangladesh in the near future.

"Once we achieve revenue of 300 million baht in Myanmar, we

will consider further overseas expansions for the manufacture of paint and coating," said Mr Pisit.

The company aims to achieve 500 million baht per year in sales in the first five years of operations.

At home, TCP is a joint venture between TOAVH and CMP, who hold 51% and 49% stakes, respectively.

The manufacturing plant is located at Wellgrow Industrial Estate in Chachoengsao province with a total monthly capacity of 2,000 tonnes in heavy-duty coating, marine paint and container coating.

Mr Pisit said in 2018, TCP captured a market share of 50%, while the market totalled at 4 billion baht, largely in heavy-duty coating and marine paint.

In 2018, TCP had sales of 2 billion baht, of which 1.4 billion was from heavy-duty coating.

The remaining 600 million baht came from marine paint and container coating. — Bangkok Post/ GNLM

Buyers must bear infrastructure costs of govt land

INDIVIDUALS purchasing land from the Yangon Region Government will also have to bear the costs of installing the necessary infrastructure accompanying it, according to the Joint Secretary of Yangon City Development Committee (YCDC), U Than.

He gave the remark during a press conference at the city hall on 21 October while updating the public on the activities of the YCDC.

The infrastructure mentioned earlier includes the roads, sewer canals, pipelines Than. He said the payments need to be made separately so that they can remit it to the implementing companies.

Over 90 per cent of the 500 plus plots of land to be sold by the regional cabinet already have good roads and working utility poles.

There have been public voices saying that the regional cabinet is selling some of the 40x60 feet plots of land at a price higher than the market price of K3.5 million.

U Than explains that the price set by the government corresponds with the market price evaluation group's analysis of individual townships and their market price for 2018-2019 financial year. the price for the plots of lands for each township. The prices differ based on the location and proximity to main roads, junctions or alleys.

The Yangon Region Government will be selling land in its region for economic, industrial and residential purposes in three phases. The first phase includes 500 plots of land in Hlinethaya, Shwepyitha and four Dagon Myothit townships, the second phase includes over 180 industrial plots in Myaungtaga Industrial Zone, and the third phase includes over 9,000 plots in East Dagon and Dagon Seikkan formerly designated as

External trade touches \$1.1 bln in 11 days of 2019-2020 FY

MYANMAR'S external trade between 1 and 11 October in the current fiscal year reached a high of US\$1.1 billion, an increase of \$90.2 million compared to the corresponding period of the 2018-2019 fiscal, according to the Ministry of Commerce.

In the first 11 days of the financial year, Myanmar's exports were estimated at \$545.67 million, and imports were valued at \$562.89 million. In the previous FY, trade stood at \$1.08 billion, according to data released by the ministry.

Myanmar exports agricultural products, animal prodgoods, while it imports capital goods, raw industrial materials, and consumer goods.

The country's export sector relies more on the agricultural and manufacturing sectors. Export earnings from the CMP (cutting, making, and packaging) garment businesses are rising, while reliance on natural resources, such as natural gas and jade, is lessening.

The government is trying to reduce the trade deficit by screening luxury import items and boosting exports, according to the Ministry of Commerce. — GNLM

for supplying water, and electrical wiring. Enquiries of interest will be sent to infrastructure companies and the cost for implementation will be added to the purchasing price of sold land.

"Let's say for example, a plot of land 40x60 feet sells for, in line with the price set by the local market price evaluation group, at K6 million and the infrastructure costs are at K5 million, then the entire plot would cost K11 million," explains U "The price is included in the application forms. It differs for each township and is set by the evaluation group. Some 40x60 feet plots sell for K6 million while others sell for K13 million or even K100 million per acre," says U Than.

He says the townships have different prices for each square feet and a book (possibly from the evaluation group) details

agricultural zones.

The regional cabinet's plan tries to ensure the plots of land fall into the hands of entities genuinely interested in using them for conducting businesses, constructing industrial sites and building residential housing. A land management committee will review every potential buyer and ensure a hundred per cent maximum usage of each sold plot of land, said Yangon Mayor U Maung Maung Soe. At the advice of the Buddha, the pea-cock brooded over the eggs in a nest on a tree growing on the bank of a creek, a tributary of the Meghavati river. In due time, two celestial females hatched out of the eggs. They were adopted by the two women living on either side of the creek. The girl who was brought up in the place where the pea-cock had brooded over the eggs was

called ' May Wat-thay' and the one who was brought up in the place where the eggs had been submitted to the Buddha was called ' May Myauk U'. They were the guardian spirits of the villages and towns. When the city was established in the place where the eggs had been submitted to the Buddha, it was known by the name of Mrauk U. And the place where the peacock had brooded over the eggs was known as 'Wat-thay'.

The last source is extracted from a palm-leaf manuscript titled ' Rakhine Htee-daw-padetha Kyan'. The source is only a Pali phrase, ' Rakkha Uttarana mate' meaning ' to the north of Rakhine'. U Tun Shwe Khaing says that this phrase implies that King Min Saw Mon might have travelled northwards from Laungkrat city to look for a site to construct Mrauk U or ancient Mrauk U might have been situated at the northern tip

of Laungkrat city. This extract suggests that Mrauk U had been 1. Candamalalankara, Ven., located in the north of Laungkrat city.

In conclusion, it is thus found thus that the word 'Mrauk 2. U' had appeared before the fall of Vesali (8th century A.D)and that it is connected with the political situation of ancient Rakhine, the animals who inhabited the area where the city would emerge and its geographical setting.



EU fires budget warning shots to Italy, France

BRUSSELS — The European Commission on Tuesday demanded urgent clarifications from Italy and France on their budget plans for next year, worried they veer widely from spending cut commitments made to Brussels.

The letters from the EU's executive arm requested a response by Wednesday and could be the first step before the commission rejects a budget outright and demands a new draft.

Portugal, Spain, Belgium and Finland were also contacted with concerns.

"Italy's plan does not comply with the debt reduction benchmark in 2020," said a letter signed by EU economics affairs

commissioner Pierre Moscovici and commission vice president Valdis Dombrovskis.

Rome hopes to get Brussels to agree to a deficit of 2.2 per cent of GDP.

But the EU said that risked delaying the reduction of Italy's massive debt mountain, which is the second highest in the euro zone behind Greece at 180 per cent of national output.

The spending plans were the product of fraught negotiations between the new coalition in Italy, an unlikely partnership between the anti-establishment Five Star Movement and the centre-left **Democratic Party.**

"We will provide all clarifications to the EU, we are not concerned," said Italian Prime Minister Giuseppe Conte.

"It is a necessary dialogue with Brussels from which we will not escape."

French tax cuts

France's government unveiled a draft 2020 budget last month with more than nine billion euros (\$10 billion) in tax cuts for households in its bid to move on from "yellow vest" protests while still cutting the deficit.

But the EU warned that these plans were "not in line" with commitments made to Brussels, and risked a "significant deviation" from the European rulebook on budgets.

Crucially, the commission criticised Rome and Paris for under-delivering on so-called structural reforms, changes to long-term costs such as pensions, hiring and firing laws and other politically difficult reforms.-AFP

French farmers stage protests as anger boils over

PARIS — Hundreds of farmers rolled out tractors to stage protests at government offices across France on Tuesday, railing against measures they say are crimping revenues and contributing to a spike in

suicides in the sector in recent years. "Macron, answer us!" read a banner in Le Mans, western France, as farmers dumped hay and dug up a roundabout in front of the regional government office as the protests began Monday night. Another asked "France, do you still want farmers?" referring to regulations, price wars and global trade deals many say are stifling their ability to make a living.

It was the second mass protest this month, after an estimated 10,000 farmers blocked highways across France on 8 October. "We're demanding an end to 'agri-bashing,' to stop making our jobs more and more difficult, to stop putting spokes in our wheels and blaming us for everything," said Delphine Fernandez, president of the Young Farmers association in the southern Gard department.—AFP

Issues raised by private sector at 30th meeting between PSDC and businesspersons

HE Private Sector Development Committee led by Vice President U Myint Swe and private business persons held its 30th regular meeting at the Union of Myanmar Federation of Chambers of Commerce and Industry (UMFFCI) on 19 October 2019. Issues covering Bayintnaung market, fishery sector, automobile manufacturing and distributing sector were raised.

Bayintnaung Market

Yangon Region Chambers of Commerce and Industry Chairman U Khin Han explained about difficulties faced by commodity trading houses, companies, banks and truck companies operating out of Bayintnaung Market due to non-extension of land grants. Land grants for lands in Bayintnaung Market was extended up to 2018 and then extended to 2021. However, as land grant extensions were no longer granted beyond 2021, the commodity trading houses, companies, banks and truck companies operating out of Bayintnaung Market were facing difficulties in obtaining bank loans and additional investment in the businesses. The matter was raised for coordination with relevant departments and organizations toward extending the land grants.

Fishery sector

Issues covering fishery sector was raised and explained by Myanmar Fisheries Federation Senior Vice President Daw Toe Nanda Tin and General Secretary U Win Kyaing.

First the matter of possible environmental effects on fishery resources in Myanmar territorial water and exclusive economic zones if offshore oil and gas exploration and production were conducted without proper environmental protection works and researches. Difficulties faced by fishery sector workers due to the depletion of fishery resources were also raised. Offshore oil and gas production works were to be permitted only if systematic preliminary surveys to protect and conserve fishery resources,

protect and conservation works on fishery resources during offshore oil and gas production and after offshore oil and gas production were systematically conducted by internationally recognized experts.

Integrated fish farming of breeding fish together with chicken on top of the fish ponds should be banned as local aquatic products were not meeting GAqP, GMP, HACCP standards for export while not also meeting food safety standard for local consumption. In the long run the practice will also affect the National Aquaculture Development program.

ufacturers and Distributors Association Vice Chairman U Zaw Htike Aye and joint secretary Dr Kyaw Kyaw Aung explained about issues in automobile manufacturing and distribution sector.

Customs Department was designating Double Cab pickup trucks as commercial vehicles and changing HS Code to reduce custom duty while Road Transport Administration Department was designating it as a private passenger vehicle in the same way as a saloon car and collecting (higher) tax. Suggestion was made to designate it as commercial vehicle and collect tax accordingly in both departments. Except for a very few commercial trucks and bus locally manufactured or assembled, the majority of the investment

Labour or workers affair is the affair of the entire world and International Labour Organization (ILO) is the sole United Nations organization formed with representatives of governments, employers and workers from 187 member countries raising appropriate work opportunities for workers, setting worker/labour norms and establishing policies. ILO was established in 1919 and in 2019 it is 100 years old. Centenary of ILO will be celebrated in Myanmar as well as all member countries.

Myanmar became a member of ILO in 18 May 1948 and was discussing together with other member countries labour/workers affair, migrant worker, child labour, forced labour, unemployment, labour dispute, being in line with standards and norms set by ILO and basic labour rights in work site together with other member countries.

Labour and workers affairs and sustainable development goals

Of the Sustainable Development Goals (SDGs) established by United Nations (UN), goal 8 of "Promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all" is an important goal for workers. Goal 1 of "End extreme poverty in all forms by 2030," goal 2 of "End hunger, achieve food security and improved nutrition and promote

Obtaining decent employment

The tripartite of government, employer and employee approved the Myanmar Decent Work Country Programme 2018-2022 on 21 September 2018 and a memorandum of understanding with ILO was signed.

The programme will be implemented through three set priorities of:

1. Employment and decent work and sustainable entrepreneurship opportunities are available and accessible to all, including for vulnerable populations affected by conflict and disaster

2. Application of Fundamental Principles and Rights at work is strengthened through improved labour market governance

3. Social protection coverage for all is progressively extended, especially for vulnerable workers and populations Migrant worker issue

According to International Organization for Migration (IOM) Indicator 2018 of the world's population of 7.6 billion, 258 million were migrant workers of which 7.8 per cent were from Southeast Asia. Lack of job opportunities, differences in wages and salary, development of technology are causing the rise in the numbers of migrant workers. Myanmar became the 147th member of IOM in 2012.

Issue of child labour

The Convention concerning the Prohibition and Immediate Action for the Elimination of the Worst Forms of Child Labour, known in short as the Worst Forms of Child Labour Convention adopted by ILO in 1999 as ILO Convention No 182 defines child as youngster below the age of 18 or children between the age of 5 and 17 years. Myanmar has a growing child labour problem. According to a study conducted in 2016, Myanmar had about 1.3 million child labour that was 10 percent of the child population. The main problem was poverty and low education. Most child labours were educated up to the primary level only and were working in dangerous work sites and places. Ministry of Labour, Immigration and Population was drawing up a list of dangerous work for children with the help of ILO and had also formed a Myanmar National Committee on Child Labour Eradication.

Forced labour issue

2008 Constitution of the Republic of the Union of Myanmar Section 359 states that the Union prohibits forced labour except hard labour as a punishment for crime duly convicted and duties assigned by the Union in accord with the law in the interest of the public. Many laws prescribed penalties and punishment for any act of forced labour. Myanmar was working together with ILO toward drawing up and approving a forced labour eradication work programme (2019-2020).

Unemployment issue

Myanmar was working toward resolving this issue through giving priority to manufacturing sector that will provide most employment opportunities. It was doing this through developing small and medium enterprises.

Resolving labour disputes

At the moment Myanmar was resolving labour disputes through 15 laws. Foreign Workers Law was drafted while a new Labour Organization Law was being redrawn. Occupational Safety and Health Law was enacted. On the centenary year of ILO, let us work toward the development of the workers affairs sectors.
