#### Joint Committee on Scrutinizing Constitution amendment bill submit report

Following this secretary of Joint Committee on Scrutinizing the second bill amending the Constitution Dr Myat Nyana Soe read the committee report on the committee's findings and comments on a bill amending the Constitution for the second time signed and submitted by 145 Pyidaungsu Hluttaw representatives including U Sai Than Naing of Kayin State constituency 5.

Dr Myat Nyana Soe said that in addition to this present bill, there were a total of five bills to amend the Constitution that were submitted to the Pyidaungsu Hluttaw. The committee found that the five bills were not to amend the entire 2008 Constitution but to amend certain provisions only.

A Joint Committee on Amending the 2018 Constitution made up of political party groups in the Hluttaw and independent Hluttaw representatives proportionately was formed with an assignment to draw up a bill amending the Constitution and submit to the Hluttaw.

Once this committee submits the bill, it would be appropriate for the Joint Committee on Scrutinizing the second bill amending the Constitution formed with all members of Pyithu Hluttaw and Amyotha Hluttaw bill committees to study this bill together with the five bills. This was the finding and comments of the majority of the members of the Joint Committee on Scrutinizing the second bill amending the Constitution.

However, some Joint Committee on Scrutinizing the second bill amending the Constitution members Daw Nan Ni Ni Aye, Brig-Gen Maung Maung and Brig-Gen Tint Lwin suggested on separately discussing the bills in the Hluttaw.

After the report was read, Pyidaungsu Hluttaw Speaker U T Khun Myat announced for Hluttaw representatives who want to discuss the matter to register their names.

## VP U Henry Van Thio addresses NWRC coord meeting 3/2019

Thio, who is the Chairman of the National Water Resources Committee (NWRC) attended and addressed the NWRC coordination meeting 3/2019 held at Ministry of Transport and Communications meeting hall in Nay Pyi Taw yesterday morning.

The meeting was attended by Union Ministers U Thant Sin Maung, U Ohn Win and U Win Khaing, Deputy Ministers U Tin Myint, U Kyaw Myo and U Soe Aung, NWRC members, Permanent Secretaries, directors general, advisory group members, experts and officials.

In addressing the meeting the Vice President said that after NWRC was formed coordination meetings were held to develop water and related sectors, effectively manage and use water resources, support effective and beneficial cooperation with international organizations and coordinating on future works and this was the eleventh such meeting.

Through the meetings, coordination works between water related ministerial departments and organizations, effective coordination in implementing the committee's work processes and resolution of water related problems were conducted.

Kayin, Mon and Taninthayi were the states and region where flooding and inundation occured during 2018. Short, mid and long term programmes were observed to be drawn up and implemented by committees to mitigate flooding and inundation formed in these states and regions. In this monsoon season, Kayin, Mon and Taninthayi faced flooding and inundation again while a landslide occurred in Mon State's Paung Township. The Netherlands was contacted through bilateral joint coordinating committee for assistance on flooding and inundation and in mid-September the Disaster Risk Reduction Team consisting of experts from the Netherlands came and conducted a study in Kayin and Mon states where natural disasters occurred. A report will be sent by the study team and once this was received,

it will be distributed to related State/Region governments and ministerial departments.

"Now that the rainy season is over, there's a likelihood of shortfalls in potable and irrigation waters, and ministerial departments and organizations notices were made to prevent and mitigate contamination of water resources from extraction of natural resources. It was an important work for relevant ministerial departments and organizations to place great emphasis on ensuring that these

are to cooperate with state and regional government departments to make preparations". To mitigate the long term water shortfall problem, immediate short terms as well as long term solutions were to be drawn up, submitted and conducted. Coordination needs to be conducted to provide potable and irrigation water, generate electricity, mitigate flooding and inundation and to preserve the natural environment through dams and reservoirs.

Laws, rules, orders and

laws, rules, orders and notices were abided by. The momentum of annual monsoon tree planting work was to be increased yearly for greening regions and to preserve the natural environment.

The NWRC and water related ministerial departments and organizations were enthusiastically conducting works for water sector development and were participating in the best way in international and regional cooperation works.

The NWRC and water related ministerial departments and

organizations cooperating and working together with international and regional organizations for water sector development. The projects and studies conducted need to be truly effective and beneficial to our country and the majority of the people. Necessary coordination between related ministerial departments and organizations were to be conducted.

Massive amount of funds were used annually by the State for development in water as well as in all sectors and the effective usage of the funds need to be systematically managed according to laws, financial regulations, instructions and guidelines.

Emphasis must be placed toward drawing up in a timely manner the National Water Law that was interconnected to prevailing laws and rules. Requirements and coordination required between ministerial departments and organizations were to be discussed openly.

Committee members and representatives from ministerial departments and organizations were to discuss and suggest on conducting water related works, cooperating with international

organizations and coordinating with ministerial departments and organizations. Relevant ministerial departments and organizations were required to successfully implement an all-round water resource management system that was beneficial for the country and the people and to successfully implement the duty and responsibility and future work processes of the committee, said the Vice President.

Next, committee Vice Chairman Union Minister for Transport and Communications U Thant Sin Maung explained drawing up National Water Law, preparation status for overcoming water shortfall and maintenance of waterways.

Afterwards committee joint secretary Directorate of Water Resources and Improvement of River Systems acting Director-General U Win Hlaing explained works conducted by the committee and implementation of decisions made at NWRC coordination meeting 2/2019.

The meeting came to a close with concluding remarks by the Vice President. —MNA ■

## Third batch of electoral capacity enhancement training opens

THE third batch of the "Training to Enhance Electoral Capacity" for the 2020 General Election was held at the Grand Amara Hotel in Nay Pyi Taw yesterday.

Speaking at the opening of the three-day training, UEC Chairman U Hla Thein said it was the third batch of the training. The first batch with 104 trainees and the second batch with 93 have been successfully held.

The commission is working to ensure the 2020 General Election are condcuted in accordance with the five norms of being free, fair, transparent, credible and reflecting the will of the people, he added.

The UEC Chairman then spoke about the needs of higher quality and capacity for the chairpersons and members of the sub-commissions and staff, so that they may perform their tasks better and in accordance with

laws, bylaws and regulations.

The course comprises of ten chapters that are important for the election process. While the compilation of the nationwide primary voters' list is completed, ensuring it is always accurate and comprehensive requires updating the list regularly in accordance with its work procedures.

THE exclusive launching ceremony of "The Guidelines for Political Parties in Myanmar on Gender Equality-A Shortcut to Development and Prosperity" was held at the Grand Amara Hotel in Nay Pyi Taw yesterday.

Myanmar School of Politics (MySoP) organized the launching event, and officials from the commission office and Netherlands Embassy in Yangon, political parties and non-governmental organizations, and invited guests attended it.

Speaking at the event, **Union Election Chairman** U Hla Thein said that the fundamental principle of democracy "equality of every citizen" is being prioritized in democratic countries.

The rights to vote and to be voted are parts of the human rights that are eligible for all gender.

Regarding the wom-

en's participation in the previous elections, the UEC Chairman said there were 127 women candidates in all 3,069 candidates in the 2010 general election, and the women's candidates selected in Hluttaw was 1.4 per cent.

In 2015 General Election, the women's candidacy reached to 800 in all 6,038 candidates and the women selected in Hluttaw 13 per cent, he added.

The UEC Chairman also urged political parties to promote the women's participation in the general election.

Myanmar signed The Convention on the Elimination of all Forms of **Discrimination Against** Women (CEDAW) in 1997, and the UEC was implementing the electoral producers that are included in the CEDAW including the rights to vote and be elected to promote gender equality and women's role.

Regarding the gender equality, the UEC assigned its duties to 26 per cent of women in regions/states level sub-commissions, 16 per cent in district level and 15 per cent in township level. The employment of women staff at the offices of the commissions and the sub-commissions reached to 58 per cent.

The UEC Chairman then urged political parties to emphasize women's participation in submitting the lists of parliamentary candidates. The launched book would assist political parties in promoting gender equality, he added.

Afterwards, Ms Linda van der Horst, the Representative from Embassy of the Netherlands in Myanmar, and former Member of Indonesian Parliament, Ms. Eva Kusuma Sundari, made concluding remarks.

## Preserving handicrafts, creating jobs through innovation

NUMBER of tangible and intangible arts from the 11th century are still being preserved in Myanmar. At present, Myanmar's arts and crafts industry is under threat due to shortage of skilled labor and a drop in demand from home and abroad.

Before 2010, Myanmar lacquerware were produced in abundance, and they had a place in the international market. But in recent years, there has been a significant decline in the export volume of lacquerware. In addition, there has been a rise in lower-priced, fake lacquerware entering Myanmar, which can have a negative impact on the local lacquerware market. Bagan lacquerware products have not been able to enter the interna-

Likewise, handicrafts made of rattan and bamboo are only being sold in the local market. The industry is facing difficulties when it comes to manufacturing high-end products and penetrating international markets.

Efforts are being made to develop the handicraft industry under a four-year project (from 2018 to 2022) with the aim of drumming up global demand.

In accordance with the basic principle of the small and medium enterprises promotion law, the Union Government is working on establishing the Myanmar Arts and Craft Centre, as part of efforts to find an export market for Myanmar arts and crafts.

In connection with this, lifting or waiving the

tax imposed on small-scale businesses, working with less than 10 workers, should be considered as one of the options to speed up the efforts as the handicrafts market has been cooling and the burden of taxation has increased.

At the same time, the organizations concerned need to review the strengths and weaknesses of Myanmar arts and crafts.

We need to promote hand-made products, use innovation to produce souvenirs to household utensils, and improve packaging to meet international standards.

Myanmar's bamboo forests, which are the main source of raw materials for hand-made products, are the largest in the world, after China and India

Holding workshops and conferences and participating in international fairs would help gain market share.

It is a certainty that demand from local and foreign markets would revive production of hand-made goods and create jobs for the people.

While our neighbors have made significant headways in the industry for hand-made products, we needs to make efforts to penetrate the international market.

## MR vaccines to be administered to over 307,000 children under 5 in Magway

OVER 2,000 healthcare personnel will administer measles and rubella (MR) vaccinations to over 307,000 children under the age of five from 26 to 28 November in Magway Region, according to the regional Public Health Department.

Although the vaccination was given across the country in 2015, only 85 out of 100 children developed resistance to MR. The vaccination is aimed at further reducing the number of fatalities among children under five years old in the country, and eradicating congenital rubella as well as measles and rubella by 2023.

"Under the regular vaccination programme, the vaccines are given to children aged nine months to one and a half years. Those children who missed the vaccination the first time can also receive it under this programme,"

said Dr Khin Maung Than, Assistant Director of the Magway Public Health Department.

"The vaccination programme cannot be handled by the health department alone. So, we need greater cooperation

from other related departments, health staff, INGOs, NGOs, and other social organizations," said Dr Aung Moe Nyo, Chief Minister of Magway Region.

Preparations have been made for the vaccination program for some months, with the assistance of experts. The health department has also conducted a survey ahead of the vaccination drive. —Zayyar Tu (Magway)

OVER 500 fuel filling stations were inspected in the previous financial year, and action was taken against 67 under the Petroleum and Petroleum Product Law for dispensing oil of low quality and for inaccuracies in fuel measurement, according to the Ministry of Electricity and

The ministry has been conducting surprise checks with the use of six mobile fuel labs in Yangon and Mandalay regions and Nay Pyi Taw. In addition, the supervisory sub-committee on petroleum and petroleum product business activities has been carrying out surprise inspections in the regions and states without mobile fuel lab vehicles. After inspections, they

are taking fuel oil samples and sending them to the respective lab. If fuel stations are found

acting unscrupulously, action is being taken against them under the law.

On 22 November, a team led by Deputy Minister for Electricity and Energy, Dr Tun Naing, and

officials of the sub-committee inspected 360 PETRO, MAX, and Myat Myittar Mon filling stations to check the quality and measurement of fuel oil using mobile fuel lab vehicles.

The lab results have been posted on the official website of the ministry and the Facebook pages of the stations to earn public trust, said Dr. Tun Naing. He also urged inspection teams to check fuel oil quality as per the prescribed norms.

The filling stations have to take fire prevention measures and they need to strictly adhere to the Petroleum and Petroleum Product Law, he added.

As of end-November, there were 2,643 licensed private stations across the country. Yangon Region has 186 stations.

## Higher exports drag down trade deficit to nearly \$20 mln

A RISE in exports helped narrow Myanmar's trade deficit to US\$19.98 million between 1 October and 15 November in the current financial year, a significant drop from a trade gap of \$569.95 million registered in the corresponding period of the 2018-2019FY, according to data from the Ministry of Commerce.

During the last one and a half months, Myanmar's external trade soared to \$4.598 billion from \$4 billion recorded in the same period of the previous FY.

While exports were estimated at \$2.289 billion, imports were valued at \$2.309 billion.

Compared to the previous fiscal, exports increased by \$568.9 million, while imports rose slightly by \$18.9 million.

Myanmar exports agricultural products, animal products, minerals, forest products, and finished industrial goods, while it imports capital goods, intermediate goods, CMP raw materials, and consumer goods.

The country's export sector relies more on the agriculture and manufacturing sectors. While export earnings from the CMP (cut, make, and pack) garment businesses are rising, the country's reliance on natural resources, such as natural gas and jade, is lessening.

The government is trying to cut the trade deficit by screening luxury import items and boosting exports.

Myanmar's trade deficit was pegged at \$1.14 billion in the 2018-2019 fiscal year, \$1.3 billion in the 2018 mini-budget period, \$3.9 billion in the 2017-2018FY, \$5.3 billion in the 2016-2017FY, and \$5.4 billion in the 2015-2016FY, according to statistics released by the Central Statistical Organization.—Mon

countries through the sea route and border gates was estimated at US\$11.17 billion in the 2018-2019 financial year, according to the Ministry of Commerce.

The ministry reported that imports surpassed exports in regional trade, with exports reaching \$4.08 billion and imports valued at \$7.09 billion.

Since April, Thailand has been Myanmar's largest trade partner in ASEAN, with trade valued at \$5.4 billion, followed

regional trade with ASEAN Indonesia (\$1.04 billion), and include food and beverages, Malaysia (\$1 billion). Viet Nam has emerged as the nation's fifth largest trade partner, with bilateral trade estimated at \$852.2 million.

Meanwhile, Myanmar's bilateral trade with the Philippines was \$184.728 million, Cambodia \$15.116 million, and Laos \$1.7 million, while trade with Brunei stood below a million dollars.

Myanmar's main export items include agricultural and fishery products, as well

# South Korean enterprises make inroads into Myanmar

HE Republic of Korea has injected around US\$ 150 million worth investment into Myanmar for construction of two industrial projects in Yangon and Bago Regions this fiscal year, according to a source from the Directorate of Investment and Company Administration (DICA) under the Ministry of Investment and Foreign Economic Relations. The Myanmar Investment Commission (MIC) had already given the green light for the establishment of the two industrial zones in Yangon and Bago Regions.

An industrial zone is being set up on 203.6 acres of land in Nyaung Inn Village-tract in Bago Region with an investment volume valued at US\$ 28 million from the Republic of Korea and construction of the project is expected to take three years, according to a senior official from the Ministry of Investment and Foreign Economic Relations. The Urban and Housing Development Department (UHDD) under

the Ministry of Construction of Myanmar and the Korea Land and Housing Corporation from the Republic of Korea sealed a deal to jointly establish an industrial complex in Hlegu Township, Yangon Region on 7 August this year. Under the agreement, an industrial zone named "the Korea-Myanmar Industrial Complex" will be established on 556 acres of land in Nyaung Hna Bin Village, Hlegu Township at an estimated cost of about US\$ 120 million.

The MIC approved the pro-

ing (MoU) with a consortium from Hong Kong and Taiwan to build a US\$ 500-million industrial zone on 2,200 acres of land in Htantabin Township.

Construction of the project startedin September this year and is expected to create around 100,000 job prospects. Another South Korean company, GS Engineering and Construction has started building a 4.3-kilometre river crossing bridge connecting downtown Yangon and Dala Township. The estimated cost of the

billion loan to Myanmar.

The two countries also agreed to promote cooperation on trade, technology, infrastructure and rural development.

Currently, over 200 South Korean companies including multinational conglomerate Lotte Group are operating in Myanmar. South Korea was the sixth largest foreign investor in Myanmar with most investment from the East Asian country came to oil and gas, infrastructure, retail, and real

ject early this year as a 60/40 partnership between Myanmar and South Korea and the industrial park will be developed in two phases with the first starting from 2019 to 2021 and the second phase from 2022 to 2024, said U Aung Naing Oo, Permanent Secretary of the ministry. The industrial complex is designed to include SMEs, heavy industry and a vocational training school and will support the development of industrial, export and human resource sectors in Myanmar.

Many South Korean companies are expected to make investments in the industrial complex which will create 50,000 to 100,000 job opportunities for local people and generate US\$ 10 million in taxes annually.

In addition, the Yangon regional government signed a Memorandum of Understand-

project is more than US\$ 150 million.

The bridge is slated for completion by 2022, and will significantly reduce the travel time for residents of Dala to Yangon.

In addition, HUBS MK Co Ltd from the Republic of Korea and the Myanmar Trade Promotion Organization inked a deal for construction of a US\$ 98 million international-standard logistics hub at Shwe Lin Ban Industrial Zone in Hlinethayar Township, Yangon Region in 2018. The two governments also sealed a deal to conduct feasibility study for the development of the Dala Satellite City Project.

Myanmar and South Korea inked the number of deals on economic and infrastructure development during President Moon Jae-in's visit to Myanmar in September this year, including an agreement for a US\$ 1

estate sectors. South Korea has pumped US\$ 3.9 billion worth of investments into 177 projects in the real estate, agriculture, manufacturing, infrastructure, logistics, and construction sectors in Myanmar, accounting for 4.86 per cent of total foreign direct investments in the Southeast Asian country.

Bilateral trade between Myanmar and South Korea amounted tonearly US\$ 800 million in the financial year 2018-2019.

Bilateral trade between Myanmar and the East Asian country reached 2017- US\$866 million in the fiscal year2016-17, US\$ 657 million in 2015-2016 FY, US\$ 862 million in 2014-2015 FY, US\$ 1.57 billion in 2013-2014 FY, US\$ 623 million in 2012-2013 FY, and US\$ 667 million in 2011-2012 FY, according to the statistics from the DICA.

## Brighton boss Potter signs contract extension

LONDON (United Kingdom)
— Brighton manager Graham
Potter has signed a contract
extension until 2025, the Premier League club announced
on Tuesday.

The club, in their third straight season in the English top flight, are currently 12<sup>th</sup> in the table after four wins in 13 games.

Potter's assistant Billy Reid, first-team coach Bjorn Hamberg and assistant head of recruitment Kyle Macaulay have all also agreed contract extensions until 2025.

The three members of the backroom staff joined Potter in moving from Swansea after he replaced Chris Hughton in May.

"I'm thrilled that the club have liked what they've seen so far, in a relatively short period of time, and have already shown an added confidence in

what we are trying to do," said Potter, who initially signed a four-year deal.

# Ex-Liverpool star Alonso acquitted of tax fraud

MADRID (Spain) — Former Liverpool midfielder Xabi Alonso has been acquitted of tax fraud, a Madrid court announced on Tuesday.

The prosecutors had intially demanded for him to face five years in jail before halving their request.

Alonso, a World Cup winner with Spain in 2010, was accused of using a company based on the Portuguese island of Madeira to avoid paying 2 million euros (\$2.2 million) in taxes on his image rights to the Spanish authorities.

Prosecutors said the fraud took place between 2010 and 2012 when he was playing for Real Madrid.

The court added it was impossible to discuss a cover-up as the transfer of the rights had

been 'formalised in the contract' signed in 2009 between Alonso and the Portuguese firm.

Alonso, who retired from playing in 2017 after a stint at Bayern Munich, is one of a string of high-profile footballers to face scrutiny by the Spanish tax authorities over the declaration of income from image rights.

Some have admitted fraud as part of a deal to avoid jail time, including Atletico Madrid striker Diego Costa and Barcelona's Gerard Pique, both of whom paid out after being convicted over the summer.

And earlier this year, the tax authorities caught up with Juventus attacker Cristiano Ronaldo and Tottenham coach Jose Mourinho, both over the management and declaration of image rights.—AFP
