Farmer rights leading committee to double down on promoting agricultural industries



Van Thio, in his capacity as the chairman of the Leading Committee for Farmer Rights Protection and Enhancement of their Benefits, asked committee members to help local farmers, who are witnessing a decline in markets for crops and fisheries products.

The meeting was held at the Ministry of Agriculture, Livestock and Agriculture in Nay Pyi Taw yesterday afternoon.

The Vice President also said local paddy farmers are suffering a downturn in foreign demand, and that the recommendation committee for rice market has fixed the floor price of paddy for 2019-2020 financial year.

Under the article 23 of the

Law of Protection of the Farmer Rights and Enhancement of their Benefits, the leading body has announced the price at K0.5 million per 100 baskets on 15 October 2019 with the approval of the Union government to be able to subsidize the farmers if the market paddy price declined under this rate by using the K15 billion operating budget of the State. The Vice President also urged the Chairman of Nay Pyi Taw Council and the chief ministers of State/Regions need to facilitate the working groups in purchasing paddy/rice.

The government has permitted export 0.2 million tonnes of Lone Thwel paddy from October to December 2019 to address the excess stockpile of paddy in the

local market, and the volume of export would be increased to 0.5 million tonnes by 31 January 2020.

He also advised the sugar-cane farmers who are suffering from the impact of freezing sugar market by preventing re-export sugar, illegal import and controlling import sugar for the actual need. A decline of price and excess stockpile of sugar in the local market have pulled down the price of sugar-canes by K2,000 to K5,000 per tonne.

The Vice President added Myanmar has seen a positive trend in export of livestock products, with over 40 countries of destination, and the EU could help export of fishery products from 24 processing factories.


Pyidaungsu Hluttaw discusses one report, approves another by committee scrutinizing the Constitution

Myanmar started implementing the National Residue Monitoring Plan (NRMP) in 2014-2015, and the 17 factories under this programme are exporting farm fishery products.

The Emerald Village (Fishery Sector) programme is providing K30 million to each village for creating job opportunities, promoting family incomes of rural people and alleviation of poverty.

The Vice President continued the updated version of Farmland Law 2012 which will be published which will come into effect with the approval of Pyidaungsu Hluttaw in near future.

In accordance with the objectives of the Law of Protection of the Farmer Rights and Enhancement of their Benefits, mentioning 'to provide aids as much as possible for loss and damage caused by any natural disaster', the government has already given over K7.32 billion for the damaged crop acres 379,964.14 from the emergency budget, and K3.02 billion for the 302,315 acres is being released to the farmers.

In his conclusion, the Vice President suggested cooperation of work committees and groups, together with the private sector, to promote the benefits of farmers.

U Thura Aung Bo, Chief



fication plans which aims to provide electricity to 5.98 million households (55% of nationwide number) in 2021-2022 FY, to 8.26 million households (75.95%) in 2025-2026 FY, and to 10.45 million households (96.07%) in 2030-2031 FY. He

said the remaining 0.43 million households (3.93%) will be provided with alternative energy sources.

The Chief Engineer said they will commemorate the achievement of supplying electricity to half of the households in the entire country by 12 and 13 December in Nay Pyi Taw and other states and regions. MoEE officials then replied to questions from the media. — MNA

AN OPENING Ceremony in honor of the 2nd Myanmar Development Effectiveness Roundtable took place at the Myanmar International Convention Center in Nay Pyi Taw in this morning. Vice Chair of the Development Assistance Coordination Unit(DACU) and Union Minister for Investment and Foreign Economic Relations, U Thaung Tun, delivered the keynote address.

Union Ministers, Chair of the Nay Pyi Taw Council, Chief Ministers of States and Regions, Deputy Ministers, Hluttaw members, Permanent Secretaries, Directors-General, Ambassadors, Development Partners, domestic and international private sector representatives, NGOs, INGOs, and invited guests totaling in excess of 500 people, attended the ceremony.

The Minister also emphasized the implementation of Myanmar Sustainable Development Plan, supported by the establishment of key institutional mechanisms including the Project Bank, the Land Bank, a new Public-Private Partnership (PPP) Center,

and Central Transformation Unit. The Minister also warmly acknowledged development partners' support to the development of a MSDP National Indicator Framework.

The Minister went on to highlight a number of key economic reform related achievements under the guidance of the MSDP, including the creation of a more investment enabling environment, increasingly openness of the insurance and banking sectors, the implementation of the legal framework supporting Intellectual Property Right, and the establishment of a Competition Commission. The Minster also underscored Myanmar's remarkable achievement noting that Myanmar was recognized as one of this year's 20 most improved economies on the World Bank's Ease of Doing Business Index.

The Minister explained the government's commitment to achieving universal health coverage by 2030, and National Health Plan (2017-2021) which led to the achievement of a 90 percent reduction in Malaria cases, and with85 percent of eligible HIV/AIDS patients received the life-saving drugs. Furthermore, monthly cash payments to pregnant women as part of the Government's "1,000 days" are leading directly to

significant health improvements to mother's and their babies.

The Minister also high-lighted linkages between the National Strategic Plan for the Advancement of Women 2013-2022, and the newly drafted Prevention and Protection of Violence Against Women Law, and the newly enacted a new Child Rights Law, and the empowerment of Women in Myanmar more broadly.

The Minister concluded his remarks with 3 key messages, the first being the crucial role of partnerships between development partners, the private sector and civil society in order to attain the goals outlined in the MSDP. The second, message noted the need for more systematic and well-structured Strategic Coordination Groups to facilitate MSDP implementation and monitoring. The third message noted that Myanmar must seek to use Official Development Assistance (ODA) wisely and in ways that can draw additional private sector financing for sustainable development.

The opening ceremony was followed by 2 Roundtable Discussions. The first Roundtable Discussion on "Coordinating Assistance in Support of Myanmar's National Development Priorities", was

moderated by Mr. Newin Sinsiri, Asian Development Bank Country Director. Deputy Ministers for Planning, Finance and Industry U Set Aung and U Min Ye Paing Hein, Daw Si Si Pyone, Director General of Treasury Department, and Daw Thway Thway Chit, **Director General of Planning** Department, shared updates relating to the implementation of MSDP, and the Project Bank online portal and associated project financing mechanisms.

Moderated by U Than Aung Kyaw, Director General of Foreign Economic Relations Department, Ministry of Investment and Foreign Economic Relations, a second roundtable discussion was continued by the remarks given by the United Nations, USAID, the Myanmar CSO Partnership for Aid and Development Effectiveness, Union of Myanmar Federation of Chambers of Commerce and Industry, AustCham Myanmar, and the INGO Forum. In their remarks, they expressed their commitments to support the future Myanmar's development program and shared experiences, views as to how to strengthen a new set of Strategic Coordination Groups in support of more effective cooperation.

Following that, the sum-

maries of previous day discussions were presented by the co-moderators.

The second Roundtable Discussion focused on" Main streaming the Myanmar Sustainable Development Plan" moderated by Dr. Wah Wah Maung, Director General, Ministry of Planning, Finance and Industry. U Hla Moe Aung, Chief Minister of Ayeyarwady Region and U Saw Bo Bo Wai Maung, Social Affairs Minister of Kayin State, discussed investment opportunities, cooperation programs and future development prospects of their respective States and Regions.

Then, U San Myint, Director General of Central Statistical Organization, Ministry of Planning, Finance and Industry, U Than Aung Kyaw, Director General of Foreign Economic Relations Department, Ministry of Investment and Foreign Economic Relations, and Mr. Gordon Johnson, United Nations Development Program Resident Representative, presented a proposed National Indicator Framework to support the financing, monitoring and evaluation of the Myanmar Sustainable Development Plan, and revitalizing the new set of Strategic Coordination Groups which development are now being planned

The sessions were followed by open dialogue between all participants.

Union Minister U Thaung Tun provided remarks during the closing session. In his remarks, the Minister expressed appreciation to all parties including development partners, CSOs, NGOs, INGOs, UMFCCI and the private sector, officials and all concerned person who have continued to support Myanmar's development agenda and reform process, as well for assistance which made possible this most successful event. The Minister committed to continue closely collaborating with development partners in support of Myanmar's development journey.—MNA

Ensuring safety of workers

IN ACCORDANCE with the 1959 Employment Restriction Act and the 2013 Employment and Skills Development Law, the Ministry of Labour, Immigration and Population has granted licenses to local employment agencies registered with the Investment and Companies Administration Department.

Under Section 35 of the 2013 Employment and Skills Development Law, those found guilty of offering employment services illegally or operating without a license can be sentenced to up to three years in prison or fined, or both.

Hence, those who wish to operate local employment agencies should apply to the ministry for a license, in accordance with the set rules.

Meanwhile, the ministry has invited complaints against illegal employment agencies and licensed employment agencies flouting rules set by the government. Agencies found breaking

the rules will be charged in accordance with the 2013 Employment and Skills Development Law.

Local and overseas employment agencies are required to act in an ethical manner, remain transparent, and refrain from committing labour violations when dealing with workers and international employers.

The law prohibits offering of illegal employment services.

This shows how the Union Government has not neglected the migrant workers, and continues to protect them. The employment business is not a trade, but involves human beings.

Developing countries likes Myanmar are facing shortage of jobs for youths due to the impact of climate change and disasters. Youths and children are leaving

schools and working as domestic help, while low employment rates and low salaries in the domestic market have forced young workers in Myanmar to seek jobs overseas.

This situation has alerted governments in developing countries to become more serious about enforcing existing laws to prevent exploitation of workers and to provide them safety and

The ministry is making concerted efforts to create more employment opportunities for both domestic and overseas job hunters through an online labour exchange management system.

At the same time, all citizens need to refrain from operating illegal businesses to ensure the safety of workers, or face legal

As for employment agencies securing domestic jobs, those agencies that do not follow the directives and rules set by the Ministry of Labour, Immigration and Population can get their business license revoked and face legal action, depending on the gravity of their offense.


Prioritizing Livestock Diseases among ASEAN

OWADAYS, there diseases which are listed as emerging, endemic, zoonotic, reemerging and pandemic diseases. Some could produce a huge impact on livestock production and productivity; some make harm to human health; some could make a problem to companion animals and its associates. As ASEAN is an official community to combat all issues which arise among the region, it needs to work together to obtain the benefit of the region. The issue of livestock diseases become threatening not only trade but also social-economic aspect. Therefore, Member States of ASEAN agree to categorize the prioritization of livestock diseases in term of the severity, technical, socio-economic aspect and human health.

and socio-economic impact, the transboundary animal diseases have been revealed as paramount important livestock diseases in the ASEAN. According to regional tripartite workshop based on individual country priorities, the prioritized diseases are Foot and Mouth Disease (FMD), Porcine Reproductive and Respiratory Syndrome

Concerning public health

(CSF), Highly Pathogenic Avian Influenza (HPAI) and Bovine Spongiform Encephalitis (BSE) while the recognized major diseases are Rabies, Influenza, Anthrax, Leptospirosis. Based on the consideration of zoonosis and social-economic impact (PRRS), Classical Swine Fever by the ASEAN Member States,

the disease control strategies and the follow-up action plan are aimed to developed for the prevention and control of the diseases among the community. Improving multisectoral coordination networks could strengthen for reducing the risk of those diseases. Being a member state

of ASEAN, Myanmar has also proclaimed the list of prioritized diseases for One Health. These are HPAI, Rabies, Tuberculosis, Foodborne Pathogen, and Japanese encephalitis which is not consistent for the whole region because of different background status, different veterinary in-

frastructure and different social economy status.

ASEAN Veterinary Epidemiology Group was officially urged to review the transboundary animal diseases in 27th Meeting of ASEAN Sectoral Working Group on Livestock in April 2019. The process included organizing a training of trainers, a facilitator training for disease prioritization workshop. The methodology was provided by the US CDC and the financial support was provided by FAO and US CDC. During the training, a total of 17 facilitators from 7 Member States and two Plus Three countries. Before the disease prioritization workshop, a total of short list of livestock diseases are proposed by the Member States at least two months ahead and 49 diseases out of 90 proposed disease are selected by online voting of Member Countries. During the workshop, voting members representing Member States agree to set five criteria: economic and trade impact; epidemic/pandemic potential/epidemic in the region; zoonotic potential and public health impact; prevention, control and mitigation and social, ecological, environmental impact in prioritized order. The pre-selected 49 diseases are

prioritized by using the set of criteria and the final result revealed that Anthrax, HPAI, Salmonellosis, Haemorrgagic Septicaemia and Rabies are top five prioritized disease by Member States. It was reported to ASEAN Veterinary Epidemiology Group (AVEG) meeting for further steps. On the prioritized list of the 5 diseases, all except salmonellosis are already on the list of Animal Health and Development Law endorsed by Myanmar Government.

Finally, it is suggested to promote the awareness of livestock industry stakeholders on the transboundary animal disease, and to enhance the collaboration and knowledge sharing in ASEAN for One Health including active participation with immediate reporting on any suspicious. At the same time, the support of the Ministry of Agriculture, Livestock and Irrigation especially Livestock Breeding and Veterinary Department is crucially important to focus not only for the prevention and control of the livestock diseases but also for the social-economic impact for both national and regional interests with relevant resource expertise and applicable logical **MYANMAR GAZETTE**



Over 93,000 tourists visited Mandalay Mahamuni Pagoda in five months

Import slips to be issued to 115 bus owners for de-registering vehicles

THE applications of 115 out of 156 bus owners who had sought import slips for family-use cars in exchange for de-registration of their buses, manufactured in 1999-2003, have been approved by the Union government, said U Hla Aung, joint secretary of the Yangon Region Transport Authority (YRTA).

"For the first time, the Union government has permitted de-registration of 112 city buses and three mini buses. Concerning those buses, we have conducted de-registration of CNG and GPS and are checking the vehicle's punishment according to the procedures. Then, the de-registration process will be carried out," said U Hla Aung.

Currently, the YRTA is scrutinizing about 156 buses, for which requests have been received for issue of import permits for family-use cars in return for de-registration. Then, a report will be submitted to the government for processing the applications as special cases, he added.

The Ministry of Transport and Communications has granted the Yangon Region government's request to grant import slips and de-register buses from the 1999 to 2003 model years. which are in poor condition in terms of energy efficiency and which do not match the city's features. Bus lines have been informed about this move. Currently, there are more than 700 YBS buses that were manufactured between 1999 and 2003. If the buses are de-registered and the owners are granted import slips, they will have to surrender their Compressed Natural Gas (CNG) purchase permits.

"CNG is being provided for cheaper transportation of passengers. So, they will have to surrender the CNG permits. And this has been practiced for a long time," said U Hla Aung.

The Union government has been granting the de-registration of old vehicles since 2011. Only buses from the 1999 model year can be de-registered. For the de-registration of 20-year-old vehicles, import slips are being issued depending upon the type of vehicles. For example, if owners de-register buses, bus import permits are issued to them and if they de-register trucks, truck import permits are handed out. (Translated by Hay Mar)

Wood sculpture competition held

THE 'world's biggest wood sculpture competition' concluded with a presentation ceremony yesterday at the Shwe Pyi Resort in Bago.

The purpose behind holding the eighth edition of the competition was to encourage the next generation of wood sculptors and to improve the Myanmar sculpture industry, said the organizers. This year, 222 sculptors from 20 townships entered 227 wood sculptures for the competition.

The winners and runners-up of the optional wood sculpture competition were awarded a half-tical of gold each. The winner also received K10 million, the first runner-up K7.5 million, and the second runner-up K5 million. Ten consolation prize winners were awarded K1 million each.

Dollar exchange rate dips to K1,500 on strong export market

THE US dollar has been sliding against the Kyat in the local currency market, with the exchange rate touching a low of K1,500 per dollar on 5 December, a decline of about K30 compared with October-end, said money exchangers.

At the end of October, the rate was pegged at K1,530. While the US dollar index was above 97 in the global market, the exchange rate slipped to K1,503 on 4 December and K1,500 on 5 December in the local forex market.

"It is normal for the dollar to depreciate against the Kyat this time of the year. At present, exports of rice and pulses are increasing, and the demand for the dollar is falling in the market. The dollar rate is likely to remain

cool and it seems it may not climb up," said a money exchanger.

The dollar has depreciated even though the Central Bank of Myanmar (CBM) has been buying about 3 million dollars per day from private banks to govern the market since 27 November. The CBM had set the reference exchange rate (weighted average market rate) at K1,500.7 per dollar on 5 December.

In October last year, the dollar exchange rate had hit a high of K1,600. Thereafter, the dollar has been falling in the local currency

With the Kyat gaining against the dollar in the internal forex market, domestic gold price plunged to K1.185 million per tical (0.578 ounces, or 0.016 kilograms) on 5 December from a record high of K1.3 million in early September.

This year, the exchange rate stood at K1,540 on 1 January and fell to a low of K1,515 on 15 January. It continued to drop and reached K1,503 on 28 February. Thereafter, it rose to K1,527 on 18 March and K1,538 on 14 May. The rate stood at K1,259 on 1 June and K1,514 on 26 August. Then, the dollar exchange rate hit a peak of K1,565 on 6 September. It was pegged at around K1,528-1,537 in October. Last month, the rate moved in the range of K1,510-1,524. —Ko Htet

FDI up \$900 mln against previous fiscal

MYANMAR attracted more than US\$1.3 billion in foreign direct investments during the first two months of the current fiscal, an increase of \$900 million compared with the corresponding period of the previous FY, said U Thant Sin Lwin, Director-General of the Directorate of Investment and Company Administration (DICA).

Between 1 October and 30 November, FDI of \$1.39 billion flowed into the country, including expansion of capital by existing enterprises. According to a press statement issued by the DICA, 41 foreign enterprises obtained permits from the Myanmar Investment Commission (MIC) and endorsements from regional and state Investment Committees in the current fiscal, bringing in a capital of \$1.35 billion.

In the year-ago period, the FDI inflow was recorded at just \$465.9 million from 34 enterprises.

"As large projects were allowed in the current fiscal, investments grew," said U Thant Sin Lwin.

"Infrastructure projects such as industrial parks and

urban development projects are bringing investments into the country," he said.

There is investment potential for large businesses, he added.

Moreover, once offshore oil and gas and mining projects are approved in the current FY, heavy enterprises will enter the country, said U Thaung Tun, Union Minister for Investment and Foreign Economic Relations, at the 30th regular meeting of the Vice President U Myint Swe with private entrepreneurs, held on 19 October at the Republic of the Union of Myanmar Federation of Chambers of Commerce and Industry office.

The ministry is inviting responsible businesses to the country.

The Myanmar Investment Promotion Plan (MIPP) was drawn up with the assistance of the Japan International Cooperation Agency (JICA) and it is being implemented. As per the MIPP, Myanmar aims to reach an FDI target of \$200 billion in 20 years, said U Thaung Tun.

In the current fiscal, the MIC has set an FDI target of \$5.8 billion.

Hong Kong firm to invest \$350 mln in Mindama Complex project

HONG Kong's Goldman Fortune International Limited will put in more than US\$350 million in the Mindama Complex project, said U That Sin Lwin, Director-General of the Directorate of Investment and Company Administration (DICA).

"The Mindama Complex project includes commercial shops, serviced apartments, shopping malls, villas, office buildings, condominiums, and hotels. It will be implemented under a BOT system on 20 acres of land held by the Commander-in-Chief (Army), on Mindama Street in Mayangon Township,

Yangon Region," he said.

The project will be implemented as a joint venture between Hong Kong's Goldman Fortune International Company and Myanmar-based Fortune International Company.

"The Myanmar Investment Commission granted permission for this huge real estate development project after scrutinizing the necessary documents as per the Myanmar Investment Law," U Thant Sin Lwin added.

"We issued the permit only after tight scrutiny. We have asked for permission from the related departments. Moreover, we will review possible social, environmental, and cultural impacts of the project. Earlier, the MIC did not issue approval to certain business proposals which could potentially affect the environment and cultural heritage," said U Thant Sin Lwin.

Hong Kong topped in the list of investors in the first two months of the current financial year, pumping in over \$1 billion into real estate development, electricity, and garment businesses, according to data from

The total foreign direct investment stood at \$1.39 billion as of 29 November in the current financial year.

Singapore-based Green Urban Development Co to use 3% of profit for CSR activities

Made up: Japan cosmetic giant Shiseido gambles on 'Made in Japan'

TOKYO — On wasteland once used for earthquake drills in the small town of Otawara north of Tokyo, Japanese giant Shiseido has built its first domestic factory in 36 years, hoping to capitalise on a boom for "Made in Japan" cosmetics.

The Japanese cosmetics industry faces huge competition not only from established players such as L'Oreal and Estee Lauder but increasingly also from the "K-beauty" craze coming from South Korea.

Nevertheless, Japan is more than holding its own, with exports nearly quadrupling since 2013 to 546 billion yen (\$5 billion), according to finance ministry figures, nearly twothirds of that going to China and Hong Kong.

The domestic industry is also benefitting from an explosion of inbound tourism in recent years ahead of the 2020 Tokyo Olympics — in particular a relaxing of visa requirements for Chinese tourists who lap

up the latest Japanese cosmetic fads.

Shiseido chief executive Masahiko Uotani told AFP that a focus on the high end of the market and time-honoured attention to detail set them apart from

the foreign brands seeking to dominate globally.

"We are focusing on prestige, premium brands. Consumers in those categories see the value of Japanese culture," said Uotani.—AFP■

Artists cash in on China's online sticker craze

BEIJING — When "Silly Piggy" appeared in China's popular WeChat social media app, the sticker became an instant hit, with people sending it more than 30 million times in its first month to express their feelings in text messages.

Stickers like the mischievous cartoon pig and other quirky creatures are all the rage in China, giving the artists behind them a way to make money and win fans — as long as they stay within the bounds of censorship.

The creator of Silly Piggy, River Rui, was able to leave her office job with a design firm and set up as an independent artist thanks to the success of the character.

"Silly Piggy' is more like how I am in my little world, how I interact with my friends, it's that 'Silly Piggy' kind of style," Rui told AFP.

The pig has many moods: he types furiously at his desk as tears stream down his face. He lays flat on the office floor as his spirit leaves his body.

"Basically anyone who has done overtime will have the same feelings as him," said Rui as she doodled on a scrap of paper in a Shanghai cafe.

Unlike memes and animated GIFs popular outside China, instant messaging stickers are often original creations of local artists who can see their little characters enjoy spectacular popularity among the country's 847 million mobile internet users and spread offline through commercial licensing deals.

S Korea's Moon requests China's backing of denuclearization

SEOUL — South Korean President Moon Jae In requested China's active support for denuclearization of the Korean Peninsula in a meeting Thursday with visiting Chinese Foreign Minister Wang Yi.

At the outset of the meeting at the presidential office, Moon said that the peace process has reached a "critical juncture" and asked for Beijing's continued efforts for the peninsula to achieve "complete denuclearization" and a "permanent peace regime."

The request comes amid a stalemate in the denuclearization talks between North Korea and the United States, with Pyongyang having set a year-end deadline for progress in the negotiations.

"I am very looking forward to deepening conversation and cooperation of the two countries through the holding of the trilateral summit with Japan this month," added Moon.

China will host the threeway summit between Moon, Japanese Prime Minister Shinzo Abe and Chinese Premier Li Keqiang in the southern city of Chengdu.

In response, Wang said that the goal of his visit to Seoul was to have "strategic communication" with South Korea, adding that there will be more room for improvement in bilateral ties as China continues to open up.

India urges countries to act against 'Kashmir cells' set up by Pak in its foreign missions

NEW DELHI — India has urged international community to take up action against the so-called 'Kashmir Desks' or 'Kashmir cells' set up by Pakistan at its embassies and diplomatic missions in different countries to spread falsehood and radicalise the local population, Minister of State for External Affairs V Muraleedharan said on Wednesday.

In a written reply to the Parliament on a question pertaining to the matter, Muraleedharan said that Pakistan had announced on August 17 that it would set up "Kashmir Desk/ Kashmir cells" at its embassies in different countries.

The minister said that the purpose of the initiative is to incite the local population and radicalise them by spreading falsehood.

"The government has urged foreign countries to realise the dangers posed by these Kashmir cells and take appropriate action in this regard," the statement read.—ANI

Indonesian airline boss to be fired for smuggling Harley parts

JAKARTA — The Indonesian government decided Thursday to fire the head of national carrier PT Garuda Indonesia over his alleged role in the smuggling of Harley-Davidson motorcycle parts into Indonesia from France.

"As the state-owned enterprises minister, I will fire the Garuda president, but because it's a public company, the process of his dismissal must pass through some procedures," Erick Thohir told a press conference regarding President and CEO I Gusti Ngurah Askhara Danadiputra, also known as Ari Ashkara.

The undeclared parts, which

included a complete disassembled motorcycle, were reportedly carried onboard a brand new Airbus A330-900 that departed Nov. 16 from the French city of Toulouse, where it was manufactured, and landed Nov. 17 at Jakarta's Soekarno-Hatta International Airport, where customs officers found them.

In the same press conference, Finance Minister Sri Mulyani said the smuggling of the parts, along with two Brompton foldable bicycles, may have potentially caused state losses up to 1.5 billion rupiah (\$107,000).

Typhoon Kammuri death toll hits 13 in Philippines

MANILA — The number of people killed by Typhoon Kammuri's pounding of the Philippines this week has hit 13, officials said Thursday, as authorities confirmed reports of storm-related deaths.

Kammuri's fierce winds toppled trees and flattened flimsy homes across a swathe of the nation's north on Tuesday, and forced a rare 12-hour shutdown of Manila's international airport.

Authorities said on Wednesday one person had drowned while three died after being hit by trees and flying objects.

Disaster officials did not offer details on how the other victims died, but local police reports indicated some may have drowned or been crushed by trees.

Mark Timbal, spokesman for the national disaster agency, said no new bodies have been found but the death toll could rise as reports on the ground are verified.

"There is the possibility of an increase in the number, but we are hoping against it," Timbal told AFP.

Hundreds of thousands of people living in exposed or low-lying areas were evacuated from their homes before Kammuri made landfall late Monday, which authorities said had saved lives.

Still the storm damaged 135 schools and destroyed nearly 1,200 homes, with crop damage in

the hardest hit areas estimated to reach nearly \$16 million.

The Philippines is hit by an average of 20 storms and ty-

phoons each year, killing hundreds and putting people in distit by aster-prone areas in a state of constant poverty.—AFP

Third general strike keeps pressure on Colombia's Duque

BOGOTA — Thousands of protesters took part in anti-government demonstrations in Colombia's capital Bogota and other cities Wednesday during the country's third general strike in two weeks.

Strike leaders say they intend to maintain pressure on right-wing President Ivan Duque's government, after brushing aside his appeals to cancel the strike on the grounds its effects were crippling the economy.

But crowds were smaller than previous demonstrations as protests took place for a 14th consecutive day.

Some roads were blocked in the capital and in the northeastern city of Cali, but many businesses remained open.

Around 250,000 people took part in the first demonstration against Duque's 15-month-old government on 21 November, when the initial general strike brought the country to a stand-

still. Interior Minister Nancy Patricia Gutierrez estimated that 40,000 people took part in demonstrations across the country on Wednesday, but organizers said

the number of participants was much higher.

"The Colombian people have woken up!" shouted Paola Jiminez, a 41-year-old lawyer taking part in a pot-banging "cacerolazo" demonstration in Bogota.

"Colombians are finding it more and more difficult financially," she said.—AFP■

Stay or go? Four scenarios as Merkel partners debate future

BERLIN — Headed by a new leftist leadership duo, Germany's struggling Social Democrats are gearing up for a crunch congress from Friday that could decide the future of Chancellor Angela Merkel's fragile coalition government.

As SPD members gather to

discuss their demands for keeping the coalition afloat, here's a look at four possible scenarios for the months ahead.

'GroKo' clings on

Incoming SPD leaders Norbert Walter-Borjans and Saskia Esken are critical of Merkel's grand right-left coalition, known as "GroKo" to Germans.

But the pair have stopped short of calling for a vote on whether to stay in the loveless marriage at the December 6-8 congress. Instead, they want to tweak the hard-fought coalition agreement struck with Merkel's centre-right CDU and its Bavarian CSU sister party after 2017's inconclusive general elections.

The duo are expected to ask SPD members to back a slew of new demands, including a higher minimum wage, more investment in Germany's crumbling infrastructure and more ambitious climate policies.

The other two coalition parties have ruled out renegotiating the coalition accord. But Merkel's spokesman has said the veteran chancellor is "open to talks".

If a compromise is struck

and the SPD secures some concessions, the GroKo could survive until Germany's next election in 2021 — allowing Merkel to complete her fourth and final term as planned.

This scenario is seen as most likely by observers as it would also allow the SPD, weakened by a series of poll setbacks, to sharpen its profile under the new leaders before facing voters again.

Merkel-led minority govern-

If it fails to push through its demands, the SPD could pull the plug on the partnership with the CDU/CSU, triggering the coalition's collapse.

Merkel, keen to shape her own political exit after 14 years in power, could then try to head a minority government — a first in postwar Germany.—AFP

Chile's lower house passes "anti-looting, anti-roadblock" bill

SANTIAGO — Chile's Chamber of Deputies on Wednesday approved a bill aimed at stamping out violent protests such as looting and roadblocking.

The bill makes it a crime to paralyze or disrupt basic services such as public or emergency transportation, hurl "sharp or cutting" objects such as knives, or destroy or occupy buildings of religious, scientific or social significance. Once enacted, those violating the law could be subject to up to five years in jail, depending on the severity of the crime.

The "anti-looting and anti-roadblock" bill was passed overwhelmingly, with 127 votes in favor, 7 against and 13 abstained. It now goes to the Senate. "We have to separate peaceful protest, which is a right we have to respect, from the commission of serious crimes by these groups that are causing so much damage in an organized way," Interior Minister Gonzalo Blumel said. Chile has been roiled by anti-government protests since a mid-October hike in subway fares in Santiago.—Xinhua ■

Floods kill 280 people, affect 2.8 mln others in East Africa: UN

NAIROBI — At least 280 people have been killed and more than 2.8 million others affected by unusually heavy rainfall and flooding in eastern Africa, the UN humanitarian agency said on Thursday.

The UN Office for Coordination of Humanitarian Affairs (OCHA) said homes, infrastructure and livelihoods have been destroyed and damaged in the hardest-hit areas, and the risk of communicable diseases including cholera is rising.

"Primarily driven by the Indian Ocean Dipole (IOD), the heavy rains are likely to persist into December and to intensify in Kenya, Tanzania and Uganda," OCHA said in its latest regional Flash Floods Update. The UN agency said the annual short rains which ordinarily last from October to December have been exceptionally heavy in Kenya and affected more than 160,000 people in 31 of the country's 47 counties. — Xinhua

Two killed in shooting at Hawaii's Pearl Harbor base

LOS ANGELES — A US sailor fatally shot two people and wounded a third at the Pearl Harbor Naval Shipyard in Hawaii on Wednesday before taking his own life, a senior Navy officer said.

The base was locked down for more than an hour after the shooting, according to a statement issued by the facility, while Navy officials said they were investigating what prompted the attack.

"I can confirm that there were three shooting victims. We have confirmed that two are deceased, one is in stable condition in a local hospital," said Rear Admiral Robert Chadwick.

He added that the shooter --

"tentatively" identified as a sailor assigned to the USS Columbia, a Los Angeles-class attack submarine — had also died after "an apparent self-inflicted gunshot wound." One witness told local media he was sitting at his computer when he heard shots fired and rushed to the window, where he saw three victims on

the ground. The witness, who did not want to be identified, said he then saw the gunman, who was wearing a sailor's uniform, shoot himself in the head.

White House spokesman Hogan Gidley said that US President Donald Trump had been briefed on the shooting and was monitoring the situation.— AFP ■
