Next, Daw Nan Htwe Thu of Pasawng constituency, U Win Myint Oo (a) U Nay Myo of Nyaungshwe constituency, U Sai Saing Mai of Mongkai constituency, U Lama Naw Aung of Injangyan constituency, Daw Yin Min Hlaing of Gangaw constituency and U Sai Okker of Laikha constituency

discussed a motion tabled by Daw Nan Kham Aye of Namtu constituency urging Union, State/Region governmental departments to post particulars about tenders invited, tender winning company and the tender work conducted until completion.

In discussing the motion Deputy Minister for Construction U Kyaw Lin said the matter was repeatedly mentioned in construction work assessment committee meetings but some relevant ministries and personnel from state/region governments reported on lack of technical expertise while there were weaknesses and difficulties in capacity building. The ministry was announcing tenders in state own media as well on ministry website and social media. To ensure transparency, sign boards providing particulars of the construction works such as construction work type, tender value, responsible engineer, particulars about the work, contact department/company etc. were instructed to be setup and recommended the motion to be approved. As there was no objection, Pyithu Hluttaw Speaker announced the motion approved by the Hluttaw.

Committee annual reports read and submitted and another committee annual report approved

Later Pyithu Hluttaw transport, communication & construction committee annual report Pyithu Hluttaw International Relations committee annual report were read by committee secretary Daw Yin Min Hlaing and committee member U Myo Zaw Aung respectively.

After the reports were read, Pyithu Hluttaw Speaker announced for Hluttaw representatives who want to discuss the report to register their names.

As a final agenda of the day Pyithu Hluttaw health and sports development committee secretary Dr Than Win tabled a motion for the Hluttaw to agree and accept the committee annual report.

Receipt of three bills amending three election laws

Next, Amyotha Hluttaw Speaker Mahn Win Khaing Than informed the Hluttaw of the receipt of bill amending Pyithu Hluttaw Election Law for the fifth time, bill amending Amyotha Hluttaw Election Law for the fifth time and bill amending State/Region Hluttaw Election Law for the fifth time returned with amendments by Pyithu Hluttaw

and announced for Hluttaw representatives who want to discuss the bills to register their names.

Hluttaw approve Vehicle Safety and Management Bill

Following this, Amyotha Hluttaw Bill Committee member reread and explained the committee's report on Vehicle Safety and Management Bill. Amyotha Hluttaw Speaker then obtained the decision of the Hluttaw on the bill clause by clause and approves it.

Later Deputy Minister for Transport and Communication U Kyaw Myo tabled a motion for the Hluttaw to approve the bill as amended. As there was no objection when Amyotha Hluttaw Speaker obtained the decision of the Hluttaw to approve the motion, Amyotha Hluttaw Speaker announced the Vehicle Safety and Management Bill approved as amended.

Deputy Amyotha Hluttaw Speaker gives religious funds, relief items in Rakhine State

DEPUTY Speaker of Amyotha Hluttaw U Aye Tha Aung, in his capacity as the chairman of Rakhine State Stability Supporting Committee, presented cash funds for installation of an elevator at the ancient Yin Yoe pagoda in Angu village of Myebon Township, and he also gave relief items for the internally displaced persons in that township of Rakhine State yesterday.

The Deputy Speaker and party arrived at Sittway Airport at 8:30 am. They were welcomed by the State Security and Border Affairs Minister Colonel Min Than, Rakhine State Advocate-General U Kyaw Hla Tun and officials.

The cash donation ceremony for installation of elevator was held at the meeting hall of

Rakhine State government villa, and it was attended by committee's Vice Chairman and Union Minister for Information Dr Pe Myint, its Secretary and Deputy Minister U Tin Myint, the committee members, departmental officials and Yin Yoe pagoda's board of trustee.

At the ceremony, the Deputy Speaker donated K15 million for the elevator.

He also provided relief assistance at the same venue for the IDPs in Rakhine State, and said the government is giving aid to the civilians fled from armed conflicts as they are facing problems in livelihood, social, education and health services.

Union Minister Dr Pe Myint also explained the process of

Rakhine State Stability Supporting Committee in producing its report for peace, stability and security of the State.

Rakhine State Chief Minister U Nyi Pu briefed on his government's works in providing humanitarian assistance to IDPs and measures to end ongoing problems in the State.

At the ceremony, Chairman U Aye Tha Aung handed over K12,734,400 to purchase two-week rice ration for 3,032 IDPs from 802 families.

Deputy Minister U Tin Myint also explained the government's plan to provide assistance in the future.

The Rakhine State Stability Supporting Committee and the Rakhine State government then held a meeting at the meeting

hall of villa.

The Chairman said that the visit of his committee was to witness developments in Rakhine State for producing a report which is in the stage of third draft.

Union Minister Dr Pe Myint also advised to present actual situations in administration, security, peace and armed conflicts to be able to produce an accurate report.

The Chief Minister of Rakhine State updated on armed clashes, security measures, IDP camps and relief aid at these camps, followed by the discussions of Rakhine State government members, the secretary and members of Rakhine State Stability Supporting Committee and officials.

The Committee's Chairman also held a meeting at the same venue with the local dignitaries, including political parties, organizations, committees, town elders, businesspersons and departmental officials.

At the meeting, he sought advice of local people to be able to end armed conflicts and establish a peaceful community in the State, and said their discussions will be put into the committee's report.

At 3:30 pm, Chairman U Aye Tha Aung met with Rakhine State Hluttaw Speaker U San Kyaw Hla at the State Villa, and separately held talks with representatives from political parties for their advice on stability of this State.—MNA

organizes the Conflict Resolution Training (Core Mediation) course.

The opening ceremony of the course was held at the training hall of UEC in Nay Pyi Taw yesterday morning, and it was attended by members of UEC and its officials, trainees from State/Region Election Commission offices, representatives of the NIMD/Demo Finland and the trainers.

ministries for ensuring effective production, and called for manufacturing marketable products, success of joint-venture lines, avoiding environmental damages and full-capacity of factory workers.

ACC takes legal actions against township administrator, executive engineer

THE Anti-Corruption Commission has submitted a first information report to file a lawsuit at the police station of Thaton Township in Mon State against a former administrator of the town and its municipal executive engineer on 9 December.

Former Thaton Township Administrator U Thein Win (now in Mabein township of northern Shan State with the same rank) and Municipal Executive Engineer U Tin Tun were accused of breaching President Office's directive for tender rules (1/2017) in building apartments for Hluttaw office, installation of 500 LED street lights and construction of a 80ftx20ft bridge in Daybarein Village in Thaton Township.

The Township Administrator withdrew K50 million from the 2018 mini budget for rural development fund of Mon State government, and kept it in the account of his Township General Administration Department.

After forming a committee for procurement and installation of LED street lights, Thaton Township

Municipal Executive Engineer U Tin Tun, as a head of committee, purchased 500 sets of 100 Watt LED Street Lights and 10 sets of 24 Hour Timer Complete at a total cost of K48 million from a company at Bawga Thiri Highway Bus Terminals in Pyinmana Township, Nay Pyi Taw.

The Township Administrator paid only K46 million to the company through the executive engineer and kept the remaining K2 million corruptly. The latter, however, signed the receipt of K48 million for the approval of accountant with the back-date.

Although the Township Administrator released the remaining K2 million to the Executive Engineer and the latter received it, the ACC decided the scandal was meant to commit corruption, and took actions against both of them under Article 56 of the Anti-Corruption Law at the Thaton Township Police Station.—MNA

Yangon

Supporters of State Counsellor rallied in front of the City Hall and the Maha Bandoola Park in Yangon yesterday.

People from four districts in Yangon gathered near headquarters of Myanmar Medical Association, Thakin Mya Park in front of Bothataung Pagoda and Myoma Kyaung Street in the morning and marched towards the Yangon City Hall, holding national flags and placards.

At the rally, people saluted the national flag, sang national anthem, read the messages sent by the great religious groups, and prayed for a success.

Well-wishers also donated foods and soft drinks to the people in the rally. The hearing at ICJ was also broadcast with the use of a LED Board in front of the Maha Bandoola Park.

Daw May Thwe Oo, a supporter from South Okkalapa Township, said, "To reject the false allegation against our country, State Counsellor, as a leader of our country as well as on behalf of the nation and people, is going to defend it. We rallied to show that we are together with her and in support of her."

Mandalay

Over 300,000 people joined rally in support of State Counsellor at the Chanmyathazi Airport in Mandalay.

The mass rally comprised of eighteen ethnic groups, social organizations, teachers, students and ethnic civilians is supporting Daw Aung San Suu Kyi who is contesting the

- In order to prevent and eradicate the dangers of narcotic drugs and psychotropic drugs, the Office of the President has formed the Drug Activity Special Complaint Department on 26 June 2018 to systematically accept and respond to reports on drug abuses and other related cases from the general public.
- With orders from the Office of the President, the Drug Activity Special Complaint Department relayed information on reports on drug-related offenses up to 7 December 2019 to the Ministry of Home Affairs to take action, as displayed below:

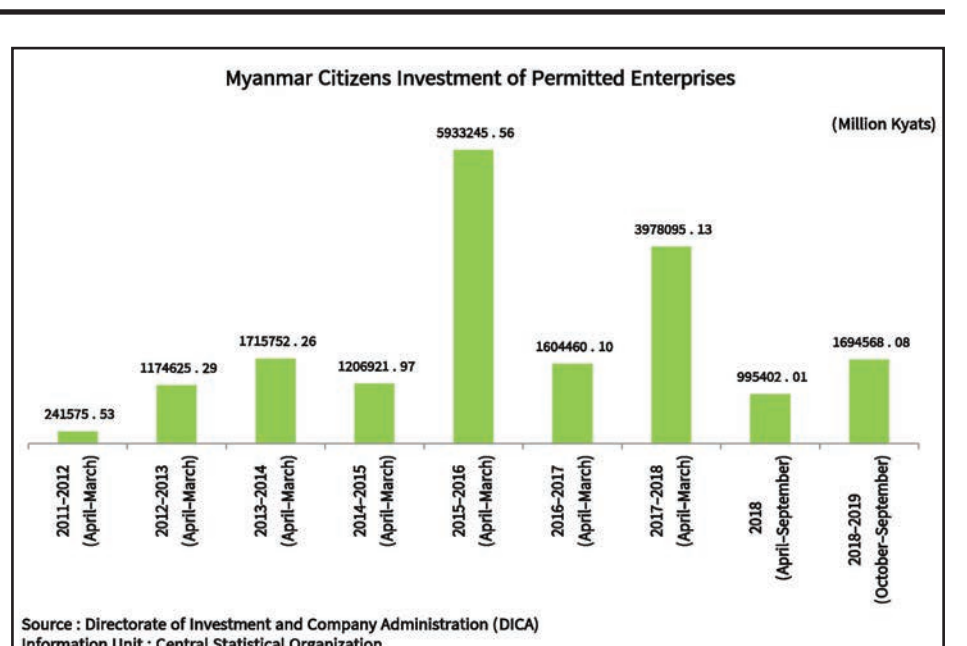
- Out of the information sent to the Drug Activity Special Complaint Department, so far a total of 883 cases have been opened files as of 7 December 2019. A total of 1353 people, including 1,132 men and 221 women had been arrested with 7,154.3694 g of heroin, 1,347.32 g of ICE, 39,999.61 g of opium, 389.92 g of low-quality opium, 53230.76 g of speciosa powder, 12097.32 g of speciosa, 2.5 liters of liquid speciosa, 431,336 stimulant tablets, 8,757.42 g of marijuana, 0.1 liters of opium tincture, 520.28 g of opium blocks, 60 g of poppy seeds, 36.15 g of crushed stimulant tablet powder, 0.001 g of crushed ecstasy powder, 19 firearms, different kinds of 257 cartridges and one grenade. Efforts for fighting the drug trafficking has been stepped up and the department will report on further exposed cases.

MLF asks government to suspend live pig, pork products import

THE Myanmar Livestock Federation (MLF) has asked the government to temporarily restrict the importation of live pig and pork products as a preventive measure against African Swine Fever (ASF) and to reduce losses of local pig breeders.

The request was made at the 31st regular meeting of entrepreneurs with the Private Sector Development Committee, led by Vice President U Myint Swe, which was held on 8 December at the Republic of the Union of Myanmar Federation of Chambers of Commerce and Industry.

At the meeting, Dr Mya Han, chair of the MLF, and U Aung Soe Min Kyaw, secretary of the Myanmar Pig Breeders Association, also forwarded requests for provision of technical and fi-

ancial aid to local breeders, and grant of land permits, and sought help to establish a stable market and purchase purebred GGP-GP animals. They also urged the government to strictly clamp down on illegal imports of live pig and pork products through the border gates and international airports.

In August this year, ASF infection was reported in Mongla area of eastern Shan State, Myanmar, prompting neighboring countries China and Thailand to ban Myanmar's pig and pork products.

ASF has been detected since August, 2018 in some northeastern provinces, central provinces, and eastern provinces of China, including Yunnan Province, which is adjacent to the Myanmar border. As per an announcement

from China's Ministry of Agriculture and Rural Affairs, the ASF outbreak started in Liaoning Province on 3 August, 2018 and spread to 32 provinces and counties within 10 months, with a total of 163 outbreaks registered. More than 1.1 million pigs were slaughtered to control the infection.

The Food and Agriculture Organization declared on 29 May that African Swine Flu had touched Menghai County in Xishuangbanna Dai Autonomous Prefecture of the People's Republic of China. The area borders Myanmar's Mongla area. And, the FAO also declared that China's neighbors Myanmar, Viet Nam, Laos, and Cambodia were the most at risk for ASF.

With high virulence forms of the virus, the ASF is a highly con-

tagious viral disease of domestic and wild pigs. The virus spreads easily between pigs through direct contact or indirectly from contact with contaminated objects. The biosecurity of pig farms plays a pivotal role in preventing an ASF outbreak. Preventive measures that need to be taken include spraying with acaricides at pig markets, avoiding feeding of leftover feedstuff to domestic pigs, systematic farming, purchasing only pedigree pigs, and carrying out separate farming of newly purchased pigs and existing pigs, according to the Livestock Breeding and Veterinary Department (LBVD) under the Ministry of Agriculture, Livestock and Irrigation.

In addition, people must avoid consuming imported frozen

pig and pork products such as bacon, ham, and sausage, according to officials. Hunting wild pigs and farming wild pigs with domestic pigs must be avoided, they said.

"On encountering any suspicious signs in pig farms, people need to immediately inform the nearest LBVD and the Myanmar Livestock Federation. They also need to cooperate with the related departments and organizations to carry out preventive measures and research on the disease," the LBVD urged.

ASF cannot be transmitted to humans through contact with infected pigs or pork, the World Organization for Animal Health (OIE) and FAO have officially announced. — GNLM

Need to build strong trade with China, instead of seeking export quota: Yangon Chief Minister

TO ship goods to China, Myanmar needs to build a strong trading system rather than an export quota, said Yangon Region Chief Minister U Phyo Min Thein at the Private Sector Development Committee meeting, held on 8 December at the Republic of the Union of Myanmar Federation of Chambers of Commerce and Industry.

Myanmar traders have to go to China to purchase goods, whereas China conducts trade with Myanmar only in the border areas, the Chief Minister said.

"They ask Myanmar traders to transport goods to border areas, but they do not promise to buy them for sure. If they do not like them, they do not make a deal. Also, they manipulate the price. Having said that, we need to create a firm trading system than quotas," said U Phyo Min Thein.

Moreover, Myanmar's traders have to meet distributors sometimes, and trading is mostly carried out by brokers, he said.

"Rather than a quota system, buyers should sign a trading agreement in Yangon and Mandalay markets to have firm trading," he added.

"For example, local traders face losses when they send watermelons to border areas and China does not buy them. As fruits and vegetables can spoil,

brokers and Chinese traders take advantage of the market," the Chief Minister said.

"Additionally, packaging businesses are crucial in logistics. China always has food requirements. Therefore, representatives from their side have come to discuss with us," he added.

The Chief Minister also asked the stakeholders in the whole supply chain, from farmers to traders, to make concerted efforts to develop trade.

At present, to promote exports, Myanmar is exploring new markets for agricultural crops.

The Ministry of Agriculture, Livestock and Irrigation has already sent information on tissue-culture bananas, lime, pineapples, avocados, pomelos, elephant foot yams, sterculia gum (locally called Saekalamat), and cardamom (*Amomum Villosum*) to China's food safety inspection mechanism, the General Administration of Quality Supervision, Inspection, and Quarantine (AQSIQ), for legitimate export.

China has asked the Ministry to reply to questions on Pest Risk Analysis of cardamom and elephant foot yam as traditional trade items, sterculia gum as a food additive, and some fruits to AQSIQ, according to the Ministry of Commerce.

Myanmar registers trade surplus of \$45.6 mln in current fiscal

HIGHER exports in the last two months of the 2019-2020 financial year have resulted in a trade surplus of US\$45.6 million, according to data provided by the Ministry of Commerce.

In the current fiscal, there has been a significant drop from a trade gap of \$654.98 million registered in the corresponding period of the 2018-2019FY, according to data from the Ministry of Commerce.

Between 1 October and 29 November, Myanmar's external trade increased to \$6.16 billion from \$5.24 billion recorded in the same period of the previous FY. In the October-November

period, exports were estimated at \$3.106 billion and imports were valued at \$3.06 billion. Compared to the previous fiscal, exports showed an increase of \$810.8 million, while imports jumped by \$110.27 million.

Myanmar exports agricultural products, animal products, minerals, forest products, and finished industrial goods, while it imports capital goods, intermediate goods, CMP raw materials, and consumer goods.

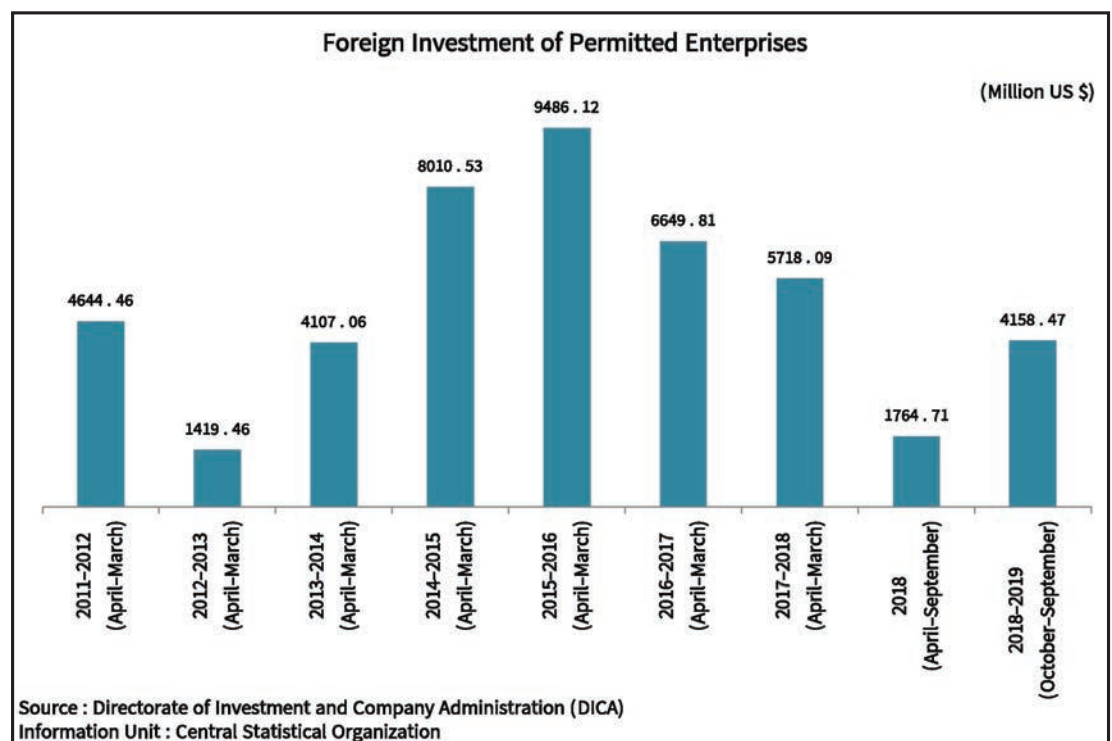
The country's export sector relies more on the agriculture and manufacturing sectors. While export earnings from the CMP (cut, make, and pack) gar-

ment businesses are rising, the country's reliance on natural resources, such as natural gas and jade, is lessening.

The government is trying to cut the trade deficit by screening luxury import items and boosting exports.

Myanmar's trade deficit was pegged at \$1.14 billion in the 2018-2019 fiscal year, \$1.3 billion in the last mini-budget period, \$3.9 billion in the 2017-2018FY, \$5.3 billion in the 2016-2017FY, and \$5.4 billion in the 2015-2016FY, according to statistics released by the Central Statistical Organization. — Mon Mon

Furthermore, we pray that, in their efforts to seek justice and in attempting to show those who are guilty of crimes, the international community might not unwittingly end up either putting the blame on those not actually involved or penalizing the citizens of Myanmar in general or resorting to ways and means which would hurt the poorest

of the poor.

Since genuine peace can only be attained by accepting and acknowledging Justice and Truth, I sincerely hope that this case will have an effect on the internal unity and the peace process of Myanmar.

YCDC cracks down on unauthorized buildings

LEGAL action is being taken against buildings constructed without permission in Yangon Region, said U Win Myint Than, committee member-7, Yangon City Development Committee (YCDC).

"Relating to construction of buildings without erection of green signboards, the elected Township municipal chairman, YCDC representative (EO), in his capacity as secretary, and two other members checked such houses and scrutinized land ownership. If the ownership was found to be legitimate, the house owner was asked to pay a fine. They were allowed to continue construction and will be given a BCC permit upon completion of construction," said U Win Myint Than.

"Some heads of households perish while staying in such houses, leaving behind the problem of inheritance. The ownership of land and building are not clear in such cases. There are many similar problems. To prevent such cases, the YCDC committee lets them pay fines and apply for ownership. There are two types of fines--pre-construction penalty. But, we do not allow construction without payment of

fines. While imposing a pre-construction penalty, we make the home or land owners pay a fine and continue with construction. Some people are willing to pay the pre-construction penalty," he added.

"Moreover, we check the ownership of land through a complaint letter. If they pay the fine, we allow them to continue construction. During the new government's term, we found only a few buildings constructed without permission," U Win Myint Than added.

"A complaint letter can be sent along with the address of the houses that are being constructed without erecting green signboards. Then, we will take legal action against them immediately," said U Maung Maung Soe, Yangon Mayor.

"YCDC staff are not allowed to levy any extra charge to issue construction permits. If anyone finds them quoting extra charges, they can inform the YCDC with detailed information. The YCDC authorities will take action against the staff under the rules and regulations," said U Tin Maung Kyi, head of the Engineering Department (Buildings), YCDC.

"People planning to construct buildings have to apply for a permit first. If they fail to apply for a construction permit for valid reasons, they can pay a fine, and they would then be allowed to continue construction," he added.

"Regarding the construction permit, the YCDC has relaxed some strict rules in order to ease the burden on the people. If they apply for a construction permit, we will issue it in a week, once the ownership is verified," said U Tin Maung Kyi.

"We would like to suggest that owners apply for construction permits themselves. Then, they will know if it is complicated. Now, we are streamlining the permit issuance process. We are also implementing an online system as a pilot project. Currently, the online system can be accessed through the YCDC website. So, people don't need to come to the YCDC office in person," he said.

Three AGTIs to be opened this academic year

THREE Government Technology Institutes (AGTIs) will be launched in the current academic year, according to the Technical and Vocational Education and Training Department, Ministry of Education. Courses on automobile engineering and agricultural farm machinery engineering will also be added in the 2019-2020AY.

"Currently, there are 25 AGTIs across the country. Three new AGTIs will be opened in December this year. This academic year will see a total of 28 AGTIs. We are planning to open new AGTIs across the country and add new engineering courses, in accordance with the new system. We are aiming at the emergence of new qualified youths from these institutes. We need more cooperation from the related

ministries and government organizations," said Dr Nay Myo Tun, deputy director-general of the Technical and Vocational Education and Training Department.

AGTI (Nay Pyi Taw), AGTI (Loikaw), and AGTI (Aung San) will be opened in the 2019-2020AY. The AGTIs offer three-year courses, and the modules will include theory and practical studies. The courses include civil engineering, mechanical engineering, electronic engineering, information technology engineering, and industrial engineering.

Beginning this December, automobile engineering and agriculture farm machinery engineering courses will be opened at Kyaiklat and Wake-ma in Ayeyawady Region and in Shwebo of Sagaing Region, according to the TVET Depart-

ment.

Those who would like to attend the AGTIs need to pass the matriculation exam. Admis-

sion to the schools will be based on English and Mathematics scores.—Myint Maung

A responsible person for Medical Emergency Rescue Committee explained about donation of the hospital. Union Minister Dr Myint Htwe witnessed the signing of documents between the Ambassador and Deputy Director-General Dr Thida Hla from the De-

partment of Medical Services.

In the closing remark, the Union Minister expressed thanks for the donation of hospital as it reflects a sign of friendly relations between Myanmar and Indonesia.

He added the station hospital could provide healthcare services to over 30,000 local people from nearby 23 villages, and it will be developed into a modal station hospital in Rakhine State. The Union Minister also said the ministry is giving medical treatments across the country without discrimination against race or religion in line with medical ethics.

The Ministry of Health and Sports has recently signed an MoU with its Indonesian counterpart for cooperation in medical services, public health, medicines and medical equipment, human resource development

Ethiopia PM collects Nobel Peace Prize, urges unity against hatred

OSLO (Norway) — Ethiopian Prime Minister Abiy Ahmed collected the Nobel Peace Prize in

Oslo on Tuesday, appealing for unity as ethnic violence flares in his country and reconciliation ef-

forts with neighbouring former foe Eritrea have stalled.

Abiy, 43, won the Nobel for his efforts to resolve the long-running conflict with Eritrea. Announced back in October, the prize also honoured his mediation efforts in eastern Africa and the democratic reforms he has undertaken in his country, long ruled by authoritarian leaders.

Ethiopia saw spectacular progress in the months after he took power in April 2018, but the winds have since shifted: in addition to the stalled peace process with Eritrea, his reforms aimed at opening up Ethiopia have paradoxically given rise to a flare-up of ethnic tensions.

Faced with these challenges, Africa's youngest leader called for unity as he picked up his award at Oslo's flower-bedecked City Hall, in a formal ceremony attended by the Norwegian royal family and dignitaries. "There is no 'Us and Them'," he said. "There is only 'Us', for 'We' are all bound by a shared destiny of love, forgiveness and reconciliation."

On July 9, 2018, following a historic meeting in Eritrea's capital Asmara, Abiy and Eritrean President Isaias Afwerki formally ended a 20-year-old stalemate between their countries in the wake of the 1998-2000 border conflict. That was just three months after Abiy took office.

'Comrade-in-peace'

On Tuesday, Abiy was quick to praise the role of his Eritrean "partner and comrade-in-peace" — the only leader Eritrea has known since it gained independence in 1993 — in his Nobel Prize.

"We understood our nations are not enemies. Instead, we were victims of the common enemy called poverty," he said. A former soldier himself, Abiy also testified to the ravages of war, recalling how his entire unit had been wiped out in an Eritrean artillery attack but he had survived after briefly leaving a foxhole to get better antenna reception. "War is the epitome of hell for all involved," he said.— AFP ■

Philippines gov't to lift martial law in Mindanao

MANILA — The Philippine government said Tuesday it will not extend martial law in the southern island of Mindanao beyond this year, ending the close to three-year military control aimed at ending rebellion in the area.

Presidential spokesman Salvador Panelo told a press conference in Manila that President Rodrigo Duterte decided not to

extend its implementation when its effectivity expires on Dec. 31.

“The commander-in-chief made the decision following the assessment of his security and defense advisers of the weakening of the terrorist and extremist rebellion,” Panelo said, also citing plunging crime rates among the reasons.

“The people of Min-

danao are assured that any incipient major threat in the region would be nipped in the bud,” he said.

Duterte declared martial law in Mindanao on 23 May, 2017, after heavily armed fighters with ties to Islamic State occupied areas within the predominantly Muslim city of Marawi.

The occupation led to a protracted, six-month battle with government

forces, with close to 1,500 people killed in the fighting, counting at least 165 from the government side and at least 47 civilians. Human rights groups have expressed opposition to the continued implementation of martial law in past years, its having been extended twice, citing human rights violations ranging from illegal arrests to extrajudicial killings.— Kyodo News ■

Regulator recommends 2.4 bil. yen fine on Nissan over Ghosn scandal

TOKYO — Japan's securities watchdog recommended Tuesday that automaker Nissan Motor Co. be fined 2.42 billion yen (\$22 million) over allegations that it underreported former chairman Carlos Ghosn's remuneration by billions of yen for years.

The Securities and Exchange Surveillance Commission said this is

the first time it has made a recommendation of a fine to the Financial Services Agency over an alleged case of false reporting of executive remuneration.

The recommended fine over alleged financial statement falsification is the second largest since the watchdog proposed Toshiba Corp. pay some 7.3 billion yen in 2015.

Nissan said in a statement it “will continue its efforts to strengthen its governance and ensure that the (company's) operations reflect full awareness of the importance of compliance.”

The SESC has also filed a criminal complaint against Nissan and Ghosn for allegedly violating the financial instruments law by underreporting the former

chairman's pay package by around 9.1 billion yen in the eight years through March 2018 in the company's securities reports that were presented to Japanese regulators. Tokyo prosecutors have indicted both Nissan and Ghosn on the charge, with the trial expected to start next spring.

The fine of 2.4 billion yen targets an underre-

ported period of four years through March 2018, for which the statute of limitations has not expired.

Initially, the penalty for Nissan was expected to reach 4 billion yen, based on the amount of pay left out of submitted documents, but the automaker asked the watchdog for a reduction in the fine since it reported the matter before

an investigation got fully under way. The SESC accepted Nissan's request.

The company corrected its securities reports in May, including executive remuneration, from fiscal 2005 to fiscal 2017. If Nissan is found guilty of the charges at trial and imposed a penalty, the amount will be offset by the latest fine.— Kyodo News ■

Death toll in New Zealand eruption rises to 6 as 8 remain missing

SYDNEY — New Zealand police said Tuesday that a sixth person has died of injuries after a volcano on a tiny island erupted without warning a day earlier, leaving eight others missing and presumed dead.

Of the 47 people on or near the volcanic White Island at the time of the eruption, officials said 30 are still being treated for injuries — the majority of which are critical — in hospitals across the country. Three were well enough to be discharged overnight.

Australian Prime Minister Scott Morrison said in the morning that it is likely as many as three of the dead are Australians. Australians accounted for roughly half of the group of mostly tourists who were caught up in the early afternoon eruption.

Also Tuesday, police

said they will conduct an investigation into the deaths of individuals on White Island on behalf of the coroner. Although police previously said they would investigate the criminal responsibility for the deaths, they have since said in a statement that “it is too early” for such an investigation.

White Island, roughly 50 kilometers off the coast of North Island, is New Zealand's most active cone volcano and a popular tourist destination, with over 10,000 people visiting each year through daily tours of the site operated by White Island Tours.

But in the weeks preceding the deadly eruption, the privately owned, uninhabited island had shown increased volcanic activity.— Kyodo News ■

Chile military plane disappears with 38 aboard: Air Force

SANTIAGO (Chile)— A Chilean military plane with 38 people aboard has gone missing after it took off from the country's south for a base in Antarctica and is presumed to have crashed, authorities have said.

Seventeen of those on board the C-130 aircraft were crew and the others were passengers, Chile's air force said Monday.

The plane is believed to have crashed and "all national and international air and maritime means available in the area are continuing the search (for survivors) in the sector where communications were lost with the aircraft," it added in a statement Tuesday.

The four-engine air-

craft took off Monday at 4:55 pm (19:55 GMT) from an airbase in the southern city of Punta Arenas and contact was lost at 6:13 pm.

The air force said conditions for flying were good and that it was in contact with the families of those on board, many of whom were traveling to carry out logistical support tasks at the country's largest Antarctic base Eduardo Frei.

Personnel were also being transferred to inspect the base's floating fuel supply pipeline and undertake anticorrosive treatment of the facility.

The air force also said that of the passengers on board, 15 were from its ranks, three were from the army, there were two

people from a private construction company, and a Chile university official.

The plane did have an emergency positioning system, but it did not appear to be working during the early morning search, said Eduardo Mosqueira, Commander of the Fourth Air Brigade.

President Sebastian Pinera, whose country is witnessing its worst civil unrest in decades, tweeted he would fly to Punta Arenas with Interior Minister Gonzalo Blumel.

Once there, they would meet up with Defense Minister Alberto Espina to monitor the search and rescue mission, which was underway using aircraft and navy vessels.

The plane went miss-

ing in Drake Passage — a key maritime route between South America and Antarctica frequently hit by some of the world's worst weather. However, conditions were fine for flying on Monday, Chile's

air force said.

The plane's disappearance is the latest incident in a country where Chileans have for nearly two months protested social and economic inequality, as well as an en-

trenched political elite.

The nearly two-month crisis and its violent demonstrations have led to 26 deaths and more than 12,000 injuries, according to the Organization of American States.—AFP ■

said U Thant Sin Lwin, Director-General of the Directorate of Investment and Company

Administration (DICA).

The MIC gave the green light to 34 foreign investment projects valued at more than US\$ 465 million during the same period in the fiscal year 2018-2019.

The increase in foreign direct investment into Myanmar attributes to massive influx of foreign investment into the Southeast Asian country, the Director-General added. "Company registration system in Myanmar has improved as compared to previously introduced scheme.

This is the reason why enormous foreign investment has been channeled into Myanmar," he said.

Union Minister for Investment and Foreign Economic Relations U Thaung Tun said that FDI inflows into Myanmar will likely increase in the current fiscal year once proposals for offshore oil exploration and mineral extraction are scrutinized and approved.

The Union Minister went on to say that the government has taken a number of significant measures to ensure that it will be much easier for foreign investors to do business in Myanmar.

The majority of the foreign investment from China, Hong Kong, Taiwan, British Virgin Islands, India, Seychelles and United Kingdom came to manufacturing, communications, transport, tourism, agriculture, electricity generation, real estate and industrial sectors.

The Southeast Asian country aims to woo US\$ 5.8 billion of FDI in the current financial year. The MIC expects that the country will receive more foreign direct investment in the years to come. The government is also committed to encouraging FDI inflows to the country that can contribute to the creation of job opportunities for Myanmar people, help their income increase and promote their socioeconomic status. The government believes that the foreign direct investment is a key drive for economic growth of the country.

The DICA has been cooperating with NGOs and INGOs so as to lure foreign direct investments to the country by organizing seminars, investment and business forums. Myanmar set a target to attract US\$ 221 billion of FDI within 20 years from 2016-2017 FY to 2035-2036 FY under the short-term, mid-term and long-term Myanmar Investment Promotion Plan in an attempt to attract responsible investments into the country.

In addition Myanmar is estimated to become a middle-income country by 2036. Arrangements are being made to attract more foreign direct investments in the industrial sector that can create more job opportunities for Myanmar citizens under the MIPP.

Around 1,780 foreign companies from 50 countries around the world were permitted to pour investments into 12 sectors, with the total amount of US\$ 81,597.743 million during the period from 1988 to early November 2019.

Myanmar received US\$ 9.4 billion of foreign direct investment in 2015-2016 FY, US\$ 6.6 billion of FDI in 2016-2017 and US\$ 5.7 billion of FDI in 2017-2018 FY.

The largest sector of foreign direct investment flowed to oil and gas sector, accounting for 27.29 per cent of the total FDI, followed by the power sector with 25.77 per cent and the manufacturing sector with 14.04 per cent.

The goals in 90 minutes for Myanmar were scored by Aung Kaung Mann at 9th minute and Myat Kaung Khant at 35th minute, while the goals for Cambodia were scored by Chanthea at 1st minute and Sokpheng at 71st minute. In the penalty shootout, Htet Phyo Wai, Lwin Moe Aung, Nay Moe Naing, Ye Yint Aung and Win

Naing Tun scored the goals for Myanmar, while Sadavid, Muslim, Piseth and Rosib scored the goals for Cambodia.

In the gold medal match, Viet Nam beat Indonesia 3-0 and claimed the championship title. The goals for Viet Nam were scored by Doan Van Hau at 39th and 73rd minutes and Do Hung Dung at 59th minute. The best goalscorers are Osvaldo Haay from Indonesia and Ha Duc Chinh from Viet Nam with eight goals each, and followed by Nguyen Tien Linnh with six goals. The champions of 2017 SEA Games was Thailand, and followed by runners-up Malaysia, third place Indonesia and fourth place Myanmar. — Kyaw Khin

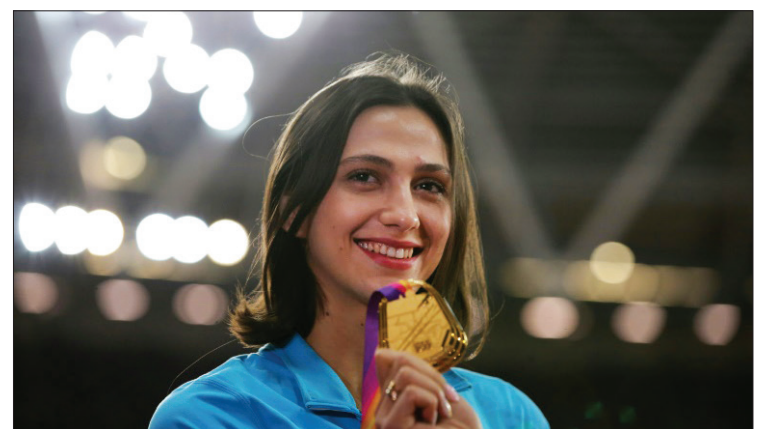
In her open letter published by Championat.com sports website, Lasitskene, a longtime critic of Russian sports officials, demanded to know who has been punished over the country's doping scandal and the fact that

she cannot compete under the Russian flag.

Lasitskene missed the 2016 Rio Olympics because of the doping crisis and had threatened to leave Russia so as not to miss the Tokyo Olympics in 2020.

"The Russian flag was taken from me at the end of 2015," the 26-year-old wrote, calling herself "an athlete who has a lot of questions".

"Have we done an internal investigation? Who was punished?" Lasitskene said. — AFP
