Further strengthen friendly ties between Myanmar and the Russian Federation

Myanmar has been adhering to the five Principles of Peaceful Co-existence in dealing with neighbouring countries, countries in the region and the global community. Cuba claims drug war victory without US help

BOCA DEL TORO (Cuba), 9 April — Flying over chains of sandy keys in a clattering old Soviet Mi-17 helicopter, Colonel Jorge Samper declares a Cuban victory over South American drug traffickers — with no thanks to the United States.

Communist Cuba wants to cooperate with its bitter political enemy in the war on narcotics, but is getting no response from Washington, says Samper, deputy commander of the Cuban Coast Guard.

Colombian smugglers have used the hundreds of tiny secluded islands off Cuba's long north coast as drop sites for bales of cocaine and marijuana to be picked up from the sea by speedboats for delivery to the United States.

Despite scarce resources to patrol its waters other than slowmoving Soviet-era torpedo boats. Cuba says it has the problem under

Tornadoes strike Tennessee

Nashville, 8 April — Tornadoes battered the southeastern United States on Friday, killing 12 people in Tennessee in the second deadly tornado strike In the state this week, officials said on Saturday.

Nine people died in Sumner County where the tornado hit a heavily populated area outside the town of Gallatin and another three people were killed in Warren County, said Randy Harris of the Tennessee Emergency Management Agency.

What had been stately brick homes near Gallatin were heavily damaged and rubble was strewn across upscale neighbourhoods. Several people were rescued after being trapped in their cars by storm debris. In Warren County, authorities said some mobile homes were destroyed and a truck overturned.

The winds knocked over walls at Volunteer State Community College in Gallatin where some 200 students huddled inside a building as the storm approached. Despite the heavy damage to the campus, the injuries were mostly minor cuts and bruises.

In Georgia, to the south, severe thunderstorms rolled through the northern part of the state early Saturday, damaging homes and businesses in several metropolitan Atlanta counties.

Local television reports showed businesses that had been leveled and trees that crashed into homes.—Internet

"Two US service members and one US civilian contractor received minor injuries today when a suicide car bomb exploded outside the main gates of the Lashkar Gah Provincial Reconstruction Team compound in Helmand Province at 11:30 am (0700 GMT) today," US military said in a Press release.

Each time I went to Thein Win for preparing a protest, he would give me about K 100,000. But, when I contacted him if the inclusive cost for a protest did not cover, he would send me more K 50,000 or 100,000 by money order. As far as I'm concerned he was mainly funded by Pyithit Nyunt Wai (a) Ko Maung Maung. But I had no knowledge of Thein Win's actual expenditures. Dr Zaw Than (Sankei Shimbun): An incident once happened that a launcher was fired at a vessel in Kyimyindine. So, I would like to know whether or not Pyithit Nyunt Wai and Thein Win are involved in that attack. And how can you know exactly that they are also involved in the three bomb explosions on 7 May? China-made watch some wires, two dry cells and a bulb together with a man by the name of Ko Thet Khaing. When asked, he said he was just teaching him making a bomb as he (Ko Thet Khaing) was interested in it. That's why I think he must be a bomb

U Myint Thura of Pyi Myanmar Journal: He said he learned that there was a woman in the hardcore of terrorists and he asked how she related them and what she carried

Daw Khine Mar Soe replied that at the end of December, 2005 after the release from the prison for the first time, she went to the other country which worked before she regarding money order to make relations between those who went abroad for their works and their parents, when she was there, her brother said that in Mae-sot, there was AAPP organization which supported the political prisoners and she could get whatever she wanted for help through Thei Win. When she arrived at Maesot, she went to Thein Win, he said to her not to worry about anything. And so, she asked him for the help that was necessary for her family. He promised to assist her in January or February, Lateron, she kept in touch with him once a month as she was in Maesot at that time. Whenever they met each other, he gave her K 200,000, K 100,000 or 50,000 to spend if necessary for her and he made her send K 50,000 or K 100,000 by chance for three persons that she had to make contact with at that moment, including the appliances for sale at the store. At such time, she did





not know if people that they were talking to were UGs. Moreover, he said that they were together in prison and he wanted to help them as much as he could. Later. due to their saying, she came to realize that they were former NLD representatives.

U Aung Shwe Oo of NTV News Agency asked Ko Yu Noot who his parents were and from which region they came.

Yu Noot (a) Aung Cho Oo replied that his parents were from Myanmar and he lived at No 225 on 103rd Street in Mingalar Taung Nyunt. Regarding the bomb blast, he committed after meeting him while he went there to work. But, he did not know before that he made explosions like that and in fact, it was sure that he never took part in bomb blast if he knew it beforehand. Though it was against the law, he did nothing to crush the lives of people like Thein Win. Anyhow, he was ready to accept the punishment of the law. If I was released after being punished, he would keep on serving under the frame of the law in the interests of the people and the nation.

U Ohn Maung of Naing Ngan Gonyi Sarpaytaik said he would like to know about the facts from the interview with some foreign media conducted by Thein Win.

Daw Khine Mar Soe said Thein Win was on the phone to a man when she arrived at his home. While using the telephone, he asked her to speak to a man who had sent some books and others to her. She had never seen the man and known his name. The man asked how she was and so was her imprisonment.

She said she was fine and had been sorrow concerning her family. She felt astonished when the man had asked how the farmers in Myanmar were and if the government had forced them to grow summer paddy. There was nothing but growing of paddy in some irrigated areas by creeks. The farmers were allowed to cultivate beans where the beans can be grown.

When she had met with Ko Thein Win, he asked how much the price of paddy in Myanmar was. She said it was about K 160,000. The men on the line had not believed what Ko Thein Win said. After she spoke to the men about the price of paddy in Myanmar, she stopped phone conversation. Once, she spoke to the men in May Thazin book shop. The men asked how sorrowful she had felt

got angry when a leader was called "Tin Oo" and said she felt sorry for the death. It was true that she had not known that was an interview, she said.

UKo Ko (Yomiuri Shimbun): It is learnt that a suspicious item thought to be an explosive was found recently at Yangon International School. I would like to know in detail how action has been taken regarding this if the incident was true?. And the second question is that salary of State service personnel has been increased since 1 April. I would like to know if the increase of the salary could lead to inflation?. How can such a large amount of money be obtained?. And how many State service personnel are there in Myanmar? And how much they constitute in the nation's population?

Director-General of MPF Brig-Gen Khin Yi: As far as I know, the incident at Yangon International School took

place on 6 April. The incident was that teacher of the school U Win Htut Kyaw on 6 April found smoke coming out of a Cookies box in the toilet of students. And he put out the smoke on the assumption that it came from secretly smoking done by a student. It was at about 1.15 pm. And he continued his teaching and thought the incident over. Reflecting the two round objects thought to be explosives and strings thought to be explosive wires along with a London cigarette end, he informed the security personnel. It was at about 4 pm. The security personnel together with those from US Embassy inspected and exposed the incident. It is learnt that there are about

400 students learning at the school, most of them are the offspring of diplomats in Yangon. Two of the students did it as a matter of kidding. To do so, the two students bought potassium nitrate and sugar at a shop in downtown Yangon, To play a trick on the students to mark April Fool, the two students also bought firecrackers to copy Jolly Walker they found on the Internet Website. They mixed one to six ratio of sugar and potassium nitrate and heat the mixture.

And then, they cool it down to such an extent that it became solid. At that time, they planted a stick onto the solid mixture and played such a joke on the students copying the findings on the Internet Website. U Kaw Kyaw Maung of the Central Bank of Myanmar: The number of State service personnel is only about one million. It is not safe to say that there will be inflation and a rise in commodity prices just as the salary of service personnel has been increased since the nation's population is about 50 million. The money was obtained from proper collection of taxes. That is why it cannot be assessed that there will be inflation or deflation in this regard.

electricity up to K 75? Daw Khine Mar Soe: I together with one of my friends went to Myawady to make a living according to my family's economy in 1998. One year after, I returned to Myanmar. Aftertaking 10 days leave, I got back, But the factory did not accept me because of being one day late. For this reason, I started to put up U May Tha Zin bookstall. While staying there, I asked the shopkeepers from the bookstall what I could help them. They replied that they had difficulties to buy books. I answered them to see to it and I bought books for them through my own expense. I saw the person so called Thein Win entering into the bookstall in March and he took out money and gave the girl sitting at the counter. When he left the bookshop, the woman I intimated told me that the bookshop was opened by students and Thein Win was a student. I considered it was a business and I continued buying books for them from Yangon 31st Street once a month. In July Thingan Nyinaung No 25 Investigation Unit questioned me and I was given four years by the section 17/2 and by sec-

petrol and diesel up to K 2500 and one unit rate of electricity up to K 75 were rumours. As the service personnel were high paid by the government, the rumours came out.

Daw Ei Ei Myat (Myomyanmar Journal): I would like to raise one question. I knew that the Yangon Mayor held meeting on stability of commodity price with officials concerned. The meeting focused on price control for commodities If the shops did not follow the current rules, the authorities would take action against them. How many actions were taken up to now?

Information Minister Brig-Gen Kyaw Hsan: Concerning the above question, there were not actions taken yet.

Daw Nwe Nwe Aye (Myanmar Times Journal): The minister said in his speech about ILO case. ILO said there were no satisfactory measures on forced labour in Myanmar. How does Myanmar respond it? Would Myanmar keep on joining hands with ILO next or resign from it? After prescribing the law for amending trade and income taxes last month, Myanmar merchants sent a letter to leaders of the State. In the letter it was suggested that instead of collecting tax from them, the price of petrol and diesel would be enhanced from K 1500 to K 3000 and so would one unit rate of electricity from K 25 to K 100. How do the heads of state consider these?

Deputy Labour Minister Brig-Gen Win Sein: Myanmar keeps joining with ILO now. Arrangements have been made for constant joining with ILO in future.

Information Minister Brig-Gen Kyaw Hsan: Measures will be taken for collecting tax in accord with the laws recently released. In this junction, the petrol price would be up K 2500 or K 3000 from K 1500 due to cropping up of rumors.

UMin Zin (Living Color Magazine): I would like to ask U Aung Thein two questions. The first point was that Daw San San from NLD (LA) sent a satellite phone. Which local news was sent through phone? Which media did it consist of? The next point was concerning with sending money. Was money spent on sending messages or where was it spent?

ŪAung Thein: NLD (LA) and IMPU are illegal organizations but they have to live up to the resolutions and demands of NLD and other political parties as if dancing to the tune. I had to release the declaration after NLD's political ceremony. I had to send the decisions made by veteran politicians and CRPP and NLD to Daw San San. In

connection with the returning of Global Fund Thad to send the declaration made by new generation students. I don't know how much money they get there. The money they sent us amounted to K 450,000. Members of NLD released from the jails were hospitalized and they had no money to buy medicines. We had to help them with the money. Moreover, we had to give cash assistance to funeral of some NLD members as much as we could. I spent about K 450,000 on such conditions.

U Yin Kyaw (Hmukhin News Journal): At present, Myanmar Police Force has launched crime free week. I would like to know if there is success and what will be the next programme. It seemed the number of majorcrimes has risen. So, I would like to know future plan of combating crimes such as murder, rape, burglar and so on.

MPF Director-General

Brig-Gen Khin Yi: MPF
launched the Crime Free
Week as a pilot project to
fully realize public life security, prevalence of law
and order, and peace and
stability. In doing so, MPF
made an assessment of the
crime rates in a specific
area during a three-year
period, and chose the highest crime rate area. And,
the Crime Free Week was

fixed for the area for one week of a month. In launching the campaign, MPF concentrated on crime control and prevention. If the crime free week meets with success, the people will accept and participate in the drive. Furthermore, if the crime free week does well in other areas, the people will be able to enjoy fruitful results of security measures in accord with the guidance of the Head of State. These activities commenced in November 2005. Regarding the murder case, Daw Nan Kham Mu of Thingangyun was killed on 6 November. As the case happened during the crime free week, the murderer was exposed within three days with the help of the people through the 199 report system. Though three persons were killed in a case on 22 November, those who committed murder were exposed within about two days. Likewise, murder

cases that occurred in November, December and January were exposed in a shorttime or almost a week. Similarly, hundreds of burglar case happened in Yangon. In six other divisions, hundreds of theft and narcotic drugs cases were exposed due to launching the crime free week.

These days, criminal cases did not increase. After shifting of Government departments to Naypyitaw from Yangon, some thought there would be an increase in the number of criminal cases. Before we moved to Naypyitaw, the number of major crimes was 37, afterwards it was 38. Hence, the number of major criminal cases did not rise.

Aung Cho Oo (a) Yu Noot: Once I saw Pyithit Nyunt Wai (a) Maung Maung come round to Thein Win's house and they were talking about something upstairs. Maung Was accompanied by KNU's Mehm Nyein Maung. They gave Thein Win a parcel. I learned later that inside the parcel were some weapons. Maung Maung, who is mainly responsible for bomb attacks, is providing explosives for Thein Win via whom they are distributed to Tin Moe and Aung Min inside the country in order to commit subversive acts. I am sure that Thein Win and Maung Maung masterminded the bomb attacks on the centres in the city because I had to give them the phone numbers of those centres. First I didn't know Ko Thein Win would commit such acts. I thought he would only hold protests against the government as usual. That was why I gave him the phone numbers. He committed the acts under the command of Pyithit Nyunt Wai.

U Hein Latt (Popular Journal): Yesterday I attended the meeting of

YCDC's committee for ensuing the decrease in commodity prices. At the meeting, rice and edible oil traders were requested so as not to further increase the commodity prices. So, I would like to know if the State's plans to stabilize the prices of commodities on a national scale

Minister Brig-Gen Kyaw Hsan: The State has approved a pay rise for government employees in order to fill the gap between their former salar ries and the increasing prices of goods. In doing so, to ensure no budget deficit, the State, after making thorough reviews

and assessments, approved the pay rise within the framework of law by having systematically collected taxes and revenues for one or two years earlier. With the collected taxes and benefits gained from State's projects, the government was able to approve the pay rise for the departmental staff. The ill attempts to increase the prices of commodities with profiteering from service personnel's increased salaries are not a natural phenomenon. It is also unacceptable. It is because they will have to enjoy their increased salaries only after the end of April. Moreover, the commodities being sold at the moment have already manufactured before the approval of pay rises. With the overall production costs plus reasonable profits, such goods have been and being sold to the public. So, it is not natural if the prices of goods are further increased at the expense of service personnel's pay rises. If so, it will be responsible for unscrupulous persons. In response to the question concerning the State's plans to stabilize the prices of commodities, I would say that there are four strategies: (1) boosting production, (2) practising thrifty in order not to cause State budget deficit, (3) employing systematic management and supervision concerning the prices of goods, and (4) organizing ways to stabilize the prices of goods.

They are measures being taken to stabilize the commodity prices. Regarding this, there are important points in which the entire people includ-

ing State service personnel are to take part. The points ought to be carried out by the entire people in order to stabilize the commodity prices are: one—each household or each one is to practise therifty.

If they do so, it amounts to stabilizing the commodity prices. Two-every family is to engage in growing vegetables for the household use. By doing so, they can maintain the prices of vegetables and fish & meat and can save money. Three—there have been rumours such as the rise in the prices of this item or that item as regards the increase of salary of State service personnel. And it is required for the people not to believe those rumours. Otherwise, the rumours will bear fruits for unscrupulous persons. At present, the nation produces over 1,000 million baskets of paddy yearly. It is required only 600 million baskets of paddy yearly for 54 million of the nation's population. It is found that the supply is greater than the demand. Therefore, the people are advised not to believe the rumours manufactured by unscrupulous persons. If the entire people participate in this regard, there is no reason for the commodity prices to rise. The government, on its part, is taking measures to maintain the commodity prices in line with the market-oriented economic system. Hence, the people need to participate in it to stabilize the commodity prices.

U Nyein Thu (Mukhin Shudaungt Journal): Due to the accusations of foreign media, there were suspicions among the public that some members of MPF tortured and bullied the people. Are there any such incidents or not? If such incidents are found, is there any response?. If there is any, to what extent action is taken against those who committed the incidents?

Director-General of MPF Brig-Gen Khin Yi:

To answer these questions, I would like to explain the functions of MPF. The MPF is an organization that is implementing the four objectives-taking measures for prevalence of law, ensuring community peace and tranquillity, engaging in elimination of narcotic drugs and serving the interest of the public. They are the long term plan. For successful realization of the plan, MPF has laid down short-term plans and is implementing them. For example, 2004 was designated as changing of the appearance of MPF. And 2005 was designated as changing of the essence of MPF. In the process, the policies of MPF were laid down and work is under way. The 2006 was designated as law enforcement year to be able to change MPF both in appearance and essence. To do so, the participation of the people is indispensable.

As far as I know, the police force and the people have become closer and the people give more assistance to the police. I honestly believed that more tasks can be carried out. During the Crime Suppression period major crimes were exposed. The nations of the world acknowledged us that we can undertake the

tasks in connection with drug control. The police force prevented the danger against the nation such as penetration of NDD Thein Win group and connections with NLD (LA). Therefore I honestly believed that success has been gained due to information and support of the people. In the website news we find that the people do not support us as we ill-treat them. I think it is because of the broadcast of false news by some media. We read the news on the websites. Among the news the case of Ko Thet Naing Oo is obvious. The case is very simple. He was born and graduated in Kvimvindine. He and his friend Win Mvint drank alcohol at his home on 17 March. They drank a bottle and half of Myanmar Whisky which is equivalent to 12 pegs. Each person had six pegs. That amount of alcohol makes a person drunk. They went out to have eggs. At 9 pm they urinated in front of Development Committee Office on Sin-o-dan Street. The township officer stopped them and quarrelled with them. Thet Naing Oo threw stones at the office. After that he returned home and drank. He took out an 18-inch long sword. Win Myint and another person asked him not to go. As he was drunk, he threatened. There was a quarrel when he met two fire brigade members on patrol. The two got hurt on their right arms as he cut them. So he fled by a trishaw on the way. The crowd chased him. When a trishawman named Bayluwa threw with a stick, the trishaw stopped and overturned. He went on running. The crowd followed him. shouting thief, thief and he shouted at the people not to follow him. One of the men in the mob named Thangyoung, a trishawman, hit him with a stick and he fractured his skull. After that the police arrived. He was taken to the hospital. The following day, he succumbed to death. That was the real case. But I was surprised to read the news about him on the Internet. It said that a political prisoner was killed after being beaten by the police and the members of the Fire Brigade. This is not a report but a confession and it is true. There was no involvement of the police in the case. His funeral service was held in Htainbin cemetery. Some youth organization paid tribute to him with one-minute silence. His photo was conveyed to the place where his body was burned. At that time. Leaders of 88 student youths were on the phone with BBC, VOA and RFA. In the conversation included Ko Thet Naing was killed due to the ill-treatment of the police and the members of the Fire Brigade. There may be some expenditures after his funeral. Leaders of 88 student youths informed Ko Bo Kyi through telephone of AAPP, a political prisoner care association in Maesot to send K 1 million. They created disturbance with the help of local and foreign links.

Our members of Police Forces have a lot of rules and regulations to abide by like members of the Tatmadaw. In addition, Not only are there civil laws but there are codes of conduct of the members of Police Force as well. There are 70 codes of conduct of the

Police Force including those prescribed indealing with the public. If a row takes place involving a police member, he faces action under the police code of conduct, civil laws, and administrative action.

In accordance with the guidance of Head of the State, plans have been made for transforming the Police Force into an efficient one. The destructionists are making plans to drive a wedge among the people in order to destroy the dignity of the Police Force.

So, I would like to express thanks for having a chance to explain the facts. The journalists are requested to disseminate the facts to the public.

Information Minister Brig-Gen Kyaw Hsan said in connection with Ko Thet Naing Oo, a young man punched a former student leader in a funeral procession. All must have already known about the case. However, what appeared on the Internet and broadcast by the BBC and VOA was that the person fisted and his group said they (the students group) was confronted with a group ready to attack them. The group added they had to be patient, not to react but to carry on work with political awareness.

Actually, the young man who punched the former student was a psychotic patient and also a member of NLD party. He got divorced. We asked the young man why he had done like this. The young man said the former student looked like a man who sexually abused him. That is an actual case and not a fabrication.

However, BBC, VOA and Internet invented the false story concerning the above case to trick the

Director-General of MPF Brig-Gen Khin Yi said that when the minister was clarifying points, he remembered the accusations about the news on the Internet that a political prisoner was punched and fought by members of Police Force and Fire Brigade. He said he did not mean to react personally and it was only to refute. At the time of 1988 unrest, the man fled to the other country and reached KNU after making contact with them through the Minthami Camp and Phaya Thonzu Road. Then he became a member of Da-Nya-Ta led by Thanmini Bo Khin Maung. He also attended the No 1 training for explosives and destruction opened by Da-Nya-Ta. After that, he closely gave advice in the cases of bomb blast and destruction of Bangkok Embassy and in 1991, he exchanged arms for peace. When he came back Myanmar, he committed the destructive acts after taking the assistance of antigovernment organizations situated in the other country and so, the action was taken against him to prevent him in time. After his 10 years of imprisonment, he was released from prison. Thus, the director-general of MPF answered for the truth, to be clear if he was a respectable politician or a destructionist. There were also so many accusations. As nothing concerned with the truth including the matters occurred in DaikU and Mandalay, he had to clarify it in detail.

Foreign masters pretended as if they did not know terrorist acts of renegade Sein Win of NCGUB and Pyithit Nyunt Wai of FTUB and followers

(from page 16) and how NCGUB Sein Win and FTUB Pyithit Nyunt Wai masterminded and provided funds to ABSDF, NLD(LA), NDD and VBSW for blasting bombs on 7-5-2005 in Yangon. I have clarified with both man and material evidences.

Beginning early 2006, information was received that the terrorists attempted to blast bombs at crowded business areas and schools. And their schemes were exposed and prevented in time. Yet, some bomb blasts occurred at some places.

According to tip-offs . in December 2005, we learnt that expatriate Sein Win of NCGUB and expatriate axe-handle Aung Lin Htut who were taking refuge in USA and ABSDF military advisor Ave Myint who was in Australia directed their sabotage groups to blast bombs at Nyaunghnapin Camp, the venue of the National Convention, airports and aircraft as well as in Yangon and Pyinmana; the saboteurs infiltrated into the country in various guises: the saboteurs would be rewarded lavishly and their

families would be well looked after if they had accomplished the mission; otherwise the saboteurs would be killed and their families would be under control: and if it was impossible to blast bombs at targeted places the saboteurs were to explode bombs at schools and busy places. According to further information received, it was revealed that the terrorist groups led by expatriate Sein Win of NCGUB were conspiring to launch media attack against the Government. It was also learnt that they had planned to blast bombs in Yangon, Mandalay and Pyinmana cities by joining hands with ABSDF and KNU whose members have expertise in exploding mines. Their motive was to frighten the people and cause the Government lose people's

confidence.

A meeting was held by The Pho of KNU brigade-3, Michael of KNU brigade-4, ABSDF joint secretary Sonny and ABSDF central committee members Soe Htut and Maung Maung Tate and they discussed measures for accelerating the terrorist acts of blasting bombs in the country. ABSDF saboteur Aung Ko Naing infiltrated into the country on 30-5-2005. He returned to Wawlaykhee camp at the border on 6-1-2006. Aung Ko Naing was chosen to blast bombs in the country and he was sent into the country during the first week of February, it was learnt

Information was also received that according to the decision of KNU central committee, KNU brigades 3,4 and 7 would launch military and sabotage attacks in the country in 2006. To blast bombs in Yangon, Bago and other cities, cooperation would be made by ABSDF, NLD (LA) and DPNS.

A bomb blast took place in Penwegon market on 2-11-2005. It was committed by three KNU members under orders of KNU brigade-3 and ABSDF. It was confessed by arrested

KNU private Wah Lay (alias) Saw Tin Win, of Kywechan Village of Kyaukkyi Township. According to the confessions of Saw Tin Win and others who were involved in the plot, it was learnt that the bomb blast of a pylon in the west Tawkywe-inn on 29-3-2003 and the bomb blast at a cinema house in Pyu on 15-5-2003 were committed by KNU terrorists. Moreover, it was learnt that KNU Wah Lay (alias) Saw Tin Win is a womanizer and he raped some village girls. It was disclosed by the victims. That disclosure shows that terrorists raped the girls. There are also other evidences.

At the previous press conference No 2/2006. I had clarified that SSA-S Ywet Sit group set Meethwaygon village of Namhsan Township on fire,

(from page 8) killed 13 persons and raped village girls on 18-1-1997 evening. Clarifications have been made that the group demanded extortion money from 30 passenger buses, raped women and killed 25 persons on Kunhein-Kentung

In replying to the questions at that press conference, sergeant Sai Tun Kyaw of SSA-S brigade-241 who had returned to legal fold said that Ywet Sit has two wives and many mistresses; Ywet Sit is a womanizer and he abused other girls by using money. Sai Tun Kyaw also revealed that SSA-S brigade-758 commander Mein Sit has 40 wives and SSA-S brigade-756 commander Khut Lawng has 20.

Foreign masterminds and their minions, expatriates and terrorist insurgents made media attack against the Tatmadaw by dubbing it with the term "Licensed to Rape". Actually, those who are committing rapes are KNU, SSA-S and their cohorts. Similarly, a bomb exploded Shwemawdaw Pagoda road and about 50 feet away from a gate of high school No 1 in Bago at 7 pm on 3-1-2006. At about 8 pm the same day, another bomb blast occurred near the drainage in front of the house of the Bago BEHS-1 headmistress on Shwemawdaw Pagoda road. An explosive with a

detonator fuse packed with the cover of Paris soap was found in a drainage 20 feet away from the second blast. No one was injured in those two bomb blasts

At about 4 am on 12-1-2006, electric power grid pylon nummber 254 was exploded by KNU insurgents and it pylon collapsed. On 14-1-2006, the pylon was repaired and the TE motor vehicle with the workers on board on their return from the repair of the pylon was torched by KNU insurgents on Leiktho-Yado road.

At 4.30 am on 15-1-2006, a mine blasted the rail track, 200 yards north of Toungoo railway station. The track was torn about 11 inches and a crater measuring about 18 square inches was left. Mine clearing was made along the railroad and another mine was discovered at about 300 yards south of the station.

According to the information received in the second week of January 2006, it was revealed that on 11-1-2006 morning a closing ceremony of training course on politics and UG tactics was held at Daungkhwin camp at the border. The course was conducted from 2 to 11 January and attended by Pyithit Nyunt Wai and group of FTUB, chairman Than Khe and group of ABSDF, Than Aye and group of NLD (LA), Khin DPNS, Thein Win and group of NDD, Meesu Pwint and group of BWO (Burma Woman Organization), foreign affairs incharge Phado David Htaw and group of KNU, nine persons from NGOs in USA and Australia and seven persons from VBSW totalling 151. Among the trainees, 38 were platoon commanders of ABSDF, DPNS, NDD, KNU and NLD (LA). The course instructors were ABSDF chairman Than Khe, Myo Win, Lwan Ni, Zaw Min of ABSDF, Htay Aung, Maung Maung Gyi and Thein Win of NDD and Than Aye of NLD (LA).

such as KNU, ABSDF, NLD (LA) and DPNS which have been launching terrorist acts in the country met with SSA-S in northern part of Chiangmai district during the second week of January 2006. They plotted to blast bombs Mawlamyine, Hpa-an and Mudon around the Armed Forces Day. They plotted to feign bomb blasts in some areas in the country hitting one out of two under so-called Operation Reflection.

The terrorist groups

The Operation Reflection was being carried out by DPNS, FTUB, ABSDF and VBSW by making use of UGs of PP-21.

Information was received in January that a group comprising 9 men


and ABSDF could not get a chance to blast bombs at targets, thus they exploded bomb at Toungoo railway station and they are said to be trying to explode bombs at every opportunity.

Consequently, due to a tip-off of a duty conscious citizen, a time bomb was uncovered in time from a dried fish box at a shop in Sipinthaya market of Pyu on 30-1-2006. The bomb was removed immediately to a safe place covered with sandbags and rice-bags. Hence, the explosion caused no injury. The person who planted the bomb was Min Oo 13 and he was exposed immediately due to the cooperation of the people. Min Oo's confession led to interrogation of Zaw Myo, 31, of Lay-ein-su village and Hsan Nyunt Soe, 36, of Paukkon village of Pyu. They confessed that while Zaw Myo jungle near Kyaungpyar village of Kanyuntkwin. KNU regional in-charge Er Htaw threatened and coerced him to blast a bomb at Pyu Sipinthaya market. Zaw Myo organized charcoal carrier Hsan Nyunt Oo by paying 25,000 kyats. Hsan Nyunt Oo asked his son Min Oo to leave the time bomb in the market, it was exposed. On 1-2-2006 evening, KNU insurgents blasted a bomb at a gas pipeline to Myainggalay cement factory near Kwanlya village of Mudon Township. The gas pipeline was exploded.

In late January Thein Win of NDD sent mercenary saboteurs Kuppali, Myint Win and Yunod of ABSDF to blast bombs in the country. Similarly, under the arrangement of FTUB secretary Pyithit Nyunt Wai, DPNS chairman Aung Moe Zaw,

Maung Maung Gyi, saboteurs Myat Kyaw of DPNS, Aung Ye Thway and San Wai of VBSW were also sent to explode bombs at departmental buildings, offices, houses and bus terminals. Moreover, 15 persons led by saboteur Aung Naing of ABSDF held a meeting at Wawlay village at Myanmar-Thai border and sent two sabotage teams into the country on 7-2-2006. One team comprised Thet Tun, Aung Thiha, Ma Aye Moe, Ma Thuzar and Nan Thida Oo and another team comprised Aung Ko Naing, Aung Zaw Moe, Sai Tun Tun, Nyi Nyi Naing and Zin Myo Ko.

According to the information received in early February, it was learnt that under the joint arrangement of NCGUB, ABSDF, NDD, FTUB and DPNS, vice-chairman Yin Htwe, Nay Lin and (See page 10)





about 2 am on 7-2-2006 Those two mines were TNT and gun powder weighing about 7.5 pounds, it was discovered later. If they exploded, it would be so dangerous that the blast could easily tear the rail and derail the train. The surrounding areas were then combed and another 3.5-inch rocket targeting the railroad near a farmland about 400 yards east of the railroad was uncovered. Issaz and ABSDF chairman Thankhe had a meeting at horticultural farm of KNU Hpa-an district chairman Phado Arto in east of Maelamat on 25-2-2006 and they discussed matters on launching military, sabotage and political attacks simultaneously beginning March.

A bomb exploded at a place eight feet from the wall of No 1 BEHS in Toungoo on 2 March 2006 morning. About two hours later, a transformer, near Panyoema women's hostel at the corner of Myogyi and Setshin streets, Ward 20, in the town was blown up by a bomb. The explosion destroyed parts of the brick building where the transformer was kept.

With public help, the authorities were able to expose and arrest the terrorist, Saw Gethe Mu (a) Nay La, 27, of KNU brigade 5, and his accomplices, soon after the incident. Together with other 70 KNU members, Saw Gethe Mu attended an explosives course Hteelekwee region. He confessed that commander of KNU 5 brigade Saw Baw Kvaw He ordered him to blow up bombs in Taungoo, Pyinmana, Thazi and Meiktila, Saw Ta Wa in Pyu, Nyaunglebin, Bago and Yangon, and Saw Te Po in Papun.

His uncle, Saw Se Kale He of Sanegon Ward, Taungoo, showed the authorities where four gelignite bars, two detonators, one hand grenade, and four table clocks were kept secret. The authorities seized the explosives and related equipment. According to Saw Gethe Mu he would continue to realize his further plans to blow up bombs in Meiktila highway terminal, and Thazi railway station, if he was not caught and arrested

The authorities received information, which said that Pakaw Htoo and Zaw Tin Win, under orders of KNU brigade 7, together with ABSDF bomber Ye Win, had plans to blow up bombs in Pyinmana.

Another information said that the KNU brigade 4 conducted a bomb explosives course in Hteenawkkhee region with foreign assistance. A French taught about the time bomb and an Australian, remote-controlled bomb explosion technique.

Thanks to the information given by a duty conscious person, the authorities were able to seize a mine at a place 80 yards west of the railroad be-Yedashe and tween Kyungon railway stations on 19 March, 2006. It was found that the fleeing terrorists left behind the mine as they were not able to plant it.

We can always expose and arrest the terrorists in time and save the people from grave dangers, thanks to the duty conscious people, who have the tradition of actively

ties, with full security awareness.

The people do not accept the terrorists and their acts to harm the good results of peace, stability and progress of the nation. It is obvious that they are always ready to join hands with the Tatmadaw to root out the terrorists.

Member of NDD Thein Win's hardcore Yunod confessed at the press conference No 2/2006 that the explosions took place just after Thein Win asked him for some information as to whether security was tightened or not in such

busy places. NDD Thein Win's hardcore UG member Sava Ye (a) Than Oo, 53. of Pyu, who was arrested on 24-3-2006 confessed that with the payment of Thein Win, he incited a demonstration of one or two protesters each in three places in Yangon; that he gave cash and supervised for two nuns to stage protests in front of the City Hall; that he gave cash and supervised Naing Lin and Naing Win to do the same in front of a foreign embassy; that he gave cash and supervised Kyaw Kyaw to protest on Shwegondaing Road; he received 3 satellite phones from Thein Win and distributed them to UGs; that he gave a satellite phone to UG U

Aung Thein of Tharkayta Township as ordered by NLD(LA) secretary Daw San San who is living in Maesot; that when he visited Thein Win's house near Baht-200 market in the neighbouring country in July 2003 he saw Thein Win conducting a course on blasting time bomb to saboteur Thet Khaing; that Thein Win told him that some arms were hidden under a duck pond at the back of his house; that while he visited Thein Win in the neighbouring country in August 2004, Thein Win told him that the attack with launcher to a ship at Kyimyindine jetty was masterminded by Pyithit Nyunt Wai and his cohorts; that NDD Thein Win mainly ordered saboteur Tin Moe in blasting bombs within the country; that Tin Moe together with Ko Naing (Bago) and Win Min (Sagaing) used to blasting bombs; and that a close follower of Thein Win disclosed to him that the blasting of bombs at 3 busy places in Yangon were masterminded by Thein Win.

Similarly, Thein Win's hardcore UG U Aung Thein of Tharkayta Township who was arrested on 25-3-2006 confessed that he worked together with Daw San San (NLD representative-elect Seikkan Township) expatriate who is now the secretary of NLD (LA), at the Labour Department

Later, NCGUB of Sein Win formed the National Council of the Union of Burma (NCUB) abroad in cooperation with NDF, DAB, NLD (LA), Members of Parliament Union-MPU. The NCUB was formed under the political cloak to get assistance for controlling and funding all terrorist acts. Its chairman is no other than Tarmalar Baw of KNU, and secretary Pyithit Nyunt Wai of FTUB. They are harmoniously resorting to terrorist acts at present.

On 30 November 2003 NCUB NCGUB issued a Joint Policy Declaration. In the declaration the NCUB and NCGUB said that they would firmly take the responsibility for working out for the future of Myanmar's policooperating with authori- tics and fate. It is obvious

money to terrorists. I have already explained their crimes to be known to the world with firm evidence at the previous press conferences. The dailies in Myanmar also carried the news about the confessions made by the seized mercenary thugs in public or at the courts together with news photos.

Myanmar is party to 11 international conventions to suppress terrorism, which include the International Convention for the Suppression of Terrorist Bombing and International Convention for the Suppression of the Financing of Terrorism. According to the two conventions, it is obvious that expatriate Sein Win and Pyithit Nyunt Wai are committing terrorist acts under cover of democracy and labour affairs. The government declared both NCGUB and FTUB unlawful association on 28 August 2005.



before the 1988 disturbances. He said that after the 1988 disturbances, he joined NLD and performed duties as Organizing Committee member and central social support committee member; that Daw San San lived at Thein Win's house in Maesot and he had phone contact with Daw San San; that in June 2004 Daw San San sent 300,000 kyats and a satellite phone to him via Saya Ye and he had to send information on political activities of the party and some organizations; that he had to send information through satellite phone for 13 times; that Daw San San sent such information to NCGUB expatriate Sein Win, NLD (LA) Win Khet and MPU; and that a total of 450,000 kyats sent by NDD Thein Win and NLD (LA) Daw San San were spent as expenditures in health and social affairs of NLD members.

Likewise, Thein Win's hardcore UG Khaing Mar Soe of Pyu who was arrested on 26-3-2006 confessed that she went to a neighbouring country to work as illegal worker and she was organized by NDD Thein Win; that Thein Win asked her to send cash and kind

into the country; that she was arrested in Thingan Nyinaung in 2001 and sentenced to 4 years' imprisonment; that she was released on 1-6-2005 and she contacted NDD Thein Win in Maesot; that Thein Win gave her about 400,000 kyats as cash assistance; that as ordered by Thein Win she distributed cash assistance to hardcore UGs within the country; that as arranged by Thein Win she was interviewed by a foreign broadcasting station through a satellite phone at Thein Win's house in January and February 2006 and that she fabricated news about summer paddy cultivation in Myanmar.

Moreover, according to the confessions of Oktwin Township NLD vice-chairman (former chairman of Oktwin Township NLD) U Khin Maung Win, on 31-3-2006, the links of terrorist NDD Thein Win can be found vividly. U Khin Maung Win confessed that he became Township NLD chairman after the 1988 disturbances; that he was representative-elect from Oktwin Township constituency-2 in the 1990 elections; that in 1991 he was sentenced to 15 years' imprisonment under section 5(J) of Emergency Act and section 15(A) of Gambling Act; that he was released on 30-7-2001 and performing duty as vicechairman of Oktwin Township NLD; that while living in Kywepwe, Khaing Mar Soe visited him twice in November and December 2005; that she told him Thein Win was in the neighbouring country and she passed the regards sent from Thein Win together with 50,000 kyats; that Khaing Mar Soe visited him for the third time in February 2006 and told him that Thein Win asked him to arrange for farmers to make complaints that their paddy did not fetch good prices; that he replied the farmers were getting good prices and high yield for paddy as well as matpe and it was impossible to make complaint; that Khaing Mar Soe asked him to try his best and gave 50,000 kyats; that in early March Khaing Mar Soe came and raised the matter again and he replied to her that he could not do the job as there was none to make complaint. She asked him to try again.

Similarly, NDD Thein Win's hard-core member UG U Aung Moe, 77, who was arrested on 28-3-2006 confessed that under the arrangements of Thein Win, he met with Pyithit Nyunt Wai at the Patik Hotel in Maesot and earned honorarium for his translation work at the course on labour affairs conducted by a US citizen; that he sent fabricated news from within the country; that while he stayed at Thein Win's house in Maesot, he met with NCGUB expatriate Sein Win, FTUB Pyithit Nyunt Wai, as well as Phado Man Shar of KNU, and compiled a paper on Myanmar currency as he was asked and paid by them for doing so. In March 2005 he went to Thein Win and the latter asked him to have discussions with Thakin Thein Pe. Ludu

Daw Amar, Dagon Taryar and U Ba Swe. Thein Win paid him 400,000 kyats. UG hardcore U Aung Moe met with Thakin Thein Pe and U Ba Swe and gave 50,000 kyats to Thakin Thein Pe and 100,000 to Ludu Daw Amar. In September 2005 he went to Thein Win again and had discussions with Phado Man Shar and Mehm Nyein Maung of KNU. When he went to Thein Win again in December he had discussions with KNU chief of staff Mutu. The above-mentioned facts reveal that the NLD members and the noted persons within the country had contacts with expatriate terrorists

All members of NCUB including NCGUB of expatriate Sein Win, FTUB of Pyithit Nyunt Wai and KNU are actually terrorists. Their hardcore UGs are brought here in this hall for you journalists to ask them.

A recent attack from abroad was made at the ILO governing body's 295th meeting held on 30-3-2006 in Geneva. At that meeting labour delegates leader Sir Leroy Trotman disclosed that he did not accept the declaration of FTUB of Pyithit Nyunt Wai as unlawful terrorist organization. Moreover, accusation was made that forced labour issue in Myanmar has no improvement. They attempted to raise the issue of Myanmar at ILO conference to be held in the coming June. It is obvious that Pyithit Nyunt Wai and four or five others were given with FTUB badge and asked to send fabricated news about the country.

Actually, renegade Pyithit Nyunt Wai was given a limelight by permitting him to attend ILC (International Labour Conference) meeting, CAS (Committee on Application of Standards) meeting and ICFTU (International Confederation of Free Trade Unions) meeting as labour representative. It is questionable that ILO is recognizing the terrorists.

It was the acceleration of above-ground attack in line with the three-pronged attack of above-ground, underground and external attacks against the Government. The minions and their foreign masters accused that there were forced labour in Myanmar, child soldiers and licensed to rape, ethnic cleansing and villages were removed by force.

The one which is actually undertaking ethnic cleansing is NCUB which has been setting villages on fire, blasting bombs at crowded places and railroads. Ignoring the true fact, USA and some EU countries imposed economic sanctions lop-sidedly against Myanmar. as a measure of foreign attack tactics. In addition, they asked China, India and ASEAN countries to put pressure on Myanmar. Moreover, they exaggerated Myanmar's affairs into the global conern and tried to put the case to UN Security Council. On 29-3-2006, the Senate hearing was conducted on Myanmar and it was discussed to continue sanctions against Myanmar until the release of detained axe-

handles in the country. The discussion also included matters for Bush administration to join hands with other governments to take action on Myanmar and to try again to put Myanmar's affairs to UN Security Council as, according to the hearing, it was threatening the regional stability.

MPU (Members of Parliament Union) of NLD expatriates included in the NCUB, joining hands with Burma Campaign (India), held a workshop on 31-3-2006 in India. At the workshop, NLD expatriate Tint Swe discussed that Myanmar's affairs were coming out of the Myanmar boundary and threatening the regional stability and they had to find ways and means.

Similarly, the discussions were held on 31-3-2006 in Brussels of Belgium. Representatives from 13 European countries, Europe-based NGOs, NCGUB of expatriate Sein Win and NCUB of Pyithit Nyunt Wai attended the meeting. Demands were made for EU to put more pressure so as for the UN Security Council to act on Myanmar's affairs; and to compile facts on violation of human rights so as to put more pressure on Myanmar Government. NLD has requested EU to put more pressure on Myanmar if Myanmar Government does not comply its demand mentioned in the Union Day special announcement.

At this juncture, VBSW (Vigorous Burmese Student Warriors) issued an announcement demanding the reply of the Government as regards the NLD's Union Day announcement and withdrawing of foreign investments. The announcement also said that if their demands are not complied with, they would attack Union Solidarity and Development Association members, Fire Brigade members, and businessmen collaborating with the government. That announcement of VBSW was broadcast by VOA on 27 March evening.

Keeping a constant vigilance, the people, the Tatmadaw, Myanmar Police Force, hand in hand, have been able to take sufficient preventive security measures against the terrorist acts. They will continue to cooperate increasingly, it is certain. Nevertheless, independence can be lost suddenly if it is not preserved properly with serious care. And it took over 100 years to regain independence after sacrificing a lot of lives, blood and sweat. The entire people are to take lessons from history and be aware of that fact.

Hence, internal and external destructive elements should be opposed and crushed as common enemies in line with the People's Desire as they are hindering the progress in endeavours of the Tatmadaw and the people in building the Union into a discipline-flourishing democratic nation. The people are to vigilantly expose the terrorists who are disguising themselves as ordinary people and to inform any suspicious looking ones to authorities concerned. Mass vigilance is required to ward off terrorist destructionists. —MNA



Three arrested for killing pasta **BAE** in talks to sell Airbus tycoon in Venezuela stake to **EADS**

CARACAS, 8 April - Venezuelan police have arrested three persons suspected of involvement in the kidnapping and murder of a prominent pasta company owner last week, the Justice Minister said on Wednesday.

Justice Minister Jesse Chacon told state television that some 10 persons were involved in the case of kidnapping and killing 74-year-old Filippo Sindoni, an Italian-born businessman who had built his fame and fortune in Venezuela with his popular Pasta Sindoni brand.

The motive behind the killing has yet to be decided, personal revenge being a possibility. Chacon said.

Three of the 10 | suspects had been arrested, Chacon said, without naming any, and among the involved was a middle-ranking police officer from the northeastern state of Aragua, where the case happened

The policeman was suspected of providing uniforms and equipment for the kidnappers who stopped Sindoni's car and ordered his driver to get out on 29 March. Sindoni

was found dead a day later in the town of Carora, some 370 kilometres west of Caracas, with a bullet wound to the head and cuts covering his body.

Authorities were searching for the other seven suspects in Aragua, neighbouring Carabobo State and Caracas.

Apart from the pasta company, Sindoni also owned a regional TV station and a small newspaper.

Bird flu kills third Egyptian

CAIRO, 8 April — An Egyptian girl died from bird flu on Thursday, taking to three the country's human death toll from the virus, the official MENA news agency reported.

The latest death was a 16-year-old girl from a province north of Cairo, who was admitted to hospital on Wednesday.

"Iman Mohamed Abdel Gawad, a 16-year-old girl from Monoufiya, died after being infected by bird flu," MENA said, quoting official information.

Late on the Wednesday the health minister said a 16-year-old girl from the same province had been admitted to hospital with bird flu after handling dead birds, taking to 11 the number of people the Egyptian Government says have caught the virus.

The World Health Organization has so far confirmed four of those cases as the H5N1 strain of the bird flu virus. including the previous two people who

Bayern expect Ballack to move to Chelsea

Frankfurt, 9 April—Bayern Munich are resigned to losing midfielder Michael Ballack to Chelsea at the end of the season. "I'm all but certain that Ballack will move to Chelsea," Bayern manager Uli Hoeness told Premiere TV on Saturday.

Ballack's contract runs out at the end of the season, leaving the Germany captain a free agent. The 29-year-old has so far rejected offers to sign a new deal with the Bayarians.

Werder crush Bayern to cap bad week for Kahn

Frankfurt, 9 April— Werder Bremen crushed Bayern Munich 3-0 on Saturday to prise open the Bundesliga title race and cap a bad week for Bayern goalkeeper Oliver Kahn.

Bastian Schweinsteiger headed past Kahn and into his own net in the 33rd minute to hand Werder the lead in Bremen and late goals from Daniel Jensen and Tim Borowski completed Bayern's heaviest league defeat of the season. Champions Bayern are top on 66 points, followed by Bremen and Hamburg on 59, the latter with a game in hand.

Bayern remain well placed for a 20th league title with five games left but Hamburg can cut their lead to four points if they win at home to Borussia Moenchengladbach on Sunday. Hertha Berlin are fifth on 43 points after winning 2-0 at third from bottom Kaiserslautern. Cologne, one place lower, beat VfL Wolfsburg 3-0.

The Bayern defeat provided further disappointment for Kahn, who was told by Germany coach Juergen Klinsmann on Friday that his great rival Jens Lehmann would be first choice goalkeeper for the hosts at the World Cup.

Kahn's form deserted him last week in a 2-2 draw with bottom club Cologne that first suggested Bayern might not have the title race sewn up. They needed a win on Saturday to reassert their authority but even though Kahn looked in good touch and was not at fault on any of the goals, Bayern ended up well beaten.—MNA/Reuters

Inter beat Ascoli to go second in Serie A

ROME, 9 April— Inter Milan put their Champions League elimination by Villarreal behind them with a 2-1 win at Ascoli that moved them up to second in Serie A on Saturday.

Spurs edge closer to Champions League qualifiers

LONDON, 9 April— Midfielder Michael Carrick guided Tottenham Hotspur to a 2-1 victory over Manchester City that tightened their grip on a place in the Champions League qualifiers on Saturday.

Canadian defender Paul Stalteri put the hosts in front a minute before halftime at White Hart Lane and Carrick made it 2-0 before Greek forward Georgios Samaras pulled one back for City in the 52nd minute.

Victory for Spurs strengthened their hold on fourth place, England's second slot in the final Champions League qualifying round, by moving them on to 58 points from 33 games. Blackburn, on 54 points from 33 games, may yetrue the points dropped at Fratton Park because they have now played two games more than Arsenal, who have 53 points and face Manchester United at Old Trafford on Sunday. Having inflicted a fifth consecutive league defeat on Manchester City, Spurs manager Martin Jol played down the pressure on his side in the Champions League race. "If Arsenal win all their games then maybe we could have a problem," he told Sky Sports.—MNA/Reuters


