Regional cooperation for food security, environmental conservation

Prime Minister General Thein Sein, at the invitation of President of the Republic of Korea Mr. Lee Myung-bak, attended the ASEAN-Republic of Korea Commemorative Summit and Related Summits of Bilateral Summit in Jeju, the Republic of Korea on 1 and 2 June.

The summits were attended by the Korean President, and the Heads of State/Government of ASEAN countries. They endorsed the Joint Declaration and the agreement of establishment of ASEAN-Korea free trade area.

Prime Minister General Thein Sein delivered an address to the ASEAN-Republic of Korea Commemorative Summit Session-II, saying that Myanmar welcomed the establishment of ASEAN+3 emergency rice reserve to avert insecurity of major food such as rice; and that Myanmar wished to see agricultural cooperation and technological exchanges for security of food, for alleviation of poverty and for sustainable development.

ASEAN-Republic of Korea relations have improved from multi-sectoral cooperation to the level of dialogue partner since 1989. It is heartening to note that the joint declaration led to an increase in the funds for cooperation. In addition, the two sides will boost trade, investment, tourism and cultural exchanges.

All the countries concerned will have to cooperate in accordance with the principles manifested in the UN climate change framework. And they should welcome the announcement of ROK that it would provide 200 million US dollars for East Asia climate Partnership.

It is, therefore, believed that ASEAN-Republic of Korea Commemorative Summit will help cope with global challenges such as climate change, conservation and sustainable development of the environment.

Bomb attack kills four Afghan farmers in Afghanistan

KABUL, 5 June-Four farmers were killed Wednesday as a mine struck their tractor in Kandahar Province in Afghanistan, the former stronghold of Taleban, police said on Thursday.

"The gruesome incident occurred in Shah Walikot district on Wednesday, resultantly killing four farmers and destroying their tractor," a senior police officer Abdullah Khan said.

This is the first time that farmers became victims of militants' cruel tactic of roadside bombing in Taleban's former stronghold. Taleban militants, who have vowed to step up activities this year in Afghanistan, have yet to make any comment.-Internet

Taleban militants kill Afghan candidate of provincial council

KABUL, 5 June — Police in central Afghan province of Wardak on Thursday found the dead body of a provincial council candidate, who was kidnapped by militants last week, provincial police chief of Ghazni Province said. "Yeiya Mulaye Azhar, who has signed up for competing provincial election, was killed on Wednesday night and police found his body in Sayed Abad district of Wardak Province on Thursday," Khil Baz Shirza told Xinhua. Azhar has not been working for government, Shirza added.

The police chief blamed the enemy of Afghanistan, a term used by Afghan officials for Taleban militants, for the incident. The second presidential and provincial election in post-Taleban Afghanistan is set on 20 August this year while Taleban militants have warned Afghans to boycott the election.-Internet

Iran's Supreme Leader says US "deeply" hated in Middle East

Leader Ayatollah Ali Khamenei said on Thursday the United States was "deeply" hated in the Middle East and urged Washington to take "actions" to transform its image.

"The nations in this part of the world deeply hate America because they have seen violence, military intervention and discrimination," Khamenei said in a televised speech on the occasion of the 20th anniversary of death of Iran's late leader Ayatollah Ruhollah Khomeini.

The new US government could not change its image by "words, speeches and slogans," Khamenei said. "Actions

TEHERAN, 5 June—Iran's Supreme | are needed." The Iranian supreme leader's remarks came as US President Barack Obama arrived on Thursday morning in Cairo, where he will deliver a much-anticipated speech to the Muslim world in Cairo University.

The speech had been promised by Obama after he assumed office in January, a move viewed as his reach out to the Muslims to mend the US-Muslim ties tarnished by his predecessor's administration. Teheran and Washington broke up diplomatic ties in 1980 following Iran's 1979 Islamic Revolution and the succedent hostage incident of US embassy in Teheran.

Two soldiers killed, six injured in clashes with rebels in Colombia

BOGOTA, 5 June — Two Colombian soldiers were killed and six others were injured during clashes with rebels in the border province of Narino early Thursday, Colombian authorities said.

Some members of the Revolutionary Armed Forces of Colombia (FARC) were detected by government soldiers in a minefield in the southern province early Thursday morning, a local government official said.

The two sides exchanged gunfire before the rebels detonated landmines, killing two soldiers and injuring six others, the official added.

The FARC, Colombia's largest rebel group, has been fighting government troops for more than 40 years. Internet

US soldier killed in grenade attack in Iraq

BAGHDAD, 5 June — An American soldier died of wounds sustained from a grenade attack in northern Iraq on Thursday, the US military said. The attack occurred when militants hurled a hand grenade on his patrol in the province of Kirkuk, a military statement said without elaboration.

Kirkuk is a volatile area which is home to a mix of Kurds, Arabs and Turkomans, who are in territorial dispute. About 4,309 US soldiers have been killed in Iraq since the outbreak of Iraq war in March 2003, according to media count based on Pentagon figures.

Turkish soldier killed in clash with PKK

ANKARA, 5 June — One soldier of the Turkish security forces was killed in a clash with the rebels of the outlawed Kurdish Workers' Party (PKK) in southeastern Turkey on Thursday, the semi-official Anatolia news agency reported.

Three other soldiers were injured in the clash in the Bestler-Dereler region in the province of Sirnak, according to the report. The clash came three days after the PKK announced it would halt its armed attacks against Turkish targets until 15 July.

Turkish security forces conduct

frequent operations against PKK militants in eastern and southeastern Turkey.

The PKK took up arms in 1984 to create an ethnic homeland in southeastern Turkey.

Some 40,000 people have been killed in the over two-decade conflict. Turkey's military forces have taken tougher actions against the PKK after the country's legislature extended the government's mandate to launch cross-border operations against the rebels in northern Iraq.

Submarine rescue system delivered to Australia

CANBERRA, 5 June — A new submarine rescue system that will cut response time for underwater emergencies was delivered to Australia on Thursday.

The LR5 submarine rescue system from Britain had previously been "on-call" but was on the other side of the world if needed.

"The relocation improves response times and allows the Royal Australian Navy (RAN) to exercise the capability with Collins Class submarines," the Defence Materiel Organization's head of maritime systems Boyd Robinson said.

The LR5 is a manned submersible in operation with the British Royal Navy.

At least four rebels killed in S Philippines

COTABATO, 5 June — At least four separatist Muslim rebels have been killed and one soldier was wounded in the latest violence in southern Philippines, an Army official said on Thursday.

Fierce firefight broke out Wednesday at around 08:00 pm local time after some members of the Moro Islamic Liberation Front (MILF)—the country's largest guerrilla organization - stormed a military detachment at the village of Riena Reginte in the township of Datu Piang, Maguindanao Province, the military's local spokesman Lt Col Jonathan Ponce told reporters.-Internet

Russia, US to hold third round of START talks in late June

Moscow, 5 June — The third round of Russia-US talks to negotiate a replacement for the Strategic Arms Reduction Treaty (START I) will be held in Geneva in late June, the Russian Foreign Ministry said on Thursday.

Russia and the United States on Wednesday concluded their second round of talks on a new strategic arms reduction agreement in Geneva. "The parties continued to discuss a wide range of issues, including the drafting of the future agreement, and the

report on the negotiating process to be presented to the Russian and the US presidents in July," the Foreign Ministry said in a statement posted on its website.

They "also agreed to hold the next round of talks in the second half of June 2009, in Geneva," it said. The Russian delegation at the talks is led by Anatoly Antonov, director of the security and disarmament department of the Russian Foreign Ministry, and the US del-

The START I, which is due to expire in December, places a limit of 6,000 strategic or long-range nuclear warheads on each side. CHICAGO, 5 June — The Chicago-based US Boeing Company might finally take flight with their 787 Dreamliner plane this summer, it is reported here on Thursday.

Boeing had originally set the first flight date for the new 787 Dreamliner back in the summer of 2007. The plane was touted to be among the lightest and most fuel-efficient in the industry. But Boeing has had to push back the flight date four times because of production problems and a labor strike last fall, according to a report by the Chicago

According to another report, the head of Boeing thinks the Dreamliner could be in the air by the end of this month.

China, Malaysia to upgrade cooperation

BEIJING, 5 June—China would take the 35th anniversary of Sino-Malaysia ties to promote cooperation, said President Hu Jintao here on Thursday. Hu made the remarks during a meeting with visiting Malaysian Prime Minister Najib Tun Razak.

He said ties had developed smoothly in the last 35 years, with frequent high level visits, increasing political trust and fruitful cooperation in trade, energy and infrastructure. The two sides had also worked together to promote cooperation in east Asia and maintained coordination to deal with the international financial crisis, Hu added. Hu said cementing strategic and cooperative partnership was an important component in China's peripheral diplomacy. The two governments signed a joint action plan on strategic cooperation on Wednesday. Najib and Chinese Premier Wen Jiabao attended the signing ceremony after their talks.

Hu said China would take the action plan as an opportunity to push forward tangible cooperation. Najib said the action plan outlined future political, economic, cultural, and education cooperation. He said Malaysia would join with China to promote bilateral and regional cooperation to deal with the financial crisis.

Najib and Chinese Vice Premier Hui Liangyu attended a business forum earlier Thursday, calling for stronger cooperation between companies from both countries. —*Xinhua*

Russia to stage Int'l Military Music Festival in September

BEIJING, 5 June — First Russian International Military Music Festival will be staged in Red Square in early September, announced the organizing committee of the festival at a press conference in Moscow on Wednesday.

Khalilov, instructor-general of the festival and also conductor-general of Russia's Defence Ministry's Military Band, said at the press conference that military bands from China, Britain, Egypt, Israel, India, Italy, Kazakhstan, Finland, France and Switzerland will be invited to perform their traditional military music at the opening ceremony, scheduled on 5 September. Meanwhile, Military Band for Russian President will also stage a special music performance, which performs only on important occasions.

It is learned that during the military music festival, from 5 to 10 September, a live music performance will be staged every night in Red Square by military bands from different countries. In daytime, military bands will also stage charity shows on the main streets, squares and parks in Moscow. — Xinhua

Air France says no hope of finding survivors

PARIS, 5 June-Air France has told families of passengers on Flight 447 that there is no hope that anyone aboard the plane could have survived, the media reported on Thursday. When meeting with families in a hotel near Charles de Gaulle airport on Wednesday, Air France's CEO Pierre-Henri Gourgeon said the plane broke up either in the air or when it crashed into the ocean and there were no survivors, according to Guillaume Denoix de Saint-Marc, a spokesman for a victim's help group. More Debris, including a seven-metre-long object and 10 other objects, some of them metallic, was found by the search planes over a wide area, but pilots had not spotted any signs of survivors, the Brazilian Air Force said.—Xinhua

Four killed in West Bank clashes

RAMALLAH, 5 June—Four people were killed in gunbattles between Hamas militants and Palestinian security forces in the West Bank on Thursday, a source said.

Three Hamas militants and a Palestinian policeman were killed in the gunbattles, the second such incident in less than a week, the source said, adding that the clashes which started early Thursday were over. The bodies of the three Hamas gunmen were found in a building in which they holed up in the northern West Bank city of Qalqilya, said the source. Early Thursday morning, Qalqilya governor Rabeh al-Khandaqji told *Xinhua* that a policeman was killed when he came under fire from a house the Palestinian security forces were trying to search. Slovenian ship escapes Somali pirates attack

BELGRADE, 5 June—A Slovenian ship was attacked in the Gulf of Aden early on Thursday by Somali pirates, but managed to escape with the help of an Indian military ship, Slovenian national radio reported.

The pirates in three boats failed in their attempt to hijack the ship Postojna owned by the Slovenian maritime transport company Splosna plovba because of the quick response from the Indian military ship, which escorting a convoy of ships, the radio said.

According to the radio, the Indian ship fired several warning shots to discourage the attackers and no one was injured in the incident.— *Xinhua*



Witnesses said the shooting began when the policeman approached the door of the house. A security source also told *Xinhua* that Hamas gunmen started the shooting.

Meanwhile, a sources close to Hamas said the Palestinian National Authority sent troops to the house of Abdel Fatah Shraim, a Hamas member who has been in detention, in a bid to arrest his fellow militants hiding there. The Hamas source, however, denied that the militant attacked the security troops.—*Xinhua*

Today, so we are celebrating the World Environment Day in Myanmar in accordance with this year's theme: "Your Planet Needs You: Unite to Combat Climate Change", the World Environment Day is being celebrated in Mexico City of Mexico at the global level. Myanmar is cooperating hand-in-hand with the international communities in the movement to conserve the environment. Myanmar is actively taking part in the activities for the benefit of the human being, holding the Environment Day annually.

Today, natural disasters such as heavy rainfall, storms, flood, land slides, earthquakes and tsunami are

using today, to use solar energy and wind energy and to extensively implement research activities.

Sustainable environmental conservation is one of eight goals of the UN for reducing environmental deterioration across the world in 2015 in addition to the development gap among the global countries and education and health requirements of developing countries. Myanmar, being a member of the UN, is striving for meeting the goals similar to that of other global countries.

Myanmar formed the National Commission for Environmental Affairs in 1990 in order to systematically and effectively perform the environmental conservation activities. The objectives of the NCEA are:

- to establish sound environmental policies for utilization of natural resources;
- to set environmental standards, rules and

being faced in some parts of the world while drought, intense heat, and extreme cold are also experienced in other parts of the world. At the same time, degradation of the environment such as air pollution, shortage of water, melting of ice sheets in the poles, rising of sea level, and greenhouse gases are threatening the existence of human being almost every day.

If we study the causes of the environmental degradation, we will find that GHGs such as CO2 and CFC (Chlorofluorocarbons) emission from industries for centuries has caused ozone depletion, deforestation and melting ice in poles, and as a consequence, ecosystem in which plants, animals and environment are intertwined, has been degraded.

Today, due to excessive utilization of resources and pollution of the environment which are the major causes leading to the environmental degradation, a regulations to control the pollution of water, air, and noise, hazardous and toxic wastes, chemicals; to formulate policies and strategies which take into consideration needs for both environment and development; and

to broaden the knowledge about the environmental conservation of the entire people through extension activities for their participation.

In addition, development tasks are being undertaken for uplifting living standard of the entire people and the aim is being realized for environmental conservation. Myanmar's environmental policy was issued in 1994. In accordance with the environmental policy, the Nature Conservation Committee was formed in 2004 with the representatives from nine ministries as the members who are responsible for monitoring the environmental conservation activities at different

The country is also carrying out the establishment of nature reserves, expansion of reserved forests and protected public forests, establishment of forest plantations, tree planting programme by public movement, conservation of watersheds, measures to reduce shifting cultivation in line with forestry and wildlife conservation legislations and regulations.

In accordance with the guidance of the Head of State, Dry Zone Greening Department was formed in 1997 and the department has been carrying out natural forest protection, plantation forest establishment, wood fuel substitution, and water supply tasks in 13 districts of Mandalay, Sagaing and Magway Divisions since then. Final statements of both sides for amendments regarding dismissal of three witnesses nominated by plaintiffs heard

NAY PYI TAW, 5 June— Yangon North District Court this morning presided over criminal cases No. 47/2009, No. 48/2009 and No. 49/2009 against US citizen Mr. John William Yettaw, Daw Aung San Suu Kyi, Daw Khin Khin Win and Ma Win Ma Ma.

As the lawyers of the defendants submitted the application for amendment related to the decree on criminal case No. 47/2009 to the Yangon Division Court, the court could not hear the final statement and hearing of the cases were adjourned until 12 June.

In the criminal case No. 47/2009 of Yangon North District Court against US citizen Mr. John William Yettaw, Daw Aung San Suu Kyi, Daw Khin Khin Win and Ma Win Ma Ma, defendants Daw Aung San Suu Kyi, Daw Khin Khin Win and Ma Win Ma Ma submitted the application for amendment to Yangon Division Court on 2 June through their lawyers U Kyi Win, U Nyan Win, U Hla Myo Myint and Daw Khin Htay Kywe to amend the decree on refusing their three witnesses ruled by the Yangon North District Court. It was the criminal amendment case No. 437/2009 of the Yangon Division Court.

After hearing the statement of Lawyer U Nyan Win, Yangon Division Court accepted the application for amendments to the decree and the hearing was adjourned until 5 June.

The final arguments of both sides were heard at 3 pm today. In his statement, Lawyer U Nyan Win said Daw Aung San Suu Kyi, Daw Khin Khin Win and Daw Win Ma Ma presented four defence witnesses. The four defence witnesses are U Tin Oo, U Win Tin, U Kyi Win and Daw Khin Moh Moh. The court stated that it would examine U Kyi Win, out of four proposed witnesses, and examined U Kyi Win on 28 May, he said. He assumed that three other witnesses were rejected as the court did not summon them to the court, he added. As they assumed that it was injust and against the law, the applicants pleaded for amendments to the decree. He continued to sav that it was against the law that in the daily records of the court, only U Kyi Win would be summoned to the court on 27 May and there is no decree related to other defence witnesses. It was wrong for the court that it did not issue a separate decree for other defence witnesses without tangible reasons and the decision of the members of the jury was biased, that the

provision of the code of criminal procedure Section 257(1) was submitted to the court for easy reference; that the accused claimed that if the application was assumed to be made for the purpose of vexation or delay or for defeating the ends of justice, summoning of a witness could be refused; that it was clearly stated that if refused, the reason must be put on record; that as for presenting the current witnesses, there was no intention concerning the points mentioned above for any reason, especially there was not any intention at all to cause delay; that it was wrong to reject without any evidence and to do so without any reason by deciding that summoning U Kyi Win alone and refusing other defence witnesses without issuing any separate decrees although four witnesses were claimed for examination as stated in the amendment form para-4 were aimed at harming the statements vexation, or delay or defeating the ends of justice prescribed in the provision of the code of criminal procedure Section 257 (1); and that the original court decree should be amended as such mistakes could not be remedied under Section 537 of the code of criminal procedure.

Yangon Division deputy law officer Daw Khin Mar Kyi in her final argument said, in the application for amendments, it was stated that in the original court decree dated 27 May U Kyi Win alone was to be examined as a witness; that refusing other witnesses without any separate decrees was contrary to the code of criminal procedure Section 257 (1); that although it was verbally said that the decree was issued in accord with the Section 257 (1) of the code of criminal procedure, it was not kept on daily record; and she added that according to the daily record of the court dated 27 May, the decision was made as follows: Daw Aung San Suu Kyi, Daw Khin Khin Win and Daw Win Ma Ma (a) Ange Lay submitted the list of witnesses, law experts U Kyi Win, Daw Khin Moh, U Win Tin and U Tin Oo with regard to their character. There was no argument against the character.

apply for amendments, U Win Tin and U Tin Oo are intended to provide some statements regarding the characters of the applicants. Regarding the characters of the applicants, the court has already made a decision that there is no need to argue. Moreover, in the case filed for Mr John William Yettaw's entering the house of Daw Aung San Suu Kyi, there has not been any accusation against her for her characters. Therefore, the decision not to call and question U Win Tin and U Tin Oo, to say about the characters of the applicants, is not against the law. The applicants have submitted that they wish to hire Daw Khin Moh Moh as a legal expert. Lawyers, who will give the clients advice, have the rights to provide arguments on legal affairs in the case. The court has summoned U Kyi Win as a legal expert, so not calling and questioning Daw Khin Moh Moh is not against the law. Section 257 (1) of Code of Criminal Procedure says, "If the accused, after he has entered upon his defence, applies to the Magistrate to issue any process for compelling the attendance of any witness for the purpose of examination or cross-examination, or the production of any document or other thing, the Magistrate shall issue such process unless he considers that such application should be refused on the ground that it is made for the purpose of vexation or delay or for defeating the ends of justice." So, the court does not need to summon all the witnesses the accused has nominated. Apparently the witnesses the applicants have nominated are the ones who are not needed to

Competent lawyers who advise the clients in the court have the rights to provide their arguments. Our decision is that we will summon Advocate U Kyi Win only to provide evidences in the arguments. Of the four witnesses nominated by those who present any evidences, so there is nothing more than delay if they are summoned and examined. Therefore, the court's decision not to call and examine those witnesses complies with the law. Therefore, I would say the amendments proposed by the applicants should be dismissed.

Today, Supreme Court Advocates U Kyi Win, U Nyan Win, U Hla Myo Myint and Daw Khin Htay Kywe were on the side of the applicants; and Yangon Division Deputy Law Officer Daw Khin Mar Kyi, Daw Khin May Day and U Myat Khaing, on the side of those who defended the application.

After hearing the final arguments of both sides, Yangon Division Court fixed the date of the 9th of June to deliver the judgment on the case.

High population density triggers cultural explosions

LONDON, 5 June — Increasing population density, rather than boosts in human brain power, appears to have catalysed the emergence of modern human behaviour, according to a new study by UCL



New research suggests that increasing population density, rather than boosts in human brain power, appears to have catalyzed the emergence of modern human behavior.

(University College London) scientists published in the journal Science.

High population density leads to greater exchange of ideas and skills and prevents the loss of new innovations. It is this skill maintenance, combined with a greater probability of useful innovations, that led to modern human behaviour appearing at different times in different parts of the world.

In the study, the UCL team found that complex skills learnt across generations can only be maintained when there is a critical level of interaction between people. Using computer simulations of social learning, they showed that high and low-skilled groups could coexist over long periods of time and that the degree of skill they maintained depended on local population density or the degree of migration between them. Using genetic estimates of population size in the past, the team went on to show that density was similar in sub-Saharan Africa, Europe and the Middle-East when modern behaviour first appeared in each of these regions. The paper also points to evidence that population density would have dropped for climatic reasons at the time when modern human behaviour temporarily disappeared in sub-Saharan Africa.—Internet

How humans have disrupted nitrogen cycle

NUUK, 5 June — More and more, scientists are getting a better grip on the nitrogen cycle. They are learning about sources of nitrogen and how this element changes as it loops from the nonliving, such as the atmosphere, soil or water, to the living, whether plants or animals. Scientists have determined that humans are disrupting the nitrogen cycle by altering the amount of nitrogen that is stored in the biosphere.

The chief culprit is fossil fuel combustion, which releases nitric oxides into the air that combine with other elements to form smog and acid rain. But it has been difficult to know precisely the extent to which such emissions have altered the nitrogen balance.—*Internet*



Ice Coring Scientists extracted a 100-meter-long ice core in Greenland to measure how fossil fuel burning of industrial times has disrupted the global nitrogen cycle. Fighter plane crashes in Greece with pilot ejecting to safety

ATHENS, 5 June — A Greek Airforce *F-16* fighter plane crashed on Thursday morning near Ioannina, northwestern Greece, while its pilot managed to eject to safety.

Ten-year-old girl battles breast cancer

BEIJING, 5 June — Ten-year-old Hannah Powell-Auslam from Southern California shocked the world when she was diagnosed with breast cancer in April. But even after her first chemo treatment recently, the girl is upbeat and determined to beat the disease.

"I always try to look on the bright side with everything," Hannah—the fifth-grader at Escalona Elementary School— said ABC's "Good Morning America" in an interview that aired on Wednesday.

Hannah, according to her family, is the youngest known girl to be diagnosed with breast cancer after complaining of an itch in her side in April. Her mother discovered a lump, and that led to a diagnosis of breast cancer. Her family said she was diagnosed with invasive secretory carcinoma, a type discovered in children in the 1960s."You feel like you're sick all the time," Hannah said of the effects of her chemotherapy. "You just want to go lay in bed and be in your closedoff little box."

In a desperate attempt to save Hannah's life, doctors removed her left breast on 7 May. The show filmed Hannah at home getting her head shaved rather than waiting for chemotherapy to take its toll. Other family members—her father, grandfather and younger

Alaska leads US states in overall Internet

access

SAN FRANCISCO, 5 June—Alaska had the highest overall Internet penetration rate among the 50 states and the District of Columbia in the United States, a new study has found.

In October 2007, when the most recent data is available, 76.1 percent of Alaskans aged 3 and over had Internet access from any location either inside or outside their homes, Alaska's largest newspaper Anchorage *Daily News* reported on Thursday, citing latest statistics from the US Census Bureau.

Alaska was followed by New Hampshire, which had an overall Internet access rate of 74.6 percent. The national average was 62.4 percent of people having Internet access from any location.

Alaska also ranked second among the US states for rate of home Internet access, with 78.5 percent of Alaskans aged 3 and over living in a household with Internet access. New Hampshire topped the category with a rate of 82.6 percent.

According to the study, among US households using the Internet in 2007, some 82 percent had a highspeed connection, and about 17 percent used a dial-up

Study shows potein may be strongest indicator of rare lung disease

WASHINGTON, 5 June — Researchers at the University of Cincinnati (UC) have discovered a protein in the lungs that can help in determining progression of the rare lung disease Idiopathic Pulmonary Fibrosis (IPF).

Researchers say the protein - Serum surfactant protein A — is superior to other IPF predictors and could lead to better decisions about treatment and timing of lung transplantation.

The study, led by Brent Kinder, will be published on Thursday in the journalTM Chest."A simple blood test may give us the information we need to help determine the short term risk of death in a patient with IPF," says Kinder, an assistant professor of medicine at the UC College of Medicine and pulmonologist with UC Physicians.

"This protein is a stronger predictor of the severity of illness than age, symptoms or prognostic data, like breathing tests." IPF is scarring of the lung. As the disease progresses, air sacs in the lungs become replaced by fibrotic scar tissue.

Lung tissue becomes thicker where the scarring forms, causing an irreversible loss of the tissue's ability to carry oxygen into the bloodstream. Internet

"The stress of being born induces the release of the hormones adrenaline and noradrenaline collectively called catecholamines — from the adrenal glands. US scientists develop new ways to make obese mice slim

Los Angeles, 5 June to make obese mice US scientists have slim, without diet or developed two new ways exercise, the Health

Day News reported on Wednesday.

The findings might someday help in the development of drugs that could be used to treat obesity or type 2 diabetes, the report said.

In one study, researchers inserted a molecular shunt into the liver cells of 94 mice. Despite chewing down on high-fat foods that mimicked a human fastfood diet, the mice with the genetically engineered shunts stayed skinny, compared with mice without the shunts.

The shunt, which contained an enzyme normally found in bacteria and plants but not in mammals, acted as an "artificial engine" that enabled liver cells to burn more fat.

Instead of accumulating in the blood or being stored by the body, the fat was metabolized, converted to carbon dioxide and exhaled.

"Exercise is always a good way to burn fat, but we found you can increase the metabolic channels for burning fat even without exercising more," said study author James Liao, a professor of chemical and biomolecular engineering at the University of California, Los Angeles.

French military fails to find more Flight 447 debris

PARIS, 5 June-French search planes have not found any more debris from Flight 447, which crashed into the Atlantic with 228 people onboard, a senior military official said on Thursday.Four planes, including an AWACS (Airborne Warning and Control System) aircraft from the Dakar French air base, took part in locating the Air France passenger jet, said Christophe Prazuck, an official with the French Chief of Staff.

The search team spotted some metallic objects, which turned out not to belong to the plane, he said. Air France on Wednesday told families of passengers on Flight 447 that the airliner disintegrated either in the air or when it crashed into the ocean and there were no survivors.Some debris, including a seven-meter-long chunk and 10 other objects, was found by Brazilian planes over a wide area, but pilots had not spotted any sign of survivors, the Brazilian Air Force said.

The overall zone is roughly 640 km northeast of the Fernando deNoronha islands off Brazil's northern coast. Investigators are working with Air France, Airbus and meteorologists to determine what caused the Airbus A330-200 with 216 passengers and 12 crew members to slam into the Atlantic Ocean after leaving Rio de Janeiro for Paris on Sunday night.—Xinhua

Summary of observations recorded at 09:30 hr MST: During the past 24 hours, rain or thundershowers have been isolated in Kayah State, lower Sagaing and Magway Divisions, scattered in upper Sagaing and Mandalay Divisions, fairly widespread in Kachin, Shan and Rakhine States, Bago Division and widespread in the remaining States and Divisions with locally heavyfall in Rakhine State, isolated heavyfalls in Kachin and Mon States, Bago, Yangon and Taninthayi Divisions. The noteworthy amounts of rainfall recorded were Myeik (7.56) inches, Thandwe (5.44) inches, Yangon (Central) and Gwa (4.96) inches, Thaton (3.27) inches, Yangon (kaba-Aye) (2.92) inches, Yangon (Mingaladon) (2.52)inches and Bago (2.01) inches.

Maximum temperature on 4-6-2009 was 90°F. Minimum temperature on 5-6-2009 was 72°F. Relative humidity at (09:30) hours MST on 5-6-2009 was 100%. Total sunshine hours on 4-6-2009 was (3.3) hours approx.

Rainfall on 5-6-2009 was (2.52) inches at Mingaladon, (2.94) inches Kaba-Aye and (4.96) inches Central Yangon. Total rainfall since 1-1-2009 was (19.45) inches at Mingaladon, (23.98) inches at Kaba-Aye and (31.77) inches at Central Yangon. Maximum wind speed at Yangon (Kabaonh from Southwest at (18.30) hours

Authorities concerned warn those in charge of NLD youth branch, NLD CECs regarding announcement dated 2 June issued by youth taskforce of NLD

NAY PYI TAW, 5 June—The youth taskforce of the National League for Democracy released the announcement No. 01/06/09 on 2-6-2009. As the announcement contained false hood detrimental to prevalence of law and order of the State and peace and stability and security, the authorities concerned on 4-6-2009 evening warned those in charge of NLD youth branch who released the announcement.

Treasurer U Hla Thein (Tamway-1), youth incharge U Myo Nyunt (Ahlon), U Hla Oo (Mandalay) and U Aye Tun (Yankin) were present to hear the warning.

Commander of Special Branch Police Col Win Naing Tun of Myanmar Police Force and Commander of Division Police Force Police Col Win Naing warned NLD CECs U Than Tun, U Nyunt Wai, U Hla Pe and U Soe Myint from 5.12 pm to 5.46 pm on 5-6-2009.

Regarding the intrusion case of US citizen Mr. John William Yettaw, the paragraph 2 of the announcement No. 01/06/09 released by the youth tasks undertaking group of NLD mentioned that the case against Daw Khin Khin Win and Daw Win Ma Ma including Daw Aung San Suu Kyi was being heard under Article 22 of the Law to Safeguard the State Against the Dangers of Those Desiring to Cause Subversive Acts without attendance of the public at the special court in the Insein Jail. In reality, Daw Aung San Suu Kyi's case is being tried at the special court with the court decision for the application of prosecution law officers and the crime of security violation. Although the trial is taking place at the special court, court reporters have been appointed and daily court hearings are reported in newspapers. Moreover, diplomats and local and foreign correspondents are allowed to visit the court occasionally. Therefore, the people are informed about the case in time. As stated in the announcement of the youth branch, there has been no report yet on the side

of the accused that the people have no chance to know about the case. Therefore, the announcement with false accusations against the measures the court is taking in accord with the law is tantamount to disturbing the court and the existing laws.

It is stated in the third paragraph of the announcement that it is regrettable that up to date, authorities have been refusing the release of Daw Aung San Suu Kyi demanded by the UN Secretary-General and leaders of ASEAN, EU and the world's countries. In reality, the case is being examined at the court as the accused including Daw Aung San Suu Kyi have violated the existing internal laws. The case is just the internal issue. The announcement that has been issued at the outside instigation is an act of misleading the public, causing misunderstandings and creating public unrest. The fourth paragraph states that in hearing the lawsuit against Daw Aung San Suu Kyi she has no full right to defend herself. The truth is that the accused have had the rights to hire their lawyers as they wished, to consult with their lawyers and to apply for amendments regarding the controversial matters. For example, they were arranging for defence witnesses at Yangon Division Court at about 3 pm on 5-6-2009. This means they have their full rights.

Those in charge of NLD youth branch said that the announcement was released with the prior permission of the CEC of NLD. They said that the points in the announcement were excerpts from the announcements of NLD CEC. They added that they compiled the draft announcement and the CEC edited and approved it before the release. Having sought the approval, the CEC assured that they would take responsibility for the announcement which was the attitude of CEC and the instructions of the authorities concerned would be submitted to the CEC, they said.

A group comprising Commissioner of Yangon Division General Administration Department U Khin Maung Tun, Division Law Officer U Zeya, Deputy
