NAY PYI TAW, 2 March—*The following is a translation of the message sent by Senior General Than Shwe, Chairman of the State Peace and Development Council of the Republic of the Union of Myanmar, on the occasion of the Peasants Day (2011).*

### Esteemed peasantry,

Today is Peasants Day designated to honour the mass of the peasantry. On this auspicious occasion, I would like to extend my warmest greetings and wish you all in physical and spiritual well-being and greater success in your agricultural businesses.

The State Peace and Development Council is trying its utmost to transform the Republic of the Union of Myanmar into a modern and developed discipline-flourishing democratic nation.

At the core of the achievement of the lofty goal lies better socio-economic life of the people. To meet this national goal calls for improving the agricultural farming, the major business of the people, with all seriousness.

The government therefore pays a serious attention to development of agriculture as the base and all-round development of other sectors of the economy as well.

In order to improve the nation's agricultural sector, the government has been scaling up reclamation of vacant lands for agricultural purposes and boosting agricultural production, harnessing land and water resources to the best of its ability. In addition, it has been encouraging use of high-yield quality strains of crops, advanced agricultural methods and fertilizers for transition to mechanized farming, while rendering all necessary assistance for boosting per acre yields and improving the quality of crops.

In particular, the government has been pouring huge funds into projects for building dams, sluice gates and river water pumping stations and sinking tube-wells and artesian wells across the nation for supply of sufficient irrigation water, which is a must for improvement of the agricultural sector.

From 1988 to date, the government has built 233 dams, spending 298,557 million kyats, which benefit over 2.8 million acres of farmlands. And 30 more projects are underway.

River pumping projects for supply of irrigation water have brought the number of river pumping stations throughout the nation to 327, which irrigate some 500,000 acres of farmlands. Beside that, the government has sunk 8253 tube-wells to tap underground water and built 1023 small dams and lakes in rural areas.

Owing to more ways and means sought by the government to supply adequate irrigation water to farmlands the length and breadth of the nation, extensive reclamation of fallow and virgin lands, transformation of highland farmlands from slash and burn system to terrace farming, and all-round assistance for mixed- and multiple-cropping patterns, most of the farmlands are utilized all year round. In addition, crop growing capacity has increased to over 171 percent, and net sown acreage of crops, to about 34 million. In 2010, the total paddy output of the nation was about 1500 million baskets,

compared with only over 600 million baskets in 1988.

The total sown acreage is growing remarkably, and the nation needs transformation into mechanized farming in order that crops are grown as planned in their seasons. The government and the private sector are in pursuit of plans to manufacture farm machinery and tools to meet the demand.

In order to expedite tasks for improvement of the agricultural sector, the government is implementing the five rural development tasks, one of which is economic growth of rural areas, it has laid down to improve the socio-economic status of the peasantry.

So, the nation has enjoyed rapid economic development constantly.

Moreover, the State Peace and Development Council is accomplishing the State's seven-step Road Map. Now, hluttaws are in session with representatives of the people. There will soon be a new government to be elected and approved by Pyidaungsu Hluttaw. In that way, the State Peace and Development Council will hand over power to the people, the ultimate owner.

I would, therefore, like to cordially and respectfully urge you the peasantry, a strong force of the Republic of the Union of Myanmar, to work hand in hand with the forthcoming government in building the new nation.

### Work harder to boost agricultural production

The 2<sup>nd</sup> of March, 2011 (today) is Peasants Day. Agricultural farming, the major business of the nation, makes substantial contribution to the nation's economic growth. As a gesture of honouring the peasantry working hard for national food security, the date was designated as Peasants Day.

Peasants make up the majority of the working population of the nation. Now, the government is improving the socio-economic status of rural folks who constitute over 70 percent of the nation's population. It has been building infrastructural buildings and boosting agricultural production for development of the agricultural sector.

So far, the government has built over 200 dams and sluice gates, over 300 river water pumping stations, and sunk tube-wells and artesian wells. So, the total sown acreage has increased to over 56 million.

In addition, the government is providing high-yield strains of crops and advanced agricultural methods and disseminating methods to minimize loss and wastage. Farmers have to reclaim vacant lands and boost per acre yield of crops.

Today, virgin lands are being reclaimed in plains and highlands. Paddy and other crops are grown all-year round by establishing special agricultural zones. The nation's paddy output hits more than 1500 million, putting over 16 million acres under monsoon paddy and over 3 million acres under summer paddy.

Paddy supply has well exceeded domestic demand. But, plans have yet to be implemented to keep abreast of top paddy exporting countries. Farmers are, therefore, to work harder than ever for boosting production paddy and other highly saleable crops.

## Militants kill four on spying charges in NW Pakistan

ISLAMABAD, 1 March—Taleban militants killed four people in northwest Pakistan for allegedly spying for the United States, local officials said Tuesday.

Residents saw four bullet-ridden bodies dumped on the road in North Waziristan tribal region and informed the authorities.

Written notes in native Pashto language were attached to the bodies, saying that the men were punished for spying for the US troops in Afghanistan.

The note warned of

such punishment to those who were found guilty of espionage for the US and Pakistani forces.

Those killed could not be identified. The Taleban claimed that the alleged spies passed on information about the hideouts of its militants in Pakistan's tribal belt to the US authorities in Afghanistan for drone strikes.

American pilotless aircraft regularly launched missile attack on the hideouts of suspected militants in the rugged tribal regions bordering Afghanistan.—*Xinhua*

## Italian service member killed in Afghanistan

KABUL, 1 March—A 37-year-old Italian lieutenant was killed in Afghanistan on Monday by roadside bomb, the coalition said. In Rome, Italy's Premier Silvio Berlusconi said four other Italian soldiers were wounded, including three seriously, in a bomb blast about 16 miles (25 kilometres) north of Shindand District of Herat Province in western Afghanistan.

Berlusconi said the attack made him wonder

if Italy's sacrifice in Afghanistan was worth it, given how "medieval" the nation is. Still, he said the Italian mission in Afghanistan must continue.

Fighting accelerated between Taleban insurgents and coalition and Afghan forces last year after 30,000 US reinforcements finished arriving in Afghanistan in the summer. The latest deaths bring to 34 the number of NATO service members killed this month.—*Internet*

## British Airways worker guilty of plane terror plot

LONDON, 1 March—A Bangladeshi militant working for British Airways has been found guilty of plotting to blow up a plane after conspiring with radical US-Yemeni cleric Anwar al-Awlaki.

Rajib Karim, 31, was "committed to an extreme jihadist and religious cause" and was "determined to seek martyrdom", jurors at Woolwich Crown Court in London were told.

The jury convicted Karim of four counts of preparing terror attacks on Monday.

The IT worker, who moved with his wife and son to Newcastle in 2006, had admitted being involved in the production of a terrorist group's video, fundraising and volunteering for terror abroad.

Karim, a privately educated member of a middle-class family in Dhaka, was lured into becoming a staunch supporter of a radical organisation called Jamayetul Mujahideen Bangladesh by his younger

brother, Tehzeeb.

The trial heard that Karim first planned to attack BA's computer systems, but then offered to attempt to plant a bomb on a US-bound plane. Police arrested him before an attack could be carried out.

Colin Gibbs, a counter-terrorism lawyer for the Crown Prosecution Service, described Karim's determination to plan an attack as "frightening".

"The most chilling element of this case is probably the fact that Karim tried to enroll as cabin crew and anyone can imagine how horrific the consequences of this could have been, had he succeeded," Gibbs said.—The jury found Karim guilty of plotting to blow up an aircraft, sharing information of use to al-Awlaki, offering to help financial or disruptive attacks on BA and gaining a job in Britain to exploit terrorist purposes.

He will be sentenced on 18 March.—*Internet*

## Grenade blast kills one in Indian Kashmir

SRINAGAR, 1 March—One person was killed and three others wounded when suspected militants threw a grenade at police near a busy bus terminal in the main city of Indian Kashmir, police said Tuesday. The incident took place in the crowded Batmaloo neighbourhood of Srinagar, the summer capital of the Himalayan region, late on Monday night.

"Militants hurled a grenade injuring four persons including two police officials," a police officer said. One of the victims — a government engineer — died of head injuries at a hospital Tuesday morning, he added.

The grenade attack was the third incident this week after a truck driver and shopkeeper were shot dead by gunmen in separate attacks on Sunday and Monday.

A separatist insurgency has raged in Indian Kashmir, a Muslim-majority state, for over 20 years. Attacks normally increase after winter ends in the Himalayan region. Indian authorities are on the lookout for signs of unrest after mass street protests last summer that brought the region to a standstill and left 114 people dead, mostly due to firing by security forces.—*Internet*



## Mexico nabs alleged head of 'Resistance' drug gang

MEXICO CITY, 1 March—Mexican police have captured the alleged leader of a drug gang that calls itself "The Resistance," a group that operates in western Mexico, officials said on Monday.

Victor Torres Garcia was detained in the Michoacan State city of Uruapan, along with two alleged associates, several guns and bags of drugs, federal police announced.

Torres Garcia allegedly led a gang whose members came several other cartels and who grouped together to resist the incursion of the Zetas drug gang. It also sought to fill a vacuum left by the death or capture of top members of the Beltran Leyva cartel in 2008 and 2009.—*Internet*

# The peasantry held in high esteem across the nation

It was very pleasant to view the scene of vast tracts of summer paddy fields in the sun with Shan Yoma mountain ranges in the background. I had not been to Mandalay for a long time, so I was in a hurry in my trip from Yangon to Mandalay on a vacation. The fine straight tarred road lies between two long paddy fields. I have ever passed through the place several times, and it is amazing that the areas on both sides of the fine road are always covered with lush and green crops. The area of the farmlands along the highway is on the increase.

Long ago, the fields along the road were not put under any crops in summer. My younger brother and I used to collect cow dung in paddy fields for agricultural purpose. In those days, in the paddy fields in summer none other than cow droppings and paddy stubble. If my father were still alive, he would be amazed at the thriving plantations of various crops in summer.

**Now, the government has built a massive number of irrigation facilities to supply adequate irrigation water to enable the peasantry to grow crops all-year round and to boost agricultural production. Unlike in the past, now farmlands can be put under any crops in summer due to supply of irrigation water. In the past, paddy could be grown only once in a year: in the rainy season. But, now it was just in the past. To put an end to that barrier is a formidable task. From 1988 to date, the government has built 233 dams across the nation, spending over 298,557 million kyats. The prudent plan benefits more than 2.8 million acres of farmlands. Thirty more dam projects are underway now.**

In addition, the government established river pumping stations and sank tube-wells and artesian wells in plains, where dams cannot be built, to increase supply of irrigation water. In that regard, the government has built 327 river pumping stations that benefit about 500,000 acres of farmlands and sank 8253 tube-wells and artesian wells that benefit over 100,000 acres of farmlands. Previously, such water sources were not exploited, but in the time of the ruling government, those water sources can be harnessed in an effective way. Then, the government took all possible measures to put all arable lands both in highlands and in plains under suitable crops and to replace slash and burn system with terrace farming to avoid soil degradation. As a result, the nation's total sown acreage has jumped to 34 million, and the paddy output, to about 1500 million baskets.

Then, I saw a large black gram field which

was like a long green carpet in a gigantic plain. It was a great pleasure for me to chat with farmers who work hard to ensure the nation's food security. I learnt from farmers about cultivation of such major crops as pigeon pea, green gram and black gram. The total sown acreage of beans and pulses was only 1.8 million. Now, thanks to agricultural methods, high-yield strains of crops and fertilizers provided by the government and the practice of the market economy, the sown acreage of peas has surged to over 11 million. Many of the farmers have bought cars, motorbikes and houses with the profits they have made from farming of beans and pulses. The per acre yield of groundnut has increased to over 52 baskets; pigeon pea, to nearly 17 baskets; green gram, nearly 15 baskets; and black gram, over 20 baskets.

Beyond the fields of beans and pulses were thick plantations of sugarcane plants that were swaying in the breeze. High-yield quality strains of sugarcane, an industrial crop, are now in place of old ones. The sugarcane sown acreage across the nation has gone up from only over 120,000 to over 370,000.

Then, I was greeted by thriving plantations of chilli and sunflower grown as mixed crops. Long ago, many parts of the arid zone were overgrown with thorny bushes. Now, those areas can be put under edible oil crops including sunflower owing to the assistance rendered by the government, and the efforts farmers have made to keep a good balance between national interests and their own. Sown acreage of edible oil crops has mounted from over 5 million to over 8.6 million. Output of edible oil crops of the nation except some regions where arable lands are scarce is very heartening. So far, edible oil sufficiency of the nation is 160 percent.

The next plantations I saw were cotton ones. According to the farmers I had met, per acre yield of cotton has risen to nearly 500 viss from only over 200 viss thanks to the introduction of Ngwechi-6 Strain of long staple cotton. The Ministry of Industry-1 purchases the cotton at good prices. So, it is fair to say that cotton farmers have a promising future. The nation achieves bumper harvests of all 28 major crops inclusive of corn. If there is no climate change in the nation and no trade embargo against Myanmar, nothing can disrupt the prosperous future of farmers.

**In order to achieve that objective, it has organized many agricultural seminars with participation of national agriculturalists, the assistance from FAO, along with GAP, IPM and GMP standards, thereby improving the living conditions for the peasantry of the nation, as evidenced by my firsthand experiences that the great majority of the houses along the highway were found fine. Many years ago, the households in those regions hardly had bikes. But, now almost every household has at least a motorbike, and the roads in those townships cope with constant streams of motorcycles. Many of the farmers have come to use power-tillers to plough fields. Today, the living standard of the peasantry is on a par with that of urban dwellers. That indicates the government has achieved its goal of bridging the development gap between rural and urban people.**

The motto laid down by the Ministry of Information "Every village must have a library" has helped expand the horizons of farmers. So, they can now get advanced agricultural methods from books, instead of asking others about them. Farmers can hold discussions about their work among themselves. Due to TV retransmitting stations and the DTH system of MRTV-4, farmers of far-flung areas have had easy access to TV programmes. Almost every house in rural areas has a TV set, saying goodbye to past conditions that the whole village had only a TV. Villages have got small-scale hydropower plants and diesel-fired power plants for electric power supply. In the near future, the areas very far from national grids will be equipped with solar system.

**Myanmar is an agro-based country. So, the living standard of farmers is the indicator of national economy. However much anti-government groups and neo-colonialists are disrupting the nation from economic growth, the socio-economic status of farmers has improved gradually, thus reflecting the economic development of the nation. Furthermore, the hluttaws that are in session with people's representatives will translate the guarantee in the State Constitution into reality to improve the living standard of farmers.**

Then, from the expressway, I saw the beauty of Mandalay from a distance. I also noticed large areas were occupied with summer paddy fields, many of them at harvest and many to come to be ripe. As a tangible proof, throughout the way from the southern to northern parts of Myanmar is a chain of fields of crops that are due to the efforts of farmers, our benefactors. Apart from that, I saw many active canals to irrigate farmlands. Myanmar has sufficient irrigation water, fertile soil and temperate climate patterns, and the mass of the peasantry. If and when those favourable conditions for agricultural farming can be effectively utilized in combination with advanced agricultural methods and advanced farm machinery, Myanmar will be at the top of the list of agricultural powers. And Peasants Day will be celebrated on a grander scale year after another, bringing honour to the motherland.

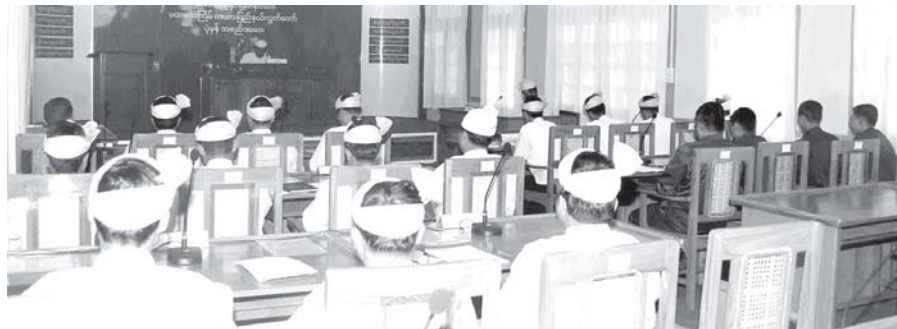

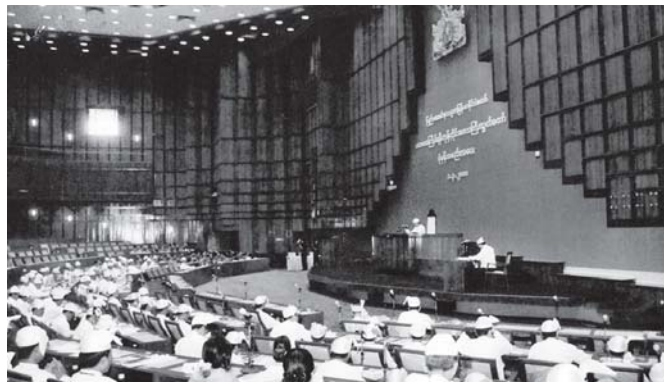

- (5) What a committee member says or does and discussions at a committee meeting shall not be leaked out. All the discussions held in committee meetings shall be recorded and approved by the committee. Meeting minutes shall not be handed out. A copy of the report to Pyithu Hluttaw shall be dispatched to Hluttaw Office in

order that the case can be kept in the case file together with meeting minutes.

### Powers of the committee are—

- (1) Committee meetings are to be held in accord with Article 43 of Pyithu Hluttaw Bylaws.
- (2) With regard to bills, the committee—
  - (a) has the right to submit proposals for the interests of the nation and the peoples to Pyithu Hluttaw,
  - (b) has the right to submit judicial suggestions, and comments made by the peoples and

experts to Pyithu Hluttaw after having analyzed,

- (c) has the right to propose amendments to Pyithu Hluttaw,
  - (d) has the right to amend writing and usages that are out of date, from judicial point of view.
- (3) According to Paragraph 2, proposals and suggestions of the committee must be ones related with matters described in the bill. In addition, those proposals and suggestions must be within the scope of the bill.
- (4) When the committee has finished drafting the bill,
- (a) the committee chairman shall draft report and submit it at the committee meeting,
  - (b) if the committee agrees the bill, the committee chairman shall sign the bill and submit it to the Pyithu Hluttaw Speaker,
  - (c) the committee secretary shall submit the bill to the Pyithu Hluttaw Speaker if the chairman is absent and a committee member who presides over the meeting shall submit the bill if both are absent,
  - (d) if there is no special instruction of the Pyithu Hluttaw Speaker, the committee is to submit its report to him within seven days (exclusive of holidays) commencing the day on which the bill is handed over to the committee,
  - (e) in doing so, committee members are to sign that he or she agrees the report. If there is any exception or disagreement, it shall be stated and enclosed in the report with signature,

- (h) Whether or not powers between a ministry and another, and between a governmental department and enter prise and another are mingled,
- (i) If a bill is drawn according to responsibilities enumerated in international, regional or multilateral agreements and MoUs, or international or regional agreements between regions, whether or not the bill conforms with the points agreed by Myanmar in the

Robotic arm operators Scott Kelly and Mike Barratt hustled to another work station in the Destiny Lab and were able to continue their spacewalk support without rebooting the failed system, NASA said.—Internet

**Japan ruling party passes budget**

TOKYO, 1 March—Japan's ruling party pushed a budget bill for the new fiscal year through the key lower house on Tuesday, but the prospects of other bills necessary for it to be implemented look bleak.

As a matter of formality, the opposition-controlled upper house will debate the 92.4 trillion yen (1.1 trillion yen) spending plan for the year starting on 1 April.

The constitution provides that a state budget becomes law even if the upper House of Councilors rejects it or fails to vote on it within 30 days after it is approved by the House of Representatives.

**Over 60 percent of US older adults has hearing loss**

WASHINGTON, 1 March—Nearly two-thirds of Americans aged 70 and older have hearing loss, but those who are of black race seem to have a protective effect against this loss, according to a new study led by Johns Hopkins University and National Institute on Aging researchers.

These findings, published online Monday in the *Journal of Gerontology: Medical Sciences*, provide what is believed to be the first nationally representative survey in older adults on this often ignored and

underreported condition.

Contrary to the view that hearing loss is of only minor importance in old age, study leader Frank Lin, assistant professor in the Division of Otolaryngology at Johns Hopkins University School of Medicine, says studies including his own have strongly linked it to other health problems, such as cognitive decline, dementia, and poorer physical functioning. However, relatively little is known about risk factors that drive hearing loss.

## Cookie sales barred at Girl Scouts founder's home

Girl Scouts are no longer able to sell their famous cookies outside the historic Savannah home of the woman who founded the organization almost a century ago.

A complaint last year ended the longtime practice of selling the cookies on the public sidewalk outside the home of Juliette Gordon Low at the busy intersection of Bull Street and Oglethorpe Avenue. Peddling on a public sidewalk is a violation of city ordinance. One city alderman said he thinks the city should consider a temporary exception for cookie season.

The city's zoning administrator, Randolph Scott, said he investigated the matter and tried to find a solution. He said he

called for a survey, hoping there would be some private space between the home and the sidewalk. He said there wasn't any.

Scott said they also looked at allowing the Scouts to sell from a small courtyard on the side of the house, but fire marshals told the Scouts they would block an exit route. The home is a National Historic Landmark open for tours.

"I know it doesn't look good," Scott told *The Savannah Morning News*. "However, other businesses won't care if it's the Girl Scouts or March of Dimes. They're going to say, 'Why can't I sit out front and solicit business?'"

City Alderman Van Johnson said he thinks the city council should consider a variance to

allow temporary sales during cookie season, which usually happens in the first few months of the year.

"Juliette Low brings thousands of tourists from around the country. Juliette Low is known for Girl Scouts, and Girl Scouts are known for cookies," Johnson said. "Let's be reasonable. Let them sell their cookies."

Scouts have since started selling near some other high-traffic intersections. Girls used to be able to sell about 250 boxes in three hours outside the Low home, said Jan McKinney, who heads product sales for the Girl Scouts of Historic Georgia.

## Arsenal posts financial loss after Wembley defeat

LONDON, 1 March—Premier League club Arsenal on Monday posted a loss in the six months to end-November, largely on the back of reduced player revenues and lower property sales on the site of its former ground.

A 2.5 million-pound (\$4 million) loss contrasts with a 29.2 million pound profit recorded in the corresponding period in 2009.

While Arsenal made 33.9 million pounds from player sales in the 2009 offseason, primarily from the transfer of Kolo Toure and Emmanuel Adebayor to Manchester City, it only garnered an equivalent 4 million pounds in 2010.

The results were announced a day after Arsenal lost to Birmingham in the League Cup final at Wembley Stadium to leave the club still chasing its first trophy since 2005. But the Gunners are still in the Champions League and the FA Cup, while sitting second in the Premier League they haven't won since 2004.

Some teams have argued the radios are essential for security reasons, with sports directors and

When he closed out Martin Kaymer on the



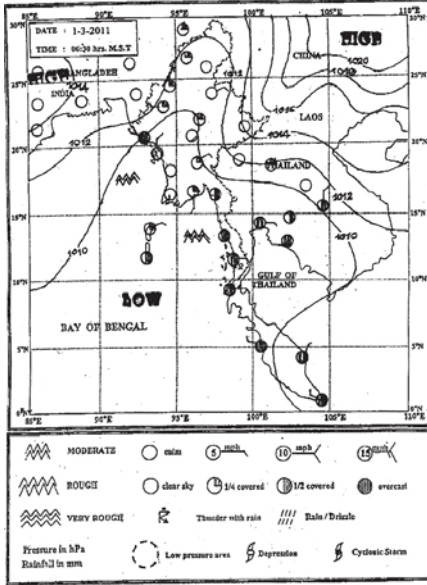

**Brazil to continue to increase minimum wage's purchase power**

RIO DE JANEIRO, 1 March — Brazilian President Dilma Rousseff said Monday that the government will continue with its policy of increasing the purchasing power of the minimum wage.

In her weekly radio show, Rousseff said that the recently-signed Minimum Wage Valorization Law, which foresees the regulations for the minimum wage rises in the next five years, is important to bring stability to the economy.

"With the law, everyone knows the rules and criteria to raise the minimum wage beforehand," she said. According to the president, the minimum wage must keep up with the Brazilian economy's growth. "The minimum wage must have real gains," she said. The law, which takes effect on 1 March, raises the country's minimum wage from 540 to 545 reais (325 to 328 US dollars) this year.—Xinhua

## Second day regular session of First Pyithu Hluttaw held Pyithu Hluttaw Bill Committee formed

NAY PYI TAW, 1 March—The second day regular session of First Pyithu Hluttaw was held at Pyithu Hluttaw Hall of Hluttaw Building here at 11 am today.

It was attended by Speaker of Pyithu Hluttaw Thura U Shwe Mann and Pyithu Hluttaw representatives.

Pyithu Hluttaw Speaker Thura U Shwe Mann announced the validity and start of the second-day session as 430 or 99.08 % of the 434 Pyithu Hluttaw representatives were present.

The speaker made clarification regarding formation of the Bill Committee; and the deputy speaker, duties, powers and rights of the committee.

The duties of the committee are:

- (1) The committee shall vet the bills based on the following points.
  - (a) Whether or not bills conform with the State policies and objectives,
  - (b) Whether or not bills conform with provisions of the constitution of the Republic of the Union of Myanmar and existing laws,
  - (c) Whether or not bills are designed to safeguard the interests of the nation and the people,
  - (d) Whether or not bills carry points that can harm State perpetuation and security,

- (e) Whether or not bills conform with objective conditions of the State,
- (f) Whether or not bills harm security of the public and their property,
- (g) Whether or not bills carry words and terms that can harm national unity,
- (h) Whether or not powers between a ministry and another, and between a governmental department and enterprise and another are mingled,
- (i) If a bill is drawn according to responsibilities enumerated in international or regional agreements and MoUs, or international or regional agreements between regions, whether or not the bill conforms with the points agreed by Myanmar in the agreements and MoUs, and whether or not the bill harms the State sovereignty,
- (j) Whether or not the bills carry all related points on policy relevant law,
- (k) Whether or not provisions of the bills are practicable or not,
- (l) Whether or not the bills carry all provisions to implement their purposes,
- (2) Committee members, when assigned duties by the Pyithu

- Hluttaw Speaker, shall serve as members of the joint bill committee to be formed with the approval of the Pyidaungsu Hluttaw Speaker,
- (3) The committee shall carry out duties occasionally assigned by Pyithu Hluttaw,
  - (4) The committee shall assess bills as the same ways in Pyithu Hluttaw. However,
    - (a) There is no need to ascertain support regarding tabling motions and submitting suggestions,
    - (b) Committee members have the right to hold discussions more than one time in a matter,
    - (c) Regarding bills, experienced officials may be invited in coordination with the departments and organizations concerned for advice,
