NAY PYI TAW, 4 March — The first regular session of Pyithu Hluttaw continued for the fourth day at Pyithu Hluttaw Hall of Hluttaw Building here at 10 am today. It was attended by Speaker of Pyithu Hluttaw Thura U Shwe Mann and Pyithu Hluttaw representatives

Pyithu Hluttaw Speaker Thura U Shwe Mann announced the validity and start of the fourth day session as 431 or 99.54 % of 433 Pyithu Hluttaw representatives were present.

Regarding formation of the Hluttaw Rights Committee, the Pyithu Hluttaw Speaker said that formation of Hluttaw Rights Committee, one of four Hluttaw Committees, would be carried out today; that according to Pyithu Hluttaw Law Section 21 and 22 and Rules 33 and 54, the Hluttaw Rights Committee shall be formed with not more than 15 hluttaw representatives; that the

Rising violence dampens local confidence for smooth security transition in Afghanistan

KABUL, 4 March-A dramatic rise in Talebanled violence recently nationwide in Afghanistan will dampen local people's confidence in Afghan National Security Forces (ANSF) to take over the security, which is to be announced on 21 March

Since last December. the capital City Kabul has witnessed at least 6 attacks, which claimed at least seven ANSF soldiers' lives and injured many other civilians, and hit by 3 rockets on 26 Feb for the first time during the past several months. Security in Afghanistan in this country," Josef

Gunmen kill two in Iraq's Divala

BAQUBA, 4 March-A member of a local paramilitary group, known as Awakening Council, was killed by gunmen in Iraq's eastern Province of Diyala on Thursday, a provincial police source said.

Gunmen stormed the house of Dhiyaa Mahmoud Ali in a village near the town of Maqdadiyah at dawn, some 100 km northeast of Baghdad, killing Mahmoud and his wife, the source from the provincial operations command told Xinhua on condition of anonymity. Mahmoud's four children, aged from one to four years, were also wounded, the source said. Iraqi security forces have cordoned off the area in search of the attackers, the source said, adding that the incident is under investigation.

The Awakening Council group, or al-Sahwa in Arabic, consists of armed groups, including some powerful anti-US Sunni insurgent groups, who turned their rifles against the al-Oaeda network after the latter exercised indiscriminate killings against both Shiite and Sunni Muslim communities. Diyala Province, which stretches from eastern edges of Baghdad to the Iranian border, has long been the stronghold of al-Oaeda militant groups and hotbed

of insurgency and sectarian violence since the US-led invasion broke out in 2003. -Xinhua

Ten people feared killed in Nigeria rally bomb blast

LAGOS, 4 March-Undisclosed numbers of lives have been lost on Wednesday in Suleija, central north Nigeria's Niger State when a bomb blast exploded during political rally organized by the ruling Peoples Democratic Party (PDP).

Security sources told Xinhua that 10 people were feared killed, noting that the bomb exploded minutes after Governor Babangida Aliyu of Niger addressed his party faithful.

The bomb exploded from a parked bus by the roadside close to Government Secondary School, Suleja, killing and maiming passersby, the source said.

State police spokesperson Richard Oguche confirmed the blast to reporters in Minna, the state capital but decline further comments. Suleija is some 45 km from Abuja, the country's Federal Capital Territory (FCT).-Xinhua

Former FBI agent missing in Iran still alive

WASHINGTON, 4 March- US has received indications recently that a former FBI agent who disappeared when visiting Iran four years ago is still alive, said US State Secretary Hillary Clinton on Thursday. Clinton said in a statement that the US citizen, named Bob Levinson, is now being held "somewhere in southeast Asia."

"We respectfully request the Iranian government to undertake humanitarian efforts to safely return and reunite Bob with his family," she said, adding that the US would appreciate the Iranian government's efforts in this regard. Bob Levinson, an American private detective and former FBI agent, disappeared in March 2007 when he was visiting Iran.

Washington has repeatedly asked Teheran to make efforts to determine the whereabouts of Robert Levinson and ensure his rapid and secure return to the United States. But the Iranian authorities had denied knowledge of the case. Xinhua

Two American men plead guilty to terrorism conspiracy charge

New York, 4 March-Two Americans have pleaded guilty to conspiring to murder individuals outside the United States by joining a Somali terrorist group, prosecutors have said.

According to the New York Daily News, Mohamed Alessa and Carlos Almonte have been in custody since their arrest at New York's John F Kennedy (JFK) Airport in June last year. The prosecutors said the pair was planning to wage jihad alongside Al-Oaedalinked militants. Both men admitted that they were flying to Egypt on their way to join Al-Shabaab

World's largest rocket production base takes shape in north China


BEIJING, 4 March—The world's largest design, production and testing base for rockets is being built in north China's Tianjin Municipality, Liang Xiaohong, deputy head of the China Academy of Launch Vehicle Technology, told *Xinhua* Thursday.

The first phase of the rocket industrial base in Tianjin's Binhai New Area will be completed within the year. Rocket parts will be designed, manufactured, assembled and tested at the base, Liang said.

Twenty of the 22 plants have been completed, and some of them are ready for operation. The base is designed to meet China's growing demand in space technology research and development for the next 30 to 50 years, he added.

By integrating the industrial chain, the base will be able to produce a whole spectrum of rockets of different sizes and types for China's moon probe project, space station and other projects, he said.

China's new rockets, including *Long March IV*, will be designed and manufactured in the 200hectare base, he said —*Xinhua*

Air Force to launch 2nd unmanned spaceplane

Los ANGELES, 4 March—The Air Force is preparing to send a second version of its secretive X-37B Orbital Test Vehicle into space.

The unmanned craft resembling a tiny space shuttle is to be launched aboard an *Atlas 5* rocket from Cape Canaveral Air Force Station, Fla.

The launch window opens at 3:39 pm EST Friday but weather could cause delays. The first *X-37B*, built by Boeing's Phantom Works in Southern California, was launched last April and autonomously landed itself in December at Vandenberg Air Force Base, Calif. The Air Force said the primary purpose of the flight was to test the craft but it hasn't revealed what it intends to do with the plane's capability.

The Air Force says the second mission is for further testing. The landing will again be in California.

HIV genetic 'editing' treatment described

PHILADELPHIA, 4 March—US researchers say they've successfully genetically engineered immune cells in HIV-positive patients to make them resistant to HIV infection.

Scientists say they took the immune cells from the patients' own blood, then snipped out a single gene.

When put back in the patient, the cells no longer make a receptor that HIV needs to enter the cell, effectively blocking the virus, *The Philadelphia Inquirer* reported on Thursday.

University of Pennsylvania genetherapy expert Carl June presented the findings at an AIDS conference in Boston Wednesday, the newspaper said.

June said nine HIV-positive patients had received the novel treatment in Philadelphia, New York, and California. The engineered cells stayed free of HIV infection in all nine patients and multiplied greatly in eight of them, he said.

June, who has worked on other experimental gene therapies to treat HIV, said the new approach "shows the most promise of any yet tested."

"It's a big accomplishment because this is the first successful attempt at genetic editing," he said. "It gives us an essential tool."—*Internet*


NEW YORK, 4 March—Want to keep an eye on your e-mail without juggling windows just to fit Mail on your display? Indev on Thursday released Mail Perspectives, the featurepacked successor to its popular MiniMail plugin for Mail.

Mail Perspectives lets you take a different look at your e-mail by shrinking Mail's interface and sprinkling in some useful customization. It distills Mail's large, comparatively sprawling window into a resizable box containing just the essentials, like a list of e-mail subjects, along with filters to view all messages, just unread messages, or just those from a certain day. You can adjust this list to show messages from multiple mailboxes

and even other folders, giving you a comprehensive, yet compact glance at all of the e-mail that matters.

Messages can be viewed with Quick Look or opened in a separate window, and you can still use all of Mail's standard keyboard shortcuts for actions like replying, deleting, and forwarding. If you prefer clickable icons, you can also display a small Mail Actions Window with buttons for most common features, including creating new messages, notes, and tasks.

Instead of a message list, Mail Perspectives can optionally display a preview of each message and allow you to flip through e-mails with arrow keys.—*Internet*



BOSTON, 4 March-Less than seven hours of sleep each night is leading to a host of sleep-related problems including drowsy driving and difficulty concentrating at work, according to two new studies released on Thursday.

Roughly one-third of adults in 12 states reported getting less than seven hours of sleep each night with about the same number saying they've unintentionally dozed off during the day, according to one of the studies on sleep-related behaviour from the Centres for Disease Control and Prevention. Perhaps the most surprising finding is that one in 20 adults reports having nodded off at least once while driving.

Drowsy driving has been linked to more than 1,500 fatalities and 40,000 nonfatal injuries

annually in the United government States. statistics show.

Lack of sleep has also been linked to chronic including diseases obesity, cardiovascular disease and diabetes, researchers said. Fitting in the recommended seven to nine hours of sleep each night is critical.

"In addition to eating right and exercise, sleep is also very important, but tends to fall to the bottom of everyone's priorities," said Anne Wheaton, CDC researcher.

Wheaton was lead author on the second study, which centered on lack of sleep and daily routines. Her findings showed people who sleep less than seven hours were more likely to report trouble concentrating, remembering things and performing at work. Reuters

Spice in curry may help treat cancer

TEL AVIV, 4 March — Turmeric, a bright yellow spice in curry and what makes mustard yellow, may help treat cancer in combination with an arthritis drug, US researchers say. Dr Shahar Lev-Ari of Tel Aviv University's School of Public Health at the Sackler Faculty of Medicine and colleagues found that curcumin - turmeric's active ingredient - can fight cancer when used in combination with a popular anti-inflammatory drug used to treat arthritis - Celecoxib, which also inhibits proliferation of colon cancer in laboratory settings - in alleviating the inflammatory response caused when cancer takes root in the body. The treatment has had promising results in human clinical trials, the researchers say. "Although more testing will be needed before a possible new drug treatment is developed, one could combine curcumin with a lower dose of a cancer anti-inflammatory drug, to better fight colon cancer," Lev-Ari says in a statement.-Internet

Heinz says 3Q net up, buys stake in **Brazilian** Co

NEW YORK, 4 March-HJ Heinz Co announced a major step Thursday in its push into emerging markets the purchase of an 80 percent stake in a Brazilian food company.

The news came as Heinz reported that its revenue from the US and emerging markets, along with recent price increases, helped drive its thirdquarter net income up 20 percent.

Heinz, the world's largest ketchup maker, has relied recently on emerging markets like China, India and Russia to fuel its growth. It said its plan to acquire the stake in SA

Industrias Alimenticias, the Brazilian maker of Quero brand tomato sauce and ketchup, eventually will double its sales in Latin America.

Terms of the deal, which will also give Heinz a factory and distribution service that could be critical to its future in the fastgrowing region, were not disclosed. But the company said it will pay with cash on hand.

"This is a major growth step under our emerging-market strategy." Heinz CEO William R Johnson said.

Japan sales of new imported vehicles climb 41.2% in Feb

Токуо, 4 March— Sales of new imported vehicles climbed 41.2 percent in February from a year earlier, data released Friday by the Japan Automobile Importers Association showed. According to the association, sales of new imported vehicles in February, including Japanese brands manufactured overseas, totaled 20,376 units, marking the 16th consecutive month of yearon-year increase.

Helped by a spike in imports of Nissan Motor Co.'s March minicar, sales of Japanese-brand vehicles surged 344.9 percent to 6,193 units, whiles sales of foreign-brand cars, trucks and buses for the domestic market rose 8.8 percent to 14,183 units, marking the second straight month of rise, the association said. Having stopped producing its top selling March minicar in Japan and moving operations to Thailand, Nissan sold 14,183 units in the recording period, to claim a 22.9 percent share of the market, compared to a meager 16 units sold during the same period a year earlier.-Xinhua

submit a case concerning a breach of rights of the Hluttaw or a Hluttaw Committee or a Hluttaw representative to the Hluttaw as prescribed in Pyithu Hluttaw Rule 58 (a); that concerning such provisions, there are duties, powers and rights for an individual Hluttaw representative, a single Hluttaw committee or the whole Hluttaw; that the privileges of the Hluttaw, a Hluttaw committee or a Hluttaw representative as prescribed in Rule 58 (a) are all concerned with those duties, powers and rights; that the Hluttaw Rights Committee is therefore formed so as to scrutinize cases concerning the breach of duties, powers and rights of the Hluttaw, a Hlutaw Committee or a Hluttaw representative.

The speaker continued to say that although it is prescribed in line with Pyithu Hluttaw Rule 56 that the tenure of the Hluttaw Rights Committee is the same as that of the Hluttaw, reviews will be made to make membership replacements as necessary one year after its formation.

Herbel teas have health benefits

BOSTON, 3 March-Herbal teas - hibiscus, peppermint and chamomile - may provide a variety of health benefits, Department of US Agriculture-funded scientists found. Diane McKay and Jeffrey Blumberg of the Jean Mayer USDA Human Nutrition Research Centre on Aging at Tufts University in Boston says chamomile tea has long been considered a brew that soothes. However,

Blumberg and McKav reviewed scientific literature on the bioactivity of chamomile and found no human clinical trials that examined this calming effect. They published a review article describing testtube evidence that chamomile tea has moderate anti-microbial activity and significant antiplatelet-clumping activity, which reduced the risk of blood clots. The researchers describe evidence of bioactivity in peppermint

tea. In test tubes, peppermint has been found to have significant anti-microbial and anti-viral activities, strong antioxidant and antitumour actions and some anti-allergenic potential, the researchers say. A human clinical trial reported that drinking hibiscus tea lowered blood pressure in a group of pre-hyperten-sive and mildly hypertensive adults, the review finds. The findings are published in Agricultural Research magazine.—Internet

19 Cambodians killed in road accident in southwest province

PHNOM PENH, 4 March—At least 19 Cambodians were killed and another eight seriously injured in a car crash in Cambodia's southwest province of Sihanoukville Friday, chief of military police for Sihanoukville Province said by phone. "The accident

"The accident happened after a container truck crushed with a tourist van coming from opposition dir-ection," Horn Seyha said.

The drivers of both vehicle were killed instantly in the accident and the tourist van was completely destroyed. "It's almost flattened," he said. Of the 19 dead, ten were male and 9 female, while six men and two women were injured. The accident

The accident happen-ed on the

national road No. 4 about 17 kilometres from the provincial town.

The tourist van was from Takeo Province en route to Sihanoukville while the container truck was on its way to Phnom Penh from original departure in Sihanoukville. The traffic police are working out which side of the two vehicles had caused the accident. Police confirm-ed that the 18 killed were Cambodians; no foreigners were on the tourist van.

Sihanoukville is located at 230 kilometres southwest of Phnom Penh. Death toll from traffic accidents in Cambodia is the second largest danger after HIV/ AIDS. Last year, 1,709 people were killed in road accidents in Cambodia.—Xinhua

Earth-orbiting satellite Glory ready for launch

Los ANGELES, 4 March— After a series of delays, NASA's earth-orbiting satellite Glory is ready for launch from California's Vandenberg Air Force Base, the Jet Propulsion Laboratory (JPL) announced on Thursday.

The launch is currently planned for Friday, 4 March, at 2:09:43 am. PST (5:09:43 am EST), said JPL, Pasadena, Los Angeles. The weather forecast is 100 percent "go," with the possibility of some fog and a low ceiling not expected to be an issue, according to JPL. NASA originally planned to launch the satellite on 23 Feb, but during the final 15 minutes before the scheduled launch, the vehicle interface control console, a ground interface with Orbital Sciences' *Taurus XL* rocket, gave an unexpected reading, prompting NASA to scrub the first launch attempt.

Then NASA postponed the rescheduled launch for two times due to failure to resolve the technical problems.—*Xinhua*

World first artificial bronchus graft in France

PARIS, 4 March—An articifial bronchus was successfully grafted onto a 78-year-old patient with lung cancer, a world first that avoided the complete removal of the lung, medical authorities announced.

The surgical innovation, carried out on 28 October 2009 by a team at Paris's Avicenne Hospital, meant that "the cancerous growth could be removed with greater safety margins" and also "avoidance of the foreseen complete removal of the lung carrying very high risk of post-operatory death," the group Public Assistance - Paris Hospitals said in a statement.

The patient "is very well" following the graft of the articifial airway, thoracic and vascular surgeon Emmanuel Martinod, who carried out the surgery, said.

"Our procedure followed 10 years of research," he said, adding however that "we must remain very

The artificial bronchus was made up of biological material strengthened by a stent. The use of aortic tissue, preserved by cold and available from a tissue bank, had the advantage of not needing anti-rejection medicaments, which are counter-indicated in treatment of cancers.

Details of this medical first are published in the review *The Annals of Thoracic Surgery*.

US has much higher obesity rate than Canada

ATLANTA, 4 March-American adults have a significantly higher rate of obesity than their neighbours to the north, a new study says.

About 24 percent of Canadians are obese compared to more than 34 percent of Americans, according to the US Centres for Disease Control and Prevention study released on Wednesday. Researchers looked at height and weight data taken in surveys in both countries during 2007-09. The two countries have different racial demographics. The United States has more black and Hispanic people, and both have higher rates of obesity. But even looking solely at white people, there was still a big difference a 26 percent obesity rate in Canada compared to 33 percent in the United States.

It's not clear why that is, said study-co-author

Cynthia Ogden, an epidemiologist with the CDC's National Centre for Health Statistics.

"We share this border and many other things. It's a question we need to investigate more," said Ogden, whose co-authors included a researcher at Statistics Canada.

Another mystery: In children there was little difference. The childhood obesity rate was 15.5 percent in the United States and 12 percent in Canada, but the difference was not statistically significant.

This study is the first time the CDC has compared American obesity rates with another country. The report adds to a growing pile of studies that show Americans are less healthy than people in other developed nations. Internet

US files 22 new charges against WikiLeaks soldier

WASHINGTON, 4 March -The US military said it has brought 22 new charges against a soldier accused of leaking hundreds of thousands of sensitive US government documents that were later published the website by WikiLeaks.

Bradley Manning, a former intelligence analyst suspected of obtaining the documents while serving in Iraq, is being held at a Marine base in Virginia as US officials investigate last year's publication of State Department cables and military documents related to the wars in Iraq and Afghanistan.

The US Army's new charges against Manning, the result of a seven-month probe, include 'aiding the enemy' and 'wrongfully causing intelligence to be published on the Internet,' the military said in a statement.



Colorado boy, 12, arrested in shooting deaths

DENVER, 4 March-A 12-year-old boy was arrested on Wednesday for the shooting deaths of a husband and wife and the critical wounding of the couple's two small children in a rural eastern Colorado Town.

Steve Johnson, division director for the Colorado Bureau of Investigation, said the boy, who is a relative of the victims, called 911 Tuesday night to report a multiple shooting at a home in Burlington, Colorado about 165 miles east of Denver.


When police responded they discovered a married couple with fatal gunshot wounds, and two of their

children, a five-year girl and a nineyear-old boy, with life-threatening injuries, Johnson said.

All the warrants in the homicides have been sealed, so authorities would not say if the boy is another son of the slain couple, who are identified as Charles Long, 50, and his wife Marilvn, 51.

Detectives questioned the boy for several hours on Wednesday, and at mid-afternoon, Johnson announced that the boy was under arrest.

"The 12-year-old family member who placed the 911 call from the residence has been taken into custody," Johnson said.-Reuters

Ex-prosecutor pleads guilty to misconduct

DETROIT, 4 March- A former Michigan narcotics prosecutor faces six months in jail after pleading guilty to misconduct in office.

Karen Plants, who was head of the narcotics unit in the Wayne County District Attorney's Office, admitted Wednesday she committed perjury to hide the identity of a police informant, The Detroit News reported.

Two Inkster police officers have also entered guilty pleas. Retired Wayne County Circuit Judge Mary Waterstone has also been charged with misconduct in office. She is scheduled to go on trial in May.

The charges stem from a 2005 drug trial. Jurors were not told a witness against bar owner Alexander Aceval was an informant. Aceval eventually pleaded guilty and is serving a long prison term.

Series of moderate quakes rattle S Philippines

DAVAO CITY, 4 March—A moderate earthquake struck parts of southern Philippines late Thursday night, hours after a milder but much shallower temblor struck the same area hours earlier, the US Geological Survey said.

The magnitude 5.4 quake hit at 11:12 pm local time, and was traced 62 kilometres east-southeast of Surigao City in Mindanao at a depth of 38.7 kilometres, the USGS said.

The shaking happened just six hours after a magnitude 4.5 temblor with a depth of 18 kilometres rattled the same region, the Philippine Institute of Volcanology and Seismology in Davao City, said. That quake was followed by a magnitude-3.9 aftershock several minutes later. Officials have yet to report damage or casualty following the quakes.

The Philippines sits on the Pacific "Ring of Fire" where continental plates collide, causing frequent seismic and volcanic activity.

WELLINGTON, 4 March—An earthquake measuring 4.7 on the Richter scale struck Wellington Region early Friday, causing no casualties or damages. The quake, which struck at 2.19 am on Friday (13:19 GMT Thursday), was centreed 10 kms north-east of Upper Hutt, it had a depth of 30 km.

The New Zealand Institute of Geological and Nuclear Sciences said it was felt widely in the lower North Island and upper South Island.

It was the second earthquake in Wellington in three days. A magnitude 4.5 earthquake struck Wellington on Tuesday night. It was centreed 20 km north-west of the city.-Xinhua





Amyotha Hluttaw carries on first regular session for fourth day 15-member Hluttaw Rights Committee formed

Suitable number of members, nominations for members, chairman and secretary will be submitted to the hluttaw for approval

NAY PYI TAW, 4 March—The first regular session of Amvotha Hluttaw continued for the fourth day at Amyotha Hluttaw Hall of Hluttaw Building here this morning.

Speaker of Amyotha Hluttaw U Khin Aung Myint declared the session valid as 222 or 99.55 per cent of the 223 Amyotha Hluttaw representatives were present, thus announcing the start of the session.

The speaker exercising the power bestowed under Article 20 of Amyotha Hluttaw Law reported to Amyotha Hluttaw that the Ministry of Immigration and Population had informed that when Daw Cho Nwe

Constituency (7) was born, her father had not been neutralized yet; that according to Article 11 (f) of Amyotha Hluttaw Election Law, she was no longer legitimate to stand as an Amyotha Hluttaw representative; and that, U Khin Maung Lay of Bago Region Constituency (8) would be in place of Daw Cho Nwe Oo who had appointed as member of the Public Accounts Committee. With the approval of Amyotha Hluttaw, the speaker declared U Khin Maung Lay as member of the Public Accounts Committee.

The Amyotha Hluttaw speaker said that a hluttaw rights committee Oo of Bago Region | shall be formed with no |

more than 15 members under Amyotha Hluttaw Rules 33 and 54; and that a suitable number of members, and nominations for members, the chairman and the secretary of the committee will be submitted to the hluttaw for approval.

He said that then the hluttaw shall designate the number, duties, powers, rights and terms of committee members according to Article 27 of Amyotha Hluttaw Law and Rules 34: that so the Amyotha Hluttaw Rights Committee is scheduled to be formed with 15 members; that after one year the members' assumption of duties, reviews will be carried out, old members will be
