NAY PYI TAW, 7 March—The first regular session of Pyithu Hluttaw continued for the fifth day at Pyithu Hluttaw Hall of Hluttaw Building here at 10 am today.

Pyithu Hluttaw Speaker Thura U Shwe Mann declared the session valid as 432 or 99.77 % of the 433 Pyithu Hluttaw representatives were present and an-

nounced the start of the session.

The Pyithu Hluttaw speaker said that according to Pyithu Hluttaw Rules (33) and (67), Government's Guarantees, Pledges and Undertakings Vetting Committee shall be formed with not more than 15 hluttaw representatives; and that a list of nominations for members, the chairman and the

secretary shall be submitted to the hluttaw for approval.

He said that Pyithu Hluttaw Rule 71 says that the committee shall check whether or not guarantees, pledges and undertakings assigned occasionally at the hluttaw by the Union Government are implemented, and shall present a report to the hluttaw; that according

Improve community health care

Nothing can be compared with health. We can do what we want only if we are in good health. The government is putting into effect national health plans it has laid down for better public health care.

In pursuit of the two objectives: to improve longevity of the people, and to keep them fit, the Ministry of Health is stepping up prevention of diseases, treatment, rehabilitation, sanitation and health education the whole country including rural and border areas.

Lewe Township People's Hospital (100-bed) in Nay Pyi Taw District was opened on 6 March. It is composed of two 50-bed wards, outpatient unit, surgical ward and labour room.

One in five Californians faces hunger last year

LOS ANGELES, 7 March—One in five Californians faced hunger last year, ranking the state No 16 for food hardship in the nation, a newly-released report said.

In a survey by the Washington-based Food Research and Action Centre (FRAC), 20 percent of Californians said there were times last year when they couldn't afford enough food for themselves and their families.

Fresno and Inland Empire areas in California

were particularly hard-hit by food shortage, according to the survey published by the *Los Angeles Times* on Sunday.

The rate in California was slightly higher than the national average of 18 percent, the survey showed.

The highest rate was recorded in Mississippi, where nearly 28 percent said they did not always have enough money to buy food. The lowest rate, just over 10 percent, was in North Dakota.

Jim Weill, president of

FRAC, said the figures underscore the need for a strong nutrition safety net — including food stamps and school meals — for families that continue to struggle as the economy begins to recover. "While the nation's Great Recession may have technically ended in mid-2009, it has not yet ended for many of the nation's households," Weill said. "For them, 2010 was the third year of a terrible recession that is widely damaging the ability to meet basic needs."—Xinhua

Karzai says US apology for Afghan deaths "not enough"

KABUL, 7 March—Afghan President Hamid Karzai told General David Petraeus, the commander of US and NATO forces in Afghanistan, on Sunday his apology for a foreign air strike that killed nine children last week was "not enough".

At a meeting with his security advisers at which Petraeus was present, Karzai said civilian casualties by foreign troops were "no longer acceptable" to the Afghan Government or to the Afghan people, Karzai's palace said in a statement.

Civilian casualties caused by NATO-led and Afghan forces hunting

insurgents have again become a major source of friction between Karzai and his Western backers.

In the meeting, Petraeus apologized for the deaths of the nine children in eastern Kunar Province last Tuesday, saying the killings were a "great mistake" and there would be no repeat.

"In return, the President said the apology was not enough and stressed that civilian casualties caused during operations by coalition forces were the main cause of strained relations between the United States and Afghanistan," the palace said.

Explosion wounds five in eastern Afghan town

JALALABAD, 7 March—Explosion wounded five people on Monday in Jalalabad city, the capital of eastern Nangarhar Province, an official said.

"We have received five injured people in hospital for medical treatment. All are civilians and sustained injured in bomb blast," head of

health department in Nangarhar Province doctor Baz Mohammad Shirzad told *Xinhua*.

Meantime, Ahmad Zia Abdulzai, the spokesman for provincial administration, in talks with *Xinhua* confirmed the incident and said two blasts in a span of 30 minutes rocked Jalalabad City wounding some people. He also added that the first explosion happened at 11:00 am local time.

An eye witness Bashari said that some civilians and policemen received injuries in the blasts.—Xinhua

Iran says US presence in Afghanistan cause of more violence

TEHRAN, 7 March—The Iranian Foreign Ministry spokesman said Sunday that presence of the US forces in Afghanistan has led to more violence, the official *IRNA news* agency reported.

Ramin Mehmanparast rejected recent statements by the Commander of the NATO forces in Afghanistan General Stanley McChrystal who accused Iran of equipping rebel forces in Afghanistan, said the report.

"Observers of Afghanistan's affairs have unanimously agreed that the US presence in Afghanistan had two major and costly consequences

including the return of violence and revival of the extremist forces in that country as well as boost of illegal drugs production in Afghanistan," Mehmanparast was quoted as saying.

Teheran was one of the pioneers of the fight against terrorism and anti-drugs campaign, the spokesman said according to *IRNA*.

Iranian officials have said that the United States and its allies have failed to fight terrorism and bring peace and stability to Afghanistan.

Four police officers killed in S Philippines ambush

MANILA, 7 March—Four police officers were killed while three others were wounded in an ambush in the southern Philippine province of Bukidnon on Sunday morning, local media reported.

The victims, including forensic officers, were on their way to Village Mapayag in Bukidnon to respond to a shooting incident when they were

attacked by around 20 heavily armed men around 11:30 am, ABS-CBN TV station reported citing official sources. Three of the victims died on the spot while another died at a hospital, the report said, adding investigators believe that the gunmen belong to the New People's Army (NPA). Police denounced the attack and have launched pursuit operations against

the ambushers. The NPA, the armed wing of the Communist Party of the Philippines, has been waging a guerrilla campaign in the countryside for more than four decades. The Philippine military estimates that there are some 4,700 NPA guerrilla fighters scattered in more than 60 provinces throughout the Southeast Asian country.—MNA/Xinhua

NASA scientist claim of 'alien life' draws scrutiny

WASHINGTON, 7 March—A NASA scientist's claim that he found tiny fossils of alien life in the remnants of a meteorite has stirred both excitement and skepticism, and is being closely reviewed by 100 experts.

Richard Hoover's paper, along with pictures of the microscopic earthworm-like creatures, were published late Friday in the peer-reviewed *Journal of Cosmology*, which is available free online.

Hoover sliced open fragments of several types of carbonaceous chondrite meteorites, which can contain relatively high levels of water and organic materials, and looked inside with a powerful microscope.

He found bacteria-like creatures that he calls "indigenous fossils," which he believes originated beyond Earth and were not introduced here after

Discovery crew readies for return to Earth

CAPE CANAVERAL, 7 March—The six crew members of the US space shuttle *Discovery* climbed back into their spaceship Sunday to get ready for their descent to Earth, NASA said.

The space agency said on its Web site the hatches between the shuttle and the International Space Station were closed at 4:11 pm EST. The shuttle had docked with the space station on 26 Feb and the hatches had been open for 7 days, 23 hours and 55 minutes.

The shuttle and space station crews bid each other farewell before the *Discovery* crew members ducked back into their vehicle.

"He concludes these fossilized bacteria are not Earthly contaminants but are the fossilized remains of living organisms which lived in the parent bodies of these meteors, e.g. comets, moons, and other astral bodies," said the study.

"The implications are that life is everywhere, and that life on Earth may have come from other planets."

Studies that suggest alien microbes can be contained in meteorites are not new, and have drawn hefty debate over how such life could survive in space and how and where life may have originated in the universe.

A NASA-funded study in December suggested that a previously unknown form of bacterium had been found deep in a California lake that could thrive on arsenic, adding a new element to what scientists have long considered the six building blocks of life.—*Internet*

"It was a very successful time on board," *Discovery* commander Steve Lindsey said while thanking station commander Scott Kelly for the hospitality.

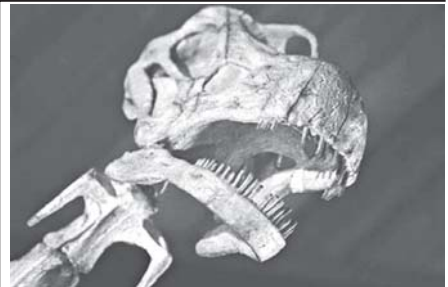
Kelly responded in kind.

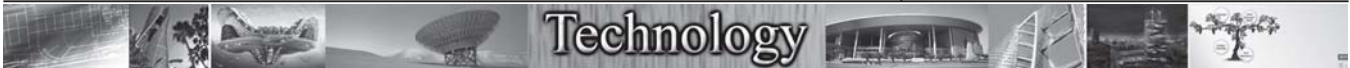
"*Discovery* has been a great ship and has really supported ISS more than any other shuttle and we wish her fair winds and following seas."

BMW aims for cars to take e-mail dictation

WASHINGTON, 7 March—BMW has developed a prototype system that allows drivers to compose full-text e-mails and text messages using voice commands. Unlike voice-activation options in existing BMWs, the technology relies on speech-recognition algorithms that offer drivers, as well as passengers, freedom to dictate original messages from over a million recognized words in the database.

The main novelty is that you can compose e-mails with the same ease of use that you would have with a PC in an office setting—without taking your eyes off of the road or using your hands. You respond to e-mail by dictating out loud what you want to say while using voice commands for editing functions, such as deleting, moving, or replacing text. For millions of workers

who otherwise waste a large percentage of their time driving every day, being able to send and receive e-mails safely while commuting would represent an obvious boost in productivity.

BMW's voice-to-text e-mail technology complements options that BMW already offers. With BMW's Connected Drive, for example, you can connect your Blackberry to the dashboard console with a Bluetooth connection and the audio system reads e-mail or text messages out loud as you drive. When the car is not in motion, it is possible read the full texts of the e-mails from a Blackberry inbox on the car's dashboard screen. For the iPhone, BMW will offer an app with which drivers can open and lock their car remotely.

Brawsome, the Australian indie game developers behind Jolly Rover, was at the Game Developers Conference to promote its latest werewolf-inclusive title, *MacGuffin's Curse*. Due in October, the puzzle adventure game for iOS and Mac seems to be on track to supply gamers with both a captivating story as well as challenging gaming.

Non-invasive test may identify Down syndrome early on

NICOSIA, 7 March—A simple blood test may one day offer a safe way to detect Down syndrome during pregnancy, researchers say.

In a small study, an experimental blood test identified a gene mutation associated with Down syndrome with 100 percent accuracy, according to the Cyprus scientists.

"Down syndrome is a common birth defect, with one Down syndrome birth in every 600 births in all populations," said lead researcher Philippos

Patsalis, chief executive medical director of the Cyprus Institute of Neurology and Genetics in Nicosia. "This is due to an extra chromosome 21, and that leads to physical and mental impairment."

Currently, Down syndrome is diagnosed using one of two invasive procedures, amniocentesis or chorionic villus sampling. Because these tests, while 80 percent accurate, carry a 1 percent to 2 percent risk of miscarriage, only about one in 10 pregnant women opts for them, he said. The new test

eliminates the risk of miscarriage, Patsalis said. It also can identify Down syndrome in the 11th week of pregnancy, early enough for a woman to end her pregnancy if she chooses, Patsalis said.

People with Down syndrome, also known as Trisomy 21, carry three copies of chromosome 21, instead of two.

The test quickly pinpointed the chromosomal variation, identifying 14 Down syndrome cases and 26 normal fetuses, the study authors said.

Researchers find genes linked to heart disease

BEIJING, 7 March—Thirteen new gene variants have been found to have connections with a high risk of developing heart disease in a large-scale international study, according to foreign media report Sunday. The study, published Sunday in *Nature Genetics*, was one of the most far-reaching in the past years. Led by researchers at the University of Leicester in the United Kingdom and University of Lubeck in Germany, it also involved 150 scientists from across Europe, Canada and the United States. For this study, the international research group examined the complete genetic profiles

of more than 22,000 people of European descent with coronary heart disease or a heart attack history. Then they compared the data to that of around 60,000 healthy people to validate the findings.

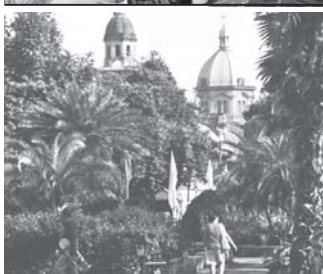
The results show that of the total of 23 variants now known, seven are linked with levels of "bad" and one is linked with high blood pressure, both of which are known risk factors for heart disease. But the others are not relevant to known cardiovascular risk factors. Researchers said that the findings would provide clues to the new opportunities for future discovery and lead to more effective treatment plans.

"With such information we should be able to better identify people at high risk early on in life and quickly take the steps to neutralize that excess risk," said Themistocles Assimes, a research scientist with Stanford University School of Medicine in the United States.

World Health Organization statistics show that cardiovascular diseases claim 17.1 million lives a year, being the world's biggest killers. The cost on medical devices and drugs for heart disease treatment amounts to billions of US dollars every year.—Internet

Sun is shining on Asian tourism trade

HONG KONG, 7 March—The sun is shining on the tourism trade in Asia-Pacific with double-digit growth notched up in 2010, spurred largely by Chinese and Indian middle classes packing their bags for a break abroad.

Strong economies, the proliferation of low-cost airlines and a burgeoning constituency of online shoppers are adding to the region's rosy outlook.

There was an 11 percent rise in arrivals in the region overall last year, according to preliminary data from the Pacific Asia Travel Association (PATA). And 2011 is also expected to be a strong year.

"Asia will receive international arrivals at close to double that of the world average growth rates," PATA's deputy CEO John Koldowski told *AFP*. "It's Asians travelling to Asia, that's the key to all these numbers and the big shift we are seeing globally in the tourism market. It's all happening in Asia now." South Asia reported the strongest arrivals growth with a gain of 14 percent, highlighting a record year for India which posted 5.6 million foreign inbound visits for the year, a nine percent increase. Over 70 million people went to Southeast Asia, 12 percent up on 2009, with Vietnam, Singapore and the Philippines all ratcheting up record growth.—Internet

LVMH to take controlling stake in Italy's Bulgari

LONDON, 7 March—French luxury group LVMH (LVMH.PA) is to take a controlling stake in Italy's luxury jeweler Bulgari (BULG.MI) in an all-share deal, the *Financial Times* reported.

The agreement is due to be announced later on Monday and will see the Bulgari family tender its 51 percent share in a share swap that will make it the second-biggest family shareholder in LVMH, the newspaper said. A tender offer for the remaining listed shares will also be launched on Monday, it said.

Bulgari shares were up 0.65 percent on Friday, valuing the company at 2.3 billion euros (\$3.2 billion). Citing an unnamed source close to the deal, the FT said the LVMH offer would put a significant premium on that figure. Bulgari Chief Executive Francesco Trapani would take a senior role in the LVMH group, famous for its silk scarves, while the Bulgari family would get board representation, the FT said.

LVMH and Bulgari were not immediately reachable for comment.

Japan's foreign exchange reserves drop to 1.09 trln USD in Feb

TOKYO, 7 March—Japan's foreign exchange reserves dropped to 1.091 trillion US dollars at the end of February from 1.093 US dollars a month earlier, the Ministry of Finance (MOF) said on Monday.

According to the Ministry, the latest figure for Japan's foreign exchange reserves marked the fourth consecutive month-on-month decline. Japan's foreign exchange reserves consist of securities and deposits denominated in foreign

currencies, International Monetary Fund reserves, IMF special drawing rights (SDRs) and gold, and are the second largest in the world after China's.

At the end of February, Japan's foreign currency reserves stood at 1.031 trillion, IMF reserves at 4.71 billion US dollars, SDRs at 21.08 billion US dollars, gold at 34.71 billion US dollars and other reserve assets stood at 440 million US dollars, the MOF said.—Xinhua

Australia records second wettest summer in 111 years

CANBERRA, 7 March— Due to one of the strongest La Nina events, 2010-11 has seen Australia's second wettest summer on record, and above average rainfall is expected to continue, a weather meteorologist said on Monday.

"Nationally we averaged 354.7mm—70 percent above normal and second only behind the infamous

summer of 1973-74 when 419.8mm was recorded," Weather Channel meteorologist Tom Saunders said in a statement released on Monday. All states and territories recorded above average rainfalls, due to one of the strongest La Nina events on record, Saunders said.

Victoria has never seen a wetter summer since records began 111 years ago, and it was Western Australia's second wettest. South Australia had its third wettest summer, New South Wales its 5th, Queensland its 6th and the Northern Territory its 8th. "Looking ahead into autumn, the La Nina is now past its peak and has been weakening since early January. "However, until the Pacific Ocean returns to neutral in winter we can expect above average rain to continue over most of the country," he said.—Xinhua

China vows to deepen strategic partnership with EU

BEIJING, 7 March— Chinese Foreign Minister Yang Jiechi said Monday that China will work with the European Union to deepen their comprehensive strategic partnership. "Both sides should work together to pursue the political partnership based on mutual respect and mutual trust and deepen their win-win economic and trade partnership," he said.

Yang made the remarks at a press conference on the sidelines of the annual session of the National People's Congress, China's top legislature.

China and the European Union are two major economies of the world and both are at a critical stage in their respective development, he said. "We can help each other and create a win-win situation, isn't it a good thing?" he said.

He said 2011 is the year of youth exchange between China and the European Union. US researchers discover way of using microbes to produce biofuels

LOS ANGELES, 7 March— US researchers have successfully used certain microbes to produce biofuels, opening a door to developing cheaper "green" energy.

The discovery was made by researchers at the University of California, Los Angeles. The findings were published on Sunday's issue of the journal "Nature Biotechnology". The work concentrat-

ed on tricking microbes into eating protein and using the resulting energy to generate specific proteins that can be refined into fuel, the researchers explained.

This is different from the current biofuel production which is based on plants or microbes that generate fats, oils or carbohydrates that can be refined into biofuel, said Dr James C Liao, who took part in

the study.

"This research is the first attempt to utilize protein as a carbon source for energy production and biorefining," Liao said. "Complex cellular regulation in nitrogen metabolism had to be rewired." The researchers said they are now working to take ammonia out of individual cells, allowing the cells to keep their nitrogen.

to the provision, the committee shall record words, pledges and guarantees by Union level organizations in response to questions asked by representatives at Pyithu Hluttaw and examine work progress; that they also cover guarantees, pledges and undertakings presented according to bills, resolutions, statements or reports presented by the Union Government; and that in order to scrutinize those tasks, the Government's Guarantees, Pledges and Undertakings Vetting Committee are formed.

He said that according to Pyithu Hluttaw Law (27) and Rule (34), the number of committee members, and their duties, powers, rights and terms shall be designated by the hluttaw; that so the committee for government's guarantees, pledges and undertakings is scheduled to be formed with 15 members; that one year after the members' assumption of duties, reviews will be carried out, old members will be replaced with new ones as necessary; and that the deputy speaker will make clarification to the committee's duties, powers and rights to be designated by the hluttaw.

The deputy Pyithu Hluttaw speaker clarified duties, powers and rights of the committee for government's guarantees, pledges and undertakings.

Duties of the Government's Guarantees, Pledges and Undertakings Vetting Committee are as follows:

- (1) The committee shall vet guarantees, pledges and undertakings in connection with bills, resolutions, statements or reports presented by the Union Government, and answer for queries, presented at Pyithu Hluttaw.

 - (b) if the Union Government has implemented its guarantees, pledges and undertakings, the committee shall check whether or not they are implemented within the fixed period and on schedule,
- (3) Regarding the abovementioned matters, the committee has the right to make an inspection tour of a region to check whether or not the tasks are carried out correctly and effectively.
- (4) In general, in scrutinizing the government's guarantees, pledges and undertakings, the committee:

- (a) does not need to ascertain support regarding tabling motions and submitting suggestions.

All the discussions held at committee meetings shall be recorded and approved by the committee. Meeting minutes shall not be handed out. A copy of the report to Pyithu Hluttaw shall be dispatched to Hluttaw Office in order that the case can be kept in the case file together with meeting minutes.

Powers of the committee are:—

- (1) Committee meetings shall be held in accordance with the provisions of Pyithu Hluttaw Rule (70).
- (2) The committee:
 - (a) shall present an interim report if Pyithu Hluttaw fails to present a final report on the scheduled day.
 - (b) The secretary, if the chairman is away, or a member, if the chairman and the secretary are away, shall present the report to Pyithu Hluttaw.
 - (c) In the process, committee members shall put their signatures on the report to show their approval. If there is an exception or difference, they may attach exceptions and differences to the report under their signatures.
 - (d) After presenting the report to Pyithu Hluttaw, the committee chairman or the committee secretary if the chairman is away, or a member, if the chairman and the secretary are away, shall present a report for the

- (3) Committee members:

 - (c) shall, if he is arrested for an offence have the right to attend committee meetings with the approval of the Pyithu Hluttaw Speaker, until a verdict is delivered against him.

Afterwards, names of the designated persons to be constituted in the Government's Guarantees, Pledges and Undertakings Vetting Committee were announced and the session was adjourned for discussion with Pyithu Hluttaw representatives who are joining the committee.

Dogs, officer shocked in Toronto

TORONTO, 7 March—Two dogs were electrocuted and a third canine and a police officer were shocked by an apparent electrical malfunction in Toronto, authorities said.

The incident occurred about 2 pm Friday at the corner of Parliament Street and Queen Street East, the Canadian Broadcasting Corp reported.

A witness, Corey Courveau, told the CBC he was working across the street when he heard a scream and saw one dog on the ground and its owner in anguish. He said he ran across the street to see if he could help and ended up running across the street to alert a veterinarian.

“The owner was obviously very, very distraught, very upset. She was bleeding. The dog bit into her as she was trying to comfort the dog.”

“It’s sad. It shouldn’t have happened,” he said.

A police officer tried to lift the dog only to suffer burns on her hands, the CBC said. Two other dogs were found shocked nearby.

Toronto Hydro said it was determined defective equipment from a Toronto Transit Commission utility pole had electrified the street.—*Internet*

To eat more fruit, picture a fruit salad

MONTREAL, 7 March—Creating a healthy eating action plan and visualizing yourself carrying it out may help improve the way you eat, researchers suggest.

“Telling people to just change the way they eat doesn’t work; we’ve known that for a long time,” study author Barbel Knauper, an associate professor of psychology at McGill University in Montreal, said in a university news release.

“But research has shown that if people make a concrete plan about what they are going to do, they are better at acting on their intentions. What we’ve done that’s new is to add visualization techniques to the action plan,” she explained.

Her study included 177 students who were asked to set the goal of eating more fruit for a week. All of the students ate more fruit during that time. However, those who made a concrete plan, wrote it down and also visualized how they were going to carry out their plan (ie when, where and how they would buy, prepare and eat fruit) increased their fruit consumption twice as much as those who didn’t plan or visualize.

Yellow River ice runs approaching frozen section in north China

HOHHOT, 7 March— Workers are busy breaking up a frozen section of the Yellow River in north China’s Inner Mongolia Autonomous so it will not block approaching ice runs and lead to flooding.

Yan Xingguang, spokesman of the Inner Mongolia Yellow River Ice Runs Control Headquarters, said floating ice chunks about 1 kilometre long were 30 kilometres away from the Haibowan Water Conservancy Project under construction in Wuhai City on Monday, where ice-breaking work was underway. He said workers were using iron boxes filled with rocks to smash through the ice at the Haibowan section.

The Yellow River, China’s second longest, freezes and thaws at different times, posing flood risks mainly in Inner Mongolia and east China’s Shandong Province.

This winter a 906-kilometre long section of the river in Ningxia Hui and Inner Mongolia autonomous regions had frozen, said Yan.

As the temperature picked up in early March, 225 kilometres of the frozen section in Ningxia partly thawed and started to flow downstream towards Inner Mongolia. The frozen part of the river in Inner Mongolia is expected to completely thaw by the end of March.

Child, teen boxing injuries have soared

COLUMBUS, 7 March—From 1990 to 2008, the number of boxing injuries increased 211 percent, from 5,361 injuries to 17,000 injuries yearly, US researchers said.

Researchers at the Centre for Injury Research and Policy of The Research Institute at Nationwide Children’s Hospital in Columbus, Ohio, say during the 19-year study period an average of 8,700 boxing injuries were treated in US hospital emergency departments annually —about 2,500 of those injuries were to children and teens ages 6-17.

Dr Gary Smith, the senior author, said the study’s most concerning discovery was the similar proportion of concussions/closed head injuries among the different age groups — 9 percent among those ages 12-17, 8

percent those ages 18-24 and 9 percent among those ages 25-34.

“We expected a smaller proportion of concussions/closed head injuries among younger boxers, since they generate a lower punch force,” Smith says in a statement.

“The fact that young boxers are experiencing a similar proportion of concussions and closed head injuries as older boxers is extremely concerning given the potential risk of developing chronic traumatic encephalopathy with repetitive brain trauma. These repetitive blows to the head may be placing boxers under 18 years of age at risk for neurological impairment and psychological problems due to chronic traumatic encephalopathy.”

Pilot in crash not trained for aerobatics

KINGSTON, 7 March — An under-trained pilot of a vintage military jet did stunts for friends before plunging to his death in New York's Hudson River, a preliminary report indicated. Michael Faraldi, 38, telephoned friends on 26 Feb from an airport refueling stop in Johnstown, Pa, to tell them he would be flying his single-engine BAC 167 Strike-master — a 1960s-era

light-attack or counterinsurgency aircraft — over Kingston-Ulster Airport at the western base of the Kingston-Rhinecliff Bridge just north of Kingston, NY, the National Transportation Safety Board preliminary report said.

On arrival there about 1:30 pm, "he reportedly flew over the airfield and performed a rolling maneuver, described by

witnesses as a roll or a barrel roll," the report said. "Following the rolling maneuver, the plane remained in the traffic pattern and the pilot executed a second pass, down the center of Runway 15 at low altitude and with the landing gear retracted," then reportedly pulled "up to a nose-high attitude and initiated a left-hand turn," it said.— *Internet*

The video showed that Lohan, with her male companion, spent 45

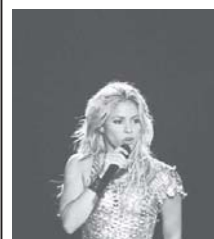

behind it. Trouble for the Honda Classic leader? Maybe. Something was rustling in the rough.

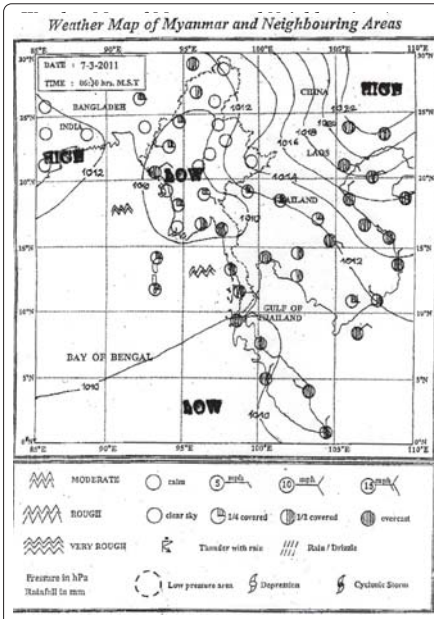
"Is that a gator?" Sabbatini said.
