Since Apr. 7, 1989 the The Working People's Daily has run a political slogan across the bottom of each front page: Aug. 1-2: Breed, grow and produce. Breed whatever can be eaten and grow whatever can be consumed. Do everything with might and main. Aug. 3-4: The three tasks of preventing the Union from disintegration, preventing disintegration of national unity and perpetuating national sovereignty are essential for continued independence of Myanmar Naing-Ngan. Aug. 5-12: The Myanmar peoples must undertake Myanmar affairs according to their own reasoning. Aug. 13-19: All Myanmars who reside in their homeland must maintain their status in accord with Myanmar reasoning. Aug. 20-27: The Constitution of our Naing Ngan-Daw should be approved and adopted only according to the wishes of all the national peoples of our country. Aug. 28-29: If one longs for this or that with misconceptions one will eventually become exhausted with longing. Aug. 30: Don't try to push the nation into a dangerous abyss by creating destructive disturbances. Aug. 31: To exist and earn a livelihood in peace and tranquillity is the over-riding desire of the people. Political Articles (Excerpts) Following the pattern begun in October 1988, each issue contains lengthy feature articles, translated from Burmese, designed

to bolster government views and policies. We note them briefly, with excerpts of particularly significant portions, but can provide copies if needed:

June 29, July 7: The life of absconding Myanmar Youths in India, by An India-returner. [Cont. (3), (6) Life of Myanmar youths in India.]

Aug. 1-3,5-7,9-13,15-31: In solving the problem of internal peace by political means, by Ye Gaung Kyaw Swa. [Cont. (31-58) 1980 negotiations with Kachins.] [Also advertised as a book (in Burmese) (WPD 8/24, etc.]

Aug. 1,3-15,17-29,31: A Concise History of Myanmar and the Tatmadaw's Role (1948-1988), by A Tatmadaw Researcher. [Cont. documentary study, with numerous facsimiles: (4-5) Introduction by Bo Thanmani; biographies of the 30 Comrades. (6-8) AFPFL split in 1958; establishment of the Caretaker Government. (9-10) 1962 Tatmadaw takeover. (11) Panglong agreement quoted. (12-23) 1962 takeover. (24) Socialist democratic government in 1962-88 was "not totalitarian" because it functioned "in accordance with enacted laws." Totalitarian governments were those of Ba Maw, and even of "a Prime Minister after independence, dubbed by his closest associates as `Bawashin Mintaragyi (Lord Arbitor of Life)'". BSPP programme was just a revival of that of Bogyoke Aung San. (25) Socialist democracy built. (26-31) 1974 Constitution.] [Also advertised as a book (in Burmese) (WPD 8/23, etc.]

Aug. 1,4: The last days of the creators of grave dangers, by Kaung Myat. [Cont. (4) KNU and Mon insurgents. Doctors in KNU camps used refugees to test "uncertain" medicines. (5) KNU atrocities.]

Aug. 2: Take care not to harm the Three Main Causes, by Maung Maung Tun. [Don't permit national disintegration. SLORC declaration No. 8/88 prohibiting anti-Tatmadaw activities by political parties, quoted. Need to draft a constitution.]

Aug. 5: "The joke's on joker Aung Bala", by Reporter Kway Gyi. ["There is no one smarter, more crooked and more ready to do anything for self-interest than U Thaung. He is prepared to work for any `ism' for his personal interest. What matters for him is the `price.'" In 1963 he was one of the "former Red Flag followers whose latent sympathy towards the Red Flag surfaced again," who "presented an Akai tape recorder to Thakin Soe on his return to the jungle." In 1962, U Thaung "exaggerated a news story in his `Kyemon' newspaper involving a University faculty member and his second wife," because he feared the people would support the Revolutionary Council.

[He publishes falsehoods in the "Burma Review," published by the CRDB expatriate group headed by Tin Maung Win. His accusation in the April issue on "Military officers and Myanmar economy" is a big joke when he says the economy has declined since "the advent of Senior General Saw Maung's administration." In 1988 enormous damage to the economy was caused "by machinations of destructionists like Aung Bala outside the country and minions and traitors inside...." It is a second joke when he says "the military government had opened the door for the capitalists abroad while it had closed the door for those within," since "a growing number of partnership firms, importers, exporters and joint venture companies are getting themselves registered...."

[He accused the 1962 Revolutionary Council of suppressing the Associated Press of Burma and founding the News Agency Branch (NAB). "Only at that stage I have come to realize what he is driving at... It has become quite evident that the decision not to put a news agency responsible for...distributing foreign news in the hands of a person like U Thaung (Aung Bala) was correct considering his running away from the motherland, traitorous acts and betraying the country if he gets money.... His words broadcast by foreign radio stations and published in bulletins influenced by expatriates have become the best jokes of 1990 for the people of Myanmar Naing-Ngan"]

Aug. 6-8: A constitution acceptable to the people, by An Observer. [Review of previous constitutions. "In the process of drafting and adopting a constitution, elected Hluttaw representatives will have to study the past events, constitutions of the past, guiding speeches of national leaders, then drafted {sic} a constitution and sought the approval of the people through a national referendum in order that the constitution may be acceptable to all the national races of the country."]

Aug. 8: It is not the time to create the kinds of disturbances of 1988, not to make demands and attacks, by Moe Kyaw. [Foreign and party criticism of SLORC denounced. A party pamphlet of July 15, 1989 urged people to "defy all authority" in emulation of Bogyoke Aung San's programme in 1945-46. This is wrong.

In the words of Gen. Saw Maung, "What the SLORC has done for demands of a multi-party democratic system. It is implementing the programme by removing the obstacles. So, all the organizations and all the people are to act as directed by the SLORC in disregard of whoever says whatever he likes."]

Aug. 9-10: The multi-party system and the role of government servants, by Maung Maung Tun. [(1) Government employees should be party-neutral (2) Privileges extended to Government employees in housing, wages, and transport.]

Aug. 12: Election returns that ought to be studied and the Election Commission that ought to be praised, by Maung Maung Swe. [Election statistics reviewed; the Commission deserves praise.]

Aug. 13,17: Those cultivating flowers and those destroying flowers, by Kaytu Maung. [Positive role of Tatmadaw in Myanmar history.]

Aug. 15-16: The BBC, the VOA & the AIR spreading skyful of falsehoods & lies, by Bo Thanmani. [False reports of Aug. 8 disturbances aimed at causing unrest.]

Aug. 20-23: The incident that took place on Ministry of Trade Office on 17-9-88, by A Lawyer (An eye-witness). [Account of incident, in which weapons were stolen from Army.]

Aug. 22,24: Whither Myanmar Naing-Ngan?, by Mya Win. [People want to know "what type of democracy is genuine democracy. Is it bourgeois democracy? Is it communist democracy? Is it socialist democracy? Is it new democracy for which no name has been given? Or is it the people's democracy of the type practised by the BCP?"]

Aug. 25: Students have to dance according to the tune set, by Kyi Nyo (Eco). [How students have been used by the BCP.] Aug. 26: To the teachers, by A Parent. ["I would like to

request the teachers to teach, train and cultivate their pupils by the Myanmar ways and Myanmar styles to ensure that they become allround outstanding, good and able persons."]

Aug. 27: What religion means (Thitsa-Myitta discussions), by Byamahso. ["SLORC leaders read literature not only on Buddhism but also on other religions.... We must not get angry if we are blamed or criticized through false accusations.... If we really adhere to the teachings of religions, live in amity with people who profess different faiths and persons of different religions help one another everything will be good."]

Aug. 31: For the return of Konbaung Dynasty Crown Jewels and eleven statues of royalty taken away by British Imperialist, by Bo Thanmani. [Four-page special article on artifacts taken in 1886, with extensive documents and illustrations.]

[During the month, there were considerably more than the usual number of political cartoons, often several per issue, denouncing foreign broadcasts, diplomatic misbehavior, and political party machinations, in contrast to the virtue of the Tatmadaw and SLORC.]

[Beginning Aug. 30, advertisements for How the Panglong Conference and the Panglong Agreement emerged, in Burmese, appeared. Advertisements continued throughout August for the speeches of State LORC Chairman Senior General Saw Maung (in English).]

Forestry Defended

Aug. 1: A Letter to the Editor from the "Forest Department of Myanmar," denounces a [London] Daily Mail article of June 4 by Sean Ryan called "Burma Teak Faces a Chainsaw Massacre." The whole [Thai] concession covers only 3,890 square miles of the 149,870 sq. miles of forests in Myanmar, or 2.6%. Myanmar extracts 350,000 "hoppus tons" of teak annually, which, at 90 tons per acre, equals 3,889 acres. Since current annual plantings of 80,000 acres includ over 40,000 acres of teak, this is more than adequate for replacement.

Press Conferences

[These conferences have been held weekly since 1988. On July 19 it was announced that the July 20 conference would not be held and that, thereafter, official press conferences would be held fortnightly unless otherwise deemed necessary.]

Aug. 10: At the 102nd State LORC Press Conference, spokesmen said:

-- Rumours were spread of disturbances in Yangon and Mandalay to mark the second anniversary of the Shitt Lay Lon (8-8-88). "All these pieces of news are absolutely incorrect. The news about the true events was published on 7 August." [see below]

-- "An AP news item in the 8 August issue of The Nation in Thailand mentions that a western diplomat said...that a [policeman] bayonetted a student on his face. This is not true at all.... Two diplomats...went to the Masoyein Taikhaung in an embassy car at 4.30 pm on 4 August and asked questions in connection with rumours of student Win Naing being bayonetted and took video shots.... The fact is that some students of No. 13 High School were shouting on 3 August and student Ngwe Soe... tried to persuade other students to take part in causing disturbances. When others did not follow him he got angry and fisted the glass window thereby injuring himself. The student made a complaint that he got ... bayonetted. However a lady teacher who knew what really happened reported the matter to the headmistress.... At No 13 High School itself, a scuffle involving throwing of stones broke out between some parents...and some members of Sangha.... One novice Shin Eindaw Bhasa, 17, was injured in the head."

-- "We would like to clarify other exaggerated rumours. On the morning of 8 August in Mandalay, some members of Sangha and some students caused unrest and shouted.... [In] a scuffle...three security personnel and one novice were injured...."

-- Extensive quotes from BBC, VOA, AFP, and other new stories alleging, on the basis of information from diplomats, that four protesters--2 students and 2 Sangha--were killed when security forces opened fire in Mandalay. "Those news items sent by the diplomats are totally false."

-- The false rumours were instigated by Directive No. 24 issued Aug. 2 by the National League for Democracy, citing Aug. 8 as the "2nd anniversary of the mass movement for democracy which began on 8 August, 1988," and calling for ceremonies to mark the occasion. "The terms, `do like this when conditions are favourable and do like this when conditions are not favourable to honour "four Eights" mass movement', have deep meanings. If we think deeply, we can know that they amount to instructing their men to cause disturbances."

-- The Government has not taken note of reported remarks by NLD Central Body member U Chan Aye on July 30 that a meeting was needed between the SLORC and the NLD to resolve a difference of opinion over the constitution, and by U Kyi Maung "that `Mai' (the NLD) could not accompany `Maung' (the SLORC) wherever he (it) would take her." However, "U Kyi Maung...had even said something in connection with the Nuremburg trials."

-- Myanmar welcomes the reestablishment of diplomatic relations between China and Indonesia.

-- As to constitutional developments, "the exact date for summoning the Pyithu Hluttaw cannot be said but we have no wish to cause delay."

-- The Government has no knowledge of rumours that "two men...entered one of the embassies [and] said they wished to meet the responsible personnel for an important matter. The security men of the Embassy received them temporarily and then took them to the Washington Park [US diplomatic residential compound---HCMacD.] in Yangon.... After...they had been looked after and fed for about two weeks...they begged for political asylum." Diplomatic rules forbid improper use of embassy premises.

-- Asked about rising prices of food (except rice), "the prices of commodities are gradually changed from the base to their real value Instability...is also connected with rumours spread and instigations made to cause disturbances. The rumours spread include that two-hundred kyat notes will be demonetized, that commodities are to be stored up with the approach of...the `four Eights' and that attempts will be made to cause unrest between 1 and 15 September."

-- Prices vary; thus pork is K130 per viss in Yangon and K60 in Bago. Price rises are lower than in Eastern Europe during its transitory period. The consumer price index rose from 144.89 in July 1988 to 201.79 in July 1989 and 214.14 in July 1990. Inflation rate is now 14.86.

-- As to [edible] oil, 24,911 tons were imported in 1988-89. As of July this year 18,600 tons were imported and have been received. Altogether, 55,199 tons is to be imported this year, of which 36,599 by private entrepreneurs.

-- "Exporting of groundnut through border trade has been banned because exporting it through Yangon port can fetch a higher price."

-- Foreign debt: Foreign debt was 5.878 billion on Mar. 31, 1988 (1.693 billion undisbursed); it was 5.679 billion on March 31, 1989 (1.446 undisbursed); and 5.238 billion on March 31, 1990 (1.133 undisbursed). So debt declined .64 billion over 1988 and .44 over 1989.

-- "Investigations are under way for exposing the instigators. Since the main reason for the taking place of disturbances in townships is the National League for Democracy's issuing of directive No 24, those who are responsible for this has [sic] been called in yesterday to give warning to them.... Action will be taken according to the law...." (WPD 8/11)

Aug 24: At the 103rd State LORC Press Conference, spokesmen said:

-- Bulletin No. 2/90 of the National League for Democracy gives a false account of the Aug. 8 disturbances in Mandalay, including a letter from 41 NLD Hluttaw representatives and others in Mandalay suggesting that "security units had used force causing bloodshed...." "Those responsible for publishing the bulletins...numbering 51 persons were called in by authorities for questioning." It was learned that Monywa U Tin Shwe who wrote the pamphlets was not an eye-witness. Others who signed pamphlets said they were not eyewitnesses. U Sein Win said he had not attended the NLD meeting or signed the document.

-- Other publications discussed. Suggested that some are being sold for commercial purposes; that a Union Nationals Democracy Party has been disowned by the UNDP, which denies an alleged interview of U Aung Gyi by Richard Muller of the Far Eastern Economic Review; that the National Unity Party was not responsible for pamphlets in its name on why it had lost the election.

-- "Political attacks on us... creating demands and attacks [are inappropriate].... The [SLORC] is not an organization that will hold on to State power for a long time."

-- "We know that a big embassy in Yangon is secretly looking after two persons whose identities are not yet known.... Three or four embassies are carrying out acts incompatible with the diplomatic functions...but we have been patient with them.... For instance, we have not yet revealed the name of an embassy that provided financial assistance to U Ye Tun who in collaboration with an insurgent group had been engaged in above-ground and under-ground activities, as well as to some youth organizations. We have withheld the name, with magnanimity; to prevent the nation concerned from losing face in the world."

-- "Some embassies are getting involved with some student circles, political circles and national races ...and are carrying out

instigative activities...[and] even using their respective intelligence agencies and the `axe-handles' within the country as informers by giving money and gifts.... The prominent journalists should extend a helping hand in exposing the malpractices of certain embassies.... Politicans who represent the people should tell the people what is true...[and] with patriotic spirit should reveal foreign interferences and involvements."

-- "We have heard the news that the [SLORC] has formed the military council only now and that the military council will continue to govern the nation.... There are now some people who have deliberately fabricated such news...there is no need to form a military council."

-- With the...election having been held, the [SLORC] will continue to carry out the remaining three tasks till the coming into being of a firm government.... We will continue taking the responsibility of the State till the emergence of a government formed in accordance with constitution accepted by all the national races."

-- Since all constitutions are now void, demands to hold a Hluttaw session are intended "to cause unrest and disturbances...." Various political parties [NLD; Mra People's Party] are framing constitutions, even some without a single seat. Parties without a seat "will have to stop their illegal acts if they want to continue to exist." Parties should not "incite acts defying the authority nor of making demands for an interim government."

"Newspaper editorials and articles have exposed improper diplomatic behavior, but "No warnings have been given...up to now to the diplomats who violate the code of conduct of diplomats. But if the interferences become too much excessive necessary action shall be taken."

-- The embassies "using their intelligence organizations, giving financial assistance to their lackeys and trying to create unrest and disturbances...are from western countries."

-- The spokesman said "the SLORC Ruby was mined in Mogok and that Than Tun and party of Mandalay Naypyidaw were trying to smuggle it out when the Tatmadaw intelligence recovered it on 18 August without any cost to the State, that action would be taken against U Than Tun, Daw Soe Soe Tun, U Hla Myint and U Zaw Win of Mandalay who tried to smuggle out the ruby.... Some persons from some political parties are engaged in illegal trading of precious stones"

-- Asked about 700 students allegedly in Bangkok and afraid to return, and as to when the colleges, closed for 2 1/2 years, would reopen, the spokesman said the reception centers were still open and students would be warmly welcomed. 3,300 youths have returned, plus 300-400 ABSDF insurgents who have returned to the legal fold, and "there were no arrests whatsoever." Action will be taken only "if they infringe laws after they come back." Example of Maung Maung Kyaw who was arrested with an "instigative document." "As regards the opening of colleges and universities, the Ministry of Education will do so when the time and circumstances are right."

-- Asked whether "the rumours that the rationing of petrol was temporary" were correct, the spokesman said "best measures" would be taken, and cited the recent address by the Yangon Commander [see below under Economics]. (WPD 8/25)

Disturbances and Trouble-making

Aug. 7: Mandalay: In recent days, "rumours [in Yangon] had it that in some high schools in Mandalay there were student unrests and that security forces opened fire on them and that two school boys and one school girl were killed; that 20 members of the Sangha and students were arrested; that the schools where disturbances took place were closed; that one student from Masoeyein Kyaungtaik was bayonetted to death by security forces; that one woman was also killed in the same way and that members of the Sangha were arrested.

"The rumours spread in Mandalay had it that there were disturbances in High Schools No 11 and No 13 of Mandalay on 3 August and that security forces entered the school compounds to disperse the students and that in doing so some impatient security forces bayonetted to death two schoolboys, one schoolgirl and two members of the Sangha and that those killed were picked up by the security units.

"The truth was that members of the Sangha gathered at U Pwa Pagoda compound in Mandalay at 1 pm on 5 August. Responsible personnel and security personnel went there and prevented them from rallying. About 200 members of the Sangha went out and shouted at 4 pm. Then the security forces dispersed them.

"On 6 August in Mandalay from about 30 to 60 students each gathered in the school compounds of high schools No 3, 5, 9, 15 and 16 and shouted and created disturbances. Teachers and parents let them go home early and they dispersed peacefully.

"Also on 7 August in Mandalay from 30 to 50 students gathered in the compounds of high schools No 1 and No 2 and shouted. Teachers and parents controlled the disturbances, let the students go home early and dispersed them peacefully."

The rumours are intended to disrupt peace, and "to team up with unscrupulous profiteers to create price instability." (WPD 8/8)

Aug. 8: Mandalay: "Some members of Sangha and students caused unrest in Mandalay this morning...[and] threw stones at security unit members and tried to wrest fire-arms.... Three security unit members and a novice were wounded in the scuffle.

"At about 5.30 am today, about 500 members of Sangha carrying alms bowls marched from the junction of 38th Street and 84th Street along 84th Street to the north and they proceeded along 35th, 80th and 26th Streets up to the junction of 26th Street and 84th Street. The number ...increased to 700.... From there they headed to the south along 84th Street. Then about 200 civilians and students followed them.... [At] 84th Street between 32nd and 33rd Street, some youths...shouted and instigated to create unrest and disturbances Some members of Sangha and students threw stones at the security unit members and tried to wrest firearms from them. Three security unit members received injuries in the head and novice Ananda, 15, of Mingyikyaung, Mogaungtaik received an injury on his left forearm....

Yangon: "Likewise, about ten youths went up the Taw-win overhead bridge of Sule Pagoda Road and Bogyoke Aung San Street in Yangon at 8.30 and hung on the bridge two wreaths made of red papers and ran away. Furthermore, about 100 youths gathered at the junction of Anawhrahta Street and 36th Street. A youth ...stuck pamphlets instigating to create unrest on...a bus.... The youths ran.... At about 3.30 pm, five youths...arrived at the junction of Bogyoke Aung San Street and Shwedagon Pagoda Road and shouted and instigated to cause arrest and disturbances...they ran away. At about 4 pm, some youths from the Pabedan side went towards the City Hall with bouquets in their hands. On arrival near the Bandoola Park, the number of people, including the onlookers, grew to about 100. They youths then shouted and instigated to cause disturbances. But they ran away when the security unit members came to bring order in the area. Investigations are underway...." (WPD 8/9)

Aug. 9: Pakokku, Monywa, Meiktila: There was unrest on Aug. 8, but demonstrating youths were dispersed without injury.

At Pakokku [Magway] High School No. 1, 15 youths gathered and went to Nos. 1 and 3 Middle Schools on Pauk Road, where they climbed over the fence and unsuccessfully "instigated the students to join them." They they went on to the Kyaungywa No. 2 Middle School "and shouted. When the students did not come out and join them, the youths broke the flag pole, shouted and dispersed."

At Monywa [Sagaing] Nos. 1 and 3 High Schools, 50 youths and Sangha gathered and shouted. The crowd at No. 3 grew to 300, which marched through Dawnachan up to the south circular road, and threw stones at security unit members. "They dispersed only when security unit members fired shots into the air."

At Meiktila [Mandalay] No. 1 High School youths "shouted and instigated the students." The crowd grew to 300, which went to the

junction of Mar Din Pale Ward, where security unit members dispersed them. At 8 pm, "about 25 youths wearing masks shouted near the Zwe Hall in Meiktila." The entered Dahattan Ward and went along the Main Road, but fled when security unit members arrived. (WPD 8/10)

Arms and Explosives Seized

Aug. 8: On July 25, Bhamo police seized demolition equipment from a house in Kokkodaw Ward, including 86 TNT slabs, a pot of gunpowder, detonators, etc. On Aug. 7, Mandalay police seized 3 guns, 2 hand grenades, and ammunition from a trishaw near the Yayzingway Myohaung junction. (WPD 8/9)

Party Official Prosecuted

Aug. 15: Police have called in for questioning and will take action against U Sann Linn, 42, Patron of the Kayan Township [Yangon] Democratic Party for New Society [No. 18], on charges of illegally distributing agitative pamphlets to students and forming an illegal students thamagga [union] at Kayan High School to cause unrest. (WPD 8/16)

Maj-Gen. Khin Nyunt's Views

Aug. 19: In a speech in Nyaungdon Township, where he was inspecting erosion controls, State LORC Secretary (1) Maj-Gen. Khin Nyunt said:

"We know that power should be handed over in accordance with constitution at the suitable time. There must be a firm constitution in our country and it is the life of the country. A government should not be formed and power be handed over in a slip-shod manner with a temporary constitution. We successfully held the election for we have arrangements for handing over power from the very beginning.

"Myanmar Naing-Ngan has two significant conditions. One is that the country is made up of 135 different national races and the other is that there is insurgency that emerged with our independence. These things are to be taken into consideration in drafting a constitution. A constitution is to be drafted in such a way that it is in accordance with the wishes of the national races who are residents of the Union and that it is in their interests.

"Myanmar Naing-Ngan remained backward due to insurgency. Now insurgents remain only in certain border areas. The State Law and Order Restoration Council has been carrying out activities for development of border areas and this work has been going on for more than one year. The work is aimed at strengthening national solidarity.

"Certain political parties and some organizations are making demands for swift transfer of power. Broadcasting stations of certain big nations are making attempts to interfere in our internal affairs to undermine national solidarity and to cause disintegration of the Union and then to make Myanmar Naing-Ngan their satellite country. We shall continue to carry out tasks for the benefit of the country and its people.

"We have no political party that backs us. We are doing things through co-ordination among Tatmadaw leaders and under the leadership of Senior General Saw Maung according to our belief and objectives for the good of national races." (WPD 8/20)

Aug. 26: Speaking in Rakhine State, State LORC Secretary (1) Maj-Gen. Khin Nyunt said:

"The [SLORC] carries out giving priority to Our Three CausesÄÄnon-disintegration of the Union; preservation of national solidarity and perpetuation of national sovereignty. Our Three Causes are the concern of every citizen.

"Our country must have a firm constitution. It is the life of a nation. It is impossible for us to hand over power to a government formed under a provisional constitution. We should see the long-term interests of the nation.

"It is necessary for the political parties to do their work within the bound of law.

"I would like you to realize that certain diplomats got themselves involved in the movements that had taken place in Myanmar Naing-Ngan and foreign broadcasting stations such as BBC, VOA and AIR broadcast false news in an attempt to cause disintegration of the Union. True events have been clarified in the press conferences.

"UG [underground] elements headed by BCP Bo Kyin Maung have infiltrated into the world of service personnel and parties.

"Market economy is being practised and natural resources of the State are systematically being exploited. Especially in the onshore oil exploration, we have signed contracts with ten foreign companies. It is expected that oil can be produced between six months and one and a half year from now. Myanmar Naing-Ngan will make rapid progress if the work meets with success....

"The most important task today is to draw up a constitution concerned with each and every citizen. Hluttaw representatives, leaderrs of nationalities and the people, therefore, are to take part in drawing up the constitution.... The constitution cannot be framed by one person or one organization...[it] must be in full accord with the wishes of the people.

"The National League for Democracy has made demands in publishing resolutions passed at Gandhi Hall and excerpts of its eighth press conference. Matters concerning the constitution and transfer of power cannot be dealt with hastily. In view of national interests these tasks must be carried out state by stage taking appropriate time.

"At present, the rule of law and peace and tranquillity are essential requirements and each and every person must abide by the law...." (WPD 8/27)

Maj-Gen. Myo Nyunt's Views

Aug. 27: Yangon Commander and Divisional LORC Chairman Maj-Gen. Myo Nyunt told judges and police:

"Just as organizations within the country are continually demanding speedy transition of power, so also the organizations outside our country are meddling in our internal affairs... As their attempts to cause disturbances in August have come to naught, they have made another move to cause unrest in September. They are again spreading rumours that something will happen on 9-9-90...15-9-90...and 18-9-90.... Some organizations...are now demanding the convening of Hluttaw on this and that date, quoting the paragraph 3 of chapter 2 of the Pyithu Hluttaw Election Law.... But it does not mention a date on which it is to be constituted as they are demanding

"The very essence of Declaration 1/90 is transfer of power according to a constitution which is acceptable to all national races.... We have...put up sign-boards bearing the three main causes. But some students, persuaded by some unscrupulous politicians, are now putting down or destroying sign-boards. And these acts amount to the implication that those politicians who are pulling the strings from behind will forsake the three causes if they ever come to power....

"Greedy merchants and traders do not hesitate to join the propaganda campaign. They do not try to make money by simply competing among themselves. They resort to unscrupulous means, spreading fabricated news...[that] may heighten the anxieties of the people. Taking advantage of the government's revised fuel distribution the destructive elements spread various rumours. They'll always attempt to push us into a corner.... We, on our part, must keep an eye on their acts so that their destructive activities can be prevented." (WPD 8/28)

"Don't Do It!"

Aug. 31: "Do we not benefit by having peace and tranquillity to prevail...? Is not the [SLORC] living up to its promise to strive for better conditions of food, clothing and shelter for the people and is it not rendering appropriate assistance to the private and cooperative sectors in this endeavour?

"We can look around us and the answers are too obviously a resounding `Yes!'

"Look anywhere and everywhere at the common decent people in the crowded markets and stores, in the parks and in the theatres and you will find the answers on their happy, satisfied faces.

"Ask them if they wish this peace and stability to be broken asunder. Ask them if they want to experience once more the terror, the confusion and the destructive anarchy of 1988. Their answer in the negative would be all too apparent on their faces.

"The self-styled political organizations claiming to have the interests of the nation and the people at heart would do well to ask such questions and watch the faces of the common decent people...if confrontational tactics and aggressive demands are conducive to the continuence of peace and stability so much appreciated by the common decent people.

"What is required now is peace, stability and sanity; time to re-think the past and initiate measures for a promising future.... Don't let devil's advocates persuade you that destruction is necessary to build anew.... Disinformation may try to persuade otherwise. Don't let such perversions persuade you. Don't be drawn into repeating past errors. Don't be persuaded into making demands, attcks and confrontations.

Agricultural Bank Law

July 6: The State LORC Law No. 17/90 of July 6, the Myanma Agricultural and Rural Development Bank Law [full text published in WPD], establishes a bank to: make easy agricultural loans, promote rural banking, encourage saving, support rural development, encourage banking habits, and develop banking business. Capital is authorized at K 1000 million, of which 60 million shall be fully paid up by the State, which is the sole shareholder. A paid-up Reserve Fund of K 20 million is established, to which will be added 25% of net profits until the Fund equals the paid-up capital of the Bank. Other profits go the the Government. The Board of Directors will consist of a Chairman, and four members appointed ex-officio by the Ministry of Planning & Finance, the Ministry of Agriculture & Forests, the Ministry of Livestock Breeding & Fisheries, and the Ministry of Cooperatives. The bank may make annual, short-term (1-4 years), and long-term (4-20 years) loans to public and private institutions and to individuals; the last two categories shall be secured, and interest and repayment terms shall be set by the Bank. Unpaid loans may be collected as land revenue [tax] arrears. The Bank may also receive deposits "on the basis of rural development," and make loans, advances, and overdrafts with or without security. It may organize, recognize, and supervise village banks. The Bank may deal in various kinds of remittances, and borrow money at home or abroad. It shall act as successor to the Myanma Agricultural Bank established by Pyithu Hluttaw Law No. 9 of 1975, which is repealed. (WPD 7/7)

Visits to sites, and past statistics.]

Basic Commodities

July 31: Joint Venture Corp. No. 4 "has made arrangements to sell three viss of edible oil to each public servant in Mandalay, Magway, Monywa, Pakhokku and Pyay at K 40 per viss." So far, the Corporation has exported 10,700 tons of beans and pulses as of July 15, and has distributed 2,646 tons of palm oil and US\$30,000 of pesticides in the country. It has signed contracts for the purchase of 1,900 tons of palm oil and 100,000 corrugated iron roofing sheets. "Since it has exported another 14,500 tons of beans and pulses it will place orders for the purchase of chemical fertilizers, foodstuffs and construction materials needed in the country." "Televisions, Video cassette recorders, radio cassettes, refrigerators and zinc roofings are now available at the saleshop." (WPD 8/18)

World Record Ruby

Aug. 20: A flawless, crimson rose ruby, weighing (uncut) 504.5 carats [496.5 carats when cleaned] and measuring 43x37x33 mm, has been recovered from abroad. It has been named the "SLORC Ruby" and will be kept as a national treasure. It was part of a group of rubies weighing 1,870.1 carats illegally mined in Mogok in Feb.-June, and "sent to the other country about June for sale abroad," but were recovered thanks to efforts of the Defence Services Intelligence. Other illegally mined rubies were recovered in Mogok since July, for a total of 28,858.5 carats, including rubies weighing 330, 260, and 250 carats. The authorities will take legal action against illegal mining in Mogok. Other famous Burmese rubies mentioned. [photos] (WPD 8/21, editorial 8/24) Fuel and Energy

Aug. 23: Yangon LORC Chairman Maj-Gen. Myo Nyunt clarified the "revised distribution programme of fuel oil," and denounced rumours. In the Yangon City Development Committee area there are 29,941 private vehicles, 7,112 taxis, and 8,103 motor cycles, not counting buses and long-distance trucks. The previous allocation of 1.5 million gallons of petroleum has been changed to 1.49 million gallons, a drop of 100,000. Diesel has been increased from 330,000 to 450,000 gallons. Methanol fuel and oil are unchanged. "In fact, we have no problem of fuel oil shortage...and there is no connection whatsoever with the Middle East events as the rumours suggest." The number of buses has increased from 1,300 to 2,100, and bus lines from 51 to 58. However, there are problems when long-distance buses carry goods instead of passengers, or fail to complete runs but claim fuel as if they had. Some taxi drivers have asked K 25 for journeys less than a mile. Price rises are not connected with fuel distribution. (WPD 8/24)

Aug. 26: Minister for Energy and for Mines Vice-Adm. Maung Maung Khin visited the Myanma Oil and Gas Enterprise (MOGE) projects in Ayeyarwady Division on Aug. 25. At Kyarkike Senior Engineer U Kyi Lwin said that as of Aug. 1, 28.5 billion cubic feet of gas were produced, and that 12 of the 18 wells in the Kyarkike region were successful. At Seinhine Field, MOGE Project Director U Sein Hlaing said that work at Payagon Camp, with an area of 200 square miles, started in 1979. Oil and gas were first found in Well No. DT-1 in the Seinhine region, and oil was produced at an average rate of 31 barrels per day and gas at 8.7 million cubic feet per day; oil and gas were [also] being produced from Nos. 1 and 5 Wells in the Hteinkyun region. At Payagon, 75% of the investment has been recovered. Altogether, 70 [oil and gas] wells have been targeted this year. The Minister then visited the Hlezeik region of the Payagon oil field project in Bogale Township. (WPD 8/27)

Rice Production Needs

Aug. 24: Speaking at a workshop on rice production technology, Minister for Livestock Breeding & Fisheries and for Agriculture & Forests Lt-Gen. Chit Swe said that because of world population increases, world rice production should rise from 485 million tons of paddy to 556 million tons by 2000; "for this reason there is a need to increase world rice production by nine million tons per year." As Myanma's population will be about 50 million by 2000, 696 million baskets of paddy will be needed for home consumption. In order to export 1 million tons, there is need to produce 776 million baskets of paddy. Thus paddy production must rise by 13 million baskets to meet home consumption needs. Land reclamation and water supply are major factors in this. The Minister went on to describe the Mu River Delta area irrigation project. (WPD 8/25)

Role of Co-operatives

Aug. 28: Minister for Construction and for Co-operatives Lt-Gen. Aung Ye Kyaw said:

"Co-operative societies are required to be competitive with the State-owned economic enterprises, joint venture corporations and private enterprises. But they should not be profit-oriented.... It is incumbent on the co-operative societies to help stabilize and bring down commodity prices. The co-operatives are necessary to sell basic commodities and kitchen items at a cheaper price without being profit-oriented." He cautioned them against mingling with the political parties. Aug. 29: During July there were 62 fires in Myanmar (49 kitchen fires; 7 due to electricity; 6 due to arson). Total damage was K 4,588,331. 313 homes, 1 factory, and 2 godowns were destroyed, and 1,497 people made homeless. (WPD 8/30)
