They must abide by the laws of Myanmar Naing-Ngan. \* Citizens of any nation resident in Myanmar Naing-Ngan must respect and abide by the law of Myanmar Naing-Ngan. During December, the following was printed on the first page of many issues of WPD: National Objectives for 43rd Anniversary Independence Day --For all citizens to make concerted efforts with the leadership of the State Law and Order Restoration Council for perpetuation of independence, sovereignty and integrity of the State; --For all citizens with the leadership of the State Law and Order Restoration Council, to unitedly safeguard and prevent the Union from disintegration; --For all citzens to join hands with the Tatmadaw to expose and crush the destructive elements; --For all citizens to conscientiously make efforts to draft and adopt

a firm constitution in accordance with the wishes of the national races.

.c.:Cartoons

[There continued to be several political cartoons in each issue, generally denouncing foreign broadcasts and embassies, those who listen to foreign broadcasts, and political parties in general.] E.g.:

Dec. 1: 1st Myanmar: "It is said that the salaries of the local staff of some foreign embassies here will be paid in dollars." 2nd Myanmar: Let them pay as they wish....this is democracy....But the local staff from those embassies must take care not to become minions of their employers... It is necessary for them not to loose [sic] their spirit of patriotism."

Dec. 2: 1st Myanmar: "Declaration 1/90 has already been signed. What is going to be done? 2nd Myanmar: "Oh! Don't be so naive! There remains Rule 81, the Commission report, certificates of representatives, etc."

Dec. 3: 1st Myanmar: "The VOA on 22-11-90 broadcast that the spokesman from the State Department `Kabauk Kachar' (Disorderly) denounced the imprisonment of the two opposition leaders for security reasons." 2nd Myanmar: "It is Richard Boucher ...not Kabauk Kachar..." 1st Myanmar: "As he is saying things in a disorderly manner he should be called Kabauk Kachar...."

Dec. 13: BBC Announcer: "Military authorities of Myanmar Naing-Ngan announced that about 50 opposition politicians were accused of planning to form a parallel government and were arrested." Myanmar man: "They were not accused to be arrested... Action must be taken to any organization which violates the law." Myanmar woman: "There is no country which does not take action against law breakers."

Dec. 13: 1st Myanmar: "The VOA alleges that the press conference given by the SLORC Secretary-1 is propaganda to discredit the opposition party." 2nd Myanmar: "There are such firm evidence and it is quite obvious like an elephant roaming in the field. It is quite laughable for them to allege that saying the truth is propaganda!"

Dec. 14: 1st Myanmar: "Pam O'toole of the BBC said that it will be quite a benefit if the opposition groups opposing the Myanmar Military government were all united. With what intent are you saying this, Mr Pam O'toole?" 2nd Myanmar: "What are the BBC and Pam O'toole doing? Interfering in the internal affairs of other nation is overt violation of the Geneva Convention. And they say they are citizens of a civilized nation....

Dec. 17: 1st Myanmar: "The poorest nation." 2nd Myanmar: "No...No.. Least Developed Country. We don't sell slaves and prostitutes. We have good character. No one has ever died of starvation. We are very rich in natural resources. Take note of that, you Dabbleduck!"

Dec. 18: Computer Screen: "214.6 THOUSAND US \$ TO MYANMAR." American: "Look here! The computer says we will have to pay back to the Myanmar Tatmadaw." Uncle Sam: "Leave it alone."

Dec. 22: 1st Myanmar: "Friend.... Who appointed the central body members in the political parties at present? Were they appointed by the people?" 2nd Myanmar: "No! They weren't. They just appointed themselves. Let us go, friend."

Dec. 22: AIR's 21.12.90 morning news: "Myanmar Military Government declared the National League for Democracy an unlawful organization." 1st Myanmar: "Huh... How is that? The Voice of Myanmar announced only the deregistration of the Party for National Democracy." 2nd Myanmar: "The error was made because they wanted to gossip about other nations very much."

Dec. 23: 1st Myanmar: "BBC broadcast on 20-12-90 morning that.... Aung San Suu Kyi will be sent back to England during the Christmas holidays." 2nd Myanmar: "This was not in the press release of the Ministry of Foreign Affairs, and was not included in what U Ohn Gyaw said. They have just fabricated it and said it by themselves." Dec. 25: "Christmas Present"-- Stone table supported by Tatmadawmen and Myanmars inscribed: "The people of all the national races, Defend and protect the country; build up the nation. Don't bully and oppress the weak. Avoid confrontation. No need to go into the jungles. Carry out your work within the bounds of law. Be united and share things in weal and woe."

Dec. 29: 1st Myanmar: "We gave our votes for choosing as Hluttaw representatives----but what's happened now?" 2nd Myanmar: "They must have gone into the jungle hoping to find democracy there----that's what!"

Dec. 30: "Timed rumour and a Thingyan gas cannon." Rumour: "Twenty-one groups of racial insurgents headed by parallel prime minister Dr Sein Win are going to attack Yangon on January 3...." 1st Myanmar: "Well, far from being able to launch attacks, they have to cling to two small bases." 2nd Myanmar: "Ko Sein Win, if you have guts, come and attack instead of acting like gas cannon. Then we can watch a jolly good show."

Dec. 31: 1st Myanmar: "Of the Pyithu Hluttaw representatives, 13 were declared absconders and 8 were stripped of Pyithu Hluttaw representation." 2nd Myanmar: "Oh yes... Then the number of Hluttaw representatives who were elected only by 38 per cent of eligible voters has considerably decreased."

Dec. 31: 1st Myanmar: "Hey friend .... It was said that the parallel government which was formed in the jungle was given Mandate by the 250 Hluttaw representatives." 2nd Myanmar: "It is certain that truth wil come out in this regard."

.c.:Political Books

"Copies of the dictionary of law terms in English and Myanmar languages and the book on code of conduct, duties and rights of lawyers are being distributed, it is learnt." (WPD 12/22)

.c.:Foreign News Coverage

In marked contrast to pre-1988 practise, the WPD in the past two years has regularly given prominence to news stories reflecting unfavorably on domestic events in countries deemed to be hostile to Myanmar, especially the UK, US, and India. As a sample of this, we provide headlines (only) of such stories appearing on the first page (only) of the WPD during December 1990:

USA: Youths and police clash after Miami officers' acquittal (WPD 12/ 5); Murder rate in New York hits new high before Christmas (12/6); American youth in racial assault of Japanese students (12/7); Cities across US experience bloodiest year (12/9); New York city faces new \$250m budget gap (12/13); Two trains collide in Boston underground (12/14); Ex-CIA agent gets 16 months in jail in Iran-Contra tax case (12/16); US consumer prices rise in December (12/20); Hunger, homelessness tightening grip on American cities (12/ 22); Report says US underestimated civilian deaths in Panama (12/22); Five Washington students shot by gunmen (12/24); Philadelphia murder rate reaches all-time high (12/26); Freak weather hits US (12/26); One killed, over 100 injured in US subway fire (WPD 12/30).

UK: British teen accused of drug smuggling appears in Thai court (12/ 10); Britain's economy in grip of recession (12/23).

India: India's FE reserves hit red alert (12/5); Bhopal gas victims observe sixth anniversary of incident (12/6); Nine killed in fresh Hindu-Muslim violence in Hyderabad (12/13); Three killed in street gunfights, 10 militants killed on border (12/15); Call for UN troops to control sectarian violence in India (12/16); Hindu-Muslim violence continues (12/17); Indian Premier vows use of force to end civil strife (12/20); Indian troops moved into Srinigar to stifle protests (12/31).

Dec. 2,4: Union Flag, worthy of respect, by My Chit Thu. [The 1974 flag should be honored. History of Myanmar flags. Law against desecrating the flag.]

Dec. 3,6: National priorities, by Aye Win Khin. [Cont. (4) "Buddhist ethics in touch with reality." "Getting hold of ordinary law-breakers may be an easy matter, but having to deal with even a few of the much-revered Sangha who had misused the robe of Buddha and were engaging in acts unbecoming of their status, is of a magnitude that transcends others. In Mandalay firm acts of restoring order had to be taken... Here again, it must be pointed out that foreign media... bent on fanning the flames, had come up with unwarrented criticism, proved unfounded.... Certainly, no one would allow a whole boatload to stink because of a few rotten fish. Monks, to be correctly respectful, are no rotten fish, but when they prove errant, they must be duly reined in, with the approval of the Sayadaws, and the law must take its course." (5) "Only hard work brings satisfactory results."] Dec. 5-7,10,12-13,16-17,26: Narcotic drug abuse control work of

Dec. 5-7,10,12-13,16-17,26: Narcotic drug abuse control work of Myanmar Naing-Ngan & the participation of the national races of north-eastern area, by A Journalist. [November visit of State LORC Secretary (1) Maj-Gen. Khin Nyunt to Kokang area, destruction of drugs and opium refineries, construction and social welfare projects.]

Dec. 6,14,17,19-20,28,31: A Concise History of Myanmar and the Tatmadaw's Role (1948-1988), by A Tatmadaw Researcher. [Cont. documentary study, with numerous facsimiles: (95) History of AFPFL. (96-98) Rise of insurrections by PVO in 1948. (99-100) Creation of Burma Army and police in 1948; Karen insurgency suppressed in 1949. (101) BTF-Burma Territorial Force.]

Dec. 10-11: Historic wars incessantly waged against the British imperialists by the entire people of Myanmar Naing-Ngan, by Tin Htwe. [(numbered 4-5) British capture of Hainggyi Island in 1753.]

Dec. 10: No short cut; no other way, by An observer. [No shortcut to transfer of power.]

Dec. 11: BBC should not broadcast only portions of the facts to suit its purpose of causing suspicions, by Bo Thanmani. [BBC on Dec. 8 said that: "`It is learnt...that 48 NLD members have been arrested {of whom} 35 are elected members of Parliament. The Government said that according to the documents seized from the NLD headquarters the NLD members were found to be trying to adopt a consititution and to form a parallel government. The Government said that after they had formed the parallel government, they intended to strive to get it recognized by the United Nations and some of the nations.' It is found that this broadcast was based only on some of the facts {explained by Maj-Gen. Khin Nyunt in his Press Conference}...." It did not mention facts about the BCP, the DAB led by KNU Bo Mya, Mr. Adam and Keith Riggin from the United States Embassy who are interfering in the internal affairs of Myanmar, financial aid by the Indian embassy, etc. "I would like to tell the BBC that the {SLORC} (Tatmadaw) will never tolerate forming of a parallel government and pushing of Myanmar... into the flames of a civil war."]

Dec. 12-13,15: How King Maha Dhamma Yarzar crushed the Portuguese imperialists, by Myo Chit Thu. [(numbered 6-7) De Brito in Syriam in 16th century.]

Dec. 13: No right to interfere in the internal affairs of a nation (Thitsa-Myitta Discussion), by Byammahso. [Dialogue denouncing false VOA broadcasts, "the handiwork of Maung Aung, son of former prime minister U Nu," in collusion with Tin Maung Win.]

Dec. 14: For unity in the face of external interference, by An observer. [Review of Gen. Saw Maung's Dec. 10 speeches.]

Dec. 15-16: Is BBC going to waste its time spreading skyful of falsehoods?, by Bo Thanmani. [The BBC on Dec. 5 broadcast two articles by Bertil Lintner from the Far Eastern Economic Review, stating that "`Although some of the arms and ammunition and military equipment are especially suitable for fighting the insurgents in the jungles, the SLORC is equipping the Tatmadaw with modern weapons to raise the morale of the officers, non-commissioned officers and other ranks as it knows the people's displeasure with the Tatmadaw since 1988. The SLORC has bought these modern weapons with the money obtained from permitting foreign countries to explore oil deposits and from sale of petroleum.... The fact is that the SLORC is determined to fully equip the armed forces with these weapons in order to threaten the citizens and it has also made its mind up more than ever before so as not to have to give up State power.' These writings are very bad and Bertil's writing falsehoods... are of a very cheap and vulgar nature.... {His statement about not giving up power} is as horrible and disgusting as the rotten excrement one has discarded.... Patron of the War Veterans Organization General Ne Win said {30 July 1982),...`our Tatmadaw is...based on the working class and the peasantry of the masses and was founded by and with real and genuine politicians who really served the interests of the country ....'"]

Dec. 15: Ethics and law to safeguard against outside interference, by An Observer. [As stated in the Clarification of the Election Law on Mar. 1, 1989: "In a Pyithu Hluttaw which is to exercise national sovereignty of the people, persons who have connexions with foreign states and have allegiences to them and are subject to the authority of foreign governments should in no way be included. Should they be included, foreign states are most likely to interfere in one way or another. Only citizens who have allegience to the State and the people should be included in the Hluttaw {as provided for in the 1948 Constitution and the present Election Law}. "1

Dec. 16: The Successful Third Congregation of the Sangha of All Orders, by Ba Sein (Research). [Review of July 14-16,1990, meeting. A Congregation is held every five years.]

Dec. 17-18: Open letter to Japan Socialist Party leader Takako Doi for 177,000 Myanmar conscripted labourers, by Maung Myanmar. [Crimes against Myanmars on "River Kwai" railway by Japanese during World War II. No compensation was received; it all went to the British.]

Dec. 18-19: Commander Colonel Ba Htoo, a Myanmar Hero, by Soe Nyunt. [(numbered No. 8) [Bo Ba Htoo of the Burma Independence Army, the first who "took initiative and launched the resistance movements against the Japanese fascists."]

Dec. 18,22: Decapitations during the 1988 disturbances, by An Eye Witness. [Events in Mandalay recalled.]

Dec. 19: If there were no Tatmadaw, by Manizawta. [Need for

Army to prevent disorder, like a referee in sports.]

Dec. 19: Hailing the 43rd Anniversary of Independence {hereafter H-43}: Burma Independence Army, by Maung Dawna. [History of BIA.]

Dec. 19-20,22-25: Incident of 25-2-42 in which 27 Myanmar people were brutally massacred at Kyontu Village in Kayan Township by the British Army, by Bo Thanmani. [British brutalities from 1885 on; in particular the World War II killing of villagers.]

Dec. 23: U Yewata, the pivotal figure in leftist & rightist machinations, by An Observer. ["One notorious participant in the scheme of the BCP UGs was U Yewata, leader of Mandalay Sangha Samaggi Organization .... " Review of U Yewata's activities in 1989-90, including contacts with US diplomat First Secretary Martin Adam, and British Information officer Ma Nita.]

Dec. 24-25: The sinister acts of the BCP-UG--dark manifestations which augur ill for the national wellbeing, by Thura Thamein. [Recent machinations by the BCP.]

Dec. 24: H-43: Warning against enemies, internal or external, by Maung Maung Aye. [US supported activities of Chinese Nationalist KMT recalled.]

Dec. 26: An act of magnanimity, humanitarianism and leniency, by Yi Mun. [SLORC's offer to let Daw Aung San Suu Kyi leave the country is proof.] Dec. 26,30: Myanmar Hero Alaungpaya, who re-organized and

consolidated Myanmar Naing-Ngan that had disintegrated, by Tin Htwe. [(numbered 9,11) How King Alaungpaya restored Myanmar unity when "national solidarity was at its lowest ebb."]

Dec. 27-28: Safequard independence & protect the nation from foreign interference, by Saw Kyaw Aye (Pabedan). [(numbered 10) Importance of a strong Tatmadaw.]

Dec. 27: Who are refugees? (Thitsa-Myitta Discussion), by Byammahso. [Japanese Prof. Ogata, who recently visited Myanmar to study human rights, may become UN High Commissioner for Refugees. "Only if UNHCR and similar organizations differentiate between the genuine refugees and those who pose themselves as refugees, will they be able to establish peace."]

Dec. 28: Adhere to laws and rules for peace and tranquillity, by An Observer. [Review of election rules, and requirements for candidates.]

Dec. 29: H-43: History of Myanmar independence written with the blood of patriotic national groups, by Ye Nyunt. [Ethnic minorities in the struggle against the British.]

Dec. 29: To turn out good citizens and fine leaders, by Sein Kalaung. [Advice to ADNG students given by Gen. Saw Maung.]

Dec. 29: An expose of dangerous manoeuvres to wrest State power, by An Observer. ["Attempts by some leading members of the National League for Democracy to get State power" as exposed by State LORC Secretary (1) Maj-Gen. Khin Nyunt at the Press Conference.] Dec. 30: H-43: Thirty Comrades and the Anti-Fascist Resistance,

by Maung Dawna. [Story of 30 Comrades.]

Dec. 31: Naymyo Thiha Thura Bo Aung Kyaw amidst the antiimperialist struggle, by Maung Myanmar. [(numbered 12) 1938 Oil Workers movement, and the Student's Strike.] .c.:Historical Exhibition

Dec. 18: Indonesian Ambassador Maj-Gen. B.P. Makadada and wife, and other [Indonesian] diplomats, visited the exhibition. (WPD 12/20) .c.:Speech by Maj-Gen. Khin Nyunt

Dec. 1: Speaking in Pakkoku on Nov. 30, State LORC Secretary (1) Maj-Gen. Khin Nyunt said [excerpt]: "[This is] one of the two towns, Mandalay and Pakokku, which contribute most towards the propagation of Sasana.... Attempts are being made to undermine unity among the people and to upset the economy of the State through the interferences of internal traitors and those of certain big foreign countries in our internal affairs.... Political parties are to draft a Constitution, which is acceptable to all national races, through coordination among themselves.... The SLORC will take action against anybody who violates law...not because he or she is a political leader or a politician but because of his or her violation of law.... The dangers of BCP insurgents is like cancer. If it occurs it cannot be eradicated.... Just as the leftists organizations are doing things against us, the rightists organizations are threatening [Myanmar] through foreign broadcasting stations saying that [Myanmar] would be blocked economically and politically and they are making efforts so that [Myanmar] would be under their influence. There are those people who think highly of other countries and they are creating conditions which will lead to the fall of Myanmar to colonialists...." (WPD 12/2)

## .c.:Hluttaw Members Abscond

Dec. 3: One Hluttaw member "opposed the State Government and took part in forming a parallel government and was nominated to head an interim government to be formed in the jungles and while legal action was being taken against him, he absconded." He is Dr. Sein Win (Party for National Democracy-PND; Paukkhaung), who is also Chairman of the PND. [photo] (WPD 12/4)

Dec. 4: Seven Hluttaw members, five of them from the National League for Democracy, have absconded to avoid legal action against them. They "had taken part in a series of clandestine meetings held during the months of September and October this year where the formation of a parallel government in Mandalay and the formation of a temporary government in the jungles were discussed." They are: U Bo Hla Tint (NLD; Mogok-2); U Thein Oo (NLD; Mandalay SW-2); U Hla Pe (NLD; Pyawbwe-2); U Win Ko (NLD; Ye-U-2); U Mya Win (NLD; Ingapu-1); U Peter Limbin (Indep.; Pyin-Oo-Lwin-2); and Dr. San Aung (Indep.; Ingapu-2). Dec. 5: Three Hluttaw members, all from the National League for Democracy, "have been declared absconders by the Bahann Township Court as they have absconded to avoid legal action to be taken against them." They are Dr. Tint Swe (NLD; Pale-2); U Than Kywe (NLD; Shwedaung-1); and U Si Maung (NLD; Laymyethnar-1). In September and October they discussed "formation of a parallel government in Mandalay and a temporary government in the jungles." [photos, with correction 12/7] (WPD 12/6)

.c.:Speech by Maj-Gen. Myo Nyunt

Dec. 5: Maj-Gen. Myo Nyunt, Yangon Division LORC Chairman and Yangon Commander, said [excerpt]: "Imperialists are obviously attempting to subjugate Myanmar Naing-Ngan. The 43rd Anniversary Independent Day will be celebrated on an elaborate scale to propagate the will to protect and to safeguard the independence wrestled back at the cost of lives and blood." (WPD 12/6) .c.:Press Conference

Dec. 7: At a special 107th State LORC Press Conference, State LORC Secretary (1) Maj-Gen. Khin Nyunt said [excerpts]:

-- "This is a press conference held in order to make known to the people through the journalists how the insurgent organizations and political parties made their moves to seize State power."

-- The BCP tried to seize power during the 1988 disturbances by creating a "mass uprising." But Kokang nationals rebelled and captured the BCP central headquarters and northern bureau at Mong Ko on Mar. 13, 1989; Wa nationals captured the BCP central headquarters at Panghsang on Apr. 17, 1989; the No. 768 and 815 brigades, made up of Shan and Akhar nationals, revolted and drove out the BCP from their area. The BCP No. 101 unit split in Nov. 1989. Action was taken against the BCP UG's [Underground] led by Thet Khaing in July-Aug. 1989, breaking up the BCP UG's in lower Myanmar.

-- Bo Kyin Maung continued to lead the BCP, and sought to infiltrate other insurgencies under the name of People's United Democratic Front.

-- BCP UG members Tin Maung Lwin and Than Tun were caught Oct. 8, 1990 with 18,000 bahts and documents at Hninpale Railway Station. Subversive materials were seized from National League for Democracy [NLD] member U Tin Hla of Thaton. BCP UG members Ohn Than and Thet Hmu were arrested Oct. 22, 1990, acting as liaison between the BCP and ABSDF. Further details given at length.

-- Activities of U Yewata and the Sangha Samaggi Organization in Mandalay discussed at length, including ties with AFPFL General Secretary Daw Cho Cho Kyaw Nyein.

-- In Sept.-Oct. 1990, plans were made to form an NLD temporary government in Thailand beginning Oct. 15. "The NLD's holding a meeting at Gandhi Hall and demanding holding of the Pyithu Hluttaw on 15 October 1990 at the latest strangely coincided with the taking of measures to form a temporary government outside the country."

-- The Democratic Alliance of Burma (DAB) was formed Oct. 14, 1988, of 22 insurgent organizations. On Apr. 24, 1990 it formed the "National Coalition Government, Union of Burma" with Bo Mya [KNU] as President and Prime Minister, and Brang Seng (KIA) and Nai Shwe Kyin (NMSP) as Deputy Prime Ministers, and drew up a constitution. A second effort to form a parallel government was made from Nov. 11-17, 1990 at the KNU headquarters at Marneplaw, with a Provisional Government headed by KNU Bo Mya, Tin Maung Win of CRDB (who shortly resigned for family health reasons), and U Sein Mya of PDF. It entered into contact with political parties, mostly the NLD.

-- Further lengthy discussions of BCP UG activities in Mandalay, and efforts to call strikes in the oil fields.

-- U Yewata, after causing disturbances in Mandalay, made contacts with the National Politics Front Force, the Ever Green Young Men Association, and the People's Progressive Party, etc. "U Yewata led the boycott and the ceremony for offering dry rations...on 8-8-90." Lengthy discussions of U Yewata's subversive activities, including ties to NLD.

-- U Yewata met with an American diplomat. Nay Lin, leading the Basic Education Students Thamagga in Yangon, met with US Embassy First Secretary Martin Adam at the Hawaii Restaurant in Mandalay, and arranged the meeting at the Dekkhinayama Taik with U Yewata. Various other meetings of Mr. Adam with U Yewata described, including at an Embassy building on Dubern Road. U Yewata arranged meetings between Mr. Adam and NLD official U Maung Ko. "This shows how embassy officials are interfering in the internal affairs of Myanmar Naing-Ngan."

-- "Making use of members of Sangha the insurgents established contact, UG elements took a foothold and manoeuvred the movements and student organizations sought refuge in the `liberated areas.' Amidst these situations, diplomats incited unrest and gave advice for bringing about confusing situations in the internal affairs in breach of their code of conduct." [photos] (WPD 12/8)

-- "I shall continue to present... how the NLD employed various devices in its attempts to come to power. The authorities took into custody U Kyi Maung and U Chit Khaing of the NLD on 7 September 1990 on the strength of mounting evidence. When the authorities searched the NLD office and examined the documents on 23 October 1990, they found that meeting Chairman U Kyi Maung had formed at the 4/90 meeting of the NLD central body meeting committees to explore ways and means of action to be taken if the demands made in the Gandhi Hall declaration, particularly that the Hluttaw session be held during September were not met ...."

-- Three NLD groups were formed. Group (1) (the "Hardline" group) comprised U Myo Aung, U Hla Pe, U Tin Aye, U Khin Maung Tun and U Soe Nyunt. Group (2) (the "soft line" group) comprised U Tin Win, U Min Wai, U Ohn Maung (Shan), U C. Vang Ciul (Chin). Group (3) (the "principled line" group) comprised U Ohn Myaing (Mandalay), U Tin Shwe (Monywa), U Thein Dan (Mandalay), U Tin Tun Lay (Ayeyarwady), U Chit Than (Kayin), Win Hlaing, Myint Soe and Moe Zaw Oo from the Lu-nge Baho (Youth Central). There was no Group (4) because the Japanese [sic] believe it an unlucky number. Group (5) comprised U Ye Htut (Mon), Thakin Soe Myint (Yangon), and U Hla Pe (Mawlamyinegyun).

-- Four papers were prepared, by Groups 1, 2, 3, and the Youth Central people. "It was found that the paper compiled by the Youth Central contains facts aimed at opposing and attacking the Government. The papers compiled by the other groups contain ambiguous expressions which can only be interpreted as opposing the Government. Therefore, those who compiled these papers have been called in and are being interrogated."

-- The Youth Central paper "includes such ways and means as launching a general strike movement, getting service personnel take part in the strike, destroying machineries at mills and factories and other critical things, like cutting off transportation and communication links all over the country. Also included...are ways and means such as `opposing and facing up the blockades and hindrances placed by the military government,' rushing headlong if the military government opens fire, taking one's own life in protest, kidnapping the authorities and members of their families, assassinating them, hijacking aircraft and destroying buildings by mines or bombs.'"

-- The Youth Central paper called for convening a Hluttaw session on Sept. 30 or Oct. 15, either in an embassy compound or a monastery in Mandalay. The Pyithu Hluttaw meeting "was to immediately form a government" and get it recognized by organizations abroad and at home. "It assumes the nature of going along the path of violence." It also relied on aid from "the BBC, the VOA and the AIR, the Central Intelligence Agency (CIA) and some ambassadors."

-- General Staff Officer (1) Major Than Tun then read out an extended description of the Youth Central paper, describing its main purposes as: (1) a general strike; (2) violence and terrorism; and (3) the calling of a Hluttaw session to form a government and get it recognized by the "UN and...the EEC nations, the United States of America, the United Kingdom, Australia, India, Thailand, Singapore." -- Maj-Gen. Khin Nyunt continued.

"The plan which was drawn by the NLD is of great danger to the nation ...." Narrative of subversive activities by Youth Central member Myint Soe, establishing contacts with insurgents. "What I have presented shows that the youth central of the NLD is planning to use terrorist means if the transfer of power is not in a way they desired and they were planning to form a parallel government together with the insurgents and even to raise an armed insurrection."

-- Some members of the NLD objected to the NLD CEC [Central Executive Committee] Declaration 5/90 that the NLD would lead in drafting a constitution and enter into a dialogue with the SLORC, claiming that the majority of NLD Hluttaw representatives were not consulted, and that Declaration 5/90 in effect repealed the Gandhi Hall Declaration calling for a Hluttaw session in September.

-- Some NLD Hluttaw representatives from Mandalay wrote the CEC on Aug. 15 threatening to call a Hluttaw session on their own in October. A secret faction met on Sept. 29, comprising U Naing Naing (Pazundaung) [parenthetical designations are of Pyithu Hluttaw constituencies represented], U Hla Than (Cocos Is.), U Tin Maung Win (Kayan), Daw San San (Port), U Aung Khin Sint (Mingala Taungnyunt), Daw San San Win (Alon), U Kyaw Thwin (Kayan), U Mya Win (Ingapu-2), U Hla Tun (Kyimyindine), and U Maung Ko (member of Central Workers Affairs Work Committee). They decided to convene a Second Gandhi Hall conference, and sent out two groups to go to Mandalay.

-- A group comprising U Hla Tun, U Hla Than, Daw San San, and Daw San San Win went to Mandalay Sept. 27; that comprising U Kyaw Thwin, U Mya Win, Dr. San Aung, and U Tha Saing went on Sept. 29. Dr. Soe Lin (Mandalay SW) made arrangments for them to meet Sept. 29-30 at the home of U Ba Phwa (Amarapura). About 28 Hluttaw representatives agreed to oppose Declaration 5/90.

-- "While those responsible CEC members of the National League for Democracy were clarifying matters on 5/90 approved by the party, the other faction formed a separate group...and this led to making efforts to form a parallel government and to carry out activities against the Government...." Thus even in a party, some act correctly and others go against the law.

-- The faction members who met at the home of U Ba Phwa decided to try to hold a Hluttaw meeting if there were over 280 representatives, and to form an interim government in Mandalay. The Hluttaw representatives would be protected by 3-5,000 monks and students. The first and second attempt by the SLORC to arrest the new Cabinet would be resisted; "on the third time it would let the cabinet be arrested peacefully."

-- After the Amarapura meeting, a second secret meeting of Hluttaw representatives was held "in a building of a rice mill belonging to a doctor on the Mandalay-Maymyo motor coach road," attended by: U Bo Hla Tint (Mogok-2), U Win Ko (Ye-U-2), U Hla Tun (Kyimyindine), U Mya Win (Ingapu-2), and U Chit Tin (Minhla).

-- This meeting arranged to "form a government in a jungle on border area...." U Aye Ko, U Bo Hla Tint, U Mya Win, and U Chit Tin are to maintain "connections with armed forces in the jungle and internal communications." 15-20 Hluttaw representatives are to meet in jungle, and "get support from the armed forces in the jungle for the temporary government." "To form that Provisional government at the insurgent camp and to get recognition of the diplomatic community does not include taking up the three executive powers of the State at once. It was just a step to pressure the SLORC to transfer power to the remaining Hluttaw representatives in the country. And in so doing, they intended to get support from the students, workers, the public and foreign countries...."

-- "When that new government came into power U Sein Mya's group would recognize and support it. Mon insurgents headed by Nai Shwe Kyin would be loyal to NLD...."

-- "Another plan was to take refuge in a foreign embassy and form a provisional government. They planned to convene a meeting of over 250 Hluttaw representatives at a certain place." NLD Hluttaw representatives would be asked to reject Declaration 5/90. They would then join with the "allied parties which was United Nationalities League for Democracy Party."

-- U Hla Tun, relying on U Tin Maung Win and U Khin Maung Swe, was to make foreign contacts. At a clandestine meeting on Oct. 8, 1990, he clarified the details with U Maung Ko, who was to go to the jungle to form the parallel government.

-- However, before they could act "the Tatmadaw systematically dealt with the strike of the Mandalay Lay-byin-lay-yet Sangha Samaggi" and frustrated their plans. "U Maung Ko...became an informer and revealed his plans, the plan to form a parallel government and plan to go underground. Only after revealing these, he could not control himself and committed suicide.

-- "These are the attempts of the National League for Democracy to establish a government in the name of a provisional government, a government in exile or a government in the jungles without fail.... Acts within the NLD, therefore, posed a grave danger to the nation. So, we knew their schemes in time and took action, called them in and interrogated them but foreign radio stations are often spreading falsehoods that the SLORC Government is indiscriminately taking action and arresting NLD personnel...."

-- "Are we not bringing about a change from the old one-party system and socialist democratic practices to a multi-party system and democratic practices? At the this juncture, the Tatmadaw is laying down protects [sic] and implementing them in order that a smooth transformation might be brought about...."

-- "Veteran politicians began wishing a return to multi-party system in 1983. I would like to recall discussions...based on a

letter of U Aung Kyi dated 6 January 1983 sent to Lanzin Party Chairman U Ne Win and documents obtained from U Htwe Myint. It was at U Nu's house on 1 January 1983. Veteran politicians U Kyaw Nyein, Bo Khin Maung Gale, U Aung Gyi and U Htwe Myint...and U Nu was reported to have said that Chairman U Ne Win was a man of two different minds. The first, he said, was that he had no fear if there was something to do; he just went ahead and did it. The second, he said, was sympathy towards others...and so it was believed U Ne Win would hold a free and fair elections.... U Nu is said to have called for preparations (for the election).... U Kyaw Nyein was unanimous chosen leader.... Daw Cho Cho Kyaw Nyein, daughter of U Kyaw Nyein, visited the [historical exhibition] on the very first day. She is said to have remarked after viewing the documents displayed that her father had spoken of the facts and that points mentioned were correct...."

-- When demonstrations broke out in 1988, Daw Aung San Suu Kyi came back to visit her mother and "was dragged into the political arena" by none other than U Htwe Myint, himself "once an expatriate." Afterwards, U Htwe Myint switched to the Democracy Party. "We have ample proof of the letters signed by U Htwe Myint and Daw Aung San Suu Kyi and sent...."

-- Review of 1988 events. "Illegal students organizations were fromed through the help of U Ye Htoon and steps were taken to enable U Sein Mya to flee to the jungle...with the aid of one of the embassies...the embassy of India.... Second Secretary Mr Keith E. Riggin from American Embassy...put letters in his diplomatic pouch for communictions with U Ye Htoon and insurgents' groups in Thailand...."

-- "I have clarified the activities of some Hluttaw representatives who...wanted to gain power within a short period as well as the attempts made by the National League for Democracy to gain power through formation of a parallel government or an underground government. Exploiting these situations, insurgents groups ÄÄKNU, DAB, ABSDF and NMSP whose days are numbered, and PDF, which is led by U Sein Mya and is supported by an organization, made attempts to get arms and ammunition...putting democracy in the forefront and using of students on the border areas, political party members and some Hluttaw representatives as pretext ....

-- "At the meeting of...DAB held in July 1990, leader of ABSDF insurgent group Moe Thee Zun...." hoped to get foreign aid. "Moe Thee Zun is a leftist trained by the BCP...." (WPD 12/9)

.c.:Speeches by Gen. Saw Maung

Excerpts from speeches  $\bar{\rm by}$  State LORC Chairman Senior General Saw Maung:

Dec. 10: At Kungyangonn [excerpts]: "I will speak on matters which ought to be told.... If you speak about [a] good person, don't speak about that person by mentioning his name, as it would amount to flattery and similarly, if we speak about a bad person by mentioning his name it would amount to downgrading him.... Lord Buddha preached not to praise or to degrade...." (WPD 12/11) [There were 1,393 kings in 11 Pyu Dynasties.] "Calculated,

[There were 1,393 kings in 11 Pyu Dynasties.] "Calculated, there were over 25,000 years of reign in the history of Myanmar based on the average of over 18 each... What I mean is that we have really had a long history... There is no other country like ours in the world. Westerners of developed nations also feel that there is no country like this any more in the world. So I am telling you with cetana that we should preserve our traditions. There are many countries in the world but there is no longer a country like Myanmar Naing-Ngan which preserves its traditions and culture ...."

[Expulsions and derobing of monks in ancient Buddhist Synods. Purifications of the Sangha by early Myanmar kings. Resistance against the British. Various religious and historical books discussed.]

[Debt of K 356 million Myanmar had to pay to Britain after independence to pay for the World War II Burmese Government in exile in India. Long discussion of Myanmar debts to Britain. Myanmar's debt to Britain was 1,280,448 pounds for 1942-43; 3,447,592 for 1943-44; 1,291,980 for 1944-45; and 1,235,455 for Apr.-Sept. 1945; for a total of 7,255,475 pounds sterling.] "We had to repay all that to the British.... Then the British reoccupied the country...and how much was charged during Civil Administration?... In 45-46 it was 8,361,065; in 46-47...it was 27,195,625 pounds...those two would add up to about 35,556,690 pounds .... How much debt did they make us repay? It was 42,812,165.... We had to repay 1,100,000...then under Nu-Attlee Agreement...they said 15 million was written off...what remained to be paid was 26,712,165 pounds... it was the debt that came along with independence.... The simple fact is that we did not get our independence for free."

[Lengthy discussion of insurgencies, negotiations with insurgents, and other historical matters.]

[Lengthy discussion of 1948 Citizenship law and regulations.] "There is only one called citizen of the Union of Myanmar. The one who lives in this country is a citizen. We should understand it well...."

[Pensions still being paid to 7,000 British army veterans.] (WPD 12/12)

Dec. 10: At Lethhokkon village, Mokkyun region [excerpts]: "When there is disunity in our country, foreign nations want to interfere in our internal affairs.... In order to bring about development, everybody must work.... The most important thing is for everybody to know his or her respective work. What duty do I have...? I have the duty to defend...the nation...by suppressing and crushing the internal insurgents, the external insurgents and those who are out to cause the disintegration of the nation...." [Duties of Army, Navy, Airforce, Intelligence Services, Police discussed.]

"What must be there in a village to keep it peaceful and tranquil... One is the law.... There are sections such as High Treason, Sedition ...Abetment.... One must know the laws which one has to abide by...." [Myanmar different from other countries. No cold weather; plenty of food. Customs, like offering hospitality to strangers, respecting elders, maintaining family ties through generations] "Their culture has not been for long. The history of America is known to be just over 200 years. Our history and our culture are known to have existed for tens of thousands of years...."

"We cannot let our country become a slavedom.... We cannot bear to be down-graded and ridiculed.... What I mean to say is we are quite different from them.... "We have a covenant. If one takes over the reins of state power

"We have a covenant. If one takes over the reins of state power then, there must be a covenant... [In 1962] Bogyoke Tommy Clift was Vice-Chief of Staff (Air) [and] a member of the Revolutionary Council. But Bogyoke Tommy Clift was married to a woman from England. Since the one he married was from England and since there was the covenant...[he] on his own volition resigned from the Revolutionary Council...

"I think there is no problem here today. In Yangon and other places, this girl's [Daw Aung San Suu Kyi--HCMacD] problem is the same. This is a covenant. There can never be a case of the leaking out of State secrets. If we look at this girl in terms of law she cannot be come a State leader on the one hand according to the covenant....

[Myanmar rich in rubies and jade.] "Ours is not a country that can starve. Why shall we be poor because others say so?..."

[Discussion of the Thirty Comrades; of splits in the AFPFL; of different slogans; of periodic nature of modern Myanmar history; of change.] (WPD 12/11)

.c.:Speech by Gen. Than Shwe

Dec. 10: Addressing students from the Academy for the Development of National Groups (ADNG), who have been touring Yangon, SLORC Vice Chairman Gen. Than Shwe, Chairman of the Central Committee for Development of Border Areas and National Races reviewed at length the suppression of BCP insurgents and Government development activities. He called on cooperation from the border area peoples. "As long as there is insurgency and as long as there are people who have the mentality to carry out destructive activities nothing can be done for development of the area. So you must tell the future generations and make them realize that if they want their region, country and race to develop and prosper they must get rid of insurgency." (WPD 12/11)

.c.:Re Daw Aung San Suu Kyi

Dec. 19: Press Release from Ministry of Foreign Affairs [text]: "The morning 0630 hours VOA Myanmar language broadcast and the 0640 BBC Myanmar language broadcast of today, 19 December 1990 carried reports that on humanitarian grounds, the United Nations Secretary-General has requested the release of Daw Aung San Suu Kyi, against whom action has been taken according to the laws of Myanmar, from the restrictions placed upon her.

"As the case of people who have had action taken against them is considered solely from the viewpoint of the existing laws of Myanmar, the Leader of the Myanmar Delegation U Ohn Gyaw informed the Secretary-General about the developments in Myanmar during the meeting with the latter at his office in New York at 1530 hours on 11 October 1990. In the course of the discussion, the Secretary-General inquired about the case of Daw Aung San Suu Kyi, and U Ohn Gyaw replied that action was taken against her because of her violation of existing laws, and not because of her political convictions; and that the restraining order is the most lenient legal measure possible. He further added that if there were individuals or Governments who had written to the Secretary-General on the matter and who had expressed their desire for leniency to be applied on humanitarian reasons, the Leader of the Myanmar Delegation would like to apprise the Secretary-General of the fact that during the visit of the Member of the Japanese House of Councillors Mr Michio Watanabe to Myanmar at the end of July and the beginning of August 1990, the Chairman of the State Law and Order Restoration Council Senior General Saw Maung, in response to Mr Watanabe's mentioning of the case of Fang Lizhi while he visited China, commented that should Daw Aung San Suu Kyi wish to stay together with her husband and children, she would be allowed to

leave Myanmar Naing-Ngan on humanitarian grounds.

"It is our belief that the Secretary-General would convey the views of the Myanmar Government to the people who have expressed concern on the matter. This Press Release, giving the true facts of the situation, has to be issued since two foreign broadcasts of this morning carried news reports presenting their own viewpoints. What the Leader of the Myanmar Delegation informed the Secretary-General remains valid today.

"Moreover, as Article 100 paragraph (1) of Chapter 15 of the United Nations Charter provides that the Secretary-General and the staff shall not seek or receive instructions from any Government or from any other authority external to the Organization, we are confident that the Secretary-General will not be receptive to pressure from any Government or organization.

"It should also be mentioned that the Prime Minister of Myanmar Naing-Ngan on 31st July 1990 and the Myanmar Permanent Representative to the United Nations on 25th May 1990 had written letters to the Secretary-General on the matter."

(3) friendship among and between the national races

(4) preservation and upholding of national culture

(5) promotion and uplifting of moral character and personal integrity

(6) elimination of crimes

(7) to keep films free from scenes of brutality and cruelty

(8) to keep films free from sexual provocation

(9) to keep films free of indecent scenes

(10) the children's affairs...

"The rules prescribed include do's and don'ts in connection with the foreign policy of the Government of the Union of Myanmar, sovereignty, the rule of law and peace and tranquillity, nondisintegration of the Union, preserving and safeguarding such fine traditions of the Union of Myanmar's national races' living together in unity and friendship, with respect and love for one another and helping one another and matters relating to the national races' customs, traditions, cultures, languages, literatures, their modes of dress."

Film costs have increased, and admission fees have been raised, so "those who screen films are earning more." The entertainment tax has been reduced from 40% to 30%. Myanmar films are similar in many ways to those made in other countries. However, "the film artistes taking part in it speak Myanmar. The main backgrounds of a film are also created with Myanmar land, Myanmar natural scenes, Myanmar thoughts and Myanmar customs and habits.... Generally speaking, a Myanmar film is like a pot of tasty curries all mixed together. If it is artistic, it is enjoyed to the full just as that pot of curries is enjoyed...."
