State Counsellor stresses peace efforts, pledges nationwide electrification

State Counsellor Daw Aung San Suu Kyi told villagers in central Myanmar yesterday that peace and power supply efforts must be priorities of the country.

At a peace talk with the villagers of Myay Taing Kan Village, Wundwin Township,

Mandalay Region, she said "I came here to talk about peace and power supply."

"The reason I chose this village is because this village just recently got electricity and I wanted to know how it has affected the people here since it is a high priority that

the entire nation receives adequate electricity. Equally important is peace," she added.

"Because of the conflicts between ethnic races in the past there is no trust or compassion with each other and there is no peace yet," she said.

"If there is no peace in the country then it doesn't matter if we are doing well in other areas, we cannot say that the country is doing well. I want to discuss this in these areas where there is no evident peace.



2nd Pyithu Hluttaw 5th regular session 40th day meeting

Second Pyithu Hluttaw 5th regular session 40th day meeting was held yesterday at Pyithu Hluttaw meeting hall.

At the meeting Dr Daw Kyi Mo Mo Lwin of Singaing constituency asked about plan to open a station hospital in Shwe Hlan Bo (Kan Auk) Village, Singaing Township and Union Minister for Health and Sports Dr Myint Htwe said Singaing Township had a population of more than 150,000 and has a 50-bed hospital, an eye hospital and Paleik station hospital. Shwe Hlan Bo Village is a village that had a little more than one hundred households and is only 16 miles away from Singaing Hospital.

There are six norms set for allowing a station hospital and Shwe Hlan Bo (Kan Auk) village meets only two and furthermore the allocation for station hospital has already been used and there is no plan to open a station hospital there, said the Union Minister.

Responding to a question by U Myint Thein of Wetlet constituency on upgrading 25

bed Wetlet Hospital to 50 bed, Union Minister for Health and Sports Dr Myint Htwe said arrangements are being made with Ministry of Planning and Finance to use the ordinary fund from FY 2017-2018 for the upgrading. Once permission is granted additional funds required for building, machineries and equipment will be allocated from the FY 2018-2019 budget said the Union Minister.

A question from Einme constituency on action to be taken against a company not conducting national project works under the Union budget in accordance with the guaran-

tees made in the agreement, rules, regulation and norms was then replied by Union Minister Dr Myint Htwe.

A 3-member investigation team was formed to conduct an investigation on this matter and based on the preliminary report of the team and report by the Region Health Department head, the station hospital has been transferred to station hospital management committee after coordination between the management committee and company project engineering and the hospital is now in operation. An audit is being conducted on Top Creative Asia

Co., Ltd that constructed the hospital and based on the audit report, actions will be taken according to procedure said the Union Minister.

Responding to the questions Union Minister for Information Dr Pe Myint said libraries are knowledge banks where generations of experiences and knowledge were stored. Anything you want to know can be found in the library books. In the world, the most developed and advanced nations are nations where there are the most readers. In the past states, regions, districts and townships offices of Information and Public Relations Department, Ministry of Information had few visitors but now, arrangements are made to turn the offices into places where people come together and meet, community centres and libraries as per the requirement of the people. As an early example, community centres were being setup in Insein, Myaungmya, Natmouk and Pyinmana together with Daw Khin Kyi Foundation.

Furthermore mobile libraries were set up with library cars. Office buildings were used for

trainings, meetings, talks and gatherings while necessary items were also put in place. Last month a community centre in Myitkyina was opened where building and other work programmes are more adequate and sufficient.

These centres will support increasing knowledge of the people, raise interest of the local people on local and the country's affairs and increased participation of the people's desire in democracy political process.

Depending on finance available from the nation and cooperation of other organisations, community based centres are planned to be set up by financial years. Currently, offices and libraries under Information and Public Relations Department are being transformed to be turned into community centres where people can meet.

However, today's discussion on implementing library development as a national movement is too wide in scope and thus the motion should just be kept on record, explained the Union Minister.

The Hluttaw then decided to put on record the motion. ■

US\$1.3 million in trade at Maungtaw border in July

BORDER trade values at the Maungtaw border in Rakhine State was estimated at US\$ 1.3 million in July, according to the Maungtaw Township Trade Department.

The trade projection for July was \$350,000, with \$300,000 in exports and \$50,000 in imports, said U Tun Kyaw, staff officer of Maungtaw Township Trade Department.

The main export items at Maungtaw gate are ginger, rice, garlic, mushrooms, saltwater prawn and dried fish.

Other exports include soap, candy, plum jam, footwear, and ointment.— A One Soe, Myo Thu Hein ■

Myanmar man arrested over stabbing of ex-girlfriend near Tokyo Station

A 28-year-old man was arrested Monday on suspicion of attempted murder after stabbing his 26-year-old former girlfriend on a street in the Otemachi business district near JR Tokyo Station.

Both the victim, who temporarily fell unconscious, and the suspect, Nyein Chang Aung, are students from Myanmar; the Metropolitan Police Department

said, adding the man has admitted to the charge.

The police arrested Nyein at the scene, alleging he stabbed the woman in the back with a knife at around 6:45 a.m.

The victim and the suspect became acquainted in June 2012 in Myanmar and broke up in April last year, the police said.

The victim consulted with

the police on 14 January, saying the suspect was waiting for her in front of her home and posting slanderous messages about her current boyfriend on Facebook. At her request, the police warned Nyein the same day to cease such behavior and he said he would desist, according to the police.

A 53-year-old man, who

passed the scene of the incident on his way to work, said, "A woman was lying limp in a pool of blood...A man was holding her while another woman was talking on the phone in a panic," he said.

The suspect was doing a part-time cleaning job at a building near the scene, the police said.—Kyodo News ■

Traditional retailers in Yangon urged to use card payment system

U Myo Min Aung, vice-chairman of Myanmar Retailers Association, said it is now working to implement card payment system in Yangon's retail market, urging traditional retailers to use card payment system instead of paying with cash.

He said; "The move is aimed at solving a shortage of small banknotes. In the retail market, both buyers and sellers are facing scarcity of small banknotes, with the result that the prices of goods increase a bit from its regular selling prices. It is also aimed at controlling the commodity price to a certain degree. For the time being, awareness raising programmes have been made by

the association in cooperation with Ayeyawady Bank in retail stores. A good internet connection and banking networks are required to successfully install a card payment system at retail shops. It needs to take a time to implement the plan. We are working to implement the plan as quickly as possible."

In the first phase, the association is introducing the card payment system at traditional retail stores in commercial city Yangon, encouraging them to use this system. It is planning to implement the plan in other regions and states through our syndicates in the future.

U Myo Min Aung said; "We invite retailers to come to seminars to understand the benefits of this payment system, which

will be needed at the time when international companies enter the country. Awareness raising campaigns have always been made every two months, resulting that some retailers show their interest in the system."

He continued to say that in making payment by card system, the aim for all different kinds of cards currently used in the country are able to use the system with an appropriate machines. Banks are ready to sell necessary equipment as well as methods of using the system. The association will perform as a bridge between retailers and bankers.

U Myo Min Aung said that he hopes that this payment system is likely to be used not only in retail market but in related

businesses in the future.

He went on to say that proposal relating to the use of card payment system in retail market have already been submitted to the government. Currently, some supermarkets started using the system, only 4 % of the total retailers. According to a survey conducted in 2015, the country has about 350,000 traditional retail stores.

To educate people about the use of card payment system in retail market, a seminar entitled "Towards Retail Stores Excellence" is planned to take place at the upcoming Myanmar Retail Sourcing Expo 2017 to be held at Yangon's Tatmadaw Exhibition Hall on 18 August. ■

MIC issues seven investment permits, 17 endorsements related with investment proposals

The Myanmar Investment Commission yesterday issued seven investment permits and 17 endorsements in relation to the investment proposals it had received and the amount of investment permitted was USD67.192 million and MMK409,348.47 million. The announcement came

after the 11/2017 meeting of the MIC in Yangon which reviewed investment proposals consistent with the Myanmar Investment Law.

U Kyaw Win, Chairman of MIC and Union Minister for Planning and Finance, Dr Than Myint, Vice Chairman of MIC and Union Minister

for Commerce, U Tun Tun Oo Union Attorney General and all members of MIC attended the meeting. The submission of permit proposals and endorsement applications from investors and post-permit activities of MIC-permitted companies were discussed in the meeting.—GNLM ■

Cotton and sugar production requires value-added processes, investment

MYANMAR'S cotton industry lacks enough state-of-the-art cultivation techniques and processing capacity to create value-added products, leading to an undue reliance on imports of finished goods, according to U Aung Soe, the director-general of Trade Promotion Organisation at cotton, sugarcane, sugar export promotion workshop held on 4 August in Chanayethazan Township, Mandalay.

As of 21 July this financial year, more than 487 metric tons of cotton worth US\$1.07 million were exported to China. However, more than \$15 million worth cotton products including cotton thread were imported into Myanmar. This is why value-added cotton products

are required for local needs, Director-General U Aung Soe said.

The government is encouraging the businesses to change from traditional to industrial activities. Cotton and sugar are prime examples of Myanmar's overreliance on extractive activities in lieu of processing capacity. Encouraging to produce finished goods rather than producing raw will enable Myanmar's industries to achieve higher export levels.

This workshop focused on cotton and sugarcane growers' and provided information on cultivation, access to capital and an overview of local investment laws.

The director general also

described the critical role of transportation. Mandalay Region is the main junction of highway roads, he said, and traders should take advantage of its location to ship goods to India and China.

There are about 73,000 acres of cotton farms across Myanmar with a production of 500,000 tons. Mandalay Region produces most of Myanmar's cotton crop.

In addition, 59,600 acres of sugarcane, out of a total of 737,900 acres, are grown in Mandalay. There are five sugar mills in Mandalay which can crush more than 1,000 tons of sugarcane daily. —Min Htet Aung (Mann Sub-printing house) ■

Sugar prices drop to Ks680,000 a ton due to re-export restrictions

CHINESE restrictions on Myanmar sugar re-exports has led to a domestic surplus and to prices dropping by Ks50,000 per ton, according to a story yesterday in Myanma Alin newspaper.

Until recently Myanmar's merchants imported sugar from Brazil, Qatar, UAE and India and then re-export to China through Muse checkpoint for margin profits. Now Chinese authorities confiscate re-exported sugar at Muse gate as China considers this trade as illegitimate. Additionally, the Myanmar Commerce Ministry no longer grants re-export licences for sugar. As a result, 100,000 tons of sugar are stockpiled in Myanmar.

Sugar prices have been de-

clining since Thingyan. Sugar was Ks730,000 per ton in May compared to Ks680,000 in August, said U Sein Tun, the secretary of Sugar and Sugarcane Producers Association.

About 2 million tons of re-exported sugar had been traded annually before new restrictions were imposed. Currently, about 100,000 tons of sugar have been imported this year under the re-export system but only small volume of it were exported. While sugar traders are suffering losses, the policy may have the effect of spurring more domestic sugar production and growth to make up for re-export shortfalls.—Phyo Lwin Aung (AMIA) ■

State Counsellor visits recently electrified village

State Counsellor Daw Aung San Suu Kyi visited Myay Taing Kan Village, Wundwin Township, Meiktila District, Mandalay Region, yesterday and talked with villagers about the area's socio-economic development.

Myay Taing Kan Village was chosen for the visit because it lies nearly at the geographical center of Myanmar. The village is home to 281 households and a population of 1,242, most of whom earn their living on farming and weaving. Paddy, cotton and pulses are the area's main crops. The electric grid was extended to the village, for the first time, in March. Prior to electrification, the village had to spend Ks150,000 for diesel oil each month to support a light weaving industry. With electrification energy costs are only one-third of that cost, increasing the income of villagers.

The State Counsellor inspected the transformer which distributes electricity to the village and Chief Engineer U Soe Min Tun briefed her about the

system. Afterwards, the State Counsellor had a round of Peace Talks with the villagers of Myay Taing Kan village.

She also viewed light-industry weaving sheds operated by

electricity. In the afternoon, the State Counsellor arrived at the Sihar Yama monastery in the village, donating offertories to Sayadaw U Kosalla and Sayadaw U San Vara Sarmi. Of Myanmar's

10.87 million households, 3.7 million had access to electricity in 2016. By June 2017 4.19 million households are electrified. Of 63,859 villages nationwide, 31,804 villages had been supplied elec-

tricity as of May 2017.

The National Electrification Project is being implemented with a World Bank loan of US \$300 million. Other funding sources include the national budget, local budgets and international loans and financial assistance.

In the first phase, 5,080 villages, home to approximately 630,000 families, located no more than two miles away from existing power grid lines will be prioritized for electrification. The second phase will provide electricity to 7.5 million people.

A German government loan has electrified 416 villages in Taunggyi, Loilem and Linkhe districts in Southern Shan State.

In all, 1,484 villages across Myanmar are to be electrified in FY2017-2018.

I want to know what kind of thoughts, if any, a village like this has on peace especially a village far away from conflict areas. Have you ever considered it?" said the State Counsellor.

"I understand that this village was linked with electricity in March this year, so it has been four months now. Has there been any significant changes with your village, with your family or individually? I want to know the differences in situation before and after you got electricity," she said.

She told the villagers that electricity is as crucial as peace, expressing the goal of the government to supply power to the entire country by 2030.

Currently, only 38.5 per cent of the country has got access to electricity.

"There's 13 years to go to achieve our goal. But, we will try to make it faster as we go along," she said.

"We cannot neglect the problems of a small village as insignificant because by considering the problems of a small village we can find similar possible solutions to the problems

of the entire nation," she added.

"I was informed of an interesting fact about this village on my way here. Apparently the young people don't leave this village to find job opportunities somewhere else. This may seem normal here but many villages across the country have no young people in them anymore. Many of them say they leave their villages to find better business opportunities but it hurts the economy of their village. Also from a social standpoint it hurts their family and by leaving their village," she said.

He added, "Because of the acquisition of electricity in our village, villagers have had an access to run light industries such as weaving machines and

its related works. Previously, they had to work for other businessmen in Wundwin Township as daily wagers and laborers. Now that they can work at the village, they can make more money. With the better economy, children's education will develop for sure."

I want my daughter to be an educated person, but she did not fulfill my wish. I intend to have her taught how to sew. Regarding Peace, I know nothing.

I bought a truck under the two-year hire purchase contract, paying K 4-5 million every six months. Yet, during six months I disconnected with the company as my business is not related with it, finding it difficult to run my transport business as my car was running to and fro nearby the village. In actuality, it is impossible to pay K 4-5 million in a period of six months. 30% interest rate is too much, in my opinion. So, I want the contract due period to be extended.

Death toll from H1N1 reaches 16

The Ministry of Health and Sports announced yesterday that 22 people received medical examinations between 6 and 7 August and 8 cases were confirmed to have the H1N1 virus. This brings the total number of H1N1 cases since 21 July to 154 and a total death toll of 16

people. The nationwide death toll has reached 4.5 per cent said the Ministry of Health and Sports.

The ministry said 19 patients at Wabargi Specialist Hospital and 34 patients in hospitals in various regions and states are receiving treatment for confirmed cases of

H1N1. The majority of patients are doing well and the number of patients coming to hospitals to receive treatment for respiratory infections has dropped a bit. So far, there is no infection to health staff or officials who are treating with the H1N1 patients.

The ministry urged in its report for the elderly, children, pregnant women, people with chronic illnesses and low immune systems to follow the ministry's guidelines to protect against the seasonal influenza.—Myanmar News Agency ■

ASEAN's golden jubilee

ASEAN was formed on 8 August 1967 through the Bangkok Declaration. It originally had five members - Indonesia, Malaysia, Philippines, Singapore, and Thailand - and has since expanded to include Brunei, Cambodia, Laos, Myanmar, and Viet Nam. Therefore, ASEAN is going to celebrate its 50th Anniversary this year.

Brunei Darussalam joined on 8 January 1984, Viet Nam on 28 July 1995, Laos and Myanmar on 23 July 1997, and Cambodia on 30 April 1999.

The ASEAN Declaration states that the founding of the ASEAN is aimed at accelerating the economic growth, social progress and cultural development in the region through joint endeavors in the spirit of equality and partnership in order

to strengthen the foundation for a prosperous and peaceful community of Southeast Asian nations.

At the 27th ASEAN summit in Kuala Lumpur on 22 November 2015, ASEAN leaders adopted the ASEAN Economic Community (AEC) 2025 blueprint in their goal for economic integration. The AEC aims to (1) Facilitate the movements of goods, services, investments, capital and skills of the region (2) Increase trade (goods and services) and investment among Member States (3) Promote and expand regional production sharing and networks and (4) Promote a higher level of transparency and predictability.

On 28 January 1992 in Singapore, the then six-members of ASEAN signed the ASEAN Free Trade Area (AFTA) agreement to support

local manufacturing in all ASEAN countries. Before that, ASEAN was involved in economic cooperation with Japan from 1985 and the ASEAN Plus Three (APT) was held with Japan, Republic of Korea and China in 1996 and 1997 to promote East Asian regional co-operation.

In 2005, the East Asia Summit (EAS) was held with 10 ASEAN member countries and Japan, Republic of Korea, China, India, Australia and New Zealand. Russia joined the EAS in 2011 and the AEC was firmly established in 2015.

In the beginning, the five members of ASEAN had an individual income of USD 122 in 1967, depending on the GDP of each country. In 2016 it grew to USD 4760. ASEAN GDP reached USD2.2 trillion taking 3 per cent of the global market.

ASEAN had no internet connections in 1990 but currently 34.2 per cent of ASEAN has internet connectivity. Only 61.9 per cent of ASEAN had electric supply but in 2014, 91.6 per cent of ASEAN had electricity. The number of mobile users in ASEAN was 1.1 per cent in 1990 and it reached 126.6 per cent in 2015. Foreign investment was at USD 22.1 billion in 2001 and it has grown to USD 130 billion in 2015. Expenditure on defence service was at USD 4.4 billion in 1970 and has grown to USD 37.8 billion in 2016.

The main concern throughout ASEAN right now is the spread of Islamic extremists. ASEAN has some way to go to catch up to the five superpower countries and Myanmar need to try harder for economic development. (Translated by GNLM) ■

Global Overview and Myanmar Democratic Transition

MYANMAR transition since 2010 is praised as “Myanmar spring” by the international media due to its smooth democratization process. The 2015 post election of Myanmar is again praised by the international community for two factors: one is free and fair election which is one of the core values of democracy and another is peaceful transfer of power from semi-civilian government to elected civilian government. Myanmar democratic transition is now on her way and democratic consolidation is necessary for the completed transition. In the global agenda, the past two decades have witnessed the most remarkable development toward democracy, which has been refereed to as third wave of democratization. Since then, democracy replaced the military or “quasi-civilian” regimes. It is an opportunity for Myanmar today to learn from the global trends of democratic transition.

In the last quarter of the twentieth century, trends in seven different regions converged to change the political landscape of the world: the fall of right-wing authoritarian regimes in Southern Europe in the mid 1970s, the replacement of military dictatorship by elected civilian governments across Latin American from late 1970s to late 1980s, the decline of authoritarian rule in parts of East and South Asia starting in the mid 1980s, the collapse of the communist regime in Eastern Europe at the end of the 1990s, the breakup of the Soviet Union and the establishment

of the post-Soviet republics in 1991, the decline of one-party regimes in many parts of sub-Saharan Africa in the first half of the 1990s and a weak but recognize liberalizing trend in some Middle East countries in the 1990s. Despite these regional democratic trends, some countries continue to be beset by unstable parliamentary institutions, weak rule of law, inchoate systems of political representation, chronic corruption, bureaucratic inefficiency, and a lack of social justice.

According to Human Rights Watch data in 2006, more than hundred countries (121) in the world are democracy and among them, 78 are liberal democracy and the rest can be labeled as electoral democracy. Though Myanmar is yet to be a liberal democracy (long way with challenges to reach there), Myanmar can be listed in electoral democracy. In spite of the political development, asserting civilian control of the armed forces remains high on the political agenda in many emerging democracies.

The book on “*Problems of Democratic Transition and Consolidation*” written by Professor Juan J. Linz (Yale University) and Professor Alfred Stepan (the first rector and president of the Central European University) is a magisterial book that represents to understand democratic broke down, transition and consolidation. The authors highlighted the five areas that are necessary for the consolidation democracy—civil society, political society, rule of law, state bureaucracy and economic society. The book aspires to cover 15

contemporary countries stretching across three areas: Southern Europe, South America and Post Communist Europe. The book is contributive for all the democratic countries that are on their way to completed transition and to consolidation.

This article would like to borrow the above-mentioned five areas as a case study on Myanmar. First let us look the civil society. The **civil society** can include manifold social movements such as women's groups, religious groupings and intellectual organizations and civic associations from all social strata such as trade unions, entrepreneurial groups, journalists or lawyers. In case of Myanmar, all these groups have been freely formed since

transition and are allowed to have free movement and free assembly if their activities do not damage the internal security. Myanmar has given more space for the civil society under this government and the fruitful contribution of civil society can be seen in Myanmar's general election and peace making process.

The second condition for the consolidated democracy is the role of **political society**. It is to contest the legitimate right to exercise control over public power. A full democratic transition and democratic consolidation must involve political society. Myanmar already has the institutions of democratic political society- political parties, elections, electoral rules, political leadership and legislature. However, to be efficient and effective, these institutions still need to work hard.

To achieve a consolidated democracy, the necessary degree of autonomy and independence of civil and political society must further be embedded in and supported by the **rule of law**. Modern democracy needs the effective capacity to command, regulate and extract. For this, Myanmar needs a functioning state and a state bureaucracy considered usable by the new democratic government. As the rule of law is weak, Myanmar requires an independent judicial system and supported by a strong legal culture in civil society. Myanmar can also learn from the Indonesian model of reforms such as Ministry of Home Affairs, transferred from military to the civilian control.

Pyithit Test Well-1 of Offshore Block A6 finds gas

Myanmar energy officials celebrated the discovery of natural gas at the Pyithit Test Well-1 of Offshore Block A6 yesterday in Nay Pyi Taw at the Ministry of Electricity and Energy. The find will be exploited by MPRL E&P Pte. Ltd., TOTAL E&P Myanmar and Woodside Energy which are engaged in a production sharing contract with Myanmar Oil & Gas Enterprise. Drilling of the Pyithit test well started at 10 June, reaching a target depth 4570 meter (14993ft). According to wireline logging data during the drilling, a gas-bearing 35-meter-thick sand bedding was detected at a depth of 3542 meters. A production test was carried out and determined that 50 million cubic feet of gas can be produced per day. Another test well at Pyi Tharyar will be

drilled in the western side of A(6) Block with deep water drilling ship Dhirubhai in August.

Under the joint venture partnership, MPRL E&P invested 20%, Woodside Energy Pte. Ltd. of Australia 40% and TOTAL E&P Myanmar 40%. Yesterday's ceremony

was attended by Union Minister for the Office of the State Counsellor U Kyaw Tint Swe, Deputy Minister for Planning and Finance U Maung Maung Win and department Heads and local and foreign media.—Myanmar News Agency

Investments of US\$1.7 billion flowed into Thilawa SEZ since establishment

THILAWA Special Economic Zone (SEZ) has generated a total of US\$1.7 billion in investments since its establishment in September 2015, according to a report of yesterday's edition of Myawady Daily.

Manufacturing sectors have absorbed investments worth \$770 million at the SEZ. Export/import sector attracted more than \$120 million in investments. Over \$70 million investments flowed

into transportation sector while service sector stimulated investments of \$50 million. More than \$30 million investments went to real estate and the hotel sector attracted \$12 million in investments. Of 2,400 hectares of land in Thilawa SEZ, development of 400 hectares have been developed. Zone B is being developed on 101 hectares of land and will be completed in mid-2018. A total of 84 companies invested at Thilawa

SEZ, 79 companies in Zone A and five companies in Zone B. Those companies are engaged in production of construction materials, auto parts, electrical appliances, farming materials.

Myanmar is currently implementing three Special Economic Zones—Thilawa, Kyaukpyu and Dawei. Of the three, Thilawa has the most advanced infrastructure and the strongest economic base.—Ko Htet ■

With regard to **state bureaucracy**, modern democracy needs the effective capacity to command, regulate and extract. For this, it needs a functioning state and a state bureaucracy considered usable by the new democratic government. The final supportive for a consolidation of democracy concerns the economic society that mediates between state and market. Market requires corporation laws, the regulation of stock market, and protection of property both public and private. Democrat-

ic consolidation requires the institutionalization of a socially and politically regulated market. This requires an economic society, which in turn requires an effective state.

Besides these five areas, civil-military relations is an important area for the consolidation of democracy. There are several theories of civil-military relations. The general understanding of civil-military relations is the civilian control over military in five decision-making areas: elite recruitment, public policy, military organization, internal security and national

defense. Whatever the theories are, the best-suited paradigm for Myanmar in this current situation is the civil-military partnership (CMP), which means neither military control over civilian nor civilian control over military in security related sectors. The possible way to construct the CMP in Myanmar is both civilian and military can cooperate in the needs of non-traditional security areas such as economic security, environmental security, health security, maritime security, etc.

The Ministry of Information will host international fo-

rum on “Myanmar Democratic Transition” in Nay Pyi Taw this week. Several distinguished speakers and experts in this field from both local and international will participate and exchange their view on Myanmar democratic transition. The forum will be conducted with interesting sessions such as -political transition from military to civilian, economic transition from central command to market economy, the transition from war to peace and the role of media in transition etc. It is hopeful that the forum will contribute to Myanmar's dem-

ocratic transition and will find constructive ways for democratic consolidation.

Tillerson says US, Russia can settle problems, ease tension

MANILA — US Secretary of State Rex Tillerson said on Monday he believes Washington and Russia can find a way to ease tension, saying it wouldn't be useful to cut ties over the single issue of suspected Russian meddling in the US election.

Tillerson said Russia had also expressed some willingness to resume talks about the crisis in Ukraine, where a 2015 cease-fire between Kiev's forces and Russian-backed separatists in the eastern part of the country is regularly violated.

"We should find places we can work together... In places we have differences we're going to

have to continue to find ways to address those," Tillerson told reporters. Tillerson met his Russian counterpart, Sergei Lavrov, on the sidelines of an international gathering in Manila on Sunday, where he also asked about Moscow's retaliation to new US sanctions against Russia.

The meeting was their first since President Donald Trump reluctantly signed into law the sanctions that Russia said amounted to a full-scale trade war and ended hopes for better ties. Lavrov on Sunday said he believed his US colleagues were ready to continue dialogue with Moscow on complex issues de-

spite tensions.

Tillerson said he discussed Russia's suspected meddling in the 2016 US presidential election with Lavrov to "help them understand how serious this incident had been and how seriously it damaged the relationship" between the two nations.

But Tillerson said that should not irreversibly damage ties.

"The fact that we want to work with them on areas that are of serious national security interest to us, and at the same time having this extraordinary issue of mistrust that divides us, that is just what we in the diplo-

matic part of our relationship are required to do," Tillerson said.

The United States sent its special representative on Ukraine, Kurt Volker, a former US envoy to NATO, to Ukraine last month to assess the situation in the former Soviet republic.

Washington cites the conflict as a key obstacle to improved relations between Russia and the United States.

"We appointed a special envoy to engage with Russia but also coordinating with all parties. This is full visibility to all parties. We are not trying to cut some kind of deal on the side," Tillerson said. —Reuters ■

Greek GDP stats gaps prompt suspension of flash data

ATHENS — Greece's statistics service ELSTAT has suspended until further notice the release of flash quarterly estimates on the country's gross domestic product because of divergences with provisional estimates, an official at the statistics service said on Monday.

The move means that flash data will not be issued on 14 August. Nationwide quarterly GDP data will be released on 1 September, taking into account more information than the early

indicator of the flash estimate. That quarterly figure, known as provisional data, can also be subject to revisions over time. The quality of Greek statistical data is under constant scrutiny by Brussels since the country plunged into crisis in 2010, requiring to date three international bailouts to stave off bankruptcy.

Discrepancies in the way the budget deficit was calculated before 2010 — which angry euro zone partners say concealed the extent of the deficit — helped

trigger the financial crisis that engulfed Greece and the euro zone. A senior ELSTAT official told Reuters the suspension of the flash data was necessary because flash data was issued on the basis of incomplete information, which subsequently needed revisions when more data came in.

"We will probably not publish flash estimates for the next coming quarters after recent divergences," the ELSTAT official said. There have been consider-

able differences in the past two quarters between flash data, issued 45 days after the lapse of the reference period, and provisional data that follows and is released within a 60 day period.

On 2 June, ELSTAT upwardly revised its first-quarter GDP estimate to an expansion of 0.4 per cent quarter-on-quarter on a provisional basis; flash data released 15 days earlier had estimated the economy had contracted by 0.1 per cent. —Reuters ■

North Korea ready to teach US 'severe lesson', says UN abused its authority

MANILA — North Korea is ready to give the United States a "severe lesson" with its strategic nuclear force if it takes military action against it, and will not put its nuclear programme or its missiles on the negotiating table, it said in a statement to a regional meeting on Monday.

In a transcript of a statement by Foreign Minister Ri Yong-ho, which was distributed to media in Manila, Pyongyang called new UN sanctions "fabricated" and warned there would be "strong follow-up measures" and acts of justice. It said the resolution showed the United Nations had abused its authority. —Reuters ■

N Korea sanctions should be implemented "swiftly and robustly" — UK PM May's spokesman

LONDON — Countries should implement agreed sanctions on North Korea "swiftly and robustly", British Prime Minister Theresa May's spokesman said on Monday.

The UN Security Council unanimously imposed new sanctions on North Korea on Saturday aimed at pressuring Pyongyang to end its nuclear programme. The sanctions could slash North Korea's \$3 billion annual export revenue by a third. —Reuters ■

Australia, Japan, US call for South China Sea code to be legally binding

MANILA — Australia, Japan and the United States on Monday urged Southeast Asian nations and China to ensure that a South China Sea code of conduct they have committed to draft will be legally binding. The Association of South East Asian Nations (ASEAN) and China should establish a set of rules that were "legally binding, meaningful, effective, and consistent with international law," the foreign ministers of the three countries said in a statement following a meeting in Manila. —Reuters ■

Kenyans stockpile food, police get first aid kits ahead of vote

KISUMU (Kenya) — Nervous Kenyans stockpiled food and water on Monday and police prepared first emergency aid kits as families headed to their ethnic heartlands on the eve of an election many fear could descend into violence.

Opposition leader Raila Odinga, 72, who lost elections in 2007 and 2013, has already said President Uhuru Kenyatta, 55, can only win if his ruling Jubilee party rigs the vote, a stance that increases the chances of a disputed result and unrest.

Opinion polls before Tuesday's presidential election put the pair neck-and-neck. Kenyans will also be voting for members of parliament and local representatives.

In 2007, Odinga's call for street protests after problems with the vote count triggered a widespread campaign of ethnic violence in which 1,200 people were killed and 600,000 displaced. The violence also hammered

East Africa's biggest economy as regional trade ground to a halt and tourists, the biggest source of foreign exchange, canceled holidays. Much of the killing a decade

ago was in Kisumu, a city of a million people, most of them from Odinga's Luo tribe, on the shores of Lake Victoria.

On Sunday, its open-air markets and shops were packed

with customers stocking up on last-minute essentials.

"We are fearful because before there was rigging and that led to violence," said orange seller Christine Okoth.

Wilson Njenga, a central government official overseeing the western region, said police had received disaster equipment including first aid and gloves but insisted it was all part of normal contingency planning.

"We don't want to be caught flatfooted," he told reporters.

On the campaign trail last week, Odinga told Reuters that Kenyatta could not win without cheating, a message that has fired up supporters in his back yard.

"If he doesn't win, we are going to the streets and we'll demonstrate," said 28-year-old Kisumu potato seller Ruth Achieng. Deputy President William Ruto, who was charged along with Kenyatta by the International Criminal Court (ICC) for organizing the 2007 violence, tweeted a prayer for peaceful and transparent polls.

The ICC cases against both him and Kenyatta collapsed. —Reuters ■

Saudi Arabia still sees no role for Assad in Syrian transition

DUBAI— Saudi Arabia, a main backer of Syrian rebels, said on Sunday it still supported an international agreement on the future of Syria and President Bashar al-Assad should have no role in any transition to bring the war there to an end.

The Saudi Foreign Ministry denied media reports that Saudi Arabia was considering a politi-

cal transition with a first phase in which Assad will stay in power.

Several media, including the state-owned Russia Today, said Saudi Foreign Minister Adel al-Jubeir had informed the Syrian opposition's High Negotiations Committee (HNC) about the decision.

A ministry statement, carried by the Saudi state news

agency SPA, called the reports attributed to al-Jubeir "inaccurate".

"The position of the kingdom on the Syrian crisis is firm, and it is based on the Geneva 1 communique and on UN Security Council resolution 2254 that stipulated the formation of a transitional body that will run the country," it said.

The agreement also called for drafting a new constitution and holding a new election with no role for Assad in the whole transitional process.

Saudi Arabia supports the HNC and its efforts to widen its membership and unify the Syrian opposition, the statement said.

The announcement came

ahead of the next round of United Nations-led Syria peace talks expected in September.

Assad's negotiators have not met directly with the opposition because there is no unified delegation as the HNC and two other groups, known as the Cairo and Moscow platforms, all claim to represent the opposition. —Reuters ■

Dozens of migrants run across border in Spanish enclave

MADRID — Dozens of sub-Saharan migrants crossed into Spain from Morocco in the early hours of Monday after running through a border gate into the enclave of Ceuta, emergency services said.

Migrants frequently attempt to storm the borders of Spain's two enclaves in northern Africa, Ceuta and Melilla, often clambering up fences which are up to 6 metres tall and topped by razor wire.

On Monday a group of more than 100 migrants ran

through one gate in the fence usually used as a border control, surprising Moroccan and Spanish security forces, a Reuters witness said.

The Red Cross said it had assisted 186 people following the morning rush across the border, adding that four migrants were taken to hospital.

Once inside Spain's enclaves, migrants are usually taken to temporary shelters and later moved to the Spanish mainland, or returned to their country of origin.

Many migrants try to

enter Spain as a means of reaching other parts of Europe.

Arrivals through Ceuta and Melilla, as well as the number of migrants attempting to cross into Spain by sea from North Africa has risen this year, although the route between Libya and Italy remains the most popular.

The Red Cross said last week it had attended 7,400 migrants crossing into mainland Spain and Ceuta and Melilla so far this year, up from 3,600 in the same period a year ago.—Reuters ■

Turkish troops hold exercises in Qatar

DOHA— Qatar held joint military exercises with Turkish troops on Monday, Qatari media reported, showcasing their strategic alliance two months into a boycott by Arab neighbours which accuse Doha of supporting terrorism.

The manoeuvres are aimed at preparing Qatar's armed forces to defend "vital economic, strategic and infrastructure facilities," state-owned newspaper Al-Sharq reported.

Turkey's parliament fast-tracked legislation on 7 June to allow hundreds of troops to be deployed to a military base in Qatar, set up as part of an agreement signed in 2014, in a show of

support for Qatar, which is also home to the biggest US air base in the region.

Ankara has said it will deploy 3,000 ground troops at the base to serve as a venue for joint training exercises and to support anti-terrorism efforts.

Turkey stood by Qatar after Saudi Arabia, Egypt, the United Arab Emirates and Bahrain called it a supporter of terrorism, which Doha denies, and cut off diplomatic ties and transport links. The countries want Qatar to close down the Turkish base, curb relations with Iran and close the Al Jazeera TV channel. —Reuters ■

British election failure shakes confidence in May's Brexit strategy — ORB poll

LONDON — British Prime Minister Theresa May's botched gamble on a snap election has shaken public confidence in the government with nearly two thirds of voters now negative about her government's approach to Brexit talks, an ORB opinion poll indicated.

Britain has less than two years to negotiate the terms of the divorce and the outlines of the future relationship before it is due to leave in late March 2019.

May is reeling from a crisis of her own making — the loss of her parliamentary majority in a 8 June snap election which she had called to strengthen her hand. The EU's top negotiator has warned that formal talks could be delayed. An 2-3 Au-

gust opinion poll for ORB International showed 61 per cent of British voters disapproved of the government's handling of the Brexit negotiations,

up from 56 per cent last month and 46 per cent in June. The data showed most voters approved of May's handling of Brexit negotiations this year until

the start of June when May lost of her majority.

"This months Brexit tracker suggests the damage from a poor election result is continuing to cast doubt over Brexit," Johnny Heald, managing director of ORB, said.

"Confidence that the prime minister will be able to negotiate the right deal remains brittle," he said.

When asked if whether they were confident May would get the right deal, 44 per cent of people said they were not confident. Just 35 per cent were confident May would get the right Brexit deal while 21 per cent said they did not know.

ORB asked 2,000 voters across the United Kingdom. The margin of error is around 2.2 per cent. —Reuters ■

Russia's new combat helicopter to undergo tests in Syria

MOSCOW — Russia's newest helicopter Mi-28UB (with dual controls) will be tested in Syria, the CEO of the Helicopters of Russia company, Andrei Boginsky, has said. "Currently the Mi-28N helicopter has a crew of two — the pilot and the operator. The task of the upgrade project is to turn into a combined combat and training aircraft, with the full set of controls in front of both seats. We would like these helicopters [Mi-28UB - TASS] to undergo tests here [in Syria]," Boginsky said in an interview on the Zvezda TV news channel recorded at the Hmeymim air base. Earlier, the Helicopters of Russia general designer, Nikolai Pavlenko, said eight new Mi-28UB

helicopters would be provided for the Aerospace Force later this year.

The chief of the Aerospace Force's army aviation combat training, Nikolai Pavlenko, said that the first Mi-28UB helicopters would be delivered to the 344th centre of combat training and retraining center in Torzhok.

Mi-28UB is a combined combat and training configuration of the attack helicopter Mi-28N Night Hunter. It began to be developed in 2010.

The double control function is one of its key features. Although the helicopter is meant for training pilots, it retains all combat capabilities and can attack enemy targets and vehicles.—Tass ■

ASEAN, at 50, faces questions of relevance, centrality

MANILA — Fifty years ago, when five countries — Indonesia, Malaysia, the Philippines, Singapore and Thailand — set up the Association of Southeast Asian Nations, their main objective was to cope with communist threats expanding in Viet Nam.

At the same time, they were trying to fight insurgencies within their borders and prevent the internal conflicts from spiraling into broader, regional ones, as well as to maintain neutrality amid rivalries between super-power states.

Over the past half century, the grouping’s membership has doubled to 10 to include Brunei, Cambodia, Laos, Myanmar and Viet Nam while trying to maintain regional peace and stability.

Amy Searight, director of the Southeast Asia Programme at the Centre for Strategic and International Studies in Washington, said that many notable and even surprising successes have been achieved by the body, including preventing armed conflict despite “such high degree of diversity and political rivalry” among member states.

The regional bloc has also succeeded in developing and promoting norms of open regionalism to commerce and investment that have been critical to the region’s economic success and has laid “the groundwork for an effective regional security architecture,” she added.

Moreover, it successfully managed to launch collaborative efforts to tackle specific problems, such as piracy in the Malacca Straits and cross-border crimes and terrorism in the Sulu Sea, and to cultivate healthy relationships with all dialogue partners, observers note.

Challenges, however, are still ahead for the regional community to maintain its relevance in global affairs and its centrality in setting the agenda for the region.

“Some challenges have proved daunting and have called ASEAN’s effectiveness and relevance into question,” said Searight, former deputy assistant secretary of defence for South and Southeast Asia.

Pou Sothirak, executive director of the Cambodian Institute for Cooperation and Peace, shared a similar view, saying emerging, serious security issues in recent times have also constantly confronted its relevance.

“The first challenge in my mind is how is ASEAN able to keep its centrality afloat amid traditional and non-traditional security challenges, which are constantly testing the association’s credibility,” he said.

Thai Foreign Minister Don Pramudwinai acknowledged that one of the tough challenges ASEAN is facing is security in the digital realm. “ASEAN has to adjust the community to the dynamic world and be ready to deal with possible threats,” Don said.

In dealing with security issues, which also include territorial disputes among member states and instability in the Korean Peninsula, according to Sothirak, ASEAN needs strong leadership to put the difficult issues on the agenda, particularly those that affect regional peace and stability.

The main problem, he said, is that ASEAN lacks effective leadership. “Now, ASEAN is often perceived by many observers as a mini clearing house of routine tools and avoids sensitive subjects that might involve the internal affairs of member states,” he said.

Avoidance of intervention in the domestic affairs of other member states is occurring, according to Sothirak, particularly in the case of “sensitive issues” related to sovereignty. He cited overlapping maritime claims in the South China Sea.

Don stressed, however, that maintaining neutrality and upholding the principle of consensus serve its unity and reliability in dealing with regional and global issues. “We have to maintain the ASEAN way of consensus because it is our charm. We have to maintain a peaceful atmosphere and avoid escalating conflicts...to make a sea of peace,” he said.

Searight and Sothirak disagreed, saying neutrality cannot be an option any longer in some cases.

“In the present era, political disputes are getting more difficult to resolve. ASEAN needs to invent itself as a provider of regional leadership and exhibit leadership skills to address complex problems,” Sothirak said.

Focusing on neutrality and showing less centrality, according to Searight, may raise the “diplomatic comfort level” in the short term, but can seriously undermine ASEAN’s influence in the long run and turn the body into a passive bystander of larger regional dynamics.

ASEAN needs to find a way forward to maintain centrality and forge greater unity and not always focus on neutrality, they said.

“This will take leadership and political courage and determination, and likely entail institutional reform,” Searight said.

“Not an easy course of action, but ASEAN has shown in the past that it is up to tough challenges, including seizing the opportunity in a period of uncertainty in regional order, if it put its collective mind to it,” she said.

North Korea, South Korea foreign ministers chat briefly in Manila

MANILA — The foreign ministers of North and South Korea held a rare but very brief meeting over the weekend on the sidelines of regional talks in Manila, a government source said on Monday, amid strained inter-Korean relations.

North Korean Foreign Minister Ri Yong Ho, however, said on Sunday that Seoul’s recent offer to resume dialogue between the two countries “lacks sincerity,” according to the South Korean government source. Ri made that comment following South Korean counterpart Kang Kyung wha’s request for North Korea to respond to the offer, the source said.

Last month, South Korea’s government proposed that the two countries hold dialogue on ways to defuse tensions along their heavily militarized border and restart reunions of families separated by the 1950-53 Korean War.

Those overtures marked the first formal olive branch extended by South Korea since President Moon Jae in took office in May. They were made after North Korea carried out its first test-firing of an intercontinental ballistic missile on 4 July.

Taylor Swift in federal court over groping allegation

DENVER — Taylor Swift might turn up in a federal court in Denver on Monday as lawyers for the pop star and a Colorado radio personality start jury selection for dueling lawsuits over whether the former disc jockey groped her four years ago during a photo shoot.

Swift, 27, is expected to take the witness stand during the trial in US District Court to testify about the incident, which resulted in broadcaster David Mueller's firing from Colorado music station KYGO-FM.

The bitter litigation centres on Swift's allegations that Mueller slipped his hand under her dress and grabbed her bare bottom as they posed together during a meet-and-greet session before her 2 June, 2013, concert in Denver.

"It was not an accident, it was completely intentional, and I have never been so sure of anything in my life," Swift said in describing the incident during a deposition.

Mueller, 55, sued first, claiming the singer-songwriter had falsely accused him of the groping and pressured station management to oust him from his \$150,000-per-year job at the station, according to the lawsuit.

Swift countersued for assault and battery, and that became part of the same trial.

Mueller denies that anything inappropriate occurred

during the brief backstage encounter in which he stood on one side of the pop star and his girlfriend on the other.

"The contention that Mr Mueller lifted up Ms Swift's skirt and grabbed her bottom, while standing with his girlfriend, in front of Ms Swift's photographer and (her) highly trained security personnel ... is nonsense," the lawsuit said.

Mueller is suing under tort claims of interference with contractual obligations and prospective business relations. Jurors will determine what monetary damages, if any, he is entitled to if Swift is found liable.

In court filings, Swift said while her manager informed

KYGO management about the incident, she did not demand that Mueller be fired.

The radio station conducted its own investigation, and two days after the incident fired Mueller for violating the morality clause of his contract, court documents show.

The judge has placed a gag order on all parties, and attorneys for both sides did not respond to messages seeking comment.

Swift, one of the most successful contemporary music artists, earned \$170 million between June 2015 and June 2016 following a world tour and her best-selling "1989" album, according to Forbes Magazine.—Reuters ■

"Wolf Warrior 2" continues to lead Chinese box office

BEIJING — "Wolf Warrior 2," a domestic action film, topped the Chinese box office in a landslide victory, grossing 2.2 billion yuan (about 321 million US dollars) in the week ending 6 August.

"Wolf Warrior 2" tells the story of a former Chinese Special Forces operative's adventures rescuing compatriots and local friends in a war-torn region of Africa occupied by insurgents and mercenaries.

The domestic romance "Once upon a Time" took second

place, making 425 million yuan in the week.

"The Founding of an Army," a domestic war film depicting the Chinese revolutionary war, landed in third place for the week, earning 129 million yuan.

Universal's animated film "Despicable Me 3" came in fourth, generating 27 million yuan.

Rounding out the top five was domestic animation "Dear Tutu," which grossed 13 million yuan.—Xinhua ■

'Dark Tower' leads slow weekend with \$19.5 million, 'Detroit' stumbles

LOS ANGELES — As the dog days of summer drag on, a trio of wide releases are kicking off the August box office with a whimper.

The weekend's leader is "The Dark Tower." Sony and MRC's long-time-coming Stephen King adaptation starring Idris Elba and Matthew McConaughey is landing on a modest \$19.5 million from 3,451 locations. Made for about \$66 million counting reshoots, the story centres on a boy (played by Tom Taylor) who discovers another dimension where he aligns himself with a Gunslinger (Elba) on a mission to save the world from various enemies, including the Man in Black (McConaughey). Critics mostly panned the movie, leading to its current 18 per cent on Rotten Tomatoes.

Meanwhile, Annapurna's "Detroit" is not faring as well as expected. Kathryn Bigelow and Mark Boal's latest collaboration should end up with \$7.3 million from 3,007 locations this weekend. Combined with a week of limited release grosses, its total should stand at \$7.8 million. An awards-season push could end up helping its bottom line. So far, critics are on board, earning the tale of the Motor City's 1967 riots a 96 per cent on Rotten Tomatoes. The movie is toplined by "Star Wars" breakout John Boyega, as well as Will Poulter, and Algee Smith.

That leaves "Kidnap" — from David Dinerstein's recently-launched Aviron, and Lotus — which is racing to \$10.2 million from 2,378 locations. The movie stars Halle Berry as a mother attempting to rescue her son after

he is taken. Aviron acquired the film from a bankrupt Relativity, but the distributor declined to release the thriller's acquisition cost, making it difficult to judge its performance.

"Dunkirk," the box office winner the past two weekends, is sliding comfortably into second with \$17.6 million from 4,014 locations. Christopher Nolan's World War II movie crossed the \$300 million mark on Saturday, and by the end of the weekend should tally a \$133.6 million domestic total. This weekend it looks to make about \$4 million from Imax screens alone, which will count for \$29.8 million of the movie's domestic grosses. Warner Bros. also continues to see profits from "Wonder Woman," which will land right up against the \$400 million domestic milestone by the end of this weekend. In limited release, TWC's "Wind River" should make \$164,167 from four locations. The film stars Jeremy Renner and Elizabeth Olsen, and marks Taylor Sheridan's directorial debut. Sheridan conceived the movie as part of a loose trilogy that also includes two recent releases that he wrote, but did not direct, "Sicario" and "Hell or High Water."—Reuters ■

Actors Chris Pratt, Anna Faris announce they are separating

LOS ANGELES — Actors Chris Pratt and Anna Faris are splitting up after eight years of marriage, they said on Sunday.

"Anna and I are sad to announce we are legally separating. We tried hard for a long time, and we're really disappointed," Pratt, 38, said in a statement posted on his official Facebook page. Faris, 40, posted a statement along the same lines on her social media pages.

Pratt, known for starring roles in blockbusters "Guardians of the Galaxy," "The Lego Movie" and "Jurassic World,"

and Faris, star of the "Scary Movie" franchise and the TV sitcom "Mom," have a four-year-old child.

"Our son has two parents who love him very much and for his sake we want to keep this situation as private as possible moving forward," the couple said. "We still have love for

Argentinean artist turns hill opposite Athens Acropolis into "jungle"

ATHENS — Celebrated Argentinean artist Adrian Villar Rojas has transformed this summer the outdoor space of the Athens National Observatory opposite to the Athens Acropolis into a "jungle", posing to locals and foreign tourists questions regarding disappearance, extinction, the passage and volatility of time.

Rojas' impressive installation on the Hill of the Nymphs entitled "The Theater of Disappearance" is the first project ever he was allowed to set up in an archaeological site worldwide, organizers of the Greek NEON nonprofit organization which commissioned the work told Xinhua.

It is also the first time Greek authorities have given the green light for such a major project in an archaeological site.

The Athens National Observatory with a remarkable view of the Parthenon is a landmark in the historic centre of the Greek capital. It is the first research institution established in Greece in 1842.

The Athens National Observatory is part of the city's history and more often in recent years tries

through various events to highlight the link between science and Art, according to its Director Manolis Pleionis.

"Opening up to a different kind of Art and hosting the Theater of Disappearance was a challenge. Adrian Villar Rojas revealed with his work more potential of the historic site of the Hill of the Nymphs," Professor Pleionis noted.

Villar Rojas is well known for large-scale sculptural installations that radically disturb the sites he engages with. He creates unpredictable settings for the visitor to explore.

On the Hill of the Nymphs he worked for months to sow 46,000 plants from 26 species, including bamboo, artichokes, watermelons, pumpkins, artichokes and asparagus across an area of 4,500 square metres.

The vegetation gradually took over the hill, swallowing statues, and will to grow until the exhibition's end on 24 September.

Since 1 June visitors — free of entrance — can walk through narrow paths to admire this "jungle" and discover the sculptural installations Rojas has hidden in vitrines among the

plants as well as a barren zone which points to a war-torn site.

Among others the visitors can see a replica of the Victory of Samothrace, the statue of a winged female figure, which lies horizontally instead of upright or a replica of NASA's unmanned space rover that arrived on Mars in 2012 to assess whether the planet has ever supported life.

"What does it mean to have the soil beneath our feet?" Villar Rojas asks visitors through this intervention which also expands into the indoor spaces of the Observatory.

"I come from Argentina, where essentially soil is a means of production... The strongest features of our national identity are our crops and cattle," the artist told the organizers.

"When I arrived in Greece, I immediately understood that for Greeks what is below their feet was as constitutive of their national identity as it is for Argentines, but in a completely different way. What was beneath their feet was culture: thousands of years of human civilizations," he said according to an NEON press release.

"The transformation

of the Athens National Observatory by Villar Rojas shows his vision and commitment to overturn status quo. It also shows NEON's determination to bring contemporary culture closer to the public with innovative and bold ideas," NEON's founder, collector and entrepreneur Dimitris Daskalopoulos said.

Founded in 2013 NEON aims to show that Art is a key tool for growth for a country which faces difficult times in recent years during the debt crisis.

The project on the Hill of the Nymphs is part of the organization's campaign to establish a link between contemporary culture and the historical and archaeological heritage of Athens.

The installation is also an umbrella title and part of four separate exhibitions taking place in 2017 across Europe and the US. In addition to Athens, Villar Rojas currently presents his work at the Metropolitan Museum of Art in New York (14 April to 29 October), Kunsthaus Bregenz in Austria (13 May to 27 August) and the Geffen Contemporary at MOCA in Los Angeles (22 October to 26 February, 2018).—Xinhua ■

The two sides of China's "coin bucket" challenge

CHANGCHUN — What would you do if a bucket of coins were placed right in front of you? In China, the "coin bucket challenge" has caused quite a stir.

Such coin buckets full of one yuan coins (1 yuan equals 15 US cents) have popped up in front of subway stations, and on overpasses and walking streets in many cities in China. A billboard is placed beside the bucket, which reads: Help yourself if in need, but take no more than 5 yuan.

According to the National Business Daily, a coin bucket was recently placed in a subway station near one of the busiest streets in Chengdu, capital of southwest China's Sichuan Province. A hidden camera captured what happened.

Some people took pictures of the scene and uploaded them online, some hesitated before taking the coins, and others used the opportunity to educate their child. The internet is sharply divided on the challenge.

"I saw the 'test' at the subway station and nobody took any coins," read a comment on microblog Sina Weibo. "Maybe that is because people's lives are changing for the better."

"I think it's great," said another Weibo user. "When you have no change for the bus, you can change your big notes into coins."

But many people remain suspicious, calling the challenge "meaningless" because it is not "scientific."—Xinhua ■

Vandeweghe, who reached the semi-finals of the Australian Open and the quarter-finals at Wimbledon this season, was also looking for her first title of 2017. She blasted six aces but faltered in the opening set tie-break to allow Keys to take control. "I think it was a high quality match from both players. It was fun to play a friend, to have an all-American final — it was enjoyable," Vandeweghe said.—Reuters ■
