The 59 Myanmar students brought back from Wuhan were in good health on the third day of their 14-day quarantine yesterday at the Kandawnadi Hospital in Mandalay, according to Deputy director Dr Khin Kyaw, Medical Superintendent of the Mandalay General Hospital, who is currently responsible for monitoring the students' health.

"A total of 59 people were evacuated from Wuhan – 16 male students, 42 female students, and a three-year-old girl. They all are well on the third day of quarantine, with no fever and no respiratory symptoms," said Dr Khin Kyaw.

The condition of the three health workers who took part in the mission to bring the students back is also being monitored, and they are also in good health, he added.

"Quarantine does not mean that they have been infected with the coronavirus. It is being imposed to prevent the possibility of an infection," he added.

The students will received quarantine care from a medical team led by the medical superintendent of the Mandalay General Hospital.

# Pyidaungsu Hluttaw hears loan plan from South Korea, national education commission's report

THE Second Pyidaungsu Hluttaw held the 5th day meeting of 15th regular session yesterday, and the deputy ministers reported on loan plan of Myanmar government from the Economic Development Cooperation Fund (EDCF) of the Republic of Korea, and Hluttaw representatives discussed a report of National Education Policy Commission for the sixmonth period.

Pyidaungsu Hluttaw Joint Bill Committee member Daw Kyin Ngeik Mam presented the committee's findings and remarks on Myanmar Insolvency Bill sent back from the President with recommendations.

Pyidaungsu Hluttaw Speaker U T Khun Myat invited the names of MPs who want to discuss the President's recommendations on the bill.

Pyidaungsu Hluttaw Joint Bill Committee member U Zaw Win read out the committee's findings and remarks on the bill to amend Farm Land Law sent back from the President with recommendations.

Pyidaungsu Hluttaw Speaker U T Khun Myat invited the names of MPs who want to discuss the President's recommendations on the bill.

Deputy Minister Dr Tun Naing explained the estimated cost for the project located in

Magway Region and western part of Bago Region is US\$129.5 million although the loan plan is just \$113.036 million, and that the government will spend its revenue in Myanmar kyat equivalent to \$16.468 million for the project.

The interest rate for EDCF loan would be 0.01 per cent with 15-year grace period and 25year settlement period. The Myanma Oil and Gas Enterprise under the Ministry of Electricity and Energy would finalize the project in 48 months from the date signed the loan agreement.

Deputy Minister U Maung Maung Win also said the gas pipeline could supply natural gas to the power plants in Shwetaung and Myanaung, as well as to Kyawswa fertilizer factory. He added the loan plan meets the existing laws and policies of the country.

The Pyidaungsu Hluttaw Speaker invited the names of Hluttaw MPs who want to discuss the loan plan.

The Hluttaw representatives discussed the report of National Education Policy Commission on its works for the six-month period from 10 April to 9 October 2019.

Pyithu Hluttaw's Tatmadaw representative Lt-Col Htin Lin Oo said the number of agriculture graduates contributes only 0.5 per cent of the country's total education degree holders, and remarked the importance of commission's suggestion to reopen agriculture and livestock high schools.

MP U Kyaw Thaung from Sagaing Region constituency 1 discussed adopting an effective private school education law to protect the rights of schools and students under this law.

MP U Khin Cho from Hlaingbwe constituency advised the National Education Policy Commission to develop an appropriate education system for the country and to carefully monitor the KG+12 education system for its effec-

MP U Okkar Min from Taninthayi constituency 8 discussed to specify minimum requirements of education level for the members of curriculum development boards, selection of these members with the recommendation of subject experts and reviewing the consistency of curricula with local contexts.

The report was also discussed by the other 18 Hluttaw representatives. The sixth day meeting of Pyidaugsu Hluttaw will convene on 6th February.— Aung Ye Thwin and Aye Aye Thant



The world we are living in is being confronted with various challenges and uncertainties of both nature and man-made. These are posing threats not only to global peace and human development but also to our very existence. They also have negative consequences on peace building endeavours in this world. Global challenges including climate change and terrorism cannot be overcome by countries acting alone, but require global partnership.

Peace is of vital importance to maintain security and achieve human development. Promoting a culture of peace is crucial in preventing violence and conflicts in societies.

We all need to pursue the goals of peaceful coexistence

and development in our society. In order to accomplish these goals, collaboration of both non-governmental and governmental organizations is essential.

Youth plays pivotal role as a huge source of potential for country development. Therefore, young people must have equal access to quality education at all levels. We need to have a concerted effort of governments, civil societies, scholars, international organizations, and parents to use education as a platform in improving the lives now and for future generations.

The main objective of human development approach is to upgrade people's freedoms and lives. Taking this opportunity, I would like to briefly share Myanmar's experience

in promoting peace and national reconciliation. Myanmar is a multi-ethnic and multi-religious country with a long history of prolonged infightings. Therefore, soon after assuming the responsibilities, our government has been striving for long-lasting peace as its topmost priority and pursuing through a complicated peace process involving 18 ethnic armed organizations.

As part of the peace agenda, we have successfully convened three sessions of the Union Peace Conference and agreed on a total of 51 basic principles for building a Democratic Federal Union. Despite many challenges ahead, it is encouraging to see that our people have started to embrace the culture of political dialogue as a means to solve internal conflicts. We firmly believe that achievement of lasting peace is an essential part of Myanmar's journey towards sustainable and inclusive development.

As we truly believe that peace, security and human development are fundamental needs for mankind in this globalized world, we are of the view that the peoples, the governments, together with the civil societies, organizations can and should work together by sharing knowledge, experiences, and positively assisting each other in promoting peace and stability as well as sustaining universal values.

So, let us join hands and renew our joint endeavours in promoting peace, security and human development across the globe," he urged.

Afterwards, Union Minister for Religious Affairs and Culture and General Secretary Dr. Young Ho Yun of the Peace, Security and Human Development World Summit 2020 signed the Letter of Intent for the Asia-Pacific Peace Summit 2020 to be held in Myanmar.

Similarly, the Prime Minister of Niger, the representative of the African Union and UPF Secretary signed the Letter of Intent for the African Peace Summit.

Also present on the occasions were Vice President U Henry Van Thio, Ambassador to the Republic of Korea U Thant Sin, Permanent Secretary U Soe Han of the Ministry of Foreign Affairs and officials.

The Peace, Security and Human Development World Summit 2020: Assembly and International Summit Council for Peace will be held until 6 February and a total of 6,000 world delegates including state leaders of 171 countries, and 25 heads of governments and ex-leaders.

# Dollar exchange rate drops below K1,450

THE US dollar continued to slide against the Kyat in the local currency market, with the exchange rate touching a low of K1,447 per dollar on 4 February, said money exchangers.

On 3 January, the rate was pegged at K1,455, while the US dollar index was above 97 in the global market.

"The current appreciation of the Kyat in the forex market can be attributed to higher exports and a low inflow of the Chinese Yuan due to the New Year holidays and the coronavirus outbreak. Also, dollar demand is falling in the market," said a money exchanger.

The dollar has depreciated even though the Central Bank of Myanmar (CBM) has been buying dollars from private banks to govern the market. The CBM had set the reference exchange rate (weighted average market rate) at K1,457 per dollar on 3 February.

In October last year, the dollar exchange rate had hit a high of K1,600. Thereafter, the

dollar has been falling in the local currency market.

With the Kyat gaining against the dollar in the internal forex market, the domestic gold price plunged to K1.185 million per tical (0.578 ounces, or 0.016 kilograms) on 5 December from a record high of K1.3 million in early September.

In 2019, the exchange rate stood at K1.540 on 1 January and fell to a low of K1,515 on 15 January. It continued to drop and reached K1,503 on 28 February. Thereafter, it rose to K1,527 on 18 March and touched K1,538 on 14 May. The rate stood at K1,259 on 1 June and K1,514 on 26 August. Then, the dollar exchange rate hit a peak of K1,565 on 6 September. It was pegged at around K1,528-1,537 in October. In November, the rate moved in the range of K1,510-1,524. Last month, the dollar rate started to dip below 1,500. —Ko Htet

# Myanmar opium cultivation continues to drop as production ranking declines from second to third

MYANMAR has seen a decline of opium cultivation in 2019 to 33,100 hectares, which was over 11 per cent drop from 37,300 hectares in 2018, according to the Myanmar Opium Survey 2019 report released in Nay Pyi Taw yesterday morning.

The survey was jointly conducted by the Central Committee for Drug Abuse Control (CCDAC) of Myanmar and the United Nations Office on Drugs and Crime (UNODC), and it has been carried out annually since 2001, together with collecting socioeconomic data of locals in opium cultivation areas.

At the report launching ceremony, Deputy Minister for

Home Affairs Maj-Gen Aung Thu said Myanmar's opium cultivation and production continued dropping since 2014. The three consecutive years of decline were recorded from the 41,000 hectares in 2017 to 37,300 hectares in 2018 and to 33,100 hectares in 2019.

Moreover, the country's total opium production dropped from 550 metric tons in 2017 to 520 metric tons in 2018 and 508 tons in 2019 respectively.

The Deputy Minister also said Myanmar's opium production ranking dropped from the second largest opium producer to the third position.

The major opium cultivation areas in Myanmar were mountainous remote States of Shan, Kachin, Kayah and Chin, according to the survey.

The Deputy Minister added the government is implementing infrastructural and socioeconomic development programmes in fighting against opium cultivation and production in coordination with private business firms and international organizations. Mr Troels Vester, the Country Manager of UNODC, made a speech and Mr Jeremy Douglas, the Regional Representative of UNODC for Southeast Asia and the Pacific, explained the report.— MNA

A total of 1,489 people, including 1,240 men and 249 women had been arrested with 7502.3814g of heroin, 1,347.42 g of ICE, 40,339.02166 g of opium, 661.27 g of low-quality opium, 53242.76 g of speciosa powder, 12097.32 g of speciosa, 2.5 liters of liquid speciosa, 463,432 stimulant tablets, 10310.42 g of marijuana, 0.1 liters of opium tincture, 520.28 g of opium blocks, 60 g of poppy seeds, 55.45 g of crushed stimulant tablet powder, 0.001 g of crushed ecstasy powder, 19 firearms, different kinds of 257 cartridges and one grenade. Efforts for fighting the drug trafficking has been stepped up and the department will report on further exposed cases.

UNION Minister for Health and Sports Dr Myint Htwe presided over a meeting of health authorities on monitoring and preventive measures against 2019 Novel Coronavirus (2019-nCoV), held at his office in Nay Pyi Taw yes-

At the coordination meeting (8/2020), officials discussed update announcements of World Health Organization, possible transmission rate of virus calculated by international experts, trial treatments on respiratory disease caused by the 2019 Novel Coronavirus in China and other countries, detail analysis on the spread of 2019-nCoV from the epidemiological perspective and tightening monitoring measures.

They also shared knowledge on medical treatment procedures to suspected/confirmed patients in quarantined wards, monitoring persons under investigations

and information exchange with

Health service personnel also discussed activities of monitoring teams at three international airports of the country and 20 border checkpoint in 10 townships of 4 States/Regions, reduction of daily flight landings from China from 26 to 2— one from Shanghai and one from Hong Kong, medical services for suspect patient and persons under investigation and collaboration with private hospitals and clinics.

They also discussed instructions to hotels and guesthouses to report on suspected symptoms to the nearest health centers, health conditions of 59 Myanmar students who were brought back from Wuhan city to Mandalay on 2 February, accumulation of funds, medicines and equipment and distributions of medical items.

The Union Minister advised

for making adequate response to prevent the 2019 Novel Coronavirus, suggestion of WHO to quash rumours on the disease and real-time information of the ministry on its internet website and social network page.

He also suggested the use of dashboard format for public information about spread of disease, taking specimens for laboratory tests and working with the National Health Laboratory.

The Union Minister added collecting the number of new health facilities which has not been used across the country, collaboration with the National Reconciliation and Peace Centre, Ministry of Border Affairs and the Ministry of Defence Services in monitoring disease at the border areas and postponing some entertainment events.-MNA

# Good understanding of rules key to contract farming success

Contract farming is a system under which companies provide farmers technology and seeds to grow crops and once they are harvested, the companies sell the crops.

It is important for farmers and companies to participate in contract farming with confidence as the government will also play a part in the sector by monitoring businesses under the Stakeholder Participatory Monitoring system.

we all need to understand that contract farming allows not just a higher profit margin, but also helps both sides understand the needs of the domestic and foreign markets.

The contract system outlines 9 provisions for farmers and 10 for farming companies, while it lists 9 obligations that need to be fulfilled by the authorities concerned.

The ministry has posted the contract on its website (www.agri.com.mm), and has urged the two sides to study it thoroughly before going into business.

The contract farming system is part of the government's efforts to encourage Private-Public Partnerships involving the government and the private

The strategies, directives, and procedures for contract farming are aimed at ensuring a strong market for crops and quality crops. Under the contract farming system, farmers and companies can decide on the price and quality of crops

before cultivation, which can help create a sustainable market.

For Myanmar farmers to reach their full potential in agriculture, they need more investment, crop diversification, access to information and research, along with complete mechanization

These challenges can be overcome by farmers as private companies, under the contract farming system, are obliged to support farmers in terms of technology and supervision, in cooperation with governmental departments.

Farmers, on their part, would be responsible for growing crops using Good Agricultural Practices and producing crops that meet the quality, quantity, and standards set by both sides under the contract.

We are confident that the contract farming system would push the development of farmers as well as the private business

The most important factor for the success of the contract farming system is a good understanding of the contract and its observance by both sides.

# Strengthen readiness to respond to the new coronavirus

**HE** outbreak of the novel coronavirus 2019nCoV is a Public Health Emergency of International Concern. The highest level of international solidarity and cooperation is needed to protect health and keep people safe. Since the novel coronavirus emerged late December, the number of cases reported globally has climbed. Human-to-human transmission has been reported in a number of countries. It is imperative that countries report and share information on suspected cases early, provide detailed reports on confirmed cases, and ensure all people receive the care they need

in accordance with the rights and

dignity that is due.

The WHO South-East Asia Region must continue to strengthen its readiness to respond. In recent weeks several countries in the Region have detected and reported cases of 2019-nCoV. The vigilance of health authorities in each country is commendable, and reflects Region-wide efforts to strengthen emergency risk management, which is one of the eight Flagship Priority Programmes in the Region. Member States have made substantial progress in recent years to

strengthen health systems to achieve universal health coverage and to build core capacities required by the International Health Regulations - the international legal framework that helps countries work together for global health security.

The response to the emergence and spread of 2019-nCoV has been rapid. Over the past month, WHO has worked with countries across the world to roll out a series of preparedness measures, including guidance on how to detect and manage cases, improve infection prevention and control, and reduce transmission. In the South-East

Asia Region, WHO and its Mem- on Emergency Preparedness, ber States have focused on increasing capacities to rapidly detect and care for patients, and to guard against onward transmission. To date, most cases reported in the Region have been imported. It is imperative that countries in the Region scale up vigilance and prepare to prevent, control and interrupt local transmission. There is much that we do

not yet know about the virus,

As we learn more, WHO will continue to provide Member States and the public high-quality information through regular situation reports and our social media accounts. Accurate, timely information empowers all people to assess risks and to take preventive measures. Regular hand-washing, coughing or sneezing into one's elbow, avoiding close contact with people with flu-like symptoms, and thoroughly cooking meat and eggs are all great ways to stay healthy and to limit one's exposure to pathogens.

The International Health Regulations (IHR) and the Region's own Delhi Declaration

which Member States adopted in September 2019, are clear: By implementing evidence-based policies, health authorities can increase their capacity to detect and control emerging and reemerging diseases, care for affected people and protect health workers. As Member States make all efforts to tackle 2019-nCoV, several priorities stand out.

First, we must strengthen early warning, alert and disease surveillance systems. To help individuals monitor their own health, authorities at ports of entry can provide information on the virus to incoming and outgoing travelers. Where they don't already exist, contingency plans to assess and manage ill passengers should be developed. Event-based surveillance should be scaled up, including via detailed case reporting, which will help authorities better understand the virus and more effectively respond. Regular risk assessments using multiple sources of data should

Second, infection prevention and control (IPC) in health facilities should be stepped up. By ensuring IPC protocols are

enforced, health authorities will limit the spread of the virus. By making personal protective equipment accessible, they will protect health workers. Triaging systems for patients with acute respiratory illness will increase the efficiency of health facilities, as will clear patient placement and transportation procedures. WHO's technical guidance on clinical case management should inform facility-based care.

Third, rapid response teams must be equipped to act decisively. At national and sub-national levels, response teams must have adequate resources, both logistic and financial. They must have the skills to carry out contact tracing and collect biological samples for respiratory pathogens. It is imperative that national command and coordination structures for emergency response are activated, and relevant sectors - such as the animal health sector - are brought on board where appropriate.

Finally, the importance of providing accurate and timely information must be fully grasped across sectors, and at all levels of government. Streamlined procedures for

developing and clearing transparent communication and messaging will increase responsiveness. Information that empowers people to protect themselves will promote trust. Systems to correct misunderstandings, misinformation and rumors will ensure all people can make health-positive decisions that are fact-based and evidence-informed.

The emergence and spread of the novel coronavirus highlights the need for all countries to be ready to respond to acute public health events by acting on the 'four I's' of emergency risk management: identify risks, invest in people and systems for risk management, implement plans, and interlink sectors. As the current situation evolves, and the Region strengthens its readiness, we must continue to implement the Delhi Declaration and achieve full IHR compliance. We live in a dynamic world that is interconnected and on the move. We are moving with it. Member States in the Region will continue to step up and stand tall. WHO will continue to support them to secure health for all.

## Yangon Circular Railway to change train schedule from 8 Feb

THE Yangon Circular Railway will revise train schedules from 8 February on account of upgrade work on railroads between the Paywetseikkone and Pazundaung stations, said officials during a press conference held yesterday at the Yangon Central Railway Station guest

The changes in timetable will not apply to rush hour periods. Commuters will be notified of the new train timetable through posters and pamphlets.

"The train schedule will change from 8 February. Passengers will be notified through railway stations. Pamphlets will be distributed to passengers," said U Zaw Lwin, traffic manager for the No.7 division of MR.

Eight trains will provide Yangon circular service under the revised schedule, with four trains each assigned for upstream and downstream services.

During rush hour, 12 trains will arrive at the Yangon Central Railway Station in the morning, while 14 trains will leave for the respective road sections from the station.

There are seven stations between Paywetseikkone and Pazundaung railroads in eastern Yangon, spanning 8.5 miles.

The upgrade is slated to finish

The upgrade project has been divided into two parts. The Shwetaung Company is conducting the upgrade on the eastern part of the Yangon railway, while the A1 Company is working on the western part.

The western part from Insein to Kyimyindine railway stations, spanning 5.5 miles, and the eastern part from Danyingon to Paywetseikkone, spanning 7.25 miles, are being upgraded simultaneously.

"After upgrading the Yangon Circular Railway, the Myanma Railways (MR) will be able to offer its services to triple the

current number of passengers. And, the upgrade will help reduce travel time on the entire Yangon circular rail network by an hour," said U Zaw Lwin.

"At present, the Yangon circular rail is providing transportation services to 85,000 commuters. It takes 2 hours and 50 minutes to complete the whole route, spanning 29.5 miles," he

The capacity of the circular railway has been decreasing over the last 20 years. Once the upgrade is finished, the MR will ensure 100 per cent on-time running services to daily commuters.

## Kyaukpadaung onion growers expect good harvest, better prices

FARMERS growing onions along the creek in Seikhtein Village of Kyaukpaduang Township, Mandalay Region, are expecting a good harvest and better prices this year.

Growers from the village are cultivating onions on 70 acres of land along the creek. Last year, a total of 1 million viss of onions were grown in the village.

Onions are grown mostly in the month of October and December. Before sowing onions, farmers have to do grounding, composting, and sanding in advance. Local farmers are growing onions with seeds.

Last year, traders from China purchased onion seeds from farmers. Onion seeds were sold for K1-1.2 million per basket. Some local farmers earned K2.5-3 million from the sale of onion seeds. However, China is not likely to make any purchases next year, said farmers.

Farmers expect to get better prices if there is demand from other countries this year.

Afterwards, Mr Christian Lechervy said the business matching event aimed to explore opportunities to link French entrepreneurs with their Myanmar counterparts, encourage interaction between private sector players, and promote opportunities through

business relations.

As part of the programme, French entrepreneurs will also visit the Thilawa Special Economic Zone to explore potential investment opportunities.

In addition, vice president Dr. Maung Maung Lay spoke about the current economic climate and the investment and trade situation in Myanmar. Entrepreneurs from the two countries discussed potential investments and business opportunities.

Between 1988 and December, 2019, 22 enterprises from France have brought in foreign direct investments of over \$550 million into Myanmar, according to data on existing enterprises provided by the Directorate of Investment and Company Administration.—GNLM

## Price of rice, defy predictions, move up in Chinese New Year

THE prices of rice and broken rice have been on the rise in the Chinese New Year, defying expectations of a decline, according to the Rice Merchants Association of Mandalay.

"We expected the prices of rice and broken rice to decline as usual during the Chinese New Year. But Chinese traders have purchased a large quantity of rice to store in their warehouses as a result of the panic following the outbreak of the coronavirus. Moreover, traders have purchased rice through contracts and it has been shipped via the sea route," said U Sai Kyaw, General Secretary of the association.

"In January, the price of rice rose to K2,000 per bag, while the price of broken rice increased to K500-1,000 per bag. There are 11 companies permitted to export Myanmar rice," according to the Rice merchants Association of Mandalay.

"Myanmar has sold a large volume of rice. And, we guessed China would purchase a lot of rice when the time is up. Moreover, the demand for rice will be higher than the supply this year. We won't suffer because of the virus," said U Sai Kyaw.

Myanmar farmers grow both summer and monsoon paddy. Monsoon paddy is mostly grown in every village in the country.

Myanmar exports nearly all types of rice and broken rice to China, except the Pawsanhmwe, Majandaw and Ayarmin varieties, which are mainly consumed by the local populace.—Tin Zar Hlaing

# Animal product exports plunge to \$50 mln in four months

MYANMAR'S export of animal products between 1 October and 24 January in the current financial year reached US\$50 million, a sharp drop from \$233.95 million registered in the corresponding period of the 2018-2019FY.

In the current fiscal, animal products exports have been solely driven by the private sector. Prior to the Chinese New Year and the coronavirus outbreak, the live cattle export market at Muse had cooled, leaving more than 3,000 heads of cattle stranded in the border area and causing difficulties to traders.

Traders usually transport 20-25 heads of cattle per 12-wheeled truck from Mandalay to Muse gate. The live cattle have to undergo an inspection at the 16<sup>th</sup> mile gate, Yebyu gates, and the animal disease surveillance station near Pakyu Village in Kutkai Township. Officials check whether the livestock meet the export standards and a health certificate has been issued for them.

Normally, a large cow fetches over K1.8-2.2 million, but trade suspension often leads to Chinese traders resorting to price manipulation and offering lower prices.

"We prefer a Government-to-Government agreement for live cattle trade as it can benefit both the traders and the two countries. While cattle exports are legal in Myanmar, livestock trade is still not permitted by China, leading to traders incurring debts. If there is a legit-

imate market for cattle exports, we can get a good price and a regular market. We are hoping for it to happen," said traders from Kyaukse Township.

In the previous fiscal, animal products exports were registered at \$178.28 million.

Myanmar has held a series of negotiations with China at the Joint Border Trade Cooperation and Coordinating Committee (JBTCC) meetings on legal exports of cattle and cross-border control of communicable diseas-

Myanmar, which allowed livestock trade in late 2017, is now exploring new export markets for cattle.

The country exports cattle that are above five years old. The

cattle are exported along with vaccination certificates, health certificates, and farming registration certificates. According to the 2018 cattle census, there are 11.5 million heads of cattle in the country.

According to trade figures, between the 2017-2018FY and the month of October in the current FY, more than 460,000 heads of cattle, worth over \$581 million, have been exported to China through Muse.

The authorities have issued cattle export licenses to more than 300 companies in Magway Region. There are around 5,000 companies holding cattle export licenses across the country. — Ko Khant

# Malawi court cancels presidential | Democrats turn sights election result, orders new vote

LILONGWE (Malawi) -- Malawi's constitutional court on Monday ordered a new presidential poll after annulling the results of a vote that re-elected President Peter Mutharika last May, citing widespread irregularities including the use of correction fluid on ballot papers.

Mutharika, who will remain president until the fresh polls, has the right to appeal the verdict, which is expected to stoke turmoil in the normally peaceful southern African country.

"We hold that the first respondent (Mutharika) was not duly elected as president of Malawi on May 21, 2019," ruled lead judge Healey Potani.

"We hereby nullify the results of the presidential elections and we order for a fresh election" within 150 days, he added, sparking jubilation in the court.

The verdict was greeted with festive cheer in the second city of Blantyre, where residents in impoverished townships set off fireworks.

"I'm delighted. I am short of words really but this is a bright new day for Malawi, " said an university student Laura Banda.

"I hope this is a turning point for the country," the 22-year-old

The main opposition Malawi Congress Party, which led the court challenge, hailed the ruling as "a very fair judgement" that had "set a precedent" for future

that "the irregularities and anomalies have been so widespread, systematic and grave... that the integrity of the results has been seriously compromised".

They added that the results announced by Malawi's Electoral Commission (MEC) "cannot be trusted as a true reflection of the will of the voters".

Neither the ruling party nor the government responded to requests for comment.

"I am still consulting and will only be able to talk to you once I have talked to my superiors," government spokesman Mark Botomani told AFP.

Sporadic protests have broken out across the country since Mutharika was declared the winner by a narrow margin, with 38.5 percent of the vote.

Runner-up Lazarus Chakwera, who lost by just 159,000 votes, said he was robbed of victory and took the matter to court.

The case gripped the nation, keeping Malawians glued to their radios for hours on end as witnesses presented evidence of alleged vote-rigging during six months of hearings. - AFP

# WADA asks CAS for public hearing on Russia doping case

MONTREAL (Canada) — The World Anti-Doping Agency (WADA) said Monday it has asked the Court of Arbitration for Sport (CAS) for a public hearing on its case for Russia's exclusion from international sporting competitions.

At stake in the hearing will be the fate of Russian athletes hoping to compete in such events as this year's Tokyo Olympics and the 2022 Beijing Winter Olympics and 2022 football World Cup.

WADA director general Olivier Niggli said his group made the formal request for a public forum to resolve the dispute would ensure the world hears the case from both sides and understands how punishment, if any, is administered.

"WADA's investigations on Russia, and this latest case of non-compliance, have generated huge interest around the world," Niggli said.

"It is WADA's view -- and that of many of our stakeholders — that this dispute at CAS should be held in a public forum to ensure that everybody understands the process and hears the arguments."

WADA sent its case against the Russian Anti-Doping Agency (RUSADA) to CAS, the world's highest sport court, last month.

It will be a CAS panel that must decide whether to confirm the four-year ban WADA imposed on Russia last month after considering Russia's case against the epic sanction.

In December, WADA imposed a four-year ban on Russia over what it considers a state-sponsored doping scheme

-- prohibiting Russia from participating in such events as this year's Tokyo Olympics.

WADA says Russia "manipulated" data from an anti-doping laboratory in Moscow in the latest move in a long-running scandal that began with the 2015 revelation of long-term institutional doping involving senior Russian officials, secret agents and trafficked urine vials.

Under the sanctions, Russians would be allowed to compete in the Tokyo Olympics only if they can demonstrate they were not part of the doping network -- the same situation Russian athletes faced at the 2018 Pyeongchang Winter Olympics.

RUSADA disputed the WADA executive committee ban on December 27, setting the stage for WADA to send the case to CAS.—AFP

#### World currently 'not in a pandemic' of China virus: WHO

GENEVA (Switzerland) —The World Health Organization said Tuesday that the outbreak of the deadly novel coronavirus, which has spread from China to two dozen countries, does not yet constitute a "pandemic".

"Currently we are not in a pandemic," Sylvie Briand, head of WHO's Global Infectious Hazard Preparedness division, told reporters in Geneva.

Instead, she said, "we are at the phase where it is an epidemic with multiple foci."

The disease has killed more than 425 people and infected a further 20,000 in China, nearly all of them in central Hubei province -- the epicentre of the outbreak -- and spread to two-dozen countries since it emerged in Decem-

Briand said that while there is rapid spread of transmission in Hubei, outside the province there are mainly "spillover cases" with sporadic clusters of transmission.

"In these other places in China, the strategy currently is to stop transmission," she said, adding that the same was true for affected countries outside of China.

"We would like to make sure that we don't have a second Hubei type of scenario," she said.

Authorities in China have taken dramatic measures to halt transmission, while other affected countries have put in place steps to rein in the spread. —AFP

#### Japan quarantines 3,700 on cruise ship over new coronavirus

YOKOHAMA (Japan)— Japan has quarantined a cruise ship carrying 3,711 people and was testing those onboard for the new coronavirus Tuesday after a former passenger was diagnosed with the illness in Hong Kong. Eight people on the vessel, which arrived at Yokohama Bay on Monday, have symptoms such as fever, top government spokesman Yoshihide Suga said. Television footage showed several quarantine officers boarding the Diamond Princess cruise ship at the port of Yokohama on Monday evening to check all 2,666 passengers and 1,045 crew.

The move comes after an 80-year-old passenger who disembarked on January 25 in Hong Kong tested positive for the virus, which has killed 425 people in China. The man "did not visit a medical centre inside the ship while he was sailing with us," cruise operator Carnival Japan said in a statement."According to the hospital where he is staying, his condition is stable and infection was not found among his family members who sailed with him," the statement said.

A woman in her twenties who was sailing with her mother on the ship told private broadcaster TBS on Tuesday that all passengers "were asked to stay in their rooms to wait for virus tests".—AFP ■

# Singapore announces first local coronavirus transmissions

SINGAPORE (Singapore)-Singapore on Tuesday announced the first local transmissions of the deadly coronavirus from China as a major aviation conference was scrapped due to the escalating health scare.

The Ministry of Health said it had found six additional cases, four of them involving human-to-human transmission in Singapore, bringing the total infections to 24 in the city-state.

"Though four of these cases constitute a local transmission cluster. there is as yet no evidence of widespread sustained

community transmission in Singapore," the ministry said in a statement.

The site for the establishment of the special economic zone is adjacent to the areas of Dala, Kawhmu and Kungyangon townships. The soil of these adjacent areas contains sea water, thereby causing a change in its fertility and finally being unable to produce good crops. The pro-

posed site has tens of thousands of acres of land. In addition to the special economic zone there is a prospect of building a seaport as well.

# Establishment of more industrial zones

Yangon regional government has got a plan to establish about 11 industrial zones

on the outskirts of Yangon. Two out of 11 industrial zones will be rapidly implemented. Speaking to the press conference on Yangon regional projects held on 22 October in 2019, Naw Pan Thinzar Myo, Yangon Region's Kayin Ethnic Affairs Minister said industrial zones will be established in Htantabin and Hlegu townships, the outskirts of Yangon. Further implementation of establishing industrial zones in Thanlyin and Kyauktan is still under negotiation. The businesspersons are casting covetous eye to the establishment of the industrial zones in Hmawby, Twantay, Kungyangon, Dala and Kawmhu Townships.

#### Plan to build a new seaport

Yangon Chief Minister Phyo Min Thein said on 6 January, "A feasibility study on the proposed special economic zone was already conducted in Dala, Kawhmu and Kungyangon a few days ago.

There is also a plan to shift the jetties in Yangon to the mouth of the river where it meets the sea. As a result of that a new seaport to be built in Thayettaw Village in Kawhmu Township is currently in preparation."

Yangon city is the commercial hub of Myanmar with Thilawa Special Economic Zone already in existence. Located 20 km southeast of Yangon, Thilawa Special Economic Zone has now gained momentum and it is the most developing special economic zone. ## 'Adopted' Italian Steyn plays down Smith South African favouritism

PARIS (France)—South Africa-born back-rower Braam Steyn said on Tuesday he had been 'adopted' by Italy and denied any preferential treatment from new interim head coach Franco Smith. Steyn, 27, who grew up in the Eastern Cape, moved to club side Mogliano in 2012 and made his Azzurri Test debut in 2016 after qualifying on residency grounds. Smith, 47, who made nine Springboks appearances in the late-1990s, took over from Conor O'Shea on a temporary basis for the ongoing Six Nations after last year's Rugby World Cup. "I've been adopted by Italy and that is where I feel at home. My life and my country is Italy at the moment," Steyn said. —AFP ■
