The incumbent government has held the three sessions of 21st Century Panglong Conference where 52-points of the agreement were reached for establishing a Democratic Federal Union.

To put an end to the armed conflicts that we have witnessed for over 70 years, we should see what salutary lessons we can gain from the bitter past.

Following is the Speech delivered by State Counsellor Daw Aung San Suu Kyi on 73rd anniversary of the Union Day celebration in Panglong.

AY I first of all wish health of body and peace of mind to you, our brothers and sisters present on the 73rd anniversary of the Union Day celebration. I am happy to see the ethnic armed organizations who have signed the Nationwide Ceasefire Agreement (NCA) and those who have not yet done so to be present on this Union Day celebration.

We all value the Union Day as a day that brought about the unity and the union spirit of all our national races. Now I would like to take this opportunity to give you a brief account of how the Panglong Conference had come to exist, and how we had undergone the hardships and obstacles.

When Myanmar fell under the British colonialists, the hilly regions and the central plains were governed separately; when the time came to grant independence without fail, attempts were made so that the hilly regions would be left out from enjoying this great opportunity. So the then AFPF government, leading the interim government, made every effort to ensure that the independence must be restored to both the hilly regions and the central plains. In January 1947, a Myanmar delegation led by Gen. Aung San went to England and held talks with the representatives of the British government to grant independence for the whole country without excluding the hilly regions. It was during the discussions that some Sawbwa council members of the Shan State sent a telegraph to the British government, stating that Gen. Aung San was not a representative of the Shan State. As a result, the discussions came to a halt temporarily. But the youths of the Shan State Independence Association held a mass gathering in Taunggyi, and there they made a unanimous decision saying that Gen. Aung San and the delegation were the genuine representatives of the people of Shan State, and then sent a telegram to Gen. Aung San and the British Prime Minister in London. Then the discussions were resumed, once again, and the Aung San-Attlee Agreement, which set a milestone for regaining the independence of Myanmar, was signed on 27th January 1947.

(12 February 2020)

So Gen. Aung San held discussions with the leaders of the Shan, Kachin, and Chin in Panglong, the Shan State. The Panglong Treaty was successfully signed on 12th February 1947, that measures would be taken for regaining the independence, simultaneously, for the whole country of Myanmar, including Burma Proper, the Federated Shan States, the Kachin Hill Tracts and the Chin Hill District. That day is now known as Union Day.

Today marks the 73th anniversary of signing the Panglong Agreement. You can assume that the word "Panglong" is the key word representing the Union. What is the most important point for the emergence of this agreement of great significance is the collaboration of the people. In other words, this acknowledges the democratic values, which mean the inclusiveness of the people, and which are essential for the achievement of the important matters for the country.

Secondly, I would like to draw your attention to one short statement that was included in the Agreement. That sentence reads thus: "Freedom will be more speedily achieved by the Shans, the Kachins and the Chins by their immediate co-operation with the Interim Burmese Government".

This statement highlights the fact that it is only through the collaboration of all national races that the important matters of the state could be implemented speedily, more efficiently. If we consider these two points, in order to successfully build the democratic union, it is obvious that the cooperation and collaboration of the people, of the national races, are quite a pressing demand. This is, of course, the Union Spirit - a spirit which will never grow old and one which we should effectively hold dearly forever.

It has been over seventy times that 12th February, the day of signing the Panglong Agreement has been celebrated. Ironically, it has been over seventy years that after we have regained our dearly won independence, our national races, our blood brothers, have been engaged in wars merely because of the conflicting policies and suspicions or lack of trust among ourselves. Up to the present the sound of guns can still be heard.

If we make a review of our history, we should not look at each other with the critical eye, putting blame on each other. That's not the way we can find the right solution to our problems. Don't look at what's wrong with them. Look at your own faults. What's been going wrong with all of us? What are the things we need to mend? That kind of critical point of view should be adopted. Why not adopt the new global views, and look at the union spirit that never grows old or stale? To put an end to our armed conflicts that have been going on over seventy years, we should see what salutary lessons we can gain from the bitter past. Since the conditions of the world in relation with the history of our own country are also important, when we consider the past, we must not fail to perceive that the then related conditions were not the same as the related conditions of the present. It is very important to consider in what condition we should pass our country to the future generations. We all know what impact these seventy-year armed conflicts have made to the status of the development of our country. Our goal is to keep abreast with the other countries in the world, a democratic federal union with our own sovereignty.

goals of peace. Ceasefire agreement has been only the highest form of agreement, and the sustainable peace has not yet been built. Why? Because, as our government believes, the political problems among us, which are the root of the problems of the armed conflicts, have not yet been settled, as has been highlighted in the message of the President.

Therefore, today, while the Union Government has been making efforts for national reconciliation and peace, the Union Peace Conference-21st Century Panglong conferences have been held, which are the political talks for building the democratic federal union, which has been the dream of all national races. It was named the Union Peace Conference-21st Century Panglong because the long-desired independence was successfully regained through the united spirit of 20th Century Panglong. This we should recall and reflect, and stand united ever again. We all should bring along the united spirit of 20th Century Panglong, and hold talks at 21st Century Panglong in relation with the times and circumstances of the present. Then we shall regain, with our collective strengths, the everlasting peace, which is now as important as our life and soul.

Our ancestors have founded this nation. If we want this union, the country whose independence our ancestors have stood united and fought for, to stand till to the end of the world, it is important to build the democratic, federal union that we shall agree upon and accept, that fits in the related conditions of the 21st century. Of course, we have different views and different beliefs. But the goal of everyone is no doubt building the democratic federal union founded on national equality and national unity. Well, how shall we shape the democratic federal union? We may have different approaches, but to reach the common goal, if we have farsightedness, and try unitedly, I believe, there is nothing that can stop our success.

As our national leaders successfully worked it out with the exercise of farsightedness at the 20th century Panglong Conference, so we will unfailingly be able to successfully build the democratic federal union if we, brothers and sisters of national races come together and work it out with farsightedness and unity.

Before I conclude my talk, I would like to draw your attention to the portraits of our fathers of the Panglong Agreement right before you. It was these great leaders who collaborated and agreed to build the union. They collaborated with the exercise of farsightedness, wisdom, magnanimity, and the spirit of taking risks. The spirit of taking risks is related to magnanimity. If you are magnanimous, if you are broadminded enough, you have the courage of setting out to do things that you have never done before. Only the narrow-minded people continue to confine themselves as the prisoners of the past. You know, they just stick to the old needs and the old demands in the old styles, as before. The fathers of our union did it, equipped with novel visions and courage, that we would found our nation in the way we had always dreamed of, in the period we lived. We all should do that way to achieve our goals. I would like to conclude my talk that in the present period we are now living, we must have the courage, wisdom and farsightedness that, though nobody has ever done before, we shall do what we should do according to the needs of our country and our world. I would like to request you all to cooperate and collaborate without fail. Thank you. (Translated by Dr Zaw Tun)

State Counsellor Daw Aung San Suu Kyi, in her capacity as Chairperson of the Rural Areas and National Races Development Central Committee, met with local residents in Panglong at the town's Union Monument Garden yesterday afternoon.

Speaking at the meeting, State Counsellor Daw Aung San Suu Kyi said, "I hold public meetings everywhere I tour in the country. I read what my father said, including his many thoughts which came from different public meetings.

"In one of his speeches in 1947, before he was assassinated, he also said that his heart was filled with what he wanted to say to the public. First, I thought that he was young and might not live longer, so he could not say what he wanted. Now, I understand that his comment meant that our hearts are filled with thoughts for a country, when we can clearly see the country.

"Today, I want to talk about two issues. The first is the issue related to Union Day, and the other is about the knowledge and lessons I gained during public meetings nationwide, whenever I toured the country. are many Unions in the world, whilst non-Union countries. The prosperity being enjoyed by the world's countries is not connected with the Union. A country's prosperity depends on its people.

Hence, our road to the Union has not yet finished. It started in 1947. We have not yet made our Union strong even though the 20th century finished. There are many things to think about for each one of us. Have we really completed the task of building our Union?

Unity among us is more important than brethren relationship between us. Only when we have the same ambition in major issues, can we build unity among us. We need to have the same ambition of building a Union. But, we might not have the same way of how to build the Union, but we can negotiate it.

We need unity physically and mentally to build a Union. The United States of America is the most famous Union in the world. By the term Americans we do not mean the American Indians who settled there before 15 century. Now, Myanmar people who migrated to the United States can be citizens of the United States of America. The people who left Panglong for the United States of America might be the citizens of the US. The Union with different peoples, different religions and different languages is the most powerful and prosperous country in the world not because of its richness in natural resources. That's the union.

self to become a prosperous country. We can see that the prosperity of a Union is not related with the country's size nor richness in natural resources. Switzerland is not rich in natural resources. As what I said before, the development of a country depends on the spirit, unity and diligence of the peoples of that country.

If we really want to develop our Union, our thinking must lead to it. Thinking about just for an ethnic race is not workable. Only when we think about prosperity of about that, the National League for Democracy laid down the policy to work for that goal within the framework of the rule of law and peace.

We never considered choosing the way that could hurt the public. Self-centered attitude will not benefit the country. We are now gathering at Panglong. I have said in the morning that we should imagine the intention of our Union fathers while we are attending the Union Day.

They might have broad-mind-

the Union, can we bring prosperity to both individual ethnic race and the whole country.

Working just for own ethnic race cannot be considered a pride. We must consider prosperity for ourselves and for others at edness. They might work in this attitude with courage. Big-hearted persons have courage. They had far-sightedness. Their courage could develop their firm determination. However, self-confidence is important for daring needy persons will fear to share their possessions.

Therefore, it is important to build up self-confidence, and also believe that everybody has their own value. This value cannot be judged by money or academic certificates, but it could be determined by the benevolent efforts. It is one of the ideas on the Union.

I also like to talk about my public meetings. I want to make regular contact with common people. The government and people should keep in touch. However, it is not easy to have close contact of the government with the people, especially in countries like Myanmar.

It can simply be seen in the transportation sector. Rural people cannot easily meet with officials in the towns due to poor road networks. Therefore, it is difficult to build up unity and close relations between the common people and the administrative officials.

It will not be practical to talk with over 52 million people of the country at the same time. We do our best for public meeting as I want to know the concerns of common people. Some are taking advantage from these meetings although they are not local residents. I frequently said not to focus on the self-interest, but on responsibility. Some people do not like my advice. Freedom and responsibility come together.

Someone who always hopes for privileges is not an independent person. They seem to be relying on others. Such persons expect the rights only from others without giving up. Responsibility is to serve for others. It is own value. I once talked about the United States. When the U.S people fought for their independence, they had a political slogan of 'No taxation without representation'. Although they had to pay tax, the administration neglected their rights. And that they blamed their government for this negligence. Tax payers deserve their rights.

In developing countries, they used to insist on demanding their rights that they were dutiful citizens to pay tax, and that the government needed to consider their rights. Just taking one-sided privileges is not a good attitude.

Therefore, I will allow for questions. Although someone won the lot for questioning, I will first identify their residency whether a local or non-local. I will never allow pretending as the locals for questions. The rights must be claimed in the rules.

Forced labour needs to stop - for good

YANMAR became a member of the International Labour Organization on 18 May, 1948. The country established a mechanism to deal with complaints, in cooperation with the ILO, in 2007. The move came under the Supplementary Understanding (SU) with the ILO in 2007 and was part of efforts to meet Protocol 29 of the ILO.

Prior to 2019, a High Level Working Group (HLWG), formed as a transitional body before the National Complaints Mechanism (NCM) came into existence, had dealt with complaints related to forced labour

Now, the National Complaints Mechanism has become operational, and anyone can lodge a complaint with the NCM via the Hluttaw, the Office of the President, regional and state governments, the Myanmar Human Rights Commission, ILO office (Yangon), Ministry of Labour, Immigration and Population, in person or by mail. The Ministry of Labour, Immigration and Population can be contacted by phone on 067-3430184, 067-3430229, 067-3430274

For the elimination of all forms of forced or compulsory labour in Myanmar, the cooperation of both employers and workers is required in implementing the National Complaints Mechanism.

To arrive at permanent and comprehensive solutions to the scourge of labour coercion and abuse, investment in workers needs to be prioritized, and their capacity to organize collectively to combat exploitation is critical to securing social and economic justice that leaves no one behind

Industries are urged to consider all approaches to end forced labour because they employ mostly women workers, who, in particular, face inequality, poverty, lack of labour protection, and criminalization globally.

Forced labour has both direct and indirect social and economic consequences.

Under the national mechanism, alleged instances of forced labour would be handled through investigation, prosecution, and adequate punishment for those found guilty, as stipulated under the terms of Forced Labour Convention No. 29.

We are confident that the new initiatives of the government would help encourage people to come forward and support those affected by the practice. Forced labour needs to end - for good.

WHO names deadly virus from China as 'COVID-19'

WHO chief Tedros Adhanom Ghebreyesus warned that the virus was a "very grave threat". But he said there was a "window of opportunity to hit hard and stand in unison to fight this virus in every corner."

THE UN health agency on Tuesday announced that "COVID-19" will be the official name of the deadly virus from China, saying the disease represented a "very grave threat" for the world but there was a "realistic chance" of stopping it.

"We now have a name for the disease and it's COVID-19," World Health Organization chief Tedros Adhanom Ghebreyesus told reporters in Geneva.

Tedros said that "co" stands for "corona", "vi" for "virus" and "d" for "disease", while "19" was for the year, as the outbreak was first identified on December 31.

Tedros said the name had been chosen to avoid references to a specific geographical location, animal species or group of people in line with international recommendations for naming aimed at preventing stigmatisation.

WHO had earlier given the virus the temporary name of "2019-nCoV acute respiratory disease" and China's National Health Commission this week said it was temporarily calling it "novel coronavirus pneumonia" or NCP.

Under a set of guidelines issued in 2015, WHO advises against using place names such as Ebola and Zika -- where those diseases were first identified and which are now inevitably linked taking part in the two-day in-

to them in the public mind. More general names such as

"Middle East Respiratory Syndrome" or "Spanish flu" are also now avoided as they can stigmatise entire regions or ethnic groups

WHO also notes that using animal species in the name can create confusion, such as in 2009 when H1N1 was popularly referred to as "swine flu"

This had a major impact on the pork industry even though the disease was being spread by people rather than pigs.

People's names -- usually the scientists who identified the disease -- are also banned, as are "terms that incite undue fear" such as "unknown" or "fatal", the WHO said.

'More powerful' than terrorist attack

WHO sent an advance team to China this week for an international mission to examine the epidemic

It was unclear, however, whether the team would be able to visit Wuhan, a city in central China which has been under lockdown after the outbreak was registered in a food and live animal market in the city.

Roadmap for research

No specific treatment or vaccine against the virus exists, and WHO has repeatedly urged countries to share data in order to further research into the disease.

"That is especially true in relation to sharing of samples and sequences. To defeat this outbreak, we need open and equitable sharing, according to the principles of fairness and equity," Tedros told the scientific con- years. ference.

China virus death toll tops 1,100 as new cases fall

The death toll from China's new coronavirus epidemic climbed past 1,100 on Wednesday but the number of new cases fell for a second straight day, as the World Health Organization urged global unity to combat the "grave threat".

As Beijing scrambles to contain the virus, the number of people infected on a cruise ship off Japan's coast rose to 174 - the biggest cluster outside the Chinese mainland.

Another 97 people died in China, raising the national toll to 1,113, while more than 44,600 people have now been infected by the newly named COVID-19.

The WHO decided to name the virus COVID-19 in keeping with guidelines aimed to avoid linking a disease to an animal or a geographic location

Addressing scientists at the first international conference on combating the virus in Geneva on Tuesday, WHO chief Tedros Adhanom Ghebreyesus warned that the virus was a "very grave threat"

But he said there was a "window of opportunity to hit hard and stand in unison to fight this virus in every corner."

"We are not defenceless," Tedros said, adding: "If we invest now... we have a realistic chance of stopping this outbreak."

"Viruses can have more powerful consequences than any terrorist action," he told reporters later on the sidelines of the meeting, which will resume Wednesday.

Chinese authorities have locked down tens of millions of people in central Hubei province, the epicentre of the crisis, and restricted movements in several other cities in other parts of the country in an unprecedented effort to contain the virus.

Bangladesh buying over 300,000 viss of Myanmar onions daily

BANGLADESH is purchasing more than 300,000 viss of onions from Myanmar every day during the summer onion season in the local market, according to sources from the onion market in Mandalay Region.(One viss equals 3.6 pounds)

Currently, around 500,000 or 600,000 viss of onions are being supplied to the domestic market. Bangladesh onion traders are purchasing onions from Myanmar via the border areas.

China is also purchasing onions this year through the border. China usually purchases onions from Myanmar between February and August.

In the summer season in Myanmar, onion prices are likely to decline to K500 per viss. But this year, the price of onions is above K1,000 per viss.

The Ministry of Commerce has issued an import license to export and import companies, at the recommendation of the Myanmar Onion, Garlic and Vegetable Producers and Exporters Association. Moreover, the authorities have allowed them to import onions using Individual Trading Cards (ITC).

In the 2017-2018 financial year (FY), Myanmar earned over US\$9 million from the export of 22,000 tons of onion. Myanmar earned over \$20 million from the export of 87,000 tons of onions in the 2018-2019FY. Myanmar exports onions mostly to China, Thailand, India, and Bangladesh.

Onions are mainly grown in

Individual trades exceed K18 bln at border gates in Oct-Jan

TRADE conducted by Individual Trading Card (ITC) holders at the border gates crossed K18 billion between October and January in the 2019-2020 financial year, according to data released by the Ministry of Commerce.

The Trade Department issued 32 cards in October-January, and card holders conducted trade worth K18.8 billion. While imports exceeded K17 billion, exports were valued at just K1.78 billion.

The Myawady gate recorded the highest trade by value at K11.3 billion in the current FY, according to the Commerce Ministry. But, the figure only reflects imports as individual trading card holders did not export goods through the gate.

The value of trade conducted by individual card holders stood at K1.5 billion at Tamu, over K6.1 million at Muse, K143.86 million at Tachilek, K22.96 million at Lwejel, K319.7 million at Kanpiketee, K695.5 million at Kawthoung, K405.5 million at Reed, K3.53 billion at Mawtaung, K2.086 billion at Hteekhee, and K127.7 million at Kengtung, as per data from the Commerce Ministry.

Individual trades topped K737 million in the period from 21 November, 2012 to 31 March, 2013; exceeded K6.6 billion in the 2013-2014FY; crossed 9.3 billion in the 2014-2015FY; stood at over K6.4 billion in the 2015-2016FY; rose above K18.5 billion in the 2016-2017FY; touched K45.9 billion in the 2017-2018FY; K22.5 billion during the mini-budget period (April-September, 2018); and K9.38 billion in the 2018-2019FY.

The trade department has issued 1,719 cards so far with the aim of boosting trade. Businessmen can trade goods worth K3 million per day using ITCs, and the Trade Department has permitted trade of up to K15 million over five days. —Ko Htet

Myanmar beans body seeks extension of export quota period for mung beans

THE Myanmar Pulses, Beans, and Sesame Seeds Merchants Association has sought an extension of the March-end deadline for exporting 250,000 tons of mung beans to India as it estimates it will need more time to ship the entire quota, said U Min Ko Oo, secretary of the association.

The association has also made a request to India through Myanmar's Ministry of Commerce to declare the quota limit for the 2020-2021 financial year.

"We will have to ship the beans around 15 to 20 March so they can reach the Indian port by March-end. However, we cannot export the whole quota by the deadline. Moreover, pulses and beans will be harvested until May. Having said that, we have requested that the period for export quota be extended and the quota limit for the next financial year be declared in the end of March. India has not yet responded to the request," said U Min Ko Oo. India had increased the mung beans quota from 150,000 tons, set earlier on 12 December last year, to 250,000 tons, according to a trade notice issued by India's Directorate General of Foreign Trade.

The increased quota of 250,000 tons will have to reach India by 31 March, 2020.

India recorded low mung beans yield due to erratic weather last year. Under the provincial government's approval, more mung beans are being purchased beyond the previous quota limit, which has driven the mung beans price up to above K1.3 million per ton.

At present, mung beans are fetching about K970,000 per ton.

"Demand and supply determine the market price of mung beans. India increased the quota limit in December, 2019 and then, the merchants obtained a license in 20 January, 2020. Thus, the period for export is short. There was active supply and demand relation in February. Nevertheless, the price of mung beans dips in the domestic market when the price in the Indian market declines amid bulk supply in the Myanmar market. More beans will be harvested in the coming months," said U Min Ko Oo. Currently, mung beans are being loaded on ships for export to India. The export ships are set to leave Myanmar port every seven to ten days, according to the association. (Translated by Ei Myat Mon)

Maritime trade up \$1.3 bln in Oct-Jan

THE value of Myanmar's maritime trade for the period between 1 October and 31 January in the 2019-2020 financial year totaled US\$9.3 billion, an increase of over \$1.3 billion compared to the year-ago period, according to the Ministry of Commerce.

While maritime exports were valued at \$3.69 billion, imports were registered at \$5.6 billion. Compared to the same period in the 2018-2019 financial year, imports were higher by \$584.87 million, while exports registered an increase of \$732.43 million.

Meanwhile, the value of trade through the border gates was estimated at \$3.78 billion, an increase of \$470.5 million. The country's total external trade reached \$13 billion, which was higher than the \$11.3 billion recorded in the year-ago period.

Myanmar exports agricultural products, fishery products, minerals, livestock, forest

products, finished industrial goods, and other products, while it imports capital goods, consumer goods, and raw industrial materials.

The country currently has nine ports involved in sea trade. Yangon Port is the main gateway for Myanmar's maritime trade, and includes the Yangon inner terminals and the outer Thilawa Port. —Mon Mon

French wine industry faces 'challenging year' as US exports drop

PARIS — French wine exports to the United States plunged by almost a fifth in the last quarter of 2019 as punitive tariffs kicked in, the FEVS industry body said Wednesday, and warned of a "challenging year" ahead.

Despite an overall 5.9 per cent rise in wine and spirits exports last year some 14 billion euros (\$15 billion) in total — the federation was downbeat as it pointed to uncertainties in its three main markets, the United States, China and Britain.

Even the global increase, it said, was partly motivated by fear as jittery buyers placed "anticipation" orders "in an international context of strong trade tensions and uncertainty".

The French Associa-

tion of Wines and Spirits Exporters repeated a call it launched Tuesday for the government to set up a 300 million euro emergency compensation fund.

"The 2019 positive result must not be misinterpreted: international political environment and trade tensions had a severe effect on French wines and spirits exports, suggesting 2020 will be a challenging year," **FEVS** president Antoine Leccia said in a statement.

A key concern was the entry into force on October 18 of additional tariffs of 25 per cent on French wine exports to the US, which the FEVS blamed for a 17.5 per cent drop in bottled still wine exports in the last quarter of 2019, along with a turnover decrease of 40 million euros. Last week, the French finance ministry said the value of wine exports to the US fell 44 percent from October to November last year. The tariff hike was in retaliation for EU subsidies to Airbus, arch-rival of America's Boe-

ing. The FEVS also pointed to an economic slowdown in China and political tensions in Hong Kong, and said its export turnover in the region declined by 3.1 per cent.—AFP

US-Taliban breakthrough appears closer as Ghani reports progress

KABUL — The US and the Taliban appeared closer Wednesday to a breakthrough in talks over an American troop withdrawal from Afghanistan, after Afghan President Ashraf Ghani said there had been "notable progress" in negotiations.

Washington and the insurgents have been locked in gruelling discussions that have stretched over more than a year for a deal that would see the US pull thousands of troops out of Afghanistan.

In return, the Taliban would provide various security guaran-

tees and launch eventual talks with the Kabul government.

In a series of tweets late Tuesday, Ghani said US Secretary of State Mike Pompeo had called him to inform him of developments in the talks, which are taking place in Doha.

"Today, I was pleased to receive a call from @SecPompeo, informing me of the notable progress made in the ongoing peace talks with the Taliban," Ghani said on his official Twitter account.

"The Secretary informed me about the Taliban's proposal with

regards to bringing a significant and enduring reduction in violence."

A Taliban source in Pakistan told AFP that insurgent and US negotiators would meet again Wednesday in Doha. Citing Afghan and US officials, the New York Times reported that US President Donald Trump had given conditional approval to a deal with the Taliban. —AFP ■

Pakistan jails Mumbai terror attack suspect, says lawyer

ISLAMABAD — The alleged mastermind of a deadly attack on India's financial capital over a decade ago has been jailed in Pakistan for nearly six years on separate terror charges, his lawyer said Wednesday. Hafiz Saeed was found guilty of "being part of a banned terrorist outfit" and for "having illegal property", his lawyer Imran Gill told AFP

He is wanted in India for allegedly planning a shocking 2008 attack in Mumbai, when 10 Islamist militants armed with assault rifles, hand grenades and other explosives killed 166 people and injured hundreds more on a three-day rampage.

Lawyer Imran gill gave no details about Saeed's conviction apart from saying he would be kept in prison in the eastern city of Lahore. The firebrand cleric — declared a global terrorist by the United States and United Nations, and with a \$10 million bounty on his head — is the leader of the Jamaat-ud-Dawa Islamist charity.

Its militant wing Lashkar-e-Taiba is believed by Washington and Delhi to be responsible for the Mumbai attacks.

Saeed has denied involvement, but has spent years in and out of varying forms of detention in Pakistan, sometimes under house arrest, on various charges.—AFP■

Rights groups want swift hand over of Sudan's Bashir to ICC

KHARTOUM — Rights groups pushed Wednesday for the swift handover of Omar al-Bashir to the International Criminal Court after Sudan's new authorities pledged to bring the ousted strongman to justice for alleged war crimes in Darfur.

Top Sudanese officials said Tuesday that the country's new rulers had agreed with rebel groups to send Bashir and three former aides to The Hague-based court for their role in the conflict in the western Darfur region. "The Sudanese authorities should translate these words into action and immediately transfer al-Bashir and other individuals (facing ICC arrest warrants) to The Hague," Amnesty International acting secretary general Julie Verhaar said. "Omar al-Bashir is wanted by the ICC over the murder, extermination, forcible transfer, torture and rape of hundreds of thousands of people during the conflict in Darfur.– AFP

Libya's easternbased army denies UN planes to land in Libya

TRIPOLI — The United Nations Support Mission in Libya (UN-SMIL) Wednesday said that the eastern-based army had denied to grant permission for the mission's planes to land in Libya.

"The UN in Libya regrets that its regular flights, which transport its staff to and from Libya, are not granted permission by the LNA to land in Libya. This practice has been repeated on several occasions in the past weeks," UNSMIL said in a statement. The eastern-based army's move "will severely hinder UN's humanitarian effort at a time when all UN staff are working relentlessly to push forward the ongoing intra-Libyan dialogue and to provide humanitarian assistance to the civilians," the statement said. In late November of 2019, the eastern-based army announced the imposition of a no-fly zone in and around the capital Tripoli where the armed conflict between the eastern-based army and the UNbacked government continues. – Xinhua 🔳

Bat for sale at Indonesia's wildlife market despite virus warning

JAKARTA — Bats, rats and snakes are still being sold at an Indonesian market known for its wildlife offerings, despite a government request to take them off the menu over fears of a link to the deadly coronavirus.

Vendors at the Tomohon Extreme Meat market on Sulawesi island say business is booming and curious tourists keep arriving to check out exotic fare that enrages animal rights activists. But scientists are debating how the new virus, which has killed more than 1,100 people in China and spread to dozens of countries around the world, was transmitted to humans. A wildlife market in Wuhan, the epicentre of the virus, is thought to be ground zero and there is suspicion it could have originated in bats.

Italy Senate votes on migrant trial for far-right head Salvini

ROME — Italian senators will decide Wednesday whether farright leader Matteo Salvini should face trial on charges of illegally detaining migrants at sea last year, for which he could be jailed for 15 years.

A court in Sicily has recommended that former interior minister Salvini stand trial for blocking migrants on a coast guard boat last July.

Under Italian law, ministers cannot be tried for actions taken while in office unless a parliamentary committee gives the go-ahead.

That committee voted in January to strip the anti-immigrant head of the Lega party of his parliamentary immunity, and now the final decision rests with the Senate.

A simple majority of 319 senators is required, with the result of the vote likely to be known on Wednesday afternoon.

Before the debate began, Salvini took to Facebook to say

that he had his "head held high. with the calm conscience of those who have defended their land and people".

"If a man is not ready to fight for his ideas, either his ideas are worthless, or he is," Salvini wrote.

Salvini had refused to allow 116 rescued migrants off of the Gregoretti coastguard boat where they had been languishing for about a week in insalubrious

conditions — until a deal was reached with other European states to host them.

A Catania court accused him of "abuse of power" in blocking them on board from July 27-31, 2019, and of illegally detaining them. Salvini insists the decision was not his alone, but had the backing of the government and Prime Minister Giuseppe Conte.— AFP

Sanders wins in New Hampshire as Biden crashes and burns

CONCORD — Bernie Sanders won New Hampshire's highstakes Democratic primary on Tuesday, according to US network projections, leaving rivals including party stalwart Joe Biden in his wake as he staked his claim to challenge President Donald Trump in November.

Sanders, the flag-bearer for the party's progressive wing, had 26 percent of votes with most of the count complete in the northeastern state, where he routed Hillary Clinton in 2016.

"Let me take this opportunity to thank the people of New Hampshire for a great victory tonight," Sanders told cheering supporters after NBC and ABC called the result in his favor.

"This victory here is the beginning of the end for Donald Trump," the senator from neighboring Vermont added as raised the roof with his rallying cry for fairer taxes and health care reform

Indiana ex-mayor Pete Buttigieg finished in second place at 24 per cent as he readied for the more difficult battlegrounds ahead.

"Now our campaign moves on to Nevada, to South Carolina, to communities across our country. And we will welcome new allies to our movement at every step," he said.

Midwestern moderate Amy Klobuchar maintained a late surge to place third on about 20 per cent, while liberal Elizabeth Warren finished in fourth at about nine per cent.

Trump weighed in, tweeting: "Bootedgeedge (Buttigieg) is doing pretty well tonight. Giving Crazy Bernie a run for his money. Very interesting!" Trump tweeted

After months atop the pack, Biden had already conceded he expected to do badly in New Hampshire, as he did a week earlier in Iowa — and the former vice president's worst fears were beginning to materialize as he languished in fifth with just over eight per cent.— AFP ■

Ukrainian President Zelensky hopes for elections in E. Ukraine this fall

KIEV — Ukrainian President Volodymyr Zelensky said that he feels it will be possible to hold the elections in the East of Ukraine this fall, Interfax-Ukraine reported on Tuesday.

In an exclusive interview with the news agency, the president underlined that it is possible only after the active phase of the conflict stops in the East of Ukraine, and the foreign armed forces are withdrawn from the

territory of Ukraine.

"Once we agree, we will still need about three months, at least, to ensure security for everyone -- for journalists, for the CEC, for the observers ... I believe that it is possible, for some reason, I have such a feeling," said Zelensky, noting that much will become clear after the Normandy Four summit scheduled for April this year.

In October 2019, Ukraine,

Russia and the Organization for Security and Cooperation in Europe (OSCE) signed the accord known as the Steinmeier Formula, giving the green light to the elections in the East of Ukraine.

In December 2019, the leaders of Ukraine, Russia, France and Germany met in Paris for the Normandy Format summit dedicated to resolving the conflict in the East of Ukraine. -Xinhua

Morrison called the failure to give indigenous children equal opportunities to other Australian kids "a national truth and a national shame". The admission comes 250 years since Captain James Cook's first voyage to the vast continent, a journey that led to British colonisation and up-

The life expectancy for Aboriginal Australians is about eight years lower than the national average. Indigenous children are twice as likely to die before their fifth birthday and 25 times more likely to be incarcerated than the rest of the population, according to official statistics. The report marks 12 years since former prime minister Kevin Rudd made a historic apology to Aboriginal people for centuries of injustice and launched the "Closing the Gap" initiative.— AFP ■
