Opening address of State Counsellor

NRPC Chairperson State Counsellor Daw Aung San Suu Kyi gave a speech. She said as everyone knows, Myanmar has not been able to resolve the issues of different ideological con-

the democratic transition, there have been differences of opinion among us as to what kind of programmes we need to pursue and what kind of steps we need to take in the establishment of the Democratic Federal Union; this is natural; it is not possible to give undue pressure in order to transform all the differences of opinion to reach conformity and merge into one single view; as an initial step we had to strive towards a common agreement as to how we should march towards a Union, although we had to contend with more than 70 years of differences of opinions; we had to share understanding and build trust; in order to establish understanding and trust, it is very important to be able to have empathy for the wounds, feelings, pain and desires of our ethnic nationals.

Today we have been able to reach an agreement for the establishment of the Democratic

Today during our era and time, everyone has accepted the fact that the establishment of a Democratic Federal Union is the solution for resolving the issues of national equality and national unity which are the root cause of armed conflicts.

flicts and conflicts arising out of demands for equality which we have faced at the same time as independence; the result of this was efforts to resolve these matters using arms leading to armed conflicts and endless armed battles: that was how we have reached the present situation. She continued, although attempts have been made for national reconciliation and peace throughout the different periods using different methods and approaches, at the present time after more than 70 years we are still striving; today during our era and time, everyone has accepted the fact that the establishment of a Democratic Federal Union is the solution for resolving the issues of national equality and national unity which are the root cause of armed conflicts.

However, with respect to

Federal Union, by conducting round tables and from these round tables, in spite of differences of opinion, we have arrived at a step-by-step approach, a detailed programme which is acceptable to everyone; this is Part 3 of the Union Accord to be signed at the Union Peace Conference - 21 Century Panglong Fourth Session which has been presented by both the working groups. This Accord would be able to show a clear path for resolving the present political difficulties and the difficulties for establishing the Democratic Federal Union by linking these to amending the Constitution.

We need to see the reality that this Accord is not perfect nor complete; we need to accept this fact; in the post 2020 period, in the step-by-step programmes and step-by-step implementation

process, although we have been able to come up with (8) main titles, there is still a need for us to continue our negotiations about the detailed programmes; we need to have detailed discussions regarding how to proceed with the step-by-step programmes as to when the states should draft their constitutions, and how to proceed step-by-step with regard to the distribution of power between the Union and the states; how to carry out the process of security integration at what stage and in what manner; all these need to be implemented in harmony and balance.

No matter what, Part 3 of the draft Union Accord presented at this meeting by the working group was not produced easily; our peace process went through many ups and downs and highs and lows after the end of the Union Peace Conference - 21 Century Panglong Third Session which was held in August of 2018; because it was not possible to convene official meetings, we could say that we experienced a stalled NCA process; during this time our NRPC conducted informal meetings, and official meetings separately and in groups; these were done many times; in order to reactivate the stalled NCA process and resume the peace negotiations, we used many different approaches by considering many methods.

We negotiated until agreement was reached with respect to the practical problems that came up after the signature of the NCA agreement. These included the root causes of incidents at the lowest level among combatants; these were reviewed objectively and views were exchanged between the two groups; discussions were made as to how to find a solution acceptable to all parties; for problems which could not be immediately solved at the present moment, we thought about the problem in many ways so as to adopt an action plan to solve the problem in the longterm. To find a path which has harmony and balance between political aspects and military aspects, we sought to find how to create a better path which could overcome all difficulties of the past. Workgroups of both sides negotiated tirelessly to seek a future path that would be com-

fortable for all parties concerned.

She added that it was found that the draft agreement was made after serious and intensive discussions with the strenuous efforts among the stakeholders; meetings and discussions were also made through videoconferencing due to the outbreak of COVID-19 pandemic; all the stakeholders in peacemaking process are expressed thanks for their energetic efforts despite many challenges.

The State Counsellor said that it will take times for democratic reform and establishment of a federal union, while the country is working for national reconciliation and peace of the Union simultaneously; after considering the connection between these long-term processes and the amendment of Constitution, the way which encompasses the whole mechanism have been identified, and the route must be taken to erase bitter experiences of the past, to address ongoing problems of the Union and to make the dream of future Union for all the national people

The global countries are fighting against the COVID-19 pandemic which is a common challenge for all; however, different managements have turned vigilant against this disease.

Although Myanmar is seen as the country with conflicts, people collaboratively faced against the pandemic and the disease has been under control.

Peace negotiation could not be made and NCA process came to a halt in the past, however, the situation has improved and the 21st Century Panglong Conference will be held soon; some political agreements have been made; these are the steps towards the emergence of a democratic federal union, national reconciliation and lasting peace in the country.

The State Counsellor emphasized the seriousness of stakeholders in peacemaking processes has generated success; more efforts are needed for the emergence of a democratic federal union and peace; the existing reciprocal understanding and trusts are important steps forward.

She also urged all the stakeholders to strive for peace which is required for the posterity.

Deputy Commander-in-Chief of Defence Services Vice Senior General Soe Win also delivered a speech, saying that implementation of NCA through the results from political dialogues is a crucial step for eternal

2020 MULTIPARTY DEMOGRACY GENERAL ELECTION



The General Election will be held on 8 November 2020.

- Union Election Commission has announced the first edition of eligible voter lists at local offices of the commission in respective wards/village-tracts, in the villages from 25 July 2020 to 7 November 2020.
- If the name of any eligible voter is not included in the list, voter registration can be requested by filling in Form 3.
- Objection can be filed against any ineligible voter in the list by using Form 4.
- Correction for voter list can be requested by using Form 4 (c).
- Voters can cast their votes only if their names are included in the voters list.
- Cooperation is requested for at least one member of each family to check their names without fail to ensure a complete and correct voters list
- Check the voters lists not to lose voting rights by filling up discrepancies, deleting and making corrections.



Section 58 (d) in Hluttaw Election Law



IN accordance with section 58 (d) of the Hluttaw Election Law, no one is allowed to give speeches at meetings, instigation, writing, distribution of using posters or attempting by other means to disturb the voting or election. Anyone who is found guilty of or abet this act shall be punishable with imprisonment for a term not exceeding one year, or with fine not exceeding K100,000 (one hundred thousand Kyats), or with both.

The 9th edition of JICM was the outcome from implementation of decisions in its 8th edition meeting; the ongoing discussions should be based on the agreements of workgroups made in their preliminary discussions; more preliminary agreements should be turned out; the workgroups met four times before the 9th edition of JICM; although some meanings have been defined in NCA, the terms were discussed again not to deviate from their senses, delaying for discussing new issues; bilateral discussions again for amending the existing agreements such as bilateral/parallel negotiations, the words such as the federal security system which are not included in the NCA; these issues have delayed further steps, and that it is required for speeding up the discussions of civil organizations.

The Vice Senior General also suggested to adopt a suitable democracy and federal system for the country without copycatting other styles and allowing to accept the formats forced by others, with giving an example of fitting a dress with the specific body size.

He also emphasized the Our Three Main National Causes, the own situations of the country, removing mistrust among the stakeholders in peacemaking He also quoted Article 354 of the Constitution concerning freedom of expression in the discussions about future processes beyond 2020.

The Vice Senior General finally advised to make peace negotiations in line with the Constitution and the situations of the country and the unity of national people in facing against the challenges; closed-door policy is no more appropriate in the period of IT and globalization; national interest must be considered in international relations; the establishment of the Union based on democracy and federal system through political dialogues; the Tatmadaw is enthusiastic about the lasting peace of the country.

Republic of the Union of Myanmar Ministry of Health and Sports Order 88/2020

10th Waning of Second Waso, 1382 ME 13 August 2020

THE Ministry of Health and Sports has issued this order under the authority of Article 21 (b) of the Prevention and Control of Communicable Diseases Law.

- The Ministry of Health and Sports has issued Order 37/2020 on 16-4-2020 and Order 56/2020 on 28-5-2020 to prohibit from gathering five or more than five persons exception for some reasons, to curb the spread of Coronavirus Disease 2019 (COVID-19) and to implement preventive measures. The ministry announced modification of these orders with Order 79/2020 on 1 August 2020, increasing the number of persons in gathering from five to 15 or more than 15 persons.
- 2. The Ministry of Health and Sports has re-issued this new order that will take effect on 16-8-2020 to increase the limited number of persons to less than 30.
- 3. The Prevention and Control of Communicable Diseases Law will apply to those who breach the orders and instructions related to the COVID-19 issued by the Ministry of Health and Sports and the Public Health Department.

Termination of registration and dissolution of a political party

The Union Democratic Party fails to contest as Hluttaw candidates from its party in at least three constituencies in the General Elections to be held on 8 November, 2020. The Union Election Commission (UEC) decided in its plenary meeting (30/2020) on 13-8-2020 to terminate the registration of Union Democratic Party as a political party and to dissolve it in line with Section 12(b) of the Political Parties Registration Law.

The Vice President firstly inspected the completion of San Kite school building of No (1) B.E.H.S in Tiddim together with Union Minister Dr Myo Thein Gyi, Chin State Chief Minister Salai Lian Luai, Deputy Ministers and other officials and Union Minister for Education Dr Myo Thein Gyi and Headmaster U Im Khan Mone explained the operation of school building.

The Vice President met town elders of Tiddim at the school and attended the ceremony of issuing national scrutinity cards under "Thitsa Project".

The 2020 Multiparty General Election will be held on 8 November, said the Vice President, adding working plans in the relevant regions and states not to lose voting rights of all eligible voters and to cast their votes, concerted efforts of relevant sub-election commission, General Administration Department and Ministry of Labour, Immigration and Population, announcement of voter lists at the relevant wards and villages, some requirements in the released voter lists and importance of correct voter lists.

In order not to lose voting rights, the relevant region, state, district and township offices under the Department of Immigration and Department of Population also conduct field projects regarding official household lists and ID cards which are the needs of ordinary migrants and temporary migrants under Thitsa Project and the Chin State General Ad-

ministrative Department, Election Commission, Department of Immigration and Population and other officials should keep cooperating in unity, he added.

Chin State Chief Minister Salai Lian Luai, Speaker of Chin State Hluttaw U Zo Bawi and Deputy Minister of Labour, Immigration and Population U Myint Kyaing presented the ID cards to the local residents.

During the second section of ceremony, the Vice President explained his inspection trip to Chin State where is difficult to get one place to another during rainy season, Myanmar ranks at a certain level out of the world countries to control the COV-ID-19 pandemic because of the concerted efforts of the government, civil service, organizations and the citizens.

He also expressed hope that the government and the public will strongly overcome any disaster together in unity and instructed to follow the health guidelines released by the Ministry of Health and Sports.

It is important not to lose the voting rights of eligible

voters in upcoming election on November 8, since every person over the age of 18 gets the opportunity only once in every five years, it is necessary to ensure that the eligible voters do not lose their votes, the relevant departments should urge the people to go and check the voters lists whether their names are in the lists and all must cooperate to cast the votes systematically in line with the laws, rules, procedures, regulations and directives.

Tiddim town elder U Khin Swin Mone discussed designation of Tiddim as district town, water access from 18 miles for water security, upgrading 100-bedded hospital into 200-bedded hospital, receiving electricity from the national grid, opening school of science and technology and construction of township-level hall and Union Minister Dr Myo Thein Gyi, Chin State Chief Minister Salai Lian Luai, Deputy Ministers U Tin Myint and U Khin Maung Win and Director General U Soe Oo joined the discussion.

The Vice President presented cash assistance to volunteer

group of Tiddim that participated in fight against of COVID-19.

The Vice President and party arrived at a silk farm in Tonzang Township and farm manager U Harain Htaung Htang explained the detail of the farm.

The Vice President inspected the construction of multi-purpose cyclone shelter and Township Administrator Salai Htaung explained the facilities.

Chin State Chief Minister U Salai Lian Luai, Chin State Minister U Paung Lon Min Htan and Director-General U Win Naing Tun explained the completion status of the multi-purpose cyclone shelter, status of completed cyclone shelters and related work in cyclone shelters, completion of disaster prevention work funded by the National Natural Disaster Management Committee, construction works for war victims and the submission of the work to be carried out to the National Natural Disaster Management Committee and the Vice President asked what he wanted to know.

The multi-purpose cyclone shelter is 60 feet long and 70 feet wide and was built with K224 million.

During the meeting with Mayors of Tonzang Township at the Township's General Administration Department, the Vice President said that the government was fulfilling the requirements of the township and that he came to inspect the implementation and know the requirements to be fulfilled. He also said that the township was located near the border area of Chin State, the focus is on development needs more than other areas.

The Vice President urged the people to cooperate with the responsible persons of the department in accordance with the rules and regulations of the Union Election Commission for the successful convening of internationally recognized election and to ensure that the voters lists for the upcoming election are accurate and those who have the right to vote do not lose their right to vote.

It is a truss bridge type and is being built at a cost of K4.050

Var Bridge No.1 was temporarily closed due to the flooding of the Manipur River during Cyclone Koman in 2015. If the river level rises more, it will be

dangerous for the Var Bridge and due to possible communication loss of Kalay-Falan-Hakha Road, the construction of Var Bridge No.2 is underway.—MNA

MoHS braces itself for second wave of COVID-19

THE COVID-19 Central Command Centre of Ministry of Health and Sports conducted the Central-Level Table-Top Exercise in preparation for effective response to possible second wave of COVID-19 yesterday morning.

During the ceremony, Union Minister Dr Myint Htwe said although the disease is controlled to a certain extent, some people fail to follow the health guidelines in most of the places and the ministry will keep carrying out the preventive measures not to occur second wave of COIVD-19.

The Table-Top Exercise is held to serve the systematic response by referencing the rules of epidemics if there is second wave of COVID-19 in the country, he said, adding continuous study on infections of neighbouring countries and world nations.

He also said that this Table-Top Exercise will mainly focus on how to control the disease during the second wave, how much time or human resources will be needed to respond to the disease including the laboratory test, restrictions and treatment and how to conduct division of labour to the relevant sectors and organizations by analyzing the current situation.

According to this discussion, it needs to fulfill the required things as quickly as possible and to designate further standard operation procedures and criteria if necessary and the responsible persons or experts of the ministry should prepare and hold such Table-Top Exercise regularly to improve the skills in response

MSWRR provides support to IDPs in Kachin

UNION Minister for the Ministry of Social Welfare, Relief and Resettlement Dr Win Myat Aye yesterday visited two villages in Kachin State where former IDPs returned to their homes, and inspected the process of rehabilitation.

The Union Minister was accompanied by the Deputy Minister, the Kachin State Chief Minister, regional ministers, the Director-General of the ministry, and other relevant officials. The visit of the Union Minister and his entourage also reflects implementation of the "agreements in social sector basic principle" included in the Union Accord and the COVID-19 Economic Relief Plan (CERP).

The Union Minister and his entourage visited Nansangyang Village in Waingmaw Township, Kachin State, and said words of encouragement to the former IDPs. The Union Minister went

the villagers, the Union Minister said that the government is giving higher priority to ethnic matters and national peace, and providing assistance to IDPs. He informed the villagers that the National Strategy on Resettlement of Internally Displaced Persons (IDPs) and Closure of IDP Camps has al-

ready been drafted, approved, and implemented. He also explained the ministry's works for various matters including providing aid to vulnerable groups, anti-drug efforts and education.

Speaking on alleviating the impact of COVID-19 crisis, the Union Minister said that the government is implementing the CERP. During the meeting, the Deputy Minister, the Kachin State Chief Minister and the Director-General also explained their works. In accordance with the CERP, the Ministry gave K40,000 to each of the 98 households in the Nansangyang Village (total K3.92 million), and handed over K1.5 million to the relevant officials for creating "Child Friendly Space". The Kachin State government provided 16 rice bags for the households in the village.

Similarly, the Union Minister and his entourage visited Dabatyang Village and said inspiring words to the villagers.

For resettlement of IDPs in the Kachin State, China recently contributed Yuan 4 million. Yesterday, the Union Minister handed over the money to the Kachin State Chief Minister Dr Khet Aung at the Kachin State Government Office in Mvitkvina.

The Union Minister and his entourage also handed over a total of K353.6 million for 8,840 households (K40,000 per household) in the IDP camps in Kachin State, K203.6 million for disabled persons in the state, K25 million for elderly persons in the IDP camps, K151.1 million as social pension for the last quarter of 2020, and K3 million for creating "Child Friendly Spaces" in the two villages. Coronavirus pushing much of the world into record slumps

THE coronavirus pandemic has pushed most of the world's major economies into unprecedented contractions in the second quarter, except for China which escaped a recession.

Here are the second quarter changes in gross domestic product (GDP) compared to the previous quarter for the world's top economies. Unless stated otherwise, the figures are from the national statistics institutes.

Europe's top economy was hit less hard by the coronavirus than its neighbours, but still saw its GDP fall by 10.1 per cent in the second quarter.

As GDP had already declined by 2 per cent in the first quarter, Germany's economy met the definition of a recession: two consecutive quarters of contracting GDP. Germany's previous record for a quarterly GDP drop: 4.7 per cent in the first quarter of 2009.

economy was in a longer and stricter lockdown than its eastern neighbour, and second quarter GDP fell more steeply, by 13.8 per cent, after a drop of 5.9 per cent in the previous three months. Previously the worst quarterly GDP growth in France happened in 1968 because of a general strike in May of that year.

Italy's growth was impacted very early on by the coronavirus which hit its richest region, Lombardy, particularly hard. Italian GDP fell by 5.4 per cent in the first quarter and then by 12.4 per cent in the second, pushing the country into recession.

After a 5.2 per cent drop in the first quarter, Spain's economy contracted a further 18.5 per cent in the second, notably because of a 60 per cent drop in tourism income and a fall by one third in exports.

The eurozone's overall GDP The eurozone's number two plunged 12.1 per cent in the three

months to June, after 3.6 per cent in the first quarter, making the second quarter downturn "by far" the worst since statistics agency Eurostat started compiling growth data for the area in 1995. **United Kingdom**

The UK suffered the worst **United States**

recession in Europe in the first two quarters of the year, also recording the highest number of coronavirus deaths in Europe. GDP fell 20.4 per cent in the second quarter after a 2.2 per cent drop in the first.

The United States, the world's top economy, suffered a 9.5 per cent slump in the second quarter following a 1.3 per cent drop in the first, according to figures published by the OECD. The US government publishes annualized figures (-32.9 per cent

in the second quarter), a method that is not comparable with most other countries.

China

China, the world's second-largest economy, may have been where the novel coronavirus originated, but thanks to strict lockdown measures it was able to largely halt the spread of the virus and reopen factories, thus avoiding a recession.

In the second quarter its economy rebounded by 11.5 per cent, having fallen by 10 per cent in the first quarter. Still, growth for this year will be much below what China has become accustomed to for decades. Japan

Japan announced in mid-May it was already in recession when first quarter GDP slid by 0.6 per cent after a 1.9 per cent drop in the final quarter of 2019. The world's number three economy has yet to publish second quarter GDP figures.—SOURCE: AFP

Unfortunately, the coronavirus isn't merely a health crisis. This means that an income shock of RM1,000 (US\$238) will add 12.3 per cent more poor households.—

9th JICM produces 7 points of agreements, UPC set for 19th August

THE 9th Joint Implementation Coordination Meeting (JICM) for the Nationwide Ceasefire Agreement (NCA) was held at MICC-1 in Nay Pyi Taw yesterday and Director-General U Zaw Htay of the Ministry of the State Counsellor's Office and New Mon State Party's executive committee member Nai Aung Ma Ngay answered to journalists in a press conference afterwards.

Agreement on 7 points

U Zaw Htay first said that they achieved 7 points of agreement in this meeting as a result of discussing the decisions made at the 8th JICM for the past 8 months. He said these agreements will be further submitted to the UPDJC and inked at the peace conference. He said Part III of the Union Accord is different from Parts I and II and the meeting agreed for practical successive implementation processes as well. He said they were drawn collectively based on the three stages of transition for democracy and federalism each.

U Zaw Htay said both the discussion and implementation processes follow three stages too with the first stage set for political dialogue, the second stage for technological discourse, and the third stage for implementation. He gave an example that if a point on federalism reached an agreement then the first step would be to discuss a political agreement framework, the

second would be to discuss the different work processes from a technological perspective after which implementation would be carried out and even incorporate possible amendments to the Constitution.

U Zaw Htay said the Union Accord encompasses national reconciliation and peace, much like the State Counsellor said in her opening speech, in addition to establishing a democratic federal republic and making amendments to the Constitution. He said the result of achieving practical and effective steps for implementation is unique and significant.

Acknowledging peace efforts

U Zaw Htay said they have conferred awards and certificates for steering peace to leaders of both sides that have participated in the JICM meetings between 2016 to 2020. Similarly, he said they will confer awards for implementing peace to the 48 individuals that have participated in the UPDJC from 2016 to 2020. They will also confer awards for conserving peace to EAO and government leaders that participated in JMC-U meetings within the same period.

U Zaw Htay said the State Counsellor will confer these awards in her capacity as Chairperson of the National Reconciliation and Peace Centre (NRPC). The reason for giving out these awards was mentioned in the State Counsellor's closing speech as the peace process being difficult and despite it almost fading away, everyone helped to bring back on the track towards the NCA and they will be recognized for their efforts.

Agreement to 7 points

Next, Nai Aung Ma Ngay also said they achieved 7 points of agreement at this 9th JICM meeting and explained four of them in detail. He said the first point of agreement was related to ceasefire and discussion formats talked about between NCA signatories and the government on 22 June 2020. He said it mainly involves chapters 3 and 4 of the NCA and an agreement on how

separate and collective discussions should be carried out.


The second point of agreement is divided into 3 parts in the Union Accord, said Nai Aung Ma Ngay. The first part achieved 15 points of agreement for an implementation framework for the NCA, the second part achieved agreement on 8 topics in Table-1 of implementation plans for post-2020, and the third part was the achievement of 5 guiding principles for establishing a democratic federal republic. All three parts were agreed to be signed into the Union Accord.

Nai Aung Ma Ngay then said the fourth point of agreement concerned Table-2 for continuing implementations in the year 2020. He said they agreed to discuss Table-2 as a principle and will go into detailed discussions for sub-headings at another point in time. He said they have yet to reach an agreement on 3 points but they have decided to put on record the agreements made at the JICM meeting and to hold the peace conference from 19 to 21 August in Nay Pyi Taw with 230 representatives. He said they also agreed to encourage the non-signatories to sign the NCA.

Director-General U Zaw Htay and NMSP executive committee member Nai Aung Ma Ngay then answered questions raised by journalists at the press conference.—Myo Naing Hein (Translated by Zaw Htet Oo)

Yangon investment committee approves 2 foreign, 1 domestic projects with over 1,000 jobs

THE Yangon Region Investment Committee (YRIC) virtual meeting on 12 August has approved two foreign projects from China, and Samoa and one domestic project.

Those projects will bring in US\$6.964 million and K2.17 billion, creating 1,073 jobs. They will invest in manufacturing of foam mattress, camera bags and garments on a Cutting, Making, and Packing (CMP) basis, according to the Directorate of Investment and Company Administration.

The manufacturing sector has attracted the most foreign investments in Yangon Region, with enterprises engaging in the production of pharmaceuticals, vehicles, container boxes, and garments on a Cutting, Making, and Packing (CMP) basis.

The investments in the regions also flowing into the hotel services, and other services sectors as well. To date, foreign investments from China, Singapore, Japan, Hong Kong SAR, the Republic of Korea, Viet Nam, India, China (Taipei), Malaysia, the British Virgin Islands, Samoa and Seychelles are arriving in the region.

Yangon Region tops foreign investments among the regions and states, attracting more than 600 enterprises over the four years of the incumbent government, according to the Directorate of Investment and Company Administration (DICA).

According to DICA statistics, Yangon Region absorbs 60 per cent of all investments in Myanmar, Mandalay attracts 30 per cent, while the other regions and states receive only a small share of investments.

The Myanmar Investment Commission (MIC) and the respective investment committees have granted permits and endorsements to 905 foreign enterprises between 2016-2017 financial year and as of May-end in the 2019-2020FY, with estimated capitals of US\$22.39 billion.

Of 51 foreign countries, Singapore put the largest investments, followed by China and Thailand.

MIC is prioritizing the labour-intensive businesses. In the incumbent government period, domestic and foreign projects employ over 500,000 residents, according to the DICA.—GNLM (Translated by Ei Myat Mon)

Hong Kong-based company to employ over 8,000 workers in Bago Region

HONG KONG-BASED Glamoroso Apparel (Myanmar) Co., Ltd will develop a factory on 20 acres of land in the industrial zone in Bago Region, creating over 8,000 jobs for the locals.

General Manager Mr Lau Siu Kin of Glamoroso Apparel (Myanmar) Co., Ltd and Bago region factory establishment and supervisory committee secretary U Khin Maung San signed a land lease agreement on 12 August.

At the leasing event, Bago Region Chief Minister U Win Thein gave the remark that the region is always open to the investors and the regional government will support them in line with the law. "The investments can create job opportunities for local people and help boost

state revenue. The company will engage in the manufacturing of apparel. It has also grasped a market share in European countries," he added.

Bago Region Chief Minister U Win Thein, the relevant ministers, the region auditor-general, the region attorney-general, the region cabinet secretary, officials concerned and representatives from the company attended the signing event.

The investments in the Bago region primarily flow into the manufacturing business.

Nearly 90 foreign businesses are being implemented in the Bago Region, according to Bago Region Investment Committee.

At present, India, which suffers from the serious outbreak of the coronavirus pandemic and is ranked the world third, is less buying the beans in this period. So, the pigeon peas and black beans are not selling well these days. The prices of the bean have also dropped these days. The price of chickpea was K27,000-K28,000 per basket in February and March. At present, the price of chickpea is K23,500-K24,000 per basket. The price of chickpea


dropped to K3,000-K3,500 per basket. The prices of a variety of beans have also declined. The coronavirus has adversely affected the businessmen," he said.


"The price of black bean has not significantly dropped. But there is low stock in the market. The price of sesame is rising in the market and has reached a minimum of K48,000 per basket. The production of the sesame has also declined. This is the reason why the price of sesame has increased. During the pandemic period, the production has dropped and so the prices of the products are rising," said U Thein Oo, a trader at Monywa Depot.—Myo Win Tun (Monywa)

US holds off on extra tariffs in EU Airbus dispute

WASHINGTON — Washington said Wednesday it would hold off on its threat to impose higher tariffs on \$7.5 billion worth of EU goods in its long-running dispute over subsidies to European aircraft maker Airbus

Last year the World Trade Organization authorized the US to impose tariffs of up to 100 per cent on \$7.5 billion in European goods.

Washington then slapped 25 per cent taxes on a number of EU products including wine, cheese and olives. A 10 percent tariff on Airbus planes was increased to 15 per cent in March.

The European Union last month said it had brought itself into compliance with WTO rulings and called for the tariffs to be lifted.

Washington said Wednesday the bloc had

not done enough but signaled it was willing to seek a solution.

"The EU and member states have not taken the actions necessary to come into compliance with WTO decisions," US trade representative Robert Lighthizer said in a statement.

"The United States, however, is committed to obtaining a long-term resolution to this dispute.

"Accordingly, the United States will begin a new process with the EU in an effort to reach an agreement that will remedy the conduct that harmed the

US aviation industry and workers and will ensure a level playing field for US companies."

In June it had threatened to levy tariffs on another \$3.1 billion in EU goods as it has been authorized to do under a WTO ruling.—AFP■

US says Iran forces board ship in international waters

DUBAI — Iranian forces boarded a tanker in international waters, using a helicopter and two ships to take over the vessel, the US Central Command said in a tweet on Wednesday.

"Today in international waters, Iranian forces, including two ships and an Iranian "Sea King" helicopter, overtook and boarded a ship called the 'Wila'," Centcom said.

It also posted grainy black-and-white footage of a helicopter hovering low over a vessel, and what appeared to be two personnel rappelling onto the deck.

The ship was most recently positioned near the Strait of Hormuz -- a chokepoint for a third of the world's seaborne oil – after floating off the eastern coast of the United Arab Emirates for about a month, Bloomberg said citing its tracking data.

It said the vessel is a Liberian-flagged chemical and oil products tanker, and that it had stopped in July near the Iraqi oil terminal of Al-Basra where its draft increased, indicating it had picked up a shipment.

Iran and its arch enemy the United States have traded barbs in the past year over a spate of incidents in the sensitive waters of the Gulf. The escalation of Iran-US tensions last year saw ships mysteriously attacked, drones downed and oil tankers seized in the strait.—AFP

Facebook launches US voting information centre

CAMBRIDGE — Facebook on Thursday launched a voting information centre as part of its campaign to help millions of voters register for November's US presidential election and counter misinformation.

The hub accessed from the menu on Facebook and Instagram "will serve as a one-stop-shop to give people in the US the tools and information they need to make their voices heard at the ballot box," the social media giant said.

It is the latest effort by the platform to prevent a repeat of the online disinformation that marred the 2016 US election.

Facebook said the voter information tool would also help people navigate the changes to voting pro-

cedures being brought in by various states due to the coronavirus pandemic.

"It is also important that we help protect the integrity of our elections," the San Francisco-based social media giant said.

Facebook and Instagram users can use the tool to check if they are registered to vote and how to do so if they are not.

The social media

group said it would from Thursday add labels to voting-related posts on Facebook and Instagram. after last month rolling them out for politicians. —AFP ■

Against the odds, Chinese companies still committed to U.S. market: survey

WASHINGTON — Against the odds of escalating anti-China rhetoric and ongoing uncertainty, Chinese companies continue to be committed to the U.S. market, according to a new survey by the China General Chamber of Com-

merce-USA (CGCC).

The 2020 Annual Business Survey Report on Chinese Enterprises in the United States, conducted in partnership with global auditing and consultancy firm PwC, found that more than half of Chinese companies operating in the United States have been adversely affected by the escalating anti-China rhetoric in recent months, with 36 per cent noticing identifiable financial losses.

Another challenge Chinese companies face in the U.S. market is barriers on immigration, which 42 per cent of respondents cited as a key area of concern for future growth, showed the survey that assessed around 200 Chinese enterprises in the United States.—Xinhua ■

Indonesia's palm oil export drifts down 11 pct in H1 as epidemic suppresses demands

JAKARTA — The volume of the crude palm oil (CPO) export from Indonesia edged down in the first half of this year as the novel coronavirus pandemic has eroded global demands of the commodity.

The Indonesian Palm

Oil Association (GAPKI) said that the shipment of the crude palm oil abroad shrank by 11 per cent to 15.5 million tonnes from January to June annualized, local media reported on Thursday.

Shops reopen at Yangon night market

YANGON night market on Strand Road closed during the COVID-19 pandemic, and it now reopens as usual.

"Small non-food shops have opened since June, with one or two remaining closed. Bars opened until 10:30 pm in mid-July. Now, there are 30 non-food shops, 97 food shops, 5 container restaurants and 8 container bars. And we are preparing another one to open. As for monthly rental fees, 25,000 kyats for small food shop and 13,000 kyats for secondhand shop. During the COVID-19 crisis, we reduce one-month rental fees for small shops and two-month rental fees for big container bars and restaurants," said A 25 Myanmar Development Co.,Ltd Director Ko Aung.

The night market has been opened since 2017. It has restaurants and night enter-

tainment programmes. There are bars, and shops selling Asian foods, European foods, Indian foods, Arabic foods as well as tea shops and local food shops. Although secondhand shops for mobile phones and electrical equipment opened

from 3 pm to 3 am, now they open from 3 pm to 10:30 pm because of COVID-19 crisis.

Since 2018, the former night market was handed over to the Yangon City Development Committee and it has been constructing the shops and public toilets. Now, 80 per cent of the constructions have been completed. The project is set to be completed in three years. — Thant Zaw Win

US to ease water rules after Trump's shower moan

WASHINGTON — The US government is looking at easing regulations on shower fittings following complaints from President Donald Trump who has regularly railed against water conservation rules in his quest for "perfect hair."

On Wednesday the Department of Energy (DOE) said it was proposing to amend the definition of a showerhead to allow multiple showerheads on a single fitting, which would get around water conservation measures brought in under president George H.W. Bush.

The 1992 rules established a maximum water use of 2.5 gallons per minute for showers but the amendment means that will apply to each showerhead rather than a single shower fitting.

The announcement comes after Trump complained about the lack of water pressure in showers. "Showerheads -- you take a shower, the water doesn't come out," he said in July at the White House announcing a rollback in regulations.—AFP

Biden, Harris appear together for 1st time as running mates

WASHINGTON — U.S. presumptive Democratic presidential nominee Joe Biden attended Wednesday a campaign event in his hometown of Wilmington, Delaware, together with Kamala Harris, his choice of Democratic vice presidential candidate, in what was the duo's first public appearance as running mates.

Postponed for several hours due to power outage on site, the event, held in a basketball venue, finally saw the former vice president and the senator from California walk out side by side, both donning masks.

"I picked the right person to join me as the next vice president of the United States of America and that's senator Kamala Harris," Biden said, praising the first African as well as South Asian-American woman to be nominated for vice president in a major party as being "smart," "tough," "experienced," and "a proven fighter for the backbone of this country - the middle class."

Sitting next to the podium and keeping social distance with Biden as he spoke, Harris, however, took off the mask as she listened to Biden, who

spoke without wearing the mask either.

Biden in his remarks pledged that a "Joe Biden and Kamala Harris administration will have a comprehensive plan to meet the challenge of Covid-19 and turn the corner on this pandemic", adding that they will adhere to "masking, clear science-based guidance", meanwhile "dramatically scaling up testing, getting states and local governments the resources they need to open the schools and businesses safely".

Harris, the daughter of a Jamaican immigrant father and an Indian immigrant mother, later took to the podium saying she was "incredibly honoured by this responsibility" of the vice presidency, and that she was "ready to work."—Xinhua ■

Greek FM visits Israel, agrees to resume Israeli tourism

JERUSALEM — Greek Foreign Minister Nikos Dendias and his Israeli counterpart Gabi Ashkenazi met in Jerusalem on Thursday and agreed on arrangements for renewing Israeli tourism to Greece.

Under the agreement, some 600 Israeli tourists could enter Greece every week and visit Athens, Corfu, Thessaloniki and Crete. The visitors will have to undergo two coronavirus tests, one before departing from Israel and the other upon their arrival in Greece. They will briefly stay in quarantine

until the results of the second test arrive.

"I welcome Greece's decision to allow tourism from Israel to Greece in the coronavirus era," Ashkenazi said in a statement released on his behalf. "I hope that other European countries will also adopt this decision," he added.

The Israeli foreign ministry said the meeting between the two ministers focused on "the importance of bilateral, trilateral (with Cyprus) and regional relations."

"The two ministers dis-

cussed regional developments, the challenges of stability and prosperity in the Mediterranean region," the statement read.

Dendias arrived in Israel on Thursday morning amidst escalating tensions between Greece and Turkey. He is expected to meet also Israeli Prime Minister Benjamin before flying back to Greece.

Israel is considered a "red country" due to its high COV-ID-19 morbidity rates and Israeli tourists have been barred from many European countries.

Italy orders virus tests on Croatia, Greece, Malta, Spain arrivals

ROME — Italy has imposed mandatory coronavirus testing for all travellers arriving from Croatia, Greece, Malta and Spain, and banned all visitors from Colombia, in a bid to rein in new infections.

"We must continue to be

cautious in order to protect the results obtained thanks to sacrifices made by all in recent months," Health Minister Roberto Speranza said after issuing the new rules, which will last until September 7, late Wednesday.

Health authorities worry in

particular that Italians returning from vacations abroad may be bringing home the virus and passing it on when people are crowding outdoors, on beaches, at festivals or parties during the summer.

Travellers arriving at an

airport, port or border crossing can choose from a number of options, including rapid tests on the spot, or the presentation of a certificate obtained within the last 72 hours which shows they are COVID-19 free.

They can also choose to car-

ry out a test within two days of entering Italy, but will have to stay in isolation until the results arrive.

Anyone found to be positive, including asymptomatic cases, must report to the local health authorities.—AFP ■

Myanmar National League to resume on 22 August

THE remaining matches of the MPT Myanmar National League 2020 season will be back into action on 22 August with strict COVID-19 standard operation procedure, according to an official statement released by the Myanmar Football Federation and the Myanmar National League Committee yesterday.

The MFF released an official announcement for restarting the football matches following a videoconference held on 12 August with State Counsellor Daw Aung San Suu Kyi, Permanent Secretary of Ministry of Health and Sports Professor Dr Thet Khaing Win, MFF President U Zaw Zaw and former Myanmar national team player and current Shan United keeper Thiha Si Thu.

The MNL 2020 season,

which will restart on 22 August, will end on 2 October, according to the MFF.

Currently, Hantharwady United is leading the MNL standing table with 27 points earned of nine wins and one draw after ten matches played.

Next, Ayeyawady United is standing in second place with 23 points of seven wins and two draws after nine matches played.

Former MNL champion Yangon United is in the third place with 20 points of six wins, two draws and one loss after nine matches played. Defending champion Shan United is sitting in the fourth place with 17 points of five wins, two draws and two losses after nine matches played.

Messi's toughest task as Barcelona face up to Bayern Munich

LISBON — Lionel Messi might never have been faced with a more daunting task at Barcelona than engineering a victory against Bayern Munich in Lisbon on Friday.

The only surviving former winners of European club football's greatest prize -- with five titles each -- meet in a heavy-weight Champions League quarter-final behind closed doors at the Estadio da Luz.

It is not often that Messi's Barcelona come into such a big

European tie as the underdogs, but they have this time, with Quique Setien's team having lost out to Real Madrid in the Spanish title race while Bayern appeared flawless on the way to winning a German league and cup double.

Messi is now 33, yet Barcelona appear more reliant on him than ever.

He scored twice against Bayern in the quarter-finals in 2009 when Barcelona went on to win the Champions League under Pep Guardiola.

He hit four against Arsenal the following year and five against Bayer Leverkusen in 2012 but on both occasions, Barca were favourites.

Messi also sank Real Madrid at the Santiago Bernabeu in 2011 when his double in the first leg of the semi-final, including one of the finest goals the competition has ever seen, transcended a rivalry that had been dragged to its ugliest point.

And he was part of perhaps the tournament's greatest comeback, the 6-1 destruction of Paris Saint-Germain in 2017 after Barcelona lost 4-0 in the first leg of that last-16 tie.

Yet this time threatens to be different. With Luis Suarez and Antoine Griezmann alongside him, Frenkie de Jong and Sergio Busquets behind him and Jordi Alba out wide, Messi should not be on his own.

Even in defence, Gerard Pique still has a claim to be the best defender in La Liga and Marc-Andre ter Stegen is among the most impressive goalkeepers in the world.

"Bayern are playing really well and are full of confidence but we have the weapons to beat them," Griezmann told Barca TV.—AFP ■

'That's what I want': Top-ranked Barty driven by Wimbledon dream

SYDNEY — World number one Ashleigh Barty won't have a chance to fulfil her dream of winning Wimbledon this year, but she remains laser-focused on being crowned champion at the All-England Club.

The Australian won the junior Wimbledon title as a 15-yearold in 2011, but the expectations that came with that success took their toll and she made a shock decision three years later to ditch tennis for cricket.

"In short, I think I needed just to find myself," Barty, who is skipping the upcoming US Open due to coronavirus fears, said in an interview Thursday (Aug 13) with broadcaster ABC of her move to the Brisbane Heat cricket team.

"I felt like I got twisted and maybe a little bit lost along the way in the first part of my career"

While cricket gave her "a different perspective about sport", the lure of tennis was never far away, driven by an ambition to taste success again at Wimbledon.

"My dream is winning Wimbledon. Without a doubt," said Barty, who returned to tennis in 2016.—AFP ■
