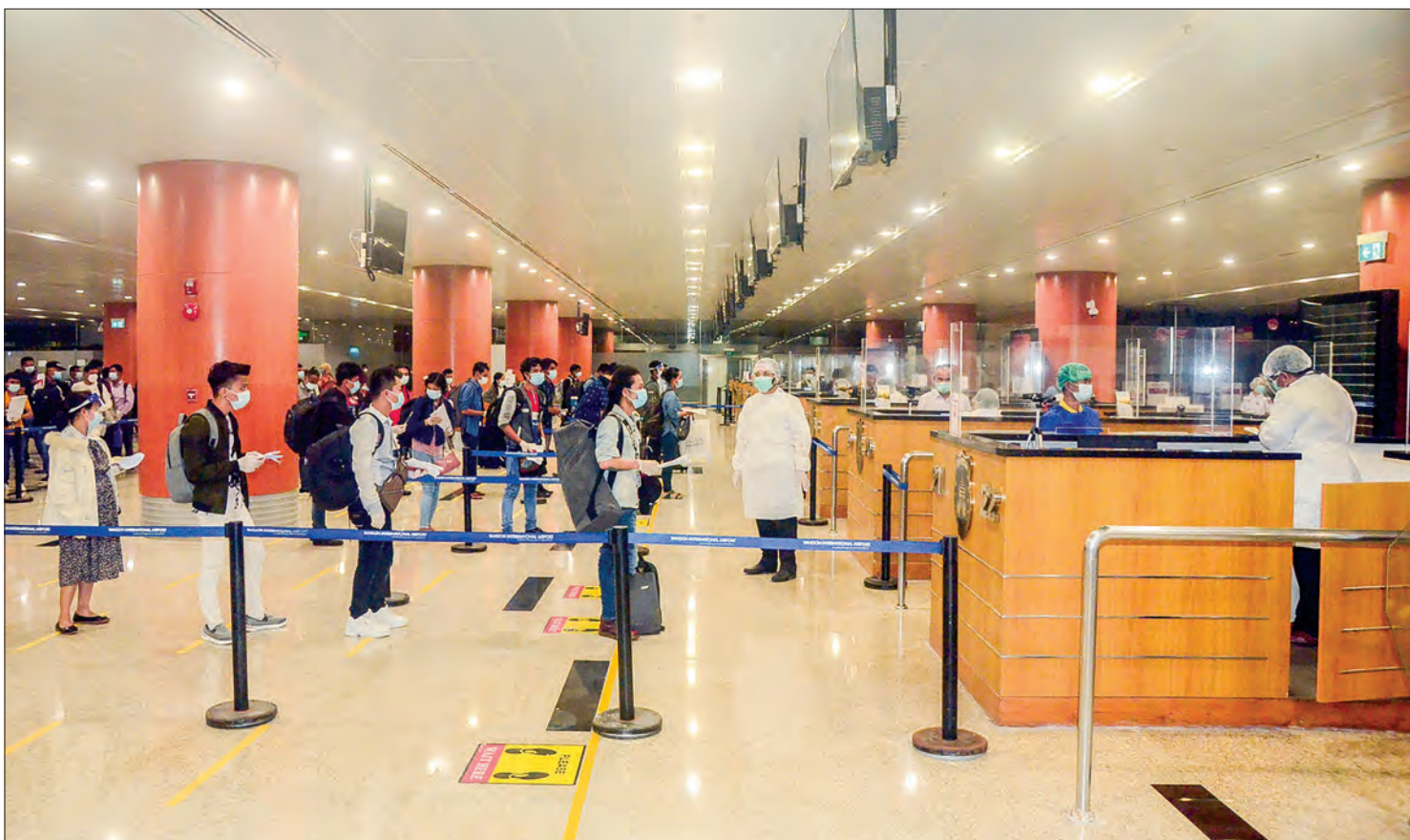

Myanmar organizes 15th relief flight to bring citizens back home from Malaysia

A RELIEF flight of Myanmar Airways International landed at Yangon International Airport yesterday with 165 nationals who wanted to return home as they were facing difficulties in Malaysia.

The returnees have to stay the 14-day quarantine at specific places or designated hotels after immigration processes and medical tests, followed by the 7-day home quarantine, which were arranged by the Ministry of Labour, Immigra-

tion and Population, the Ministry of Health and Sports and the Yangon Region government.

In accordance with the directives of Ministry of Foreign Affairs, the Myanmar embassy in Kuala Lumpur is also working together with the respec-

tive organizations to repatriate the citizens who have no valid documents and who were kept at the detention centres after verifying their citizenships. —MNA

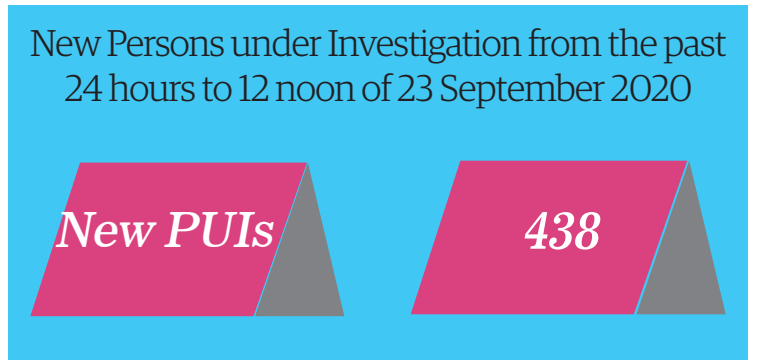
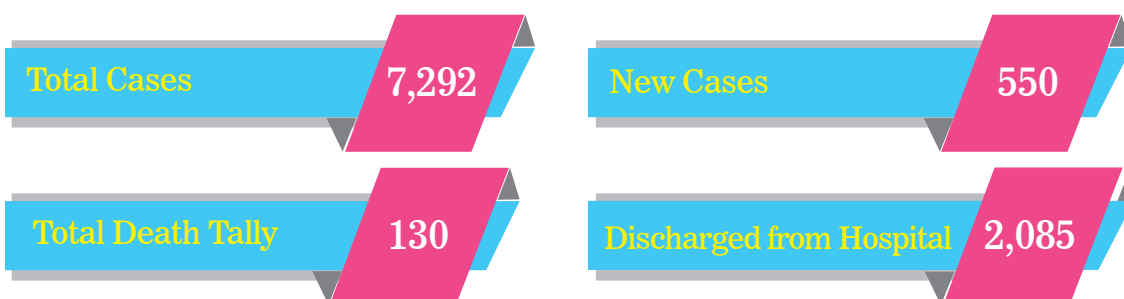

MYANMAR'S COVID-19 positive cases rise to 7,292 after 550 new cases were reported on 23 September according to Ministry of Health and Sports. Among these 7,292 confirmed cases, 130 died, 2,085 have been discharged from hospitals and 438 were held under investigation.—MNA

UEC passes advance ballot papers to MoFA for Myanmar citizens living abroad

DIRECTOR-GENERAL of the Union Election Commission U Khin Maung Oo presented advance ballot papers and envelopes for 20,426 eligible Myanmar voters living abroad to Director-General for the Planning and Administrative Department of the Ministry of Foreign Affairs U Aung Soe Win yesterday for the second time.

The sub-commissions of UEC scrutinized the copies of Form-15 for eligible voters, sent by the Ministry of Foreign Affairs, for the voters in foreign countries.

In the first time, advance ballot papers and envelopes for 188 eligible overseas voters have been sent to the respective Myanmar embassies, missions and consulates in foreign coun-

tries on 18 September.

In the second time, the ballot papers and envelopes for advance voting will be sent to the Myanmar embassies in Bangkok, Singapore, Seoul and Kuala Lumpur for the national voters from 8 regions and states.—MNA

India donates Remdesivir injection to Myanmar

INDIA donated Remdesivir injection produced by Zydus Cadila Company to the Ministry of Health and Sports for COVID-19 treatment and the donation was organized at the Embassy of India in Yangon on the morning of 20 September.

At the ceremony, Indian Ambassador Mr Saurabh Kumar handed over the Remdesivir injections to Director-General for Department of Medical Research Professor Dr Zaw Than Htun.

"These medical supplies are produced in India and are now used to treat the COVID-19 patients there. They are also used for the treatment of patients with severe or moderate COVID-19," said Director-General Professor

Dr Zaw Than Htun.

Indian Ambassador Mr Saurabh Kumar said, "The currently donated injections are produced in India and approved in line with the Indian medical rules and regulations. They are widely used in treating the patients with severe COVID-19. Now, the medicines are donated by Alidac Healthcare Myanmar Ltd, a subsidiary of Zydus."

The Indian government donated US\$900,000 worth of medicine and medical supplies to prevent, control and treat COVID-19 in Myanmar on 6 May 2020, according to the Indian Embassy.—Min Thit (MNA)

Remote assessments to be used in grading, registration for PWDs

SINCE 2018, the Ministry of Social Welfare, Relief and Resettlement, in cooperation with UNICEF (Myanmar) and Myanmar Federation of Persons with Disabilities, has carried out a project for disability grading and registration for the dis-

abled in Hlinethaya Township in Yangon Region, Nyaunglebin Township in Bago Region, Hpan and Kya-in-Seikkyi townships in Kayin State.

To continue the project during the COVID-19 pandemic, the project officials need to under-

take remote assessments and use of digital technologies, so the department yesterday organized a coordination meeting about the plan for registration and disability grading for the disabled by undertaking remote assessments and digital technology.

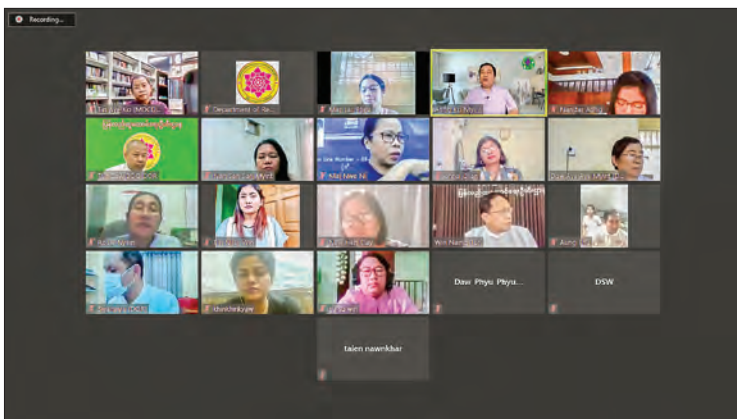
At the meeting, the Department of Rehabilitation Director-General U Win Naing Tun delivered an opening speech.

The participants discussed the roles of organizations in implementation of remote assessments and digitalization, the roles of Myanmar Federation of Persons with Disabilities, pros and cons of using technology, necessary arrangements, funding, and other related matters.

The initial plans for disabil-

ity grading and registration for the disabled has been postponed because of COVID-19 pandemic. But from September to December this year, the project will continue by using remote assessments and digital technology.

The meeting was attended by officials from Myanmar Federation of Persons with Disabilities, UNICEF (Myanmar), Myanmar Autism Association, Myanmar Down Syndrome Association, Myanmar Deaf Community Development Association, Eden Centre for the Disabled, Shwe Minn Tha Foundation, Myanmar Christian Fellowship of the Blinds, and Myanmar Independent Living Initiative.—MNA *(Translated by Maung Maung Swe)*

146 Myanmar migrant workers from Thailand return through Myawady border on 23 September

A total of 146 Myanmar migrant workers (84 males and 62 females) returned home through the Thai-Myanmar Friendship Bridge No 2 in Myawady Border town yesterday. Local authorities welcomed the returnees and the responsible persons from respective townships arranged the necessary medical check-up and send them to quarantine centres in respective regions and states in accordance with the COVID-19 health guideline.

- Heads of trainings, schools, hospitals and jails are to contact the sub-election commissions to get documents of Form 15.
- They must return these documents to sub-commission of respective townships by 26 August 2020 after the documents are filled by the voters.
- Sub-election commission of respective townships must send ballot papers and envelopes for advance voting to the trainings, schools, hospitals and jails by 7 October 2020.
- Advance voting must be organized at trainings, schools, hospitals and jails on their appropriate day from 8 October 2020 to 21 October 2020.
- The envelopes containing ballot papers must be sent back to sub-election commission of respective townships by 4 pm on 8 November 2020.

Advice to people in Yangon Region

1. About 6,000 people have been quarantined in Yangon. Within two days, quarantine spaces were arranged for 1,000 people who came back from Rakhine State. Now, the number of people who had contacts with COVID-19 patients has increased, so seven new quarantine centres have been established for 1,000 more people. The civil society organizations and volunteers are invited to help the persons at the quarantine centres.
2. People in Yangon need to send the persons who had contacts with confirmed cases in the contact tracing to the quarantine centres without making them worried.
3. People should adhere to the required rules and regulations in the quarantine centres. When sending food to people in quarantine centres, alcohol and cigarettes should not be included in the delivery.
4. People in Yangon have lots of difficulties, challenges and burdens. Therefore, they need to strictly follow the rules by staying at home in two to three weeks during this period. In going outside for necessary reasons, they must wear masks. As Yangon City has a large number of population, people are also advised to abide by the rules of Ministry of Health and Sports amidst the increasing number of confirmed cases.

MoI holds online meeting with CPC Central Committee Publicity Department

THE Ministry of Information held an online meeting with the Publicity Department of the Central Committee of the Communist Party of China yesterday morning.

The meeting was held between the two headquarters in Nay Pyi Taw and Beijing.

Union Minister Dr Pe Myint, Deputy Minister U Aung Hla Tun, Permanent Secretary U Myo Myint Maung and officials took part in the discussions with Minister of CPC Central Committee Publicity Department Mr Huang Kunming, Vice-Minister and Chairman of the China Film Bureau Mr Wang Xiaohu, Vice-Minister of Culture and Tourism Mr Zhang Xu, and Vice-Minister of National Broadcast and Television Bureau Ms

Meng Dong.

Chinese Ambassador to Myanmar Mr Chen Hai, Patron of Myanmar Motion Picture Organization U Kyi Soe Tun, its Chairman U Nyi Nyi Tun Lwin and officials joined the meeting via videoconferencing from Yangon.

Before the discussions, Vice-Minister and Chairman of the China Film Bureau Mr Wang Xiaohu presented the Myanmar movie 'Nga Ba' conserved in digital cinema package by experts from the China Film Archive, to commemorate the centenary of Myanmar Film Industry and the 70th anniversary of diplomatic ties between the two countries.

Union Minister Dr Pe Myint expressed thanks for the digital version of Nga Ba movie which

was created by Director Academy U Chit Khin in 1961 to the novel of the same title written by Myanmar veteran writer Maung Htin.

The film depicts the lives of Myanmar rural farmers who were oppressed by colonialists and fascists during Second World War. The movie also presents struggles for independence with national spirit.

In the session of online meeting, Chinese Minister Mr Huang Kunming explained the main objective of the meeting to implement agreements made during the official visit of Chinese President Mr Xi Jinping to Myanmar in January this year.

He also talked about promotion of information sector, cultural exchange and cooperation be-

tween the two countries, as well as development of the strategic partnership cooperation in multi sectors which was agreed by leaders of the two countries.

He also discussed better cooperation between the two countries which have marked the 70th anniversary of diplomatic ties this year, economy recovery in the post COVID-19, further collaboration in mutual support for stability and peace in the region.

Union Minister Dr Pe Myint talked about participation of Myanmar film actors and screening of Myanmar films in Chinese film festivals, the joint project between Myanmar and Chinese companies for building a major film studio in Nay Pyi Taw, and cooperation in radio and

TV industry between Myanmar private companies and Chinese TV stations. Myanmar staff members are working at the Myanmar programme of China Radio International.

The MRTV has also signed cooperation agreement with the Guangxi Broadcasting Service (GXBS) in 2013, and produced Chinese TV series dubbed in Myanmar language, and has been producing some programmes with Yunnan Television since 2013.

The Myanmar News Agency (External) under the MoI signed the first agreement on exchange of news with Xinhua News Agency in 1963 and the agreement was updated in 2018.

The Union Minister discussed printing and publishing of books between the two countries, including the translation of book series written by Chinese President Xi Jinping about the governance in his country.

The meeting also focused on implementation of bilateral agreements in the post COVID-19, transfer of films and news documentaries stored in China, technical cooperation in new media and sharing knowledge.

Even if the words are true, will they be beneficial? I want all of you to be prudent and wise to consider whether certain words if spoken, would make the people more afraid; or whether such words would not make the people more vigilant or diligent.

MoC organizes virtual meeting on free food ration distribution in Yangon

THE Ministry of Commerce yesterday organized a virtual meeting on free food ration distribution in Yangon Region.

During the meeting, Union Minister for Commerce Dr Than Myint said that the National-Level Central Committee on Prevention, Control and Treatment of COVID-19 has already instructed the relevant officials to distribute food during COVID-19 crisis if necessary. The second wave of COVID-19 has severely hit Yangon Region, so the Ministry of Health and Sports imposed necessary restrictions, and consequently, the government need to distribute food for the needy people in Yangon Region, said the Union Minister.

The main objective of the meeting is to effectively distrib-

ute food, said the Union Minister. He also stressed the need to take measures which can ensure that people do not throng food distribution centres.

Similarly, the Deputy Minister for Commerce made discussions in the meeting. He said that

officials in Yangon could manage to effectively distribute food during the period in which the first wave of COVID hit Yangon. The Deputy Minister urged the participants to make suggestions on how to effectively provide a 2-week emergency food supply

for poor families in Yangon.

The Deputy Minister said that the Ministry of Commerce has already gathered emergency food to some extent.

Government officials, representatives from Union of Myanmar Federation of Chambers of

Commerce and Industry and its associated organizations, officials from Yangon Region Transport Authority and officials from Bayint Naung Market participated in the discussions.—MNA

MoHS organizes virtual meeting on COVID-19 response

THE Ministry of Health and Sports yesterday morning organized a virtual meeting with advisors on issues related to prevention, control and treatment of COVID-19 via videoconferencing.

During the meeting, the

Union Minister for Health and Sports Dr Myint Htwe said that only if people in Yangon Region adhere to the "Stay-at-Home" order, the transmission of the virus will be controlled in two weeks.

The Union Minister said

that the majority of factories in Yangon Region will be closed from 24 September, so the spread of the disease will be limited.

He said that officials will inspect the factories that have been allowed to continue open-

ing in order to check whether they follow the COVID-19 related guidelines. He also stressed that regional authorities in all states and regions must supervise the COVID-19 containment measures in markets.

He said that people failed to strictly follow COVID-19 related guidelines when the first wave of COVID-19 became weaker.

He continued that there can be transmission of the virus even after the second wave of COVID-19, so people need to strictly adhere to the health guidelines. He added that the spread of the disease will be stopped only when an effective COVID-19 vaccine is widely available.

He called on all of the citizens to strictly follow COVID-19 related instructions.

During the meeting, Deputy Minister Dr Mya Lay Sein explained how they are working in order not to run out of COVID-19

preventive accessories, medical equipment and medicines.

Permanent Secretary Dr Thet Khaing Win explained the situations related to conducting COVID-19 lab tests by using Cobas 6800, RT PCR and GeneXpert. Similarly, other officials and participants explained their tasks and activities to control the spread of COVID-19 and make suggestions.

In response to the discussions made by the participants, the Union Minister made necessary suggestions. He said that local officials need to use handheld loudspeakers to educate the people about COVID-19 response measures in quarantine centres.

The Union Minister also urged medical experts, public health officials and management experts to cooperate in managing quarantine centres.—MNA

Myanmar black bean price up by over K120,000 per tonne over 3 weeks

PRICES of black bean have increased by over K120,000 per tonne over three weeks, according to the bean market.

The black bean fetched K950,000 per tonnes in the bean market on 1 September. However, the price of black bean rose to K107,000 per tonne on 23 September.

The pigeon pea price hit K814,000 per tonne on 1 September, and it jumped to K830,000 per tonne on 23 September.

The price of bean has risen because of demand not only from India but also from Pakistan, Bangladesh, Nepal and UAE, said an official from Myanmar Pulses, Beans and Sesame Seeds Merchants Association (MPBSSMA).

“The price of bean has increased in the local market because of rising demand from India. With the yield of bean rising in Myanmar, the demand from In-

dia, Pakistan, Bangladesh, Nepal and UAE is also on the rise. India is purchasing Myanmar bean directly these days. Then, they will import the bean later when the

gates are reopened. With a slight increase in FOB price, the price of bean has also increased,” he added.

Although India is the pri-

mary buyer of Myanmar’s black beans and pigeon peas, it has been delaying the buying of the beans amid the COVID-19 crisis, said the traders. India govern-

ment rapidly changed the import period of 400,000 tonnes of black bean to three months by the end of August 2020 from the earlier set deadline of March 2021. Its official notice was announced on 22 May.

Although Myanmar bean traders have asked for deadline extension for import quota of 400,000 tonnes, India stall has not responded to the request.

Myanmar has delivered nearly 100,000 tonnes of black bean out of 400,000 tonnes quota. Around 200,000 tonnes of black beans are also stockpiled in the local market, according to MPBSSMA.

Myanmar is the prominent grower of black bean, which is highly demanded from India. Besides Myanmar, Australia and Africa grow other kinds of peas such as pigeon peas, green grams and yellow peas, according to the MPBSSMA.

External trade tops \$149.67 bln in incumbent government period

MYANMAR’S external trade over the past four years under the incumbent government period touched a high of US\$149.67 billion, comprising exports worth \$68.53 billion and imports valued \$81.1 billion, according to the statistics released by the Ministry of Commerce.

Between Financial Year 2016-2017 and FY2019-2020 (as of 21 August), the maritime trade outperformed the border trade. Myanmar’s regular trade was estimated at \$109 billion, while its border trade with the neighbouring countries — China, Thailand, Bangladesh, India and Laos stood at \$40.6 billion.

Myanmar’s foreign trade has shown a 10-per cent increase, year over year, under the incumbent government.

The values of foreign trade were registered at \$29 billion in the FY2016-2017, \$33.57 billion in the FY2017-2018, \$18.7 billion in the 2018 mini-budget period, \$35 billion in the FY2018-2019

and \$33 bln in the FY2019-2020 (as of 21 August), the ministry’s data showed.

Myanmar exports agricultural products, animal products, minerals, forest products, and finished industrial goods, while it imports capital goods, raw industrial materials, and consumer goods.

Myanmar’s top export countries are China, Thailand, Japan, Singapore, the US, India, Germany, the Republic of Korea, Spain and the UK. In contrast, it primarily imports from China, Singapore, Thailand, Malaysia, Indonesia, India, Viet Nam, Japan, the Republic of Korea and the US, as per data of the Ministry of Commerce.

The country’s export sector relies more on the agricultural and manufacturing sectors. The Ministry of Commerce is endeavouring to boost export under the World Trade Organization’s rules, enhance value-added production and competitive-

ness, reduce export barriers and provide trade financing services. The government is trying to reduce the trade deficit by screening luxury import items and boosting exports. The country mainly imports essential goods, construction materials, capital goods, hygienic material and supporting products for export promotion and the import substitution.

The Ministry of Commerce has adhered to its policy reform depending on the requirements of the State and people. Moreover, a series of trade liberalization and openness for policy development have been introduced for enhancing a more viable trade environment. The private sector plays a prominent role in Myanmar’s market-oriented economic system. The ministry is highlighting free and fair trade, ensuring product safety and quality goods and services.—GNLM

Myanmar trade deficit with Singapore estimated at US\$9.4 bln in past 4 years

MYANMAR trade deficit in goods with Singapore was estimated at US\$9.439 billion in the past four years, the statistics issued by the Central Statistical Organization under the Ministry of Planning, Finance and Industry indicated.

The value of Myanmar’s bilateral trade with Singapore in normal trade and border trade topped \$13.96 billion between the FY2016-2017 and the FY2019-2020 (as of August).

The CSO reported that imports surpassed exports in trade with Singapore in the past four years, with exports reaching over \$2.26 billion and imports valued at over \$11.7 billion.

Singapore is Myanmar’s second-largest trading partner in the region, after Thailand. It accounted for 10.56pc of total trade in FY2016-2017 with an estimated trade value of \$3.4 billion, 11.59pc in FY2017-2018 with a trade value of \$4.15 billion, 9.98pc in the FY2018-2019 with \$3.5 billion and 12.76pc in

the FY2019-2020 (Oct-April) with \$2.89 billion respectively.

Myanmar exports agricultural products such as broken rice, pulses, sesame seeds, onion, footwear, textiles and clothing, minerals, and other products to Singapore. At the same time, it imports plastic, fuel oil, edible oil, transport equipment, chemical elements and compounds, wheat flour, pharmaceutical products, dairy product and consumer products.

Next, Singapore is the top source of foreign direct investments into Myanmar in the incumbent government period, bringing in the capital of \$10.72 billion by 122 Singapore-listed enterprises, according to the data released by the Directorate of Investment and Company Administration (DICA).

Singapore companies put investments into urban development, real estate, power and manufacturing sectors.—Ko Htet

Over 1,000 businesses to receive K20 bln from second COVID Fund

A total of 1,041 enterprises have been approved to take out over K20.7 billion from the second COVID-19 Fund, according to a committee to remedy the economic impacts caused by the coronavirus pandemic.

The applicants approved by the committee will be screened in line with bank rules and procedures, and they are not eligible for the loan if they get sued by a bank. The remaining applications are being processed, the committee stated.

The priority sectors for the second batch of COVID loan are agriculture and livestock enterprises, manufacturing businesses, import-substitution businesses, food and beverage businesses, oversea employment agencies, export and import businesses, and vocational schools.

The 2019-2020 additional budget of K100 billion is put into the second COVID Fund to mitigate the economic impacts of the coronavirus on the businesses.

The government started the first COVID Fund to the business stricken by the coronavirus im-

pacts, with K50 billion allocated from the country's revolving fund and another K50 billion from the social welfare fund. The loan is set to pay off within one year, at one per cent of the interest rate.

In the first batch, more than 4,250 businesses applied for the loan and 3,393 of them received the loan in line with the loan procedures. Over K101 billion have been disbursed under seven batches, Ministry of Investment and Foreign Economic Relations announced.

The committee was formed on 13 March, and Union Minister

U Thaung Tun for Investment and Foreign Economic Relations was appointed as the chairman of the committee.

The committee is responsible for measures to address the negative impacts of the pandemic situation on trade and tourism sectors, short, medium and long term measures to respond to the COVID-19 crisis, together with the private sector and related associations, creation of new jobs for those employees who have been laid off at the factories, conducting vocational education to the workers, and additional measures to explore new markets to buy raw materials for CMP garment businesses in the country instead of relying on the sole market — China.

Additionally, the public and private sectors need to cooperate in setting up the supply chain on our own sources, including weaving, knitting, dyeing, and sewing factories, the committee urges.

Furthermore, as the long-term strategies, the committee will request Myanmar President office to give tax exemption and reliefs depending on the situations of the COVID-19 impacts on SMEs and to provide loans to the domestic businesses at a low-interest rate.

300 women with disability receive K50,000 assistance each

THE Department of Rehabilitation under the Ministry of Social Welfare, Relief and Resettlement supported K50,000 each to 300 women with disability from 11 states and regions in COVID-19 period in cooperation with Shwe Mintha Foundation.

"Our Shwe Mintha Foundation supported K50,000 to 300 women in the pandemic

period in cooperation with the Department of Rehabilitation. We went to their houses and gave them the cash from 7 to 18 September. Currently, the data collection is being conducted by the government in the wards to provide the persons with disability," said Ko Kyaw Htet Aung, the person in charge of Shwe Mintha Foundation from

Myanmar Head Office.

According to the 2014 census, there are around 2.3 million persons with disabilities in Myanmar. The Department of Rehabilitation provided K30,000 each to 200,000 persons with disabilities from across the country in cooperation with the social disabilities associations.

"The government provided

K30,000 to them from the wards and villages. The associations are also collecting the data to report to the department," he added. The government is also providing cash to the low-income people for their convenience in COVID-19 period.

23 Myanmar seamen stay quarantine in Kawthoung

THE HISTORIC AND UNPRECEDENTED 75TH SESSION OF THE UN GENERAL ASSEMBLY

UN chief appeals for global solidarity at General Assembly, warns COVID is 'dress rehearsal' for challenges ahead

In his centerpiece address to the historic and unprecedented 75th session of the UN General Assembly, Secretary-General António Guterres on Tuesday appealed for global solidarity to overcome the COVID-19, and again call for a global ceasefire during the pandemic, by the end of the year.

ADDRESSING the largely empty General Assembly Hall in New York, Mr Guterres characterized the pandemic from the podium as "not only a wake-up call" but "a dress rehearsal" for challenges to come.

"In an interconnected world, it is high time to recognize a simple truth: solidarity is self-interest. If we fail to grasp that fact, everyone loses", he said, delivering his annual report on the work of the Organization.

The Secretary-General underscored the need for solidarity at this moment, particularly as countries least capable to address COVID-19 have received far too little assistance. He urged the UN's 193 Member States to move forward in humility and unity in the face of the disease.

A world turned upside-down

Due to COVID-19, most world leaders will not attend the annual gathering at UN Headquarters, known as the General Debate. Instead, many have pre-recorded their speeches on video, although they have the right to deliver them in person from their seat in the Hall, not from the podium.

"In a world turned upside down, this General Assembly Hall is among the strangest sights of all", Mr Guterres remarked at the outset. "The COVID-19 pandemic has changed our annual meeting beyond recognition. But it has made it more important than ever."

Clock ticking on global ceasefire

Mr Guterres also used the occasion to repeat his call for a global ceasefire during the pandemic. The Secretary-General had initially issued the appeal back in March, when he urged warring parties to "end the sickness of war and fight the disease that is ravaging our world".

Some 180 Member States have endorsed the appeal, as have religious leaders, regional partners and civil society networks. Several armed movements also responded, some of whom announced ceasefires, though they were not sustained.

Mr Guterres saw several reasons to be hopeful now, with the peace agreement in Sudan, and peace talks in Afghanistan, as just two examples. However,

he feared terrorist and violent extremist groups will exploit the pandemic.

Threats to peace, gender equality

The ceasefire is not only critical to stop "hot" conflicts, he stressed, pointing to the need to avert a new Cold War.

"We are moving in a very dangerous direction. Our world cannot afford a future where the two largest economies split the globe in a Great Fracture — each with its own trade and financial rules and internet and artificial intelligence capacities", the Secretary-General warned.

"A technological and economic divide risks inevitably turning into a geo-strategic and military divide. We must avoid this at all costs."

ing towards renewable energy to achieve net zero emissions by 2050, highlighting a longstanding message of his tenure.

As part of their COVID-19 recovery, the Secretary-General encouraged countries to consider six climate-positive actions, ranging from green jobs and ending fossil fuel subsidies, to aligning any industry bailouts with international goals to limit global warming.

21st century multilateralism

The Secretary-General believes that after more than seven decades, multilateral institutions need an upgrade to more equitably represent all the world's people, rather than giving disproportionate power to some, and limiting the voice of others.

He laid out a blueprint for this "21st century multilateralism", saying it must be "networked" — that is, linking global institutions, such as development banks, regional organizations and trade alliances, across sector and geographies.

No going back

Mr Guterres made the case for more international cooperation in the face of COVID-19, stressing that there is no "going back to what was or withdrawing from national shells."

While the crisis has upended the world, it has also created the space for something new, he said.

UN response to COVID-19

Earlier in his speech, the Secretary-General spoke of the UN's comprehensive response

throughout the pandemic.

The UN system, led by the World Health Organization (WHO), has assisted governments, particularly in the developing world, including through providing personal protective equipment and other medical supplies to more than 130 countries. The Organization also launched the 'Verified' campaign to fight the "toxic virus" of misinformation surrounding COVID-19. It is also supporting efforts to develop a fair and equitable vaccine against the actual coronavirus, as well as treatments and therapies.

'Vaccinationalism'

However, Mr. Guterres warned against what he called "vaccinationalism", as countries are reportedly making "side deals" for their own populations. He underlined that "None of us is safe, until all of us are safe."

The UN has also pushed for a "massive" rescue package, equivalent to roughly 10 per cent of global economic output, to get economies back up and running. Developed countries can afford it, he said.

"But we need to ensure that the developing world does not fall into financial ruin, escalating poverty and debt crises," he stated. "We need a collective commitment to avoid a downward spiral." To this end, the Secretary-General will convene world leaders for a meeting next Tuesday to find solutions to finance development in the COVID-19 era and beyond.

ADOPTING A COMMON SET OF DEFINITIONS FOR HATE SPEECH

Tech giants strike deal with advertisers over hate speech

WEB giants including Facebook have struck a deal with advertisers on how to identify harmful content such as hate speech, after an impasse over the issue which led to boycotts of the platform. The agreement — which also included Twitter and YouTube — laid out

for the first time a common set of definitions for hateful statements online.

In July, hundreds of advertisers including big-name consumer brands suspended advertising with Facebook as part of the StopHateForProfit campaign, saying the social-media titan should do more to stamp out hatred and

misinformation on its platform. And earlier this month a group of celebrities — including Kim Kardashian, Leonardo DiCaprio and Katy Perry — stopped using Facebook and Instagram for 24 hours, to push a similar message.

The World Federation of Advertisers (WFA) said in a statement Wednesday: "Facebook,

YouTube and Twitter; in collaboration with marketers and agencies through the Global Alliance for Responsible Media have agreed to adopt a common set of definitions for hate speech and other harmful content and to collaborate with a view to monitoring industry efforts to improve in this critical area."The alliance was

founded by the WFA and includes other major trade bodies.

According to the WFA, key areas of agreement included applying the alliance's common definitions of harmful content; developing reporting standards for such content; establishing independent oversight; and rolling out tools for keeping advertisements

away from harmful content. The WFA said that properly defining online hate speech would remove the current problem of different platforms using their own definitions, which it said made it difficult for companies to decide where to put their ads.

Lisu National Development Party (L.N.D.P) presents its policy, stance and work programmes

Lisu National Development Party (L.N.D.P) executive committee member Daw Betty Yarn presented party's policy, stance and work programmes through radio and TV on 23 September.



I pray auspiciousness for all the voters and people.

I am Daw Betty Yarn, executive committee member of the Lisu National Development Party (L.N.D.P) or the Cross-Bow Party.

We have already presented the list of our candidates, who will stand for the 2020 election in Kachin State, Mandalay Region and Shan State, to the respective Election Sub-commissions.

Before presenting our political ideology and the 2020 election manifesto, I would explain the flag and the logo of our party. The colour of the flag is red, and it bears a white star and a white cross-bow that is aiming at the former.

Voters must be aware of the fact that there may be other logos that are similar to our flag or the logo. So, we would inform them that only the red flag bearing the picture of a white star and a white cross-bow is ours.

Now, I like to present a brief account of the flag. The colour red signifies bravery, courage, alertness, activeness and decisive. The white cross-bow represents the Lisu people, while the white colour epitomizes purity, sincerity, steadiness, tranquillity and loyalty. The white star at the left corner indicates the role of Lisu National Development Party (cross-bow party) is playing in the affairs of the Republic of the Union of Myanmar.

I will now present the policies laid down by the party.

1. Political policy

- (a) Build a federal democratic Union, which ensures the self-determination, while exercising the freedom of occupation, expression, thinking, profession, and creation in the country, without harming anyone;

- (g) Foster patriotism by promoting the language, literature, culture, customs and history of Lisu people.

2. Economic policy

Continuation of the free and fair market economy

3. Education policy

- (a) Encourage the individual creative thinking of the education system that meets the international level;
- (b) Support necessary programs to narrow the education gap between the rural and the urban.

4. Health policy

- (a) Implement an inclusive health system that is available for everyone;

EU to unveil long-delayed asylum plan to share responsibility

BRUSSELS — Five years after Europe's migrant crisis, Brussels will propose on Wednesday that member states share the responsibility for asylum seekers under a "compulsory solidarity mechanism". The New Pact on Migration and Asylum will be unveiled by European Commissioner for Home Affairs Ylva Johansson and Commission Vice-President Margaritis Schinas. Johansson wants the 27 member states to commit to

sharing the burden of handling asylum claims from migrants arriving on the bloc's shores. "It's obvious to everybody that ad hoc solidarity or voluntary solidarity is not enough. That has been proven for many years now," she said. "It has to be mandatory." The plan will make showing solidarity with all EU countries on the front lines -- often Greece, Italy or Malta -- compulsory when they are "under pressure" from arrivals.—AFP ■

Fujifilm to seek approval for COVID-19 drug Avigan possibly in Oct.

TOKYO — Fujifilm Holdings Corp. said Wednesday it will seek regulatory approval as early as October for using its antivirus drug Avigan to treat patients infected with the novel coronavirus as clinical tests have shown efficacy in easing symptoms. According to analysis of data on 156 patients without severe symptoms, Fujifilm found those administered with Avigan show improvement after 11.9 days, shorter than the 14.7 days for those in a placebo group. If approved, the drug, also known as favipiravir, would be the third treatment drug for

COVID-19, the respiratory disease caused by the virus. Fujifilm Toyama Chemical Co., a subsidiary of Fujifilm Holdings, began clinical trials in March. It faced difficulty in securing enough data due to a downtrend in the number of coronavirus cases and the tests ended later than initially expected. Fujifilm said it will continue with its detailed analysis of the data gathered during the study before filing its application for approval. Former Prime Minister Shinzo Abe had expressed hope to have the drug approved in

May but a Japanese university's interim report, released in mid-May, did not show any clear efficacy of Avigan against COVID-19. In Japan, the antiviral drug remdesivir developed by U.S. firm Gilead Sciences Inc. was given the green light in May, followed by the steroid drug dexamethasone. The number of coronavirus cases in the country has reached 80,500, including about 700 from the Diamond Princess cruise ship that was quarantined in the port of Yokohama in February. The death toll has topped 1,500.—Kyodo ■

Belgium will no longer prohibit travelling to at-risk countries

BRUSSELS — Belgium will no longer place travel bans on European countries and regions classified as at-risk zones for their high infection rates. Minister of Foreign Affairs Philippe

Goffin explained that Belgium had been the only European country not only to discourage, but to actually prohibit travels to these zones. He noted that the change

would come in effect on Friday 25 September and that it aimed at strengthening coordination between EU members. Thus far, Belgium has employed a three-colour-system

that designated countries as either safe, medium, or at-risk, which meant that travels to such regions could be accompanied with quarantine measures or even prohibited

if not deemed essential. This caused a number of problems over the summer months, since many places fluctuated between safe and at-risk.—AFP ■

Section 59 (g) in Hluttaw Election Law



IN accordance with section 59 (g) of the Hluttaw Election Law, no one is allowed to vote more than once in any election for a Hluttaw constituency in which he or she has the right to vote. Anyone who is found guilty of or abetting this act shall be punishable with imprisonment for a term not exceeding one year, or with fine not exceeding K100,000 (one hundred thousand Kyats), or with both.

S. Korea's Moon advocates regional initiative to fight coronavirus

SEOUL — South Korean President Moon Jae In on Wednesday proposed a Northeast Asian initiative involving the two Koreas, Japan, China and Mongolia to combat the novel coronavirus pandemic.

Moon unveiled the "Northeast Asia Cooperation Initiative for Infectious Disease Control and Public Health" in his video address to the U.N. General Assembly.

Such an initiative would lead North Korea to "engage with the international community," according to Moon.

The president said the coronavirus pandemic has posed a "greater threat to humanity than a war," and that "the safety of neighbouring countries is directly linked to that of our own."

He emphasized the need for global cooperation to tackle the economic crisis caused by the pandemic,

as well as in the development and provision of vaccines. Moon also marked the 70th anniversary of the outbreak of the Korean War,

which ended in 1953 in an armistice, and called for international support for an end-of-war declaration. — Kyodo ■

Japan may ease virus entry restrictions next month: reports

TOKYO — Japan is considering easing strict coronavirus border restrictions from October to allow more foreign nationals to enter, local media reported Wednesday.

Tourists would still be banned and only longer-term visas approved, the reports said, as the nation looks to rebuild its economy and prepare for the postponed Olympics next year. Japan currently bans entry for foreigners from most countries, but has been negotiating the gradual resumption of cross-border business travel. Business visitors are already allowed from seven places -- including Thailand, Vietnam and Taiwan. This limited travel resumption has not resulted in additional virus cases, so the government is now considering letting in eligible visa-holders from all countries, the Asahi Shimbun newspaper reported, citing unnamed government sources. —AFP ■

West Ham were not the only Premier League club affected by the virus as Tottenham's tie at Leyton Orient was postponed after their fourth tier opponents suffered a Covid-19 outbreak.

West Ham's match went ahead as planned despite the virus tests, with assistant manager Alan Irvine taking charge of the Hammers.

"At 20 past six we suddenly got some information from our

doctor and head physio to say there were three positive tests, the manager and the two players," Irvine said.

"We'd had contact insofar as we were in the same area of the stadium as David.

"We were shocked by the news. We've had so many tests and not had any positive. But we've been very particular about protocol right from the start."

Sebastien Haller and Andriy Yarmolenko both struck twice for West Ham after Robert Snodgrass opened the scoring.

West Ham will play Fleetwood or Everton in the last 16.

The news of the virus striking at football's heart came after British Prime Minister Boris Johnson dealt a major blow to the sport's financial future on Tuesday.

Johnson said fans would not be allowed back into stadiums in October as originally planned due to a spike in virus cases, measures that will remain in place for "perhaps six months".—AFP ■

LONDON — West Ham manager David Moyes and Hammers players Issa Diop and Josh Cullen have tested positive for the coronavirus, the Premier League club announced on Tuesday (Sept 22).

West Ham's medical team were informed of the test results while Moyes and his squad were at the London Stadium preparing for Tuesday's League Cup third round tie against Hull.

"The manager and both players immediately left the stadium and returned home," a West Ham statement said.

"All three, who are asymptomatic, will now follow Public Health England and Premier League guidelines and protocols." Tuesday's match went ahead as planned, with West Ham assistant manager Alan Irvine taking charge of the team.

It is the latest setback in a difficult start to the season for West Ham, who have lost their first two Premier League games against Newcastle and Arsenal.

Fans have protested against the club's co-owners David Gold

and David Sullivan, while West Ham captain Mark Noble criticized the board's decision to sell promising youngster Grady Diangana to West Bromwich Albion.
