

Section 58 (d) in Hluttaw Election Law



IN accordance with section 58 (d) of the Hluttaw Election Law, no one is allowed to give speeches at meetings, instigation, writing, distribution of using posters or attempting by other means to disturb the voting or election. Anyone who is found guilty of or abet this act shall be punishable with imprisonment for a term not exceeding one year, or with fine not exceeding K100,000 (one hundred thousand Kyats), or with both.

adhere to healthcare guidelines of COVID-19 containment measures during the 2020 General Election.

On arrival at the primary school in Chin Village in Ottarathiri Township in the morning, the State Counsellor and party were welcomed by Chairman of the Union Election Commission U Hla Thein, Union Minister for Office of the Union Government U Min Thu, Union Minister for

Health and Sports Dr Myint Htwe, Chairman of the Nay Pyi Taw Council Dr Myo Aung, members of UEC, Deputy Minister Dr Mya Lay Sein and officials.

Director-General of UEC Office U Khin Maung Oo reported on the third demonstration, the number of expected voters on election day, assignment of duties for 13 officers inside and 5 officers outside polling stations, physical safety and feeling of security of voters during voting processes in

accordance with the guidelines of the State Counsellor on the first and second demonstrations under rules and regulations of the elections and distributions of COVID-19 preventive supplies to the voters in line with the guidelines of the COVID-19 national-level central committee.

The primary school in Chin Village will be used as the polling station No.1 of the Ottarathiri Township, and the practical demonstration was organized for

distribution of N95 masks, taking body temperature, helping to use alcohol 85% hand sanitizer, and completion of voting processes during the prescribed voting hour.

The State Counsellor then gave the advice to prepare for the convenience of voters and to erect information and education signboards for the safety of voters inside the polling stations.

The No.1 polling station at the primary school will be used

for 1,526 voters.

The UEC has updated that the number of voters in respective townships of Nay Pyi Taw Union Territory is recorded at 89,816 in Zabuthiri Township, 28,167 in Dekkhinathiri Township, 134,603 in Pyinmana Township, 218,671 in Lewe Township, 81,750 in Zeyathiri Township, 178,844 in Tatkon, 94,116 in Pubbathiri Township and 52,469 in Ottarathiri Township.—MNA

- irrespective of sex or religion
- those who are 18 years of age on the date of the election
- citizens, associate citizens, and those who have permission to become naturalized citizens, who do not contravene the provisions of the Hluttaw Election Law
- a person whose name has been included in the voting list of the respective constituency

Who is ineligible to vote?

- a member of a religious order
- person serving a prison sentence
- person adjudged to be of unsound mind as provided for in the relevant law
- person who has not yet been discharged as an insolvent
- person prohibited by the Election Law
- foreigner or person who has assumed foreign citizenship

THE Ministry of Health and Sports organized the National Launching on Human Papillomavirus (HPV) Vaccine Introduction yesterday.

The launching ceremony for central-level was organized at the Myanmar International Convention Centre-II in Nay Pyi Taw, and those present at the event were Union Ministers Dr Myo Thein Gyi and Dr Myint Htwe, Deputy Minister Dr Mya Lay Sein, Permanent Secretary Professor Dr Thet Khaing Win and department heads.

Meanwhile, it was also virtually participated by Union Ministers Dr Pe Myint and Dr Win Myat Aye, chief ministers of states/regions, deputy ministers, government members of states/regions, directors-general, managing directors, rectors, superin-

tendents of the hospitals, state/regional heads of Public Health and Medical Services Department, those from the relevant departments, Gavi, the vaccine alliance, officials from WHO and UNICEF, donor organizations, chairperson and members of National Immunization Technical Advisory Group, medical organizations, officials from NGO/INGOs and health experts.

A video message of State Counsellor Daw Aung San Suu Kyi was screened at the cere-

Union Minister for Health and Sports Dr Myint Htwe talked on the ministry's ongoing works not only in containment measures against COVID-19 but also in other healthcare services, including the vaccination programme among over 40 health projects

of the country. The HPV for prevention of cervical disease is the 13th vaccination programme of the ministry, and it was launched on 20 October. The vaccination will be given to over 450,000 girls ages 9-10 years. Although the programme will be skipped in the areas under stay-at-home order at present, it will begin as soon as the order was removed in these areas. The vaccination programme will be conducted at the schools when the academic year is resumed. The HPV that will be used in Myanmar is a quadrivalent vaccine which was supplied by Gavi, the vaccine alliance, at a special price of US\$4.5 for one dose to one person and the second and final dose will be injected in the alternative year.

Speech of State Counsellor at National Launching on Human Papillomavirus (HPV) Vaccine Introduction

(20 October 2020)

ODAY is a historic and milestone day for our health sector in our country.

The reason I can say this is because beginning from October 2020, HPV vaccine (Human Papillomavirus Vaccine) has been included as the 13th vaccine in the regular vaccination programme of the Ministry of Health and Sports and 450,000 young girls between the ages of 9 to 10 years will be vaccinated on a nationwide scale in the wards and villages of regions, states and townships.

The HPV vaccine can prevent cervical cancer caused by the Human Papillomavirus (HPV).

Cervical cancer affects women all over the world, and it is the fourth most prevalent cancer, and this type of cancer afflicts Myanmar women the most.

According to available data, in 2018, a total of 849,569 women all over the world were afflicted with cervical cancer and 365,311 women lost their lives.

It is learnt that in Myanmar, 6,472 women were afflicted with cervical cancer and 3,856 women lost their lives.

It is learnt that in Myanmar, 21 women out of every 100,000 women were afflicted with cervical cancer, and Myanmar ranks second among South-East Asian countries.

Among the viruses that cause cervical cancer, 70 per cent are caused by HPV 16 and 18; among women who have normal immunity level, cervical cancer may develop only after a period of 15 to 20 years after being infected by this virus. However, among women with low immunity level (e.g. those who have HIV), cancer can develop with 5 to 10 years.

We can prevent HPV infection, which causes cervical cancer by having HPV vaccination while young.

By vaccinating young women as early as possible before 15 years before they are exposed to the HPV virus, sufficient time could be given for protection; this is why the WHO – World Health Organization has urged member countries to include the HPV vaccination the regular vaccination programme as a priority.

There are now 100 countries which have included HPV vaccination in their regular vaccination programmes up to August 2019.

Rich countries have been able to provide HPV



vaccinations as a result of which they have been able to reduce the rate of cervical cancer occurrence. However, we have seen that poor countries have not been able to make use of this vaccine for a disease which is quite prevalent.

By including the HPV vaccination in the regular vaccination programme in Myanmar, we would be able to effectively reduce the occurrence/fatalities caused by cervical cancer; furthermore, we can reduce the expenses needed for medical treatment and human resources.

From the part of the people, they will become to have more confidence in vaccination programmes because of the availability of additional potent and valuable vaccines as well as trust and acceptance; they will thus have more enthusiastic cooperation and participation to improve the coverage of current vaccinations and dispensation of medicines.

This year during October and November, we will be including the HPV vaccination in the regular vaccination programme to cover the targeted age group for young girls who were born between September 2010 and August 2011; they will be vaccinated two times with a spacing of 12 months.

Every year, we will collect data and provide vaccination against HPV to all the girls aged between 9 and 10.

HPV vaccine price for a girl is USD4.5 per dose. The government will pay 20 per cent of the expenses while an international organization named "Gavi, the

Vaccine Alliance" will pay 80 per cent. But after 2025, the government will have to pay all of the expenses.

The Central Expanded Immunization Programme section, operated under the Public Health Department of the Ministry of Health and Sports, have already made advance preparations systematically on a real-time basis, to give the vaccination to all children of the targeted age group, leaving no one behind, at the national, regional, township-level up to the rural health divisions.

Similar to this central-level opening ceremony marking the vaccination period, Region/State level, and township level opening ceremonies marking the vaccination period will be held in their areas to coincide with the actual commencement of vaccination.

The objective is that all officials from the central government and regional governments, all level of public administrators, relevant departments, NGOs, local and foreign civil society organizations, and all the citizens need to know about the introduction of HPV vaccination programmes, the targeted agegroup, and all other diseases that can be prevented by vaccinations; the intention is that all of them will willingly participate in the vaccination programme, and all children of the targeted age-group will receive all the vaccines they need.

Moreover, we will be able to urge women between the ages of 30 and 49 to have regular cervical cancer screening and to receive necessary treatments early enough, so that the fatality rate of cervical cancer will be sharply reduced.

In conclusion, the introduction of the HPV vaccination, as 13th vaccine, in the regular vaccination programmes of the Ministry of Health and Sports is a huge investment that will bring effective benefits for the country; so I would like to urge all relevant ministries, region/state governments, administrative units, civil society organizations and all citizens to cooperate in the programme so that all children of the targeted age-group, leaving no child behind, can be vaccinated.

Thank you all. May you have good health and well-being.

The programme will also reach to far-flung areas, self-administered zones and ethnic areas with the cooperation of state/region governments.

The Union Minister also quoted the study of Johns Hopkins University, conducted in 94 countries during the Decade of Vaccines from 2011 to 2020. The findings showed that for every dollar invested in immunization over this period, there is a US\$16 return for the health sector and \$44 for the social sector.

Gavi, the vaccine alliance,

will also assist in receiving COV-ID-19 vaccine for 20 per cent population of Myanmar after it has been developed.

Myanmar is working to meet the objective of the WHO to lower the elimination target of 4 cases per 100,000 women per year.

He also discussed the awareness programme to prevent this disease at all levels of the community.

After screening the HPV programme video, the three girls were vaccinated before the ceremony was concluded. —MNA


Vice President U Henry Van Thio delivers speech at virtual event marking World Statistics Day

VICE President U Henry Van Thio, in his capacity as Chairperson of the Central Committee for Accurate and High-Quality Statistics, delivered an opening speech at a virtual event marking the World Statistics Day 2020 hosted at the Ministry of Planning, Finance and Industry in Nay Pyi Taw yesterday morning.

The committee Secretary U San Myint (Director-General), the Deputy Director-General, and other officials attended the event in the ministry.

The virtual event was also participated via videoconferencing by Union Ministers Lieutenant General Soe Htut. U Soe Win, U Kyaw Tin, Dr Pe Myint, Dr Aung Thu, U Thant Sin Maung, U Ohn Winn, U Win Khaing, U Thein Swe, Dr Than Myint, Dr Myo Thein Gyi, U Han Zaw, Dr Win Myat Aye and U Ohn Maung; Deputy Ministers U Tin Myint, U Maung Maung Win, U Sett Aung and Dr Min Ye Paing Hein; the Central Bank of Myanmar Deputy Governor, regional Ministers, Permanent Secretaries, Directors-General, Managing Directors, and officials from development partner organizations, civil society organizations and private sector.

The United Nations General Assembly adopted resolution 69/282, in which it designated 20 October as the World Statistics Day and decided to celebrate the Day every five years on that date. Myanmar also celebrated

the Day in 2010 and 2015, according to the Vice President. This year's event was held online because of COVID-19 pandemic.

The theme of World Statistics Day 2020 is "Connecting the world with data we can trust". Myanmar has aimed to strengthen the national statistics system that the citizens trust, according to the Vice President.

The Vice President stressed that trustable data is needed to know the changes in the world, and statistics also have a crucial role in responding to the global COVID-19 crisis.

The virtual event is also intended to promote cooperation between all stakeholders to create Myanmar's comprehensive national statistics system that can acquire trustable socio-eco-

nomic data and reliable indicators, and to develop trustable data between the people and the government and among the global countries, according to the Vice President.

The Pyidaungsu Hluttaw enacted the Statistics Law on 22 January 2018 and, it has been applied starting from 22 January 2019. The Central Committee for Accurate and High-Quality Statistics held ten meetings from 2016 to 2020, said the Vice President

Myanmar has already drafted the Statistical Policy Brief and the National Strategy for Development of Statistics (NSDS) Implementation Action Plan (2018-19~2022-23) to produce accurate statistics.

The Vice President said that

like other countries, Myanmar has made efforts to formulate Code of Practice for statistics. He also pointed out that "data culture" needs to be developed in government departments, private sectors and the general public

The Vice President claimed that investing in the statistics sector is the only way to assess the results related to the Sustainable Development Goals (SDGs) 2030.

The Vice President also called on all stakeholders to effectively cooperate in preparing reliable statistics to connect the international community with trustable data.

During the event, a message of the UN Secretary-General was read by UN Resident and Humanitarian Coordinator Mr Ola Almgren.

United Nations Statistics Division (UNSD) Director Mr Stefan Schweinfest also sent a video message to the virtual event.

A documentary video featuring the development of Myanmar statistics sector was also screened in the event.

The committee's Secretary U San Myint explained Myanmar's statistics system.

During the event, the Economist and Professor Dr Aung Tun Thet led the discussions on "Connecting the international communities with the data we can trust".—MNA

HONG KONG business and those already present in Myanmar expressed a keen interest in Myanmar's significant investment potential including areas as diverse as energy, transport, banking and finance, retail and services during a recent webinar organized by the Myanmar-Hong Kong Chamber of Commerce and Industry.


As a guest of honour delivering a keynote address, U Thaung Tun, Union Minister for Investment and Foreign Economic Relations, highlighted Myanmar's enviable geographic position as:

"...a strategic land bridge, connecting two of the world's largest regional economies, those of South and South East Asia, we also wish to play a greater connecting role – connecting East and West – from the Mid-East to the Mekong!"

The Union Minister also referred to ongoing challenges posed by COVID-19 noting that:

"...today the IMF forecasts Myanmar's growth at closer to 2 per cent – still placing us amongst a small handful of nations who will post positive growth this year. Thankfully, most forecasts suggest our rapid return to pre-crisis growth of 6 per cent plus in 2021."

The Union Minister together with panellists, including Memories Group CEO Mr Cyrus Pun, Cycle & Carriage

Myanmar General Manager Mr Adrian Short, and Mr Edgar C P Kwan, Marga Group Chief Development Officer were in firm agreement that such growth could be achieved via increased and diversified investment in maritime infrastructure, roads, rail, urban housing, border cooperation zones, agriculture, technology, cyber and clean energy projects amongst many others.

Despite current sluggish global growth and general uncertainty, Mr Edgar C P Kwan expressed optimism that the coming year will bring forth further opportunities for Myanmar, highlighting in particular, investment opportunities in Myanmar's energy, real estate and manufacturing services sector, while noting that the continued

expansion of a world-class services industry will also help to further facilitate Myanmar's broad-based and inclusive development.

Memories Group CEO Mr Cyrus Pun enquired as to what steps had been taken to cut through red tape and to lower administrative hurdles faced by investors, to which the Minister replied noting the launch of the Myanmar Companies Online (MyCo) company registration platform, the recent launch of an online tax payment system in Yangon, as well as the continued development of Standard **Operating Procedures across** all administrative units within the Ministry of Investment and Foreign Economic Relations as clear signs of progress being

With examples on offer such as the recent successful West Yangon Industrial Park competitive tender launch, the successful conclusion of international tendering for 30 solar power projects, and the recent approval (Notice to Proceed) of a new Thilawa LNG-to-Power project – amongst Myanmar's largest and equal to one-fifth of the country's current power generation capacity - the Minister noted how continued investment in Myanmar's energy sector will unlock further flowon investment in other sectors, generating new jobs for a young population while ensuring the government keeps its commitment to electrifying the nation

The Union Minister also drew attention to the upcoming

launch of the Myanmar Economic Recovery and Reform Plan (MERRP), clarifying its role as an interim reform-oriented measure, a natural successor to the shorter-term COVID-19 Economic Reform Plan (CERP), that will be used to ensure remains on track toward achieving the MSDP once the COVID-19 pandemic sub-

Noting the reputation Hong Kong investment has garnered as responsible and of high quality, the Minister emphasized that Myanmar welcomes responsible, quality investment from wherever it may come and remains committed to providing a level playing field for all responsible investors seeking to do business, or to explore greener pastures in Myanmar.—MNA

MINISTRY of Labour, Immigration and Population held a pre-coordination meeting on 16th ASEAN Senior Labour Officials Meeting and related meetings to be held by video conferencing in Indonesia on 26 and 27 October, ASEAN Labour Ministers' Meeting and the 11th ASEAN +3 Labour Ministers' Meeting to be held on 28 October.

Union Minister U Thein Swe

said that the meetings of ASEAN Senior Labour Officials Meeting, ASEAN Labour Ministers' Meeting and ASEAN+3 Labour Ministers' Meeting aimed to implement the guidelines set by the ASEAN leaders in their respective sectors.

The Union Minister continued that the ASEAN Labour Ministers' Action Plan 2021-2025 and related work programmes

will be submitted to the ASE-AN Labour Ministers' Meeting with the approval of the ASEAN Senior Officials' Meeting and the ASEAN Labour Guidelines and Roadmap, which have been officially approved by the ASEAN Labour Ministers will be reaffirmed at the meeting.

He called for preparation and coordination with relevant departments to make effective participation in video conferencing meetings from 26 to 28 October; participants should prepare information and requirements in advance and ensure that there is no internet or power outage and to prepare the necessary information related to the discussions at previous meetings and information to be approved at this meeting.

The Union Minister said it is necessary to study and prepare for the main purpose of the 26th ALMM "Competitiveness of ASEAN Workers for Future Careers; Improving resilience and mobility".

He also said to send the necessary information related to the department accurately and completely in time; to submit in time if there are any issues to be submitted to the higher authorities for decision before the meeting; to assign English skills experts and to prepare for the

new generation; to send the midterm report in a timely manner related to the decisions made at previous ASEAN meetings; to constantly monitor the activities of other ASEAN countries as Myanmar has the largest number of migrant workers in ASEAN and to take in-depth study of ASEAN labour issues.

Afterwards, the Directors of the Department of Labour and the Social Security Board explained their participation in the 13th SLOM-WG meeting. The cost of vaccinating a child against cervical cancer

is about four dollars. Twenty per cent of the total funds required for the nationwide immunization programme will be paid by the Union government, while Gavi, the Vaccine Alliance, has donated 80 per cent of the funds. The government will have to fund the entire immunization programme after 2025.

Hence, it is important that the funds allocated for the programme are used effectively.

Meanwhile, the Union Government is keeping on watch the trial results of COVID-19 vaccine in the world, and so far, no country has yet finalized the phase-3 clinical trial.

It is worth noting that Gavi, the vaccine alliance, would provide the COVID-19 vaccine for 20 per cent of our population once the vaccine is approved by the World Health Organization, and the Union Government has made necessary arrangements to prepare for COVID-19 vaccinations.

We believe that the Ministry of Health and Sports and its health workers would leave no stone unturned to make the nationwide immunization programmes a success despite COVID-19 challenges.

Relation between climate change and COVID-19

HE COVID-19 has spread rapidly and exponentially all over the world. It is affecting the lives of millions of people and, also, the environment. The effects are detrimental not only for human health but also for the economy, industries, tourism, social and politics. The Carbon Dioxide (CO2) emissions and human mobility have been reduced, which improves air quality and encourages wild animals to come out and explore the cities. With drastic reduction in CO2 and other greenhouse gas emissions since the outbreak of the pandemic the climate conditions are visibly improving, the only beneficiary is our

Positive effects of the COV-

With many factories shutdown, major construction works ceased, most traffics at standstill and less people are out and about on the streets due to the stay home and the lockdown orders, the air, the noise and the plastic pollutions markedly decreased across the globe. I first noticed those conditions in Yangon at the beginning of the pandemic in our country. During my morning walks, I came to notice the surrounding vistas looking clean, pristine and the air fresh and pure with clear blue skies above and the streets, roads and

sidewalks devoid of plastic wastes

-- a sight rarely seen in Yangon

In China, notorious for air pollutions, where the present pandemic originated, the CO2 emissions have decreased by a quarter. Similarly, in Italy and Spain, COV-ID-19 has substantially reduced air pollution as the emissions of the greenhouse gases have been reduced drastically during the first two and a half months of 2020. Some experts are of the opinion that the COVID-19 pandemic is linked to the climatic conditions.

Only a few months into the outbreak of the disease, the reports from around the world widely acclaimed the great improvements in the climate conditions. One interesting news was about the sighting of a distant snow-capped peak in the Himalayan Range from a place inside India for the first time in thirty years. These incited in me an urge to mention about the positive impacts of the COVID-19 on the climate change, which I duly did in one of my articles. These are the bright sides of the COVID-19 pandemic, but how sustainable is this positive effect in the long term?

Adverse effects of the COV-

It is learnt that the opposite effects are also taking place; the climate change is impacting the humans adversely during the pandemic. Many had written about the impacts of the pandemic on the economy, social, ways of life and some other aspects. I may be wrong or missed them, but only a few or none have written about how the worsening climate change can affect the pandemic, in our

avoided and will be done generally and simply. First and the most important impact of the climate change on the pandemic is how the natural disasters, such as, the storms and floods are expediting the spread of the disease. When there are dangers of an eminent storm and possibilities of flooding, residents are usually required to evacuate to safe and higher grounds. Such actions taken under pandemic conditions will expose the populace to the disease, as they will have to cram into crowded transport and stay in confined and overcrowded shelters. No one can know who among those evacuees are infected or who are silent carriers of the disease.

In support of the above statement, allow me to cite some evidences of the impact that the climate change has on the spread of the disease. In late May 2020, as COVID-19 was spreading rapidly around the globe, one of the most powerful storms in decades ravaged the east coast of India. In anticipation, some 3 million people were evacuated into crowded cyclone shelters. Many refused to go there out of fear of contracting the virus. An unknown number of whom were killed as the cyclone ripped through their ramshackle coastal villages. The extent to which the virus was able to spread due to the evacuations has yet to be assessed, but surely those evacuations were not without undesirable

Another example worth mentioning is the one that took place almost about the same time as the one in India. Halfway around the world, two dams on the Tittabawassee River in the US state of Michigan were failing after record flooding from intense rains. As the waters rose a state of emergency was declared and the authorities pleaded with the residents in the floodplain to evacuate immediately. Michigan, at the time, was being particularly hard hit by COVID-19 and the state had, despite considerable opposition, implemented far-reaching lockdown and quarantine measures. Just imagine how difficult and risky those moves would be during a pandemic. There are many similar examples, but hope these two cases will suffice.

The basic logic of the risks in an overlap between the pandemic and extreme weather events is straightforward. During a pandemic, the urgent displacement of millions of people during a storm BY Khin Maung Myint

increases the risk of exposure to the virus as maintaining adequate precautionary measures becomes difficult, if not impossible; so does the effective contact tracing of new cases among the evacuees.

Once the storm has passed, residents face the grueling task of cleanup and repair, made more difficult because of necessary virus protection measures. Storm-battered health-care facilities, if fortunately they remain operational will face the challenge of accommodating an influx of storm-related cases. On top of the pandemic caseload, storm victims must be kept separated to reduce the risk of transmission. In the event of widespread storm disaster, like the one sustained during the Cyclone Nargis, the state healthcare systems could quickly be overwhelmed, seriously increasing the toll of both the pandemic and the storm.

Basically, the climate change helps create conditions for the emergence of new pandemics and for increasing their lethality. Thus, the climate change can be called a pandemic enabler, a pandemic accelerant and a multi-pathway crisis engine. COVID-19 is pointing out to us that our health and our planet's health are inseparably entwined. The same conditions that contribute to climate change

also contribute to the pandemics. Investing in the mitigation of these conditions will yield a double reward. So, it's needless to say that failure to invest will lead to an exponential increase in the risk

Conclusion

As some climate change experts are predicting, the worsening of the climate, which is the result of human activities, will definitely return to its old conditions as before the pandemic, once all these are over. People will start polluting the environs as ever before. This collision of the climate change and the pandemic is a very loud and clear alarm siren for us to be aware of the challenges ahead if the climate change is not reined in. So, now that we know the climate change and the the pandemics are inseparably entwined, all of us, humans should endeavour to fight the worsening climatic conditions. Our efforts will not go to waste, but contribute greatly to the control of the spread of the pandemics, in case we are unfortunate to encounter in the future again.

NATIONS TO CONTINUE CORONAVIRUS MITIGATION STRATEGIES

Focus on fundamentals as COVID-19 caseloads rise: WHO

As COVID-19 cases continue to accelerate, particularly in Europe and North America, the World Health Organization (WHO) is advising governments and people everywhere not to let their guard down, for the benefit of those hospitalized, or working on the front line of the battle to end the pandemic.

"I know there's fatigue but the virus has shown that when we let our guard down, it can surge back at breakneck speed and threaten hospitals and health systems", agency chief Tedros Adhanam Ghebreyesus told journalists on Monday.

Last week, WHO reported that the pandemic has entered a worrying phase as the northern hemisphere winter season approaches.

At the time, the caseload in Europe was almost three times higher than during the first peak of the pandemic in March. **Break transmission chains**

Tedros said he was encouraged to see many leaders com-

municating with their populations about targeted measures necessary to slow coronavirus spread and protect health workers and health systems.

He pointed out that as cases rise, the number of people needing hospital beds and intensive care also increases. And although nurses and doctors now have a much better understanding of how best to treat people with the virus, the situation could put them and patients at risk.

"So, it's important that all governments focus on the fundamentals that help to break the chains of transmission and save both lives and livelihoods".

Announcement related to ballot papers with Hluttaw candidates of United Democratic Party (terminated)

- 1. The Union Election Commission announced the dissolution of United Democratic Party in line with Section 12-(b) of the Political Parties Registration Law as the party failed to comply with provisions in Section 12, Sub-section a-iv of the Political Parties Registration Law and Section 15, Sub-section b, c, and f of the Political Parties Registration Act.
- 2. UDP candidates have also lost their rights to be elected as Hluttaw candidates in 2020 General Election as they failed to comply with the provisions of the Sub-section (h) of the Section 10 of the Hluttaw Election Law. The UEC has also instructed the sub-commissions to remove their names from the list of Hluttaw candidates in line
- with respective Hluttaw election bylaws and bylaw 36 (c and d).
- 3. It is now 19 days ahead of the General Election, and the ballot papers printed at the Ministry of Information are being transported to the various levels of election sub-commissions through the sub-commissions of states, regions and the Union Territory.
- 4. It is not enough time to reprint the ballot papers without the name of UDP candidates at the Ministry of Information, and transport the papers to the respective sub-commissions. Moreover, the respective election sub-commissions have no sufficient time to draw a red line over the name of candidates, party logo and marking place for vote
- to cancel them. The respective sub-commissions will not also remove/delete the name of candidates of this party from the ballot papers.
- 5. Therefore, the voters, either for advance voting or for polling station vote on the Election Day, shall not vote for the terminated candidates of United Democratic Party. Otherwise, such votes will be determined as rejected ballots.
- 6. The announcement will also be published at the sub-commission offices and polling stations. And that, it is informed to the voters to prevent the rejected ballot in line with this announcement.

YGN region tops \$308.768 mln from 137 foreign firms last FY

YANGON Region Investment Committee endorsed 137 enterprises in the past financial year 2019-2020, bringing in estimated capital of US\$308.768 million, according to the Directorate of Investment and Company Administration (DICA).

Between 1 October and 30 September of the FY2019-2020, Yangon Region stood at the first place with 137 foreign enterprises (with a capital of \$308.768 million), followed by Bago Region with 18 foreign projects (\$72.645 million) at the second place and Ayeyawady, with nine at the third place (\$19.614 million).

Additionally, foreign direct investments also flow into Taninthayi Region from two projects worth \$1.397 million, Magway Region from two worth \$0.991 million, Mon State from two worth \$1.664 million, Mandalay Region from one business valued \$4.6 million, Sagaing Re-

gion from one worth \$3 million, Kachin State from one worth \$1 million, Shan State from one worth \$4.13 million and Nay Pyi Taw Council from one valued \$5.862 million.

In the last FY, the respective investment committees of Kavah, Kavin, Rakhine and Chin states did not endorse foreign enterprise at all, the DICA stated.

The region and state investment committees endorsed a total of 175 foreign enterprises with an estimated capital of \$423.671 million last financial

The endorsed enterprises are to be engaged in the manufacturing, hotels and tourism, other services, power and agricultural sector.

Of them, the majority of the investment goes into the manufacturing sector, followed by other service sector and hotels and tourism sector.

The manufacturing sector has also attracted the most foreign investments in Yangon Region, with enterprises engaging in the production of pharmaceuticals, vehicles, container boxes, and garments on a Cutting, Making, and Packing (CMP) basis.

To date, foreign investments from China, Singapore, Japan, Hong Kong, the Republic of Korea, Viet Nam, India, China (Taipei), Malaysia, the British Virgin Islands and Seychelles are arriving in the region.

To simplify the verification of investment projects, the Myanmar Investment Law allows the region and state Investment Committees to grant permissions for local and foreign proposals, where the initial investment does not exceed K6 billion, or \$5 million.—Nyein Nyein

Merchants sell stocked beans to India to meet its purchase target

MOST variety beans exporting merchants are selling the beans, which were bought at high prices and stocked in the warehouses, to India that will buy 400,000 tonnes of pigeon peas, said General Secretary U Zaw Moe of the Monywa Commodity Depot.

"Now, the price of pigeon peas is rising in the market because India has set up the import quota of pigeon peas and black beans for Myanmar. The price of pigeon peas rose by K3,000 or K4,000 per basket. The market price of pigeon peas is K30,300 per viss. The retail shops are selling a viss of the pea for K30,300. The price is rising as India set up the import quota for Myanmar. Recently, the bean bags are being loaded onto the ship at Yangon jetty," he added.

Now, Monywa town is sending around 3,000 bags of bean daily to Yangon via land route. The pigeon pea bags in Yangon are also selling well.

"India highly demanded the black beans and pigeon peas from Myanmar. We can also sell those beans as long as India demands," said U Tin Ko Ko, the officer in charge of the Monywa Commodity Depot. The exported pigeon peas to India are harvested in 2020 as well as those which were harvested in 2018 and 2019. The local merchants are selling them, which are stocked in their warehouses

"Most of the traders are selling the beans which were stocked in their warehouses. Some are still waiting expecting the extended deadline of India. I think, 75 per cent of the merchants are selling their stocked beans," said the general secretary of the Monywa Commodity Depot.

There are around 70,000 or 100,000 bags of pigeon peas in Sagaing Region. Twenty bags of pigeon peas weigh one tonne. --Myo Win Tun (Monywa)

"GO TO TRAVEL"

Over 25 mil. overnight stays covered by Japan travel subsidy campaign

THE Japanese government's "Go To Travel" subsidy campaign covered 25.18 million domestic overnight stays for about two months since its launch through the end of September, the tourist

ministry's preliminary figures showed Tuesday.

During that period, the government funded a total of 109.9 billion yen (\$1 billion) in discounts under the programme, which is aimed at boosting the tourism sector hit by the novel coronavirus pandemic. The scheme will last through the end of January. Guests took advantage of the initiative which offered a 35 per cent discount for hotels and package tour costs, paying on average 12,000 yen per person in lodging expenses.

Although some have pointed out that bookings are skewed toward luxury hotels rather than cheap ones, as guests find the scheme allows higher returns at expensive accommodations, tourism minister Kazuyoshi Akaba told reporters Tuesday that travelers are using the campaign for "every price range."

Around 16.89 million domestic overnight stays were covered by the programme between July 22 and Sept. 15, with the government shouldering a total of 73.5 billion yen in discounts, according to the data from hotels and travel agencies across the country.

BLEAK GROWTH FORECASTS

New virus restrictions deal fresh blow to Spain economy

FRESH virus restrictions imposed in Spain's two regional economic powerhouses, Catalonia and Madrid, have darkened the country's already bleak growth forecasts and angered business leaders.

The two regions together account for around 40 percent of Spain's economic output and are home to most of the country's big firms, as well as the pillars of its economy such as tourism and the manufacturing sector.

"We will die of hunger," hundreds of restaurant operators chanted during a protest Friday in Catalan capital Barcelona against a 15-day shutdown of bars and restaurants to contain a surge in cases in the northeastern region.

The measure was introduced shortly after a partial lockdown was imposed in Madrid and several of its satellite towns early October to curb a second wave of the virus in Spain, where nearly 34,000 people have died and about 975,000 have been infected.

Madrid residents can only leave city limits for essential reasons linked to work, school or healthcare, while opening hours and the capacity of bars and restaurants have been reduced. If the restrictions are maintained for long in the two regions, it will have "a very negative impact" on the economy, Inigo Fernandez de Mesa, the deputy chief of business lobby group CEOE, told AFP.

External trade touches \$473 mln as of 9 October in 2020-2021FY

MYANMAR'S external trade between 1 and 9 October in the current financial year 2020-2021 touched a low of US\$473.89 million, a sharp drop of \$473 million compared with the corresponding period of the FY2019-2020, according to the Ministry of Commerce.

During the same period in the previous FY, trade stood at \$947 million, according to data released by the ministry.

The decrease in Myanmar's foreign trade was attributed to the drop in exports and imports in the first nine days of the current FY amid the COVID-19 crisis. Myanmar exports agricultural products, animal products, minerals, forest products, and finished industrial goods, while it imports capital goods, raw industrial materials, and consumer goods.

The country's export sector relies more on the agricultural and manufacturing sectors. The government is trying to reduce the trade deficit by screening luxury import items and boosting exports.

Myanmar external trade between FY2016-2017 and FY2019-2020 (as of 21 August) under the incumbent government period touched a high of US\$149.67 billion, comprising exports worth \$68.53 billion and imports valued \$81.1 billion, according to the statistics released by the Ministry of Commerce.

Myanmar foreign trade has shown a 10per cent increase, year over year, under the incumbent government. Myanmar has already surpassed the total trade value target of \$34 billion for the last FY, said an official from the ministry.

The Ministry of Commerce is endeavouring to boost export, enhance value-added production, reduce export barriers and provide trade financing services.

Myanmar's top export countries are China, Thailand, Japan, Singapore, the US, India, Germany, the Republic of Korea, Spain and the UK. In contrast, it primarily imports from China, Singapore, Thailand, Malaysia, Indonesia, India, Viet Nam, Japan, the Republic of Korea and the US, as per data of the Ministry of Commerce. The Ministry of Commerce is endeavouring to boost export, enhance value-added production, reduce export barriers and provide trade financing services.

Under the National Planning Law for the Financial Year 2020-2021, Myanmar intends to reach an export target at US\$16 billion and import at \$18 billion.—Ko Htet

Yangon gold market to reopen on 22 October

YANGON gold market, which has suspended due to the COVID-19 resurgences, will be officially reopened on 22 October, said U Myo Myint, chair of Yangon Region Gold Entrepreneurs Association (YGEA).

"Restriction has been imposed on the businesses, except essential enterprises, regarding passing from one township to another by 21 October. Consequently, the gold shops will reopen on 22 October. Also, the trading can start resuming at YGEA's office on 22 October," he said.

Starting from 12 October, the members of YGEA, who are located at the same township with YGEA

office in Shwebontha Road, started trading the gold at the office.

Yangon gold market was temporarily closed on 15 September amid the coronavirus crisis, and the price of yellow metal stood at over K1.3 million per tical (0.578 ounces, or 0.016 kilogrammes) then. Some shops were open at over

K1.3 million on 12 October as well.

The pure gold fetched K1,313,500 per tical on 20 October, while global gold price stood at US\$1,901 per ounce.

Despite the closure of Yangon gold market, small shops, which are operating at their own houses, are still running in Yangon Region. They like to get selling rather than buying, he contin-

There are more than 10,000 gold shops in the region and about 50 visses of gold were traded earlier. During the first wave of COVID-19, Yangon gold market was closed between 29 March and 18 May. (Translated by Ei Myat Mon)

Ajax -- What remains of the team that took Champions League by storm?

AMSTERDAM — Ajax host Liverpool in the Champions League on Wednesday, 18 months after being denied the chance to play the Anfield club in the final by a stunning Tottenham Hotspur comeback in the semi-final in Amsterdam.

The Dutch side wowed Europe on that run to the last four, before many of their best players were unsurprisingly picked off by wealthier clubs elsewhere.

AFP Sport looks at what remains of that Ajax team:

Moved on

The two big names to leave in the summer of 2019 were the Dutch international duo of Matthijs de Ligt and Frenkie de Jong.

Centre-back De Ligt, who captained Ajax in that campaign aged 19, scored the win-

ner against Juventus in the quarter-finals and also scored

against Tottenham in the semi-final. He moved to Juve for 75 million euros (\$84.2 million) plus 10.5 million euros of add-ons, a world-record fee for a defender. Meanwhile midfielder De Jong, now 23, was sold to Barcelona in a deal worth a total of 86 million euros that was agreed midway through the 2018-19 season.

Kasper Dolberg was really only a bit-part player in that Champions League campaign, but Ajax still cashed in on the Danish striker, selling him to French club Nice for 20.5 million euros. Another Dane, veteran midfielder Lasse Schone, left for Genoa in Italy.

After failing to progress beyond the group stage of last season's competition, Ajax allowed another mainstay of their side to go, with supremely gifted Moroccan international attacking midfielder Hakim Ziyech joining Chelsea for 40 million euros.

Arrested Czech deputy FA head steps down

PRAGUE — Czech Football Association (FACR) deputy head Roman Berbr stepped down Monday after being put in custody the day before over suspected match-fixing, the FACR said in a

statement.

Berbr is one of 19 people detained by police last Friday as part of an organized group. A club director, a former player and a former referee have ended up in

custody too.

The FACR said it had also dismissed its referee department and that it would boost control over match-fixing and hire new referees.

"This is the beginning of a long journey on which Czech football must win back the trust of fans, partners, and the broader public," FACR head Martin Malik said in a statement.

"We are all guilty," he added. On Friday, police raided the FACR's Prague headquarters and other places linked to football across the country.

Berbr, a 66-year-old former referee, has held his post since 2013 and according to local media has been pulling the strings in Czech football for years.—AFP

Nadal to play Paris Masters next month

PARIS — Rafael Nadal announced on Tuesday that he will compete in the Paris Masters next month, despite previously saying he might not play again this season.

The 34-year-old won a record-extending 13th French Open title earlier this month with a one-sided final victory over world number one Novak Djokovic at Roland Garros.

"It's indoor season time... this picture was earlier today practising at rnadalacademy," he posted on Twitter alongside a photo of him training.

"And yes... getting ready for ParisBercy."

The Paris Masters is scheduled to run from November 2-8. Any health rules to be implemented for the event due to the coronavirus are yet to be announced.

After moving level with Roger Federer on a men's record 20 Grand Slam titles, Nadal said: "I don't know what I'm going to do after Roland Garros.

"I can't tell you if I'm going to play again or not in the next two months."

Nadal has never won the Paris Masters in his career. He pulled out before a scheduled semi-final against Denis Shapovalov at Bercy in 2019.—AFP

Liverpool must stay in trophy hunt for injured Van Dijk, says Henderson

LONDON — Liverpool captain Jordan Henderson says the loss of Virgil van Dijk is a "big blow" but he wants the Premier League champions to use his absence as an added incentive to stay in the trophy hunt.

Defensive talisman Van Dijk requires surgery after suffering knee ligament damage during Saturday's Merseyside derby with Everton.

Manager Jurgen Klopp is reluctant to put a timescale on the Dutchman's return but admits he faces a lengthy absence after being clattered by Everton goalkeeper Jordan Pickford in the 2-2 draw. Henderson is confident Liverpool can cope in Van Dijk's absence, even though he has been a pivotal player since he joined the club in 2018.

"It's a tough one. It's a big blow for us," Henderson told the club website. "For him personally, obviously. But for us as a team, a massive blow.

"I'm just gutted for him. It's a difficult moment, but that's

when you need to be there for each other."

The skipper said it was up to the team to "win as many games as we can for him".

"That's down to us as players to make sure that when he is back and he is fit that we're still fighting to be successful and fighting for trophies," said Henderson.

"You've got to use times like this to be stronger and to be even more together than we already are. And use it as a positive in some way."—AFP
