## State Counsellor reports on measures against COVID-19



ODAY, the most important thing I want to report to the people regarding COVID-19 is that the "Stay at home" order issued for certain townships is still in force; especially in Yangon. Just because we have given permission for some factories, workplaces, as well as factories and workplaces which are important for the economy in the long term, to resume operations if they abided by the rules and regulations that we have issued, does not mean that the "Stay at home" order is no longer in effect as some might think.

The "Stay at home" order is still in force. The rules and regulations are still in force. I request all of you to be patient and abide by the rules and regulations. In Yangon, we have been able to control COVID-19 as a start. This is only the beginning. I am not saying that the situation is under control. When I say we have been able to control the disease, as a beginning, the numbers have come down from the previous highest level. However, there have been ups and downs. It is not a continuous downward trend. It comes down, and then it goes up a little, then it comes down a little and goes up again. That's why we can say that we have begun to control the disease.

## New Goktwin bridge inaugurated in northern Shan State

DEPUTY Pyithu Hluttaw Speaker U Tun Tun Hein attended the inauguration ceremony of new Goktwin bridge located on Mandalay-Lashio-Muse road section of Union Highway in Nawnghkio township, Kyautme district in northern Shan State yesterday afternoon.

The ceremony was also attended by Chief Minister of Shan State Dr Lin Htut, his government members, Hluttaw representatives, departmental officials and local people.

After the Chief Minister made a speech, the Director for the Road Management Department (northern Shan State) explained the facts about the bridge and a local person expressed words of thanks.

The Deputy Speaker, the Shan State Chief Minister and the Shan State Minister for Road Transport cut the ribbon to open the ceremony and walked across the bridge.

The new bridge was built by the Ministry of Construction with Union funds 874 million kyats. The construction of this 30-ft-wide and 60-tonne twolane reinforced bridge began on 1 December 2019 and completed on 31 August 2020.

The old Goktwin bridge was damaged by a landmine on 15 August, and its loading capacity was reduced to a 48-tonne bridge.—Mine Htun (IPRD)

## COVID-19 medical devices for General Election imported from China

MEDICAL devices for COVID-19 prevention imported from China and to be used in the 2020 General Election arrived at Yangon International Airport by special flights on 21, 22 and 23 October.

These devices will be distributed to voters, polling station staff and volunteers during the elections.

Up to 23 October, 5,768,000 KN95 masks, 250,400 protective face masks, 66,700 sets of PPE medical protective clothing and 4,500 boots have been imported.

Special flights for more stocks of COVID-19 medical supplies will land at Yangon and Mandalay international airports from 24 October to 3 November. —MNA (*Translated by Aung Khin*)

#### Section 58 (d) in Hluttaw Election Law



IN accordance with section 58 (d) of the Hluttaw Election Law, no one is allowed to give speeches at meetings, instigation, writing, distribution of using posters or attempting by other means to disturb the voting or election. Anyone who is found guilty of or abet this act shall be punishable with imprisonment for a term not exceeding one year, or with fine not exceeding K100,000 (one hundred thousand Kyats), or with both.

## 2020 MULTIPARTY DEMOGRACY GENERAL ELECTION



#### Who is eligible to vote?

- irrespective of sex or religion
- those who are 18 years of age on the date of the election
- citizens, associate citizens, and those who have permission to become naturalized citizens, who do not contravene the provisions of the Hluttaw Election Law
- a person whose name has been included in the voting list of the respective constituency

#### Who is ineligible to vote?

- a member of a religious order
- person serving a prison sentence
- person adjudged to be of unsound mind as provided for in the relevant law
- person who has not yet been discharged as an insolvent
- person prohibited by the Election Law
- foreigner or person who has assumed foreign citizenship

Therefore, this year's UN theme, "The Future that We Want; the United Nations that We Need: Reaffirming our Collective Commitment to Multilateralism", truly reflects the current situation that requires the revival of the spirit of enhanced global cooperation.

We believe that the United Nations represents our collective efforts to improve the socio-economic lives of hundreds of millions of human beings the world over, as has been done over the past seventy-five years, through the promotion of peace and stability, sustainable development, a culture of justice, legality, and rule of law.

Regardless of its imperfections, the United Nations has visibly made the world a better place than it was seventy-five years ago. It has helped to deter major wars, lifted millions of people out of extreme poverty and hunger, and achieved an average life expectancy that is higher than ever before. There is no better alternative to the United Nations for steering multilateral efforts to realize the dream of creating a better world and shaping the future we want.

According to the global consultations recently conducted by the UN with peoples around the world, the priorities identified by the majority of the respondents are: better healthcare, education, clean water and sanitation. To meet their expectations, it is imperative for the United Nations to be revitalized and made

more responsive to the priority needs of the sovereign Member States.

Myanmar believes that a rules-based multilateral system, with the United Nations at its heart, should be a beacon of hope for developing and small countries. We look to the United Nations as the protector of developing small countries, especially at a time when the world is full of unfairness, injustice, inequality and multiple standards even in the application of international law.

Since joining the United Nations in 1948, Myanmar's faith in the values of the purposes and principles of the UN Charter has always been firm and solid. However, to be able to control completely, we need to continue our efforts.

When I said we need to continue our efforts, I don't know if some of our people might feel stressed out. But we need to be patient. We need to steel ourselves and stand firm. This is the same all over the world. In some countries, they are even saying it is the third wave because the infections have spread far and wide. The situation in our country is not in the worst situation. But we are also not in the best situation. Before August, we could say that we were among the countries with the best situation. Now, we cannot say anymore. However, because we have been able to control the disease, as a start, we can say that this is great progress.

Now if we look at the data for the whole country in terms of numbers and percentages, Yangon Region is at the top. After that it is Bago Region. After that, it is Rakhine State and after that Mandalay Region. However, Mandalay Region does not rank fourth in terms of percentages; only in terms of numbers. Yangon Region, Bago Region and Rakhine State are on the high side both in terms of percentages as well as numbers. That is why the people in Yangon Region must continue to be vigilant. The people in Bago Region must also continue to be vigilant. The people in Rakhine State must also be vigilant.

As the COVID-19 disease stays with us for a longer period of time, we know that it has caused hardships for the livelihood of the people. So how should we assist our people. We are now making plans to begin another programme of assistance for the people. We will inform the people as soon as these plans are ready. We regret that we have not been able to assist fully 100 per cent. However, we will do as much as possible. This will be done as quickly as possible. This is from the economic side. On the health side, we have heard that there have been some shortcomings.

For example, people who need to go into quarantine could not go into quarantine because arrangements could not be made in time; some people could not be admitted into the hospitals. We are considering these things so that we can fulfil the requirements of the people speedily; so that people can enter quarantine speedily; and so that people who need to be admitted into the hospitals can be admitted speedily. We are initiating new arrangements. We have been doing these things.

For example, in some cases, we have delegated people at the township level to make the decisions; the regional level authorities need not decide all matters. We will make new arrangements. For a case like sending people to quarantine, it could be done speedily if the township level could decide. Here I am talking only about sending people into quarantine. I am sure people would like to know how the situation will be in the long term. How the situation will develop in the long term, we ourselves cannot say definitely. However, I have said this before.

At the moment, in terms of medicines that are needed, as soon as we heard that vaccines have become available, we have contacted countries like China and India which have plans to produce these vaccines, to cooperate with them. That is why when the vaccines become available, our people will be able to use them. I am sure some of our people know what the experts have been saying about the vaccines. They have been saying many things. Some experts say that even if vaccines become available, there might not be 100 per cent guarantee. They say that vaccines would be more effective for people who have good health. Of course we can say this is true in all circumstances. A person with good health would be able to put up a better resistance to any type of disease. He would be in a better position to overcome the problem. That is why I want people to study about staying healthy during this COVID period.

This programme is broadcast twice a week. Questions can be raised to senior health experts and veteran doctors in the programme. Health knowledge would be searched on mobile phones. However, people need to understand that every health information online is not true. The UN has even reminded people to protect themselves from this type of misinformation. False knowledge and wrong information about health can pose risks on those who followed them. For example, some persons unreasonably give the wrong advice on foods and lifestyle to prevent COVID-19. There is no 100 per cent correct method that can guarantee prevention of the pandemic until now. Some experts have not confirmed in advance that the vaccine can guarantee 100 per cent prevention, and they have said a definite answer would be available only after the vaccine has been produced.

Therefore, try to live healthily. If your basic health conditions are good, you can overcome any disease. Therefore, healthy practices can be found in the information and news released by the Ministry of Health and Sports. It is advised to raise questions to the Q & A programme with senior health experts. Don't believe unfounded information and don't follow unreasonable ideas.

If any information was thought to be realistic, it could be put forward to the programme for seeking the right

I also want to report on the elections and COVID-19 situations. The number of overseas voter turnout increased by three times in comparing with that of 2015. However, the percentage of voter turnout from their registration declined from 75 per cent in 2015 to 69 per cent this year. Nevertheless, the figures of overall voter turnout surged by three times. Although Myanmar citizens abroad want to cast their votes and received applications of Form 15, they failed to cast their votes. It was possibly due to the COVID-19

outbreak. It is assumed that they got Form 15 because they had a desire to vote. However, in some countries, it was very difficult to go and vote.

Some countries allowed polling booths only in major cities. So, our people could not cast their votes. Actually, the percentage of 69 is considerably high, although it is lower than 75 per cent of the 2015 General Election. We are grateful to our citizens for their active voting in the elections in performing their duties as citizens.

As the elections become nearer, people need to abide by the rules and guidelines of COVID-19. Respective political parties need to follow these guidelines in their campaign activities not only for the health of the people but also for the victory of their party. So, it is advised to control their temper. Voting on 8 November is more important than energetic campaign activities. The voters who are eligible for advance voting can cast their votes before 8 November. Therefore, please build up your strength. Every political party will conduct its campaign in line with the rules. People might breach the rules during their participation in political campaigns of their party. It is requested to stay vigilant about this. In relation to the COVID-19, I have said this many times; we have to think about the future; we have to think about the economic situation. I want to tell the people that we are constantly monitoring the situation.

I am not telling you not to worry about the future. It will not be possible to persuade people not to have anxiety. It is reasonable to consider about the future. We cannot tell people not to have growing concerns under these circumstances. However, health is more important at present. Health is vital to overcome the pandemic. If someone is not healthy, they could not work. As a Myanmar saying goes, 'Health is the greatest of blessings'. It is very true. Please stay healthy and abide by the rules and regulations. It is essential to wear a mask. If all the

people wore masks, the infection rate of COVID-19 would decline significantly. I am collecting the infection data from respective countries. I am surprised at the infection rate of Japan because Japanese people strictly follow rules and disciplines.

In further studying, it was found that the population density of Japan is high and many people are using trains and buses. It is concluded that such public transports are some sources for the spread of COVID-19. Therefore, public gatherings have encouraged the spread of infections. Moreover, I have learnt that Japanese people are used to wearing masks. However, the masks cannot prevent this disease among the crowd. Therefore, people are suggested to stay away from crowded areas and to wear masks in public areas. For necessary reasons for going outside, it is required to wear a mask for the prevention of the disease. Don't hesitate to ask guests to wear masks and to wash hands. Don't have meals together with elderly persons at home. Although the younger persons can resist to the virus, the elderly persons at home might not have sufficient immunity to resist the disease.

Especially, the underlying disease of these elderly persons would reduce their immunity. Therefore, it is required to avoid having meals together at home during this period to prevent the spread of disease among the family members. It is believed that people have understood the rules for COVID-19. Their compliance with these rule plays a crucial role. If they failed to comply with these rules deliberately, their knowledge of the rules would be in vain to prevent the disease. Therefore, awareness campaigns are being conducted again and again with loudspeakers in residential areas. I would therefore like to request all of you to stay healthy so that you would not have listened in vain to these public awareness campaigns.

# Myanmar-Singapore Economic Ministers discuss economic matters via videoconference

Union Minister for Agriculture, Livestock and Irrigation Dr Aung Thu and Cambodian Minister of Agriculture, Forestry and Fisheries Mr Veng Sakhon co-chaired the meeting which could release a joint press statement for ensuring the unimpeded flow of safe and nutritious agricultural produce in the regon.

The Union Minister discussed the importance of laying down regional policies to avoid famine like the one experienced in 2017-2018 and awareness on possibility of famine resulted from the pandemic.

Participants also held talks on matters relating to the progress of cooperation between ASEAN and India on agriculture and forestry during 2016-2020 and medium-term procedures for agriculture and forestry which were adopted for 2021-2025.

The meeting decided reassignment of ASEAN-India Working Group on Agriculture and Forestry, holding the working group's meeting annually, and organizing the ministerial meeting every two years.

The Sixth Meeting of ASE-AN-India Ministers of Agriculture and Forestry approved a joint press statement, and agreed to hold its 7<sup>th</sup> edition meeting in 2022.—MNA

# 138 Myanmar citizens fly back home from Singapore by relief flight

A relief flight of Myanmar National Airway (MNA) organized by the Myanmar Embassy in Singapore landed at the Yangon International Airport bringing back a total of 138 Myanmar nationals, who were stranded in Singapore due to the suspension of international flights, yesterday evening.

The Ministry of Labour, Immigration and Population, the Ministry of Health and Sports and the Yangon Region government arranged 7-day quarantine at specific places or designated hotels, followed by the 7-day home quarantine.

To bring back the Myanmar citizens who are stranded in foreign countries by relief flights and chartered flights in accordance with the instructions from National-Level Central Committee on Coronavirus Disease 2019 (COVID-19), the Ministry of Foreign Affairs cooperated with the relevant ministries and Myanmar embassies from respective countries and there were 23 relief flights from Singapore to date.—MNA

The UNCTFMR in its press release on 14 October 2020 raised its concerns regarding the death of two children resulting from a clash between the Tatmadaw and AA terrorists in Buthidaung Township, Rakhine State on 5 October 2020.

In order to prevent its servicemen from violating the rights of children, the Tatmadaw issued a directive on 22 August 2020 ordering its servicemen to abide by the provisions of the Myanmar Child Rights Law; to take necessary and effective action against any violations of the provision; and to supervise in accordance with existing command structures to

prevent any violations.


Even prior to the press release by UNCTFMR with regard to what happened, the Tatmadaw carried out a preliminary investigation. The Tatmadaw is currently conducting a detailed investigation to ascertain the initial findings and the accuracy of what happened in an accountable manner. The findings of the investigation will be released further, said the Tatmadaw True News Information Team. — MNA

#### Statement on adherence to healthcare guidelines in 2020 General Election

- 1. The Union Election Commission, in accordance with 2008 Constitution, already announced that the multiparty democracy general elections will be held nationwide on 8 November 2020 to elect MPs for third term of three Hluttaws.
- 2. The election process includes setting up of polling stations, coming of voters to the stations and voting at the stations. Similarly, it also includes preparations for voting in the general elections of those who are under quarantine due to COVID-19 infections, advance voting of those who are unable to come to polling stations on the election day at relevant ward/village-tract election sub-commissions on designated dates, counting votes at respective township election sub-commissions and polling stations, collecting of election results and announcing the names of elected candidates by region/state election sub-commissions.
- 3. Due to present COVID-19 situation, polling station heads, deputy heads and members who will perform duties at the polling stations of different levels of relevant election sub-commissions, those who will manage outside the polling stations and voters need to be careful of the successful holding of the general election not to be infected by COVID-19.
- 4. The Ministry of Health and Sports issued the standard operation procedure Part-I about campaigning in accordance with COVID-19 preventive and control measures for Hluttaw candidates, who will compete in the general election, on 7-9-2020.
- 5. Therefore, it is hereby announced that those who are involved in the election works according to paragraph-2 will have to abide by the directives included in standard operation procedure Part-II that is to be carried out in accordance with COVID-19 prevention and control measures during the general election and health guidelines issued by relevant officials depending on situations.
- 6. The standard operation procedure Part-II which is to be carried out in accordance with COVID-19 prevention and control measures in holding the general election can be viewed at the website of the Union Election Commission, www.uec.gov.mm, and UEC Facebook.

# MoHS organizes coordination meeting over COVID-19 containment measures, prison healthcare

A coordination meeting over improving COVID-19 containment measures and prison healthcare was held via videoconferencing yesterday morning.

During the meeting, Union Minister for Health and Sports Dr Myint Htwe discussed healthcare services for inmates like other ordinary people in accordance with the medical ethics, health checks on inmates with Rapid Antigen Diagnostic Test Kits by cooperating with officials of Home Affairs as some of the lockups and prison cells reported positive cases, cooperation works between Prison Department to give the latest COVID-19 information for the inmates, prison visitors and prison staff, plans to prevent COVID-19 in a timely manner together with the heads of regions and states Prison Department, Public Health and Medical Services Department. The Union

Minister also stressed that the prison healthcare services were reviewed in June 2020 and it needs to accelerate the public health-related matters at the prison for the health of prisoners and the ministry will provide the needed hand speakers containing recorded sound about COVD-19 information to conduct educating programmes in the prisons. As the prisons have strict rules and regulations, it will be easy to set health rules for the prisoners and the prison staff should wear masks and face shields.

Then, Director-General for Prison Department U Myint Soe briefed preventive measures of COVID-19 at the prisons, suspension of prison visitations, purchasing of medical supplies, isolation of newly-arrived prisoners at the separate wards for 14 days and another 7 days at other prison lockups and health

checks on new prisoners and those to be released.

# MSWRR reviews mid-term ASEAN action plan on violence against women

THE Ministry of Social Welfare, Relief and Resettlement organized a national-level workshop on mid-term review of the ASEAN Regional Plan of Action on the Elimination of Violence against Women (ASEAN RPA on EVAW) on 22 October.

Union Minister Dr Win Myat Aye and Deputy Minister U Soe Aung participated in the meeting together with representatives from the Women and Children Rights Committee of parliament, UN agencies, INGOs, NGOs and civil society organizations.

At the meeting, Union Minister talked about the ASEAN RPA on EVAW which was approved in November 2015 during the ASEAN Summit and its implementation began in the following year.

The Phase I is Desk Review and the Phase II national level. Currently, the ministry is serving as Focal Point for ASEAN Ministerial Meeting on Women in addition to the ASEAN Committee on Women and the ASEAN Commission on Promotion and Protection of the Rights of Women and Children.

## Section 59 (g) in Hluttaw Election Law



IN accordance with section 59 (g) of the Hluttaw Election Law, no one is allowed to vote more than once in any election for a Hluttaw constituency in which he or she has the right to vote. Anyone who is found guilty of or abetting this act shall be punishable with imprisonment for a term not exceeding one year, or with fine not exceeding K100,000 (one hundred thousand Kyats), or with both.

## Yangon gold market to resume on 26 October

YANGON gold market, which has suspended its sale because of the outbreak of COVID-19, will resume its sale commencing from 26 October, according to Yangon Gold Entrepreneurs Association (YGEA).

The Yangon gold market has planned to operate in conformity with the Covid rules prescribed by the Health Department and under the supervision of YGEA. The association members must follow the rules and regulations.

Moreover, the association's office can accommodate only 30 persons. So, the association has requested the brokers, buyers, sellers and shopkeepers to understand the rules and work peacefully and safely in COV-ID-19 period.

Besides, the association has made necessary arrangements to enable the sale in the gold

market via zoom application.

Presently, the YGEA's members have been trading the

gold starting from the first week of October at the Yangon YGEA office located in Shwebontha Township, YGEA Chair U Myo Myint said.

Yangon gold market was

temporarily closed on 15 September on account of the outbreak of coronavirus. During the suspension period, the price of yellow metal stood at over K1.3 million per tical (0.578 ounces). Gold trading has started at the cost of over K1.3 million in the first week of October.

The pure domestic gold fetched K1,314,500 per tical on 23 October while the global gold price hit US\$1,906 per ounce.

During the suspension period, some gold shops in Yangon which are operating at home are still running in their way. They like to sell the gold rather than buying it, he added.

There are more than 10,000 gold shops in Yangon region and about 50 visses of gold could be sold daily before the pandemic.

During the first wave of COVID-19, Yangon gold market was closed between 29 March and 18 May.

## State/Region committees approve over 280 local investments in 3½ years after Myanmar Investment Law

REGION and State Committees have approved over 280 local investments in three and a half years since the enactment of Myanmar Investment Law, according to the Directorate of Investment and Company Administration (DICA).

Myanmar has attracted more than K618,389.881 million of investment from the approved local enterprises of 283.


After the Myanmar Investment Law came into force, the investment committees endorsed 37 local enterprises in 2017-2018 financial year with an estimated capital of K66,786.656 million, 62 projects worth K126,969.101 million in the 2018 mini-budget period (April to September), 114 businesses with K 232,735.482 million in the 2018-2019FY and 70 businesses with K191.898.642 million in the 2019-2020FY.


In three and a half years, the Yangon region stood the highest in terms of investment, followed by the Sagaing region and Ayeyawady region. Besides, Chin State, Nay Pyi Taw, Shan State, Rakhine State and Bago Region have attracted lower investments of the approved local investments, according to the statement of DICA.

According to the newly enacted Myanmar Investment Law, the Region and State Investment Committees have approved the investment proposals which are worth not more than US\$ 5million (K6 billion) without having to seek permission from MIC.

However, the facts and figures of the businesses permitted by the Region and State Committees will have to be reported to MIC to ensure more accurate and comprehensive statistics.

## Over 400 COVID patients discharged from Inya centre

MORE than 400 COVID patients, who complied with requirements of the Ministry of Health and Sports, were discharged from Inva centre, according to the Inya COVID-19 Treatment Centre.

Under the supervision of Yangon Region COVID-19 Pre-

vention and Control Coordinating Committee and the Ministry of Health and Sports, a total of 426 patients were discharged from Inya centre in the week between 16 and 22 October.

The centre was open on 10 October and accepted about 754 COVID-confirmed patients from the first day to 22 October.

Under the guidelines of the

Ministry of Health and Sports and Yangon Region government, the treatment centre was first constructed on 29 September with an initial fund of K1 billion -- K700 million by KBZ Bank and K300 million by Shwe Thanlwin Company.

The treatment centre will be equipped to conform to the status of a 500-bed hospital,

including 16 high-dependency units (HDUs).

Moreover, the centre has arranged breakfast, lunch and dinner of nutritional value and provided necessary medicines for the patients. The centre includes separate buildings for the doctors, nurses and volunteers and also a 24-hour food court.

## Ayeyawady river faces shortage of fish in peak season

ALTHOUGH this is the abundant fish season annually for the local fishermen, Ayeyawady River is with the shortage of fish in this period, according to a report from Magway region fishers.

Ten years ago, a fishing vessel caught around ten visses of fish daily with the use of the fishing nets. This year, the local fishermen are challenging to catch even five visses of fish per day, said the local fishermen.

"I do not have the vaguest idea of why there is a shortage of fish. Before pandemic, we could work on the land if we could not work in the water.

Now, we couldn't work either on the land or in the water," said Ma Ei Ei Tun, a fisher.

Some assume that the climate change is the leading cause of changing the natural environment in the river, distracting the fish habitats by growing the alluvial soil and using of agricultural pesti-

cides and herbicides and this is causing the shortage of the fish in the river year by year.

"There are many reasons for the shortage of fish. It is also concerned with the weather condition, illegal fishing and rising of the fishermen. We could not look for anyone

The fish may be scarce in this place but maybe abundant in another place," said U Myint Shwe, the head of the Fisheries Department in Magway region.

There has been illegal electro-fishing in the river for around three years. When we tell the illegal fishers, they pose a threat to the family who is involved. So, we stay quiet for this reason, said Ma Thin Nu Aung, a fisherwoman.

There are some 1,500 fishers in Magway region. Among them, most of the fishers are living onboard the fishing vessel because they don't have a place to live in, according to the local fishermen. - Zayyatu (Magway)

## Chinshwehaw COVID-19 committee hands over 36 returnees to Lashio

CHINSHWEHAW'S COVID-19 Containment Working Committee handed over a total of 36 Myanmar nationals who returned from China to Lashio yesterday.

## Spared by Covid-19, Seychelles suffers dearth of tourists

THE Seychelles, with its idyllic white beaches and luxury resorts, has had only 149 cases of Covid-19, but the global crisis caused by the pandemic has ravaged its vital tourism industry.

The Indian Ocean island nation, famed as a honeymoon destination, took swift action against the virus in March, banning cruise ships and international flights and implementing a lockdown.

But even though the archipelago re-opened to tourists on August 1, the global downswing in travel and devastation wrought by the virus in major tourist-providing countries in Europe and elsewhere, has led to little improvement.

"Since the re-opening of the airport we have tried to re-open our establishment, but it is a catastrophe, we are running at a loss because there is no one," said Sybil Cardon, who had to let go of 10 per cent of her staff at her hotel on Praslin, the second-largest island.

In Beau Vallon, the most touristy part of the main island Mahe, the Equinox scuba diving centre once did three or four excursions a day, taking tourists to see bountiful fish and marine life around the granite cliffs and coral reefs.

# Cheese, car parts and Kobe beef: Britain's trade deal with Japan

BRITAIN says the post-Brexit trade deal signed with Japan on Friday "secures major wins that would be impossible as part of the EU", though its

substance is largely similar to the current EU-Japan accord. Britain hopes the agreement will boost trade with Japan by around \$20 billion when it comes into force in January after being ratified by lawmakers in both countries.

Here are four things to know about the bilateral deal:

#### Low or no tariffs

When the deal was announced last month, Britain said it meant around 99 per cent of its exports to Japan would be tariff-free.

Under the current EU-Japan trade agreement, in place since February 2019, the vast majority of custom duties are also absent. The European Union says that under its deal, the bloc's meat exports to Japan increased by 12 per cent, while electrical machinery exports were boosted by 16.4 per cent.

"In terms of market access, we have maintained Japan's high level access to the UK market as under the Japan-EU deal," Japan's Foreign Minister Toshimitsu Motegi said on Friday. SOURCE: AFP

## Financial regulators probe Tokyo bourse over outage

FINANCIAL regulators conducted an onsite inspection of the Tokyo Stock Exchange on Friday following a system failure that caused a full-day trade suspension earlier this month, Finance Minister Taro Aso said.

The Financial Services Agency is expected to examine the bourse's governing structure and also interview officials operating its systems about the details of the shutdown on Oct. 1.

In the worst outage since the TSE's trading system was fully computerized in 1999, the problem was caused by an issue with the memory functionality of a server in its trading system and a failure of the auto-backup system that was blamed on a settings error, the bourse said.

"We need to assess why its backup sys-

tem failed," Aso told reporters.

The TSE disclosed Monday that one of the setting specifications was altered in 2015 when the "arrowhead" trading system was updated, but the bourse was unaware of the change as it was not reflected in the manual provided by the system's developer Fujitsu Ltd.

The TSE has said, however, it has no plans to seek compensation from Fujitsu, adding it expects the developer to implement improvement measures.

The bourse said it will conduct thorough checks of current system settings while running scenario drills with securities companies to test the process for switching to a backup system if a similarly serious technical problem reoccurs.

# The Town Minhla and Wooden Backdrop

carved as layers in wooden logs depicting Buddhological plots of sculptural works can be seen at the back rest of throne on which Buddha images are kept in Gandakuti Chambers of some eminent temples and stupas in Myanmar. Among these masterpieces, a significant backdrop takes a position in precinct of Maha Thatipahtan Monastery in Minhla of Bago Region.

## Background of the town Minhla

There are two Minhla townships across the nation—the town Minhla in Thayet District of Magway Region is called Upper Minhla and the town under the same title in Thayawady District in Bago Region, called Lower Minhla.

Local people accepted two ideas for emergence of the name Minhla in Thayawady District. They assumed the town was established by Thadoe Latt (nephew of Bagan King Narathihapatae, and the name was changed to Minhla from Minlatt. And, some assume that a very beautiful medium woman Ma Min Hla resided in the town as

location of now Minhla. Her reputation was famous for the name of Minhla town. Minhla Township is 19 miles long from the east to the west and 13 miles wide from the south to the north. Its total area is 258.31 square miles. The township takes a position at an altitude of 76 feet, sharing border with Kyaukdaga Township in the east, Monyo Township in the west, Letpadan Township in the south and Okpo Township in the north. Minhla has 91 miles access to Yangon by car and by train.

Minhla Township, home to 126,369 population based on the data released in September 2018 is formed with Minhla and Sitkwin towns, 12 wards and 246 villages of 54 village-tracts. Bamar people accounting for 91 per cent are residing in the township together with Kayin, Shan and Rakhine ethnics. The majority of the people believe in Buddhism.

A total of 52 temples and stupas, 18 Christianity buildings, three Islamic mosques, one Hindu temple and two Chinese temples take positions in the township. The brick building built in 1915 with colonial era works and backdrop is located in the precinct of Maha Thatipahtan Monastery in Minhla.

#### **Myanmar backdrop**

The backdrop is a back rest decorated with carved wooden or masonry works of Myanmar traditional arts and crafts. Generally, backdrops are kept behind the sitting and standing Buddha images.

Some people call throne and backdrop as throne-backdrop decorated with 12 kinds of crafts –sculptural statues of lion, flying elephant, peacemaker celestial being, peacock feather fan, elephant ear, door post, celestial king, mythical bird with human head, virtuous deva, stylized figure resembling a lion, lotus and floral motif on either side of Indra. The throne must be based on lion statues.

Throne-backdrops were created with plots of Jataka on three layers, five layers and eight layers of wood flanked by floral works in detail. Currently, most of the wooden backdrops were decayed in climatic condition in Bagan, Inwa and Nyaungyan era but wooden backdrops in Konbaung era can be seen till today.

Finials of Myanmar architecture are decorated and carved

works and reliefs on woods, stone, concrete, gold, silver, iron and minerals. Likewise, ornamental motif in stucco of ogre, mythical king of bird, mythical bird with human head, celestial king, peacock, elephant and lion statues were decorated with floral arabesque. Among these finials, people are interested in crafts of wooden backdrop.

Moreover, concrete backdrops can be seen at arches and entrances to pagodas. Mostly, arch-backdrops were made of wood at ancient monasteries with statues of celestial king, celestial beings, parakeet and peacock.

Wooden backdrops decorated with reliefs and sculptural works in floral works were different in locations and eras. Especially, the backdrops in Konbaung were created with the best retail artistic works.

#### **Eminent backrops**

People can observe just photos of backdrops which were ablaze at Thihoshin Pagoda in Pakokku. Such pagoda had two backdrops. The east backdrop was shaped with three standing Buddha image at the archway and the west backdrop behind the east one. Such two backdrops were burnt together with Gandakuti chamber and prayer halls of

the pagoda in April 1964. So, new backdrop was made with modern art works.

Carving of the original east backdrop was started by sculptor U Kan Gyi and son U Te on full moon day of Waso in 1275 Myanmar Era. Donors U San and Daw Kyue from Mesalipingon Village of Pakokku Township contributed K1,000 to the sculptors. The two sculptors linked three Yamane logs and carved the log into a festoon by taking a year. They shaped episodes from preaching of Dhammacakka preached by the Lord Buddha to the Parinibbana including king, queen, celestial being, celestial king and other reliefs totalling some 1,000.

Those two sculptors carved the western backdrop of the pagoda within three years with donations of Daw Ein Min on Potan Street in Pantaw Ward of Pakokku. It cost K3,000. The carving completed on full moon day of Tabaung in 1271 ME. A log of Yamane wood was used for the backdrop in eight layers of floral works depicting episode of the Lord Buddha in leaving the royal palace and 25 episodes from Vidhura Jataka.

Shweku backdrop which is the most famous among other backdrops in the nation is being

displayed in the glass box in the east of Gandakuti Chamber of Shweku Pagoda in Pakokku. The backdrop made of Yamane wood behind the five feet and two inches high standing Buddha image is five feet and 10 inches long, 12 feet and 10 inches high and eight inches thick. The backdrop was decorated with 136 sculptural works and 18 animal statues in addition to 12 episodes from Devarohana, Nemi, Sadhina and Bimbisara Jatakas in eight layers.

Shweku backdrop was made by U Kan Gyi and son. They started work with charge of 4,000 coins on 3rd waning of Tabaung in 1269 ME. They used five wood logs to shape the eight inches thick backdrop with eight layers of floral works, according to the backdrop inscription. Well-wishers were U Hin Nga and wife Daw Zee Zi and daughters Mei Thit and Mei Myit from building 575 on Zayhaung Kyaungdawya Street in Pakokku. Left floral arabesque was impressed with Saya U Kan Gyi and son Maung Te and the right one with meritorious deeds of Ma See San, Ko Hin Nga and Ma Mei Thin.

A Tharekkhan Buddha image was kept on a throne based on 14 elephant statues in Gandakuti chamber of Shwetanttit Pagoda, three miles east of Pakokku. Its backdrop was 13 feet and three inches high and 10 feet wide.

The backdrop at Shwetanttit Pagoda was created with floral arabesque and stocks of lotus. It was donated by U Toe, Daw Oh, son U Pe, Daw Bwint, grandson Ko Ngwe Zone and Ma Mya from Shwetanttit Village. Such backdrop was carved by U Chan

Tha from Shwetanttit Village and Saya Aye from Pakokku within three years, two months and 10 days from 1895 to 1898. Carving charge cost 1,500 coins.

The backdrop was made of 13 logs of teak and Yamane depicting 13 episodes of Vidhura Jataka on floral layers.

The backdrop behind Maha Lawka Muni bronze Buddha image, nine elbows and two mikes in height, was very magnificent in Phayagyi Monastery of Yaiksu Ward in Kanaung of Myanaung Township in Ayeyawady Region. The backdrop made of Yamane log with 18 feet and eight inches high, 15 feet and three inches wide and six inches thick depicts plots of Buddhology on four layers. Kanaung backdrop was craved by U Kan Gyi and son U Te within three years. It cost 3,000 coins. Eastern part of the backdrop was shaped with Buddha-to-be who opened the royal mosquito, the western part some plots of Vidhura Jataka and the top plots of Maha Janaka Jataka.

The backdrop was carved at five layers on five teak logs decorated with floral arabesques, human, celestial beings and animal statues. The sculptors took three years for carving the backdrop. It cost K9,600, in comparison with value of three visses of gold at that time.

Pyilone Chantha Buddha image kept in precinct of Dekkhinayama Pariyatti Monastery in downtown Kyaunggon of Ayeyawady Region is 25 feet in height and 23 feet in diameter. Its backdrop is six inches thick on the left side of the Buddha image and seven inches on the

right side. The backdrop, 25 feet and seven inches high and 15 feet and 10 inches wide, is the highest and largest in wooden backdrops across the nation. Bhaddanta Kesara ordered sculptor U Kan Gyi and his son U Te to carve the backdrop.

Shweku backdrop is 12 feet and 10 inches high, Shwetanttit backdrop, 13 feet and three inches high and Pyilone Chantha backdrop 25 feet and seven inches high. Shweku backdrop is five feet and 10 inches wide, Shwetanttit backdrop 10 feet wide and Pyilone Chantha backdrop 15 feet and 10 inches wide. Pyilone Chantha backdrop depicted the people asking Shin Maha Moggalana for return of the Lord Buddha from Tavatimsa abode after preaching Abhidhamma Desana in 15 plots created on the top of backdrop. Minhla backdrop and building in colonial era

The backdrop of Buddha image kept in Ananta Miba Myitta Mingala ordination hall in the precinct of Satubonmika Maha Thatipahtan Monastery in Minhla of Bago Region is 10 feet high, three feet and five inches wide and seven inches thick. It was made of Yamane wood with seven layers of floral crafts on which 60 statues were carved. The backdrop bears seven plots of Buddhology and plots from Ramayana Jataka.

The backdrop donor was U Pun Nan and Daw Ngwe Thet who were also donors of Maha Thatipahtan Monastery. Sculptor Maung Bo Min from Pakokku carved the backdrop within three years starting from 1301 ME. The donor awarded 100 coins and

three sets of suits to the sculptor, according to the backdrop record.

A brick building in colonial era between Myole Monastery and Maha Thatipahtan Monastery in northwest of Minhla was famous thanks to social media pages. Maha Gandakuti brick chamber was built in 1277 ME with 30,000 peacock coins contribution of farmland owner Daw Hsar Pwint from Minhla. Before construction of the chamber, Daw Hsar Pwint built two pagodas near the current site of the chamber in 1250 ME.

It can be assumed that the brick building facing the eastward might be two-storey building in the past but it was shifted into one-storey building. Four dimensions of the chamber were installed with brick ladder each but the western, southern and northern entries were closed by concrete works. Now, travellers can enter the building through the eastern stairway. A large Buddha image facing the eastern ward is kept in the building.

Daw Hsar Pwint built Myole Monastery in 1288 ME. Then, her daughter Daw Ngwe Thet built Maha Thatipahtan Monastery and fenced Maha Gandakuti Chamber, two pagodas and Maha Thatipahtan Monastery. So, two monasteries are separated by a street.

As Minhla could preserve two buildings in colonial era and the backdrop well, people from four corners of the nation can observe them till today. Likewise, Myanmar's arts and crafts at wooden backdrops were maintained in various regions of the country so that new generations can observe Myanmar cultural heritages.

## AFC Futsal Asian Cup moved to 2021

THE Asian Football Confederation (AFC) recently announced a postponement of the AFC Futsal Asian Cup, which is scheduled to hold in Kuwait this year and it has been moved to 2021, according to the statement with the AFC.

The new dates for the tourney and further information will be announced later, AFC officials said.

The 16<sup>th</sup> edition Futsal Asian Cup, originally scheduled to play between 26 February and 8 March 2020, had been moved to 5–16 August 2020.

But recently, tourney's organizers further postponed the tourney next year for pandemic safety.

Like the previous year's version, the tournament will act as the AFC qualifiers for the World Cup. The top five teams will qualify to the 2021 FIFA Futsal World Cup.

Iran Team is currently the defending champions of the tourney.

Similarly, the AFC reached the decision to withdraw AFC U23 Asian Cup 2022 due to the challenges of the pandemic.

The AFC will now reopen the invitation to host the final Competitions of the 2022 and 2024 editions of the AFC U23 Asian Cup, according to the football authorities. —Lynn Thit (Tgi) ■

#### Juve play catch-up on AC Milan before Barca showdown

MILAN—Juventus warm-up for their Champions League clash against Barcelona with a Serie A home tie against Hellas Verona on Sunday, trying to close the gap on leaders AC Milan. Zlatan Ibrahimovic's AC Milan, who next host Roma, are flying high, the only team with maximum points after four games. Andrea Pirlo's Juventus are coming off back-to-back league draws against promoted Crotone 1-1 last time out and 2-2 at Roma, with two red cards in as many games.

The nine-time reigning champions are fifth in the table, four points behind Stefano Pioli's Milan.

Portuguese star Cristiano Ronaldo remains a doubt having returned another positive test for coronvirus this week, after missing their 2-0 Champions League win at Dynamo Kiev.

The 35-year-old could still be available against Verona, and great rival Lionel Messi's Barcelona on October 28, if he tests negative 24 hours before either game.—AFP ■

## Football: Clasico still the biggest game in the world, says La Liga president Tebas

MADRID—"The Clasico is still the Clasico," says La Liga president Javier Tebas.


"For the league it's another match but for intrigue and international appeal, it's the two biggest clubs in the world going face to face. It's still the most important club game in the world."

On Saturday (Oct 24), Bar-

celona and Real Madrid go face to face in the biggest football stadium in the world too, but almost all of the 99,000 seats at Camp Nou will be empty.

In sporting terms, it would be hard to find a more dramatic event reduced so dramatically, as clear a demonstration as there could be of the effects of the coronavirus pandemic. "Any football match without fans loses a fundamental part of the game," Tebas says, in an exclusive interview with AFP.

"But we've had more than 300 games played without fans and we've seen the players still provide a spectacle on the pitch. In fact the television numbers prove it. People are still watching."—AFP ■

# Premier league race wide open after early-season stumbles

LONDON—Five games into a Premier League season full of goals and drama, each of the traditional 'big six' have dropped at least five points, and the title race is wide open.

Unbeaten Everton and Aston Villa are the surprise pace-setters and with a gruelling schedule of European games under way, the odds of a shock title winner have tumbled. AFP Sport looks at the runners and riders. Three weeks ago the title looked like Liverpool's to lose after an impressive start to their title defence.

However, a 7-2 thrashing at Villa knocked the champions off course and the loss of Virgil van Dijk, likely for the rest of the season, is a devastating blow.

Liverpool, who lack options in central defence, still have the firepower to mount a title challenge but they have already dropped the same number of points as they did in their first 28 league games last season as they cruised to a first leavgue title in 30 years.

City and Liverpool have been dominant over the past three seasons but there are big questions over Pep Guardiola's defence despite a £100 million (\$131 million) outlay on defenders in the transfer window.

Leicester won 5-2 at the Etihad last month, while goalkeeper Ederson made a string of important saves to salvage a 1-1 draw at Leeds and ensure a 1-0 victory over Arsenal.—AFP
