## Domestic flights resume operation under healthcare guidelines

LOCAL airlines resumed their domestic flights yesterday in line with the healthcare guidelines after the suspension of their operations to control the spread of COVID-19 in the country.

The Myanmar National Airlines flew its flights from Yangon to Loikaw-Heho-Kengtung route and the Air KBZ from Yangon to Myeik, Sittway and Tachilek townships.

Ko Min Kyaw Than, a passenger who will go to Sittway, said, "I have undergone medical test in the last 36 hours. I had to prepare for the medical test. Resumption of domestic flights will be very convenient for the stranded passengers."

Captain Thein Zaw, Chief Operating Officer from Air KBZ, said, "Our flights are being operated to

the cities with higher passenger numbers. Although tickets can be purchased freely, the passengers need to show the COVID-free health document before taking the flight. If the passenger tested positive after purchasing the air ticket, our airlines would refund the ticket."

The Golden Myanmar Airlines will restart its flights to Sittway, Heho and Tachilek, while Air Thanlwin airlines and Mann Yadarnapon Airlines will announce the dates to resume their services.

The Ministry of Health and Sports set the healthcare guidelines for air travellers to support the recovery of the national economy through civil aviation sector.

Passengers also need to undergo medical test at the des-

## Union Minister Dr Myint Htwe receives COVID-19 donation from UNHCR



During his meeting with the UNHCR Resident Representative in Myanmar Ms Hai Kyung Jun, the Union Minister discussed matters related to an MoU with UNHCR to provide humanitarian assistance, implementation of resettlement and rehabilitation processes for IDPs, and cooperation between Myanmar and the UNHCR, plans for the closure of temporary IDP camps in accordance with the national-level strategy, disaster management activities, the ministry's plan to cooperate with UNHCR on future humanitarian and development works and other relevant issues.

During his virtual meeting with the US Chargé d'Affaires' Ms Gwendolyn J Cardno, the Union Minister discussed the implementation of the National Strategy on Resettlement of **Internally Displaced Persons** and Closure of IDP Camps, the ministry's assistance including financial aid for IDPs and vulnerable groups during the COV-ID-19 crisis, the continuation of humanitarian work in the Rakhine State in accordance with COVID-19 related guidelines, implementation of Child Rights Law, which was approved in 2019 and other vital issues.

Myanmar ratified the Optional Protocol to the Convention

on the Rights of the Child (CRC) on the involvement of Children in Armed Conflict on 27 September 2019, according to the Union Minister, who said that the President Office had formed a national-level committee to implement the protocol.

The Union Minister also discussed matters related to human trafficking, Myanmar's cooperation with neighbouring countries in social welfare and relief activities. He said that the US could cooperate in expanding the Emergency Management Centres (EOCs), which is significant for disaster prevention.

## Resettlement of IDPs in Kachin State discussed via videoconferencing

THE 4<sup>th</sup> meeting between the Working Committee on implementation of resettlement of Internally Displaced Persons (IDPs) in Kachin State and the Kachin Humanitarian Concern Committee (KHCC) was held via videoconferencing yesterday afternoon.

During the meeting, Union Minister for Social Welfare, Relief and Resettlement Dr Win Myat Aye said that prioritizing the resettlement of IDPs and the closure of IDP camps are aimed at working on ethnic issues and nationwide peace. He added that the move is aimed at lasting peace and building a democratic federal union.

The government will increase cooperation with national ethnic people, according to the Union Minister, who said that a democratic federal union could be achieved by making efforts for democracy, human rights and the rule of law.

The Union Minister stressed that the government, MPs and civil society organizations need to strengthen cooperation.

## Domestic gold price rises to over K1,320,000 per tical

THE domestic gold price has risen to over K1,320,000 per tical (0.578 ounces, or 0.016 kilogrammes) and it is likely to increase continuously, said U Myo Myint, the chairman of Yangon Gold Entrepreneurs Association (YGEA).

With the rising of global gold prices, the dollar exchange rate and less entering of raw materials from the regions, the domestic gold prices are rising. If it is increasing continuously like now, the domestic gold price will be likely to grow continually, he added.

"With the increase of the global gold price, the US dollar exchange rate is slightly rising. Also, there are less entering of the raw materials because of long closing days. Sometimes, we don't have raw materials, and we are generating with the old items. However, the gold price is hard and has risen to K1,321,000 per tical," said U Myo Myint.

Now, the global gold price hit US\$1,857 per ounce on 16 December. Additionally, the local forex market sees a slight gain of US dollar against Kyat. That is another cause of gold price hike. The dollar against the Kyat exchange rate is around K1,400 per dollar.

After the first wave of COV-ID, the pure domestic gold price hiked to K1,331,500 per tical, which is higher recorded in four months. However, the domestic gold market sees more sellers than buyers. Previously, about 50 visses of gold were traded daily in the domestic market, but now, only five visses of gold are being traded.

According to the gold traders, during the past four months, the domestic gold was priced with a minimum rate of K1,216,500 (1 July) and the maximum rate of K1,296,500 (27 July). The price moved in the range of K1,286,500 on 13 August and K1,332,500 on 7 August. The local gold price reached the lowest level of K1,310,500 (2 September) and the highest level of K1,314,000 (1 September). In October, the rate ranged between K1,307,800 (30 October) and K1,316,500 (21 October). In November, the domestic gold was priced with a minimum rate of K1,270,000 (30 November) and the maximum rate of K1,317,000 (9 November)

With global gold prices on the uptick, the domestic price hit fresh highs last year, reaching K1,000,000 per tical between 17 January and 21 February, crossing K1,100,000 (22 June to 5 August), climbing to over K1,200,000 (7 August-4 September), and then reaching an all-time record high of K1,300,000 on 5 September in 2019.

## Exporters body to construct cattle yard near Mandalay Region

A yard will be constructed near Mandalay Region for the cattle designated for export to China will be mustered into there, according to the Mandalay Region Cattle Exporters Association (MRCEA).

"At present, live cattle export to China through the Muse land border is facing hardships due to housing difficulties and high feedstuff cost," said Chairperson U Soe Naing of the exporters association.

"We are discussing this matter with key participants. Muse border is too small to handle thousands of cattle. If the number of cattle exceeds 5,000, housing difficulties occur; therefore, we need cattle yard. PyinOoLwin has abundant pasture land. It is easy to buy hay and corn there as well," he added. Mandalay Region Cattle Exporters Association will submit a report to the authority concerned to build cattle vard.

Additionally, the association is planning to raise the cattle to gain weight in a bid to receive a reasonable price in Muse border, he said.

"The cattle are departing from distant places such as Magway and Sagaing and leaving for Muse border. For instance, if a cow is weighed 100 visses (a viss equals to

3.6 pounds), the cattle lose weight to 80-85 visses. The weight loss happens during commercial long-haul transport. Nevertheless. China manages to feed the cow to maximize the value before reselling them. Therefore, we are trying to adopt the new feeding system for fattening cattle," he elaborated.

About 15,000 heads of cattle, owned by 150 companies, are now stranded in Muse border as China stopped purchasing cattle.

The labour wages and feedstuff cost burden them. It costs K400,000-600,000 to take care of 100 heads of cattle every day.

China permits live cattle import only after ensuring the cattle is free from 20 diseases, including Foot and Mouth Disease, along with vaccination certificates, health certificates, and farming registration certificates. Thus, the officials concerned from the two countries are negotiating this.

Earlier, 1,500-2,000 heads of cattle were

daily traded through Muse border. With China stepping up border control as precautionary measures for the COVID-19 and other reasons, it was three months that China halted cattle trade, MRCEA Chair U Soe Naing affirmed.

In the meantime, we are concerned about possible market manipulation when the supply is surpassing the demand. Additionally, Myanmar's live cattle export is heavily relying on the China market due to a fair price. However, Myanmar has other external markets such as Laos, Thailand, Malaysia and Bangladesh, he added.

The Ministry of Commerce grants a permit to each company for 100 cattle export, and the pass is valid for three months. The companies can be taken legal actions if they do not sell the cattle during the three months.

Live cattle export was allowed in late 2017, to eradicate illegal exports, creating more opportunities for breeders and promoting their interests.

Myanmar has around 500,000 heads of cattle for export beyond domestic consumption, the association stated.

## Myanmar regains foreign markets as export rice prices rise in November

MYANMAR regained rice market shares from certain countries on account of high quality and the price also increased in November, said U Ye Min Aung, Chairman of Myanmar Rice Federation.

The export price of Myanmar's rice is relatively lower than the rates of Thailand and Viet Nam. Yet, the prices are higher than those market prices of India and Pakistan, MRF's data showed.

In November, the export prices of Myanmar white rice (low quality), broken rice and parboiled rice rose compared to October's rate. The prices moved in the range of US\$400-490 per metric ton.

Following the coronavirus resurgence in Myanmar, rice was highly demanded in the domestic market. The domestic retail market in November saw a rise of K5002,000 per 108-pound bag compared to October's prices, said traders from Bayintnaung market. The prices of rice last month for Pawsan varieties moved in the ranges of K38,000-57,000 per 108-pound-bag in the domestic market, while low-quality rice fetched K22,000-28,000, MRF data showed.

The local people prefer old rice to the newly harvested crop. When the fresh rice enters the market, the price of old rice is remained strong, said a trader from Wahdan commodity depot. Myanmar exported 350,260 tonnes of rice and broken rice to foreign trade partners between 1 October and 27 November in the current financial year 2020-2021, generating an income of over US\$300 million, as per MRF's data.

MRF expected to ship 2.4 million tonnes of rice, and broken rice in the last FY ended 30 September 2020. The country surpassed the export target, sending over 426,611 tonnes to neighbouring countries through border trade and over 2.15 million tonnes of rice and broken to foreign trade partners via maritime trade, totalling over 2.58 million tonnes.


Last year, Myanmar shipped rice to 66 foreign markets. China is the leading buyer of Myanmar rice, followed by the Philippines and Malaysia. Madagascar is the fourth-largest buyer and Poland, the fifth-largest buyer of Myanmar rice.


Meanwhile, Myanmar exported broken rice mostly to Belgium, followed by China, Senegal, Indonesia and the Netherlands. Broken rice was placed in 60 foreign markets. ASEAN countries constitute 18 per cent of Myanmar's total rice exports with

over 466,882 tonnes. In comparison, 30 per cent of total rice exports in Myanmar goes to China with over 775,884 tonnes, followed by African countries with 27 per cent after exports of around 706,302 tonnes. The European Union countries account for over 20 per cent of rice exports with over 514,523 tonnes while other countries represent five per cent of exports with over 122,786 tonnes.

Next, Myanmar yearly produces 13 million tonnes of rice. There is self-sufficiency in the domestic market, and rice reserves have been stored in Yangon, Nay Pyi Taw and Mandalay. Myanmar shipped 3.6 million tonnes of rice in the FY2017-2018, which was an all-time record in rice exports. The export volume plunged to 2.3 million tonnes, in the FY2018-2019. —Ko Khant

## Act fast in implementing COVID-19 response plans to support economic recovery

YANMAR'S economy continues to suffer from the COVID-19 pandemic, with growth estimated to have slowed sharply to 1.7 percent in FY19/20, down from ■ 6.8 per cent the previous year, according to the World Bank's Myanmar Economic Monitor, released yesterday.

The pandemic and associated containment measures have weakened consumption and investment, and disrupted businesses operations and the supply of labor and inputs.

As part of measures that slow the spread of the virus, and mitigate increases in poverty, the Union Government set up COVID-19 funds of K200 billion, and approved over K101 billion to 3,394 enterprises as first disbursement and over K64 billion to

For the longer term, public investments in infrastructure and digital technologies can increase domestic demand and employment, while boosting the productive capacity of the

To achieve this, we must carry out an assessment on the effective impact of the loan disbursed, government's support to improve the country's economy in line with "Enchanting Myanmar Health and Safety Protocol" and issues presented by the ministries and other organizations to Working Committee.

The World Bank's report stated that as a result of COV-ID-19, the poverty rate could increase from 22.4 per cent in

FY2018/19 to 27 per cent in FY20/21 and return to pre-crisis level in FY21/22 at the earliest.

Due to the ongoing impacts of the pandemic, economic growth is projected to remain subdued at 2 per cent in FY20/21, said the report of the World Bank.

But provided mobility restrictions are gradually relaxed and cases of local transmission of the virus slow, the economy is projected to slowly recover from March 2021 onwards. The medium-term outlook is positive – supported by public investment, a resurgence in manufacturing, and productivity gains associated with the adoption of digital technology – with growth estimated to recover to 7 per cent on average.

However, risks remain high given continued uncertainty about the future evolution of the pandemic, both locally and globally. Availability of vaccines for everyone will take time. For more months to come, we must continue to implement the basic public health measures such as washing our hands, wearing face masks and maintaining physical distance and avoiding crowds. New waves of the pandemic can happen before we all are vaccinated and it can result in more severe restrictions and can delay our economic recovery. Now is the time to scale up our COVID-19 response plans to support the recovery of our economy as soon as possible.

## Teacher/Instructor Training in the Context of **Education Reform**

ECENTLY, the Global New Light of Myanmar Learried a news item to the effect that the Ministry of Education in Nay Pyi Taw held a coordination meeting via videoconferencing on the draft of the National Education Strategic Plan (NESP) (2021-2030). This comes as no surprise because the National Education Strategic Plan (NESP) (2016-2021) is in its last stage. Due to the incidence of the Covid-19 pandemic, the last stage has probably been transposed to the (2021-2030) Plan. Perhaps the public could be informed in due course about the achievements of the (2016-2021) Plan. However, it is presumed that the drawing up of the (2021-2030) NESP will build upon what has been achieved in the previous plan and what is targeted for the (2021-2030) NESP.

#### "Mother Law"

The NESP (2021-2030) will presumably abide by the National Education Law of 2014, and it's the amendment of 2015. The National Education Law is the "Mother Law" of all other Education Laws, subsequently to be enacted. It also takes into account quality assurance of education. Following up on the National Education Law the Basic Education Law was enacted in 2019. Perhaps new laws on TVET and Private Education are in the pipeline.

All "Education Strategies" based on whatever law, have one aspect in common, which is the "Training of Teachers/Instructors". The National Education Law has a chapter devoted to this aspect of education/training. Teachers have the important duty of not only helping to transfer the "learning" content but also to inculcate civic sense and self-study capability for lifelong learning of their students/trainees. As I have been an "Instructor Trainer" for many years I would like to make some suggestions about Teacher/ Instructor training based on my

The Basic Education Law enacted in 2019, in its aims and objectives, states that "the educational environment should be of international standard and

use modern teaching-learning technology to ensure high-quality learning". At the same time, in the basic principles part, it is stated "that the use of modern technology should include the "student-centred approach" to teaching and learning. Such an approach is conducive to "active

#### **Using modern technology**

It is true that training the teachers on using modern technology and new methods of teaching would address the issue of the current deficiencies in the Teaching-Learning process. However, it requires the support of all stakeholders, including the teachers, the students and parents to work together for the Education Reform to meet with success.

The "Teaching-Learning" process needs to be steered away from the current" one way talking by the teacher and rote memorizing of learning content by the student" to a more "student-centred approach" as is stated in the Basic Education Law. Of course, "Rote Learning" is the means of learning vocabulary, mathematical tables, poetry recitation etc., particularly in the pre-primary and primary classes. It has its place in what is often known as "foundational learning". However it's not conducive to the understanding of complex ideas, problem-solving and creative thinking as in "active learning". The aim of teaching is to create a "learning environment" which will engage

the students more in the learning process and thus enhance their assimilation of the learning con-

However, most teachers at every level are used to the "Chalk and Talk" mode of teaching and note giving. It may also involve the teacher drawing diagrams and charts on the black/whiteboard thus reducing the time of "facing the class" while teaching. This in effect negates "eye contact with the students" as well as proper body language like gesturing or pointing out to any trainee in asking questions to get their feedback and so on. The "Chalk and Talk" method is also prone to leaving "visualization" of abstract ideas to the individual student's imagination, among other drawbacks.

#### A two-way modality

With the advances in technology, "teaching" has progressed, depending upon the stage of development, to the point where the teacher, using modern technolknowledge, skills and attitude/ behaviour to the students. At the same time, it involves using a two-way modality in which there is the interaction between the teacher and the students. Teacher training has to take this into account and teach the teachers how to teach using modern education technology and a more interactive approach which is conducive to "active learning" on the part of

the intent of the Education Law, hopefully in the teaching-learning process, all teachers will be able to use modern Education Technology. It will help students to "understand" better what is being taught. It will at the same time reduce the time taken by the teacher in drawing diagrams or writing detail notes on the blackboard/ whiteboard and hence increase the "productivity" of

It is my experience that the Teacher/Trainers who are hired for imparting the practical skills based on their academic qualification alone are often not very competent in actually demonstrating how to perform the jobs/tasks to their trainees. Hiring "Trainers" who have been practising the occupational skills to earn their living for some years and have the ability to actually show their trainees how to perform the job/task to the required standards of performance, is a prime necessity. Here we come up against a

new TVET Instructors will arise.

constraint in that many are not so keen to work as instructors on the salary generally offered to "practical training instructors". Hence to really get practical instructors who are skilled, there may need to be relaxations made regarding their academic qualification as well offering them incentives to the extent possible. Not getting the right practical instructor has been the obstacle in assuring quality training in the TVET sector. This is an issue we have to resolve for the success of our TVET sector. Perhaps practical instructors from among those who have the required years of experience of the occupation in Industry or in self-employment and possess at least a Level 3 competency certificate in the occupation concerned from the National Skills Standards Authority could be considered for hiring as a practical instructor. Such instructors could be trained in Teaching Methods through an Instructor Training Course.

In fact, on my part, I feel the need for establishing TVET Instructor Training Centres. In my recollection once there was an "Instructor Training Facility" in the Insein Government Technical Institute in Yangon. Now however that is "water under the bridge". Hence my suggestion is to re-establish such facilities in the GTI s in Yangon, Mandalay and some of the other Regions.

## Anti-Corruption Commission receives over 5,000 complaint letters as of November 2020

Commission received more those of last year. than 5,000 complaint letters in eleven months of 2020, which is the lowest number of letters in three years, according to a press release of the commission.

According to its recent statements, the anti-corruption commission received 10,543 complaint letters in 2018 and 9,394 letters in 2019 across the country. Among the complaints received in 2019, about 1,044 are under investigation. Now, the commission received only a total of 5,372 letters, which has dropped nearly

In eleven months of 2020, the commission received the complaint letters mostly from Yangon Region. The number of complaints was: 1,315 complaint letters in Yangon Region, 1,127 letters in Mandalay Region and 698 letters in Bago Region. However, the commission received only 14 letters from Kayah State, according to the press released by the commission. The complaint letters are about the departments' action, management and administration error, land management, judiciary cases, personal misconduct within the department, withdrawal of the complaint and other general things. The commission is handling a total of 6,416 letters including 5,372 letters in eleven months of 2020 and 1,044 letters from 2019. Of those letters, 6,063 letters have been handled. Among them, there were 69 for investigation, with 1,091 handed over to respective Ministries and region and state governments, 2,160 for which suggestions were sent to the public, 2,743 not being relevant to the law and 353

being still under review, according to the announcement of the commission. Out of the 1,091 letters which were handed over to respective region and state governments, most of them were delivered to the Ministry of Home Affairs with 120 letters and the Ministry of Agriculture, Livestock and Irrigation with 60 letters. Myanmar's Anti-Corruption Law took effect in September 2013, and the Anti-Corruption Commission was formed in 2014 and was reformed in November 2017.—Aye Chan Moe

## Rebuilt Prussian palace, scarred by history, opens in Berlin

A reconstructed Prussian palace will open in Berlin on Wednesday as a museum complex housing colonial artefacts, just as debate is gathering pace around the return of treasures plundered from abroad.

A reconstructed Prussian palace will open in Berlin on Wednesday as a museum complex housing colonial artifacts, just as debate is gathering pace around the return of treasures plundered from abroad.

The opening ceremony for the Humboldt Forum, which will house attractions including the Ethnological Museum of Berlin, will take place virtually due to restrictions to curb the spread of the coronavirus pandemic.

Launched in 2013, the huge renovation project in central Berlin has been plagued by delays, controversy and spiralling costs -- much like the capital's ill-fated new international airport that opened in October.

The bitter irony of the building being home to a museum housing nearly 20,000 artifacts from Africa, Asia and Oceania, mostly from the former colonies, has not been lost on critics.

Until the fall of the German Empire at the end of World War I, the palace was the main residence of the Hohenzollerns, instigators of German colonialism.

The construction has also cost some 677 million euros (\$823 million) -- almost 100 million more than originally

Culture Minister Monika Gruetters and Berlin Mayor Michael Mueller are due to hold a press conference at midday.

#### **Victim of history**

The original palace was a victim of Berlin's history, including World War II and the division between East and West.

## Flipping the script: China school reforms spark Mongolian writing revival

## EU chief says 'next days decisive' in Brexit talks

BRITISH and European negotiators have made progress towards agreeing fair trade rules but are still far apart on access to fishing, EU chief Ursula von der Leyen said Wednesday.

"The next days are going to be decisive," the president of the European Commission told the European Parliament, as intense talks on a post-Brexit trade deal continued nearby in Brussels.

"The good news is that we have found a way forward on most issues," she said, adding that she and EU negotiator Michel Barnier can now see a "narrow path to an agreement".

"But this is now a case of us being so close, and yet being so far away from each other, because two issues still remain outstanding, you know them: a level playing field and the fisheries." Von der Leyen said that Barnier and his UK counterpart David Frost had made progress towards resolving rules for state aid to businesses and that the ways the deal will be governed "by now are largely being resolved".

But she was pessimistic on fish. Britain is insisting that when it leaves the EU single market at the end of the year it will resume full control over access to its waters. EU member states are holding out to preserve quotas for their crews fishing in UK waters and they want a long-term arrangement to provide stability.

Britain has so far only offered reduced access and annual quota renegotiations.

"On fisheries, the discussion is still very difficult," von der Leyen said.

"We do not question the UK sovereignty on its own waters, but we asked for predictability

## Trump aide Kushner heads to Israel, Morocco after deal on ties

JARED Kushner, US President Donald Trump's son-in-law and advisor, will visit Israel and Morocco next week to discuss the normalization of ties between the two countries, a US official told AFP Tuesday.

The American delegation, headed by Kushner, will take the first direct commercial flight from Tel Aviv to Rabat, the source said.

Kushner is expected Monday in Israel. Morocco last week announced a "resumption of relations" with Israel, in an announcement making it the fourth Arab country this year to unveil plans to normalize ties with Tel Aviv through a US-brokered deal, following the United Arab Emirates, Bahrain and Sudan.

The announcement came after Trump tweeted that Rabat and the Jewish state had agreed to "full diplomatic relations".

That followed Trump's recognition of Morocco's contested sovereignty in Western Sahara, infuriating the Algerian-backed Polisario Front, which controls about one-fifth of the vast, arid region.

Western Sahara is a disputed and divided former Spanish colony, mostly under Morocco's control, where tensions with the pro-independence Polisario have simmered since the 1970s.

The movement has dismissed Trump's announcement and vowed to fight on until Moroccan forces withdraw from the entire region.

#### UK Supreme Court rules Heathrow can have third runway

BRITAIN'S Supreme Court on Wednesday ruled that Heathrow, one of the world's busiest airports, can build a third runway, overturning a legal decision to block the plan on environmental grounds.

The nation's highest court struck down a Court of Appeal ruling in February that the UK government had failed to take into account climate change commitments when in 2018 it approved the new runway at the London airport. Heathrow successfully argued that the Court of Appeal made errors of law.

Environmental group Greenpeace said Prime Minister Boris Johnson should still not allow the project to proceed, in the light of his government's targets on cutting carbon emissions.

The Supreme Court said the previous Conservative government had "no obligation" to consider the Paris climate agreement when it gave the nod to the extra runway. While the UK government said building work could begin in 2022, Heathrow warned that it would delay construction by at least two years owing to the coronavirus fallout and the legal challenges.

#### 'Win against rivals'

Heathrow hailed Wednesday's ruling, which it said would also allow Britain to compete with continental rivals following Brexit

"Only by expanding the UK's hub airport can we connect all

of Britain to all of the growing markets of the world, helping to create hundreds of thousands of jobs in every nation and region of our country," it said in a statement. "Demand for aviation will recover from Covid-19, and the additional capacity at an expanded Heathrow will allow Britain as a sovereign nation to compete for trade and win against our rivals in France and Germany."

The airport added that it had "already committed" to net zero carbon emissions and that the latest ruling "recognizes the robust planning process that will require... expansion is compliant with the UK's climate change obligations, including the Paris Climate Agreement."

## Biden joins battle for Senate as top Republican accepts win

PRESIDENT-ELECT Joe Biden threw his weight into the Democratic battle for control of the US Senate on Tuesday, as his White House win was finally acknowledged by top Republicans and holdout foreign leaders.

President-elect Joe Biden threw his weight behind the Democratic battle for control of the US Senate on Tuesday, as his White House win was finally acknowledged by top Republicans and holdout foreign leaders.

Biden flew into Georgia -- a southern state he won in an upset against President Donald Trump -- to host a rally for two Democratic candidates in runoff races that will determine the Senate's balance of power.

"Honk for your next United States senators Jon Ossoff and Rev. Raphael Warnock," Biden told the crowd at the drive-in event in Atlanta as he urged voters to turn out in force on January 5. "Send me these two men, and we will control the Senate!"

One day after the Electoral College affirmed Biden's victory, attention shifted to the looming Senate battle — and to the shape of the incoming administration, as Biden also announced he had nominated Pete Buttigieg, a former mayor and presidential rival, as secretary of transportation.

## Greek budget foresees weaker recovery from virushit 2020

GREEK lawmakers on Tuesday approved a 2021 budget built around weaker forecasts for a rebound from the coronavirus pandemic, which also includes cash for buying new fighter jets from France.

Latest projections see the Greek economy slumping 10.5 per cent this year, worse than the 8.2 per cent predicted in October.

Meanwhile the 2021 rebound should see 4.8 per cent expansion, down from a previous forecast of 7.5 per cent.

After weathering the first wave of the pandemic better than most European countries, Greece in early November resorted to a nationwide lockdown that has weighed on activity and is now expected to last until January 7.

The economy had returned to growth in the third quarter, following a 14-per cent quarter-on-quarter slump in April-June that was the worst in at least 25

While many countries

have suffered from high infection and mortality rates, Vietnam has recorded fewer than 1,500 coronavirus cases and 35 deaths thanks to mass quarantines, expansive contact-tracing and strict controls on movement, allowing factories to largely stay open and people to swiftly get back to work.

"The serious lockdown lasted for less than three months, so domestic activity was quickly back to normal by June," Nguyen Xuan Thanh, a public policy lecturer at Fulbright University Vietnam, told AFP.

While many Western countries were imploring citizens to stay home midyear, Vietnamese people were able to flock to scenic beaches as the government tried to give the domestic tourism industry a much-needed shot in the arm.

There were grave fears for Vietnam's export-reliant economy as demand for clothing, footwear and smartphones slumped in some of its biggest markets including the European Union, Japan and South Korea.

# Infrastructural development projects to make Bago City a major transport hub

THE New Hanthawaddy
International Airport will
be implemented as a national project," Vice-President U Henry Van Thio told the
media. The new airport project
will be developed on over 9,600
acres of state-owned landon outskirts of Bago City, about 75 km
from commercial city Yangon.

The new airport, designed to be built in three phases, includes the construction of an international terminal with capacity for 12 million passengers p/a, a 3,600m runway capable of handling A340 and Boeing 747 aircraft, taxiways, 42 aircraft stands and installation of a baggage handling system and other support systems, according to an aviation website CAPA. Phase 1 of the HIA project is expected to complete in 2027 with the target of 8 million annual passenger handling capacity. It will mainly be composed of one runway with 3,600 metres in length and 45 metres in width, one parallel taxiway, two taxiways, two high-speed taxiways, and other essential facilities. After Phase 3 is completed, which is estimated to be in 2048, it is targeted to reach 30 million annual passenger handling capacity.

The new airport will be the main gateway of Myanmar for attracting tourists and boosting freight economy and trade of the country. The new airport is estimated to cost between US\$1.5 billion and US\$2 billion to develop and become a major entry for international airlines to use and operate their businesses. Once completed, the airport will be the largest of its kind in Myanmar. The new airport is expected to draw more foreign direct flights to Myanmar and increase tourist arrivals as Bago Region lies on ASEAN highway. Industrial zones and dry ports will also be established in Bago Region as part of the ASEAN Highway, according

to Ministry of Construction. The development of the airport will increase commercial and industrial activities around Bago Region and beyond and raise the living standard of locals through the creation of job opportunities.

In addition, the Bago River Bridge (MyoOo Kin) project which started in the financial year 2018-2019 has fully completed recently, according to the bridge construction group. The Bago River Bridge (MyoOo Kin) was built by the Bridge Construction Group 9 of the Department of Bridge under the Ministry of Construction at the cost of K1.758 billion. The Bago River Bridge (MyoOo Kin) is located on SeinThaLyaung and ThameinBaran Roads, which allow vehicles to avoid congested downtown Bago. The Bago River Crossing Bridge (MyoOo Kin) is a two-lane reinforced concrete facility measuring 518 ft. in length and 28 ft. in width. The facility can withstand up to 60 tonnes of weight and have a 6-ft wide pedestrian walkway on each side. The bridge is a steel box girder with the floor of reinforced concrete and its piles are mainly constructed from reinforcement cement concrete. The bridge's clearance is 39 metres, and waterway under the facility is 3 metres. The bridge is connected with the Bago's detour and with the road network to

Yangon. The construction of the Bago River Bridge (MyoOoKin) started in February 2019 and was completed on November 29 this year. The new bridge is scheduled to be opened to traffic soon. With the opening of the new bridge, traffic congestion in Bago will be reduced to a certain extent, which will help speed up the flow

"I think Alisson is not injured. Alexander-Arnold is not injured. Matip, I believe that he's going to play. Fabinho is not injured. Robertson is not injured. Henderson is not injured. Wijnaldum is not injured. Salah is not injured, Firmino is not injured, Mane is not injured," Mourinho told reporters on Tuesday.—AFP

## Golovkin warns De La Hoya over comeback talk

LOS ANGELES — Gennady Golovkin issued a deadly warning to Oscar De La Hoya on Tuesday after the US boxing legend said he wanted to fight the middleweight world champion when he makes his improbable return to boxing.

The 47-year-old De Le Hoya, who announced in August he plans to come out of retirement after a 12-year absence from the ring, said recently he wants to fight IBF world champion Golovkin on his return.

"You know how easy GGG would be for me? Oh, my gosh," De La Hoya told the Boxing Scene website last month.

"I always took a good shot and I always took apart fighters like him. In my mind it would be that easy."

But Golovkin, who is preparing for a mandatory defence of his title against Poland's unbeaten Kamil Szeremeta in Florida on Friday, brushed off De La Hoya's trash talk. —AFP

## PSG face Barcelona in Champions League knockout phase

PARIS — Paris Saint-Germain, last season's beaten finalists, will face Barcelona in the last 16 of the Champions League while Liverpool were paired with RB Leipzig in Monday's draw.

French champions PSG will relish another chance to avenge their soul-destroying 'Remontada' defeat to the Catalan giants in 2017.

Having beaten Barca 4-0 in the French capital, PSG crashed to a 6-1 defeat at the Camp Nou orchestrated by Neymar.

The Brazilian, who won the 2015 Champions League with Barca, then joined PSG in a world record move weeks later but has yet to taste similar European success with Ligue 1's dominant force.

They came closest last season when they were beaten 1-0 in the final by Bayern Munich, who claimed a sixth European

crown thanks to a goal from PSG youth product Kingsley Coman.

With the first legs due to be played in February, PSG seem hopeful Neymar will have recovered in time from an ankle injury which forced him to be stretchered off the pitch in his side's 1-0 Ligue 1 defeat to Lyon on Sunday.

On Monday PSG said Neymar's prognosis was "reassuring" while the 28-year-old said on Instagram that his injury "could have been worse" following a rough tackle from Lyon midfielder Thiago Mendes which left him screaming in agony.

Barca may not be as intimidating opponents as in the past after a troubled start to the season influenced by boardroom chaos and Lionel Messi's attempt to leave the club in the summer.—AFP
