MoE minister meets education staff for drafting NESP 2021-2030

UNION Minister for Education Dr Myo Thein Gyi organized a virtual meeting with education staff from the ministry's departments including the Union Minister's Office, interested staff and NESP 2 Drafting Teams on drafting of National Education Strategic Plan 2021-2030 yesterday.

The Union Minister, Deputy Minister U Win Maw Tun, Permanent Secretary, Directors-General, officials and education staff from the ministry and departments participated in the meeting via videoconferencing.

Speaking to the meeting attendees, the Union Minister stressed the importance of cooperation spirit of the ministry, universities, schools and institutes in reviewing the condition of Education Sector Analysis-ESA on the National Education Strategic Plan 2016-2021.

Education reform would be successful only with the cooperation spirit and collective strengths. Implementations leading to quality education are also being made, he added, saying that if the works are done with family spirits, successful works would be more successful and difficulties and challenges could be overcome together.

The ministry was making education reform in accordance with NESP 2016-2021 towards

the core values of objectives – no one left behind in the education reform, no dropping out of school, not losing learning opportunities, students to become decent human beings, cooperation, accountability and creativity.

The government already published and distributed the new textbooks for kindergarten and 12 classes of basic education. Learning and teaching must be made in accordance with Teacher Competency Standard Framework-TCSF, he added.

Teachers were being appointed and trained for building their capacity and sustainable development. Scholarships for them were also provided.

The rate of primary, middle and high school completion has increased. In 2018-2019 academic year, students who studied at high school classes exceeded 1 million the first time. In 2019-2020 academic year, students studied at primary, middle and high school classes reached 9.716 million in total. In 2020, a total of 566,274 students got the certificates of high school completion.

According to analysis reports about primary school completion, reading analysis at primary school and mathematics analysis at primary schools, students from Myanmar are

good at reading, writing and mathematics skills.

Students from Myanmar achieved a total of six honorary mentions in competing at International Mathematical Olympiad between 2016 and 2020. According to national education quality index, those who got the certificate of basic education school completion can join Level 4 vocational schools, Level 5 vocational schools for diploma and advanced diploma courses, and open universities.

The ministry already provided nine English proficiency courses, seven IT courses,

management, and financial management courses, and was working on short-term courses for requirements from technical, vocational and training sector, diploma courses, and upgrading curriculums.

He called for collective cooperation in creating learning opportunities of lifelong learning blended effective subjects, saying that the ministry was working on all citizens to complete basic high school education.

Permanent Secretary Dr Zaw Myint introduced the drafting works of NESP 2021-2030 and detailed about the Education Sector Analysis-ESA conducted by UNESCO IIEP.

Director-General U Ko Lay Win discussed basic education sector, Director-General Dr Sai Kyaw Nai Oo technical and vocational sector, Director-General Dr Thein Win higher education sector, Director-General Dr Win Tun management, cooperation, capacity building and quality assurance sector.

Attendees at the meeting made discussions about the NESP 2021-2030 and gave suggestions.—MNA

Since production costs have risen in other countries in the region, investors have started seeking better locations for producing their goods. Because of the strategic location of our country as well as being one of the eco-

nomically developing countries in Asia, due to these good characteristics, our country is bound to be among the locations chosen for investment. However, on our part, it is important to create favourable conditions for investments to flow in.

That is why the Union Government has made strenuous efforts for the creation of a good investment climate characterized by transparency, simplicity, predictability and competitiveness capable of attracting FDI – foreign direct investment; this is to ensure that these investments are not only responsible but of high quality and would be supportive of sustainable development. As a good outcome of the efforts thus made, according to 2020 Ease of Doing Business Report of the World Bank Group, Myanmar's ranking, which stood at 171 last year, now stands at 165, which has placed Myanmar among the twenty most developing countries.

Since the foreign direct investment influx in this fiscal year fetches nearly 5.7 billion in US dollars, according to the Myanmar Investment Promotion Plan (MIPP), nearly 98 percent of the expected outcome has been achieved. In the present, more investments have come in from our regional partners Japan, Thailand, South Korea and Singapore while foreign investments from US and European countries are also coming in.

The UMFCCI President said that the government has set up a committee to remedy the economic impacts caused by the COVID-19, and spent nearly Kyat 3,000 billion, which is about 4 per cent of the GDP, for the plan. He added that some businesses are able to survive because of government's assistance such as easing economic procedures, reducing bank interest rates and tax cuts.

The UMFCCI President concluded his speech by saying that his federation and the business community welcomed the government's plans to implement the CERP and MERRP to remedy the economic impacts.

After that, Union Minister for Investment and Foreign Economic Relations U Thaung Tun, in his capacity as a Patron of the UMFCCI, delivered a speech. He said that the government is providing loans at low interest rates to the businesses affected by the COVID-19 crisis. To date, more than K166 billion have been loaned to 6.333 businesses.

Union Minister U Thaung Tun said that although the COV-ID-19 pandemic has challenged all the nations, Myanmar received about US\$ 5.7 billion in foreign investment in the 2019-2020 financial year. He continued that there is great potential for domestic and foreign investments in agriculture, electricity and industrial zones in Myanmar in the upcoming financial year.

Construction of Korea-Myanmar Industrial Complex (KMIC) will begin on 24 December, and AMATA Smart and Eco City will be implemented by cooperating with Thailand. Moreover, Myanmar and Singapore will continue implementing the Myanmar Singapore Industrial Park, according

Myanmar has signed the 15-nation Regional Comprehensive Economic Partnership (RCEP), said Union Minister U Thaung Tun, who added that the RCEP is the world's largest trade agreement, representing more than 30 per cent of the world's population and 29 per cent of world trade volume.

He said that by cooperating with the signatory nations, Myanmar will achieve benefits in the long run.

A statement of the World Bank said that although the COVID-19 pandemic has severely affected the economy in many nations, Myanmar is able to maintain a good position compared to other nations, and Myanmar's economy will gradually recover in 2021, according to the Union Minister. A report of the ADB also said that Myanmar's economic growth rate is only 1.8 per cent this year, but will reach 6 per cent in 2021

Then Union Minister for Commerce Dr Than Myint, in his capacity as a Patron of the UMFCCI, delivered a speech. He said that the government is making great efforts to develop Myanmar's economy in various ways. The government holds meetings with business organizations including the UMFCCI, and takes into account the suggestions of the business organizations. The government is doing what should be done in a timely manner. He continued that the government,

local organizations and business persons need to work together in order for domestic products to compete in local and foreign markets.

For the development of the private sector, the Ministry of Commerce is a focal ministry and the ministry is cooperating with UMFCCI, which represents the private sector, said Union Minister Dr Than Myint, who added that difficulties and challenges of the private sector are being continuously discussed and coordinated with other relevant ministries.

Regarding the "Ease of Doing Business" rankings, Union Minister Dr Than Myint said that Myanmar has achieved good results in cooperation with the private sector, and the aim was not only to improve the rankings but also to really make it easier to do business.

The Union Minister said that his Ministry is working to issue an e-commerce guideline as soon as possible.

He said that in order to encourage the flow of goods and to stabilize commodity prices during the COVID-19 crisis, his ministry is coordinating with business organizations including UMFCCI.

Because of the cooperation

of the UMFCCI and its associated organizations, the distribution of basic food to the needy people could be carried out smoothly, according to Union Minister Dr Than Myint.

He said that the Ministry of Commerce has been providing online services since 2004. In order to make it easier for traders to do businesses, his ministry has made arrangements, so by using the "Registration of importers and exporters with Tradenet 2.0 system", business persons can register as importers and exporters via online and they can also apply for export licenses and import licenses online.

Yangon Region Chief Minister U Phyo Min Thein said that it is a time for Myanmar to overcome the economic difficulties and challenges caused by the global COVID-19 pandemic.

In the endeavor to overcome the challenges, success will be achieved only with the cooperation among the government, the private sector and the general public, said the Yangon Region Chief Minister, who added that his regional government was able to effectively cooperate with the UMFCCI during the COVID-19 crisis.

The virtual meeting was participated by Union Ministers, the Yangon Region Chief Minister, Deputy Ministers, the Speaker and the Deputy Speaker of Yangon Region Parliament, Yangon Region Ministers, ambassadors, economic diplomats, local and foreign business organizations, business persons, officials from the UMFCCI and its associated organizations, and guests.

Myanmar nationals brought back home from Chinese Taipei by relief flight

A total of 147 Myanmar citizens including seamen who were stranded in Taiwan (Chinese Taipei) because of the suspension of commercial flights returned home by relief flight yesterday.

Myanmar Consulate-General Office in Hong Kong arranged the relief flight of China Airlines that landed at the Yangon International Airport in the morning.

The Ministry of Labour, Immigration and Population, the Ministry of Health and Sports and the Yangon Region government provided them with proper medical tests and arranged 7-day quarantine at specific places or designated hotels, followed by the 7-day home quarantine.

The Ministry of Foreign Affairs has been working with Myanmar embassies in foreign countries and local ministries concerned to bring back cit-

Chrysanthemum growers face financial hardship amid COVID-19 crisis

THE slump in Chrysanthemum demand amid the COV-ID-19 pandemic brought down the market in Minbu Township,

Magway Region. Additionally, the growers are facing financial hardship due to high input cost to stop whiteflies on Chrysanthemum during the harvest time.

"The Chrysanthemum market is commonly dependent on household consumption in flower offerings to Buddha. The whiteflies infestation caused damage to flower. The price is not good during the pandemic. The growers are not financially doing well with the business due to high input cost for insecticide," said a grower Ko Zaw Min.

Yetwingon village-tract among the villages of Minbu Township is the primary producer of Chrysanthemum. Shwewahwin, Lucky, Shwesain and Ngushwewah (local Chrysanthemum varieties) are primarily grown. "The travel restriction poses another reason for market fallouts. The traders are experiencing difficulties to send to markets in other regions and states. The market sees a steep drop in demand," a seller Mon Mon said.

Furthermore, Chrysanthemums are damaged by heavy rain in June this year, the growers said.—Zayyatu (Magway) (Translated by Ei Myat Mon)

COVID-19 Call Centre opens daily

In efforts to speed up the prevention, containment and treatment of the COVID-19 disease, the call centre (phone number 2019) is established by four communications operators and the Blue Ocean Company with the coordination of the Medical Research Department of the Health and Sports Ministry and Post and Telecommunications Department from 9 am to 5 pm daily at the Medical Research Department in Yangon.

New sugar likely to fetch good price at year-end

THE price of new sugar produced at the end of December is expected to rise as the stock of old sugar, and imported sugar is remained less, according to Sugar and Cane Related Products Association.

"Local sugar mills are started running beginning from 5 December. The new sugar will be produced in December-end. The stock of old sugar has become lesser. Additionally, sugar import is rarely found in the meantime. Sugar price has surprisingly risen this year in the international market. The domestic sugar market also sees a potential," said U Thi Ha Tun, secretary of Sugar and Cane Related Products Association.

Sugar millers purchased sugarcanes in mid-December,

and the mills are operating to produce sugar by the 2020-2021 sugarcane season. At present, the sugar mills in eastern and western Bago Region are running. The mills in northern and southern Shan State and Sagaing Region are soon to operate

"Myanmar can export locally produced sugar to China and Viet Nam. As the supply is deficient, the price will rise on the growing demand for sure," vice-chairman U Win Htay of the association guessed.

Sugarcane covered 438,420 acres in the country this year. Myanmar's sugar mills intend to grind 4.2 million tonnes of sugarcanes in the 2020-2021 sugarcane season, the Agriculture Department stated.

Myanmar produced about 450,000 tonnes of sugar from 440,000 acres of sugarcane plantations in the 2014-2015 financial year, over 390,000 tonnes from 390,000 acres in the 2015-2016FY, over 370,000 tonnes from 400,000 acres in the 2016-2017FY, over 500,000 tonnes from 400,000 acres in the 2017-2018FY, and 500,000 tonnes from 500,000 acres in the 2018-2019FY.

Sugar cane prices were pegged at over K50,000 per ton in the 2015-2016FY, K45,000 in the 2016-2017FY, K41,500 in the 2017-2018FY, and K38,000-40,000 in the 2018-2019FY, according to news released online by the Ministry of Commerce.—Min Htet Aung (Mandalay sub-printing house)

CMP garment exports drop by \$176 mln in first month of 2020-2021FY

MYANMAR'S garment export sector, which constitutes over 20 per cent of overall export value, showed a steep drop of US\$176 million in October of the current financial year, according to the data released by the Ministry of Commerce.

In October of FY2020-2021, the country exported \$203.95 million worth garments to foreign countries. The figure plunged from \$384 million registered in October of the 2019-2020FY.

At present, over 100 CMP garment factories temporarily shut down on the reason for the lack of raw materials and slump in demand due to the coronavirus negative impacts, leaving thousands of workers unemployed. Sixty-four factories have been permanently closed down during the pandemic, compensating about 25,000 workers. The

data does not include those factories which have not resolved worker payments, the Ministry of Labour, Immigration and Population stated.

The coronavirus impacts badly batter the labour-intensive enterprises according to the Directorate of Investment and Company Administration.

"Myanmar mainly exports the garments to Japan and European countries, especially Germany. The US has also purchased the garments made in Myanmar. Some western countries cancelled orders amid the pandemic. That's why we need to focus on market diversification. Myanmar Garment Manufacturers Association (MGMA) requested the ministries concerned to deal with changing and cancelling order to keep the business alive. Myanmar's

health guidelines, and the buyers recognized this. If the factories can prevent from spreading the virus, it will not affect the production," MGMA General Secretary Daw Khaing Khaing Nwe shared at the virtual conference held on 11 December 2020.

The plan is designated to train the trainees for ten days, with 18 batches, in a bid to upgrade the existing skills and make them more readily employable.

Next, foreign direct investments flow into many types of businesses, including garment enterprises. The foreign investors are not bothered by the disputes between employers and employees and the closure of some CMP businesses during the mean times, the Myanmar Investment Commission affirmed

Of the investment proposals, the manufacturing and labour-intensive businesses are prioritized by the commission.

The commission is planning

The commission is planning to accept investment projects in manufacturing masks, pharmaceuticals and others which can contribute to the fight against the coronavirus in the country at the soonest.

Myanmar mainly exports CMP garments to markets in Japan and Europe, along with the Republic of Korea, China, and the US.

The garment sector is among the prioritized sectors driving up exports. The CMP garment industry has emerged as a promising one, with preferential trade from Western countries.

Myanmar's garment factories operate under the CMP system, and those engaged in this industry are striving to transform CMP into the free-on-board (FoB) system. As the factories cannot enter into a contract for FoB, Own Design Manufacturing (ODM) and Own Business Manufacturing (OBM), the income is limited, according to the MGMA.

Exports of garments manufactured under the cut-makepack (CMP) system were valued US\$4.798 billion in the last financial year 2019-2020, according to the data from the Ministry of Commerce.

Although the sector is facing hardships because of the cancellation of order from the European countries and the suspension of the trade by western countries amid the pandemic, export values rose in the previous FY.

The export value of CMP garments was only \$850 million in the 2015-2016FY, but it has tripled over the past two FYs. In the 2016-2017FY, about \$2 billion was earned from exports of CMP garments. The figure increased to an estimated \$2.5 billion in the 2017-2018FY and \$2.2 billion in the 2018 mini-budget period (from April to September). It tremendously grew to \$4.6 billion in the 2018-2019FY, according to the Commerce Ministry.

Since an outbreak like COVID-19 might happen in the future, it is necessary to prepare for a sufficient supply of raw materials. The public and private sectors will cooperate in setting up the supply chain on our own sources, including weaving, knitting, dyeing, and sewing factories.

The MGMA has more than 500 members, and garment factories in Myanmar, employing more than 400,000 workers. Investors prefer to invest in countries with inexpensive labour, such as Myanmar.—Ko Htet

A brief look into the case studies in ELT during and post-COVID crisis


by the new opportunities, we are faced with the emerging challenges. To use Thornbury's (2019) terms, "in 1990s, and thereafter, the English language teaching proliferated big before them, absolute global, massive by the turn of the twenty-first century." However, according to English UK's report "Impact of COVID-19 on the English Language Teaching Sector in the UK" (2020), the pandemic hit in early February, and there was no chance for face-to-face teaching starting from 20 March 2020. As the unprecedented changes had taken place, many students had to pack up for their return journey home. Many courses offered for scholarships were cancelled or postponed.

During the COVID crisis, since face to face teaching is out of the question, online learning like a synchronous Zoom Web Conference System has to be the last resort we have to seek for so that teachers would not go unemployed while learners would not go idle, but continue learning during this long break. In the post-COVID crisis, since the New Normal context in which this teaching-learning process takes place can make a strong impact on all sectors, the overall impact may be considered by the researchers focusing on

the local context, which would be feedback to other stakeholders, including the language policy makers. Despite its drawbacks of lack of social interaction through personal contacts, one of the advantages of online learning is flexibility: you can learn anywhere at any time. But this flexibility is challenged by the ease of access: Is the Internet access guaranteed to all parts of our country? To exploit this advantage of flexibility of online learning, the language teachers need to consider how to get "socialized language learning" springboard from the rigid frame of learning of textbook and "grammar mcnuggets" to use the terms of Thornbury (1999) because we do not want to produce the glued-tothe-screen generations.

The research findings of Dwi Rahayu (2020) in Pamulang University, Indonesia, show that 62 students make positive responses to three factors of online activities: communication, lesson material and study process. On the other hand, students prefer the traditional face-to-face learning in terms of communication and materials, compared with the

On the other hand, since the staff have to follow the Stay-at-Home rules under the directives of the Ministry of Sports and Health, a considerable number of teaching staff had left their jobs and picked up their own online teaching to three or four students. As a result, a private international school in Mandalay suffers a dearth of language teachers to continue running the school. Such challenges may come over again if, God forbid it, the pandemic would repeat itself. It is suggested that as a project of post-Covid crisis, schools should start training the teaching staff on how to conduct online classes and exploit the effectiveness of online teaching, as suggested by an instructor trainer Lokethar (2020): "It is true that training the teachers on modern technology and teaching methods would address the issue of the current deficiencies in the teaching-learning

Bamboo chicken coops on brink of extinction

chicken baskets. It takes two to three hours to make a basket. We make many kinds of bamboo baskets, including fish trap, chicken trap, eel trap, etc.," he added.

Saudi Arabia and Russia express unity ahead of OPEC+ summit

Saudi Arabia and Russia on Saturday said they backed each other ahead of a key OPEC+ oil summit, following a tumultuous year of differences over oil production and volatile prices.

Earlier this month, the 13-member Organization of the Petroleum Exporting Countries (OPEC), plus allies including Russia — a group known as OPEC+ — said that from January 2021 they would raise production by 500,000 barrels

Saudi Oil Minister Prince Abdulaziz bin Salman said the **OPEC+** cooperation charter had brought the group together,

producing "good results".

"That's why it should be perpetuated," he told reporters in a broadcast on state-run Al Ekhbariya TV.

Russian Deputy Prime Minister Alexander Novak said Moscow "once again confirmed our loyalty" to existing agree-

"We plan to work together in order to achieve a balanced situation... and to propose solutions aimed at stabilising the market," Novak said.

OPEC+ will hold an online summit on January 4, while Riyadh and Moscow are due to hold talks in March, a meeting

hoped to be "in person", Prince Abdulaziz said.

At the start of the year, a price war had pitted Saudi Arabia against Russia, the third and second largest oil producers respectively, as the oil market was hit hard by the Covid-19 pandemic.

But faced with Moscow's refusal to reduce production in line with OPEC cuts, Riyadh had sharply increased its own, causing prices to plummet.

Earlier this month, the OPEC+ group struck a deal to increase production over coming months.

Path to post-Brexit deal blocked by fish dispute

INTENSE haggling Saturday over EU fishing rights in UK waters threatened to sink negotiations on a post-Brexit deal and plunge cross-Channel trade into chaos.

Fishing is now the main obstacle to securing a pact by 1 January, when Britain leaves the EU single market, after progress on the other main issue of guaranteeing fair competition.

"It remains very blocked," one EU diplomat told AFP.

Another said Brussels had made Britain its last offer on fishing access and it was down now to UK Prime Minister Boris

Johnson to decide whether he wants a deal.

"If Britain doesn't accept the latest EU offer it will be a 'no deal' over fish," he warned, adding that London has until the end of the year to decide.

The EU's chief negotiator Michel Barnier has proposed EU fishermen giving up nearly a quarter of the value of the fish they currently catch in UK waters. Britain is understood to be holding out for getting back much more than half. The UK has suggested this compromise last for three years before it is renegotiated, whereas Europe is

holding out for double that. "It's all down to numbers now," the second European diplomat said.

EU fishermen expressed alarm that "we are in the throes of being sold down the river," in a statement from the European Fisheries Alliance.

It urged Barnier to stick to protecting them, saying: "The shape of a deal, as currently stands would give a huge blow to the European seafood sector which is made up of more than 18,000 fishermen and 3,500 vessels with an annual turnover of 20.7 billion euros."

In refugee camps, Palestinians prepare for post-Abbas power struggle

IN Palestinian refugee camps in the Israeli-occupied West Bank, some residents are preparing weapons for a potential power struggle when president Mahmud Abbas finally leaves the stage.

Abbas, 85, leader of the dominant Fatah movement and of the Palestinian Authority (PA), has promised legislative and presidential elections in 2021, for the first time in almost 15 years.

Rivals are already seeking to build up a power-base.

In Balata camp, outside the city of Nablus, walls are plastered with posters picturing Hatem Abu Rizq, regarded as a "martyr" of Palestinian infighting.

On October 31, Palestinian media reported one dead and others wounded in Balata, where 30,000 people are crammed into one quarter of a

square kilometre (one tenth of a square mile).

This time, the casualties were not the result of a clash with Israeli forces, although Abu Rizq spent almost 10 years in Israeli jails for his part in the Palestinian uprising of 2000 to 2005. At the age of 35, he died in the eruption of intra-Palestinian violence in October.

Palestinian officials said he was killed by the premature explosion of a bomb he was about to detonate.

"But in truth he was killed by shots from the Palestinian Authority," says his mother, Um Hatem Abu Rizq, in the family's tiny apartment in a dilapidated concrete building.

"He was looking to fight corruption within the Palestinian administration, that's why they didn't like him," she weeps, kissing a giant poster of her son.

North Korea to redevelop flagship tourist resort

PYONGYANG plans to redevelop its flagship Mount Kumgang tourist complex into an international resort, a year after leader Kim Jong Un ordered South Korean-built buildings there demolished, state media reported Sunday.

The resort -- once a prominent symbol of inter-Korean economic cooperation -- was built by South Korea's Hyundai Asan on one of the North's most scenic mountains, drawing hundreds of thousands of Southern visitors.

But last year Kim condemned the development with the South as an eyesore and described facilities there as "shabby" and built like "makeshift tents in a disaster-stricken area or isolation wards", ordering their removal.

On Sunday, the official Korean Central News Agency reported that Kim Tok Hun, the

North's premier, stressed "the need to build the tourist area our own way" to turn it into a "cultural resort envied by the whole world", during his visit to the area.

He also called for pushing ahead to turn the area into a "modern and all-inclusive international tourist" resort, it added.

The Mount Kumgang complex was once one of the two biggest inter-Korean projects, along with the now-shuttered Kaesong Industrial Complex, where Southern companies employed North Korean workers while paying Pyongyang for their services.

But its tours came to an abrupt end in 2008 after a North Korean soldier shot dead a tourist from the South who strayed off an approved path, and Seoul suspended travel.

SPIKE IN DEMAND

German factory races to churn out Covid-19 syringes

THE battle against Covid-19 has delivered not just a vaccine at record speed but also a spike in demand for the billions of syringes needed to administer it.

One German factory is already busily churning out the little plastic tubes and is confident global needs can be met.

"There won't be a short-

age of syringes, even if we are facing a big challenge," said Otto-Philipp Braun, co-director of Almo, Germany's leading syringe manufacturer.

At the company's production site in the central German town of Bad Arolsen, the loud hum of machinery fills the hall.

Employees man the assembly lines, wearing masks, hair nets and occasionally ear plugs.

They churn out disposable syringes 24 hours a day, seven days a week, destined for use in Germany and more than 140 other countries around the world.

One machine moulds high-quality plastic granules into thin, one-millilitre syringes, while another spits out the pistons that fit snugly inside the cylinder and are needed to push out the vaccine.

The plastic piston is green, matching the logo of German parent company B.Braun, a giant in the medical devices industry and still owned by the Braun family.

A total of 64 syringes with pistons are assembled every 13 seconds.

Every year, Almo churns out more than two billion syringes of various kinds.

The needles that can be added to the injection devices are produced by a B.Braun subsidiary in Malaysia.

The company intends to spend 30 million euros on an additional assembly line, partly to cope with increased demand for the Covid-19 jabs.

PHARMACEUTICAL SUPPLY CHAIN

Singapore gets shot in the arm from global drug demand

SCIENTISTS in protective clothing work in a high-tech laboratory at a pharmaceutical plant in Singapore, whose coronavirus-hit economy has received a shot in the arm from robust global drug demand.

The city-state is on course for its worst ever recession this year but factory activity has held up, thanks partly to countries rushing to stockpile medicines during the pandemic.

The nation just half the size of Los Angeles has become a centre for drug makers and is home to more than 50 factories, owned by big players including Pfizer, Roche, GlaxoSmithKline and Takeda.

Singapore's drug sector "plays an important role in the global pharmaceutical industry supply chain", Rajiv Biswas, Asia Pacific chief economist at consultancy IHS Markit, told AFP.

And in 2020, "governments and private-sector firms have been building up inventories of critical drugs as a result of the severe supply chain disruptions in many countries during the pandemic", he added. Data highlights the benefits for the trading hub -- biomedical manufacturing, which covers pharmaceuticals, has grown strongly, with output expanding 90 percent on-year in September alone.

TRADE MEASURES IN THE TIME OF COVID-19

Air cargo and container ship restrictions impacting delivery of goods

AMID the Christmas festivities and the year's biggest shopping season, severe restrictions on trade between China and the rest of the countries have infuriated retailers and shoppers in Europe and the United States.

During Germany's first lockdown in March due to coronavirus, Oliver Hellmold, CEO of Notebooksbilliger, one of Europe's largest online electronics retailers, had started ordering a large number of gadgets from China like every year's pre-Christmas sales "anticipating a pandemic-related shift toward people working from home", said Nikkei Asia. However, by October Hellmond's struggle to maintain inventory had begun. According to Hellmond, since August the demand from schools and the public sector for monitors, PCs and notebooks had increased by as much as 40 per cent year-onyear due to shifting of learning and services to online mode.

Indonesia launches Japanese-funded port to boost auto exports

INDONESIAN President Joko Widodo on Sunday presided over the soft launching and initial operation of the Japanese-funded Patimban deep sea port, located some 120 kilometers east of Jakarta.

Widodo said that with the completion of the first phase of Patimban International Port in Subang Regency, West Java Province, Indonesia's exports, including autos, to the global market are expected to increase.

In November 2017, the Japanese government signed an agreement with Indonesia to finance the first phase of the port development project with a

soft loan of some 119 billion yen.

The port has a current capacity for 3.75 million 20-foot-long cargo containers or their equivalent, while its car terminal can accommodate 218,000 completely built-up units,

or CBUs.

Its capacities are expected to increase to 7 million containers and 600,000 CBUs upon the completion of the third phase in 2027.

Also on Sunday, Widodo, participating in the ceremony virtually, witnessed the first shipment of 140 Toyota, Daihatsu and Suzuki cars to Brunei from the new port.

Patimban, designated as a national strategic project, is expected to facilitate the country's exports by boosting time efficiency and lowering logistics

It will ease heavy congestion on roads to Tanjung Priok port, a major export base north of Jakarta.

The new port is located in the east of industrial parks in and around Bekasi Regency, where Japanese automakers and car parts manufacturers are building an industrial cluster.

US lawmakers set to vote on virus stimulus deal: WSJ

US lawmakers agreed on pandemic spending powers for the Federal Reserve late Saturday, the Wall Street Journal reported, clearing the way for a vote on a roughly \$900 billion Covid-19 relief package for millions of Americans.

The deal would maintain the central bank's ability to set up emergency lending programs without congressional approval, the Journal said, but the Fed would require approval to restart existing CARES Act programs once they expire

at the end of this year.

Republicans had sought to limit the Fed's ability to provide credit for businesses and other institutions, claiming Democrats were trying to use the legislation to create a "slush fund" for state and

local governments they control. Democrats argue restricting the bank's powers could compound the fiscal crisis and hamper the ability of the incoming Joe Biden administration to boost the ailing US economy.— SOURCE: AFP

Pwe Hla Haw Nan in Pwe Hla Village, southern Shan State

WE Hla, also known as Pwe Hla Village in Danu Region in southern Shan State, is now a thriving town. It has been 260 years that Pwe Hla was built and it can be said that it is a very long-lived area. The town is also peaceful on its own. During my visit, I noticed that there was a lot of natural beauty in the area. I assume that it has the beauty of nature the travellers haven't seen yet. I went trekking near its environment and also took a look in the town and market.


The region owns various kinds of flower and vegetable. Speaking of Pwe Hla, in this article, I am going to tell you my unplanned visit to Pwe Hla Haw Nan while on a trip to Pindaya.

Pwe Hla Haw Nan

During my trip to Pindaya, some local more talked about Pwe Hla Haw Nan than Pindaya Haw Nan and it

makes me want to visit Pwe Hla Haw Nan. I felt profound and enjoyed it when I got there. The building structure of Pwe Hla Haw Nan is unique. It feels like it has stone walls, unlike any other Hall Nan. It is said that the Indians created the Haw Nan by carving gravel. The carpenters were from China. One unique thing about the Haw Nan is that the building has a European-style look with the Myanmar interior decorations. This nearly 120-year-old Haw Nan is said to be built in Japanese rule in Myanmar. The Haw Nan was the palace of Saopha Sao San Mya, and we can see the photographs of the Saopha and his family and relatives in black and white colours.

There are altogether 20 rooms, ten rooms in upstairs and 10 in downstairs in the 400 square feet wide Haw Nan. Except for some slight damages in some place, the entire Haw Nan

is still in a perfect condition. The rooms don't have much light because it has not been systematically transformed yet into a museum. The things inside of it are also found in a state of disrepair with dust like a warehouse.

As I looked around the room, I could guess the conditions of that time. The room where the Saopha lived, the bed and the type of cord used in those days are still there. The door handles are also unique.

Even though the other rooms are left as such, a small place where Grandma Daw Sao Mya Aye lived at the back entrance of the downstairs and the Buddha shrine hall was cleaned. The Buddha shrine was there since the palace was built and the photographs on the wall of the living room in upstairs are the real history, showcasing the first Saopha to the last one.

I personally prefer the exterior design of the Haw Nan. Grandma Daw Sao Mya Aye whom I met during my visit is the last daughter among eight children of Saopha and. Despite her age of being 90, I noticed that she was relatively healthy and active. The last daughter was a professor at the History Department at Taunggyi University and can speak English fluently with clear pronunciation. Due to her age, she didn't guide the tour when she was not in the mood but, when she wanted to, she used to explain the story of the Haw Nan.

I appreciated her explanation

Hpa-Baung cave in Mon State attracts more visitors

ORE and more people are visiting Hpa-Baung Cave located in Lamukho Village-tract, Kyaikmaraw Township in Mon State. The cave is home to the fascinating beauty of nature and ancient pagodas, decorated with stalactite and stalagmite inside



MELBOURNE — All the world's top players, including 20-time Grand Slam champion Roger Federer, are expected to be in Melbourne for the coronavirus-disrupted Australian Open, tournament organiser Craig Tiley said.

The opening Grand Slam of the year, in front of at least 50 percent of normal crowds, has been pushed back three weeks until February 8 with all players to undergo a mandatory 14-day quarantine on arrival.

The delay could be pivotal for Federer, who admitted last week he was in a "race against time" to be fit as his recovery from two rounds of knee surgery takes longer than expected.

Tiley said he had been in touch with the 39-year-old and he was going through his normal pre-season training routine in Dubai. "Every player, including Roger, has made a commitment to travel to Melbourne to play," he said after confirming the new start date on Saturday.

"We have been in touch with him and his team and it's been three days now, he's hit for the first time in Dubai. He's in his normal pre-season training routine. "He did say to us that February 8 was a more suitable date for him in terms of preparing for the Australian Open," Tiley added. "But a lot will depend on how he responds to his surgery in the next two to three weeks of training."—AFP■

How many goal landmarks left for Lionel Messi?

MADRID — Lionel Messi reached a new landmark Saturday by scoring his 643rd goal for Barcelona, equalling the record held by Pele for goals recorded for the same club, but who is football's greatest marksman?

Messi's latest achievement came in the 2-2 draw with Valencia when the 33-year-old headed in from Jordi Alba's cross after his first-half penalty was saved.

It equalled the mark set by Brazilian great Pele for Santos before he left for New York Cosmos in 1974. Messi's goals have come in 748 matches, an average of one every 1.16 games; Pele's came in 757 matches at one every 1.17 games.

"These figures are impressive, we will never have a player so effective at this club," admitted Barcelona coach Ronald Koeman.

"That's why he is the number one. What he has done for this club, it's impressive." Rarely does a season go by when Messi isn't forcing football's history books to

be updated.

On July 1, in a 2-2 draw with Atletico Madrid, Messi scored the 700th goal of his professional career -- club and internationals combined -- with a clever 'Panenka' penalty. More than 15 years have passed since Messi opened his goal account with Barcelona.

It was on May 1, 2005, against Albacete in La Liga in a 2-0 win.

However, his love affair with Catalonia soured in August this year when he threatened to leave.—AFP ■

Mexico's Alvarez overpowers Britain's Smith to claim two titles

LOS ANGELES — Mexican pound-for-pound champ Saul Alvarez ended the longest layoff of his career on Saturday, brutally overpowering the previously unbeaten Callum Smith to capture two super middleweight titles with a unanimous decision in

Three-division champion Alvarez claimed the vacant WBC title and Briton Smith's WBA

version of the 168-pound belt, overcoming a stark height difference as he moved up in weight class for the fight in front of a pandemic-limited crowd at the Alamodome in San Antonio.

"I feel really proud to have this," Alvarez said. "I represent not only the boxing world but my country. I did a great job after a 13-month layoff.

"I am the best in the world."

Alvarez improved to 54-1-2 with 36 knockouts, while Smith suffered the first defeat of his pro career and dropped to 27-1, 19 knockouts.
