Republic of the Union of Myanmar State Administration Council Nine Objectives

1. Political affairs

- (a) To build a Union based on democracy and federalism, through a disciplined and genuine multiparty democratic system that is fair and just.
- (b) To emphasize the achievement of enduring peace for the entire nation in line with the Nationwide Ceasefire Agreement (NCA).
- (c) To continue implementing the principle of peaceful co-existence among countries through an independent, active and non-aligned foreign policy.

2. Economic affairs

- (a) To enhance production based on agriculture and livestock through modern techniques and strengthen all-round development in other sectors of the economy.
- (b) To develop a stable market economy and promote international investment in order to enhance the economic development of the entire National people.
- (c) To promote and support local businesses to create employment opportunities and increase domestic production.

3. Social affairs

- (a) To ensure a strong and dynamic Union spirit, the genuine spirit of patriotism.
- (b) To respect and promote the customs and traditions of all National peoples and preserve and safeguard their cultural heritage and national characteristics.
- (c) To enhance the health, fitness and education quality of the entire nation.

Five-Point Road Map of the State Administration Council

1. The Union Election Commission will be reconstituted and its mandated tasks, including the scrutiny of voter lists, shall be implemented in accordance with the law.

2. Effective measures will be taken with added momentum to prevent and manage the COVID-19 pandemic.

- 3. Actions will be taken to ensure the speedy recovery of businesses from the impact of COVID-19.
- 4. Emphasis will be placed on achieving enduring peace for the entire nation in line with the agreements set out in the Nationwide Ceasefire Agreement.
- 5. Upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held in line with the 2008 Constitution, and

further work will be undertaken to hand over State duties to the winning party in accordance with democratic standards.

COVID-19: start ourselves to take preventive measures

ALL people are urged to abide by the following ways of prevention against COVID-19 without fail in line with the motto: "COVID-19: start ourselves to take preventive measures" not to violently infect COVID-19 as next wave and not to be infected of variant COVID-19 virus.

- (1) Systematically wear masks whenever go outside and also wear face shields whenever associate with many people.
- (2) Take adequate distance from each other as much as they can.
- (3) Avoid the crowds.
- (4) Take 20 seconds in systematically washing hands many times.
- (5) Avoid the visits to the closed chambers, air-conditioned rooms and the lesser ventilated rooms as much as possible.
- (6) Those who need to go outside houses should avoid acts close to and eat meals together with older persons above 60 years and those with diabetes, hypertension, and heart diseases.
- (7) Fully cooperate in quarantine processes.
- (8) Don't buy something from the vendors who do not wear masks.
- (9) Exchange information to each other.
- (10) Cooperate in vaccination of COVID-19 pandemic. Continuously follow the preventive measures although they have received the vaccinations.
- (11) Strictly follow the work guidelines for preventing the COVID-19 pandemic issued by the Ministry of Health and Sports.

(12) If somebody suffers from symptoms of higher body temperature, coughing, suffocation, tiredness and sudden loss of smell and flavour, they need to immediately contact nearby health units to receive medical treatment.

Moreover, the group of outstanding award-winning officers visited Patriotic Park in Moscow and the main church of the Russian Armed Forces, the delegation of the Ministry of Religious Affairs and Culture the Mahayana Buddhist Monastery of the Moscow Sangharaja and the delegation of the Ministry of Foreign Affairs, the MGIMO University. —MNA

Ex-Magway region chief minister, Hluttaw speaker, ex-regional ministers, Yangon region social affairs minister charged under anti-corruption law

FORMER Magway Region chief minister Dr Aung Moe Nyo, Former Magway Region Hluttaw speaker U Tar, former minister for Natural Resources, Environment, Electricity and Energy U Myint Zaw, former social affairs minister Dr Khin Maung Aye, former minister for construction and transport U Tin Nwe Oo and former Yangon Region social affairs minister U Naing Ngan Lin, have been charged under Section 55 of Anti-Corruption Law. The former ministers were found corrupt when the Anti-Corruption Commission (ACC) investigated the allegations of corruption in their activities during their tenures as ministers. According to the findings of the ACC, former Magway Region chief minister Dr Aung Moe Nyo received 50 million kyats to let a company open a gas station on a one-acre land that was not allowed for

other land use applications due to falling in the residential zone since 2016.

Although the company did not charge for the design of the Magway Region Hluttaw Building, former Magway Region Hluttaw speaker U Tar, during his tenure, gave the company 2 per cent of the value of the Hluttaw (main building) project, more than K84 million in the design fee, which was not included in the contract, to make a statue of the general in the shape of attending the Hluttaw, causing the state to lose more than K84 million. According to the regional government's Notification No. (36/2018) dated 31 October 2018, a rent of K300,000 was collected for one acre of land from the official oil mining licence holder. The former Magway Region chief minister and former minister for Natural Resources, Environment, Electricity and Energy U Myint Zaw failed to collect a total of K310.2 million for

a total of 569 acres of land lease in Minhla, Thayet, Saw and Pauk townships, which caused the loss of the State budget in 2018, 2019 and 2020. Former minister U Myint Zaw, in November 2019, received K2.5 million from the chairman and secretary of the Magway Region Petroleum EntrepreConstruction and Transport U Tin Nwe Oo received the bribery of K6 million from a company that inspects the quality of the Magway Region Hluttaw main building in August 2020.

The former Magway Region chief minister and the Magway Regional Hluttaw speaker let the Hluttaw representatives carry out the regional development work that was supposed to be done by the government organizations, without submitting to the Union Government and without complying with the financial procedures of the Regional Development Fund issued by Notification No. 58/2019 in the 2019-2020FY. Due to this, the State lost K2,497 million. Similarly, former Yangon Region social affairs minister U Naing Ngan Lin was found to be corrupt by receiving cash and expensive appliances from numerous businesses and companies during his tenure as the minister. - MNA

Lashio Myoma market closed for two weeks to control COVID-19

BECAUSE of the increasing number of COVID-19 infection cases in Lashio township day by day, Lashio Myoma Municipal Market of the Lashio Municipal Department has closed for two weeks, with effect from 23 June.

As 15 vendors at the Lashio market were found to have been infected with COVID-19 on 22 June, the market was closed for two weeks starting from 23 June until 7 July to control the spreading of COVID-19, said U Kyaw Zin, the executive officer of the municipal department.

Besides, the Lashio town night bazaar and Kharyo market have also suspended their operation.



As 15 vendors at the Lashio market were found to have been infected with COVID-19 on 22 June, the market was closed for two weeks starting from 23 June until 7 July to control the spreading of COVID-19.

During the closure of the market, the vendors are urged to stay at home and if there are some strange things with their health, they are requested to inform the ward administrators or health department as quickly as possible.

On 22 June, a man, who

was home quarantines at ward 9 in Lashio town was found to be positive with COVID-19. Then, he committed suicide. The COVID-19 operation team buried the corpse in line with the guidance of COVID-19 protection.

Those who had close contact with the COVID-19 positive person are put in home quarantine and it can take three days to get the result, said an official from the health department.

Lashio has found 168 COVID-19 confirmed patients as of 23 June, according to the Township Level Committee of COVID-19 Prevention, Control and Treatment. — Han Htay (Lashio)/GNLM

MCC ready to provide COVID treatment for 250 patients

MYANMAR Convention Centre (MCC) has the facilities made ready to provide treatment for 250 COVID-19 patients on Mindhamma Road in Mayangon Township, according to the Ministry of Health and Sports.

In order to provide the cure for COVID-19 patients, MCC has already prepared the beds and supplies for the patients. The necessary medical team will also be assigned by the joint medical coordinating team of COVID-19 Prevention, Control and Treatment, according to the Ministry of Health and Sports.

Further, the authorities have supplied necessary things after monitoring the COVID-19 vaccination of the educational staff at MCC.

At present, two hospitals are also carrying out preparation measures to hospitalize the COVID-19 positive patients. These two hospitals are the People's Hospital in Hlinethaya township and the People's hospital in Shwepyitha township. Hlinethaya township hospital will be able to accommodate 100 patients and has made ready the essential things such as oxygen for 50 patients while Shwelinpan civil hospital will be able to accommodate 50 patients.

The authorities are also having the medical examinations conducted on all the visitors who will come from the stay home townships to the Yangon region to make sure whether they have COVID-19 or not.

Currently, the number of confirmed cases of COVID-19 has increased in Lashio.

With the essential further control of spreading of COV-ID-19, the instructions, orders and notifications of the union level organizations and the relevant ministries released on 31 May 2021 was extended to 30 June 2021.

So far, Myanmar has reported a total of 148,617 cases, with 3,265 deaths and 133,753 recoveries as of 22 June 2021. — Aye Maung/GNLM

Myanmar exports about 20,000 bags of rice to China via Bhamo-Lwejel route

MYANMAR daily ships about said. 20,000 bags of rice to China through the Bhamo-Lwejel route, said U Min Thein, vicechair of Muse Rice Wholesale Centre.

Man Wein, a major border crossing between Myanmar and China for rice exports, came to an abrupt halt from 30 March, following the COVID-19 detection in the border.

As a result of this, the export channel was shifted to the Bhamo-Lwejel route, he continued.

"The rice is delivered from Mandalay to Bhamo, Kachin State by ship and sent to Lwejel, which is 59 miles away from Bhamo by truck. Lwejel border is next to China," U Min Thein

Previously, it took about a month to China via the Mandalay-Muse route due to traffic congestion. This new trade channel cut both the shipping time as well as the cost, he added.

Man Wein border post has remained close even after two and half months.

Japan ranks second-largest foreign investor in Myanmar

FOLLOWING the UK moving up a rank with the largest investments made last month, Japan became the second-largest source of foreign direct investments into Myanmar in the past eight months (Oct-May) of the current financial year 2020-2021, according to data released by the Directorate of Investment and Company Administration (DICA).

Last month, the UK-listed enterprise brought in large investments of \$2.5 million and became the top source of FDI in Myanmar in the past eight months, DICA's statistics indicated.

Japan stood as the sec-

ond-largest investors this FY with an estimated capital of \$518.76 million from three projects, followed by Singapore investing \$428.336 million in Myanmar.

Japan focuses more on responsible businesses. Therefore, it thoughtfully considers and learns before they make investments, DICA stated.

Additionally, Thilawa Special Economic Zone is a symbol of development in Japan's investments in Myanmar. Besides, Japan is a development partner of Myanmar.

Japan has been providing comprehensive support in developing the infrastructure including railway, road, and research in Myanmar through the Japan International Cooperation Agency.

Since 2016-2017FY, the FDI of over \$449.367 million has flowed into the Special Economic Zones (SEZs) from 15 Japanese businesses, under the Special Economic Zone Law.

Japan's investment in Myanmar stood at \$768.456 million in the last FY2019-2020, \$42.77 million in the 2018-2019FY, \$134.5 million in the 2018 mini-budget period (April-September), \$384 million in the 2017-2018FY, \$60 million in the 2016-2017FY and \$219.79 million in the 2015-2016FY, respectively, the DICA's data showed. - KK/GNLM

Thailand remains Myanmar's top trading partner among regional countries in H1

NEIGHBOURING Thailand is Myanmar's major trading partner, which accounts for US\$2.45 billion in the first half (October-March) of the current financial year 2020-2021, the statistics issued by the Central Statistical Organization under the Ministry of Planning and Finance indicated.

The ministry reported that exports surpassed imports in trade with Thailand, with exports reaching over \$1.55 billion and imports valued at over \$901 million.

Thailand has been Myanmar's largest trade partner among the regional countries, followed by Singapore and Malaysia.

Thailand accounted for 18.48 per cent of total trade in 2016-2017 FY with an estimated trade value of US\$4.6 billion, 19.17 pc in 2017-2018FY with a trade value of \$5.57 billion, 40.38 pc in 2018-2019FY with \$5.46 billion and over 40 pc in 2019-2020 FY with \$5.117 billion respectively. Exports of natural gas from the Taninthayi Region contributed to the enormous increase in border trade with Thailand in the previous years. Last year, corn exports to Thailand also rose significantly as well, the Ministry of Commerce stated.

Myanmar primarily exports natural gas, fishery products, coal, tin concentrate (SN 71.58 per cent), coconut (fresh and dry), beans, corns, bamboo shoots, sesame seeds, garment, footwear, plywood and veneer, broken rice and other commodities to Thailand. It imports capital goods such as machinery, raw industrial goods such as cement and fertilizers, and consumer goods such as cosmetics, edible vegetable oil and food products from the neighbouring country.

Myanmar is carrying out border trade with the neighbouring country Thailand through Tachilek, Myawady, Myeik, Mawtaung, Hteekhee, Kawthoung and Meisei border areas respectively. Among them, Myawady performed the largest trade in border trade

two or three feet apart and they are growing well without using fertilizer. The cultivated yams could be harvested in the next three years. Renew and ramp up action to address noncommunicable diseases

mid the COVID-19 response, opportunities to Aprevent, detect, control and treat NCDs must be fully harnessed

Noncommunicable diseases (NCDs) kill 41 million people globally every year, more than a third of them prematurely. The four major NCDs - cardiovascular diseases, cancer, chronic respiratory diseases and diabetes - account for over 80% of all premature NCD deaths, of which 85% occur in low- and middle-income countries, including in the WHO South-East Asia Region. Key NCD risk factors such as tobacco use, physical inactivity, harmful use of alcohol and unhealthy diets also contribute to and exacerbate mental health disorders, such as depression and anxiety. Amid the ongoing COVID-19 response, the time is ripe for all countries in the Region to accelerate action to prevent, detect and control NCDs, and bring treatment to everyone who needs it.

at higher risk of severe COV-ID-19-related illness and death. They are among several groups who have been particularly af-

fected by the pandemic, which has been marked by the interaction of SARS-CoV2 infection with a broad range of NCDs, which are themselves mediated by social and economic disadvantage. Amid ongoing waves of infection, WHO will continue to support countries in the Region to aggressively respond, while also enhancing health equity and main-People living with NCDs are taining essential health services, including for NCDs. High-impact innovations such as telemedicine, extended prescriptions, and door-step delivery of medicines must continue to be leveraged, and all at-risk groups actively encouraged to get vaccinated, in line with national deployment and vaccination plans.

The Region's progress against NCDs must not be halted, much less reversed. Since 2014, the Region has intensified action to prevent and control NCDs as a Flagship Priority. All countries continue to implement national multisectoral NCD action plans. Even amid the COVID-19 response, they remain committed to achieving the global 2025 and 2030 NCD targets. Most countries have developed national mental health policies, which must continue to be strengthened in the months and years to come. For the Region to protect and defend its many gains, and to catalyse more, several priorities require targeted attention.

First, taking full advantage of new initiatives. For example, in April, WHO launched its Global Diabetes Compact, which aims to ensure all people can access quality diabetes diagnostic tools, medicines and other medical products, without financial hardship. The Region has in recent years made significant progress on increasing access to quali ty-assured insulin, however, barriers persist, especially for the most vulnerable. In the coming months, the Compact is set to drive innovations in technology and pricing, which all countries in the Region must harness and apply to maximum effect.

Second, implementing "best buy" interventions that we know work. Evidence shows that by increasing taxation of unhealthy products, policymakers can drive down consumption, enhance overall health, and reduce individual and public health costs. In the process, they will increase fiscal revenue, which if allocated towards health, will help achieve a health and economic recovery from COVID-19 that is more equitable, resilient and sustainable. Restrictions on the marketing of unhealthy products are likewise essential, however must cover surrogate advertising, which aims to cultivate brand loyalty among the young.

Third, strengthening action to address NCDs within health systems, especially on the frontlines. The Region's 2016 Colombo Declaration emphasizes the need for all people to have access to

Because, American Continent extends too long from the extreme north towards the extreme south containing countries of the North, South of Central America voyaging in a lengthy way is a sheer waste of time and very costly and; uneconomical for the mercantile world. Panama is in the area of the

World powers in new push for Libya peace

WORLD powers gathered Wednesday in Berlin to seek lasting peace in Libya by ensuring the conflict-wracked North African country stays firmly on the path towards general elections on December 24.

Representatives of Libya's interim government will join US Secretary of State Antony Blinken as well as the foreign ministers of France, Turkey and Egypt at the UN-sponsored talks.

Russia's Sergei Lavrov will be absent, but deputy foreign minister Sergey Vershinin will attend in his place.

The efforts to end a dec-

ade-long spiral of violence in Libya are the second round held in Berlin, after the first attended by the presidents of Turkey, Russia and France in January 2020, before the pandemic.

Ahead of the talks, host German Foreign Minister Heiko Maas reminded participants of pledges made in 2020 for an end to international meddling and for foreign militants or troops to withdraw. "For the further stabilisation of the country, it is crucial that elections take place as planned and that foreign fighters and mercenaries really do leave Libya," Maas said ahead

of the gathering. "It is our aim to support the Libyan transitional government so that it can take the fate of the country into its own hands."

The United Nations has estimated that 20,000 foreign fighters and mercenaries are still on Libya's territory. And that presence is seen as a threat to the UNbacked transition leading to the elections.— AFP ■

World Bank lowers Malaysia's growth projection to 4.5 pct

THE World Bank on Wednesday revised down Malaysia's growth projection this year to 4.5 per cent from 6 per cent earlier, as the ongoing pandemic and movement restrictions will affect Malaysia's economy in the near term.

The World Bank said in its latest report that the revision reflects the slower pathway towards suppression of the pandemic and the slower-than-expected vaccine rollout.

"The trajectory and pace of growth will depend on the duration and severity of movement restrictions, the containment of the pandemic, and the pace of the vaccine rollout," it said.

The movement restrictions coupled with increased precautionary behaviour and subdued wage growth are expected to affect household spending activity, but with recovering global demand, export growth is likely to gain momentum, it said.

Given the acceleration of advanced nations' vaccination programmes and the reopening of their economies, global demand is expected to continue to recover in the near term, it added.

"The growth rate for Malaysia's exports of goods and services is projected to rebound to 13.1 per cent in 2021 (2020: -8.9 per cent) as global demand picks up," it said. – AFP

ARGENTINA said Tuesday it had reached an agreement with the Paris Club of creditor countries to avoid defaulting on a loan repay-

Five years on, Brexit bedevils pandemic-hit UK

FIVE years on from Britain's shock decision to quit the European Union, the wounds opened by Brexit have yet to heal, and analysts say its far-reaching changes are only just beginning.

The coronavirus pandemic has masked the economic dislocation caused by the referendum verdict, which backed severing five decades of integration with the European mainland.

British trade with the EU collapsed at the start of the year, when Brexit's full effects came into force, but against a backdrop of much deeper damage wrought by Covid-19. And the benefits promised by Prime Minister Boris Johnson for a newly invigorated "Global Britain" remain a work in progress, while the country's very cohesion is at risk from an emboldened nationalist movement in pro-EU Scotland.

Johnson was upbeat on the effects of Brexit in comments marking the anniversary of the 23 June 2016 referendum. "Now as we recover from this pandemic, we will seize the true potential of our regained sovereignty to unite and level up our whole United Kingdom," the prime minister said.

"With control over our regulations and subsidies, and with freeports driving new investment, we will spur innovation, jobs and renewal across every part of our country," he added. "This Government got Brexit done and we've already reclaimed our money, laws, borders and waters."

'Slow puncture'

Johnson also hailed trade deals negotiated with the EU and 68 other countries as well as the start of negotiations to join the \$9 trillion Pacific trade area. — AFP ■

"We have reached an understanding with the Paris Club" to avoid defaulting on July 31, when a grace period was to expire for the repayment of a final tranche of debt of about \$2.4 billion, Economy Minister Martin Guzman told reporters.

Instead of \$2.4 billion, Argentina will repay \$430 million in the short term, followed by the rest later.

The \$2.4 billion was the last repayment on debt renegotiated with the Paris Club in 2014.

Paying the amount, said Guzman, "would have been a blow to international reserves, (and) would have generated more exchange rate instability and more macroeconomic instability."

A default, on the other hand, would have similarly been a hard blow to the economy.—AFP

Turkmenistan capital tops Hong Kong as world's costliest: survey

TURKMENISTAN'S capital Ashgabat has overtaken Hong Kong as the world's most expensive city for foreign workers, a survey showed on Tuesday.

Beirut jumped to third place in the 2021 Mercer survey from 45th a year earlier owing to a "severe and extensive economic depression" resulting from multiple crises, including the country's financial trouble, Covid-19 and a deadly blast in the Lebanese port. Ashgabat rose from second in the previous survey to the first spot due to "high local inflation", Mercer France global mobility practice leader Jean-Philippe

Sarra told AFP.

Turkmenistan is almost wholly dependent on natural gas exports and has struggled to recover from the global energy price slump in 2014 that battered the local manat currency and plunged many citizens into poverty.—AFP

Sydney residents banned from leaving city as coronavirus cluster grows

SYDNEYSIDERS were largely banned from leaving the city Wednesday as Australian authorities rushed to stop a growing outbreak of the highly contagious Delta Covid-19 variant from spreading to other regions.

More than 30 people have been diagnosed with Covid-19 since the cluster emerged in the city's Bondi Beach area last week, the latest in a string of flareups that highlight Australia's difficulty in extinguishing outbreaks.

New South Wales state Premier Gladys Berejiklian announced new restrictions that will

apply for the next week, including the immediate ban on non-essential travel out of Sydney and limits on social gatherings.

A "very huge proportion" of Sydney's five million residents are subject to the travel ban, which applies to seven local government areas where Covid-19 cases have been detected, she said.

UK borrowing sinks in May on easing lockdown: data

UK government borrowing sank in May as the easing Covid lockdown boosted the

economy and tax revenues, but remains elevated on costly pandemic support, official data

showed Tuesday. Public sector net borrowing, the state's preferred meas-

ure of the deficit, slid to £24.3 billion (\$33.7 billion, 28.3 billion euros) last month, the Office for National Statistics (ONS) said in a statement.

However, that was still the second highest May level since records began after £43.8 billion in May 2020 at the height of the pandemic.

The ONS also revised down borrowing for the financial year to the end of March to £299.2 billion -- but this remained the highest level since World War II.

The public purse has been plagued by emergency Covid measures, in particular a furlough scheme which has paid the bulk of private sector wages for millions of workers across the UK during the crisis.

However, the economy is regaining its footing thanks to a phased reopening.-AFP



Emirates to fly from India again after ban over virus

AVIATION giant Emirates said Sunday it will resume flights from India from next week, after Dubai lifted a ban imposed when coronavirus cases spiked.

The United Arab Emirates, which includes Dubai, suspended all flights from India -- including for transit passengers -- in April in an effort to curb the spread of the novel coronavirus.

"We will resume carrying passengers from South Africa, Nigeria and India... from June 23," Emirates said in a statement.

Dubai said on Saturday that only passengers from India "with a valid residence visa and who have received two doses of a UAE-approved vaccine" would be allowed to travel to the emirate. They would also need a negative PCR test taken within 48 hours of departure, a rapid test four hours before departure, and another PCR test on arrival with "institutional quarantine" required until the results are received.-AFP

Chaotic situation reported at Bogota's vaccination sites

IN Bogota, Colombia, vaccinations have continued to take place throughout the severe inclement weather. However, vaccine seekers are calling on authorities to do more to safeguard them while they queue up for vaccinations given the terrible weather, but also to do more to organize vaccinations more clearly to avoid hundreds of people wasting their time queuing up only to be turned back. "They've turned back a lot of people because they arrive too late, so it's better to come early", says Octavio Osorio, who came for a vaccine. "I'm someone who gets very sick a lot and I don't think it's good for people to play with other people's health. I have a chronic bone sickness and it's raining and yet I'm still here early in the day, and still they tell me that I have to schedule an appointment for my second shot? That's outrageous", said Floralba Arevalo, who also queued.—AFP

Bitcoin drops under \$30,000 for first time in five months

Bitcoin fell underneath \$30,000 (€25,204) on Tuesday for the first time in five months, hit by concerns over China's ongoing crackdown on the world's most popular cryptocurrency.

At about 1230 GMT, bitcoin sank as low as \$29,334 (€24,645), a level last seen in January, with analysts citing Chinese efforts to curb trading and mining operations.

The unit later stood at \$29,590 (€24,860), down 9.25 per cent in value.

"Concerns mount over China's ongoing clampdown and fears that widespread acceptance of bitcoin and other digital currencies will be delayed because of concerns about their environmental impact," said analyst Fawad Razaqzada at trading site ThinkMarkets.

Bitcoin also faces a green backlash because mining often uses electricity produced from fossil fuels, he noted. –AFP

Argentina progressively resumes beef exports

ARGENTINA'S government on Tuesday announced the progressive resumption of beef exports suspended a month ago in a bid to moderate skyrocketing prices at home. Exports were authorized up to a maximum of 50 per cent of 2020's average monthly volumes, government ministers told reporters in Buenos Aires. The country is the world's fourth-largest beef exporter as well as one of its biggest consumers per capita, and revenues from the sector are vital to the country's economy. It exported some 819,000 tonnes of beef and cow leather worth \$3.37 billion in 2020 -- a 16.5-per cent drop from 2019 -- primarily to China, Germany and Israel, according to the IN-DEC statistics institute. "The 50 per cent quota will remain in place until August 31 and depending on the results, we will consider how to adapt it," said Minister of Productive Development Matias Kulfas.-APF

A Jaguar, a Lexus, a Cor-

vette Stingray, and dozens of top-end German sedans and Japanese SUVs were crushed at a customs yard in the capital Manila. The vehicles were seized after they were smuggled in, authorities said.

A total of 30 vehicles worth a combined 61.6 million pesos (\$1.2 million) were scrapped in Manila and two other cities on Duterte's orders

The president has made fighting corruption and illegal drugs the cornerstones of his six-year term.

"Reduce them to scrap metal," Duterte said in a speech to customs employees after the event.

Normally, seized smuggled vehicles are impounded and

then auctioned with the government taking the proceeds.

"I will pay for them, no problem," Duterte said.

The Bureau of Customs collects duties on imports and is one of the state's key revenue-generating agencies. It consistently tops independent surveys as one of the country's most corrupt government agencies.

Customs commissioner Isidro Lapena said in a speech at the ceremony that he has reassigned 691 of his some 7,000 employees since he took office in August last year.

Two other employees were dismissed and 16 others have been suspended over alleged illegal activity, he added.—AFP

Japan to work with U.S., others to improve process for AI patents

JAPAN will cooperate with the United States, most European nations, China and South Korea to improve application and examination procedures for patents related to artificial intelligence and new technologies, sources close to the matter said Tuesday.

The move, which involves patent offices of the five parties, aims to encourage inventors to protect their intellectual property rights in a field where demand is growing.

According to the Japan Patent Office, applications filed in the five economies accounted for around 85 per cent of the roughly 3.22 million patent applications filed worldwide in 2019.

Commissioners of the five agencies, who have been meeting since 2007, will set out a schedule at their next meeting to be held online Wednesday to create a collaborative system for examining AI-related patents. As requirements for the same patent application vary, making each area's standards easier to compare is expected to simplify the process for applicants.

Wednesday's meeting will also affirm each agency's commitment to promoting online procedures, which have become increasingly needed amid the coronavirus pandemic.

The patent offices will also report on their measures to achieve sustainable development goals set by the United Nations, and convey their dedication to solving social issues through technological innovations spurred by intellectual property.— Kyodo

EU launches antitrust probe against Google over online ads

THE EU launched a wide-ranging antitrust probe against Google on Tuesday over concerns that it is forcing out rivals in the lucrative online advertisrival online advertising services to compete" in display ad technology, said EU competition chief Margrethe Vestager.

At issue is Google's largely

technologies AdX and Doubleclick, but will also look at other aspects of its business.

Crucially, the probe will also look into Google's announced

plans to prohibit the placement of third party "cookies" on its Chrome browser, a move that has angered some publishers and advertisers. — AFP ■

The investigation will "assess whether Google has violated EU competition rules by favouring its own online display advertising technology services", a statement said.

The probe narrows in on an important slice of Google's business model where over 80 per cent of the giant's revenue last year came from advertising, or \$147 billion (€124bn).

"We are concerned that Google has made it harder for unnoticed, but highly dominant

technologies that serve as an intermediary or broker between advertisers and publishers online.

The business was also at the heart of a recent case in France – brought by News Corp, French daily Le Figaro and Belgium's Groupe Rossel – that saw Google fined &220 million (&267million). As in France, the EU will try to determine whether Google gave preferential treatment to its own ad inventory

Fukui nuclear unit becomes Japan's 1st to operate beyond 40-yr limit

AN aging nuclear reactor in central Japan's Fukui Prefecture was restarted Wednesday, becoming the country's first nuclear unit to operate beyond the government-mandated 40year service period introduced under new rules set after the 2011 Fukushima disaster.

Kansai Electric Power Co. said it began operating the No. 3 unit at the Mihama plant for the first time in about 10 years, after completing final inspections. The reactor had stopped operations after the crisis at the Fukushima Daiichi plant triggered by a massive earthquake and tsunami.

However, the Mihama No. 3 unit, which began commercial operation in 1976, is expected to be halted in about four months before the Oct. 25 deadline for the implementation of counterterrorism measures which Kansai Electric is unlikely to meet, according to the company.

The Nuclear Regulation Authority granted approval in 2016 for the reactor to operate beyond the 40-year limit for an additional period of up to 20 years, after screening the

company's safety measures for the unit.

In February, Mihama Mayor Hideki Toshima also gave his consent for the resumption, followed by approval from Fukui. Gov. Tatsuji Sugimoto on April 28, despite increasing worries about aging nuclear reactors among local residents.

On Monday, a group of nine people in Fukui as well as neighbouring Kyoto and Shiga prefectures filed a lawsuit with the Osaka District Court, seeking suspension of the Mihama No. 3 reactor. — Kyodo 🔳

Lifting off? Sudden travel surge tests US airlines

US airlines are scrambling to ramp back up to meet soaring travel demand that has transformed America's airports from cavernous to crowded almost overnight.

The surge in pent-up demand is exposing immediate staffing shortfalls in the aviation workforce, as well as medium-term labour challenges following an exodus of experienced workers during the downturn.

The issues came to a head over the weekend when American Airlines canceled 400 flights and said it would cut one percent of its flights in July to better manage an "incredibly quick ramp-up of customer demand." While American was more aggressive than rivals in adding capacity, all major carriers face challenges in the sudden rush, analysts said. "They've had so many planes just waiting in hangars or runways that weren't being used... there's a lot of maintenance," said Ian Gendler, executive director of research at Value Line. "It's not an overnight thing."

The surge in bookings and the economic recovery are "fantastic things for the airlines, but they have to execute," Gendler said.

Training needed

Activity at US airports bottomed out in April 2020, when there were several days with fewer than 100,000 passengers nationwide, US data show. Volumes recovered somewhat from that nadir over the next months, but airports remained strikingly low-trafficked until vaccinations became widespread.—AFP ■

Welcome to border town of **Mong Yu** in Shan State (East)

By Ko Ko Naing (IPRD) Translated by EPPA S URROUNDED by Shan mountain ranges and old fortifications, Mong Yu, a border town in Tachilek district, eastern Shan State, is located on the bank of Namlwe creek. The town is naturally beautiful with ancient historical pagodas, monasteries, and Shan traditional festivals all year round. Mong Yu border town is a favourite for waterfall lovers and those who want to visit the other side of the friendship bridge between two nations.

The history of Mong Yu town started during the Buddha time when the town was covered by forests. It is believed that the town was preordained by the Buddha while He took a rest at the place of Hokhone monastery.

Mong Yu is located at 100 ° 32'E and 100° 33'E. It is located between 21° 29'N and 21° 30'N and covers an area of 1,120.938 square miles. It is 46 miles wide from east to west and 19 miles wide from south to north. With numerous mountains and hills, the town has a few flat plains and is neighbour to Laos in the east, Kengtung in the west, Mongyawng and Tachilek townships in the south and China in the north.

There are two creeks, Namlwe creek which flows





from north to south and Namphun creek which flows from west to east. Due to the temperate climate, the vegetation such as locally called Mitekaw, Sakawar, Seik Nangyi, Ohn Tone, chestnut, Thit Te, Thit Ae and pine trees are naturally grown, and Cassia siamea plant which is used as a firewood.

Although the 18-mile road Mongyawng- Mong Yu road was on earthern road that took the travellers an overnight to get to the town in the rainy season, the public construction company has expanded and upgraded the road to an asphalt road with a concrete bridge.

Village farmers in the town mainly grew the paddy in the past and they have grown maize, various peas, sesame, peanut, sugarcane, rubber, tea, coffee, coconut, banana and other vegetables and fruits now. Although they did breeding of cow, buffalo, pig, duck and fish manageably, not commercially, to use the cows and buffalo in farming, they now raise them for donation only.

Most of the villagers in Mong Yu town are Bamar, Shan, Lwai and Akha ethnic nationalities, with a few Mon, Chin and Rakhine people. The population has increased to an average of 34,461. The Shan people in Mong Yu live are ethnic people who make a living by honestly selling farm and farm groceries at home.

As Mong Yu is the closest city to the neighbouring country of the People's Republic of China, it has the best border trade, and the village has been developed with its main engagement in trade and agriculture.

Thet Htar Thuzar in good shape to enter Tokyo Olympic

ACCORDING to figures released by the World Badminton Federation on 15 June, Myanmar badminton star player Thet Htar Thuzar is ranked 29th in the women's individual category to advance to the Tokyo Olympics.

The Badminton World Federation (BWF) will approve the qualifiers for the Olympics and will allow 38 athletes to compete in the individual event and thus Thet Htar is in good condition to enter the Olympics.

According to the rules of the tournament, 34 players will be selected according to the rankings. Of the remaining four, one will be a host from Japan and three from the Asian Olympic

Council.

Once the BWF has selected the four athletes, they will be sent to the relevant Olympic Committees for approval of the Tokyo Olympics.

According to the BWF, those with a rating of 1 to 16 must have a maximum of two candidates per country. Starting from 17th place, only one player per country will be allowed to compete, and thus some players outside of 34th place can expect it, BWF officials said.

The BWF had previously set a time limit for the Olympics from April 2019 to May 2020, but the Olympics were postponed due to the pandemic situation.

The BWF has extended the qualifiers period from 4 January to 13 June this year, but most competitions have been cancelled due to the epidemic.

Therefore, the BWF will de-

termine the qualifying criteria for the Olympics based on the results of the competitions from April 2019 to March 2020. The results are calculated from some of the competitions held this year. If Thet Htar Thuzar qualifies for the upcoming Tokyo Olympics, it would be the very first Myanmar badminton player to enter the Olympic tourney. — GNLM

England's Sterling undaunted by heavyweight clash in last 16 of Euro 2020

RAHEEM Sterling said England were braced for a heavyweight last-16 clash at Euro 2020 after topping Group D with a 1-0 win against the Czech Republic on Tuesday. The victory at Wembley means England are likely to face either world champions France, holders Portugal or Germany in the knockout phase. England were heavily criticized for their toothless performance in the 0-0 draw against Scotland but found more of an attacking edge in their final group game.

Spain put five past Slovakia to book Croatia showdown

SPAIN finally have lift-off at Euro 2020 after a 5-0 hammering of Slovakia on Wednesday sent them through as runners-up in Group E, with Croatia their opponents in the last 16 on Monday.

Luis Enrique described his team as a bottle of cava about to be popped and they certainly exploded in Seville, where a scoring frenzy felt cathartic and could yet prove transformative for their chances in the knock-out stages.

Spain were even about to progress as group winners until Viktor Claesson scored in the 94th minute against Poland to secure top spot for Sweden. Slovakia finish third and are out.

After two tension-filled draws against Sweden and Poland, Spain were left scrambling to qualify, with Luis Enrique admitting he would have taken any position in the group as long as it meant going through.

But Spain ran riot at La Cartuja, their early anxiety heightened by Alvaro Morata's missed penalty and then quickly eased by two dreadful mistakes by Slovakia's goalkeeper Martin Dubravka.

The first was an own goal that will surely go down as one of the strangest moments of the tournament before another Dubravka error allowed Aymeric Laporte to head in. — AFP

Claesson hits last-gasp winner for Sweden against Poland

VIKTOR Claesson scored an injury-time winner as Sweden beat Poland 3-2 in Saint Petersburg on Wednesday to clinch top spot in Group E and knock their opponents out of Euro 2020. The RB Leipzig attacker collected a loose ball just outside the Poland area after Kamil Glik flattened Alexander Isak, riding a challenge from Kamil Jozwiak before firing into the far corner. — AFP
