THE Tatmadaw has ceased the fire until the end of 2022, leading to the enduring peace that the entire people are longing for.

The State Administration Council Chairman Prime Minister Commander-in-Chief of Defence Services said that the upcoming 4 January 2023 is Diamond Jubilee Independence Day of the Republic of the Union of Myanmar. Measures will be conducted to end the armed conflicts across the nation. Moreover, leaders of ethnic armed organizations are also invited to discuss frankly in-person to effectively and practically conduct peace processes.

During the invitation period for peace talks and in the progress of talks, ethnic armed organizations should not make activities that can affect peace, such as recruitment, operations, land expansion and attacks on bases and headquarters of security members who are serving duties for security and the rule of law. If they do so, the Tatmadaw will take necessary actions in response to the attacks.

First day of 57th Myanma Gems Emporium held in Nay Pyi Taw

THE 1st day of the 57th Myanma Gems Emporium was held yesterday at the Mani Yadana Jade Hall in Nay Pyi Taw.

Starting in the morning, local and foreign jewellers were able to see pieces of pearl and jade lots on display inside the Mani Yadana Jade Hall. They also enjoyed the jade lots on display outside the hall, and

In addition, gems and jewellery shops are opened in the Mani Yadana Jade Hall and are alive with shoppers.

The gems emporiums have been held successfully since 1964 to generate foreign income, and this 57th gems emporium will be held from 22 and 28 April. – Myo Satt Thit/ GNLM

proposed prices were put in tender boxes.

At the emporium, 2,000 jade lots, 330 pearl lots, and 120 gems lots, owned by the state, joint-venture companies and private companies, will be sold through an open tender system.

The pearl lots will be sold on 23 and 24 April; Gems lots will be sold on 22 and 24 April and Jade lots will be sold on 26 and 28 April.

In this emporium, pieces

The largest jade stone was cut from the 308-tonne jade rock excavated from block-2 being operated in mutual interest with the State in Metlinchaung mine in Lonkhin-Phakant gem land. It is a quality utility jade stone, and its reserve price is calculated as more than 5 million euros.

The emporium will be held from 22 to 28 April with the display of 330 lots of pearl, 120 lots of gems and 2,000 lots of jade to local and foreign gem merchants through open tender under the rules and reg-



ulations. The showrooms are opened in the hall to showcase finished jewellery items of private businesspersons for sale.

The reserve prices are set for lots of pearls in US dollars. Foreign gem merchants need to pay US dollars or yuan for the purchase of items, and local gem merchants US dollar, yuan and kyat. Floor prices are also set for lots of gems and jade in euro. Gem merchants may pay US dollars, euro, and yuan to purchase these items.

The Senior General inspected the improvement of the jade park and attended to





the needs for the reports of Union Minister U Khin Maung Yi for Natural Resources and Environmental Conservation and officials.

The jade park, located on 8.26 acres of land, was inaugurated in 2010. A total of 5,117 pieces of uncut jade stones and 14,252 other uncut stones are allotted in the park. In accord with the guidance of the Senior General, the park has been upgraded as of February 2022. — MNA

Union Ministers U Maung Maung Ohn, U Aung Naing Oo give virtual interview to foreign news agencies

MINISTERS U Maung Maung Ohn and U Aung Naing Oo replied to questions raised by reporters from AP, Reuters, the South China Morning Post, Straits Times, China Central Television (CCTV), the People's Daily and Xinhua via videoconferencing on 21 April.

In his opening speech, Union Minister U Maung Maung Ohn expressed his delightedness to meet them and spoke words of thanks for his interest in the affairs of Myanmar.

He said he would give interview along with Union Minister U Aung Naing Oo of the Ministry of Investment and Foreign Economic Relations. The statement would be released after 12:15 pm on 21 April. Generally, Myanmar receives significant development in the energy and economic sectors. Oil and gas prices, triggered by the Russia-Ukraine conflict, have risen sharply in the world today. The country faced poor development infrastructure, decreasing Myanmar kyat prices, financial issues and other impacts due to the attacks on power grids by the terrorists.

Nowadays, it needs to resolve the energy to ensure the stability of the State. At the same time, the new economic sanctions against Myanmar have been imposed recently. Most media also highlighted that some foreign oil and gas companies left Myanmar. Therefore, the two Union Ministers will reply to the questions during this interview.

Then, Union Minister U Aung Naing Oo expressed his for meeting with the media and said he would discuss the current economic status of Myanmar and the energy sector, especially the exchange rate that the media are most interested in. The current government faces different challenges, not like previous governments. Economic sanctions and unstable conditions in some regions and states affect the economy.

However, the COVID-19 pandemic is controlled to a certain extent. The state economy faced delays in economic growth due to the pandemic, and now it is slower than before.

The current government is focusing on providing the country with the electricity it currently needs. It is working to stabilize the country's economy while the energy sector is a priority. It also tries to implement the projects in the energy sector as soon as possible. New continue to strive for economic stability and development in Myanmar. He also thanked the media for their participation.

The reporter from the Straits Times said that it was known that new investors are being sought in the oil and natural gas sector. Currently, such a press release is not suitable for investors. The reporter asked: why does it release such information? In reply to the question, Union Minister U Aung Naing Oo said the instability of the local currency kyat exchange rate harms some businesses. So, such a statement was released on 4 April as part of the initial pace in order to stabilize the currency exchange rate. The government has formed the foreign exchange supervisory committee. After releasing the statement, it much affected the businesses but triggered criticisms. Hence, the committee supervises the release of information and the foreign currency exchange process. The committee holds meetings three times a week to discuss currency exchange in the country and seek answers for problems in coordination

led by UMFCCI the other day and helped them seek ways to solve their problems. After the Central Bank of Myanmar has issued its announcement, efforts are being made to ease the restrictions for local businesses as much as possible. The committee held the meetings three times last week to adopt decisions for exemption of some foreign-invested businesses, especially companies in special economic zones, from the announcement of the Central Bank of Myanmar.

Moreover, a decision was adopted to grant the exemption for the foreign-invested businesspersons allowed by the Myanmar Investment Commission from the announcement of CBM. So also, foreign embassies, INGOs and NGOs will enjoy the exemption from the notification. As those from the committee understand that the announcement may have some harmful impacts, they solve the best solution by doing the daily analysis. As now is time for the start of the reform period, efforts are being made to arrange the best solution for all-inclusive persons.

In reply to the question of the Straits Times about whether the exemption is for new investors, current investors or not and will it need to apply for exemption and how to do so, Union Minister U Aung Naing Oo said it includes new foreign investors and current investors. Emphasis is placed on protecting these enterprises against extra impacts triggered by the announcement of the CBM. The supervisory committee always conducts the analyses during the reform process to have progress and success.

The reporter from the Straits Times asked: will the announcement be persistent for a period? Union Minister U Aung Naing Oo replied that it depends on the situation of progress. It was an announcement of CBM, and the committee formed by the government can give guarantees for exemption depending on the situation. Depending on the stability of the Myanmar currency kyat exchange rate, the prohibitions may be lifted.

With regard to the question of stability of currency exchange rate, Union Minister U Aung Naing Oo said in reviewing the instability of currency exchange rate, the exchange rate of US dollar was set as K1,350 per dollar in February 2021. Last month, the currency exchange rate reached K2,000-K2,050 per dollar. It can be seen that the currency exchange rate was very high. Hence, the CBM released the announcement for stabilizing the currency exchange rate.

The reporter from the AP news agency asked whether the news on signing the agreement with the company of Finland for the implementation of two power plants based on natural gas and solar power is correct or not and asked about the performance of energy projects with China. are many solar power projects. Some of them are to be launched, and some are under construction. The Ministry of **Electricity and Energy signed** the agreements on these projects. The majority of projects are located in central Myanmar, and there are 13 solar power electrification projects. The medium-scale hydropower projects will be implemented to electrify the country at full capacity. Investors from China submitted proposals for some projects in the previous government eras. But the meetings are still in progress. He hoped that the Ministry of **Electricity and Energy would** approve the implementation of the projects.


One more question was raised regarding the departure of LNG projects and energy companies. Union Minister U Aung Naing Oo said that it is right that LNG projects were suspended for the unprecedented high prices. They were stopped for no cost-effectiveness in some previous months. But a company submitted its offer to the government for putting an investment in MIC for an LNG project. It is expected that the MIC will approve it in the future. Electricity for foreign-invested projects will be taken from LNG, and the projects will go on. If the prices are down, the suspended LNG power plants will resume operations. There is no problem for the departure of energy companies such as Petronas. And remaining share-holders will take positions under the agreement of rules for operating the works. Hence, oil and natural gas projects will still be operated.



exemption from the currency exchange rate notification. He said embassies from Thailand, Singapore and Japan, in addition to the US and other western countries operating the invested works in Myanmar, requested to take the exemption for their companies from the announcement. The foreign exchange supervisory committee held the meeting. It adopted three decisions for immunity for all embassies to Myanmar and all UN agencies, their companies which have invested in the special economic zones, and all MIC approved foreign-invested businesses. For instance, as PTT is an invested work approved by MIC, it will have the chance of exemption.

As Myanmar wishes investment, it does not have the purpose of harming the invested works. Hence, the MIC approved works, and the works operated at Thilawa SEZ will have the exemption.

Union Minister U Aung Naing Oo also replied to the question about the Myanmar-India direct payment process, saying that both sides hold meetings. In contrast, the CBM will continuously take responsibility for the coordination sector. He also answered the question of whether the lessening of electricity is based on the high price of LNG and the blowing up of terrorists on national grids or not and how to take action. He said the high LNG price is one of the



Regarding the question on the currency exchange rate and export items, Union Minister U Aung Naing Oo said exporters are difficult in foreign exchange transactions and Myanmar kyat and taking out Myanmar kyat from banks. Due to the instability of the currency exchange rate, they are difficult to operate their businesses. Hence, the CBM set a rate for ensuring the smooth process of these businesses.

But some exporters committed criticism. Accordingly,

To ensure a smooth process, the standard operating procedures-SOP will be released this week. If so, they will do their businesses smoothly.

In reply to the questions raised by AP News Agency: Does Myanmar face a shortage of natural gas or fuel due to the withdrawal of foreign companies to end a joint venture with Myanmar? How obvious is the problem? How will the State Administration Council manage it? Union Minister U Maung Maung Ohn said some foreign investors ended the joint venture with Myanmar and the country currently faces a shortage of natural gas and fuel. The rumour spreading on a social network that there is a fuel shortage in the Thilawa oil storage tank terminal is false information. The country's fuel storage tanks due to the Thingyan holidays.


There would be no shortage of fuel stocks. The State Administration Council arranges to make a Production Sharing Contract-PSC with local/foreign oil companies to explore oil and gas from 21 vacant onshore and 21 offshore blocks, and the international bids are also invited with the permission of SAC.

The offshore gas drilling projects are being conducted by making PSC contracts with foreign oil companies such as Yadana, Yedagun, Shwe and Zawtika projects.

The Yadana gas field produced 21990.90 million cubic feet in December 2021 and transmitted to local and foreign countries during the Partial Shutdown period. The production/transmission of gas was suspended between 31 December 2021 and 2 January 2022. It currently transmits to Thailand as usual.

The Yedagun gas field daily exports to Thailand via 24 inches pipelines starting in 2000. The Shwe gas field in the Rakhine offshore basin has transmitted gas to China since July 2013, and the project will be ended in 2043.

The field yielded 16,092.99 million cubic feet in December 2021. The Zawtika project in the Gulf of Mottama has been



Concerning the continuous implementation of the project worth US\$2.4 billion, Union Minister U Aung Naing Oo said that as the MIC has approved the implementation of the project in Metlinchaing of Ayeyawady Region, the work process will go ahead. It is a heavy energy project.

As you know, the economic status has declined worldwide due to the COVID-19 pandemic, and tourism is one of the most affected sectors.

The tourism industry earns foreign income for the country, and it is also a non-smoke industry, especially it creates various job opportunities for the youths and women. The COVID-19 disease is significantly controlled, and it has already made arrangements by cooperating with the Ministry of Hotels and Tourism and the ministries concerned. Currently, the preparations are being completed for the international tourists.

Moreover, the tourism industry plays a vital role for the country, and it also profoundly invites all the countries and the neighbouring country, China. Since the beginning, the arrangements are also made to ensure proper tours by discussing with the consulate general in Mandalay.

Myanmar hosted more than 3.5 million tourists in 2019 (January to October), while there were only more than 800,000 in 2020 (January to October), and it saw a 75 per cent drop in tourist arrivals compared to the previous year, according to the data of the Ministry of Hotels and Tourism released in November 2020. — Htun Htun/GNLM

Construction ex-deputy minister U Kyaw Lin, ex-directors-general U Aung Myint Oo, U Ye Min Zaw, U Nay Aung Ye Myint receive sentences under Anti-Corruption Law

ANTI-CORRUPTION Commission inspected the complaints against the ex-deputy minister U Kyaw Lin.

According to inspections, U Kyaw Lin allowed ex-DG of the Highways Department U Aung Myint Oo to spend more than K562 million fund of maintenance without any exact budget data in repairing from the Monywa-Yargyi-Kalewa Road milepost (85/0) to Kyabin Village without following the Myanmar regulations on financial management issued by the Ministry of Planning and Finance Notification No 35/2017, while he was arranging to compete as Minkin Township Pvithu Hluttaw MP of Sagaing Region. Ex-irector-general of the Building Department U Nay Aung Ye Myint also constructed a new KyaukOh Bridge in Minkin Pyithu Hluttaw MP of Sagaing Region, he paid a visit to the monasteries in Minkin Township and donated cash and rice bags, and he accepted 68 rice bags from the ministry staff without paying the costs.

He got more than K36.3 million cash donations for the election campaign from his personal assistant, construction employees and companies and used it to buy party flags, shirts, caps and pamphlets. He received K60 million from two construction companies via his personal assistant. So he was charged under the Anti-Corruption Law Section 55 while ex-directors-general U Aung Myint Oo, U Ye Min Zaw and U Nay Aung Ye Myint under Anti-Corruption Law Section 55/63 at Mandalay Region High Court on 14 December 2021. The High Court accepted 10 cases from 26/2021 to 35/2021. The court sentenced ex-construction deputy minister U Kyaw Lin to 20 years in prison under Section 55 of Anti-Corruption Law, while the former director-general U Aung Myint Oo to 4 years in prison with labour under Section 55/63 of Anti-Corruption Law, ex-directors-general U Ye Min Zaw and U Nay Aung Ye Myint to two years each in prisons with labour under Section 55/63 of Anti-Corruption Law. - MNA

China makes high offer for Myanmar quality peanut

THE prices of Myanmar's quality peanuts exported to China touched a high of K3,800 per viss (a viss equals 1.6 kilogrammes) due to the domestic market's lack of supply and a hike in imported edible oil prices.

According to the Mandalay wholesale market, the price of peanuts remains on the upward trend following the strong domestic and foreign demand.

Tracking the price hike of imported palm oil and Kyat depreciation against the US dollar, the price of peanut oil rises tremendously to over K8,500 per viss and sesame oil fetches K8,000 per viss in the domestic market.

The consumer's behaviour has changed and turned to peanut oil due to the health bene-



Chilli prices jump to over K5,000 per viss

THE prices of chilli pepper (Shankyun and Moe Htaung varieties) fetch up to over K5,000 per viss (a viss equals 1.6 kilogrammes).

The prices increased from K4,500 to K5,400 per viss in early March. High input costs such as fertilizers and fuel oil for farming machinery are attributed to the price hike.

Cultivation of chilli varieties that China primarily demands costs K2.5 million per acre on its farmland and K2.5 million for rental management. The chilli can be harvested every 15 days for six months. Yield is estimated at 100 visses per acre in the early season. It

can produce 400-500 visses at maximum.

Traders shared their opinions that the prices of chilli pepper are expected to remain high on the back of solid demand following high input costs and fuel oil. Myanmar's chilli pepper is primarily conveyed to Thailand and China via cross-border trade channels, while it is shipped to Viet Nam through maritime trade.

It is commonly grown in Ayeyawady, Mandalay and Magway regions and Shan State.

The export varieties of fresh chilli are 692, 777, 999, Demon, Sunshine and Lucky One. - NN/GNLM

WHO 'strongly recommends' Pfizer's Covid pill

HE World Health Organization said Friday it "strongly recommended" Pfizer's Covid-19 antiviral pill Paxlovid for patients with milder forms of the disease who were still at a high risk of hospitalization.

However the UN agency warned it was "extremely concerned" that the inequality in access seen with Covid vaccines would again leave low- and middle-income countries "pushed to the end of the queue".

US pharma giant Pfizer's combination of nirmatrelvir and ritonavir was the "superior choice" of treatment for unvaccinated, elderly or immunocompromised people with Covid, the WHO's experts said in the BMJ medical journal.

For the same patients, the WHO also made a "conditional (weak) recommendation" of the antiviral drug remdesivir made by US biotech firm Gilead — which it had previously recommended

The WHO recommended Paxlovid over remdesivir, as well as over Merck's molnupiravir pill and monoclonal antibodies.

Pfizer's oral treatment prevents hospitalization more than the "available alternatives, has

fewer concerns with respects to harms than molnupiravir, and is easier to administer than intravenous remdesivir and antibodies," the WHO's experts said.

The new recommendation was based on the findings of two trials involving almost 3,100 pa-

tients which showed that Paxlovid reduced the risk of hospital admission by 85 per cent. The trials also "suggested no

important difference in mortality" and "little or no risk of adverse effects leading to drug discontinuation"

Towards Powerful Agriculture with food self-sufficiency and big exports of agricultural and marine products

WROTE last time that the SDGs have a great influence I on the policies of countries around the world. To achieve this, not only Japanese companies but also consumers felt social pressure and began to live a life conscious of SDGs. However, consumers do not understand everything about what their usual behaviour meets or violates the goals of the SDGs, and some people are confused. Little by little, attention has begun to be focused on the SDGs activities that can be done. That is self-sufficient in everyday food and also a counter-measure against climate change

Japan's energy self-sufficiency rate was 11.2 per cent, and its food self-sufficiency rate was 37 per cent last year. In many cases, feed such as hay and corn used as feed for domestically raised cattle is imported from the United States. The depreciation of the yen and the exchange rate has been added to this, leading to soaring is trying to promote the use of do-

feed prices. On 19 April 2022, it was 127.65 yen to the dollar, approaching 128.15 yen in 1988. It was the level 34 years ago. Some foodstuffs have begun to stagnate due to the inability to fly over Russia. The prices of foods made from wheat flour, cheese, pork and beef purchased from all over the world are 1.2 to 1.5 times higher than a year ago. mestic ingredients for domestic consumption. The concept of socalled "local production for local consumption" is the idea of consuming locally produced products locally. For example, locally produced rice is mixed and used with flour when making bread. Substitute "Shinshu salmon" (a farmed variety of rainbow trout and brown trout crossed using biotechnology, which does not lay eggs) rather than Norwegian salmon. The price is somewhat higher for domestic products, but it can provide a stable supply and increase the income of local farmers. If this is the case, even if the price rises somewhat, the people will be convinced that it will bring profits to the country. This is a sign of major changes in Japanese agriculture. This is because the appreciation of the yen has taken root due to the Plaza Accord in 1985, and imported agricultural products are cheaper

to eat on a daily basis, which is no longer profitable for local farmers.

Japan had maintained its self-sufficient agricultural policy as much as possible until the Plaza Accord (an agreement in 1985 that allowed the governments of five developed countries to adjust the exchange rate to correct the dollar's appreciation. Since then, the yen has become stronger). However, after the Plaza Accord, the government and the public were convinced that it was cheaper to import all food than to make it within a country. And farmers got ageing gradually.

Export high value-added agricultural and marine products

There is another high-value-added product carefully produced by agriculture, fisheries, and forestry workers in Japanese agriculture. For instance, the cultivation of sweet and fresh fruits

Patients must start taking their Paxlovid pills within five days of the onset of symptoms

- the course then lasts five days. Remdesivir can be taken within seven days of symptoms setting in, but it is administered intravenously over three days.

Questions about cost

The WHO called on Pfizer to "make its pricing and deals more transparent" for Paxlovid.

Lisa Hedman, the WHO's senior advisor on access to medicines, said that radio station NPR reported a full course of Paxlovid costs \$530 in the United States. Another source unconfirmed by WHO gave the price of \$250 in an upper-middle income country.

Remdesivir meanwhile costs \$520. Hedman said, but generic versions made by companies in India sell for \$53-\$64.

MIFER ex-minister charged under Anti-Corruption Law gets 9-year prison sentence

INSPECTION team of the Anti-Corruption Commission inspected complaints against Union ex-minister U Thaung Tun for Investment and Foreign Economic Relations under the Anti-Corruption Law.

According to the inspections, former chairman of the Myanmar Investment Commission and former Union minister U Thaung Tun rented 9.220 acres of land owned by the Consumer Affairs Department of the Ministry of Commerce located on Upper Pazundaung Road in Mingala Taungnyunt Township to his close private company for 30 years without calling tenders.

In such doing, he failed to follow the (land use permit notification relating to the Foreign Investment Law of the Republic of the Union of Myanmar) Notification No 39/2011 and the provisions to set the actual fee of state-owned land and building as per market prices of locations stated in the directive of the President's Office 3/2018, President's Office Directive 1/2017. So, it caused losses of more than \$0.13 million in rental fees per year and more than \$8.9 million in premium costs. He was prosecuted under Section 55 of the Anti-Corruption Law at Mandalay Region High Court on 20 December 2021.

He was found guilty, and the court sentenced him to nine years in prison with labour for three cases under Section 55 of the Anti-Corruption Law yesterday. — MNA

Shanghai's cautious awakening from Covid lockdown

WHEN Rui ventured out of her Shanghai apartment complex this week for the first time in 20 days, she found a city much altered since Covid-19 brought it to a standstill.

Barricaded storefronts and a makeshift hair salon in an empty swimming pool greeted her on a surreal foray into a Chinese commercial capital yawning back to life after lockdown.

Near her home, a few convenience stores had reopened, but blocked their entrances with stacks of shopping baskets and required customers to "stand outside and yell their orders", she told AFP. "Everyone has endured a lot during this time," she added.

The country's largest city ordered its entire population of 25 million to stay home last month, prompting scenes of panic buying and scuffles between residents and police.—AFP

S Korea reports 90,867 new COVID-19 cases

SOUTH Korea reported 90,867 new COVID-19 cases as of midnight Wednesday compared to 24 hours ago, raising the total number of infections to 16,674,045, the health authorities said Thursday. The daily caseload was down from 111,319 the previous day and far lower than 148,425 a week earlier, according to the Korea Disease Control and Prevention Agency (KDCA).

The health authorities believed that the daily caseload has been on the decline following the resurgence, driven by the spread of the highly contagious Omicron variant and its subvariant BA.2, which peaked in mid-March.

Among the new cases, 31 were imported from overseas, lifting the total to 31,666.—ANI

Thailand drops on-arrival Covid-19 tests for vaccinated visitors

THAILAND on Friday announced the end of compulsory Covid-19 tests for vaccinated travellers, as the country steps up efforts to revive its pandemic-thumped tourism industry.

Tight border restrictions helped the kingdom limit infections and deaths in 2020 but brought the tourism sector which had accounted for about a fifth of the country's economy — to its knees.

Thailand's Covid-19 taskforce said that from 1 May, fully vaccinated visitors would no longer have to take a test on arrival and wait in a hotel room for the result.

Taskforce spokesperson Taweesin Visanuyothin said authorities will now only require arrivals to show proof of vaccination and health insurance coverage of at least \$10,000.

"This will propel the economic (recovery) momentum since we are a country that relies quite heavily on tourism," said Prime Minister Prayut Chan-O-Cha.

Unvaccinated travellers will either need to show a negative test result taken within 72 hours of departure for Thailand or undergo five days of hotel quarantine and a test.

Earlier this month, Thailand dropped the requirement for mandatory pre-arrival Covid tests.

Hotels, resorts and tour operators have long been pushing for hassle-free entry rules in an effort to lure more foreign tourists.

The kingdom faces an uphill battle to bounce back from its worst economic performance since the 1997 Asian financial crisis. —AFP

'Long live the samba!': Brazil holds first carnival since Covid

AFTER two long years without its frenetic festival of sparkling sequins, sultry samba and towering floats, Rio de Janeiro will hold its famed carnival parades Friday for the first time since Covid-19 hit Brazil.

In what is sure to be a giant, glittering spectacle of pandemic catharsis, thousands of dancers and drummers will descend on the iconic beach city's "Sambadrome," reclaiming the carnival parade venue that was turned into a drive-through vaccination centre at the height of the health crisis.

The all-night parades by the city's top samba schools Friday and Saturday nights will be the first since February 2020, marking a turning point for hard-hit Brazil, where Covid-19 has claimed more than 660,000 lives, second only to the United States.—AFP

Possibility of new variants of Omicron in Delhi



"There is a possibility that new variants are emerging of the Omicron and they are being sequenced," said Dr Sarin.

Dr Sarin further said that there are eight variants of Omicron and amongst them, one is dominating.

"I think by today at our institute ILBS many samples have been sequenced and I think there are eight variants of which one is now dominating, we will come to know slowly," he told ANI. According to the sources to ANI, BA.2.12.1 is the variant which is a sibling of Omicron and is also responsible for the sudden surge in Delhi. Dr Sarin warned and said that people need to be careful. "I would suggest people should be very careful. There is a fear that children may get infected because they are not adequately vaccinated. People must wear masks," he added.--ANI

WITH the latest spike of more than 1000 COVID-19 cases in the national capital in a single day, the health experts believed that possibilities of new variants of the Omicron are emerging and they are being sequenced.

Delhi on Wednesday reported 1,009 fresh cases, the highest since 10 February, while the positivity rate is 5.70 per cent. The top expert believes that there are eight variants of Omicron and amongst them, one is dominating which can be held responsible for the surge in cases. Speaking to ANI, Dr SK Sarin, Director, Institute of Liver and Biliary Sciences (ILBS) said that there is a possibility of new variants of Omicron in Delhi while adding that the samples at the ILBS lab have been sequenced.

Revitalized Angkor Wat brings hope for Cambodia tourism recovery

AS dawn breaks, foreign tourists gather by the ancient towers of Cambodia's Angkor Wat, some of the lucky few to see the World Heritage Site with the crowds thin as the country recovers from the coronavirus.

Hopes are high that the temple complex, recently revitalized from repair work, will spearhead a recovery in tourism after the Southeast Asian nation began re-opening to travellers last November. A handful of overseas visitors are once again roaming the sacred site, with many calling it a unique opportunity.

"I think it's a once-in-a-lifetime experience to really see it with such few tourists," Belgian holidaymaker Marjan Colombie told AFP. "It's so different."

On previous visits to the

12th-century ruins she had been forced to jostle with others and endure long queues, she said.

Despite the huge economic cost for Cambodia, the pandemic has been a boon for renovations and conservation work at Angkor Wat.

The government agency that manages the UNESCO site says the shutdown allowed extra time and space for repair work, maintenance and gardening.

"Our temples could rest too," APSARA Authority spokesman Long Kosal said. Workers fixed crumbling towers and installed a water system to keep the grass green during the dry season. Local businesses in Siem Reap are now seeing an uptick in bookings after Covid-19 decimated tourism.— AFP

Argentina launches construction tender phase of mega gas pipeline

ARGENTINA on Thursday launched the construction tender phase for a gas pipeline megaproject that will eventually extend more than 1,000 kilometres (621 miles) from the southwest to north of Buenos Aires.

It is the largest natural gas project in Argentina in the last four decades and comes at a time when worldwide energy costs have shot up due to Russia's invasion of Ukraine.

The tender will be launched in May with a decision due in July.

The first stage of the project is due to cost \$1.5 billion, beginning in August and ending in 2024.

In an official ceremony near to the Vaca Muerta pipeline pro-

ject in Neuquen province, President Alberto Fernandez celebrated "the start of work to create the Nestor Kirchner pipeline."

The aim of the megaproject is to expand Argentina's fuel transport capacity for both domestic use and exports.

The first section of the pipeline, named after a late former president, will extend 558 kilometres from Neuquen province to Buenos Aires province.

A second section will extend another 467 kilometres northwards, reaching San Jeronimo.

In total, the new pipeline will increase Argentina's gas supply by more than 40 million cubic meters a day "supplying urban centres and industry in the centre and north of the country and giving the opportunity to export to

Cash-strapped Sri Lanka hit by record inflation

CRISIS-hit Sri Lanka's inflation hit a record high for the sixth consecutive month, official data showed on Friday as the government asked the IMF for an urgent bailout. The broad-based National Consumer Price Index (NCPI) rose 21.5 per cent year-on-year in March, more than four times the 5.1 per cent inflation of a year earlier. Food inflation in March stood at 29.5 per cent, according to the latest data from the Department of Census and Statistics. The figures are likely to rise further: the state-run oil company has subsequently raised the price of diesel, commonly used in public transport, by 64.2 per cent.—AFP

A European ban on Russian oil and gas imports could have unintended economic consequences, US Treasury Secretary Janet Yellen said Thursday.

The pace of economic integration in Asia has sustained despite COVID-19 inflicting heavy losses, according to the report titled "Asian Economic Outlook and Integration Progress" released by the BFA. –Xinhua

Russia fines Google for Ukraine videos

A Russian court on Thursday slapped a series of small fines on Google for failing to take down contentious YouTube videos about the Kremlin's military operation in Ukraine.

The Moscow court ordered the US tech behemoth to pay a total of 11 million roubles (\$135,000) for ignoring the state media regulator's orders to remove posts alleging heavy Russian losses in Ukraine.

One of the videos showed an alleged phone conversation between Russian soldiers and their relatives back home in which the troops

complained of numerous casualties in their ranks, Russian state news agencies reported.

Another alleged that soldiers who were trying to move back from Ukrainian counter-offensives were being shot by retreat-blocking Russian detachments, the state media reports said.

Google's ubiquitous video hosting service has been in Russia's crosshairs throughout its nearly two-month campaign in Ukraine.

The tech giant infuriated Russian officials by blocking the lower house of parliament's official media channel earlier this month.—AFP

Mexico to operate digital currency in 2025

MEXICO will begin to operate a digital currency issued by the Central Bank of Mexico (Banxico) in 2025, the bank's Governor Victoria Rodriguez Ceja announced Thursday.

The digital currency will seek to generate means of payment aimed at financial inclusion; expand options for fast, secure, efficient and interoperable payments; and implement competitive features to payment methods, she said before

Slovenian PM Jansa risks defeat in tight vote

SLOVENIAN Prime Minister Janez Jansa faces a tight race on Sunday in parliamentary elections billed as a "referendum on democracy" by the opposition in the deeply polarised country.

Jansa, an ally of nationalist Hungarian Prime Minister Viktor Orban and admirer of US ex-president Donald Trump, is polling head-to-head with newcomer Robert Golob, former chief of a leading power company.

Analysts say concerns over the rule of law have boosted the opposition and Golob has a real chance of getting a majority in the Alpine nation of two million, the first ex-Yugoslav state to join the European Union in 2004.

Tens of thousands of people have attended regular anti-government rallies, accusing Jansa of authoritarianism since he took power in March 2020.

The opposition has accused Jansa of using the coronavirus pandemic to dent the country's democratic institutions, violate press freedom and question the independence of the judiciary.

"Slovenia has reached a point it has never been before... It has become one of the biggest troublemakers (in the EU) with an authoritarian-style government and almost daily breaches of the rule of law, with narrowing freedoms," Ljubljana University professor Vlado Miheljak told AFP. Golob's ascendancy began when he took over a small Green party in January, renaming it Freedom Movement (GS).-AFP

Mexico says it axed US-trained unit fighting drug cartels

MEXICO has dissolved a special unit trained by US authorities to fight drug cartels because it was infiltrated by criminals, President Andres Manuel Lopez Obrador said Thursday.

Some members of the group have been detained over the allegations, Lopez Obrador told reporters.

The police unit, which received training from the United States Drug Enforcement Administration, was disbanded more than a year ago, but the decision was not announced at the time.

"There's still cooperation (with US authorities) but that group that was supposedly of a very high strategic level was infiltrated (by organized crime) and its leaders are being investigated," Lopez Obrador told reporters.

The unit, whose closure was

first reported by the Reuters news agency, was created in 1997 and worked on cases such as the capture of notorious drug kingpin Joaquin "El Chapo" Guzman.

In December 2020, Mexico announced steps to restrict the activities of foreign agencies like the DEA, following a row over the arrest of a former defence

minister in Los Angeles for drug trafficking.

Lopez Obrador expressed irritation that he had not been informed about the investigation into retired general Salvador Cienfuegos, who was eventually sent back to Mexico, where he was exonerated by prosecutors.—AFP

Oueen Elizabeth II turns 96

GUN salutes will mark Queen Elizabeth II's 96th birthday on Thursday, although the monarch herself was expected to mark the occasion with little fanfare after a troubled year hit by health concerns.

Royal officials released a photograph of the horse-loving head of state with two of her fell ponies, as family members wished her well. Her grandson Prince William and his wife Kate called her "an inspiration to so many across the UK, the Commonwealth and the world".

In the British capital, 62 gun rounds will be fired later from the Tower of London and 42 in Hyde Park, where a military band will also play "Happy Birthday".

Royal tradition since the 18th century has also seen the monarch have a second, official birthday, typically celebrated in warmer weather in June.-AFP

Venice readies day-trip booking system to ease crowds

VENICE plans to trial a reservation system for day-trippers, an official said Wednesday, in a bid to ease over-tourism as visitors flock back to the Italian city following the pandemic.

The pay-to-visit scheme will not cap tourist numbers but aims entice some people to visit during the low season by charging them less. "We will start with an experimental phase during which the reservation will not be mandatory, but optional" and will cost nothing, Venice's deputy tourism councillor Simone Venturini told AFP. Visitors just popping in for the day will be encouraged to sign up through incentives "such as discounts on museum admissions", he said. The start date will be announced in the coming weeks.-AFP

PM's offering to war-linked shrine

SOUTH Korea on Thursday expressed regret over Japanese Prime Minister Fumio Kishida sending a ritual offering to the notorious war-linked Yasukuni Shrine, seen as a symbol of the militaristic and colonial past of Japan.

The South Korean foreign ministry said in a statement that the government expresses deep disappointment and re-

gret over the fact that responsible leaders of Japan have once again sent offerings to and paid respects at the Yasukuni Shrine, which glorifies Japan's war of aggression and enshrines war criminals.

The South Korean government strongly urges the leaders of Japan to squarely face history and demonstrate through action their humble

reflection and sincere remorse for Japan's past history.

The Japanese premier reportedly sent the masakaki offering to the Yasukuni Shrine earlier in the day on the occasion of the shrine's spring festival.

Kishida sent a similar offering during the autumn festival after becoming prime minister in October last year.—Xinhua

NORTH Korean leader Kim Jong Un and outgoing South Korean President Moon Jae In have exchanged personal letters, the North's official media reported Friday, despite rising tensions over Pyongyang's military provocations.

Kim and Moon shared the view that inter-Korean relations "would improve and develop" if the North and South "make tireless efforts with hope," the Korean Central News Agency said.

In Seoul, presidential spokeswoman Park Kyung Mee said that in his letter to Kim, Moon said, "Holding the hands of Chairman Kim, I took one clear step that would change the fate of the Korean Peninsula."

The exchange between the two leaders came just days after South Korea and its defence ally the United States began joint springtime military exercises, which the North slammed as a "rehearsal" for war.

By improving ties with Seoul during Moon's remaining tenure, Pyongyang might be trying to urge South Korea's conservative President-elect Yoon Suk Yeol to abide by joint declarations previously signed by Kim and Moon, pundits said. Yoon will take office on 10 May.

KCNA said Kim received a personal letter from Moon on Wednesday and replied to him the following day, adding the exchange of letters between the two leaders is "an expression of their deep trust." "Kim Jong Un appreciated the pains and effort taken by Moon Jae In for the great cause of the nation until the last days of his term of office," the news agency said.

Spokeswoman Park relayed that Kim said in his letter he regretted not being able to achieve as much as the two leaders had hoped.--Kyodo

Russia slaps travel ban on Kamala Harris, Zuckerberg

RUSSIA on Thursday slapped travel bans on US Vice-President Kamala Harris, Facebook chief Mark Zuckerberg and dozens of prominent Americans and Canadians in retaliation for sanctions imposed over Ukraine.

The Russian foreign ministry said the travel restrictions on 29 Americans and 61 Canadians – which also includes defence officials, business leaders and journalists from both countries - would remain in effect indefinitely. The foreign ministry said the list was comprised of people responsible for the two countries' "Russophobic" policies.

In Washington, one of the officials targeted, State Department spokesman Ned Price, said that the travel ban was "an honour." -AFP

Ukraine says Russia planning sham independence vote in occupied regions

UKRAINIAN President Volodymyr Zelensky has accused Russia of planning to "falsify" an independence referendum in the partly occupied southern regions of Kherson and Zaporizhzhia.

In a video message Thursday evening, Zelensky urged residents of areas under occupation to not provide any personal information, like their passport numbers, to the Russian forces.
