## Re-invitation for basic education staff who are absent from duty

THE State Administration Council is implementing nine objectives, including a social goal of national health and higher education, and is working hard to restore education to the next generation of young people in order to develop the nation's human resources.

For the education of the new generation, basic education schools across the country were reopened on 1-11-2021, and higher education universities/colleges were reopened on 12-5-2022. Basic education schools for the 2022-2023 Academic Year will be reopened on 2-6-2022.

Basic education is very important in the education of the new generation of young people who will be the leaders of the future. So those students can learn fully and to make the teachers/students ratio balance, experienced teachers are needed.

In order to resume their teaching duties for the next generations, teachers and educators who have been away from their duties due to intimidation, participation in peaceful protest, or worry, and teachers and educators who have been prosecuted under staff discipline are informed to report to the relevant Township Education Offices where the schools are located or the nearest Township Education Offices in their current area of residence to file an appeal voluntarily by 31-5-2022.

Among the basic education staff who are absent from duty due to various reasons, those who are absent without leave due to various reasons, those under the investigation, and those who file an appeal, shall be considered as unpaid leave for the period of non-duty and will be re-employed except for those who have committed serious crimes.

## COVID-19 vaccine drive continues in various states, regions

DOCTORS and nurses from public hospitals, Tatmadaw medical teams, healthcare workers and volunteers are working hard to give COVID-19 vaccines in different states and regions as the vaccination programme is one of the most important activities in the prevention, control and treatment of COVID-19 disease.

COVID-19 vaccine is administered daily to target groups regardless of race or religion, including Buddhist monks and nuns, local people over the age of 40, students, religious leaders, prisoners, people with disabilities, ethnic armed groups, people with chronic diseases, people in IDP camps and over

12-year-old students, respectively.

The Union minister and party inspected the E-library and the library, technology gallery, audio lab, demonstration room, trainees' classrooms, computer lab room, school museum, four-storey classroom under construction, officers' mess and the trainees' training in tactical subjects.

During the inspection, the Union minister said that trainees should be trained to use the E-Library and library as the main place in teaching subjects. The training school offers books on the rule of law and law. Legal books need to be added more than now. It is necessary to train and demonstrate crime scene demonstration and training and to acquire the ability to make conclusion based not only on technology but also on ideas, he said.

He called on trainees to learn military tactics during the training and not to have mismanagement while performing their duties in the practical field and local security duties. He also mentioned keeping records of police officers who have obtained honorary awards at the school.

# Monkeypox virus causes pneumonia disease, encephalitis and retina damages

THE monkeypox virus causes pneumonia disease, encephalitis and retina damage, said Dr Ko Ko Lwin from South Okkalapa Township based on the statement of WHO during the interview with the GNLM.

"The incubation period of monkeypox is usually from 6 or 13 days and can range to 21 days. The symptoms of monkeypox are fever, headache, rash, muscle ache, exhaustion and lymph nodes. The lymph nodes are different from other diseases like chickenpox and measles," he told the GNLM.

The monkeypox virus is transmitted from one person to

another by close contact with lesions, body fluids, respiratory droplets and contaminated materials such as bedding. The patients will have smallpox on their body, face, hands and legs 1-3 days.


It should watch the infection rate of monkeypox in the international countries and make preparations in the country, said MoH Deputy Minister Prof Dr Aye Tun during a coordination meeting on preventing a dengue-fever outbreak in 2022 held on 23 May.

The Public Health Department released notices based on the statements of WHO.

According to the nature of



monkeypox, Myanmar has a lower risk of disease outbreaks. But it needs to accelerate disease control activities regarding these pox diseases and other diseases. Moreover, it should make preparations for suspected patients to provide medical treatment at the nearest health departments and conduct lab tests. The monkeypox disease can be transmitted



to humans from animals and according to the One Health Approach, the breeding and veterinary, environmental conservation and health sectors should work together, explained MoH Deputy

Minister Prof Dr Aye Tun.

There are 80 cases of monkeypox in 11 countries including the UK and another 20 suspected patients in the UK. — TWA/ GNLM

## Nok Air, Thai Smile, Air Asia reopen flying to and from Myanmar

NOK Air, Thai Smile, and Air Asia will resume flying to and from Myanmar in June, according to the statement of the Yangon International Airport.

Commercial airlines had been suspended due to COVID-19 since 29 March 2020, and Myanmar resumed its first commercial flight from Singapore-Yangon flight on 17 April 2022. Along with international airlines such as Malaysia Airlines and Singapore Airlines, two Myanmar airlines, MAI and MNA, are also offering international flights. Thai Smile will resume on 1 June; Air Asia will resume on 3 June, and Nok Air will resume on 1 July.

Myanmar National Airlines-MNA is flying regularly to Singapore, Bangkok, and Kuala Lumpur, and the Myanmar Airways International (MAI) is also flying to Kuala Lumpur, Bangkok, Tokyo, Singapore, and Seoul, Guangzhou, Dubai, Phnom Penh, Kolkata, and Delhi on des-

ignated days regularly. From 1 April, fully-vaccinated travellers will no longer need to show entry approval and be quarantined in Singapore, according to the statements.

From 17 April until the end of the month since the resumption of commercial flights in Myanmar, there were 6,455 arriving travellers and 9,593 departing travellers, a total of 16,048 travellers, according to the Department of Civil Aviation. — TWA/GNLM

## Myanmar earns \$58.933 mln from rice exports via maritime route

THE data from the Ministry of Commerce showed that Myanmar generated US\$58.933 million from 175,910 tonnes of rice and broken rice exports via the sea route in April 2022.

The country exported more than 26,940 tonnes of rice to Asian countries, 49,720 tonnes to EU countries and 42,600 tonnes to Africa.

Myanmar exports rice to Ivory Coast the most with 10,000 tonnes while 9,000 tonnes to Cameroon, 15,000 tonnes to Angola, 8,500 tonnes to Madagascar, more than 14,300 tonnes to China, 12,200 tonnes to the Philippines, 250 tonnes to Sri Lanka and 180 tonnes to Hong Kong.

It also exported about 8,800 tonnes of rice to Poland, 8,200 tonnes to Lithuania, 8,690 tonnes to Italy, 15,180 tonnes to Spain, 7,750 tonnes to Bulgaria and 700 tonnes to Belgium.

In April 2022, the country earned about \$1.410 million from the export of 4,180 tonnes of rice via the Myanmar-China border trade route. It received \$42.708 million from the export of more than 123,440 tonnes of rice via sea and border areas in April.

Moreover, it exported more than 50,530 tonnes of broken rice via sea in April 2022 and earned \$15.627 million. It exported 18,200 tonnes to China, 30,600 tonnes to Belgium, 1,000 tonnes to Lithuania, 500 tonnes to Poland, 180 tonnes to Singapore and 50 tonnes to Germany. The exports of 1,620 tonnes of broken rice via the Myanmar-China border and 320 tonnes via the Myanmar-Thai border earned \$0.598 million.

The country exported more than 119,260 tonnes of rice worth \$41.298 million in April 2022. —TWA/GNLM

# Three-hour power outage on 24, 31 May due to power plant upgrade works

FOUR power plants in Yangon Region will be upgraded and there will be a three-hour power outage on 24 and 31 May, according to the statement of the Yangon Electricity Supply Corporation.

The upgrade works on the Ahlon substation, Hlawga substation, Ywama substation, and Thakayta substation are being carried out, and the 230/66/11kV, Bank (6) 200 MVA, Transformer has been installed at the Thakayta substation.

The upgrade works will be conducted at Thakayta station

from 9 am to 11 am and from 4 pm to 6 pm on 24 May and from 9 am to 11 am on 31 May.

The power cut will affect Thakayta, Dawbon, Dagon Myothit (Seikkan), Dagon Myothit (South), Dagon Myothit (North), Thingangyun, Yankin, Tamway, South Okkalapa, Mayangon and Hline townships. The power will be provided through power lines of substations to prevent power outages in critical areas, according to the statement. — TWA/GNLM

## Illegal teak, gold, foodstuffs, consumer goods and vehicles seized

SUPERVISED by the Anti-Illegal Trade Steering Committee, action is being taken under the law against illegal trades across the country.

The combined inspection team made inspections on 22 May. They captured an unregistered Toyota Mark II car at an estimated value of K3,500,000 on the Minbu-Magway Road in Minbu Township and an unregistered Nissan X-trail car (estimated value of K4,000,000). Police opened case files under the Export/Import Law.

In addition, on the same day, the team led by Myanmar Police Force seized K82,000,000 worth of four illegal gold plates - ten grammes per one gold plate which are expressed an academy label at No (3) Port in the Kanyinchaung economic zone of Maungtaw Township. Police opened a case file at the Pyinphyu Police Station.

Moreover, on 23 May, the Mayanchaung checkpoint of Mon State also captured K2,002,000 worth of illegal consumer goods that showed no official document

from an express bus heading from Thaton to Bago Township.

The combined inspection team confiscated electronic appliances and cigarettes (estimated value of K1,820,000) that showed no official documents at the Nandaw checkpoint in Muse Township. The action was taken under the Customs Law.

On 24 May, the Bago Region Forest Department seized 4.4120 tonnes of illegal teak (estimated value of K1.455.964) in the Mukar forest reserve of Minhla township. The action was taken under the Forest Law.

Therefore, from 22 to 24 May, seven arrests were made, totalling K94,777,964, according to the Anti-Illegal Trade Steering Committee. — MNA

### Illegal drugs worth over K1 billion seized in Mohnyin, Kachin state

HEROIN and stimulant tablets worth over K1 billion were seized in Mohnyin Township, Kachin State, on 16 May, according to the Myanmar Police Force.

A combined team consisting of security personnel searched a six-wheel vehicle at the Nantsiaung combined checkpoint on the Mandalay-Myitkyina Road, in Mohnyin Township, Kachin State, and found and seized 26.4 kilogrammes of heroin and 342,000 stimulant tablets from the vehicle.

According to the investigation, the seized illegal drugs were transported from Mandalay to Kachin State. The driver was prosecuted under the law, and the police are investigating to take action against the related suspects. — MNA

### Traffickers sentenced to jail for human trafficking

THE Pakokku District Court sentenced two people to eleven years imprisonment each with labour for their role in trafficking two girls to be prostitutes.

Victims Ma ..., aged 30,

and Ma..., aged 26 from Mawlaik Township of Sagaing Region were forced to be prostitutes by Naing Win Htay, Ma Moe Thae Phyu (aka) Moe Moe (aka) Ei Thandar Moe and they exploited the money

## Mandalay market sees brisk sales of wheat crops

WHEAT is highly demanded in the Mandalay market these days and also fetching a high price, beans and pulses traders said.

It is mainly supplied by Monywa, Shwebo, Sagaing, Budalin, Myinmu and Myaung areas. The wheat fetched only K90,000 per three-basket bag in January 2022, whereas it soars to K125,000 per bag in the last week of May, said U Soe Win Myint from the Mandalay Soe Win Myint depot.

"The prices of wheat crops stay high in recent days. The Mandalay market sees brisk sales as well. Global consumption of wheat is growing. It is the second-highest demanded crop in Myanmar after the staple food

rice. The high price allows the wheat growers to make profits this year. Earlier, wheat was commonly imported. To minimize the capital outflow, I like to suggest the growers add more acres and improve production. The domestic consumption of wheat is also growing year over year. The wheat has become one of the essential crops in Myanmar," he elaborated.

The wheat can be cultivated once a year. It cannot be grown anywhere in Myanmar, especially in Sagaing Region. It is commonly found in southern and northern Shan State, Chin State and Kayah State.

## Export rice prices spiking



Myanmar also generated an income of US\$700 million from two million tonnes of rice exports to the foreign countries in the past 2020-2021 Financial Year.

THE prices of rice for the export market are rocketing, said U Than Oo, secretary of the Bayintnaung Rice Wholesale Depot-BRWD.

At present, traders are purchasing the rice to export them as per a previously signed MoU. However, they are not commercially doing well, he said.

"As the contract price has been already fixed and the domestic rice price stays on the rise, the traders are struggling to meet the contracts. Moreover, the summer paddy is not that abundant and local brokers keep the inventory on hand. Therefore, the prices of rice are going up," U Than Oo elaborated.

According to the provisions stipulated in Sections 11, 12 and 13 of the Foreign Exchange Management Law, all the foreign currency earned by locals have to be exchanged for local currency at the CBM's reference rate of K1,850 by opening the accounts at the authorized dealers in the country within one working day, according to the notification released on 3 April.

"Exporters fill the inventory from the domestic market. The rice is loaded on the ships after the rice cleaning process to remove dust. The foreign exchanges earned according to the contract are deposited into an account and exchanged for local currency at the set rate of K1,850. This is the trading process for now. Although the dollar is worth over K2,000 at the unofficial exchanges, the official exchange rate is fixed. This is why the exporters are facing financial hardship to offer a higher price in the competitive market. Those who are buying them are not making profits yet they are trying to accomplish the contract," the BRWD secretary said.

The export rice prices (low grade) move in the range of K29,000 and K30,000 per 108-pound bag depending on different varieties, according to the Bayintnaung Commodity Centre.

Myanmar has shipped more than 1.4 million tonnes of rice and broken rice to foreign trade partners between 1 October and 31 March in the past mini-budget period 2021-2022, the Myanmar Rice Federation stated.

The country sent over 76,000 tonnes of rice and broken rice to the neighbouring countries through land borders whereas it placed over 1.3 million tonnes in the international market via the sea route.

## Myanmar's foreign trade surges to \$3.4 bln over one month

MYANMAR'S external trade between 1 April and 13 May of the 2022-2023 Financial Year tremendously rose to US\$3.438 billion, indicating a sharp increase of \$470.98 million as against the year-ago period, according to the Ministry of Commerce.

The figures soared from \$2.967 billion in the corresponding period last year.

Myanmar's export was

worth over \$1.69 billion whereas, the country's import was valued at \$1.74 billion over one month.

The border trade dropped owing to the closure of the border post by the main trade partner China amid the coronavirus impacts, with a decrease of \$116.97 million as against the year-ago period. However, the maritime trade registered a sig-

nificant increase of US\$587.95 million over one month.

Myanmar exports agricultural products, animal products, minerals, forest products, and finished industrial goods, while it imports capital goods, raw industrial materials, and consumer goods.

The country's export sector relies more on the agricultural and manufacturing sectors.

The Ministry of Commerce is focusing on reducing the trade deficit, export promotion, import substitution and market diversification.

The external trade stood at \$15.5 billion in the past mini-budget 2021-2022 (October-March) period and \$29.58 billion in the 2020-2021FY, as per the Commerce Ministry's statistics. — KK/GNLM

## Don't Panic among the people of monkeypox

URRENTLY, monkeypox, which has appeared again in the world, apart from the Covid-19 pandemic, is able to shake the human society due to dreadful symptoms such as a high temperature, aches and a rash of raised spots that later turn into blisters. But it is typically mild and for most people clears up within two to four weeks

Moreover, the suspect patient will face their bodies with initial symptoms—fever, headaches, swellings, back pain and aching muscles. If so, they should take care of their health conditions by receiving proper medical treatment in time. The infection usually clears up on its own and lasts between 14 and 21 days.

news stated that other people who may have come into contact with a case do not need to stay at home and isolate themselves but should watch out for symptoms such as fever and a rash.

The other day, the Ministry of Health held a coordination meeting on the possibility of monkeypox and how to prevent and monitor its infection in Myanmar. In this regard, it is necessary to raise the awareness of monkeypox disease through various ways and means while conducting preventive activities against the infection of chickenpox and smallpox.

Health officials warned the people of an outbreak of monkeypox in addition to chickenpox and smallpox in the country to make sure that the people should not panic as there is an outbreak of chickenpox among children in the country.

There is a need to intensify disease surveillance activities

on existing communicable diseases as well as monkeypox although there is little evidence of the disease in Myanmar, and the preparations must be made for lab testing and medical work. But, Myanmar is less potential for an outbreak of monkeypox due to its nature, it is necessary to raise the surveillance and monitoring the infectious diseases with momentum for ensuring the safety of the people in the health sector.

Whatever it may be, not only relevant ministries and health officials but the entire people should not underestimate the infection of monkeypox, chickenpox and smallpox in the international community while making preparations for the current disease surveillance system in the nation with relentless efforts.

## British expert rules out new pandemic as monkeypox spreads to more countries

AS CASES of the Monkeypox virus have been reported Sunday in more non-endemic countries, a British virologist said it wouldn't become a COVID-like pandemic.

"Monkeypox is not a COVID situation and it will never be a COVID situation. It will be a problem, but it will be a problem that we will ultimately manage to control. I'm quite convinced," said Paul Hunter, a specialist in medical microbiology and communicable disease control. "Ultimately, it's something we will be able to control before it becomes a really big issue. The reason for that is we have already have a pretty effective vaccine, the same vaccine we use with smallpox. And the really useful thing with this vaccine is that you can give it to somebody after they've been in contact with a case," Hunter told Xinhua in an exclusive interview.

"So the way you would control this is identifying every case that you can as quickly as you can and then vaccinating all their closed contacts. The technical term is ring vaccination for this. You vaccinate a ring around the case and hopefully then stop that spreading further," he added.

More than 120 cases of the

More than 120 cases of the virus, a close relative of smallpox, have now been reported in a disease normally confined to parts of Africa. With Israel, Switzerland and Austria among the latest coun-

tries to confirm Monkeypox cases, at least 15 countries have reported the outbreaks.

The UK Health Security Agency has reported on Monday 36 additional cases of monkeypox in England, bring the total number of monkeypox cases confirmed in England since 7 to 56 May.

Besides Britain and mainland Europe, there have been cases in the United States, Canada and Australia.

Hunter said many, but not all of the cases, have been reported to be in men who have sex with men. "So, it's quite plausible that it's spreading now amongst sexually active networks in a way that typically in Africa, you wouldn't see."

This is probably "an infection that is spreading primarily amongst sexual networks of close contacts, but not exclusively so. And you do get some infection spreading from outside. So we're not at the moment sure how it's going to behave, so I think we have to be very cautious," he said.

Monkeypox is also potentially more severe in children who contact the virus, said Hunter, also a professor of medicine with the Norwich Medical School at the University of East Anglia. "There is an issue with monkeypox in children. In African cases we do see more severe disease in children

than we do in adults," Hunter said. Hunter said more cases were likely to be reported in Britain and elsewhere in the coming weeks.

"But I think the UK Health Security Agency is right when it says this isn't generally a disease that spreads very easily, and so it probably wouldn't be come much of a risk to the general population. But certainly, with some parts of the population appearing to be more at risk there will be a need for appropriate advice and management when they've been into contact with cases," Hunter said.

At the moment, Hunter said, there are still a lot of scientists who "don't know about how this virus is spreading, and what networks it's spreading through, and how people are being infected and from whom, because it almost certainly will be passed from somebody

"I'm pretty sure people will be doing a lot more of the genetics on this, but I think most of us are going to be having to do quite a bit of background reading over the next few days to make sure we know what's been going on. The last two years, we've been reading pretty much only coronavirus

"Undoubtedly there is a lot of nervousness around at the moment about viral infections amongst the general public, and much of that nervousness is well placed. I think we have to consider each new infection that we're exposed to on what we know about that infection," the expert said.

## Occupational Safety and Health in Myanmar

WAS trained as a civil engineer after graduating from **L** the Rangoon Institute of Technology (RIT) in 1985. Such a vocation was with me till 2003 when I switched over to a career in the workplace safety and health after completing one year of coursework for the Safety Officer Training Course conducted by Singapore Polytechnic. Subsequently, I was certified as registered workplace safety and health officer in Singapore. My profession was officially recognized in a foreign land.

But one certificate was not enough to get this career alive. Other certifications such as environmental control officer, fire safety manager, and earth control measures officer had to

be acquired through learning from different institutes and authorities there. In addition, those registrations would require to be renewed every two years through continuous learning by attending training courses, seminars as well as active participation in professional activities

Ascending the career ladder, topping with other certifications for workplace safety and health auditor and trainer was

a must that I got. My profound profession was even reinforced with the attainment of a further degree - M.Sc. (Safety, Health and Environmental Technology) from the renowned National University of Singapore (NUS) in 2012. International Safety Conferences in Singapore (2012) and Sweden (2014) organized by International Council for Research and Innovation in Building and Construction (CIB W099) saw me representing NUS to read

academic papers.

Not keeping to myself, experiences were shared not only at work but also through other channels such as publications, seminars, etc. with many hats worn as a writer or a speaker or a host or an organizer on different fronts in different countries. Professing out of the box earned me international accolades – a certificate of commendation for the workplace safety and health officer award from the Workplace

Safety and Health Council, Singapore and the Guardian Angel award from the Royal Society for the Prevention of Accidents (RoSPA), the United Kingdom. Not once, three times each.

Three decades passed on. The present-day sees me back with a vast experience in my native country, Myanmar wherein the occupational safety and health arena is far left behind in other countries. As a dutiful citizen, I would like to contribute

to the nation's development as a brick and a grain of sand. To do so, a specific guide or law is required. Myanmar has already drawn up the Occupational Safety and Health Law, 2019. But it has not come into existence yet, pending the President's approv-

Given the situation, we are like a boat without a rudder in a stormy sea. The Law would ensure the formation of the Occupational Safety and Health Na-

tional Council comprising the representatives of the Government, Employers and Workers. It would oversee the prescription of national-level policies and procedures as well as co-work with counterparts of other countries.

Seeing is Believing. Abroad I saw it, I believed it.

Let us see together a well-establishment of occupational safety and health in Myanmar in the near future for which my kind assistance is at your disposal.

# US unveils Asia-Pacific trade framework, but questions remain

PRESIDENT Joe Biden launched a new Asia-Pacific trade initiative Monday in Tokyo, with 13 countries including India and Japan signing up, although questions about the pact's effectiveness remain

Biden formally unveiled the Indo-Pacific Economic Framework for Prosperity, or IPEF, on his second day in Japan, where he is also holding talks with Prime Minister Fumio Kishida before joining a regional Quad summit on Tuesday.

"This framework is a commitment to working with our close friends and partners in the

region on challenges that matter most to ensuring economic competitiveness in the 21st century," he said

Unlike traditional trade blocs, there is no plan for IPEF members to negotiate tariffs and ease market access — a tool that has become increasingly unpalatable to US voters fearful of seeing homegrown manufacturing undermined. Instead, the programme foresees integrating partners through agreed standards in four main areas: the digital economy, supply chains, clean energy infrastructure and anti-corruption measures.—AFP

# Electric car sales soar but raw materials a concern: report

SALES of electric cars accelerated last year but the availability of critical raw materials such as lithium risked slowing the sector's growth, a report warned

Monday.

At 6.6 million last year, electric vehicles sales more than doubled and they now account for one in 10 new cars sold, ac-

cording to the International Energy Agency's annual report on the sector.

China alone accounted for half of those sales.

Electric vehicle sales continue to soar, rising by 75 per cent in the first quarter of this year compared to the same period last year.

Public subsidies to lower the cost to consumers have been a major factor in the adoption of electric vehicles, and they doubled last year to nearly 30 billion euros (\$32 billion) last year.

Manufacturers have also increased their offer with around 450 models now on sale, a five-fold increase since 2015.

But supply constraints and rising prices risk putting brakes on the sector's growth.—AFP

### Biden says US recession not inevitable

A recession in the United States is not inevitable, President Joe Biden said Monday, while acknowledging the economic pain experienced by Americans as inflation soars.

Speaking in Tokyo, Biden replied "no" when asked if a US recession is inevitable.

"This is going to be a haul, this is going to take some time," Biden said. The US economy has recovered strongly from its Covid-19 era shutdown, but the highest inflation in four decades and persistent problems in getting international supply chains flowing again are driving pessimism—and Biden's sinking poll numbers.—AFP

### Algeria president sacks central bank chief

Algerian President Abdelmadjid Tebboune on Monday sacked central bank chief Rostom Fadli, in office for less than two years, the presidency announced without giving any further explanation.

Tebboune "on Monday ended the functions of the Governor of the Bank of Algeria, Mr Rostom Fadli, and appointed Mr Salah Eddine Taleb to replace him", it said in a statement.—AFP

# Brazil's Bolsonaro fires third Petrobras chief as fuel prices soar

BRAZILIAN President Jair Bolsonaro on Monday dismissed the president of state oil giant Petrobras, who had been in the job for only 40 days.

Fuel prices in Brazil have increased more than 33 per cent in the past year, according to official figures, driving annual inflation of more than 12 per cent and hurting

Brazilians' wallets. Inflation is a central issue as the far-right Bolsonaro seeks re-election in October and trails leftist ex-president Luiz Inacio Lula da Silva in the polls. "The Federal Government, as controlling shareholder of Petroleo Brasileiro S.A., Petrobras, advises that it decided to make a change to the Company's presi-

dency," said the Ministry of Mines and Energy in a statement.

Without giving specific reasons for the dismissal, it thanked Jose Mauro Coelho for his service but said: "Brazil is currently experiencing a challenging moment, due to the effects of the extreme volatility of hydrocarbons in international markets."—AFP

### Mobile phone shipments in China top 69.35 mln in Q1

CHINA'S mobile phone shipments dropped 29.2 per cent year on year to about 69.35 million units in the first quarter of this year, according to a report by the China Academy of Information and Communications Technology (CAICT).

Shipments of 5G mobile phones amounted to 53.88 million units during the period, a drop of 22.9 per cent, said the CAICT, a research institute under the Ministry of Industry and Information Technology.5G phones continued to dominate China's smartphone market in the first three months, accounting for 77.7 per cent of all phone shipments.—Xinhua

### Google marks 15 years of Street View

GOOGLE celebrated on Tuesday 15 years since it kicked off its mammoth and hugely controversial effort to photograph streets in minute detail across the globe.

The panoramic images of Google Street View have slipped into daily life for millions -- but during its early years it attracted countless court cases and howls of anguish from privacy campaigners.—AFP

## ANA to remove self-check-in machines at domestic airports next year

ALL Nippon Airways Co. said Tuesday the Japanese airline will remove self-check-in machines for domestic flights at 51 domestic airports from April next year as most passengers can complete their pre-flight procedures via a smartphone app.

The move, which en-

tails removal of 437 machines used for domestic flights, is part of efforts to offer contactless services amid the coronavirus pandemic and reduce costs associated with airport checkins. For those who cannot use the app, the airline will continue to offer in-person check-ins at the airports.

Using the carrier's app, passengers can book and purchase electronic tickets for domestic flights and skip check-in procedures at airports. They can then use the electronic tickets on the app to go straight to security inspections and board their flights.

While some domestic and international flights are still operating out of the facility, it needs significant upgrades for major foreign airlines to restart full service. —AFP

### China tops the world in globally important agricultural heritage systems

CHINA ranks first in the world in the number of Globally Important Agricultural Heritage Systems (GIAHS) designated by the Food and Agriculture Organization of the United Nations (FAO), the Ministry of Agriculture and Rural Affairs said Tuesday.

Three sites in China—an ancient tea-producing area in Anxi County, east China's Fujian Province, a nomadic livestock-rearing region in Chifeng City, north China's Inner Mongolia Autonomous Region, and a rain-fed stone terrace farming system in Shexian County, north China's

Hebei Province, have been recently recognized as GIAHS by the FAO, bringing the country's total number of GIAHS to 18. The sites were designated as GIAHS for their unique ways of using traditional practices and knowledge while maintaining unique biodiversity and ecosystems, according to the FAO. GIAHS, which is celebrating 20 years in October, is a flagship programme of the FAO. FAO's worldwide agricultural heritage network now consists of 65 systems in 22 countries around the globe, the organization said.—Xinhua

### Ukraine extends martial law

UKRAINE extends martial law and the general mobilization of the population for three months through to 23 August.

### Stop Russia trade: Zelensky

UKRAINIAN President Volodymyr Zelensky urges the international community to halt all trade with Russia, shun its banks and IT sector and impose an oil embargo.

In an address by video-link to political and business leaders attending the World Economic Forum in Davos, he tells delegates: "There should not be any trade with Russia."

He also argues that tens of thousands of lives could have been saved if Kyiv had received "100 per cent" of its weapon requests.

### Mental health challenge

UKRAINE'S First Lady urges the World Health Organization to help tackle the country's vast mental health crisis, warning that the effects of the three-month-old war could last for decades.

"Following what Ukrainians have experienced during the occupation, at the front, in bomb shelters, under shelling... they need rehabilitation in the same way as those who are physically wounded," Olena Zelenska tells the WHO's annual assembly.

### Starbucks leaves Russia

STARBUCKS says it will cease operations in Russia, shuttering its 130 cafes in the country. Last week, McDonald's announced it was leaving Russia after more than 30 years.

### Seized region adopts rouble

AUTHORITIES in the Moscow-controlled southern Ukrainian region of Kherson announce the introduction of the ruble as an official currency alongside the Ukrainian hryvnia.

The region's capital Kherson was the first major city to fall to Russian forces.

### **Russian soldier convicted**

A Ukrainian court convicts a 21-year-old Russian soldier of war crimes and sentences him to life in prison at the first trial held over Russia's invasion of its neighbour.

Vadim Shishimarin admitted to shooting dead 62-year-old civilian Oleksandr Shelipov in the early stages of Moscow's invasion. His lawyer says he will appeal.

## Russia intensifies Donbas offensive as Severodonetsk under heavy fire

RUSSIAN forces on Tuesday stepped up their offensive on the last pocket of resistance around Lugansk in Ukraine's eastern Donbas region, as the conflict entered its fourth month.

Since Moscow's invasion in late February, Western support has helped Ukraine hold off its neighbour's advances in many areas — including the capital Kyiv — but Russia is now focused on securing and expanding its gains in Donbas and the southern coast.

"The coming weeks of the war will be difficult, and we must be aware of that," Ukraine's President Volodymyr Zelensky said Monday in his nightly address after regional leaders and residents reported heavy bombardments.

"The most difficult fighting situation today is in Donbas," Zelensky said, singling out the worst-hit towns of Bakhmut, Popasna and Severodonetsk. The governor of Lugansk, in Donbas, said that Russia has sent thousands of troops to capture his entire region and that Severodonetsk was under massive attack, warning residents that it was too late to evacuate.

"At this point I will not say: get out, evacuate. Now I will say: stay in a shelter," Sergiy Gaidai said on Telegram. "Because such a density of shelling will not allow us to calmly gather people and come for them."

Residents of Bakhmut, a crucial junction that serves as a command centre for much of the Ukrainian war effort, told AFP of the aerial onslaught they had suffered.—AFP

### Moscow quits bid to host World Expo 2030

RUSSIA on Monday notified the Bureau International des Expositions, World Expo's organizing body, of its decision to voluntarily withdraw Moscow's candidacy for the right to host the World Expo 2030.

"We are forced to state that the international exhibition movement turned out to be another victim of the large-scale anti-Russian campaign launched by the collective West to squeeze our country out of all areas of cooperation," the Russian Foreign Ministry said in a statement.

Five countries had submitted competing candidatures to organize the event, namely Russia, South Korea, Italy, Ukraine, and Saudi Arabia. — Xinhua

## Quad announces maritime initiative to track illegal fishing, activity

THE leaders of Japan, the United States, Australia and India on Tuesday announced a new effort to uphold a "free and open Indo-Pacific", unveiling a maritime initiative to help countries track illegal fishing and monitor other activities in their waters.

The second in-person meeting of the Quad took place in Tokyo at a time when Russia's war in Ukraine is seen to be representing a dire warning of the need to prevent a similar situation from occurring in the Indo-Pacific, where China has become increasingly assertive.

At the outset of the meeting, Japanese Prime Minister Fumio Kishida said, "the Russian invasion into Ukraine squarely challenges the principles which are enshrined in the UN Charter."

"We should never ever allow a similar incident to happen in

the Indo-Pacific...There is great significance in demonstrating the four countries' solidarity and our strong commitment to the shared vision of a free and open Indo-Pacific (through the meeting)," Kishida said.

US President Joe Biden, who is in Japan as part of his first trip to Asia since taking office, said Russia's assault on Ukraine "only heightens the importance" of ensuring a free and open Indo-Pacific.

Kishida, Biden and Indian Prime Minister Narendra Modi all commended the attendance of Australian Prime Minister Anthony Albanese, who flew to Japan to attend the meeting in Tokyo within hours of being sworn in as the new leader.

Albanese, who returned his Labour Party to power for the first time in nine years, assured

### Pressure mounts on French disabilities minister accused of rape

FRENCH President Emmanuel Macron's newly appointed disabilities minister rejected accusations of rape against him Monday and said he would not be resigning.

"Should an innocent man resign? I don't think so," he told reporters in his constituency of Ain in eastern France on Monday.

"I contest the accusations against me with the greatest firmness... I have never raped a single woman in my life."

The controversy over Damien Abad is a major headache for Macron and his new Prime Minister Elisabeth Borne, as they try to maintain political momentum ahead of June parliamentary elections.

They also come after several politicians running for parliament stepped down in recent weeks over alleged violence against women.

Abad was responding to the weekend publication of rape allegations against him from more than a decade ago.

The appointment of Abad as minister for solidarities and people with disabilities in a reshuffle Friday was seen as a major coup for Macron, as the 42-year-old had defected from the rightwing opposition.—AFP

### Sunken Hokkaido tour boat drops back to seabed while being towed

A sightseeing boat that sank off Hokkaido a month ago, leaving 14 people dead and 12 missing, dropped back to the seabed at a depth of around 180 metres as a salvage company was attempting to tow it, the Japan Coast Guard said Tuesday, in a setback to efforts to bring it to port for an investigation into the cause of the accident.

The company was scheduled to tow the 19-tone Kazu I to shallow waters in order to load it onto a barge and drain it of seawater for several days before transporting it to the nearby port of Abashiri.—Kyodo

### AFC U-17 & U-20 Asian Cup Qualifiers Draws set the scene

THE drawing-lots ceremony for the 2023 Asian Cup U-17 and U-20 qualifiers in which Myanmar teams participated was held on 24 May.

The AFC U-17 Asian Cup Qualifiers will divide 44 participating teams into 10 centralised qualifying groups, six of which will feature four teams, while four groups will include five teams when the Qualifiers take place from 1 to 9 October 2022.

Japan, Korea Republic, India, the Islamic Republic of Iran, Yemen and Thailand occupy Pot 1 followed by Iraq, Malaysia, Afghanistan, China, Hong Kong and Brunei Darussalam in Pot 2.

Myanmar, Timor-Leste, Qatar, Palestine, Cambodia, Syria, Singapore and China Taipei will be drawn from Pot 3 while Nepal, Lebanon, Laos, the Philippines, Mongolia, Maldives, Guam, Bhutan, Sri Lanka and the Northern Mariana Islands are in Pot 4. Kuwait, Turkmenistan, the United Arab Emirates and Bahrain will have their names pulled

Similarly, 44 teams will be allocated to six groups of four teams and four groups of five in the AFC U20 Asian Cup Qualifiers based on their AFC U-19 Championship Indonesia 2018 ranking.

Bahrain, Indonesia, Iraq, Jordan, Kyrgyz Republic, Laos, Mongolia, Oman, Saudi Arabia and Tajikistan, which will host the Qualifiers and will occupy the Host Pot followed by Korea Republic, Qatar, Japan, Thailand, Australia and UAE in Pot 1.

Pot 2 will include China PR, Malaysia, Vietnam, China Taipei, Cambodia, IR Iran and Yemen while Syria, Bangladesh, India, Myanmar, Lebanon, Hong Kong, the Philippines and Palestine occupy Pot 3.

Turkmenistan, Singapore, Timor-Leste, Maldives, Brunei Darussalam, Sri Lanka and Nepal are allocated in Pot 4 while Afghanistan, Bhutan, Guam, Kuwait, the Northern Mariana Islands and Uzbekistan sit in Pot 5. - Ko Nyi Lay/GNLM

### Son Heung-min's 'joyous' Golden Boot hailed by S Korea president

SON Heung-min has been congratulated by South Korean President Yoon Suk-yeol for winning the Premier League's Golden Boot, as his club Tottenham Hotspur announced Tuesday they would play a pre-season friendly against Sevilla in Suwon on 16 July. Son on Sunday became the first Asian footballer to be the English top flight's leading scorer with 23 goals, with President Yoon calling it a "joyous occasion to be celebrated by the entire Asian football community".

"I believe this award is the result of your passion after having devoted yourself and worked endlessly for your team all season," Yoon said in a message to Son, posted on Facebook.

Son's achievement was "a message of hope" for South Koreans during the Covid-19 pandemic, Yoon said, adding that he was looking forward to watching Son lead South Korea at the World Cup in Qatar in November and December.

Tottenham's final match of the season against Norwich on Sunday was aired live in South Korea, kicking off at midnight and ending at 2:00 am Monday.
