Myanmar categorically rejects every act of interfering in sovereign State under pretext of Human Rights

DURING the 52nd session of the Human Rights Council (HRC) in Geneva, Interactive Dialogues with the United Nations High Commissioner for Human Rights and with the Special Rapporteur on the situation of human rights in Myanmar were organized on 6 and 20 March 2023 respectively. The Council further adopted the EU-sponsored draft resolution entitled "Situation of human rights in Myanmar" on 4 April 2023. Similarly, the Special Envoy of the Secretary-General on Myanmar made a briefing at the United Nations General Assembly on 16 March 2023 in New York. Since the participation of Myanmar's legitimate representative was prevented in the meetings against the principles of international cooperation and dialogue, Myanmar registered its objection with the relevant UN bodies.

The High Commissioner for Human Rights fails to reflect the extent of terrorist acts committed by so-called CRPH, NUG and PDF though they were publicly available. It is disappointing that the High Commissioner evidently waters down the killings and violence committed by the terrorist groups which have claimed the lives of 5,475 innocent civilians including 162 children, 73 teachers, 16 health staff and 773 administrators as of 31 March 2023.

The Special Rapporteur on the situation of human rights in Myanmar is going far beyond his mandate by shifting his focus to the matters related to refugees and migration and publishing numerous papers on that issue and interfering in interstate relations between the sovereign countries. It is unacceptable that some countries have offered asylum to the masterminds who are responsible for committing and inciting the massive killings and violence in Myanmar. The Special Rapporteur's call for imposing sanctions and isolating Myanmar means disturbing the peace and stability of the country and to harm the interest of the general population.

The Special Envoy of the Secretary-General on Myanmar made a one-sided presentation to the United Nations General Assembly based on distorted information from terrorist organizations and opposition groups. She should be further careful with the proposals from armed groups to misuse humanitarian assistance for their political and military gains. The Government has been providing necessary assistance to the affected population. In addition to the field presence of UN agencies in different Regions and States, Myanmar has allowed 24 UN field visits and 49 field visits of the diplomats from EU, Switzerland, Germany, Canada, Britain and Norway between 2021 and 2022. Therefore, the allegations of access constraints are not true. The consent of the Government is a prerequisite for providing assistance

including humanitarian aid while Myanmar has been extending its cooperation to the United Nations agencies. The Special Envoy is advised to note that initiatives without the consent of the country concerned will only be counterproductive and engaging with unlawful groups and people responsible for atrocities may amount to supporting terrorism.

The European Union again tabled the resolution against Myanmar contained in document No A/HRC/52/L.19 to the 52nd session of the Human Rights Council. The lengthy document shows the extent of numerous mechanisms imposed on Myanmar and the level of interference in the internal affairs of a sovereign country. Myanmar does not accept the resolution which includes dictated elements and intrusive language against the political system, the political process on democratization in line with the 2008 State Constitution and matters that fall within the domestic jurisdiction of the country. The said resolution neglects the endeavours of Myanmar on the repatriation of the displaced persons from Rakhine State following the terrorist attacks by ARSA aka Aqa Mul Mujahideen in 2017. In this connection, progress has been made between Myanmar and Bangladesh as Myanmar Technical Team for in-person verification visited Teknaf and conducted interviews with the verified persons in March 2023. The resolution further

turns a blind eye to killings including 16 persons who were killed within the first three months of 2023 for their active role in the repatriation process. The resolution ignores the undeniable fact that such killings and intimidations made forced displacement in 2017 and hinder the return of the displaced persons. The people of Myanmar and successive governments do not recognize the term "Rohingya" which is neither legally supported nor included in British colonial official records. Myanmar has been granting citizenship status to those who meet the criteria set out in the 1982 Citizenship Law without any discrimination.

The afore-said country-specific dialogues and resolutions are purely based on unfounded allegations, one-sided narratives and politically motivated agendas. Since the resolution entitled "Situation of human rights in Myanmar" goes contrary to the fundamental principles of impartiality, objectivity and non-selectivity of the Human Rights Council, Myanmar categorically rejects it and dissociates itself from the adoption of the resolution. The Government highly appreciates the countries which uphold a balanced position during the dialogues and dissociate themselves from the adoption of the resolution.


The death toll from COVID-19 in the country remained unchanged at **19,490** on 6-4-2023 with no new death reported from the pandemic. — GNLM

DPM MoHA Union Minister attends Precursor Regulatory Workshop

THE Precursor Regulatory Workshop was held in Nay Pyi Taw yesterday.

During the meeting, State Administration Council Member Chairman of the Central Committee for Drug Abuse Control (CCDAC) Deputy Prime Minister Union Minister for Home Affairs Lt-Gen Soe Htut said the State Administration Council reorganized the central committee

with 19 members as per the 1993 Narcotic Drugs and Psychotropic Substances Law and 11 working groups, precursor regulatory group and other region/state inspection teams to supervise the export/import of precursor, storage, trading and production under the law.

The precursor chemical control also plays a key role in reducing the drug production rate. It should work hard as per the motto "no precursor, no drug abuse, no drug users, no drug cases". It should cooperate with international organizations in addition to regional countries in combatting drug problems.

The special missions are underway to accelerate the drug abuse prevention programmes and Operation 39 was launched across the nation from 1 February to 31 May 2023 to combat the illegal drug trade in Shan State.

During the Operation 39 period, the central committee organizes such workshops to discuss the weak points in combatting drug-related cases.

Then, Central Committee Secretary Deputy Minister for Home Affairs Chief of Myanmar Police Force Maj-Gen Zin Min Htet reported on information exchanges with neighbouring countries, regional countries, and international anti-doping agencies including UNODC, capacity building training, meeting, cooperation work with Tatmadaw, the department concerned and international organizations in combating drug cases as per the existing law and drug seizers in 2022-2023. Chairman of Precursor Regulatory Group Deputy Chief of Myanmar Police Force Police Maj-Gen Aung Naing Thu talked about the drug seizers in Yangon, Bago and Mandalay regions and other officials discussed recommendations to exchange information with international anti-doping agencies, systematic inspection of precursor and chemicals, seven types of precursor and 17chemicals that are used in producing drugs.

The workshop will be held until 7 April. — MNA/KTZH

Arrangements are being made to hold Rakhine traditional water festival and the pagoda festival suspended due to the outbreak of COVID-19 will be also held. The Koethaung pa-

goda (ninety thousand Buddha statues) festival was held actively in the last week of March and the Shitthaung pagoda festival will be held in early April. The Rakhine State government arranges to hold the Sittway Thingyan festival and the MraukU cultural zone of Rakhine State will become alive with travellers. MraukU is also a tourist destination like Bagan and so we invite the people to pay a visit it," said U Tin Htut Aung, director of the Rakhine State Directorate of Hotels and Tourism.

The State-owned MraukU hotel will be opened on 9 April. It contains 33 rooms and the vis-

itors can study the ward at which Thai's King daughter Sirindhorn stayed.

Myanmar's cultural heritages are concentrated in Bagan and MraukU. The companies also offer online services for air tickets, and land and waterway routes for the MraukU tour. They also make Sittway-MraukU trip plans by boat or car.

The ancient city of MraukU is located in the northern part of Rakhine State, which is the western part of Myanmar, and in the east of Kaladan River and surrounded by ranges of hills boasting ancient pagodas and stupas. The officials also make efforts for MraukU to be on the list of World Heritage. The tourism sector of Rakhine State will be revived with the travels of local/ foreign visitors to the MraukU region along with the Myanmar traditional Thingyan Festival in the Thingyan period this year. — Nyein Thu (MNA)/KTZH

Mural paintings of 90 ancient pagodas, stupas, edifices in Bagan to be renovated

MURAL paintings of 90 ancient pagodas, stupas, and edifices in Bagan will be renovated in collaboration with India, according to the Department of Archaeology and National Museums (Bagan Branch).

Since March, experts from

the Archaeological Survey of India have been visiting Myanmar to discuss the restoration and preservation of the mural paintings of pagodas and edifices in Bagan.

Deputy Minister for Religious Affairs and Culture Daw Nu Mra Zan signed the MoU and checked the renovation processes of the Nathlaung Kyaung, Thagyapon Pagoda, and Ananda Pagoda, and the maintenance of palaces belonged to King Anawrahta and King Kyansittha. - TWA/KZW

Myanmar-China border trade via Wang Ding crossing exceeds 2 bln yuan in Q1 2023

BORDER trade between Myanmar and China through the Wang Ding border amounted to over 2 billion yuan in the first three months of 2023, according to a statement released by the Chinese Embassy to Myanmar.

Between January and March 2023, over 67,000 trucks and over 87,000 travellers were allowed to pass the Wang Ding border point. The number of trucks passing increased compared to that of the year-ago period. The border trade value totalled 2.856 billion yuan from 849,000 tonnes of exports and imports in Q1.

Myanmar has opened Muse, Lweje, Chinshwehaw, Kampaiti and Kengtung border posts to conduct cross-border trade with China.

Myanmar mainly exports rice, broken rice, fishery products, rubber, dried areca nut and food products to China, while construction materials, electrical appliances, cement and pharmaceuticals are imported into the country. — TWA/EM

Myanmar-Thailand border trade values exceed \$5 bln in FY 2022-2023

THE border trade between Myanmar and Thailand in the last financial year 2022-2023 topped over US\$5.27 billion, according to the Ministry of Commerce.

The figures indicated an increase of \$462.13 million compared to that in the 2021-2022 FY.

The majority of the trade was carried out via the Myawady and Hteekhee border, the Ministry of Commerce's statistics showed.

The trade values stood at over \$148 million at Tachilek, \$2.03 billion at Myawady, \$224 million at Kawthoung, \$132 million at Myeik, \$2.72 billion at Hteekhee and over \$15 million at Mawtaung

border. Myanmar conveys onion, green gram, fresh and dried chilli pepper, rice powder, broken rice, corn, peanut, tamarind, cassava, cabbage, Mollusca, eel, crab, fish paste, shrimp, clam, anchovy, other fish, clothes manufactured on the Cutting-Making and Packaging basis to Thailand through Mvawadv.

The main export items are garments from the CMP busi $nesses, rice\ powder, corn, peanut,$ fish paste, chilli pepper, broken rice, onion, fishery products, cassava, tamarind, cabbage, transformer main and green gram. — TWA/EM

Corn price moves slightly up in domestic market

THE corn price rose above to K1,220 per viss on 6 April, according to the Yangon Region Chambers of Commerce and Industry (Bayintnaung commodity

From mid-March, the corn price stayed below K1,200 per viss.

The strong demand and the price increase in the Thailand market which is the main buyer of Myanmar corn pushed up the price, said corn traders.

At present, Myanmar delivered corn to China and Thailand through border posts and also shipped corn to China, India, Viet Nam and the Philippines by sea, according to Myanmar Corn Industrial Association.

China is purchasing Myanmar's corn through cross-border trade under the opium substitution programme. Legitimate corn trade between Myanmar and China commenced at the end of 2022. A total of 112 companies have been given the goahead for corn exports.

Thailand gives green light to corn imports under zero tariff (with Form-D), between 1 February and 31 August. However, Thailand imposed a maximum tax rate of 73 per cent on corn imports to protect the rights of their growers if the corn is imported during the corn season of Thailand.

The directive released on 30 June said that transactions for the exports of agricultural products including corn, rice, bean and oil crops are to be made in dollars instead of Yuan-Kyat/Baht-Kyat. Therefore, 65 per cent of export earnings (US dollars) of the corn have to be exchanged according to the reference rate of the Central Bank of Myanmar (K2,100). Nonetheless, there is a large gap between the regulated rate and the unauthorized rate of the US dollar (over K2,870).

Myanmar exported more than two million tonnes of corn

to foreign trade in the 2022 corn season. The majority of them were sent to Thailand and the remaining went to the Philippines, China, India and Viet Nam.

More than two million tonnes of corn are expected to be shipped to foreign trade partners in the 2023 corn season, said U Min Khaing, Patron of the Myanmar Corn Industrial Association.

At present, corn is cultivated in Shan, Kachin, Kayah and Kayin states and Mandalay, Sagaing and Magway regions. Myanmar has three corn seasons - winter, summer and monsoon. The country produces 2.5-3 million tonnes of corn every year. - NN/EM

400 companies fail to submit AR in March

A total of 400 companies failed to submit annual returns (AR) on the online registry system in March, MyCO, according to the Directorate of Investment and Company Administration (DICA).

The DICA notified any registered company which fails to file its AR on MyCO will be struck off the register from the date of the directive under Section 430 (F) of the Myanmar Companies Law.

Five hundred companies in January and 400 in February did not file the AR on MyCO. Additionally, 5,000 companies failed to submit AR in 2022, the DICA stated.

The registration and re-registration of companies on the MyCO website commenced on 1 August 2018 under the Myanmar Companies Law 2017.

All registered companies need to submit AR on the MyCO registry system within two months of incorporation, and at least once every year (not later than one month after the anniversary of the incorporation) under Section 97 of the law.

Under Section 266 (A) of the

Myanmar Companies Law 2017, public companies must submit annual returns and financial statements G-5 simultaneously. All overseas corporations must submit ARs in the prescribed format on MyCO within 28 days of the financial year ending, under Section 53 (A-1) of the Myanmar Companies Law 2017.

As per DICA's report, thousands of companies were suspended for failing to submit AR forms before the due date. Newly established companies are required to submit ARs within two months of incorporation or face a fine of K100,000 for filing late returns.

The DICA has notified that

any company which fails to submit its AR within 13 months will be notified of its suspension (I-9A). If it fails to submit the AR within 28 days of receiving the notice, the system will show the company's status as suspended. Companies can restore their status only after shelling out a fine of K50,000 for the AR fee, K100,000 for restoration of the company on the Register, and K100,000 for late filing of documents, totalling K250,000.

If a company fails to restore its status within six months of suspension, the registrar will strike its name off the register, according to the DICA notice.

If so, the duty-assigned personnel need to perform inspection and seizure of illegal goods applying their experienc-

Currently, the Customs Department applies the Myanmar Automated Cargo Clearance System-MACCS system as well as the Trade Department uses Myanmar TradeNet 2.0 and QR Code system in checking and managing the import and export of commodities to ensure the smooth and swift flow of commodities and to effectively hamper illegal trade measures.

It is necessary to manage the deployment of staff members and system in checking commodities whether is based on illegal or illegal trade processes. Only if so, will it be effectively eradicating the illegal trade. Authorities and officials should apply the techniques and systems appropriate for the current era in addition to conventional means

The seized commodities must be managed under systematic procurement procedures for the State to get deserved amount of income as revenue. Duty-assigned personnel make sacrifices and take risk of seizing illegally imported commodities. If the seized materials are damaged before the auction, the efforts of those personnel will be wasted as well as the State will lose income. As such. relevant departments need to take responsibility for supervising the seized materials.

Eradication of illegal trade is playing an important role in implementing the five-point roadmap and 12 objectives of the State Administration Council. Authorities and relevant bodies need to seek the best ways for hampering, inspecting and taking action against illegal traders and illegally imported goods more than now through comprehensive long-term plans for the sake of the State and legal traders such as businesspersons engaging in micro, small and medium-sized enterprises to have the capacity of market competitiveness.

Tokyo Electric Power (TEP-CO) on Tuesday released a series of video clips from a robotic survey inside Fukushima Daiichi plant's Reactor 1, one of three that suffered core meltdowns

"There were areas that we could not see. But we believe (damage) is spread across large areas," a TEPCO official told a briefing. The video showed damaged concrete walls exposing steel rods embedded inside, with debris piled roughly 50 centimetres (20 inches) high.

The video illustrated the daunting task ahead to decommission the plant after it was hit by a huge tsunami triggered by a 9.0-magnitude earthquake.

UK govt unveils new water plan after sewage discharges outcry

THE UK government on Tuesday announced its latest plan to better protect England's water supplies, amid a long-running scandal over privatized water firms pumping raw sewage into rivers and onto

The "Plan for Water" follows months of criticism over the release of untreated wastewater into Britain's waterways, which last summer sparked the closure of some beaches at the height of a heatwave. – AFP

Amsterdam's Schiphol airport to ban overnight flights by 2025

TO meet the Paris climate agreement, the Dutch airport is introducing a few new regulations for overnight flights and private jets.

In order to reduce noise pollution, the Dutch airport Schiphol will no longer allow commercial or cargo flights to depart between midnight and 6 am or land between midnight and 5 am.

Presently around 10,000 flights run during overnight hours, per year. Starting in November these flights will gradually be faded out. - AFP

Massive sperm whale beaches itself, dies in Bali

INDONESIAN animal experts were preparing Thursday to conduct an autopsy on an 18-metre (59-foot) whale that died after washing up on a beach in Bali, conservation officials said.

The sperm whale, believed to weigh many tonnes, beached itself in the east of the holiday island on Wednesday before locals and officials pushed it back

But after swimming away it became stranded again just hours later on a different beach and died on the shore with no visible wounds, local marine and fisheries official Permana Yudiarso told AFP.

"We are still investigating the cause of death. We want to get a scientific explanation of whether it was because of pollution or plastic," he said.

Sperm whales, the world's largest predators, are listed by the International Union for Conservation of Nature as being "vulnerable" to extinction.

Vets and forensic experts have arrived at the scene to investigate the cause of the whale's death, and its carcass will be buried in the coming days.

"Today we will conduct a necropsy test, and after that we

will get an excavator to try to bury the carcass nearby," Yudiarso said.

Police cordoned off the beach in Bali's Klungkung regency to stop the theft of the whale's meat or body parts.

Yudiarso said whales usually come closer to the shore when they are sick or dying.

In 2018, a sperm whale was found dead in Indonesia with more than 100 plastic cups and 25 plastic bags in its stomach, raising concerns about the Southeast Asian archipelago's massive marine rubbish problem. — AFP

'Infecting minds': US book sent to teachers seeks to sow climate doubt

FROM crops to corals, a book circulated by a controversial US think tank is riddled with misleading claims about established climate science, in what campaigners slam as a bid to "infect" young minds.

The free-market Heartland Institute drew outrage from campaigners and educators, but applause from climate skeptics, when it sent the book to more than 8,000 American school teachers this year "to present facts" it said were ignored or distorted by pundits and the media.

Bosnian leader convicted over Covid ventilators deal

THE prime minister of one of Bosnia's two regions was sentenced to four years in prison on Wednesday in a case involving the purchase of Chinese ventilators in the early days of the Covid-19 pandemic.

Fadil Novalic, who leads the Bosnia and Herzegovina federation, was taken in for questioning in May 2020 as prosecutors investigated the 5.4 million euro (\$5.9 million) deal.

The government had bought 100 ventilators through a company that usually specializes in fruit and vegetable preservation — and the devices turned out to be unsuitable for use with serious ill patients.

The court ruled that Novalic, 63, "abused his position"

by creating conditions for the company to buy the ventilators despite not being registered for importing medical equipment, state court judge Branko Peric

"The equipment did not even have the minimum required parameters" and "could not be used for the care of patients in serious condition", Peric said.

Novalic, who can appeal the sentence, was not in court for the verdict. He has previously denounced the trial as a "political case" aimed at discrediting him. The owner of the company, Fikret Hodzic, was sentenced to five years in prison, and the region's civil protection director Fahrudin Solak, who acted as middleman between the firm and the government, got a sixyear term on charges including forgery. — AFP

G7 trade ministers back tech export controls

THE G7 trade ministers pledged on Tuesday to work with other countries to strengthen export controls for technologies that could be used to threaten global security.

In a statement issued after their first talks of the year, held online, the ministers hit out at a range of unfair play in global trade, from non-transparency to economic coercion.

They did not mention

any country by name, but the meeting took place just days after Group of Seven president Japan unveiled planned export

controls on items used to make semiconductors.

Japan's move followed similar restrictions implemented last month by the Netherlands, as the United States presses its allies to restrict China's access to the technology.

Global trade growth to slow to 1.7% in 2023 amid Ukraine war: WTO

WORLD merchandise trade is expected to expand 1.7 per cent in volume in 2023, slowing from a 2.7 per cent gain last year, affected by the war in Ukraine, high inflation and tighter monetary policy, the World Trade Organization said Wednesday. The 2023 growth projection is above the 1.0 per cent increase estimated in October by the Geneva-based body, but far below the past 12-year average growth figure of 2.6 per cent, according to its "Global Trade Outlook and Statistics" report.

"The lingering effects of COVID-19 and rising geopolitical tensions were the main factors impacting trade and output in 2022 and this is likely to be the case in 2023 as well," WTO chief economist Ralph Ossa said in a press release.

Geopolitical fragmentation could cut global growth by 2%: IMF

GROWING geopolitical fragmentation around the world, including the US-China trade war and the Russian invasion of Ukraine, could cut global growth by two per cent, the International Monetary Fund said Wednesday.

Research by the IMF found that growing geopolitical tensions were causing a reallocation of foreign direct investment (FDI) away from countries that were geographically close and towards those that were geopolitically close, like the US and Europe.

This reallocation of FDI has the potential to cause serious damage to emerging market economies, the IMF said, since they are more reliant on inflows of investment from more geopolitically distant countries.

"In general, a frag-

mented world is likely to be a poorer one," IMF officials wrote in a blog post published Wednesday to accompany the research.

The IMF also published research on Wednesday outlining the impact to the banking sector of geopolitical fragmentation, highlighting the cost to Russia and its allies of the 2022 invasion of Ukraine.

"Cross-border banking and portfolio debt flows to Russia and its allies (countries that rejected the motion in the United Nations in March 2022 to condemn Russia's war on Ukraine) have reversed sharply, with allocations falling by about 20 and 60 per cent relative to prewar levels, respectively," IMF officials wrote in a blog post. — AFP

Putin accuses Western spies of role in 'terror attacks' in Russia

PRESIDENT Vladimir Putin on Wednesday accused Western security services of having helped Kyiv stage "terror attacks" in Russia, after giving an icy welcome to the new US and EU ambassadors.

His Ukrainian counterpart Volodymyr Zelensky meanwhile made a rare foreign visit to Warsaw in a show of thanks for Poland's support since the start of Russia's offensive.

Putin spoke at a meeting of the Kremlin's security council dedicated to ensuring law and order in four Ukrainian territories he claimed to have annexed last year.

"There are grounds to assert" that other countries and Western intelligence services were involved "in staging sabotage and terrorist attacks", Putin said in televised remarks.

In what appeared to be a reference to the Ukrainian authorities, Putin said "neo-Nazis and their accomplices were acting" in Russia as well as the annexed territories including the regions of Zaporizhzhia and Kherson.

Putin's remarks come days after an explosion at a cafe in Russia's second city, Saint Pe-

tersburg, killed a high-profile military blogger and staunch supporter of Moscow's assault on Ukraine, Vladlen Tatarsky.

Moscow said the attack had been orchestrated by Ukraine with help from supporters of jailed critic Alexei Navalny. Kyiv has blamed it on Russia's domestic infighting.

But Russian foreign ministry spokeswoman Maria Zakharova said Wednesday the blogger's death would be "one of the topics of discussion" at the UN Security Council, where Moscow has taken over the rotating presidency. — AFP

Iran-Saudi vow to bring Mideast 'security, stability'

In a joint statement released after talks between Iranian Foreign Minister Hossein Amir-Abdollahian and Saudi counterpart Prince Faisal bin Farhan, the two sides vowed to continue to work together to improve ties.

"The two sides emphasized the importance of following up on the implementation of the Beijing Agreement and its activation in a way that expands mutual trust and the fields of cooperation and helps create security, stability and prosperity in the region," said the statement. Tehran and Riyadh announced a Beijing-brokered agreement in March to restore relations that had been severed seven years ago when protesters in Iran attacked Saudi diplomatic missions. — AFP

Four children killed in attack on Brazil preschool

A 25-year-old attacker burst into a preschool in southern Brazil and killed four children Wednesday with a bladed weapon before turning himself in to police, authorities said.

Police and government officials in the state of Santa Catarina said the man had also wounded four victims at the private preschool, known as the Good Shepherd Centre, in the morning attack in the city of Blumenau. - AFP

Thousands of migrants stranded in north Niger's scorching desert

The strong walkers are at the front. The weakest at the rear.

Every week hundreds more migrants thrown out of Algeria end up here in Assamaka, the first village on the Niger border.

More than 4,500 of them so far have washed up in this tiny windswept corner of the Sahara -- Malians, Guineans and Ivorians mainly, but also Syrians and even Bangladeshis.

They have marched across 15 kilometres (nine miles) of wasteland only to enter a new purgatory. -AFP

French minister defends Playboy shoot as criticism mounts

A feminist French minister who posed for Playboy told the magazine she backed the right of women to pose nude if they wanted to amid fresh criticism from her cabinet colleagues about her stunt on Wednesday.

Marlene Schiappa, currently minister for the social economy and associations, appears in the French edition of Playboy this month which is set to hit shelves on Thursday, although the photos have already leaked to French media.

In the shots to accompany the 12-page interview, Schiappa strikes a series of poses — all fully clothed — featuring extravagant dresses and outfits in the red, white and blue of the French tricolour.

"If some (women) want to pose in a men's magazine and enjoy it, I think that we shouldn't blame them," Schiappa told the magazine.

She cited Pamela Anderson as an inspiration after the US glamour model spoke of how

posing for Playboy had been "an act of emancipation".

"Like the Miss France. If they enjoy winning a beauty contest, I find that great too and we should support them," Schiappa continued.

The lengthy interview features several innuendo-laden questions, including "is politics an aphrodisiac?", and delves into the 40-year-old's past as an erotic novelist and author on issues such as the female orgasm. — AFP

Xi holds talks with French president

CHINESE President Xi Jinping held talks with French President Emmanuel Macron in Beijing on Thursday.

Xi welcomed President Macron's state visit to China after a lapse of over three years, saying that over the past three years and more, despite a changing and unstable international landscape, China and France have worked together to maintain a positive and sound growth momentum in their bilateral ties.

He said the two sides have maintained high-frequency and high-quality strategic communication in a hybrid format, supported each other in the fight against COVID-19, and seen robust growth in bilateral trade and important outcomes from cooperation in aerospace, aviation, agriculture, food and other areas.

The two countries have also carried out close communication and coordination on such issues as climate change, biodiversity, and Africa's development, Xi

Noting that the world today is undergoing profound historic

transformation, Xi said China and France are permanent members of the UN Security Council and major countries with a tradition of independence.

"China and France are firm advocates for a multi-polar world and for greater democracy in international relations. They have the ability and responsibility to rise above differences and obstacles, keep to the overall direction of a comprehensive strategic partnership that is stable, mutually beneficial, enterprising and dynamic, and practice true multilateralism for global peace, stability and prosperity," he said.

Noting that President Macron's visit to China is the first by a European head of state after the full resumption of China's exchanges with the world and the successful conclusion of China's "two sessions", Xi said the visit will inject new momentum and bring new vitality to China-Europe relations. — Xinhua

UK leases barge to house 500 asylum seekers

BRITAIN on Wednesday announced plans to house around 500 asylum seekers on a barge, as the government seeks cost-cutting measures and deterrents

 $for \, arrivals \, crossing \, the \, Channel.$

Following his pledge to stop the small boats used by tens of thousands of migrants each year to make the treacherous trip, Conservative Prime Minister Rishi Sunak said the barge would save money and reduce pressure on hotels.

The Conservative government has already put forth a plan to outlaw asylum claims by all illegal arrivals and transfer them to "safe" third countries, such as Rwanda.

"We have to use alternative accommodation options, as our European neighbours are doing — including the use of barges and ferries to save the British taxpayer money and to prevent the UK becoming a magnet for asylum shoppers in Europe," said Immigration Minister Robert Jenrick

UN demands Taliban revoke ban on women staff

TOP UN officials warned Wednesday that a Taliban government ban on Afghan women working for its mission in the country would violate the world body's charter, and demanded it be revoked.

The United Nations also announced it had instructed all its Afghan staff, men and women, not to report to the office after the ban was confirmed.

Under their austere interpretation of Islam, Taliban authorities have imposed a slew of restrictions on Afghan women since seizing power in 2021, including banning them from higher education and many

government jobs.

The increasing curbs are reminiscent of the Taliban's first government between 1996 and 2001, when the UN said they were responsible for repeated human rights violations — particularly against girls and women.

UN Secretary-General Antonio Guterres demanded the ban be "immediately revoked".

"This is a violation of the inalienable fundamental human rights of women," spokesman Stephane Dujarric said in a statement on behalf of Guterres on Wednesday. — AFP

Justice Dept agrees to pay \$144.5 mln to Texas shooting victims

THE Justice Department announced a \$144.5 million settlement on Wednesday with victims of a 2017 mass shooting at a church in Texas that left 26 people dead and 22 injured.

The agreement in principle, which still needs court approval, is aimed at resolving civil lawsuits stemming from the attack carried out by a former member of the US Air

Force, the department said in a statement.

A federal district court judge ruled in July 2021 that the government was partly liable because the air force failed to enter information into the FBI's background check system that would have prevented the assailant from buying a gun.

Devin Kelley, who killed

himself after carrying out the attack at the First Baptist Church in Sutherland Springs, had a conviction for domestic violence on his record and had been court-martialed.

The Texas judge who heard the case ordered the government to pay more than \$230 million to victims of the attack but the Justice Department appealed the ruling. — AFP

SIX of Qatar's eight World Cup stadiums will be used for the Asian Cup to be staged in the Gulf state next January, the AFC has announced.

But the Lusail stadium used for the World Cup final and the iconic 974 stadium made from containers will not be part of the 24-nation tournament to run from 12 January to 10 February.

The Asian Cup was originally meant to be held this year in China but was switched and delayed because of the country's coronavirus restrictions.

Asian Football Confederation president Salman bin Ebrahim Al Khalifa said that based on Qatar's hosting of the World Cup last year the Asian Cup will be "a true spectacle never before experienced in Asian football history".

"We have every faith that they will showcase their unrivalled hosting capabilities, state-of-the-art infrastructure and warm hospitality," he added

in comments made when the Kuala Lumpur-based AFC released the dates late Wednesday.

Qatar will use the Al Janoub stadium, Al Bayt stadium, Ahmed Bin Ali stadium, Al Thumama stadium, Education City stadium and Khalifa International stadium which were all part of the multi-billion dollar infrastructure laid on for the World Cup. The smaller Jassim bin Hamad stadium and Abdullah bin Khalifa stadium will also be used, the AFC said.

The 974 stadium near the Doha seafront is scheduled to be dismantled and donated to a developing country. Some containers have already been taken away but authorities have not yet said where the stadium will go.—AFP

French army fears overstretch at 2024 Paris Olympics

LIKE past Olympic host nations France plans to deploy soldiers for securing the 2024 summer games in Paris, but army and government sources have told AFP that they fear the forces being overloaded.

"It's completely logical for the armed forces to contribute" to Olympic security, Chief of Defence Staff Thierry Burkhard told defence committee MPs Thursday. He trailed a deployment of up to 10,000 soldiers — matching the "Operation Sentinelle" forces created to patrol following 2015's terrorist attacks in Paris.—AFP
