DEPUTY Prime Minister Admiral Tin Aung San, who is a member of the State Administration Council and also the Union Minister of the Ministry of Transport and Communications, welcomed a delegation led by Mr Wei Gang, the Governor of the People's Government of Dehong Autonomous Prefecture of the People's Republic of China, at the ministry in Nay Pyi Taw yesterday.

During the meeting, they discussed the operation of four weekly flights between Mangshi and Mandalay by Ruili Airline. Myanmar National Airlines will operate three weekly flights between Yangon, Mandalay, and Mangshi, while also expanding passenger and cargo flights to other potential cities. Collaboration needed to safeguard people's right to accurate information, emphasizes Union Information Minister

UNION Minister U Maung Maung Ohn, speaking at the Four Pillars Workshop held in Nay Pyi Taw yesterday, stressed the critical impact media outlets have on the country's peace, stability, development, and unity. He highlighted the need for various sectors to work together to ensure the public's right to accurate information.

In his address, the Union minister emphasized that the media must uphold the three pillars of the country - the legislative, the administrative, and the judiciary - on behalf of the public. Achieving this demands cooperation to guarantee the right to information.

"Mutual respect and understanding the nature of each pillar are essential," he added, pointing out that transparency can be achieved through cooperative efforts. He urged the four pillars, including the media, to collaborate in ensuring qualified journalists and safeguarding the public's right to access correct information.

Reflecting on the past, the Union minister noted that the relations between the media

and the three pillars were smooth during the early years of democracy. However, with the outbreak of COVID-19 and political changes, the proliferation of false information, disinformation, and the rapid spread of news via social media platforms have made it challenging to provide true and reliable news to the public.

In light of this situation, he emphasized the importance of providing accurate information to the public and creating opportunities for them to discuss their concerns openly. This way, people will increasingly rely on the three pillars and media for credible information.

The Union minister called for a collaborative effort between the government and media to develop a Professional Development Programme for media personnel to ensure their growth and skills enhancement.

During the workshop, State Administration Council Member Daw Dwe Bu, Union Minister U Maung Maung Ohn, Chairman of Myanmar Press Council U Ohn Maung (Myinmu Maung Naing Moe), Union Minister Dr Thida Oo, and Union Minister U Aung Naing Oo, discussed ways to promote cooperation among the four pillars.

The workshop, moderated by Myanmar Media Development Group Member U Ko Ko (Ko Ko-RIT), also saw participation from Deputy Ministers, advisory board members of the SAC Chairman, departmental officials, and journalists. They engaged in discussions on finding proper solutions to ensure the right to information for citizens, conducting training courses by Myanmar Press Council, supporting journalism career growth, facilitating fast flow of information, and upholding freedom of the press while addressing challenges in digitalization, illegal satellite use, and online media.

The primary objectives of the workshop were to foster mutual respect based on media ethics among the legislative, administrative, and judiciary branches, and to explore ways to enhance cooperation within the Myanmar media sector while ensuring the public's right to information. The participants aimed to build better relations among the four pillars and develop effective future work plans through suggestions and information exchange.

The Ministry of Information and Myanmar Press Council jointly hosted the workshops, on 30 December 2016, 21 February 2018, 30 April 2019, and 21 August 2020. — MNA/KTZH

Yangon commodity market sets new price opening conditions

TRADERS are closely monitoring the Yangon beans and pulses market, as the prices fluctuate almost daily for these exported goods.

Currently, buyers request dealers to present sample packs of beans and pulses for evaluation, unlike the practice before 2010 when they were openly displayed. After the commodity depot's closing hours, some traders engage in price negotiations over the phone during the evening and night.

In the morning, the lower hall of the Bayintnaung Commodity Depot is bustling with the sale of commodities like onions and potatoes. During this time, onion, jaggery, and chilli pepper traders set their opening prices at certain streets and brokerage house meeting points. Potato traders set their opening prices around 10 am, while bean traders open their markets at noon, and edible oil traders start trading at 1 pm.

The commodity prices for the day are available both online and in paper form, pub-

lished by the commodity depot after compiling the price list for Yangon and the export FOB price sheet. However, the prices of rice and palm oil are not mentioned in the daily price list of the Bayintnaung Commodity Depot as they belong to specific non-governmental organizations (NGOs).

Before 7 am, some broker-

age houses register the daily supply of onions and potatoes, noting the number of truckloads and the origin regions. They use this information to set their opening prices at the rallying place in front of the brokerage house on Yaytama Road. Regional traders, especially those from Nyaungpinlay Market in Lanmadaw Township, closely monitor these opening prices for fluctuations.

For those who cannot visit the Bayintnaung Market in person, the daily prices can be observed through social media posts around 7 am. Some regional traders may pay more than the official opening price to buy rare goods. When demand is low at the market's opening, the brokerage houses may sell at an adjusted price below the opening price.

In the market, both sellers and buyers must establish mutual trust, not only regarding the goods but also the prices. Buyers often prefer to purchase goods on credit rather than make immediate payments. Although the commodity depot sets the credit period for goods to be not more than two weeks, the actual credit period is often longer, depending on agreements between the seller and the buyer. To access the commodity trading area, a recognized membership card is required. The Bayintnaung Commodity Depot, being the largest trading centre in Yangon, holds great importance for traders.

The brokerage houses in the Bayintnaung Commodity Depot were relocated from Lanmadaw and Latha Townships. The depot was established around 1993, making both the depot and brokerage houses nearly 30 years old.

China invites Myanmar entrepreneurs to new energy vehicle plant, relevant forum

MYANMAR entrepreneurs can visit the new energy vehicle plant and study the forum on new energy vehicles in Liuzhou of China, according to Myanmar Consul-General U Kyaw Soe Thein in Nanning.

The consul-general met Ms Cai Xuping, Director of the Guangxi Institute of Science and Technology at the Myanmar Consulate-General in Nanning on 24 July.

During the meeting, Ms Cai Xuping said arrangements will be made for Myanmar entrepreneurs and vehicle manufacturing-related representatives of ministries to visit China on study tours to the new energy car plant in Liuzhou and a forum in connexion with the new energy vehicle will be organized sentatives to attend the third China-ASEAN Standardization Cooperation Forum to be held in Liuzhou on 12 and 13 October.

Myanmar's attendance at the panel discussion titled "New Energy Vehicle" included in the **China-ASEAN Standardization** Cooperation Forum as well as the study tour of the new energy car plant will bring benefits to the country that imports electric vehicles mostly from China. Moreover, it can boost the business connections between Myanmar and Chinese entrepreneurs who mainly operate electric vehicle production. Additionally, the consul-general also invited Chinese entrepreneurs to make investments in the Thilawa Special Economic Zone to manufacture new energy vehicles in Myanmar. — ASH/KTZH

A total of 338 small-scale industries which could not operate for various reasons were cancelled from the registration list and a total of 463 businesses were registered during the three months from April to June of the financial year 2023-24, according to the Department of Small-Scale Industries under the Ministry of Cooperatives and Rural Development.

During the financial year 2022-2023, a total of 100 non-operational small-scale industries were cancelled from the registration list. Currently, a total of 19,526 small-scale industries registered with the Department of Small-Scale Industries up to June of the financial year 2023-2024 are in operation. — TWA/MKKS

Mandatory adherence to rules for EV-importing companies

A committee on the development of importation, installation and investment of electric vehicles and associated businesses emphasized that actions will be taken if EV importing companies fail to comply with the rules regarding EVs and related components.

Some companies are found to be making pre-order sales at showrooms and through social networks.

The committee held coordination meetings with EV importing companies in April and June and has already notified them that they are not to make more than 20 per cent profit on CIF price, not to advertise online and not to make pre-orders without vehicles arriving at the Port.

If the companies violated those policies, they will get their export/import licence revoked and face legal actions under the Consumer Protection Law, the committee warned.

Importation, manufacturing and trading of the battery electric vehicles (BEVs) and their components are exempted from commercial tax, according to Notification 4/2023 released by the Union Government on 8 May

2023, in the exercise of the power conferred by Section 37 of the Union Tax Law 2022, under the approval of the State Administration Council.

Also, the Customs duty exemption on electric vehicles (EVs) and their components was extended until the end of March 2024, according to the Ministry of Planning and Finance. Myanmar Investment Commission also released a statement on 15 February that electric vehicles and related businesses will be promoted as the priority sector, according to its notification dated 15 February.

In the exercise of the power conferred by Sections 43 and 100 (B) of the Myanmar Investment Law, the MIC issued this statement with the approval of the Union government.

Enterprises executing installation, manufacturing and restoration services of the EVs, renewable electricity generation, EVs charging service businesses, electric vehicle battery production, EV battery and related service business, electric bus operation services, electric taxi and transport service businesses and scientific research development business are included in those priority sectors.

During the establishment and ideation phase for incorporation and operations, those businesses can seek permits from the MIC to enjoy tariff relief or zero-customs tariff status and the exemption for other taxes levied in the country under Section 77 (A) of the Myanmar Investment Law and income tax exemption under Section 75 (C) of the Myanmar Investment Law for the importations of machinery, essential equipment and accessories, spare parts and construction raw materials that cannot be found in domestic markets.

Myanmar has been bringing in electric vehicles (EVs) under the Customs tariff relaxation through seaborne and border trade routes, according to the Ministry of Commerce.

As of 30 June, 3,206 EVs were registered with the Road Transportation Administration Department, including 467 private EVs, two light load trucks, 2,474 two-wheel vehicles and 263 three-wheel vehicles. — NN/EM

Kyat weakens to K3,280 against US dollar, contrary to CBM reference rate of K2,100

KYAT against greenback appreciated at approximately K3,280 in the grey market although the Central Bank of Myanmar set the reference exchange rate at K2,100, the traders involved in the forex market said.

CBM has set the currency trading band at 0.3 per cent for the Kyat to fluctuate between these two specified upper and lower exchange rates for transactions, selling or buying, according to a directive issued by the CBM on 10 August 2022. There is a large price difference between the reference rate of the CBM and the unofficial market rate. Yet, there is no way for the CBM to set the new price, as per the notification released in May 2023.

The CBM announced on 23 July that it will issue the new K20,000 notes from 31 July 2023. The new currency notes will be issued in a limited number in exchange for the torn, defective and damaged notes. However, the prices of gold and the dollar exchange rate are gaining, following the news of new currency notes. Pure gold was priced at K3.61 million per tical, while a US dollar is exchanged at K3,460 in recent days.

Myanmar Embassy in Kuala Lumpur increases passport fine to 480 Ringgit

STARTING from 24 July, the Myanmar Embassy in Kuala Lumpur, Malaysia, has announced an increase in the fine for Myanmar passports from 330 ringgit to 480 ringgit.

The embassy pointed out a rising number of Myanmar citizens applying for passport services (renewal/lost/new) and appointments are issued daily. Passport appointment dates are announced promptly on the embassy's website and Facebook page, and Myanmar nationals must bring the required documents on their appointed dates to complete passport procedures. – TWA/MKKS

Sugar price in Yangon reaches K3,350 per viss

SUGAR prices in the Yangon market is cool in July and prices on 25 July remained unchanged as those on 24 July. The prices rose K50 per viss and it became K3,350 per viss while K3,400 for fixed jaggery and K3,500 for normal jaggery, purchaser Ko Aung told The Global New Light of Myanmar (GNLM).

On 29 May, the sugar price reached K3,280-3,320 per viss and it dropped again. On 5 June, it was K3250-3300 per viss and K3,230-3,270 between 30 June and 23 July.

Although the wholesale price was set at K3,270 per viss, the Htatesa is K3,300 per viss and K3,270 per viss for ones that contain a little moisture, said a sugar miller from the Aungthapyae road of Bayintnaung.

The sugar price is cool for nearly the whole month and it rose again like the prices of onion, palm oil and rice in the Yangon market on 24 July.

The sugar was permitted to be re-exported to China via land borders in 2016. At that time, the sugar wholesale price rose to K1,600 per viss and K1,500 in 2017.

After such operation was suspended, about four million bags of sugar and rice exported by various countries were stacked at the border areas in 2019, the media reported.

The sugar prices fell in 2019 and 2020 and bounced again in 2022 and it reached K3,350 per viss in mid-2023.

While the sugar price was high, the sugarcane was priced at K40,000 per tonne and reached about K90,000 per tonne by the end of 2022.

The local sugar consumption rate is about 450,000 per year and the local production rate is about 500,000 tonnes a year. It also exported 50,000 tonnes of sugar surplus. The international sugar price was \$600 per tonne in 2022 while \$700 in June 2023 and \$650 during this month.

India's sugar production is estimated up to 36 million tonnes in the 2023-2024 marketing year and domestic sugar consumption is estimated at around 27.5 million tonnes.

There are about 20 sugar mills in the country and the sugar brands produced from the sugar mills of northern Shan State occupied the first place in the market. The Yangon market sets sugar prices depending on the prices of the Mandalay sugar market.

Farmers earn higher incomes as the prices of rice, cooking oil, onion, garlic, tomato, sugar and beans and pulses rose in 2022 and 2023. – TWA/ KTZH

TikTok rivals Twitter with new text format

TIKTOK, the social platform known for its addictive video content, announced Monday that it will offer text-only posts, becoming the latest tech giant to offer an alternative to embattled Twitter.

The text posts on TikTok will most closely resemble similar offerings on Instagram, which earlier this month also launched a challenge to Twitter — which owner Elon Musk renamed X — called Threads.

Like Meta-owned Threads, TikTok benefits from its size, with around 1.4 billion monthly active users, according to specialist site Business of Apps.

But unlike Facebook's parent company, it has chosen to integrate its new text-only feature into its app rather than launch a separate product, as Meta did with Threads.

TikTok's version will remain more visual than a Twitter or Threads post, with users able to add a colour background, music and stickers to the post.

The Chinese-owned company said the new format will expand "boundaries of content creation for everyone on TikTok" and tap into the "creativity" seen in comments and captions, the company said.

In addition to Threads, smaller platforms such as Mastodon, Bluesky and Substack Notes have emerged as potential rivals to Twitter, but none have so far dethroned it despite its troubles. — AFP

Thousands of Afghan parlours close as Taleban deadline bites

THOUSANDS of beauty parlours across Afghanistan closed permanently on Tuesday following an order by Taleban authorities that cuts off one of the few revenue streams available to women, as well as a cherished space for er in August 2021, the Taleban government has barred girls and women from high schools and universities, banned them from parks, funfairs and gyms, and ordered them to cover up in public. But an order issued last sands of salons nationwide run by women—often the only source of income for households and one of the few remaining places for them to gather away from home.

"We used to come here to spend time talking about our future together. Now even this right has been taken away from us," said Bahara, a salon customer in the capital Kabul. "Women are not allowed to enter entertainment places, so what can we do? Where can we go to enjoy ourselves? Where can we gather to meet each other?" Last week, security officials shot into the air and used firehoses in the city to disperse dozens of women protesting against the order. On Tuesday, many salons in Kabul had already closed, while others were staying open until the last

Tupac Shakur ring sells for record \$1 million

A gold, ruby and diamond crown ring worn by rap legend Tupac Shakur during his last public appearance sold for \$1 million at auction in New York Tuesday.

The winning bid was well above Sotheby's pre-sale estimate of between \$200,000 and \$300,000 and becomes the most valuable hip-hop artifact ever sold, the auction house said.

The New York-born rapper wore the ring during his final public appearance at the MTV Video Music Awards on September 4, 1996.

He was shot dead by an unidentified assailant in a driveby shooting in Las Vegas just days later on 13 September. He was 25.

Shakur, whose hits included "California Love", designed the ring over the course of a few months, Sotheby's said.

He did so through his godmother Yaasmyn Fula, who put the ring up for sale.

Shakur was influenced by 16th century Italian philosopher Niccolo Machiavelli's political manifesto "The Prince" which he read while in prison on sex abuse charges.

He modeled the design on the crowns of the medieval kings of Europe, Sotheby's added.

The ring is engraved "Pac & Dada 1996," a reference to his girlfriend Kidada Jones. — AFP

Iran's Zoroastrians keep ancient, sacred flame burning

A Zoroastrian priest dressed in white carefully added wood to a fire that has burned for centuries inside an Iranian temple, sacred to one of the world's oldest religions. Record grain harvest eyed as market under pressure

THE world is heading for a record grain harvest in the 2023-2024 season thanks to gains for maize and rice, but the market remains under pressure thanks to El Nino and risks due to the war in Ukraine.

The International Grain Council (IGC), which includes both major producer and consumer nations, now forecasts 2.3 billion tonnes of grains excepting rice, slightly higher than the 2021-2022 season.

Maize production continues to rise, with a 5.5 per cent rise to 1.2 billion tonnes, thanks to more acreage in the United States and a record harvest expected in Brazil.

The IGC expects the production of rice, the top grain consumed by people, to rise by

2.5 per cent to 527 million tonnes. But the wheat harvest is ex-

pected to come in at 784 million tonnes. That is stable in compar-

ison to the last five years, but a reduction of 2.4 per cent from last

year when Russia and Australia had bumper harvests.

Hard time for hard wheat

"The pressure on wheat is due to the consumption forecast which is 20 million tonnes more than production," said Damien Vercambre, a trader at Inter-Courtage commodities brokerage.

Demand for maize is even stronger, with consumption up by 30 million tonnes over the past year, but is covered by production. The increase is essentially for animal feed and is a sign of "the return of economic growth in Asia, where people eat more meat when their income permits," said Vercambre, but he noted the uncertainty around China's recovery. — AFP

Australia to remain as reliable gas supplier for Japan: minister

THE Australian energy minister said Wednesday the country will remain a "reliable energy supplier" for Japan after the resource-poor country expressed concern over Canberra's new rule restricting carbon emis-

sions.

"We are committed to working with Japan, one of our most important partners," Climate Change and Energy Minister Chris Bowen said in his speech in Tokyo, vowing that Australia will continue to supply the country with resources such as liquefied natural gas and coal.

His remarks came after a new Australian law came into force on 1 July, requiring new LNG facilities to be carbon neutral, while facilities already in operation need to lower their carbon emissions by 4.9 per cent a year until 2030 and more after that year.

Japan imports more than 40 per cent of its LNG from Australia.

While assuring that Australia remains committed to its energy exports to Japan, Bowen also said his country will endorse renewable energy solutions as a way to reduce carbon emissions. — Kyodo

As West fears Tunisia collapse, hopes of IMF bailout fade

WESTERN nations fear an economic collapse in Tunisia could trigger even greater migrant flows to Europe and have offered financial assistance. Yet prospects of Tunisia's sealing the biggest deal of all — a \$1.9-billion bailout from the International Monetary Fund — seem increasingly remote.

The inflation-ravaged and heavily indebted country reached a tentative deal for the loan from the Washington-based IMF in October.

It would require Tunis to undertake what the IMF calls a "comprehensive economic reform programme" that would phase out subsidies on fuel and electricity.

But President Kais Saied has repeatedly rejected "foreign diktats that will lead to more poverty".

In March, US Secretary of State Antony Blinken warned Tunisia urgently needs to reach an IMF deal because its economy "risks falling off the deep end". That followed European Union foreign policy chief Josep Borrell's concern that a collapse "economically or socially" in Tunisia would trigger a new flow of migrants to Europe — an assessment rejected by Tunis. — AFP

US consumer confidence rises to two-year high amid easing inflation, tight labour market

US consumer confidence in July rose to its highest level in two years, amid easing inflation and continued optimism for the labour market despite worries about a recession.

The Consumer Confidence Index climbed to 117 this month, up from 110.1 in June, according to the latest survey released by The Conference Board, a business research group, on Tuesday. It was the highest level since July 2021.

The Present Situation Index improved to 160 from 155.3 last month, and the Expectations Index surged to 88.3 from 80.0 in June, the monthly survey showed. Economists believe despite rising interest rates, US consumers are more upbeat, likely reflecting lower inflation and a tight labour market. The consumer confidence increase in July reflected pops in both current conditions and expectations, said Dana Peterson, chief economist at The Conference Board. — Xinhua

Nissan to invest up to 600 mln euros in Renault's new EV unit

NISSAN Motor Co will invest up to 600 million euros in Renault SA's new electric vehicle unit, after they signed an agreement to revamp their decades-old capital alliance to allow for more management flexibility and meet growing demand for zero-emission cars, the two automakers said Wednesday.

Under the new partnership, Renault will reduce its stake in Nissan to 15 per cent from 43.4 per cent while the Japanese firm will retain its 15 per cent stake in the French partner.

The Japanese carmaker could take a less than 10 per cent stake in in the new EV business called Ampere to be spun off from Renault, according to people familiar with the matter.

Nissan had been cautious about participating in the joint venture due to concern over the terms of the deal, including how its EV-related intellectual property would be handled, and that had delayed the deal being agreed to from the originally planned end of March.

Nissan's investment in Ampere had been widely seen as a prerequisite for Renault's agreement to shed its stake in Nissan, analysts say.

The reshaped alliance, a significant change from the structure of the tie-up formed more than two decades ago, comes after resentment grew at Nissan, where it was felt Renault was too dominant despite the fact that Nissan sells more cars than the French automaker.

Renault initially took a 37 per cent stake in Nissan in 1999 to rescue the Japanese carmaker from the brink of bankruptcy. Since then, Nissan has regained its financial soundness and became the main growth driver in the alliance under former CEO Carlos Ghosn who was sent in by Renault. — Kyodo

UK bank NatWest CEO resigns after Farage 'error'

THE chief executive of Britain's NatWest bank, Alison Rose, stepped down Wednesday after admitting a "serious error of judgement" in speaking to a reporter about the banking affairs of arch-Brexiteer Nigel Farage.

Farage, former leader of the Brexit Party and the anti-immigration party UKIP, had complained about the closure of his account with the upmarket Coutts, the bank used by the late Queen Elizabeth II and subsidiary of NatWest.

He said he was removed as a client for his political views.

But, in a report which it has since apologized for, public broadcaster the BBC suggested Farage's accounts were closed because he did not have sufficient funds to remain a client of the prestigious establishment. Rose previously admitted she was the source for the story, and acknowledged "a serious error in judgement" in discussing Farage's relationship with the bank.

NatWest's board on Tuesday gave its backing to Rose, a 30-year veteran of the company. But by early Wednesday it announced she was stepping down.

Farage, a Euroscep- n

tic politician and now a television presenter, campaigned for decades for Britain's withdrawal from the European Union and was a key figure in the 2016 Brexit referendum.

"The Board and Alison Rose have agreed, by mutual consent, that she will step down as CEO of the NatWest Group," board chairman Howard Davies said in a statement. — AFP

TotalEnergies drills first oil wells for huge Uganda project

TOTALENERGIES announced Tuesday it had started drilling wells for oil in Uganda as part of a huge project condemned by environmental and rights groups.

The French oil major and the China National Offshore Oil Corporation (CNOOC) signed a \$10-bilfields and ship the crude via a 1,445-kilometre (900mile) pipeline to Tanzania's Indian Ocean port of Tanga. N Korea to mark war anniv with China, Russia delegations

NORTH Korea is set to commemorate the 70th anniversary of the Korean War armistice Thursday with Chinese and Russian delegations, in an apparent show of unity amid their respective rivalries with the United States.

Pyongyang could stage a military parade in the early hours of Thursday, according to sources familiar with inter-Korean relations. The delegations sent by Beijing and Moscow are the first known foreign groups to be invited to North Korea since the country's 2020 COVID border closure.

Russian Defence Minister Sergei Shoigu, who is leading Moscow's delegation, held talks with his North Korean counterpart Kang Sun Nam and agreed to strengthen bilateral defence cooperation, calling Pyongyang an "important partner", Russia's Defence Ministry said Wednesday.

The Chinese group is headed by Li Hongzhong, a member of the ruling Communist Party's Political Bureau.

There is a possibility that Shoigu and Li will meet North Korean leader Kim Jong Un during their stay. If realized, their talks will be the first contact between Kim and senior foreign officials since the leader met with then US President Donald Trump at the Demilitarized Zone dividing the two Koreas on 30 June 2019. — Kyodo

N Zealand 'open to conversations' about role in AUKUS defence pact

NEW Zealand is "open to conversations" about a possible role in the AUKUS defence pact, its prime minister said Wednesday, opening the door to cooperation that could rile trade partner China.

Speaking to reporters in Wellington after meeting his Australian counterpart, Chris Hipkins said New Zealand could participate in the Australia-UK-US pact as long as it did not relate to the development of nuclear submarines. "I think there's no question that we have a different position around nuclear, in terms of nuclear propulsion (which is) also covered by New Zealand's nuclear-free arrangements, " Hipkins said. New Zealand has been nuclear-free since the mid-1980s. But he indicated that cooperation with AUKUS could take place on defence technologies such as cyber, artificial intelligence and hypersonic weapons — the agreement's so-called "pillar two".

New Zealand's participation had been "an ongoing topic of conversation between our two countries over the last couple of years, and particularly in the last six months", Hipkins said.

"But in terms of pillar two... we're open to conversations with the AUKUS partners around what New Zealand's involvement might look like." — AFP



One dead as typhoon Doksuri batters Philippines

TYPHOON Doksuri was packing maximum sustained wind speeds of 175 kilometres an hour (110 mph) as it hovered over waters around Dalupiri Island, off the northern tip of the main island of Luzon, the state weather agency said in its latest update at 0300 GMT.

The agency warned of "vio-

lent, life-threatening conditions" as severe winds and heavy rain pounded the lightly populated region. A woman selling bread rolls died when she was hit by a falling coconut tree in Ramon municipality in the northern province of Isabela on Wednesday, provincial disaster official Constante Foronda told AFP.

Rey Aguinaldo, a retired government official in the coastal municipality of Pasuquin in Ilocos Norte province, said: "The wind and rain were so strong overnight I could not sleep well." "When I got up today I saw fallen trees and broken branches outside. We have no electricity," Aguinaldo told AFP.— AFP

Cambodia PM Hun Sen to resign, pass power to son in few weeks

CAMBODIAN Prime Minister Hun Sen said he will resign in a few weeks and hand power to his son Hun Manet, in a televised address Wednesday.

Hun Sen ruled the country for 38 years. The announcement of his resignation comes after his Cambodian People's Party won a landslide victory in Sunday's general election, held in the absence of viable challengers.

"I announce that Hun Manet will become prime minister on 22 August ," said Hun Sen, now aged 70, adding that he will not be retiring from politics but will instead continue to serve as the head of the CPP. Hun Manet, 45, contested and won a parliamentary seat for the first time in Sunday's election.

It was the second consecutive National Assembly election to be held without a viable opposition force, with the previous one having taken place in 2018. The main opposition Candlelight Party was barred from taking part after they were disqualified by the country's election committee in May. The committee said the party failed to submit proper registration documents. — Kyodo

China's top legislature holds session, foreign minister, central bank governor appointed

CHINA'S top legislature voted to appoint Wang Yi as foreign minister and Pan Gongsheng as central bank governor, as it convened a session on Tuesday.

Qin Gang was removed from the post of foreign minister he concurrently held; Yi Gang was removed from the post of governor of the People's Bank of China, according to a decision adopted at the fourth session of the Standing Committee of the 14th National People's Congress (NPC).

President Xi Jinping signed a presidential order to effectuate the decision.

Zhao Leji, chairman of the NPC Standing Committee, presided over the session, which

It refines stipulations concerning the crime of offering bribes as well as corruption conducted by private enterprise personnel. On Tuesday afternoon, Zhao presided over a meeting of the Council of Chairpersons of the NPC Standing Committee before the closing meeting of the session. — Xinhua

Ex-PM Thaksin to return to Thailand on 10 August from exile: daughter

FORMER Thai Prime Minister Thaksin Shinawatra will return to Thailand on 10 August, his youngest daughter Paetongtarn Shinawatra said Wednesday, after 17 years in self-imposed exile.

Thaksin fled the country during the 2006 military coup, escaping trials for tax evasion and corruption cases. Paetongtarn expressed her delight at her father's planned return in a social media post, adding he will arrive at Don Mueang International Airport in Bangkok.

But Paetongtarn noted that she is aware of public concern about Thaksin's safety. The 74-year-old, who spent most of his self-exile in Dubai and remains popular in Thailand, told Kyodo News in March that he was ready to spend a few years in prison provided he can spend the rest of his life with his family. Thaksin said in May in a Twitter post he plans a return to Thailand in July, but it has been delayed. Paetongtarn is a possible prime minister candidate from the Pheu Thai Party, which was founded by Thaksin in 2007 and garnered the second-most votes in the 14 May election this year. — Kyodo

Japan sees record drop in population

JAPAN'S population fell by a record in 2022, government data showed Wednesday, as the country struggles to reverse its perennial low birthrates.

While many developed countries face low birthrates, the problem is particularly acute in Japan where the population has now fallen for 14 straight years.

The country has the world's second oldest population, after tiny Monaco, and in January, Prime Minister Fumio Kishida

warned Japan was "on the verge of whether we can continue to function as a society".

Last year, the number of Japanese fell by 800,523, or 0.65 per cent, to 122,423,038 from a year earlier, a survey by the internal affairs ministry shows. For the first time, the population fell in all 47 prefectures. The overall drop was the steepest decline recorded since 1968, when the government survey began, the ministry said. — AFP
