Upcoming elections must maintain political prestige

A ll party members must be hard cores of relevant parties as well as a democratic system, said Senior General Min Aung Hlaing. At the meeting with officials of reg-

istered political parties at the hall of the SAC Chairman Office in Nay Pyi Taw yesterday, Chairman of the State Administration Council Prime Minister Senior General Min Aung Hlaing unveiled that the ultimatum vision of the government is to hold a free and fair election so as to hand over the State responsibilities to the election-winning party.

He continued that armed conflicts

occur in the country due to attempts to solve the political problems in terrorist ways but political ones. On the other hand, ethnic armed organizations widely shape terror acts. So far, skirmishes still happen in some areas. As such, the Tatmadaw cooperates with the Myanmar Police Force to lessen terror acts through the strength of the people, he added.

Wintering birds arrive in Rakhine State

REPORTS indicate that since December, wintering birds from the northern hemisphere have been spotted entering Nantha Island in Rathedaung Township, Rakhine State.

The island, regarded as a World Ramsar wetland site, is the second-largest wintering habitat for the endangered Spoon-billed Sandpiper.

Chairman U Yan Naung Soe of the Rakhine State Biodiversity and Nature Consernoticed the birds entering Rakhine State since 25 December. In the last week, we counted about 16,000. Compared to last year, we found more other birds except the Spoon-billed Sandpiper."

The island spans 22,979 acres and sits 10 miles northwest of Sittway Township between the Mayu Estuary and the Bay of Bengal.

The Ramsar Convention recognized the island as a wetland on 21 May 2020, meeting designation.

Nantha Island boasts rich biodiversity; it serves as a nesting ground for sea turtles and hosts various aquatic creatures, including dolphins.

Efforts to designate the island as a marine national park began in March 2020. However, the island is facing challenges from sand diggers and bird hunters.

Conservationists are trying to preserve the island's territory and prevent the erosion of coral

The Senior General noted that the government had adopted the last point of the roadmap that work will be undertaken to ensure accuracy and fairness in the general election to prevent eligible voters from losing their rights. Upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held, and State duties will be handed over to the elected government.

He underlined that all party members must be hard cores of relevant parties as well as a democratic system, adding they have to utilize the strength of the parties for the State efficiently. Moreover, he underscored that party members have to participate in the peace and stability of the State. He said everyone must unite to forge peace and stability in the State and peacefully solve controversial measures.

The Senior General highlighted that peace and stability must prevail in the entire nation to initiate the democratic system. Implementing an all-inclusive public security system is necessary to ensure peace and stability. He noted that the acts of PDF terrorists, which emerged after 2021, caused loss for the State and harmed the life and property of the people. As such, all party members have to know

diverse attitudes and weaknesses and systematically implement their policies and visions.

The Senior General stressed that the State Administration Council has adopted political and national visions, roadmaps, and objectives and strives to develop the nation on political, economic, and social trends while encourparties participating in the forthcoming election will have the capacity to develop the education, economic, and social sectors of relevant regions. He explained that the census and household registration are being enumerated as a preliminary measure. He said that if so, the voter lists would be correct. So, political

aging MSME businesses. So, he continued that parties need to participate in implementing these measures. If all schoolage children have chances to learn, they will have improved knowledge and technologies. He added that parties need to cooperate with the government to enable all school-age children to be educated in the country.

The Senior General expressed his firm belief that all parties need to participate in that process.

He disclosed that a plan is underway to hold meetings with political parties and ethnic organizations to exercise the PR system. Necessary provisions will be amended in the constitution. To do so, all measures must be taken in the parliamentary process, he noted.

The Senior General remarked that armed conflicts hinder preparations to hold the election successfully. The forthcoming election must be politically prestigious. Hence, political parties need to strive to ensure the betterment of the nation with a firm spirit. The Senior General invited open discussions of officials from the political parties for the nation's sake.

Officials from political parties discussed the implementation of their functions in line with the directives and disciplines of the SAC under the supervision of the Union Election Commission, their participation in the successful undertaking of MSME businesses, plans of political parties to contribute to the public security system, forging the patriotic spirit of ethnic people, needs to ease some restrictions over political parties, creation of chance for parties in flourishing democratic system and firmness of public security system, assistance for the development of agriculture and livestock tasks in respective areas, the help of the State for opening office of political parties, some points for enumeration of census, State security measures, and needs for arranging to vote of all eligible citizens.

The UEC Chairman, the Union Minister for Legal Affairs and the member of the Legal Advisory Board, clarified party registration and revocation,

the needs of political parties to follow the relevant laws, legal assessment over suggestions on easing restrictions over political parties and holding the election.

In his response, the Senior General said the government could not take loans abroad and faced many economic sanctions. So, the government operates all measures with the currency obtained from exports. A large sum of foreign currency is spent on fulfilling the needs of fuel and cooking oil. Hence, local oil refineries are being prepared to be run at total capacity to meet the fuel demand of factories and industries. Raising the salaries of State service personnel depends on the State budget. The government has provided uniforms, allowances and cash awards to the employees.

The government will fulfil the demands of political parties but consider some demands for the long term. The government has noted down reports of political parties in individuals for fulfilling their needs.

The meeting was also attended by SAC Secretary Lt-Gen Aung Lin Dwe, Joint Secretary Lt-Gen Ye Win Oo, UEC Chairman U Thein Soe, Union Minister for Legal Affairs Dr Thida Oo, legal advisory board members, officials from 39 political parties and officials. -- MNA/TTA

Tender process arranged on 21 December for Botahtaung Pagoda cancelled

THE Pagoda Board of Trustees has announced the cancellation of the tenders that were called on 21 December for the Botahtaung Kyaikdeatt Pagoda.

The tender works that were called to complete the full gold robe include double scaffolding, removal of old gold waste, purchase of 7,000 gold foils in size of $2"\times 2"$ which includes 100 layers of gold foils, and donation of $9"\times 9"$ pure gold plates.

In addition, gilding activities, copper frame, copper plate import business, and copper plating business for copper frames are included in the announcement.

The tenders were originally planned to be submitted and opened on 3 and 4 January, but they were cancelled since the activities were no longer to continue and the resumption date of opening the tender will be re-advertised in the newspapers, according to the Board of Trustees.

Myanmar citizens in Viet Nam required to pay 2% of income tax

THE Myanmar Embassy in Hanoi, Viet Nam, stated that Myanmar citizens must pay two per cent of their income as tax.

It is also described that

the two per cent of income tax ranging from October 2023 to March 2024 will be collected starting from 5 January.

Counter-argument to false information

Alert: Fake news fabricated by Khit Thit Media

KHIT Thit Media is circulating false information on social media platforms, claiming that the army carried out bombardment using two airplanes above Seinnan village in Taze Township, Sagaing Region, resulting in civilian casualties.

The actual incident, as reported by a relevant area security officer, reveals that drone bombs deployed by PDF terrorists attacked Seinnan Village in Taze Township.

Similarly, there was another instance of fake news stating that the army fired heavy weapons and conducted air strikes on villages near Maha Muni Buddha Image in Kyauktaw Township, Rakhine, leading to the destruction of Pagoda or the surrounding villages in Kyauktaw Township.

Instead, AA insurgents fired from a distance at the military camp using heavy weapons and improvised rockets, resulting in reported incidents of houses catching fire due to the explosions in villages inhabited by local ethnic groups.

Reports indicate that media outlets supporting terrorists and spreading malicious news are fabricating and circulating false information.

They intend to conceal the actions of terrorists and create a misleading image of Tatmadaw to disrupt peace, stability, and socioeconomic life in towns and villages, ultimately causing harm to people's lives

IT has been discovered that malicious news media outlets are circulating misinformation about Tatmadaw, falsely claiming that Tatmadaw burned twenty houses and attacked local people with heavy weapons in Taungkhamauk village, Thitpok village-tract, Paungde Township, Bago Region, without provocation.

REGARDING this news, officials in the relevant area have clarified that there were no active security forces present at that specific time, and the PDF terrorists were responsible for burning the houses and subsequently fleeing. Similarly, the malicious Khit Thit Media is the death of eight individuals and injuring twelve people from Yayphyukan village, Nyaunglebin Township, Bago Region.

In response to this news, an official from the area explained that armed insurgents and PDF terrorists attacked the village using drones, causing fatalities and damage to residents.

Reports indicate that armed insurgents and PDF terrorists are killing local people, burning and destroying houses, and coercively extorting money from citizens through fear.

However, malicious news media outlets are intentionally spreading misinformation about Tatmadaw, aiming to create misunderstanding between Tatmadaw and the people while concealing the violent actions of terrorists. — MNA/TRKM

Record-high visitor numbers to Kyaiktiyo in December 2023

SINCE November 2023, people from all over Myanmar have visited Kyaiktiyo Pagoda daily. As of December, the total number of visitors reached a record-breaking 65,389, with 64,105 domestic travellers and 1,284 foreign tourists, according to U Soe Hla, the Chairman of the Pagoda Trustee's Board.

He mentioned that December, with holidays and gazette holidays, saw a high influx of pilgrims, making it the busiest time of the year. From January to December 2023, 284,079 domestic pilgrims and 10,214 foreign tourists visited, totaling to 294,293 pilgrims.

About 250 mountain cars run daily to the Kyaiktiyo hill, and hotels, rest houses, and restaurants are open full-time to cater to pilgrims.

The Buddha Pujaniya Festival of the Kyaiktiyo Pagoda is an annual event from the full moon of Kason to the full moon of Nayon. — ASH/TKO

Annual examination of Indawgyi Lake water quality, studies planned for fish species

U Maung Win, the warden of Indawgyi Lake Wildlife Sanctuary, reported that water quality in Indawgyi Lake, located in Mohnyin Township, Kachin State, undergoes annual testing.

"Collaborating with Norway and Germany, a fish species study in the lake is ongoing. Since 2016, water quality has seen no significant changes, with only slight variations observed. The lake boasts four unrecorded loach species globally and two unique fish species," contributing to Indawgyi pride", U Maung Win said.

The report highlights joint fish species and water quality studies with Fauna and Flora International (FFI). The biodiverse location attracts winter migratory birds, and research collaborates with Norway, sending water specimens to Germany for laboratory tests.

Recent research reveals 95 fish species in the lake, including the unique loaches and two specific species. Indawgyi Lake, a Forest Department-protected wildlife sanctuary spanning 314.67 square miles, remains uninhabited, ensuring an uncontaminated natural environment.

As one of Myanmar's eight Ramsar Sites, Indawgyi Lake is a preferred destination for winter migratory birds. — ASH/ TMT

Myanmar workers in HK, Macau informed of 2% income tax

ACCORDING to the announcement by the Consulate-General of Myanmar in Hong Kong, Myanmar citizens residing in Hong Kong and Macau must pay a two per cent income tax. Beginning on 2 January,

Myanmar citizens in Hong Kong and Macau who hold PJ or PS passports will be eligible to pay income taxes.

Furthermore, income tax payment will be a prerequisite for processing passport renewal and consular procedures.

Approximately 5,000 Myanmar citizens live in Hong Kong and Macau, working at manufacturing factories, hotels, restaurants, and casinos.

Similarly, income tax collection has begun at the Myanmar Embassies in South Korea, Japan, Singapore, Thailand, and Malaysia. -TWA/MKKS

Indonesia buys 1.5 mln tonnes of rice from Myanmar in 4 months

INDIA'S banned on exporting some types of rice abroad has led to a rice shortage in the market, and Indonesia's purchase rate of Myanmar rice has risen higher than the previous month. Indonesia's monthly purchase of Myanmar rice was 11,775 tonnes in September, 40,150 tonnes in October, 42,225 tonnes in November, and 55,850 tonnes in December, according to Myanmar Rice Federation (MRF) statistics.

YGEA diminish gold reference price to below K3.7 million per tical tracking spot gold price dip

WITH the decline in spot gold price, the Yangon Gold Entrepreneurs Association (YGEA) set the pure gold price lower to K3.6537 million per tical (0.578 ounce, or 0.016 kilogramme).

The spot gold price stood at US\$2,045 per ounce at present.

On 5 December, the Central Bank of Myanmar (CBM) allowed authorized dealers (private banks) to operate forex exchange transactions freely as per the liberalized market rate determined by the supply and demand dynamic. Following this move, the price

gap between the YGEA's price and the market price is not that different.

Earlier, the YGEA used the interbank transaction rate set by the CBM in calculating the reference price for pure gold, indicating a big gap of K400,000-K500,000 per tical. The greenback is valued at around K3,450 at the over-thecounter market.

When the Kyat depreciated at K4,000 against the greenback in the forex market, the gold price peaked at K4 million per tical in late August 2023. — NN/EM

Myanmar is the top producer of the black gram that is primarily demanded by India, while pigeon peas, green grams and chickpeas are cultivated in Australia and African countries besides Myanmar.

MYANMAR shipped over 1.1 border posts between 1 April

grams are exported to China and Europe.

India has growing demand and consumption requirements on black gram and pigeon peas.

According to a Memorandum of Understanding between Myanmar and India signed on 18 June 2021, India will import 250,000 tonnes of black gram and 100,000 tonnes of pigeon peas (tur) from Myanmar for five consecutive years from 2021-2022 financial year to 2025-2026 FY. This G to G pact will not affect the pulses annual quota set by India. Myanmar's exporters are also entitled to deliver the pulses to India under that annual quota. The prevailing market prices stand at K3.005 million per tonne of black gram (urad), K3.39 million per tonne of pigeon pea (tur) and K1.888 million per tonne of green gram. Black gram that India primarily purchases is commonly found only in Myanmar, whereas pigeon pea, green gram and chickpeas are grown in African countries and Australia, Myanmar Pulses, Beans, Maize and Sesame Seeds Merchants Association. - NN/EMM

CBM sells nearly US\$29 million within five days

CENTRAL Bank of Myanmar (CBM) sold US\$12.93 million on 1 January and \$16 million on 5 January.

Also, the CBM injected US\$22.15 million into fuel oil sector last year, selling \$9.72 million on 18 December and \$12.43 million on 21 December for fuel oil importing companies.

Yet, the CBM did not reveal the exchange rate in selling dollars. At present, the CBM set the reference exchange at K2,100 against a US dollar. Kyat-US dollar exchange rate is K3,450 at the over-the-counter-market.

On 5 December 2023, the CBM allowed authorized dealers (private banks) to operate forex exchanges freely as per the market rate determined by the market force of the supply and demand.

Additionally, the CBM notified that outward remittance must comply with the rules and regulations of the Foreign Exchange Management Committee. — NN/EM

The value of Myanmar's pulses exports totalled over \$1.47 billion from over 1.9 million tonnes in the previous FY 2022-2023, the Ministry of Commerce's statistics indicated. Myanmar mainly exports black gram, green gram and pigeon peas to foreign markets. Of them, black gram and pigeon peas are primarily shipped to India while green

A Comprehensive Survey of Curriculum Developing

In the curriculum, there are found four components. These components are objectives, content, implementation, and evaluation. The objectives make the curriculum decision on what to cover, what to emphasize, what content to select, and what learning experiences to stress. A curriculum's objectives should be stated clearly and succinctly consistent with the general objectives of education and a particular curriculum as well as the specific objectives of each subject and the translation into objectives for each lesson or activity. These objectives may be derived from three main sources of data - the student, the social condition, and the nature of the subject matter - and then divided into three domains - cognitive, affective, and psychomotor. And the curriculum content should contain the learning experiences organized as regards at least two fundamental requirements - the requirement of society, and that of child growth and learning, in which content standards are those considered competencies all students must attain before graduating from high school. Integration, reiteration, and sequence are the guiding principles in the detailed organization of an effective course. Integration is the relationship between learning experiences in the several areas concurrently being presented to the lesson that must be arranged so as to reinforce and illuminate one another. The integration within and between areas of knowledge is needed. Reiteration refers to the repetition of major curriculum elements that have to involve wider and more

advanced information. Sequence emphasizes that each successive learning experience needs building on the preceding one in the progression of tasks in order of depth and difficulty as the student climbs an educational ladder. Besides, learning experiences are planned and guided by the school in accordance with societal opportunities, school community nature, teacher-student relationship, individual differences, readiness levels, actual lesson content, and methods given to students. The major purpose of curriculum evaluation is to determine whether what has been planned has actually been carried out and the intended outcomes have been achieved. Positive findings on these two purposes aid in the interpretation associated with student evaluation. Through evaluation, more rational decisions may be made about the extent to which precisely defined objectives have been or can be attained. For the curriculum develop-

ment, the teacher must recognize five broad categories of students: terminal students (drop-out students), college-bound students (students preparing for higher education), vocational-technical students (students primarily preparing for jobs), destination unknown students (students with native ability but not an expected level of achievement during high schools), and students with special needs (students with emotional, mental, or physical disabilities). Curriculum development should always proceed on the basis of a clear understanding of the various kinds of students the curriculum is intended to serve; in other words, every

curriculum includes three expansive academic offerings: general education, exploratory education, and career education. General education addresses the common learning requirements for all students. This education aims to provide a basis for citizenship participation and good mental health; fosters student development in reading, composition, speaking, listening, computing, humanities, arts, music, social and natural sciences; stresses learning skills of knowledge application and inquiry. Exploratory education is expected to help students take exploratory experiences and utilize them in making educational and career decisions that they will pursue in high school and beyond. Career education is a balanced education that prepares students to function successfully in the real world, where elective courses enrich this education by giving them an opportunity to take up in earnest a particular avenue of learning. The task of education is to promote creativity, emotional health, physical prowess, social expertise, and cognitive skills as well as a curriculum should have everything that happens to students within the space of their time at preschools, nursery schools, or students' centre. What a teacher is obliged to do is develop the curriculum that enables such total learning to take place.

School systems are now using a large variety of structures to develop their curricula. Such structures are commonly founded on two categories, subject-centred and learner-centred curriculums. The subject-centred curriculum focuses on what is to be taught and is content-orient-

ed, whereas the learner-centred curriculum relies on the needs of students and is process-oriented. The subject-centred structure comprises separate courses and fused programmes. In the single-subject curriculum, the areas of knowledge are taught in isolation without any attempt at integration with the intent to provide a discipline for students that alerts them to set classifications and to recognize arrangements of facts and ideas which have lasted over time. The single-subject curriculum remains almost intact, but students are introduced to subject areas as a whole rather than to bits and pieces. This curriculum demands extensive explanation and oral discourse. On the other hand, the fused curriculum attempts to decrease the number of separate subjects that have gradually accumulated in the single-subject structure. The fused approach provides students and teachers more latitude within an extensive subject area.

Typical learner-centred structures are the core curriculum and the activity curriculum, both of which have social and psychological foundations. The social foundation lies in an awareness of what society expects of maturing young students while the psychological foundation is in students' interest and appreciation for learning. In the learner-centred structure, its motivation becomes intrinsic instead of being extrinsic. With an increasingly fragmented society, the only logical approach to developing social values and vision is through a core organization. The core curriculum may have different degrees of organization

and cross broader subject lines, even placing much greater stress than the fused curriculum on the need to integrate subject matter. It stresses facts, descriptive principles, socioeconomic conditions, and moral values of conduct and behaviour; students spend much time studying the culture and its moral content. On the other side, the activity curriculum treats the student as the sole centre of learning in its purest form. If a child develops an interest in something and becomes emotionally involved with it, learning is enhanced. After all, the activity curriculum encompasses all subiect matter.

Articulation and balance play two essential sectors for curriculum evaluation. Assessment of articulation evaluates how well various school programmes are working together both horizontally and vertically in achieving curriculum goals and aims for education whilst balance examines the degree of emphasis in any school programme. In this context, student evaluation, standardized assessment, authentic assessment, portfolio assessment, and grading can be applied effectively and efficiently. Above all, curricular issues are constantly changing as modern society acquires new expectations. A teacher working in curriculum development must be knowledgeable about current issues and how these issues bear on the goals and aims of the curriculum. The teacher ought to bring about the motivation in such curriculum development and its implementation at all levels of education with a view to accomplishing the national educational goal.

Singapore to face more extreme weather amid climate change: report

SCORCHING heat, extreme rainfall, and rising sea levels will bring growing challenges to Singapore if climate change intensifies, according to a report issued by the Centre for Climate Research Singapore Friday. The "Third National Climate Change Study" of Singapore shows that the city-state is expected to become warmer, with its annual mean temperatures rising to 0.55 degrees Celsius per decade by the end of the century under the high emission scenario.

Singapore's annual mean temperatures increased at a

rate of 0.24 degrees Celsius per decade in the past 40 years, the report added.

Noting that Singapore's rainfall is highly variable at seasonal scales, the report warned that the rainfall will be increasingly unbalanced due to severe climate change. — Xinhua

India expected to grow 6.2% in 2024: United Nations report

ECONOMIC growth in India is projected to reach 6.2 per cent in 2024, slightly lower than the 6.3 per cent estimate for 2023, amid robust domestic demand and strong growth in the manufacturing and services sectors, the United Nations' World Economic Situation and Prospects 2024 report said on Friday.

Gross domestic product in South Asia grew by an estimated 5.3 per cent in 2023 and is projected to increase by 5.2 per cent in 2024, driven by a robust expansion in India, which remains the fastest-growing large economy in the world.

"Growth in several economies in the region will face downward pressures from tighter financial and fiscal conditions, balance-of-payments challenges, and the return of the El Nino climate phenomenon," the report said. India, however, registered strong investment performance in 2023, driven by government infrastructure projects and multinational investments.

"Investment has been more resilient in developing economies than in developed economies. Investment in South Asia, particularly in India, remained strong in 2023. India is benefiting from growing interest from multinationals, which see the country as a key alternative manufacturing base in the context of developed economies' supply chain diversification strategies," the report said.

Global inflation is projected to decline further, from an estimated 5.7 per cent in 2023 to 3.9 per cent in 2024. But price pressures are still elevated in many countries and any further escalation of geopolitical conflict will add to that.

In about a quarter of all developing countries, annual inflation is projected to exceed 10 per cent in 2024, the report highlighted. — ANI

ADB secures US\$ 5 bln through dual-tranche global bonds for Asia-Pacific development

The funds raised will contribute to the ADB's ordinary capital resources, supporting social and economic development initiatives across the vast Asia-Pacific region.

THE Asian Development Bank (ADB) has successfully priced a dual-tranche global benchmark bond, securing US\$ 3 billion for a 3-year issuance and US\$ 2 billion for a 10-year issuance. The draft requests financial leasing companies to return to the main business of leasing, raises standards for market entry, and accentuates the prevention and control of risks. – Xinhua

China strengthens NEV industry design to support the sector's high-quality development

By 2025, China aims to fully implement and optimize a time-of-use electricity pricing mechanism for NEV charging.

CHINA has stepped up the design of its new energy vehicle (NEV) industry to facilitate the sector's high-quality development and consolidate its strong growth momentum.

Most recently, the National Development and Reform Commission and three other authorities released a guideline to strengthen the integration of NEVs into the country's power grid.

By 2025, China's preliminary technical standards system for this

integration will be established, and its time-of-use electricity pricing mechanism for NEV charging will be implemented fully and optimized.By 2030, NEVs will be an important part of the country's electrochemical energy storage system, per the guideline.

China has released a series of plans and guidelines for the NEV industry, outlining the sector's development path and aiming to accelerate the country's transition into

Maersk says to avoid Red Sea for foreseeable future

ACCORDING to data from the International Energy Agency (IEA), biofuel demand is expected to expand, making up six per cent of forecasted road transport energy demand by 2030. According to a report by S&P Global Commodity Insights (GCI), this growth is attributed to policies and planned project additions outlined in the IEA's December report titled "The Role of E-fuels in Decarbonising Transport."

The forecasted 6 per cent share is equivalent to 5.3 exajoules, reinforcing the significance of biofuels in the broader context of decarbonizing the transport sector. The IEA notes that road transport will continue to dominate the use of liquid biofuels, maintaining a share of 98 per cent by 2030. — ANI

US hiring exceeds expectations in December

US job growth surged unexpectedly in December, government data showed Friday, wrapping up a solid year for the labor market even as voters remain gloomy about the economy ahead of November's presidential election.

The world's biggest economy added 216,000 jobs in the final month of 2023 despite expectations of a slowdown from the prior month, according to Department of Labour data.

The unemployment rate was unchanged at 3.7 per cent, holding at a historically low level and defying forecasts of a small uptick.

These robust figures come as higher interest rates bite, after the Federal Reserve lifted the benchmark lending rate rapidly and held it at a high level to ease demand and rein in inflation. — AFP

Israel says time for diplomatic solution with Hezbollah is "short"

Israeli Defence Minister Yoav Gallant emphasizes a limited timeframe for a diplomatic resolution with Hezbollah, expressing concern over the escalating tensions.

ISRAELI Defence Minister Yoav Gallant said on Thursday the window of time for a diplomatic solution with Hezbollah is short.

Gallant made the remarks in Tel Aviv when meeting with visiting US Senior Advisor Amos Hochstein, who arrived in Israel earlier on the day in a bid to lower roiling tensions between Israel and the Lebanese militant group.

A statement released by Israel's Government Press Office said the US envoy, during the meeting with Gallant and other senior military officials, was briefed on the security situation on Israel's northern border and the conditions required by the defense establishment to facilitate over 80,000 displaced Israelis to return home.

According to statements released by the Israel Defense Forces (IDF) on Thursday, the army continued to carry out airstrikes on several Hezbollah sites in southern Lebanon. The targets included a rocket launch position, an observation post, and other infrastructure belonging to the Lebanese military group. — Xinhua

Climate change is an urgent threat to pregnant women and children

The document, titled "Protecting maternal, newborn and child health from the impacts of climate change," contends that the effects on maternal and child health have been overlooked, underreported, and underestimated.



Pregnant women, babies and children face extreme health risks from climate catastrophes that warrant urgent attention, according to a Call for Action released today by United Nations (UN) agencies ahead of the global Conference of the Parties (COP28) negotiations on climate change in Dubai.

According to the document - Protecting maternal, newborn and child health from the impacts of climate change — the effects of climate events on maternal and child health have been neglected, underreported and underestimated. It highlights that very few countries' climate change response plans mention maternal or child health, describing this as "a glaring omission and emblematic of the inadequate attention to the needs of women, newborns, and children in the climate change discourse".

"Climate change poses an existential threat to all of us, but pregnant women, babies and children face some of the gravest consequences of all," said Bruce Aylward, Assistant Director General for Universal Health Coverage, Life Course at the World Health Organization (WHO). "Children's futures need to be consciously protected, which means taking climate action now for the sake of their health and survival, while ensuring their unique needs are recognized in the climate response". -- UNICEF

yanmar conveyed over 290,000 tonnes of fisheries worth US\$448 million to more than 40 foreign countries in the past eight months of the current financial year 2023-2024 beginning 1 April, said U Nyunt Win, director of the Department of Fisheries in Nay Pyi Taw.

The fisheries are steadily delivered to Japan, countries from the Middle East, European Union member countries, Malaysia, Chinese Taipei, and Australia. Myanmar Fisheries Federation and the Department of Fisheries are closely working together to bolster fisheries exports.

"Fisheries exports are separated into three main categories: fish, shrimp and others. Fisheries exports are estimated at 180,000 tonnes, while shrimp export volume was 30,000. Myanmar exports fisheries to its trade partners via maritime and border channels. China and Thailand are the main buyers of Myanmar's fisheries," U Nyunt Win elaborated.

Myanmar territorial seas: Remarkable fishery resources for domestic consumption and export purpose

LESSED with land and water resources, Myanmar possesses a long coastal line from the mouth of the Naf River in Rakhine State, the western part of Myanmar, to Kawthoung, the southernmost of the nation, which is 2,800 kilometres long.

The total coastal area of Myanmar is 1,384 nautical miles, which is long-formed with several small and large islands as well as beautiful archipelagoes. Myeik Archipelago is constituted of more than 800 islands accumulating natural resources such as above-ground, underground, above-water and underwater resources.

Myanmar's total water area is 8,910 square miles (23,100 square kilometres), and an exclusive economic zone covers 205,706 square miles (532,780 square kilo-

metres). The entire economic zone of the State is an area beyond and adjacent to the territorial sea. Such an exclusive economic zone extends to a distance of 200 nautical miles from the baselines.

Maritime zones comprise territorial sea, contiguous zone, exclusive economic zone and continental shelf. Myanmar's marine fisheries waters mean the waters along the sea coast of Myanmar from the high tide mark toward the open sea, the waters on the seaside of the straight line drawn from one extreme end of one bank to the extreme end of the other bank of the river and creek mouths, the waters from the said high tide

mark to the end of the Exclusive Economic Zone.

Inshore fishery means fishery carried out in the inshore area along the Myanmar coast as determined by the Director General of the Fisheries Department as an inshore fishery area. Offshore fishery means fishery carried out in the Myanmar marine fisheries waters as determined by the Director General as an offshore fishery area. As Myanmar is a sovereign country, everybody needs to follow any laws enacted by the State in operating their businesses or doing something concerning all the measures of the Republic of the Union of Myanmar. As such, not only Myanmar fishery entrepreneurs and fishermen but also those from foreign countries engaging in the fishery industry in Myanmar have to abide by the provisions of existing laws enacted by Myanmar governments in successive eras.

Myanmar citizens, foreign businesspeople, and those from the fishery industry must know the restrictions, prohibitions and penalties in Myanmar's fishery sector. In this regard, Tatmadaw (Navy) and Myanmar Coast Guard are serving their defence and security duties in the Myanmar water territorial area. They will seize illegal fishermen and fishing trawlers for taking action against them under the law.

Myanmar authorities and relevant organizations are ready to take rescue and relief measures for those who face natural disasters and accidental dangers to life while legally doing fishery business in Myanmar's waters. As such, any fishermen can seek help from these organizations for their survival in emergency cases or in natural disasters. On the other hand, **SEE PAGE-C**

Commercial farms of Panamei white shrimp set to develop in Bokpyin District, Taninthayi Region

MANAGER of Pyae Phyo Tun Panamei white shrimp farming company from Taninthayi Region U Moe Kyaw Han reported that the commercially produced Panamei white shrimp, which is one of the major aquatic products of the region, will



be expanded farming in Bokpyin District in addition to the significant farming plots in Kawthoung District, Myeik District, and Dawei District.

"Panamei white shrimps are primarily produced in Myeik District in Taninthayi Region. At the time, the target is to expand farming in the Bokpyin District. Three companies are running the Panamei white shrimp farms in Myeik Township in Myeik District. Two more companies in Kyunsu Township and another two companies in Bokpyin will also be operating it. These companies are projected to commence farming this financial year," U Moe Kyaw Han said. U Moe Kyaw Han added, "Major external markets of Myanmar are China and Japan. We will seek to expand the market into European countries and Thailand later. We are trying to meet the criteria demanded by China and Japan for exporting Panamei white shrimp."

The Panamei white shrimps were farmed in the Myeik Archipelago, commencing in 2018. Furthermore, Myanmar's clean and fresh marine environment favours the successful breeding of shrimp there.

Since Myanmar exports this type of shrimp to the external market, the report says that the canned Panamei white shrimps are mostly shipped to China, whereas to Japan, the farmed Panamei white shrimps are sent in container shipment by cold chain. The fishery business entrepreneurs are keen to increase Panamei white shrimp farming upon getting global market shares to a certain extent. Additionally, the deep sea fishers prefer commercial farming of Panamei white shrimp rather than fishing marine life in the deep sea territory since the farmed Panamei white shrimps are potentially profitable after three months of breeding. — ASH/ TMT

those organizations are searching for illegal fishery businesspersons in the seas to be taken action.

Businesspersons and those wishing to operate and those operating offshore and inshore fishery industries need to know the prohibitions of the Myanmar Marine Fisheries Law. The law states that no person shall engage in inshore and offshore fishery without a licence. The licence holder shall not violate any of the conditions contained in the licence. The holder of the licence shall not transfer his licence. No person shall engage in the industry with the licence obtained by way of transfer under Section 36 of the Myanmar Marine Fisheries Law. No person shall keep on board the fishing vessel explosive substances, poisons, chemicals, and other dangerous substances not permitted for use in fishing. No person shall dispose of living aquatic creatures or any material into the Myanmar Marine Fisheries Waters to cause water pollution or to harass fishes and other marine organisms. No person shall search for and collect any marine products without a licence.

Myanmar captures fisheries from the sea for the purpose of export and domestic consumption. Myanmar's fishery industry exports a large volume of fishery products to China, Thailand, Bangladesh and other regional countries through land borders such as Htikhee, Mawtaung, Myawady, Myeik, Kawthoung, Sittway and Maungtaw border points as well as through the maritime trade route, generating millions of US dollar incomes on a yearly basis not only for the businesspersons but for the State.

The Department of Fisheries set a timetable for the non-fishery period all offshore trawlers must follow. Every year, the non-fishery period is set from May to July to set a time to regenerate various species of fish in the Myanmar water territorial area to avoid depletion of fishery deposits in Myanmar seas. According to the restrictions, all fishermen and fishing entrepreneurs need to prevent fishery processes in the seas totally.

In line with the economic objective of the State, which mentions Enhancing agriculture and livestock production with modern technologies for the benefit of all National people and promoting growth in other sectors of the economy for achieving national prosperity and food security, businesspersons have to produce foodstuffs based on agriculture and livestock raw materials as well as fishery products for ensuring local food security. That is why fishery businesspersons and fishermen have to take deserved rights and advantages in doing their businesses of offshore and inshore fisheries with might and main, whereas they have to be liable to follow the existing laws of the State. To ensure the sustainability of fish resources at Myanmar seas, all Myanmar citizens must conserve water resources, including fish deposits and aqua creatures and underwater resources such as coral reefs, seagrass, natural plants in the seas and various fish species.

HE sun-dried salt production can be mainly found in coastal regions like Ayeyawady Region, Mon State and Rakhine State. The Mon and Rakhine states produce salt only about 34 per cent, but the Ayeyawady Region has 66 per cent.

The Ayeyawady Region is a focal salt production region, mainly in Labutta, Ngaputaw and Pyapon townships. The coarse salt received from traditional salt production methods like seawater is pooled into evaporative farms to make salt that is transported to the salt factories by the salt farmers. said a salt trader.

The coarse salt from the Ayeyawady Region, Mon and Rakhine states are being transported to the regions and states.

"The coarse salt fetched K120-K130 per viss last year. It is only K70-K80 per viss this year. The salt businesspeople cannot profit from high production costs, employee fees and warehouse rental fees," said U Zaw Htay, who runs a salt



the destruction of stored coarse salt, salt fields and flaws made flaws in the local salt market during the period of Nargis and the salt was imported from foreign countries, according to market indexes.

"The slat market was ruined after the Nargis. The slat was imported from foreign countries. The imported salt is better than the locally-produced salt and occupies the market at good prices. If the locally-produced salt is processed with high technology and packing to export, it can get firm foreign market," said U Zaw Htay.

The salt farmers start the sun-dried salt production in October yearly. They first dig farms and fill them with seawater. After four months, the coarse salt is ready to be distributed to the market.

"We cannot make salt in the rainy season. The salt season lasts from the end of the rainy season to the summer. It takes about seven months. It costs over K500,000 per farm," a salt producer told The Global New Light of Myanmar.

Although the salt is produced from boiling processes, sun-dried salt was produced from 1963 to 1964 in Kyaikkhami. Since then, the sun-dried salt production process has become widespread nationwide. The government controlled salt production and trade, but salt was recognized as an essential goods under the 1965 fisheries products order, and salt trading was also exempted in 1976. Then, the number of salt producers started growing, and the salt production industry developed. The officials need to provide finance and modern techniques to establish the modern salt mill and improve the existing salt mills. If so, it can reduce the reliance on salt imports and export of locally-produced quality salt to foreign markets.

In the last week of September 2023, the government signed a MoU with the South Korean government to export quality coarse salt from Mon State, according to the Mon State Salt Trader Association.

"Arrangements are being made to export the coarse salt from this region to the Korean market. It is likely to create a firm foreign market for salt farmers," production business in Pyapon Township.

Some salt farmers are watching the market status despite the typical transaction of coarse salt, and the profits and losses can be estimated at the end of the salt season, April.

Although there is a high local demand for Myanmar's salt, the coarse salt market is not controlled due to the lack of raw industrial materials and export market the salt farmers considered. Although the slat production indus-

try took a long time and required hundreds of workers before Cyclone Nargis,

Livestock entrepreneur U Win Myo Lin unveils lucrative soft-shell crab farming generating export earnings during an exclusive interview with The Global New Light of Myanmar.



ABIDING by the guidelines of the Prime Minister to make progress in agriculture and livestock, the backbone of the economy, all the stakeholders in the supply chain are exerting concerted efforts to have industrial growth based on agriculture and livestock products. Sunflower soft-shell crab farming, run by Sunflower Co Ltd, located in Kyauktan Township, Thanlyin District, Yangon Region, is a successful soft-shell crab farming business.

Following is the interview with U Win Myo Lin from Sunflower soft-shell crab farming.

When did you start getting into the crab farming business?

When the Kyauktan Shrimp Farming Zone was implemented in 2000 to effectuate the nation's economic growth, ten companies started executing shrimp farming operations. Most of the livestock companies turned to potential soft-shell crab farming in 2007. The Department of Fisheries designated some areas as soft-shell crab farming zones; we commenced running this business in 2009.

Could you elaborate on capital investment and the number of farming acres for the soft-shell crab business?

The soft-shell crab farming camp covers 99.06 acres. We started the business with only four farms. Each farm is 2-acre wide. The company has expanded to 25 farms, with three acres and four water lakes.

Please explain the crab population and soft-shell crab production?

If farming operations are in full swing, about 1.5 million crabs can be farmed. The soft-shell crab production is 20 tonnes a month.

How do you find raw materials for soft-shell crab production?

We rely on mud crabs or wild-caught crabs dwelling in mangrove forests, rivers and the mouth of the sea as raw material for soft-shell crab business.

For farming, we buy natural crabs

weighing above 80 grammes from the Pvapon, Bogale and Labutta areas. This business creates job opportunities for marine workers in Delta regions and helps contribute to community development.

Would you please explain the soft-shell crab production stages step by step?

The wild-caught crabs are systematically farmed at the crab farms, under the close monitoring of the staff by day and night shifts. We provide feedstuff in line with the standards of the Food and Drug Administration. When they have matured and out-

grown their shell to 15-20 per cent growth beyond their original size, those soft-shell crabs are collected and sent to a temporary storage tank with oxygen treatment. They are delivered to cold storage facilities after discarding the dirt. After processing them step by step, they are ready to be packaged.

How many countries do you export the soft-shell crabs to? What label symbolizes your business?

They are distributed to local hotels and restaurants and shipped to foreign countries under the Frozen Myanmar Soft

Shell Crab label according to the customized packaging style of those countries that place the order. They are primarily exported to China, Australia, the US, the UAE, and Europe. Please tell me about the service to the con-

sumers?

Soft-shell crabs are value-added products, so they are ready to cook.

Could you please reveal the advantages of soft-shell crab farming?

We follow the instructions given by the experts to ensure no environmental impact. The shells of the crabs can be recycled to biofertilizer. It is a zero-waste product and environmentally friendly.

How do you use waste crab shells in compost?

For recycling waste crab shells, after sun drying the shell, the powder is used as a compost and an amino organic solution to treat plants.

How do you handle biofertilizer from waste crab shells?

We distributed biofertilizer (amino organic folio fertilizer and land treatment fertilizer) under the brand Wathondray in the domestic market. We also conducted awareness training for the farmers regarding organic fertilizer.

Please let me know the number of staff and employment management?

We employ about 200 staff. We also provide accommodation for the married and the single separately. Additionally, we support educating the employees' children and the religious house and library to improve IQ, EQ, and literary skills. Moreover, we have a health care service plan as well.

Is there anything you would like to add?

Our soft-shell crab farming business creates job opportunities for locals and contributes to economic growth. The GNLM genuinely appreciated

Saltwater shrimp farming projected to expand more acres in Myeik District

THERE are more than 1,500 acres of saltwater shrimp farms in Myeik District, Taninthayi Region, and the Myeik District Fisheries Department stated that shrimp farming acres are set to expand this financial year, according to the department's Deputy Director U Zaw Min Oo.

Saltwater shrimp is one of the major marine export products of Myeik District.

The district mainly operates offshore fishing businesses and saltwater shrimp farming businesses to boost regional fishery product exports. There are over 1,200 offshore fishing trawlers in Myeik. In detail, 900 regularly depart for the offshore area to fish.

In addition, the report states that there are more than 1,500 acres of saltwater shrimp farms within the district, especially in Palaw and Kyunsu townships.

"Offshore fishing is conducted in Myeik District as an export business. There are more than 1,200 offshore fishing trawlers in Myeik. Amongst, at least 900 are being operated regularly. Since fishing is a business that extracts aquatic resources, it has some limitations. However, we will



expand the aquatic farming businesses. Currently, we run four plots of aquatic farming, especially in Palaw and Kyunsu (townships). Seven more plots are projected to expand within this financial year. Three new plots are being expanded in Kyunsu," said U Zaw Min Oo.

Myeik District of Taninthayi Region shipped 4,471.35 tonnes of fishery products to Thailand in November 2023, which generated US\$4.73 million as trade revenue.

Taninthayi Region exports fish. prawns, commercially farming fish and shrimp, and other marine products from the Kawthoung, Dawei, and Myeik districts via five transport channels. Besides. the aquatic products from the Taninthavi Region are also delivered to Yangon by both land and water transport modes; then, the marine products from the Taninthayi Region are exported through Yangon. — ASH/ TMT

Ngapi made from Myanmar fish enriches taste of Myanmar meal with nutritional values

GAPI (fish paste), a Myanmar side dish meal served deliciously with fresh vegetables, is a popular fermented condiment to complement Myanmar cuisine. Ngapi has been commonly consumed and highly demanded by people of all ages from the past generations. Moreover, ready-made fish paste with good packaging and value addition is delivered to foreign countries to satisfy the cravings of Myanmar citizens abroad.

MAKING THE PROCESS OF NGAPI

Ngapi is made from mixing fish such as butter catfish, Mystus vittatus, swamp barb, small snake-headed fish, catfish and snakehead murrel. There are two types of fermented fish: small fish and large fish Ngapi. Its taste differs from fish ingredients. Fish paste is a taste to Myanmar people.

"Ngapi can be made on your own. After salting and drying fish under the sun for two days, it is pounded to a certain extent. Some ferment them with rice water or broken rice soup to get thicker liquid. They are fermented in glass bottles, plastic jars and earthen pots. If it's not mixed with rice water, Ngapi sauce looks thin," Daw Tin Aye, a Ngapi maker working on a manageable scale in Pantanaw Township, Ayeyawady Region, told the Global New Light of Myanmar.

Commercial fish paste processing businesses utilize a glazed earthen pot with a capacity of a hundred visses of fish, placing a glazed earthen bowl at the bottom. Desmodium triquetrum leaves cover the top of the lid to kill blowfly larvae. "Salting and pounding fish are important steps in fermenting fish to enrich the flavour of Ngapi. If the fish is not pounded well, the taste is not rich. Fermentation duration takes five months at least to get delicious Ngapi", Daw Tin Aye explained. The Ngapi-making process varies depending on the region. It's primarily found in coastal areas and delta regions. **BIZARRE CASE OF NGAPI FERMEN-TATION**

Ngapi pot is overfilled during high tide, even if the location is far from the coastal area. The pot is dry during the





waning days of the month. During the waxing days of the month (high

tide), the pot is refilled with fish sauce after collecting them. The clear liquid at the top of the Ngapi pot is called fish sauce from the pot (locally called O tat Ngan Pyar Yay).

FERMENTED FISH PASTE AND ITS NUTRITIONAL VALUE

Myanmar people love eating boiled Ngapi with fresh and assorted vegetables. Ngapi is rich in water, protein, vitamins and minerals such as calcium, phosphor, copper, potassium and zinc. It contains 40-50 per cent of water content, 20-30 per cent of protein and 3-4 per cent of fat. The salt content in fish and shrimp paste is 10-25 per cent, while fish sauce and salted fish have a high salt content of 20-30 per cent. Thanks to protein and fat, 31-48 calories are found in Ngapi. This being so, it gives one nutrition like a slice of meat like mutton, beef and pork. Ngapi consists of 1.5-2.5 per cent of calcium and 0.75-1.25 per cent of phosphorus. "Children are fed a plate of rice mixed with fish paste as the adults consider Ngapi contributes to strengthening bone. Because of its nutritional value, some people feed Ngapi to the children. It is like receiving child nutrition from lowcost Ngapi," Ma Thanda Swe, a mother of a five-year-old child, told The Global New Light of Myanmar. VALUE-ADDED MYANMAR'S NGAPI PENETRATING EXPORT MARKET Myanmar's fisheries businesses are commonly found in coastal areas and delta regions. Value-added fish paste, shrimp paste, fish sauce, dried fish, dried shrimp and ready-made canned fish paste (Ngapi) are shipped worldwide. Many value-added and diversified fish products are placed on external markets to meet consumer demand.

Crocker Fish is caught the most during the winter months such as Tazuaungmone, Nattaw, Pyatho and Tabodwe (Myanmar months). Demersal fish named Croaker, is most commonly found in the mixed area of freshwater and saltwater, and saltwater areas.

Especially, they are mostly found in the Ayeyawady Delta region and Gulf of Mottama. — ASH/KZL

Fisheries Federation to export value-added river catfish products

THE Myanmar Fisheries Federation revealed a plan to export value-added river catfish products.

Dr Toe Nandar Tin, vice president of the federation, said: "We'll source the fish from the Ayeyawady Integrated Food Industry Complex in Pantanaw Township, Ayeyawady Region. The primary foreign market is China but we'll also expand to Russia, Europe and Saudi Arabia."

The products include fish fillet, fish meal and fish sausage.

The industry complex processes 30,000 to 50,000 visses of fish daily based on the order from dried fish manufacturers. It is part of the larger fish farming project.

The federation initiated the project in 2019 on 1,000 acres of land. The first phase of the project encompasses 300 acres and includes a fish-pellet factory and cold storage.

The first of the three phases of the project has concluded. Upon full completion, the complex holds the potential to process 1,000 tonnes of marine products daily, positioning itself as the largest fish farm in Southeast Asia. - ASH/NT

Over 7,558 MTs of shrimp to international markets last eight months

IN the past eight months, Myanmar exported over 7,558 metric tons of shrimp to global markets.

The shrimp exports dropped by over 3,000 tonnes compared to the year-ago period, according to the statistics of the Department of Fisheries. Myanmar sent over 11,181 tonnes of exported shrimp worth \$40.095 million in the corresponding FY period.

Myanmar delivers fishery prod-

ucts, including fish and shrimps, to over 40 countries, including Thailand, Bangladesh and Japan, through Yangon Port and land borders.

There are over two million workers in the fishing industry, and the ability to export is being checked to ensure the food safety of aquatic products, following international standards. - TWA/MKKS
