
Myanmar, Indian Armed Forces to forge friendly ties, further cooperation

n Pyapon Township of Ayeyawady Region, the Maha Ponnyarama Minkyaung Monastery, built in the mid-Konbaung era, and an upside-down star-flower tree, which is said to be the only one in the whole Myanmar, have been conserved, according to the Maha Ponnyarama Minkyaung Monastery Preservation Body.

The monastery was built in 1208 ME (1846 AD) during the reign of the Konbaung dynasty's King Bagan. When the land was selected for the

construction of the monastery and the undergrowth was cleared, branches of a star flower tree were rooted in the ground and were found to be growing fresh. So, the officials moved it to the southeast corner of the monastery and planted them.

It is said that the appearance of the star-flower tree is completely different from other trees of the same species, so it is called the upside-down star-flower tree, and it still attracts visitors from all over the region.

"Pyapon, Minkyaung-

tawgyi and upside-down star-flower tree are indistinguishable. If you want to know more about this extraordinary upside-down star-flower tree, find it in Myanmar encyclopedia which contains topics starting with the first letter of the Myanmar alphabet "Kha".

The facts about the plant are described together with the photos. Minkyaungtawgyi and upside-down star-flower tree have very interesting history.

So, we are preserving these heritages that date back more than 170 years with our utmost efforts," said a member of the monastery preservation body.

The two-storey monastery is 200 feet long and 100 feet wide and has 22 big teak pillars with two internal stairs leading to the upper floor, where two balconies (south and north) exist.

In addition, the temple having 10 rooms to accommodate studying monks is decorated with wood carvings and various other decorations of wood-turning art in both lower and upper floors. The structure is also installed with eight brick stairs.— ASH/TH

Sri Ksetra Cultural Zone to undergo renovation and flood prevention measures

LIGHTNING conductors are set to be installed at the ancient buildings, and flood prevention measures will be taken in the Sri Ksetra cultural zone, a World Heritage Site in Pyay Township, according to Deputy Director U Soe Min of the Department of Archaeology and National Museum (Sri Ksetra branch).

Efforts to prevent floods involve dredging existing ponds and excavating new ones. Lightning rods will be placed at Bawbawgyi Temple, Belbel Temple, U Khinba Mound, and Phayahtaung Temple.

Additionally, plans were revealed for the construction of an information department and a special exhibition hall at the Sri Ksetra Museum

The department's renovation strategy includes developing a map to guide tourists to the viewing tower, using chemicals to remove unwanted banyan trees from religious structures, weeding within a 20-foot radius of ancient buildings, and installing fencing around the structures to discourage bats and birds.

Furthermore, the museum will undergo a name change from to Tharay Khittaya to Sri Ksetra. Authorities will extend invitations to middle and high school students, as well as university students, and will organize pop quiz events where participants can win knowledge books as prizes. — ASH/NT

Ministry of Health approves expansion of cancer treatment facilities and funding

THREE new items of cancer radiotherapy equipment will be installed at some general hospitals this year for cancer treatment, as announced by the Ministry of Health.

Currently, Yangon General Hospital, Mandalay General Hospital, Nay Pyi Taw General Hospital (1000-bed), and Taunggyi Sao San Tun General Hospital have already been facilitated with 12 cancer radiotherapy units to serve patients.

Three new pieces of equipment, one to be purchased with a special permission from the Head of State and two others under the Ministry of Health's arrangement, will be installed at the newly-built National Cancer Treatment Centre in Dagon Myothit (Seikkan) Township this year.

Additionally, the government has already approved a fund of K12 billion for the purchase of cancer drugs this year. In 2023, the aforesaid general hospitals provided radiotherapy treatment for patients 110,367 times at general military hospitals and private hospitals in Yangon and Nay Pyi Taw.—ASH/MKKS

THE Royal Thai Embassy in Yangon announced on 20 February that visa application appointments can now be made online. Due to the large number of visa applicants, the Embassy has provided two options for submitting visa applications -online appointment and queue number collection at the

To book an appointment online through Visa Appointment Booking Online (VABO) at https://thaiconsularyangon.com/visa or QR Code, applicants can submit visa application from Thursday, 22 February 2024 onwards. 200 queue numbers per day will be issued for visa appointments, which can be made up to thirty days in advance.

After making the appointment, online applicants are advised to take a screenshot or print out the appointment confirmation e-mailed to them and present it to embassy staff on the date of appointment.

Queue numbers will be available at the Embassy from 14.00 hrs on Wednesday, 21 February 2024 for visa applications on Thursday, 22 February 2024 and Friday, 23 February 2024 with 200 numbers allocated per day.

Those who wish to obtain a queue number must present their own valid passports and will receive one non-transferrable queue number per person. The embassy said that one queue number is valid only for one person and it will blacklist and deny the application of those who fake the queue numbers or transfer them to others. For in-person applications from 26 February, the Embassy will evaluate and consider the volume of applications, and make further announcements as to whether or not it will accept the applications only through VABO in the future. - MT/ZN

hen one hears Gin, it might be considered as ginger (locally called Gin in upper Myanmar regions) that is utilized in traditional medicine as well as in cooking. Meanwhile, locals in Taninthayi Region realize the term Gin as a blood clam. The blood clam has two shells. Some called them the blood cockles. The residents in Taninthayi widely called them Gin. The blood clam from the region is primarily exported to Thailand, generating foreign earnings and creating jobs for the local community.

Daw Ni Ni, who runs blood clam farming business in Taninthayi Region emphasizes, in her interview with the IPRD, that the blood clams are currently exported to Thailand only, which re-exports them.

The following is the interview with Daw Ni Ni engaged in blood clam farming in Yaykantaung village-tract, Kyunsu Township, Taninthayi Region, by Myint Oo (Myeik), the journalist dwelling in that region.

When did you commence the blood clam farming business?

I noticed the Gin in 2011. I had a knack to start farming the baby blood clams. Before I got

into that business, I did market research by selling big blood calm in the potential Thailand's market

Please tell me about the market potentials in Thailand at that time.

The blood clams were offered only 10 Thai Baht per kilo then. As it was not profitable enough to be placed in the market, I just farmed them only. Later, it fetched 15 Thai Baht. At present, the clam receives up to 90 Thai Baht per kilo.

Could you tell me the expansion of the business operation?

We were granted a business licence to farm the blood clams in the 2013-2014 financial year. Thereafter, the business has become popular. It was incredibly trendy to run this business in the 2017-2018 FY. The department concerned keeps issuing the licences.

Could you elaborate on Myanmar's blood clam market and export?

Earlier, we used to sell them in Thailand as per the rate they offered. Now, they're commercially valued even in the domestic market. We distribute the blood clams to the clam farmers. The business can be considered lucrative.

How does this business contribute to the local community?

From baby blood clam farming to market, the business creates job opportunities.

How about the current market situations?

The average price of the clam is K8,000 per kilo when there are less than 100 clams. The price is cut to K6,500-K7,500 if the number exceeds 100 clams.

Please explain about clam harvesting.

The capacity of a clam farm is 30,000 clams. When the blood clams reach one kilo with less than 100 clams, it's the right size to deliver them to market.

How is the success rate of clam farming?

The death of baby blood clams occurs. The production rate this year is around double to triple. We have yet to calcuplans to explore more markets?

The spawning season is normally in October. We open our constructed pond surrounded by mud and clay soil depending on up-tide and downtide during the spawning season. This way, the blood clam population increases.

Is there any challenge or something you would like to add on?

There are around 100 clam farming ponds in Taninthayi Region. We have concerns over the scarcity of the clam larvae. This business can thrive throughout the year as long as there are young seeds to be raised.



Shan potato floods market on 19 Feb amid supply shortage of Chinese potato

The wholesale price of Shan potato is K500 lower than Chinese potato.

THE potato from Shan State (Aungban and Heho) is increasingly flowing into the market when there is a supply shortage of Chinese potato on 19 February, a seller involved in Yaytama Street at Bayintnaung Brokerage told the Global New Light of Myanmar (GNLM).

The shortage of Chinese potatoes shot up the price. High influx of Shan potatoes slowed down the supply of Chinese potatoes. The wholesale prices stood at K2,400 per viss for Chinese potato and K1,900-K2,000

per viss for Shan potato.

The potato depots set the price only for Chinese potato while they have disclosed that of Shan potato for half of the year.

The prices were K1,200-K1,700 per viss for potatoes from Sinbyukyun ara and K2,150 for Chinese potatoes in the corresponding period last year.

New potato from Sinbyukyun area is soon to enter the Yangon market, yet the output is likely to decline. The potato is cultivated in Shan State throughout the year.

Chinese potatoes usually flood the domestic market when the production of potatoes drops locally.

The onion prices have reached a record high of K5,100 per viss, when the garlic fetched up to K17,000 per viss. Meanwhile, the highest price of potato was just K4,200 per viss.

The prices of kitchen groceries were K2,400-K3,200 per viss of onion, K1,700-K9,000 for garlic and K2,000 for potato on 20 February. — TWA/KK

brokers and individuals who demand large sums of money for passport services.

Despite misinformation suggesting otherwise, the office clarified that passports would continue to be issued following the existing procedures and approved quotas.

Additionally, the Passport Office conducts online reservations via QR codes, processing around 2,700 reservations daily. Passport services are available at various branches across different cities in Myanmar, including Nay Pyi Taw, Myitkyina, Mandalay, and others. — TWA/MKKS

Weekly market update of dry groceries at Bayintnaung Commodity Wholesale Centre

FOR a week from 14 to 21 February 2024, the prices of black gram and pigeon pea plunged. The prices of onions moved up. The wholesale reference price for palm oil stayed the same this week.

Onion

Bayintnaung market saw the supply of 132,000 visses of onion on 21 February. The wholesale prices hit the highest of K2,100-K2,650 per viss depending on the producing areas (Seikphyu, Myittha and Myingyan) on that day.

K115,000 per sack of Pawkywe variety on 21 February. Meanwhile, the new Pawsan rice of premium quality were worth K140,000-K166,000 per sack depending on producing areas (Pyapon, Myaungmya and Shwebo). The sticky rice fetched K100,000-K110,000 per sack. The door to door price of Ayeyawady Pawsan is K150,000-K155,000 per sack in Yangon Region.

Palm oil

For a week from 19 to 25 February 2023, the wholesale reference price of Yangon Re-

Garlic

The prices of garlic from Aungban, Shan State touched a high of K16,000-K17,800 per viss depending on varieties and qualities, whereas Kyukok garlic prices stood at K9,150-K9,200 per viss on 21 February.

Chilli pepper

The wholesale prices of chilli peppers were registered at K8,000-K11,000 per viss for long chilli pepper and Moehtaung variety on 21 February. The price of bell peppers from Sinbyukyun and delta regions was K15,600-K16,500 per viss.

Rice

The prices hit K86,000-K90,000 per sack of non-premium monsoon rice, K103,000gion remained unchanged at K5,140 per viss like that of the previous week.

Potato

Prices of Shan potatoes were ranged at K1,950-K2,400 per viss on 21 February.

Pulses

The prices of various pulses stood at K3.12 million per tonne of black gram (Fair Average Quality/RC), K3.34 million per tonne of black gram (Special Quality/RC), K3.9 million per tonne of pigeon pea (red gram) RC, K4,500 per viss of green gram (Shwewah) and K6,300-K6,600 per viss of chick pea in Yangon's wholesale markets on 21 February 2024. — TWA/KK

Green tea leaves in high demand, dried tea prices rise

SOME tea traders said that price of green tea has gained higher due to increase in purchase of the green tea leaves.

Tea growers have reduced the amount of drying the green tea as its price is good.

Currently, traders are buying the green tea leaves directly from the farms. As the leave price has risen, farmers sell it as soon as they stop making dried tea, said a tea trader.

He added that traders are making a purchase of green tea leaves that have been plucked at a rate of around K4,000 to K5,000 per viss.

In the southern Shan State, the price of dried tender tea leaves is rising up to around

K14,000 per viss.

In 2023, the tender green tea leave was only around K12,000 per viss and the price has risen by about K2,000 per viss at present.

The price of dry tea leaves produced in southern Shan State depends on the location and type, and it ranges from K10,000 to K18,000 per viss.


According to a tea grower, merchants from Mandalay come to the southern Shan regions and are directly purchasing green tea leaves, and they are buying them as far as they can.

As a result, production of dried tea leaves is decreasing.

Transportation challenges affect quality of watermelon

The more extreme watermelons are damaged, the more significant the loss.

MYANMAR'S watermelons exported to China are bracing for transport hurdles such as rough roads and extreme weather conditions, affecting the quality of the fruits. The loss is mounting as much as they are damaged and rejected for inferior quality, Khwanyo Fruit Depot stated.

At present, heavy snow blankets some regions in China. Additionally, the quality of watermelon deteriorates amid the transport on rough roads and scorching weather on the Myanmar side. China's demand has faltered. Therefore, some watermelon traders are facing two to three-digit losses, traders

stressed.

Myanmar's watermelon is stockpiled for many days. Traders grappled with quality defects triggered by China's snow wave and freight transport on rough roads. Some were forced to sell them at a huge loss, according to the Khwanyo Fruit Depot.

This being so, the fruit traders suggest the exporters and suppliers consider thoroughly the law of supply and demand amid the challenges.

At present, watermelons and muskmelons are mostly delivered to China through Lweje and Mongla road channels.

Myanmar's watermelon is

primarily exported to China. However, traders are facing prolonged challenges amid the policy changes of China, fruit traders emphasized.

In early February last year, tight inspections of Chinese Customs hindered truck transport. That being so, only 20-30 trucks were able to pass the checkpoint despite high demand. Consequently, watermelon was sold out at the depots on the China side, and more than 500 trucks queued in line on the Myanmar side.

In 2021, the COVID-19 restrictions hindered Myanmar's watermelon and muskmelon exports to China. Chinese Customs Regulation increased delay. Long delays of trucks caused harm to watermelon quality, and only one in five trucks heading to China remained undamaged with quality watermelons. The traders need to consider delivery time, price and profitability as watermelon is a perishable fruit, while trying to explore new markets beyond China. — NN/EM

Domestic sugar price going upward spiral

THE sugar price is on an upward trend in the domestic market as global sugar prices spiked.

With the global price soaring to \$630 per tonne. The sugar price rose to K4,050 per viss in the domestic market. It is the time of sugarcane harvest season. The sugar mills notified sugarcane growers that they raised the price of sugarcane to K150,000 per tonne for the 2023-2024 sugarcane season.

The company set the sugarcane floor price at K90,000-K100,000 per tonne last season. Sugarcane and sugar traders emphasized that the rise in the offering price is aimed at covering the high input cost of the growers amid the rise in sugar price.

Additionally, sugar mills en-

couraged the growers to ramp up per-acre yield and expand the cultivation acres. Myanmar's annual sugar production is estimated at 450,000 tonnes. Myanmar earlier sent sugar to China and Viet Nam beyond self-sufficiency. At present, it is delivered to Viet Nam only, Myanmar Sugar and Cane Related Association stated.

Sugarcane is commonly found in the upper Sagaing Region, followed by northern Shan State. It is also found in the western and eastern Bago Region, Yangon Region and Mandalay Region. The sugarcane is grown in December-January. It can be harvested from November to February of the following years. The sugarcane growing rotation cycle lasts four years in Myanmar.

Steady sales of electric cars and slowing sales of petrol cars in automobile market

IN Myanmar's automobile market, electric vehicles (EVs) sell steadily but petro car sales are sluggish, according to U Min Min Maung, chairman of Yangon Region Automobiles Manufacturers and Distributors Association. "EVs were selling well before. We heard that more permits have been granted to the companies recently, but the market has slowed down a bit. It is just selling steadily. Petrol cars were sold at good prices for one month, but it became slow," he said.

The market slackened in the second half of 2023, resumed

trading at the end of 2023 and became slow again in mid-February. "Especially, the price of SKD cars worth less than K 100 million increased by K7 million. It was almost three days. During these days, the market has slowed down again. The market is in a wait-and-see mode with few buyers and many sellers," he said. The price of left-hand drive cars worth K 100 million increased by 10 per cent and those worth K100-200 million by 7 per cent, he said. However, the price of K400-K500 million cars hasn't increased at all, he added. — MT/ZN

IN Yangon property market, apartment rental has been high while buying and selling has been dull, said a real estate expert.

At present, property rental, from condominium room to separate house, has been high and apartment rent has been active too, he said.

Digital gold investment scams target housewives

A scam to trade gold online in foreign market has broken out, targeting housewives, according to interviews with some victims.

Using the name of an official Thailand-based investment company, scammers have created a website and application and from which, they manipulate the investment trade.

"I accepted a friend request from a man on Facebook. He started a chat on messenger to make friends. Later we talked about each other. He said he had started engaging in gold trade after the business was not good since Covid-19. He talked to me about how he was playing the gold trade, about how much the trade could profit or face loss, just a narrow margin. He convinced me every day by saying how much we could make commercial success and gave guarantee that he would help not to lose," said a woman who was cheated.

The man helped her in opening an account on their application to make gold investment and she gave K3 million by KPay for initial investment and dollars equivalent to the invested amount in kyat was shown entering the account, she said.

"On the day the account was opened, I received \$90 profit after playing the trade twice with his help. When I withdrew the profit \$90, Myanmar kyat entered my Kpay in equivalent amount. He convinced me totally that it would not be like fraud.

That is just one time and later he gave me different kinds of reasons and stopped doing the trade. I felt doubtful and asked him various questions, then he disconnected two weeks later,"

When she attempted to take out the initial investment, another deposit about one fourth of the initial investment was asked to pay again to withdraw all invested money, but couldn't take out her money and even showed losses when she continued the trade, she said.

She said there were other women who encountered similar fraud and the Facebook account they were using to communicate was actually a fake using other person photo. - Htet Oo Maung/ZS

ME Seoul receives complaints from Myanmar students in Korea about losses from paying tuition fees through intermediaries

MYANMAR Embassy in Seoul has announced that it has received documented complaints of losses suffered by Myanmar students in Korea who had paid entrance and tuition fees through their friends and some education service firms.

Myanmar students enrolled in the universities and language schools in the Republic of Korea are required to make direct transfers from Myanmar banks to respective banks in Korea to pay their tuition fees, but some who couldn't make so were found to be making payments via their friends and education service firms, it stated.

When they didn't actually pay, Myanmar students suffered losses and they complained to the embassy with evidence. Therefore, the embassy informed that the students should thoroughly check before transfer payments without making reckless transactions to avoid unnecessary losses, disputes and lawsuits. The embassy will also carry out necessary scrutiny after communicating with relevant authorities. — MT/ZN

Drugs seized in some Hopong, Tachilek townships

THE Customs Department's on-duty teams confiscated various goods worth K45.913 million from two containers at the Asia World Port Terminal and goods worth K40.053 million from a container at the Thilawa Port Terminal on 19 February. Among the items seized were 150 kilogrammes of towels, an External Counter Pulsation Device (used), 700 kilogrammes of seasoning powder, and 2,800 kilogrammes of undeclared cloth rolls. Action was taken according to Customs procedures.

On the same day, a Mitsubishi Fuso truck carrying 6,500 kilogrammes of East Hope PVC powder, undeclared in the Import Declaration (ID), was impounded at Ywathagyi Dry Port. Additionally, 600 gallons of smuggled diesel were confiscated from a motorboat in Ye township, and 95 gallons of illegal crude oil and a XIAOMI phone valued at K932,500 were seized at the Htaukshapin-Htankai-Yenanma oil field in Minbu township. Russia's Lavrov to hold several bilateral meetings with top G20 diplomats - Moscow

Lavrov's packed schedule includes discussions with various foreign ministers, alongside participation in key G20 events on 22 February.

RUSSIAN Foreign Minister Sergey Lavrov plans to hold bilateral meetings with his counterparts from Mexico, South Africa, Egypt, Bolivia and Brazil on the sidelines of the G20 foreign ministers' meeting, Russian Foreign Ministry spokeswoman Maria Zakharova said on Wednesday.

"Sergey Viktorovich Lavrov will begin a marathon of bilateral meetings. These are G20 colleagues ... A number of bilateral meetings are scheduled with counterparts from

Mexico and South Africa, and a meeting with a colleague from Türkiye is being prepared.

There are a lot of meetings. There will be a meeting with the foreign minister of Brazil, of course. There will also be a meeting with the foreign ministers of Egypt and Bolivia," Zakharova told Radio Sputnik.

Lavrov will also take part in the key events of the G20 on 22 February, she added.

On 19 February, Lavrov kicked-off his Latin American

Japan trade deficit halves to 1.76 tln yen on record January exports

Japan's exports surged to a record high in January, driven by robust shipments of autos to the US, helping the nation cut its trade deficit by half from a year earlier to 1.76 trillion yen (\$11.74 billion).

JAPAN'S exports rose to a record high in January as US-bound auto shipments were robust, helping the nation halve its trade deficit from a year earlier to 1.76 trillion yen (\$11.74 billion) as energy imports also slumped, government data showed Wednesday.

Exports increased 11.9 per cent to 7.33 trillion yen, marking

the second straight month of growth despite concerns about slowing global demand after aggressive interest rate hikes in the United States and Europe.

Imports of coal and liquefied natural gas fell by double digits, leading the resource-scarce nation to report a 9.6 per cent drop in overall imports, which came to 9.09 trillion yen. The country

posted a record 3.51 trillion yen trade deficit in January 2023, due to massive imports inflated by a weak yen. Comparable data became available in 1979.

Japan had a 415.04 billion yen trade surplus with the United States as exports hit their largest-ever level for the month, at 1.42 trillion yen. Imports rose 6.0 per cent to 1.01 trillion yen.

Japan logged a 959.52 billion yen trade deficit with China, another major trading partner, even as its shipments were supported by strong demand for chip-making equipment and cars. Exports jumped 29.2 per cent to 1.25 trillion yen, a record, while imports dropped 7.6 per cent to 2.21 trillion yen. China-bound shipments tend to decrease during its Lunar New Year holidays. The holidays began in early February this year, later than in 2023, which may have contributed to the strong export number. — Kyodo

German economy buffeted by 'perfect storm'

WEAKER exports, costly energy and a stuttering green transition have combined to form a "perfect storm" for the German economy, leaving Chancellor Olaf Scholz's coalition bickering over how to change course.

The government will unveil its latest economic forecasts for 2024 on Wednesday, with media reports suggesting a sharp downgrade to a mere 0.2 per cent growth.

In its autumn projections, the government was still expecting output to expand by 1.3 per cent.

The country ended 2023 in

recession, shrinking by 0.3 per cent, and the latest data suggest the first quarter of 2024 will see another contraction.

Germany also risks facing anaemic growth up to 2028 if no action is taken, German media said.

The German economy, Europe's largest and traditionally a driver of eurozone growth, is being buffeted by "a perfect storm", Economy Minister Robert Habeck said earlier this

HSBC reports 'record profit' of \$30.3 bln in 2023

HSBC said Wednesday it achieved "record profit" in 2023 as pre-tax gains soared by nearly 80 per cent, with the banking giant also announcing further share buybacks.

The Asia-focused lender and its peers have been buoyed by rising interest rates for more than a year, but are bracing for greater economic uncertainties in 2024. The bank generates most of its revenue in Asia and has spent several years pivoting to the region, vowing to develop its wealth business and target fast-growing markets.

Despite bumper profits, HSBC noted the effects of China's slower-than-expected economic recovery after the Covid-19 pandemic as well as heightened geopolitical tensions.

The firm reported pre-tax profits of \$30.3 billion, up from \$17.1 billion the year before, in a statement to the Hong

Kong stock exchange.

Profit after tax increased by \$8.3 billion, to \$24.6 billion, while revenue rose by 30 per cent to \$66.1 billion.

"Our record profit performance in 2023 enabled us to reward our share-holders with our highest full-year dividend since 2008," said chief executive Noel Quinn. — AFP

United flight makes emergency landing due to wing damage

Indonesia issues more tax incentives for EV sales

INDONESIA has announced new incentives to encourage sales of locally produced and imported electric vehicles (EVs), in its latest bid to boost take-up of environment-friend-lier cars as well as attract investment to its domestic EV industry.

The detailed incentives are a follow-up to a December-announced tax incentives plan for imported EVs for manufacturers that match import numbers with domestically made EVs in coming years.

Under new rules made public late on Tuesday, Indonesia will remove the luxury tax on EVs for the 2024 fiscal year and import tax until the end of 2025.

It will also lower value-added tax to 1 per cent from 11 per cent for EV buyers this year, extending a tax break that had expired at the end of 2023.

The incentives are aimed at stimulating domestic demand for EVs while attracting investment by automakers, the government has said.

Many EV makers have disclosed plans to launch vehicles in Indonesia since the government announced its intention to introduce incentives, said Rachmat Kaimuddin, deputy coordinating minister overseeing EV sector development.

China's BYD the world's biggest EV maker by sales volume, last month unveiled three all-battery EV models it plans sell in Indonesia. — Xinhua

Iraq no longer needs US-led coalition forces: PM

IRAQI Prime Minister Mohammed Shia' al-Sudani said Tuesday that Iraq does not need military advisors from 25 countries to work within the mission of the US-led international coalition to fight the Islamic State (IS) group.

Al-Sudani made the comments during a press conference, in which he stressed that the Iraqi government began an integrated programme to improve the armament of the security forces in conjunction with seeking to end the presence of the international coalition in the country.

The justifications for the coalition's existence in 2014 have ended today, and "we are in the year 2024," al-Sudani said.

He said that the IS group no longer poses a threat to Iraq's security, adding that the capabilities of the Iraqi security forces have improved significantly and it can now maintain security throughout the country. — Xinhua

House Speaker says requested meeting with Biden about US border security, White House rejected

US House Speaker Mike Johnson said on Wednesday that he has requested a meeting with President Joe Biden about border security, but that the White House has rejected his request.

"I've been requesting a meeting with the president for weeks now, a month. I've been asking to sit down with the president to talk about the border and talk about national security, and that meeting has not been granted," Johnson said during a press conference.

Johnson said he will continue to insist on a meeting, adding that it is a "problem" if the Speaker of the House cannot sit down with the president. House Republicans will insist on addressing the United States' border security before sending aid to foreign countries, Johnson said.

Earlier this week, Johnson said that he has no plans to bring a \$95 billion supplemental funding bill passed by the US Senate to the House floor. The bill provides approximately \$60 billion for Ukraine and \$14 billion for Israel.

However, a congressional source told Sputnik on Tuesday that House lawmakers may divide the legislation into separate portions in an effort to pass the measures. — SPUTNIK

About 32,000 NATO troops deployed near Russia, Belarus borders: Lukashenko

Belarusian President Alexander Lukashenko stated that approximately 32,000 NATO soldiers, over 1,000 armoured vehicles, and 235 airplanes and helicopters are deployed near Russia's and Belarus's borders.

ABOUT 32,000 NATO soldiers, over 1,000 armoured vehicles, 235 airplanes and helicopters are deployed near Russia's and Belarus's borders, Belarusian President Alexander Lukashenko said on Tuesday.

"The situation is no calmer on the European continent, including near our borders. In the immediate vicinity of Belarus and Russia, as part of the alliance's operations in Europe, about 32,000 soldiers of the contingents of the united armed forces of NATO and the

United States are stationed.

There are more than 1,000 armoured vehicles, about 160 artillery systems and mortars, 235 airplanes and helicopters," Lukashenko was quoted as saying by the Pul Pervogo Telegram channel.

Bosnia and Herzegovina, Moldova, Georgia and Serbia will be drawn into NATO just like the scenario of the situation in Ukraine, Lukashenko added.

In recent years, Russia has witnessed unprecedented NATO activity near its western borders.

Moscow has repeatedly expressed concern about the alliance's buildup of forces in Europe, especially since the bloc supported the Kyiv regime amid its attacks on Donbass.

Since the start of Russia's special military operation, NATO countries have supplied Ukraine with military equipment. Moscow has repeatedly stressed that any Western weapons in Ukraine will become legitimate targets for Russian strikes. — SPUTNIK

Amid torrid spell, Bayern says Tuchel to leave at end of season

Bayern will seek a new coaching direction for next season.

BAYERN Munich said Wednesday they would part ways with manager Thomas Tuchel at the end of the season, as the reigning German champions struggled to stay in the Bundesliga title race.

"We came to the decision to end our working relationship by mutual agreement in the summer," Bayern CEO Jan-Christian Dreesen said in a statement, following talks with Tuchel.

The coach, whose contract was set to run through to 2025, would exit the club on 30 June this year.

"Until then, I will of course continue to do everything I can with my coaching staff to achieve maximum success," Tuchel said in the statement.

Bayern would look for a "newfootballing direction" under a different coach next season, CEO Dreesen said.

Tuchel's preemptive dismissal comes after three straight defeats, including a painful 3-0 loss to league rivals Bayer Leverkusen.

With 12 games left in the season, Bayern sit eight points behind Xabi Alonso's side, who have yet to lose during the campaign.

Leverkusen are on an historic 32-game unbeaten streak in all competitions, equalling a record set by Hansi Flick's Bayern across the 2019-20 and 2020-21 seasons.

Following the loss to Leverkusen, Bayern slipped to a 1-0 defeat against Italian side Lazio in the Champions League round of 16 and a humiliating 3-2 loss to lowly Bochum in the league. **'Not so realistic'**

After the horror run of form, Tuchel admitted Bayern's chances of winning the Bundesliga title were "not so realistic".

The manager brushed off talk that he might be immediately replaced, but his planned exit reflects the uncompromisingly high standards at the Bavarian giants. — AFP

Myanmar's Lethwei star Tun Tun Min to fight against Cambodian Kun Khmer fighter on 29 Feb

KUN Khmer Fight will be held in Cambodia on 29 February, so Myanmar's Lethwei Icon and Myanmar's Lethwei World Champions Tun Tun Min and former rival Cambodia's current champion, Kun Khmer star fighter Prom Samnang, will battle it out in traditional Kun Khmer rules.

Prom Samnang, the current Kun Khmer champion, competed against traditional Lethwei king Tun Tun Min in the 32nd ASEAN SEA Games hosted by Cambodia in 2023. He defeated Tun Tun Min by points and won the gold medal.

The Cambodian star fought against Myanmar's Lethwei fighter Shwe Rahman in Cambodia and won by knockout on 9 February 2024.



Prom Samnang also faced against another Lehtwei star fighter Dave Leduc in a friend-

ly fight last year and finished as a tie bout. — Pwint Thitsar/KZL

Japan women's captain condemns Asian football chiefs over venue switch

JAPAN women's captain Saki Kumagai has criticized Asian football officials after the away leg of their tie against North Korea for a spot at the Paris Olympics was moved to Saudi Arabia days before the game.

Kumagai said that the Asian Football Confederation "have

a responsibility" to look after players after Saturday's match was switched from Pyongyang to Jeddah. Kumagai spoke to reporters in Japan on Tuesday as she was set to leave for Saudi Arabia, just a day after jetting in from her Italian club Roma. The 33-year-old said "this kind

of thing can't happen", referring to the late notice the national team had been given. Japan's football association had reportedly asked the AFC to move the first leg from the North Korean capital Pyongyang over a lack of operational transparency and a scarcity of flights. — AFP

Paris 2024: a 'new era' of corruption-free Olympics?

AHEAD of the Paris Olympics in July and August, French prosecutors are working on four enquiries into possible wrongdoing, but are the investigations a sign of problems or of genuine efforts to tackle graft?

Andy Spalding, an academic and author who studies corruption in sporting "mega-events" such as the Olympics or the football World Cup, believes French authorities are showing they are serious about delivering a clean Games.

Three preliminary investigations are into possible favouritism in the awarding of around 20 contracts worth tens of millions of euros, while a fourth — revealed on 6 February by AFP — is scrutinising the pay of chief organizer Tony Estanguet.

In an interview with AFP, Spalding, a

professor at the US-based University of Richmond School of Law, explained the troubled history of Olympic corruption and why he believes the Paris Games might spell the start of a "new era" of cleaner international sport.

Question: When did corruption in the Olympics first come to wide public attention?

"The Salt Lake City Winter Olympics in 2002 was the first time in which there was hard evidence of corruption that went public. Pre-2002, we know there's corruption. But we can't prove it and the world is largely resigned to corruption.

Then in the late 1990s, there's something sometimes called the "corruption eruption" — a period of time in which all of a sudden the world starts paying a lot of attention to corruption issues. — AFP

China-Saudi Arabia ethylene project enters full construction stage

CONSTRUCTION of the main complex of a joint-investment ethylene project, which in-Saudi Basic Industries Corporation (SABIC), began on

Monday in east China's Fujian Province.

The project, with a total volves petrochemicals giant investment of 44.8 billion yuan (about 6.3 billion US dollars) from SABIC and Fujian Energy

Petrochemical Group Co, Ltd, is being built in the Gulei petrochemicals base in the city of Zhangzhou.

As the largest single Sino-foreign joint venture in Fujian Province, the project is expected to be completed in 2026 and possess a maximum annual production capacity of 1.8 million tonnes of ethylene.

The project has triggered

investment totalling more than 200 billion yuan for upstream and downstream industries in the Gulei petrochemicals base, according to preliminary estimates.

The base is one of China's seven largest petrochemicals bases. It has 15 operational projects and a further 12 are under construction. - Xinhua

Foreign visitors to Japan in Jan returns to pre-pandemic level

Despite a powerful earthquake on New Year's Day, its impact on tourism has been limited.

THE number of foreign visitors to Japan soared 79.5 per cent in January from a year earlier to about 2.69 million, reaching the level seen in the same month in 2019 before the onset of the coronavirus pandemic, government data showed Wednesday.

The number of overseas visitors has been growing after Japan lifted border control measures related to COVID-19 in late April. A weak yen has also been fuelling the return of inbound tourists.

The impact of a powerful January 2019. — Kyodo

earthquake that rattled central Japan on New Year's Day has been "limited", although some people in South Korea and China cancelled their trips to Japan in the wake of the quake, according to the Japan National Tourism Organization.

By country and region, the largest number of travellers came from South Korea at 857,000, up 10.0 per cent from the same month in 2019, followed by those from Chinese Taipei at 492,300, up 27.0 per cent, and those from China, which has been slower than other countries in easing travel restrictions, at 415,900, down 44.9 per cent, the data showed.

The number of Japanese travelling overseas in the reporting month jumped 89.3 from a year earlier to 838,600 but was still down 42.3 per cent compared with the number observed in

NEIGHBOURLY COOPERATION

Laos, Thailand to step up cooperation in border security

LAO and Thai security forces will step up cooperation in border security, with the aim of reducing criminal activities along the two countries' shared border.

A meeting of cooperation sub-committee on maintaining peace and order along Lao-Thai border was held in northern Laos' Luang Prabang province on 13-16 February, Lao Army Television reported on Tuesday.

The attendees reviewed results of cooperation in border peace-keeping operations and general cooperative relations between Laos and Thailand.

Lao and Thai security forces are pleased that relations and cooperation between the two countries have progressed based on equality and mutual benefit, enabling the two sides to resolve various problems and improve stability in border areas, the report said.

The two sides agreed to further strengthen their neighbourly cooperation, share more information, and take necessary measures in line with laws of each country.

They also agreed to strengthen law enforcement in border areas to prevent illegal immigration and combat human trafficking, drug trafficking and smuggling.

The two sides also agreed to work with local authorities to educate people living in border areas about the law concerning crossing of the border and illicit activities, according to the report. — Xinhua
