Myanmar Daily Weather Report

BAY INFERENCE: Weather is partly cloudy to cloudy over the Andaman Sea, Eastcentral Bay and South Bay of Bengal and a few cloud elsewhere over the Bay of Bengal.

Special Features: According to the observations at (18:30) hrs MST today, Typhoon Yinxing over the South China Sea is likely forecast continue to move westwards.

FORECAST VALID UNTIL NOON OF THE 9 November 2024: Rain or thundershowers will be scattered in Sagaing, Magway Regions and Kachin, Chin, and Rakhine States, fairly widespread in Mandalay, and Taninthayi Regions and widespread in the remaining Regions and States with the likelihood of isolated heavyfalls in Bago, Yangon, and Ayeyawady Regions and Kayin, and Mon States. Degree of certainty is 100%.

THE CONDITION OF CUMULONIMBUS CLOUD: The cumulonimbus clouds are developing in Yangon, Ayeyawady, and Taninthayi Regions and Mon State. The area along the cumulonimbus clouds movement, the weather phenomena such as strong winds accompanied with rain, thunder, lightning and hail may occur and therefore it is recommended to be aware in advance of these phenomena.

STATE OF THE SEA: Squalls with moderate to rough sea are likely at time in Myanmar Waters. Surface wind speed in squalls may reach 30-35 miles per hour. Wave height will be about 7-9 feet off and along Myanmar Coasts.

OUTLOOK FOR SUBSEQUENT TWO DAYS: Likelihood of scattered to fairly widespread rain or thundershowers in Nay Pyi Taw, Shan, Kayah, Kayin, and Mon States.

FORECAST FOR NAY PYI TAW AND NEIGHBOURING AREA FOR 9 November 2024: One or two rain or thundershowers. Degree of certainty is 100%.

FORECAST FOR YANGON AND NEIGHBOURING AREA FOR 9 November 2024: Some rain or thundershowers with may be heavy at times. Degree of certainty is 100%.

FORECAST FOR MANDALAY AND NEIGHBOURING AREA FOR 9 November 2024: Isolated rain or thundershowers. Degree of certainty is 100%.

WEATHER OUTLOOK FOR WEEKEND: Rain or thundershowers will be widespread in Nay Pyi Taw, Yangon Region and scattered in Mandalay Region. — DMH



Individuals need to join necessary preparations to minimize loss and waste in storm

The weather forecast indicates Myanmar will face some rains less than usual from 8 to 17 November.

VICE-SENIOR General Soe Win unveiled that the National Disaster Management Committee has provided cash and kind – over K25 billion and emergency foods – to recent flood-affected areas, dead and injured people and those who lost homes.

The National Disaster Management Work Committee held the coordination meeting at the assembly hall of the Ministry of Social Welfare, Relief and Resettlement in Nay Pyi Taw this afternoon, with an address by the Chairman of the Management Committee Vice-Chairman of the State Administration Council Deputy Prime Minister Vice-Senior General Soe Win.

In his opening address, the Vice-Senior General said that Myanmar is also facing natural disasters based on climate change, and it is included in the list of the most likely causes of loss and damage in natural disasters.

He pointed out that news showed Typhoon Yinxing entering the Philippines on 7 November and then heading to the west and northwestward.

He recounted that central Myanmar and Shan State suffered impacts of heavy rains and flash floods triggered by Typhoon Yagi, which coincided with a small storm from the depression in the Bay of Bengal.

Now, he disclosed that clashes of the cold and warm air streams stipulate rain in Myan-

mar, whereas Typhoon Yinxing from the Philippines heads to Vietnam. As such, preparations must be made to provide necessary aid for the people considering the possible heavy rains, flash floods and landslides, he added.

According to the press releases of the Department of Meteorology and Hydrology under the Ministry of Transport and Communications and international meteorological centres, the Vice-Senior General noted that Myanmar is expected to face some rains less than usual from 8 to 17 November. However, it is necessary to make preparations and conduct rehearsals so as not to cause impacts of storms similar to Typhoon Yagi again.

At present, he explained that whirlwinds which moved from the South China Sea, facing occurrences between warm winds from the Andaman Sea and the Bay of Bengal cold winds from the high press area of China mainland, may cause instability of the atmosphere in the Andaman Sea and the Southeast of Bay of Bengal despite passing the monsoon period. Hence, heavy rains may occur in the coming days, according to the Department of Meteorology and Hydrology.

He stressed that it is necessary to release early warnings, set safer places for displaced persons from the flood-ravaged areas, stockpile purified drinking water and foods in advance, group heavy machinery and vehicles to transport affected people, manage the evacuation of the people in time, and organize the people who refuse to move under the natural disaster management law. All need

to cooperate with each other in necessary preparations to minimize loss and waste.

He revealed that the National Disaster Management Committee had provided cash assistance of more than K25 billion and emergency foods for recent flood-affected areas, dead and injured people and those who lost homes as part of the emergency response to the flood-hit areas.

He highlighted that all flood-damaged basic education schools could be reopened within one month thanks to the State fund and the contribution of well-wishers.

Vice Chairs of the committee Union Ministers Lt-Gen Yar Pyae and Dr Soe Win reported on possible natural disasters, progress in making preparations with the formation of region-wise emergency response teams, and purchase of relief aid with the use of the natural disaster management fund.

The Director General of DMH clarified the route of Typhoon Yinxing from the South China Sea and weather forecasts.

The meeting discussed preparations for conducting region-wise and sector-wise emergency responses, rescue and relief, logistics and rehabilitation measures.

Union ministers, the Nay Pyi Taw chairman, deputy ministers, senior Tatmadaw officers from the Office of the Commander-in-Chief, departmental heads and officials attended the meeting, together with chief ministers of regions and states, who are also chairpersons of regional and state natural disaster management committees, and officials through videoconferencing.

the chairman of the conference organizing committee, and senior representatives from Iran's National Innovation Fund.

Pleistocene Orogenic Period and Igneous **Manifestations.**

This continues from Episode 48, which H L Chhibber, 1934 described as the Pleistocene Orogenic Period and Igneous Manifestations.

Shinmadaung: The majority of the igneous developments in the Shinmadaung inlier took place along the line of the main strike fault, and it would appear that they were determined partly by its presence. In general, they lie on (b) of the folding described above.

Mount Popa Area: In the case of the Mount Popa area, the general strike of the volcanic hills is NNW-SSE, corresponding to the anticlinal and synclinal axes of the neighbouring Tertiary rocks. Two miles south of Sima and Shawdaw, the writer observed a powerful tendency towards anticlinal folding. The eastern limb is well developed, while the western shows a scarp, which may be due to faulting; very likely, Mount Popa lies on the same fault. It is noteworthy that the lavas have erupted along the Pegu-Irrawaddian junction.

There is a subsidiary line on the west, however, with the same general strike on which the Kyaukpadaung volcanoes are situated.

Doleritic Intrusions in the Pequ Yoma, Prome Area: The general structure of the country into which the dolerites are intrusive, consists of anticlinal and synclinal folds. At two localities, viz, Lethadaung Myenethaung and Tondaung Myenethaung, the writer saw dolerites as small sheets or sills intrusive along the bedding into the Pegu Series. In the latter case, the Peguan rocks dip towards the south with an average dip of 30,° and into them, the dolerites have forced their way. At the contact, the clays and sandstones are altered as a result of thermal metamorphism, the former having been converted into shales

Tharrawaddy Area: The area mapped here consists of a big anticline with its axis running roughly east and west. The northern limit of this anticline is well-exposed in the Kvaukpyu chaung, while southerly dips are to be observed near the igneous intrusions. It appears that the latter occur generally as small sills, intrusive along the bedding planes. This is seen near the ""Three Falla Hill" in the Ngayan chaung etc. The central intrusion of Kyaukyi taung appears to have forced its way near the crest of the anticline and may represent a small laccolite

Kabwet Area, Shwebo, and Mandalay Districts: Farther eastwards, the dolerites and basalts of the Kabwet area are situated on the edge of the Shan Plateau. The tectonics of the region are comparatively simple. The Irrawaddian sands have been folded into an anticline on the west, followed by a syncline. The axis of the former is marked roughly by Nattaung's main doleritic intrusion. Some of the doleritic intrusions seem to occur as sills.

Basalts: The basalts, or the "Younger Lava," of the Kabwet area, as they were originally termed, are confined to the south of the River Irrawaddy, and form a roughly horizontal sheet, resting on the denuded edges of the folded Irrawaddian rocks. The remarkable change in general direction in this region is of the Tenasserim Yoma to the east.

The Burma Circle of the Geological Survey of India and their Contributions to the Geology of Myanmar

As regards the age of the lavas, they have flowed over the sedimentary rocks which are presumed to be Permo-Carboniferous, so it can be said that they are at least post-Permo-Carboniferous in age. But from their freshness and their great similarity to the rhyolites tuffs of the Mount Popa area, the Lower Chindwin, and the Jade Mines region, it may be surmised that the Thaton lavas are contemporaneous with these, as to the post-Pliocene age of which there is not a shadow of doubt.

EPISODE:49

Loi Han Hun Volcano, Northern Shan States: Passing to the Shan Plateau to the east, on the east, we come to the volcano of Loi Han Hun in the Loi Ling range. It is very interesting to note that in the present state of our knowledge, this is the first manifestation of volcanic activity in northern Shan State, after the outpouring of the Bawdwin lavas and tuffs. It appears that towards the close of the Tertiary period, earth movements were of a very extraordinary severity, and produced a series of cracks by which the whole of the plateau was dissected. It is these cracks that opened the way for the dormant energies lying below.

The volcano of Loi Han Hun, according to La Touche, is a conical hill, the lower part of which is composed of Tertiary silts which can be nearly horizontal, while the upper part is a dome-shaped mass of columnar basalt with dykes or wall-like masses of the same material radiating in all directions from it, but most highly developed towards the west and northwest, where there may be another focus of eruption. The form of the volcano is similar to that of a volcanic plug.

Teng Yueh Volcanoes, Yunnan: Some of the volcanoes near Teng Yueh in southwest Yunnan were contemporaneous with Loi Han Hun, referred to above. Geologically, this part of Yunnan is simply a northern continuation of the Shan Plateau, and there is no doubt that the two regions were affected by the same tectonic movements. The volcanoes of Lao-Kuei-po, Tay-in-Shan, and the Kung-po group described by Coggin Brown and Burton are all believed to be of late Pliocene or Pleistocene age, when, according to the former author, the general orography of the district was almost the same as that of the present day.

Mergui Archipelago: Passing southwards, the olivine basalts of the Medaw Island form a little plateau and rest on the Mergui Series. Sethu Rama Rao said that "although a careful search was made, nothing resembling volcanic vents or necks could be seen". The writer vis-

ited the area in October 1926 and found that this occurrence showed great similarity to the olivine basalts of the Kabwet area, referred to above. It is most probable that the flows of olivine-basalt have erupted through a fissure in the Mergui Series.

Recent Orogenic Movement and Igneous

There is considerable evidence to show that important orogenic movements operated during Recent times. There is unmistakable evidence of the recent uplift of land in the form of raised beaches on the Arakan coast and the Andaman Islands. Similarly, signs of Recent elevation are not wanting on the Malayan shores. Dr Cotter, in his paper on the geotectonics of the Irrawaddy basin, has given many instances of Recent upheaval in the Irrawaddy Valley. It must have been during Recent and sub-recent times that the Plateau Gravels of the Pleistocene age were folded and tilted. Similarly, the Uru Boulder conglomerate in the Jade Mines area and Tanai Hka Boulder conglomerate in the Hukawng Valley, both of Pleistocene to sub-Recent age, were found tilted at an average angle of 10°.

Some of the volcanoes of the Jade Mines area, the Lower Chindwin area, Mount Popa region, Narcondam, and Barren Islands, all lying in the Central Belt of Burma, were undoubtedly active, as an accompaniment of these movements. The last-named volcano still smokes at times and was observed in actual eruption during the later part of the last century.

Jade Mines Area, Myitkyina District: An example of volcanic eruption during Recent times is furnished by the olivine basalt of the "1361" hill, about a mile south of Namyong. Here, the upper slopes of the hill are built of basalt overlying late Tertiary rocks. It is evident that the volcano erupted when the present small drainage channels of this neighbourhood had been carved out, as the blocks of lava, a few feet in diameter, representing the broken flows, have a much greater extension along them, and are piled up wherever any little ascent commences. The writer is inclined to believe that the blocks of siliceous breccia are seen in so many places in the area, and some of the hornblende-andesites have erupted in

The Lower Chindwin Region: Farther southwards, some of the flows, explosion craters, ash and tuff deposits are undoubtedly of Recent or sub-Recent origin. Most of them are

composed of soft, incoherent ashes, but despite that, they present today an appearance as if they had only just been formed.

Mount Popa Area: Farther down the same line are the volcanoes of Barren Island and Narcondam. The latter has become extinct lately, but the former still smokes at times and was observed to have been in active eruption. Tipper believes that, to the east of Andaman Island, there is an important fault, on which these volcanoes are situated.

Teng Yueh, Yunnan: On the eastern extremity of Yunnan the volcano of She-toe-Shan belongs to this category. Coggin Brown says, "Although She-toe-Shan has been quiescent within historical times, nothing could be more evident than its recent appearance. Erosion and denudation have up to the present made little impression upon it". The vegetation is very scarce, on account of the scanty soil on the lavas of She-toe-Shan.

As explained below, some uncertainty pre-

vails concerning the early Palaeozoic igneous activity. In the east, covering the site of the Shan Plateau, the Karenni Hills, and Tenasserim, the land after the deposition of the Chaung Magyi and Mergui Series was upheaved and subjected to significant disturbances when the igneous activity occurred in the neighbourhood of Bawdwin, the Lagwi Pass and in the Mergui district, as explained below. After this phase of igneous activity, the whole of Burma, including the Shan Plateau and the Tenasserim Yoma, was under the sea, and, as mentioned elsewhere, it was during the late Cretaceous-early Eocene period that the land -masses on the east and the west were upheaved. In the latter region, a belt of serpentinised peridotites is intrusive into the eastern margins of the mountain masses, though a solitary occurrence of serpentine in the Sandoway district in the Arakan Yoma is known. These hill ranges mark the site of an important geosycline, which is, in all probability, the continuation of the Himalayan geosycline, towards the south. It seems, therefore, that these serpentine intrusions took place in the margins of the geosycline, and mainly in the eastern arc, which had just begun to be upheaved. Since most of these serpentine intrusions occur on the eastern margin of the geosyncline it is perhaps reasonable to assume that the thrusts responsible for the upheaval of the land came largely from an

easterly direction.

This belt in the north, especially in the Myitkyina district, widens considerably, as not only do the serpentine intrusions occur in the Jade Mines area and the Hukawng Valley, but they extend as far east as the neighbourhood of Myitkyina itself.

ARTICLE

Volcanic rocks, mainly in the form of ash beds, sometimes interbedded with Eocene sedimentary deposits, occur and are associated with almost every area of serpentine intrusions. This tends to confirm the conception of sub-aqueous igneous eruptions in the late Cretaceous -early Eocene period on the eastern margin of the rapidly shallowing geosyncline. Instances of this, which have been described above, occur in the Bassein, Myaung mya, Henzada, Minbu, and Pokokku districts and the Manipur hills. The Central Belt, or Burma proper, was still under the sea. Still we find vestiges of igneous activity during the Eocene period in the Shinmadaung hills in the Pokokku district. I, but we find vestiges of igneous activity during the Eocene period in the Shinmadaung hills in the Pokokku district, and it is likely that, during the Eocene period, an inlet of the sea extended in that direction, the intervening portion of which was subsequently covered by the Irrawaddian Series.

The precise age of the Wuntho and Loimye volcanics cannot be determined, but it is known that in both areas, the eruptions were initially sub-aqueous, and marked almost the middle of the northern portion of the Central Belt, which commenced shallowing and gradually rising from the north. It may be that these eruptions occurred either during Eocene times with the others or during the next orogenic period (post-Eocene). The writer is, however, inclined to the former view.

It was only during late Tertiary times that the Burmese Gulf, marking the site of the Central Belt of Burma, was gradually silted up. It is known to have constituted an important geosyncline, where deposits (according to Dr Cotter) with a minimum thickness of 43,000 feet were laid down. In the Jade Mines region, the ower Chindwin and the Mount Popa areas, the igneous activity commenced under sub-aqueous conditions, but almost towards the end of the silting up of the gulf, t. These igneous occurrences lie in the centre of the geosyncline and are connected with the axes of the various fold lines into which it has been thrown.

The margin or the edge of the geosyn cline is marked by a boundary fault, where the eruptions of the Kabwet area, the Mandalay and Shwebo districts, and those of the Thaton district occurred. Here, again, we find igneous activity on the eastern margin of the rapidly shallowing geosyncline, as was noticed in the case of the Arakan Yoma and its continuation to the north. No igneous occurrences of this age are known from the western margin of

determined by the presence of the lava plateau of the Singu to the south, around the northern and western edges of which the river now swings. There is little doubt that the lava erupted through fissures, almost marking the junction of the crystalline rocks (Mogok Series) of the Shan Plateau and the Tertiaries. As already remarked, this fault constitutes one of the major structural features of the Burmo-Malayan region. La Touche wrote: "It is to be observed that these ancient rocks were brought to the surface in Upper Tertiary times since on the western side they are in continuous contact with sandstones of that age. The whole length of the western edge of the Shan Plateau is a fault scarp due to a great fault.

The Thaton District: Passing southwards along this line, we have the rhyolites and rhyolitic tuffs of the Thaton district. The volcanic rocks here, from their north-south linear arrangement, appear to have erupted along a strike fault in the sedimentary rocks produced probably as a result of folding and faulting of the Tenasserim Yoma, which are merely a southern continuation of the Shan Plateau. The ridge formed by the capping of lava also forms the foothills, or, in other words, the edge

Yangon's monsoon paddy harvest reaches target despite floods

ACCORDING to the Yangon Region Agriculture Department, 1,144,372 acres out of the targeted 1,148,222 acres were successfully planted with monsoon paddy, with 198,488 acres harvested as of the first week of November.

"This year's rice planting faced several challenges, but the ministry responded promptly to ensuring areas affected by flooding were quickly replanted.

Despite the need to replant during the typhoon period, the rice has withstood these difficulties, allowing us to meet our production target," explained Daw Hla Kyi, Assistant Director of the Agriculture Department for

Yangon Region.

In Yangon, high-quality rice varieties suitable for export are grown, including Pawsanmwe, Pawsanyin, Ayeyamin, Hmawby-2, Sinthukha, Manawthukha, GW 11, 90-day, Theehtatyin, Shwewahtun, Yakyaw, Sinthwelat, Hmawby-3, Pakhangshwewah, and Kayinma Hteiksaung.

Early- and medium-matured rice varieties are currently harvested, while late-matured varieties are expected to be harvested between December and the end of February.

The harvested rice fields are being prepared for winter crops such as peanuts, mung beans, sesame, and sunflowers, with the expectation that these crops will be flourishing across the region by the end of November. — Nyein Thu (MNA)/TMT

Illegal trade crackdown seizes goods worth K366M on 7 Nov

UNDER the supervision of the Illegal Trade Eradication Steering Committee, efforts to combat the illicit trade were continued effectively by the law.

On 7 November, the combined teams seized a Hino Profia truck (approximately K30 million) carrying two types of consumer goods (estimated value of K564,000), without official documents at the Mayanchaung permanent checkpoint, a Nissan UD truck (estimated value of K25 million) carrying consumer goods and motorbike parts worth K7.2 million without official documents at the Yetha temporary vehicle checkpoint and consumer goods worth K8.15 million that were smuggled and piled up in the bus station compound in Kawthoung Township. The action was taken in line with Customs procedures.

Similarly, the combined

teams conducted inspections in the seizures of two vehicles (estimated value of K60 million), heading to Mandalay from Yangon and to Mandalay from Yatsauk, carrying 11 kinds of consumer goods and three kinds of industrial materials worth K35.897 million at the Myitnge checkpoint, a Sunlong bus (approximately K100 million) carrying two kinds of consumer goods worth K18.562 million without official documents in Mandalay, a Yutong bus (approximately K45 million) carrying foodstuffs valued at K2.5 million without official document in Amarapura Township and two trucks (estimated value of K21.5 million) carrying illegal teak weighing 1.489 tonnes, illegal timbers weighing 11.773 tonnes and five types of related things valued at K12.043 million in PyinOoLwin and Patheingyi Townships. The action was car-

ried out under the Forest Law and Customs procedures.

Additionally, an unregistered Sumbo Star motorbike (approximately K300,000) was seized in Monywa Township. The action was conducted under the Export-Import Law.

The Illegal Trade Eradication Steering Committee reported 19 arrests on 7 November, seizing illegal goods worth approximately K366 million. — MNA/MKKS

False claims: Arson and theft of civilians' property in Yesakyo

Subversive media Khit Thit fabricates stories about activities of prisons

THE subversive Khit Thit media fabricated fake news on its Facebook page on 3 November, claiming that political prisoner Ko Ye Yint Aung had been severely beaten, despite having escaped an assassination attempt at Myaungmya Prison, and that former parliamentarian Dr Pyae Phyo had been the target of an assassination plot.

Upon investigation, there were no political prisoners in the prison, only individuals who had violated existing laws and were serving their sentences. On the evening of 22 October, inmates Tun Lin Aung and Ye Yint Aung, housed in separate buildings – Room 9 and Room 10 – fought, leaving Ye Yint Aung with a head injury.

The incident occurred, and the prison doctor provided the necessary medical treatment for the head injury of inmate Ye Yint Aung. During the investigation, Ye Yint Aung, the victim of the beating, stated that it was merely a fight between inmates and that they both wanted to be punished according to the administrative measures set by the officer in charge. The officer in charge placed foot restraints on Tun Lin Aung for 14 days, revoked his sentence reduction days, and moved him to a separate building.

In addition, it was incorrect to say that prison inmate Pyae Phyo was planned for assassination in prison. He is not in contact with TB patients, and Pyae Phyo himself is staying in a separate room in the dormitory of his own will because it has better ventilation.

Similarly, the Facebook page named DVB Media reported on 3 November that the health condition of prisoner Zarni Aung was poor, which is not true. It is false that Zarni Aung, a prisoner from Obo Prison in Mandalay, is suffering from diabetes, high blood pressure, and coronary heart disease. In reality, he is in good health, and the prison hospital superintendent and nurses are closely monitoring and treating him.

On 31 October, prisoner Zarni Aung was diagnosed with suspected skin cancer of the left eyelid and was sent to Mandalay General Hospital. The oncologist conducted the necessary tests and provided medical treatment. He was given a medical note to return in three months. He is currently in good health. The report on the Facebook page named DVB Media is intended to mislead the public about the prison's routine operations and is false. — Thitsa/TKO

SHRIMP trawling businesses are thriving this year with strong demand in the domestic market and foreign seafood markets, Vice-Chair U Aung Than Oo

of the Myanmar Marine Fisheries Association said.

Locals used to consume less shrimp caught on the sea. They were primarily exported. Domestic consumption has increased by 10 per cent due to changes in consumer behaviour.

"This year, shrimp trawling's catch rates significantly rose. Furthermore, demand ticked up as well. Earlier, 90 per cent of sea-caught shrimps were supplied to international markets, and only 10 per cent were sent to domestic markets. At present, domestic demand has reached 20 per cent. Locals rarely

consumed them due to the high price. They can afford to buy them for now, changing market patterns," U Aung Than Oo elaborated.

Myanmar's tiger shrimps are shipped to the US and European countries beyond Asian countries like Japan and China. Hard-shell shrimps are mostly conveyed to Japan, China, and other regional countries.

Moreover, Myanmar can process hard-shell shrimp into value-added food products which are designated for Malaysian and Chinese markets. — ASH/KK

Myanmar ships 1.36M+ tonnes of rice to international markets in 7 months

MYANMAR'S rice and broken rice exports hit over 1.36 million tonnes in the past seven months of the current financial year 2024-2025, beginning 1 April, with an estimated value of US\$647 million, according to statistics from the Myanmar

Rice Federation (MRF).

Myanmar exported over 1.3 million tonnes of rice through maritime trade channels and 20,000 tonnes at border posts.

The export volumes are 111,862 tonnes worth \$55 million in April, 71,279.5 tonnes worth

\$36 million in May, 162,325.75 tonnes worth \$84 million in June, 165,444 tonnes worth \$81 million in July, 207,369 tonnes worth \$97 million in August, over 219,560 tonnes worth \$104 million in September and 424,784.27 tonnes of rice worth

\$189 million in October respectively.

The federation aims to achieve 2.5 million tonnes of rice exports in the 2024-2025 financial year (April-March).

The Ministry of Commerce has been cooperating with departments and institutions concerned to achieve export targets and beyond depending on the supply volume of rice, broken rice, pulses, corn, rubber and fisheries from the respective companies.

Ministry of Commerce is working together with the Union of Myanmar Federation of Chambers of Commerce and Industry, Myanmar Rice Federation, Myanmar Pulses, Beans, Maize and Sesame Seeds Merchants Association, Myanmar Garment Manufacturers Association, Myanmar Industries Association, Myanmar Rubber Planters and Producers Associ

ation, Myanmar Fisheries Products Processors and Exporters Association to meet monthly export targets and facilitate exports.

The federation is projected to achieve 2.5 million tonnes of rice export in the FY 2023-2024, generating earnings of \$1 billion. However, rice exports fell short of the target with 1.6 million tonnes worth \$845 million.

The Central Bank of Myanmar's monetary policy to control export earnings impeded rice exports, hurting exporters financially. The El Nino weather condition also hampered rice export, the MRF chairperson affirmed.

Myanmar exported 2,261,203 tonnes of rice and broken rice to foreign trade partners in the past 2022-2023 FY (April-March), with an estimated value of \$853.472 million.

CBM pumps foreign currencies into financial market on 7 Nov

THE Central Bank of Myanmar (CBM) sold over 2.1 million baht, two million yuan and over US\$3,300 on 7 November, following sales of about \$9,000, 490,000 yuan and 1.2 million baht on 6 November.

It announced on 5 November the sale of seven million yuan and 20 million baht to importers on foreign exchange trading platforms. CBM sold \$15 million, 1.5 million yuan and 100.8 million baht on 4 November.

CBM injected over \$91 million, over 9.8 million yuan and over 610 million baht into the financial market in October 2024. CBM also sold over \$76 million, 86 million baht and 4.8 million yuan in September. Moreover, CBM sold over \$190 million, 19 million yuan and 79 million baht in August.

CBM aims to curb the instability in the foreign exchange market and the currency devaluation. According to CBM's notification on 15 March, it has been joining hands with law enforcement agencies to combat and prosecute those who attempt to manipulate the currency market under the existing laws. CBM allowed authorized dealers (private banks) to operate online foreign exchange trading freely as per the market rate depending on supply and demand, starting from 5 December 2023. — NN/KK

MYANMAR'S various pules exports hit 2.98 million tonnes of pulses in the past seven months of the current financial year 2024-2025 beginning 1 April, according to Myanmar Pulses, Beans, Maize and Sesame Seeds Merchants Association.

Myanmar mainly exports black grams, green grams

and pigeon peas to foreign markets. Of them, black grams and pigeon peas are primarily shipped to India, while green grams are exported to China and Europe.

India has growing demand and consumption requirements for black grams and pigeon peas. According to a Memorandum of Under-

standing between Myanmar and India signed on 18 June 2021, India will import 250,000 tonnes of black grams and 100,000 tonnes of pigeon peas (tur) from Myanmar for five consecutive years from 2021-2022 financial year to 2025-2026 FY. This G-to-G pact will not affect the pulses' annual quota set by India. Myanmar's exporters are also entitled to deliver the pulses to India under that yearly quota.

Myanmar's black gram output is estimated at 400,000 tonnes per year, whereas pigeon pea production crosses 50,000 tonnes.

The Myanmar Pulses, Beans, Maize and Sesame Seeds Merchants Association stated that black grams, which India primarily purchases, are commonly found only in Myanmar, whereas pigeon peas, green gram and chickpeas are grown in African countries and Australia. — NN/KK

Multinational companies surpass expectations in China's 3^{rd} quarter operations

Yum China reported total revenue of \$3.07 billion for the July-September quarter, marking a five per cent increase year-on-year.

YUM China, which operates popular fastfood chains like KFC, Pizza Hut, and Taco Bell, reported a total revenue of \$3.07 billion for the July-September quarter, reflecting a 5 per cent year-on-year increase.

Operating profit rose by 15 per cent to \$371 million, resulting in an operating margin of 12.1 per cent. Net profit surged 22 per cent to \$297 million. Analyst Anne Ling noted that while sales met expectations, the operating profit exceeded market predictions.

Yum's acting CFO, Adrian Ding, highlighted recent Chinese government stimulus measures as encouraging but acknowledged that it would take time to influence consumer behavior.

To address challenges, Yum has expanded rapidly, introducing cost-effective store models to attract budget-conscious consumers.

The company opened 438 new stores in the third quarter, reaching a total of 15,861 outlets, including 11,283 KFCs and 3,606 Pizza Huts.

In a related development, Lululemon has seen a significant rebound in China, with sales increasing 48 per cent in August and 67 per cent in September.

Bigger than expected drop for German factory output in September

GERMAN industrial production fell by more than expected in September, official data showed Thursday, as Europe's biggest economy struggles to emerge from a period of stagnation.

Output fell by 2.5 per cent month-on-month according to seasonally adjusted data published by the Destatis agency, erasing the increase observed in August, revised to 2.6 per cent. Analysts consulted by Factset had forecast a more modest decline of one per cent.

Production has closely tracked developments in the key automotive sector, where output fell by 7.8 per cent in September after a jump of 15.4 per cent in August. – AFP

Indian court orders liquidation of Jet Airways

INDIA'S top court has ordered the liquidation of bankrupt airline Jet Airways, ending a five-yearlong legal process that began when the full-service carrier collapsed in 2019 with \$1.2 billion in debt.

Once the country's second-largest airline, Jet Airways stopped operating five years ago after it ran out of cash and its planes were grounded, with lenders forcing it into bankrupt-

cy proceedings the same year. A national company law tribunal last year allowed ownership of the airline to be transferred to a consortium of buyers that included UAE-based businessman Murari Lal Jalan as part of the bankruptcy resolution process.

But concerns raised by lenders over how the resolution process was executed led to court appeals. — AFP

Trump rides global wave of anti-incumbency

The aftermath of the Covid-19 pandemic has been cited as a contributing factor to the recent political shifts and the defeat of incumbents.

INCUMBENT leaders used to have the edge. In the United States, the power of the Oval Office and glamour of Air Force One once made presidents the prohibitive favourites to win reelection.

With Donald Trump's defeat of Kamala Harris, Republican and Democratic presidents will alternate control of the White House for the fourth straight term, a level of volatility between the parties not seen in the United States since the late

19th century. Anti-incumbency fervour has swept not just the United States but other major democracies, battering both the left and the right.

Britain's Labour swept out Conservative rule in July, self-professed "anarcho-capitalist" Javier Milei triumphed in Argentina last November, and incumbent parties, some long-dominant, lost ground this year in countries as diverse as India, Japan, South Africa and South Korea.

There are exceptions — with Claudia Sheinbaum of Mexico's ruling left-wing populists elected president in June — but the anti-incumbency wave has defied traditional political trends. Under outgoing President Joe Biden, US economic growth has topped the developed world, despite high inflation, and the country has no troops in active combat, factors that led respected political scientists to predict victory for Vice President Harris. — AFP

Reported engine explosion sparks fire at Sydney Airport

A grassfire was ignited next to a runway at Sydney Airport following a reported engine explosion on a Qantas flight upon takeoff on Friday afternoon.

Fire and rescue crews were deployed to the airport, the busiest in Australia, to extinguish the blaze next to the third runway.

News Corp Australia newspapers reported that the fire was caused by an engine explosion on Qantas flight QF520 to Brisbane, which departed Sydney just before 1 pm local time.

Flight tracking data showed that the Boeing 737-800 circled the area after takeoff before landing back at Sydney Airport at about 1:10 pm.

According to Nine Network television, there were 174 passengers onboard and no serious injuries were reported. — Xinhua

Nepal's disasters cause huge loss in late September

DISASTERS triggered by monsoon rains in Nepal in late September led to an estimated loss of 46.68 billion Nepali rupees (US\$347 million) in properties in addition to human casualties, the authorities have announced.

A total of 41 roads and highways across the country were damaged, with the loss reported at 27.98 billion rupees (\$208 million), the National Disaster Risk Reduction and Management Authority said in a report released on Thursday evening. — Xinhua

Türkiye arrests nearly 4,000 human smugglers so far in 2024

TURKISH security forces conducted 6,339 operations against human trafficking organizations throughout the year and arrested 3,924 smugglers, Turkish Interior Minister Ali Yerlikaya said Friday.

When sharing these updates on social media platform X, Yerlikaya noted that in the operation "Shield-28" alone, which was conducted over the past two weeks across 41 provinces nationwide, 257 human smugglers were caught.

"We are determined to leave no room for traffickers who attempt to turn our country into a target and transit route for irregular migration," he reaffirmed.

Türkiye faces great challenges in managing illegal migration due to its unique geographic position between Europe, Asia, and the Middle East. — Xinhua $\,$

Israeli football fans face assault

FIFTY-SEVEN people were detained in relation to attacks on Israeli football fans in Amsterdam. Riot police had to intervene to stop physical and verbal attacks before the Europa League match between Maccabi Tel Aviv and Ajax.

According to BBC news, Israeli football fans faced violent attacks in central Amsterdam, prompting Dutch riot police to intervene multiple times. Prime Minister Dick Schoof condemned these "antisemitic attacks".

Israeli Prime Minister Benjamin Netanyahu announced two "rescue planes" would be sent to Amsterdam. Despite heavy police presence, Israeli fans were reportedly injured across the city as they travelled to attend a Europa League match between Maccabi Tel Aviv and Ajax. The clashes started in Dam Square with arrests and disturbances involving Maccabi fans and pro-Palestinian protesters and escalated following the game, with reports of fireworks, damaged property, and physical assaults circulating on social media.

Dutch authorities detained 57 individuals, although officials indicated the identities of those involved in the riots were unclear. Videos shared online showed violent confrontations, with pro-Palestinian slogans heard in the background. — AFP

This series of friendlies is preparation for the 2024 ASEAN Cup, set to kick off in mid-December.

China advances commercial cargo spacecraft to cut space station supply costs

CHINA has taken a significant step in space logistics and commercial space advancement with the introduction of low-cost cargo spacecraft, including a space cargo shuttle, tailored to meet the frequent supply needs of its space station.


The China Manned Space Agency (CMSA) revealed on 29 October the winners of its solicitation for overall schemes aimed at the low-cost cargo transportation system, a crucial component of the space station's operations.

After two rounds of selection, schemes respectively from the Innovation Academy for Microsatellites of the Chinese Academy of Sciences (IAMCAS) and from the Chengdu Aircraft Design and Research Institute under the Aviation Industry Corporation of China (AVIC) finally won the contracts for the flight verification phase, said Lin Xiqiang, deputy director of the CMSA.

The IAMCAS-developed Qingzhou

cargo spacecraft features an integrated single-capsule configuration with a cargo volume of up to 27 cubic metres. This ex-

pansive capacity is set to significantly cut cargo transportation costs and enhance flexibility in logistics. — Xinhua
