Myanmar inked a Memorandum of Cooperation with EAEU in 2023 and another MoC with EEC in Saint Petersburg of the Russian Federation in June 2023.

Chairman of the State Administration Council, Prime Minister Senior General Min Aung Hlaing, held a meeting with Chairman of the Board of the Eurasian Economic Commission (EEC) Mr Bakytzhan Abdirovich Sagintayev at Minsk International Exhibition Centre BELEXPO yesterday morning.

The Chairman of the EEC Board warmly welcomed the Senior General.

At the meeting, the Chairman of EEC Board extended greetings that he warmly welcomed the Chairman of the State Administration Council and Prime Minister, and his entourage, and expressed that the participation of the Chairman of the State Administration Council and Prime Minister himself at the Fourth Europe-Asia Economic Forum (EEF 2025) will further enhance cooperative efforts.

In his discussions, the Senior General expressed his firm belief that this meeting will be a drive to practically implement cooperation between Myanmar and Eurasian Economic Union (EAEU) member countries. Myanmar and EAEU inked a Memorandum of Cooperation in 2023. Moreover, he added that the government of the Republic of the Union of Myanmar and the Eurasian Economic Commission



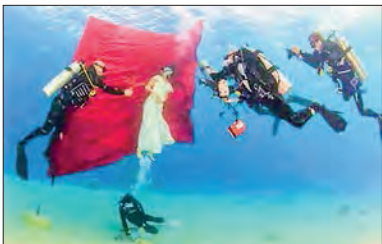

(EEC) signed a Memorandum of Cooperation in Saint Petersburg, the Russian Federation, in June 2023. He continued that many opportunities for cooperation have been found between Myanmar and EAEU member countries. The Senior General expressed his hope that the implementation of the signed memorandum of cooperation will be a step for Myanmar to advance to the level of an observer country in the Eurasian Economic Union (EAEU). So, he affirmed that Myanmar will strive to further strengthen cooperation through practical implementation.

Furthermore, the Senior General and the Chairman of EEC Board frankly exchanged views on promotion of economic cooperation between Myanmar and EAEU member countries, enhancement of agriculture, transport, mining technology and energy sectors of Myanmar and potential for cooperation in these sectors, further acceleration of trade opportunities through conducting direct trade and investment and holding expositions and fora between Myanmar and EAEU member countries, support of EAEU for Myanmar to become an observer country of EAEU,

and creation of good opportunities to ensure economic cooperation.

Also, present at the meeting together with the Senior General were Council Joint Secretary General Ye Win Oo, SAC member General Nyo Saw, Deputy Prime Minister and Union Minister for Foreign Affairs U Than Swe, Union Minister for Investment and Foreign Economic Relations Dr Kan Zaw, deputy ministers, Myanmar Ambassador to the Republic of Belarus U Thit Linn Ohn and officials. 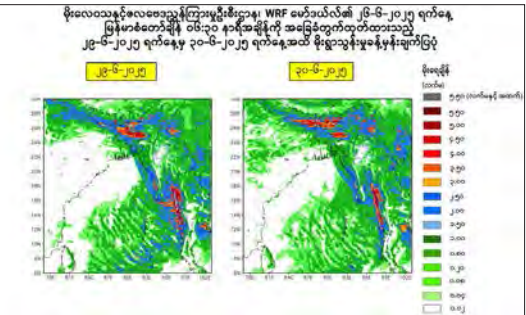
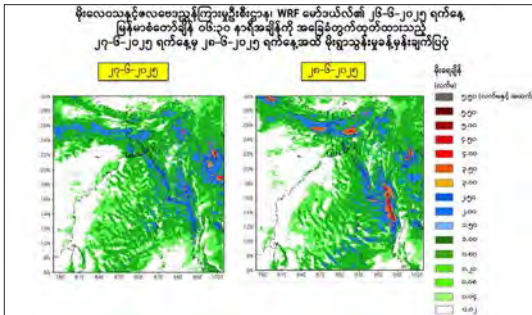

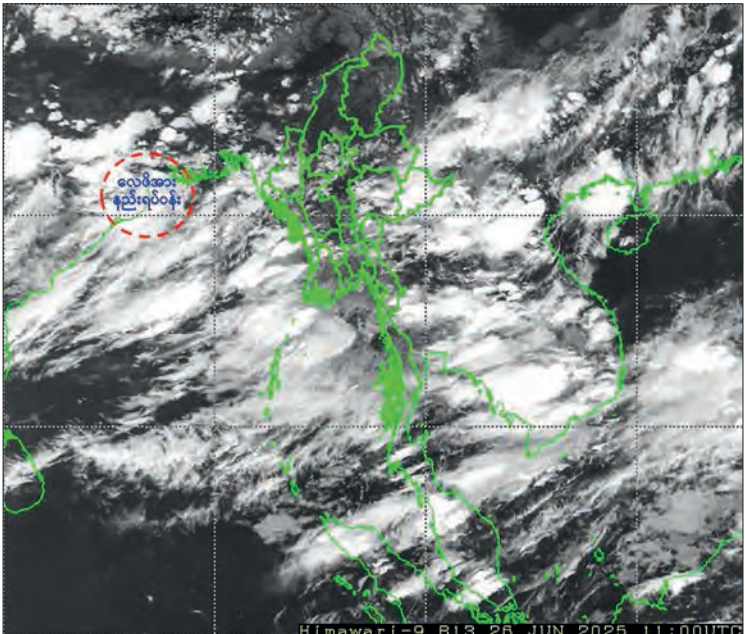

Relief and rehab efforts ongoing for Mandalay quake victims

AS of 26 June, six regions and states in Myanmar severely affected by the powerful earthquake that struck on 28 March have reported a total of 3,768 deaths, 5,104 injuries, and 38 people still missing.

The Myanmar Fire Brigaded, along with local and international search and rescue teams, has been actively conducting emergency operations

in the affected areas. To date, they have successfully rescued 653 survivors trapped under collapsed buildings and recovered the bodies of 846 deceased persons.

Donations in cash and kind continue to be provided to those affected by the disaster. These contributions come not only from domestic donors but also from foreign countries, or-

ganizations, and international philanthropists.

Between 5 pm on 25 June and 5 pm on 26 June, a shipment of medicines weighing a total of 17.542 tonnes arrived at Yangon International Airport. The donation was made by the ICRC. These medical supplies are to be used in healthcare services. — MNA/MKKS

The Chairman of the State Administration Council, Prime Minister Senior General Min Aung Hlaing, attended the Plenary Session of the 4th Eurasian Economic Forum (EEF 2025) at the Minsk International Exhibition Centre BELEXPO in Minsk, the Republic of Belarus, yesterday evening.

The forum was held with the title of Strategy of the Eurasian Economic Integration: Outcomes and Prospects. It was attended by the Rotating Chair of Eurasian Economic Union-EAEU President of the Republic of Belarus together with the President of the Russian Federation, the President of Kazakhstan and the President of Kirgizstan of EAEU member states, EAEU observer State President of Cuba, invited countries' representatives from Mongolia and the UAE, the SAC Chairman, Prime Minister of the Republic of the Union of Myanmar and the special envoy of the President of Nicaragua. Moreover, government representatives from partnership countries interested in Eurasian economic cooperation, businesspersons and representatives from international organizations also attended the forum.

The Senior General and Heads of State from various countries were welcomed by Belarusian Deputy Prime Minister Mrs Petkevich N V.

At the plenary session of the forum, they were also welcomed by Belarusian President Mr Alexander Grigoryevich Lukashenko.

The plenary session was held with the title of Strategy of the Eurasian Economic Integration: outcomes and prospects. The Belarusian President delivered a speech. Afterwards, Heads of State from Armenia, Kazakhstan, Kyrgyzstan and the Russian Federation, the President of Cuba, the Chairman of the Board of EEC, the SAC Chairman and Prime Minister of Myanmar and the special envoy of the Nicaraguan President delivered speeches.

member states, observer countries, invited nations, and international economic stakeholders — has been organized, and this year marks its fourth edition. Through these forums and collaborations with international organizations and countries, the EAEU has been able to progressively implement various initiatives to adapt to the changing global environment. These include enhancing its international presence, establishing a platform for cooperation in the transport and energy sectors, upgrading international payment systems, promoting the emergence of Free Trade Agreements (FTAs), facilitating smooth investment flows across different development sectors, and advancing financial support mechanisms. In building a progressive human society, it is necessary for us to construct a unified and harmonious regional

organization based on mutual respect and cooperation.

The fundamental principles of the Eurasian Economic Union (EAEU) include following international laws, such as the equal sovereignty of member states and the inviolability of borders, as well as respect for national interests — values that are practically needed in today's world. In the current global landscape, powerful nations are exerting political and economic pressure and imposing sanctions on smaller countries, and this is the violation of the fundamental principles of international relations. Myanmar wishes to express its support and admiration for the actions and achievements of the EAEU, which upholds sound principles that every nation should embrace and puts them into practice for global development. Just as Myanmar values and is interested in

the EAEU's initiatives and successes, the country will also continue to enhance its cooperation with the Union. It is also hoped that, in support of such efforts, the Chairman, member states, and the EAEU headquarters will continue to assist in these undertakings.

Myanmar burns K1,000B worth of seized narcotic drugs

MYANMAR burned narcotic drugs in major cities of the country yesterday, marking the International Day Against Drug Abuse and Illicit Trafficking.

In Taunggyi, 19 kinds of narcotic drugs and 12 types of precursor chemicals worth over K353 billion (US\$98 million), which were seized in Shan and Kayah states, were destroyed at the event.

In Yangon, 25 kinds of narcotic drugs and 11 types of precursor chemicals worth over K424 billion (\$118 million) that were seized in Yangon, Ayeyawady, Bago, Tanin-

thayi, Mon, Kayin, Rakhine, were also destroyed.

Moreover, 26 kinds of narcotic drugs and 17 types of precursor chemicals worth over K295 billion (\$82 million) that were seized in Mandalay, and the upper and middle parts of the country, were burnt in Mandalay Region.

This year, the country burnt 66 kinds of drugs and precursor chemicals, including heroin, opium, methamphetamine, ICE, Happy Water, speciosa powder, cannabis and ketamine worth over K1,072 billion (\$297 million) in Yangon,

Mandalay, Taunggyi and Sagaing.

Moreover, the ceremony to award the winners of different categories for short stories, articles, and so on, marking the 38th International Day against Drug Abuse and Illicit Trafficking, was also organized at the designated places in Nay Pyi Taw and different regions and states, with the attendance of relevant officials.

From 1 June 2024 to 31 May 2025, the police seized drugs and precursor chemicals worth over K972.461 billion. — MNA/KTZH

Kayin State records 78 drug-related cases worth K3.9B in 5 months

AUTHORITIES in Kayin State recorded a total of 78 drug-related cases involving 117 offenders between 1 January and 31 May 2025, with the estimated value of the seized drugs reaching K3.9 billion. This was revealed during the 38th International Day Against Drug Abuse and Illicit Trafficking event held at Zweekabin Hall in Hpa-an at 8 am on 26 June.

Although poppy cultivation and drug production are minimal in Kayin State, officials reported that illegal drug trafficking continues due to cross-border smuggling of controlled chemicals, issues related to migrant workers, and local drug distribution through various channels. In response, Tatmadaw, Myanmar Police Force, Anti-Drug Police Force, and allied organizations are carrying out daily anti-drug operations based on tailored regional strategies.

At the event, Kayin State Chief Minister U Saw Myint Oo encouraged enhanced cooperation between the health and justice sectors in addressing drug problems, stressing that drug abuse is a global threat to humanity. He called on all stakeholders to join hands to eliminate drug dangers and build a “Drug-Free State”.

During the ceremony, Minister for Security and Border Affairs and Chair of the Kayin State Drug Control Committee Colonel Min Thu Kyaw read a message from the Chairman of the Central Committee for Drug Abuse Control, who is also Union Minister for Home

Affairs Attendees then viewed a video showcasing the committee’s activities. The chief minister also presented the certificates of honour and awards to individuals who made notable contributions to anti-narcotics efforts.

Following the ceremony, the chief minister and officials met informally with participants and visited educational booths, photo exhibitions, and crime scene display vehicles. They observed students actively engaging in the displays and discussed necessary support measures with responsible personnel. — Saw Myo Min Thein (IPRD)/KZL

Walking Together, Rain or Shine

LOVE is life, isn’t it? It’s not always found in poems or songs, not always loud or full of fireworks. Sometimes, love is quiet. It walks gently on the streets, unnoticed by most, but deeply felt by those who pause to observe. I once saw such love, and I still remember it vividly.

Almost every day, between 7 am and 8 am, I became aware of a couple who came to the same street as I sat sipping my morning tea. At first, I didn’t pay them much attention, but soon, the quiet rhythm of their presence touched something deep in me.

The man always wore sunglasses – thick, dark ones that covered his eyes completely. The woman carried a canvas bag, medium in size, hanging over her right shoulder. Their clothes were plain and faded, neither neat nor messy, simply lived-in, speaking of honest lives and long days. There

was nothing flashy or extraordinary about them. But the way they walked – ah, that was something worth noticing.

He held on to her shoulder gently, his fingers curved softly, never gripping too tightly. His steps were hesitant, uncertain, but hers were calm and sure. She led the way, not pulling him, but walking in a pace that allowed him to follow with dignity. They moved together in harmony, like two parts of one soul.

They used to enter the small café nearby, the one called “Sein”. It was not a grand place – just a humble shop with a few tables, the smell of tea leaves, and a boy who served quietly. This couple came in almost every morning, and every morning, they followed the same routine.

The woman would ask for just one cup of tea, not the special one, the “Shal”, which was more ex-

pensive and fragrant, but the ordinary one, the cheaper, simpler tea. That choice, too, said something. Perhaps it was a matter of money, or perhaps it was simply their way, living within means, without complaint.

She also ordered deep-fried twisted dough sticks, fresh from the pan. When they arrived, golden and warm, she tore one in half and placed a piece in the man’s hand. Then, with delicate care, she poured half of the tea into the saucer and slid the remaining tea, still steaming in its porcelain cup, toward the man. Everything was shared, halved with balance, not out of duty, but out of love.

I watched as they dipped their dough sticks in the tea, tasting each bite slowly, sipping tea in between. There was no rush. Their silence was not empty – it was peaceful, filled with meaning. They spoke in whispers, close to



one another, as if the world didn’t need to know what they were saying. I never heard their words, but I didn’t need to. Their connection was clear in the way they sat, the way they listened, the way they smiled faintly now and then.

When they were done, the woman would wave to the young boy and quietly settle the payment. No arguments, no show. She paid, they stood, and they left the café, side by side.

I watched them go, every

time. It became a habit of mine, this silent observation. Whether the sky was clear or cloudy, whether the sun was shining or the rain was falling, they walked the same path. Their steps did not falter. The man’s hand remained

gently on her shoulder. And she led him, with the same care and calm as always.

I didn’t know where they went after they left. I didn’t know where they lived or how they earned their living. The man’s sunglasses were not just for the sun. He was losing his eyesight – perhaps already completely blind. And the woman, with her gentle guiding steps, could see. She could lead. But still, it was impossible to tell who supported whom.

It is easy to assume that the one who sees is the one who guides in every way. But life isn’t always that simple. Perhaps the man, despite his blindness, had a special talent, a craft, a knowledge, a quiet strength. Perhaps he was once an artist, or a musician, or someone who taught others through voice and wisdom, not sight. Perhaps they both had learned to depend on one another equally, not out of weakness but out of love.

They didn’t look wealthy. But they didn’t look poor in spirit either. There was a richness in their togetherness, something that could not be bought. The way she handed him the tea, the way he waited patiently for his share, the way they walked in step – it all spoke of a deep, unshakable trust.

I thought many times about their life. Were they husband and wife? Likely so. Had they faced hardship? Surely. But they carried

it lightly, gracefully. No complaints, no bitterness. Just a shared path, walked side by side.

Perhaps they had married long ago, not for comfort or convenience, but because they had found something real in each other. Perhaps their love had been tested by time and trouble, but it remained firm and kind. That kind of love is rare – not made of passion alone, but of patience, acceptance, and quiet care.

His blindness, I realized, was not a void in their life. It did not seem to be a loss that broke them. Instead, it became something they lived with, and around, and through. Her eyes became his eyes, and maybe in return, he gave her something equally valuable – his trust, his presence, his unwavering companionship.

What I saw in them each day was not dramatic, not loud. But it stayed with me. It made me think about love differently, not as a feeling that comes and goes, but as something one chooses, every single day.

Love, in their case, was a cup of tea, shared in halves. It was warm dough sticks, broken in two. It was a hand on a shoulder, steady and soft. It was walking together, rain or shine, on a path that had no clear end.

Yes, love is life.

And for some, it is lived not in grand gestures, but in the simplest things done together, with care.

boys tend to spend too much time playing video games online. Even some of them play the games all through the night. As a consequence, they are given to yawning or dozing off very quickly during class time for the simple reason that they have not got enough sleep at night. Hence, they are getting to pay such less attention to teachers that the teachers cannot stimulate any positive motivation, like joking or other similar stimulation towards them. In other words, such schoolboys are beset with so much ‘sleep debt’ that they are unable to pay back quite easily. Sleep is a physiological need as well, and if they do not have enough sleep, they will lose their health, which can do serious damage to their school studies sooner or later.

It is natural if students become interested in the opposite sex; that is, a boy is attracted by a girl or vice versa, when they grow up, especially during adolescence. However, teachers cannot assume it to be more than the nature and neither should students. Despite this, not only schoolboys but also schoolgirls are inclined to make contact with someone who interests them on the phone from afar. Surprisingly, those people may include non-students, not student-to-student, sometimes. Some students have a deadly serious relationship with someone who is not worth saying. As a result, they are most likely to face the threat of privacy invasion, sexual conflicts, sexual harassment, and even sexual abuse. At the very worst, some students with the phone in their

hands are found to be particularly prone to marry young.

To say it candidly, students find it more interesting to use the phone than learn school subjects. Certainly, their time to use the phone will never make them bored to a great degree. At least it will surely lessen their feeling of boredom or loneliness to a certain extent. But on the other side, the more students use the phone, the more they stay in isolation from their studies, teachers, friends and environment. To make sense, the students are even completely unaware of what their surrounding is happening. Due to their sedentary lifestyle, their health begins to go downhill – in the main, they will have poor vision and then can underachieve or lose concentration on their studies. They may

do badly in their school lessons, as well as their exam results should not be good. If the worst comes to the worst, they could drop out just before the end of the academic year.

I used to have a pupil with online game addiction. Of course, he came from a distant town, namely Myeik, and went to school in our nearby village. As he stayed away from his parents, his father got him a phone lest he could lose face in their relatives’ village. First of all, he used the phone for a regular connection between him and his family – frankly speaking, sometimes with his girl. But later, he wasted too much time playing online games, lying in his bed. Then, he often suffered from paralysis of his mouth. Afterwards, he put a bet on online games and had an illegal lottery in the flesh. Thus, he had to go back to his hometown with an outstanding debt of

K300,000, sad to say.

In actual fact, students using the phone itself is not the problem, but not having digital literacy is a very real problem. If a student can use Facebook, TikTok and Telegram, he or she must also be able to go to Google and YouTube. Students can see a wide variety of study resources on the internet websites over there. They will be able to study video lessons on YouTube regarding school languages and science subjects. It means that students can do home-based learning, self-directed learning and continuous learning. Here, I do not mean that it is pointless for students to use the phone at all. As my tip, students should use the phone only at weekends, not on weekdays, and only for a few hours at a sitting. After all, the fact that the phone is a friend or an enemy for young students today depends on the phone users only.

30,000+ foreign

DICA: 400 companies fail to file AR in May 2025

FOUR hundred companies were struck off the register in May 2025 as they failed to file annual returns (AR) on the online registry system, MyCO, according to the Directorate of Investment and Company Administration (DICA).

The DICA report showed failure of 1,500 companies each in February and January, 900 in March to submit AR. No company lacked to file AR in April.

The DICA notified those companies which failed to file their AR on the MyCO and were struck off the register from the date of the directive, under 430 (F) of the Myanmar Companies Law, according to the DICA's notification.

A total of 19,000 companies also failed to submit the AR in 2024. The registration and re-registration of companies on the MyCO website commenced on 1 August 2018, in keeping with the Myanmar Companies Law 2017.

All registered companies need to submit AR on the MyCO registry system within two months of incorporation, and at least once every year (not later than one month after the anniversary of the incorporation), according to Section 97 of the law.

Under Section 266 (A) of the Myanmar Companies Law 2017, public companies

must submit annual returns and financial statements (G-5) simultaneously. All overseas corporations must submit ARs in the prescribed format on MyCO within 28 days of the financial year ending, under Section 53 (A-1) of the Myanmar Companies Law 2017.

As per DICA's report, thousands of companies were suspended for failing to submit AR forms before the due date. Newly established companies are required to submit ARs within two months of incorporation or face a fine of K100,000 for filing late returns.

The DICA has notified that any company which fails to submit its AR within 13 months will be notified of its suspension (I-9A). If it fails to submit the AR within 28 days of receiving the notice, the system will show the company's status as suspended. Companies can restore their status only after shelling out a fine of K50,000 for AR fee, K100,000 for restoration of the company on the Register, and K100,000 for late filing of documents, totalling K250,000. If a company fails to restore its status within six months of suspension, the registrar will strike its name off the register, according to the DICA notice. — NN/KK

Trainees invited for farm machinery training

THE Agricultural Mechanization Department under the Ministry of Agriculture, Livestock and Irrigation recruits trainees for farm machinery operation and maintenance training at the respective training schools to equip them with essential knowledge and skills to efficiently operate, maintain and repair agricultural equipment.

It plays a pivotal role in maximizing productivity, extending the lifespan of the machinery and ensuring workplace safety on the farms. Therefore, the department has been offering the training starting from the 2011-2012 financial year, producing 6,888 trainees in 110 batches.

Ninety per cent of them are found to be engaged in the

agricultural machinery-related industry.

Interested individuals must have at least a middle school education background (Grade 9). They must be male between 18 and 35 years old, with a passion for agricultural equipment. The department will provide the food, accommodation and training fees. Yet, trainees must purchase a manual.

Those interested can contact the nearest schools and workshops of the departments in the regions and states to enrol in the training for the 2025-2026 FY.

Training opening dates are from 14 July to 5 September for Meiktila Training 2, from 4 August to 26 September for Phayagyi Training 2, from 8

September to 31 October for Meiktila Training 3, from 13 October to 5 December for Phayagyi Training 3, from 17 November 2025 to 9 January 2026 for Meiktila Training 4, from 5 January to 27 February 2026 for Phayagyi Training 4 and from 19 January to 13 March for Meiktila Training 5.

Upon completion of the training, trainees will have job opportunities in the department or the farm machinery and related companies or as self-employed to manage the farms.

CBM sells over US\$1.4M to edible oil importing companies on 25 June

THE Central Bank of Myanmar (CBM) made US\$1.479 million injection from foreign currencies purchased from the CMP businesses into the edible oil-importing sector on 25 June.

CBM sold over 700,000 yuan on 24 June. Furthermore, CBM sold \$870,000, which was purchased from the CMP companies, to edible oil-importing companies on that day.

CBM announced on 23 June to pump US\$30 million into the fuel oil sector. CBM sold \$464,500 to edible oil importing companies and over \$496,000 to commodity-importing companies on that day after injection of over 16,540 yuan

into the market.

CBM sold over \$600,000 and 387,000 yuan on 20 June. Furthermore, it sold \$800,000 to edible oil-importing companies and over \$503,000 from its designated injection into commodity-importing companies.

CBM pumped over \$577,000 out of its designated \$10 million injection into commodity-importing companies on 19 June.

Moreover, CBM sold \$1.524 million from the companies working on a Cutting-Making and Packaging basis to edible oil-importing companies on the same day.

CBM sold over \$1 million

out of the designated \$10 million injection to commodity-importing companies on 18 June 2025. Furthermore, CBM also sold US\$1.68 million from CMP companies to edible oil importing companies on that day.

CBM aims to curb the instability in the foreign exchange market and currency devaluation. According to CBM's notification on 15 March, it has been collaborating with law enforcement agencies to combat and prosecute those who attempt to manipulate the currency market under the existing laws. CBM allowed authorized dealers (private banks) to operate online foreign exchange trading freely as per the market rate, depending on supply and demand, starting from 5 December 2023. — NN/KK

H&M sales fall in second quarter on stronger currency

SWEDISH fashion giant H&M on Thursday reported a drop in sales and profit in the second quarter, as currency effects weighed on the company’s earnings.
H&M said its net profit fell to 3.96 billion kronor (\$419 million) for the period of March to May of 2025, down from 5.06 billion a year earlier.
“The quarter’s result was negatively affected by higher

purchasing prices as a result of a more expensive US dollar and higher freight costs, but also by the fact that we have continued to invest in the customer offering,” H&M chief executive Daniel Erver said in a statement.
Erver noted that “negative external factors that increased the costs of purchasing for the first half of the year are turning positive for the

second half of the year”.
Net sales for the company fell nearly five per cent to 56.7 billion kronor, compared to the second quarter of 2024.
But the company noted that net sales rose by one per cent in local currencies “with four per cent fewer stores at the end of the quarter compared with the same point in time the previous year.” — AFP

India’s passenger vehicle retail sales drop 13.6% in May amid geopolitical tensions: ICRA

THE Indian passenger vehicle (PV) industry witnessed a 13.6 per cent contraction in retail sales in May 2025, primarily due to subdued consumer sentiment amid heightened geopolitical tensions in northern India following the India-Pakistan conflict, according to a report by credit rating agency ICRA.
The credit rating agency said that despite continued discounting by automakers, demand for PVs has softened from 3,49,939 units in April 2025 to 3,02,214 units in May 2025.

Meanwhile, the two-wheeler segment demonstrated stronger performance, with retail volumes growing seven per cent year-on-year, supported by robust rural demand and a healthy harvest season.
As per the agency, the PV wholesale volumes remained steady at 3.4 lakh units in May 2025.
The availability of rare earth magnets (a key component for electric vehicles) is monitorable amid restrictions imposed by China.— ANI

New foreign bank begins operation in Kazakhstan

KAZAKHSTAN has granted a banking licence to BNK Commercial Bank, a subsidiary of South Korea’s BNK Financial Group, which marks the country’s first newly licensed commercial bank in over a decade, the Kazinform News

Agency reported Wednesday. BNK Commercial Bank becomes the first foreign bank to receive a banking licence in Kazakhstan since 2010.
The move aligns with Kazakh President Kassym-Jomart Tokayev’s call to

attract reputable international financial institutions and enhance competition in the banking sector, as outlined in his annual state-of-the-nation address in September 2023.

Russia initiates creation of international BRICS scientific databases

RUSSIA has initiated the development of joint BRICS scientific databases, which will allow half of humanity to consolidate its scientific resources and accelerate breakthrough research, Russian Deputy Minister of Education and Science Konstantin Mogilevsky said.

Mogilevsky chaired Russia's delegation to the 13th meeting of BRICS ministers of science, technology, and innovation in Brazil on Wednesday, where the participants discussed key steps to strengthen the scientific sovereignty of the BRICS countries.

"BRICS represents more than half of humanity, and the BRICS countries have a natural competitive advantage in this regard. It is certainly necessary to use it: we are raising the issue of creating international databases under BRICS — on medicine, genetics, and materials science," Mogilevsky said at the summit, as quoted by his ministry's press service in a news release on Thursday.

He added that this topic will be discussed within a specialized BRICS working group on biomedicine and biotechnology. — SPUTNIK

S Korea's Lee seeks opposition cooperation over extra budget bill

SOUTH Korean President Lee Jae Myung on Thursday called for cooperation from the biggest opposition party in passing an extra budget bill, as he delivered his first speech to the country's parliament since taking office earlier this month.

South Korea's two main parties, the ruling Democratic Party and the opposition People Power Party, have been locked in a fierce confrontation since Yoon Suk Yeol, the former president from the PPP, came to power in 2022. Yoon was ousted in April following his short-lived imposition of martial law in December. — Kyodo

Global South can play greater role in promoting peace through health: experts

COUNTRIES of the Global South can play greater roles in promoting world peace by providing more equitable and accessible health public goods, according to experts at an international forum held in Beijing.

The forum, focusing on the Global Health and Peace Initiative launched by the World Health Organization (WHO), was hosted by China Foreign Affairs University (CFAU) on Wednesday. Dozens of experts from organizations and institutes, including the WHO and the International Committee of Red Cross (ICRC), held extensive discussions on the relationship between public health and global peace. — Xinhua

NATO countries agree to hike defence spending to 5% of GDP by 2035

MEMBER states of the North Atlantic Treaty Organization (NATO) have agreed to raise their defense spending to five per cent of gross domestic product (GDP) annually by 2035, according to a declaration issued on Wednesday following the high-level summit in The Hague.

The five-paragraph statement outlined that the new spending target will be split between two key categories: 3.5 per cent for core defence and 1.5 per cent for related areas, including critical infrastructure, networks, and defence industrial capabilities.

The plan will undergo a review in 2029, taking into account the strategic environment and revised capability targets, the document added. US President Donald Trump hailed the agreement at a press conference after the summit, asserting that Washington had long carried more than its fair share of the alliance's defence burden. — Xinhua

Iran's Constitutional Council approves plan to suspend cooperation with IAEA

IRAN'S Constitutional Council on Thursday approved a plan, already ratified by the parliament, to suspend the country's cooperation with the United Nations nuclear watchdog.

The plan, which calls on the Iranian government to halt cooperation with the International Atomic Energy Agency (IAEA), was reviewed by the council and found to be in line with Iran's religious regulations, laws, and constitution, council spokesperson Hadi Tahan Nazif said in an interview with state-run IRIB TV on Thursday.

"Given the violation of Iran's national sovereignty by the United States and Israel, their attacks on its territorial integrity as well as peaceful nuclear facilities and jeopardizing of the national interests, the Iranian administration is duty-bound to suspend any cooperation with the IAEA by the time full respect is not guaranteed for the country's national sovereignty and territorial integrity, and security is not ensured for Iranian nuclear centers and scientists," said Tahan Nazif. — Xinhua

US President Donald Trump said here on Wednesday that the United States will hold talks with Iran next week. "We're going to talk to them next week, with Iran. We may sign an agreement," Trump said during a press conference in The Hague following the NATO summit. Earlier on Wednesday, Trump said that a ceasefire between Iran and Israel is going "very good." "I think it's (going) very good. Israel came back yesterday," Trump told reporters at the NATO summit in The Hague, referring to his Tuesday warning to Israel to halt airstrikes on Iran. — Xinhua

Olympian Arimori picked as 1st female chief of Japan athletics ass'n

YUKO Arimori, who won two Olympic marathon medals in the 1990s, was selected Wednesday as president of the Japan Association of Athletics Federations, becoming the first female to serve in the role.

Arimori, 58, is also the first Japanese Olympian to lead the association, which marks this year the 100th anniversary of its founding. Her elevation from vice president of the organization comes ahead of the World Athletics Championships in Tokyo in September. "I'll work to make track and field appealing so more people love and enjoy it," Arimori told a press conference in Tokyo. — Kyodo

Liverpool sign Bournemouth defender Kerkez

LIVERPOOL on Thursday announced they had completed the £40 million (\$55 million) signing of Bournemouth defender Milos Kerkez.

The 21-year-old, who has penned a five-year deal, is the third major signing of the transfer window for the Premier League champions following the arrival of Jeremie Frimpong and Florian Wirtz.

Germany midfielder Wirtz was signed for a club-record fee that could reportedly rise to £116 million.

With Valencia goalkeeper Giorgi Mamardashvili joining next month in a deal done 12 months ago there will be more than £200 million of new talent present when pre-season training starts.

Left-back Kerkez is viewed as the long-term successor to 31-year-old Andy Robertson, who is a target for Atletico Madrid.

"I'm really happy," said the Hungary international. "It's a real honour for me, a privilege to come to play for one of the biggest clubs in the world, the biggest club in England. I'm just really, really happy and excited. "After this, I'll go home and in my hometown enjoy a few days, and then I can't really wait to come back and put the training kit on and start to train and prepare for the season." Kerkez made 74 appearances for Bournemouth after joining from AZ Alkmaar two years ago, scoring twice. — AFP

Myanmar to face Afghanistan and Maldives in futsal qualifiers

MYANMAR is grouped in Group H alongside Afghanistan and the Maldives in the AFC Futsal Asian Cup 2026 qualification lot-drawing event, which took place on 26 June.

Group A features Kuwait, Australia, Mongolia and India. Group B includes Thailand, South Korea, Bahrain and Brunei. Group C consists of Japan, Tajikistan, Macau and Cambo-

Cristiano Ronaldo to stay at Al Nassr until 2027

CRISTIANO Ronaldo inked a two-year extension with Saudi Arabia's Al Nassr; the club announced Thursday, following months of speculation over which team he would sign for next season.

"Cristiano Ronaldo is staying at @AlNassrFC until 2027," the club wrote in a post on X.

Minutes before the official confirmation, the

team posted a teaser video, with the 40-year-old Ronaldo walking along a beachfront and saying: "Al Nassr forever".

The Portuguese superstar arrived in 2023 in the kingdom to play with the club, heralding a rush of players in the latter stages of their careers to the oil-rich country.

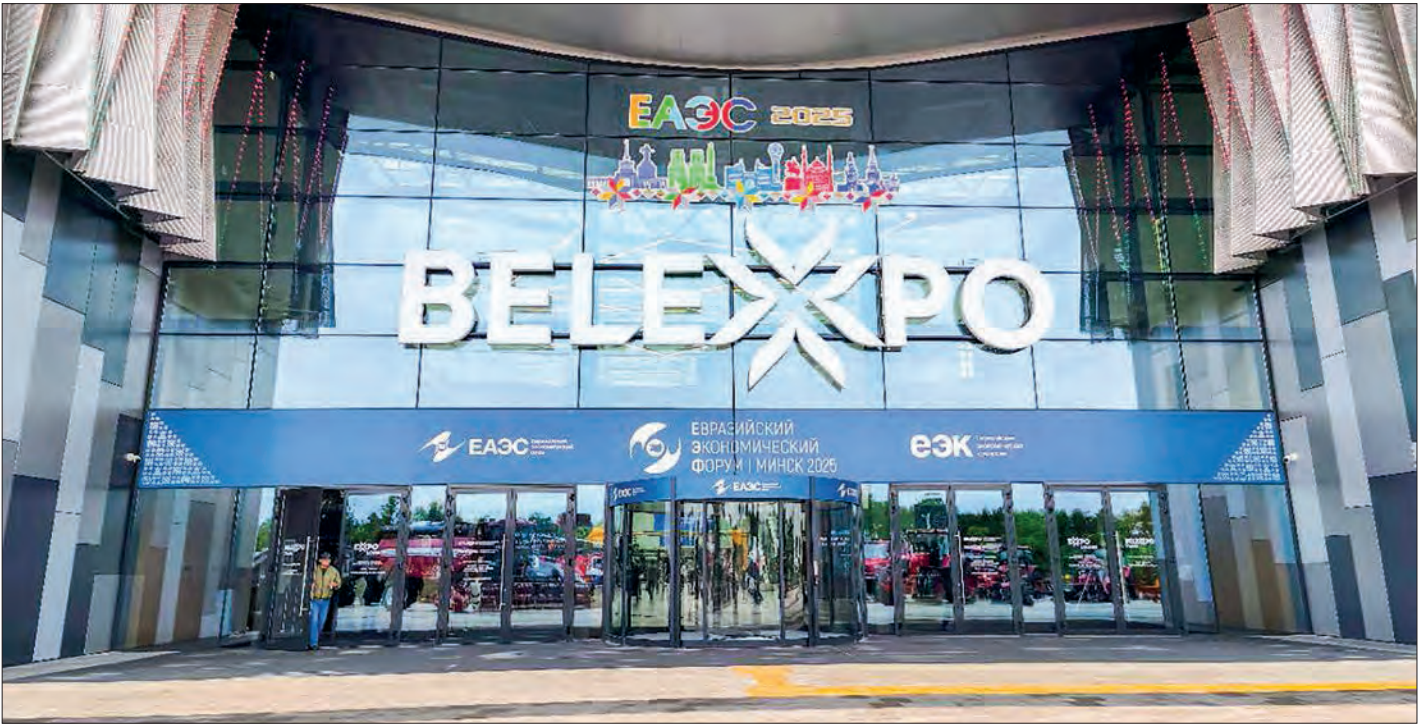
Neuroscience

Global conflict potential
growing dangerously, warns
Russian Defence Minister

THE military-political situation in the world is deteriorating, the potential for conflict is growing dangerously, Russian Defence Minister Andrei Belousov said on Thursday.

"The current military-political situation in the world remains complex and tends to deteriorate. Geopolitical contradictions have intensified. The fundamental foundations of strategic stability are being destroyed. The potential for conflict has increased threateningly. Against this background, the role of international institutions designed to ensure global stability has fallen to an unacceptable level," Belousov said, addressing the a meeting of heads of the Shanghai Cooperation Organization (SCO) member countries' defence ministries.

Numerous hotbeds of instability are being created in the world, including in the SCO and along its perimeter, the minister added.

Prolonging military operations by supplying Kyiv with Western weapons threatens to destabilize the situation in Europe, Andrei Belousov said. — SPUTNIK
