Strive for development of agriculture sector

Enlisting the cooperation and participation of the entire national people, the State Peace and Development Council has vowed to enable the Union of Myanmar to keep abreast of the development of other nations of the world. Malaysian Supreme Head of State visits Great Wall

BELJING, 2 March — When 62-vear-old Malaysian Supreme Head of State Tuanku Syed Sirajuddin was told on Tuesday that he is indeed a true man while gazing at the snow-covered Great Wall, he felt excited and smiled happily.

"Late Chairman Mao Zedong once said, 'He who does not reach the Great Wall is not a true man' You are indeed a true man for you have just climbed the Great Wall, particularly in snowing weather," Guo Zaoshun, a local official in charge of the Badaling Great Wall, told the distinguished guest, who is the 406th head of state the Badaling has received since 1954.

Built 2,000 years ago, the 6,300kilometre Great Wall was the greatest military defence project in ancient China.

The 3,741-metre-long Badaling section, first built approximately 500 years ago and dotted by 19 beacon towers, is one of the most popular tourist attrac-

tions for guests from home and abroad, including quite a number of political dignitaries from other countries

Sirajuddin arrived in Beijing on Monday noon for a state visit to China from 28 February to 6 March, at the invitation of Chinese President Hu Jintao

Sirajuddin toured the Great Wall Tuesday morning. Looking around at the impressive view of the Great Wall in white snow, Sirajuddin took photos with his wife and his lovely granddaughter, with great interest.

"Now I am visiting one of the Seven Wonders of the World and seeing is believing the achievement of the Chinese people in the past," Sirajuddin praised the Great Wall .- MNA/Xinhua

Organizing committee set up for world law conference

BEIJING, 2 March— An organizing committee chaired by China's Chief Justice was set up on Tuesday, to begin preparation for the upcoming congress to the World Jurist Association (WJA) this September

The 22nd Congress on the Law of the World will be held in Beijing and Shanghai from 4 to 10 September

"The Rule of Law and Harmony of International Society" was set as the theme of the congress, said Xiao Yang, the Chief Justice and President of the Supreme People's Court who led the 44-member committee mainly composed of elite in China's justice circle

"Law is the language with which we communicate with the world," Xiao said. He pledged to make the conference a high-level gala for the world's legal community.

The congress will focus on the rule of law, the role each country plays in building a harmonious international community and future challenges, said Cao Jianming, vice-president of the Supreme People's Court.

The topics will cover legal cooperation, law and politics, law and international trade, law and technology, law and environment protection and legal education, Cao said. The conference will hold simulation trials with chief justice and judges of international

Malaysia to rehire Filipino workers with proper documentation

MANILA, 2 March — Malaysia Government has promised to rehire Filipino workers who returned to the Philippines before the crackdown on illegal aliens, a local TV reported on Tuesday. The Department of Labour and Employment | in Sabah. (DOLE) told the ABS-CBN news channel that the Malaysian Ministry of Home Affairs has assured the Philippine delegation from the Labour, Foreign Affairs and the Social Welfare departments that Filipino workers can go back to their old jobs in Malaysia.

However, Labour Undersecretary Manuel Imson said that the pledge was given provided that the workers present proper documentation from the Philippine Government. On 22 October, 2004, the Malaysian Government granted amnesty to illegal aliens in the country.

The original 31 December deadline of the amnesty was extended until 31 January upon Indonesia's request because of the earthquakes and tsunamis that hit many parts of Asia on 26 December.

The crackdown scheduled for 1 February was suspended upon the request of the Philippines and Indonesia and was rescheduled to 1 March.

According to the DOLE, there are an estimated 170,000 undocumented Filipinos in Malaysia, mostly

However, only 6,527 returned to the Philippines in late January to avoid arrest, it added.

The DOLE said that members of the Sabah Employers Federation also vowed they will reemploy Filipino migrant workers after they complied with the requirements.

The Department of Foreign Affairs (DFA) on Monday said that Philippine Navy ships are on standby to transport hordes of Filipinos who will be deported on Tuesday by Malaysian authorities from the island of Sabah. The DFA said that in preparation for the mass deportation, two teams have been deployed - one in Malaysia and the other in southern Mindanao to facilitate the smooth turnover of deportees.

Malaysia's revised immigration policy against illegal workers, which led to the expulsion of thousands of Filipino workers in Sabah in 2002, caused a diplomatic furore between Manila and Kuala Lumpur.

Iraq war to cost US taxpayers at least \$50b in 2006

WASHINGTON, 2 March — The Senate's top budget writer said on Tuesday his plan assumes the Iraq war will cost US taxpayers at least 50 billion US dollars next year, as lawmakers questioned spending in the Bush Administration's current emergency request for the war.

Senator Judd Gregg, the New Hampshire Republican who chairs the Budget Committee, said he will propose a 50billion-US-dollar "reserve fund" for the Iraq and Afghanistan conflicts for next fiscal year that starts on 1 October.

That is on top of the 419 billion US dollars the Administration wants for next year's regular Pentagon operations.

President George W Bush excluded war costs, as well as costs of reconfiguring the Army that has been stretched by the conflicts, from the 2.5trillion-US-dollar federal budget for fiscal 2006 he submitted to Congress early last month.

Instead he is seeking a separate 81.9 billion US dollars spending bill to get funds as soon as possible this year, pushing the total tab for both conflicts toward 300 billion US dollars. The Pentagon has said it will seek another substantial emergency supplemental budget request next year.

Democrats and some Republicans charged the White House is trying to ram through the Iraq war funding, giving lawmakers little time for oversight and masking the war's overall costs.

"The harsh reality is this has cost us a lot, and it's going to cost us a lot more,' said Kent Conrad of North Dakota, the committee's top Democrat. "As I look at the budget, I don't see the President providing for these costs anywhere close to what most objective observers say the cost is going to be."

Deputy Defence Secretary Paul Wolfowitz told the committee he could "absolutely predict there will be a supplemental budget request next year."

But he said he could not predict the amount, although he said it would include "a substantial request" to continue efforts to break Army forces into smaller, more mobile brigades and refurbish their equipment.

NZ to support Tsunami recovery in Maldives

WELLINGTON, 3 Mar-- New Zealand is ch to contribute about 1.08 million US dollars to relief and reconstruction efforts in the Maldives, Foreign Minister Phil Goff announced Wednesday during his visit to the Indian Ocean nation.

According to a government release here Wednesday, Goff said loss of life in the Maldives, whose highest point is no more than two metres above sea level, was thankfully low.

However, almost every island group was hit and the effect on housing, water and health services and tourism infrastructure has been severe, Goff said. MNA/Xinhua

Zimbabwe launches tourism marketing programme in China

HARARE, 2 March— The Zimbabwe Tourism Authority (ZTA) has launched a marketing programme in China to take advantage of the Approved Destination Status (ADS) awarded to Zimbabwe by the Asian country, the *Herald* newspaper reported on Tuesday.

A joint commission on China bringing together key players in the tourism industry has been formed to spearhead the programme.

The programme has already seen the authority holding workshops to appraise hotels on how to prepare Chinese food in anticipation of an increase in tourist arrivals from that destination.

Mary-Anne Situma, the human resources director at the authority, was quoted as saying that an electronic brochure had been launched in January to attract more tourists from Asia.

She said as the marketing programme begins to bear fruit, there was need for Zimbabwe to prepare itself to cater for the Asian market.

Ukraine to start bringing its troops home from Iraq

KIEV, 3 March—Ukraine plans to start bringing its 1,600 troops home from Iraq this month and complete the withdrawal by 15 October, President Viktor Yushchenko said on Wednesday.

Yushchenko, speaking after a meeting of the National Security and Defence Council, said the first group would leave Iraq on 15 March and servicemen would gradually be replaced by instructors and civilian specialists.

We are changing the form of our presence there," he told reporters.

Ukraine has lost 18 which n soldiers in Iraq during their service as part of the USled force based in the country after last year's removal of Saddam Hussein. Yushchenko, who won the presidency in held mass rallies against electoral fraud, has long promised to bring the troops home.

But Yushchenko. who last week met US President George W Bush and other NATO leaders at a summit in Brussels, has also said any withdrawals must be completed in consultation with U S and Iraqi officials. The Ukrainian contingent is one of the largest in a multinational division under Polish command, which now numbers about 6,000 troops. Ukraine's decision to send troops to Iraq last year helped ease strains in relations with the United States caused by allegations that former President Leonid Kuchma's administration had sold weapons to Iraq while Saddam was in

Kuwait announces new LPG prices

KUWAIT CITY, 2 March— Kuwait Petroleum Corporation (KPC) on Tuesday announced new prices of liquefied petroleum gas (LPG) products, propane and butane.

According to a statement released by KPC, propane will be offered at 377 US dollars per metric ton in March, a 12-dollar increase over February and January prices. Butane will also be sold for 382 dollars per metric ton this month, 10 dollars more than the previous two months, said the statement.

Propane and butane are used in household cooking and production of petrochemicals. Analysts attribute high LPG prices to the rising oil prices in the world markets.

Propane prices had reached 417 dollars and 463 dollars, while Butane was offered at 427 dollars and 483 dollars in December and November respectively last year. — *MNA/Xinhua*

SBU detains man with **Uranium-238 at Kiev's airport**

KIEV, 3 March — Ukraine's SBU security service arrested a man at Kiev's airport who had a case containing radioactive Uranium-238 in his car, the Emergencies Ministry said on Tuesday.

It said the man was detained at Boryspil Airport, Ukraine's main international gateway, with 582 grammes of uranium. It did not say when the arrest took place or whether he had been attempting to leave the country.

"SBU officers detained the person who was moving a case with a radioactive substance - Uranium-238 in his car," the ministry said in a statement. It said ministry specialists had seized the case.-MNA/Reuters

Indonesia hopes to attract more Chinese tourists

JAKARTA, 3 March — The Indonesian Government is casting an appreciative eye toward the increasing number of Chinese travelling overseas for vacation, and hopes to lure some 240,000 Chinese tourists to Indonesia in 2005.

"We plan to quadruple the number of Chinese tourists visiting Indonesia," State Minister for Culture and Tourism Jero Wacik was quoted Wednesday by The Jakarta Post as saying.

Jero said the number of outbound tourists from China reached about 20 million last year, but Indonesia was only able to attract some 80,000 of these tourists

To improve on this figure, Jero said the government had recently opened immigration offices in its consulates in Shanghai and Ghuangzhou, in addition to the immigration office in the Indonesian Embassy in Beijing.

The government also hopes to cooperate with Singapore, which last year received 700,000 Chinese tourists, in their efforts to bring in more Chinese tourists to the region.

"We hope that when Chinese tourists are done sight-seeing and shopping in Singapore, they will be interested in continuing on to Indonesia, which has hundreds of tourist attractions for them to visit," Jero said.

The government hopes to attract 6 million foreign tourists this year, who are expected to bring in 6 billion US dollars in foreign

exchange revenue.

Last year, Indonesia attracted some 5.3 million foreign tourists who brought in some 5.3 billion dollars in foreign exchange revenue.

the rights of women in accordance with the traditions and customs of the ethnic groups. Efforts are to be exerted to realize these objectives through the four principles. The tasks of the MWAF cover the whole country. The number of its members is not limited. As it is a social organization in which members can carry out the tasks of their own volition, every Myanmar woman has an opportunity to take part not only in women's affairs but also in national and social activities as members of MWAF.

He said it is necessary for MWAF led by Myanmar women themselves to make arrangements to carry out the tasks systematically like a dynamic and efficient machinery in order to actively participate in Myanmar women's affairs and State affairs. Defence and security industries. man of the National Convention Convening Work Committee Chief Justice U Aung Toe's full clarification concerning the laying down of detailed basic principles for sharing of legislative power to be included in the framing of the State Constitution at the plenary session of the National Convention at Nyaunghnapin Camp in Hmawby Township today.

First, I wish health and happiness for all the delegates to the National Convention.

All the delegates have already known the clarifications made by the National Convention Convening Work Committee Chairman at the plenary meeting of the National Convention held from 17 May to 9 July 2004 and the suggestions presented by delegate groups and some of the delegates concerning the sharing of the legislative power. Of the suggestions, the ones that are suitable for the basic principles already laid down by the National Convention and the detailed basic principles have already been submitted. Some of the presentations of the certain delegate groups are found to be beneficial to both the nation and the people. Thus, the Work Committee has sought the opinion of the delegate groups regarding the suggestions through the panel of chairmen.

The Work Committee thoroughly studied suggestions of the delegates concerning the sharing of the legislative power. And it presented a comprehensive and complete compilation of facts that should be formulated as detailed basic principles to the National Convention Convening Commission. After studying the compilation in detail, the Commission approved them. Now, I will explain the detailed basic principles for the sharing of the legislative power approved by the Commission.

In connection with the sharing of legislative power of the State, the National Convention has already laid down a fundamental principle, --- the legislative power of the State is shared among Union Hluttaw, Region Hluttaws and State Hluttaws; legislative power stipulated by the State Constitution shall be distributed to self-administered areas.

First, the Work Committee will clarify the proposed legislative list to be entrusted to the Pyithu Hluttaw, Amyotha Hluttaw, Pyidaungsu Hluttaw comprising Pyithu Hluttaw and Amyotha Hluttaw and Region or State Hluttaw in 11 sectors as follows:

- (1) Defence and security sector
- (2) Foreign Affairs sector
- (3) Finance and planning sector
- (4) Economic sector
- (5) Agricultural and livestock breeding sector (6) Energy, electric power, mining and forestry sector
- (7) Industrial sector
- (8) Transport and communication sector
- (9) Social sector
- (10) Management sector
- (11) Judicial sector.

Concerning the defence and security sector, the delegates will have to discuss and give suggestions on whether or not the following basic principles should be laid down to be included in the Union Legislative list concerning defence and security of the State:

1. The defence of the Union of Myanmar and of its every part, and to prepare a defence programme thereof.

- Arms and ammunition and explosives including biological and chemical weapons.
- 4. Nuclear energy, nuclear fuel and radiation, and mineral resources that produce them.
- 5. Declaration of war and declaration of peace.
- 6. Peace and stability of State and the rule of law. 7. Police Force.

Above are the obvious explanation of the points that should be put on the Union legislative list of the defence and security sector.

The delegate groups - the national race delegate group, the peasant delegate group, the worker delegate group, the intellectuals and intelligentsia delegate group, State service personnel delegate group — and the delegate group of the political parties

- The National Unity Party, the Union Pa-O National Organization, the Mro (a) Khami National Solidarity Organization, the Lahu National Development Party, the Union Kayin League, the Kokang Democracy and Unity Party and the Wa National

Development Party - supported the points explained by the Work Committee Chairman to be laid down as detailed basic principles.

I will now present the separate suggestions.

The intellectuals and intelligentsia delegate group presented a suggestion to add "prevention of terrorist acts and pressures" in enacting the law regarding "The defence of the Union of Myanmar and of its every part, and to prepare a defence programme thereof'; to add "conventional arms, ammunition and explosives and non-conventional sophisticated strategic arms" in enacting the law concerning "Arms and ammunition and explosives including biological and chemical weapons"; and to enact the law concerning nuclear energy, nuclear fuel and radiation, and mineral resources that produce them, highly classified materials, objects, areas, technologies, researches and information and special security issues, accidents concerning the persons whose works involve highly classified materials, objects, areas, technologies, researches and information, and compensation and insurance cover for them in case of accidents. The suggestion will be put on record for future legislative bodies to take it into consideration in enacting laws.

The other invited persons delegate group said that the armed groups that have made peace are taking part together with the Government in ensuring regional stability and development, eliminating narcotic drugs and the national defence. Their contributions are showing signs of progress and serving the interest of the Union. Thus, the groups can be said the positive strength of the Union. They should be kept in the future also as the forces discharging duties for regional peace and stability, border security and safeguarding the lives and property of the people. In accord with the basic principle - the Defence Services Commander-in-Chief is the Supreme Commander of all armed forces laid down by the National Convention in 1993, suitable arrangements should be made to put the armed groups under the command of the Commander-in-Chief in the future.

Concerning the suggestion, I would like to explain that according to the basic principle, the Defence Services Commander-in-Chief is the Supreme Commander of all armed forces. Since ancient times, the Tatmadaw has been an institution formed with various national races. At present also,



the Tatmadaw has been providing all necessary assistance and protection for the national race groups starting from their basic needs. And in the future too, it will continue to look after the welfare of the national races.

The delegate group presented another suggestions on the nuclear energy sector. It said, the global nations at present are against the use of nuclear power for military purpose. If the basic principle - Nuclear energy, nuclear fuel and radiation, and mineral resources that produce them

- should be put in the defence and security sector. it would become an issue of international criticism. Thus, the matter should be put in the energy, electricity, mining and forestry sector instead of the defence and security sector.

Regarding the suggestion, I would like to explain that the aim of putting the point - Nuclear energy, nuclear fuel and radiation, and mineral resources that produce them - on the Union legislative list of the defence and security sector is just to enact laws when and as necessary in the future. Inclusion of the point in the defence sector cannot be assumed for military purpose only. The aim is to generate electricity and to use nuclear energy and fuel for human interest as well.

Whatever sector is the point in, the main aim is to put it on the Union legislative list. In the 1947 Constitution, the issue was included in the defence sector, and some nations too put it in the defence sector. Thus, the point should be under the defence and security sector.

Delegates of the representatives-elect delegate group of the political parties presented the same opinion as the respective parties.

Independent representatives-elect of the representatives-elect delegate group, discussed in support of the clarification made by the Work Committee Chairman.

Thus, in accord with the suggestions made by most of the delegates, the following points have been laid down as detailed basic principles to be included in the Union legislative list concerning the defence and security sector:

- 1. The defence of the Union of Myanmar and of its every part, and to prepare a defence programme thereof.
- 2. Defence and security industries.
- Arms and ammunition and explosives includ-3 ing biological and chemical weapons.
- Nuclear energy, nuclear fuel and radiation, and mineral resources that produce them.
- 5. Declaration of war and declaration of peace.
- Peace and stability of State and the rule of law. 6.
- 7. Police Force.—MNA

YANGON, 3 March — The following is the full clarification of Vice-Chairman of the National Convention Convening Work Committee Attorney-General U Ave Maung, on behalf of the Chairman of the Work Committee, regarding the foreign affairs sector for laying down of detailed basic principles for the sharing of legislative power to be included in the State Constitution, at Pyidaungsu Hall of Nyaunghnapin Camp in Hmawby Township today.

In connection with the matters related to the foreign affairs sector that should be embodied in the portion of the sharing of legislative power in the Union Legislative List, the Chairman of the National Convention Convening Work Committee said at the Plenary Meeting of the National Convention on 18 May 2004 as follows:

- "Detailed basic principles should be laid down on 1. diplomats, consular officials and trade representatives:
- 2. the United Nations;
- 3. participation in international, regional and bilateral conferences, seminars, meetings, associations and other organizations and the implementation of their resolutions;
- 4. the realization and materialization of international and regional treaties, agreements, conventions, bilateral agreements and other contracts;
- 5 passports, entry visas and certificates of identity;
- 6. the entry into the Union of Myanmar, the departure from the country, immigration control and deportation order; and
- 7. the extradition of criminals to the home country and request made therefrom."

As is known to all the delegates to the National Convention, suggestions in respect of the seven points mentioned in the foreign affairs sector that shall be embodied as detailed basic principles in the portion of the sharing of legislative power in the Union Legislative List have been made by

- the delegate group of national races,
- the delegate group of peasants,
- the delegate group of workers, and the delegate group of intellectuals and intelligentsia, all of which are the delegate groups to the National Convention, and by
- National Unity Party,
- Union PaO National Organization,
- Mro (a) Khami National Solidarity Organization,
- Lahu National Development Party,
- Union Kayin League,
- Kokang Democracy and Unity Party, and Wa National Development Party, which are mem-

bers of the delegate group of political parties. I will continue to present separate proposals by the delegate groups.

The delegate group of other invited persons said they all agreed to the seven points clarified by the Work Committee Chairman and offered their additional suggestions.

They said that in a sovereign state, there are two sectors of foreign policy: one is at central level and the other is at Region or State-level. The former takes charge of the most important issues while the latter takes charge of protocol matters concerning their areas.

The major issues of the central concerning the foreign policy are as follows:

- the adoption and implementation of the foreign policy,
- the recognition of a foreign nation or government and the withdrawal of the recognition,
- the establishment and termination of diplomatic/ consular/trade relations (The establishment of relations between two countries is conducted through trade, consular, and diplomatic channels, in which some establish direct diplomatic relations, in other words, at embassy level.)

A sovereign state joins international or regional organizations, attends meetings, signs the resolutions, approves and implements them, and withdraws from such organizations. A sovereign state enters international, regional or bilateral agreements, signs them, approves of them, and carry out them.

The central level issues a passport and an identification certificate to a citizen to identify himself to travel abroad based on specified standards.

The central level also takes charge of foreigners visiting, staying in and leaving Myanmar by scrutinizing their entry visas. The responsibility for immigration and deportation falls on the central level.

Therefore, 'the adoption and implementation of the foreign policy' and 'the recognition of a foreign nation or government and the withdrawal of the recognition' should be added to the foreign policy. and detailed basic principles for it should be laid down.

The delegate group of other invited persons also suggested that the term 'diplomats, consular affairs, and trade representatives' be replaced with the term 'the establishment and termination of diplomatic, consular and trade relations'

Furthermore, the term 'the United Nations' should be replaced with the term 'the United Nations and international organizations'; the term 'participation in international, regional and bilateral conferences, seminars, meetings, organizations and implementation of their resolutions' with the term 'participation in international, regional and bilateral conferences, seminars, meetings, organizations and implementation of their resolutions, and the withdrawal from such organizations'; the term 'the signing of international, regional and bilateral agreements and conventions, and the implementation of them' with the term the signing of international, regional and bilateral agreements and conventions and the implementation of them and the withdrawal from them'; the term 'passports, entry visas, and ID cards' with the term passports and ID cards'; and the term 'permission of



entry to and departure from Myanmar and immigration and deportation' with the term 'entry visa, stay permit, departure permit, immigration and deportation'. In connection with these changes in terminology, detailed basic principles should be laid down.

The delegate group of other invited persons also discussed that certain regions or states share borders with neighbouring countries. So, there are many forms of social relations in these areas. To ensure close supervision in these areas, the following two points should be taken into consideration when the State constitution is drawn. They are:

- 1. temporary entry/exist permit in border areas, and
- border trade with neighbouring countries bordering with Myanmar.

As regards its suggestions, I would like to explain that being executive tasks, such matters as 'the adoption and implementation of the foreign policy' and 'the recognition of the nation or government and the withdrawal of the recognition' are relevant to the sector for the sharing of executive power.

Analytical approaches to the remaining suggestions concerning the foreign affairs sector show that what has been clarified is the matters that should definitely be included in the portion of the sharing of legislative power in the Union Legislative List wherein succinct legislative terms are used.

In the term 'diplomats, consular affairs, and trade representatives' suffices to illustrate the words 'establishment, termination, and other matters. When it comes to the term 'United Nations Organization', it covers the UN itself and other relevant organizations.

Likewise, the same thing can be said of the term 'participation in international, regional and bilateral conferences, seminars, meetings, organizations and implementation of their resolutions' and the term 'the signing of international, regional and bilateral agreements and conventions, and the implementation of them. The matters - temporary entry/exist permit in

border areas, and border trade with neighbouring countries - are only concerned with the granting of adminstered areas. However, these matters should be placed on record for future legislation.

That delegate group gave the suggestions on the replacement of the term 'passports, entry visas, and ID cards' with the term 'passports and ID cards'; and that of the term 'permission of entry to and departure from Myanmar and immigration and deportation' with the term 'entry visa, stay permit, departure permit, immigration and deportation'. Reasonable and appropriate, these suggestions deserve deep consideration.

The delegate group of State service personnel, in its separate suggestion, replaced the Work Committee's words "diplomats, consular affairs, and trade representatives" with the words "diplomats, consular affairs, and representatives of other affairs". Since what it has suggested carries a deeper meaning, emphasis should be placed on it.

In connection with the adoption of detailed basic principles concerning Point One "diplomats, consular affairs, and representatives of other affairs", Point Five "passports and ID cards" and Point Six "entry visa, stay permit, departure permit, immigration and deportation", the National Convention Convening Work Committee met and coordinated with members of the panel of chairmen. The members of the panel of chairmen held groupwise discussions among their respective delegate groups and submitted their proposed papers to the Work Committee. A majority of the delegate groups agreed to the Points One, Five and Six. The representatives-elect of the political parties that constitutes the delegate group of representativeselect also mentioned the same attitude as their respective parties

The independent representatives-elect of that delegate group gave separate suggestion, expressing their agreement.

By the consent of most of the delegates to the National Convention, following points are adopted as detailed basic principles for the foreign affairs sector to be included in the Union Legislative List as regards the sharing of legislative power:

- 1. Diplomats, consular affairs, and representatives of other affairs;
- United Nations Organization;
- 3 Participation in international, regional and bilateral conferences, seminars, meetings, organizations and implementation of their resolutions;
- 4 Signing of international, regional and bilateral agreements and conventions, and the implementation of them:
- 5. Passports and ID cards
- Entry visa, entry into the Union of Myanmar stay 6. permit, departure permit, immigration and deportation: and
- 7. Extradition of criminals to the home country and request made therefrom.

Vice-Chairman of the National Convention Convening Work Committee Attorney-General U Aye Maung, on behalf of the Chairman of the Work Committee, continued to present matters on finance and planning sector.

At the plenary session of the National Convention. held on 18 May 2004, the Work Committee Chairman explained the detailed basic principles concerning the finance and planning sector that should be included in the Union legislative list and the region or state legislative list for sharing the legislative power.

The delegate groups presented discussions and suggestions on the matter. The delegate groups - the national race delegate group, the peasant delegate group, the worker delegate group, the intellectuals and intelligentsia delegate group and the State service personnel delegate group, - and the delegate group of the political parties ---the National Unity Party, the Union Pa-O National Organization, the Mro or Khami National Solidarity Organization, the Lahu National Development Party, the Union Kayin League, the Kokang Democracy and Unity Party and the Wa National Development Party - gave suggestions to put the following points on the Union legislative list as detailed basic principles for the finance and planning sector.

- The Union budget (1)
- (2) The Union Fund
- (3)Currency and coinage
- The Central Bank of Myanmar and financial (4)institutions
- Foreign Exchange control (5)
- (6) Capital and money market
- (7)Insurance
- (8) Income tax
- Commercial tax (9)
- (10)Stamp duty
- (11)Customs
- State lottery (12)
- (13)Tax appeal
- Service enterprises of the Union (14)
- (15)Disposal of Union-owned property through sale or rent or other means
- (16)Disbursement of loans from the Union funds
- (17)Investment with the Union funds
- (18)Loans borrowed from inside and outside the country
- Acquisitions of the Union (19)
- External financial assistance and aid (20)
- (21)National Plan
- Data collection (22)
- (23)National Archives
- (24)Investment, and
- (25)Inspection of statistics

The delegate groups also gave suggestions to put the following points on the region or state legislative list:

- (1) The Region or State Budget
- (2) The Regional or State Fund
- (3) Land revenue
- (4) Excise duties (excluding narcotic drugs and psychotropic substances)
- (5)Development Affairs revenues such as building and land revenue, water tax, street light tax, wheel tax
- (6) Service enterprises of the Regions or States
- (7) Disposal of the Region- or State-owned property through sale, rent or other means
- Disbursement of loans within the country from (8)the Regional or State Fund
- Investment of funds from the Regional or State (9)Fund within the country
- (10) Regional projects
- (11) Small loans enterprise

Now, I will present the separate suggestions submitted by the delegates group-wise.

The peasant delegate group said that tax appeals office should be set up at region or state level in addition to the Union level for convenience of tax payers and for work facilitation.

Regarding the suggestion, I would like to explain that inclusion of the point -tax appeal - in the Union legislative list is to enable the Union to enact laws concerning the issue, and the enacted laws will cover the right to tax appeal in the region or state. At present also, tax appeals can be submitted to the respective state or division Internal Revenue Department offices if the tax-payer finds the decisions of the township offices to be dissatisfactory. The suggestion will be put on record for consideration in enacting laws as necessary in the future.

Other invited persons delegate group discussed that the presentation to include the 25 points of the finance and planning sector clarified by the Work Committee Chairman in the Union legislative list as detailed basic principles and the 11 points explained by the Work Committee Chairman in the region or state legislative list as detailed basic principles are appropriate and correct.

But the group gave another suggestion saying that the terms "Income tax", "Commercial tax" "Stamp duty", "Customs" and "State lottery" should be substituted with the term "revenue matters."

Regarding the matter. I would like to explain that the terms "Income tax", "Commercial tax", "Stamp duty", "Customs" and "State lottery" have their specific meaning. If they are collectively termed "revenue matter", it will not cover the "state lottery". The terms are defined separately for enabling the tax payers to differentiate the meanings between the state lottery and the types of tax. In my view, the original terms are more appropriate for the matter.

The State service personnel delegate group said that the 25 points of the financial and planning sector clarified by the Work Committee Chairman should be included in the Union legislative list as detailed basic principles and the 11 points explained by the Work Committee Chairman should be included in the region or state legislative list as detailed basic principles. It also gave a separate suggestion, saying that in the basic principles and detailed basic principles already laid down by the National Convention plenary sessions, it was stated: "the State shall enact necessary laws for State service personnel to have due security in service and sufficiency of food, clothing and shelter, for married women in service to get maternity benefits, and for welfare to ease livelihood of persons who have retired from service." Hence, an additional point "26. Pension pay" should be put to the 25-item list that should be included in the Union legislative list to enact laws as necessary concerning pensions.

As the already-laid-down basic principle includes enactment of necessary laws for the matter, it may not be needed to be put as a separate item in the legislative list. Delegates of the representatives-elect delegate group of the political parties presented suggestions similar to the options of the papers presented by the delegates of the respective parties.

Independent representatives-elect of the representatives-elect delegate group, presented discussions, saying, the clarifications made by the Work Committee Chairman should be laid down as detailed basic principles.

Hence, in accord with the suggestions of the most of delegates concerning the finance and planning sector, the following points are laid down as detailed basic principles to be included in the Union legislative list:

- (1) The Union budget (2) The Union Fund
- (3) Currency and coinage
- (4) The Central Bank of Myanmar and financial institutions
- (5) Foreign Exchange control
- (6) Capital and money market
- (7) Insurance
- (8) Income tax
- (9) Commercial tax
- (10) Stamp duty
- (11) Customs
- (12) State lottery
- (13) Tax appeal
- (14) Service enterprises of the Union
- (15) Disposal of Union-owned property through sale or rent or other means
- (16) Disbursement of loans from the Union funds
- (17) Investment with the Union funds
- (18) Loans borrowed from inside and outside the country
- (19) Acquisitions of the Union
- (20) External financial assistance and aid
- (21) National Plan
- (22) Data collection
- (23) National Archives
- (24) Investment, and
- (25) Inspection of statistics.

And the following points are laid down as detailed basic principles to be included in the region or state legislative list:

- (1) The Region or State Budget
- (2) The Regional or State Fund
- (3) Land revenue
- (4) Excise duties (excluding narcotic drugs and psychotropic substances)
- (5) Development Affairs revenues such as building & land revenue, water tax, street light tax, wheel tax (See page 11)

- (6) Service enterprises of the Regions or States
- (7) Disposal of the Region- or State-owned property through sale, rent or other means
- (8) Disbursement of loans within the country from
- the Regional or State Fund
- (9) Investment of funds from the Regional or State Fund within the country
- (10) Regional projects
- (11) Small loans enterprise.

Next, Vice-Chairman of the National Convention Convening Work Committee Attorney-General U Aye Maung, on behalf of the Chairman of the Work Committee, presented matters relating to the economic sector.

At the Plenary Meeting of the National Convention held on 19 May 2004, the Chairman of the National Convention Convening Work Committee clarified detailed basic principles of the economic sector that should be included in the portion of the sharing of legislative power in Union Legislative List and the Region or State Legislative List. In connection with this clarification, the detailed basic principles of the economic sector that should be included in the Union Legislative List are as follows:

- 1. Economy;
- 2. Trade;
- 3. Cooperatives;
- 4. Corporations, boards, enterprises, companies and partnerships;
- 5. Imports and exports, and control of their quality;
- 6. Hotels and accommodation; and
- 7. Tour business.

And the detailed basic principles of the economic sector that should be included in the Region or State Legislative List are as follows:

- Economic activities carried out in a region or state in accord with the law enacted by the Pyidaungsu;
- Trade activities carried out in a region or state in accord with the law enacted by the Pyidaungsu; and
- Cooperative activities carried out in a region or state in accord with the law enacted by the Pyidaungsu.

It is found that the following delegate groups to the National Convention gave suggestions on the adoption of detailed basic principles in connection with the economic sector. The delegate groups are:

- the delegate group of national races,
- the delegate group of peasants,
- the delegate group of workers,
- the delegate group of State service personnel, and
 the delegate group of political parties, which constitutes:
- (1) National Unity Party,
- (2) Union Pa-O National Organization,
- (3) Mro (a) Khami National Solidarity Organization,
- (4) Lahu National Development Party,
- (5) Union Kayin League,
- (6) Kokang Democracy and Unity Party, and
- (7) Wa National Development Party.

I will continue to present separate proposals of the delegate groups.

The delegate group of intellectuals and intelligentsia, in its separate suggestion, said that the word 'inspection' should be added to the fifth point of the economic sector that shall be included in the Union Legislative List. It also said that some imported dairy products could not be examined or tested through conventional methods whether they were contaminated by radiation. As such, it continued, there were times when the entire shiploads of the products were dumped into the sea. Fortunately, it added, the products imported by the country were tested uncontaminated by radiation after the Chernobyl incident. However, it suggested that the fifth point of the economic sector should be replaced with the term 'import, export, inspection and control of their quality', for some dairy products might have been contaminated by radiation".

To this suggestion, I would like to reply that the quality of a particular product can be identified only after that product has been inspected. Otherwise, it will not be possible. The term 'quality control' automatically covers the meaning of 'inspection'. It is therefore not necessary to add the word 'inspection'. The term 'quality control' itself is complete and has a succinct meaning.

The delegate group of other invited persons suggested that "of the seven points, the fifth point be substituted with the term 'import and export', in lieu of the term 'import, export, and control of their quality'. As regards the three points to be included in the Region or State Legislative List, it also suggested that the term 'in accord with the law prescribed by the Union' be replaced with the term 'in accord with the economic policy of the State'.

To this suggestion, I would like to reply that the term 'import, export, and control of their quality' carries a more complete definition than the term 'imports and exports' does.

The term 'in accord with the law prescribed by the Union' used in the three detailed basic principles mentioned in the Region or State Legislative List is the common practice in drafting the constitution. Only then will the arm of law reach the entire country. Law is enacted to be in consistence with the policy of the State. The term 'in accord with the law' will agree to the policy of the State. The term 'in accord with the law prescribed by the Union' is therefore more complete and deeper in meaning and consistent with the legislation procedures.

That group also said that as regards the sixth point 'hotels and accommodation', the seventh point 'tourism' and the matter of border trade, consideration should be taken into granting the right for close supervision on these two points to the Region, or State or Self-administered Division, or Zone Leading Bodies.

This suggestion is considered to be the matter that shall generate rights when the Pyidaungsu enacts law. It is therefore necessary to place these suggestions on record for the enactment of law in future.

The representatives of political parties which are members of the delegate group of representativeselect submitted the proposals in accord with their respective parties.

U Tin Win, the independent representative-elect from the constituency-2 of Kyaiklat township, U Thein Kyi, the independent representative-elect from the constituency-1 of Taungdwingyi township, U Hla Soe, the independent representative-elect from the constituency-2 of Minbu township, U Mya Hlaing, the independent representativeelect from the constituency-2 of Twantay township, U Kyi Win, the independent representative-elect from the constituency-1 of Mingaladon township, and U Tin Tun Maung, the independent representative-elect from the constituency-2 of Mingaladon township suggested on hotels and accommodations. They said hotels and accommodations vary from one another in standard. Tourism is undertaken globally and locally. It will therefore be wise to distribute legislative power to the Region or State Hluttaw so that they can enact law relevant to the size of tourism industry as well as to the conditions of security, economy, and transport in their respective areas.

To their suggestions, I would like to reply that what has been mentioned in the legislative list is aimed mainly at the right to enact law. Implementation in accord with the enacted laws is what we call management tasks. According to a certain law enacted by the Pyidaungsu, measures are to be taken to implement management tasks on a national scale by granting the rights to local authorities. The Pyidaungsu is responsible to enact law relevant to 'tourism industry'. Accordingly, besides the region or state government, the authoritative bodies vested with the rights are to implement the tasks in accord with the enacted law.

U Tun Kyaw, the independent representative-

elect from the constituncy of Namhsan township in Shan State (North), in his separate suggestion, said that certain crops are sufficiently available in the regions or states and hence a basic principle should be included in the Region or State Legislative List so that law can be enacted as necessary in these areas to prohibit the import of such crops from neighbouring countries.

To this, I would like to reply that the matter of export and import is the thing that should be carried out uniformly on a national scale. Therefore, the legislative body at Union level should enact necessary law by taking approaches from various angles. Since the Pyidaungsu Hluttaw constitutes illuttaw representatives of the region or the state, they will have the right to submit their proposals.

The delegate group of peasants, in its separate suggestion, said that the places of tourist attraction may exist in the regions or states. Therefore, tourism industry should be undertaken on a greater scale in these areas with the help of the Ministry of Hotels and Tourism.

It also pointed out that hilly regions lagged behind in development as a result of the continued practice of the slash and bum farming method although measures are being taken to boost the national economy through agriculture.

It continued that close supervision should be made more than ever before to ensure the shift from the old method to the modem slope farming method in line with the highland farming method set by the government. It added that the right should be granted according to law as to turning the 'slash and bum' farmland into village-owned firewood plantations or into manageable-scale forest plantations.

To this, I would like to reply that nowadays tourism industry is being and will be undertaken on an extensive scale. More and more rights to do so have been granted to states and divisions.

Likewise, the State is making efforts to provide assistance for greater undertaking of the modern slope farming method and highland farming methods on a commercial scale.

These suggestions will be placed on record for the enactment of law in future.

By the consent of most of the delegates to the National Convention, following points are adopted as detailed basic principles for the economic sector to be embodied in the Union Legislative List as regards the sharing of legislative power:

- 1. Economy;
- 2. Trade;
- 3. Cooperatives;
- 4. Corporations, boards, enterprises, companies and partnerships;
- Imports and exports, and control of their quality;
 Hotels and accommodation; and
- 7. Tour business.

And the following points are laid down as detailed basic principles for the economic sector to be embodied in the Region or State Legislative List:

- Economic activities carried out in a region or state in accord with the law enacted by the Pyidaungsu;
 Trade activities carried out in a region or state in

Austrian skier banned for 18 months for doping

VIENNA, 2 March — World championships silver medalist Hans Knauss has been banned from racing for 18 months by the International Ski Federation (FIS) on Tuesday after the Austrian skier was tested positive for the banned anabolic steroid Nandrolone.

Knauss, giant slalom silver medalist at the 2003 world championships and one of Austria's most experienced and popular racers, was provisionally suspended in January after a positive B test for Nandrolone.

The 33-year-old skier's lawyer Christian Flick told Austrian news agency APA that Knauss would appeal the decision with hopes of having the ban reduced to 12 months, though he had escaped a potential two-year ban. FIS set the start of the ban from November 27, 2004, when Knauss first returned a positive A test after a race in Lake Louise, Canada, and said in a statement that they believed Knauss had not acted intentionally.

Myanmar dismisses US issue on violation of human rights

YANGON, 3 March-The Ministry of Foreign Affairs of the Union of Myanmar today issued a statement in response to the report issued on 28 February by United States Department of State, to the effect that there has been violation of human rights in Myanmar.

The full context of the statement is as follows:

The United States Department of State has once again arrogated to itself the moral authority to pass judgement on human rights practices in Myanmar. The report for 2004 issues in Washington DC on 28 February is patently false and is nothing more than a catalogue of allegations. It fails to reflect the true situation obtaining in the country. The Myanmar government has not only succeeded in meeting the challenge of re-

storing peace and stability in the country but in strengthening national unity as well. With the steady improvement of the country's infrastructure, the economy has expended and living standards of the people have improved.

Any objective observer can see the positive changes in the political, economic and social spheres in Myanmar. The very fact that the sevenstep Road Map to democratization is on the track, and that the National Convention, which resumed work on 17 February is attended by delegates coming from all parts of the country and all strata of society including representatives of national races, political parties and armed groups, speaks volumes for the systematic manner in which the aspirations of the people are being met.

With regard to the economy, the country has

registered an average growth rate of 8.5 per cent annually for the past three years, despite sanctions imposed by some countries. In the social field, notable improvements can be seen as health and education facilities have been enhanced both quantitatively and qualitatively.

No foreign power can claim to have greater interest in the well-being of citizens of Myanmar than the government and people of Myanmar. The report of the United States Department of State can only be regarded as a politically-motivated attempt to maintain pressure on Myanmar and to interfere in the domestic affairs of the country.

The Ministry of Foreign Affairs therefore categorically rejects the United States Department of State annual report on human rights in Mvanmar.-MNA
