US under pressure to explain Italian convoy shooting in Iraq

BAGHDAD, 6 March — Pressure has increased on the United States to explain its troops firing on a convoy carrying freed Italian hostage Giuliana Sgrena, that wounded her and left one of her rescuers dead.

A tempest was brewing over the tragic mishap on the road to the Baghdad airport late Friday when US soldiers opened fire on Sgrena's speeding convoy, killing an Italian service agent who shielded her from the bullets. About 100 anti-globalization protesters gathered outside the US embassy in Rome demanding the withdrawal of US troops from Iraq.

Paris-based journalist rights group Reporters Without Borders demanded an independent UN-led inquiry into the incident.

US President George W Bush, who earlier called Berlusconi to express his regrets, has pledged a full investigation into the shooting.

Differing accounts of what happened emerged, with Sgrena telling the country's ANSA news agency her convoy was fired at by a patrol and that the car was not speeding. "Our vehicle was running at normal speed which could not be misunderstood," she said, rejecting US fears of a possible suicide attack.-Internet

Peruvian police seize 500 kilos of drugs

LIMA, 5 March — Peru's National Police said Friday it had seized 500 kilos of drugs hidden in a refrigerator truck in the northwest of the country.

The driver of the vehicle and his assistant were arrested during the operation on Wednesday night.

According to the driver, the truck departed from Huanuco department in the central jungle region, where important cocaineproducing valleys are located, and was heading to the coastal city of Talara.

This has been the fifth time the police have seized a large amount of drugs in 31 days. Besides a total of 3.5 tons of drugs seized, the police have arrested a number of suspects, including 14 Colombians, nine Mexicans and 19 Peruvians during the period. - MNA/Xinhua

Canada to double aid to Africa by 2008-2009

ADDIS ABABA, 5 March — Canada has confirmed its continued commitment and concern for Africa in its new budget allocation, according to a Press release issued from the Canadian Embassy to Ethiopia on Thursday.

and other measures announced in Budget 2005 show Canada's continued leadership in helping the people of Africa overcome the overwhelming challenges of poverty and disease, the release quoted Canadian Minister of Finance Ralph Goodale as saying.

"By almost any measure Africa is a continent in crisis. More than 260,000 people die in Africa of AIDS and malaria every single month," Goodale said while announcing the budget for 2005.

Canadian budget 2005 includes a doubling of Canada's aid to Africa by 2008-2009 from its 2003-2004 level.

Accordingly, 160 million US dollars goes in funding for the global alliance for vaccines and immunization, 140 million dollars to the global fund to fight AIDS, tuberculosis and malaria, and 4 million dollars to the global polio eradication initiative.

China's economy is stepping into a sound development track and increasing steadily but gradually, an expert said quoted by China Securities Journal, Friday.

More space for economic development together with the gradual improvement of the market-oriented economy drove China's economy into a new round of increases, Zhang Liqun, researcher with China Development Research Centre of the State Council said.

Beginning in 2002, China's new round of economic growth is comparatively all-round and features the growth of manufacturing and new technologies, Zhang said. MNA/Xinhua

Tests of bird flu vaccine on monkeys in Vietnam successful

HANOI, 5 March — Initial tests of a bird flu vaccine on monkeys in Vietnam, the country hit worst by an epidemic that has killed 47 people in Asia, have been successful, a top medical official said on Friday. Vietnamese researchers injected a paper as saying.

vaccine based on weakened H5N1 bird flu virus on three monkeys early last month and three weeks later found the monkeys were healthy and had produced anti-bodies.

"Researchers have repeated the injections in the monkeys and we expect results in the next two weeks," Nguyen Tran Hien, director of the National Institute of Hygiene and Epidemiology, told Reuters. Vietnam, where 14 people have died of the bird flu virus in the latest outbreak that began in December, hopes to have a vaccine ready for testing on humans later this year.

"Hopefully, in September tests will start for the vaccine on a small group of volunteers," Hoang Thuy Nguyen, head of the vaccine research group, was quoted by the state-run Tuoi Tre news-

However, experts said last month the effectiveness of a vaccine against a versatile and resilient virus if it mutated into a form that could jump easily between humans, their main fear, would be limited. If it did mutate into that form, the experts fear it would trigger a pandemic which might kill millions of people in a world population with no immunity to it.

The poultry virus has killed one man and infected three in northern Vietnam this month, although fewer outbreaks have been detected in poultry.

Almost all the Asian victims - 34 Vietnamese, 12 Thais and a Cambodian - have caught it from infected poultry. Bird flu kills more than 70 per cent of those known to have been infected, but doctors said victims can be saved if they are diagnosed early .- MNA/Rueters

Chinese, French provinces to collaborate on tourism

GUIYANG, 5 March — Southwest China's Guizhou Province on Thursday announced to cooperate with France's Lozere Province on exploring tourism markets and training tourism professionals.

An agreement on the cooperation was signed here Thursday between a senior delegation from Lozere and the tourism authorities of Guizhou.

Jordanian FM to meet Abbas, Sharon over peace efforts

Амман, 6 March — Jordanian Foreign Minister Hani Mulqi will leave here on Saturday for the Palestinian territories and Israel in an effort to push forward the Mideast peace process, the official Petra news agency reported.

During his two-day visit, Mulqi will stress the necessity of confidence-building between Palestinians and Israelis within the frame of the roadmap peace plan, the report said.

In the Palestinian territories, Mulai will hold talks with Palestinian leader Mahmoud Abbas on a mechanism of implementing resolutions reached at a February 8 Palestinian-Israeli summit in Egypt.

Abbas and Israeli Prime Minister Ariel Sharon declared a mutual ceasefire at the Sharm el-Sheikh summit to end more than four years of bloodshed.

In Israel, Mulqi will meet Israeli Prime Minister Ariel Sharon and Foreign Minister Silvan Shalom to urge Israel to release all Jordanian prisoners in Israeli prisons, the report said.

American women, children in worrying conditions

BEIJING, 4 March — The situation of American women and children was disturbing. The rates of women and children physically or sexually victimized were high, says a report issued by the Information Office of China's State Council on Thursday.

According to FBI Crime Statistics, in 2003 the United States witnessed 93,233 cases of raping. Virtually 63.2 in every 100,000 women fell victims. The statistics also showed that every two minutes one woman was sexually assaulted and every six minutes one woman was raped, says the report, entitled the Human Rights Record of the United States in 2004. "The number of

women abused and treated at First Aid Centres exceeded one million every year," it says.

Women's labour and social rights were violated, the report says. According to The Sun newspaper (16 July, 2004), the charges handled by the Equal Employment **Opportunity Commission** on sexual discrimination against women grew 12 per cent in the past decade.

Int'l conf on disaster management held in HK

HONG KONG, 6 March — An International Conference on Issues Relating to Disaster Management and Challenges for Governance Reform in Asia was held here at the City University of Hong Kong on Friday.

United Nations Secretary-General Kofi Annan sent his personal message to the conference. In his messages, Annan said: "The tsunami of December 26. 2004, was an unprecedented, global natural disaster. We are already seeing an unprecedented, global response. But it's not enough to pick up the pieces when a tragedy like this happens. We must draw and act on every lesson we can, and prevent such tragedies from occurring in the future."

"Over the past 10 years, the number of

people killed by natural disasters has increased by almost 50 per cent from the previous decade, the loss of human life has been matched by a rise in the loss of livelihoods and huge cost to а development," he said.

"At the same time, we have learnt a great deal about what works to reduce the impacts of disaster - in terms of preparedness before it strikes, and mitigation once it does. We have learnt about the value of investing in changed behaviour." Annan added.-MNA/Xinhua

12 soldiers killed in Iraq violence

SAMARRA, 6 March - Seven Iraqi soldiers were killed in various attacks on Saturday, said security sources. A daytime curfew was also imposed in Samarra, north of Baghdad.

Five soldiers were killed when mortars hit their camp in Al Duluiyah as new army recruits got up for training around 3:00am, said Captain Assad Saddad.

Captain Ali Yussif of the Iraqi army said that a soldier was killed and another wounded when the roadside bomb they were trying to diffuse blew up near the northern oil-refining town of Baiji. He said that nine suspected guerillas were arrested in a joint overnight raid with US troops in Al Siniyah in Baiji. According to the police another roadside bomb in Tikrit killed an Iraqi soldier and wounded three other.

Gunmen also wounded three Iraqi policemen in an ambush near the village of Bir, east of Tikrit, said the local police. They added that a police officer was wounded in a similar attack in Baguba.

A Bulgarian soldier was shot and killed in central Iraq on Friday, becoming Bulgaria's eighth casualty since the start of the war, said the Defence Ministry.

Four Iraqis, including one woman, were wounded when a motorcycle rigged with explosives blew up in the Baghdad's Sunni neighbourhood of Adhamiyah. --Internet

If they happen to make a bit review of my concepts after or during their reading, I will be very satisfied with it.

In the nation there are a lot of people who think that they do not need to do further studies after their higher education. I met with one of such persons one day and he said that he had got his degree and so no longer needed to share time to study. Such a person

has not had a wide view on things, and I do not think he reads even newspaper regularly. If he does, he may realize that he badly needs to mend his views and attitudes. The technologies and knowledge the national people have currently gained will no longer be modern after a period to an extent because the world is changing very every day. If the people are not abreast of modern technologies nor latest developments, the nation will further lag behind development, when compared to other nations.

The national people are thus to thoroughly cover the knowledge, views, ideas and concepts prevailing in the world, and study latest developments and publications. In this regard, some give an excuse that fresh publications are not in their reach. Here they should grab an access to a good library.

In spite of gaining no access to a good library, one should take publications within one's reach. Then, one will be able to leap-frog over those who read nothing. However, one is to be convinced that one does not need to apply all the points from the knowledge, views and concepts that one gains through reading. And one should try to be able to distinguish good and bad points and take suitable and useful points only and upgrade them if necessary.

During the successive eras, there emerged a large number of active and dynamic youths in the nation. Sometimes they manage to do things they wish to at will, and they achieve success. However, sometimes, they fail to finish their tasks due to the fact that although brilliant enough, they fail to exert mindfulness on things they are doing.

In short, everyone should apply their energy at full capacity to meet their ultimate goals. One can achieve their aims through one's knowledge and attentiveness.

YANGON, 6 March — The following is clarification made by member of National Convention Convening Work Committee Supreme Court Judge U Tin Ave. on behalf of the Work Committee Chairman, concerning formation of Financial Commission, and Taxation and funds allotment among the Pyidaungsu and Regions or States, for laying down detailed basic principles for sharing of legislative power to be included in the State Constitution, at Pyidaungsu Hall of Nyaunghnapin Camp in Hmawby Township, on 3 March

Now, I will present the separate suggestions submitted by the delegates group-wise.

In presenting a separate suggestion, the Wa National Development Party discussed that as regards the allowances and expenditures mentioned in paragraph (h), it is stated that the Pyidaungsu Hluttaw has only the right to give counsel to the approval of the draft of the Union Budget and the draft of the additional fund allotment law, and it has no right to make rejection and deduction. It is not appropriate to use such terms for the Pyidaungsu Hluttaw, which is the highest authoritative body. The party continued that similarly, in paragraph (m), it is also stated that the Region or State Hluttaw concerned has only the right to give counsel to the approval of the Chief Minister of the Region or State concerned in connection with the allowances and expenditures, and it has no right to make rejection or deduction. It is not appropriate to use such terms for the Region or State Hluttaw.

Concerning the suggestion, I would like to explain that the expenditure stated in the point (h) and its four sub paras are actual and essential expenditures of the Union, and the expenditures have the time limit. As such expenditures should not be subject to rejection and deduction, the wording is used to define the meaning clearly.

In a separate suggestion on revenue, the national races delegate group said, education, health, economic and social infrastructures can be built for the people with the use of revenues. Steps should therefore be taken, it added, to secure an annual targeted amount of revenues.

The group continued that as far as it has observed, the income earned from revenues is still low for the country. In the time of the present government, which is working hard to develop and modernize the country in all spheres, the onus is on the people to pay their taxes fully. This is the practice common in democratic nations. Therefore, organizational campaigns should be launched on a broader scale so as to hand down this fine practice to posterity. I would like to say that the suggestion sounds positive and beneficial to the nation. Thus, it will be put on record for future use.

In a separate suggestion, the peasant delegate group said, in the collection of tax revenues, severe action should be taken against corrupt employees so that the country and the people will not suffer from it.

I found the suggestion appropriate. At present, the Government is taking measures to protect the people against facing such sufferings, and will continue to do so in the future too. Thus, it is worthy of putting on record.

In connection with the delegation of legislative powers to the Pyidaungsu Hluttaw, and the Region or State Hluttaw, the group suggested, an exact percentage of representatives of each Hluttaw be mentioned clearly. The group also suggested that consideration be taken into the number of Hluttaw representatives each of the Pyidaungsu Hluttaw, and the Region or State Hluttaw require to pass a certain law.

In my view, it is a proper suggestion. As the matter concerns only the sector of discussing the detailed basic principles regarding the task of presenting draft laws to the Hluttaws and the connections between one Hluttaw and another it can be raised when the National Convention reaches the stage of discussing the sector.

In my clarifications covering the sector of the Formation of Financial Commission, and Taxation and funds allotment among the Pyidaungsu and Regions or States, I have already explained, in sharing the financial power between the Union and the region and state. measures should be taken for sharing the power fairly

and equally for development of the entire nation. Besides, the appropriate financial power should be entrusted to the Union to collect adequate amount of tax revenues for building infrastructures, systematic progress of the entire Union, and improving the livelihood of entire Union.

Based on the above-mentioned facts, financial budget has been allotted fairly. There are regions and states rich in natural resources and the ones which have less resources. The natural resources extracted in the whole Union should be distributed to all regions and states under the management of the Union itself for equitable development of all the regions and states. Only then will the entire Union be able to develop itself well and stand perpetually. The facts contained in the financial list are not only for a single region or state, but for equitable development of the entire Union. The act of allotting, providing and lending funds collected by the Union to the regions and states is for the development of the entire Union.

The other invited persons delegate group gave suggestions on the formation of a full-time committee that will help assure the effect of the laws passed by the Hluttaws at different levels

Concerning the matter, detailed basic principles on the formation of Pyithu Hluttaw committees have already been laid down in the sector of adopting the detailed basic principles for formation of legislature. Thus, enactment of a separate law will not be necessary.

The group also said, it will be more appropriate if the chief minister of the state or the region is the person elected by the people of the region or the state concerned. The matter should be included as a principle in writing the Constitution.

In my view, the suggestion has no concern with the sector of sharing the legislative power. It only concerns the detailed basic principles for the Formation of the Executive which have already been laid down. But it will be put on record. Delegates of the representatives-elect delegate group of the political parties presented the same opinion as the respective parties.

- 1. The President
- 2. The Vice-Presidents Vice-Chairmen
- 3. The Pyidaungsu Attorney-General

- Member 5. The Chief Ministers of Regions and States Members
- 6. The Yangon City Council Chairman Member
- 7. The Pyidaungsu Minister for Finance Secretary
- (d) (1) When forming the Financial Commission, the President of the State has the right to appoint a suitable person as a member on a temporary basis, if the post of a member remains vacant for a certain reason.
 - (2) The President of the State is to announce the formation of the Financial Commission. However, orders and directives necessary for the Financial Commission can be announced by either the President of the State or the person to whom duties are assigned by the President of the State.
- (e) To submit to the Pyidaungsu Hluttaw the draft of Union budget containing the Union budget, the distribution of appropriate funds from Union Fund Account to regions or states, the provision of funds as a special case and disbursing of necessary loans, the Financial Commission is to submit them to the President of the State.
- (f) The Financial Commission, if need be, may seek advice from finance experts.
- (g) On behalf of the Union Government, the President of the State or the person to whom duties are assigned by the President of the State is to submit the draft of the Union budget to the Pvidaungsu Hluttaw.
- (h) (1) Salary and allowance of heads and mem bers of organizations set up according to the Constitution of the State and expenditures of those organizations at Union level;
 - (2) Debts the Union has to settle, expendi tures related to those debts, and other expenditures related to money borrowed by the Union; (3) Expenditures to be paid according to verdict or order or decree released by the court or a particular tribunal: and
 - (4) Other expenditures to be paid according to a particular existing law or a particular international treaty, for which discussions can be held at the Pyidaungsu Hluttaw. However, rejection and deduction are not allowed.
- (i) The Pvidaungsu Hluttaw shall exercise in accord with majority consent the right to pass approval and to make rejection and deduction for other expenditures, save the expenditures mentioned in above paragraph (h).
- (j) The Union Government is to take necessary steps according to the Union budget law enacted by the Pvidaungsu Hluttaw.
- (k) Additional funds allotment law is to be enacted in accord with the procedures mentioned above, if appropriations and permitted expenditure

The Academy established the Overseas Experts Scheme in 1998 to recruit outstanding overseas academics to help promote research collaboration, conduct evaluation, and award research projects. Of the 84 Overseas Experts elected by the CAS in this latest cohort, only four are from Hong Kong.

Computer scientist Professor Lionel Ni is also the Director of the Ministry of Education/Microsoft Research Asia (MOE/MSRA) Information Technology Key Laboratory at HKUST, the first MOE key lab in Hong Kong.

His research interests lie in developing novel computing and networking systems, such as wireless network-

The appointed researchers are Head | ing and high-performance computer architecture etc.

An expert in nanotechnology, Dr. Zikang Tang fabricated the world's smallest single-walled carbon nanotubes which have a diameter of only 0.4 nanometers, and he later discovered their superconducting properties.

He also developed the room-temperature ultraviolet-emitting laser from a thin film of nano-structured zinc oxide semiconductor. This outstanding achievement earned him the 2003 State Natural Science Award, China's most prestigious award in the field of natural sciences.

Professor Mingjie Zhang focuses his research on investigating the structure and functions of proteins in regulating neuronal signal transductions.

His laboratory has elucidated a series of the structures and the biological functions of proteins that play central roles in regulating cellular activities. MNA/Xinhua

Heavy snow hits Tokyo, surrounding areas

Токуо, 5 March — А heavy snow hitting Tokyo and the neighbouring regions since Friday morning has disrupted traffic and resulted in injures.

The snow was 2 centimetres deep in the downtown Otemachi District in Tokyo, the heaviest snowfall logged at this season in central Tokyo since 1995, according to the Japan Meteorological Agency. The snow waned and stopped in central Tokyo after noon. The snow has

affected transportation, with Tokaido Shinkansen bullet train services operating under speed restrictions in some sections, while 56 flights to and from Haneda Airport had been cancelled as of 1 pm (0400 GMT).

Ordinary train services carrying commuters were shot down temporarily in some lines at morning rush hours. MNA/Xinhua

Rains, floods kill 500 in Pakistan

ISLAMABAD, 5 March — At least 500 people have been killed and 10.000 houses demolished in Pakistan's Northwestern Frontier Province (NWFP), the World Health Organization (WHO) said on Friday.

WHO medical officer Qaid Saeed Friday was quoted by the local Geo TV as saying that a coordination committee of the UN agencies has been set up and eight districts have been declared as calamity hit areas in NWFP

Heavy rains and snowfall hit the province last month, causing roof collapse and road blockade in parts of the province.

Saeed did not give any casualty figure in southwestern Baluchistan Province where reports said that in the last four days at least 20 people have been killed and more than 25,000 displaced as torrential rains hit the province.

Floods, heavy rains and snow in Baluchistan last month left an estimated 85 people dead.

Saeed said that about 300,000 people are in need of basic necessities of life in NWFP alone.

He said the UN agencies are helping to open the roads, which have been blocked by snowfall. The other priorities are providing food, shelter, and medical facilities to the people of rain hit areas, he added.

'We are facing difficulties in providing assistance to affectees due to roads blockade," Saeed said.

He said that the government has provided two helicopters for the hilly districts but due to bad weather access to far flung areas is impossible.

Japan wants to end yen loans to China

Токуо, 5 March -Japan wants a "soft landing" in talks with China on ending yen loans to its Asian neighbour. Japanese Finance Minister Sadakazu Tanigaki said on Friday. Egypt sees full Syrian withdrawal from Lebanon possible

CAIRO, 6 March — Egyptian Foreign Minister Ahmed Abul Gheit said on Saturday that he believes Syria's announcement of redeploying its troops in Lebanon would be followed by a full pullout, Egypt's official MENA news agency reported.

Syrian President | Resolution 1559. Bashar al-Assad told the Parliament earlier Saturday that "Syrian troops will completely pull back to Bekaa Valley in eastern Lebanon and then to the Syrian-Lebanese border." Abul Gheit said he is confident that the aim of the Syrian move is the full implementation of the Taif Agreement and the


Under the 1989 Taif Agreement ending Lebanon's 1975-1990 civil war, Syria should first redeploy its forces to eastern Lebanon and coordinate a subsequent full withdrawal with Beirut.

The French-US backed UN resolution adopted last September not only urged Damascus to pull out its forces but also asked Syria, a key power broker in Lebanon, to stop meddling in its neighbour's internal affairs

Syria has been under mounting pressure to withdraw its 14,000 soldiers from Lebanon since the assassination of former Lebanese prime minister Rafik Hariri on February 14

Summary of observations recorded at 09:30 hours MST: During the past 24 hours, rain or thundershowers has been widespread in Kachin State and upper Sagaing division, scattered in Shan State, isolated in Chin and Rakhine States, lower Sagaing, Mandalay and Taninthayi Divisions and weather has been generally fair in the remaining areas. The significant day temperatures were (40°C) in Mandalay and (39°C) in Magway.

Maximum temperature on 5-3-2005 was 95°F. Minimum temperature on 6-3-2005 was 65°F. Relative humidity at 9:30 hrs MST on 6-3-2005 was 58%. Total sunshine hours on 5-3-2005 was (8.2) hours approx. Rainfalls on 6-3-2005 were nil at Yangon Airport, Kaba-Aye and central Yangon. Total rainfalls since 1-1-2005 were nil at Yangon Airport, Kaba-Aye and central Yangon. Maximum wind speed at Yangon (Kaba-Aye) was (12) mph from East at (10:10) hours MST on 5-3-2005.

Bay inference: Weather is partly cloudy in the Southwest Bay and generally fair elsewhere in the Bay of Bengal.

Forecast valid until evening of 7-3-2005: Isolated to scattered rain or thundershowers are likely in Kachin, Chin, Northern Shan States, Sagaing and Mandalay Divisions and weather will be partly cloudy in Kayin and Mon States, Yangon and Taninthayi Division and generally fair in the remaining areas. Degree of certainty is (60%).

State of the sea: Strong easterly wind with (35)mph prevailing temporarily, and moderate seas are likely Gulf of Mottama, off and along Mon-Taninthayi coasts. Seas will be slight elsewhere in Myanmar waters.


The compilations of detailed basic principles presented by Chief Justice U Aung Toe are as follows:

In line with the suggestions of most of the delegates to the National Convention, detailed basic principles have now been adopted in connection with the sharing of legislative power. For easy reference, I will conclude by sorting out the detailed basic principles relevant to the sharing of legislative power.

1. Defence and Security Sector

- The Union Legislative List constitutes: 1. The defence of the Union of Myanmar and of its every part, and to prepare a defence pro-gramme thereof.
- 2. Defence and security industries.

- 3. Arms and ammunition and explosives including biological and chemical weapons.
- 4. Nuclear energy, nuclear fuel and radiation, and mineral resources that produce them.
- 5. Declaration of war and making of peace.
- 6. Peace and stability of State and the rule of law. 7. Police Force.

2. Foreign Affairs Sector The Union Legislative List constitutes: 1. Diplomats, consular affairs, and representatives of other affairs; United Nations: (See page 8)

tion held on 21 May 2004, the Chairman of the National Convention Convening Work Committee explained matters in connection with the basic principles to be laid down for the legislative powers to Union territories on grounds of the matters relevant to the sharing of legislative power that shall be included in writing the State constitution.
