Cambodian Prime Minister Mr Samdech Hun Sen, Indonesian President Dr Susilo Bambang Yudhoyono, Laotian Prime Minister Mr Bouasone Bouphavahn, Malaysian Prime Minister Dato' Seri Abdullah Bin Haji Ahmad Badawi, Philippine President Madame Gloria Macapagal Arroyo, Prime Minister of Singapore Mr Lee Hsien Loong, Thai Prime Minister General Surayud Chulanont (Retd), Vietnamese Prime Minister Mr Nguyen Tan Dung, Australian Prime Minister Mr John Howard, Premier Mr Wen Jiabao of the People's Republic of China, Indian Prime Minister Dr Manmohan Singh, Japanese Prime Minister Mr Shinzo Abe, President of the Republic of Korea Mr Roh Moo Hyun, Prime Minister of New Zealand Mrs Helen Clark and ASEAN Secretary-General Mr Ong Keng Yong.

Establish caring and sharing community among ASEAN countries

Prime Minister of the Union of Myanmar General Soe Win attended the 12th ASEAN Summit and the mid-term summit of the Ayeyawady-Chao Phraya-Mekong Economic Cooperation Strategy held in Cebu, the Republic of the Philippines, on 13 January and signed five Cebu Declarations.

The 12th ASEAN Summit focused on consideration for suggestions of the eminent persons group to draft the ASEAN Charter, which is important for the ASEAN, measures to implement 2020 ASEAN Vision, combating international terrorism, environmental conservation. efficient use of energy and utilization of fuel substitute oils.

The discussion also covered the programmes prevailing among the member countries such as nurturing of educated youth who are adorable to ASEAN, addressing the issue of migrant workers, and prevention against HIV/AIDS.

At the ceremony to sign the Cebu Declarations of the ASEAN Summit of Heads of State/ Government of ASEAN countries, the Cebu Declaration Towards a Caring and Sharing Community, the Cebu Declaration on the Blueprint for the ASEAN Charter, the Cebu Declaration on the Protection and Promotion of the Rights of Migrant Workers, the ASEAN Convention on Counter Terrorism, and the ASEAN Convention on the Acceleration of the Establishment of an ASEAN Community by 2015 were issued.

The points discussed and the Cebu Declarations issued at the 12th ASEAN Summit will enhance cooperation and unity of the ASEAN countries. So, it is believed that a caring and sharing community will be established among the members soon.

Insurgent-planted mine kills innocent civilian

YANGON, 18 Jan — A 30-year-old man was killed by an insurgent-planted mine when he stepped it in Kyaukkyi Township, Toungoo District, Bago Division, on 12 January.

The victim, Saw Htay Hlaing Win, hit the mine while on his way to pick betel leaves at his farm located 17 miles east of Kyaukkyi at 4.30 pm. The explosion seriously wounded his left leg, and he was rushed to the hospital in Kyaukkyi. However, he died at 5.30 pm the following day.

Saw Htay Hlaing Win, son of U Kyi Shwe, lived in Metta Ward, Kyaukkyi.

Poll shows Bush's new Iraq plan fails to rally public support

Washington, 17 Jan— US President George W Bush's new Iraq plan failed to rally public support, according a latest survey released here Tuesday.

In the USA TODAY/ Gallup Poll, more than 60 per cent of the respondents back the idea of a nonbinding congressional resolution expressing opposition to Bush's plan to commit an additional 21,500 US troops to Iraq.

Sixty per cent have little or no confidence that the Iraqi government will be able to take responsibility for handling security there by November as Bush suggested.

By more than 2-1, those surveyed oppose the president's plan to send an additional one billion US dollars in economic aid for Iraq.

By 51 per cent to 36 per cent, the respondents have more confidence in congressional Democrats to handle Iraq than in the president.

The survey also shows that Americans feel more pessimistic about the war in the wake of Bush's speech on his new plan last week. For the first time, a narrow plurality —49 per cent to 47 per cent — say the United States is likely to lose the war.

Before the speech, they said by 50 per cent to 46 per cent that the United States was likely to win. Compared with that of the previous poll, Bush's


overall job-approval rating dipped 3 points, to 34 per cent.

The telephone poll of 1,003 adults nationwide was taken between last Friday and last Sunday, after Bush announced his new plan for Iraq on last Wednesday.

Charles Franklin, a political scientist at the University of Wisconsin, said the results are not surprising.

"We've had four years to think about the war," Franklin said. "This is not him (Bush) making a speech about a policy that the public hasn't been debating for a long time... At this point, it's very hard for a speech to make much difference."

BAGHDAD, 17 Jan—Four US soldiers have been killed in northern Iraq, the US military said in a statement on Tuesday.

The four assigned to the 4th Brigade, 1st Cavalry Division were killed Monday by a roadside bomb while conducting operations in Ninawa Province, the statement said. The latest deaths brought to 3,024 the number of US soldiers killed in Iraq since the US-led invasion in March 2003, according to media count. — MNA/Xinhua

Iraq troop build-up 'not in US national interest'

BAGHDAD, 17 Jan— Senate Democrats working with a well-known Republican war critic are developing a resolution declaring that US President George Bush's troop buildup in Iraq "is not in the national interest", says a person familiar with the document.

The resolution also would put the Senate on record as saying the US commitment in Iraq "can only be sustained" with popular support among the American public and in Congress, according to an yesterday that keeping his

official familiar with the draft.

The official would speak only on grounds of anonymity because the drafting is still under way.

Senator Chuck Hagel, a Republican and potential 2008 presidential candidate, is helping Democrats with the wording of the anti-war resolution.

Bush has been trying to sell his revised war plan to the public in a series of television interviews.

He told PBS' Jim Lehrer in an interview broadcast old policies in place would lead to "a slow failure", but withdrawing from Iraq, as some Democrats and other critics suggest, would result in an "expedited failure".

"I am frustrated with the progress," Bush said.

"A year ago, I felt pretty good about the situation.

I felt like we were achieving our objective, which is a country that can govern, sustain and defend itself.

No question, 2006 was a lousy year for Iraq."

Iranian troops shoot down US spy drone

Teheran, 17 Jan—Iranian troops have shot down a US pilotless spy plane, local Fars news agency reported on Tuesday.

The aircraft was brought down when it was trying to cross the borders "during the last few days", Seyed Nezam Mola Hoveizeh, a member of the Iranian Parliament, was quoted as saying. The lawmaker gave no exact date of the shotdown or any other details about the incident, but said that "the United States sent such spy drones to the region every now and then".

The announcement


came amid reports that the United States is increasingly flexing its muscles to counter Iran's growing regional assertiveness and put more pressure on Teheran over its controversial nuclear programmes.

It is reported Tuesday

that a second US aircraft carrier, the USS John C Stennis, will arrive in the Middle East in about a month, the first time since the US-led Iraq war in 2003 that the United States will have two carrier battle groups in the region.

Chinese scientists conduct more tests on "EAST' reactor

Hefei, 16 Jan—Chinese scientists began a new round of tests on the reliability of the experimental thermonuclear fusion reactor, nicknamed "the artificial sun".

The Experimental Advanced Super-conducting Tokamak (EAST)

fusion reactor, which replicates the energy generating process of the sun, was tested at the Institute of Plasma Physics under the Chinese Academy of Sciences (CAS) in Hefei, capital of east China's Anhui Province. The reactor was first

tested in September 2006. Since then scientists have made adjustments to improve results.

"The new tests show the reactor is very reliable, and we can repeat the experiments," said Wu Songtao, deputy director of the institute.

This new round of tests will continue till 10 February.

During the experiment, deuterium and tritium atoms were forced together at a temperature of 100 million degrees Celsius.

Gates to consider more troops for Afghanistan

New York, 17 Jan— US Defence Secretary Robert Gates has wrapped up a visit to Afghanistan, saying he is sympathetic to a request for more troops to battle an expected upsurge in the

Taliban-led insurgency this year.

Mr Gates said commanders had told him during his two-day visit that they needed more troops but he would not be drawn on how many.

"It depends on different scenarios and those are the kinds of decisions we are going to have to look at," he said.

"If the people leading the struggle out here feel they need additional help, I'm going to be very sympathetic to that kind of a request."

The NATO-led International Security Assistance Force (ISAF) includes about 33,000 soldiers from 37 nations but is still short of the manpower it has been promised, despite pleas for more support after a year of intense fighting. —Internet

Three US soldiers killed in Iraq

BAGHDAD, 16 Jan—Three American soldiers were killed and five others were wounded in Iraq in separate incidents, the US military said in a statement on Monday.

A soldier assigned to the 89th Military Police Brigade died Sunday of wounds sustained in a roadside bomb blast near his vehicle in north of Baghdad, the statement said.

Another soldier was killed and four others were wounded when a roadside bomb went off near their patrol in Baghdad on Sunday, the military said in a separate statement.

A third soldier, assigned to the 105th Engineer Group, died of wounds sustained in an explosion while he was conducting operations in northern Iraq on Saturday, a statement said. Another soldier was wounded in the explosion.— MNA/Xinhua



Myanmars to build a golden nation on own strength, labour despite negative view of ILO with whom the country is cooperating

The joint US-Britain draft resolution submitted to the UNSC on 11 January this year for putting pressure on Myanmar was objected by the People's Republic of China and the Russian Federation with a double veto the following day.

Myanmar is an independent and sovereign nation, and one of the demands of the US in connection with its false accusations against the country to interfere in her affairs is the Myanmar government to fully cooperate with the International Labour Organization (ILO) and its representatives in combating forced labour.

The original aim of the ILO is to promote employment and to improve labour conditions and living standards.

Throughout history, workers of the world launched struggles to demand their rights, leaves, holidays, medical treatment, education opportunities, appropriate pays and salaries at the risk of facing death, torture, anguish and dismissal. The struggles are the milestones of their history. Till now, world nations observe Workers Day on 1 May. As the Workers Day falls on 1st May, it is also known as May Day, which is observed in honour of the struggle launched by the workers of Chicago, the US.

The oppressions on workers in the US, Britain and European colonies left as black marks in history. Seventy-seven per cent of Earth's land area were occupied by the European colonialists, and the peoples of the colonies were subject to exploitation, while workers faced extra torments. There were no workers rights. The workers had to work more than 14 hours a day. Their pays were so low that they were living in a state of poverty and hunger. Hence, struggles between employees and employers were common in almost all the nations. We have read in many books that workers' strikes in the US were crushed with guns and killings.

During over 100 years of colonialist enslavement, Myanmar had continuously witnessed workers struggles. A study of oil field workers' uprising shows how cruel and oppressive the colonialists were towards Myanmar workers. Myanmar workers who demanded their own rights were hit with sticks or galloping horses, or thrown into jails. Those are the unforgettable memories for Myanmars.

We have already recorded the history of the colonialists applying forced labour in Myanmar in accord with the Town Act and the Village Act enacted in 1906. Thanks to the law proclaimed in 1964 to protect workers rights, today's Myanmar workers can enjoy their rights fully.

The suffering of present-day Myanmar workers is the consequence of economic sanctions imposed on Myanmar by the US, Britain and European colonialists (all are veteran colonialists). Because of the pressures and coercion made by Myanmar expatriates and the CIA in cooperation, regular customers in America and Europe dare not buy the garments manufactured in Myanmar. The outcome is that many garment factories in Myanmar had to be

closed down, and a large number of women became jobless.

Actually, the ILO, should stop the evil acts of the US, Britain and expatriates to impose unjust sanctions on Myanmar to cause mass lay-offs in the country. Instead, the global body is trying to find fault with Myanmar, with the accusation that forced labour does exist in the country. The expression "forced labour" was coined as a new usage by the US and neocolonialists.

Colonialists invaded and occupied over a hundred nations of the world, and violated democracy and human rights covering public freedom and the freedom of serving national interest. Now, they are trying to hamper the progress of developing nations with the words such as "human rights", "democracy" and "freedom of worship". They are like thief shouting "thief"!

The US and allies are gradually dominating and manipulating the UN and its subordinate organizations and other international organizations by filling the posts of those bodies with their citizens and expatriates and persons who betray their own nations, but are useful to them. In addition, they make their voices the bodies' through orchestration to substitute the legitimate governments with the ones they like. They are controlling the ILO for those purposes.

The ILO was established in 1929. It has connections with the UN since the global peace body's emergence on 24 October 1945. The aged ILO has witnessed the death and sufferings of workers of the world nations under the suppression of colonialists. The ILO should be aware of the fact that the big colonialists of that time were tormenting and exploiting workers, while ignoring the body are now using it as a tool.

Myanmar joined the ILO on 18 May 1948. It has accepted and is exercising the 19 principles out of the principles of the body. The nation always submits her annual reports to the ILO in time, and has comprehensively answered all the questions raised by the experts of the ILO and provided all the facts and data they want. The country always sends delegates to the annual ILO conferences.

The ILO enacted provision 29 concerning forced labour in 1930. Myanmar began to accept and follow the provision in March 1955. The provision officially defines the kinds of jobs that do not mean

forced labour. Myanmar has been observing all the provisions, and in addition, the Ministry of Home Affairs issued the Order No 1/99 and additions, that prohibit forced labour, for the public.

The Tatmadaw during its 35-year offensives against the internal insurgents from 1955 to 1990 had used the public strength to a certain degree. Seventeen major national race armed groups and many other minor groups returned to the legal fold during the years after 1990 and restored peace. From that time on, there have been no major offensives, and the public strength has never been used again.

The ILO had never made objections against Myanmar till the period up to 1990. However, it is now finding fault with Myanmar with accusations. So, we need to analyze the fundamental facts concerning the ILO's attitude and acts towards Myanmar.

In many nations including Myanmar, people make donations out of their beliefs, traditions and culture, wishes and religious teachings. Myanmars voluntarily contribute labour to serve the interest of the people of their own land, village or ward. In other words, they donate their own labour out of goodwill. Generally, at least one person from every family always comes out to help a person who is repairing or roofing his house. Some even provide the person with materials required in repairing or roofing the house.

Traditionally, Myanmars collectively build or repair ward, village or town roads, and contribute voluntary labour in building a pagoda, a monastery or a lake. People take necessary tools and come to render assistance happily in digging wells or lakes to supply water to their village. They collectively fill pot holes and build bamboo or wooden bridges.

The US and cohorts are accusing that Myanmar is practising forced labour, while ignoring the lovely tradition of contributing voluntary labour. They have no such lovely tradition of helping each other. Actually, not only Myanmar but also all the Asians have the willingness to help one another and provide social services. It is the Asian value.

Today, Myanmar has been gaining momentum in her development drive. It has built many miles of new roads and repaired the existing ones. It has also built numerous bridges and dams.

The entire Union has seen a large number of educational institutions, hospitals and health care centres along with dams and hydel power stations. In fact, the West colonialist bloc and internal and external saboteurs begrudging such remarkable progress are making an accusation of forced labour so that the development momentum slows down to a halt and the strength of the workers will not be mobilized in the national development undertakings.

Needless to say, no worker will work in a factory, office, company or joint-venture construction project without being paid. Inspired by satisfactory salaries along with aspiration for national development, they are engaged in these projects.

The US does not want to see Myanmar enjoy any progress, but to make the people live below poverty line in the time of the Tatmadaw government. Only then will the ruling government be replaced with the puppet government, and Myanmar be in their hands. These facts testify to why the US and its associates are making groundless accusations.

Now, the nation has restored peace and stability and enjoyed unprecedented development in various sectors due to the desire for progress of the entire Union. Myanmar is rich in various kinds of precious stones, and natural gas is harnessed offshore on a commercial scale. The oil wells off Mottama coast are producing a great deal of natural gas. Thailand purchased the gas. So, gas pipelines were laid through Taninthayi region.

No sooner did they get the information that the pipelines for piping the natural gas would be laid from east to west, not far from Dawei in Taninthayi Division, than renegades, the NLD and the US made accusations that the project was causing pollution of the environment and deforestation and would have effects on the regional climate, the government was using forced labour and forcibly dislocating nearby villages. In fact, there was not a grain of truth in their accusations. The trees along the route of the pipelines were cut down, but the trees planted then in compensation were several times more than the trees that had been cut down. And for the huts in the villages demolished along the pipelines, the government built better houses in compensation along with schools and health care centres. The workers were better-paid as they had to work in the jungles.

Then, the expatriates and CIA put the oil companies on trial in the court in the US. The companies refuted the accusations by presenting sound evidences, and so the cases were settled. Then, terrorists blasted the pipelines near the border areas. So, the pipelines were repaired repeatedly. Expatriates and CIA members dissuaded Thailand from purchasing gas from Myanmar, but it did not accept their demand. The accusations of the US and its lackey axe-handles were absolutely baseless, designed to prevent the nation from making economic development through the earning from the export of gas.

The US wielded its power to make expatriates entitled to attend the UN General Assembly and UN human rights conferences. It provided funds for Pyithit Nyunt Wai, who had absconded with the money of the government department, under the name of the Free Trade Union of Burma (FTUB) and asked him to complain to the ILO about forced labour in Myanmar that he had made up. It helped him meddle in the affairs of the ILO. Actually, the ILO is an international organization that has to try to reach an agreement among the representative of the government, the representative of the company that is engaged in a nation in line with Law and the representative of the workers. Pyithit Nyunt Wai's FTUB consists of a

handful of outlawed expatriates and it does not represent any Myanmar workers.

Therefore, it can be deduced from above-mentioned facts that the ILO is accepting and approving the subjective accusations of the US and renegades against Myanmar, failing to find out Myanmar's objective situations and lopsidedly finding fault with the nation.

Myanmar is constantly cooperating with the ILO in the labour affairs. The ILO once stated the source, from which it got the accusations against the nation. The accusations against Myanmar surfaced along the border, especially from the absconders whose camps are based in the neighbouring country and from Pyithit Nyunt Wai's FTUB.

Therefore, the renegades, in return for the assistance, have to do whatever the US asks them. To the liking of the US and its associates, the expatriates will continue to send slanderous, exaggerated and invented stories intended to make baseless accusations against Myanmar. So, it is not strange why the USled colonialist bloc, renegades and internal axehandles are shouting the same voice in making accusations against Myanmar.

It is visible the US and Britain are aggravating and then pacifying the situation, while demanding Myanmar for full cooperation with the ILO in a fight against forced labour. However much Myanmar cooperates with the ILO in this regard, the US and its associates will never be satisfied with the outcomes and will continue to find fault with Myanmar one way or another.

Whatever it may be, the people will continue to make self-reliant efforts so as to transform Myanmar into a golden land.

"The parents of those


soldiers are still asking us about their sons and if they died. Their parents need the evidence," Charles told some 100 media management students at the Royal University of Phnom Penh.

Federer is chasing a third Australian Open crown following triumphs in 2004 as well as last year.





Everyone of the importance of an "active and constructive" relationship between the United States and United Nations.

Stating that partnership cannot flourish in a climate of fear and mistrust, Ban said with US actively and also emphazised the constructively engaged,

the potential of the UN is | Ban said the member unlimited.

"And with UN's potential fulfilled, the US can better advance the aspirations for a peaceful, healthy and prosperous world."

Addressing the Centre after his first meeting as Secretary-General with American President George W Bush, Ban said complex global challenges is exactly the environment in which the UN should thrive because these are challenges that no country can resolve on its own.

But several developing countries would not like his comments on what is called "Responsibility to Protect" which means humanitarian interventions in situations of genocide or ethnic cleansing where a country is unable or unwilling to protect its own citizens.

Hailing the concept,

states had expressed their will to act collectively, through the Security Council, in cases where population is threatened with genocide, ethnic cleansing, or crime against humanity and national authorities fail to take appropriate action.

"The time has come to build consensus among Member States about how to opertaionalize that will," he added.

But several developing nations feel that the principle could be used by the major powers, who dominate the Security Council, to undermine their sovereignty.



Summary of observations recorded at 09:30 **hours MST:** During the past 24 hours, light rain have been isolated in Chin State and upper Sagaing Division and weather has been generally fair in the remaining areas. Night temperatures were (3°C) to (4°C) below normal in Kachin, Shan and Chin States, (5°C) below normal in upper Sagaing Division and (3°C) to (4°C) above normal in Mon State and Taninthayi Division and about normal in the remaining areas. The significant night temperatures were Haka (0°C), Putao and Namhsan (3°C) each, Mogok (4°C).

Maximum temperature on 17-1-2007 was 97°F. Minimum temperature on 18-1-2007 was 63°F. Relative humidity at 09:30 hours MST on 18-1-2007 was 70%. Total sunshine hours on 17-1-2007 was (8.5) hours approx.

Rainfalls on 18-1-2007 were (nil) at Mingaladon, Kaba-Aye and Central Yangon. Total rainfalls since 1-1-2007 were (nil) at Mingaladon, Kaba-Aye and Central Yangon. Maximum wind speed at Yangon (Kaba-Aye) was (4) mph from North at (08:30) hours MST on 18-1-2007.

Bay inference: Weather is partly cloudy in the Southwest and West Central Bay and generally fair in the Andaman Sea and elsewhere in the Bay of Bengal.

Forecast valid until evening of 19-1-2007: Weather will be partly cloudy in Rakhine State and Taninthayi Division and generally fair in the remainstates and divisions.

State of the sea: Seas will be slight to moderate in Myanmar waters.

Outlook for subsequent two days: Likelihood of slight increase of night temperatures in the Southern Myanmar areas.

MMCWA strongly condemns attempts of US and Britain to interfere in Myanmar's internal affairs

Kachin State Special Region 1 denounces draft resolution

Yangon, 18 Jan — Kachin State Special Region 1 New Democratic (Kachin) (NDAK) on 15 January proclaimed its stance concerning the submission of a draft resolution to the UNSC by the US and Britain to interfere in and manipulate Myanmar's internal affairs. NDAK also denounced the draft resolution.

- 1. We have already protested against the proposal to put Myanmar issue on the UNSC agenda with the aims of interfering in her internal affairs. Like us, the People's Republic of China and the Russian Federation and the entire Myanmar have already objected it.
- 2. Despite the objections, the US and Britain submitted the draft resolution to the UNSC, with groundless reasons, to interfere in Myanmar's internal affairs. Their groundless reasons were the continued detention of political prisoners, suppression of minorities in eastern Myanmar, human rights violations, uncontrollable spread of HIV, TB and malaria, and failure to wipe out drugs production.
- 3. As the People's Republic of China, the Russian Federation and South Africa did not accept the reason which said that Myanmar's internal affairs had posed a threat to regional and international peace, they objected the draft resolution. Another three nations also abstained. It is the first double veto since (See page 11)

Karenni Nationalities People's Liberation Front protests at US-Britain resolution

Yangon, 18 Jan—The Karenni Nationalities People's Liberation Front (KNPLF) on 15 January issued a declaration in protest against the draft resolution co-sponsored by the US and Britain and decided at the United Nations Security Council.

- 1. US, Britain want Myanmar to become neo-colony, to install a puppet governmet in Myanmar

Yangon, 15 Jan — The US and Britain submitted a draft resolution to put Myanmar issue on the UN Security Council in order to interfere in Myanmar. The Myanmar Motion Picture Asiayon issued on 15 January a declaration oppoing, objecting and condemining the resolution.
