Build small hydropower generators for rural areas

The government is making efforts for generation of more power in the whole nation and it has been implementing hydropower projects in order to fulfil the power need of the people.

Among the hydropower projects, Ma Mya Dam in Myanaung Township, Ayeyawady Division, is one of them.

The Construction-9 of the Irrigation Department has built small generators to be used in irrigation. Arrangements are being made for supply of power to Hmyinwataung Village near Ma Mya Dam with the use of the two five-kilowatt generators.

One five-kilowatt generator is capable of lighting 200 two-foot fluorescent lamps. Socio-economic life of the people in the regions will improve as Ma Mya Dam can supply water and power to Hmyinwataung Village and its environs.

It is believed that construction of small hydropower generators at other dams will contribute towards supply of power in the rural areas.

Tornado destroys some wards and villages in Labutta Township

Toxic cloud to hit 2bn people

NEW DELHI, 5 Aug — They call it the Asian Brown Cloud. Anyone who has flown over South Asia has seen it — a vast blanket of smog that covers much of the region. It is also what colours those sunsets at the Taj Mahal. Now a group of scientists has carried out the first detailed study of the phenomenon and arrived at a troubling conclusion.

They say that it is causing Himalayan glaciers to melt, with potentially devastating consequences for more than two billion people in India, China, Bangladesh and other downstream countries. In a study published by Nature, the British journal, they say

that black soot particles in the cloud are absorbing the Sun's heat and pushing up temperatures at the same altitude as most Himalayan glaciers.

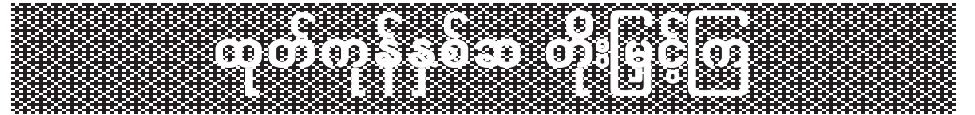
Scientists have already observed that two thirds of the 46,000 glaciers in the Himalayas are shrinking, leading to increasingly severe floods downstream and, eventually, to widespread drought. Greenhouse gases were previously thought to be the main cause of the problem, which threatens the sources of Asia's nine main rivers — including the Indus, the Ganges and the Yangtze.

But the research team from the Scripps Institution of Oceanography

in California says that the Asian Brown Cloud—made up of gases and suspended particles known as aerosols — is just as much to blame. "My one hope is that this finding will intensify the focus of Asian scientists and policy makers on the glacier issue," Veerabhadran Ramanathan, who led the research, told The Times.

"These glaciers are the source for major river systems, so at least two billion people are directly involved in this."

The cloud is an enormous plume of smoke from factories, power plants and wood or dung fires that stretches across the India into SouthEast Asia.—*Internet*

US soldier sentenced to 110 years

BAGHDAD, 5 Aug—A US soldier has been sentenced to 110 years in prison for his role in the rape and murder of a 14-year-old Iraqi girl and the killing of her family. Private Jesse Spielman was convicted of conspiracy to rape and murder. He said he acted as a lookout for four other soldiers who carried out the attack in Mahmudiya in March 2006. Pfc Spielman was given the longest sentence of the group. Three other soldiers pleaded guilty and received sentences between five and 100 years. The fifth man faces trial in a civil court having been discharged from the army. —*Internet*

Iranian commander says enemy not able to launch attack

TEHERAN, 4 Aug — A senior Iranian military commander said on Thursday that the country's enemy is by no means able to launch military attack against the Islamic Republic, the official IRNA news agency reported.

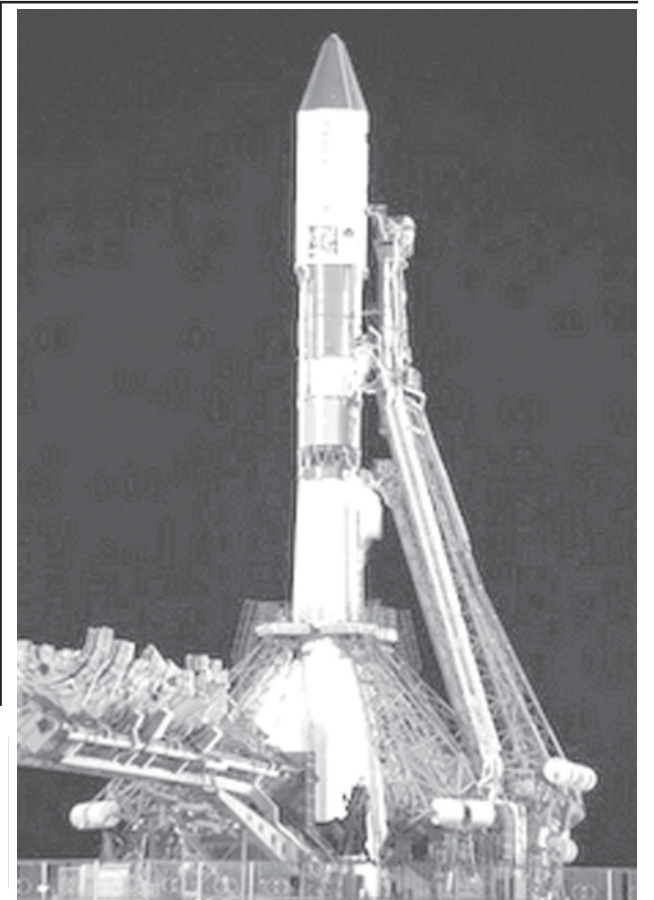
Air Force Commander Brigadier-General Ahmad Miqani made the remarks in his speech at a ceremony to celebrate the graduation of a number of officers in an unidentified air base, said IRNA.

Miqani was quoted as saying that threats by certain countries "have been always made against the country, but the question is why they have never been carried out?"

He said his Army has made remarkable achievements in various fields relying on efforts made by its young experts, adding

"this has resulted in promoting Iran's authority inside and outside the region".

Four US soldiers killed in Baghdad

BAGHDAD, 4 Aug— Four US soldiers were killed in Baghdad on Thursday, three of them when their patrol was struck by a roadside bomb, the US military said on Friday.

The roadside bomb attack took place as US troops were conducting operations to disrupt insurgent and militia activities in eastern Baghdad, the military said.

A fourth soldier was killed in combat in western Baghdad. The deaths took

the US death toll in Iraq since the US-led invasion in 2003 to at least 3,665.

Thousands of US troops have been deployed in Baghdad to quell sectarian violence between majority Shiite and Sunni Arabs. US commanders have said they expect troop casualties to rise as the troops increase their visibility.

The website icasualties.org, which tracks the number of coalition deaths in Iraq, also said the July

death toll for US soldiers had risen to 81, tying with February and March. US troops began the crack-down in Baghdad in February.

May was the deadliest month in two-and-a-half years with 126 killed, and more than 100 died in both April and June.

Helicopters drop food to two million

LUCKNOW, (India) 5 Aug — Helicopters dropped food to almost 2 million marooned Indian villagers on Saturday as the death toll from unusually heavy monsoon rains and floods in South Asia rose to more than 225.

The food drops to 2,200 villages cut off by flooding aimed to help desperate residents in the worst-hit eastern parts of India's Uttar Pradesh state. Umesh Sinha, the state relief commissioner, also said nearly 280,000 acres of rice paddy crops had been destroyed.

In India's northeastern Assam state, flooding forced rhinos from their habitat at the Kaziranga National Park and their panicked charges killed one person and injured two others, wildlife officials said.

At least 229 people have been killed in India and neighbouring Bangladesh, and 19

million driven from their homes in recent days. The South Asian monsoon season runs from June to September as the rains work their way across the subcontinent, a deluge that scatters floods and landslides across the region and kills hundreds of people every year.

The number of dead in Bangladesh rose to 81 Saturday, up from 65 a day earlier, the country's information ministry said. Raging floodwaters have battered 38 out of 64 districts in the delta nation of 145 million people.

Fakhrudin Ahmed, head of Bangladesh's military-backed interim government, visited the

northwestern district of Sirajganj on Saturday. Despite the devastation, he said the government had enough food and medicine to distribute and foreign assistance wasn't yet needed.

Low-lying areas around Dhaka were under neck-deep water, and many residents were using boats to travel around. Government meteorologists said water levels in Dhaka continued to rise.

US spy satellite declared loss, to drop from orbit

WASHINGTON, 4 Aug — The National Reconnaissance Office has deemed an experimental US spy satellite a total loss and will allow it to slowly drop from orbit and burn up in the atmosphere, two defence officials told Reuters this week.

The classified L-21, built by Lockheed Martin Corp at a cost of hundreds of millions of dollars, was

launched on December 14 but has been out of touch since reaching its low-earth orbit, put by satellite watchers at about 220 miles (350 kilometres) above the earth.

It will now gradually fall out of orbit over the coming decades, said the officials, who asked not to be named. At some later date, it will burn up as it enters the earth's

atmosphere, posing no danger to people below, they said.

Meanwhile, the Pentagon will likely now have to test aspects of new technologies that were on the L-21 by piggybacking them onto other satellites over the next four to five years, the officials said.

For instance, the military could put the new sensors aboard TacSat 3, the latest in a series of smaller satellites, when it launches later this year.

The NRO could still try to build a new

spacecraft to test the technology, but it would take several years to get the funding for such a satellite and build it, one official said.

The two officials declined to identify what exactly the experimental Lockheed satellite was meant to test, but said its failure was troubling, given that other countries were rapidly plowing ahead with development and launch of new capabilities, especially in the area of synthetic aperture radars. — MNA/Reuters

US soldier killed in Baghdad combat

BAGHDAD, 4 Aug — A US soldier was killed and three others were wounded during combat operations in Baghdad, the US military said on Friday.

The incident took place on Thursday in western part of the Iraqi capital, the military said in a statement. The latest death brings the number of US soldiers that have been

killed in Iraq to more than 3,660 since the Iraq war broke out in 2003, according to media count based on Pentagon figures.

Afghans check reports of civilian deaths from bombings

KANADHAR, (Afghanistan), 4 Aug — Afghan

authorities were checking on Friday reported heavy civilian casualties after air strikes by Western forces in the southern province of Helmand.

At least 20 wounded civilians were brought to a main hospital in Lashkar Gah, the pro-

vincial capital, Helmand's police chief Mohammad Hussein Andiwal said.

Residents have told journalists and provincial officials that between 200 to 300 civilians were killed or wounded in the raids on Thursday in the remote district of Baghran, which lies to the north of Lashkar Gah.

"I can confirm there were heavy bombardments," Andiwal told Reuters by phone from Helmand.

"We have heard of heavy casualties too and have sent a team to investigate this."

A provincial lawmaker in Kabul, Mohammad Anwar, also received reports of high civilian casualties.

- the Lahu National Development Party;
 - the Union Kayin League;
 - the Kokang Democracy and Unity Party;
 - the Wa National Development Party; and
 - representatives of political parties from the Delegate Group of Representatives-Elect, and three Independent Representatives-Elect including Dr Hmu Htan, and six Independent Representatives-Elect including U Tin Win held group-wise discussions, and suggested that the detailed basic principles for the Chapter "General Provisions" should be adopted. The are:
1. **This Constitution is the Basic Law of laws of the State.**
 2. **Myanmar language is the official language.**
 3. **The State fundamental principles are the guidelines to be followed by the legislative Hluttaws in enacting laws and interpreting provisions of the State Constitution and of other laws.**
 4. **Interpretation of the preamble, articles, clauses, words and expressions contained in this Constitution shall be based only on Myanmar text.**
 5. **Interpretation of the expressions of this Constitution should be referred to the existing Interpretation of Expressions Law.**
 6. **A Myanmar manuscript of this Constitution shall be kept at the National Archives. The manuscript shall be conclusive evidence of the provisions of this Constitution.**
 7. **In the interest of the State, the Union Government may permit—**
 - (a) **Region or State government,**
 - (b) **a cooperative society, an organization or a person to run any of economic enterprises, which are prescribed to be operated solely by the Union Government, through a joint-venture system with the Union Government or under agreements.**
 8. **The Union of Myanmar shall honour all legitimate obligations arising out of any treaties or agreements which before the commencement of this Constitution were in force between the Government of Myanmar and the Government of any other State, provided that such other State honours any reciprocal obligations towards the Union of Myanmar.**
 9. (a) **Any proceedings relating to contracts or liabilities which might have been brought against the Government of the Union of Myanmar before this Constitution comes into force, may be brought against the Union Government.**
 - (b) **The Union of Myanmar may sue and may be sued by the name of the Union of Myanmar.**
 10. **The Constitutional Tribunal shall consist of nine members including the chairman. The President, the Speaker of the Pyithu Hluttaw and the Speaker of the Amyotha Hluttaw shall select three members each who meet the following qualifications from among Hluttaw members or non-Hluttaw members:**
 - (a) **person who has attained the age of 50 years;**
 - (b) **person who possesses qualifications set for a Pyithu Hluttaw, other than restriction on age,**
 - (c) **person who possesses qualifications set for**

- the Chief Justice and a Supreme Court Justice, other than restriction on age;
- (d) **person who has political, administrative, economic and security outlooks.**
- (e) **person who is loyal to the State and the people.**
11. **The list of three members each nominated by the President, the Pyithu Hluttaw Speaker and the Amyotha Hluttaw Speaker, and a member nominated for chairmanship of Constitutional Tribunal among the nine members shall be submitted to the Pyidaungsu Hluttaw for its approval.**
12. **The Pyidaungsu Hluttaw shall have no right to reject the persons nominated for members of the Constitutional Tribunal by the President unless it can prove the members disqualified.**
13. **The President may, in accord with the provisions of the State Constitution, have the right to nominate new members for the seats of Constitutional Tribunal that are still vacant due to failure to obtain agreement of the Pyidaungsu Hluttaw.**
14. **The President shall appoint the chairman and members of Constitutional Tribunal approved by the Pyidaungsu Hluttaw.**
15. **The term of the Constitutional Tribunal is five years, the same as that of the Pyidaungsu Hluttaw. However, the ongoing Constitutional Tribunal, on expiry of its term, shall continue to carry out its functions till the President forms a new Constitutional Tribunal under this Constitution.**
16. **A member of the Constitutional Tribunal:**
 - (a) **shall be deemed to have resigned from the Hluttaw concerned on the date of being appointed if he is a member of any Hluttaw.**
 - (b) **shall be deemed to have resigned from civil service in accord with civil service rules and regulations on the date of being appointed if he is a government employee.**
 - (c) **shall have no right to participate in activities of the political party concerned during tenure of membership starting from the date of being appointed if he is a member of a political party.**
17. **A member of the Constitutional Tribunal may have the right to submit his resignation to the President if he wishes to resign before expiry of his tenure due to a reason.**
18. **The President may appoint a new member in accord with the provisions of this Constitution if there is a vacancy in membership in the Constitutional Tribunal for a certain reason.**
19. (a) **A member of the Constitutional Tribunal can be blamed or impeached under any of the following reasons:**
 - (1) **treason;**
 - (2) **violation of any of the provisions of the Constitution;**
 - (3) **misbehaviour;**
 - (4) **incapability of discharging duties prescribed in the Constitution for a member of the Constitutional Tribunal;**
 - (5) **inefficient discharge of duties;**
- (b) **If need arises to blame or impeach a member of the Constitutional Tribunal, it shall do so under the provisions prescribed in this Constitution set to blame or impeach the Chief Justice or a Supreme Court Justice.**
20. **The functions of the Constitutional Tribunal are as follows:**
 - (a) **to interpret provisions of the Constitution,**
 - (b) **to scrutinize whether or not laws enacted**

- by the Pyidaungsu Hluttaw, the Region Hluttaws and the State Hluttaws and Self-Administered Areas are in conformity with the Constitution,
- (c) **to scrutinize functions of executive authorities of Pyidaungsu, Regions, States and Self-Administered Areas are in conformity with the Constitution,**
- (d) **to decide on disputes in connection with the Constitution between Pyidaungsu and regions, between Pyidaungsu and States, between Regions and States, among Regions, among States, and between Regions or States and Self-Administered Areas and among Self-Administered Areas themselves to perform other duties prescribed in the Constitution,**
- (e) **to decide on disputes in connection with the rights and responsibilities of the Pyidaungsu and Regions; or States or Self-Administered Areas in implementing Union law by Regions, States or Self-Administered Areas,**
- (f) **to scrutinize and decide on matters relating to Union territories informed by the President,**
- (g) **tasks entrusted by laws prescribed by the Pyidaungsu Hluttaw,**
21. **If there is a dispute as to whether a provision prescribed in a law is in conformity with the Constitution in hearing a case by a court, and the Constitutional Tribunal has not made any decision regarding the case, the court shall suspend its hearing and submit its views to the Constitutional Tribunal in accord with the procedures for its decision. The decision of the Constitutional Tribunal regarding the dispute shall apply all the cases.**
22. **The decision of the Constitutional Tribunal shall be final.**
23. **The following persons shall have the right to directly submit a case to the Constitutional Tribunal for its interpretation, decision, and stance:**
 - (a) **President;**
 - (b) **Speaker of the Pyidaungsu Hluttaw;**
 - (c) **Speaker of the Pyithu Hluttaw,**
 - (d) **Speaker of the Amyotha Hluttaw,**
 - (e) **Chief Justice;**
 - (f) **Chairman of Union Election Commission.**
24. **The following persons or bodies shall have the right to submit a case to the Constitutional Tribunal in accord with the procedures for its interpretation, decision and stance:**
 - (a) **Region or State Chief Minister;**
 - (b) **Speaker of the Region or State Hluttaw,**
 - (c) **Chairman of Leading Body of Self-Administered Areas.**
 - (d) **At least 10 percent of the members of the Pyithu Hluttaw or the Amyotha Hluttaw.**
25. **Formation and relations of the Constitutional Tribunal, and duties, rights and privileges of the chairman and members of the Constitutional Tribunal shall be prescribed by law.**
26. **The status of the chairman of the Constitutional Tribunal is designated to be equivalent to the status of a Vice-President, and a member, to the status of a Union minister in order to make reference in prescribing by law regarding the duties, rights and privileges of the chairman and members of the Constitutional Tribunal.**

The Shan State Kokang Democratic Party in its suggestion said, "As regards the para 6, we would like to give a suggestion. Myanmar is formed with Regions and States and self-administered areas where various national races reside. There are national races who are not skilled in Myanmar literature and language. Moreover, some areas of the nation are far away from the place where the National Archives is located. Hence, copies of the Constitution that are translated into the languages of various national races will surely be required."

"So, we would like to make a suggestion that the government enact necessary law to keep the translated copies of the Constitution at the respective Regions, States and self-administered areas."

To respond to this suggestion, I would say Myanmar language is common among the national races of the Union of Myanmar, so it has been designated as official language for long. The terms enumerated in the law are to be correct and exact, and I do not think it is easy to translate the terms of law into respective languages of national races, and especially it is more difficult to translate the provisions of a State constitution, and it calls for no mistakes in the process. If there is some mistakes, there will be some difference between the translated work and initial definition. It is needed to continue to use Myanmar language as official language, as practised previously.

I would say this suggestion will be recorded so that if need arises to translate the law into languages of national races in respective Regions or States, necessary measures can be taken under the supervisions of respective governments of respective Regions or States.
Mr chairman,

Independent Representatives-Elect Dr Hmu Htan of Thantlang Township Constituency in Chin State, U Aung Thein of Ywangan Township Constituency in Shan State and U Tun Kyaw of Namhsan Township Constituency in Shan State (North) from that Delegate Group of Representatives-Elect said, "Therefore, the points from No 1 to No 26 the Work Committee chairman explained at the NC plenary session held on 13 November 2006 should be adopted.

"I would also like to make a suggestion about a **constitutional index**. An index should be stated in the booklet of the State constitution in order that when need arises to refer sub-paras, paras and pages, the facts can be looked up in the booklet in a short time. The constitutions of some countries feature an index, but those of most countries do not feature an index. The former countries state an index in the end of the booklet of the State constitution. So, I would like to suggest that after the booklet of the State constitution is in circulation, it should feature a **constitutional index**.

They added, "I have learnt that in order to achieve success in working in a systematic and smooth way, there need some methods such as

- (1) implementation of tasks in accordance with policy guidelines,
- (2) reviewing the weak points in doing so,
- (3) assessing the reviews,
- (4) evaluating the assessments,
- (5) laying down better policy guidelines based on the findings. This aphorism is reasonable and useful at any times. In pursuing policy guidelines, it is required to regularly fund out weak points and strong points. It is also needed to assess the reviews to know as to whether

achievement is made or not. Only then, will it be possible to know whether the assessments are effective. And it is required to constantly review the weak points and causes and effects of the remedies to lay down better plans and new guidelines. Now, most nations are practising such methods. So, in building a modern and developed nation in accordance with the upcoming State constitution, emphasis should be placed on **reviewing, assessing the reviews, remedying and evaluating.**"

Of the two suggestions, the first — to feature a constitution index, the 1974 constitution carries a constitution index. So, this suggestion will be put on record to be featured if necessary when respective bodies write a draft of the State constitution.

In relation to the second suggestion, it is in connection with the ongoing procedures being carried out in accordance with the existing law, and it is needed to continue to use the procedures in doing so.

Therefore, in line with the suggestions of the majority of the delegates, the detailed basic principles:

1. **This Constitution is the Basic Law of laws of the State.**
2. **Myanmar language is the official language.**
3. **The State fundamental principles are the guidelines to be followed by the legislative Hluttaws in enacting laws and interpreting provisions of the State Constitution and of other laws.**
4. **Interpretation of the preamble, articles, clauses, words and expressions contained in this Constitution shall be based only on Myanmar text.**
5. **Interpretation of the expressions of this Constitution should be referred to the existing Interpretation of Expressions Law.**
6. **A Myanmar manuscript of this Constitution shall be kept at the National Archives. The manuscript shall be conclusive evidence of the provisions of this Constitution.**
7. **In the interest of the State, the Union Government may permit—**
 - (a) **Region or State government,**
 - (b) **a cooperative society, an organization or a person to run any of economic enterprises, which are prescribed to be operated solely by the Union Government, through a joint-venture system with the Union Government or under agreements.**
8. **The Union of Myanmar shall honour all legitimate obligations arising out of any treaties or agreements which before the commencement of this Constitution were in force between the Government of Myanmar and the Government of any other State, provided that such other State honours any reciprocal obligations towards the Union of Myanmar.**
9. (a) **Any proceedings relating to contracts or liabilities which might have been brought against the Government of the Union of Myanmar before this Constitution comes into force, may be brought against the Union Government.**
 - (b) **The Union of Myanmar may sue and may be sued by the name of the Union of Myanmar.**
10. **The Constitutional Tribunal shall consist of nine members including a chairman. The President, the Speaker of the Pyithu Hluttaw and the Speaker of the Amyotha Hluttaw shall select three members each who meet the following qualifications from among Hluttaw**

members or non-Hluttaw members:

- (a) **person who has attained the age of 50 years;**
 - (b) **person who possesses qualifications set for a Pyithu Hluttaw, other than restriction on age,**
 - (c) **person who possesses qualifications set for the Chief Justice and a Supreme Court Justice, other than restriction on age;**
 - (d) **person who has political, administrative, economic and security outlooks.**
 - (e) **person who is loyal to the State and the people.**
11. **The list of three members each nominated by the President, the Pyithu Hluttaw Speaker and the Amyotha Hluttaw Speaker, and a member nominated for chairmanship of Constitutional Tribunal among the nine members shall be submitted to the Pyidaungsu Hluttaw for its approval.**
 12. **The Pyidaungsu Hluttaw shall have no right to reject the persons nominated for members of the Constitutional Tribunal by the President unless it can prove the members disqualified.**
 13. **The President may, in accord with the provisions of the State Constitution, have the right to nominate new members for the seats of Constitutional Tribunal that are still vacant due to failure to obtain agreement of the Pyidaungsu Hluttaw.**
 14. **The President shall appoint the chairman and members of Constitutional Tribunal approved by the Pyidaungsu Hluttaw.**
 15. **The term of the Constitutional Tribunal is five years, the same as that of the Pyidaungsu Hluttaw. However, the ongoing Constitutional Tribunal, on expiry of its term, shall continue to carry out its functions till the President forms a new Constitutional Tribunal under this Constitution.**
 16. **A member of the Constitutional Tribunal:**
 - (a) **shall be deemed to have resigned from the Hluttaw concerned on the date of being appointed if he is a member of any Hluttaw.**
 - (b) **shall be deemed to have resigned from civil service in accord with civil service rules and regulations on the date of being appointed if he is a government employee.**
 - (c) **shall have no right to participate in activities of the political party concerned during tenure of membership starting from the date of being appointed if he is a member of a political party.**
 17. **A member of the Constitutional Tribunal may have the right to submit his resignation to the President if he wishes to resign before expiry of his tenure due to a reason.**
 18. **The President may appoint a new member in accord with the provisions of this Constitution if there is a vacancy in membership in the Constitutional Tribunal for a certain reason.**
 19. (a) **A member of the Constitutional Tribunal can be blamed or impeached under any of the following reasons:**
 - (1) **treason;**
 - (2) **violation of any of the provisions of the Constitution;**
 - (3) **misbehaviour;**
 - (4) **incapability of discharging duties prescribed in the State Constitution for a member of the Constitutional Tribunal;**
 - (5) **inefficient discharge of duties;**

- (b) If need arises to blame or impeach a member of the Constitutional Tribunal, it shall do so under the provisions prescribed in this Constitution set to blame or impeach the Chief Justice or a Supreme Court Justice.
20. The functions of the Constitutional Tribunal are as follows:
- to interpret provisions of the Constitution,
 - to scrutinize whether or not laws enacted by the Pyidaungsu Hluttaw, the Region Hluttaws and the State Hluttaws and Self-Administered Areas are in conformity with the Constitution,
 - to scrutinize functions of executive authorities of Pyidaungsu, Regions, States and Self-Administered Areas are in conformity with the Constitution,
 - to decide on disputes in connection with the Constitution between Pyidaungsu and regions, between Pyidaungsu and States, between Regions and States, among Regions, among States, and between Regions or States and Self-Administered Areas and among Self-Administered Areas

- to perform other duties prescribed in the Constitution,
 - to decide on disputes in connection with the rights and responsibilities of the Pyidaungsu and Regions; or States or Self-Administered Areas in implementing Union law by Regions, States or Self-Administered Areas,
 - to scrutinize and decide on matters relating to Union territories informed by the President,
 - tasks entrusted by laws prescribed by the Pyidaungsu Hluttaw,
21. If there is a dispute as to whether a provision prescribed in a law is in conformity with the Constitution in hearing a case by a court, and the Constitutional Tribunal has not made any decision regarding the case, the court shall suspend its hearing and submit its views to the Constitutional Tribunal in accord with the procedures for its decision. The decision of the Constitutional Tribunal regarding the dispute shall apply all the cases.
22. The decision of the Constitutional Tribunal shall be final.
23. The following persons shall have the right to directly submit a case to the Constitutional Tribunal for its interpretation, decision, and stance:

- President;
 - Speaker of the Pyidaungsu Hluttaw;
 - Speaker of the Pyithu Hluttaw,
 - Speaker of the Amyotha Hluttaw,
 - Chief Justice;
 - Chairman of Union Election Commission.
24. The following persons or bodies shall have the right to submit a case to the Constitutional Tribunal in accord with the procedures for its interpretation, decision and stance:
- Region of State Chief Minister;
 - Speaker of the Region or State Hluttaw,
 - Chairman of Leading Body of Self-Administered Areas.
 - At least 10 percent of the members of the Pyithu Hluttaw or the Amyotha Hluttaw.
25. Formation and relations of the Constitutional Tribunal, and duties, rights and privileges of the chairman and members of the Constitutional Tribunal shall be prescribed by law.
26. The status of the chairman of the Constitutional Tribunal is designated to be equivalent to the status of a Vice-President, and a member, to the status of a Union minister in order to make reference in prescribing by law regarding the duties, rights and privileges of the chairman and members of the Constitutional Tribunal.

Likewise, flood waters coming from the Ayeyawady River, Dokhtawady River and Panglong River forced more than 700 households in 64 village-tracts to leave for safe places. As TataU-Paleik road Zaycho road in TataU Township have been flooded, small vehicles cannot manage to pass through. The flood victims were provided with 260 bags of rice and 17 schools in TataU Township have been temporarily closed since 30 July.—MNA

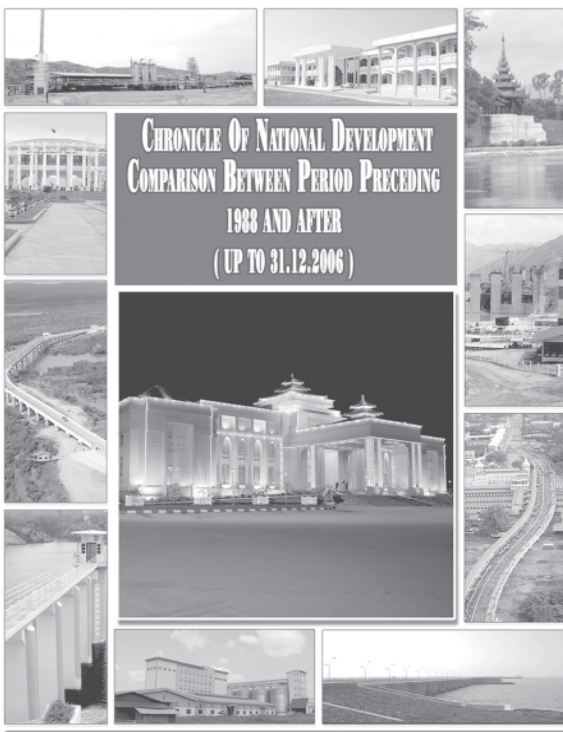

ASEAN forum calls for unconditional release of Korean hostages

MANILA, 4 Aug — The 14th Association of South-East Asian Nations (ASEAN) Regional Forum Thursday released a statement, calling for unconditional release of South Korean hostages in Afghanistan.

“The foreign ministers of the participating countries of the ASEAN Regional Forum express our solidarity with the people and government of the Republic of Korea and condemn the hostage taking of their nationals in Afghanistan and deplore in the strongest terms the brutal murder of two hostages,” said the statement. “We call for the immediate, unconditional and safe release of all hostages.” — MNA/Xinhua



US cities double-check bridge safety after Minneapolis collapse

LOS ANGELES, 3 Aug — Cities across the United States are scrambling to double-check safety of bridges after the collapse of a Minneapolis bridge into the Mississippi River, killing at least five people and leaving about 100 injured.

In Los Angeles, city council members Friday introduced a motion asking the Bureau of

Engineering and the Public Works Department to provide an update on the city's bridge-renovation programme.

Los Angeles County Supervisor Mike Antonovich also planned to ask his colleagues next week to have county road engineers “redouble their efforts” to look at area bridges in light of Wednesday's tragedy in

Minneapolis.

“We are confident with our bridges, but we're asking them to take one more look, to be vigilant in their inspection and maintaining practices,” said a spokesman for Antonovich.

Los Angeles officials said there are two bridges in the city similar in design to the Minnesota bridge, and both are scheduled for replacement.

Each of the 500 bridges in Los Angeles is inspected every two years to assess safety, ability to accommodate traffic and structural integrity, according to the city's Board of Public Works President Cynthia Ruiz.

California hard-hit by West Nile Virus

LOS ANGELES, 4 Aug — California Governor Arnold Schwarzenegger on Thursday declared a state of emergency in four counties hit hardest by West Nile Virus.

The number of people infected this year with West Nile Virus has been three times higher than the same time last year, Schwarzenegger said in a statement e-mailed to *Xinhua*. The state of emergency, applied to Kern, Colusa and San Joaquin counties, was intended to prevent the spread of this mosquito-borne disease, said the governor.

This year there have been four deaths in California due to West Nile Virus (two in Kern County, one in San Joaquin County and one in Colusa County).

“Today I’m taking action to help the counties hit hardest by West Nile Virus,” Schwarzenegger said. “My proclamation makes financial assistance available to the local vector control districts and directs state agencies to take proactive measures to protect Californians from further spread of this deadly virus. I will continue to ensure our local agencies have whatever resources they need to fight the spread of this disease.”

The recent upturn in foreclosures this year has increased the number of vacant homes this summer

with unattended and untreated pools, which has exacerbated the spread of West Nile Virus, said the governor.

Since taking office, Governor Schwarzenegger has invested more than 15 million US dollars to fight the West Nile Virus. California has one of the most comprehensive West Nile Virus surveillance and control systems in the United States.

Insulin in plants relieves diabetes in mice

LOS ANGELES, 4 Aug — Insulin grown in plants has been shown to relieve diabetes in mice, according to a new study.

Diabetic mice showed signs of recovery after

they were treated with insulin grown in plants, showed the study, conducted by a research team at the University of Central Florida.

In the study, the researchers genetically engineered tobacco plants with the insulin gene and then administered freeze-dried plant cells to five-week-old diabetic mice as a powder for eight weeks. By the end of the study, the diabetic mice had normal blood and urine sugar levels, and their cells were producing normal levels of insulin.

These results and prior research indicate that insulin capsules could someday be used to prevent diabetes before

symptoms appear and treat the disease in its later stages, said biochemist Henry Daniell, who led the study.

Daniell has since proposed using lettuce instead of tobacco to produce the insulin because the crop can be produced cheaply and avoids the negative stigma

associated with tobacco.

Capsules of insulin produced in genetically modified lettuce could hold the key to restoring the body's ability to produce insulin and help millions of Americans who suffer from insulin-dependent diabetes, said the study.

Poland attacks German demands for pre-war art

WARSAW, 4 Aug — Poland on Friday attacked German efforts to get back works of art that fell into Polish hands after World War II, in the latest sign of diplomatic tensions

between the neighbours. Museums in Germany have been trying to secure works that stayed in Poland after borders were shifted at the end of the war and a German official recently described such items as looted art.

“I am shocked by such rhetoric,” Polish Foreign Minister Anna Fotyga was quoted as saying by Polish daily *Rzeczpospolita*.

Her deputy, Pawel Kowal, said it was particularly inappropriate to raise the issue as Poland was commemorating the 1944 Warsaw Uprising during which Nazi occupiers destroyed almost all the capital and killed tens of thousands of Poles.

Pesticide kills farmer, poisons 154 in Colombia

BOGOTA, 4 Aug — One farmer was killed and 154 others were poisoned on Friday by Endosulfan pesticide used to protect coffee and banana crops in the central western Quindio Province of Colombia, local health officials said.

Jose Arias, Health Sector Institute representative of that area, said local farmers continue using Endosulfan even though this dangerous

pesticide has been banned since 2001.

“It is possible that the farmers are not following the correct instructions,” Arias said. According to him, the farmers have not been using masks and other protective equipment while using the lethal pesticide.

Quindio, with 12 municipalities, is one of Colombia's main coffee-producing and exporting regions.— MNA/Xinhua

Liverpool beat Shanghai, Porto hold Feyenoord

ROTTERDAM (Netherlands), 4 Aug — Liverpool scored a goal in each half to beat Shanghai Shenhua of China 2-0 in the opening match of the Port of Rotterdam tournament on Friday.

Spaniard Fernando Torres opened the scoring after 12 minutes with his first goal since moving to Liverpool for a club record 36 million euros (49.35 million US dollars) from Atletico Madrid when he picked up a defence splitting pass from Yossi Benayoun. Steven Gerrard, who came on in the second half with Dutchmen Dirk Kuyt and Ryan Babel, doubled Liverpool's lead in the 65th minute with a beautiful shot from 25 metres.

In the other match Feyenoord and Porto drew 0-0 leaving Liverpool, who face the Dutch on Sunday, top of the table with three points ahead of the hosts and Portuguese on one point. —MNA/Reuters

RIO DE JANEIRO, 4 Aug — Sao Paulo pulled level on points with Brazilian championship leaders Botafogo by beating Juventude 3-1, their fourth consecutive win.

Lowly Juventude took a shock lead when Luciano broke to score after only two minutes of Thursday night's game, but Sao Paulo defender Miranda equalized in the 31st minute when he pounced on a rebound following a free kick. Strikers Hugo and Borges added two more in the last 15 minutes to give the defending champions the points.

confidence after reaching the final of the Stanford Classic last week and having beaten eighth seed Dinara Safina in the previous round in San Diego.

AMSTERDAM, 4 Aug — Striker Eduardo Da Silva scored his first goal for Arsenal in a 2-1 win over Lazio in the opening game of the Amsterdam tournament on Thursday. The Brazilian-born Croatia international, granted a work permit on Wednesday, netted with a fine header from a corner 10 minutes into the second half.

Danish midfielder Nicklas Bendtner had fired the London side ahead but Goran Pandev levelled five minutes before halftime.

In other action, 10-man Ajax Amsterdam struck twice in the second half to beat Atletico Madrid 2-0.

Spaniard Gabri headed home the opening goal early in the second half but was sent off in the final minute after elbowing an opponent. —MNA/Reuters

Roddick rolls into final 4, Haas, Safin out

WASHINGTON, 4 Aug — Andy Roddick rolled into the semifinals of the Washington Open but second seed Tommy Haas and number three Marat Safin were ousted on Friday from the US Open tune-up.

Roddick fired 16 aces to defeat South Korea's Lee Hyung-taik for the 10th time in 11 career meetings, 7-6, 6-2.

"That was by far the best I've hit the ball this tournament," said Roddick.

"He gets into a groove sometimes and you just have to stay the course and wait for the opportunities. I did a good job of that. "I felt like I was in control of my service games and even when I was down I felt like I controlled the pace of the match."

In Saturday's semis, Roddick will face

Ivo Karlovic, the hard-serving Croatian who escaped with a 4-6, 6-3, 7-6 quarter-final victory over Paul Capdeville of Chile. Haas went out to 41 6th-ranked John Isner, a 6 feet 9 inches American playing in just his second ATP event. Isner blasted 30 aces to subdue the German 6-4, 6-7, 7-6 in a two-hour, 27-minute match on a steamy day in Washington.

"He's got a big game," admitted Haas. "His serve is a huge, huge weapon. He's got to be happy about his third-set tie-breakers this week.

"Confidence does a lot for you. I'm sure he's feeling pretty good right now."

Next up for Isner will be Frenchman Gael Monfils, the ninth seed who recorded 14 aces to beat Safin 6-3, 7-5.

Australia Asia's top seeds for 2010 World Cup qualifiers

KUALA LUMPUR, 4 Aug — Australia were named as Asia's top seeds for region's 2010 World Cup qualifiers by the Asian Football Confederation (AFC) on Friday.

The Socceroos will go into Monday's draw seeded first with South Korea second, Saudi Arabia third and Japan fourth, based on the teams' results at the 2006 World Cup.

Iran will be seeded fifth, significant with the top five teams all receiving automatic byes into the third round of Asian qualifying matches.

Australia, who reached the last 16 in Germany, only joined the AFC at the start of 2006 after ditching Oceania in order to gain a direct qualifying path to the World Cup.

A total of 43 nations, including North Korea, Myanmar and tiny Bhutan, will go into the draw at AFC Headquarters in Kuala Lumpur.

Blaming begins in Minneapolis bridge collapse

MINNEAPOLIS, 5 Aug — Politicians trying to account for one of worst bridge collapses in US history cast blame ranging from engineering faults to the Iraq war on Friday, while divers tried to reach the

bodies of more victims in the Mississippi River's treacherous waters.

As investigators probed Wednesday's collapse that killed at least five people, Minnesota Governor Tim Pawlenty said outside experts would review the decisions of state engineers to shore up problems with the heavily-travelled 40-year-old bridge in central Minneapolis.

Engineers had decided to periodically inspect the steel superstructure beneath the Interstate 35W bridge and bolt on reinforcing plates where any flaws were found. But that work, which Pawlenty said fit in the state's budget, was postponed by resurfacing and repair work that was going on when the bridge buckled and fell.

"Experts that we rely on, technical experts and engineers, made some decisions about what needed to be done. They thought they were making an appropriate decision for their reasons, and now those

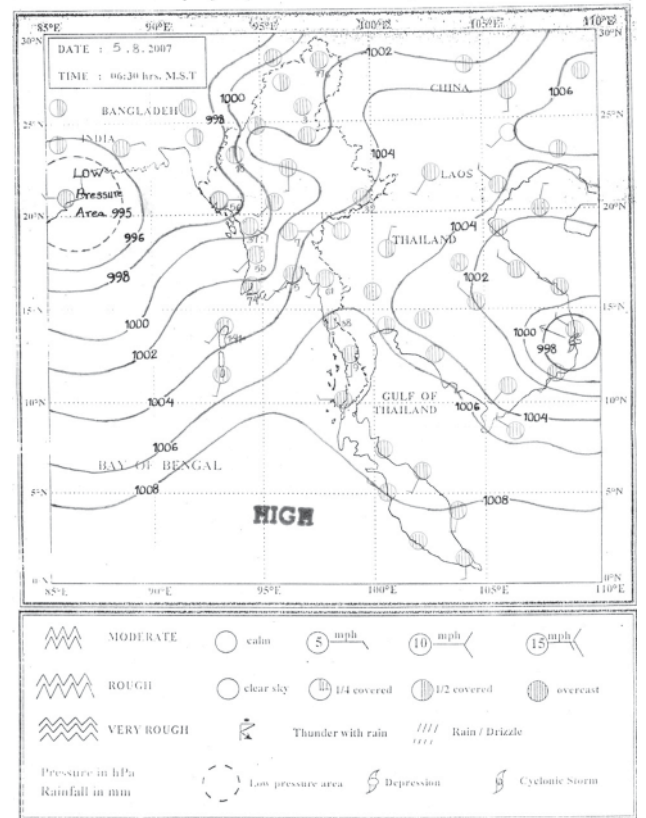
decisions will have to be reviewed," Pawlenty said. A private engineering firm had been hired for the review.

"The bridge was declared fit for service," he said. "There will be tough questions asked, including by me, and we will get to the bottom of this."

US Senator Amy Klobuchar, a Minnesota Democrat, suggested Bush Administration spending on the Iraq war may have cramped funding for domestic projects such as road and bridge construction, and for such infrastructure projects as new levees for New Orleans.

YANGON, 5 Aug — Lt-Gen Myint Swe of the Ministry of Defence attended the concluding ceremony of ploughing and cultivation of monsoon paddy of Yangon Division for 2007-08, the paddy transplanting contest and the prize presentation for outstanding persons in agriculture sector at 500 acres of land near West Malit Village in Hlegu Township this morning.

Speaking on the occasion, Lt-Gen Myint Swe said that Yangon Division has already completed cultivation of 1,152,462 acres of monsoon paddy. After growing late-monsoon paddy, the division will exceed the target of growing 1.2 million

acres of monsoon paddy. In striving for boosting production of paddy, a total of 20.1 million acres were put under paddy in the entire nation in 2006-07, and 1,450 million baskets of paddy were produced. In the 2007-08, arrangements are being made for cultivation of 16.9 million acres of monsoon paddy and 3.4 million acres of summer paddy, totalling 20.3 million acres to produce over 1,500 million baskets of paddy. Therefore, Yangon Division is to make efforts for cultivation of 240,000 acres of summer paddy to meet the target.

He continued to say that the division is to place emphasis on cultivation of edible oil crops for ensur-

ing edible oil sufficiency. Departmental personnel, Tatmadawmen and people are to join hands in growing 81,000 acres of physic nut this year, and efforts are to be made for meeting the target of 500,000 acres. In conclusion, Lt-Gen Myint Swe said that as the government has built 10 dams, 19 river water pumping stations and eight sluice gates in Yangon Division, officials and local farmers to carry out tasks to expedite agricultural sector for development of Yangon Division and the national economy.
