Meanwhile, Bush's approval ratings in California have stayed at

rock bottom, with 26 per cent of voters approving of his job performance, compared with 65 per cent who disapprove. His rating was also 26 per cent in March, when the last similar poll conducted.

Only former president Richard Nixon dipped to lower levels — a 24-percent approval rating —and that was at the height of the Watergate scandal, according to Mark DiCamillo, director of the Field Poll, California's independent public opinion service.

"This is the lowest approval rating for an extended period of time of any US president" in California, DiCamillo said. "That rating for Nixon was just for one moment in time, and then he resigned."

## Four million US teens drenched in drug, alcohol culture

Beijing 17 Aug — Thirty-one percent of high school students in US more than 4 million — see drug dealing, illegal drug use or students high or drunk at least once a week on their school grounds, said a survey quoted

by media reports on Friday.

Nine percent of middle school students, or more than 1 million, at least once a week see classmates engaging in drug-related activity at school, the survey found.

The results also show that since 2002, the proportion of students who attend schools where drugs are used, kept or sold has soared 39 percent for high school students and 63 percent for those in middle school.

From 2006 to 2007, the proportion jumped 20 percent for high school students and 35 percent for middle school students, according to the survey.

Joseph Califano, chairman of the National Centre on Addiction and Substance Abuse (CASA) at Columbia University in US warned that too many US schools have become open drug bazaars for teens. —Internet

## UK security worker shot dead in Afghanistan

London, 17 Aug — A British security worker has been shot dead in Afghanistan Wednesday, according to the British Foreign Office.

The Foreign Office confirmed that the shooting happened in a residential area in the east of Afghan capital Kabul about a mile from British Embassy.

The victim, named Richard Adamson, was the senior manager of the British security company ArmorGroup, which since 2003 provides protection to personnel in Afghanistan working for the British Embassy and organizations such as the Department For International Development, HM Customs and Revenue and the British Council. Two Afghans from the ArmorGroup were suspected of the killing and had been arrested, according to Afghanistan Interior Ministry.

The next of kin of the victim had been informed, a spokesman for ArmorGroup said. The shooting came on the same day as a bomb near Kabul left dead three German police officers who were protecting the German Embassy.

## Three undersea quakes strike Indonesia, no damage reported

Jakarta, 17 Aug — Three undersea earthquakes struck western and eastern Indonesia on Friday, but there were no reports of casualties or damage, the country's meteorological agency said.

There were no tsunami warnings issued. The first quake struck overnight at 0126 a.m. **GMT** (1826)Thursday) south of a strait between the islands of Java and Sumatra, with its epicentre about 275 kilometres (170 miles) southwest of the capital Jakarta.

The Indonesian agency said the quake measured 5.9 on the Richter Scale,

## Lightning kills 306 Chinese in three weeks

Beijing, 17 Aug — Lightning strikes killed 306 Chinese from 25 June to 16 August, the China Meteorological Administration (CMA) announced on

So far this year, 499 Chinese have been killed by lightning, 199 more than the same period last year, said

China was more frequently hit by extreme weather conditions this year, said CMA head Zheng Guoguang.

Extreme weather was usually concentrated in summer and autumn, especially in July and August, he said, adding it was hard to forecast.

The meteorological disasters this year were of "various types, wide reaching, scattered and very intense", he said and pointed out that global warming increased the possibility of extreme weathers.

Zheng said east China's Jiangxi Province suffered most from lightning, which had killed 116 people in the province this year.

Research shows that all the victims were rural residents and 79 per cent were working in fields where they were killed.—MNA/Xinhua

## Former US Marine charged with killing Iraqi prisoners

Los Angeles, 17 Aug— The US attorney in Los Angeles has filed charges against a former Marine sergeant for his alleged role in the killing of eight unarmed Iraqi prisoners, it was reported on Thursday.

The defendant, who conducted the killing during a November 2004 battle in Falloujah, Iraq, is expected to appear in court today, according to the Los Angeles Times.

Jose Nazario, a former sergeant, is being charged in civilian court because

he is no longer a Marine. Naval Criminal Investigative Service agents are examining allegations against other members of Nazario's squad, who are still in the Marine Corps, but referred Nazario's case to the US attorney, sources were quoted as saying.

The investigation involves the same company — Kilo Company, 3rd Battalion, 1st Regiment — that is the focus of the worst alleged atrocity in Iraq, the killing of 24 civilians in Haditha on 19 November, 2005, said the paper. Nazario enlisted in the Marines in September 1997 and left as a sergeant in October 2005. — *MNA/Xinhua* 

#### Magnitude 6.7 quake jolts **Solomon Islands**

SINGAPORE, 17 Aug — A magnitude 6.7 quake struck the Solomon Islands to the northeast of Australia on Thursday, the US Geological Survey said on its website.

The USGS, monitored in Singapore, said the quake's epicentre was about two kilometres (about one mile) under the sea and occurred 75 kilometres (45 miles) west-southwest of Honiara, the capital of the Solomon Islands. There were no immediate reports of damage and the Hawaii-based Pacific Tsunami Warning Centre said in a statement on its website that a destructive Pacific-wide tsunami was not expected. — MNA/Reuters

#### Three soldiers injured in Thai southern bomb attack

BANGKOK, 17 Aug — Three soldiers were injured when insurgents detonated a bomb on a road in Thailand's southern province of Narathiwat Thursday morning, local police said.

The bomb exploded on the Rusoh-Samakkhi Road in Rusoh District while around 10 soldiers were patrolling the road on foot.

The three soldiers were severely injured and have been rushed to a nearby hospital.

Thailand's three southernmost provinces – Narathiwat, Yala and Pattani — have been troubled with insurgency-related violence which has claimed more than 2,300 lives since it resumed in early 2004. MNA/Xinhua

#### Indonesian teenager dies of bird flu

JAKARTA, 17 Aug — A 17-year-old Indonesian girl has died of bird flu, taking the country's death toll from the virus to 83, a Health Ministry official said on Thursday.

Her death comes days after a 29-year-old woman living on Bali died of the disease, becoming the resort island's first known human fatality from the H5N1 virus.

The 17-year-old maid from Tangerang west of Jakarta died on Tuesday after falling ill with a high fever last week, Joko Suyono of the ministry's bird flu centre said by telephone.

The most common way for humans to become infected with the H5N1 virus is through contact with sick fowl, but officials were still investigating how she contracted the disease.— MNA/Reuters

## New Zealand to invest \$12m in China to expand trade

Beijing, 17 Aug —New Zealand Trade and Enterprise (NZTE) is to invest 12 million US dollars in China to boost trade and promote its businesses.

Rod MacKenzie, group managing director of North Asia with NZTE, said the investment would be used to develop a New Zealand concept centre in Shanghai.

The Centre would chiefly provide information on New Zealand, such as travel, fashion, food and lifestlyles. Meanwhile, New Zealand, will open five new business offices in China in four years.

The project served as a strategic plan for identifiying key trade opportunities in China, especially during the 2010 Shanghai World Expo, said MacKenzie. Locations of the five offices

## **Crude prices** rise on storm forecast, rate cut

N EW YORK, 17 Aug. -Crude prices rose Friday on Hurricane Dean and the Federal Reserve's interest rate cut.

The National Hurricane Centre said Dean strengthened, which will head straight into the Gulf and a direct threat to oil and gas infrastructure.

The Fed cut its discount rate by a half percentage point, easing some investors' fears of an economic slowdown.

Light, sweet crude for September delivery rose 98 cents to settle at 71.98 dollars a barrel on the New York Mercantile Exchange.

In London, October Brent crude added 67 cents to settle at 70.44 dollars a barrel on the ICE Futures exchange.

## Cell Therapeutics to buy cancer drug

Washington, 16 Aug Biotech firm Cell Therapeutics Inc on Thursday will announce plans to pay Biogen Idec Inc. up to \$30 million for a lymphoma cancer treatment. Seattle-based Cell Therapeutics will take over sales, marketing and development of Zevalin in

the US, while Bayer Schering will continue to sell the drug outside the country. Zevalin posted sales of \$15.4 million in the US last year as a treatment for patients with relapsed non-Hodgkin's lymphoma.

Cell Therapeutics management hopes to expand the drug's use to serve an initial treatment for non-Hodgkin's lymphoma.

"We see potential for substantial revenue growth for this product," Cell Therapeutics Chief Executive James Bianco said in a statement.

## **Putin pledges \$2b** to Kyrgyzstan

BISHKEK, 17 Aug — Russia will invest two billion US dollars former Soviet Kyrgyzstan, Russian President Vladimir Putin said on Wednesday, after meeting his Kyrgyz counterpart ahead of a regional summit.

Central Asia holds huge supplies of untapped energy resources and the West, Russia, China and Iran have being eyeing ways of developing them and transporting them world markets. Kyrgyzstan also hosts both a Russian and a US air base.

"We need only good projects," Putin said. "We must take all necessary steps to fund these projects."

Kyrgyzstan lags behind Kazakhstan and Turkmenistan in terms of enery resources, but has considerable reserves of gold. On Thursday leaders from Russia, China and four of the ex-Soviet Central Asian states meet to work out how to strengthen an alliance, the Shanghai Cooperation Organization, aimed at maintaining strategic control over the region.

## **BMW sedan performs** worst in crash test

Detroit, 16 Aug — The 2008 BMW 5 Series was the worst performer in new side-impact crash tests of luxury sedans by the insurance industry.

The Acura RL, Kia Amanti and Volvo S80 all earned the highest safety rating from the Insurance Institute for Highway Safety, according to results released Thursday. The Cadillac STS and Mercedes E-Class earned the second-highest rating.

The tests were designed to show what would happen if a truck or sport utility vehicle hit the side of the sedan at 31 mph, the speed of a serious crash. Side-impact crashes are the most common type of fatal crash after a frontal crash, killing around 9,000 people on US roadways in 2005, the institute said. "Growing sales of SUVs and pickups have exacerbated height mismatches among passenger vehicles, thereby increasing the risks to occupants of many vehicles struck in the side," Insurance Institute President Adrian Lund said in a news release. All six sedans were equipped with standard side air bags. The air bags in the BMW 5 Series protected the head, but separate air bags designed to protect the chest and abdomen performed poorly, the institute said.—Internet


# "Supreme Court of the Union" should be used instead of the term "Pyidaungsu Taya Hluttaw"

Yangon, 18 Aug— The following is the compilation presented by member of the Panel of Chairmen of the Plenary Session of the National Convention U Kan Nyunt of Delegate Group of Peasants on suggestions made by Delegate Groups on matters concerning the amendments, the additions and the repeals and the transfer out of the fundamental principles and detailed basic principles that have been adopted by the National Convention.

#### Esteemed delegates,

At the Plenary session of the National Convention held on 6 August 2007, the Work Committee Chairman said, "The plenary session of the National Convention held on 16 September 1993 adopted the following State Fundamental Principles for para 9 in connection with judiciary:

"(a) the judicial power of the State is distributed among Pyidaungsu Taya Hluttaw (Supreme Court), Region Taya Hluttaw (Region High Court), State Taya Hluttaw (State High Court) and law courts of different levels including law courts of self-administered areas;



"(b) in the Pyidaungsu is constituted one Pyidaungsu Taya Hluttaw. Pyidaungsu Taya Hluttaw is the supreme law court of State;

"(c) Pyidaungsu Taya Hluttaw has powers to issue writs.

"But from paras1 to 9 of the Formation of Judiciary and paras 1, 2 and 8 of Sharing of the Judicial Power, use the term "Supreme Court of the Union" to clearly express the difference between the term "Supreme Court of the Union" and the term "High Court" of the Region or State. In our view, to have a uniformed context and to prevent occurrence of disputes in the future, the term "Supreme Court of the Union" should be used.

"Hence, delegates will have to suggest whether the term Pyidaungsu Taya Hluttaw in the subparas (a), (b) and (c) of para 9 of the Chapter "State Fundamental Principles" should be substituted with the term "Supreme Court of the Union".

#### Esteemed delegates,

Concerning the matter, National Unity Party said, to be able to clearly express the difference between the term "Supreme Court of the Union" and the term "High Court" of the Region or State, to have a uniformed context and to prevent occurrence of disputes in the future, the term "Supreme Court of the Union" should be used instead of the term Pyidaungsu Taya Hluttaw.


## The expression "may exercise relaxation of stipulation on age limit" should be substituted with the expression "shall exercise relaxation of stipulation on age limit"

YANGON, 18 Aug—The following is the compilation presented by member of the Panel of Chairmen of the Plenary Session of the National Convention U Kyaw Win Tun of Delegate Group of Workers on suggestions made by Delegate Groups on matters concerning the amendments, the additions and the repeals and the transfer out of the fundamental principles and detailed basic principles that have been adopted by the National Convention.

#### Esteemed delegates,

At the plenary session of the National Convention held on 6 August 2007, the Work Committee Chairman said, "The plenary session of the National Convention held on 29 March 1996, adopted the detailed basic principles for the formation of executive including subpara (h) of para 22 which states "The President of the State may exercise relaxation of stipulation on age limit in the State Constitution in appointing Region or State Ministers, the okkahta of the self-administered division or selfadministered zone or Hluttaw representatives elected to undertake the affairs of national races."

The subpara (g) of para 34 for the formation of the



executive states "The Okkahta of the self-administered division or self-administered zone is Minister in the region or state concerned. As such, provisions in the Constitution applying to the Ministers of the region or state will also apply to the self-administered division Okkahta or self-administered zone Okkahta."

The subpara (e) of para 22 states, "The Region or State Chief Minister shall submit the names approved by the Region or State Hluttaw, that of okkahta of the self administered division or self-administered zone and that of Hluttaw representatives elected to undertake the affairs of national races for appointment as Region or State Ministers" to the President of the State.

According to subpara (h) of para 22, the okkahta of the self-administered division or self-administered zone or Hluttaw representative elected to undertake the affairs of national races should be automatically appointed Minister of the respective Region or State. The okkahta of the self-administered division or self-administered zone or Hluttaw representative elected to undertake the affairs of national races may meet all the qualifications of a Hluttaw representative but can be younger than 35, the minimum age limit for Region or State Minister.



## More than 400 migrants rescued off Sicilian coast

Rome, 17 Aug—Italian Coast Guards rescued more than 400 migrants off the southern island of Lampedusa on Thursday, including a group of 300 men, women and children crammed into a wooden boat, officials said.

The number migrants from Africa arriving on Italian shores has spiked in recent weeks, boosted by the balmy summer weather and calmer sea conditions.

Italian Coast Guards said they first helped two rubber dinghies — one carrying 49 people, the other 57 in the sea off Lampedusa before spotting the boat with about 300 people.

Those on board included women and children, some suffering from dehydration. They were taken aboard Coast Guard vessels which brought them to the island.

The Coast Guards have also recovered the corpses of seven of as many as 14 migrants spotted floating in Maltese waters by a military aircraft on Tuesday.Closer to Africa than mainland Italy, Lampedusa is a popular entry point into Europe for

## **British tourists** fuelling endangered wildlife trade

London, 17 Aug-Coral, ivory and snakeskin souvenirs brought home by unwitting British tourists are helping to push endangered species closer to extinction, environmental group WWF (World Wild Life Fund) said on Thursday.

Traditional Chinese medicines made from endangered tigers, rhinos and seahorses also come top of World Wiltlife Fund blacklist of illegal holiday souvenirs."Although the latest figures indicate that some illegal wildlife trade items are being brought in knowingly by wildlife criminals, the majority of seizures appear to be items innocently brought back by holidaymakers as souvenirs," said Heather Sohl, wildlife trade officer at WWF.

"Our message is: if in doubt, don't buy."

The group warns that at the height of the holiday season some tourists may try to bring home live snakes, iguanas and chameleons as household pets, while others attempt to transport protected plants such as orchids from abroad.— MNA/Reuters



## ASEAN 10+3 youth exchanges programme starts in China

Beijing, 17 Aug — More than 500 youth delegates from ten member nations of the Association of South-East Asian Nations (ASEAN) and China, Japan and the Republic of Korea (ROK) (10+3) gathered here on Thursday to launch the ASEAN 10+3 youth exchanges programme.

The youth delegation, invited by the All-China Youth Federation, is to join the China-ASEAN Youth Camp and attend the China-ASEAN Young Leaders Meeting with topics on youth leaders' role in ASEAN members' social development, volunteers and East Asia community buildup.

## Colombia to construct Latin America's longest tunnel

BOGOTA, 17 Aug- The Colombian Government on Wednesday invited bids for the construction of Latin America's longest tunnel, a project that will cost 300 million US dollars and provide a road link between the Colombian capital and the port of Buenaventura.

The tunnel will boost the competitiveness of the country's exports by speeding up the transportation of goods, Minister of Transport Andres Uriel Gallego Henao told a Press conference.

## NASA delays spacewalk to decide on repair

Houston, 17 Aug — NASA on Wednesday put off a planned fourth spacewalk for the space shuttle Endeavour crew as officials said they had not decided whether to repair a gouge in the ship's heat shield.

While the US space agency studied the 3-inchby-2-inch gash Endeavour's belly, a spacewalking astronaut on Wednesday had to go back inside after finding a hole in his glove during work outside the International Space Station.

The fourth spacewalk, which includes other tasks besides the possible repair, had been scheduled for Friday but now will take place on Saturday, NASA said. Mission management team chairman John Shannon said more tests

were being run on damage | a decision Thursday mockups, but analysis so far "showed there would be no danger at all to the underlying structure" if *Endeavour* returned to Earth without the repair.

## **Study says AIDS virus** a 'double hit' to the brain

Washington, 17 Aug - The AIDS virus damages the brain in two ways, by not only killing brain cells but by preventing the birth of new cells, US researchers reported on Wednesday.

The study, published in the journal Cell Stem *Cell*, helps shed light on a condition known as HIV-associated mentia, which can cause confusion, sleep disturbances and memory loss in people infected with the virus.

It is less common in people taking drug cocktails to suppress the virus, and why HIV

damages brain function is

not clearly understood.

The virus kills brain cells but it also appears to stop progenitor cells, known as stem cells, from dividing, the team at Burnham Institute for Medical Research and the

The cocktail of drugs known as highly active antiretroviral therapy or HAART that treats HIV does not infiltrate the brain well, allowing for a "secret reservoir" of virus, said Stuart Lipton, who worked on the study. Working in mice, the researchers found that the virus directly interferes with the birth of new brain cells from stem cells.

Los Angeles, 17 Aug — The Academy of Motion Picture Arts and Sciences, which awards the Oscars, said on Wednesday it reelected Sid Ganis to his third straight term as president and made actor Tom Hanks one of its vice-presidents.

Ganis is a film industry veteran who has been on the academy's Board of Governors for 21 years. He has been an executive with several film companies including Columbia Pictures and Paramount Pictures.

Hanks won two Oscars for best actor in 1993's "Philadelphia" and 1994's "Forrest Gump". He had previously served as a governor of the academy's actors branch, and has a long history in Hollywood as both an actor and producer. — MNA/Reuters

## Fans mark Elvis death anniversary with vigil

Memphis(Tennessee), 17 Aug — Elvis Presley fans from around the world gathered outside his Memphis home on Wednesday to mark the

30th anniversary of his death in an event meant to both honour the singer's legacy and cash in on it.

Tens of thousands of fans were expected to file past Presley's grave site at his Graceland estate beginning Wednesday night and continuing into Thursday morning.

The candlelight vigil began amid an intense heat wave, with temperatures in Memphis rising past 100 degrees (38 degrees Celsius) by midafternoon. Paramedics treated several waiting fans for heat exhaustion and kept ambulances standing by.

## UK picks shortlist to build bigger express trains

London, 17 Aug — The British Government announced on Thursday a shortlist of firms bidding to design and build a new type of express train that will be more environmentally friendly and capable of carrying more passengers.

The Department for Transport said the short-listed firms were the Alstom-Barclay Rail Group, Hitachi Europe Ltd. and the Express Rail Alliance, which is a consortium comprising Bombardier Transportation, Siemens, Angel Trains and Babcock & Brown.

"We are developing a flexible train that can be deployed on different lines, in different lengths, and with different sources of power — so this train can operate wherever we need it in the future," Rail Minister Tom Harris said in a statement. An invitation to tender will be issued to short-listed bidders in autumn this year. Proposals will then be received from bidders in summer 2008, with the award of the contract in winter 2008-09, the Department of Transport said.— MNA/Reuters



CINCINNATI, 18 Aug — Top seed Roger Federer struggled to a 6-3, 3-6, 6-2 victory over Spaniard Nicolas Almagro on Friday to reach the semifinals of the Cincinnati Masters. 
But third seed Svetlana Kuznetsova, four times a runner-up this year, was ousted 2-6, 7-5, 6-1 by Tatiana Golovin of France.

## Three missing in US Navy plane crash

Washington, 18 Aug | Three US Navy sailors are missing at sea after a command and control plane crashed over the Atlantic on Wednesday night, CNN reported on Thursday.

The E-2C Hawkeye was conducting exercises off the Virginia-North Carolina coast at the time, according to the report.

The plane crashed after it launched from the deck of the aircraft carrier USS Harry S Truman about 11 pm Wednesday.

Navy officials said they do not know what caused the plane to crash, and search and rescue missions are under way from units on the Truman, the carrier Eisenhower and the Coast Guard.

The twin-engine plane usually carries a crew of five, but had only three aboard during the flight.

The plane was part of a training squadron and is based at the Naval Station Norfolk in southern Virginia.

# Laying of natural gas pipeline, growing of physic nut plants inspected

## A political party shall accept and practise disciplineflourishing genuine multiparty democracy

YANGON, 18 Aug—The following is the compilation presented by member of the Panel of Chairmen of the Plenary Session of the National Convention U Maung Hla (a) U Hla Myint of Delegate Group of National Races on suggestions made by Delegate Groups on matters concerning the amendments, the additions and the repeals and the transfer out of the fundamental principles and detailed basic principles that have been adopted by the National Convention.

#### Esteemed delegates,

At the plenary session held on 6 August 2007, the Work Committee chairman said, "The Chapter "State Fundamental Principles" that was adopted at the plenary session of the National Convention held on 16 September 1993, includes the sub-para (d) of the para 2 which states "flourishing of genuine multiparty democracy system"; the para 3 which states, "the State | said, "The subpara (a) of para 2 of the adopted practises genuine multiparty democracy system" and para 28 which states "the State shall enact necessary law for systematic formation of political parties for flourishing of genuine multiparty democracy system.'

But sub-para (a) of para 2 of the adopted detailed basic principles for the chapter "Political Parties" states "A political party shall: (a) accept and practise discipline-flourishing genuine multiparty democracy".

Hence, delegates should discuss whether to use "discipline-flourishing genuine multiparty democracy" instead of genuine multiparty democracy in para 2 subpara (d), para 3 and para 28 of the Chapter "State Fundamental Principles".

#### Esteemed delegates,

Regarding the explanation, National Unity Party



detailed basic principles for the chapter "Political Parties" states "A political party shall accept and practise discipline-flourishing genuine multiparty democracy." The expression emphasizes in all seriousness that the democracy Myanmar will practise in the future is a discipline-flourishing genuine multiparty democracy system. In our view, there should be a contextual uniformity in drafting the Constitution.

Hence, the usage "discipline-flourishing genuine multiparty democracy" prescribed in para 2 subpara (d), para 3 and para 28 of the Chapter "State Fundamental Principles" should be "discipline-flourishing genuine multiparty democracy".

Union Pa-O National Organization said, "Of the

basic principles and detailed basic principles, the Work Committee chairman explained eight points for addition, five points for amendment, one point for repeal, and one point for transfer totalling 15 points. We support that these 15 points should be added, amended, repealed or transerrred".

Shan State Kokang Democratic Party said, "The expression "genuine multiparty democracy system" contained in para (b), sub-para 4 (c) and (d) should be "discipline-flourishing genuine multiparty democracy".

Mro or Khami National Solidarity Organization said, "In laying down the State Fundamental Principles, it is stated "flourishing of genuine multiparty democracy system"; and "the State practises genuine multiparty democracy system". But subpara (a) of para 2 of the adopted detailed basic principles for the chapter "Political Parties" states "A political party shall: (a) accept and practise discipline-flourishing genuine multiparty democracy." We need a uniforrmed context in drafting the Constitution.

Hence, we would like to suggest to use "discipline-flourishing genuine multiparty democracy" instead of "genuine multiparty democracy" in para 2 subpara (d), para 3 and para 28 of the Chapter "State Fundamental Principles".

Lahu National Development Party said, "We agree that the expression "discipline-flourishing genuine multiparty democracy" instead of genuine multiparty democracy should be used in para 2 subpara (d), para 3 and para 28.
