### Turning out national race technicians

The government has been building social and economic infrastructures for development of border areas. At the same time, it is implementing plans for development of human resources.

The government is nurturing students to become intellectuals and intelligentsia with high efficiency in the border areas. Nationalities Youth Resource Development Degree Colleges were opened in Yangon and Mandalay in 2000. The colleges have now produced over 500 graduates.

Twenty seven border areas national race youth technical training schools were opened for youths in the border areas to possess technical know-how and to turn out skilled workers needed in the implementation of urban and industrial projects.

Now youth technical training schools have been opened in Sittway, Laukkai, Pangsang and Mongla. Food and accommodation are provided free of charge to the national race youths who can study with the aid of modern equipment.

The youths can earn their living with the knowledge of carpentry, masonry, mechanics, welding and maintenance of motor vehicles learned at the schools.

It is believed that in the future national race youths will become national technicians with high efficiency with the training of the technical schools and the government's encouragement.

**US foreign policy experts oppose Bush's surge**

WASHINGTON, 20 Aug—More than half of top US foreign policy experts oppose President George W Bush's troop increase as a strategy for stabilizing Baghdad, saying the plan has harmed US national security, according to a new survey.

As Congress and the White House await the September release of a key progress report on Iraq, 53 per cent of the experts polled by *Foreign Policy* magazine and the Centre for American Progress said they now oppose Bush's troop build-up.

That is a 22-percentage point jump since the strategy was announced early this year.

The survey of 108 experts, including Re-

publicans and Democrats, showed opposition to the so-called "surge" across the political spectrum, with about two-thirds of conservatives saying it has been ineffective or made things worse in Iraq.

*Foreign Policy*, published by the Carnegie Endowment for International Peace, said the experts polled on 23 May to 26 June included former government officials in senior positions including Secretary of State, White House National Security Adviser and top military commanders.

The findings were published in the form of a Terrorism Index in the magazine's September/October issue, to be released on Monday. The

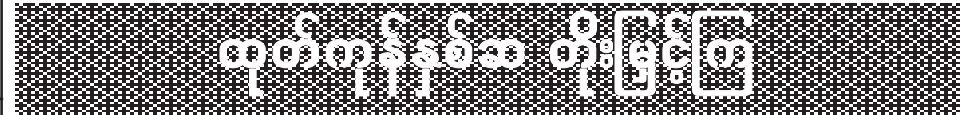
magazine published similar indices in July 2006 and in February.

Bush has deployed 30,000 additional US forces in and around Baghdad to quell sectarian violence in a bid to foster political reconciliation between Iraqi's Sunni, Shiite and Kurdish communities.

The strategy was announced early in the year but US forces did not reach their intended strength in Baghdad until mid-June.

US Ambassador to Iraq Ryan Crocker and the top US Commander in Iraq, General David Petraeus, are due next month to provide Congress with a progress report that could prove vital in determining how long US troops stay.

**Missing miners' families blast rescue effort**

HUNTINGTON, 19 Aug—Families of the six miners trapped for nearly two weeks in the collapse of a Utah coal mine blasted officials in charge of the rescue effort Sunday, accusing them of having "given up" on the missing men. In a statement read by a spokesman, the families urged the mine's owner and federal officials

to drill a hole into the mine large enough to send down a rescue capsule.

"Precious time is being squandered here, and we do not have time to spare," the spokesman, Sonny Olsen, said on behalf of dozens of relatives who faced cameras Sunday

evening. The families expressed their sorrow for the loss of three rescuers who were killed in a rescue effort Thursday. But they said they still held out hope "that our loved ones are still alive and are waiting to be rescued." —Internet

**More remains found Sunday from bridge collapse**

MINNEAPOLIS, 19 Aug—More human remains were recovered Sunday from the site in the Mississippi River where a bridge collapsed this month, bringing the confirmed death toll to 12, authorities said.

The Hennepin County Sheriff's Office, which is leading recovery efforts, said water recovery teams recovered human remains and a vehicle at the site of the I-35W bridge collapse at 8:30 am (9:30 am ET).

The Medical Examiner identified the remains as Scott Sathers, 30, from Blaine, Minn. —Internet

**Israeli troops kill two Palestinians in West Bank raid**

JENIN (West Bank), 19 Aug—Israeli troops killed two Palestinians and wounded six others during a raid near the West Bank city of Jenin on Friday, Palestinian sources said.

Palestinian security officials said that a gun battle broke out between Israeli troops and local gunmen in the village of Kafr Dan. One gunman and a 16-year-old boy were killed. —MNA/Reuters

**NATO soldier killed while escorting convoy in southern Afghanistan**

KABUL, 19 Aug—A NATO soldier escorting a convoy in southern Afghanistan was killed on Sunday, a statement from NATO's International Security Assistance Force said.

The statement did not specify the exact location where the soldier was killed or how the death

occurred. In addition, ISAF withheld the announcement of the soldier's nationality pending notification of next of kin.

"Our thoughts and condolences go out to the friends and family of the soldier who has been killed today," said ISAF spokeswoman Lt Col Bridget Rose. —Internet

**Carbon monoxide leak near Virginia Tech sends 17 to hospitals**

BLACKSBURG, 19 Aug—A carbon monoxide leak in an apartment building near Virginia Polytechnic Institute sent 17 people to the hospital Sunday as the school scarred by an April massacre prepared to start a new semester, a hospital spokeswoman said.

Montgomery Regional Hospital spokesman Suzanne Barnette said two of the patients were transferred to the University of Virginia Hospital and three to

Duke University Medical Center. The 12 remaining at Montgomery were in stable condition, she said.

The leak was reported in the Collegiate Suites apartments around noon, the same time that a dedication ceremony was being held to honor 32 students and faculty shot dead last April by a student who then killed himself, said Mark Owczarski, director of university relations.

## The Hluttaw to be formed with Hluttaw representatives elected on the basis of township as well as on the basis of population

YANGON, 20 Aug— *The following is the compilation presented by member of the Panel of Chairmen of the Plenary Session of the National Convention U Tin Kha of Delegate Group of State Service Personnel on suggestions made by Delegate Groups on matters concerning the amendments, the additions and the repeals and the transfer out of the fundamental principles and detailed basic principles that have been adopted by the National Convention.*

### Esteemed delegates,

At the plenary session held on 6 August 2007, the Work Committee chairman adopted the detailed basic principles regarding the Formation of Pyithu Hluttaw laid down at the plenary session of the National Convention held on 28 March 1996. They are:

**“Pyithu Hluttaw shall be formed with a maximum of 440 Hluttaw representatives as follows:**

- (a) **Not more than 330 Hluttaw representatives elected on the basis of population.**
- (b) **Not more than 110 Tatmadaw member Hluttaw representatives nominated in accord with law by the Commander-in-Chief of the Defence Services”.**

As the Pyithu Hluttaw is termed as the Hluttaw formed with Hluttaw representatives elected on the basis of population, the election of Pyithu Hluttaw representatives will have to be based on population. If the Constitution has a principle saying that election should be based on population, it will be not possible to elect one representative each from every township.

If the election of the Pyithu Hluttaw representatives is based on population, Regions will be able to elect 237 representatives and they will have 31 more representatives; and the States will be able to elect only 93 representatives and they will have 31 less representatives.

If the election of the Pyithu Hluttaw representatives is based on population and township, Regions will be able to elect 206 representatives and the States, 124 which is plus 31.

According to the adopted detailed basic principle, population-based constituencies have been designated for the formation of the Pyithu Hluttaw and not more than 330 Pyithu Hluttaw representatives must be elected.

When the total number of townships exceeds 330, the number of Pyithu Hluttaw representatives will also exceed 330, if one representative from each township is elected.

So, when the number of townships goes over 330, a newly formed township should be joined with one of the townships adjacent to it to designate a Pyithu Hluttaw constituency. The 330 Pyithu Hluttaw representatives will be elected one each from every such designated constituency.

Here, concerning the formation of the Pyithu Hluttaw:

**“Pyithu Hluttaw shall be formed with a maximum of 440 Hluttaw representatives as follows:**

- (a) **Not more than 330 Hluttaw representatives elected on the basis of township as well as on the basis of population from constituencies designated in accord with the law after combining a newly formed township with one of the suitable townships adjacent to it if the total number of townships exceeds 330**
- (b) **Not more than 110 Tatmadaw member Hluttaw representatives nominated in accord with law by the Commander-in-Chief of the Defence Services”.**

Mro or Khami National Solidarity Organization said the points the Work Committee chairman had explained in relation to formation of Pyithu Hluttaw should be adopted as detailed basic principles.

Lahu National Development Party suggested the points the Work Committee Chairman had explained regarding the formation of Pyithu Hluttaw should be adopted as detailed basic principles.

Union Kayin League said the points the Work Committee chairman had explained in relation to formation of Pyithu Hluttaw should be adopted as detailed basic principles.

Kokang Democracy and Unity Party said, “We are in support of amending, adding suitable words to, and repealing some necessary basic principles and detailed principles the Work Committee chairman explained”.

Wa National Development Party said that regarding formation of Pyithu Hluttaw the points the Work Committee Chairman had explained should be adopted as detailed basic principles.

## The word “the respective” should be added to the word “Union territories” for the usage to be more precise

YANGON, 20 Aug— *The following is the compilation presented by member of the Panel of Chairmen of the Plenary Session of the National Convention Dr Ma Nan Tu Ja of Delegate Group of Other Invited Persons on suggestions made by Delegate Groups on matters concerning the amendments, the additions and the repeals and the transfer out of the fundamental principles and detailed basic principles that have been adopted by the National Convention.*

### Esteemed delegates,

At the plenary session held on 6 August 2007, the Work Committee Chairman said, “At the plenary session of the National Convention held on 28 March 1996, I have explained the adoption of detailed basic principles for the Chapter “Formation of Legislature.”

Concerning the Amyotha Hluttaw, I have explained as follows:

“Amyotha Hluttaw shall be formed with a maximum of 224 Hluttaw representatives, as follows: (a) 168 Amyotha Hluttaw representatives elected in equal numbers of 12 from each region or state inclusive of Union territories, and including one representative from each self-administered division or self-administered zone

(b) 56 Tatmadaw member Amyotha Hluttaw representatives nominated by the Commander-in-Chief of Defence Services in accord with law at the rate of four representatives from each region or state inclusive of Union territories.”

The expression “inclusive of Union territories” means areas that were included in the present states and divisions but have been designated as Union territories and the areas proclaimed by the Pyidaungsu Hluttaw as Union territories because of their significant characteristics after the promulgation of this Constitution. The word “the respective” should be added to the word “Union territories” for the usage to be more precise.

Hence, delegates will have to decide whether the abovementioned detailed basic principle should be amended as follows:

**“Amyotha Hluttaw shall be formed with a maximum of 224 Hluttaw representatives, as follows:**

(a) **168 Amyotha Hluttaw representatives elected in equal numbers of 12 from each region or state inclusive of the respective Union territories, and including one representative from each self-administered division or self-administered zone.**

(b) **56 Tatmadaw member Amyotha Hluttaw representatives nominated by the Commander-in-Chief of Defence Services in accord with law at the rate of four representatives from each region or state inclusive of the respective Union territories.**

(c) **In forming the Amyotha Hluttaw in accord with the subparas (a) and (b), the words “the respective Union territories” mean Union territories designated by this Constitution and Union territories proclaimed by Pyidaungsu Hluttaw after enacting laws concerning the matter to elect Amyotha Hluttaw representatives are inclusive in the**

Lahu National Development Party said that the detailed basic principle concerning the formation of Amyotha Hluttaw should be adopted in accord the clarification of the Work Committee Chairman.

Union Kayin Leagues agreed to the adoption of the detailed basic principle concerning the formation of Amyotha Hluttaw in accord the clarification of the Work Committee Chairman.

Kokang Democracy and Unity Party said, “we agree to the amendments, additions and repeals made to few detailed principles and facts as explained by the Work Committee Chairman.”

# The designation of Yangon as a Union territory under direct administration of the president should be revoked

YANGON, 20 Aug— *The following is the compilation presented by member of the Panel of Chairmen of the Plenary Session of the National Convention U Myo Thant (Maung Hsu Shin) of National Convention Convening Work Committee on suggestions made by Delegate Groups on matters concerning the amendments, the additions and the repeals and the transfer out of the fundamental principles and detailed basic principles that have been adopted by the National Convention.*

**Esteemed delegates,**

At the plenary session of the National Convention held on 6 August 2007, the Work Committee Chairman said, “Regarding the designation of Union territories, the National Convention plenary session held on 9 April 1994 laid down detailed basic principles:

5. Designation of Union territories—

- “(a) **Yangon City, that is the Capital of the Union, is designated as Union territory placed under direct administration of the President of the Union.**
- (b) **Cocogyun Township which has a special situation is designated as Union territory and placed under direct administration of the President of the Union,**
- (c) **if need arises to designate areas that have special situation in connection with national defence, security, administration and economy etc. as Union territories they may be so designated as Union territories after enacting laws.”**

Internationally, the city where the office of the central government is based is designated as the capital of the State. And in some countries, the capitals are placed under direct administration of the President or the Union. Now, the government of the Union of Myanmar and the offices of the central governments are based in Nay Pyi Taw. So, the capital of the State is Nay Pyi Taw. Therefore, need arises to amend the words “Yangon City, that is the Capital of the Union” prescribed in one of the three above-mentioned detailed basic principles. Yangon is not the capital of the nation any longer, but it remains a commercial city.

The designation of Yangon as a Union territory under the direct administration of the president should be revoked. And the municipal area of Nay Pyi Taw, which has become the Capital of the State, should be designated as a Union territory placed under the direct administration of the president.

Yangon is no longer the Capital of the State, so the term “Capital Yangon” will be replaced with the term “Yangon”. Moreover, the detailed basic principle “Cocogyun Township which has a special situation is designated as Union territory and placed under direct administration of the President of the Union” should be revoked. The designation of Yangon and Cocogyun Township as Union territories is revoked, so, they will remain in Yangon Region.

“As I have presented that by revoking the designation of Cocogyun Township as a Union territory, the detailed basic principle of the sub-para (b) no longer needs to be prescribed. However, sub-para (c) should still exist. So, sub-para (c) should be sub-para (b). Therefore, discussions are to be held and suggestions, to be made to decide whether or not the detailed basic principle:

- “(a) **Nay Pyi Taw, that is the Capital of the Union, is designated as Union territory placed under direct administration of the President of the Union.**
- (b) **if need arises to designate areas that have special situation in connection with national**

**defence, security, administration and economy etc. as Union territories they may be designated as Union territories after enacting laws” should be adopted.”**

**Esteemed delegates,**

## Kidnapped German woman freed in Afghanistan

KABUL/BERLIN, 20 August — A German woman abducted by gunmen in Afghanistan has been freed, the German Foreign Ministry said on Sunday hours after she appeared in a video asking Berlin to use every effort to gain her freedom.

Christina Barbara Meier, an aid worker, had been seized from a Kabul restaurant while having lunch with her husband on Saturday. Her kidnapping was the first of a Westerner in the Afghan capital for more than two years.

"The kidnapped woman is now at the

German Embassy," a German Foreign Ministry spokeswoman said.

In the video, the blonde aid worker had worn a long headscarf and a red local outfit and read from a note in Dari.

"I am fine I ask my country to urgently help and cooperate for my release," she had said in the video aired by private television station Tolo, adding she was an employee of "ORA International" aid agency.

A bespectacled young man who had covered his face appeared on the video to say the abductors were

not Taleban, adding they belonged to a "special network".

He demanded the release of the group's men held by President Hamid Karzai's government. He did not give any figure or names, adding details would be passed to the government through special channels.

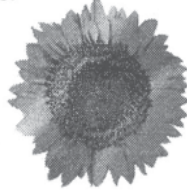
The Afghan Interior Ministry said the abductors were not Taleban guerillas who have seized more than 30 people, many of them foreigners, in several parts of the country in recent weeks.

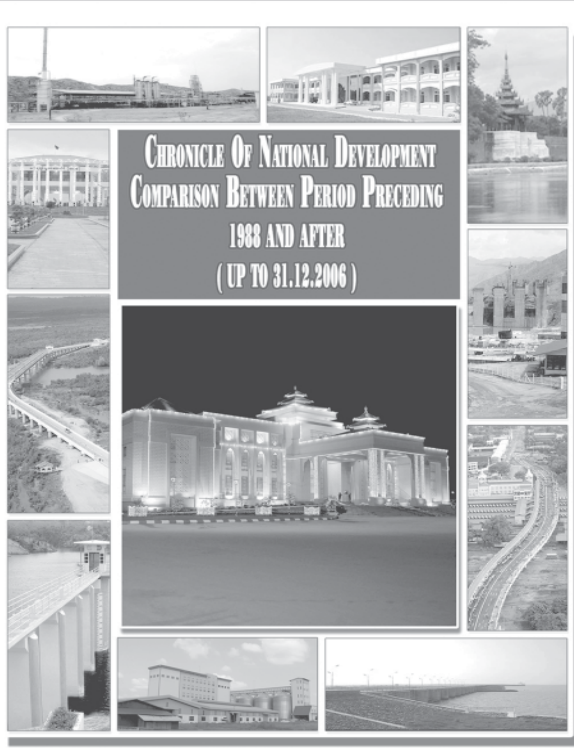

**Nine killed by tornado in east China**

WENZHOU, 20 Aug—Nine people were killed as a tornado hit east China's Zhejiang Province, according to local sources on Sunday.

A gale belt of 800-metre broad and eight-kilometre long swept through the Longgang Township, Cangnan County of Wen-

zhou City at about 11:30 pm Saturday from the sea, according to local meteorological bureau. The tornado toppled down 156 houses. More than 60 local people were injured in the mishap, with eight described as "in serious condition".

"The 'bizarre wind' smashed all the windows of our four-storey building and tore down my mom's old house in no more than one minute, just like a hurricane," recalled 48-year-old villager Zhang Zhongling, who is under medical treatment together with his wife and mother in hospital.

Experts believe that the tornado was formed under the influence of typhoon Sepat that churned ashore in Chongwu Town, Hui'an County of Fujian Province early Sunday morning.

**Southern Africa launches peacekeeping brigade**

LUSAKA, 19 Aug—Southern African leaders launched a peacekeeping brigade on Friday as part of a planned African standby force to be deployed on peace missions and to tackle disarmament and humanitarian crises on the continent.

Zambian President Levy Mwanawasa officially launched the brigade, inspecting troops in front of regional heads of state at a summit of the 14-member Southern African Development Community (SADC) in Lusaka.

Cannons were fired and fighter jets screamed overhead. "The SADC brigade shall ... serve in peacebuilding efforts including post conflict disarmament and demobilization and humanitarian assistance to alleviate the suffering of civilian populations in conflict areas and support efforts on major natural disasters," Mwanawasa, the new SADC chairman, said. The peacekeeping brigade, part of an Africa-wide effort to form an operational standby force by 2010, is expected to deploy in areas for a "limited duration", with a mandate from the United Nations, African Union or SADC.— MNA/Reuters

**UNICEF calls for aid to most affected by DPRK floods**

GENEVA, 19 Aug—The United Nations Children's Fund (UNICEF) highlighted on Friday the needs of children affected by massive flooding across the Democratic People's Republic of Korea (DPRK), saying international aid is needed to help the most vulnerable.

Over 350,000 people in DPRK have had their houses destroyed or damaged, with 221 dead, UNICEF said in a statement. "In addition to the loss of life, the damage caused by floods to agriculture and infrastructure is really a big blow to the already precarious situation for most of the population of DPRK," said Michel Le Pechoux, UNICEF's deputy representative to DPRK.

### Psychologists weigh interrogation ban

SAN FRANCISCO, 20 Aug — Stung by reports implicating mental health specialists in prisoner abuse scandals at Guantanamo Bay and Abu Ghraib, the nation's largest group of psychologists is considering banning its members from interrogations of terror suspects.

The American Psychological Association, which is holding its annual meeting in San Francisco, is scheduled to vote Sunday on two competing measures concerning its 148,000 members' participation in military interrogations at Guantanamo Bay and other US military detention centres.

One measure would bar members from any involvement in interrogations at US detention facilities where foreign-

ners are held. The moratorium would not be backed by sanctions, but it would carry the APA's "moral authority," said psychologist Neil Altman, who wrote the proposed resolution.

The other proposal, which is backed by APA's board of directors, would reaffirm the group's opposition to torture and prohibit members from taking part in more than a dozen specific practices, including forced nakedness, mock executions and simulated drowning.

An APA member who violates the torture resolution could be expelled from the Washington-based organization, which could lead to the loss of the professional's state license to

practice, said spokeswoman Rhea Farberman.

A recently declassified Defence Department report said that since 2002, psychiatrists and psychologists have helped military interrogators develop new techniques to extract information from detainees.

Psychologists for an Ethical APA, which supports the moratorium, rallied Friday outside the Moscone Centre, where the conference is being held.

Supporters wore buttons that read "Do No Harm" and carried signs condemning torture.

### Report: Rowling writing detective novel

LONDON, 20 Aug — JK Rowling has been spotted at cafes in Scotland working on a detective novel, a British newspaper reported Saturday.

The Sunday Times newspaper quoted Ian Rankin, a fellow author and neighbour of Rowling's, as saying the creator of the "Harry Potter" books is turning to crime fiction.

"My wife spotted her writing her Edinburgh criminal detective novel," the newspaper, which was available late Saturday, quoted Rankin as telling a reporter at an Edinburgh literary festival.

"It is great that she has not abandoned writing or Edinburgh cafes," said Rankin, who is known for his own police novels set in the historic Scottish city. Rowling famously wrote initial drafts of the Potter story in the Scottish city's cafes. Back then, she was a struggling single mother who wrote in cafes to save on the heating bill at home.

Now she's Britain's richest woman — worth \$1 billion, according to Forbes magazine — and her seven Potter books have sold more than 335 million copies worldwide.

In an interview with The Associated Press last month, Rowling said she believed she was unlikely to repeat the success of the Potter series, but confirmed she had plans to work on new books.

"I'll do exactly what I

did with Harry — I'll write what I really want to write," Rowling said.

The office of Rowling's literary agent, Christopher Little, was not immediately available to comment late Saturday. —Internet

### Pet camel kills woman in Australian outback

SYDNEY, 20 Aug — A pet camel given as a birthday present killed a 60-year-old woman in Australia's remote outback in a bizarre attack, police said Sunday.

The young male camel

had been hand-reared by the woman and still drank out of a bottle, but had a history of unusual behaviour and had previously attempted to smother the family's pet goat by sitting on it.

Police said the 10-month-old animal on Saturday knocked the woman to the ground, stomped on her head and then lay on her at her sheep and cattle property near Mitchell in Queensland state, about 600 kilometres (360 miles) west of the state capital Brisbane.

The woman's husband found her body in the evening on returning from feeding stock and was devastated, police said.

"The camel was actually a 60th birthday present that he and his daughter got her in March," said Detective Senior Constable Craig Gregory from the nearby town of Roma.

"She had a love of exotic pets."

Camel expert Paddy McHugh said the behaviour was unusual for such a young animal and was more characteristic of a bull in season, which might use such behaviour to kill its opposition.

The woman's name has not been released.

### Helicopters pluck flood victims to safety in central Oklahoma

OKLAHOMA, 20 Aug — Remnants of Tropical Storm Erin turned central Oklahoma into a wash

basin Sunday, with helicopter-borne rescuers plucking people from flood waters and roof

Two people died and at least two others were hurt, said Michelann Ooten, a spokesman for the state's emergency operations centre in Oklahoma City.

## Benitez, Mourinho in verbal spat after 1-1 draw

LIVERPOOL (England), 20 Aug — Jose Mourinho and Rafael Benitez were involved in a verbal spat on Sunday after Chelsea held Liverpool to a 1-1 draw at Anfield.

Chelsea got a barely deserved point when referee Rob Styles awarded them a second half penalty after Florent Malouda fell into the unlucky Steve Finnan.

Frank Lampard converted the spot kick in the 62nd minute to cancel out Fernando Torres' well-taken first half goal, scored on his home debut.

Liverpool captain Steven Gerrard said he felt the referee had been intimidated by Chelsea's players and had "cracked". Blues manager Mourinho defended his players by calling them "pure" before Benitez questioned that statement.

After being told of Gerrard's comments, Mourinho said: "I think I have a naive team because we don't have divers, don't have violent people, nasty tacklers and don't have people diving in the swimming pool. Chelsea are a pure and naive team." — MNA/Reuters

## Henin defeats Jankovic to win Toronto Cup

TORONTO, 20 August — World number one Justine Henin warmed up for the US Open by taming third seed Jelena Jankovic 7-6, 7-5 to capture her second Toronto Cup on Sunday.

Playing her first tournament since losing in the semifinals at Wimbledon, the 25-year-old Belgian was quickly back to her best and lifted her sixth title in 2007. She raced through the 1.3-million-US-dollar event without dropping a set.

A near capacity centre court crowd was treated to a display of high-quality tennis as Henin continued her domination over Jankovic and improved her head-to-head record against the Serb to 7-0.

## Sevilla crush Real Madrid to take Super Cup

MADRID, 20 Aug — Sevilla got the new season off to a glittering start when they claimed their fifth trophy in a little over a year after a 5-3 win over Real Madrid in the second leg of the Spanish Super Cup at the Bernabeu on Sunday.

A hat-trick from leading striker Frederic Kanoute and a double from Brazilian midfielder Renato earned Juande Ramos' side a 6-3 aggregate victory over the Spanish champions.

Sevilla have won back-to-back UEFA Cups, the King's Cup and the European Super Cup in the space of the last 15 months.

Real, who have overhauled their squad since Fabio Capello was sacked after steering the team to the league title last season, looked ragged throughout and new coach Bernd Schuster will have plenty to do before the league begins next week. It was the second time that Schuster has fallen victim to Sevilla at the Bernabeu in the last two months. The German's former club Getafe lost to the Andalucians in the final of the King's Cup in June. — MNA/Reuters

Bothered by a sore right shoulder that flared up during her semifinal win over China's Yan Zi on Saturday, Henin had warned officials that there was only a 50/50 chance she would play.

After receiving intensive treatment on the sore joint early on Sunday, the six-times Grand Slam winner managed to walk out for the match.

When Miroquesada emerged from beneath his table after the ground had stopped heaving, a dense cloud of damp, muddy dust was all that was left of San

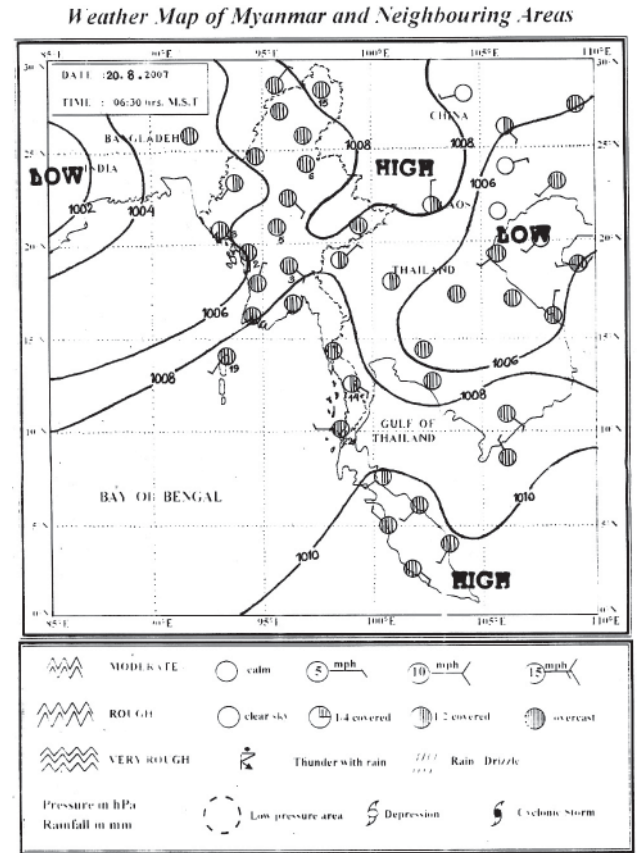
Clemente's main chapel.

"It happened just as the mass was ending, at the point when all the participants move to the front to greet the grieving relatives," said the white-haired priest.

"I would take a wild guess that about 100 people died in there because there were roughly 200 in the chapel," he said.

Rescue workers had pulled 70 bodies from the ruins of San Clemente by late on Friday. Even though they pulled a man alive from the same wreckage 24 hours after the quake, they were not hopeful about finding more survivors.
