Myanmar eyes 2 million tons of rice exports in 2015-16 FY

Yangon, 19 May — Myanmar's rice exports will hit roughly 2 million tons this fiscal year amid increasing demand from China, Africa and Europe, according to the Myanmar Rice Federation.

Exporters are sending roughly 4,000 tons a day by road to China following a surge in demand from the neighbouring country, Kyemon Daily. After three consecu-

tive years of high export volume — 1.4 million tons in fiscal 2012-2013, 1.2 million tons in 2013-2014, and 1.8 million tons in 2014-2015 — Myanmar is looking to become one of the world's top three rice exporters in the next few years.

Myanmar's roughly 1.8 million tons of rice ex-

according to the state-run ports in 2014-2015 marked a 49-year high, while the 1.4 million tons exported in 2012-2013 was a 74-year high, according to the Ministry of Commerce.

Myanmar's fiscal year begins on April 1 and ends on May 31.

The agro-based economy has seen a dramatic increase in agricultural exports, earning some US \$2.7 billion in fiscal 2014-2015, up from around US

\$1.8 billion the previous year.

According to Ministry of Commerce figures, Myanmar's corn exports have increased from some thousands of tons before fiscal 2012-13 to more than 1 million tons in 2012-2013 and 2013-2014, respectively, and more than 1.8 million tons in the 2014-2015. Meanwhile, export

volumes of fruits, sesame, beans and pulses in fiscal 2014-2015 also increased.

Myanmar mostly exports agricultural produce, animal by-products and fishery products, as well as mine and forest products, while it imports consumer products, raw materials and investment goods.

The government is planning to implement the National Export Strategy, which focuses on seven sectors - rice, peas and pulses, fisheries products, textiles, timber and forest products, rubber, and tourism in an attempt to tackle the trade deficit, which stood at roughly US \$5 billion in 2014-2015, according to the Ministry of Commerce.

Against this backdrop, Myanmar is making 3. serious efforts on the prevention of smuggling and illegal migration. One such activity is the regular patrolling in Myanmar territorial water by the Myanmar Navy and Air Force to deter any illegal trespassing in the territory and to provide safety for the trespassers, if any, in the sea. Myanmar stands ready to provide humanitarian assistance to anyone who suffered in the sea.

4. Preventive measures on human smuggling and illegal migration are being implemented throughout the nation. Likewise, the Rakhine State Government and concerned departments are endeavoring diligently to prevent illegal migration by sea. Measures are also in place to maintain rule of law and security for all individuals there.

Myanmar has been extending its full co-5. operation with countries in the region in regional mechanisms including the Bali Process on People Smuggling, Trafficking in Persons and Related Transnational Crime. Myanmar is fully prepared to work with the international community, on humanitarian ground, to alleviate the sufferings of the smuggled victims.





In his welcome address, Vice President U Nyan Tun said the conference provides opportunities to share ideas about environmental conservation and the formulation of a regulatory mechanism to develop the ecotourism sector.

Myanmar recognizes the potential for growth in the sector and is developing its tourism policies accordingly, the Vice President said, adding that ecotourism development is included in the government's strategy to develop a green economy.

The policy includes expanding the country's protected network of areas, and aims to establish a diversity of range of quality ecotourism products and services by 2020.

The Myanmar Ecotourism Policy and Management Strategy, developed with technical collaboration from the

International Centre for Integrated Mountain Development (ICIMOD), and supported by the European Union and the GMS-Environment Operation Centre, has six strategic programmes for the development of the country's ecotourism sector.

They include the strengthening of institutional arrangements, research, and monitoring marketing frameworks, and interpretation, development of ecotourism management plans, investment in infrastructure and establishment of responsible business models.

With significant progress since 2012, Myanmar's tourism industry is growing at an impressive pace. The country received 3.081 million visitors in 2014, a 51 percent increase over the previous year, and welcomed 909,510 during the first three months of this year.

Founding members of China-backed AllB to meet in Singapore

SINGAPORE, 19 May — Representatives from the 57 prospective founding members of the China-backed Asian Infrastructure Investment Bank will meet in Singapore from Wednesday, Singapore's Finance Ministry said on Tuesday.

The three-day meeting of chief negotiators will be co-chaired by Shi Yaobin, vice minister of China's Ministry of Finance, and Yee Ping Yi, deputy secretary of Singapore's Ministry of Finance, the ministry said in a statement.

"The meeting will discuss the draft Articles of Agreement (AOA) and operational policies for the AIIB," it said.

The AIIB was proposed by China in 2013, and in October last year representatives from 21 Asian countries signed the Memorandum of Understanding on Establishing the AIIB.

Currently, a total of 57 countries, including some Group of Seven major countries, announced their plans to participate in the AIIB, while the United States and Japan, the world's largest and third largest economies, respectively, have stayed out of the project.

This will be the fifth chief negotiators' meeting, with the fourth held just last month in Beijing.

J Soedradjad Djiwandono, professor of international economics at the S Rajaratnam School of International Studies at Singapore's state-run Nanyang Technological University, said Asia's emerging economies are in dire need for infrastructure to narrow the infrastructure gap among them.

He said the meetings will have to decide on issues such as capitalization and management issues

Ma Tieying, an economist in the group research unit at DBS Bank, said, "The bank hasn't been fully established, so key issues are the contribution of the fund or capital, (and) the percentage of share of capital contribution for individual countries."

She added that the officials will have to discuss and decide "on governance of the new investment bank, the voting power of individual members and their influence on investment projects, the financing process, and also manpower and how to set up the recruitment process."—Kyodo News

Thai Prime Minister Yingluck Shinawatra insisted on her innocence on Tuesday as she went on trial at the Supreme Court for allegedly mismanaging a rice subsidy programme that cost the country billions of dollars.

Before entering the courtroom, Yingluck briefly told reporters that she is "ready to clarify and defend" herself at the trial, which could see her jailed for up to 10 years if convicted, and that she hopes the court will "deliver justice.'

After Yingluck heard the charge against her and declared her innocence in court, the judges opted not to detain her. She was released on bail on condition that she not travel abroad without their permission.

The next hearing was set for 21 July

Supporters of Thailand's first female leader, who claim the case against her is politically motivated, appeared at the venue to provide her with moral support and a bunch of red roses.

In denying the accusations against her, Yingluck has said that as prime minister between August 2011 and May 2014, she adhered to the law, worked for the benefit of the Thai people, and implemented the rice-pledging scheme to "promote fairness in the market mechanism" and to "enhance the living standards of the rice farmers."

Critics say her government ran up huge bills when farmers were paid overly high rates for their rice and that it allowed the scheme to continue, despite acknowledging the losses, causing Thailand's financial situation to deteriorate.

Yingluck, 47, was unseated in May last year when the Constitutional Court ruled that she must step down for having abused her power as prime minister. The military seized power later the same month.

In January, junta-appointed parliamentarians formally impeached her and banned her from politics for five years.

Innovation Party elects Matsuno as new leader

Токуо, 19 May — Japan's second largest opposition party, the Japan Innovation Party, elected Yorihisa Matsuno as new leader on Tuesday following a failed administrative reform bid by the party's associated group in Osaka in Sunday's referendum.

At a general meeting of party lawmakers, Matsuno, who has been the party's secretary general, was approved as successor to Kenji Eda whose resignation was accepted earlier in the day at a meeting of party executives.

In the referendum, Osaka city residents rejected by a slim margin a plan to reorganize the city government into a metropolitan entity like Tokyo by merging its 24 wards into five districts — a policy Eda called his party's "point of origin."

The plan was the brainchild of high-profile Osaka Mayor Toru Hashimoto, the party's supreme

JAKARTA, 19 May — Indonesia's ambassador to Pakistan died on Tuesday, 11 days after he was injured in a helicopter crash in northern Pakistan that killed seven others, Indonesia's foreign minister said.

"The foreign ministry has lost one of its best diplomats," Indonesian Foreign Minister Retno Marsudi said.

The Pakistani government has said the helicopter crashed

because of engine failure, dismissing Pakistani Taleban claims that militants had shot it down. The Mi-17 helicopter crashed into an empty school while those on board were inspecting a tourism project.

Muhammad, who had be based in Islamabad since 2008, was taken to a hospital in Singapore for treatment after the 8 May crash. His body would be taken to the Indonesian city of Yogyakarta later on Tuesday, the foreign ministry said.

Pakistan has said 17 people were on board the helicopter. The ambassadors of Poland and the Netherlands were among the injured.—Reuters

NurOwn by BrainStorm gets fast-track approval for ALS treatment (Unique Israeli Experimental treatment)

Enhanced adult stem cells are being tested in major medical centres to slow progression of incurable neurodegenerative diseases.



JERUSALEM, 19 May The US Food and Drug Administration (FDA) has designated NurOwn, a unique Israeli experimental treatment for neurodegenerative diseases, as a "fast track" product — meaning it could find its way to the market more quickly than many other drug candidates.

NurOwn was developed by BrainStorm Cell Therapeutics based on a technique developed by Profs Daniel Offen and Eldad Melamed at Tel Aviv University for growing and enhancing stem cells harvested from patients' own bone marrow, rather than from controversial fetal stem-cell sources. The enhanced cells secrete elevated levels of nerve-growth factors that protect existing motor neurons, promote motor neuron growth and reestablish nerve-muscle interaction.

NurOwn isn't a cure for devastating neuromuscular conditions such as amyotrophic lateral sclerosis (ALS, or Lou Gehrig's disease), but in clinical trials conducted in Israel, it appears to ease symptoms and slow progression of such diseases. Advanced clinical trials

of NurOwn began in June 2014 at three major US medical centres, and Brain-Storm raised \$10.5 million in private investments. In July, BrainStorm was notified of the allowance of its US patent application, and the company began trading on NASDAQ in September.

Dr Tony Fiorino, the New York-based CEO of BrainStorm, says the fasttrack status "will allow us greater and more frequent dialogue with the [FDA] as we continue the development of this groundbreaking cell therapy for the treatment of ALS.'

According to the ALS Association, every year in the United States two in 100,000 people are diagnosed, usually between 55 and 65 years of age.

Promising results

Dr Dimitrios Karussis, head of Hadassah University Medical Centre's Multiple Sclerosis Centre in Jerusalem and a noted stem-cell transplant pioneer, conducted two initial trials on 24 patients. 'We are working on

analysis of the data, but we can say there is some positive effect," Karussis says. "In some of the parameters there was up to a 60 percent beneficial response after the treatment."

In addition to those trials, four ALS patients in an advanced stage of the disease received NurOwn transplants

at Hadassah, starting in 2012, as "compassionate use" cases, including Omri Chotam, a former paratrooper in his 20s, and octogenarian sage Rabbi Rafael Shmuelevitz.

"All four had, at least for three to six months, a response of improvement in respiratory function or muscle power," reports Karussis.

"The most impressive response was in the rabbi, who had a very severe and unique combination of ALS and myasthenia gravis. He improved substantially for about six months, started walking and speaking, and then the effects faded. Then we did a second injection and he had even more impressive improvement. This makes it highly unlikely to be a placebo effect, which is important to note."

Ordinarily, some 90 percent of ALS patients die of respiratory failure within three to five years after the onset of symptoms. As the disease progresses, they lose the ability to stand or walk, and have difficulty breathing because the muscles of the respiratory system weaken.

"According to the data we have, the treatment makes a beneficial change in the progression of the disease. This is the first step. We probably need to improve the protocol to do multiple injections for the longer term, and find the best way of administration in each individual patient."

Platform technology for several diseases

Karussis, who has now treated 30 patients with NurOwn, is collaborating and consulting with the multicenter US study approved by the FDA. This safety trial will involve a total of 48 patients in Massachusetts General Hospital, the University of Massachusetts

Memorial Hospital and the Mayo Clinic.

"Each of the three sites is headed by important leaders in the field of ALS," says Fiorino.

Three-quarters of the patients enrolled in the randomized, double-blind trial will receive NurOwn enhanced stem cells from their own marrow, and the remaining 12 will receive a placebo. The study is expected to be completed in early 2016, after which the results will be analyzed for safety and efficacy.

"This is really a platform technology with applications outside of ALS, though ALS is our lead indicator," Fiorino explains. "The cells can apply in any disease where neurons are dying." These

include multiple sclerosis and Parkinson's.

Fiorino acknowledges there are many companies in the stem-cell space. However, BrainStorm is the first to reach the clinical phase. What also makes it unique is its focused approach.

"Many other companies in the stem-cell space take a shotgun approach in which they use early stem cells that possess the potential to turn into many different cell types. By contrast, we have taken adult stem cells and converted them into factories that pump out growth factors known to promote the survival of neurons. Thus we know exactly where we want to use them; there are no mysteries."

Iran uses maritime confrontations to project power in Gulf

Ankara, 19 May— Iran is using its sea power in the Gulf to show it will not be cowed by Washington's newly assertive Arab allies, prompting critics to accuse Teheran of destabilizing the region.

Iranian ships fired shots at a Singapore-flagged tanker which it said damaged an Iranian oil platform, causing the vessel to flee, and seized a container ship in the Strait of Hormuz, the world's most important oil route, over a debt row.

The incidents coincided with a push by Washington to reassure Gulf Arab monarchies that their interests would not be threatened by a nuclear accord that Teheran and world powers are trying to reach by the end of June.

In an escalating confrontation with Saudi Arabia over Yemen, Teheran criticized Arab states for recklessness and brutality in that country, where a Saudi-led coalition is attacking

an Iranian-allied militia.

Iran has also sent an aid ship, the Iran Shahed, to the Yemeni Red Sea port of Hodaida to test a naval blockade enforced by the coalition. Several Iranian military officials have warned of war if the Iran Shahed is attacked by Saudi-led forces. It expected to reach the port by Thursday.

"Iran's recent measures in the Strait of Hormuz have one clear message to Saudi Arabia. No one can ignore Iran's key role," said an Iranian official, who asked not to be named due to the sensitivity of the issue.

"Whether reformist or hardliner, Iranian leaders have consensus on securing Iran's influence in the region," said the official. "They (the United States and its Gulf allies) don't expect a key regional power like Iran to remain silent over its aid ship being prevented from entering Yemen." Teheran and Riyadh have long been locked

in a proxy war, competing for regional supremacy from Iraq to Syria and Lebanon to Yemen, where Riyadh backs Yemen's exiled government against Iranian-backed Houthi rebels.

In a bold operation by Gulf Arab states, the Saudi-led coalition backed by the West on 26 March began pounding Houthi rebels and allied army units that control much of Yemen as well as inspecting all ships in a bid to stop weapons smuggling. Teheran denies training Houthi fighters and supplying arms, as claimed by Riyadh.

The standoff has intensified since the coalition declared that it had to inspect all aid for Yemen including that sent by Teheran.

Iran has been cautious about direct military confrontation with Saudi Arabia. "Riyadh is trying to drag Iran into a military conflict," said a senior Iranian security official.

"The Saudis are pursu-

ing a very dangerous path We are strong enough ... to confront them ... but we prefer political solutions, for now."

Iran's maritime operations have brought a new dimension to the stand-off between Teheran and Riyadh, and officials and analysts say they clearly mark a renewed drive to wield regional influence.

Last week five Iranian **Revolutionary Guard Corps** patrol boats fired shots at the Singapore-flagged Alpine Eternity oil products tanker in the Gulf, US officials said. It fled to safety in the United Arab Emirates' waters.

The Maritime and Port Authority of Singapore on Monday called on Iranian authorities to investigate the incident and "prevent future recurrences".

"Such interference with navigational rights is a serious violation of international law," the authority said.—Reuters

UN chief Ban to visit N Korea on **Thursday: source**

SEOUL, 19 May — UN Secretary General Ban Ki-moon is scheduled to visit an inter-Korean industrial park in North Korea's border town of Kaesong on Thursday, a source said on Tuesday.

Ban's visit to the Industrial Kaesong tion, will be the first by a leader of the world body. The industrial zone,

launched in 2004 with a combination of the North's cheap labor and the South's capital and technology, is the key source of revenue for North Korea.

Earlier in the day. Ban expressed hope of visiting North Korea at Friday.-Kyodo News

Athens sees EU deal soon, Greeks' approval of government stance dwindles

ATHENS, 19 May — Greece's labour minister said on Tuesday Athens would soon conclude a deal with its foreign creditors that could unlock further loans to the cash-starved country.

Greece's new government has been in talks with its European Union and International Monetary Fund lenders over the past four months about the release of around 7.2 billion euros (5 billion pounds) in aid.

Asked on Greek TV when Athens would reach the cash-for-reform deal, Labour Minister Panos Skourletis said: "De facto, in the coming days."

"There's a deadline, which is 5 June," he said the date on which Greece's next repayment of a loan to the IMF falls due. "We all know that if there is no solution, let's say until then, in relation to funding, things will be difficult.

Greece faces payments of about 1.5 billion euros to the IMF next month. It made its last repayment of about 750 million euros to the IMF last week by emptying a holding account at the Fund. Speaking on a late-night talk show on Monday, Finance Minister Yanis Varoufakis said the government hopes it can both make debt repayments and pay wages and pensions in June, but if it has

to choose, it will choose the latter.

The Greek government took power in January promising to end years of EU/IMF-imposed austerity that worsened a deep recession and pushed up unemployment and poverty. Not accepting cuts to pensions and wages is one of its so-called red lines.

The creditors, on the other hand, have been demanding Greece implement reforms, including pension cuts and labour market liberalisation. Talks on the conflict have been deadlocked.

They two sides are now getting closer to an understanding, the EU's monetary affairs chief, Pierre Moscovici, said on Monday. But the European Commission denied a report in a Greek newspaper the commission president, Jean-Claude Juncker, had made a new, more lenient proposal.

Most Greeks are unhappy with their government's negotiating strategy, a poll published late on Monday found.

According to the survey carried out on May 13-15 by the University of Macedonia, 41 percent of Greeks believe the governments negotiating strategy "is not stable and is therefore sometimes right and sometimes wrong." Thirty-five percent believed it was right, compared to 72 percent in February.

As many as 61 percent believe the government should water down its pre-election pledges given the circumstances, the poll said, compared with 35 percent who want them seen through. —*Reuters*

Hungary defuses 'suspicious package' on coach bound for Bulgaria

BUDAPEST, 19 May— Hungarian police said they defused a "suspicious package" on a coach carrying 34 Bulgarian and Romanian citizens from Prague to the Black Sea town of Varna through Hungary on Saturday.

The driver stopped the coach at a service area on the M0 motorway around Budapest after noticing the smell of chemicals, police said in a statement late on Monday.

It said the driver had found a suspicious package in the luggage compartment and called the police. A disposal squad defused the package on site, the statement said, adding that further checks were being made. No one was injured.

Police have begun an investigation, the statement said. Press officials declined to respond to further questions.—*Reuters*

French attack survivor Luz says he is leaving Charlie Hebdo

PARIS, 19 May — One of the few cartoonists to survive an Islamist militant attack on France's *Charlie Hebdo* journal is leaving the publication, saying he can no longer bear the pressure.

Renald Luzier, better known simply as Luz, announced his decision in an interview in Liberation, the newspaper that helped *Charlie Hebdo* publish again in the wake of an attack in which most of his cartoonist colleagues were killed. "Every print-run was torture because the others are no longer there," said Luz, who drew the cover picture on the first



post-attack edition of Charlie Hebdo but had recently declared he would no longer draw cartoons of the Prophet Mohammad because he was fed up with it. The pressure of work

in the wake of the attacks and media scrutiny were the main reasons he cited for the decision.

Mapping Mt St Helens magma progresses, 35 years after eruption

Portland, 19 May —

Early data collected in a pioneering effort to map the inner workings of Mount St Helens have provided promising initial insights, 35 years after a massive eruption by the Washington state volcano killed at least 57 people, scientists said on Monday.

Further progress is expected soon after readings are collected from more than 70 monitoring devices that ring the mountain, many at high altitudes, which have been inaccessible throughout the winter,

they said.

"It doesn't look the way we expected it to," Rice University geologist Alan Levander, who is involved in the research, said of the initial data, adding that with limited two-dimensional images collected so far it take several years for scientists to more fully understand what they are viewing.

Mount St Helens, which sits between Seattle and Portland, Oregon, erupted in an explosion of hot ash on 18 May, 1980, spewing debris over a wide

area, killing 57 people and causing more than \$1 billion in damage.

Now, through small quakes created via dynamite-triggered blasts that fire seismic waves through the volcano's interior, researchers are working to develop ultrasound-like images of molten rock within the volcano in a project that could improve warning systems.

The team, which includes researchers from universities and federal scientific agencies, aims to apply what it learns about the below-surface flow of molten magma to volcanoes in more populous areas, such as Mount Rainier, which overlooks Seattle.

Seismic activity and gas emissions already help geologists predict the timing of eruptions, but there are no good tools for predicting their size, said Kenneth Creager, a University of Washington seismologist involved in the study.

Mapping the flow and volume of magma from the earth's crust up through Mount St Helens' peak could change that, and ultimately help researchers anticipate large eruptions elsewhere, Creager said.

"It's difficult to tell how big an eruption might be. Knowing how much eruptible magma is down there may tell us," he said.

At the time of the 1980 blast, scientists had been monitoring a bulge and tracking mini-eruptions for several months, but had little understanding of the forces at work beneath the surface, said Carolyn Driedger, a US Geological Survey glacier hydrologist who was driving towards the volcano on the morning of the eruption.

A year ago, the US Geological Survey said magma levels were slowly rebuilding inside Mount St Helens, but there was no sign of an impending eruption.—*Reuters*

Let's Boost Cooperation with GIZ

N corporated as a public limited company under the auspices of the Ministry of Industry, the Small & Medium Industrial De-Bank velopment Ltd. (SMIDB) started its operations on February 15, 1996. The main objective for the establishment of the bank is to provide financial support to small and medium enterprises (SMEs) in the country and thereby to support the government's economic policy.

SMIDB is the sole bank in Myanmar focused on the SME sector. However, the bank operates as a mixed institute, i.e. it combines the elements of a commercial and a development bank. The vision of the bank is **to become a leading bank in SME financing. The bank has the following mission:**

Saudi-led air strikes hit Yemen's capital Sanaa: residents

CAIRO, 19 May — Saudi-led air raids hit the Yemen capital Sanaa overnight, targeting forces loyal to former President Ali Abdullah Saleh in the east and south of the city, residents said on Tuesday.

The strikes are the first to hit the capital after a fiveday ceasefire ended late on Sunday, although military operations resumed earlier on Monday in northern Saada province and in the southern city of Aden.

Saudi Arabia and its

Sunni Muslim allies have been conducting an offensive against Iranian-allied Houthis and units loyal to Saleh for more than seven weeks, part of a campaign to restore exiled President Abd-Rabbu Mansour Hadi to power.

The truce ended despite appeals by the United Nations and aid groups for extra time to allow badly needed humanitarian supplies into the country of 25 million people, one of the poorest in the Middle East.

Houthi sources also said they had fired mortar rounds at several areas in Saudi Arabia's southern Najran province late on Monday and that they had engaged in clashes with Saudi forces near the border area

Reuters could not immediately verify that information. Houthi rebels have been shelling some populated areas across the borders between Yemen and Saudi Arabia.

Burundi protesters gather in capital, defying threat of crackdown

BUJUMBURA, 19 May — More than 100 protesters chanted slogans against Burundi's President Pierre Nkurunziza and his bid for a third term in office on Tuesday in defiance of government threats of a crackdown on demonstrations.

"We will not stop unterm,"

shouted in the capital's suburb of Nyakabiga, a flashpoint during three weeks of unrest that have triggered fears of another bout of ethnic bloodletting in Africa's Great Lakes region.

Protesters say Nkurunziza's bid for five more years in power violates the til he gives up the third constitution and a peace the protesters deal that ended an ethni-

cally-fueled civil war in Burundi in 2005.

A group of generals, laying the same charge against the president, tried and failed to overthrow him last week. The government said late on Monday it would treat any future demonstrators as accomplices in the failed putsch.

But the protesters in

Bujumbura said they were against both Nkurunziza and the attempted coup.

"No to the coup, and no to the third term. We will continue until he says no to the third term," one of the demonstrators, who gave his name as Jean-Paul, told Reuters. He did not wish to give his last name, for fear of reprisals. Police and soldiers

watched the demonstration from the other end of the street. Burundi, an impoverished nation with a population of 10 million, is still recovering from its civil war that killed about 300,000 people.

Neighboring Rwanda, which shares a similar ethnic mix between a Hutu majority and Tutsi minority, suffered a genocide in 1994 genocide in which 800,000 people, mostly Tutsis and moderate Hutus, were killed. Nkurunziza says his participation in elections this year would not violate a two-term limit in the constitution, as his first term does not count, because he was appointed by parliament not chosen by a popular vote.

Judge sentences 11 Afghan police over lynching of woman in Kabul

KABUL, 19 May — An Afghan judge sentenced 11 police on Tuesday to one year in jail for failing to prevent the mob killing of a woman in Kabul who was accused of burning a Koran.

Judge Safiullah Mujadidi freed eight other officers accused of failure to carry out their duty for lack of evidence.

The lynching in March of the 27-year-old woman, named Farkhunda, sparked outrage and demonstrations in the Afghan capital even before it was revealed that she had not desecrated Islam's holy book.

It prompted rare protests against religious extremism and violence against women in Kabul.

Earlier this month, the same judge sentenced four men to death after they were convicted of murdering Farkhunda. Among

them was the caretaker of a local shrine who had accused her of burning the Koran and led the mob that beat her to death and set her body on fire.

Eight others were jailed for 16 years for participating in the attack.

Some of those arrested were tracked down after posting footage of the attack on social media and bragging about taking part.

Afghanistan remains a deeply conservative religious society where many frown on women in the public sphere, more than 13 years after the Taleban's hard-line Islamist regime was ousted.

Under the Taleban's five-year rule, women were banned from leaving home without a male guardian, denied education and forced to wear the all-covering burqa.

(Libya), Benghazi, 19 May — One person was killed and seven were wounded on Tuesday in a suicide bombing in the eastern Libyan town of Qubbah, a security official said.

Islamic State militants, exploiting a power vacuum amid conflict between two rival governments,

have built up a presence in Derna, a city to the east of Qubbah. But there was no immediate claim of responsibility.

A car packed with explosives hit a checkpoint in the east of the small town, the security official said.

Qubbah lies near the seat of the internationally recognized government, which has worked out of eastern Libya since losing the capital Tripoli to a rival group in August.

In February, militants loyal to Islamic State claimed responsibility for a car suicide bombing that killed 42 people in Qubbah in apparent retaliation for Egyptian air strikes following the killing of 21 Egyp-

Apple gets partial win on appeal in Samsung patent case

NEW YORK / SAN FRANcisco, 19 May — Apple Inc was handed a mixed ruling by a US appeals court in the latest twist in a blockbuster intellectual property battle with Samsung Electronics Co Ltd, as a prior patent infringement verdict was upheld but a trademark finding that the iPhone's appearance could be protected was thrown out.

That means up to 40 percent of a \$930 million verdict which had been won by Apple must be reconsidered.

In the highly anticipated ruling stemming from the global smartphone wars, the Federal Circuit in Washington, DC upheld patent infringement violations including one which protects the shape and color of its iPhone as well as the damages awarded for those violations.

"This is a victory for design and those who respect it," Apple said in a statement on Monday.

"We remain confident that our products do not infringe on Apple's design patents and other intellectual property, and we will continue to take all appropriate measures to protect our products," it said in a statement.

Shares in Samsung climbed 2.6 percent in Seoul trading after the decision, beating the wider Samsung welcomed market's 0.6 percent gain.

The long-running dispute with Samsung dates back to when former Apple Chief Executive Steve Jobs was still alive and was seen as emblematic of his tendency to fiercely defend the company's proprietary designs and technology from copies.

company sued to advance, said Brian Love, an assistant professor of law at the University of Santa Clara. "They made this argu-

ment from the beginning of the case that they were sort of the true innovators in the smartphone world, and that although a lot of this technology existed in the past, they came up with very simple, elegant and easyto-use design that took the smartphone to the next level," he said. "To the extent

that it was protected, it was protected by these design patents."

The 2012 trial between the two smartphone titans was widely watched, and the jury found Samsung violated several Apple patents including those related to iPhone's design and appearance.

Apple was eventually awarded \$930 million in damages, but failed to win a ban on the sale of the infringing Samsung phones, which are now no longer on the market. The appeals court further muddied the waters for Apple by ordering the court in San Jose to reconsider the \$382 million portion awarded for trade dress dilution.

Since the 2012 trial, Samsung and Apple have mostly dropped their legal battles, except for another case pending in the same appeals court involving a \$120 million verdict in 2014 for Apple on separate smartphone patents.

Samsung said in its

appeal that the damages award was excessive and unprecedented. The company argued it should not be forced to pay such a high price for making a "rectangular, round-cornered, flatscreened, touch-screened phone," calling those features "basic."

Apple countered that Samsung was trying to downplay its "shameless copying" of the iPhone design to increase its market share. Apple's shares rose as much as 1.8 percent to \$130.72 by midday on Monday after billionaire investor Carl Icahn said in a letter to CEO Tim Cook the company was "still dramatically undervalued" and that it should be trading at \$240. The stock has gained more than a quarter since October, when Icahn first said it was undervalued. The case is Apple Inc v Samsung Electronics Co, Ltd, in the US Court of Appeals for the Federal Circuit, No. 14-1335.

US researchers test way to rejuvenate muscles, brain

SAN FRANCISCO, 19 May — A study led by researchers with University of California at Berkeley has found that a small- molecule drug can inhibit the activity of a growth factor, allowing aging tissues to regenerate.

Dr rina Conboy, associate professor of bioengineering at UC Berkeley and co-author of the study, told Xinhua that high numbers of the growth factor, known as TGF-beta1, in the tissues are a typical sign of aging.

And the drug under the study is able to inhibit the receptor of TGF-beta1, blocking its pathway to the stem cells. The researchers were able to tackle both the brain and muscle tissues because they have the same molecular mechanism for aging. Using a viral vector for genetic therapy developed by Dr David Schaffer, director of the Berkeley Stem Cell Center and professor of chemical and bimolecular engineering, the team was able to insert genetic blockers into the brains of old mice to knock down TGF-beta1 activity.

"After blocking the pathway," Conboy said, "we saw that the hippocampal stem cells get. —Xinhua

began generating new nerve cells."

Concluding that inhibiting the pathway leads to renewed cell activity, Conboy and Schaffer injected mice with a molecule known as Alk5 kinase inhibitor to block TGF-beta1. The animals not only began regenerating old brain and muscle tissues, but also became smarter as their stem cells were rejuvenated. "All the mice regained between 70 and 80 percent of tissue youth and increased their cleverness," Conboy said. However, the researchers cautioned that this is a small step towards creating an actual rejuvenating solution for humans, since there are many other biochemical cues regulating adult stem cell activity. Though it has been successful with mice models, clinical trials will determine if the treatment is applicable to the human body. Conboy said the team would begin testing with human models as soon as they come up with the funding.

The researchers reported their finding in the current issue of the journal Oncotar-

Two die as 480 rushed to hospital due to heat exhaustion last week

Токуо, 19 Мау Two people died as 480 were taken to hospitals due to heat stroke or heat exhaustion in the week through on Sunday, the Fire and Disaster Management Agency said on Tuesday.

Of the 480, 11 were diagnosed with severe symptoms and required hospitalization of three weeks or more, while 131 with milder symptoms needed to stay at hospitals for shorter periods, the agency said. Nearly half of those sent to hospitals were 65 or older.

As temperatures are expected to rise, the agency is calling on people to ward off heat exhaustion by staying hydrated and using air conditioning.

By region, Tokyo had the largest number of 39 sent to hospitals last week, followed by Saitama Prefecture with 37 and Okinawa Prefecture with 33, the agency said.

Pentagon has no plan to change Osprey operations in Japan after crash

WASHINGTON, 19 May - The US Defence Department foresees no changes to a planned deployment of Osprey military aircraft to a western Tokyo air equivalent of the MV-22, to base even after the deadly crash of an Osprey unit in Hawaii over the weekend, a spokesman said on Monday, adding that there are no plans to change operations of already stationed vehicles in Japan.

The incident left one US Marine dead and 21 injured after an MV-22 Osprey of the Marines made a hard landing during a routine training session,

following just days after an announcement by the department that it would deploy a squadron of CV-22 Osprey, the Air Force Yokota Air Base beginning in 2017.

So far, details surrounding the crash remain murky. At a Press conference, Pentagon spokesman Steve Warren said that the accident would not affect the planned Yokota deployment and that there are currently "no plans to adjust our flight operations in Japan" or elsewhere.

Platini hints at easing of **FFP rules**

LONDON, 19 May UEFA president Michel Platini has suggested European football's break-even rule known as Financial Fair Play (FFP) could be "eased" with the executive committee to discuss the idea in June.

FFP was introduced in 2010 in an attempt to prevent rich owners from pumping unlimited amounts of cash into clubs and distorting the market. Under the rules, clubs who take part in European competition cannot spend more than their generated revenue. "I think things will be eased," Platini told French radio station RTL on Monday. "It will be the executive committee which decides and you will know at the end of June. "I think that the rules which have been made are very good. Financial fair play was voted for by the clubs."

UEFA could not be reached for comment on the interview. When the rules were introduced, Platini said that UEFA would not hesitate to ban clubs who broke them.

However, in pratice clubs have been allowed to negotiate settlements with UEFA's financial control panel. Manchester City and Paris St Germain were given fines of up to 60 million euros (\$68.1 million) last season and had their squad sizes capped for the Champions League, although they could get 40 million euros back if they stick to the terms of their negotiated settlements.

The contest, in its fourth year, attracted entries from more than 4,000 boys and girls ages 7 to 14. The top entrants flew to Omaha,

"This competition has taught us a lot, not just business skills but also cost-evaluation, problem-solving skills, and business etiquette, and how to interact with other people," said Emily, who was on "cloud nine" after winning.

Winners each got \$5,000, and said they plan to invest it towards their businesses. Bryn and Emily may also seek a patent.

Buffett gave each finalist 10 Class B shares of Berkshire -if they vote to reelect him next year as chairman.

Many entries were pure online concepts. That is a change from when Buffett would buy Coca-Cola sixpacks at his grandfather's grocery store for 25 cents, and then sell bottles for a nickel each.

"They've had the benefit of the Internet," Buffett said, "and that's reflective of the products they've come up with. They are leagues ahead of where I was at the same age."

Still, Buffett remains a role model. "He has a ton of inspirational quotes to believe in yourself, to save money, and maybe someday grow up to be someone like him," Bryn said.

More than 50 dead, dozens injured in Colombia landslide

Водота, 19 Мау — A landslide sent mud and water crashing onto homes in a town in Colombia's northwest mountains on Monday, killing more than 50 people and injuring dozens, officials said.

"The earth slid into the course of the La Liboriana ravine, then the dammed water caused an avalanche which destroyed everything in its path" in Salgar in Antioquia department, regional police commander Jose Angel Mendoza said in an interview.

The national disaster unit said in a statement that 52 people were killed and 37 others had been treated for injuries. Rescue teams, including search dogs, continue working in the area

looking for an unknown number of missing people.

Photographs released by the country's air force and television news footage showed homes and streets covered in mud and debris in the town in a mountainous area close to the Colombian Andes.

Residents were shown digging through rubble with sticks and their hands, looking for survivors.

"We don't know how many people are missing," said President Juan Manuel Santos, who flew over the affected area to survey the damage and met with local authorities.

Santos declared a public emergency, freeing up relief funds for victims.

London, 19 May — Nine-times French Open champion Rafa Nadal will no longer be regarded as an "immovable obstacle" at Roland Garros this year, according to twice former winner Jim Courier.

The American, who ruled the claycourt grand slam in 1991 and 1992, has watched the Spaniard's increasing vulnerability on the red dust with interest in the build-up to the year's second grand slam which begins in Paris on Sunday.

While Courier believes the best-of-fiveset format means Nadal remains formidable, he makes world number one Novak Djokovic favourite followed by Japan's Kei Nishikori.
